We are learning that the virus has been mutating as it spreads around the world. As COVID-19 blankets the globe – now having officially infected over 800,000 people in 179 countries, causing over 39,000 deaths – scientists are tracking a multitude of strains, according to *'USA Today.'* I'm not sure *'USA Today'* is all that reliable.

The virus has undergone over a hundred tiny mutations that act like genetic fingerprints – allowing researchers to see how the virus is migrating and splitting into similar but new subtypes, which can be seen at the website NextStrain.org.

Frequent sequencing of the virus has allowed researchers to draw several conclusions; for example, social distancing and shelter-in-place orders appear to be working in some areas, and that the virus doesn't appear to be growing more lethal as it evolves.

"The virus mutates so slowly that the virus strains are fundamentally very similar to each other," said infectious disease specialist Charlies Chiu of the University of California, San Francisco School of Medicine. "The outbreaks are trackable. We have the ability to do genomic sequencing almost in real-time to see what strains or lineages are circulating," he added.

Chiu also believes that it's unlikely that the difference in strains is responsible for the virus hitting people differently – with most some feeling only slightly under the weather for a day or two, 15% needing hospitalization, and a mortality rate that varies by country (and likely by testing rates).

SARS-CoV-2, the virus that causes the COVID-19 illness, began circulating in China around mid-November or mid-December. Its genome is made up of approximately 30,000 base pairs – while a human has over 3 billion. According to the report, the virus's most divergent strains contain only 11 base pair changes. So far, most cases on the U.S. West Coast are linked to a strain first identified in Washington state. It may have come from a man who had been in Wuhan, China, the virus' epicenter, and returned home on January 15, 2020. It is only three mutations away from the original Wuhan strain, according to work done early in the outbreak by Trevor Bedford, a computational biologist at Fred Hutch, a medical research center in Seattle.




Figure 1: Maximum likelihood genealogy show the evolution of 2019- nCoV: The evolutionary history

On the East Coast there are several strains, including the one from Washington and others that appear to have made their way from China to Europe and then to New York and beyond, Chiu said. –USA Today.

The theory is that the virus, which was developed by infectious disease experts to function as a bio-weapon, originated in the Wuhan-based lab of Dr. Peng Zhou, China's preeminent researcher of bat immune systems, specifically in how their immune systems adapt to the

presence of viruses like coronavirus and other destructive viruses. Somehow, the virus escaped from the lab, and the Hunan fish market where the virus supposedly originated.

Now, a respected epidemiologist who recently caught flack for claiming in a twitter threat that the virus appeared to be much more contagious than initially believed is pointing out irregularities in the virus's genome that suggest it might have been genetically engineered for the purposes of a weapon, and not just any weapon but the deadliest one of all.

In "Uncanny similarity of unique inserts in the 2019-nCoV spike protein to HIV-1 gp120 and Gag", Indian researchers are baffled by segments of the virus's RNA that have no relation to other coronaviruses like SARS, and instead, appear to be closer to HIV. The virus even responds to treatment by HIV medications."

For those pressed for time, here are the key findings from the paper, which first focuses on the unique nature of 2019-nCoV, and then observe four amino acid sequences in the Wuhan Coronavirus which are homologous to amino acid sequences in HIV1:

Our phylogenetic tree of full-length coronaviruses suggests that 2019-nCoV is closely related to SARS CoV [Fig1].

In addition, other recent studies have linked the 2019-nCoV to SARS CoV. We, therefore, compared the spike glycoprotein sequences of the 2019-nCoV to that of the SARS CoV (NCBI Accession number: AY390556.1). On careful examination of the sequence alignment, we found that the 2019- nCoV spike glycoprotein contains 4 insertions [Fig.2]. To further investigate if these inserts are present in any other coronavirus, we performed multiple sequence alignment of the spike glycoprotein amino acid sequences of all available coronaviruses (n=55) [refer Table S.File1] in NCBI RefSeq (ncbi.nlm.nih.gov) this includes one sequence of 2019-nCoV[Fig.S1]. We found that these 4 insertions [inserts 1, 2, 3 and 4] are unique to 2019-nCoV and are not present in other coronaviruses analyzed. Another group from China had documented three insertions comparing fewer spike glycoprotein sequences of coronaviruses. Another group from China had documented three insertions comparing fewer spike glycoprotein sequences of coronaviruses (Zhou et al., 2020).

We then translated the aligned genome and **found that these inserts are present in all Wuhan 2019-nCoV viruses except the 2019-nCoV virus of Bat as a host** [Fig.S4]. Intrigued by the 4 highly conserved inserts unique to 2019-nCoV we wanted to understand their origin. For this purpose, we used the 2019-nCoV local alignment with each insert as a query against all virus genomes and considered hits with 100% sequence coverage. Surprisingly, each of the four inserts aligned with short segments of the Human immunodeficiency Virus-1 (HIV-1) proteins. The amino acid positions of the inserts in 2019-nCoV and the corresponding residues in HIV-1 gp120 and HIV-1 Gag are shown in Table 1.

Those who analyzed the virus discovered that it had been weaponized, made into a bio-weapon with "inserted" protein pathogens known to virilogists, noted in the below chart.

The first 3 inserts (insert 1,2 and 3) aligned to short segments of amino acid residues in HIV-1 gp120. The insert 4 aligned to HIV-1 Gag. The insert 1 (6 amino acid residues) and insert 2 (6 amino acid residues) in the spike glycoprotein of 2019-nCoV are 100% identical to the residues mapped to HIV-1 gp120. The insert 3 (12 amino acid residues) in 2019- nCoV maps to HIV-1 gp120 with gaps [see Table 1]. The insert 4 (8 amino acid residues) maps to HIV-1 Gag with gaps.

Everything is right on schedule and, now, the time is come to remove one of the final obstacles standing in the way of a New World Order: The United States Constitution – even if, over the course of many decades, it has already been greatly diminished by the B.E.A.S.T. system; or, more specifically, Bullshit Emerging As Strategic Totalitarianism (B.E.A.S.T.).

In the worst, they will be prohibited from participating in certain aspects of society. It is not hard to fathom considering public schools have already implemented such policies for unvaccinated children.



To check this out, I looked at the British government's <u>own statistics</u> on total deaths registered weekly across the UK. It shows that in the week ending on the 8th of March 2019, 10,898 people died in total in the UK. This year, in the week ending the 6th of March 2020, the

equivalent figure was almost identical: 10,895. Make of that what you will. Statistics are currently available up to March 20, and while there is a lag between the spread of the virus and the resulting deaths, so far only about 1 percent of all mortalities bear any relation to coronavirus, and there is no visible spike. If nothing else, it helps to view the extent of the crisis in proportion - thousands of people die each week, and from the long-term view what we are seeing is not a plague, but a blip.

So when all is said and done, will any additional people die of the coronavirus? And what is meant by extra or additional?

Risk of Dying

Understanding this requires a bit of lateral thinking, but it helps to remember that everyone on Earth has a terminal disease: being alive. We all have to go sometime. 150,000 die every day around the globe. Nations actually are very accurate in reporting births and deaths surprisingly.

Recording exactly how and when we do is a big part of the job of statistician Professor Sir David Spiegelhalter. In a recent blog post, he outlined the concept of background risk. This is obtained by recording all of the people dying in any given year, at any given age. At its most simple, this is the percentage chance a person has of not reaching their next birthday, based solely on their age. Of course, that is not to say that if you are a 40-year-old man you have precisely a 0.2% chance of dying this year - the data are based on averages, and do not apply to individuals.

But nonetheless, across a country or given populations, the averages will be right, and it is possible to predict with great accuracy how many people will die in a given year. In the UK, for example, 600,000 people die annually. But wait a minute! A novel, brand-spanking new coronavirus is terrorizing us all. Therefore surely we can expect more people to die this year than would in a normal year? And when come year's end we should be able, with simple arithmetic, to count exactly how many more there were.

Spiegelhalter, chair of the Winton Centre for Evidence and Risk Communication at Cambridge University, won't say exactly what he does think that figure will be. **But he does say that if the deaths are towards the lower end of the current estimates, say at around 20,000 in the UK, Covid-19 will end up having "a minimal impact on overall mortality for 2020". He told R4 that his findings showed, to his own professed astonishment, that if someone contracts the coronavirus, they've got almost exactly the same chance of dying over the ensuing few weeks as they would normally have of dying over the next year, no matter what their age or background health.**

And depending on who you ask, that 20,000 figure might still be an overestimate. In fact, Spiegelhalter says that if extra people die it will likely be as a result of the knock-on effects of the lockdown, such as delayed normal health care, depression and isolation. American political commentator Candace Owens has been <u>Tweeting</u> consistently about the apparent insignificance of Covid-19 deaths compared to overall trends. She tweeted about this issue in relation to New York City, where meaningless figures are being waved around by the media. It has been in the forefront of the 5G roll out, keep that fact in your memory bank. It's likely the data will be difficult to assay when it comes to the true cause of death for months to come, if at all. The planners of this invisible war surely calculated this into their subversive diabolical plan.

Final Destination

With all of the numbers being bandied about these days by various universities and governments, NGO's, one would swear that they knew exactly what they were talking about. Make no mistake: this air of certainty is just a front. It is definitely too early to accurately gauge how many - if any - extra people will die because of coronavirus. It will depend on how four key pieces of information intersect.

These are:

How many people will become infected by Covid-19? How much does Covid-19 increase the risk of death? Are deaths being properly recorded? Of those people who die having contracted coronavirus, are they dying from the virus, or just with it?


Of those who died, how many had common health issues that would have killed them this year anyway? Since all of this began, the mainstream media have focused almost entirely on the first of these points, and stressing with an onslaught of material how important it is to slow the spread. The most extreme possible measures have been implemented to do that. Meanwhile, the three other points could end up comparing Covid-19 pretty much to the common flu. Only careful consideration by governments of all the key factors will result in the best future decisions.

It is hard to believe that when this all blows over, the damage that will have been done by the shutdown measures - to businesses, to civil liberties, to individual lives and, of course, to the global economy - could have been for nothing. Nonetheless, it seems entirely possible based on the present data. Remember above all to not take the figures the mainstream media throw at you at face value; there are lies, damned lies and statistics.



The U.S. lagged behind much of the world when it came to deploying 5G 60-gigahertz technology. Even now we are being told the virus has mutated, again perhaps an excuse to falsely identify cause of death.

On an average day in America 8,000 people die, or 2.9 million per year. Compared to 150,000 a day world-wide, we are a drop in the casket. When that perspective is placed in context next to

the 2,400 deaths in the month of March from the coronavirus, you have to question the necessity of shutting down the entire country. The suggestion that it has something to do with the removal of President Trump from office has some merit, I would think.

As soon as the World Health Organization put out a case fatality rate of 3.4% for the new coronavirus, multiple academics jumped in and criticized the projection. Most notably, three medical professors from Stanford University.

Dr. Eran Bendavid and Dr. Jay Bhattacharya, two professors of medicine at Stanford University recently published an opinion piece in the Wall Street Journal entitled, "Is the coronavirus as deadly as they say?"

In it, they provide reasons for why the fatality rate might be significantly lower than the projection given by the World Health Organization (WHO). This is not to say they weren't criticized, after these Stanford medical professors published their opinion, many took to YouTube in an attempt to explain why they were wrong.

But if we stick to the experts, and scientific analysis, it's safe to assume that the original case fatality rate put out by the WHO may be off by a significant margin.

John P. A. Ioannidis, a professor of medicine and epidemiology at Stanford University, recently published an article entitled "A fiasco in the making? As the coronavirus pandemic takes hold, we are making decisions without reliable data." In the article, he also argues that there is simply not enough data to make claims about reported case fatality rate.

He states that rates, "like the official 3.4% rate from the World Health Organization, cause horror — and are meaningless. Patients who have been tested for SARS-CoV-2 are disproportionately those with severe symptoms and bad outcomes. Keep in mind, Bill Gates and the "Event" predicted the death of 65-million in 18 months. Computer modeling is a very sophisticated process, and the input demands precise accurate data. As a computer guy, Bill Gates should be closer to the truth than Dr. Anthony Fauci.

As most health systems have limited testing capacity, selection bias may even worsen in the near future." He states that the real death rate of this virus could be five or more times lower, at 0.025 percent to 0.625 percent.

The main idea is that the number of people infected with the new coronavirus is most likely much higher than we know right now, which would drastically drop the case fatality rate.

According to an article recently published in the 'New England Journal of Medicine' by Dr. Anthony S. Fauci, Dr. H. Clifford Lane, and Dr. Robert R. Redfield, the case fatality rate may be less than one percent, and the clinical consequences of Covid-19 may be more similar to that of a severe seasonal influenza. Recent reports of multiple strains does not help in making predictions. "On the basis of a case definition requiring a diagnosis of pneumonia, the currently reported case fatality rate is approximately 2%. In another article in the New England Journal, Guan et al. report mortality of 1.4% among 1099 patients with laboratory-confirmed Covid-19; these patients had a wide spectrum of disease severity.

"If one assumes that the number of asymptomatic or minimally symptomatic cases is several times as high as the number of reported cases, the case fatality rate may be considerably less than 1%."

"This suggests that the overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza (which has a case fatality rate of approximately 0.1%) or a pandemic influenza (similar to those in 1957 and 1968) rather than a disease similar to SARS or MERS, which have had case fatality rates of 9 to 10% and 36%, respectively."

I felt it was important to share this information because what we are seeing right now is a lot of hysteria, and a lot of fear from people. White House health advisor Dr. Anthony Fauci said the first human trial testing a potential vaccine to prevent COVID-19 is "on track" with public distribution still projected in 12 to 18 months. He called it the "ultimate game changer" in the fight to control the pandemic. (CNBC).

That's not to say it's not warranted, but we must remember that there's a good chance that this is not going to turn out as bad as so many people believe when it comes to death rates, and perhaps there is something more behind this full economic shutdown.

With all of the models out there, it's important to remember that modelling is controversial, and models that promote such deadly scenarios from this new coronavirus have been contested by other scientists. That being said, there are models that have been published that show a much less cause for concern.

A study, from the Nuffield Department of Medicine at the University of Oxford, used data on the number of deaths and reported cases in the early stages of the epidemic in Italy and the UK. The researchers used mathematical modelling to estimate infection rates by fitting a "susceptible—infected—recovered" model of epidemics to the number of deaths seen.

The researchers showed outcomes generated from different assumptions, including a reproduction number of 2.25 and 2.75, and setting the proportion of the population at risk of death or severe disease at 1% or 0.1%. The study was led by Sunetra Gupta, professor of theoretical epidemiology at the University of Oxford.

One of the models in the study suggests that that millions may have already been affected by the new virus with little or no symptoms, and that the virus is actually in the later stage. If this is true, like all of the information above in this article suggests, then the death rate is much lower.

Approximately 150,000 people die every day, worldwide. That's 13 million people that have died so far this year. Coronavirus has killed 22,000 people worldwide so far this year. Perhaps this can offer a little better perspective. The data masks the real cause of deaths labeled COVID-19, and skews the death-to-infection case ratio.

Deborah Leah Birx, an American physician and diplomat who serves as the response coordinator for the White House Coronavirus Task Force also seems to contradict some mainstream media narratives, as well as all of the models that have predicted such doom and gloom and dire situations compared to what they are seeing on the ground, in real time. She makes some interesting points.

The predictions of the models don't match the reality on the ground in either China, South Korea, or Italy. We are about five times the size of Italy, so, if we were Italy and you did all those divisions, Italy should have close to 400,000 deaths, we're not anywhere close to achieving that.

So these are things kinds of thins we're trying to understand, models are models, we're adapting now, there's enough data now of the real experience with the coronavirus on the ground, to really to really make these predictions much more sound.

So when people start talking about 20 percent of the population getting infected, it's very scary, but we don't have data that matches that based on the experience.

The Takeaway here is this.

At the end of the day, we have to ask ourselves why certain narratives and opinions are being ridiculed. Dr. Ron Paul, for example, has received multiple "Fake News" strikes for sharing his opinions about the coronavirus. He was a trained physican before running for a seat in the Congress. According to him, "people should ask themselves whether this coronavirus "pandemic" could be a big hoax, with the actual danger of the disease massively exaggerated by those who seek to profit – financially or politically – from the ensuing panic." I have said from the beginning it was a hoax, a plan-demic, which mis-labeled the diagnosed cause of death.

What's interesting is how some are allowed to share opinions, while others are not. The Internet censors have been working around the clock to keep you from learning the truth about the Corona virus both as a bio-weapon and its link to 5G EMF sickness.

I'd also like to add in, again, when the final numbers come out they will most likely not account for all those infected or who have been infected.

Furthermore, why is mainstream media not mentioning what's been happening with vitamin C, D_3 , Zinc, and Potassium Iodine? Neither are they discussing the importance of an optimum immune system to ward off any kind of pathogens.


The median age of the patients was 59 years, with higher morbidity and mortality among the elderly and among those with coexisting conditions (similar to the situation with influenza); 56% of the patients were male. Of note, there were no cases in children younger than 15 years of age. Either children are less likely to become infected, which would have important epidemiologic implications, or their symptoms were so mild that their infection escaped detection, which has implications for the size of the denominator of total community infections.

Fauci and his co-authors also reviewed the timing of the onset of the disease to the need for an infected person to be hospitalized.

For example, Li et al. report a mean interval of 9.1 to 12.5 days between the onset of illness and hospitalization. This finding of a delay in the progression to serious disease may be telling us something important about the pathogenesis of this new virus and may provide a unique window of opportunity for intervention.

I have taken Statistics and Probability studies in college and graduate school and I can tell you that the public is as ignorant as they can be in knowing how the data is compiled, processed, and reported. 


Fig. 10—The Coronavirus is not Chinese in origin. It is a man-made British-US Pilgrims Society bioweapon invented by Wellcome Fund, Wellcome Trust, Bill Gates, DARPA, UN, WHO and EU, among others, in Pirbright, Woking, Surrey UK by <u>The Pirbright Institute</u> holds <u>U.S. Patent No.</u> <u>10,130,701</u>. This proof comes from their own hand.







Fig. 6—George W. Bush, Pilgrims Society; progenitor of The Patriot Act where basic rights in the Bill of Rights were suspended following the Pilgrims Society fears conjured up and stoked by the MSM Pilgrim propaganda after their 9/11 false flag attack. Numerous whistleblowers have confirmed that Bush, Cheney, Rumsfeld etc. knew the attack was coming... because they ordered the C.I.A. to organize it for their Pilgrims Society brethren in Britain and the U.S.
