- Produce HHS question-and-answer videos featuring local Black doctors discussing the vaccines, how they work, and why the public should get vaccinated
- Request that Tom Brady create a video with his parents encouraging vaccination
- Create custom partnerships with the social media platforms with algorithms to hit the audience
- Launch Hollywood comedy writers video content
- Work with YouTube on an original special about vaccinations targeted to young people
- Work with Instagram to produce a series about vaccines for @Instagram (the largest social media account in the world, 387 million followers)
- Request major TikTok, Snapchat and Instagram influences to create videos of themselves being vaccinated
- Request a vaccination special on Christian Broadcast Network featur[ing] Evangelical leaders
- Request that the major live TV entertainment shows feature hosts being vaccinated on air (ex: the hosts of The Voice)
- Request that the TV morning and daytime talk shows feature special vaccination reunion moments with everyday Americans
- Convene an editorial meeting with the publishers of Catholic newspapers and newsletters across the country

- Place a trusted messenger on the Joe Rogan Show and Barstool Sports to promote vaccination
- Work with the NFL, NASCAR, MLB, CMA to request they create content with their talent and release through their broadcast and social channels

As Judicial Watch President Tom Fitton stated, *“These records show a disturbing and massive campaign by the Biden administration to propagandize and politicize the controversial COVID vaccine. It seems as if the entire entertainment industry was an agent for the government!”*

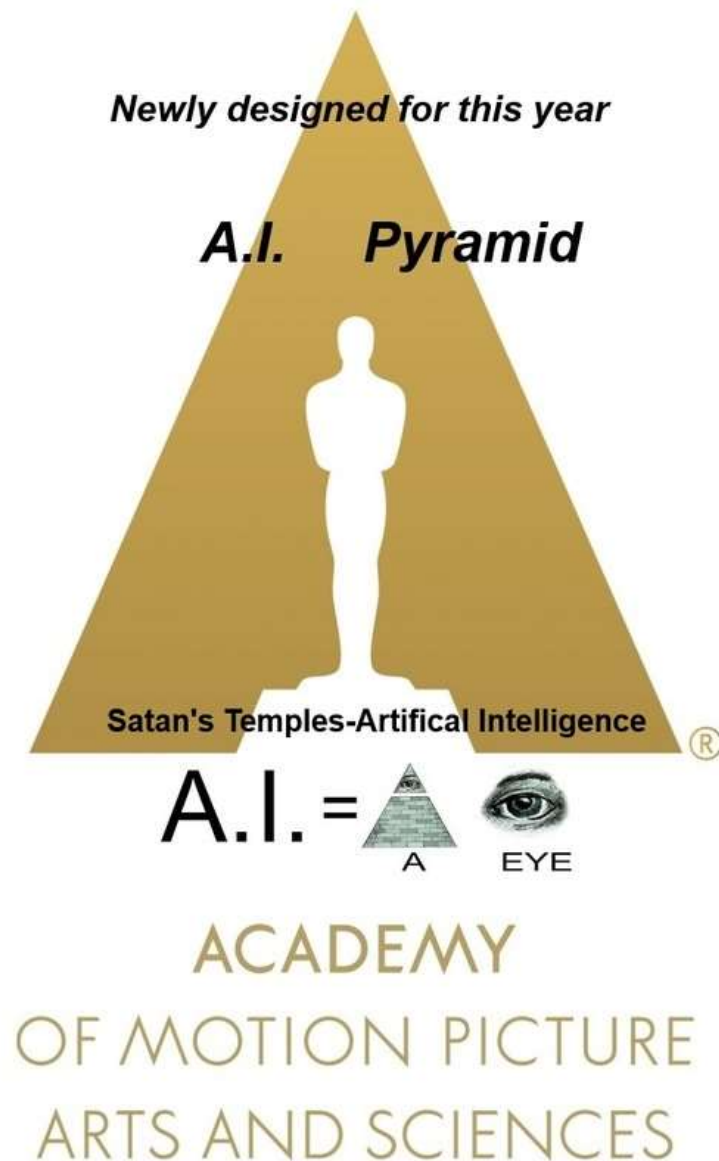
This was all taxpayer money, used to brainwash Americans with a monstrous, coordinated vaccine propaganda campaign coordinated by HHS and the CDC.

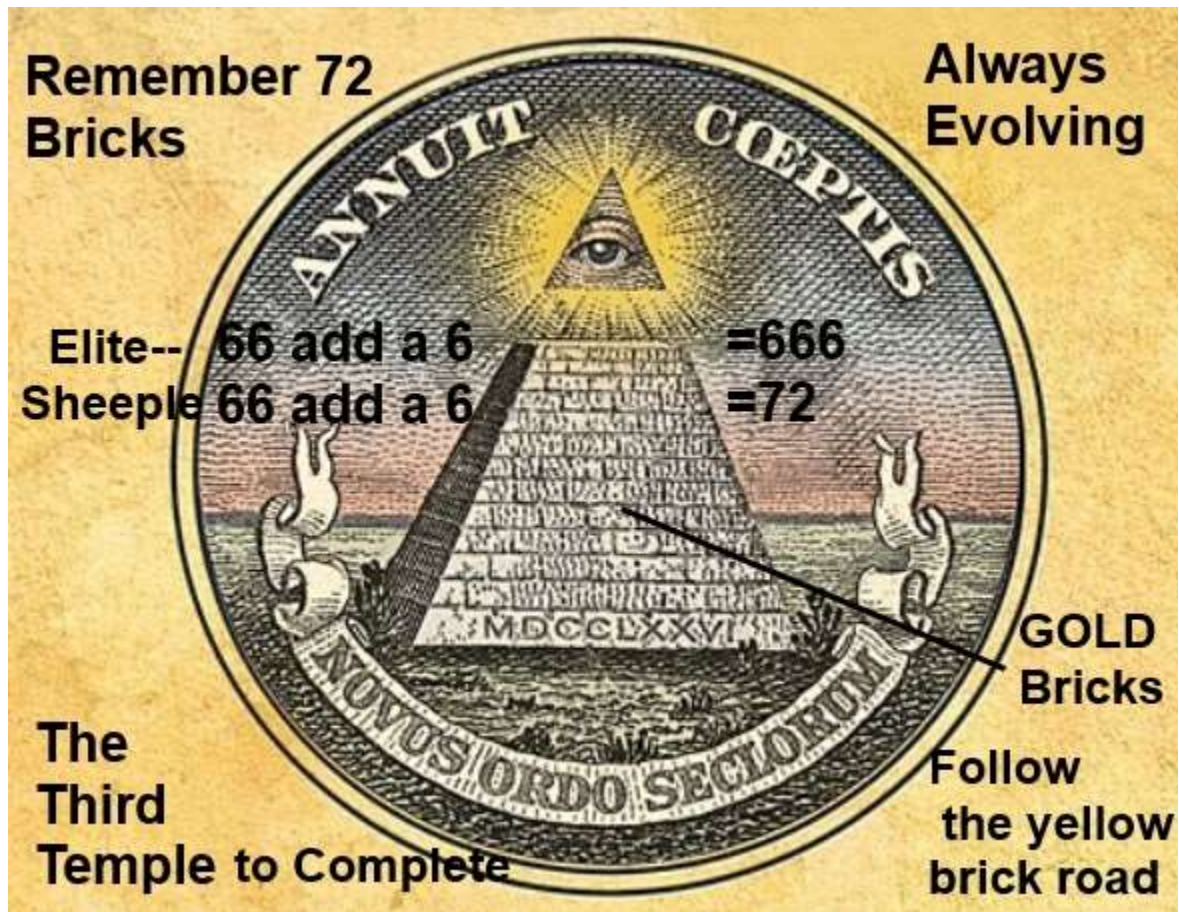
The media was in on it the whole time, of course, and they refuse to report on this bombshell HHS document even now. They’ve been complicit the entire time.

It was first unveiled in China’s designated “Smart” cities in the early fall of 2019.

1.85+ Million 5G Base Stations Now Deployed in China

China ended May of 2022 with a total of 899.3 million subscribers in the **5G** segment. Chinese operators have already deployed over 1.85 million **5G** base stations across the country, local news agency Xinhua reported, citing data from the Ministry of Industry and Information Technology.

The ministry reported that Chinese carriers deployed nearly 300,000 **5G** base stations during the second quarter of the year. Also, mobile operators are expected to add a total of 600,000 base stations to boost **5G** infrastructure across China during 2022.

The ministry also reported that the combined revenues of sectors including electronic information manufacturing, software, communication and the internet totaled over CNY10 trillion (\$1.48 trillion).

China ended May, 2022 with a total of 899.3 million subscribers in the **5G** segment, according to the carriers’ latest available figures. Chinese operators recorded a net gain of 30.18 million **5G** subscribers in May.

China Mobile, the world’s largest operator in terms of subscribers, added a total of 18.21 million **5G** subscribers during last month. The operator said it ended May with 495.13 million **5G** subscribers, compared to 221.95 million **5G** customers in May 2021.

Rival operator China Unicom said it added a total of 4.93 million **5G** subscribers during May. The carrier ended the month with 179.70 million **5G** subscribers.

Meanwhile, China Telecom added 7.04 million **5G** subscribers last month to take its total **5G** subscribers base to 224.47 million. During the first five months of the year, the telecom had added a total of 36.67 million **5G** subscribers.

A few months ago China Broadnet became the fourth mobile operator in China to offer **5G** services in the country.

The operator already supplies cable services and became the country’s fourth operator when formally inaugurated in 2020, having previously acquired a license for commercial **5G** services in 2019. The carrier was initially known as China Broadcasting Network before rebranding earlier this year. According to previous reports, China Broadnet will use **5G** infrastructure owned by China’s largest mobile operator China Mobile.

Last year, China Broadnet and China Mobile said they aim to initially deploy 400,000 **5G** base stations as part of the companies’ efforts to launch a shared **5G** network.

The two companies expect this shared network to reach nationwide coverage within the next two years. In May 2020, the company had announced plans to deploy a nationwide 700 MHz **5G** network in cooperation with China Mobile.

Under the terms of the deal, China Broadnet will have access to China Mobile's 2.6 GHz network and will also receive guidance and investment from the mobile operator. China Mobile will share its 2.6 GHz network on a paid basis, with China Broadnet able to access its 2G, 4G and **5G** infrastructure prior to the launch of the 700 MHz network.

Since 2017 doctors and scientists have asked for moratoriums on Earth and in space *and* the majority of scientists oppose deployment. Since 2018 there have been reports of people and animals experiencing symptoms and illnesses after it was activated. Some researchers have suggested that **5G** activation may be contributing to COVID-19 infections as well as hundreds of thousands if not millions of bird deaths. Of course, there are health and environmental risks associated with 4G and other sources of wireless Wi-Fi radiation and electromagnetic fields (aka "Toxic Electrosmog") as well. 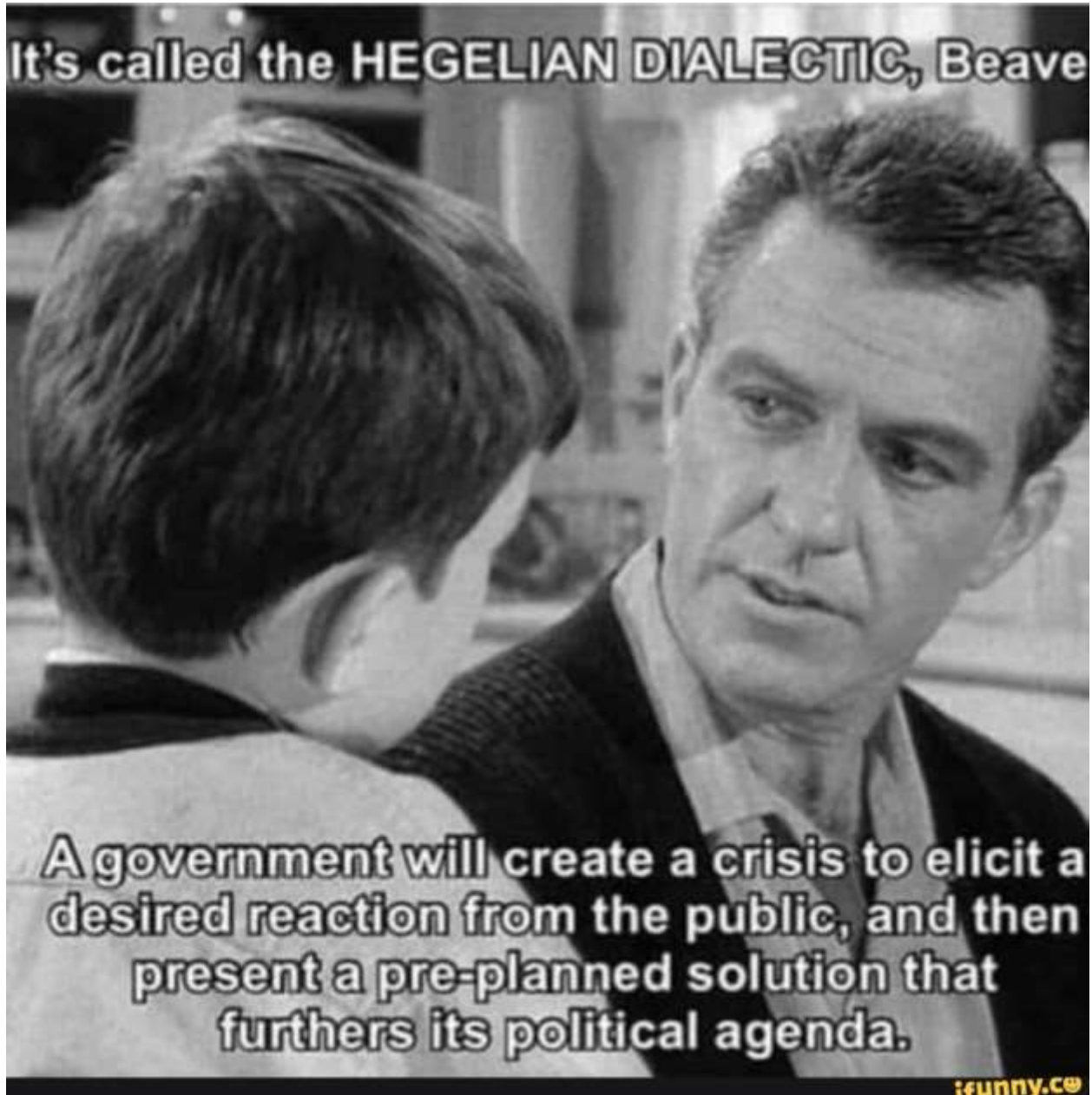

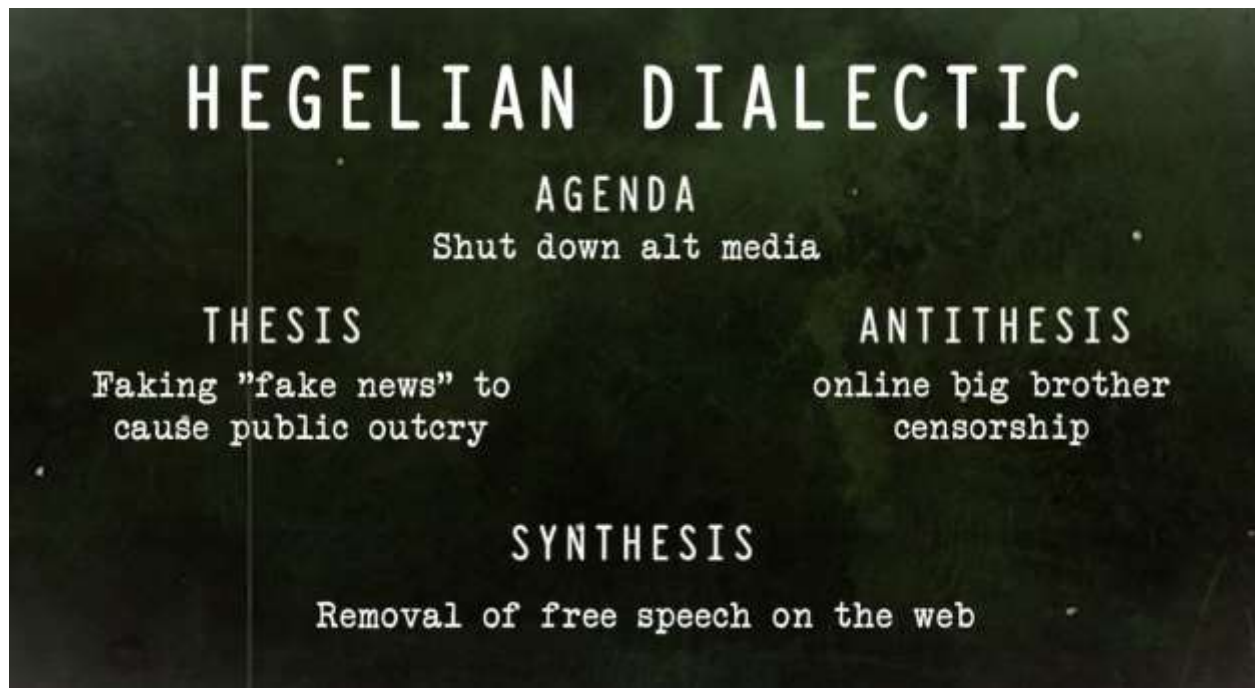
HEGELIAN DIALECTIC

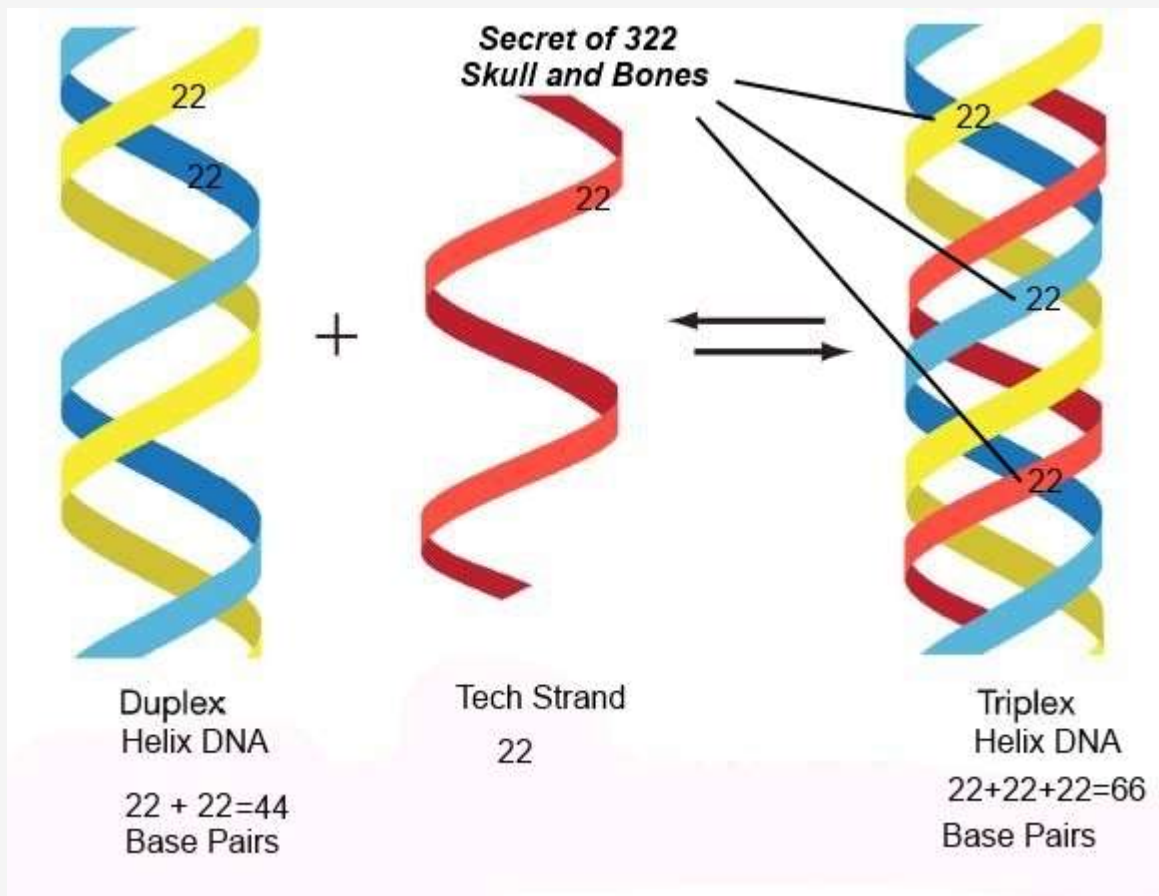
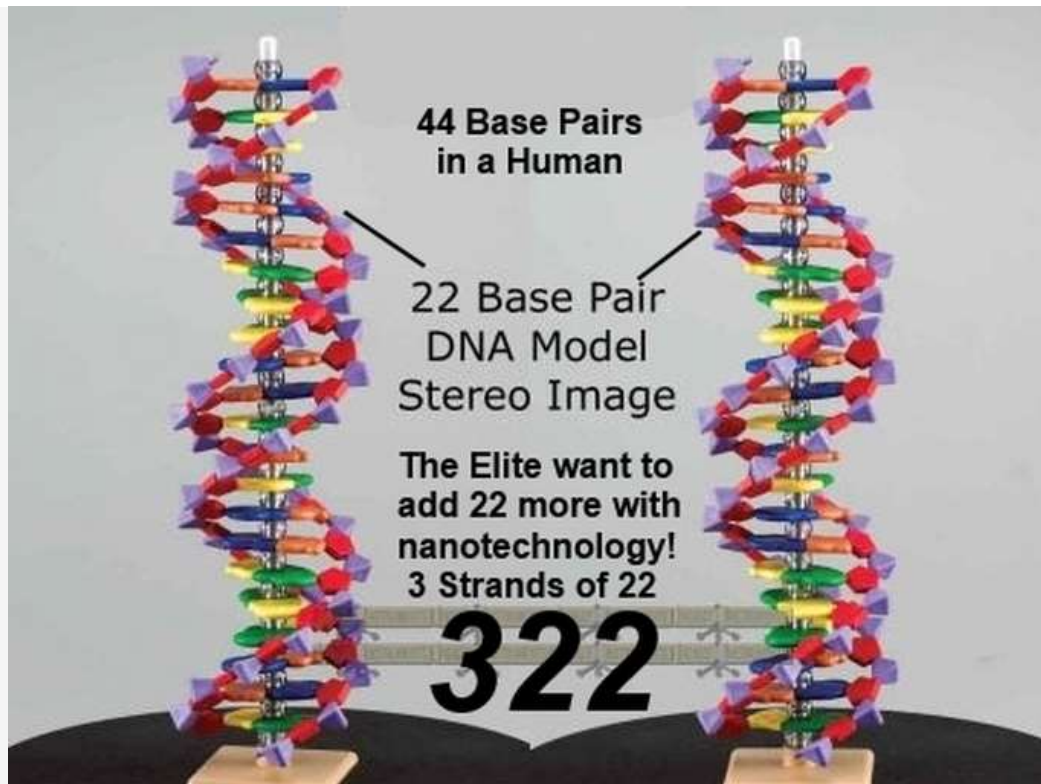

"Now, these numbers are beyond staggering. To contrast that with history, vaccines have typically been pulled from the market – the last one, the bird flu vaccine – was pulled with only 35 — three, five deaths."

*"I hope people can appreciate the scale of what is going on here. An unimaginable carnage **WHICH ISN'T OVER** because that number – first of all, is the current estimate. It does not include future deaths of a similar type, which will be cumulative on top of that."*

"It does not include stillbirths. It does not include those avoidable deaths due to having had a one-disease healthcare system for two and a half years, with people not being treated or investigated for cancer or treated for cancer, for example."

"Those numbers are not included. The numbers from the lockdowns, the suicides are not included."

"And also not included are the future deaths that we're anticipating from a rapid increase in the rate of cancer presentations and fatal infections because of immune suppression induced by the clot shot."

*"Those factors are **IN ADDITION TO** those jaw-dropping numbers that I just mentioned."*

Now that the genetic manipulation of people has taken a giant leap forward by altering over 70% of the population already, [At least 262,908,216 people or 79% of the population have received at least one dose. The details of the Biden Executive Order are outright chilling. Here is a word for word excerpt from a segment of the actual order:

"For biotechnology and bio-manufacturing to help us achieve our societal goals, the United States needs to invest in foundational scientific capabilities. We need to develop genetic engineering technologies and techniques to be able to write circuitry for cells and predictably program biology in the same way in which we write software and program computers; unlock the power of biological data, including through computing tools and artificial intelligence; and advance the science of scale-up production while reducing the obstacles for commercialization so that innovative technologies and products can reach markets faster."

Whereas there are a few points elsewhere within the order that would be beneficial to our economy and development of "biotechnology" based on advancing technology in general, they make it very clear that the real goal is to change "us" to achieve THEIR societal goals – but they don't specify what their goals are. It clearly states that they wish to create mRNA strings to be incorporated into people which will "rewrite the circuitry of their cells" so that the cells now do "*what they want*" instead of what God intended and designed for us. They continue to state that they intend to fast track the technology to reach the "market" (us) faster.

Even through this Order is vague, it is clear that this genetic-based technology is being fully funded and backed by the U.S. Government and they will be using the U.S., the people, to put their programs into. Whatever this is, it will most likely lead to the "Mark of the Beast" that the Anti-Christ will require all to be marked in order to be part of society and be able to buy and sell -(Revelation 13:17).

Although that this executive order is something that senile Joe Biden or a look alike double signed, no politician has an idea of what all it means. So with this being the official truth, why does United States Government data show

that the U.S. Department of Defense (DoD) awarded a contract on November 12th 2019 to Labyrinth Global Health INC. for 'COVID-19 Research', at least one month before the alleged emergence of the novel coronavirus, and three months before it was officially dubbed Covid-19?

The shocking findings, however, do not end there. The contract awarded in November 2019 for 'COVID-19 Research' was not only instructed to take place in Ukraine, it was in fact part of a much larger contract for a 'Biological threat reduction program in Ukraine'.

Perhaps explaining why Labyrinth Global Health has been collaborating with Peter Daszak's EcoHealth Alliance, and Ernest Wolfe's Metabiota since its formation in 2017.

The Government of the United States has a website called '[USA Spending](#)', an official open data source of federal spending information. According to the site as of April 12th 2021, the U.S. Government has spent a mind-blowing \$3.63 trillion "in response to COVID-19". But that's not the only information on Covid that can be found on the site.

Hidden within the 'Award Search' are details on a contract awarded by the Department of Defense to a company named 'Black & Veatch Special Projects Corp', which is allegedly "a global engineering, procurement, consulting and construction company specializing in infrastructure development".

Hal Turner aired this report on his radio show October 12, 2022 as a reminder that our own government leaders want to get rid of "*useless eaters*" placing a burden on the Social Security roles. Dr. David L. Martin first made this issue public in the summer of 2020.

The contract was awarded on September 20th, 2012 and is described as "Professional, Scientific, and Technical Services". Obviously, this is very vague and most likely of little interest to anyone who happens to stumble across it. But there is something contained deep within the details that should be of interest to anyone and

everyone.

The 'Award History' for the contract contains a tab for 'Sub-Awards' detailing the recipients, action date, amount, and a very brief description for 115 Sub-Award transactions. Most of the Sub-Awards are extremely mundane for things such as *"laboratory equipment for Kyiv"*, or *"office furniture for Kyiv"*.

But there is one Sub-Award that stands out among the rest, and it was awarded to Labyrinth Global Health INC for "SME Manuscript Documentation and COVID-19 Research".

An award for Covid-19 research isn't exactly shocking when the world is allegedly in the grip of a Covid-19 pandemic, but considering the fact the sub-contract was awarded 12th November 2019, at least one month before the alleged emergence of the novel coronavirus, and three months before it was officially dubbed Covid-19, the award for Covid-19 research should come as a shock to everyone.

But the shock doesn't end there, because the place the contract for Covid-19 research was instructed to take place was Ukraine, as was the entire contract awarded by the DoD to Black & Veatch Special Projects Corp.

The contract details found on the 'USA Spending' site actually reveal that the specific DoD department that awarded the contract was the Defense Threat Reduction Agency (DTRA). The contract was awarded 20th September 2012, and concluded on October 13, 2020.

Whilst the details are vague, the U.S. government site also reveals that \$21.7 million of the \$116.6 million contract was spent on a 'Biological threat reduction program in Ukraine'.

Why did the Department of Defense pay a company that is allegedly "a global engineering, procurement, consulting and construction company specializing in infrastructure development", to help implement a "Biological threat reduction program in Ukraine"?

And why did both the DoD and said company then pay Labyrinth Global Health INC

to carry out COVID-19 research in Ukraine at least one month before the alleged emergence of the novel coronavirus, and three months before it was officially dubbed Covid-19?

Founded in 2017, [Labyrinth Global Health](#) is allegedly a *“women-owned small business with deep expertise and a proven track record supporting initiatives for scientific and medical advancement.”*

They describe themselves as *“a multicultural and international organization with offices in four countries and a team of experts with diverse backgrounds and competencies, including microbiology, virology, global health, emerging infectious disease nursing, medical anthropology, field epidemiology, clinical research, and health information systems.”*

One of those offices just happens to be located in Kyiv, Ukraine, which the company dubs *“a gateway to Eastern Europe”*.

The leadership team of Labyrinth Global consists of Karen Saylors, PHD who is the Chief Executive Officer; Mary Guttieri, PHS who is the Chief Science Officer; and Murat Tartan who is the Chief Financial Officer.

Karen Saylors, PhD, who co-founded Labyrinth Global Health, has allegedly worked in the international public health field for over a decade and has spent many years living in Africa establishing global surveillance networks, *“working with partners to improve Global Health policy on infectious disease detection, response, and control”*. At Labyrinth, Dr. Saylors specializes in studies that aim to understand and mitigate the biological and behavioral risks of disease transmission. Dr. Saylors worked with Oxford University Clinical Trials Network in Vietnam on zoonotic disease surveillance research and continues to coordinate with regional partners on emerging outbreaks in animal and human populations.

But who are the partners that Dr. Karen Saylors and Labyrinth Global Health choose to work with? They are none other than the ‘Eco-Health Alliance’ and ‘Metabiota’.

Dr. Karen Saylors, Eco-Health Alliance and Metabiota worked together on the United States Agency for International Development (USAID) ‘PREDICT’ program from 2009, while Labyrinth Global Health worked alongside EHA and Metabiota on the PREDICT program from 2017.

Launched in 2009 and funded by USAID, PREDICT was an early warning system for new and emerging diseases in 21 countries. It was led by the University of California’s (“UC”) Davis One Health Institute and core partners included EcoHealth Alliance (“EHA”), Metabiota, Wildlife Conservation Society, and Smithsonian Institution, and as we’ve just revealed; Labyrinth Global Health. PREDICT was a forerunner of the more ambitious Global Virome Project.

The USAID describes PREDICT as having made “*significant contributions to strengthening global surveillance and laboratory diagnostic capabilities for both known and newly discovered viruses within several important virus groups, such as processing*”. It can be customized for an infinite number of applications. As an example the corona virus has been experimented with by research scientists for more than two decades; filoviruses (including ebolaviruses), influenza viruses, paramyxoviruses, and **coronaviruses**. This is but a single example of how the U.S. government plays a significant role in the harming and murdering the U.S. Where this connects to Synthetic Biology is where we need to look at next. In Part 2 I will pick up with this topic of Synthetic Biology and how it was used to “create” pathogens as viruses.
