

The 5G's (End Game) Trap Will Soon Be Activated!

Part 3



What I am about to share will shake you to the core if you were intimidated or coerced into taking the alleged vaccines by Pfizer, Moderna, J&J, or Astra Zeneca. You may have forgotten about all the gimmicks used to coerce people to get the government's poison. Attorney Todd Callendar is a hero in this war we are in the middle of. Todd Callendar, Dr. David E. Martin and former Blackrock investment expert Edward Dowd have been at the forefront in exposing the crimes against humanity by Dr. Anthony Fauci, Bill Gates, and others at the WHO, FDA, CDC, NIAID, NIH.

While most experts have been in the fields of medicine, microbiology, chemistry, genetics doing the deep-dive research into these "bioweapons", these noted experts were looking at such things as insurance mortality claims, death statistics, spikes in such things as coffin sales, baby coffins, funeral floral arrangement sales, company insurance claims that come with hiring of employees as company-paid benefits, etc. I have been following Todd Callendar, David Martin, and Edward Dowd that have appeared on a variety of Internet web sites. In this segment we will be looking at the findings of Todd Callendar, as an attorney representing 400,000 military personnel who refused to take experiment vaccines even though the DoD mandated them for all active, reserve and National Guard personnel.

TODD CALLENDAR: "EVERYONE WHO HAS HAD THE SHOT HAS AIDS"

Back on April 8, 2022 I came across a video discussion between Reiner Fuellmich and members of the Corona Investigative Committee with Todd Callendar who is an attorney that is well-versed in what he talks about and has been working with the military. Reiner Fuellmich leads a task force of more than a thousand attorneys and professionals from health and related disciplines. They have global class-action law suits against the WHO and others.

This is taken from the introduction from the video itself. I replayed the interview with Germany attorney Reiner Fuellmich, who is known for his multi-billion-dollar law suit against Volkswagen several years ago.

Reiner Fuellmich had as a Guest: Todd Callendar – Lawyer (Disabled Rights Advocates) worked in the disability, health and life insurance industry for more than 20 years and focuses on the international convergence of biomedical, morbidity and mortality risks in the global legal context.

He was the first lawyer in the U.S. to sue the U.S. Department of Defense, HHS and FDA in relation to the mandates and as such, he acquired 400,000 military clients (plaintiffs) and whistle blowers with scores of them and others that have provided ample whistleblower evidence.

Todd knows from the military's own DMED Database that in 10 months of 2021 all cause morbidity and mortality has increased by 1,100% between 18-40 years of age only for military personal. Callendar says: "This is Genocide" It is proof positive that elements in the U.S. government are facilitating a Fascist takeover of the U.S.

The Corona Committee was formed by four lawyers. It is conducting an evidence review of the Corona crisis and actions around the world.

I recognized that what Todd Calendar had to say is very important and needs to be spread as widely as possible. The audio was very poor and it took some effort to understand what was being said. I transcribed notes over the course of several days so as not to miss anything of importance. The following is the result of my efforts to try and copy the message. Below is the core content from interview. I have taken notes from his presentation and provided some references where I could and interspersed with some explanation.

BY-PASSING THE IMMUNE SYSTEM

Lipo-nano-particles are like "little bombers" carrying a payload of spike proteins, mRNA and synthetic DNA: In order to slip this past and disarm the natural human immune system they used three HIV proteins to bypass the immune system:

GP120,
AV5 as an adjuvant and
PP14

Those three proteins were injected into humans for the specific goal of allowing these “little bombers” (the lipo proteins) to go into the cells and deliver those payloads and create synthetic DNA, recombinant mRNA and DNA

What is alarming in the terms of all the excess death and morbidity is that the people who put these three proteins into the shots disarmed people’s immune systems and gave them vaccine-induced AIDS without anything to reverse it.

So what you are seeing in terms of excess death and morbidity, from data on the DoD database, DEMD is a **1,100% increase in all-cause mortality and morbidity**. For this to happen there has to be something systemic going on.

When you see all types of mortality in people who are physically-fit – heart issues, inflammation issues, clotting, rise by hundreds of percentiles there has to be only one cause and that is the destruction of the immune system. Furthermore it was not by accident!

Everyone who got this injection got some form of immune deficiency syndrome. Those that got one shot had about 30% of their natural immunity destroyed. This can be seen in medical practice. The real epidemic is NOW. A second injection resulted in an additional 30% of their immunity destroyed. Each successive shot or booster destroys more of an individual’s ability to fight off the invaders.

Based on what they are seeing they are expecting a **5,000%** increase in excess mortality for this year of 2022.

It is not by coincidence that Moderna has received license for the emergency use of their HIV vaccine. They gave everyone AIDS and said “here’s your salvation”.

He also says that those who received the Covid shots already have the dormant Marburg virus encapsulated in lipid nano-particles, which can be activated via **5G** frequencies.

In the next PLANdemic (the Marburg pathogen), which will be the excuse used to force the unvaxxed into quarantine camps (FEMA) where kill-shots will be administered.

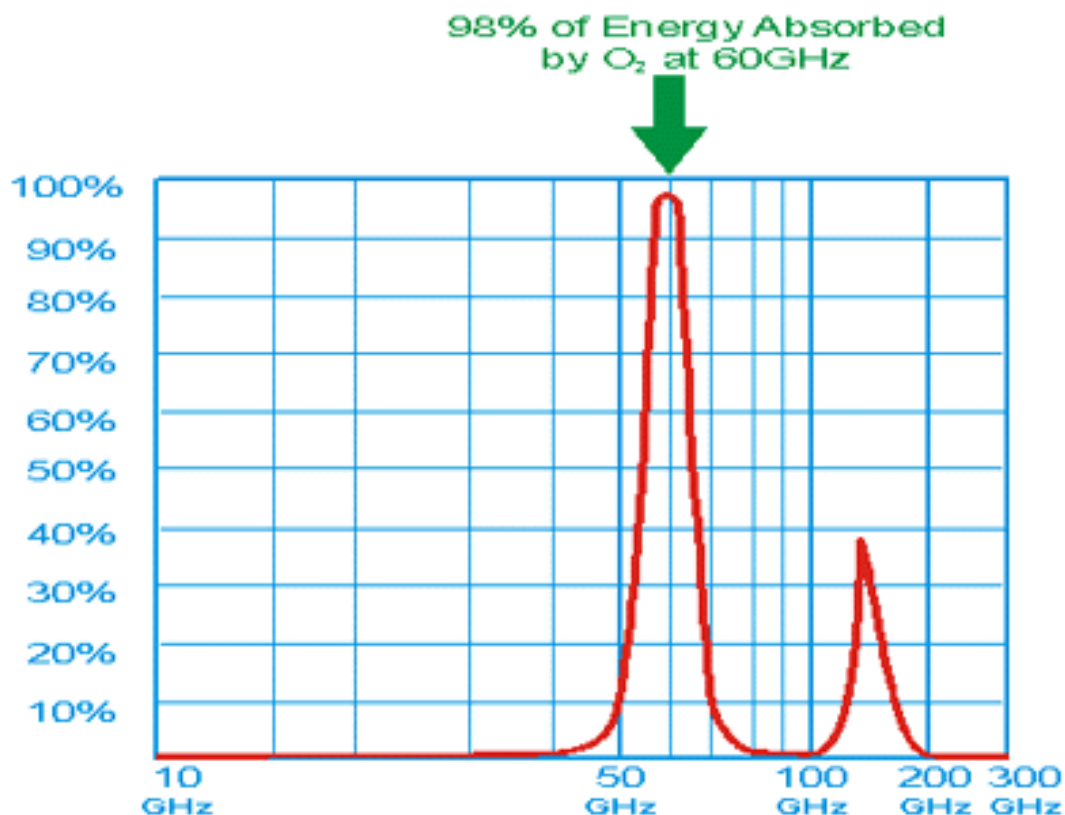
THE 5G CONNECTION

Experts have figured out that there is an EMF connection to all of this. During the lockdown period of 2 years there was a tremendous rollout of **5G-** in every single public school district in the United States. There are 12,754 school districts across the land. The various telecoms were working their people seven days a week installing **5G** infrastructure. Why? That was the big question. I have a grandson who is an IT technician and during the summer of 2021 he was installing cable infrastructure in the very school he graduated from.

Each **5G** frequency does different things including mimic the symptoms of COVID.

At Halloween, October 31st, 2019 Wuhan, China was the first in the world to introduce **5G**. Within a short period of time we had people standing on the street and then falling over dead.

Using the cellphone as a transmitter they were able to rip the oxygen from the nitrogen and without the oxygen they fell over dead. As I have reported numerous times in other articles, **5G** at 60-GHz will consume 98% of the blood oxygen, resulting in instant death. **5G** is a dual use item – you can use it to communicate or to kill.



Todd reported that military focused a lot of their research involved the 18-GHz signal band. If you look at the Pfizer and Modern patents the COVID pathogen was chimeric. It was part-viral and part-bacterial. The pathogens in the lipid nano-particles, the ones that were created and are inside the vaccine, are also chimeric. The 18-GHz signal is strong enough to activate pathogens without dropping people in their own footprint that comes at the 60-GHz signal.

In some cases they are Marburg's mixed with e-Coli and they were Ebola mixed with staphylococcus.

When they are exposed to 18-GHz they will swell and become porous which means they will pour out the proteins that caused people's bodies to produce these pathogens.

This was the whole point of the mRNA technology.

Later on Todd Callendar returns to the question of **5G** in the Q & A session.

The telecom industry will argue to you are blue in the face that **5G** has no relationship whatsoever with Covid-19, but there is abundant evidence to the contrary. One such study is on the Pub Med site:

The above link is from the NIH's National Library of Medicine. While lengthy, it does point to **5G** as a significant factor in Covid. Now, you can say "correlation" does not mean or confirm "causality", but when you see smoke, inevitably we will find a fire.

A recent military study shows military personnel evaluated who received the flu vaccine were at 36% higher odds of testing positive for coronavirus (pre-SARS CoV2) with varied benefit in preventing some strains of the flu. That study represents a specific group of healthy military personnel. That study was questioned since the VA recommends veterans get a yearly flu shot. Taken at face value, the study indicates people who received the flu vaccine are at increased risk for coronavirus pre-COVID-19, during 2017-2018. Like veterans, current service members, school teachers, and medical professionals, the study population consisted of a population with a history of being heavily vaccinated. Given that this report was published by DoD researchers in a scientific journal, why is the VA telling veterans to get the influenza vaccine?

What is the motive behind their advice? They are "carrying water" for the government, plain and simple. The U.S. government is carrying out the wishes of the Rothschild's in their Great Reset takeover of the world. I noted in Part 1 how the U.S. government ran the most controlled sophisticated scam on the America people, as shown in the documents obtain by Judicial Watch recently.

The DoD mandated the EAU "Emergency Authorization Use" of the Vaxxes in spite of the fact none of the Vaxxes were subjected for safety or efficacy testing, again an issue of what the real motivation is, even after the national numbers are clearly revealing they are neither safe or effective. The evidence is to the opposite and suggests the policy and decision makers are driven by other nefarious reasons.

5G – why use cellphones and the satellite signals?

When you understand Electroporation and how it works it does not take long to answer this question. The easiest way to describe Electroporation is a beam of energy like a laser gun. ***"Under the influence of the electrical current, temporary pores created into the cell membrane enables the entry of nucleic acid in a cell, the process is referred to as electroporation."***

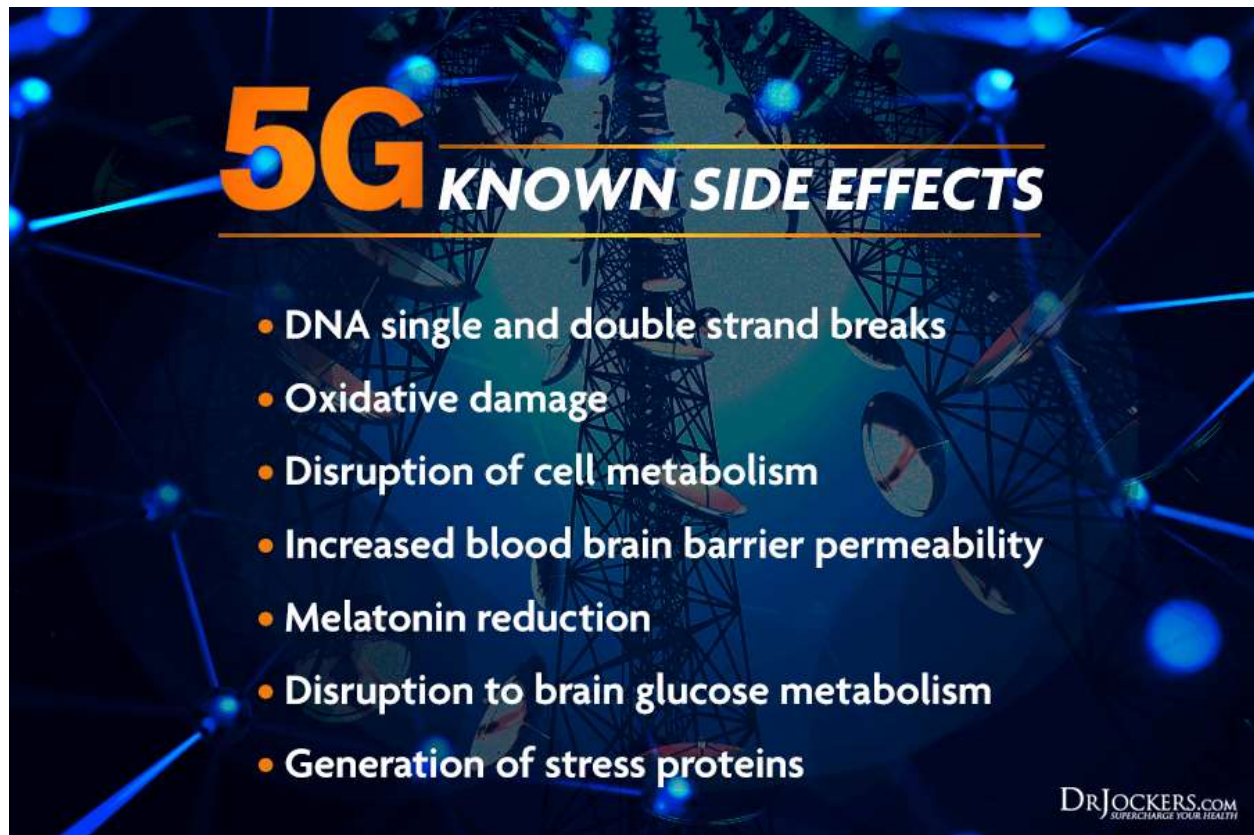
Apart from the nucleic acid, the present method is powerful enough to transfer chemicals and drugs into cells. Therefore, the electroporation technique is also known as electrotransfer.

Electropermeabilization is another name used to describe the present method, let me tell you why!

Electrical pulse performs two functions here, permeabilize cells and creates pores in the cell membrane as well. Both functions help in gene transfer.

Gene therapy is nowadays very popular for curing inherited genetic disorders. Broadly, a nucleic acid sequence of interest is inserted into the target genome using either viral or non-viral vectors.

The gene replaces the mutant gene in a target cell. In the final stage, the transformed cells are cultured in vitro.



What usually is required to transfer a gene into a cell?

A target gene DNA or nucleic acid, vector, target cell and a technique to insert nucleic acid into a cell.

The major focus here is on applications of electroporation in genetics. Hence we need to discuss the process of how foreign DNA or plasmid DNA can be transferred into cells using the electroporation. The entire process is invisible to the human eye! A perfect tool to meet the criteria of “Silent Weapons for Quiet Wars!”

Todd Callendar thinks it is a function of what frequency they are using. **5G** is just a range of different frequencies from (2-GHz – 500-GHz – they do different things.

The cell towers dotting the sky line have 3 MegaWatts of energy – enough to run a small city – they are beaming energy similar to what you cook food with and examples of birds and animals dropping dead from exposure. A MegaWatt = 1,000,000, or one million watts of power. Cell phones do not require this level of energy! In fact, a single cell phone signal uses 1 Watt of power to send a signal up to 25 miles. **5G** however is a different thing!

These waves do not travel far and are easily obstructed. Obstructions are the weak link to **5G**, which can include fog, dust, rain, snow, sleet, cloud cover, trees and other foliage. The need for orbital satellites becomes a vital element of the global coverage of **5G** satellites. Karen Kingston has called for the removal of the **5G** cell tower network.

We do not know what frequency the **5G** that comes from space is operating on. There are 28,000 satellites up there that cover every part of the planet. They blanket the Earth from Mid Earth Orbit (MEO) and there is no escaping that beaming power. For example, the Ukraine military had been using Elon Musk’s StarLink satellites to target Russian military targets in its war with Russia. Elon Musk a few days ago said he would not fund the StarLink system in the Ukraine and remove the Ukraine military to use the satellites to provide accurate targeting GPS coordinates. StarLink had 500,000 subscribers as of a few months ago. 12,000 satellite transmitters are planned with a potential of 42,000.

The more cell towers where you live increases the level of exposure to **5G** wireless energy. For example, where I reside, a rural farming/residential community, there are 10 towers and 52 antennas within a three-mile radius. Those living in large cities are infinitely more exposed to the combination of towers and antennas. A city like Dallas, TX has 237 towers and 2,540 antennas. Los Angeles, CA has 314 towers and 3,269 antennas. We are all being bathed 24/7/365 in 4G and **5G**.

You can check your area at the web site: <https://www.antennasearch.com> Click on the link and enter the address or area to find out what you face in terms of wireless energy EMF/EMR. All cell towers are fitted for both 4G and **5G** communications transmission. Every school district in the U.S. has one on its property. Early on a number of fire departments in California demanded the removal because of the effects experienced by fire department firemen and EMS people.

The whole point was to genetically modify people for the purpose of having them produce these synthetic proteins.

In the case of COVID vaxxes it was to have the body produce spike proteins.

After the 18-GHz it will be to produce other proteins, the M-protein which produce the same HIV proteins. When people who have had the shots produce these proteins, these synthetic pathogens they also will be shedding them on others through sexual activity, and close contact association with family members and co-workers.

MARBURGS HEMORRHAGIC FEVER

The vaccines were designed to be contagious in the words of Bill Gates. So when we look at the next disease we can already say what this will be. It is Marburg. How does he know that?

Because in 2020 the Marburg provisions of the U.S. Prep Act were already been put into action although theoretically, there is or were no Marburg's in the United States.

Marburg provisions were invoked in 2020's although there is no Marburg's in the USA – mandate to quarantine, test people for Marburg. Send out the 18-GHz signal which will induce the Marburg's that will act as the pretext to fill hospitals and.....

At some point the 18-GHz signal will be put out and this will produce the Marburg result and they will use this as a pretext to control and occupy the quarantine centers and the hospitals that have already murdered, according to his estimate 2 million or so Americans. That will skyrocket with the higher mortality rate of Marburg, i.e, Ebola. In Nigeria and other African states, the death rate was upward of 80%+. Marburg and Ebola are basically the same pathogen but with different names. A breakout occurred in 1967 of what was Ebola in the city of Marburg, Germany about a hundred miles north of Frankfurt, Germany.

THE HOSPITALS

Why does Todd mention the hospitals?

This is because he has put a lot of effort into getting people out of them.

In his research he soon discovered that in 2008 they merged hospitals, public health, law enforcement, judiciary corrections and brought them all under one roof.

Say someone goes to the hospital with a broken arm. They are given a mandatory COVID test which they repeat until they get a positive result. They are moved to a COVID ward where they are given Midazolam, (which is used in lethal injection drugs), which lowers the oxygen absorption of the lungs to about 70%.

That is used then to move them to bring ICU ward where remesdevir is added to the IV bag and inevitably they end up on the ventilator which are operating and transmitting on

the 60-GHz signal, the same one that separates the oxygen from the nitrogen – and so they die.

Todd's job has been to get people out of hospital and off the respirators; his success rate has been about 50%. Generally the hospitals refuse to release them (he has been told 'your client is going to die in hospital'), the police won't investigate but often arrest the loved ones trying to get their family members off the respirator. Hospitals are part of the law enforcement apparatus and the judiciary has been combined with public health and law enforcement.

We are in all three of these stages right now. Todd Callendar quotes a legal document from 2013 from the U.S. Supreme Court, the title of which I could not catch which states that:

"The court finds that use of mRNA in particular, creates intellectual property rights in the synthetic genomes they create"

It means that everyone who got the shot where mRNA converted their cells into producing spike proteins are now the chattel property of the patent holders.

He refers back to NASA and DARPA documents dating back to 2001 that talk about hybrid humans that they will own and operate **This is an extinction level event whereby the owners are going to decide who is going to live and who is going to die.**

Genocide is the taking of human life but these people are no longer homo sapiens and so have no human rights as such.

They have found their way around the law in the same way as experimenting with human mice. If you are new to all this and it all sounds like science fiction backed up by nothing consider this.

These are the words of Klaus Schwab's deputy, Yuval Harari. He has been quite prominent in his remarks in the media that the world does not need all these people and they need to be eliminated. So to confirm their agenda, just listen to their own words, like *"you will own nothing and be happy about it."*

This was followed by a Q & A fairly random assortment of questions..

People turn up at airports with faked vaccine passports and they already know they are not vaccinated and it's a forgery. This comes by the fact that vaxxed people will scan purple under specific light analysis, showing one is vaxxed or not.

They did mass spectroscopy and found components (including a compound called luciferase) which indicate that they can determine if someone has had the shot which gets around the problem of faked vaccine passports. Luciferase glows at the epidermas skin tissue exposing those who are not vaxxed.

Mass spectroscopy indicates they did not include graphene oxide in the shots but introduced all the base compounds needed for the body to produce graphene oxide. The EMF from cellphones will lead to a 300% increase in graphene hydroxide. I recall it was a German chemist who exposed this information and it was a day after he had appeared on a German or Swiss video he was summarily executed.

All they have to do is put the base compounds into the shot, expose it to **5G** EMF and those people grow graphene dioxide in their bodies.

Todd Callendar talks about the mortician who couldn't get the embalming fluid inside the cadavers and he cut open the veins and found these long sheets in the veins – this is the self-replicating process of the graphene dioxide.

Because these vaccines are under investigation they can change the ingredients without telling the authorities – designed to test various components. There are 8-9 different patents so it seems that people are receiving different batches.

Pfizer and Moderna do not have to tell us what it is they are testing under proprietary technology, yet they have no modesty about expecting the public to take their toxic pathogens.

In Germany there is no need for any labelling or to keep any batches for any future investigation. The pretext for this is to make things more efficient and speed things up.

Cominarty was approved a full year before it was approved in the USA but it was not available on the market. They are in reality experiments with no evidence of safety or efficacy.

All the main vaccines have lipo nano-particles (also called hydrogels) in them – and they all share the same HIV adjuvant (and this includes Sputnik).

Polyethylene glycol picked up in all the main vaccines. Mass spectroscopy showed Moderna and Pfizer have the same ingredients but in different proportions. What was different was the programming RNA and anti-virus DNA to program the body. We have no clue what pathogens are in the lipo nanoparticles – some will show up as Ebola, Marburg or as COVID – we do not know.

Johnson and Johnson and Astra Zenica use synthetic DNA whereas Pfizer and Moderna use mRNA but otherwise they are basically the same. **Unless they received a placebo everyone is in danger – they all have AIDS.**

There are two elements of causation – the aim is the destruction of the immune system and constant software upgrades are necessary. The hardware has already been implemented, people are made of graphene dioxide – this is the mainframe.

People will need monthly shots to:

- a) stay alive,
- b) receive their software upgrades.

These people do not care about human life, in fact they hate us – they want us gone or as slaves.

The Bank of International Settlements already own the world's money supply, they own the food supply, the water supply, the electricity supply and they want to genetically modify all of Life. Super-soldier program

Todd Callendar discussed the Chinese and North Korean government experimental AI gene editing program. They have been doing human gene modification since at least 2005. Informed consent as in the Nuremburg Protocol is gone and all they have to do is to inform people what they are doing. It is already being done by North Korea turning soldiers into something very durable.

There is research showing they can download information directly into the brain.

Graphene is very conductive – if someone with graphene receives a signal of 2 GHz they are able to produce a 1 Terra Byte signal outbound, they become a human battery (Bill Gates holds a patent on this) – they become electricity generators.

They become sources of intelligence – everything they see, and hear becomes connected through the bio-net of things every other person and to every cellphone tower connected via the Cloud. They become bio machines that become capable of detecting everything, sound, touch etc.

Graphene is the most durable substance on the planet so when you see Kim Jun-Un's soldiers become extraordinarily robust from this is in the graphene. You cannot even puncture graphene at the single molecular level.

Graphene is self-assembling when an electrical current is added it naturally self-assembles into an electrical circuit. This is where CRISPR gene editing comes into play. Videos on the internet exist showing how this self-assembling of circuits occurs.

CRISPR technology – gene deletion program. One adverse effect that came out of the Pfizer FOIA 1P6 gene deletion – a congenital disease that leads to loss of cerebral cortex – the only way to get this is if there is gene deletion in the body.

My interest originated with holding out hope for a cure which never came during my first wife's time here on earth. However, my interest never waned and since 2012, I have purchase many books on CRISPR-Cas9 gene editing. Few people are aware of the potential uses of this technology, both for good and evil. Those who have been obsessed with "Depopulation" know-well what it can do in secrecy and humanity is wearing a bull's eye on their back.



Michael Nevradakis, Ph.D. days ago commented about CRISPR on Robert Kennedy Jr.’s Children’s Defense Fund web page. It is well worth reading and so I share it just below.

Exclusive: CRISPR Technology Is a ‘Recipe for Disaster’ — Not a Solution for World Hunger

Bill Gates, the World Economic Forum and Silicon Valley investors routinely tout CRISPR gene-editing technology as the solution to global food security, but scientists told *‘The Defender’* there are better — and safer — ways to produce enough food for everyone.



Bill Gates, the World Economic Forum (WEF), Silicon Valley investors and others routinely tout gene editing — specifically, [CRISPR technology](#) — as the solution to global food security.

But some scientists — including two who spoke with [The Defender](#) — are critical of the technology which, they said, carries known and unknown risks. And besides, they said, there are better and safer ways to produce enough food for everyone.

Claire Robinson, managing editor of [GMWatch](#), criticized pro-GE (genetic engineering) scientists, government authorities and a “compliant media” that “mislead people about the level of complexity and risk involved in gene editing, never mind attempts to pretend it is not even a form of genetic modification.”

Dr. Michael Antoniou, head of the Gene Expression and Therapy Group at King’s College London, said CRISPR brings “nothing useful at all” to agriculture.

“There’s been a lot reported in terms of gene editing of food crops,” Antoniou said. “But I would say every one of those is a complete and utter waste of time because it hasn’t done the consumer any good whatsoever.”

Despite the risks and questionable benefits cited by Robinson and Antoniou, Bill Gates, the WEF and major chemical manufacturers who hold multiple CRISPR patents continue to heavily invest in the technology while lobbying to weaken or eliminate regulatory controls.

‘GMO free-for-all,’ ‘recipe for disaster’ that can cause ‘unintended DNA damage’
[CRISPR](#) — which stands for **Clustered Regularly Interspaced Short Palindromic Repeats** — acts as a “precise pair of molecular scissors that can [cut a target DNA sequence](#), directed by a customizable guide.”

Put differently, this technology allows scientists to [edit sections of DNA](#) by “snipping” specific portions of it and replacing them with new segments. Gene editing is not a new concept, but CRISPR technology is viewed as being cheaper and more accurate.

The issue for Robinson is that CRISPR is far from a “precision” technology.

“I think the thing to remember with gene editing, like all forms of genetic modification, is that it can have unintended effects in terms of plants,” Robinson said. “We’re worried about unexpected toxins or allergens. Plants are naturally very good at producing their own toxins, but with conventional breeding, you know what to look for.”

She added:

“CRISPR doesn’t only cut the DNA at the intended cut point at that intended sequence, because there will be other sequences in the genome that are very similar to that target sequence. So it can also cut out other places where you don’t want it to cut. And it can also have all kinds of knock on effects ... in terms of DNA damage that it causes to the genome.”

“And the worry is with these unintended damages to the genome, in the case of gene-edited plants, the worry is that this will change the composition of the plant and it could become unexpectedly toxic or allergenic.”

The same is true with regard to the gene editing of animals, according to Robinson:

“These were also risks with the old style GMOs [genetically modified organisms], and they are still risks with these gene-edited GM plants with animals.”

“The risks, if you’re gene editing them ... are that there will be knock-on effects on the animals, welfare or health that we can’t anticipate, such as deformities or changes in the function of certain genes in the animal.”

Antoniou agreed, stating that, *“innately, gene editing also can bring about unintended DNA damage ... even at the site of your intended edit or elsewhere in the DNA of your target cells, with unknown downstream consequences.”*

Antoniou, Robinson and other scientists warn that CRISPR is not the miracle technology its promoters portray it as.

Antoniou told The Defender:

“We should not fall into this trap of — either in a medical context or in the agricultural context — that somehow manipulating genes is the solution to all of our problems. We need to look at a situation and see where the gene defect is the problem. Then we can go in and try to solve it.”

“But in the majority of cases that isn’t true, and then we need to look at the root cause, which is non-genetic.”

Using cancer as an example, Antoniou said, *“It does have a faulty gene function at its basis,”* but *“the cause of the cancer was not what caused the genetic damage that caused the cancer in the first place.”*

Instead, exposure to toxic chemicals and pollutants in the environment and food *“are the root causes ... of the chronic disease epidemic.”*

In an online campaign, the [Institute for Responsible Technology](#) shares this view, arguing that gene editing *“threatens our food and the genetic integrity of all living things,”* adding that it *“is cheap, easy, prone to side effects, poorly regulated, and can permanently alter nature’s gene pool — a recipe for disaster.”*

What this means, according to the campaign, is that *“new GMOs can be deployed without safety assessments of any kind.”*

The campaign also warns that because CRISPR technology is “*cheap and easily accessible,*” it may lead to a vast amount of new GMOs in the next 25 years wherein “*even organic and non-GMO certified products could eventually be overrun,*” in a “*GMO free-for-all.*”

‘Just because something looks like a tomato doesn’t mean that it is’

A report published in the [Journal of Genetics and Genomics](#) in 2020 found that CRISPR gene-editing in rice resulted in numerous unintended and undesirable on-target and off-target mutations.

Antoniou described this as “*a grave oversight, because we know that gene editing is not precise ... the evidence is there to show that you will always have unintended DNA damage in addition to what you want ... a whole spectrum of unintended DNA damage that accumulates at the multiple steps of the gene editing process.*”

“*If you don’t take this into account, as is happening at the moment,*” said Antoniou, “*you will launch a product that could have marked changes in its biochemistry and therefore composition. And included in that chain-altered composition could be the unintended production of toxins and allergens,*” including in food crops.

Both Robinson and Antoniou raised ethical concerns regarding CRISPR, with Robinson saying “*These unexpected effects of CRISPR are very well recognized. They’re written about in the scientific literature ... Scientists know that these things are not ready yet to go into clinical trials. On the whole, they’re certainly not ready to be used on patients.*”

“*So, in the medical field, these problems are acknowledged widely,*” continued Robinson, “*but in the field of agricultural gene editing, there’s a lot of lies ... claiming precision, predictability, safety, when not only is the evidence not there for those things, but also the existing evidence suggests that there’s a lot to be concerned about.*”

“*They ignore this as ... ‘oh, well, you see this tomato, it grows like a tomato, it looks like a tomato, tastes like a tomato, therefore there’s nothing wrong with it.’ But I’m sorry, no. Just because something looks like a tomato doesn’t mean that it is,*” added Antoniou.

‘Powerful lobby’ vying to exempt gene-edited plants and animals from regulation

According to Robinson, there’s “*a very powerful lobby*” arguing gene-edited plants and animals should be exempted from the regulations that govern GMOs — and that could lead to “*no safety testing, pre-market safety testing, no GMO labeling, and there’d be no traceability.*”

“*You’ll find a lot of lies are told about gene editing by its proponents,*” Robinson said. “*They’ll say, ‘oh, we don’t insert foreign genes.’ That’s incorrect. CRISPR can be used not only to deliberately insert foreign genes, but it can also inadvertently result in the insertion of foreign genetic material during the gene editing process because it’s not completely controlled.*”

As a result, Robinson said, *“If something did go wrong, we would not be able to trace the cause of it, because that gene-edited plant would not be labeled as a GMO and there may not be any record of it being a GMO.”*

Antoniou said that *“none of these products”* and *“none of these crops and their products have been tested properly.”*

He added, *“I’m not saying the products that have been developed so far are harmful. The reason I can’t say that is actually because the work hasn’t been done.”*

For Antoniou, the proponents of CRISPR are demonstrating *“sheer arrogance.”* He said that *“they are so completely sure of the so-called prediction predictability and therefore safety of their product that they become ... incredibly complacent and they’re simply not prepared to do what, for me, the science says you ought to do — which is a thorough characterization, health risk assessment and environmental risk assessment.”*

It’s all about corporate control of the food supply

The same powerful lobby that’s fighting regulation is also contributing to the high cost of CRISPR technology, primarily through patents.

Many [CRISPR patents](#) are owned by [Corteva Agriscience](#), a conglomerate formed via the merger of Dow AgroSciences and DuPont/Pioneer.

“The technology is patented, the products are patented. Therefore, it is all about increasing corporate control of the food supply,” said Robinson. *“We all know that Gates is into what I would call ‘closed-source technology’ — patented technology that is not free to use but is owned.”*

“What we want to avoid,” said Robinson, *“is a situation where the food supply ends up entirely patented, owned by big corporations ... The patents on CRISPR are mostly owned by Corteva. Another patent owner used to be Monsanto, now owned by Bayer.”*

According to Antoniou, because Corteva holds the patent rights to the CRISPR applications in agriculture, anyone else who wants to come in *“has to first take out a license from them in order to develop and, more importantly, to then market a product. Then there will be massive fees to be paid back, no doubt, to Corteva.”*

This means, Robinson said, *“that if a farmer wanted to plant a seed or we want to eat a food, we are paying somewhere along the line ... you can see where this is going: increased consolidation of the food supply and the seed supply ... We will basically be told what kind of food they want us to eat,”* including [lab-grown meat](#) and dairy.

Antoniou told ‘The Defender’:

“And so we have both small and large companies trying to gene edit key food crops ... for things that clearly they believe will bring them money ... The patents give you control

and therefore you can charge what you want, you can dictate what farmers grow, and you can dictate what the public eats”.

“It’s nothing to do with feeding the world. It’s nothing to do with generating wonder crops to face the challenges of climate change. It’s got nothing to do with ... high yields and so on. It’s all got to do with controlling the food supply and making money, and that is for me, just totally and utterly immoral.”

Robinson agreed. *“It’s amazing how many promotions of gene-editing technology in agriculture start with this idea that we don’t produce enough food and there’s a shortage of food, and therefore we’re going to have to use gene editing to kind of boost agricultural production,”* she said.

But this line of thinking is *“nonsense on many levels,”* Robinson said, adding:

“There’s no shortage of food in the world. Even in those countries where there are terrible hunger problems, they are producing food and it is available for those to buy if you have money.”

“But the problem with hunger is, of course, poverty. The failure of infrastructure, the fact that you cannot get the food to the hungry people. But mostly it’s inequality, things like wars and conflicts that are going on in some countries that mean that supply chains are disrupted. So really, there is no shortage of food and there isn’t ever likely to be.”

Gates, WEF, Silicon Valley ‘obsessed’ with CRISPR

Robinson said she isn’t surprised the WEF is interested in CRISPR technology, adding: *“I’m not an expert on the WEF, but I know that they’re extremely keen on all these things like bioreactor technology, GM — technological fixes to our agricultural problems and food problems.”*

“They’re very into corporate control of just about everything. So, yes, we need to be careful of how that agenda is being promoted.”

CRISPR is also *“an obsession of Silicon Valley,”* according to Robinson, and *“of some very wealthy investors ... that we’re all going to be eating lab-grown meat and dairy.”*

But Robinson said this is a *“pipe dream, because the energy costs and the resource costs of bioreactor technologies are actually huge, and it simply won’t be possible, especially in a climate of rising energy bills ... It simply won’t be possible to feed thousands or millions of people on the products of these technologies.”*

Antoniou told *‘The Defender’*, *“Bill Gates has bought into [CRISPR] bigtime and increasingly, because he’s been a staunch advocate of genetic modification of crops for decades now ... because of his staunch belief in technological fixes to everything, I’m not surprised that now he’s bought into the gene editing sector as well.”*

Describing Gates' efforts to introduce [GMO crops in Africa](#) as “complete failures,” he added that “not a single genetically modified crop has contributed positively to the livelihood of peoples in Africa, and in many cases it's gone the other way around.”

Robinson, in turn, described Gates as “a real enthusiast for GMOs,” adding that “he puts far more money into gene-editing solutions than he does into conventional breeding, though the latter has been very successful and very cheap in comparison.”

This may explain why Gates is purchasing farmland in large quantities, said Robinson, in a trend she described as “worrying”.

“I think that's an incredibly worrying trend. He's buying up farmland ... and increasingly big corporations are also buying up farmland all over the world.”

“This means basically that they extend their control over the food supply because the person who owns the land gets to decide what is done on that land, [including] if they decide they only want to grow genetically modified crops and that all crops that will be grown will be GM.”

The Daily Mail, quoting the Associated Press, has noted [Gates is considered the largest private owner of farmland](#) in the U.S., having “quietly amassed” close to [270,000 acres](#).

And in India, [Monsanto](#) — in which Gates had long been a major shareholder — hired famous Indian actor [Nana Petakar](#), as its “brand ambassador” to promote [genetically engineered cotton seed](#).

Farmers in India were encouraged to use the seeds, which in many cases appear to have produced smaller-than-promised yields. The farmers frequently incurred significant debts, resulting in a massive wave of suicides. As of 2014, more than 270,000 farmers had reportedly [committed suicide](#) as a direct consequence.

Gates also is on record saying, “All rich countries should move to [100% synthetic beef](#).” Robinson said she suspects Gates may also be interested in CRISPR technology for its potential to edit human genes:

“I suspect he's also looking at the possibility of gene editing with CRISPR humans, which is something that's going to be coming up increasingly.”

“There is this idea that you should gene edit human beings so that they don't inherit genetic diseases. But we also have to look at the possibility that some actors will be looking to gene editing [of] humans for certain traits.”

Robinson said this would “commodify the genetic material of human beings,” and could include “things like height, intelligence, skin color, eye color, athleticism and so forth” that would be “marketable traits to the general public” — even if the technology “won't be accessible to very many people.”

Such concerns are not theoretical. In 2018, Chinese biophysicist He Jiankui announced the creation of the world's first [gene-edited babies](#), via editing DNA in human embryos.

For this, Jiankui was sentenced to three years in prison and fined 3 million yuan (\$560,000) for practicing medicine without a license, violating regulations on human-assisted reproductive technology and fabricating ethics review documents. This also led to international calls for a moratorium on what is known as [human germline editing](#).

This concluded the article posted on *'The Defender'* concerning the excitement of CRISPR technology.
