The lower portion of the image is the forecasted population for 2025. It forecasted a U.S. population of 100-million for 2025. This is a reduction of 227-million and all of us who regularly monitored this web page were scratching our heads wondering why and what for were the reasons for this posting. As I stated, in the near distance past, it was removed completely from view.

It becomes relevant when we take into consideration the events since the WHO declared a pandemic on March 10/11th of 2020. Yesterday, October 19, 2022, the CDC voted 15-0 to mandate that all children now have to receive the Covid poison added to the Schedule of Immunization shots in order to attend public school. By doing so the CDC has ensured exemption for the pharmaceutical industry from being sued by the families of children that may be damaged as a result of being required to take these “gene” therapy shots. You the taxpayer will end up paying the damages out of a federal fund to handle law suits. The government has paid out over \$5-billion for damaged children from all the other 72 required vaccines needed to attend public school.

COVID 19 was reportedly responsible for **1,304** deaths from individuals 0-17 years of age according to [Statista.com](https://www.statista.com/statistics/1101117/covid-19-deaths-us-children/). This accounts for 00.1% of ALL COVID deaths in the United States. It’s worth noting that 0-17 is a sample size double the other groups which are spread out among 9 year increments.

It’s also worth noting that is 00.1% of **deaths**, not cases. Also according to [Statista](https://www.statista.com/statistics/1101117/covid-19-deaths-us-children/), the US has reported 15.2 million cases in children under 18. This would suggest a mortality rate of **00.0085%** amongst 0-17 year old children. This is criminal to the core - a case of pre-medicated murder.

They want our children dead, sterilized or incapacitated. Their option is to forcibly “vaccinate” our children in order to attend government sponsored state indoctrination centers currently known as “schools”.

They want civil war and although the government has already mobilized against the people who represent true America, they will try to make it look as if we are the “domestic terrorists” as they destroy absolutely everything that is America.

Hal Turner reported on 10/19/22 that Russia has destroyed the satellite uplink Earth-station of the communications center of Ukraine. This information becomes valuable in

our understanding of the **5G** satellite network that is blanketing the globe. Its significance will become clear somewhat later in this study for many reasons.

To destroy it, a special operation was organized by the Russian Army. After first pinpointing its location, it was hit using high-precision weapons.

The destruction of this earth station - at least for the time being - has totally shut down Ukraine's secure government communications network, and has stopped the flow of NATO intelligence to Ukraine's government distribution network. Military planners are no longer able to get real-time intelligence via space satellite communications with NATO!

This creates extremely serious problems for the Ukrainian government to organize operations and secure communications. In simple words, it means the Ukraine cannot use the **5G** system to target Russian assets through the use of GPS satellite positioning. **5G** in modern warfare has replaced the old system of "forward observers" to sight and provide fire direction control to an army.

"In the area of Palievka settlement, Odesa region, the communications space station of the Government Communications Center of Ukraine was destroyed," the Ministry of Defense of the Russian Federation said during a routine briefing.

According to the Russians, the consequences of the impact will be seen after the last pass by the Sentinel-2 and World View spacecraft.

Intelligence community information is that the earth station was fully outfitted with NATO secure communications gear, and all NATO targeting data passed to the Kiev regime through this center. Its destruction is a massive blow to the Ukrainians.

The International Commission on the Biological Effects of Electromagnetic Fields (ICBE-EMF), authors of a recent scientific study, have confirmed that the U.S. Federal Communications Commission (FCC) and the International Commission on Nonionizing Radiation Protection (ICNIRP) wireless exposure guideline, based on science from the 1980's, is wrong and needs to be revised.

According to the researchers, the current RFR [radiofrequency radiation] exposure limits do not consider potential synergistic effects that reflect modern day exposures to multiple environmental agents. Current guidelines also do not consider duration of exposure to RFR.

Adverse health effects at exposures far below the threshold dose claimed by these agencies, are well documented in scientific studies that according to Dr. Ronald Melnick, *"have demonstrated oxidative effects associated with exposure to low-intensity RFR [radiofrequency radiation], and significant adverse effects including cardiomyopathy, carcinogenicity, DNA damage, neurological disorders, increased permeability of the blood-brain barrier, and sperm damage."*

In order to understand the magnitude of the **5G** issue it becomes necessary to study the entire scam used to create a diversion to all the **5G** issues mentioned in the [ICBE-EMF](#) statement above.

The “*Diamond Princess*” is the Petri dish proof for 15 deaths and 705 infections during the near-month-long sequestering at sea of the “*Diamond Princess*.” The “*Diamond Princess*” was the first cruise ship equipped with the latest MedallionNet “Best Wi-Fi at Sea”. Twenty MEO (Mid Earth Orbit) **5G** satellites orbiting the equator provide global coverage for the *Princess Line* cruise ships. The passengers who died were all in their 70s and 80s, with the exception of one in his 60s. [A related data point is that 80% of the deaths and adverse reactions from Covid vaxxes are among those over 60 years of age.] More at the end of this segment of the **5G** trap springing shut!

The telecoms have an investment of billions of dollars with a potential “Return on Investment” that will conservatively yield \$17-trillion in profits. This huge potential for profits becomes the major reason for the lies and deception obfuscating the story of a virus that came from bats in China. The truth is viruses do not naturally jump species from animals to humans. They first have to be genetically altered through “gain-of-function” using a germ line process and subsequently injected into humans.

Some frequencies will cure (as in Rife frequencies); others will kill you. Rife machine works on the principle of ‘sympathetic resonance’, which states that if there are two similar objects and one of them is vibrating, the other will begin to vibrate as well, even if they are not touching.

Basically, if you can mimic the quantum frequency of a cell or an atom, you cause it to vibrate. This will work with sound waves as well and may best be demonstrated when an opera singer hits the frequency of crystal, causing a glass to shatter. Have the atoms in the crystal changed in any way? NO, they just vibrated and were unable to remain in their current shape. The STATE of atomic structure was unaltered; the EFFECT on the atomic structure was simply mechanical. In the same way that a sound wave can induce resonance in a crystal glass and ultra-sound can be used to break up kidney stones, a Rife machine uses sympathetic resonance to physically vibrate offending cancer cells, bacteria, viruses and parasites resulting in their destruction and elimination from the body by causing them to vibrate, stimulating an immune response against them.

Rife is non-invasive in the sense that the skin is not broken and there is no damage to normal, healthy tissues and cells etc. The frequencies and voltages are purposely in the range that only are harmful to cancer cells, bacteria, viruses, parasites, etc., and not healthy tissue or gut bacteria. Rife is non-toxic (little or no side effects other than the standard kill-off effect, i.e. “Herxheimer reaction”, caused by any modality that destroys pathogens and necessitates the body having to clean up and detoxify the mess. This is a well-known and documented effect of any treatment that actually works. It has no ionizing radiation and so cannot cause damage to tissue, the immune system, DNA breakage, etc.)

Llewellyn H. Rockwell, Jr. wrote a piece on his Rockwell Report this past July 25th, 2022 that adds to our evidence that suggests our government has nefarious reasons for pushing the Covid vaccines; The Covid vaccine kills people and the government knows it. This is hardly a secret, and the question naturally arises, why are people pushing the vaccine on us? Why are they pushing this deadly drug on small children? Answering this question takes us to the root of the dark forces controlling the world.

It's clear that those who push the vaccine know about its lethal effects. As Dr. Naomi Wolf points out, *"I've been silent for some weeks. Forgive me."*

The truth is: *"I've been rendered almost speechless — or the literary equivalent of that — because recently I've had the unenviable task of trying to announce to the world that indeed, a genocide — or what I've called, clumsily but urgently, a 'baby die-off' — is underway."*

The 'WarRoom/DailyClout' Pfizer Documents Research Volunteers, a group of 3000 highly credentialed doctors, RNs, biostatisticians, medical fraud investigators, lab clinicians and research scientists, have been turning out report after report, as you may know, to tell the world what is in the 55,000 internal Pfizer documents which the FDA had asked a court to keep under wraps for 75 years. By court order, these documents were forcibly disclosed. And our experts are serving humanity by reading through these documents and explaining them in lay terms. The lies revealed are stunning.

The WarRoom/DailyClout Volunteers have confirmed: that Pfizer (and thus the FDA) knew by December 2020 that the MRNA vaccines did not work — that they 'waned in efficacy' and presented 'vaccine failure.' One side effect of getting vaccinated, as they knew by one month after the mass 2020 rollout, was 'COVID itself.'

Pfizer knew in May of 2021 that 35 minors' hearts had been damaged a week after MRNA injection — but the FDA rolled out the EUA for teens a month later anyway, and parents did not get a press release from the U.S. government about heart harms until August of 2021, after thousands of teens were vaccinated.

Pfizer (and thus the FDA; many of the documents say **"FDA: CONFIDENTIAL"** at the lower boundary) knew that, contrary to what the highly paid spokesmodels and bought-off physicians were assuring people, the MRNA, spike protein and lipid nanoparticles did not stay in the injection site in the deltoid, but rather went, within 48 hours, into the bloodstream, from there to lodge in the liver, spleen, adrenals, lymph nodes, and, if you are a woman, in the ovaries.

Pfizer (and thus the FDA) knew that the Moderna vaccine had 100 mcg of MRNA, lipid nano-particles and spike protein, which was more than three times the 30 mcg of the adult Pfizer dose; the company's internal documents show a higher rate of adverse events with the 100 mcg dose, so they stopped experimenting with that amount internally due to its 'reactogenicity' — Pfizer's words — but no one told all of the millions of Americans who all got the first and second 100 mcg Moderna dose, *and the boosters.*

Pfizer skewed the trial subjects so that almost three quarters were female — a gender that is less prone to cardiac damage. Pfizer *lost* the records of what became of hundreds of their trial subjects.

In the internal trials, there were over 42,000 adverse events and more than 1,200 people died. Four of the people who died, *died on the day they were injected*.

Adverse events tallied up in the internal Pfizer documents are completely different from those reported on the CDC website or announced by corrupted physicians and medical organizations and hospitals. These include vast columns of joint pain, muscle pain (myalgia), masses of neurological effects include MS, Guillain Barre and Bell's Palsy, encephaly, every iteration possible of blood clotting, thrombocytopenia at scale, strokes, hemorrhages, and many kinds of ruptures of membranes throughout the human body. The side effects about which Pfizer and the FDA knew but you did not, include blistering problems, rashes, shingles, and herpetic conditions (indeed, a range of blistering conditions oddly foreshadowing the symptoms of monkeypox).

The internal documents show that Pfizer (and thus the FDA) knew that angry red welts or hives were a common reaction to the PEG, a petroleum-derived allergen in the vaccine ingredients — one that you are certainly not supposed to ingest. Indeed, PEG is an allergen so severe that many people can go into anaphylactic shock if they are exposed to it. But people with a PEG allergy were not warned away from the vaccines or even carefully watched by their doctors, EpiPen in hand. They were left to their shock. Dr. Sherri Tenpenny was reporting the danger issue of PEG as early as the fall of 2020.

Pfizer knew that 'exposure' to the vaccine was defined — in their own words — as sexual contact (especially at time of conception), skin contact, inhalation or lactation.. 'Fact-checkers' can deny this all they want but the documents speak for themselves.

Of course, people who have tried to raise any of these issues have been de-platformed, scolded by the President, called insane, and roundly punished.

Athletes and college students and teenagers are collapsing on football and soccer fields. Doctors wring their hands and express mystification. But BioNTech's SEC filing shows a fact about which the CDC and the AMA breathe not a word: [fainting so violently that you may hurt yourself is one of the side effects important enough for BioNTech to highlight to the SEC.](#)

But why are the forces of evil doing these terrible things to us? Paul Craig Roberts has some important things to say on this topic: *"The medical and scientific evidence is completely clear that the entire Covid narrative is counterfactual and that the authorities know it. Yet they still push, using coercion, for more vaccination."*

Vaccination does not protect. It harms. So the only reason to enforce it is to kill people. The inability of people to distrust 'authorities' and the inability of people to inform

themselves and to think for themselves guarantees that millions will die from being vaccinated. When you see thousands of independent doctors and medical scientists damning the vaccine only to be ignored by bureaucratic 'public health' organizations, you have clear evidence that real authority is not speaking. It is being suppressed.

Anytime debate and information is suppressed, you know that something is being hidden and that a secret agenda is operating.

The orchestrated 'Covid pandemic' is a massive crime against humanity. Are we going to allow them to get away with it? Or will there be too few of us left to do anything about it?

In the Addendum it was reported:

An expert pointed out to me that clearly medical authorities do not mind if the vaccine is killing people, and the deaths are consistent with the Bill Gates/World Economic Forum intent to reduce the world population. However, an intermediate goal is to transition to the vaccine passport as in Germany, Austria, Italy, Greece, and with France, Belgium and the Netherlands about to join in the requirement of a digital ID that allows tracking of everyone and every interaction and, thereby, control of the population with rewards and punishments like the Chinese Social Credit System. This allows the [controlled populations to be scapegoated for the mayhem caused by depopulation](#).

This is a reasonable explanation for the emphasis on Covid passports. As it is known and admitted that the vaccine is inefficient as a protection against the virus, and as the virus is dangerous mainly to untreated patients with comorbidities, the passport is pointless for any purpose other than control. The passport provides no protection whatsoever against the spread of the virus and the immune system's attack on the body's vital organs.

I'd like to follow up on the key to the whole operation. The dark forces that aim to kill much of the world's population had their agenda in place long before the alleged Covid "pandemic." As Brandon Smith pointed out in an article written a couple of months before Covid became an issue, *"Population control has also been brought up consistently as an issue in the 2020 Presidential Election race. Bernie Sanders [argued for birth control](#) measures in poor countries. Elizabeth Warren promoted abortion by saying it was as safe as ['getting your tonsils removed'](#). She has consistently promoted the carbon control agenda of the UN and was, interestingly, a member of the University Of Texas Population research Center in the 1980s. And, Green New Deal politicians are [throwing their support](#) behind the statements from the Worthy Garden Club on population reduction."*

This is the first time I have seen the argument for population reduction used so blatantly and widespread in the mainstream media, and it suggests to me that a trend is forming. For years I have warned my readers that they will know when the globalists are about to pull the plug on the current system when they start talking about their criminality openly. When they admit to their agenda in a free way, this means they are close to a global

reset and do not care anymore who knows about it. The openness of the plan to cut world population is becoming apparent.

Strangely, there has been little mention of the fact that the world population, in the west most of all, [is actually in decline](#). Far from exploding beyond the Earth's capacity, people are barely having enough children to keep the current population stable. It would appear that the globalist agenda is already in motion. Through engineered economic disintegration, the population is being slowly reduced. However, this slow decline may not be enough to satisfy the globalists.

How many people would the globalists like to kill off to achieve their utopian aspirations? Well, globalist Ted Turner in a moment of honesty said when confronted by [We Are Change](#) that the population should be reduced to 2 billion down from 7 billion.

The primary issue here beyond the moral horror show of eugenics is, who gets cut? And furthermore, who gets to decide who gets cut? Who gets to decide if you can have children or not? Who gets to decide if you are allowed to access resources to produce and make a living or not? Who gets to decide if the global economy will sustain the population or not? Who pulls the trigger on the culling of the population?

As history has shown us, it is always the elites that end up in the position of deciding the fates of millions or billions. Karen Kingston joined Stew Peters a few days ago to discuss how she's discovered the whole lie behind COVID-19. She says, *"the greatest lie that we were told is that the "novel coronavirus"...COVID-19 was caused by the SARS-CoV-2 virus, this mRNA gain-of-function virus."*

"In Chemical Engineering News, they talk about this breakthrough lipid nanoparticle technology, because for over 30 years, mRNA was considered and SARS viruses were considered a lame duck invention.”

"There's also a publication from 2017 in Nature Biotechnology – and this is the real kicker, Stew – in that publication, of this peer-review publication of experts in mRNA technology, they state that no RNA viruses, including mRNA can ever infect ANY cell, because of the 4 billion-year evolutionary defense of the lipid bilayer.”

"It was always a lie that this virus could infect humans and be transmissible and I have all the documentation to prove it.” All lies to mislead the public and deceive us.

"So the question is, are the experts that are telling us this is transmissible – are we to trust them? Or are we going to trust the body of evidence that we're showing your viewers? We've been gaslit...”

"We've been gaslit and distracted by this concept of a coronavirus that's infectious and everyone that's come forward to validate the experts and the witnesses that you've had on your show saying, 'Hey, people are magnetic. People are having weird neurological and CNS dysfunctions.'

"We're looking underneath the microscope to see these self-assembling nanotechnologies. We're looking under the microscope of people who have been injected and their self-assembling nano-technologies and we're ignoring the evil, itself.”

"Why are we being gaslit about a virus that is clinically, statistically, evolutionarily and scientifically impossible to infect people and not talking about the Artificial Intelligence nano-weapon that's been unleashed on the American People?”

"And by the way, the spike protein is actually matches up with the CAD file – the Computer-Animated Design files – in three patents for a nano-weapon technology that is made from Artificial Intelligence magnetic hydrogels."

Stew then asks her if it's not a virus and it's not contagious, then how were people getting sick?

Karen responds, *"They were getting sick with an Artificial Intelligence nano-weapon...Let me explain what it is, first...If you go through the research for mRNA and Professor Catherine Whitehead from Carnegie-Mellon, head of chemical engineering she had said, 'Look, we can't do anything with mRNA technology.'"*

*We can't even do research *in vitro*, outside of the cells, in the labs, it's so unstable. We have to do the genetic editing technology of the technology inside the cells, inside the animals. mRNA can only be successful if the genetic editing is done by nano-technology inside the cells, inside the animals.'*

"So, what the spike protein is, is this lipid nano-particle; it's a [magnetized lipid nanoparticle](#), it's called an MPEG that has the CRISPR-Cas9 technology and something called a 'cubosome'. And the AI nano-weapon...looks just like the spike protein. And those spikes are actually probes that actually penetrate the cells."

"So, they look like cholesterol and per Ralph Baric's pitch to DARPA, per the patents, these can be delivered in an aerosol attack, they can be delivered through water, they can be delivered in food. And so what people were infected with was an Artificial Intelligent parasite."

Stew then asks her if this is why we saw all of those videos of people sticking magnets to meat in the grocery store.

"Yeah. So, it's in our food supply. People are sticking magnets to themselves. It's an AI nano-weapon and again, if you take a look at the peer-reviewed journals in nanotechnology and the peer-reviewed journals in vaccinology and viruses, you'll see that the technology for the lipid nanoparticles is the same as the spike protein. You'll also see it's the same as a military-grade bio-weapon or a nano-weapon and [James Giordano](#) has said, 'Look, we can use these lipid nanoparticles to infect people and cause disruptions in their emotions and their thoughts and behaviors. We can also induce a pandemic of strokes'."

"So this is what the nano-technology is. And maybe because it's so unbelievable, I think people really found validity in patents. Would it be OK if I went to one of the patents right now to explain exactly what this is? OK, so I'm going to go to this patent. It's one of three patents for the nano-weapon technology and it's called [Intelligent Sensor Platforms](#) and in the abstract, the viewers can see on the cover something similar to a spike protein image."

"So this invention is '...embodiments that are directed to self-adapting, scalable, and communicating sensor platforms that are further capable of autonomous and/or cognitive action. The invention relates to a multifunction sensor platform, such as a biomedical sensor platform, bio-molecular sensor platform, electronics sensor platform, communications sensor platform, information processing sensor platform, and the like. In another invention embodiment, one or more sensors improve the efficacy of a healthcare'."

"So this can be used as a bio-weapon and it can be used in healthcare. Now, as long as there's no FDA approval of a product under a pre-market application, a medical device does not need to be disclosed to the American People...That's why the August 23rd approval was so important. We could have changed the rules of warfare."

"But let's go through this patent to go through what people have been inoculated with. Essentially, the new AI nano-weapon is a new AI species. Those spike proteins are parasites. And those parasites do gene editing inside of you to spawn viruses, diseases, biosynthetic structures, as well as to host the development of these new species that are being developed."

"So, I'm going to read it from the patent. So, it says here: 'In one embodiment, the instant invention teaches one or more elements that in whole or in part execute one or more types of actions for creating, spawning, comprising modifying, repairing, regenerating, reassembling, and or control and regulation of one or more cells, cellular elements, cell organelles, including like action and behaviors involving cellular processes such as endocytosis (so things being exuded from cells), exocytosis (being extracted from cells, such as DNA), mitosis, trafficking and signaling (so completely controlling your cytokines, your signals of your immune system, the signals of your central nervous system, your nerve cells), communication between cells, receptor upregulation and downregulation, other behaviors, and the like'."

"So it truly is to completely control the body and now, we know COVID-19, there's all these CNS symptoms, fatigue, emotional disruption and that's because this does hijack the central nervous system. So, in one other section here, it says, 'In one invention embodiment, one or more elements, with or without additional elements, and in some embodiments with minimal functionalization, enter the central nervous system, including passing the blood brain barrier (BBB),'"

"Again, I warned the nations about this crossing the blood brain barrier in May of last year – on your show and July of last year – and that these were lipid nano-particle technologies that were meant to hijack the central nervous system. So here is one of the evil master patents that talks about that."

"An, now, this part's really important, as well. It says here, that, 'the invention enables post administration delivery of one or more types of agents into the Central Nervous System in 30 minutes or less.' So, you'll see sometimes when people get injected, there

was that nurse that was injected and you'll see them automatically go like this [put her head in her hand].”

"Well, that's because this AI nano-weapon is designed to hijack your central nervous system and go straight to your brain within less than 30 minutes. Some of the sequences that are in there are designed to do that."

"So when we were told that the vaccine contained the full mRNA sequence for SARS-CoV-2, we were under the assumption...[it was] this synthetically recreated virus that was encapsulated in the lipid nanoparticles. No! It's actually a computer sequence. It is a computer program sequence."

"So that's what this is. These are nano-technology...1/100th as small as a virus. So the masks don't do anything. Nothing does anything. A biohazard suit doesn't do anything...they can get through nearly anything."

Stew comments that these are biosynthetic parasites and that's why they were responding to ivermectin.

Karen replies, "Thank you for bringing that up, because I want people to have hope. This is not just technology. It's part technology, part biology. "The 5G towers are part of the energy source for this AI nano-weapon. This AI parasite. White House COVID-19 Response Coordinator Ashish Jha, FDA Commissioner Robert Califf, and CDC Director Rochelle Walensky, are now complicit in criminal intent to commit mass murder in the United States.

The Biden administration on Thursday extended the COVID-19 public health emergency through Jan. 11 despite the president's declaration last month that the pandemic was "over."

The extension to the public health emergency, which was first declared in January 2020, accompanies officials' warnings of a potential surge in infections over the winter.

Dr. Ashish Jha, the White House COVID-19 response coordinator, urged Americans to blunt the potential spike in infections by getting the updated COVID-19 vaccine, which targets dominant variants of the virus.

"If you are up to date with your vaccines and if you get treated, if you have a breakthrough infection, your risk of dying from COVID is now close to zero," he told reporters Tuesday.

The U.S. rolled out new booster shots that target the dominant omicron BA.5 subvariant in September. **Although there's no real-world data on their effectiveness yet**, Jha said they should provide a much higher degree of protection based on what scientists know about how the human immune system works.

The Centers for Disease Control and Prevention on Wednesday recommended the new omicron boosters for kids as young as age 5, allowing pharmacists to soon start administering the shots.

CDC Director Dr. Rochelle Walensky signed off on the shots just hours after the Food and Drug Administration authorized them. **Walensky made the swift decision without a meeting of the CDC's independent panel of vaccine experts.**

Children ages 5 to 11 are eligible for Pfizer's omicron shots and kids ages 6 through 17 are eligible for Moderna's shots two months after receiving their primary series or previous booster with the first generation vaccines.

The FDA, CDC, and White House could not have authorized these new versions of the experimental COVID-19 shots without extending the "Public Health Emergency" status which overrides laws and Constitutional protections that prohibit drug companies from injecting experimental products into the bodies of American adults and children.

There are numerous studies that show that the CDC actions are not justified, as shown in the one below that was posted on the Internet less than two weeks ago. It becomes more of the evidence line to negate the decisions of the CDC and its criminal director Dr. Rochelle Walensky.

In wrapping up this article, I take us back to the recent destruction of the Georgia Guidestones down in Elberton, GA. It speaks volumes of the Globalist plan to reduce humanity through so-called vaccines.

The Georgia Guidestones was a mysterious monument on which are carved ten "commandments" for a "New Age of Reason". The first commandment? Maintaining the world population under 500 million people. Ready for another sinister fact? The authors of what was called the American Stonehenge are still a "mystery." In this video we will look at the numerous features that defined this monument, its dark message calling for a New World Order, and explain why the occult secret society that built it decided that 2022 was the year to bring it down.

Upon on the granite slabs was written ten "commandments" or "guides" engraved in eight different world languages.

However, it was the very first guide that made the Guidestones so controversial:

The World Economic Forum, led by Klaus Schwab, have made clear their plans for humanity. Schwab's right-hand-man, Yuval Noah Harari, recently declared that the WEF considers the vast majority of the human population to be useless and obsolete.

Covid-19 vaccination is going to lead to mass depopulation.

One of the documents contained in the data dump is '[reissue 5.3.6 post marketing experience.pdf](#)'. Page 12 of the confidential document contains data on the use of the Pfizer Covid-19 injection in pregnancy and lactation.

Confidential Pfizer Documents reveal 90% of Covid Vaccinated Pregnant Women lost their Baby.

Pfizer state in the document that by 28th February 2021 there were 270 known cases of exposure to the mRNA injection during pregnancy.

Forty-six percent of the mothers (124) exposed to the Pfizer Covid-19 injection suffered an adverse reaction.

Of those 124 mothers suffering an adverse reaction, 49 were considered non-serious adverse reactions, whereas 75 were considered serious. This means 58% of the mothers who reported suffering adverse reactions suffered a serious adverse event ranging from uterine contraction to fetal death.

Everything that has occurred since 2012, when CRISPR technology was announced is full confirmation of what the UN Agenda 21 was calling for.

Agenda 21 is a 300-page global action plan written by the United Nations and signed by 179 countries in 1992. It is supported by all Western governments including Australia, Canada, Britain, France, Germany, Italy etc. Some refer to it as "*The New World Order*" or "*Sustainable Development*."

NOTE: Agenda 21 and Agenda 2030 are actually the same thing, the difference being the 2030 version just goes into a little more detail about its execution and adds 17 new sustainable development goals. Agenda 21 is intended to integrate currently existing international law, treaties, conventions and proposals into a single overarching framework agreement. This will allow all nations to be bound to this one system of rules in an attempt to create this one-

world system that will circumvent any current or future National Constitution, Law or Regulation.

In 2012, there was a massive wave of "sustainable" initiatives introduced at the local level all across America. It was overwhelming. Nobody understood what the hell it really meant. The agenda was being pushed by both Democrats and Republicans, while both were quick to blame each other for the movement. The truth is, it came from both sides.
