### Bill Gates Funded Digital Identity Based On Your Vaccination History

The level of technology today surpasses what most people can grasp or handle with any degree of understanding. If any of you saw the movie, 'The Manchurian Candidate', released way back in 1962, it will help one get a handle on what this is all about. The Manchurian Candidate was a 1962 American psychological political thriller film about the Cold War and sleeper agents.

The plot centers on the Korean War veteran Raymond Shaw, the progeny of a prominent political family. Shaw was a prisoner of war during the conflict in Korea and while being held was brainwashed by his captors. After his discharge back into civilian life, he becomes an unwitting assassin involved in an international communist conspiracy. Officials from China and the Soviet Union employ Shaw as a sleeper agent in an attempt to subvert and take over the United States government. The film was released in the fall of 1962, at the height of U.S.–Soviet hostility during the Cuban Missile Crisis. I remember it well as I was staying at the YMCA in Rochester, NY in search of housing since I had accepted a new position with Xerox Corp. I saw the movie twice during the week I was house hunting.

The movie was re-released around 2004 but I never bothered to see it. The CIA Project MK-ULTRA was scaled back extensively and then terminated in the late 1960s, and the CIA supposedly destroyed most of the program's records in 1973. A cache of surviving documents relating to the agency's "mind control" program was eventually discovered and revealed to the public in 1977, but the full extent of the government's psychedelic experimentation remains uncertain.

LSD was first made by Albert Hofmann in 1938 from lysergic acid, a chemical from the fungus ergot. Hofmann discovered its hallucinogenic properties in 1943. In the 1950s, the Central Intelligence Agency (CIA) believed that the drug might be useful for mind control, so they tested it on people, some without their knowledge, in a program called MKUltra. LSD was sold as a medication for research purposes under the trade-name Delysid in the 1950s and 1960s. It was listed as a schedule 1 controlled substance by the United Nations in 1971. It currently has no approved medical use.

The MKUltra program Project Monarch included brain-washing of individuals for covert purposes and most of those who came out of de-programming were found to have multiple personalities. Author Fritz Springmeier and Cathy O'Brien, a survivor of that program is the focus of the Project Monarch clandestine activity. I do not want to get off track here on MKUltra, other than to point out that the CIA has conducted research in which they remove a person's memory.

I viewed a video a year ago in which the CIA spokesman agent said that they knew the area of the brain that could be expunged of any identity of God or morality. We have known for years that the human brain has been mapped out and so that was not a huge surprise. What is a surprise is that the idea of re-writing our DNA has been brought out in relation to what is being described in the "Trust Stamp" portion of the Gates "ID2020" plan.

This may be difficult for many to fully understand, but in the most basic element, we are being prepared for a world with trans-humans, partly man, partly beast. You could compare this with "worker" bees in a hive with the task of feeding and protecting the queen bee of the colony.

The "Trust Stamp" also shares this market-focused vision for its digital identity system as the company has stated that it is looking for new commercialization options for its "Evergreen Hash" technology, specifically with prison systems. Talks with private and public prison systems have revealed an interest in their utilization of "Trust Stamp's" technology to provide identification for individuals on parole "without making them pay for pricey ankle bracelets that monitor their every move," as "Trust Stamp's" platform would ostensibly provide that same function but in a "touchless" and less expensive manner.

"Trust Stamp's" interest in providing its technology to both Covid-19 response and to law enforcement is part of a growing trend where numerous companies providing digital solutions to Covid-19 also offer the same solutions to prison systems and law enforcement for the purposes of surveillance and "predictive policing."

For instance, contact tracing software originally introduced as part of the Covid-19 response has since been used by police departments across the U.S. to track protesters during the country's recent bouts of protests and civil unrest. Similarly, a controversial Israeli tech firm currently being used in Rhode Island offers AI-powered predictive analytics to identify likely future Covid-19 hotspots and individuals likely to contract Covid-19 in the future, while also offering governments the ability to predict future locations of and participants in riots and civil unrest.

So when the left no longer needs its soldiers, it can track them down, sentence them to prison (where they will receive the technology injected into their bodies) or worse – kill them!

What is perhaps most alarming about this new “Wellness Pass” initiative, is that it links these “dual use” digital solutions to cashless payment solutions that could soon become mandated as anything other than touchless, cashless, methods of payment have been treated as potential modes for contagion by GAVI-aligned groups like the World Health Organization, among others, since the pandemic was first declared earlier this year.

To inject a vaccine loaded with side effects can have a synergetic effect on the host that can activate pathogens or organisms, such as cancer, or any known virus DNA, which can change the DNA of the recipient.

The gene editing technology CRISPR has prompted both breathless predictions of medical breakthroughs and warnings of apocalypse. Yale Insights asked Dr. Greg Licholai, a biotech entrepreneur and a lecturer at Yale SOM, to explain CRISPR’s potential and dangers.

One of the biggest risks of CRISPR is what’s called “gene drive”, or genetic drive. What that simply means is that because you’re actually manipulating genes and those genes get incorporated into the genome, into the encyclopedia, basically, that sits within cells, and potentially those genes can then be transferred on to other organisms. For decades, advances in generic engineering have prompted both breathless predictions of a wondrous future and warnings of apocalypse. Both have gotten louder in the five years since the development of CRISPR, which allows for much more precise editing of genes than previously existing tools.

In 2017, for the first time, scientists used CRISPR to repair a genetic mutation—one that could cause a heart defect—in an embryo. Reporting the breakthrough, the *‘New York Times’* said that *“it raises the prospect that gene editing may one day protect babies from a variety of hereditary conditions.”* But in the article’s third paragraph, the newspaper added that the successful experiment *“is sure to renew ethical concerns that some might try to design babies with certain traits, like greater intelligence or athleticism.”* Designer babies is becoming an in vogue possibility.

My first wife was diagnosed with Huntington’s Chorea in 1967, and her doctors could only say, *“Someday they might find the gene that causes Huntington’s.”* Huntington’s disease (HD) is named after George Huntington, who described it among residents of East Hampton, Long Island in 1872. It is a hereditary neurodegenerative disease. In 1993, a collaborative group of investigators discovered the gene that causes HD. My wife and family both suffered for years with the debilitating progression over the next 25 years. She died three years after the discovery of the HD gene.

With the promises of gene editing, it has not stopped scientists from correcting hereditary diseases such as HD, it has become a rush to experiment in unimaginable mixing of human and animal DNA experiments. There is a picture on the Internet showing a pig creature with human facial features. Even though there was a treaty that the scientific community would not attempt cross species breeding, it has not stopped experimenters.

What is CRISPR and how is it different from the methods that have been used to manipulate genetics before?

CRISPR is this fascinating, powerful technology. It's got a very clunky name. It's called Clustered Regularly-Interspaced Short Palindromic Repeats. Now what does that mean? The name actually refers to the way it interacts with DNA. It's a way to manipulate DNA, to edit DNA, in a way that is much more powerful than previous methods, much simpler, much cheaper. And the important part is it's exceptionally precise.

So as you probably know, our book of life is made of DNA. DNA itself is many millions of base-pairs, which is like a language. And within that language, there are certain regions which code for genes, and those genes are incredibly important because those genes go on to make up everything about us. There's 40,000 proteins that become outputs of those genes and they are involved in our health, our well-being, and any defect in those genes becomes problematic and causes disease.

What was previously attempted with gene editing was to manipulate genetic information in blocks, basically in big pieces. It's kind of like trying to edit a book by only being able to rip out a page at a time and transfer a page at a time, without really being able to control the actual words. The power of this technology: it literally comes down to the individual letters. So the precision is far better than anything that has happened before. The excitement in the scientific community is being able to go in and very precisely make changes in DNA of actual genes that you can actually turn off bad genes or you can potentially repair genes that have got mutations in them where the code is written incorrectly.

Dr. Carrie Madej mentioned in chapters 12 & 13 has issued a warning on how this plays a role in the Bill Gates "ID2020" identity pass. Recombinant DNA (rDNA) molecules are DNA molecules formed by laboratory methods of genetic recombination (such as molecular cloning) to bring together genetic material from multiple sources, creating sequences that would not otherwise be found in the genome. Immortalized cells (also called continuous cells or cell lines) are primary cells whose telomeres and/or tumor suppressor genes have been altered. Tumor suppressor genes (e.g. p53 and Rb) are important for signaling the cell to stop dividing when the likelihood of DNA damage is higher. In the case of immortalized cells, these genes have been knocked down or their function inhibited so that the cell is able to keep dividing indefinitely.

Keep this in mind because the medical science community has been on a quest for decades interested in creating immortality, i.e., no death as we know it. It was in print since I was a child, if not even before that. I remember reading reports in my grandma's 'Life' magazines. We do not know how far this quest has gone or what they may have discovered. It has been my view for decades that the elite would offer the world immortality as a provision that would come with one to receive the "Mark" of the Beast. I still do not rule that out down the road in the NWO grand plan as an inducement to volunteer to take the "Mark" of the Beast.

I am noting what Celeste Solum (Bishop) shared regarding how this plays into the World Economic Forum plans. She talked about the Hydrogel that will be inserted into the vaccine planned for the world. Something that cannot be overlooked is how quickly the 5G satellites are deployed into space orbit. Elon Musk has already deployed a couple hundred of the 5G satellite antennas to date. 40,000 5G satellite antennas are to be deployed over two years. The vaccine commitments seem to focus on the period of between late October, 2020 and February, 2021.

**Hydrogel Mimics Human Brain with Memorizing and Forgetting Ability**  
by [Hokkaido University](#)

The hydrogel's memorizing-forgetting behavior is achieved based on fast water uptake (swelling) at high temperature and slow water release (shrinking) at low temperature, which is enabled by dynamic bonds in the gel. The swelling part turns from transparent to opaque when cooled, enabling memory retrieval.

Hokkaido University researchers have found a soft and wet material that can memorize, retrieve, and forget information, much like the human brain. They report their findings in the journal *Proceedings of the National Academy of Sciences (PNAS)*.

The [human brain](#) learns things, but tends to forget them when the [information](#) is no longer important. Recreating this dynamic [memory](#) process in man-made materials has been a challenge. Hokkaido University researchers now report a hydrogel that mimics the dynamic memory function of the brain: encoding information that fades with time depending on the memory intensity.

Hydrogels are flexible materials composed of a large percentage of water—in this case about 45%—along with other chemicals that provide a scaffold-like structure to contain the water. Professor Jian Ping Gong, Assistant Professor Kunpeng Cui and their students and colleagues in Hokkaido University's Institute for Chemical Reaction Design

and Discovery (WPI-ICReDD) are seeking to develop hydrogels that can serve biological functions.

*"Hydrogels are excellent candidates to mimic [biological functions](#) because they are soft and wet like human tissues," says Gong. "We are excited to demonstrate how hydrogels can mimic some of the memory functions of brain tissue."*

In this study, the researchers placed a thin hydrogel between two plastic plates; the top plate had a shape or letters cut out, leaving only that area of the hydrogel exposed. For example, patterns included an airplane and the word "GEL." They initially placed the gel in a cold water bath to establish equilibrium. Then they moved the gel to a hot bath. The gel absorbed water into its structure causing a swell, but only in the exposed area. This imprinted the pattern, which is like a piece of information, onto the gel. When the gel was moved back to the cold water bath, the exposed area turned opaque, making the stored information visible, due to what they call "structure frustration." At the cold temperature, the hydrogel gradually shrank, releasing the water it had absorbed. The pattern slowly faded. The longer the gel was left in the hot water, the darker or more intense the imprint would be, and therefore the longer it took to fade or "forget" the information. The team also showed hotter temperatures intensified the memories.

*"This is similar to humans," says Cui. "The longer you spend learning something or the stronger the emotional stimuli, the longer it takes to forget it."*

The team showed that the memory established in the hydrogel is stable against temperature fluctuation and large physical stretching. More interestingly, the forgetting processes can be programmed by tuning the thermal learning time or temperature. For example, when they applied different learning times to each letter of "GEL," the letters disappeared sequentially.

The team used a hydrogel containing materials called polyampholytes or PA gels. The memorizing-forgetting behavior is achieved based on fast water uptake and slow [water](#) release, which is enabled by dynamic bonds in the hydrogels. *"This approach should work for a variety of hydrogels with physical bonds,"* says Gong.

*"The [hydrogel's](#) brain-like memory system could be explored for some applications, such as disappearing messages for security,"* Cui added.

The third, which sometimes is overlooked, is actually in farming. Both farming with animals as well as farming with crops. And in fact, the application of CRISPR to foods has already been done. There are companies that have already been using CRISPR to create enhanced foods to resist bacteria or viruses; to create even better-tasting foods. And that's already being done.

Similarly, the application of CRISPR to animals has already been done. They actually call them CRISPR mice, and they are already being used in the research community. The ability to apply it to larger animals such as food animals is in the very near future.



In terms of human health, we can divide that into two different categories. One is taking cells out of the body, manipulating them in the laboratory—either removing a defective gene or adding and enhancing an ability to do something by turning on a gene or fixing a gene—and then putting those cells back in the body. That’s one category. The other category would be actually injecting something into the body which can edit people’s genes so that within their own tissues those genes can either be turned on or off. And all of these have got some pretty profound complications and risks.

One of the biggest risks of CRISPR is what’s called “gene drive”, or genetic drive. What that means is that because you’re actually manipulating genes and those genes get incorporated into the genome, into the encyclopedia, basically, that sits within cells, potentially those genes can then be transferred on to other organisms. And once they’re transferred on to other organisms, once they become part of the cycle, then those genes are in the environment.

That’s probably the biggest fear of CRISPR. Humans manipulating the genetic code and those manipulations get passed on generation to generation to generation. We think we know what we’re doing, we think we’re measuring exactly what changes we’re doing to the genes, but there’s always the possibility that either we miss something or our technology can’t pick up on other changes that have been made that haven’t been directed by us. And the fear then is that those changes lead to antibiotic resistance or other mutations that go out into the population and would be very difficult to control. Basically this would mean to be creating incurable diseases or other potential mutations that we wouldn’t really have control over. This was one of the points brought out by Dr. Carrie Madej in her video earlier this past July, 2020.

There are many ignorant preachers and Bible Prophecy teachers out there who will not consider what the Luciferian group headed up by Bill Gates is developing. 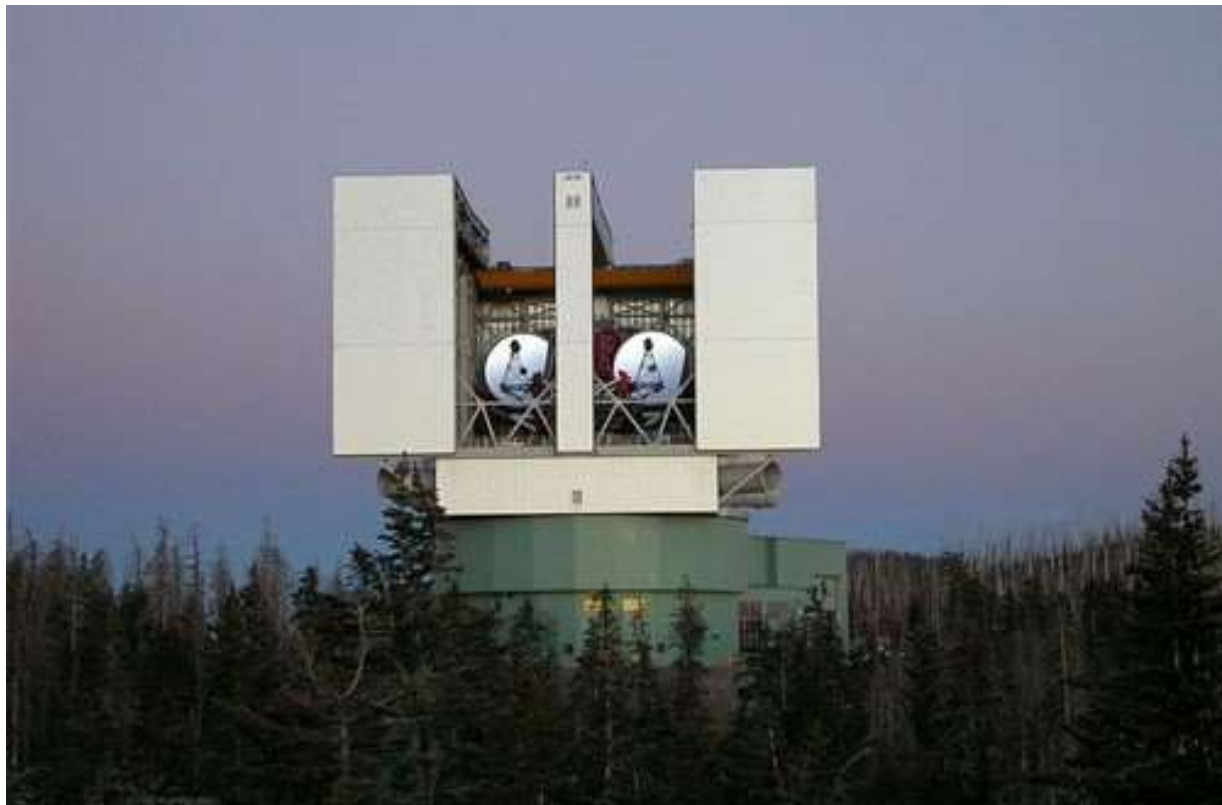

**Luciferase** is a generic term for the class of oxidative enzymes that produce bioluminescence, and is usually distinguished from a photoprotein. The name was first used by Raphaël Dubois who invented the words [luciferin](#) and luciferase, for the substrate and enzyme, respectively. Both words are derived from the Latin word [lucifer](#) – meaning lightbringer.

Luciferases are widely used in biotechnology, for microscopy and as reporter genes, for many of the same applications as fluorescent proteins. However, unlike fluorescent proteins, luciferases do not require an external light source, but do require addition of [luciferin](#), the consumable substrate. [Source](#)

**Luciferin** (from the Latin [lucifer](#), "light-bringer") is a generic term for the light-emitting compound found in organisms that generate bioluminescence. Luciferins typically undergo an enzyme-catalysed oxidation and the resulting excited state intermediate emits light upon decaying to its ground state. This may refer to molecules that are substrates for both luciferases and photoproteins.



The Jesuit dual lense telescope located at Mt. Graham, AZ. Its name is “Lucifer” and Greg Szymanski, JD, wrote about it back when it was announced.

Here is an article that appeared in the **Native American Roots web site**, explaining how the Vatican violated Native American holy ground:

It is here that the Ga’an, the guardian spirits of the Apache, live.

In 1873, Mount Graham was removed from the boundaries of the San Carlos Reservation and placed in public domain. The spiritual value of Mount Graham to the Apache was not considered. This action set the stage for conflict a century later.



In 1984, the University of Arizona and the Vatican selected Mount Graham as a site for a complex of 18 telescopes. The fact that this is a sacred place for the Apache was not taken into consideration. To get around the legal barriers of the American Indian Religious Freedoms Act, the University hired a lobbying firm to put pressure on Congress to remove this, and other, roadblocks. The area in question is administered by the U.S. Forest Service.

The Vatican has an observatory staff which is officially support by the Vatican City State. The Vatican Observatory Foundation is supported by private donations. One of the important duties of the church is to maintain an accurate calendar and this requires astronomical observations. Hence the involvement of the Vatican with astronomy. The first Vatican observatory was established in 1774.

Congress passed the Arizona-Idaho Conservation Act in 1988. In response to **lobbying by the University of Arizona and the Vatican**, the Act included a provision to allow the construction of three telescopes on Mount Graham **without having to comply with the American Indian Religious Freedoms Act or with environmental laws.**

The following year the Apache Survival Coalition was started by Ola Cassadore-Davis, the daughter of Apache spiritual leader Phillip Cassadore. The purpose of the Coalition was to save Dzil Nchaa Si An from desecration by a telescope complex to be built by the University of Arizona and the Vatican.

In 1991, the San Carlos Apache Tribe passed a resolution stating that Mount Graham is sacred to them. Furthermore, the resolution stated that the tribe supported the efforts of the Apache Survival Coalition to protect the religious and cultural beliefs of the tribe.

Following the declarations of the sacredness of Mount Graham by the Apache Survival Coalition and the San Carlos Apache Tribe, the Vatican in 1991 declared that Mt. Graham was **not sacred because it lacked religious shrines.**

Jesuit Father George Coyne, director of the Vatican Observatory, indicated that he could not find an authentic Apache who thought the mountain was sacred. Father Coyne stated that to convince him that the mountain was sacred he would need to see evidence of shrines and that he would not accept Apache oral history or statements by Apache-speaking Euro-American anthropologists.

Father Coyne further declared that Apache beliefs were *“a kind of religiosity to which I cannot subscribe and which must be suppressed with all the force we can muster.”*

The *‘Arizona Republic’* (Phoenix, Arizona) reports that the Jesuit Father Charles W. Polzer calls opposition to the construction of the telescope complex on top of Mount Graham **“part of a Jewish conspiracy”** and comes from the Jewish lawyers of the American Civil Liberties Union who are out to undermine and destroy the Catholic Church.

In spite of opposition by the San Carlos Apache tribal council, Apache spiritual leaders, and environmental groups, actual **construction of the project began in 1991.**

With flagrant insensitivity to American Indians, the University of Arizona announced that it intended to name its new telescope on Mount Graham the Columbus telescope in honor of the European explorer. The University was apparently unaware that Columbus is not considered to be a hero by American Indian people. Ultimately, the University withdrew the name following public response against it.

The San Carlos Apache tribal council in 1993 reaffirmed resolutions opposing the construction of the telescope on Mount Graham. The council resolution stated that the telescope *“constitutes a display of profound disrespect for a cherished feature of our original homeland as well as a serious violation of our traditional religious beliefs.”*

After meeting with Apache elders and spiritual leaders at the San Carlos Apache Reservation, the National Council of Churches in 1995 passed a resolution calling for the removal of a telescope from Mount Graham.

The President’s Advisory Council on Historic Preservation in 1996 declared the entire Mount Graham observatory project to be in violation of the National Historic Preservation Act because of the project’s harm to Apache culture and spiritual life, **but the telescope was not removed.**

In 1997, the spokesman for the Apaches for Cultural Preservation was arrested for praying on Mount Graham. The Apaches for Cultural Preservation feel that the Forest Service, the University of Arizona, and the Vatican developed the project on Mount Graham knowing that it would violate Apache religious beliefs.

President Bill Clinton, using the line item veto deleted \$10 million in federal funds for the operation of the University of Arizona’s Mount Graham telescope project. San Carlos Apache Chairman Raymond Stanley and the White Mountain Apache Cultural Resources Director Ramon Riley sent letters to the President thanking him for the veto.

Beginning in 1998, the University of Arizona began requiring Indians to obtain “prayer permits” before they crossed the top of Mount Graham near the University’s telescopes.

The University’s prayer policy required that the permit be requested at least two business days before the visit and that it include a description of where on the mountain the prayers will take place. **Only people who were enrolled members of federally recognized tribes were allowed to pray.**

In 1999, the University of Notre Dame, a Catholic university, announced that it would also build a telescope on Mount Graham. The University president claimed that he was unaware that Mount Graham was sacred to the Apache and that the Apache opposed the desecration of this sacred place. This was in spite of the fact that the building of

telescopes on this sacred mountain by the University of Arizona and the Vatican was a controversial issue and had been the subject of many news stories.

In 1999, the White Mountain Apache tribal council passed a resolution urging the U.S. Forest Service to “honor its duties to protect the physical integrity of Mount Graham and its long-standing and ongoing historical, cultural and religious importance to many Apaches.”

Realizing that they were making little headway with the bureaucracies of the American government (Department of the Interior and Department of Agriculture) and Congress, the Apaches took their cause to the United Nations in 1999.

Ola Cassadore Davis testified before the Sub-Commission on Prevention of Discrimination and Protection of Minorities. She stated: We Apache wish to bring to the people of this world a better understanding of Indian people, in order that we are able to preserve and freely live by our traditional culture and religious beliefs.

Four years later, Vatican scientists co-hosted conference on alien life forms. Nearly 200 scientists are attending the conference, called The Search for Life Beyond the Solar System: Exoplanets, Biosignature & Instruments, which runs from March 16-21 in Tucson, Arizona. The Vatican Observatory is co-hosting the conference with the University of Arizona’s Steward Observatory.

*“Finding life beyond Earth is one of the great challenges of modern science and we are excited to have the world leaders in this field together in Tucson,”* said event co-chair Daniel Apai, assistant professor of astronomy and planetary sciences at the UA Steward Observatory.

*“But reaching such an ambitious goal takes planning and time. **The goal of this meeting is to discuss how we can find life among the stars within the next two decades.**”*

The Rev Paul Gabor of the Vatican Observatory, the conference’s other co-chair, added that **scientists will give more than 160 research presentations during this week’s conference.**

According to the organizers, the conference will cover the technical challenges of finding and imaging exoplanets and identifying bio signatures in the atmospheres of far-flung worlds. Other presentations will discuss the study of life forms that live in extreme environments on Earth, which could be apt analogs for life on other planets.

The Vatican Observatory is one of the oldest active astronomical observatories in the world, with its roots going back to 1582 and the reform of the Julian calendar. Papal interest in astronomy can be traced to Pope Gregory XIII who had the Tower of the Winds built in the Vatican in 1578 The observatory in its present form was officially

founded in 1891 by Pope Leo XIII. Today there are 13 Jesuits from 6 countries throughout the world on staff of the Observatory at Mount Graham, AZ.

The Vatican and Catholic church are neck high in idolatry and apostasy, so, is it any wonder that they are looking for “aliens?”

This is a spiritual issue.** This is going to be difficult for many non-Christians to understand and grasp. They are lost for eternity if they do not read their Bible, or what I have been

sharing in my series on **666/999**. While watching Celeste Solum's latest video, it borders on something on the level of science fiction.

The truth is scientists are doing Satan's work of creating a race of Nephilim – half human, half demon – beings whose souls cannot be saved. New York City Adds 3,800 Probable Virus Victims to Death Toll

New York City added thousands of people to its coronavirus death toll to account for victims who died in recent weeks without a confirmed diagnosis. Freddi Goldstein, press secretary to Mayor Bill de Blasio, said Tuesday that the data include at-home deaths of people suspected of having Covid-19.

#### 5. Outright MURDER of Seniors in Hospitals & Nursing Homes

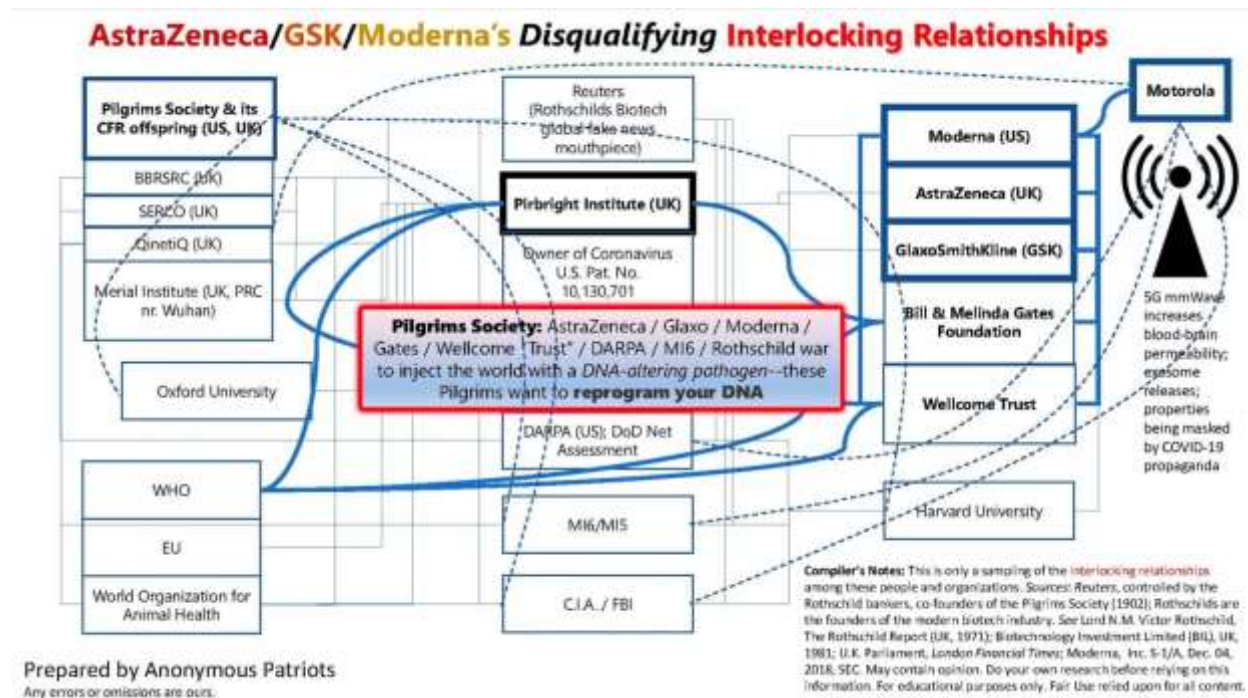
