The date of the report below of **January 30, 2020** is the date that I first posted the Covid-19 article information on my web page over a year ago. Michael McKibben and his company, Leader Technology of Columbus, OH is the real inventors of what you know as Face Book. They invested \$20-million dollars into the source code for the popular social media platform, which they still possess, as proof of

their work, but it was stolen by the CIA and “assigned” to Mark Zuckerberg. Leader Technology has a \$1-trillion dollar legal suit against the U.S. government under the Miller Act. It was stolen by an attorney working in the Clinton administration by the name of James P. Chandler III. Mark Zuckerberg could not write three lines of code if his life depended upon it. He is a CIA “cutout” puppet as its CEO.

Hillary’s legal mentor was a clever black Harvard and George Washington University law professor named James P. Chandler, III. While he coached Bill and Hillary Clinton, Chandler was scheming to corner the legal market on protection of software inventions, trade secrets and “the intellectual property of the United States.” So he boasted at every opportunity. Hillary Clinton began her career as a “patent” attorney at the Rose Law Firm in Little Rock, AR. This becomes very important in her later career of crime.

When the Clintons came to power in 1993, Chandler became their top outside advisor for intellectual property, patents, trademarks, copyrights, trade secrets, economic espionage, counterfeiting and counter intelligence. He immediately wrote and Congress approved (unanimously) The Economic Espionage and Federal Trade Secrets Acts of 1996, and The False Statements Accountability Act of 1996 (officially sanctioned lying to Congress and the courts, that’s right, you did not misread).

One of Chandler’s strategies was to use his influence over the Clintons to take over the Internet as a way to stay perpetually ahead of Russian, Chinese, Japanese, Israeli, Irish, Indian and French intelligence. So he also boasted.

At the same time, Chandler was outside counsel to IBM. He worked closely with IBM inside intellectual property counsel, David J. Kappos (Obama’s Patent Office director – 2009-2013), to muscle IBM’s competitors with “junk patents” to extort license fees. This activity was the real “patent troll” which Chandler and Kappos have flipped 180 degrees into unfounded media attacks on small inventors as the trolls.

The Weaponization of Social Networking

IBM was all the while standing behind Chandler’s plan to weaponize the Internet. See our previous post: “The Weaponization of Social Media Should Concern Us All (PDF).”

Within months of Clinton coming to power, Chandler arranged for the Carnegie Endowment for Peace, Clinton chief of staff John Podesta, and a raft of DOJ insiders, including Robert Mueller, James Comey, Duval Patrick and Louis Freeh to hold a Who’s Who conference to promote giving the FBI backdoor encryption access to the emerging commercial Internet, which was in its infancy then. That “Clipper Chip” died in Congress over privacy concerns and inadequate safeguards.

Undeterred, Chandler and his FBI/DOJ co-conspirators turned to the Departments of Commerce and Justice to concoct an export license requirement to embed the backdoor key as a prerequisite for sale of their hardware, software and firmware offshore. The list of vendors who embed the NSA Dual_EC_DRBG encryption algorithm to this day is even published. Three people controlled the U.S. Keys to the Internet:

Hillary Clinton, Robert Mueller, and Michael Chertoff. Control of those “keys” facilitated unbelievable hacking power beyond our imagination, and let’s simply notes, a lot of aircraft crashed under mysterious conditions and many key people and witnesses were murdered in those crashed aircraft and helicopters.

Michael McKibben’s team at Leader Technology are experts at “digging” down into the Internet in a way few know how to or are able to do. Their IT tech savvy skills in research are simply incredible and astonishing. So what I share here, I had in my possession more than a year ago and I shared what I had in articles during early 2020. This story is rocking the economic world as the virus scamdeminc narrative is unravelling like a ball of yarn. That has become evident in the sudden rush to vaccinate the world with a fake vaccine, which really is not a vaccine! Government health agency people are saying the vaccine will end in April, 2021, and that herd immunity achieved will protect the population. Many things are beginning to smell about the whole narrative still being hyped in the mainstream media.

The virus incident was set into motion in Wuhan China as part of a larger project with Klaus Schwab’s World Economic Forum “Great Reset”. The first part of the plan was to provoke a war between China and the U.S. Although that portion of the plan failed in part, it did heighten the tension and rhetoric between the U.S. and China. The U.S. deployed added naval assets to the Pacific and has applied regular show of force in the waters between the Philippines, Japan, South Korea, and Taiwan. The U.S. deployed as many as 4 CSG aircraft carrier battle groups to the region last year. Currently 2 CSG (Carrier Strike Groups) operate in unison in the Chinese-disputed waters of the Pacific Ocean. 2 additional CSG’s can be on station in five to eight days if needed. In 2020 one of the U.S. Navy’s CSG groups was relocated from its port base in Norfolk, VA to San Diego, CA as the U.S. focus was shifting strategically toward China.

The logic behind the plan was to provoke a war between the two countries and simply to destroy the two major economic powers by making it appear each had attacked the other. The House of Rothschild used the well-known philosophy of “divide and conquer” strategies, and the Rothschild’s were the money power responsible for the economic rise and growth of both the U.S.(1913) and China(1974-1980). One of the Rothschild’s lieutenants, George Soros even owns a vaccine factory in Wuhan, China, some 7-kilometers from the CCP BSL4 lab location, from where the Corona virus was alleged to have been leaked from in late 2019. China was being setup to be the scapegoat for the scam. Then Secretary of State Mike Pompeo appeared to be in on the plan when he made the infamous statement on March 20th, 2020,

Pompeo made a speech on March 20 from the White House with President Trump beside him. A google search reveals that this story was reported by AFP on March 20, making it perfectly clear that Pompeo was accusing China of some sort of cover-up in relation to the virus, and taking only that angle of discussion. For example, U.S. Secretary of State Mike Pompeo tells China to share virus details with the ‘whole world’. Mike Pompeo was placing the blame on the CCP of China as the world looked on believing China was guilty of the virus being leaked at Wuhan.

Pompeo's 'live exercise' mention made during this speech was picked up as a separate story by Shepard Ambellas at Intellihub on March 21, and reissued by Global Research. Here, we are using Makia Freeman's version of the story of March 25, an independent author who follows all aspects of the One World crowd's agenda pretty closely.



Crucially, Trump immediately interjects with this comment during Pompeo's 'we're in a live exercise here' remark: "You should have let us know." Freeman offers the interpretation, no doubt plausible, that Trump was genuine in his statement, i.e. he didn't know about the virus situation being a 'live exercise', and that the Deep State Swamp is certainly running the show. Or, did Pompeo reveal something Trump was indeed in on, and that he was hoping his remark would be picked up in order to distance himself? In the videos that Trump re-starts his comment when Pompeo takes a natural pause – in order to be heard? Either way, Trump jumping in reveals that Pompeo misspoke in some way, thus drawing attention to it. Furthermore, MSM silence on it speaks volumes.

We are in the midst of a live exercise according to US Secretary of State and former CIA head Mike Pompeo, who only a year ago openly boasted that “*we lied, cheat and stole.*” The folks at Leader Technology strongly suggest that Mike Pompeo was really a UK operative/spy double-agent and a member of the Pilgrim Society.

Pompeo admitted on CNN that “*we’re in a live exercise here*” when referring to COVID-19 during a press conference. This is yet more evidence that the entire coronavirus crisis has been scripted, planned for and orchestrated. The language that Pompeo used – “live exercise” – is eerily reminiscent of language used in false flag operations when the exercise or drill “went live”, i.e. when the very scenario that the authorities were planning for actually happened (see 9/11, 7/7 and numerous U.S. mass shootings) as they were in the middle of their exercise.

Does this indicate that Trump was not ‘read-in’ until later, reinforcing the idea that presidents and prime ministers don’t really run their countries, but are rather told what the plan is, and that they’d better get on board?

In September, 2019 all Chinese citizens were vaccinated. In October Wuhan was debuted as a “Smart” city with 1,580 5G EMF base stations activated as part of a future ten-thousand 5G EMF base-stations to be deployed in the industrial city of Wuhan. Two other world-class cities simultaneously were also activated and being show-cased as “Smart” cities: Seattle, WA and Milan, Italy. The 7th World Military Games were held in Wuhan, China in October, 2019. Such world-class military events always bring out the spies from around the world. The U.S. CIA and the UK MI6 were known to be represented as military participants in the 7th World Military games. On October 31st, Wuhan turned on the power to activate their brand new 5G network.

What most people do not understand is that when the 5G technology was activated, it was done with virtually minimal electric energy consumption, and just below the energy level of a TSA body scanner at airports of less than 10-GHz, and probably closer to that of a “smart” utility meter at around 4-GHz. As was revealed later, it was not until the Wuhan 5G network was hacked by Rothschild operatives 7,000 miles away in Surrey, UK, that people began dropping like flies in their own footprint from the 5G EMF “modulated” energy kicked up to the 60-GHz fatal energy level. Cell phone videos of such incidents appeared daily on the Internet sent to Chinese family members in the U.S. In any given college school year, there are upwards of a half-million Chinese student attending U.S. colleges and universities, at U.S. taxpayer expense as part of the trade imbalance adjustment payments.

What was so very strange was to see three or five in a group of Chinese young people walking on a street and suddenly one or two would simply fall over dead, but the others seemed perfectly fine. In watching the cell footage again in greater detail, those who fell over dead had been on their cell phone texting, but those remaining on their feet did not have their cell phones in their hands if they had them on their personal clothing. At the time it was really weird. I viewed literally dozens of such cell phone videos posted

on the Internet. There were so many that they simply became passé as the time passed and the focus shifted to things like masks and lockdowns.

In the months that followed, satellite photos showed Chinese crematories operating around the clock for months. Since secrecy in China is basic with the CCP, information is hard to come by, but one of the most revealing pieces of information that came out in mid-March, 2020, was a small article in a business trade paper that the Chinese telephone company reported a decline of 21-million cell phone accounts. As to why so has been a classified secret to this day. We can only speculate at this point. Knowing how people are addicted to their cell phones, it seems unlikely that a thousand, let alone 21-million Chinese would suddenly give up willingly their cell phones. After all, China has been the leader in the cell phone technology; with its QR code application, Chinese nationals use it for virtually all form of commerce imaginable from use to make purchase at a convenience store, enjoy a meal at a restaurant, ordering a cab, etc..

I recently shared a report from Jon Rappoport in which the Chinese head of epidemiology recently stated that they [China] had never proven or isolated the Covid-19 virus. The implications of that statement has brought even more doubt about the existence of such a virus, further suggesting other factors were at play in the dilemma some 7,000 miles away.

We need to return back to the Pirbright Institute in Surrey, UK, a Rothschild-owned science lab facility that deals in “foot and mouth” disease in animal studies and vaccines. It has a telecommunications facility with two-dozen satellite dishes of various sizes located at the farm. Now, who would imagine in their wildest dreams or to think of scientists at the Pirbright Institute remotely hijacking the Chinese 5G EMF network in Wuhan, China, 7,000 miles away and suddenly jacking-up “modulating” the energy level to kill anyone likely with a Smart phone in their hands? Yet that is exactly what happened and we have not heard much said publicly as to whether the Chinese realized what happened or figured out how it happened. And if they figured it out, they might choose not to share that fact with the outside world for their own reasons!

In the months following the alleged virus leak and the cremating bodies for months in Wuhan, China had their hands full with the flooding that occurred for months at the Three Gorge River Dam. 80% of their agricultural planting season was wiped out by the dam’s flooding and the need to release accumulated water up stream. The Chinese had to flood 400 miles of land downstream to Wuhan to relieve water pressure buildup at the dam. The Three Gorge River dam has since shown satellite deformation of the structure. Dam engineers have found serious flaws from cracks found since the waters receded. Several hundred cracks are leaking water according to civil engineers inspecting the dam. The unusually long rainy season in China is suspected to have been part of a geo-engineered weather warfare program run by the CIA against China. The monsoon rainy season has not abated and the dam is still in danger of collapse according to outside engineers studying the dam. Dr. Henry Kissinger often spoke about the use of food as a weapon of war.

Lord Pirbright (Rothschild) and his banker cousins at N.M. Rothschild & Co. were godfathers of the 2nd Boer War concentration camps (1899-1902) to drive the French, Dutch and Germans out of South Africa.

Henry (Rothschild) de Worms 1st Baron Pilbright (1840-1903), also called Lord Pirbright. Baron Pilbright's grandmother was Schönche Jeannette Rothschild (1771–1859). Her father was Mayer Amschel Rothschild (1744–1812), the founder of the House of Rothschild colonial banking business in Ceylon where Lord Pirbright's father Solomon de Worms established the "Rothschild" coffee and tea plantation with slaves, and nearly slave labor.

The Pirbright Institute has been known as a scientific research facility for the study of such things as foot and mouth disease among bovine and sheep studies. But when you think about it, what better place to disguise other nefarious activities than at an animal farm lab! Somehow something seems out of place for an animal research lab amidst two dozen satellite dish antenna. There is even a 5G antenna receiver in the lower left corner below between the two large dish receivers mounted on the small gray building. Our suspicions are confirmed by the names of those funding The Pirbright Institute and with what the McKibben team at Leader Technology has discovered.

That tiny white globe below proves that the Pirbright Institute could hijack the Chinese 5G EMF base station in Wuhan, China. 5G technology has within it an Achilles heel or weak spot. On the very same property as The Pirbright Institute is Cobbett Hill Earth-Station - a satellite teleport that boasts “more than 25 antennas with active operations on 13 satellites” using C and KU-band antennas that are powerful enough for directed energy weaponry. To emphasize what that means is that a 5G satellite hit Wuhan’s 5G telecommunications network with a “directed energy weapon” attack. On November 11, 2002, this MOD property housing both the Pirbright Institute and Cobbett Hill Earth-station was sold to QinetiQ Holdings Limited. The British Monarch hold a “Special Share” (aka “Golden Share”) giving it complete control of QinetiQ.

Then, in 2004, QinetiQ “sold” Cobbett Hill according to official Parliamentary debate records. I became interested in bees back in the fall of 1996, when bee keepers were reporting the collapse of their bee colonies. Since I retired I am a professional student, and well-read in many areas, I saw a pattern taking place in the real world causing concern.

You may or may not have noticed that bees form their honey comb in the pattern of the hexagon. Well, that curiosity was addressed in a science magazine a few years ago. Scientists use their observations to make sense of the world we live in. When scientists

come across a phenomenon and are puzzled by what they observe, such as the hexagonal shape of a honeycomb cell, they will often ask questions and try to understand the phenomenon by forming a premise “claim.”



A scientific claim . . . answers a scientific question or problem and is usually a statement about, or understanding of, a phenomenon. It is always supported by scientific data or “evidence.” That evidence provides “reasoning,” or a justification, that logically connects the evidence to the claim. It is usually based on a scientific definition, law, rule, or principle. It can be revised as more evidence is gathered and/or logical connections are made that support changes in reasoning.

We often call the process of developing and explaining a claim “**CER**,” for **C**laim, **E**vidence, and **R**easoning. I know what you are thinking here, why is he telling me this? Stay with me as this enabled me to figure out the nefarious connection between 5G and the Covid-19 mystery when I was wading through scientific abstracts and science papers.

Why do honeybees use hexagonal shapes to construct their honeycombs?

Honeycombs are made from beeswax, a substance created by worker bees. When the temperature is right, worker bees secrete wax scales from special glands in their body. Then they chew the wax with a bit of honey and pollen to produce the beeswax. The hexagonal cells serve as storage vessels for honey, as well as homes to raise young bees. Bees must build their honeycomb efficiently. When I was a kid, I would chew a piece of honeycomb my grandma would break off her honey combs she sold in small 8-inch squares at the farm packaged in small wooden frames wrapped in wax paper.

Bees collect nectar and pollen from flowers to make honey, a sugary food, for the colony. Honey provides bees with the energy they need to survive and reproduce, as well as to build their homes. In order to make enough wax, worker bees need a lot of energy, and must therefore consume a lot of honey. Some studies estimate that bees must consume eight ounces of honey for every ounce of wax they produce. Imagine how many flowers a bee must visit to be able to convert nectar into eight ounces of honey! On average, each bee can produce about 1/12 of a teaspoon of honey in its lifetime. That’s not a lot to show for a life time of work. Consider this, If a bee were to

provide one pound of honey, it would need to visit about 2 million flowers. A whole colony may travel about 55,000 miles in its lifetime!

One of the amazing wonders of the honey bee is found in New Zealand where Manuka honey is harvested. Unique to the islands of New Zealand, Manuka honey is God's miracle healing honey. By building honeycomb cells that share walls, bees can better conserve their resources (wax) and energy (honey). But don't forget that bees use the combs as storage vessels for their honey. When bees construct their combs, they need to minimize the space between cells while maximizing the space available within the cell to store their honey.

In this little study about God's gift to us you can probably see now where I have been taking you in this lesson that has huge significance in this article. How do bees do it? The honeycombs in which they store their amber nectar are marvels of precision engineering, an array of prism-shaped cells with a perfectly hexagonal cross-section. The wax walls are made to a very precise thickness, the cells are gently tilted from the horizontal to prevent the viscous honey from running out, and the entire comb is aligned with the Earth's magnetic field. Yet this structure is made without any blueprint or foresight, by many bees working simultaneously and somehow coordinating their efforts to avoid mismatched cells. It is truly a marvel of the Creator's design.

Why hexagons, though? It's a simple matter of geometry. If you want to pack together cells that are identical in shape and size so that they fill all of a flat plane, only three regular shapes (with all sides and angles identical) will work: equilateral triangles, squares, and hexagons. Of these, hexagonal cells require the least total length of wall, compared with triangles or squares of the same area. So it makes sense that bees would choose hexagons, since making wax costs them energy, and they will want to use up as little as possible - just as builders might want to save on the cost of bricks. This was understood in the 18th century, and Charles Darwin declared that the hexagonal honeycomb is "absolutely perfect in economizing labor and wax."

Darwin thought that natural selection had endowed bees with instincts for making these wax chambers, which had the advantage of requiring less energy and time than those with other shapes. But even though bees do seem to possess specialized abilities to measure angles and wall thickness, not everyone agrees about how much they have to

rely on them. That's because making hexagonal arrays of cells is something that nature does anyway.

In geometry, a hexagon is a polygon with **six equal sides**, and for the bees, the hexagon is the perfect shape to build their homes. Based on studies done by scientists, the hexagon is the most efficient use of materials and space for the beehives. Nature and the bees seem to know this instinctively. **Biblically, six is considered the number of man! But there is more to this puzzle.**

Variant

As used herein, the term 'variant' is synonymous with 'mutant' and refers to a nucleic acid or amino acid sequence which differs in comparison to the corresponding wild-type sequence.

A variant/mutant sequence may arise naturally, or may be created artificially (for example by site-directed mutagenesis). The mutant **may have** at least 70, 80, 90, 95, 98 or 99% sequence identity with the corresponding portion of the wild type sequence. The mutant **may have** less than 20, 10, 5, 4, 3, 2 or 1 mutation(s) over the corresponding portion of the wild-type sequence.

The term "wild type" is used to mean a gene or protein having a nucleotide or amino acid sequence which is identical with the native gene or protein respectively (i.e. the viral gene or protein).

For example, the word "variant" is used 60 times in the patent. However, the defined term is vague with the use of "may." This leaves open the possibility of including future circumstances whether not known, or known and hidden from view:

In other words, "mutant" variants not included in these percentages will certainly be claimed by Pirbright as one that a person of "ordinary skill in the art" would certainly understand is included by this specification. judges assigned to these cases in their pockets. The outcome is a forgone conclusion. The small inventor has no chance in this big pharma patent mill.

A layman patent claims readers could be excused for being confused by this patent-ese technical wording. But, every time a reference is made to another Claim in the back of a patent, some further elucidation of the referenced Claim is claimed also. For example, Claim 1 could be a description of a basic hammer, Claim 2 could reference Claim 1 and add a crooked nail puller. Claim 3 could reference Claim 1 and add a fiberglass shaft on the handle. Claim 4 could reference Claim 1 and claim a 20 pound head and specify it for pounding posts. Then, Claim 5 could reference Claim 3 and add claims to some special alloy shielding on the shaft, and so on.

12. A variant replicase gene as defined in claim 1.
13. A protein encoded by a variant coronavirus replicase gene according to claim 12.

(iv) selecting for recombinating virus comprising the modified replicase gene.
16. The method according to claim 15, wherein the

21. The method of claim 20, wherein the disease is infectious bronchitis (IB).

22. The method according to claim 20 wherein the method of administration is selected from the group consisting of: eye drop administration, intranasal administration, drinking water administration, post-hatch injection and in ovo injection.


23. The method according to claim 21 wherein the administration is in ovo vaccination.


24. A method for producing a vaccine according to claim 19, which comprises the step of infecting a cell according to claim 18 with a coronavirus according to claim 1.




Fig. 1—Sir Geoffrey E. Pattie, Pilgrims Society, Keeper of the Monarch's Golden Shares, founder of SERCO.




Fig. 2—Viscount Alfred Milner, Co-founder, Pilgrims Society (Jul. 16, 1902). Our research has tracked the Burroughs Wellcome & Co. involvement with bogus vaccines back to their experiments on 60,000 whites and black in British concentration camps during the Second Boer War that was promoted by the disciples of Cecil Rhodes like Viscount Alfred Milner, Winston Churchill and John Buchan, among others—all founders of the Pilgrims Society in London (1902), then New York (1903).




Fig. 4—George W. Bush, Pilgrims Society; progenitor of The Patriot Act where basic rights in the Bill of Rights were suspended following the Pilgrims Society fears conjured up and stoked by the MSM Pilgrim propaganda after their 9/11 false flag attack.




Fig. 5—Rupert C. Soames, Pilgrims Society; CEO of SERCO, human trafficking client of Jeffrey E. Epstein’s “Lolita Express” junket jet to “Pedophile Island” in the Caribbean. On Feb. 28, 2014, Rupert Soames, OBE, became CEO of SERCO. His brother is Sir Nicholas Soames who is also a confidant of Prince Charles of Wales.




Fig. 6—Jeffrey E. Epstein, Pilgrims Society blackmailer for MI6, C.I.A. and Mossad; human trafficking procuror for the Pilgrims Society.






Fig. 8—The Coronavirus is not Chinese in origin. It is a man-made British-U.S. Pilgrims Society bioweapon invented by Wellcome Fund, Wellcome Trust, Bill Gates, DARPA, UN, WHO and EU, among others, in Pirbright, Woking, Surrey UK by The Pirbright Institute holds U.S. Patent No. 10,130,701. This proof comes from their own hands.



Bill Gates: Third Shot May Be Needed to Combat Coronavirus Variants

Gates told CBS News we might need a third shot of a currently available vaccine, or a "modified" vaccine as the virus mutates, but CHD's RFK, Jr. asks why we haven't focused instead on non-vaccine strategies, including therapeutic drugs.



With more than 40 million Americans having received at least the first dose of the Pfizer or Moderna vaccine, a third dose may be needed to prevent the spread of new variants of the disease, Bill Gates told CBS News Tuesday. Why? Could it be for the purpose of tricking the human immune system to accept what comes later? I think that is precisely the reason for a booster dose.

Gates' comments come amid growing concern that the current vaccines are not effective against the more contagious Brazilian and South African variants.

Pfizer and Moderna have stated that their vaccines are 95% and 99% effective, respectively, against the initial strain of COVID. However, some scientists have questioned those statements. Additionally, the World Health Organization and vaccine companies have conceded that the vaccines do not prevent people from being infected with COVID or from transmitting it, but are only effective at reducing symptoms.

[Gates](#) told CBS Evening News:

*“The discussion now is do we just need to get a super high coverage of the current vaccine, or do we need a third dose that’s just the same, or do we need a **modified vaccine?**”*

*“U.S. vaccine companies are looking at **making modifications**, which Gates refers to as **“tuning.”**”*

*“People who have had two shots now may need to get a third shot and people who have not yet been vaccinated would **need the modified vaccine,**” explained Gates. **When asked whether the coronavirus vaccine would be similar to the flu vaccine, which requires yearly boosters, Gates couldn’t rule that out. Until the virus is eradicated from all humans, Gates said, “additional shots may be needed in the future.”**”*

“AstraZeneca in particular has a challenge with the variant,” Gates explained. “And the other two, Johnson & Johnson and Novavax, are slightly less effective, but still effective enough that we absolutely should get them out as fast as we can while we study this idea of tuning the vaccine.”

The Bill & Melinda Gates Foundation is funding the studies being conducted in Brazil and South Africa, CBS News said. The foundation has also invested in the AstraZeneca, Johnson & Johnson and the Novavax vaccines, which are being tested against new variants. Once the AstraZeneca vaccine is approved, the Global Alliance for Vaccine Initiative or GAVI, founded by Gates, will distribute it globally.

With COVID mania in full swing, they moved the goal posts as they pleased. Free of any science, data, or logical reasoning, the ruling class had the terrified masses completely under their thumb. Those steps would need to include the development and/or identification of therapeutic drugs, the sharing of information among doctors to hone improved treatment models that reduce infection mortality rates below those for flu, and the kind of broad-spectrum long-term herd immunity that protects against mutant strains and that only derives from natural infection.”

“Instead, Gates and vaccine makers are proposing a [lifetime of boosters](#), supporting [insufficient testing](#) to determine safety and failing to address the [inadequate monitoring of vaccine injuries](#),” Kennedy said.

The English word technology is derived from ancient Greek (*tékhne*), also translated as the "science of the craft".

COVID-19:

- Definition: A virus is a submicroscopic infectious agent that replicates only inside the living cells of an organism.
- Previously, there have been 7-8 prior coronavirus strains such as MERS, SARS.
- COVID-19's genetic sequence was generated by scientists in January 2020, which documented that CRISPR gene technology was used to perform genetic editing of the coronavirus virus cell at its DNA level.

CRISPR gene editing is a genetic engineering technique in molecular biology by which the genomes of living organisms that may be **'modified'**. It is based on a simplified version of the bacterial CRISPR-Cas9 antiviral defense system. By delivering the Cas9 nuclease complexed with a synthetic guide RNA into a cell, the cell's genome can be cut at a desired location, allowing existing genes to be removed and/or new ones added in vivo (a process performed or taking place in a living organism. The opposite of in vitro).

In my articles on **“Covid-19 is a Bioweapon”** I have previously noted that **four groups of scientists around the world in Australia, China, France and India had discovered that the Covid-19 had been modified with at least 4 inserts of other fragments, most likely for the purpose to achieve “Gain-of-Function” in implanting itself into the human genome.** One of those inserts contained 18 fragments of the HIV-1 genome. This was the conclusion of Dr. Luc Montagnier, the 2008 Nobel Laureate prize winner, who originally discovered the HIV/AIDS pathogen. His credibility is world renown.

Although, the 4 inserts represent discontinuous short stretches of amino acids in spiked glycoprotein of 2019-nCoV, the fact that all of them share amino acid identity or similarity with HIV-1 gp120 and HIV-1 Gag (among all annotated virus proteins) suggests that this is not a random fortuitous finding. Prashant Pradhan et al. (2020). Furthermore, **the inserted fragments for HIV-1 represents 80% of the HIV-1 genome!**

Because of this, COVID-19 qualifies and is considered to be a "man-made virus."

- Therefore, it is essential to understand that COVID-19:

- Is not a regular virus;

- It is a modified RNA virus; Genetically Modified Organism (GMO)

In other words, one may sporadically expect a fortuitous match for a stretch of 6-12 contiguous amino acid residues in an unrelated protein. However, it is unlikely that all 4 inserts in the 2019-nCoV spike glycoprotein fortuitously match with 2 key structural proteins of an unrelated virus (HIV-1). –(Prashant Pradhan et al. 2020).

Therefore:

- The vaccine that is to be used to fight against COVID-19 infection cannot be a "regular vaccine."

- But it must be a DNA modified vaccine to attack at the DNA level of the virus.

- The problem is that if you take a DNA modified vaccine, your DNA will be changed or altered. Let's be very clear on this point and understand this important fact, to modify, means to "change" what was natural into something that is synthetic and unnatural.

SARS-CoV-2 mRNA vaccines contain a bit of mRNA suspended in a lipid capsule. These enter your cells, and then, your ribosomes take the mRNA and manufacture copies of SARS-CoV-2's Spike protein. In further explaining how this is part and parcel of the Biblical “Mark” of the Beast, you will have to pay very close attention here. I say that because many are refuting this as the “Mark” of the Beast or the proverbial “666”. I believe most people misunderstand this from knowing little to nothing about genetics, DNA, viruses, vaccines, biochemistry, molecular biology, nanotechnology and nanomedicine. It will be given in higher doses for the first few months following transplant surgery and is tapered to a smaller maintenance dose thereafter.

For many patients with end-stage organ failure, transplantation is the only effective and remaining treatment option. **To prevent transplant rejection, recipients must take medications long-term that suppress the body's immune system.** These immuno-suppressive drugs are effective at preventing rejection over the short term; however, because anti-rejection drugs suppress all of the immune system nonspecifically, people taking these drugs face the risk of serious infections and even cancer. Additionally, non-immunological side effects of immuno-suppression, such as hypertension, kidney toxicity, diarrhea, and diabetes diminish the benefits of a transplant. Finally, immuno-suppressive drugs are much less effective at preventing transplant rejection over a long period of time, thereby leading to graft loss in many recipients' years later.

Current research in experiments with primates suggests promising future potential in that it one day may solve the issue in the need of taking anti-rejection medications. Now, hold this thought for a moment here as we consider this larger issue of your immune system. **God so designed the human immune system so perfect as to make it virtually impossible to be modified or changed in any way possible by man!** That does not mean that evil scientists will not attempt to do so, and even worse, succeed!

The pharmaceutical drug makers are suggesting that anyone receiving the so-called vaccine for Covid-19 will require 2 doses, and based upon Bill Gates recent remarks this past week, a third booster shots may be needed yearly. The important challenge for DNA vaccines is getting the host body's cells (DNA) to accept the introduced genetic (DNA) material, which is why 5G-related technology is needed to cause the opening of the cell to allow/force the DNA modified vaccine in through the sweat pores. In phase two clinical trials, antibody levels of the vaccinated faded in as little as two months. It may be more sensible to consider six doses of these new mRNA vaccines each year, as the science becomes a dependency program, hurting herd immunity.

Manipulating the immune system to respond to properties of years-old coronaviruses won't necessarily prepare the immune system for the upcoming variants and the ever-mutating properties of coronaviruses. The vaccine technology could create conditions that make the immune system more vulnerable, a phenomenon that was observed in a 2018 Department of Defense study. The study showed that influenza vaccines caused virus interference, making vaccine recipients 36% more likely to be infected with currently circulating coronaviruses.



Scientists discovered that the second language instructs the cells on how genes are controlled, according to findings published in ‘Science’ magazine. The study is part of the Encyclopedia of DNA Elements Project, also known as ENCODE.

DNA (Deoxyribonucleic acid) is a nucleic acid that is the main constituent of the chromosomes of all organisms, except in the case of some viruses. DNA is self-

replicating, plays a central role in protein synthesis, and is responsible for the transmission of hereditary characteristics from parents to offspring.

The second language remained hidden for so long because one language is written on top of the other, scientists said.



Scientists already knew that the genetic code uses a 64-letter alphabet called codons. The research team discovered that some of the codons can have two meanings – one related to proteins, the other to gene control. Those codons were given the name 'duons.' "The fact that the genetic code can simultaneously write two kinds of information means that many DNA changes that appear to alter protein sequences may actually cause disease by disrupting gene control programs or even both mechanisms simultaneously," said Stamatoyannopoulos. Our DNA is digital and so it can easily be read just like a UPS or USPS "Bar Code" label like this one below. This example was created for joint-delivery of packages where UPS

handles the front-end of shipping to the nearest USPS facility handling the back-end or delivery destination point.

The UPS Mail Innovations label requires two barcodes, the **Data Matrix barcode** used by UPS and the **IMpb** tracking barcode used by the USPS. It does not take a PhD in Molecular Biology to see how easy we become merged with technology.



Luciferase is a generic term for the class of oxidative enzymes that produce **bioluminescence**, and is usually distinguished from a photo-protein. The name was first used by Raphaël Dubois who invented the words luciferin and luciferase, for the substrate and enzyme, respectively. **Both words are derived from the Latin word Lucifer – meaning “lightbringer”.**



By selectively loading microparticles into microneedles, the patches deliver a pattern in the skin that is invisible to the naked eye but can be scanned with a smartphone that has the infrared filter removed. The patch can be customized to imprint different patterns that correspond to the type of vaccine delivered. Tests using human cadaver skin showed that the quantum dot patterns could be detected by smartphone cameras after five years of simulated sun exposure. The researchers also tested the

Luciferases are widely used in biotechnology, for microscopy and as reporter genes, for many of the same applications as fluorescent proteins. However, unlike fluorescent proteins, luciferases do not require an external light source, but do require addition of luciferin, the consumable substrate. If my memory is still fresh and accurate, this was first experimented with on beef cattle herds back around 1999. Gary Stearman discussed this when the late J.R. Church had his television program “Prophecy In The News”.

The patch contains an enzyme called Luciferase which makes Bill Gates Implantable Quantum Dot Hydrogel ID2020. **This is the end-game for the “Mark” of the Beast System.**

“The Bill and Melinda Gates Foundation came to us and said, ‘Hey, we have a real problem — knowing who’s vaccinated,’” said Kevin McHugh, who was recruited to join Rice University in Texas with funding from the Cancer Prevention and Research Institute of Texas. *“They said, ‘We go on vaccination campaigns where people get into Hummers, drive to a rural village, set up a tent and start immunizing people, but they don’t always know who’s been immunized before and what vaccines are still needed.’”*

Parents often don't know their children's vaccination histories, McHugh said. *"So our idea was to put the record on the person,"* he said. *"This way, later on, people can scan over the area to see what vaccines have been administered and give only the ones still needed."*

"There are two sides to this," he said. *"First, is that you don't administer unnecessary vaccines, which has a cost. But even bigger, you don't leave people under-immunized and at risk of getting an infectious disease."*

McHugh said the team worked with a bioethicist to be sure the patients' data remains protected. *"She said we're on solid ethical ground as long as people can opt out, like getting the patch with only the vaccine. Also, the patch with quantum dots only contains information about the vaccine received. It doesn't tell you anything else about the person."*

The Bill & Melinda Gates Foundation donated \$21-million for this project. Even an amount as small as this to the Gate family is expected to produce a return on their investment, and not always in the same way we might think.

The square-centimeter patches hold up to 16 tiny needles. *"They don't go very deep, which makes them theoretically painless and a lot easier for kids,"* McHugh said. *"They're like putting on a bandage."*

Because the 1.5-millimeter needles disintegrate in the skin, no biohazardous sharps remain for disposal, he said. Testing in model skin in strong light showed the 4-nanometer dots should be readable for at least five years.

McHugh plans to continue his work on the technology at Rice. *"There are so many aspects to this particular project that we need nanotechnologists, bacteriologists, chemists and computer scientists,"* he said. *"So this is certainly something I'm thinking about for my lab here."*

One key component of that is the micro-needle delivery system, when the substance called Luciferase is added it produces under the skin, an array of quantum (nano-sized) dots. The Luciferase allows the dots to fluoresce when illuminated with the correct wavelength of light. Thus the pattern of the dots may be read by an external device.

This means not only can a vaccine or other injectables be put into the body but also a machine readable array, that is unique to each person, like a fingerprint could be added. This would essentially bar-code every person that receives this type of injection. Recall, that the Nazis numbered (they didn't have bar-codes then) all of their victims in the death camps with tattoos on their arms. A 16-needle array can be read or translated in this fashion up to: 1,000,000,000,000,000 or One Quadrillion. This would be miniscule for the QR system. Like QR codes, these designs could be scanned and interpreted by smartphones, and someday allow health providers to archive and access patients' past

vaccinations without the muss and fuss of external records in a doctor's office or hospital archives.

Why these are of such great importance and relevance is this serves as the means of command and control of all who willingly take the "Mark" of the Beast Communications between humans and the antichrist or the antichrist's Quantum Computer will occur through the quantum entanglement of electrons contained within quantum dots.

Within quantum dots, again, are referred to as artificial atoms, electrons are entangled with one another. Instantaneously, they communicate with each other. As the state, referred to as 'spin', or orientation of an electron's northern pole is altered from 'up spin' to 'down spin', or vice versa, the state of its paired electron changes. I have purposefully presented an overview with a minimum of the technical language, focusing instead upon the practical ramifications of the quantum dots delivered by the microneedle array patch. There are versions employing photons, however those using electrons are the more prevalent. Other quantum mechanisms are, of course, at work, specifically annealing, tunneling, and ground states. Reverse transcriptase (RT) is an enzyme used to generate complementary DNA (cDNA) from a messenger RNA (mRNA) template. Reverse transcriptases are used by certain viruses such as HIV-1 and the Hepatitis B virus to replicate their genomes, by retrotransposon mobile genetic elements to proliferate within the host genome, and by eukaryotic cells to extend the telomerase at the ends of their linear chromosomes. The process is not abled for violating the linear flow of genetic information. That's a mouthful but it simply means this process copies the viral genetic material back into the genome of the host DNA. Thus, it permanently alters the host DNA. Those who tell

you otherwise are lying or do not know what they are talking about. Whenever you see the word "modify" mentioned it is your proof that the DNA is being changed from the original.

Retroviral RT has three sequential biochemical activities: RNA-dependent DNA polymerase activity; ribonuclease H (RNase H); and DNA-dependent DNA polymerase activity. Collectively, these activities enable the enzyme to convert single-stranded RNA into double-stranded cDNA, but with the addition of the third-strand of DNA.

In retroviruses (e.g. HIV) and retrotransposons, this cDNA can then integrate into the host genome, from which new RNA copies can be made via host-cell transcription. The same sequence of reactions is widely used in the laboratory to convert RNA to DNA for use in molecular cloning, RNA sequencing, polymerase chain reaction (PCR) testing, or genome analysis.

The employment of a messenger RNA (mRNA) template in this case is for the production of complementary DNA (cDNA). In genetics, cDNA is synthesized from a single-stranded RNA (mRNA) template in a reaction catalyzed by the enzyme reverse transcriptase.


When scientists want to express a specific protein in a cell that does not normally express that protein, they will transfer the cDNA that codes for the protein to the recipient cell. This cDNA is also produced naturally by retroviruses such as HIV-1, and then integrated into the host's genome, where it creates a provirus. A provirus is a virus genome that is integrated into the DNA of a host cell.

When a retrovirus invades a cell, the RNA of the retrovirus is reverse-transcribed into DNA by reverse transcriptase, then inserted into the host genome by an integrase. A retroviral integrase (IN) is an enzyme produced by a retrovirus such as HIV, that integrates (forms covalent links between) its DNA genetic information into that of the host cell that it infects. Be mindful that the virus had been engineered [man-made] with the insertion of 18 fragments of the HIV-1 genome (constituting 80% of the package of an HIV-1 genome). This served as a means of enhancing its potential toxic damage. This is commonly known as the "gain-of-function" to achieve various effects the scientists were working towards. Reading the Abstracts of the patents does indicate what those desired effects are, but perhaps not all.

The present invention relates to a "delivery" method. This method is particularly useful for therapeutic agent delivery of modified nucleic acids, such as modified mRNA (mmRNA). The Pfizer agenda suggests they are preparing the body for future vaccine upgrades by the addition of a third-strand of DNA that will create a compatible hand-shake effect with the QuantumDot:Hydrogel ID2020 microneedle patch.

The larger issue is that of the human body immune system's rejection of the cybernetics [attempt to merge man and machine] as a cyborg!

There are many problems with conventional delivery methods of pharmaceutical compositions to achieve effective protein expression in both therapeutic and bioprocess applications. For example, the introduced DNA can be incorporated into the host cell genomic DNA at a certain signal frequency, resulting in changes and or damage to the host cell genomic DNA. As I have pointed out in other articles on this, 5G EMF “modulated” to 60-GHz consumes 98% of the oxygen in one’s lungs and you are dead before you can hit the floor. Scientists have had twenty years to test their theories without serious oversight of medical transparency and ethics. As such we can only speculate as to the success or failure by their own literature and the scientific journals. In addition, many steps must be performed after delivery, but before production of the encoded protein, to allow protein expression to be achieved. After entering the cell, the DNA must be transported into the nucleus and transcribed into RNA. The RNA transcribed from the DNA must then enter the cytoplasm and be translated into protein. Many process steps from administered DNA to protein not only form a lag time before

the production of functional protein, but each step provides an opportunity for error and cell damage. Furthermore, it is known that achieving DNA expression in cells is difficult because DNA often enters cells but is not expressed or expressed at a reasonable rate or concentration. This can be particularly problematic when DNA is introduced into primary cells or modified cell lines.

Even if the above is properly managed, there is still considerable difficulty to achieve a therapeutically appropriate level of protein for a time sufficient to deliver effectively and produce a clinical outcome. Thus, there is a need for the delivery of biotherapeutic agents that address the hidden difficulties surrounding intracellular translation and process modulation of nucleic acids encoding polypeptides, and thus the optimization of protein expression from the delivered therapeutic agents.

The present invention addresses this need by delivering pharmaceutical compositions that can contain modified nucleic acids, such as modified mRNA (mmRNA), and can further encompass formulations that avoid problems in the art of delivery.

The present invention relates to nucleic acids (RNAs) encoding at least one polypeptide and containing one or more modified nucleosides (referred to as "modified nucleic acids" or "modified nucleic acid molecules" or "engineered nucleic acids"). Including mRNA in particular), this nucleic acid has useful properties, including a lack of substantial induction of the innate immune response of cells into which mRNA has been introduced. Because this mmRNA enhances the efficiency of protein production, the intracellular retention of nucleic acids, and the viability of contacted cells and has reduced immunogenicity, this nucleic acid having these proper ties is referred to as "enhanced" nucleic acid or modified RNA.

This all relates to the employment of mRNA and mmRNA as delivered by the bioluminescent microneedle array patch, resulting in the "Mark" of the Beast, and the permanent alteration of a person's (host) DNA.

The patent describes the delivery of mRNA and mmRNA to encode one or more polypeptides. However, the incorporation into the host cell of genomic DNA at a certain frequency, results in changes and/or damage to the host cell genomic DNA. Peptides are short chains of between two and fifty amino acids, linked by peptide bonds. A polypeptide is a longer, continuous, unbranched peptide chain of up to approximately fifty amino acids, and is known as a protein. In the case of this patent, mRNA and mmRNA express a desired biotherapeutic protein (agent).

Methods for delivering biological material through living tissue are described by Kodgule et al., For example, U.S. Patent Application Publication No. 201110196308, the contents of which are hereby incorporated by reference in their entirety. According to Kodgule, multiple biodegradable microneedles containing a therapeutically active ingredient are incorporated into a device that delivers proteins, carbohydrates, nucleic acid molecules, lipids, and other pharmaceutically active ingredients, or combinations thereof.

A microneedle transdermal delivery device is described by Angel et al., For example, as taught in U.S. Patent No. 7,364,568, the contents of which are hereby incorporated by reference in their entirety. According to Angel, multiple needles are incorporated into a device that transports material into the body surface via needles inserted into the surface from different directions.

Formulations for topical, and/or transdermal administration of compositions include ointments, pastes, creams, lotions, gels, powders, solutions, sprays, inhalants, and/or a patch. In addition, the present invention contemplates the use of transdermal patches. This often has the added advantage of providing controlled delivery of the compound to the body.

The mRNA according to the present invention can also be bound or conjugated to one or more detectable agents. Examples of detectable substances include various small organic molecules, inorganic compounds, nanoparticles, enzymes or enzyme substrates, fluorescent materials, luminescent materials, **bioluminescent** materials, chemi-luminescent materials, radioactive materials, and contrast agents. However, it is not limited to these.

Devices and methods for intradermal delivery of vaccines and gene therapy agents via a micro-cannula have been described by Mikszta et al., For example, U.S. Patent No. 7,473,247, the contents of which are incorporated herein by reference in its entirety).

According to Mitszta, at least one hollow microneedle is incorporated into a device that delivers the vaccine to the subject 's skin at a depth of 0.025 mm to 2 mm.

Devices for delivering substances to the skin are described by Palmer et al., For example, U.S. Patent. No. 6,537,242, the content s of which are hereby incorporated by reference in their entirety. According to Palmer, a series of microneedles is incorporated into a device that uses a stretch assembly to enhance skin-needle contact and provide more uniform delivery of the substance.


Methods for improving the transport of drugs and biological molecules through tissues by improving the interaction between microneedles and human skin have been described by Prausnitz et al., For example, U.S. Patent, 743, 211, the contents of which are hereby incorporated by reference in their entirety. According to Prausnitz, multiple microneedles are incorporated into a device capable of presenting a more rigid and less deformable surface to which the microneedles are applied.

Since I first began my fifty year study of the Biblical “Mark” of the Beast, it has been amazing to see how the “Mark” of the Beast has progressed to become manifested to the point where we are today. 


What is DNA Barcoding?

Barcoding is a standardized approach to identifying plants and animals by minimal sequences of DNA, called DNA barcodes.

It's an honor to work alongside Adobe, BBC and other CCPA members to take this critical work to the next step," Microsoft wrote in a blog post announcing the coalition.

According to Microsoft, the CCPA will *"develop content provenance specifications for common asset types and formats to enable publishers, creators and consumers to trace the origin and evolution of a piece of media, including images, videos, audio and documents."*

Former Microsoft CEO Bill Gates has been a big supporter of modern moves to censor more on social media. During an interview at the *'Wall Street Journal'* Summit in London, Gates complained that the suggestions for suppressing conspiracy theories and "misinformation" on Big Tech platforms are *"less creative than we need at this point"* and called for *"smart solutions."* Mr. Gates was likely attacking his nemesis Robert F. Kennedy Jr., chairman and counsel for the Children's Health Defense Fund, who can bring to bear a larger voice to exposing Bill Gates, and his crimes against humanity.

We firmly believe that ecosystem-wide adoption through an open standard is crucial to the long-term health of the internet. The CCPA will streamline the distribution of high-integrity digital content at scale, a vital step in restoring society's shared sense of reality," Truepic said in a statement.

Robert F. Kennedy Jr., son of Robert and nephew of the late President John F. Kennedy, said that the National Institute for Allergic and Infectious Diseases (NIAID),

Dr. Fauci's agency, will collect 50% of all royalties from a potential coronavirus vaccine. Robert Kennedy Jr. said that Dr. Fauci owns a number of vaccine patents, including (Moderna) that is being trialed to fight coronavirus by some of America's biggest vaccine manufacturers.

The Gates Foundation invests in Dr. Fauci's NIAID as part of its Decade of Vaccines program which aims to introduce a Global Vaccine Action Plan.

Kennedy Jr. said that Dr. Fauci owns a patent for a specific type of vaccine that packages a virus in a protein sheet. The virus is then delivered to the human body through the vaccine and Kennedy Jr said that it very quickly reaches the organs necessary to give a person immunity to a certain illness. 
and 20:4 are the key references to the “Mark” of the Beast. Each referenced verse has to be studied in its context of the chapter in order to glean the big picture.

The Human Race with three strands of DNA?


Many scientists argue about whether people have more than 2 or even 3 strands of DNA. Some even believe we have 12 or more threads of DNA. The name is an acronym. DNA coming from the name of **deoxyribonucleic acid**. DNA contains the codes that give instructions to the cells and tell them how to behave. Most DNA is located in the cell nucleus, while a much smaller portion is located in the mitochondria.



In the traditional model of DNA it is intended to carry an information code, made up of four chemical bases. In a standard DNA has about 3 billion base chemical pairs, and

99% of the DNA is the same for all people. We all know the DNA model with two threads, which is formed when the nucleotides are arranged in the two long fibers, forming a double helix. The structure of the double helix looks a bit like a ladder. How it is structured DNA allows to store up to 700 terabytes of information in only one gram. It sounds amazing, right! There are 10 base pairs per each twist of the double helix.



2. Provoke a Terrified Reaction








