5G, the Mark of the Beast, and the UPC Code

Chapter 16

Back when the World Health Organization declared the Coronavirus known as Covid-19 on March 10th, 2020, it was also becoming known that the alleged virus was really a “bioweapon” and that it was hijacked by scientists and modified through the use of what is called CRISPR-Cas9 “gene” editing technology. This technology was discovered in 2012 and enabled “gene” editing to be done at a mere fraction of the cost of other methods. This method of “gene” editing holds great promise but it brings with it a double-edge sword, meaning that it can be used for evil just as easy as it can be used for good!

A group of Indian research scientists working under IBM in early February of 2020 identified the HIV-1, and SARS-CoV2 pathogens inserted into the samples they obtained and indicated a pattern of what appeared to be “intentional”, albeit a meticulous insertion within four locations on a particular genome of 18 fragments of the HIV-1 genome and 4 fragments of the SARS-Cov-2 genome.

Dr. Luc Montagnier, a 2008 Nobel Peace Prize winner who died this past February 8th of 2022 of cancer at the age of 89, confirmed and verified the discovery by a group of Indian scientists’ that had presented in a paper in late February of 2020. It was later learned in 2022 that Dr. Anthony Fauci, director of the NIAID had exerted pressure on the team to withdraw their paper or face the loss of any future funding for any research work. Dr. Anthony Fauci, a 50-year government bureaucrat with over 35 years as director controlled the purse strings of grant money, the life blood for research science. The IBM-based group in India complied and withdrew their paper. Although the paper had been withdrawn it was still on the Internet when the late Dr. Luc Montagnier took a closer look at the paper and would later confirm the Indian group was correct in their research. This finding was picked up and was the focus of the December, 2020 issue of “*Entangled*” magazine published by Anthony Patch. There was found an uncanny similarity of unique inserts in the 2019-nCoV spike protein to HIV-1 gp120 and Gag. The majority of the issue was devoted to the evidence of what we would consider a “Gain-of-Function” making the pathogen into a “bioweapon”. I will be focusing on Anthony Patch’s analysis, insights, and discernment for understanding his logic and rational and ability to reconcile with Biblical evidence the case Mr. Patch presents to his readers. I never considered writing another chapter to my series but with what I shared in chapters 12, 13, 14, and 15, it seemed appropriate to present his study as part of this eBook.

But before looking at Anthony Patch’s work, I would like to quote from an article by Jon Rappoport posted on February 6th, 2020, a full month before the World Health Organization declared its pandemic on March 10th, 2020. It is eye-opening in its own place in the exposure of the corrupt vaccine industry. Pfizer vaccine raked in nearly \$60-billion in 2021 for “gene” therapy drugs offered as vaccines.

I (Jon Rappoport) repost this story now because, in the rush to develop a vaccine against the China coronavirus in the next 90 days, public health officials are mentioning several experimental technologies---never before released openly for public use.

One of those technologies is: DNA insertion.

The reference is the ‘*New York Times*’, 3/10/15, “*Protection Without a Vaccine.*” It describes the frontier of research. Here are key quotes that illustrate the use of synthetic genes to “*protect against disease,*” while changing the genetic makeup of humans. This is not science fiction:

“By delivering synthetic genes into the muscles of the [experimental] monkeys, the scientists are essentially re-engineering the animals to resist disease.”

“‘The sky’s the limit,’ said Michael Farzan, an immunologist at Scripps and lead author of the new study.”

“The first human trial based on this strategy --- called immunoprophylaxis by gene transfer, or I.G.T. --- is underway, and several new ones are planned.” [That was nearly five years ago.]

“I.G.T. is altogether different from traditional vaccination. It is instead a form of gene therapy. Scientists isolate the genes that produce powerful antibodies against certain diseases and then synthesize artificial versions. The genes are placed into viruses and injected into human tissue, usually muscle.”

Here is the punchline: *“The viruses invade human cells with their DNA payloads, and the synthetic gene is incorporated into the recipient’s own DNA. If all goes well, the new genes instruct the cells to begin manufacturing powerful antibodies.”*

Read that again: *“the synthetic gene is incorporated into the recipient’s own DNA.”*

Alteration of the human genetic makeup.

Not just a *“visit.”* Permanent residence!

The *‘Times’* article taps Dr. David Baltimore for an opinion:

“Still, Dr. Baltimore says that he envisions that some people might be leery of a vaccination strategy that means altering their own DNA, even if it prevents a potentially fatal disease.”

This is genetic roulette with a loaded gun.

More investigation is likely to reveal that federal money received was temporally linked to e-mail blasts, town hall meetings, public service announcements and many other activities pushing mass vaccination.

Could COVID-19 Community Corps money to the AMA have been the reason why the AMA launched its campaign to “abolish” the use of ivermectin in 2021 so the public would be panicked into taking more shots?

How could the pediatric associations take federal money before the clinical trials for their patients were completed or the vaccines approved via EUA?

Did they promote the vaccines to pediatricians before clinical trial results were known?

Finally, how could federal dollars flow to gynecologists/obstetricians when pregnant women and those of childbearing potential were excluded from randomized trials reported just a few months before the HHS initiative?

These broad acts of public bribery, corruption, and vaccine racketeering worked to put millions of lives in danger as we learned about the risks of COVID-19 vaccination in 2021.

As we sit here today in early December, 2022, the CDC VAERS system through November 25, 2022, is reporting 15,508 U.S. deaths after COVID-19 vaccination, 22% occurred within 96 hours of the shot. There have been 15,505 Americans disabled, 9,266 with heart damage, and 356,269 office visits, urgent care encounters, or hospitalizations attributed to vaccine side effects.

The actual death total reported by the CDC is more than double that before the CDC stopped releasing week data and statistics in early September, 2022. The '*Children's Defense Fund*' posted on their site a detailed weekly summary of death statistics and my last weekly "Mass Murder" report was #85 posted on 9/17/22. The death figure will be found in this [Mass Murder, Part 85](#). I recall it had passed over 31,000 or above that figure. The CDC and the FDA have been discredited numerous times in the past two years and their reports are regularly adjusted or modified to the lower ranges.

Never again can we allow our public health agencies use unchecked financial power to promote any medication or vaccine to healthcare providers. Corruption and indoctrination are deadly.

Dr. Peter A. McCullough, MD, MPH has been demonized by the government, public health, pharmaceutical, and medical community for exposing the Covid-19 crimes against humanity. He was fired from his position at Baylor University Hospital in Texas, attacked by credential committees seeking to defrock and destroy his impeccable medical career in cardiology, and who authored more papers than any other physician in U.S. medical journals.

Kentucky Senator Rand Paul told Fox News in early December, 2022 that Dr. Anthony Fauci was responsible for the death of at least 7-million people. By 2025 Deagel predicts US population will be reduced from 327 to 100 million.

On 4/20/21, Deagel.com, a military intelligence agency, has deleted their mysterious 2025 forecast spreadsheet that predicted a major collapse of the western countries. The forecast used to exist at [\[link to deagel.com \(secure\)\]](#) and now that page just redirects to the home page.

The spreadsheet predicted a major drop in the U.S. population from 332 million in 2019 to only 99 million in 2025 (-70%). Intuitively, I felt led to make a brief screen shot recording of the forecast on 4/19/21, the day before it was deleted from the Deagel web page. You will find it interesting that this deletion was made within 24 hours of every American over the age of 16 qualifying for their COVID-19 vaccine. I followed the Deagel Report beginning around 2009 and considered all the scenarios that might bring about such a drastic decline in the U.S. population for 2025, now just two years away. The answer seems obvious now but this prediction was on their web page for more than a decade, and that begs the larger question who knew what and when and why?

It is no longer a secret that New World Order globalists are proponents of eugenics and world depopulation, as was Woodrow Wilson, Adolf Hitler and as are Hillary Clinton, Barack Hussein Obama and Planned Parenthood. Indeed, government data aggregator Deagel.com, Prince Charles Agenda 21 and Ted Turner's Georgia Guidestones predict higher than 70% population reduction by 2025-30.

After COVID we can draw two major conclusions:

The stark reality of diverse and multicultural Western societies is that a collapse will have a toll of 50 to 80 percent depending on several factors but in general terms the most diverse, multicultural, indebted and wealthy (highest standard of living) will suffer the highest toll. This is being driven by supply chains breaking down, manipulated oil and gas shortages, ocean shipping costs skyrocketing, monthly double-digit inflation, etc.

The only glue that keeps united such an aberrant collage from falling apart is overconsumption with heavy doses of bottomless degeneracy disguised as virtue.

Nevertheless, the widespread censorship, hate laws and contradictory signals mean that even that glue is not working any more. Not everybody has to die. Migration can also play a positive role in this.

The formerly known as second and third world nations are an unknown at this point. Their fate will depend upon the decisions they take in the future. There are many signs this is straining public compliance in many nations around the globe.

Western powers are not going to take over them as they did in the past because these countries won't be able to control their own cities far less likely countries that are far away. If they remain tied to the former World Order they will go down along with the Western powers.

There is a lot of bad blood in the Western societies and the protests, demonstrations, rioting and looting are only the first symptoms of what is coming. However a new trend is taking place overshadowing this one.

Six years ago the likelihood of a major war was tiny. Since then it has grown steadily and dramatically and today is by far the most likely major event in the 2020s.

Another particularity of the Western system is that its individuals have been brainwashed to the point that the majority accept their moral high ground and technological edge as a given.

This has given to the rise of the supremacy of the emotional arguments over the rational ones which are ignored or deprecated. That mindset can play a key role in the upcoming catastrophic events. Critical thinking skills appear lacking in much of the culture today.

Over the next decade it will become obvious that the West is falling behind the Russia-China block and the malaise might grow into desperation. Going to war might seem a quick and easy solution to restore the lost hegemony to finally find them into a France 1940 moment. This is certainly a manifestation driving the Atlantic alliance or NATO to think that they can destroy Russia using a client state of the Ukraine to do it. 'Time' magazine announced their man of the year is Ukraine Dictator Zelensky. 'Time' magazine chose another Nazi as their man of the year in 1938, Adolph Hitler!

If there is not a dramatic change of course the world is going to witness the first nuclear war. The Western block collapse may come before, during or after the war. The Washington Beltway crowd is determined to defeat Russia even if it means that every Ukrainian man, woman and child dies in the process. I might add that the Bible predicts it in the Revelation 6:8 passage when it speaks of a fourth of humanity will die by war.

It does not matter. A nuclear war is a game with billions of casualties and the collapse plays in the hundreds of millions. An interesting statement regarding the forecast was made by the authors on Deagel's forecast page on October 26, 2014.

"Historically a change in the economic paradigm has resulted in a death toll that is rarely highlighted by mainstream historians. When the transition from rural areas to large cities happened in Europe many people unable to accept the new paradigm killed themselves. They killed themselves by a psychological factor. This is not mainstream but it is true. A new crisis joins old, well-known patterns with new ones."

We are not a death or satanic cult or arms dealers as some bovine excrement as is floating around the internet on this topic. Take into account that the forecast is nothing more than a model whether flawed or correct. It is not God's word or a magic device that allows us to foresee the future.

Henry Kissinger & NSSM 200

On Dec. 10, 1974, the U.S. National Security Council under Henry Kissinger completed a classified 200-page study, It has overshadowed world events since it was published.

“National Security Study Memorandum 200: Implications of Worldwide Population Growth for U.S. Security and Overseas Interests.”

The study falsely claimed that population growth in the so-called Lesser Developed Countries (LDCs) like India was a grave threat to U.S. national security.

Adopted as official policy in November, 1975 by President Gerald Ford, NSSM 200 outlined a covert plan to reduce population growth in those countries including India through birth control, and also, implicitly, war and famine.

Brent Scowcroft, who had by then replaced Kissinger as national security adviser, was put in charge of implementing the plan. CIA Director George Bush was ordered to assist Scowcroft, as were the secretaries of state, treasury, defense, and agriculture.

King George VI & Royal Commission On Population

The bogus arguments that Kissinger advanced were not original.

One of his major sources was the Royal Commission on Population, which King George VI had created in 1944 *“to consider what measures should be taken in the national interest to influence the future trend of population.”*

The commission found that Britain was gravely threatened by population growth in its colonies – the biggest being India, since *“a populous country has decided advantages over a sparsely-populated one for industrial production.”*

The combined effects of increasing population and industrialization in its colonies, it warned, *“might be decisive in its effects on the prestige and influence of the West,”* especially effecting *“military strength and security.”*

NSSM 200 similarly concluded that the United States was threatened by population growth in the former colonial sector.

It paid special attention to 13 *“key countries”* in which the United States had a *“special political and strategic interest”*: India, Bangladesh, Pakistan, Indonesia, Thailand, the Philippines, Turkey, Nigeria, Egypt, Ethiopia, Mexico, Brazil, and Colombia.

It claimed that population growth in those states was especially worrisome, since it would quickly increase their relative political, economic, and military strength.

Population Control Law

This policy, known infamously as ‘Depopulation Policy’ and being normalized through Hollywood movies, the latest being personified by Thanos in Marvel’s Infinity War was imported to India via the United Nations’ Agenda 21. **Thanos** is the Greek word for immortal and **Thanatos** is the Greek word for death!

The new Population Control Law being advocated recently is actually the impetus for Agenda 21 which is a British policy [think of Prince Charles of Wales “Sustainable Development” agenda] to reduce the population of former colonies like India through various sterilization projects and other policies implemented through the United Nations and popularized by Hollywood to effectively keep nations under Anglo-American orbit.

We know from Dr. David E. Martin’s reports that in the late 1990s the government had a big problem on their hands with its “Social Contract” with the American people. It has been obvious for years that the Social Security System was unable to meet its obligations with the “Baby Boomer” generation coming of retirement age. Just a few days ago, I read that after 2035 Social Security benefits will be reduced by 20%. Several reports from a few years ago indicated that the program would be bankrupt by 2025. Dr. Martin said that the government could have corrected the problem in 1996 but congress decided to ignore and let it collapse.

While I have no specific documents to support my theory, I believe that decision was likely to be what is referred to as **“The New Manhattan Project”**. I am not referring to atomic weapons, but rather is considered to be a ‘*Silent Weapon for a Quiet War*’ [Chemtrails Exposed: A New Manhattan Project: second edition](#) by Peter A. Kirby published on May 11, 2020. The U.S. and other countries are being aerial sprayed like pesky cockroaches with heavy metals, poisons, toxins, chemicals, and pathogens intended to damage respiratory systems of humans. The program went active in a large-scale way during the fall of 1996 continuing to the present day. Using commercial jet aircraft and U.S. Air Force aircraft that have been configured to hold the tanks of toxic soup that crisscross the country. There is a third element that being the use of contract aircraft companies such as Evergreen Air, American Air, and others like them.

Evergreen Air is a CIA front company for chemtrail operations within the U.S., based out of Marana Air Park near Tucson Arizona and McMinville Oregon, near Portland.

Nigeria limits cash withdrawals as part of aggressive push toward digital-only currency system

The Central Bank of Nigeria announced this week it would cap daily and weekly bank withdrawal amounts *"in line with" its "Cashless policy."*



([LifeSiteNews](#)) — The Central Bank of Nigeria (CBN) announced Tuesday that it is capping daily ATM withdrawal at 20,000 naira (\$45) to encourage digital banking options.

The CBN directed all deposit money banks to limit daily and weekly ATM withdrawals as well as weekly over-the-counter cash withdrawals “in line with the Cashless policy of the CBN,” according to its Tuesday [press release](#).

Weekly over-the-counter cash withdrawals are now capped at 100,000 naira (\$225) for individuals and 500,000 naira (\$1,124) for corporations, with new processing fees of 5 percent and 10 percent, respectively, for excessive withdrawals.

ATM cash withdrawal is also now limited to 100,000 naira (\$225) per week.

“Customers should be encouraged to use alternative channels (Internet banking, mobile banking apps, USSD, cards, POS, eNaira, etc.) to conduct their banking transactions,” the central bank said.

The financial news outlet ‘Pyments’ framed the new restrictions as a “*step toward pushing Nigerians to embrace the country’s newly minted central bank digital currency (CBDC), eNaira,*” which was launched last year.

“Finally, please note that aiding and abetting the circumvention of this policy will attract severe sanctions,” the press release concluded.

Nigeria is one of a growing number of countries limiting cash use in favor of digital payments. In August, Israel restricted the use of cash for payments to businesses as well as between private citizens. Australia is cutting down on banks themselves, and experts predict that its shift to digital currency will leave the country effectively cashless by 2031 or earlier.

Over 100 countries are exploring a CBDC digital payment option, according to the Atlantic Council. Eleven countries (primarily in the Caribbean) have launched a CBDC, and 50 countries are in an advanced phase of exploration (development, pilot, or launch).

Even the United States, which is considered along with the UK to be the furthest behind in CBDC development among the G7 countries, the digital payment “infrastructure” of CBDCs is ramping up, according to financial adviser Joe Brown.

On August 29, the Federal Reserve announced that its digital instant payments service FedNow would begin “*full-scale pilot testing*” in mid-2023. FedNow would allow “*24/7 settlement ... that happens instantly from bank to bank.*”

Financial experts such as economist, investor, and former Central Intelligence Agency (CIA) official Jim Rickards are warning against CBDCs because they enable government tyranny.

Rickards has [asserted](#) that “many experts,” himself included, believe a U.S. CBDC “will begin an era of total government control and surveillance.”

Neel Kashkari, president of the Federal Reserve Bank of Minneapolis, openly questioned in August what CBDCs can do that a digital payment system like Venmo cannot. He argued that the difference is that with CBDCs, the government can “*monitor every one of your transactions*” and “*directly tax customer accounts.*”

The global Rothschild-led cabal of central banks of 194 countries, in order to keep the petro-dollar system functioning for a few more years required a world-wide crisis that would keep global economies operating, but with greatly reduced activity required them to create the pandemic scam in order to lock people down at home living in fear. At this point the scam of a virus proved to be the trick.

CRISPR “gene” editing technology was discovered in 2012, and bio-labs around the world have been experimenting with the Coronavirus for years looking for a virus that would be so lethal to kill a larger percentage of the people in a given community. For example, Ebola has a kill ratio of 80%, or out of 10 infections, 8 will die in weeks. Outbreaks of Ebola in Africa claimed as much as 90% of those infected. COVID-19 - Definition: A virus is a submicroscopic infectious agent that replicates only inside the living cells of an organism. - Previously, there have been 7-8 prior coronavirus strains such as MERS, SARS. - COVID-19's genetic sequence was generated by scientists in January, 2020, which documented that CRISPR gene editing technology was used to perform genetic editing of the coronavirus virus cell at its DNA level. The Covid vaxxes are “bioweapons” created from the common cold virus and strains of the yearly flu.

CRISPR gene editing is a genetic engineering technique in molecular biology by which the genomes of living organisms may be modified. It is based on a simplified version of the bacterial CRISPR-Cas9 antiviral defense system. By delivering the Cas9 nuclease complexed with a synthetic guide RNA into a cell, the cell's genome can be cut at a desired location, allowing existing genes to be removed and/or new ones added in vivo. -Wikipedia

I know that is a huge mouthful but since 2012, scientists have been able to re-write animal, plant, and human DNA, and that means they can create an infinite array of viruses, customized to make you sick, damage your immune system, and kill you instantly or delayed, all at little expense. Indian scientists discovered that the Corona virus was made lethal with the HIV1 pathogen as early as February, 2020.

Now you know how it was created, but where and why? The government essentially removed the bulk of traditional industry risks related to vaccine development: a) scientific failures, b) failures to demonstrate safety and efficacy, c) manufacturing risks; and d) market risks related to low demand."

"In response to the Covid-19 pandemic, the government leveraged investments in those platforms in three ways. First, it supported additional preclinical studies. Second, it absorbed the bulk of human testing costs and risk through a set of contracts that paid for the various phases of vaccine development and manufacturing. And third, it reduced manufacturing risk by underwriting capacity investments."

"The government also largely eliminated market risks through advance purchase agreements. These contracts involved negotiation over price and quantity that ended in mutually agreeable contract terms between the government and industry."

So we can see how our own government went out of the way - to the extreme - to bring this deadly "vaccine" to its own people. The above shows the depth of planning that went into this "plandemic" by our own government. Demanding 'a vaccine in every arm'! 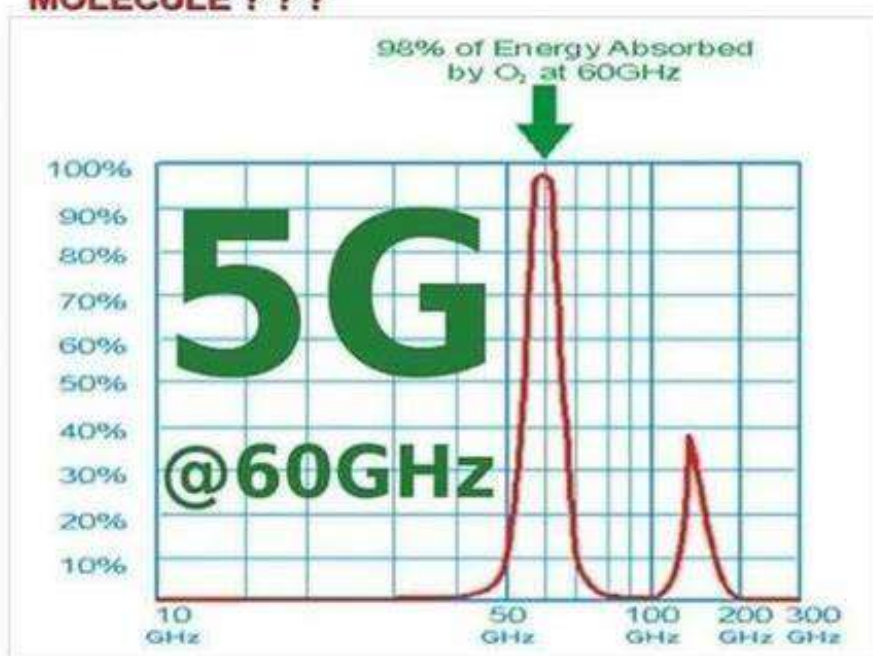

To close on what I wanted people to understand about Anthony Patch's article in *'Entangled'* magazine, is that the "Mark" of the Beast as described below was based upon the Micropatch Tattoo Microneedle plan. Due to the fact the global elite had to execute their plan sooner than originally planned, they were forced to improvise their system of delivery through a "syringe" needle and vaxx. There were not enough of the Micropatch supplies ready to roll out to a world-wide public market.

When you read the rest of this article, the term "microneedle patch array tattoo" and the brief term "vaxx", Anthony Patch equates as being one in the same, but different terms or labels to differentiate methods.

I noted on page 6 above that at least **262,908,216** people or **79%** of the population have received at least one dose. - The vaccine tattoo is comprised of microneedle arrays that deliver both a DNA-based vaccine and a quantum dots-based record into the body. - At the same time, it invisibly encodes vaccination/medical history directly into the skin;

Graphics and illustrations from the original article are taken directly from patent-related medical literature but not reproduced here.

The DNA modified vaccine administered via the microneedle patch does not require any temperature control management for storage and shipping. - Therefore, it is easily distributed by postal service, Amazon, Fed Ex.

- It can be applied by anyone, even at home; not even a child would mind having a 'band aid' applied.

Quantum dots:

- The microneedles deliver the quantum dots via the vaccine into the body.

- It provides documentation detailing the type of vaccine given, who administered it; verifies that change occurred within your DNA; etc.;
- The vaccine record is to serve as certificate of proof, allowing a person to go about freely, (work, school, travel, etc.).
- It functions as a tracker: Surveillance; Facial recognition; Remote sensing devices.

Vaccine Tattoo (Location)

- The tattoo/patch will be applied to either the hand/or forehead;
- This is a matter of personal preference and convenience:
- Currently, people are having their temperature taken before allowed into a building (shop, school, mall) and the forehead is used for easy access;
- A person wearing protective equipment (i.e., gloves) would have to pull back the glove to expose the hand and would choose the forehead.

5G: (General)

- **5G** is used to connect everything; sometimes referred to as the 'Internet of Things';
- **5G** will be used to trigger (forces the insertion of) the DNA derived vaccine through electroporation (opening the pores briefly) into the body's cell membranes.
- This "triggering" by **5G** results in changes at the body's DNA level without a person even knowing. This means that the person is connected to the 'hive mind'.
- **5G** is the mechanism used to link the vaccine tattoo to the Cloud system.
- **5G** technology is used, among other things, such as directed energy weapon; Phased-array weaponry such as in crowd control; Contact tracing, and social distancing.
- Once the vaccine tattoo is applied, it becomes the only proof of record that the vaccine is embedded in the skin; This is verified through interrogation by **5G** (i.e., phone app) a scanner that can read UV light or Luciferase bioluminescence dye.
- It's Important to understand that:
- A person's full medical history will not be inserted subcutaneously;

- A person's complete medical information and all other private data will be stored in cloud-based server farms containing blockchains.

- The 'tattoo' acts as an antenna to receive/send **5G** signals; - Through the transmission of **5G** wave signals to the cloud, which is then transmitted to the blockchain, it allows blockchains to verify the information.

5G-Related Health Concerns:

- It is important to mention that the power densities of **5G** are up to 30 times higher than previous systems of 1G to 4G.

- Given the high pulsation level for **5G** radiation, even short exposures may well produce severe biological effects.

- Examples of **5G** radiation health related symptoms

- Metabolic disturbances; Cancer;

- Reactive Oxygen Species Generation; Sensory Disorder;

- Neurodegeneration;

- Genotoxicity and Carcinogenic; Sleep disorders;

- Immunotoxicity and inflammation;

- Infertility;

- Congenital Abnormalities;

- Apoptosis (cell death), and necrosis (tissue death);

5G exposure vs. Coronavirus Infections: (Similar symptoms)

- Infertility; Sperm /Testicular damage;

- Neuropsychiatric Damage;

- Cellular DNA Damage; Genetic damage;

- Apoptosis (cell death);

- Cardiac/Blood pressure disruptions.

Biosensors:

- Definition: A biosensor is an analytical device used to detect a chemical substance that combines a biological component with a physicochemical detector.
- Biosensors, which are administered along with the vaccine, become fully embedded and fully part of a person's DNA.
- Biosensors are placed throughout the environment that send results to the cloud.

ID 2020 (Digital Identity Alliance):

- Goal: To create universal digital identities for everyone in the world, the entire population, without which the controlled population cannot access goods and services
- Vaccinations are to play a significant role in completion of the ID2020 digital identity program agenda in which everyone receives a permanent digital ID. This would be like the UPC or EAN bar code but invisible to the human eye.
- However, they are not for the purpose of administering an actual microchip-like device into the body.
- But rather to serve as the opportunity to apply biocompatible near-infrared quantum dots, delivered into the skin by microneedle array as a record of vaccination.

It is worth noting that this upgraded system goes way beyond microchipping.

- The plan is to combine ID 2020 with quantum dot technology via the vaccine tattoo.
- Embedded in this tattoo is digital technology that records and verifies that a person has received the vaccine.
- The microneedle array/patch/tattoo: Meets the requirements of ID 2020.

Blockchain: - A blockchain is an append-only public ledger to which anyone can write and read.

- At the core of the blockchain is a consensus mechanism that allows nodes to agree on changes to the ledger, while ensuring that changes once confirmed cannot be altered.
- Blockchain technologies are gaining popularity due to public indoctrination promoting privacy, security, convenience and distrust of mainstream banking systems.
- All of your medical, personal, and financial information become linked to the blockchain system.

Cryptocurrencies: - Definition: Cryptocurrency is a digital asset designed to work as a medium of exchange using cryptography to secure the transactions, to control the creation of additional units, and to verify the transfer of assets. Cryptocurrencies are classified as a subset of digital currencies and are also classified as a subset of alternative currencies and virtual currencies.

Patents for Microsoft in which human beings, human bodies, are connected by Wi-Fi to the blockchain and the biosensor arrays picking up on the movements of the body including the eyes picking up on brainwave activities that are intended to fulfill a task, assigned by a computer, by a server, a task assigned to a human. – Microsoft's pending Cryptocurrency Patent was assigned the following Number: WO2020060606 World Order 2020 060606.

Libra Blockchain System:

- All existing cryptocurrencies operate for the purpose of speculating on future values, not transactions.
- Present cryptocurrencies are designed for speculative investment purposes only.
- Each, along with sovereign currencies, are planned for obsolescence with the advent of Libra mid-2020. [Implementation has been delayed to early resistance.]

Libra is designed to be the single global currency as a result of worldwide economic collapse and forthcoming debt jubilee, debt reset;

- It is expected that Libra will rapidly encompass all global transactions, including those of individuals, which is something existing cryptocurrencies inherently are incapable of performing.
- End Point: To render all cryptocurrencies obsolete making it the single form of global currency
- Concordia is behind Libra. Concordia is headquartered in Greece.

Background:

- The vaccine to be used to immunize against the novel COVID-19 virus needs to be a DNA modified vaccine to attack at the DNA level of the genetically modified virus.
- Although a specific vaccine is yet to be identified, there are several patents for DNA modified vaccines pending with some in Phase 1.

[What I am describing here is the ultimate delivery method planned, and up until now, the Covid-19 scamdemic because it was released prematurely, and required delivery by syringe needle. The virus scare was to keep people locked down in order to cover a global financial problem – over half of the 194 nations are in bankruptcy.]

Those having received the shots received what is call a “delivery” system, in which the nanoparticles were “gene” therapy, including mRNA, spike Protein (PEG), graphene oxide, and other pathogens that have since been discovered by investigative research labs. The pathogens are designed to self-replicate once inside the cell tissue of the individuals who volunteered to receive the shots.

- The delivery system (syringe versus patch) is yet to be verified, but the Micron patch is expected to be deployed in the not too distant future.
- It is the only delivery system that meets all of the requirements, and - It is already available on the market.

The Vaccine tattoo is multifaceted: Physical; Mental; Spiritual.

- One cannot separate the physical from the spiritual.
- The spirit world affects our physical world, and our physical world is only temporary.
- Taking the DNA modified vaccine alters the focal point of what makes us who we are:
- Physically: Our DNA comprises the infrastructure of our body:
- If we take the vaccine tattoo (or the shot), we are no longer fully human. (Human 1.0)
- We now belong to the Human 2.0 category.
- Spiritually: Our DNA reflects that we are made in the image of God - We are no longer God's creation if we take the DNA modified vaccine and accept the vaccine tattoo.

There are three components to the beast system: Mark; Name; Number:

#1. Mark: Only he that had the mark (technology);

#2. Name: Or the name of the beast (technology records and identifies your name);

#3. Number: Or the number of his name.

Once you take the Vaccine/Tattoo Mark of the beast:

- You are identified by name as someone who is now in the beast system.

- You are identified as being apart from God.

- Now the two separate components to the mark are personal:

- Your personal name: is now written into the beast system.

- Your personal number: Your personal number (Social Security #; Personal #) is now recorded in the beast system. The vaccine/tattoo delivery system makes up the complete package of the beast system:

On March 24, 2020, Bill Gates was interviewed by Chris Anderson, the curator of non-profit that conducts the popular TED Talks. While discussing what the future would look like in a post COVID-19 world, he stated, *“Eventually what we’ll have to have is certificates of who’s a recovered person, who’s a vaccinated person’ Because you don’t want people moving around the world where you’ll have some countries that won’t have it under control, sadly.”*

If a person willingly takes the vaccine/tattoo:

- The modified DNA vaccine is delivered via the applied microneedle array patch to the arm or forehead. (Mark of the beast)

- The person’s information (medical, personal, financial) is then automatically transferred via **5G** to the cloud.

- The person's data is then transmitted into the blockchain (Infrastructure of the beast system)

- The person’s name is recorded in the beast system; (Name of the beast)

- The person's number is recorded in the beast system (Number of the beast)
- Proof of vaccination; Proof of record; Proof of mark; Proof of DNA changed
- **5G** then transmits this information to the cloud, then sends it on to the blockchain and automatically linked to cryptocurrency. (Beast system)
- The person is now wholly embedded into the complete package of technologies
- The person is not aware their DNA has been changed
- The person doesn't even know that they have given up their ability to think independently having been connected to the blockchain
- The person's name is no longer found in the Lamb's Book of Life.

What does it mean to *“throw the switch”*

- Globally there is now a big push for **5G**, which is part of the infrastructure of the beast system. It will be a year or two before the world is fully connected to the **5G** networks.
- Not only are they accelerating the deployment of **5G**, but they're getting ready to throw the switch.
- Once the vaccine, along with the biosensors, have entered the body via the quantum dot tattoo, they are dispersed throughout the body.
- As of December 14, 2022 there are 7,000 **5G** satellites circling the globe and by 2025, there will be in excess of 50,000 5G satellites in orbit.

Then the body's cells are triggered by **5G** which drives the modified DNA vaccine into the cells at the DNA level (resulting in the DNA being changed);

- Then through **5G**, a person is connected to the cloud and then to the blockchain. - Thus, the person is now completely connected to the infrastructure of the beast system.

- It's through these pulsed electrical signals (**5G**) that open up the cells that is referred to as **"the throwing of the switch"**. Mandated vaccination - Appearing on the near horizon (end of 2020/beginning 2021, but has been delayed until the Petro-Dollar is collapsed);

- Presently, contact tracing is being ramped up; - Contact Tracing Investigators are currently being trained and are reaching out to people;

- U.S. Military to be deployed for testing;

- The next step is to introduce mandatory testing; - From mandatory testing, this will lead to mandatory vaccination. [While this has not happened yet for every person alive, a forthcoming World Health 'Pandemic Treaty' is being debated at the UN. It is expected to be ratified by all 194 countries, and at that point your freedom of choice will be nullified.

Right now, it is a free-will decision to take the vaccine/tattoo once available:

- People don't understand the consequences of taking a genetically modified vaccine, much less the impact related to the technologies.

- People have no sense or hint of the danger taking the vaccine tattoo, which is, in reality, is the mark of the beast and has eternal repercussions.

- People aren't aware or if they heard about it, don't want to believe what's coming.

A patent granted to Bill Gates awarded the self-appointed world health czar the “*exclusive rights*” to computerize human bodies and use them as local wireless networks.

The human body is a vibrating, throbbing, pulsing gateway of tubes and tunnels, filled with electrolytes and all capable of transmitting information, the lifeblood of the internet and the 21st century.

Now it has emerged that Gates’ Microsoft was granted “*exclusive rights*” to this ability of the body to act as a computer network.

If this sounds too much like science fiction, then you are welcome to check this out for yourself. Microsoft was awarded U.S. Patent 6,754,472, which is titled: *Method and apparatus for transmitting power and data using the human body*.

Which really should be science fiction, if you stop to think about it. Did anybody consult you about whether you are willing to hand over to Bill Gates the exclusive rights to your body?

Civil liberties groups have expressed outrage over Gates’s move to patent the human body. “*Body parts, in this case skin, should not be in any way patentable,*” said Jim Thomas of the ETC group, which monitors developments in technology. “*There are big questions here about whether individuals will be able to refuse this technology if it is used in, for example, tracking devices.*”

Klaus Schwab’s right hand man, Yuval Noah Harari, says there is no question that individuals will have no say whatsoever about refusing this technology. According to Harari, “*The designer of life will no longer be God, the WEF are going to be the designers of the future of life.*”

Harari also explains why Gates’ patent on the human body is so important. Gates was at the forefront of the computer science revolution, according to Harari, and he is also at the forefront of “*the revolution in the biological sciences.*” And guess what? According to Harari, Bill Gates’ two revolutions are about to merge.

While Harari is dropping some hints, Gates is remaining coy about what they plan to do to the human body, and more to the point, whose human bodies they plan to computerize.

The big question is whether Gates is planning to allow his human subjects a choice in the matter. It remains to be seen whether he uses the carrot or stick but neither is likely to be to our liking.

According to Robert F. Kennedy Jr, Gates has a “*God-like willingness to experiment with the lives of lesser humans.*”

Kennedy Jr. goes on to warn that Bill Gates has used his money to systematically purchase “*powers exceeding, in some respects, those wielded by presidents*” and is using these powers to experiment on human beings like “*guinea pigs*”.

“Gates’ strategy of buying WHO [World Health Organization] and purchasing control of U.S. health officials like Tony Fauci & Deborah Birx” means the Microsoft co-founder can now “dictate global health policies affecting 8 billion people and to control the most intimate details of our lives,” said Kennedy Jr. on his Instagram page.

“Under his direction, the WHO is conducting global social and medical experimentation applying Gates’ religious faith that he can use technology (vaccines and GMO agriculture) and his deep understanding of computers to make him the savior to all of humanity. We are his guinea pigs.”

But if you think Bill Gates’ plans for humanity are disturbing, wait until you meet the people he is collaborating with.

A controversial proposal by a New York University professor to combat ‘climate change’ through biohacking has attracted the attention of World Economic Forum *and* the Gates Foundation. Strap yourself in. Things are about to get weird.

Matthew Liao, a bioethicist at NYU, first presented the proposal in a [paper](#) he wrote in 2012. Titled ‘[Human Engineering and Climate Change](#)’, the crux of the paper argues for the use of *radical biomedical interventions* on humans so as to create people who are literally physiologically environmentally-friendly.

These biomedical interventions involve three approaches: **a eugenics program against tall people, inducing intolerance towards meat** including beef, pork and chicken, and **radically lowering birth rates by altering women’s cognitive abilities**.

Liao states that its necessary to have a eugenics program that breeds tall people out of the population because the increase in human height over the past few centuries has had a negative environmental impact, because tall people consume more calories.

To carry out the eugenics program, Liao has two suggestions. The first one being the genetic screening of embryos before IVF implantation so that parents can have the option to **choose children who are likely to be short and small**. Liao’s second suggestion is even more radical, and involves **injecting children with hormones to severely stunt their growth so they consume less calories when they are adults**.

As for inducing meat intolerance, Liao uses the globalist elites favorite excuse; ‘climate change’, **to argue that we must make people allergic to meat**, by stimulating the immune system against common bovine proteins.

This is taking authoritarianism to a whole new level, far surpassing anything attempted in Mao’s China or Stalin’s Russia.

Instead of eating meat, as humans have since time began, the WEF want us to eat Bill Gates' lab-grown meat. The elite also have a thing for cannibalism. Here is WEF-aligned transhumanist politician Ben Zion consuming lab-grown human meat in what he claims is a historic first.

The 40 year-old-Facebook politician turned biohacker claims the lab-grown human meat is from cell cultures that he took from his own skin.

Why do they want us to eat crickets, bugs and lab-grown human meat? The answer lies in how badly the elite want to humiliate and degrade us.

But Liao's suggestions don't stop there. Getting onto the elite's favorite topic, depopulation, and Liao suggests that to lower birth rates even further, the WEF should pump women full of smart drugs to enhance their cognitive abilities. He arrives at this conclusion by arguing that the more educated women become, the less children they have.

"Women with low cognitive ability are more likely to have children before age eighteen," says Liao, "Hence, another possible human engineering solution is to use cognition enhancements such as Ritalin and Modafinil to achieve lower birthrates."

When Liao published his paper almost a decade ago, it caused controversy, and was for the most part dismissed as eco-extremism, even by 'climate change' activists. But fast forward to the present day, and the extreme bioengineering proposals of the paper are being seriously discussed at the World Economic Forum.

Last year in December, in preparation for this year's Davos Summit, the World Economic Forum unveiled its bioengineering framework in a presentation called ['3 Scenarios for How Bioengineering Could Change Our World in 10 Years.'](#)

Edible vaccines grown in plants and [CRISPR gene-editing](#) were some of the highlights of the framework. The presentation was based off a World Economic Forum sponsored academic paper called [Bioengineering Horizon Scan 2020](#).

For this year's Davos Summit, Liao's human bioengineering paper was added to the 'Bioengineering Horizon Scan 2020' paper for both the World Economic Forum's bioengineering framework and Climate Change framework.

As radical as Matthew Liao's human bioengineering suggestions might seem, their consideration and deliberation by the World Economic Forum should come as no surprise.

Bill Gates is a fan of experimenting on the human body, whether his human subjects have given their consent or otherwise, and Klaus Schwab considers bioengineering a key component of his [Fourth Industrial Revolution](#).

Do not underestimate these people. They are mad, drunk on power, and they do not have our best interests at heart. The World Economic Forum web site is a multi-layered network of what embraces every aspect of human life as was noted in chapter 15, showing that Bill Gates holds patents on Covid related aspects at least several years before the Covid-virus plan was executed as part of the plan to “chip” and enslave humanity. I was aware of the Gates plan to “microchip” humanity in 2013. Being well-prepared to know what to look for from the passages of the Book of Revelation, it was not even a Segway leap to see how Mr. “philanthropy” Gates was buying control of science and technology that could and would be used for evil purposes.

Dr. Joseph Mercola had this to say about Mr. “philanthropy” Gate just recently:

“While philanthropy is considered noble, some philanthropists appear to be doing far more harm than good with their donated millions. Bill Gates, who cofounded Microsoft in 1975, is perhaps one of the most dangerous philanthropists in modern history, having poured billions of dollars into global health initiatives that stand on shaky scientific and moral ground.

Gates answers to the problems of the world consistently focused on building corporate profits through highly toxic methods, be it chemical agriculture and GMOs, or pharmaceutical drugs and vaccines¹. Rarely, if ever, do we find Gates promoting clean living or inexpensive holistic health strategies.

Gates Donates Billions to Private Companies

A March 17, 2020, article² in The Nation titled, “Bill Gates’ Charity Paradox,” details “the moral hazards surrounding the Gates Foundation’s \$50 billion charitable enterprise, whose sprawling activities over the last two decades have been subject to remarkably little government oversight or public scrutiny.”

As noted in this article, Gates discovered an easy way to gain political power — “one that allows unelected billionaires to shape public policy” — namely charity. Gates has described his charity strategy as “catalytic philanthropy,” one in which the “tools of capitalism” are leveraged to benefit the poor.

The only problem is that the true beneficiaries of Gates’ philanthropic endeavors tend to be those who are already rich beyond comprehension, including Gates’ own charitable foundation. The poor, on the other hand, end up with costly solutions like patented GMO seeds and vaccines that in some instances have done far more harm than good.” (For a few examples, see the following references.^{3,4,5}) The Nation reports:⁶

“Through an investigation of more than 19,000 charitable grants the Gates Foundation has made over the last two decades, The Nation has uncovered close to \$2 billion in tax-deductible charitable donations to private companies ... which are tasked with developing new drugs, improving sanitation in the developing world, developing financial products for Muslim consumers, and spreading the good news about this work.

The Gates Foundation even gave \$2 million to Participant Media to promote Davis Guggenheim's previous documentary film 'Waiting for Superman,' which pushes one of the foundation's signature charity efforts, charter schools — privately managed public schools. This charitable donation is a small part of the \$250 million the foundation has given to media companies and other groups to influence the news.

'It's been a quite unprecedented development, the amount that the Gates Foundation is gifting to corporations ... I find that flabbergasting, frankly,' says Linsey McGoey, a professor of sociology at the University of Essex and author of the book 'No Such Thing as a Free Gift.'

'They've created one of the most problematic precedents in the history of foundation giving by essentially opening the door for corporations to see themselves as deserving charity claimants at a time when corporate profits are at an all-time high.'

Companies that have received large donations from the Gates Foundation include GlaxoSmithKline, Unilever, IBM, Vodafone, Scholastic Inc. and NBC Universal Media.^{7,8}

Those Calling the Shots Stand to Gain the Most

In the video above, Spiro Skouras reviews how the global is being used to snatch freedom and liberty away from us, and the role Bill Gates is playing in the process.

"We have been encouraged to sacrifice our liberty for a false sense of security, being conditioned more and more each day to rely on the state for protection and now many of us find ourselves relying on the state to pay our bills," Skouras says.⁹

"Some are beginning to see that there may be more to the official story than what we are led to believe. The very few may have seen this coming and are waiting for the next phase of what very well could be another step closer to global governance.

The exact same individuals and government agencies, in addition to global institutions who stand to benefit the most, are the ones calling the shots."

Gates, surely, fits the description of someone who is both calling the shots and stands to gain handsomely from the COVID-19 pandemic. How? First, by investing in the same industries he's giving charitable donations to and, second, by promoting a global public health agenda that benefits the companies he's invested in and supports.

How Gates' Foundation Benefits From Its Own Donations

For example, in 2014, a Mastercard affiliate, MasterCard Labs for Financial Inclusion, received a \$19 million donation^{10,11} "to 'increase usage of digital financial products by poor adults' in Kenya," The Nation reports, adding:¹²

“The credit card giant had already articulated its keen business interest in cultivating new clients from the developing world’s 2.5 billion unbanked people, McGoeys says, so why did it need a wealthy philanthropist to subsidize its work? And why are Bill and Melinda Gates getting a tax break for this donation?”

Indeed, those are sensible questions that need serious review. The Mastercard donation also appears to have benefited the Gates Foundation, making an investigation into Gates’ *“philanthropy”* all the more necessary.

As explained by The Nation, at the time of that donation, the Gates Foundation had *“substantial financial investments in Mastercard through its holdings in Warren Buffett’s investment company, Berkshire Hathaway.”*

That’s not the only questionable donation on record. The Nation found *“close to \$250 million in charitable grants from the Gates Foundation to companies in which the foundation holds corporate stocks and bonds.”* In other words, the Gates Foundation is giving money to companies that it owns stocks in and will benefit financially from.

As a result, the Foundation and Gates himself continue to increase their wealth. Part of this growth in wealth also appears to be due to the tax breaks given for charitable donations. In short, it’s a perfect money-shuffling scheme that limits taxes while maximizing income generation.

Companies that have received donations that in turn made money for the Gates Foundation include Merck, Novartis, GlaxoSmithKline, Vodafone, Sanofi, Ericsson, LG, Medtronic, Teva and “numerous startups,” The Nation writes, adding:

“A foundation giving a charitable grant to a company that it partly owns — and stands to benefit from financially — would seem like an obvious conflict of interest ...

Tax scholars like Ray Madoff, a law professor at Boston College, indicate that multibillionaires see tax savings of at least 40 percent — which, for Bill Gates, would amount to \$14 billion ...

Madoff, like many tax experts, stresses that these billions of dollars in tax savings have to be seen as a public subsidy — money that otherwise would have gone to the U.S. Treasury to help build bridges, do medical research, or close the funding gap at the IRS.

If Bill and Melinda Gates don’t pay their full freight in taxes, the public has to make up the difference or simply live in a world where governments do less and less (educating, vaccinating, and researching) and superrich philanthropists do more and more.

‘I think people often confuse what wealthy people are doing on their own dime and what [they’re] doing on our dime, and that’s one of the big problems about this debate,’ Madoff notes.

'People say, 'It's the rich person's money [to spend as they wish].' But when they get significant tax benefits, it's also our money. And so that's why we need to have rules about how they spend our money.'"

Take Action — Demand an Investigation

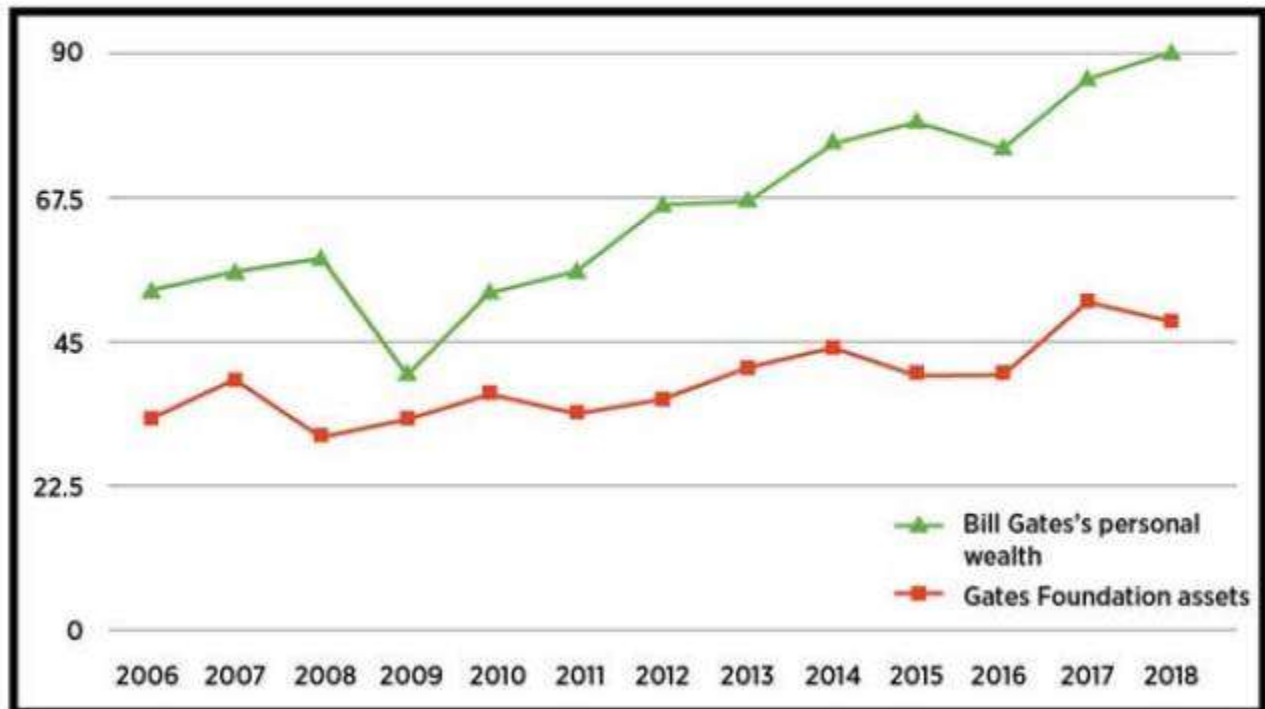
If donating to for-profit companies sounds oddly illegal to you, you'd be right. Gates is a tax evader for doing so — he's simply getting away with it. The nonprofit foundation is a disguise to avoid taxes while funding the research arms of for-profit organizations that his foundation is invested in.

In reality, Bill and Melinda Gates should be given federal prison sentences, and while not directly spelled out, I believe that's really the point of The Nation's article. Using nonprofit money to advance research for companies you're invested in is illegal.

Though the Gates family and the Gates Foundation have given away tens of billions of dollars, their assets have continued to grow, raising questions about the long-term influence of billionaire philanthropy in American politics.

Gates' Pro-Patent Agenda Limits Reforms

That Gates philanthropic endeavors protect his own investments can also be seen in his pro-patent stance. James Love, director of the nonprofit Knowledge Ecology International pointed out to The Nation that Gates:¹³

"... uses his philanthropy to advance a pro-patent agenda on pharmaceutical drugs, even in countries that are really poor ... He's undermining a lot of things that are really necessary to make drugs affordable ... He gives so much money to [fight] poverty, and yet he's the biggest obstacle on a lot of reforms."

Gates is a staunch and longtime defender of the drug industry, and his intent to further the pharmaceutical agenda can clearly be seen in the current COVID-19 pandemic.

Gates' COVID-19 Plan — Vaccinate Global Population

As reported by Forbes,¹⁴ The Bill & Melinda Gates Foundation has committed \$100 million to fight the global COVID-19 outbreak. As much as \$20 million will reportedly go to agencies such as the U.S. Centers for Disease Control and Prevention and the World

Health Organization to be used for front-line detection, containment and treatment efforts.

Another \$20 million is earmarked for at-risk populations in Africa and South Asia while the remaining \$60 million is to be used for vaccine development, diagnostics and other treatments.

Vaccines are clearly one of Gates' mainstay "solutions" to most diseases. Gates has gone on record saying the U.S. needs disease surveillance and a national tracking system¹⁵ that could involve vaccine records embedded on our bodies (such as invisible ink quantum dot tattoos described in a Science Translational Medicine paper.^{16,17})

In fact, he's stated that life will not go back to normal until we have the ability to vaccinate the entire global population against COVID-19. Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases (NIAID), has echoed this exact sentiment as well, as if they're reading the same cue card.

It would not surprise me if they were, seeing how the Bill & Melinda Gates Foundation collaborates with both the NIAID and WHO "to increase coordination across the international vaccine community and create a Global Vaccine Action Plan."¹⁸

Dr. Fauci is on Gate's Leadership Council board charged with developing this vaccine action plan, as is WHO's former director general Dr. Margaret Chan. As explained in a Bill & Melinda Gates Foundation press release:

"The Global Vaccine Action Plan will enable greater coordination across all stakeholder groups — national governments, multilateral organizations, civil society, the private sector and philanthropic organizations — and will identify critical policy, resource, and other gaps that must be addressed to realize the life-saving potential of vaccines."

Gates influence over global health policies has been criticized for years, yet nothing has been done to limit it. If anything, his power has only grown, and warnings that his corporate interests may undermine public health policy now appears to have come true. As reported by Politico in 2017:¹⁹

"Some billionaires are satisfied with buying themselves an island. Bill Gates got a United Nations health agency in Geneva. Over the past decade, the world's richest man has become the World Health Organization's second biggest donor, second only to the United States and just above the United Kingdom ...

The Gates Foundation has pumped more than \$2.4 billion into the WHO since 2000 ... This largesse gives him outsized influence over its agenda ... The result, say his critics, is that Gates' priorities have become the WHO's ...

Some health advocates fear that because the Gates Foundation's money comes from investments in big business, it could serve as a Trojan horse for corporate interests to undermine WHO's role in setting standards and shaping health policies."

Vaccinate or Become a Social Outcast?

According to statements made by Gates, societal and financial normalcy may never return to those who refuse vaccination, as the digital vaccination certificate Gates is pushing for might ultimately be required to go about your day-to-day life and business.

An April 4, 2020, article by OffGuardian comments on Gates' March 24, 2020, interview with Chris Anderson, the curator of TED (which runs TED Talks) above:²⁰

"Shockingly, Gates ... suggests people be made to have a digital ID showing their vaccination status, and that people without this 'digital immunity proof' would not be allowed to travel. Such an approach would mean very big money for vaccine producers."

Again, vaccine producers stand to make enormous amounts of money from any given pandemic, and the Gates Foundation is both funding and making investment profits from vaccine makers. Is it any wonder then that Gates is trying to indoctrinate people into thinking there are no other answers? When asked by Anderson about the economic ramifications of the COVID-19 pandemic, Gates says:

"It is really tragic that the economic effects of this are very dramatic ... But ... bringing the economy back ... that's more of a reversible thing than bringing people back to life. So, we're going to take the pain in the economic dimension, huge pain, in order to minimize the pain in disease and death dimension."

As noted by OffGuardian, Gates' statement:²¹

"... goes directly against the imperative to balance the benefits and costs of the screening, testing and treatment measures for each ailment — as successfully promulgated for years by, for example, the Choosing Wisely campaign — to provide the maximum benefit to individual patients and society as a whole. Even more importantly ... there may be dramatically more deaths from the economic breakdown than from COVID-19 itself ...

Millions could potentially die from suicide, drug abuse, lack of medical coverage or treatment, poverty and lack of food access, on top of other predictable social, medical and public-health problems stemming from the response to COVID-19."

Gates Explains Economic Shutdown

At 33:45 in the interview, Gates goes on to reveal what appears to be a stunning insider's insight into the current economic shutdown:

"We don't want to have a lot of recovered people ... To be clear, we're trying — through the shut-down in the United States — to not get to 1% of the population infected ... I believe we will be able to avoid that with having this economic pain."

In other words, if we are to believe Gates, we're sacrificing the financial stability and sanity of hundreds of millions of Americans in order to prevent the infection rate from hitting 1% of the population.

Keep in mind, the death rate for COVID-19 now appears to be on par with seasonal influenza, according to Fauci,²² so the vast majority of those infected end up recovering after mild illness, and have antibodies that should provide them with long-lasting immunity. Clearly, if you want to make money from a vaccine, you don't want people to develop immunity naturally, and this is precisely what Gates is admitting to. As noted by OffGuardian:²³

"Gates and his colleagues far prefer to create a vast, hugely expensive, new system of manufacturing and selling billions of test kits, and in parallel very quickly developing and selling billions of antivirals and vaccines.

And then, when the virus comes back again a few months later and most of the population is unexposed and therefore vulnerable, selling billions more test kits and medical interventions."

Gates Leads Medical Tyranny Agenda

The short video above summarizes some of the points I've touched on in this article so far and reviews how the Bill & Melinda Gates Foundation influences public health policy at the very highest levels through a vast web of personal and organizational interconnections.

Gates has a history of *"predicting"* global pandemics with vast numbers of deaths,²⁴ and with his call for a tracking system to keep tabs on infected/noninfected and vaccinated/unvaccinated individuals, he's ensuring an unimaginably profitable future for the vaccine makers he supports and makes money from via his Foundation investments.

In an April 9, 2020, Children's Health Defense article,²⁵ Robert F. Kennedy Jr. further details Gates' vaccine agenda. As noted by Kennedy:

"Vaccines, for Bill Gates, are a strategic philanthropy that feed his many vaccine-related businesses (including Microsoft's ambition to control a global vaccination ID enterprise²⁶) and give him dictatorial control of global health policy."

The vaccination ID enterprise Kennedy mentions refers to a program called ID2020, launched in 2019, which is designed to "leverage immunization as an opportunity to establish digital identity."²⁷

This digital identity system is said to carry *"far-reaching implications for individuals' access to services and livelihoods,"* so to think that Gates' call for implantable COVID-19 vaccine certificates would be limited to that alone would likely be a grave mistake.

It's not so far-fetched to imagine a future in which your vaccine certificate simply replaces personal identifications such as your driver's license, state ID card, Social Security card and passport.

Wall Street Journal Wants Us to Pity Gates

As people are starting to see the truth, Gates' social media accounts have been flooded with criticism, resulting in *The Wall Street Journal* publishing an article²⁸ trying to raise pity for him, saying he's being attacked by "social media mobs." April 17, 2020, Zero Hedge commented on the PR campaign to protect Gates:²⁹

"The Wall Street Journal's Deepa Seetharaman wants us to know that while poor billionaire Bill Gates has 'long been a target for online trolls' ... 'the social-media attacks have intensified' as the Microsoft co-founder and World Health Organization (WHO) benefactor has become the left's de-facto coronavirus czar ...

Perhaps the 'conspiracy theorists' are having a little trouble digesting the fact that Gates — whose vaccine efforts in India were blamed for a devastating non-polio acute flaccid paralysis (NPAFP) epidemic that paralyzed 490,000 children — coincidentally hosted an October, 2019 high-level 'pandemic simulation' in New York called Event 201 which specifically focused on coronavirus ...

Combine that with Gates' recent comments about mass vaccination and biometric identification in order to 'open up' the country and allow people to attend mass gatherings — an idea which Dr. Anthony Fauci said 'has merit,' and so-called conspiracy theorists have plenty of dots to connect.

Bill Gates, Johns Hopkins & WHO Conduct Another Pandemic Simulation With Deadlier Virus That Targets Children

The Johns Hopkins Center for Health Security, in partnership with the World Health Organization (WHO) and the Bill & Melinda Gates Foundation, conducted another pandemic tabletop exercise in Brussels, Belgium, on October 23, 2022.

The same people behind Event 201, which took place almost three years ago to the day, just completed a desktop simulation for a new Enterovirus originating in Brazil.

The exercise, dubbed Catastrophic Contagion, simulated WHO emergency health advisory board meetings addressing a fictional pandemic that spreads from Brazil to the rest of the world.

The virus in this simulation, called the Enterovirus, has a higher fatality rate than COVID-19 and disproportionately affects children and young people.

The phenomenon is dubbed SEERS (Severe Epidemic Enterovirus Respiratory Syndrome 2025).

Enteroviruses are any of a group of RNA viruses (including those causing polio and hepatitis A) which typically occur in the gastrointestinal tract, sometimes spreading to the central nervous system or other parts of the body.

[Event 201](#) was a simulation involving a coordinated global response to a coronavirus that was conducted just months before COVID-19 was declared a global pandemic in early 2020.

From the Johns Hopkins [website](#):

Event 201 was a 3.5-hour pandemic tabletop exercise that simulated a series of dramatic, scenario-based facilitated discussions, confronting difficult, true-to-life dilemmas associated with response to a hypothetical, but scientifically plausible, pandemic. 15 global business, government, and public health leaders were [players](#) in the simulation exercise that highlighted unresolved real-world policy and economic issues that could be solved with sufficient political will, financial investment, and attention now and in the future.

As such, the fact the same globalist organizations who conducted that exercise are also behind the Catastrophic Contagion simulation is both alarming and foreboding, especially with the inclusion of the specific year 2025 as the start date.

Speaking of 2025, another coronavirus pandemic exercise preceding COVID-19 that also involved Johns Hopkins was called [SPARS 2025-2028](#), which examined the global pandemic response to a respiratory virus that spread from the Philippines to St. Paul, Minnesota.
