5G, the Mark of the Beast, and the UPC Code

Chapter 5

According to the last book in the Bible, “666” is the number, or name, of the wild beast with seven heads and ten horns that comes out of the sea -(Revelation 13:1, 17-18). It’s something that has confused Christians, scared them, and not be chatted about in most circles. However, taking the time to learn more about what the Bible says can put the mark of the beast into perspective.

There are a number of Bible scholars and researchers who see the second beast that comes out of Revelation 13 being the land mass that we know as North America, particularly the United States. *“**And I beheld another beast coming up out of the earth; and he had two horns like a lamb, and he spake as a dragon. And he exerciseth all the power of the first beast before him, and causeth the earth and them which dwell therein to worship the first beast, whose deadly wound was healed. And he doeth great wonders, so that he maketh fire come down from heaven on the earth in the sight of men, And deceiveth them that dwell on the earth by the means of those miracles which he had power to do in the sight of the beast; saying to them that dwell on the earth, that they should make an image to the beast, which had the wound by a sword, and did live.**”*

Whatever your view you hold on this, try to keep an open mind about it as a distinct possibility. Most denominations today do not teach Bible prophecy, at least not since the mid-1960’s. This was a direct consequence of the Vatican II ecumenical movement that began back then. The fact that Bible prophecy is still a subject of study only relates to Hal Lindsey’s book, *‘The Late Great Planet Earth’* published in 1979. The fact is I have never read it but have hundreds of books in my library that came along later. I have been a student of Bible prophecy since the Israeli Six-Day War that resulted in the Israeli IDF liberation of the Temple Mount on June 7, 1967. In the ensuing years, I came to the belief that the United States is the second Beast of Revelation 13. I believe the cumulative evidence that I bring forth in this eBook offers cogent proof for this belief, particularly with the UPC barcode system **first** introduced into the world of commerce in 1974; **second** as the nation that imposes so much influence and control on the rest of the world; third for its leading the charge of implementing technology, such as 5G and 6G as President Trump says, *“Bring it on!”* A **third** reason was the legislation of the 2005 Patriot Act; and, a **fourth** reason is the Real ID Act of 2005. The Real ID Act becomes Law of the Land as of October 1, 2020. I will discuss this more in a subsequent part of this study.

Most of you are unaware of something that happened back in the mid-1960 era. The Jesuits introduced Vatican II. Out of that, the Jesuit-controlled Vatican focused on bringing back the “Lost Brethren” of the Protestant denominations that spun off from the Reformer Martin Luther. If you were a believer who identifies as a Protestant, before Vatican II, you were

referred to as a “heretic”. However, Vatican II was the biggest full-press campaign to bring the many Protestant denominations back under the umbrella of Rome. Within a matter of a decade, a new translation was brought forth, known as the New International Version, the NIV, and an ecumenical Bible that was influenced by Cardinal Carlo Martini, who worked with the translators of the NIV. Along with a Jesuit Cardinal, the NIV translating team included an avowed homosexual, and a lesbian.

“The New International Translation (NIV) is straight out of the pits of Hell. The man appointed to be the Chairman of the Old Testament Committee of the NIV Committee on Bible Translation, Dr. Marten Woudstra, was a homosexual. Also, Virginia Mollenkott, who worked as the stylistic editor for the translation, is a proud lesbian. Some of Dr. Woudsta's collaborators on the NIV knew about his homosexuality years ago during the translation process. The fact that a homosexual oversaw the translating of the Old Testament should be alarming to anyone who loves the Lord Jesus Christ and recognizes the Word of God as the most important Book in their life. The sad truth is that at least two known homosexuals influenced the NIV used in most churches today.” writes David J. Stewart, a well-known conservative Bible scholar.

In 2011, the TNIV (The New NIV) was released, with much criticism. The NIV 2011 version debuted amid controversy, with some Christian groups and individuals criticizing the translation for allegedly having too much “gender inclusive” language, similar to the TNIV translation of the Bible. Members of the Southern Baptist Convention and the Committee on Biblical Manhood and Womanhood criticized the edition, saying the 2011 NIV “cannot be considered sufficiently trustworthy in its translation of gender language.”

Cardinal Carlo Maria Martini, S.J. (February 15, 1927 – August 31, 2012) was an Italian Jesuit and Cardinal of the Catholic Church. He was Archbishop of Milan from 1980 to 2002 and was elevated to the cardinalate in 1983. A towering intellectual figure of the Roman Catholic Church, Martini was the liberal contender for the Papacy in the 2005 conclave, following the death of Pope John Paul II. According to highly placed Vatican sources, Martini received more votes in the first round than Cardinal Joseph Ratzinger, the conservative candidate: 40 to 38. Ratzinger ended up with more votes in subsequent rounds to be elected to the Papacy.

My point here is that most mainline Protestant churches do not discuss the Beast or the “Mark” of the Beast, and the consequence of that is ignorance among most Protestants today. The “ecumenical movement” that came out of Vatican II, was resolved in a joint Protestant-Roman Catholic doctrine known as “Pluralism”. Basically, pluralism is a catch all phrase that can be used in different contexts to designate a “more than one option” philosophy. Pluralism then would stand in opposition to the idea of an absolutely correct system or belief. Such pluralism would contradict biblical teaching that there is one absolute and supreme being -(Isaiah 43:10; 44:6; 45:5), that Jesus is the only way to be saved from the righteous judgment of God -(Acts 4:12), and that the Bible alone is the revealed word of God.

Pluralism for all intent and purpose pursues a middle ground relative to the Bible and church doctrine. It opened a door to which a number of individual theologians have moved in

recent years. According to this view, the great world faiths, including Christianity, are valid spheres of a salvation that takes characteristically different forms within each--though consisting in each case in the transformation of human existence from self-centeredness to a new orientation toward the Divine Reality. The other religions are thus not secondary contexts of Christian redemption but independently authentic paths of salvation. The pluralist position is controversial in Christian theology because it affects the ways in which the doctrines of the person of Christ, atonement, and the Trinity are formulated.

Christians engage in dialogue with the other major religions through the National Council of Churches and the World Council of Churches' subunit on Dialogue with People of Living Faiths and Ideologies and the Vatican's Secretariat for Non-Christians, as well as a variety of extra-ecclesiastical organizations, such as the World Congress of Faiths. A multitude of inter-religious encounters takes place throughout the world, many initiated by Christian and others by non-Christian individuals and groups.

In the 20th century industrial world, "Consensus" thinking was introduced by Dr. Peter Drucker, as a method in resolving labor/management issues as a means to avoid labor strikes. The 1940's and early 1950's saw major strikes in the coal, iron and steel, railroad industry that had crippled the nation's economy. Professor Drucker's "Consensus" thinking was fine during the 1950's through the late 1970's. It ended when President Ronald Reagan broke the Air Traffic Controllers Union strike of 1981. Today, only 12-15% of workers are members of a union. This style of labor negotiations introduced by the late Peter Drucker helped reduce labor strikes. The goal was to sit all parties at the table and establish where two differing parties would determine what it was the agreed on in common. From that the negotiating parties would seek to reduce the bargaining issues through trade-offs (give and take) that eventually resulted in a labor settlement without the disruption of business as usual. What does that have to do with the Biblical "Mark" of the Beast? Glad you asked?

The down side of "Pluralism" in the church is that matters of Scripture become watered down to the point of meaning very little. When I began ministry, the effects of Vatican II was that as Methodists, we were instructed not to say anything negative toward the Roman Catholic Church and reciprocity would set the tone of inter-faith relations for the years to come. Another down side to "Pluralism" is that of church decline. People have left most denominations in droves because of what can be described as "irrelevance", meaning church leaders skirt the real issues of the world that the church refuses to address. Denominational leaders that teach Bible prophecy in their churches actually thrive and grow. It boils down to feeding people the truth rather than skirting around it! The church will grow once again when it offers the Biblical answers that people seek. They ask is it real and does it work?

The Catholic position in the documents of Vatican II under the Decree on Ecumenism we read, *"Every effort to avoid expressions, judgments and actions which do not represent the condition of our separated brethren with truth and fairness and so make mutual relations with them more difficult. (Should be avoided). ... The results will be that, little by little, the obstacles to ecclesiastical communion are overcome; all Christians will be gathered, in a common*

celebration of the Eucharist, into the unity of the one and ONLY Church, which Christ bestowed on His Church from the beginning. This unity, we believe, subsists in the Catholic Church as something she can never lose, and we hope that it will continue to increase until the end of time."

It was that very change in language that has caused the ultra-Traditionalist Catholic to reject Vatican II, and the ultra-liberal to fall into indifferentism, or pluralism. Changing the language from 'heretic' to "separated brethren" and from the rejection of essential truths to holding to some truths angered Traditionalists and confused liberals. Nothing changed except the language and this only to enter into a dialogue that could bring those who left back to the faith. Well, it should come as no surprise here, but many Protestants were pretty much opposed to Pluralism for much the same reasons.

All of that said has led to a dumbing down of what people understand or believe when it comes to the "Mark" of the Beast. Liberal Christians either discount the importance of the "666" references or refute its meaning.

It's Just a Name

The number "666" is actually the name of the coming Antichrist. The names given by God have meaning, and this is seen elsewhere in the Bible. For example, God gave the name Abraham, which means "Father of a Crowd (Multitude)". This makes sense, because God promised that He would make Abraham "*a father of many nations*" -(Genesis 17:5). Likewise, God named the beast "666" as a symbol of its defining attributes.

Contrary to what you may have heard, the number "666" is mentioned in the Bible. Revelation 13:18 says "*Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.*" The English word "hath understanding" comes from the Greek word for "calculate" or "solve". For some scholars, it's as if the Bible is saying to us that the number is a riddle.

In Greek and Hebrew, giving a number to a letter or name is called "gematria," which is the Greek practice of adding up the letters in someone's name. Each letter in the Greek language has a numeral equivalent. Add up the letters and you get the number of the name. There is a similar practice in Hebrew. When you actually look at the original text, we see that in this passage the letters of "666" are actually written in Hebrew, which places a higher significance on numbers meaning words and words meaning numbers than ancient Greek.

When we translate the number "666" out of the Hebrew alphabet, it spells out Neron Kesar - the Hebrew spelling of Nero Caesar. Given the hatred of the Roman Empire at the time, and particularly its leader, Nero Caesar, who was considered to be especially evil, it's no surprise some people believe the antichrist has already come.

The Number “6” Has Meaning in the Bible

Numbers in the Bible often are used as symbols. For example, the number 3 often correlates to the Holy Trinity, and the number 7 is considered the perfect number, representing completeness, spiritual fullness. The number “6” in the Bible is often associated with man. Being one short of 7, the number 6 can denote something incomplete or flawed in God’s eyes, and it can be associated with God’s enemies -(1st Chronicles 20:6; Daniel 3:1). Because it represents man, it can be seen that God views human “man” as flawed creatures. He knows they will be unable to bring lasting peace and security—things that only God’s Kingdom will achieve.

“666” is thus a number that consistently falls short of triple perfection: 777. The Bible sometimes stresses a matter by stating it three times. The number also refers to the “*unholy trinity*,” Satan, the Beast and the False Prophet. Satan is the great counterfeiter of whatever God has created.

The Mark of the Beast

The Bible refers to the number as the “Mark” of the beast, and people can receive the “Mark” when they follow it “with admiration” to the point of worshipping it -(Revelation 13:3, 4; 16:2). They do so by worshipping their country or other false prophets. This beast is a symbol of the worldwide political system, which rules over “every tribe and people and tongue and nation” -(Revelation 13:7).

Regarding His commands to the nation of Israel, God said: “***Bind them as a reminder on your hand, and they should be like a headband on your forehead***” -(Deuteronomy 11:18). This didn't mean that the Israelites were to mark their literal hands and foreheads, but that God’s Words would guide all their actions and thoughts. Orthodox Jews wrap their arms and forehead with what are Phylacteries based upon this verse; a small leather box containing Hebrew texts on vellum, worn by Jewish men at morning prayer as a reminder to keep the law. Likewise, rather than being something literal such as a “666” tattoo, the “Mark” of the beast symbolically identifies those who let the political system rule their lives. Those with the “Mark” of the beast place themselves in opposition to God -(Revelation 14:9, 10; 19:19-21).

The number “666” is something that confuses most Christians, but it shouldn’t be something to worry about. The more you learn about the book of Revelation, the Antichrist, and the “Mark” of the Beast the more confident you can feel for Jesus’ Second Coming. We continue to learn what God wrote for us and don’t need to be afraid.

The number of the Beast, “666”, is associated with the “Mark” of the Beast and the name of the Beast in Revelation 13:17. One of the earliest explanation is attributed to John’s disciple Polycarp, who, according to his student Irenaeus, said this number is derived from adding together the numerical equivalents of the letters in the word *Lateinos*, the Greek word

for “Roman”—this being the name of the Beast empire, its ruler and everyone in it. So the number may well denote this general distinction, though it could also be more specific. I have written a series entitled “The Beast Empire”, containing 24 parts to date. One cannot find a timelier or better reference to the Beast than that of Polycarp.

Another explanation is that the Bible associates the number six with man; God made him on the sixth day of creation week. The number “666” is a triple repetition of the number of man and emphasizes that this beast represents a government whose base is human authority, as opposed to God’s authority.

As with the “Mark” of the Beast, God’s people will reject it. They will **“have the victory over the beast, over his image and over his mark and over the number of his name”** - (Revelation 15:2). However this prophecy is fulfilled, it is clear that accepting the “Mark” or number will involve compromising and contradicting God’s commands. Having proof that one is officially associated in some way with the Beast will be necessary for one to be allowed to engage in commerce -(Revelation 13:17).

To help the reader understand how different Bible scholars understood or viewed the “Mark” of the Beast, there is a great summary of how Bible prophecy teachers interpreted the phrase, “The Mark of the Beast”, I share Dr. Terry Watkins excellent summary below. This summary offers a varied interpretation that existed when compiled in 1999.

Richard Abanes, End-Time Visions, 1998

. . . nothing in the Bible, either linguistically or grammatically, indicates that the mark of the beast in Revelation 13 is a *literal* mark on, or in, the skin." (Richard Abanes, End Time Visions, p. 127, 1998)

M.J. Agee, Revelations 2000, 1998

The mark may even be used as it appears in the Greek, Chi, Xi, Sigma $\chi\xi\sigma$. The middle letter even resembles a serpent, as Seiss pointed out in his book, [The Apocalypse](#). . .

It could be like the Chinese chop, a mark that represents a person's name made into a stamp similar to our rubber stamps. My niece had her chop made on her trip to Taiwan and Hong Kong. She used her initials. The mark of the beast is also made up of three letters. It is

possible that the initials of the False Prophet could be used. (M.J. Agee, Revelations 2000, 1998, p. 325)

Baker's Evangelical Dictionary of Biblical Theology, 1996

Mark of the Beast

This mark is equivalent to the beast's name or number (13:17; cf. 14:11). This enigmatic number is announced in 13:18 as 666.

Isbon Beckwith, The Apocalypse of John, 1919

The mark is explained in v. 17 as consisting of the name of the Beast, or what is equivalent, the number of his name. . . it is set where it could not easily be hid, on the forehead or the right hand...the agreement of the number and the name is to be ascertained by the calculating the sum of the value of the letters which form the name. (Isbon Beckwith, The Apocalypse of John, 1919, p.641, 642)

Gary D. Blevins, 666 The Final Warning!, 1990

I personally believe that the MARK will be either an *invisible laser tattoo* (they are in the skin) or a *micro chip*, which will be placed under the skin having the *Uniform Product Code* (UPC). This MARK, a type of bar code in the skin or on the micro chip, would be scanned at the point of trade. . .

MARK: The UPC code [barcode] with needed information on each person.

NAME OF THE BEAST: This, I believe, will be a name with six letters in each name invisibly coded into the laser tattoo or micro chip. A computer could pick this up as 'six digits' in each name. For example, Ronald Wilson Reagan!

NUMBER OF HIS NAME: The number 666 invisibly coded into the laser tattoo or micro chip and placed on each person in the form of the UPC [barcode] 'mark'. (Gary D. Blevins, 666 The Final Warning!, 1990, pp. 204, 205)

Roy L. Branson, Jr., The End of the World, 1989

Instead of social security cards and credit cards, the number will be printed in the forehead or hand so that all who receive it will carry it at all times. Using modern technology, it will be a method to eliminate losing such cards or having them stolen or duplicated.

Just how will the number be imprinted? Will it consist only of the numbers 666? We do not know for certain, but it is possible a small computer chip will be embedded under the flesh, or even into the bone of the forehead of hand. That kind of technology is already in place. Another method may be used, but the results will be the same — instant identity, and little or no likelihood of counterfeiting or reproducing. I suspect the numbers 666 will be a prefix followed

by other numbers, but I do not know. (Roy L. Branson, Jr., *The End of the World*, 1989, p.78)

Tal Brooke, *When the World Will Be As One*, 1989

Yet the apostle John describes a reality that has only recently come into focus: global banking, laser scanning, and the universal bar code. . . It is a tiny step to go from using a Visa card or a bank card on the Plus System and other ATM machines, in which the electronic strip is attached to the card, to putting that same strip of information on the human body so that it can be laser scanned. This has already been done with laser tattoos and implanted microchips. . . Again, what better descriptive term could John have found in the ancient world than "the mark," which would enable every citizen to buy or sell who had it? (Tal Brooke, *When the World Will Be As One*, 1989, pp. 229, 230)

Arthur H. Brown, *Europe After Democracy*, 1993

Europeans believe that the monetary system called ECU (European Currency Unit), now in place, will serve as the medium of commercial exchange and trade. However, the Bible reveals that a mark (or the symbolic number 666) on the right hand or forehead will replace the ECU and become the mandatory currency expression necessary to conduct trade and commerce in much of the world. Those refusing to accept this mark will be killed. (Arthur H. Brown, *Europe After Democracy*, 1993, pp. 138,139)

Dr. Gary G. Cohen, cited in *Satan's Mark Exposed*, Salem Kirban, 1978

What will be his mark?. . . It appears that it will be some sort of credit card number and loyalty badge combined into one. Possibly it may be a tattoo invisible to the naked eye but visible upon some type of light-beam scan. It will, however, in its numerical aspect have some logo type connection with the number 666, or a code based on these digits, which will be related directly to the name of the Antichrist. (Dr. Gary G. Cohen, cited in *Satan's Mark Exposed*, Salem Kirban, 1978, p.131)

Terry Cook, *The Mark of the New World Order*, 1996

It is my well-researched opinion that the Mark of the Beast, as related in scripture, is *absolutely literal*. Soon, all people on earth will be coerced into accepting a Mark in their right hand or forehead. I am convinced that it will be an injectable passive RFID transponder with a computer chip — a *literal* injection with a *literal* electronic biochip 'mark'. . .I believe that such an implanted identification mark literally will become Satan's Mark of the Beast, as we will discuss further in this chapter." (Terry Cook, *The Mark of the New World Order*, 1996, p. 587)

M.R. DeHaan, *Studies in Revelation*, 1946

What this mark of the beast will be we may not know now. Hundreds of answers have been

suggested, but I do not believe these are scriptural. Men have tried to identify this Antichrist, and there have been hundreds of guesses concerning his identity, but all of them have been wrong. . . It is foolish, therefore, to speculate concerning his identity. The same is true of the mark of the beast.

What the mark will be we do not know. . .

There are many who believe that the mark will consist of the number 666 tattooed upon the foreheads and hands of the followers of the beast. . .(M.R. DeHaan, Studies in Revelation, 1946, pp. 187, 188)

Samuel B. de Klerk, Coming Great Prophetic Events, 1962

All religions are to be placed under the control of the counterfeit ruler or false Christ, making a single world religion. He will have the power to enforce his mark, "666", known as the "the mark of the beast" (Rev. 16:2, 19:20). This mark or stamp of the Antichrist will be placed on the foreheads or right hands of all living persons when Antichrist rules. (Samuel B. de Klerk, Coming Great Prophetic Events, 1962, p.72)

Robert W. Faid, Gorbachev! Has the real Antichrist come?, 1988

It appears that there will be three separate things or marks which will qualify a man to buy or sell. The first is called the 'Mark of the Beast.' If indeed the antichrist is the leader of the Soviet Union, then the mark may well be the Red Star — the universal communist symbol. This may be a simple tattoo of the communist Red Star.

A second possibility concerns what is meant by the 'name of the beast.' I do not think it will be name of a specific man. . . This mark again might be a simple tattoo indicating that the bearer is a member of the Communist Party, and loyal to the antichrist.

The third may be more complicated — the number of his name. I do not believe that this means simply the number 666. With the recent advancements in computer chip technology, especially in the miniaturization of them, it is now possible to make them microscopic enough to be injected beneath the skin. . .

Although the microchip could possibly be the ultimate in the antichrist's control of people's lives, this would take considerable time to implement and the cost would be enormous. A much simpler form would be to use the series of bars utilized in the Universal Products Code already in place in most supermarkets. This code could be tattooed, possibly with a dye visible only under ultraviolet light, on either the hand or forehead. (Robert W. Faid, Gorbachev! Has the real Antichrist come?, 1988, pp. 60,61)

Arnold G. Fruchtenbaum, The Footsteps of the Messiah: A Study of the Sequence of Prophetic Events, 1982

In this passage [Rev 13:16-18] whatever the personal name of the Antichrist will be, if his name is spelled out in Hebrew characters, the numerical value of his name is 666. So this is the

name that will be put on the worshippers of the Antichrist. (Arnold G. Fruchtenbaum, *The Footsteps of the Messiah: A Study of the Sequence of Prophetic Events*, 1982, p. 173)

Oliver Greene, *The Revelation, Verse by Verse*, 1963

Yes, I believe there will be three sixes tattooed on foreheads and right hands. . . indeed I do. I believe John 3:16. I believe God literally loved, literally gave, Jesus literally came and literally died. Why should I not believe the number of the Beast will be 666? (Oliver Greene, *The Revelation, Verse by Verse*, 1963, p. 350)

Mark Hitchcock, *The Complete Book of Bible Prophecy*, 1999

This passage [Rev 13:16-18] provides five key clues as to the interpretation of the mark of the Beast.

1. The name of the beast
2. The number representing his name
3. The number of the Beast
4. The number of a man
5. The number is 666

When these five clues are followed through their logical progression, the number or mark of the Beast is the number of a man who is the Antichrist or final world ruler. This number is the number of the Antichrist's own name. (Mark Hitchcock, *The Complete Book of Bible Prophecy*, 1999, p.202)

Dave Hunt, *How Close Are We?*, 1993

A tiny computer chip painlessly and quickly implanted just under the skin in hand or forehead will likely become the means of fulfilling this prophecy [Rev 13] (Dave Hunt, *How Close Are We?*, 1993, p. 261)

Thomas Ice & Timothy Demy, *The Antichrist and His Kingdom*, 1996

Although all the specifics and ramifications of the mark are not known, we do know that it will be a symbol of the Antichrist and allegiance to him. The biblical word for *mark* is similar to our modern *tattoo*. Just as tattoos were imposed upon victims of the Holocaust, so will similar, permanent marks be given to willing recipients during the tribulation. (Thomas Ice & Timothy Demy, *The Antichrist and His Kingdom*, 1996, p. 33)

Grant R. Jeffrey, *Prince of Darkness*, 1994

What kind of mark will it be? It will be a physical mark, probably visible, that the False Prophet will force every man and woman to receive on his right hand or forehead. The mark will be related to both the "name of the beast" as well as the "number of his name" — 666. Possession of the mark will indicate that you willingly worship the "beast". . .

The number 666 indicates that the letters in the Greek form of the name of the Antichrist will add up to 666. There is a slim possibility that his name will equal 666 in the Hebrew language since the Antichrist will be Jewish. The numeric system does not work in English or in languages other than Greek or Hebrew, so it is useless to calculate the values of names in these modern languages. (Grant R. Jeffrey, Prince of Darkness, 1994, pp. 275, 277)

Grant R. Jeffrey, Surveillance Society, 2000

The mark will be a physical, probably visible, mark that the False Prophet will demand every man and woman receive on their right hand or forehead. The Mark will be related to both the "name of the beast" and the "number of his name" — "666". It will indicate that the individual willingly worships the "beast" the satanic Antichrist.(Grant R. Jeffrey, Surveillance Society, 2000, p. 233)

The totalitarian control will involve "the mark, or the name of the beast, or the number of his name." All three of these identifying marks may be used either simultaneously or at different times to identify the worshippers of the Antichrist from those who reject his claims to be god...(Grant R. Jeffrey, Surveillance Society, 2000, p. 238)

This mark must be something different from the name or the number 666 because scriptures, including Revelation 13:18, mention all three as separate items. We are not told the exact nature of the Mark, but it may be a physical brand on the surface of the skin including either the actual name of the Antichrist or the number 666. The Mark may also be implanted as a miniature computer micro chip beneath the skin of the right hand or forehead.(Grant R. Jeffrey, Surveillance Society, 2000, p. 238)

Jerry Johnston, The Last Days of Planet Earth, 1991

The number 666 will be a finance number, perhaps invisibly tattooed on every person's right hand or forehead. (Jerry Johnston, The Last Days of Planet Earth, 1991, p.135)

Salem Kirban, Satan's Mark Exposed, 1978

One day in the Tribulation Period you will need proper identification to withdraw or deposit money in your bank. The identification will be an invisible mark either on the back of your hand or on your forehead! (Salem Kirban, Satan's Mark Exposed, p.46)

. . . the Social security number will become your identification number. It will be prefixed by 666 and quite possibly followed by your own personal zip code. (Salem Kirban, Satan's Mark Exposed, p.60)

The Government knows you by a number. Your most universal number is now your Social Security Number. Quite conceivably it could be the Mark. Technology is already here whereby

the Social Security Number could be painlessly imprinted on your forehead or right hand in invisible ink revealed only by a special light. (Salem Kirban, *Satan's Mark Exposed*, p.72)

The MARK will be a "harmless" and "invisible" Laser Beam applied mark. You will have the choice of having the Mark placed on your right hand or on your forehead! (Salem Kirban, *Satan's Mark Exposed*, p.99)

What this identifying mark will be . . . the Lord has not desired to make clear to us at this time. Nor can we know at this time the identity of Antichrist. It may be the number "666" which is the number of man. . . (Salem Kirban, *Satan's Mark Exposed*, 1978, p. 123)

Tim LaHaye and Jerry Jenkins, *Are We Living in the End Times?*, 1999

One of the best known prophecies of the Tribulation is that the "Beast," or Antichrist, will have the ability to put his mark "666" on the forehead or hand of the world's people. . . Revelation 13:13-18 teaches that after the midpoint of the Tribulation, all men and women will be ordered to bow down before the image of the Beast and worship him. Those who do will receive "a mark. . . on their foreheads" that is "the name of the beast, or the number of his name" — later identified as 666. (Tim LaHaye and Jerry Jenkins, *Are We Living in the End Times?*, 1999, pp. 195,196)

Tim LaHaye and Jerry Jenkins, *The Mark: The Beast Rules the World*, 2000

"The first page of your folders. . . is a listing of the ten world regions and a corresponding number. It is the product of a mathematical equation that identifies those regions and their relationships to His Excellency the Potentate [Anti-Christ]. The loyalty mark, . . . shall begin with these numbers, thus identifying the home region of every citizen. The subsequent numbers, embedded on a biochip inserted under the skin, will further identify the person to the point where every one shall be unique. . .The mark shall consist of the name of His Excellency or the prescribed number". (Tim LaHaye and Jerry Jenkins, *The Mark: The Beast Rules the World*, 2000, p. 85)

"'We have settled on the technology,' Viv continued. 'The miniature biochip with the suffix numbers embedded in it can be inserted as painlessly as a vaccination in a matter of seconds. Citizens may choose either location, and visible will be a thin, half-inch scar, and to its immediate left, in six-point black ink — impossible to remove under penalty of law — the number that designates the home region of the individual. That number may be included in the embedded chip, should the person prefer that one of the variations of the name of the potentate appear on their flesh.'

'Variations?' someone asked.

'Yes. Most, we assume, will prefer the understated numbers next to the thin scar. But they may also choose from the small initials — no bigger than the numbers — *NJC* The first or last name may be used, including one version of *Nicolae* [Anti-Christ] that would virtually cover the left side of the forehead.'" (Tim LaHaye and Jerry Jenkins, *The Mark: The Beast Rules the World*, 2000, p. 86)

"In a few moments you will be led to the central building, where you will tell the staff whether you want your loyalty mark on your forehead or your right hand. The area you choose will then be disinfected with an alcohol solution. When it is your turn, you will enter a cubicle, where you will sit and be injected with a biochip, while simultaneously tattooed with the prefix 216, which

identifies you as a citizen of the United Carpathian States. The application takes just seconds." (Tim LaHaye and Jerry Jenkins, *The Mark: The Beast Rules the World*, 2000, p. 285)

"David could barely take his eyes off the small black tattoo that read 30 and was followed by a half-inch pick scar [where the biochip was implanted] that would fade to a darker line in a few days." (Tim LaHaye and Jerry Jenkins, *The Mark: The Beast Rules the World*, 2000, p.352)

Peter Lalonde, One World Under Anti-Christ, 1991

In fact, the microchips currently used in "smart cards" could easily fulfill the definition of "the mark" which will be issued under the Antichrist regime. (Peter Lalonde, *One World Under Anti-Christ*, 1991, p. 229)

Peter & Paul Lalonde, Racing Toward The Mark of the Beast, 1994

[referring to the Mark VI Personal Identity Verifier, which reads the biometrics characteristics of the hand to verify identification] — The student of Bible prophecy will not only be interested in the name of this device [Mark] but in the fact that its developers have decided to record both hands in case of injury. The Bible may well have been foretelling just such a precaution when it referred to 'marking' the right hand or forehead. (Peter & Paul Lalonde, *Racing Toward The Mark of the Beast*, 1994, p. 77)

Clarence Larkin, Dispensational Truth, 1918

The "Mark" will be BRANDED or burnt on. It will probably be the "NUMBER OF BEAST" OR "666". (Clarence Larkin, *Dispensational Truth*, p.. 124, published 1918)

Hal Lindsey, The Late Great Planet Earth, 1970

Everyone will be given a tattoo or mark on either his forehead or forehead, only if he swears allegiance to the Dictator as being God. Symbolically, this mark will be 666. (Hal Lindsey, *The Late Great Planet Earth*, 1970, p.101)

Hal Lindsey, The 1980's: Countdown to Armageddon, 1980

Those worshippers will each be assigned a trade number. Without that number, on one will be permitted to buy or sell anything (Revelation 13:16-17). . . The only safeguard would be to tattoo the number on your skin with an ink that could be seen only in a special light. . .The anti-Christ, with the help of his false prophet, will require that a number representing his name become part of your own banking number to make it valid. (Hal Lindsey, *The 1980's: Countdown to Armageddon*, 1980, pp. 110,111,112)

Betty Lynn, Pathways to Armageddon, 1992

The prince... will exclude everyone who does not have an approved cashless account. Because of the importance of that account to daily existence and to protect it from theft, account information will be bio-implanted, leaving a small mark on the hand or temple. (Betty Lynn, Pathways to Armageddon, 1992, p.47)

Texe Marrs, Mystery Mark of the New Age, 1988

Could a microchip be programmed with the number of the Beast and be inserted under a person's skin? And what of the bar code? Could the laser be used to 'brand' people with the Mark?

In light of the meaning of the Biblical word 'mark' as used in Revelation 13, I do not see this as a viable possibility. For one thing, I believe the coming New Age World Leader will promote the Mark as a spiritual status symbol that people will proudly covet. It will be a Mark of distinction. Like the commercial for a well-known credit card says, you wouldn't want to leave home without it! To hide or somehow make the Mark indistinguishable would defeat its purpose. (Texe Marrs, Mystery Mark of the New Age, 1988, p. 38)

Texe Marrs, Project L.U.C.I.D., 1996

Will the implantable biochip, linked in with L.U.C.I.D. worldwide control net, become the basis for the mysterious, but diabolical, Mark of the Beast? It seems possible, even likely, that this will prove to be the case. (Texe Marrs, Project L.U.C.I.D., 1996, p.113)

Robert Mounce, The Book of Revelation, 1977

The mark is identified as the name of the beast written in its numerical equivalent. It is not the name of the beast or the number of his name that is stamped on his followers. The mark *is* the number of the name... the number of the beast stamped upon his followers was 666. (Robert Mounce, The Book of Revelation, 1977, p. 263)

Naked, a movie Directed by Mike Leigh, starring David Thewlis, 1993

What is the mark? Well the mark Brian, is the barcode. The ubiquitous barcode that you'll find on every bog roll, and every packet of Johnny's and every poxie-pot pie. And every [expletive-removed] barcode is divided into two parts by three markers and those three markers are always represented by the number six. Six-six-six. Now what does it say? No one shall be able to buy or sell without that mark. And now what they're planning to do in order to eradicate all credit card fraud and in order to precipitate a totally cashless society. What they're planning to do; what they've already tested on the American troops; they're going to subcutaneously laser

tattoo that mark onto your right hand or onto your forehead.

B.J. Oropeza, 99 Reasons Why No One Knows When Christ Will Return, 1994

If the antichrist had lived in the first century, he could have easily fulfilled Revelation 13:16-18 by ordering a tattoo or branding-iron mark placed on everyone. Such primitive means would suffice to carry out the Beast's job. Of course, computers and electronic networks would allow an antichrist today to keep tabs on everyone more easily than a first-century antichrist could have done. So inventions like the biochip give us a better explanation of how the mark of the Beast could be implemented, but they do not necessarily herald the mark of the Beast.

There is no evidence that any candidate for the mark of the Beast is in fact the mark. (B.J. Oropeza, 99 Reasons Why No One Knows When Christ Will Return, 1994, pp. 165,166)

J. Dwight Pentecost, Prophecy for Today, 1961

I confess that I don't know what this number means. I am certain, however, that there are more than 666 interpretations. Everyone seems to have an opinion. Since God doesn't explain the meaning, apparently it's not important for us to know. Before this person comes to prominence believers will have been translated into God's presence. We will not have the slightest interest in the Beast or the False Prophet because we will be occupied with the Lord Jesus Christ in glory.

The reason God gave us any information at all, I believe, is so that believers alive in that day will have a clear identifying sign that the one in world power is Satan's masterpiece. (J. Dwight Pentecost, Prophecy for Today, 1961, p.114)

Arthur W. Pink, The Antichrist, 1923

This "mark" will be the *official sign* of allegiance to the Emperor stamped either upon the hand or forehead of his loyal subjects. It will be the satanic travesty of the "seal" which the angel will stamp on "the foreheads of God's servants" (7:3). This "mark" on the persons of the subjects of the Beast will be, we believe, *the name of the Devil*, (cf. Rev. 13:4), as the seal on the foreheads of God's servants is defined in 14:1 as "having their Father's name written on their foreheads". (Arthur W. Pink, The Antichrist, 1923, p. 200)

Mary Stewart Relfe, When Your Money Fails...The "666" System" is Here, 1981

"And he causeth all . . . to receive a mark . . ." In Greek this word mark is charagma, which literally denotes a stamp, an impress, and is translated mark. Notice that John did not say that he causeth all to receive a number in the right hand or forehead. This astute prophet could have certainly delineated between a series of numbers, and an unexplained stamp or mark. . .

The same Electronic Eye which scans the UPC marks [barcodes] will in the near future scan

the marks that will be required to be inserted on the body. . .

While some specifics remain vague, of this we are certain: All commerce will be conducted in the near future with a number, a name, or an identifying mark in the hand or forehead. It is my sincere deduction that the 'mark of the beast' will not be the insertion of numbers per se on the body, but of vertical lines which will represent encoded messages and digits. (Mary Stewart Relfe, *When Your Money Fails...The "666" System" is Here*, 1981, pp. 56,57,58)

Mary Stewart Relfe, The New Money System 666, 1982

The Prophet John identified this Cashless System of Commerce 1900 years ago as one in which business would be transacted with a 'Mark' and a Number; the Mark will obviously be a Bar Code; the Number will be '666;' the combination of the two, about which you will read in this book, will be an integral part of the '666 System'. . .

RECEIVING OF ONE'S OWN VOLITION THE MARK (BRAND) IN THE RIGHT HAND OR FOREHEAD; which I believe will be a Bar Code facsimile incorporating a concealed use of '666,' unintelligible to the eye,. . . Mary Stewart Relfe, *The New Money System 666*, 1982, pp. xii, 206)

A.T. Robertson, Word Pictures in the New Testament, 1930

The stamp (the mark) may bear either the name or the number of the beast. The name and the number are one and the same. They could write the name in numerals, for numbers were given by letters. Swete suggests that it was "according to a sort of \gematria\ known to the Apocalypticist and his Asian readers, but not generally intelligible."

Joseph Seiss, The Apocalypse, 1865

The "mark" itself is at once a number and a name. The Apostle tells us what it is. As he gives it, it is made up of two Greek characters which stand for the name of Christ, with a third, the figure of a crooked serpent, put between them, the name of God's Messiah transformed into a Devil sacrament. (Joseph Seiss, *The Apocalypse*, 1865, p. 457)

MARK

5480 **charagma**, *khar'-ag-mah*; from the same as 5482 (*charax*) a scratch or etching, i.e. stamp (as a badge of servitude), or sculptured figure (*statue*): — graven, mark.

The mark (Gr. *charagma*, *stamp*) is to be stamped on the right hand or the forehead as the badge of the followers of Antichrist. (Unger's Bible Dictionary, 1957, p. 695)

Jack Van Impe, Dictionary of Prophecy Terms

MARK OF THE BEAST

This mark will consist of either the name of the Beast (Antichrist) or his number, 666 (Revelation 14:11). . .

It is likely that the Image of the Beast, a forth-coming master computer, will give Antichrist all the information necessary for him to govern the world. Its memory bank will know the number, record, and history of every living person. Perhaps this number would be composed of an international, national, and area computer code plus an individual number, such as one's social security number. The present international computer code is "6" . . . it could easily be expanded to "666." (Jack Van Impe, Dictionary of Prophecy Terms, "Mark of the Beast".)

Robert Van Kampen, The Sign, 1992

We do not know how the mark will be imprinted on the hand or the forehead. Given modern technology, however, there are numerous ways this could be accomplished. A tiny microchip, for example, could be imbedded just under the skin in the palm of the hand...it seems unlikely that the mark would be a series of numbers crudely branded on the hand or forehead, but it will be a mark nonetheless that clearly identifies the man with either the name of the beast or the number of his (Antichrist's) name. (Robert Van Kampen, The Sign, 1992, p. 231)

Vine's Expository Dictionary of Biblical Words, 1985

MARK (Noun)

1. *charagma* denotes "a stamp, impress" translated "mark" in Rev. 13:16, 17, etc. See GRAVEN. (Vine's Expository Dictionary of Biblical Words, p. 393)

John Wesley's Explanatory Notes on the Whole Bible

But he that had the mark, namely, the name of the first beast, or the number of his name - The name of the beast is that which he bears through his whole duration; namely, that of Papa or Pope: the number of his name is the whole time during which he bears this name. Whosoever, therefore, receives the mark of the beast does as much as if he said expressly, "I acknowledge the present Papacy, as proceeding from God;" or, "I acknowledge that what St. Gregory VII. has done, according to his legend, (authorized by Benedict XIII.,) and what has been maintained in virtue thereof, by his successors to this day, is from God." By the former, a man hath the name of the beast as a mark; by the latter, the number of his name. In a word, to have the name of the beast is, to acknowledge His papal Holiness; to have the number of his name is, to acknowledge the papal succession. The second beast will enforce the receiving this mark under the severest penalties. (John Wesley, Explanatory Notes on the Whole Bible, Revelation 13:17)

Warren Wiersbe, Be Victorious, 1985

Everybody (except believers; 20:4) will receive a special mark in order to buy or sell; but the only way to get that mark is to submit to "the beast" and worship him. . .

This special mark is the name or number of "the beast" — the mystical 666. (Warren Wiersbe, Be Victorious, 1985, pp. 107, 108)

Allen Woodham, South East Christian Witness Newsletter, 1996

In this soon-coming CASHLESS ELECTRONIC DEBIT system, no one will be able to BUY OR SELL anything, anywhere without the New World Order global biochip "MARK" in their right hands or foreheads (the mark of the beast) (Allen Woodham, South East Christian Witness Newsletter, Feb 1996, p 6)

Although the summary list is dated at this point in time, it does provide us insight how Bible scholars, theologians, prophecy writers, understood "666" and the "Mark" of the Beast. Many of the names noted have gone on to be with the Lord.

At this point, we need to do a background on Satan, his agenda, his strategy, and all that is relevant to the "Mark" of the Beast.

Satan: Facts, Beliefs, 666, Pictures, Worship, Quotes, Names

Satan or the Devil is the embodiment of evil, and plays a major role in Christian theology and literature, as well as in many other religions. He is the tempter and spiritual enemy of mankind. He is the adversary of God, although subordinate to him and able to act only by his sufferance, and is represented frequently as the leader or prince of all apostate angels and as ruler of hell. Satan is the force that loves to find the guilt and weakness in people, to humiliate them with it, to convince them that, because they are not perfect, God cannot love them.

Who is Satan?

In the Judeo Christian tradition, Satan, from the Hebrew word for "adversary," is the principal figure of the demonic world that is hostile to God and his will. In the Old Testament (for example, the Book of Job), Satan is presented as a distinct personality of darkness and accusation - the heavenly prosecutor. A fuller expression of his role is presented in the New Testament, where he is called "the tempter," "the slanderer," "the enemy," "the liar," and "the angel of the bottomless pit." Collectively, these titles present Satan as the one who has the power of death, rules with lies and deception, accuses humankind before God, and opposes the purpose of God in the world (while remaining obedient to God).

The concept of a temporal dualism in which Satan has influence is brought to expression most clearly in apocalyptic literature, such as the Book of Revelation. Two ages are reflected in apocalyptic cosmology: "this age" and "the age to come." Satan appears to be prevailing in this age, but in the age to come God will clearly display his sovereignty. In Christian tradition Satan is described as a fallen angel. Although no explanation is given in the Bible for God's allowing Satan to exist, it does indicate that his time is short (only for this age of time and history) and his end is certain - ultimately he will be banished by the Messiah.

Satan in the Bible

The Bible gives us a clear portrait of who Satan is and how he affects our lives. Put simply, the Bible defines Satan as an angelic being who fell from his position in heaven due to sin and is now completely opposed to God, doing all in his power to thwart God's purposes.

Satan was created as a holy angel. Isaiah 14:12 gives Satan's pre-fall name as Lucifer. Ezekiel 28:12-14 describes Satan as having been created as a cherubim, apparently the highest created angel. He became arrogant in his beauty and status and decided he wanted to sit on a throne above that of God -(Isaiah 14:13-14; Ezekiel 28:15; 1st Timothy 3:6). Satan's pride led to his fall. Notice the many "I will" statements in Isaiah 14:12-15. Because of his sin, God barred Satan from heaven.

Satan became the ruler of this world and the prince of the power of the air -(John 12:31; 2nd Corinthians 4:4; Ephesians 2:2). He is an accuser -(Revelation 12:10), a tempter -(Matthew 4:3; 1 Thessalonians 3:5), and a deceiver -(Genesis 3, 2nd Corinthians 4:4; Revelation 20:3). His very name means "adversary" or "one who opposes." Another of his titles, the devil, means "slanderer."

Even though he was cast out of heaven, he still seeks to elevate his throne above God. He counterfeits all of that God does, hoping to gain the worship of the world and encourage opposition to God's kingdom. Satan is the ultimate source behind every false cult and world religion. Satan will do anything and everything in his power to oppose God and those who follow God. However, Satan's destiny is sealed—an eternity in the lake of fire -(Revelation 20:10).

Old Testament

Satan was once a member of the divine council of God referenced in the Old Testament. He is referenced 11 times in Job and 4 other times in the Old Testament. The New Testament mentions Satan 34 times in all, starting with the first book Matthew and ending with the last Revelation. In the Christian tradition he rebelled against God and is now the enemy of God and man alike. He is the father of lies and no good is found in him. He leads a host of fallen angels (or demons) who know their days are numbered before they will be cast in the lake of fire and they seek to take as many humans as possible with them.

In Christian theology Satan's goal is to lead people away from the love of God, by tempting or tricking them. The only sources of supernatural power in the world are from either God (good) or Satan (evil). In the book of Genesis, Satan takes the form of a snake and tempts Eve with fruit from a tree. This causes sin to come into the world.

Satan, in the Book of Job, listens to God speak highly of Job and accuses Job to God before the host of angels that Job praises God only because he is blessed and would curse God if he was forced to suffer. God allows Satan to do what he will except to spare his life, and Satan causes Job to suffer immensely. (Job remained true to God through his hardships; Satan accused him further and punished him further, but could not get Job to break).

New Testament

In the New Testament, Satan tries to tempt Jesus in the desert, and fails. Jesus warns extensively to beware of Satan as does Paul. He appeals to Jesus through the primary temptations of Sin: Lust of the Flesh, Lust of the Eyes, and the Pride of Life.

What is the lust of the flesh, the lust of the eyes, and the pride of life? Simply stated, these are the three temptations to sin that every human will experience. All human will commit: Sins of commission and sins of omission. Now let's examine these three temptations to sin that every human will experience.

Satan is a synonym for the Devil. He is an angel who rebelled against God—and also the one who spoke through the serpent and seduced Eve into disobeying God's command. His ultimate goal is to lead people away from the love of God—to lead them to fallacies which God opposes. Satan is also identified as the accuser of Job, the tempter in the Gospels, the secret power of lawlessness in 2nd Thessalonians 2:7, and the dragon in the Book of Revelation. Before his insurrection, Satan was among the highest of all angels and the "brightest in the sky". His pride is considered a reason why he would not bow to God as all other angels did, but sought to rule heaven himself.

He is called "the ruler of the demons" -(Matthew 12:24), "the ruler of the world" and "the god of this world". -(2nd Corinthians 4:4). The Book of Revelation describes how Satan will

be cast out of Heaven, down to the earth, having "great anger" and waging war against "those who obey God's commandments and hold to the testimony of Jesus". Ultimately, Satan is thrown into the "Lake of fire", not as ruler, but as one among many, being tormented day and night forever and ever.

Names of Satan

The word Satan derives from the Hebrew "*ha-satan*", meaning the "accuser", "tempter", "persecutor", "calumniator", or "adversary". He "was a liar and a murderer from the beginning" -(John 8:44) Synonyms include Lucifer, demon, Mephistopholes, Mephisto, Beelzebub, the Evil One, the Tempter, and The Prince of Darkness. Only "devil" is used as an epithet for a profoundly evil person. The adjectives include "devilish," "demonic", and "diabolic". Those who worship Satan are called Satanists, Satan-worshippers, or demonists.

Satan. Satan is a spiritual being who led a heavenly revolt against God and was subsequently cast down into the earth -(Luke 10:18). His personal name, "Satan," means "adversary." This name indicates Satan's basic nature: he is the enemy of God, of all God does, and of all God loves.

Devil. He is also called "the devil" in the New Testament. The word "devil" means "false accuser" or "slanderer." Satan plays this role in Job 1–2 when he attacks Job's character.

Beelzebub. In Matthew 12:24; the Jews refer to Satan as "Beelzebub," an epithet derived from "Baal-Zebub" ("lord of the fly"), a false god of the Philistines in Ekron (2 Kings 1:2-3; 6).

Other. Other titles of Satan include the tempter -(1st Thessalonians 3:5), the wicked one -(Matthew 13:19; 38), the accuser of the brethren -(Revelation 12:10), and—three titles that point to Satan's authority in this world—the ruler of this world -(John 12:31), the god of this age -(2nd Corinthians 4:4), and the prince of the power of the air -(Ephesians 2:2). Second Corinthians 11:14 says that Satan transforms himself into "an angel of light," a description that highlights his capacity and inclination to deceive.

The Book of Revelation twice refers to "the dragon, that ancient serpent, which is called the devil and Satan," -(12:9, 20:2). The Book of Revelation also refers to "the deceiver," from which is derived the common epithet "the great deceiver."

There are a couple of passages which refer to the judgment of earthly kings but may very well also refer to Satan. The first is Isaiah 14:12-15. This is addressed to the king of Babylon -(verse 4), but the description also seems to fit that of a more powerful being. The name "Lucifer," which means "morning star," is used here to describe someone who sought to overthrow God's very throne.

The second passage is Ezekiel 28:11-19, addressed to the king of Tyre. As in the "Lucifer" passage, this prophecy contains wording that seems to go beyond the description of a mere mortal. The king of Tyre is said to be "anointed as a guardian cherub," but he was laid low by pride and "expelled" by God Himself.

In addition to providing names and titles of Satan, the Bible uses various metaphors to reveal the character of the enemy. Jesus, in the parable of the four soils, likens Satan to the birds that snatch the seed off the hardened ground -(Matthew 13:4; 19). In another parable, Satan appears as the sower of weeds among the wheat -(Matthew 13:25; 28). Satan is analogous to a wolf in John 10:12 and a roaring lion in 1 Peter 5:8. In Revelation 12:9; Satan is the "great dragon . . . that serpent of old"—obviously, a reference to the serpent who deceived Eve -(Genesis 3:1).

Satan's Fall From Heaven

Satan's fall from heaven is symbolically described in Isaiah 14:12-14 and Ezekiel 28:12-18. While these two passages are referring specifically to the kings of Babylon and Tyre, they also reference the spiritual power behind those kings, namely, Satan. These passages describe why Satan fell, but they do not specifically say when the fall occurred. What we do know is this: the angels were created before the earth -(Job 38:4-7). Satan fell before he tempted Adam and Eve in the Garden -(Genesis 3:1-14). Satan's fall, therefore, must have occurred somewhere after the time the angels were created and before he tempted Adam and Eve in the Garden of Eden. Whether Satan's fall occurred a few minutes, hours, or days before he tempted Adam and Eve in the Garden, Scripture does not specifically say.

Why did Satan fall from heaven? Satan fell because of pride. He desired to be God, not to be a servant of God. Notice the many "I will..." statements in Isaiah 14:12-15. Ezekiel 28:12-15 describes Satan as an exceedingly beautiful angel. Satan was likely the highest of all angels, the most beautiful of all of God's creations, but he was not content in his position. Instead, Satan desired to be God, to essentially "kick God off His throne" and take over the rule of the universe. Satan wanted to be God, and interestingly enough, that is what Satan tempted Adam and Eve with in the Garden of Eden -(Genesis 3:1-5). How did Satan fall from heaven? Actually, a fall is not an accurate description. It would be far more accurate to say God cast Satan out of heaven -(Isaiah 14:15; Ezekiel 28:16-17). Satan did not fall from heaven; rather, Satan was pushed out of heaven.

Why did God Allow Satan and the Demons to Sin?

With both the angels and humanity, God chose to present a choice. While the Bible does not give many details regarding the rebellion of Satan and the fallen angels, it seems that Satan—probably the greatest of all the angels -(Ezekiel 28:12-18)—in pride chose to rebel

against God in order to seek to become his own god. Satan (Lucifer) did not want to worship or obey God; he wanted to be God -(Isaiah 14:12-14). Revelation 12:4 is understood to be a figurative description of one third of the angels choosing to follow Satan in his rebellion, becoming the fallen angels—demons.

Unlike humanity, however, the choice the angels had to follow Satan or remain faithful to God was an eternal choice. The Bible presents no opportunity for the fallen angels to repent and be forgiven. Nor does the Bible indicate that it is possible for more of the angels to sin. The angels who remain faithful to God are described as the "elect angels" -(1st Timothy 5:21). Satan and the fallen angels knew God in all His glory. For them to rebel, despite what they knew about God, was the utmost of evil. As a result, God does not give Satan and the other fallen angels the opportunity to repent. Further, the Bible gives us no reason to believe they would repent even if God gave them the chance -(1st Peter 5:8). God gave Satan and the angels the same choice He gave Adam and Eve, to obey Him or not. The angels had a free-will choice to make; God did not force or encourage any of the angels to sin. Satan and the fallen angels sinned of their own free will and therefore are worthy of God's eternal wrath in the lake of fire.

Why did God give the angels this choice, when He knew what the results would be? God knew that one-third of the angels would rebel and therefore be cursed to the eternal fire. God also knew that Satan would further his rebellion by tempting humanity into sin. So, why did God allow it? The Bible does not explicitly give the answer to this question. The same can be asked of almost any evil action. Why does God allow it? Ultimately, it comes back to God's sovereignty over His creation. The Psalmist tells us, "As for God, His way is perfect" -(Psalm 18:30). If God's ways are "perfect," then we can trust that whatever He does—and whatever He allows—is also perfect. So the perfect plan from our perfect God was to allow sin. Our minds are not God's mind, nor are our ways His ways, as He reminds us in Isaiah 55:8-9.

The most likely explanation for the existence of evil, is that good can come out of it. For example, certain virtues couldn't exist without evil: courage, mercy, forgiveness, patience, the giving of comfort, heroism, perseverance, faithfulness, self-control, long-suffering, submission and obedience, to name a few. These are not virtues in the abstract, but elements of character that can only be had by moral souls. Just as evil is a result of acts of will, so is virtue. Acts of moral choice accomplish both.

What good comes out of a drive-by killing, someone might ask, or the death of a teenager through overdose, or a daughter's rape, or child abuse? The answer is that a commensurate good doesn't always come perceptibly out of those individual situations, though God is certainly capable of redeeming any tragedy. Rather, the greater good results from having a world in which there is moral freedom, and moral freedom makes moral tragedies like these possible. We have seen in the past two years an explosion of exposes of sex crimes, pedophilia, pederasty, sex trafficking that is global in nature. A book just released by a UK publisher, '*In The Closet of The Vatican*' was released on the exact same day that Pope Francis was holding a summit on sexual abuse of children at the hands of Catholic priests and bishops. The Catholic

Church is a snake pit, and the Vatican is the hold of every manner of vile and unclean spiritual devils. The author claims that 80% of Roman Catholic priests are homosexuals.

This observation reveals an interesting twist in this problem. If morality freely chosen can only happen in a world where evil is possible, then heaven will be a place where there will be no moral growth, where moral choices will not be possible because all the inhabitants of heaven will be immutably good. Growth of the soul is only possible and available to inhabitants of a fallen world.

Two Scriptural observations lend credibility to this view. First, in recounting the great heroes of faith, the writer of Hebrews mentions that some were rescued by faith, but others endured by faith **"...in order that they might obtain a better resurrection."** -(Hebrews 11:35) Second, St. Paul tells St. Timothy that **"...godliness is profitable for all things, since it holds promise for the present life and also for the life to come."** -(1st Timothy 4:8)

Both of these verses indicate that conditions in this life affect conditions in the next. Bearing up under evil in this life improves our resurrection in the next. Godliness in this life brings profit in the next. These benefits are not available after this life or there would be little urgency to grow now; all eternity would be left in which to catch up.

A deeper, more profound good results when virtue is won by free, moral souls struggling with evil, rather than simply granted to them as an element of their constitution.

There is a sound reason why God has allowed man the freedom to choose evil. It doesn't conflict with His goodness. God is neither the author of evil, nor its helpless victim. Rather, precisely because of His goodness He chooses to co-exist with evil for a time, that His goodness may be all the more manifest in those who overcome it by freely choosing to do good and avoid evil.

"And we know that to them that love God, all things work together unto good, to such as, according to his purpose, are called to be saints." -(Romans 8:28)

It is already clear from over 10,000 studies on 2G, 3G, and 4G that these wireless network radio frequency (RF) radiation network systems are causing significant acute and chronic health problems, including life-threatening diseases such as cancer, heart disease, type-2 diabetes, and mental disturbances, such as depression, anxiety, and increased suicidal tendencies.

Beyond the statements of informed individuals decrying the 5G “rollover”, there are also major organizations warning of its dangers. The International Appeal to Stop 5G on Earth and in Space currently boasts approximately 31,300 signatories as of January 11th, 2019. They write,

“We the undersigned scientists, doctors, environmental organizations and citizens from () countries, urgently call for a halt to the deployment of the 5G (fifth generation) wireless network, including 5G from space satellites. 5G will massively increase exposure to radio frequency (RF) radiation on top of the 2G, 3G and 4G networks for telecommunications already in place. RF radiation has been proven harmful for humans and the environment. The deployment of 5G constitutes an experiment on humanity and the environment that is defined as a crime under international law.”

Even before 5G was proposed, dozens of petitions and appeals[i] by international scientists, including the Freiburger Appeal signed by over 3,000 physicians, called for a halt to the expansion of wireless technology and a moratorium on new base stations.[ii] In 2015, 215 scientists from 41 countries communicated their alarm to the United Nations (UN) and World Health Organization (WHO).[iii] They stated that “numerous recent scientific publications have shown that EMF [electromagnetic fields] affects living organisms at levels well below most international and national guidelines”. These concerns have a strong scientific foundation. More than 10,000 peer-reviewed scientific studies demonstrate harm to human health from RF radiation.[iv] [v]

These wise statements, while accurate on one level, are missing the larger point. There is a plan, within the next two years, to launch 20,000 satellites to beam 5G onto the planet. This new attack on life on Earth would cause a disruption of the earth’s primary harmonic frequency called the Schumann Resonance. When this harmonic resonance is disrupted, it is likely to cause and activate more physical and biological mechanisms for creating even more human health problems.

In order that the reader understands the issue of 5G is really quite simple in terms of how it impacts all of us. If you are connected to the “Internet of Things”, cell phone, PC, iPad, laptop, Kindle, Roku, anything that is wireless you are vulnerable. For example, my hard drive has a wireless antenna and a wireless mouse. Both of those little devices internally has a UPC bar code label, some visible, and some not so visible. Each of the electronic devices in your home is connected to a wireless router. Let’s look now at how those 20,000 satellites will be saturating the air waves.

Since there’s not a lot of understanding about the Schumann Resonance, a little bit of background will help the discussion. The Schumann Resonance is a frequency generated from the wave resonance of the lower part of the ionosphere and the earth. The ionosphere has several different layers and is a shell of electrons and electrically charged atoms and molecules that surrounds the earth. It stretches from a height of about 50 km (31 miles) to 1,000 km (620 miles). The most relevant layer is the D-layer, which is the innermost layer at about 37-56 miles above Earth’s surface. It’s between the earth and the D-layer where there’s a resonance that is set up that creates the Schumann Resonance. There is a significant amount of research on the topic. In a paper by Neil Cherry published in July of 2002, he writes, “A large number of studies have identified significant physical, biological, and health effects associated with changes in solar and geomagnetic activity (S-GMA).”

The Schumann Resonance is a geomagnetic electric resonance between the surface of the earth and the lower levels of the ionosphere, which has a natural ultra-low frequency and extreme low-frequency signal. They are discovering that the Schumann Resonance signal is correlative with sunspot numbers and has a real physical mechanism located in the D-layer of the ionosphere with an ion and electron density that varies with the S-GMA. The Schumann Resonance would be potentially disrupted by 20,000 5G satellites put into orbit in the D-region of the ionosphere, as this D-region forms the upper boundary of the resonant cavity in which the Schumann Resonance is formed in relation to the earth. Research suggests that the Schumann Resonance signals are the mechanism through which melatonin production is activated. When the Schumann Resonance goes above 7.87 Hz, there is a decrease in melatonin secretion.

Many feel that the Schumann Resonance is already being altered by all the radio frequency/microwave (RF/MW) radiation humans are presently creating, and 5G will alter it significantly more. In the process, the 5G may also be creating enough electro--pollution noise, whether or not it is raising the Schumann Resonance frequency, and therefore disconnecting humanity from accessing the Schumann Resonance itself, and, thus, creating and/or amplifying a variety of acute and chronic disease problems documented in over 10,000 scientific papers that come from these 2G, 3G, and 4G frequencies.

The Schumann Resonance is essentially the pulse of the heart of the earth, to which our hearts and brains are specifically attuned with. It is highly likely it will be disrupted by 5G satellites, and thus would disrupt the basic harmonic of all life on the planet. The Schumann Resonance particularly resonates with our brains and hearts. This fact takes us to the heart of the matter. Basically, the electromagnetic field generated by the heart is evolutionarily tuned to 7.83 Hz. As this frequency potentially changes due to the increase in RF/MW radiation, it would most likely create problems in human health. This research needs to be done before 5G, and, particularly, 5G beamed from satellites is installed. This is basic health safety research. The Schumann Resonance is a planetary tuning fork to which all lifeforms on the surface of our planet are tuned. In essence, the physical, emotional, mental, and spiritual bodies and minds would be highly likely to be affected as the Schumann Resonance is disrupted.[vi] [vii] If it continues to rise in frequency due to the 5G (100 times more intense than current microwave), these human-made electromagnetic fields will create electromagnetic chaos. The increase of the Schumann Resonance above 7.83 Hz would increase the chaos within all biological organisms on the planet.

Researchers have shown that there is a key connection between the Schumann Resonance and the brain's alpha states (frequencies between 8 Hz – 12 Hz). Many researchers, such as Dr. Konig, from Munich University, have shown a correlation between Schumann Resonance and brain rhythms. Alpha states are the brainwave frequency at which thinking and creativity are associated. Alpha brainwaves are associated with overall mental and body/mind coordination, alertness, and learning. These are core human functions, which may eventually express problematically as discordant psychological states.

The good news is that as long as the properties of the earth's electromagnetic cavity, which holds the Schumann Resonance remain the same, we will remain in harmony with the Schumann Resonance and with the earth. The Schumann Resonance also helps the human biological system to become synchronized with the daily rhythmic cycles of the earth and melatonin production. According to Dr. Cherry's research, as we disrupt the Schumann Resonance, including raising the potential frequency above 7.83 Hz through a variety of ways, we decrease melatonin secretion, which decreases our ability to be in harmony with the earth's daily rhythmic cycles. Specifically, when there is an alteration, such as changes in S-GMA activity, ill effects follow such as altered blood pressure; reproductive, immune system, cardiac and neurological problems; mental disorders, depression, and suicide; increase hospital admissions, accidents, and sudden death; as well as other stress-related conditions. These electromagnetic disruptions and their negative health effects are not new, but 5G is one hundred times more potent in moving in that direction and will likely result in an increase in cancer, heart disease, depression, and other diseases. We already see epidemics in all these areas, as well as in type-2 diabetes. In *There Is a Cure for Diabetes*, this form of electromagnetic RF/MW radiation caused type-2 diabetes is well documented.

The awareness of the Schumann Resonance helps us to see the real cosmic interconnectedness of all of us humans, animals, plants, the planet earth, and the sun and moon. EMF and EMFR reduce melatonin secretion in animals and people. Once we understand that, it helps us examine at least one mechanism for why, indeed, we are seeing so many health problems. Melatonin is a vital natural neuro-hormone that regulates the daily circadian rhythm in mammals. Melatonin is the most potent known antioxidant; it has also been shown to protect against various forms of cancer. The pineal gland's production of melatonin rises at night, and the melatonin is carried by the circulation system throughout the body, passing through the cell membrane and scavenging free radicals in the cell in order to protect the DNA.

Melatonin also has many other vital functions involving the assistance of the immune system to maintain its immune-competence, and it regulates sleep activity including aspects of REM sleep and sleep efficiency. Reduced melatonin production causes many serious biological effects in humans and other mammals, including chronic fatigue, sleep disturbance, DNA damage leading to cancer, cardiac, reproductive and neurological diseases, and mortality. Melatonin reduction is also associated with arthritis, depression, and suicide, seasonally affective disorder (SAD), miscarriage, sudden infant death syndrome (SIDS), schizophrenia, Alzheimer's disease, and Parkinson's disease. Multiple independent studies have found that electromagnetic fields reduced melatonin in animals and human beings. The scientific evidence includes correlations with altered geomagnetic activity reducing human melatonin, through the Schumann Resonance signal effect. The level of evidence exceeds requirements for a causal link, strongly suggesting that melatonin production caused by electromagnetic fields and radiation exposure contributes significantly to the allocation of many adverse health effect rates.[viii]

All life has adapted over time to live in the electromagnetic frequencies of the Schumann Resonance, somewhere between 7.83 and 8 Hz. When we move away from this

biologically attuned resonance field, it is highly likely to result in disorganization of our electrophysiology. This means that if you are susceptible to some of these frequencies, you may begin feeling “unusual stress, mental confusion, forgetfulness, unusual or repetitive thoughts and mood swings, periods of diminished hearing and eyesight, sudden onset of unexplained neurological problems and sharp pains shooting into head, as well as symptoms that mimic mental illness; depression, split personality disorder, and paranoid schizophrenia.[ix]

The 5G frequencies have already been shown potentially to literally have a mass effect on mental functions in the populace. This has obvious serious negative spiritual implications because if you don't have a functioning brain it is very hard to access our soul connection and evolve spiritually on the planet from a spiritual point of view. An additional worry held by many anti-globalists is that the globalist elites will use 5G, in a high percentage of cases, to keep everyone's brainwaves in a range that prevents critical thought processing, and thus keeping people in the brainwave range that favors their agenda, for example, an emotional, slow, or hysteric state of thought — all depending on what they want the population to think. We need to understand that 5G will greatly amplify these mind-control mechanisms that have already been proven to exist and be effective scientifically.

Research in the last 20 years shows that ELF electromagnetic fields affected the way calcium ions move in brain tissue and the way this affects the cells' inner workings. The more permeable blood/brain barrier, which will happen with the 5G, a greater amount of toxins can enter the brain. The opening of the blood/brain barrier and calcium leakage is also associated with oxidative damage to the neurons; and it also breaks up the DNA structure. All of this is already associated with electro-smog, dirty electricity, electrical pollution, and electrical hypersensitivity, which is seen in many patients.

In addition to this, the 5G frequency is connected to the 60 GHz millimeter-wave band — 5G applications will require unlocking of new spectrum bands in higher frequency ranges above 6 GHz to 100 GHz and beyond (5G is to start initially with sub-6GHz moving as quickly into 6GHz and above as the network advancement allows). This will allow the utilization of sub-millimeter and millimeter waves to allow ultra-high rates of data to be transmitted in the same amount of time as compared with previous deployments of RF/MW radiation. 5G represents a massive step up from 3G at 1.8-2.5 GHz, and 4G at 2-8 GHz, placing it well within the microwave category. This frequency is miles away from the natural resonance of 8Hz that our bodies are accustomed to, and far, far above current EMF levels (which are already damaging enough). High-frequency 60GHz 5G has already been shown to interfere with the oxygen molecules we breathe. Joe Imbriano, hosts “The Fullerton Report” out of California and has studied the molecular level of impact 5G will have and made an alarming discovery — 5G's 60GHz bandwidth was selected for a specific reason. Imbriano thinks this reason may be to negatively affect the oxygen we breathe as part of a population control mechanism: *“60GHz is the frequency of oxygen molecule absorption. Oxygen molecules have electrons that they share with each other, oxygen is a diatomic molecule. What we breathe are two oxygen molecules bonded together with the electrons that they share.”* When the oxygen molecule is hit with 60GHz 5G waves, these waves affect the orbital resonance properties of those shared electrons. It is those

shared electrons that bind to the hemoglobin in our blood. In addition to disrupting oxygen absorption, 5G will alter the iron and magnetite function respectively of the hemoglobin and pineal gland. Hemoglobin and the pineal gland have a magnetic compound within them. The magnetic field disruption is already happening, but, with 5G, this disruption will be more seriously amplified. Hemoglobin is a very complex ferromagnetic compound. If we interfere with the orbital spin properties of diatomic oxygen's (O₂) electrons via 5G, our ability to absorb oxygen will be significantly hampered, creating slow suffocation. Because of this additional factor, with or without 5G, people should avoid 60 GHz Wi-Fi systems in any case. At 60GHz the frequencies also impair the body's ability to produce vitamin D and melanin. In this context, 5G and the 60 GHz delivery system is an overt attack on the human body.

Most living organisms are naturally equipped to deal with low-level environmental frequency exposure. For example, a ferromagnetic compound called magnetite is naturally present in the brain that absorbs frequencies up to 12GHz, which shields the brain from such radiation. However, beyond 12GHz this natural defense is rendered ineffective; our biology hasn't made provisions for a frequency exposure as abnormal as 5G at 60 GHz will be, which is well above 12 GHz and beyond.

In summary, we've been given a story of how good it is that we can have "smart" homes, "smart" businesses, "smart" highways, "smart" cities and self-driving cars. Virtually everything we own and buy, from refrigerators and washing machines to milk cartons, hairbrushes, and infants' diapers, will contain antennas and microchips and will be connected wirelessly to the Internet. We're being told that this is a good thing, but it's not if we value our physical, mental, moral, and spiritual health. In other words, no matter how "ultra-convenient" these ultra "smart" devices, agreeing to be seduced by the promises of convenience is potentially not too smart. What isn't acknowledged in all this media hype is that this technology may present as an unprecedented negative environmental effect.

The planet, plants, animals, humans, and all life on Earth are in jeopardy. With millions of new 5G base stations, also known as cell towers or small cells, from Earth, and 20,000 new satellites from space simultaneously beaming hundreds of times more powerfully focused RF/MW radiation of pulse modulated millimeter waves, with a much higher absorption rate than 4G/3G/2G centimeter waves, through walls, trees, and human bodies day and night, we're talking about an estimated of 200 billion transmitting objects, which will be part of the "Internet of Things" (IoT) by 2020. This could be a large-scale and complete disaster for the human race. Part of what the globalists are trying to do is deny that there's a problem with non-ionizing frequencies, even though, as already stated, more than 10,000 papers are saying there are indeed multiple levels of health problems. According to the actual scientific research, there's clear evidence of damage of DNA, cells, and organs in a wide variety of ways and increased disease processes, including cancer, heart disease, diabetes, and a host of electromagnetic diseases. If 5G comes to fruition, no person, no animal, and no plant will be able to avoid the 24/7 exposure to levels of RF/MW radiation that are at least 100 times greater than current levels. 5G will threaten to provoke severe and irreversible effects in humans and also damage to all of Earth's ecosystems.

The potential or actual disruption of the Schumann Resonance effect on all life on the earth and also our atmosphere is an important additional insight into the whole picture of how we'll be susceptible to a variety of illnesses from 5G. In order to transmit the enormous amounts of data required for the "Internet of Things" (IoT), 5G technology, when fully deployed, will use millimeter waves, which are poorly transmitted through solid material. This will require every carrier to install base stations every 100 meters[x] in every urban area in the world. Unlike previous generations of wireless technology, in which a single antenna broadcasts over a wide area, 5G base stations and 5G devices will have multiple antennas arranged in "phased arrays"[xi] [xii] that work together to emit focused, steerable, laser-like beams that track each other. Each 5G phone will contain up to dozens of tiny antennas, all working together, to track and aim a narrowly focused beam at the nearest cell tower, which may be less than 25 feet from your home; and those beams will be sent back and forth between the 5G device and the cell tower in order to be able to handle important things like Ultra HD video downloaded in seconds versus minutes for 1,000 people per meter. Unfortunately, the US Federal Communications Commission (FCC) has adopted rules[xiii] permitting the effective power of those beams from a 5G cell phone is to be as much as 20 watts, ten times more powerful than the levels permitted for current phones. Each 5G base station will contain hundreds or thousands of antennas aiming multiple laser-like beams simultaneously at all cell phones and user devices in its service area. This technology is called "multiple input multiple output" or MIMO. FCC rules permit the effective radiated power of a 5G base station's beams to be as much as 30,000 watts per 100 MHz of spectrum, or equivalently 300,000 watts per GHz of spectrum, an estimated hundreds of times more powerful than the levels permitted for current base stations.

Making potential health problems significantly worse, at least five companies[xiv] are proposing to provide 5G from space from a combined 20,000 satellites in low- and medium-Earth orbit that will blanket the Earth with powerful, focused, steerable beams. Each satellite will emit millimeter waves with an effective radiated power of up to 5 million watts[xv] from thousands of antennas arranged in a phased array. Although the energy reaching the ground from satellites will be less than that from ground-based antennas, it will irradiate areas of the Earth not reached by other transmitters and will be additional to ground-based 5G transmissions from billions of IoT objects. Even more importantly, the satellites will be located in the Earth's magnetosphere, which exerts a significant influence over the electrical properties of the atmosphere including the Schumann Resonance. As previously explained, the alteration of Earth's electromagnetic environment, especially where Schumann Resonance resides, may be an even greater threat to life than the radiation from ground-based antennas.

In conclusion, in 2015, 215 scientists from 41 countries communicated their alarm (about the potential of 5G) to the United Nations (UN) and World Health Organization (WHO).[xvi] They stated that "numerous recent scientific publications have shown that EMF [electromagnetic fields] affects living organisms at levels well below most international and national guidelines". As already stated, more than 10,000 peer-reviewed scientific studies demonstrate harm to human health from RF/MW radiation.[xvii] [xviii] Effects include:

Damage goes well beyond the human race, as there is abundant evidence of harm to diverse plant- and wildlife[xl] [xli] and laboratory animals, including ants,[xlii] birds,[xliii] [xliv] forests,[xlv] frogs,[xlvi] fruit flies,[xlvii] honey bees,[xlviii] insects,[xlix]mammals,[l] mice,[li] [lii] plants,[liii] rats,[liv] trees,[lv] and microbes.[lvi]

The Earth and the ionosphere and the lower atmosphere form the Global Electric Circuit in which we live. It is well established that biological rhythms are controlled by Earth’s natural electromagnetic environment, which is this global electric circuit. - The Rio Declaration on Environment and Development (1992) has also been violated: “States have... the responsibility to ensure that activities within their jurisdiction or control do not cause damage to the environment of other States or of areas beyond the limits of national jurisdiction” (principle 2).

- The United Nations World Summit on Sustainable Development (2002) has also been violated: “There is an urgent need to... create more effective national and regional policy responses to environmental threats to human health” (para. 54(k)).

- The African Convention on the Conservation of Nature and Natural Resources (2017) has also been violated: “The Parties shall... take all appropriate measures to prevent, mitigate and eliminate to the maximum extent possible, detrimental effects on the environment, in particular from radioactive, toxic, and other hazardous substances and wastes” (art. 13).

- The Universal Declaration of Human Rights: “Everyone has the right to life, liberty and security of person” (art. 3).

- The United Nations Global Strategy for Women’s, Children’s and Adolescents’ Health (2016-2030) has as objectives and targets to “transform”, by expanding enabling environments; to “survive”, by reducing maternal and newborn mortality; and to “thrive” by ensuring health and well-being and reducing pollution-related deaths and illnesses.

- The Outer Space Treaty (1967) requires that the use of outer space be conducted “so as to avoid [its] harmful contamination and also adverse changes in the environment of the Earth”(art. IX).

- The United Nations Guidelines for The Long-Term Sustainability of Outer Space Activities (2018): “States and international intergovernmental organizations should address... risks to people, property, public health and the environment associated with the launch, in-orbit operation and re-entry of space objects” (guideline 2.2(c)).

The violation of all those international agreements, given the knowledge of the seriously detrimental physical, emotional, mental, and spiritual effects of 5G, is a serious planetary violation. With the slightest imagination, one can see how the implementation of 5G, going a step further, may actually limit and block spiritual evolution on the planet as it is explicitly detrimental to the higher brain and spiritual function. that the CEO's or government officials gain, they are vulnerable to multi-million or multi-billion-dollar liability claims, which can be used to place a lien on them or even shut the company down, no matter how big the company is. A lawful humanitarian activist group called InPowerMovement.com has a proven successful track record in removing toxic Smart Meters worldwide and will have boilerplate documents available in the near future to facilitate a similar halt of 5G. Inhabitants of the United States of America will be the first to use these boilerplate documents. Other countries will follow shortly thereafter. - Some 5G base stations have already been installed residentially without consent or knowledge based on “perceived demand”. If people refuse to purchase 5G devices, it will disrupt the 5G rollout from the grassroots level.

- We must urge all regulatory agencies, at local, national, and international levels, to halt the 5G RF/MW radiation expansion until independent scientists can ensure that 5G and the total radiation levels caused by current RF/MW radiation, EMF, and 5G, together with 2G, 3G, 4G, WiFi, and Smart Meters are not harmful to all world citizens.

- Recommend that all countries, especially their so-called radiation safety agencies, inform citizens, including teachers and physicians, about the health risks of RF/MW radiation and how and why to avoid, or at least minimize wireless communications.

Back in the summer of 2016, several New York University students took it upon themselves to investigate just how far 5G millimeter waves could travel in rural southwest Virginia. A two-day testing event took place in and around the town of Riner, VA after the students erected a transmitter on the front porch of their professor's mountain home. Then, they chose 36 locations from which to measure any 5G millimeter waves being received from the 5G equipment on Professor Ted Rappaport's front porch.

To their delight, the group found that the waves could travel more than 10 kilometers in this rural setting, even when a hill or knot of trees was blocking their most direct route to the receiver. The team detected millimeter waves at distances up to 10.8 kilometers at 14 spots that were within line of sight of the transmitter, and recorded them up to 10.6 kilometers away at 17 places where their receiver was shielded behind a hill or leafy grove. They achieved all this while broadcasting at 73 Gigahertz (GHz) with minimal power—less than 1 watt.

The 73 GHz frequency band is much higher than the sub-6 GHz frequencies that have traditionally been used for cellular signals. In June, the Federal Communications Commission opened 11 GHz of spectrum in the millimeter wave range (which spans 30 to 300 GHz) to carriers developing 5G technologies that will provide more bandwidth for more customers.

In the past, Rappaport's group has shown that a receiver positioned at street level can reliably pick up millimeter waves broadcast at 28 GHz and 73 GHz at a distance of up to 200 meters in New York City using less than 1 watt of transmitter power—even if the path to the transmitter is blocked by a towering row of buildings.

Before those results, many had thought it wasn't possible to use millimeter waves for cellular networks in cities or in rural regions because the waves were too easily absorbed by molecules in the air and couldn't penetrate windows or buildings. But Rappaport's work showed that the tendency of these signals to reflect off of urban surfaces including streets and building facades was reliable enough to provide consistent network coverage at street level—outside, at least.

However, did Professor Rappaport and his students take into consideration whether there were any non-thermal radiation effects upon humans, animals or the environment that were within the distances 5G millimeter waves were being transmitted?

Researchers working in the microwave industries seem concerned only with verifying transmission ranges and bandwidths, but not in questioning—nor looking for—whether there are electromagnetic hypersensitivities being caused by millimeter wave transmissions, since that type of testing apparently has not been performed on any of the former generations (G's) used within the microwave industry. That industry only acknowledges heat (thermal) sensitivity at the specific urging and industry parameters apparently set by ICNIRP.

Shouldn't environmental impact studies, plus consumer health contraindications assessments, i.e., electromagnetic hypersensitivity (EHS), aka IEI (Idiopathic Environmental

Intolerance), be mandated to be performed by federal and state health regulatory agencies, specifically the Federal Communications Commission, since there have been thousands—if not millions—of strange debilitating health problems for U.S. and global consumers since electric utilities have retrofitted AMI Smart Meters, which emit microwaves?

What adverse health impacts can consumers expect when 5G cells will be placed outside their bedroom windows, front doors or in their back yards? Who in the microwave industry is willing to answer that question? For non-consensus science results, we have to look to independent academic researchers who do not agree with the microwave professional associations claims of only “thermal” effects!


Apparently, the students’ testing results are providing some beginning research for an ability to install rural cellular networks! However, there are natural factors like weather and rain, which can diminish or reduce the signal strength, thereby affecting how far a 5G signal can travel. Microwaves, I think, should not be considered as a dependable communications “infrastructure”! Lots of things can interfere with it.

By collecting rural measurements for millimeter waves, the NYU experiment was designed to evaluate a propagation model that the standards group called the 3rd Generation Partnership Project (3GPP) has put forth for simulating millimeter waves in rural areas.

The NYU group suggests that because this model was “hastily adopted” from an earlier one used for lower frequencies, it’s ill-suited to accurately predict how higher frequencies behave. Therefore, according Rappaport’s team, the model will likely predict greater losses at longer distances than actually occur. Rappaport prefers what’s called a close-in (CI) free-space reference distance model, which better fits his measurements. A representative of 3GPP was not available for comment.

The above technical information is one of the most comprehensive documents that I have found and read. Many of you will not fully grasp the importance of what all of this means. Since we are talking about something that is invisible, it becomes more difficult to comprehend. The telecommunications industry has invested \$59-billion dollars in 5G technology.

The new fifth generation (5G) cellular system that is being installed in major American cities such as **Dallas, Atlanta, Waco, Texas, and Sacramento** [1, 3] will intensify the microwave radiation health risks for everyone living in those cities. [2]

Deployment of next-generation 5G technology won't happen overnight, but AT&T said Monday at its Spark conference in **San Francisco** that it plans to target some of the larger U.S. cities with 5G deployments in 2018 and 2019, including saturating parts of the Bay Area.

The company has already said that it plans to roll out 5G in **Atlanta**, Georgia; Charlotte and **Raleigh** in North Carolina; **Dallas** and **Waco** in Texas; **Indianapolis**, Indiana; and **Oklahoma City**, Oklahoma. To this list, the company has added two more cities in Texas, **Houston** and **San Antonio**; **Jacksonville**, Florida; **Louisville**, Kentucky; and **New Orleans**, Louisiana—again, with plans to bring the 5G technology to these cities later this year. Some cities have already begun receiving the first shipments of 5G equipment, AT&T said.

In 2019, AT&T plans to roll out 5G to yet more cities. These will include parts of **Las Vegas**, Nevada; **Nashville**, Tennessee; **Orlando**, Florida; and four cities in California: **Los Angeles, San Diego, San Francisco, and San Jose**.

AT&T's transition to 5G began several years ago, when the company deployed a higher-speed version of its 4G network, called 5G Evolution, to several United States cities. AT&T now says

that it's actually at the point of testing "standards-based, production equipment with a mobile form-factor device." Over the weekend, AT&T claimed it made the world's first wireless 5G data transfer using this equipment, specifying that it wasn't in a lab, or with emulators, or preproduction hardware—the real deal, in other words.

AT&T said it will work with Ericsson, Nokia, and Samsung as the company's technology partners to build out the 5G network. It's not clear whether Nokia will supply the basic infrastructure or actual handsets.

AT&T and Samsung have previously announced a partnership to roll out 5G handsets. However, Justin Denison, the senior vice president of marketing for Samsung in North America, declined to be pinned down, saying Samsung will make that 5G announcement when "the time is right," Denison said. at the AT&T Spark conference in San Francisco.

AT&T didn't make any public claims about the available bandwidth that will accompany 5G deployment, or what Eleven More Cities Targeted for 5G Deployment this Year



The new 5G cell systems that Verizon and AT&T are planning to install in other cities in 2018 [1, 3] will use shorter length microwaves than the existing 4G (fourth generation) systems. New generation cell phones will be able to communicate with either 5G or 4G microwave towers to optimize connectivity.

Copper phone lines will be replaced with 5G rooftop antennas on homes and businesses. These antennas will communicate with 5G cell towers and with the wireless equipment in homes and offices to provide phone and broadband services.

5G will be the foundation for the “smart cities” of the future. [15]

The Safety of 5G Has Not Been Tested

The microwave frequencies that are being used in this new generation 5G system are in the 1-millimeter wave length.

The long-term health risks of these short microwaves have not been adequately tested and the Federal Communications Commission (FCC) and telecom companies are simply presuming that they are safe based on 1996 research. [2, 16]

New Research Reveals Harmful Effects of Cellular Systems

Research on microwave frequency radiation conducted since 1996 shows that the existing 3G and 4G cellular systems are causing serious harm to human health.

The 5G systems will increase the level of harm to the level where illness and death can no longer be denied. [16]

Harmful Effects are Cumulative

We now know that the development of cancer, heart disease, diabetes, Alzheimer’s and numerous other diseases and disabling symptoms are linked to the cumulative effects of microwave radiation.

Cellular systems are pushing microwave radiation into our bodies and brains 24 hours a day regardless of whether we use a cell phone or even own one. [4, 5, 16]

AT&T didn’t make any public claims about the available bandwidth that will accompany 5G deployment, or what its tests actually generated. Instead, the message here is that 5G’s goal is to reduce network latency significantly to enable technologies like cloud-based rendering for gaming, and also to improve business technologies like manufacturing, so that robotic production equipment can be remotely synchronized.

What this means for you: Just like 4G slowly rolled out, you can expect 5G to do the same. Verizon is slowly deploying 5G across 11 cities, and other carriers are as well. Over time, 5G will supersede 4G across the country—but only for handsets that support it. As you consider your own smartphone purchases for 2019 and beyond, which network—4G or 5G—will once again have to be factored in which phone you eventually buy.



The 5G towers will be spaced approximately 500 feet apart and will be highly visible eyesores. The “small cell” transmitters will be mounted on top of electric utility poles, municipal buildings, schools, and in city parks, on top of street signs, bus shelters, and anywhere else telecom companies wish.

In low lying areas they might need to erect new towers that are taller than electric utility poles to accomplish their objectives. Refrigerator size electrical boxes will be attached to each transmission tower. [2, 9]

If you happen to be in an area with underground electric service, then they will erect new towers that use the underground electrical lines.

If you live or work in a densely populated area where electrical poles are very close to buildings, then you might have a 5G cell tower located a few feet from your place of employment or your bedroom. [2, 9]

It is estimated that the daily microwave exposure generated by the 5G system will be equivalent to living inside a microwave oven and turning it up to high and baking yourself for 19 minutes a day. [2]

Telecom Companies Hold the Upper Hand on 5G Tower Placement

FCC regulations [11] make it illegal for government entities to try to delay or stop cell tower installation on the basis of health risks.

Telecom companies can sue cities and states that attempt to use health concerns to impede their cell tower building plans. [2]

How Harmful is 5G? Can We Stop It?

Documented Health Dangers Linked to Microwave Radiation Exposure

In this section we have covered the near-term and potential long-term health issues as the result of 5G technology. Note the fact that longer exposure becomes increasingly problematic for human life. Long-term Microwave Exposure Equals Extreme Harm

The bottom line in microwave frequency radiation exposure is, "The longer the exposure, the more deadly the cumulative effects." [8]

In 2011, Professor Karl Hecht from the International Research Center of Healthy and Ecological Technology in Germany reported three distinct phases of illness caused by microwave radiation.

During the first phase, lasting up to 3 years, the living organism struggles to cope and compensate for the exposure to microwaves. [8]

They may experience numerous symptoms and may be aware of illness indicators, but aren't able to fix their problems unless they stop the exposure.

3 to 5 years of Microwave Exposure

Professor Hecht described the damage that occurs during the second phase of exposure – 3 to 5 years of microwave irradiation. He stated:

During this second phase, chronically irradiated people develop weakly visible, pathological neurasthenic symptoms with vagotropic reaction tendencies.

This means over activity or irritability of the vagus nerve, adversely affecting function of the blood vessels, stomach, and muscles. It also means that the parasympathetic autonomic system is overactive, while sleep disorders and daytime tiredness are common.

Neurasthenic symptoms involve: poor appetite or overeating, insomnia or hypersomnia, low energy and fatigue, low-self-esteem, poor concentration, difficulty making decisions and feelings of hopelessness.

In its most severe form, this phase may include a chronic disturbance of mood called dysthymia (depressive neurosis) in which a depressive mood accompanies the other physiological features listed here.

This might explain why millions of Americans need anti-depressant drugs and illegal narcotics to cope with their radiation-induced depressive symptoms.

By this end of this stage, the systemic damage may be irreversible, even if the radiation exposure ceases. [8]

5 years or more of Microwave Exposure

According to Professor Hecht, during the third Phase (5 years or more), the body degenerates into exhaustion and severe states of disease. He stated:

This final degenerative phase produces pronounced neurasthenic symptoms with increasing pathological lapses of the regulation system, sleep disorders, daytime tiredness, and general exhaustion.

People who have progressed to this phase suffer a dramatic increase in chronic illnesses and elevated cancer incidence.

After 30+ years of environmental Wi-radiation, America's chronically-ill population certainly fits this description.

A 2016 study by researchers at Emory University confirms that over one half of the US adult population is now chronically ill: "The health of individuals is increasingly being defined by complexity and multi-morbidity, the co-occurrence of two or more chronic medical conditions." However, not one in a million would guess that the mortal misery of cancer, heart disease, diabetes, Alzheimer's and even depressive mental illness, is inextricably connected to years of covert irradiation delivered by crafty Wi-profiteers who have been laughing all the way to their gold-lined vaults. Russian Studies Revealed Microwave Harm Long Before the FCC Adopted Its Regulations

Professor Hecht evaluated nearly 900 studies from Russian sources, which demonstrated the harmful effects of microwave technology. This was a factor in Russia where the micro-wave oven was banned years ago. The Russian research took place between 1960 and 1996 — long

before the 3G and 4G cellular systems were built. [8] Consumers are dying today in part because they continue to eat dead foods that are killed in the microwave. They take a perfectly healthy piece of raw food, loaded with vitamins and natural medicines, then nuke it in the microwave and destroy most of its nutrition. Humans are the only animals on the planet who destroy the nutritional value of their food before eating it. All other animals consume food in its natural, unprocessed state, but humans actually go out of their way to render food nutritionally worthless before eating it. No wonder humans are the least healthy mammals on the planet.

In Russia, microwave ovens were banned in 1976 because of their negative health consequences as many studies were conducted on their use. The ban was lifted after Perestroika in the early 90's. Numerous documents can be found online relating to this subject.

The invention of the microwave and its mass adoption by the population coincides with the onset of obesity in developed nations around the world. The FCC Says we have Nothing to Fear

This is the logic followed by the FCC to ensure safety — as long as the transmission of cell towers don't exceed the microwave radiation levels they set and cell phones don't exceed FCC standards, then the towers and phones are safe.

They have decreed that 3G and 4G towers operate at safe levels, therefore, the new 5G towers are also safe, because they use less powerful transmitters.

The FCC isn't taking into account the proximity of transmitters and the biological effects of the shorter wave lengths. It is as if they believe that a tower that is 30 feet away from a person is less harmful than a tower that is 20 miles away.

It is as if they believe very short microwaves in the gigahertz range are less harmful than longer microwaves in the megahertz range.

Both beliefs are false!

Instead of focusing on long-term and cumulative effects of microwave radiation exposure, the FCC keeps talking about the heating effects of cell phones. [6, 7]

It is not the heating of body tissue that should be our major concern. It is the 24-hour – 7-days a week – 365-days per year exposure to microwave frequency radiation that is literally the killer. [8]

Public Entities that Delay 5G Implementation can be Sued

1996 FCC regulation permit telecom companies to sue any municipality or state that prohibits the implementation of cellular service on the basis of health.

New FCC regulations adopted in 2017 have further weakened the opportunity to resist the plans of telecom companies to implement wireless systems for other reasons

President Trump has even signed an executive order permitting 5G towers on public lands to fulfill the national priority of building the fastest cellular system in the world. [10]

Telecom companies are planning to implement the 5G system in every major city in America by the end of 2020. As it stands right now, they have the right to do so regardless of health concerns.

Telecom Companies Seek State Regulations to Give Them Even Greater Freedom!

Telecom companies are currently working in most states to establish rules that will give them complete freedom to implement their 5G systems.

They want statewide legislation that will prevent municipal governments or planning boards from delaying their 5G building program because of aesthetic concerns or zoning conditions. Telecom Companies simply want to inform municipalities of their plans and then start putting up cell towers. [2, 9]

Some States are Not Caving in to Telecom

Not all states are rolling over and playing dead. Some are trying to maintain some level of authority with respect to the 5G rollout.

Summary: Are Technological Advances such as Driverless Cars and Instant Downloads of Movies more Valuable than Increases of Disease and Premature Death?

Believe it or not, some research continues to show that microwaves are harmless. A 2017 study showed that when human skin cells in a culture were exposed to varying frequencies of microwaves for 3 hours, 70 hours, and 96 hours there were no changes. [14]

These are the kinds of silly studies that the FCC and Telecom companies use to prove 5G safety. They would have observed damage if the scientists had looked at the right kinds of cells. T-cells and B-cells are highly sensitive and many will die after 8 hours of microwave exposure. They also might have found damage if they did a very close look at the DNA in their cells. [16] For example, 24-hours of continuous cellphone use is the equivalent of 1,600 chest x-rays.

The 4G system is actually still being enhanced and improved even while the 5G system is being installed and promoted. It is debatable whether the new 5G system will provide any more benefit to the average consumer than the current 4G system. [13]

The cost of 5G service should not be measured by the dollars invested by telecom companies to build their systems. It must be measured in terms of the destruction of human health. Are the promised technological advances such as driverless cars and instant downloads of movies more valuable than the occurrence of disease and premature death that these systems will cause?
