### The Catholic Encyclopedia Record on the

(DISTRICT OF COLUMBIA)

To put to rest any suggestion this is conspiracy theory, or disinformation, I thought it would be only fair to include what the Catholic Encyclopedia Record has to say about our National Capitol. Little or none of what the Catholic Encyclopedia documents will be found in books written about Washington, D.C. Most of this information from an official Roman Catholic source is either excluded or diluted and obscured. I have underlined an important piece of information that Washington, D.C. is a corporation.

Washington, the capital of the United States, is situated on the left bank of the Potomac River, 108 miles from its mouth in Chesapeake Bay: latitude (Capitol), N. 38° 53'; longitude, W. 77°. The original district (10 miles sq.) was reduced by the retrocession of Alexandria County to Virginia, in 1846, to the present approximate land area of 60 sq. miles. The population, according to census of 1910, was 331,069, and was classified as wholly urban: the county organization (Washington County, D.C.) was abolished in 1874, and the city of Washington is now coextensive with the District of Columbia. The larger part of the district is built up, and, because of its predominant urban character, whatever farm land exists possesses its chief value as a potential residence property.

The Continental Congress had held its sessions in different places, principally at Philadelphia, and there was no permanent seat of the general government until after the adoption of the Constitution of the United States. The following provision, enumerating the powers of Congress (Sec. 8, Art. I), was included in that instrument: "To exercise exclusive jurisdiction over such District (not exceeding ten miles square) as may, by cession of particular States and acceptance of Congress, become the seat of Government of the United States". Various places were proposed, and much warmth of feeling and sectional jealousy were elicited in the debates on the resolutions and bills introduced before Congress on the subject: the States of Maryland and Virginia, in 1788 and 1789, had offered the requisite area, and the "acceptance of Congress", under Acts of 16 July, 1790, and 31 March, 1791, constituted the District of Columbia the seat of the national government. The territory thus selected was determined as to its exact location and boundaries by George Washington: it included within its limits the flourishing boroughs of

Georgetown, Montgomery County (Maryland), and Alexandria (Virginia); the rest of the territory was rural. The president was also authorized to appoint three commissioners to lay out and survey a portion of the District for a federal city, to acquire the land, and to provide buildings for the residence of the president, the accommodation of Congress and the use of the government departments. One of the commissioners thus appointed was Daniel Carroll "of Duddington", of the family of Bishop John Carroll, and one of the principal landed proprietors of the District; Major Charles Pierre L'Enfant, a French Catholic, was employed to furnish a plan of the city, and to him the credit of its magnificent design is mainly due; James Hoban, a Catholic, won by competition the prize offered for a plan of the president's house, and the "White House" is constructed in accordance with his design. The corner-stone was laid (13 October, 1792) by President Washington, who also officiated at the laying of the corner-stone of the north wing of the Capitol (18 September, 1793): the site which the Capitol occupies was part of the land of Daniel Carroll, and was practically a gift from him to the United States.

The first local authorities of Washington were the president, three commissioners appointed by him, and the Levy Court; the city was incorporated in 1802, with a city council elected by the people, and a mayor appointed by the president. Robert Brent, a Catholic and nephew of Bishop Carroll, was the first mayor, and was annually reappointed by Presidents Jefferson and Madison until 1812; in 1812 the duty of electing the mayor devolved on the council, and from 1820 to 1871 on the people. In 1817 the charters of the corporations of Washington and Georgetown were abolished by Act of Congress; for a brief time the District was assimilated to a territorial form of government, with a board of public works as the most important administrative factor. Since 1878 it has been governed by a board of three commissioners appointed by the president, with the approval of the senate. The District of Columbia is neither a state nor a territory, but a municipal corporation, holding the same relation to the governments. It has no share in the election of president, nor any district representation in Congress: its inhabitants have no voice in national legislation, and, since 1874, not even any part in local self-government, except by favor of Congress.

Father Andrew White, S.J., "the Apostle of Maryland", was the first priest to visit this region: in 1639 he established a mission at Kittamaquund, a few miles below Washington, and, with solemn ceremony, baptized the tayac, or "Emperor of Piscataway". He also carried the Gospel still nearer to a Washington. The "Annual Letter" for 1641 mentions that the King of the Anacostans was a most promising candidate for baptism. The tribe from which the Anacostia River (eastern branch) is named, dwelt in the immediate neighborhood, and on the site of the national capital: so that the history of Catholicism in the District is traced back to the earliest days of Lord Baltimore's Colony. As settlements advanced up the country from lower Maryland, a fair proportion of those who acquired land in what is now the District were Catholics. In 1669 "a parcel of land. . .called Rome. . .was laid out of Francis Pope. . .extending to the south of an inlet called Tiber"; this gentleman, "Pope of Rome on the Tiber", was sheriff of Charles County, and, in all probability, a Catholic. The well-known families of Carroll, Digges, Queen, and Young were the possessors of extensive landed estates before the American Revolution. There was no church in the region during the early decades of the eighteenth century, as the public exercise

of Catholic worship was prohibited by the laws of Maryland: the faithful depended for spiritual aid on the Jesuit Fathers from White Marsh, Prince George's County, or St. Thomas' Manor, Charles County. Stations were visited and Mass was celebrated in private houses, a room being set aside for the purpose, the neighbors being invited. An interesting collection of vestments, altar furnishings, chalices etc., relics of those stations and memorials of the old Jesuit missions, is preserved in the museum of Georgetown College. The independence of the United States ensured religious liberty, and new era for the Catholic Faith began in Maryland. Father John Carroll, having returned to America in 1774, resided at Rock Creek, from which he made missionary excursions to all the neighboring region, including what is now the District. In 1784, he has appointed superior of the American Church, and his consecrations at Lulworth Castle, England, in 1790, to the Sea of Baltimore coincided with the selection of Washington as the seat of government. The District of Columbia has always been included in the Diocese of Baltimore. In 1789 Bishop Carroll had already taken steps for the establishment of Georgetown College, where, on 4 May, 1912, a bronze statue to his memory as founder was erected by the Alumni Association, with imposing ceremonies and addresses by the chief justice of the Supreme Court, the rector of the university, the attorney-general representing the president, Cardinal Gibbons, the Ambassador of Austria-Hungary, dean of the Diplomatic Corps, and the speaker of the House of Representatives.

The oldest Catholic Church in the District is Holy Trinity, Georgetown: the original edifice, erected by Father Francis Neale, S.J., is still standing, but is now used as a parochial school. The register of baptisms and marriages, beginning with 1795, has entries of people "living in the Federal City", even after the name of Washington had been officially adopted. The present Trinity Church dates from 1844. St. Patrick's is the parent church of Washington city proper, the land for it having been acquired in 1794 by Father Anthony Caffry; the first church was a oneand-a- half-story frame house. St. Mary's, or Barry's Chapel as it was generally called, was built by a merchant of that name, in 1806, for the accommodation of the workmen at Greanleaf's Point, near the Navy Yard; this chapel disappeared long ago, but its corner-stone was saved, and is now inserted in the outer wall of the Holy Name Chapel, the Church of St. Dominic. Queen's Chapel, in the north-east section, existed in 1816, and perhaps earlier, but was destroyed during the Civil War. In 1805 Father William Matthews became the second pastor of St. Patrick's, and continued in that position for nearly half a century; he was the first nativeborn American to be raised to the priesthood in the United States. Among his assistants was Father Charles Constantine Pise, chaplain of the United States Senate, 1832-1833, and among his parishioners were: Roger Brooke Taney, Chief Justice of the Supreme Court; Mayor L'Enfant, who drew the plan of the city; James Hoban, the architect of the White House; Robert Brent, the first mayor of Washington; Dr. Ironside, a distinguished convert; and Mayor Thomas Carbery, a brother of Mrs. Ann Mattingly, whose wonderful cure in 1824 was held to be miraculous, Father Matthews being one of the witnesses in the case. The original Catholic inhabitants were mainly Maryland planters, of English descent, and their colored servants; accessions came from other sources, Irish, German, French, when artisans were required for the construction of public buildings, but the absence of large commercial and industrial activities was a drawback to rapid increase in the general population, and foreign immigration,

which has contributed so notably to swell the Catholic statistics of northern and western cities, has had but little effect on Washington.

St. Peter's and St. Matthew's were the first divisions of St. Patrick's, the original parish, which embraced the whole federal district, Georgetown excepted. There are now (1912) twenty-four churches, two of which (St. Augustine's and St. Cyprian's) are for the exclusive use of colored people. All the congregations are English-speaking, except St. Mary's, which is German. St. Aloysius' and Holy Trinity are in charge of the Jesuit Fathers, and St. Dominic's in charge of the Fathers of St. Dominic. The Apostolic Delegation for the United States was established in 1893, and the successive delegates, Cardinals Satolli, Martinelli, and Falconio, and Archbishop Bonzano, have resided in Washington. The religious freedom guaranteed by the Constitution has been always fully enjoyed; the many representatives of Catholic countries in the Diplomatic Corps and the Catholics prominent in Congress and in the departments are factors for social influence and a restraint upon illiberal legislation. All churches, institutions of public charity, school houses, and cemeteries are exempt from taxation upon all their property not used for business purposes or to secure an income. Subventions, or appropriations to a limited amount, are granted to some of the Catholic charitable institutions. Catholic funeral services have been held in the Capitol occasionally for foreign ministers and members of either house, and Catholic chaplains have officiated in the halls of Congress: a Catholic priest, Father Gabriel Richard, of Detroit, was a delegate from Michigan territory to the House of Representatives. The local sentiment towards the Church has been, in general, one of good- will. When, during the Know nothing craze, a band of bigots secretly took away the memorial slab contributed by Pius IX to the Washington Monument, which was then being built, the better sentiment of the community condemned that act of vandalism: within the shadow of that same completed monument a solemn field Mass was celebrated in 1911, thousands attending it, and amongst them the chief magistrate of the republic. The grandest civic celebration which the capital has witnessed was that of the Columbus Memorial, 8 June, 1912, when, under the auspices of the Catholic Knights of Columbus, a superb monument was dedicated in honor of the Catholic discoverer of America.

George Washington cherished the hope that the capital would become the home of a great national seat of learning. Although that hope has not yet been realized, in the sense of a university endowed by the Government and under governmental control and patronage, yet Washington is well supplied with institutions for higher education, offers extraordinary advantages for scientific and literary labor and research, and possesses an unparalleled educational equipment in the great scientific collections and libraries of the Government. By authority of Congress, all such facilities for research and information are made accessible to students of institutions of higher learning in the District. This provision applies to the Library of Congress, the National Museum, the Patent Office, the Bureau of Education, the Bureau of Ethnology, the Army Medical Museum, the Department of Agriculture, the Fish Commission, the Botanical Gardens, the Coast and Geodetic Survey, the Geological Survey, the Naval Observatory, several hospitals and other departments supplies with special libraries, laboratories, and equipment for research. The Library of Congress contains 1,100,000 volumes; Surgeon-General's Office, 140,639: National Museum, 16,000; Museum of Hygiene, 10,5000;

Bureau of Ethnology, 5000; Bureau of Education, 30,000; Department of Agriculture, 25,000. The Law Library of the United States Capitol contains over 100,000 volumes, and is free to students seven hours daily. Washington presents advantages for the study of American jurisprudence which are unequaled elsewhere, and must always remain so. Congress, the Court of Claims, the Supreme Court of the United States, and the Court of Appeals of the District of Columbia are in session during several months of each scholastic year, and, with the executive departments, the Patent, Pension, and General Land Offices, furnish advantages for professional study nowhere else enjoyed. There are six law and three medical schools in the city.

Georgetown University, founded in 1789, and the Catholic University of America, canonically instituted by Pope Leo XIII in 1887, offer in their various departments numerous courses in the arts and sciences to men who desire a complete general and liberal education, or who aim at a professional career. The Catholic University has 52 professors, and schools of the sacred science of law, of philosophy, of letters, and sciences. It has affiliated colleges and communities of the Dominican and Franciscan Orders, of the Sulpician, Paulist, Marist, and Holy Cross Congregations, and a Polish house of studies. Georgetown University, besides the collegiate department, includes schools of law, medicine, and dentistry; attached to the medical school is a hospital, in charge of the Sisters of St. Francis, with a training school for nurses; the law school has (1911-1912) 959 students, the largest registration of any law school in the United States. the total number of students in the university is 1445. For female education, the Academy of the Visitation, Georgetown, and Trinity College, Brookland, are institutions of high standing. A summer school, under the auspices of the Catholic University, was successfully inaugurated in 1911., for the members of Catholic teaching orders of women. Besides these are: Gonzaga College, directed by the Jesuits; St. John's College, by the Christian Brothers; the Visitation Academy of Washington; the Immaculate Academy of the Sisters of Providence; academies and high schools, directed by the Sisters of the Holy Cross, Sisters of Charity, Sisters of Notre-Dame, Sisters of the Third Order of St. Dominic, and the Oblate Sisters of Providence (for coloured children). Over 4000 pupils attend the parochial schools.

The eleemosynary and benefit institution include St. Ann's Infant Asylum, and orphan asylum for little boys, another for girls, St. Rose's Technical School, and Providence Hospital (all in care of the Sisters of Charity). The Sisters of Mercy conduct a home for self-supporting girls. The houses of the Good Shepherd, the Little Sisters of the Poor, and the Bon Secours provide for their special objects of care and charity. Conferences of St. Vincent de Paul exist in nearly all parishes. The Christ Child Society, having for its object to provide for all the needs of child life among the destitute, has its headquarters in Washington, with branches in several other cities; the Bureau of Catholic Indian Missions has its office here; the Apostolic Mission House was established in 1902 near the Catholic University. It is difficult to determine the exact number of Catholics in Washington, but it has been estimated to be 30 per cent of the entire population.

# The Illegal Quasi-Government in Washington D.C.

The "Federal" Government is a Separate Nation and should be called the United States, Incorporated.

This Awareness indicates there are two governments operating in this country:

- the United States of America is the Republic government created by the states, for the states, created by the people, for the people
- and there is the US government, which is a corporate government, or corporation. This
  federal government, should be called the United States of America, Incorporated.

Corporations are not allowed by law to become politically charged in terms of their controls over the masses of a region.

#### The Illegal Quasi-Government in Washington D.C.

A corporation is simply an entity which makes its own rules for its own employees and for its own structural operation. The <u>US government</u>, which is on a ten acre parcel of property in **Washington D.C.** (District of Columbia), outside the United States of America is a corporation that has taken on the role of a guasi-government, but which has no legal authority to do so.

This Awareness indicates that any action whereby this quasi-corporation known as the <u>United States Federal Government</u> attempts to make laws, to impose laws on the states or on the people that have not been authorized by the states of the people, operates illegally. This Awareness indicates that any of the states or the people who give their allegiance, and give their rights to such a quasi-government are doing so illegally. Anyone who volunteers to let such a foreign entity control their lives is volunteering their freedom away illegally, and this is where changes will soon begin to occur, and where entities will begin to recognize a breech in the relationship between the people, the states, and the quasi-government in Washington D.C.

The Federal government, which is foreign to the United States of America, which is located in the District of Columbia, which is not part of the United States and which is in fact controlled to a great extent by the <u>international bankers</u> and by the laws and rules of the <u>United Nations</u>, whereby this Federal Washington D.C. state or country, has set itself up as a control over the United States of America as a quasi-government

This Awareness indicates that elected officials residing outside of the United States of America in Washington D.C., are not actually employees or officials of the United States of America, or its rules. The states' rules do not apply. The states' Constitution does not apply to these entities in Washington D.C. because they are acting outside the country in this second nation known as the Federal government.

This Awareness indicates in other words, the **United States Federal government** and the **United States of America** are basically <u>two different countries</u>, and the Constitution of the United States of America is not the law of the United States Federal government. Therefore, these entities cannot, while in the District of Colombia, be accused of treason. They are operating on behalf of the foreign bankers and their special interests.

#### Most entities are unaware of vanishing freedoms

This Awareness indicates essentially, these so called "freedoms" that entities have enjoyed or believe they had, are taken away without the public even realizing they are being taken. It is as though an entity is ushered into prison by a very powerful hypnotist and one who is very persuasive, who talks the entity along as he walks him towards the prison, and who even walks the entity through the gate and into the cell before the entity awakes to find he is imprisoned.

This is the way it will be for many entities. They will be deeply imprisoned, unable to escape before they know what happened. If they are interested in the patriot movement, then it is important that they risk communicating with such entities, for you can't escape the reality by ignoring it. There are many entities who live in denial, right up to the time when they face the inevitable imprisonment, but of they recognize what is coming, if they are open to hearing what is evidenced in regards to the future events so that they do not ignore the evidence that is available through Patriot groups, then these entities stand a chance of adding their weight to the weight of others who are still dedicated to freedoms in this country and in other countries around the world.

# Some U.S. States Now Seeking Sovereignty

This Awareness indicates, there are close to a dozen states in the US that have seriously been moving toward secession from the United States and regaining their own sovereignty. This Awareness indicates that Colorado, Nevada, Texas, Utah, Idaho, Hawaii; these are but a few of those mentioned as turning toward the pursuit of their state sovereignty. Technically, the "United States" refers to the states themselves, not the Washington D.C. government, and the Federal government, or the United States, Incorporated, refers to the corporation that is governing ten square miles known as Washington D.C. It is not part of the United States. It is a separate nation, incorporated as the United States of America, and it has self-appointed its own purpose as being that of extending rule over the separate United States. The sovereign states of the union being individually sovereign with their own constitution or charters or separate laws based on the Constitution of the United States.

# The United States of Americas, Incorporated

This <u>Federal government</u> sees itself as a democracy, whereas the original states of the Union were a Republic . This Republic is no longer recognized by the "democracy" known as the United States

of America. It should be understood that "democracy" essentially is majority rule, or what some call "mob rule," and a Republic is a system of government that is focused on the right of each individual. The rules are such to protect the rights of the individuals, not so much the mob or the majority, but of the individuals that make up the whole. This Awareness indicates that these things that most entities are not taught in their school or not taught through the news, through television or through the ordinary information sources of the country. It should be realized that the **United States of America**, **Incorporated** is <u>dominated and controlled by 13 powerful banking families</u>; the <u>Rothschilds</u> being a dominant influence, so that the laws are passed to help curb the freedoms of the states.

Most of the laws of the **Federal government** are essentially just <u>corporate rules</u> and corporate laws on the states who have become associated with the Federal government, given there allegiance or otherwise bought into the Federal government in Washington, D.C., a corporation. The government in Washington, D.C. is not set up to <u>represent</u> the states, but to <u>control</u> the states, as though they were subordinate corporations to this greater corporation.

Originally, the laws passed were by consent of the states, but it has reached a point now where the Federal Reserve Bank has such power and loans to the states or programs for the **states can be financed from Washingt**on DC, the states sell out and go along with the Federal programs in order to get Federal money.

This Awareness indicates that it has been a very slow and gradual take over of the states and their sovereignty and independence, so that the independence is more of a sham. The so-called independence day is a celebration that occurs each July 4<sup>th</sup>, more out of memory than out of actual reality of the present time. There is really very little independence. In fact, there is much talk of "interdependence," meaning that the states are dependent on the Federal government, and the Federal government has some reliance on the state for its taxes collected from the people of the various states, and in this sense there is an interdependence. They each depend on each other.

# The Oversight of the Founding Fathers

This Awareness indicates this all came about by an oversight of the Founding Fathers, wherein the **Rothschild** lawyers and representatives recognized that the oversight was that Washington, D.C. government for the states had never actually been a part of the United States and therefore, they took over and created a corporation of this Federal government, making it a separate nation from the United states, and from that action began to move toward a gradual take over of the various states of the union through statutes and laws which the states bought into.

# Why the Fed &

### The National Debt Are Illegal

This Awareness indicates that you must understand that when the Federal Reserve Bank, the privately owned Federal Reserve bank, was given authority to print Federal Reserve notes instead of the Treasury Department writing the Treasury Notes as directed by the U.S. Constitution, these Federal Reserve notes were not printed to be given out to the economy, in the way as the Treasury Notes of the Treasury Department. Rather, they were loaned to the U.S. government and then circulated into society, and society was required to pay back interest on the IRS notes and that amount of interest accumulated to the point of approximately 5 trillion dollars at this time (Revelations of Awareness newsletter issue no. 430 1994), to where, if everything in the United States were sold, half of the debt would still be owed.

This Awareness indicates that the Treasury Department has the potential for totally denouncing the Federal Reserve debt of 5 trillion dollars because it was illegal in the first place. The Treasury Department in the U.S. Constitution is the only proper way of financing the nation; Congress, operating the Treasury Department has the right to mint and coin money, and set the value thereof.

This Awareness indicates that in this fact, the Federal Reserve was never given any such a right, even with the vote of the Congress, because Congress did not have the right to relegate its obligations to the Federal Reserve, therefore the entire debt of five trillion dollars, because it was illegal in the fist place, is not forcible in a technical sense.

#### The District of Colombia a Loop-Hole

Another factor is that because the U.S. government is situated in the District of Columbia, which is not part of the United States, it is essentially, according to Black's Law Dictionary, a different nation entirely. It is a Federal Nation, which rules over the District of Colombia. It has no real jurisdiction over the rest of the United States in a technical sense, and to pass laws taxing another country such as the United States is technically and legally in error.

You are being taxed by a foreign country. This Awareness indicates that this is not right, if you look at it from a legal and technical sense. This Awareness indicates that therefore, in the creation of the United States with the Capitol situated in the District of Colombia, which was not a state, an error by the Founding Fathers occurred, but this error has had benefits for the Rothschilds in that it has allowed them to break rules of the Constitution without fear being charged for treason, because these entities are not operating from within the United States, they are operating from a different country.

Thus, they can pass off their obligations to a Federal Reserve board, a Federal reserve bank; they can make rules of taxation against the masses, which would constitutionally prohibited. This Awareness indicates that it is indeed a situation in which the Rothschilds took total advantage of the loopholes, or the mistake by the Founding Fathers of creating the seat of the government in a non-state, in a District of Colombia.

Once the Federal Reserve Bank was created, people of the government needing money would only borrow from the Federal reserve Bank. The Federal Reserve bank only had to go to the Treasury Department and get money printed at printing costs, and then loaned the money out at full face value, thus making enormous profits and putting this nation into enormous debt.

#### **National Debt Not a Legal Debt**

The debt that is known as the National Debt of so many trillion dollars is simply the result of borrowing from the Federal Reserve Bank, the money that the Treasury Department prints for them, which is used to print for the country. In other words, instead of being printed for the United States, it is printed for the foreign bankers and the United states borrows from them and owes them the National Debt, and the National Debt is so high now (Revelations of Awareness Newsletter 94-14 no. 440) that your grandchildren will never be able to pay it off.

By the year 2000, the debt will be so high that the interest will be greater than the taxes brought in. This Awareness indicates that the country will be bankrupt again. This time it will be taken over totally. This Awareness indicates that this country went bankrupt in 1933 and the gold standard was removed from the dollar and this country will be again further bankrupted, even though it has been operating on Federal Reserve notes.

These Federal Reserve notes have been used in such a wasteful manner, that all the borrowed money from the Federal Reserve, creating the national Debt, have not worked to restore a solid economy for this country. It is likened into an entity who goods broke, is bankrupt, has nothing, but through the apparent gratuity of a banker, is allowed to borrow enough to get a fresh start on credit.

The entity begins working, using credit to rebuild an apparent business, but forgets perhaps that it is all borrowed money, and thinks that he is doing quite well in this new thriving business, only to discover that after awhile, he is getting nowhere and his business activities are suffering further damage, and that he owns far more than he ever imagined he would owe, so that he is even deeper in debt now than he was at the time he borrowed the money to start his new business.

According to Law, National Debt is Null & Void

This Awareness indicates essentially, this country is bankrupt several times over, and the only way that it can be made whole in a legal sense is when entities recognize that the law suggests that anything, any debt, any contract, any activity of partnership between entities which is based on fraud from the beginning, is null and void.

This Awareness indicates that in accordance with the law in the Western world, which has come down from Rome through England and into the United States, the law reads that any contract, any obligation, financial or otherwise, which is based on fraud and misinterpretation or illegal activity, is null and void from the beginning.

#### New World Order (Global Governance) Accelerated Due to Hildebrand Lawsuit

This Awareness indicates that because the Federal Reserve Act was illegal, according to the Constitution, and because the loaning of money by an illegal foreign bank to the United States government and its people and projects is based on a banking scam that was originally illegal, then the debts that were brought about from such loans, are themselves illegal.

This Awareness indicates that with this understanding, the National Debt could be and should be declared null and void. This Awareness indicates that this is the concept or theory behind the Hildebrand settlement with the Federal Reserve Bank and there are several other suits that have been brought against the Federal Reserve Bank based on similar or the same concept.

This Awareness indicates that wherein on the one hand, the debts are falsified, are originally based on misinterpretation and fraud; on the other hand, they appear to be real debts, both to the Federal Reserve Bank and to the 13 super-wealthy families of the world.

The appearance is that which these families wish to continue. It is that which is creating the extreme urgency to bring on the New World Order before enough people awaken to the fraud, to stop the takeover of the country by those who perpetrated this fraud early in this century, and they use every means possible to continue and perpetuate this fraud.

#### The Declaration of Martial Law

This Awareness indicates that when Lincoln was assassinated, no one thought to put an end to his declaration of martial law because of the civil War and because the martial law has continued up to this time, from the time of the Civil war, the nation can be directed by what is called Admiralty Law or martial law by simply command of the President or the authority of the land or his agents.

It is not even acquired by Admiralty law that Congress conduct proceedings to make laws. The Admiralty Law can provide statutes, which are called statutory laws, while the country is under Admiralty or martial law, but the Admiralty and martial law must come to an end and

eventually, and this is the year (Revelations of Awareness Newsletter 94-14) in which it must either end or be reinstated.

Thus, within a short time, entities will find a new effort to create martial law in this country again. It may be martial law against what is termed a crime wave, even though crime has decreased two years in a row and has not increased much in the past several years. This Awareness indicates it still is considered to be a major concern by most entities, because crime is being advertised continuously on television and in the news media, to make entities feel that crime is ever on the march, ever on the increase.

The history of the city plan for **Washington**, **D.C.** is not quit what most citizens of the United States might expect. It appears to be more of a private venture than a public project. Private in more ways than one.

The newly formed Congress established as one of the newly elected President's first duties to chose the location of the city to be the Capital of the United States. After a location was determined, a new city would be established for the Nation's Capital. It was the responsibility of George Washington to determine the sight for the Capital.

But, was this location already chosen before the forming of the United States? Washington, D.C. is found in the same general geographic location as Jamestown, the first permanent English settlement in North America. Most history books tell us that Washington's location was established as a compromise between the Southern and Northern States. But, **Baron De Graffenried** (a Swiss baron) tried to establish a colony at the exact location of Washington, D.C. as the preferred site for his project.

#### De Graffenried states,

"I believe that there are scarcely any places in the world more beautiful and better situated than this of the Potomac... There is a very pretty island (Theodore Roosevelt Island) of very good ground, and facing it, an angle between the great Potomac River and another little river named Gold Creek (now Rock Creek)."

The land on which much of the Capital City is built today was owned by **Ninian Beall**, a Scot who owned a 1,503-acre track called "Inclosure." Two other tracks called "Beall's Levels and the Rock of Dumbarton" make up current day Washington, D.C. and Georgetown. *Was George Washington continuing a project established by De Graffenried and Beall 60 years earlier?* 

#### WHERE DOES L'ENFANT FIT IN?

History tell us that the Frenchman Major **Pierre Charles L'Enfant** was the city planner for Washington, D.C. But, a few books establish the fact that L'Enfant was really the middleman working from a set of original plans developed by George Washington and Thomas Jefferson.

Both Washington and L'Enfant had two things in common. First, they both served in the War for Independence, L'Enfant being a French volunteer in the Corps of Engineers. Second, they were both members of the newly formed Society of Cincinnati.

<u>L'Enfant</u> had been asked by **Baron von Steuben** and members of the Society of Cincinnati to design the insignia for this exclusive group. This was the job for someone who understood symbols related to the principles of the Society. His work so impressed George Washington, the president of the Society of Cincinnati; that L'Enfant was asked to work on several national projects.

Later L'Enfant designed the courthouse in New York, where the first Congress of the United

States held its meetings. History tells us, it was a combination of his work with the Society of Cincinnati and the New York Congress building that made George Washington chose L'Enfant as the designer for the city plan of Washington, D.C. It appears L'Enfant was handpicked for his ability in the use of symbolic design, instead of his ability as a city planner.

This is most true when you consider the fact that **L'Enfant** was not known as a city planner, or does it appear he designed any city plans before Washington, D.C. Based on a letter to L'Enfant, date August 18, 1791, Jefferson communicated his ideas for the map of the city directly to L'Enfant. Some historians believe L'Enfant adopted these ideas and expanded on them.

#### THE MISSING NOTES - A COVER-UP?

It is unclear if George Washington, Thomas Jefferson, or Pierre L'Enfant himself determined the various symbols that form the streets of Washington, D.C. Many things indicate that L'Enfant was just following orders from Washington and Jefferson. In the book *L'Enfant and Washington*, it is pointed out that Washington was pulling all the strings, since the plans appear to be "orally conveyed" by Washington to L'Enfant.

The fact that <u>three years of George Washington's diary</u> has *mysteriously disappeared*, prevents us from knowing exactly what sort of communications occurred between George Washington and L'Enfant. In addition, correspondence with Jefferson concerning the development of the proposed "Plan" have disappeared. The mysterious *disappearance* of this historical information concerning both **Washington** and **Jefferson** and their involvement in the original design of Washington, D.C. wreaks of a cover up - perhaps *the original Watergate*.

Is it possible that the missing dairies and correspondence have been intentionally lost to maintain secrecy about the true nature of the development of the Nation's Capital?

It is known that the Secretary of State, **Thomas Jefferson**, issued the orders for **L'Enfant** to design the city and public buildings. Washington, Jefferson, and L'Enfant met twice weekly, every Wednesday and Saturday evenings to discuss the "Plan." Both Jefferson and Washington felt an affinity with Roman institutions, law, citizenship, and architecture; so many Roman features like dooms and columns were adopted to the "Plan."

**Andrew Ellicott** was the surveyor who laid out the city and its streets. He established 40 boundary stones one mile apart, producing a ten mile square boundary. The center point was fixed by night observations from a level platform on the hill where the Capital Building was to be built. Records were kept on the north star and the moon to establish a line due east and west, another straight line due north and south, with the center of the Capital dome at the point of intersection. Ellicott was responsible for finishing the "Plan" when L'Enfant was fired.

The city that L'Enfant's original plans proposed for the Capital City is nothing like the present day Washington. The symbols in the streets of Washington, D.C. today appear to have evolved from L'Enfant's basic design. This basic design did include the layout of "different shapes" as specified in the written legends that accompanies the original set of plans. The following is the original legend for the plans for Washington, D.C.

#### "OBSERVATIONS EXPLANATORY OF THE PLAN

I. The positions for the different Grand Edifices, and for several Grand Squares or

Areas of different shapes as they are laid down, were first determined on the most advantageous ground, commanding the most extensive prospects, and the better susceptible of such improvements as the various intents of several objects may require.

**II.** Lines or Avenues of direct communication have been devised, to connect the separate and most distant objects with the principal, and to preserve through the whole a reciprocity of sight at the same time. Attention has been paid to the passing of these leading avenues over the most favorable ground for prospect and convenience.

**III.** North and South lines, intersected by other running due East and West, make the distribution of the city into streets, squares etc., and those lines have been so combined as to meet at certain given points with those divergent avenues, so as to form on the spaces "first determined," the different Squares or Areas which are all proportional in magnitude to the number of avenues leading to them."

Though the legend does not name or explain the specific shapes or symbols, it does make clear that areas of "different shapes" were in the original plans proposed to L'Enfant by Washington or Jefferson.

Now take the words from the legend that have been underlined and think about their meaning. Is it possible another meaning is being expressed other than the layout of city streets?

When land in the city limits of Washington, D.C. was offered for sell, property owners demanded copies of the city plan. L'Enfant refused claiming that if the maps were made public before the principal buildings were established, unsightly structures would be built on the best locations. This caused the sell of lots to fail, preventing the government from getting the needed funds to finish the city on time. The President was forced to dismiss L'Enfant in 1792, only one year after he had started work on the city.

In 1812, Secretary of War **James Monroe** ask L'Enfant to build Fort Washington south of the city to defend against future British attacks. Again, his work was incomplete and he was dismissed. He spent his remaining years as a ground keeper residing at the Chilham Castle Manor, the estate of his benefactor, <u>William Dudley Digges</u>, at Green Hills, Maryland. He died on June 14, 1825 and was buried in obscurity until 1909. In 1909 his remains were moved with military escort to the Capital building, where he laid in state for three hours.

During that time, thousands of Americans paid their respects to the man who had planned the Nation's Capital City. On noon of that day, he was buried at a honored vantage point in Arlington National Cemetery. On May 22, 1911 a tombstone that now marks his grave was dedicated. The tombstone is engraved with a motif of the first map of L'Enfant's "Plan."

Is it possible that L'Enfant had designed something so special in his city plan that no one of his day could appreciate or understand it? It is possible that someone around 1900 recognized the value of his work? Placing the body of an architect who does not finish what he starts, in the Capital Building Rotunda for public ceremonies eighty-four years after his death for only three hours, sounds very unusual. According to the history books, thousands of people appeared for the public viewing at the Capital.


- Can thousands of people really pass in precession through the Rotunda in three hours?

- Is someone trying to sidetrack us with a re-write on history?


The *Capital Rotunda* has a secret of its own. Hidden below the floor of the Rotunda is a <u>Crypt</u> Room which was originally designed to be the resting place of George Washington.


You will see a model of the Capital Building on display in this room. Beneath the center of the Crypt floor (marked by a star) is the *vacant tomb of George Washington*. This is an American version of Napoleon's tomb. Washington's resting place is at Mt. Vernon, but his remains were nearly moved to the Rotunda in 1832. Space was provided in the construction of the central section of the Rotunda between 1818-1829 for the tomb by a joint resolution passed by Congress.

On Feb. 13, 1832 Congress executed an original resolution to have the body of Washington moved to the Crypt Room. But, <u>John A. Washington</u>, grand-nephew of George Washington, refused consent. The bodies of Kennedy, Lincoln, McKinley, Garfield, Harding, Taft, Hoover, Wilson, Stevens, Dewey, Pershing, MacArthur, L'Enfant, and two unknown soldiers have been placed on the catafalque found in the tomb.

There is another well-known *underground Crypt* beneath a dome. It is <u>the tomb of *St. Peter*</u> beneath the Basilica at the Vatican.







#### THE CHANGES

Washington, D.C. will always be a city of constant change. The city has experienced many changes in the street layout that can be grouped in stages. Each stage has added new symbols to the original "Plan." The next few pages illustrates the changes in the streets of Washington over the past 200 years.

The *L'Enfant-Ellicott stage* was started on April 15, **1791** and was finished in **1799**. Congress moved to town the following year. On Saturday, November 22, 1800 the Congress met for the first time in Washington at a joint meeting in the Senate Chamber of the unfinished Capital Building. President **Adams** made a speech at this first meeting.

"... it would be unbecoming the representatives of this nation to assemble for the first time in this solemn *temple*, without looking up to the Supreme Ruler of the Universe and Imploring His blessing."

Why did Adams refer to the Senate wing of the unfinished Capital building as a "temple?"

#### THE BATTLE WITH THE BRITISH IN 1814

The attack on Washington, D.C. by the British was the only time the Capital of United States was invaded since its conception. On August 24, 1814 the British began their destruction that went on through the night and the next morning. Only the Patent Office was spared destruction because <u>Dr. Thornton</u> convinced them,

"to burn what would be useful to all mankind, would be as barbarous as formerly to burn the Alexandrian Library, for which the Turks have since been condemned by all enlightened nations."

But, on August 25 a great storm blew up, putting out the fires and driving out the invaders.

According to Mary Ingle, thirteen at the time;

"I well remember the terrific tornado which drove the enemy in haste to their ships, from which [hey were in dread of being cut off... The sky changed from the peculiar leaden hue portending a wind storm, into almost midnight blackness. Then came the crash and glare on incessant thunder and lightning, and the wild beating of the rain....... Later we encountered a group of British officers taking a last drink from the old pump.

'Great God, Madam!' said Admiral Cockburn, 'is this the kind of storm to which you are accustomed in this infernal country?' 'No, sir,' was the reply; 'this is a special interposition of Providence to drive our enemies from the city.' 'Not so, Madam,' he answered; 'it is rather to aid them in destruction of your city.'

With this parting shot the 'Red Coats' galloped off and disappeared forever from the Nation's Capital."






This is the stage of city growth in which the Washington Monument was started and finished.

# **The Lincoln Stage**

The Senate Park Commission of 1901, lead by Senator **James McMillan** of Michigan, further expanded the city's design by adding to the west end of L'Enfant's original plan the Lincoln Memorial and Jefferson Memorial. The Lincoln Memorial was built on swamp land. It was completed before the Jefferson Memorial.




McMillan Plan 1901, Library of Congress

# The Jefferson Stage

This is the start of what may be considered to be the current stage of the city plan for Washington, D.C. The finishing of the *Jefferson Memorial*, originally named "Hall of the Founding Fathers," adds to the plan by giving it the current symmetrical shape based around L'Enfant's original "Plan." This shape not only adds to the symmetrical layout of the original design, but it adds to the symbolic meaning of the "Plan."

The *Jefferson Memorial* appears to be borrowed from the original design of the Washington Monument. Most historians believe it was designed after the Pantheon in Rome.


The original "Plan" by L'Enfant called for **five points** of interest. With the completion of the Jefferson Memorial, the Washington Monument, the Lincoln Memorial, the White House, and the Capital Building these five points were accomplished.
