

Are COVID-19 Injections the “ethno-bomb” Israel Began Developing in the late 1990s?

TEL AVIV — Israel was the first country to start [administering fourth booster shots](#) at the beginning of 2022. Turkey started administering [fifth booster shots](#) at that same

Who are the Israelis?

The Western world refers to the people of Israel as “Jewish.” Biblical Jews are descendants of the tribe of Judah, which the people of today’s Israel are not. Israelis are Ashkenazis and political Zionists. We’ll interchangeably refer to them by one of those two names or the nationality in this article. You must look no further than the Torah, in the very first book, to begin understanding Ashkenazis.

“And the sons of Gomer; Ashkenaz, and Riphath, and Togarmah...By these were the isles of the Gentiles divided in their lands; every one after his tongue, after their families, in their nations” . –(Genesis 10:3-5)

Gentiles are, of course, non-Jewish people. Interestingly or otherwise, the foregoing passage only appears in the King James Version of the Holy Bible. It has been deleted and/or changed in all subsequent Bible versions. Lots of mental gymnastics have taken place about this one verse for decades. This blogger was almost kicked out of a college history course for writing a paper about Ashkenaz and Ashkenazis that challenged the accepted narrative.

The New Testament is even blunter as to the whom and what of today’s Israelis.

“I know thy works, and tribulation, and poverty, (but thou art rich) and I know the blasphemy of them which say they are Jews, and are not, but are the synagogue of Satan.” –(Revelation 2:9) [See Revelation 3:9 also]

One of the best books this blogger has ever read on the subject is [*The Invention of the Jewish People*](#) by Tel Aviv University history professor, Dr. Shlomo Sand. The book has of course been widely denounced by mainstream media despite Dr. Sand being the son of Holocaust survivors and a tenured professor at one of Israel’s most prestigious universities.

Dr. Sand’s book, combined with Arthur Koestler’s 1976 book [*The Thirteenth Tribe: The Khazar Empire and Its Heritage*](#), leave little doubt that Ashkenazis are descendants of Eastern Europeans and Turks.

The “ethno-bomb” reports The “*Sunday Times*” in the U.K. reported on November 15, 1998, that Israel was [developing a biological weapon](#) that kills Arabs but is [harmless to Ashkenazis](#). The report, citing Western intelligence sources, said that Israeli scientists are [“trying to identify distinctive genes carried by Arabs to create a genetically-modified bacterium or virus.”](#) The weapon [as described in the story](#) likely sounds very familiar to those who follow this blog.

“The intention is to use the ability of viruses and certain bacteria to alter the DNA inside their host’s living cells. The scientists are trying to engineer deadly micro-organisms that attack only those bearing the distinctive genes”

Several U.S. media outlets tried to “debunk” the story. But one of their sources used to debunk the story may have provided the greatest clue as to a connection between the 1998 ethno-bomb and COVID-19 injections today. Dr. [Bill Richardson](#) served as Deputy Assistant to the Secretary of Defense in both the Reagan and H.W. Bush Administrations. Salon interviewed him to debunk the story.

“I think it’s nonsense,” [Richardson told reporter Jeff Stein](#). He continued with this antenna-raising quote, as it relates to the potential deployment of an ethno-bomb:

“Even if an ethno-bomb were developed in a petri dish, [Richardson] said, ‘there’s a long leap from having a mechanism to having an environmental viability, a weapon, or vector, or means of dissemination,’” he said.

Of course, the Johnson & Johnson and AstraZeneca COVID-19 “vaccines” are viral vectors. J&J, specifically, [uses Adenovirus 26](#) to deliver DNA that instructs cells to produce spike proteins.

Apartheid South Africa origins of ethno-bombs

Every report on the Israeli ethno-bomb to kill Arabs said that Israeli scientists used South Africa research as the baseline. The Europeans who ruled South Africa attempted to develop a biological weapon that only kills Black people in the 1980s. The above-linked UPI story says the following:

Foreign Report in October cited unnamed South African sources saying Israeli scientists used South African research in a bid to develop an ‘ethnic bullet’ against Arabs. The head of a South African chemical and biological warfare plant, Dr. Daan Goosen, said his team was ordered in the 1980s to develop a ‘pigmentation weapon’ to target only Black people. He said the team discussed spreading a disease in beer, maize or even vaccinations but never managed to develop one.

The story goes on to say that Israeli scientists discovered Arab-specific genetic traits that they could exploit with biological weapons. *“The intention is to use the ability of viruses and certain bacteria to alter the DNA inside their host’s living cells,”* the story says.

The good [Dr. Lee Merritt](#), in a recent broadcast with attorney Reiner Fuellmich, clarified the foregoing further. She spoke about how Australian scientists utilized [“immunogenic contraceptive”](#) technology to vastly decrease the population of mice.

The rodents were captured and injected with self-disseminating “vaccines” that kill the female ovaries. The injected mice were released back into nature and transmitted the

vaccines to other mice via shedding. It sterilized thousands of them. Dr. Merritt said that the mouse DNA vaccines were built exactly like the J&J shots. Note – the video is further down in the article, as it is referred to again.

Project Coast in South Africa

Dr. Merritt said there was no such thing as “*emerging infectious diseases*” until Ebola and HIV “*came out of the jungles in Africa.*” [Project Coast](#) was the name of the aforementioned chemical and biological weapons program in South Africa. **The goal was to make these weapons so they were [untraceable and undetectable](#). They’d kill, maim and manipulate slowly so it’s more difficult to pinpoint the cause.** It was reported that these weapons could not only sterilize and paralyze, but also change Black men’s personalities to be more docile, and prevent rebellions.

The aforementioned Dr. Goosen headed Project Coast. The weapons were never fully developed because Project Coast was disbanded once Nelson Mandela took power in 1994. **But Dr. Goosen said, “*the weapons placed in the wrong hands could have killed millions.*”**

Who developed the COVID-19 “vaccines?”

Albert Bourla has been with Pfizer since 1993. He was promoted to Chief Operating Officer in January 2018, before being appointed CEO later that year. Thus he has been in charge of Pfizer since the so-called pandemic commenced.

Bourla frequently speaks about his [love of Israel](#) and how his parents survived World War II. In fact, he [accepted the Theodor Herzl](#) award on November 9, 2021. The award is administered by the World Zionist Organization and is [given to the most influential and important Zionists](#) in the world. In his acceptance speech, Bourla compared November 9, 1938 ([Kristallnacht](#)) to November 9, 2020, when Pfizer [announced that their mRNA injections](#) were effective against COVID-19. Take that for what you will. **Bourla did not develop the Pfizer mRNA injections. But he hand-picked the guys who did.**

Dr. Mace Rothenberg was [promoted to Chief Medical Officer](#) by the new CEO Bourla in January 2019. Rothenberg [led the entire development effort](#) for Pfizer’s mRNA injections. He [quit his job at Pfizer in January 2021](#), as soon as the mRNA shots he developed were deployed on the human race. Rothenberg [is a Zionist](#). Mikael Dohlsten is the company’s Chief Scientific Officer and head of research and development. He [is a Zionist as well](#).

Tal Zaks – Moderna

Dr. Tal Zaks was appointed [Chief Medical Officer of Moderna](#) in March 2015. He was the man in charge of developing the Moderna mRNA injections. Zaks was born in Israel and served in the Israeli military as a [medic and ambulance driver](#). He [frequently talks about his Israeli heritage](#), making no bones about where his loyalty lies.

Coincidentally or otherwise, Zaks stepped down from his Moderna CMO position last February, around the same time Rothenberg left Pfizer. He's now a board member for [Israeli pharmaceutical company Teva](#).

There's also Facebook, YouTube and Google. The three platforms are the primary COVID-19 and "vaccine" propaganda machines. They are owned by Mark Zuckerberg, Sergey Brin and Larry Page. [All of them are Zionists](#).

Smoking gun evidence that Moderna created SARS-CoV-2

We would never use that term lightly, as it could destroy credibility. But there is a fascinating report that this blogger will attempt to summarize and explain in layman's terms since it is highly scientific and virtually indisputable.


Next, we give credit to [Dr. Ah Kahn Syed](#). He is a medical doctor and a Ph.D. The [name is a pseudonym](#) because his work on this subject is essential as a whistleblower, and he doesn't want to lose his position. His article also introduced this blogger to the [Basic Local Alignment Search Tool](#) (BLAST) administered by the National Institutes of Health. It took reading his article three times and toying around in BLAST for 2-3 hours to grasp the scientific truth being presented. We also had two biology professors at two different U.S. universities read Dr. Syed's article, and asked them to refute it. Both said the research and analysis were rock solid.

The "smoking gun" if you will is [#CTCCTCGGCGGGCACGTAG](#) (note we added the hashtag. It's not part of the sequence). That is the 19 nucleotide genome sequence of SARS-CoV-2. [The chances of these sequences happening in nature are less than one in a billion](#). There was no such virus containing this sequence prior to 2020. Every patent in BLAST that contains this near-impossible sequence is owned by Moderna, and all of them predate SARS-CoV-2.

Dr. Michael Worobey is the Head of Ecology and Evolutionary Biology at the University of Arizona. He attempted to [prove that SARS-CoV-2 is a product of nature](#). "Dr. Syed" responded and completely dismantled Dr. Worobey's arguments in one tweet. The latter disappeared and did not respond further.

Two of the first 13 stories we wrote on The COVID Blog back in January 2021 were about Israel. At least [four Israelis died and 13 others developed Bell's Palsy](#) after Pfizer mRNA injections by January 16 last year. But the more interesting story was about the Helsinki Committee for Human Rights accusing Israel of running [unauthorized human trials](#) in the country. Pfizer and the Israeli government signed an agreement that allowed Pfizer to collect data on all Israelis who received the shots.

Dr. Merritt spoke about the differences in angiotensin-converting enzyme 2, or ACE2, receptors by race. It is the ACE2 receptors that spike proteins in the mRNA injections hook on to and begin wreaking havoc in the human body. Dr. Merritt referenced a July 2020 paper published in the peer-reviewed journal *BMC Medicine*. Cleveland Clinic

scientists studied the racial specificity of the ACE2 pathway. The study measured up-regulation of ACE2 receptors by race, meaning how active said receptors are in specific groups of people.

White Europeans and Americans (except the Finnish) have 54% up-regulation of the ACE2 receptors, the highest of all humans. Thus they are the most susceptible to post-injection adverse reactions and deaths. Black Americans and Black Africans have 39% up-regulation. The Finnish, along with East and South Asians, and Latinos, range from 2 to 10% up-regulation. But the most surprising part of the study – the Amish and Ashkenazis have ZERO percent up-regulation. Read [the full study here](#) and watch Dr. Merritt talk about it below. The Amish have been free of all vaccine contamination over the past century when vaccines became common in public health.

There's also the December 2020 study published in the journal *Biochemistry and Biophysics Report*. It concluded that ACE2-K26R decreases the electrostatic attraction of spike proteins. These receptors are most frequently found in Ashkenazi populations. All other ACE2 variants increase the electrostatic attraction of spike proteins, with South Asians and Europeans having the strongest attraction. Read [the full study here](#).

What does all this mean?

Zionism is a political ideology that attempts to justify the apartheid state of Israel. Many people remember when Senator Joe Biden declared “you don't have to be a Jew to be a Zionist. I am a Zionist” in 2008 after Barack Obama selected him as the Vice Presidential candidate.

Of course, Biden is also right up there with Justin Trudeau (Canada), Jacinda Ardern (New Zealand) and Scott Morrison (Australia) as the top Pfizer spokespeople posing as world leaders.

What we know for sure is that Israel has been talking about this ethno-bomb since the 1990s. We also know that Israelis used research from South Africa's Project Coast as the guide to race-specific weapons. Further, the spike proteins behave differently in ethnic Ashkenazis than they do in everyone else on the planet. We've covered only one post-injection Israeli death (linked above) after the January 2021 stories, despite paying a lot of attention to what's happening there. Perhaps the Israeli government is hiding the deaths and/or Israeli do not report them as readily on social media as others. Regardless, make of that what you will.

During the past twenty months, I (Pastor Bob) have been watching how Israel was keeping death statistics close to the chest and reporting was not easily found in the public realm.

This blogger fully expects backlash for writing this article, just like we got from [Mormons](#), [Trump supporters](#), [Christians](#) and [LGBT people](#), for telling the truth. This one is different because Zionists are 100% off-limits to talk about in the United States. You get the “anti-semitic” label if you think critically about Israel. But nobody is

allowed to escape the truth here. And let's be honest – it's the epitome of irony that the Illinois Holocaust Museum is now asking people to "[show their papers](#)" before entering the facility.

The late Shulamit Aloni, a 30-year Israel Knesset member, told the greatest truth about so-called anti-semitism in a [2002 interview with Amy Goodman](#) on Democracy Now.

We know that vaccines are the leading cause of coincidences. Now we see all these coincidences related to the development and deployment of the mRNA and viral vector DNA injections.

The United States [declassified NSA documents in 2004](#) revealing that the whole Gulf of Tonkin incident that escalated the Vietnam War didn't really happen as history told it. That's 40 years after it happened. We'll likely have to wait at least that long to know the full truth about COVID-19 vaccines.

FOUR Presidents Who Opposed Covid Vaccines Have Conveniently Died – Replaced By Pro Vaccines

The leaders of three [update: FOUR] different countries died after having stopped the distribution of the experimental Covid-19 jabs. All [four] countries took the decision to distribute the vaccines to their citizens only after their leaders passed away.

One of them was Haitian President Jovenel Moise, who was assassinated at his home in Port-au-Prince recently by a group of mercenaries.

The Caribbean country has been eligible for free vaccines through the COVAX scheme, run by the World Health Organization as well as global vaccine charities, but Moise had notably refused the AstraZeneca shots. Only days after his murder, the US [dispatched](#) vaccines to Haiti, together with a team of FBI agents.

This means that Haiti is now no longer the only country in the Western Hemisphere not to accept the Covid injection.

Soon after President John Magufuli of Tanzania had [declared](#) the vaccines dangerous, he passed away from a "heart ailment". In February 2021, his health minister had told the media:

"We are not yet satisfied that those vaccines have been clinically proven safe."

The death of the immensely popular Magufuli resulted in thousands of mourners crowding into a stadium to view his body.

However, soon after Magufuli's death, Tanzania ordered a huge shipment of the products worth millions of dollars for its 60 million citizens.

“You should stand firm. Vaccinations are dangerous. If the White man was able to come up with vaccinations, he should have found a vaccination for AIDS by now; he would have found a vaccination [for] tuberculosis by now; he would have found a vaccination for malaria by now; he would have found a vaccination for cancer by now,” Magufuli had warned in January 2021.

Magufuli, a former chemistry teacher, also trashed PCR tests by demonstrating how a goat and a papaya fruit had both tested positive for Covid-19. Magufuli’s view on PCR tests is shared by the international trial lawyer [Dr. Reiner Fuellmich](#) who has [launched a historic class-action lawsuit in Germany](#) and the US against Christian Drosten and the other scientists who created the PCR testing protocol used to “diagnose” Covid-19.

In November 2020, an appeals court in Portugal had ruled that *“the PCR process is not a reliable test for SARS-CoV-2, and therefore any enforced quarantine based on those test results is unlawful”*.

The judges, Margarida Ramos de Almeida and Ana Paramés referred to several pieces of scientific evidence showing that in PCR tests with 35 cycles or more the accuracy dropped to three percent, meaning up to 97 percent of positive results could be false positives.

In March 2021 an Austrian administrative court acknowledged the limitations of PCR and antigen testing in use currently, ruling that “PCR tests have no diagnostic value”. This view was [echoed](#) in April by a German court in Weimar, stating that PCR tests were not “suitable for determining an ‘infection’ with the SARS-CoV-2 virus”. It also ordered the lifting of various restrictions in the region.

Burundi was the second African country to [reject](#) Covid shots in February this year. The health minister of the African nation, Thaddee Ndikumana, told reporters that prevention was more important, and *“since more than 95 percent of patients are recovering, we estimate that the vaccines are not yet necessary”*.

Burundi’s late President Pierre Nkurunziza was harshly criticized for not advancing the notion of injections against SARS-CoV-2.

Remarkably, the current President Evariste Ndayishimiye now describes the virus as Burundi’s *“worst enemy”*.

In the most vaccinated countries, like [Israel](#), the UK, or [Seychelles](#), and especially in [Gibraltar](#) which boasts a 100 percent vaccination rate, the alleged delta variant now doubles every 3 days. Perhaps the current 23 cases are not significant, but 23 cases in an area with 35,000 inhabitants is the equivalent of 45,000 cases per day in a country like France.

And it has been more than a month and a half since 100 percent of the population of Gibraltar was vaccinated with two doses. This “paradise” for the vaccinated vindicates the hesitation of the Africans to take part in the mass experiment.

The fascinating story of how DNA studies confirm an ancient Biblical tradition. This is supportive of a premise which I have made at least a half dozen times in the past year or so. That premise is based upon the need to disprove the Biblical plan of Redemption of the descendants of Abraham, Isaac, and Jacob. If Dr. Chuck Missler were alive today to see this, he would have been front in center pointing to the crimes against humanity are first and foremost against the Sephardic Jews. Since the Diaspora, Jews settled around the world and so the global mandate that everyone be vaxxed was so that they would not miss a Biblical descendant at some far away area of the world!

Dr. Karl Skorecki, a Cohen of Eastern European parents, was attending synagogue one morning. The Cohen called up for the Torah reading that morning was a Jew of Sephardic background, whose parents were born in North Africa. Dr. Skorecki looked at the Sephardi Cohen's physical features and considered his own physical features. They were significantly different in stature, skin coloration and hair and eye color. Yet both had a tradition of being Cohanim, direct descendants of one man -- Aaron, the brother of Moses.

Cohanim (plural of Cohen) are the priestly family of the Jewish people, members of the Tribe of Levi. The books of Exodus and Leviticus describe the responsibilities of the Cohanim, which include the Temple service and blessing of the people. The Torah (the first five books of the Bible) describes the anointing of Aaron, the brother of Moses, as the first High Priest (Cohen Gadol).

Jewish tradition, based on the Torah, is that all Cohanim are direct descendants of Aaron, the brother of Moses. The Cohen line is patrilineal -- passed from father to son without interruption for 3,300 years, or more than 100 generations.

Dr. Skorecki considered, *“According to tradition, this Sephardi Cohen and I have a common ancestor. Could this line have been maintained since Sinai, and throughout the*

long exile of the Jewish people?" As a scientist, he wondered, could such a claim be tested?

Being a nephrologist and a top-level researcher at the University of Toronto and the Rambam-Technion Medical Center in Haifa, he was involved in the breakthroughs in molecular genetics which are revolutionizing medicine and the study of the life-sciences. He was also aware of the newly developing application of DNA analysis to the study of history and population diversity.

Dr. Skorecki considered a hypothesis: if the Cohanim are descendants of one man, they should have a common set of genetic markers -- a common haplotype -- that of their common ancestor. In our case, Aaron HaCohen.

HOW IT WORKS

A genetic marker is a variation in the nucleotide sequence of the DNA, known as a mutation. Mutations which occur within genes -- a part of the DNA which codes for a protein -- usually cause a malfunction or disease and is lost due to selection in succeeding generations. However, mutations found in so-called "non-coding regions" of the DNA tend to persist.

Since the Y chromosome consists almost entirely of non-coding DNA (except for the genes determining maleness), it would tend to accumulate mutations. Since it is passed from father to son without recombination, the genetic information on a Y chromosome of a man living today is basically the same as that of his ancient male ancestors, except for the rare mutations that occur along the hereditary line.

A combination of these neutral mutations, known as a haplotype, can serve as a genetic signature of a man's male ancestry. Maternal genealogies are also being studied by means of the m-DNA (mitochondrial DNA), which is inherited only from the mother.

THE SEARCH BEGINS

Dr. Skorecki made contact with Professor Michael Hammer, of the University of Arizona, a leading researcher in molecular genetics and a pioneer in Y chromosome research. Professor Hammer uses DNA analysis to study the history of populations, their origins and migrations. His previous research included work on the origins of the Native American Indians and the development of the Japanese people.

A study was undertaken to test the hypothesis. If there were a common ancestor, the Cohanim should have common genetic markers at a higher frequency than the general Jewish population.

In the first study, as reported in the prestigious British science journal, *Nature* (January 2, 1997), 188 Jewish males were asked to contribute some cheek cells from which their DNA was extracted for study. Participants from Israel, England and North America were asked to identify whether they were a Cohen, Levi or Israelite, and to identify their family background.

The results of the analysis of the Y chromosome markers of the Cohanim and non-Cohanim were indeed significant. A particular marker, (YAP-) was detected in 98.5 percent of the Cohanim, and in a significantly lower percentage of non-Cohanim.

FURTHER CONFIRMATION

In a second study, Dr. Skorecki and associates gathered more DNA samples and expanded their selection of Y chromosome markers. Solidifying their hypothesis of the Cohens' common ancestor, they found that a particular array of six chromosomal markers was found in 97 of the 106 Cohens tested. This collection of markers has come to be known as the Cohen Modal Haplotype (CMH) -- the standard genetic signature of the Jewish priestly family. The chances of these findings happening at random is greater than one in 10,000.

The finding of a common set of genetic markers in both Ashkenazi and Sephardi Cohanim worldwide clearly indicates an origin pre-dating the separate development of the two communities around 1000 CE. Date calculation based on the variation of the mutations among Cohanim today yields a time frame of 106 generations from the ancestral founder of the line, some 3,300 years -- the approximate time of the Exodus from Egypt, the lifetime of Aaron HaCohen.

Date calculations based on the mutations yield a time frame for the Cohen line of some 3,300 years.

Professor Hammer was recently in Israel for the Jewish Genome Conference. He confirmed that his findings are consistent -- over 80 percent of self-identified Cohanim have a common set of markers.

The finding that less than one-third of the non-Cohen Jews who were tested possess these markers is not surprising to the geneticists. Jewishness is not defined genetically. Other Y-chromosomes can enter the Jewish gene pool through conversion or through a non-Jewish father. Jewish status is determined by the mother. Tribe membership follows the father's line.

AMAZING STATISTICS

Calculations based on the high rate of genetic similarity of today's Cohanim resulted in the highest "paternity-certainty" rate ever recorded in population genetics studies -- a scientific testimony to family faithfulness.

Stated Dr. David Goldstein of Oxford University:

"For more than 90 percent of the Cohens to share the same genetic markers after such a period of time is a testament to the devotion of the wives of the Cohens over the years. Even a low rate of infidelity would have dramatically lowered the percentage."

Wider genetic studies of diverse present day Jewish communities show a remarkable genetic cohesiveness. Jews from Iran, Iraq, Yemen, North Africa and European Ashkenazim all cluster together with other Semitic groups, with their origin in the Middle East. A common geographical original can be seen for all mainstream Jewish groups studied.

This genetic research has clearly refuted the libel that the Ashkenazi Jews are not related to the ancient Hebrews, but are descendants of the Kuzar tribe -- a pre-10th century Turko-Asian empire which reportedly converted en masse to Judaism. Researchers compared the DNA signature of the Ashkenazi Jews against those of Turkish-derived people, and found no correspondence.

OTHER SURPRISING FINDINGS

In their second published paper in *'Nature'* (July 9, 1998) the researchers included an unexpected finding. Those Jews in the study who identified themselves as Levites did not show a common set of markers as did the Cohanim. The Levites clustered in three groupings, one of them the CMH. According to tradition, the Levites should also show a genetic signature from a common paternal patrilineal ancestor. The researchers are now focusing effort on the study of Levites' genetic make up to learn more about their history in the Diaspora.

Using the CMH as a DNA signature of the ancient Hebrews, researchers are pursuing a hunt for Jewish genes around the world.

This research could have ramifications in the search for the Biblical Ten Lost Tribes

Using the genetic markers of the Cohanim as a yardstick, these genetic archaeologists are using DNA research to discover historical links to the Jewish people.

The researchers' policy is that the research is not a test of individuals, but an examination of the extended family. Having the CMH is not a proof of one's being a Cohen, for the mother's side is also significant in determining one's Cohen status. At present, there are no ramifications in Jewish law due to this discovery. No one is certified nor disqualified because of their Y chromosome markers.

The research has shown a clear genetic relationship amongst Cohanim and their direct lineage from a common ancestor. The research findings support the Torah statements that the line of Aaron will last throughout history:

"... and they shall have the Priesthood as a statute forever, and you shall consecrate Aaron and his sons." –(Exodus 29:9)

"... it shall be for them an appointment to an everlasting Priesthood throughout their generations." –(Exodus 40:15)

"And it shall be to him and to his descendants after him a covenant of everlasting Priesthood ." –(Numbers 25:13)

That our Torah tradition is supported by these findings is an inspiration for many that God surely keeps His promises. May we soon see the Cohanim restored to their service, Levites on their Temple platform and Israelites at their places.

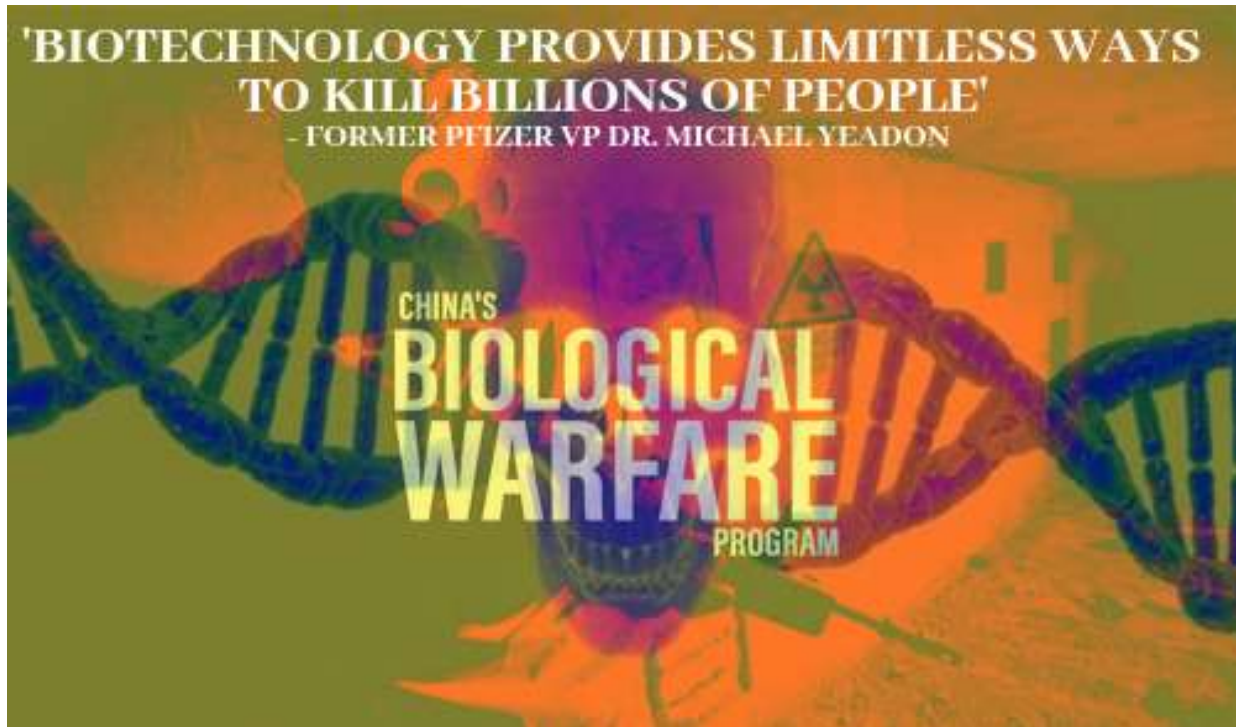
'Conspiracy' and not just 'convergent opportunism.'

Vaccine Passports: One Passport to Rule Them All

Vaccine passports are a major goal of those orchestrating Operation Coronavirus, though not the ultimate end goal of the COVID agenda.

The purpose of **vaccine passports** is clear, despite whatever flimsy and mealy-mouthed excuses given to justify them: to restrict the movement of the unvaccinated, or in plainer terms, to restrict the movement of those who have seen through the agenda.

There are no clever legal arguments that can distract from this basic truth: vaccine passports are inherently discriminatory.

In a sane society, no nation that even pays lip service to care about human rights could claim that vaccine passports are in alignment with their existing laws on individual rights, freedom of choice, freedom of movement, informed consent and medical sovereignty.

However, it hardly bears stating that we do not live in a sane world. Below is a brief list of the vaccine passport schemes that are either proposed, about to be rolled out, or already in existence.

This is a worldwide agenda being rapidly promoted and implemented.

The EU Planned for Vaccine Passports in 2018.

Long before the word 'coronavirus' become a household word, or the term 'COVID' even existed, the European Union (EU) was planning for a vaccine passport scenario.

The European Commission (the executive arm of the EU) published a proposal for vaccine passports on April 26th, 2018 in a document entitled ["Proposal for a Council Recommendation on Strengthened Cooperation against Vaccine Preventable Diseases"](#).

It lays out the plan for a "vaccine passport" or "vaccine card" and "vaccine portals":
"HEREBY WELCOMES THE COMMISSION'S INTENTION TO:

17. Examine issues of insufficient vaccine coverage caused by cross-border movement of people within the EU and look into options to address them, including developing a common EU citizens' vaccination card/passport, compatible with electronic immunization information systems and recognized for use across borders.

HEREBY WELCOMES THE COMMISSION'S INTENTION TO TAKE THE FOLLOWING ACTIONS, IN CLOSE COOPERATION WITH THE MEMBER STATES:

10. Aim at establishing a European Vaccination Information Sharing (EVIS) system, coordinated by the European Centre for Diseases Prevention and Control (ECDC), in order to:

a. Together with the national public health authorities,

i. examine the options of establishing, by 2020, guidelines for a core EU vaccination schedule, aiming to facilitate the compatibility of national schedules and promote equity in Union citizens' health protection, and subsequently ensuring broad uptake of the core schedule as well as a common vaccination card;

ii. strengthen the consistency, transparency, and methodologies in the assessment of national and regional vaccination plans, by sharing scientific evidence and tools with the support of National Immunization Technical Advisory Groups (NITAGs);

iii. design EU methodologies and guidance on data requirements for better monitoring of vaccination coverage rates across all age groups, including healthcare workers, in cooperation with the World Health Organization (WHO). Collect such data and share them at EU level;

b. By 2019, establish a European vaccination information portal, with the support of the European Medicines Agency, to provide online objective, transparent and updated evidence on vaccines, their benefit and safety, and the pharmacovigilance process.

c. Monitor online vaccine misinformation and develop evidence-based information tools and guidance to support Member States in countering vaccine hesitancy, in line with the Commission Communication on tackling online disinformation.”

Interestingly, on pg.13, this document also mentions the term **vaccine hesitancy** as it recommends a “*Joint Action on Vaccination, co-funded by the third Programme for the Union’s action in the field of health ... to address vaccine hesitancy.*”

Vaccine hesitancy has also become a theme in the **COVID op** because so many people have become aware of just how [toxic vaccines can be](#) and how [experimental](#) these ones are in particular; in my [article from August 2020](#) I revealed how a Yale study was analyzing how to combat vaccine hesitancy and increase **vaccine uptake** through a variety of psychological techniques and manipulation.

European Vaccine Passports

Given the above documents, it’s no great surprise that Europe is at the forefront of implementing vaccine passports.

The UK and many European countries are getting close to rolling out their passport scheme; on March 17th 2021, the European Commission [proposed](#) the following draft legislation to create a “**Digital Green Certificate**” as you can see from this [document](#). In a classic example of doublespeak, Commissioner for Justice, Didier Reynders, said:

With the Digital Green Certificate, we are taking a European approach to ensure EU citizens and their family members can travel safely and with minimum restrictions this summer.

The Digital Green Certificate will not be a pre-condition to free movement and it will not discriminate in any way.

A common EU-approach will not only help us to gradually restore free movement within the EU and avoid fragmentation.

No pre-condition for movement? Not discriminate in any way?

The very essence of the vaccine passport is to regulate and restrict movement, as well as to discriminate. Otherwise, what is the point of it?

This is a constant theme of the COVID op. Politicians make rules to control your life, and right when they announce these rules, they claim they are not controlling you.

Black is white, up is down and tyranny is freedom.

American Vaccine Passports

They're coming to America too. The U.S. state of New York was the first state to introduce a pilot program.

Authorities have said it's optional, but that's how all these schemes of control initially work; first they're optional to break down resistance and get people accustomed, and then they're mandatory.

New York is calling its vaccine passport the "[Excelsior Pass](#)" and the official announcement states:

Developed in partnership with IBM, the Excelsior Pass will use proven, secure technology to confirm an individual's vaccination or a recent negative COVID-19 test through a confidential data transfer to help fast-track the reopening of theaters, stadiums and other businesses in accordance with New York State guidelines...

The Excelsior Pass will play a critical role in getting information to venues and sites in a secure and streamlined way, allowing us to fast-track the reopening of these businesses and getting us one step closer to reaching a new normal.

On the upside, there are certain states which have [preemptively banned vaccine passports](#) in some form or another, including Florida, Texas, Arizona, Montana, and Idaho.

As for much of the duration of the COVID op, support or resistance to vaccine passports is mostly following party lines, with the left-wing Democratic states supporting it and the right-wing Republican states resisting it.

Vaccine Passports in Israel, China, and India

Israel has earned itself another dubious distinction by leading the world in COVID vaccination rates, and by already implementing its vaccine passport program.

Unvaccinated Israelis are being banned from going to so-called non-essential places.

Tyrannical Israeli Health Minister Yuli Edelstein [warned](#):

"Whoever doesn't vaccinate will only go out to supermarkets or pharmacies, while the vaccinated will go to stadiums and gyms."

The tyranny doesn't stop there.

Israel has also issued "[Freedom Bracelets](#)" to be worn by those entering the country from abroad.

Israel's parliament joined action taken previously [by the Spanish government](#) in approving a law to [create a registry](#) of people refusing the COVID vax.

Interestingly, UK Cabinet Office minister [Michael Gove was recently seen arriving in Israel](#) for what they say was “vaccine passport talks” but in reality, from those who know the backstory of the [Zionist New World Order](#) (NWO), was likely his marching orders.

China and India have both joined the vaccine passport game. China called their version the “[International Travel Health Certificate](#)” (downloadable from its WeChat mobile app) while India has a [QR code certificate version](#).

One Passport to Rule Them All

No matter what fancy and different names these passports, apps and QR codes have, there are plans afoot to link them all via a common software or framework.

The leading developers of this technology include [AOK Pass](#), [Common Pass](#), the [Vaccination Credential Initiative](#), [Good Health Pass Collaborative](#) and the [IATA Travel Pass](#).

This is a clear manifestation of the NWO Agenda of a One World Government with detailed information on every single person (except for the ruling elite) on Earth, who are planned to be its subjects or slaves.

I call this The Ashkenazi Suicide Path.

To begin, it is important to understand who the Ashkenazi are and why they are being uniquely set-up for irreversible harm by the actions of those ostensibly working on their behalf. **First, Judaism is a religion, but being Jewish is an ethnicity. This is hard for Christians to understand because they typically disassociate ethnicity and faith.** For example, among Whites, one may be both an Anglo-Saxon and an Episcopalian, two distinct entities. Perhaps the closest thing to the Jewish intertwined identity is found among Irish-Catholics. I will always be an ethnic Irish-Catholic, even though I am no longer a Catholic (I find more in common theologically with Presbyterianism). **For Jews, being Jewish is an all-encompassing construct that is both cultural and genetic, even when they do not practice the faith.**

Jews favor the matrilineal blood relationship. This embrace of matrilineality means that a Jewish family would view the offspring of an ethno-Christian male (e.g., Norwegian-Lutheran) and a Jewish woman as being a Jewish child, even if the child were raised Christian. The child will never become “un-Jewish,” and if the child is a female, her offspring will be Jewish, too, even if raised Lutheran. Conversely, if the product of the marriage were reversed, and the child was raised Jewish, conservative Jews would not view the child as Jewish – he or she is just honoring their Jewish heritage.

Recognizing the importance of the intertwined ethno-religious identity of Jews, it is then important to understand that there are two primary Jewish ethnic lines: Ashkenazi and Sephardic. Approximately 95% of all Jews are Ashkenazi. Only 5% of Jews are Sephardic. Sephardic Jews have their origins in the Arabian Peninsula and North Africa. These two sets of Jews are distinct. Whereas most on the Dissident Right focus on modern Jews, who are primarily Ashkenazi, the Ashkenazi Jews were barely a blip on the European radar until about the 14th Century. Sephardic Jews who worked in tandem with Muslims to help conquer the West, are those with whom early Western European Christian-Jewish interaction originated. For those Christians who may be confused as to why Jews and Muslims would work together, it is important to understand that Muslims and Sephardic Jews have almost always worked together, because Muslims consider Jews “of the Book” (the Bible) and Muslims believe they have a shared Abrahamic lineage. One needs only to read the Constitution of Medina to understand Mohammed’s feelings on the protected status of Jews. But Sephardic Jews, although far less so today, once looked down upon the Ashkenazi.

There are a whole list of origin references about the Ashkenazi, ranging from some who say they originated in Germany to others who state they were a Turkic tribe that suddenly embraced Judaism in the later portion of the first millennium. Wikipedia, which frequently peddles misinformation, offers several origin points. In fact, the Ashkenaz are referenced in Genesis 10:3 – likely written about 1500 BC. Thus, the tribe predates Germany and modern Europe. Additionally, the tribe is referenced in Jeremiah 51:27, as a Judean ally against the Assyrians. They are referenced as a tribe occupying Armenia, which would make a lot of sense genetically and historically. Since Jeremiah lived and died around the 6th Century BC, we know the Ashkenazi were a well-entrenched, warrior tribe from the Caucasus that likely traded (at a minimum) with Judea and were familiar with early Israelite worship.

Movses Khorenatsi, the Armenian historian and Saint, wrote a history of Armenia that I read prior to working in Yerevan. Armenia was the first European sovereign territory to embrace Christianity as a state religion. Again, this makes sense, given its historical ties to Biblical Israel. This conversion likely led to a revival of some version of Judaism coupled with refugees after the Romans destroyed Jerusalem in 70 AD. All in all, Ashkenazi Jews are most likely far older than many believe them to be. More importantly, they are genetically White (Armenian) – a controversial position to take by anyone on the Dissident Right or the Jewish Left. The fact is, both the Bible and historical research indicates that the Ashkenazi Jews predate the Turkish invasions that come at the end of the first millennium. While it is likely that the Northeast Asian origin-Turks added Asiatic blood to the Ashkenazi, they similarly did this to the Greeks, Serbians, Romanians, and other Eastern European peoples whom the Turks either conquered or attempted to conquer. Prior to the Turkic invasions, the Ashkenazi Jews likely looked similar to Byzantine Greeks: fairer skin, lighter eyes, and other Caucasian physical attributes.

This genetic origin of the Ashkenazi Jews brings me back to the original topic: The Ashkenazi Suicide Path. As the Turks pushed from East to West, refugees of various

ethnic types similarly sought refuge in Europe. This would not have been a problem for Christians originating from the East. For a tribe of Armenians calling themselves Jews, however, this would be an issue in late-Medieval Europe. Christians knew that Jews were responsible for the death of Jesus Christ. As such, Ashkenazi Jews were largely confined to the edges of Central and Eastern European nations, often acting as an independent, parallel entity. This differs from the Sephardic Jews who were being courted by Western European states that sought complex financial dealings in an increasingly trade sensitive world in the post-Turkic ascendancy. In other words, while London employed Sephardic Jews to count their coin (before an expulsion in the late 13th Century), the Ashkenazi Jews were primarily tinkers, tradesmen, and serfs extending from Russia to modern-day Germany. Occasional intermarriage with other Europeans not only ensured Ashkenazi Jews enjoyed genetically White features, but more likely awakened them within their early Armenian genetic line.

Why is all of this important? Jews are racially White, even if neither them nor National Socialists agree on this point. As such, the steps that far-left Jewish Supremacists have taken is parasitic in nature. It is suicide by another name. A smart parasite at least knows not to kill the host. Rather, Jewish Supremacists seem hell bent on destroying Western Civilization. What they do not seem to appreciate is that – whether they like it or not – Jews are viewed as White by our replacements. Worse, they are non-Christian Whites, meaning that blacks and Hispanics, both of whom identify as overwhelmingly Christian, do not look favorably on the Jewish faith. Catholic Hispanics who are not introduced to Dispensationalism and do not recognize a Jewish Jesus, have a significant hatred for Jews. Meanwhile, blacks are well aware of the Jewish involvement in the slave trade. They will not make distinctions between Sephardic Jews and Ashkenazi Jews, when White Christians are out of the way. All one needs to do is listen to the speeches of Louis Farrakhan or any Black Hebrew Israelite. But why are they doing this? I have a theory before closing.

The Ashkenazi Jews really began to settle in the United States toward the latter portion of the 19th and early 20th Centuries. By the time they began to settle in the United States, the Ashkenazi Jews had three massive cultural shifts occurring simultaneously. First, Bolshevism – a Marxist revolutionary movement in Russia – was heavily influenced by Jews who derived from the merchant middle-class of Czarist Russia. With a significant number of Jews in impoverished socioeconomic status within Russia, these middle-class Jews, many of whom ascended through academia, had a willing army within the ranks of a disaffected Russian under-class. Many of those Russian Jews came to the United States during a particularly unique time of far-left Jewish radicalization.

Second, the industrialization of the 19th Century and the collapsing Ottoman Empire shifted more Jews away from Eastern Europe and into more accommodating Central and Western Europe. By the end of the 19th Century, Ashkenazi Jews were found throughout France, Germany, Italy, Poland, and elsewhere. Again, many brought with them radical ideas and given that they were less likely to assimilate, they were viewed as troublemakers. This led to attacks by fed up Christian Europeans with long standing

lineal connections to the lands now occupied by a foreign people. Tensions heightened and the Ashkenazi Jews, who bred like rabbits, did little to ameliorate the situation. As future generations of Jews began to enter into political, economic, and academic positions of prominence, many saw it as their mission to destroy the very countries and cultures whom they believed to be responsible for previous pogroms. Institutions like the Frankfurt School emerged in the post-World War I Era. When the National Socialist German Workers Party (NSDAP) took power in 1933, they immediately deconstructed these culturally corrosive institutes and many of those Jews fled to the United States. Who was there to greet them? Many Jews with Bolshevik sympathies who had settled in New York and elsewhere during the tumultuous early days of the Marxist Russian Revolution.

Third, and finally, the ascendance of Ashkenazi Jews in Europe was not entirely left leaning. Zionism began to arise in the broader push for Nationalist movements in Europe. These movements, which led to Greek, Romanian, Bulgarian, and other Eastern European independent states, as well as a war in Ireland (1918-1922), were not ignored by Ashkenazi Jews who believed Palestine was their territory, not Great Britain's. These Zionist Jews were mostly devout fascists and Hitler agreed with them. Consequently, the NSDAP Germany spent millions on fomenting Zionism, supporting the creation of the modern state of Israel, as well as providing military training and aid to the early founders of the Jewish state. In 1948, when Israel was recognized as a country, it should be noted that not all Israeli-Jews were happy to accept their Ashkenazi kin who were left leaning with radical cultural morals.

Furthermore, I believe this is why some Ashkenazi Jews who are anti-leftist tend to be the most virulent anti-leftists. They see things through a Nationalist lens. Whereas there is an element of Zionism, there will also be an element of "homeland" reactionary sentiment. This probably explains the hardline anti-Communist approach of Ashkenazi Jews like Stephen Miller and Ashley Rae ("Communism Kills"). They are not less Jewish, they just know that the alternative – the collapse of Western Civilization – brings nothing good to the table – for their people or the world writ large.

Still, the combination of Zionism coupled with both ingrained, early 20th Century Marxist sympathies and an "us-vs-them" mentality now plays a strong role in Ashkenazi Jews who have recently ascended to power in the United States. One hundred years ago, Jews were largely seen as gangsters and generally constrained to large urban environments. Today, their descendants occupy the most powerful positions in society. Many of them view this as an opportunity for both revenge and to firmly entrench their positions of power. The irony is that, in order to achieve these goals, they need to kill the functioning society they inherited from the previous Anglo-Saxon elites. In so-doing, they will kill themselves.

A few weeks ago, Ashkenazi Jewish comedian Seth Rogen wrote the following on Twitter: "The [overwhelmingly negative] response to the Santa Inc. trailer shows exactly why we need diversity. Too many angry white men can't accept that their time is up." Rogen deleted that Tweet, but the sentiment was insightful. It mirrors the views of

many leftist Ashkenazi Jews in the United States. Sephardic Jews are an infinitesimal group and largely non-existent in the United States. But the Ashkenaz now enjoy powerful positions previously occupied by Whites. The diversity they invite will eat them, too.
