

Britain's 100 'Holocausts'

NOTES ON BRITAIN'S 100 HOLOCAUSTS (all listed in the attached PDF file)

1. Most British people are not genocidal. There are really TWO “Britains”: one based in the offshore tax-haven known as the City of London, having a secret GDP in the troposphere; and a second Britain whose “loyal” slaves pay 80 percent of their lifetime-labor to the City of London and call it “freedom” and “democracy”;
2. The British Empire genocided over 300 million human beings and counting, all in the name of the English monarchy. In many of Britain's 100 Holocausts, Britain was “merely” an accessory to, or a financier of, the carnage. But in the vast majority of Britain's 100 Holocausts, Britain was the chief perpetrator of the evil;
3. In eight cases, Britain was the victim of the Holocaust in question: [a] There were 300,000 victims in the English Civil War in 1642-51; [b] There were 150,000 victims in the Scottish Famine of 1694-1700, dubbed “Seven Lean Years”; [c] 70,000 British Civilians died in WW2, in 1939-45, or “slightly” less than the 39 million German Civilians genocided by the Zionist powers (US, GB, RU, FR) in 1914-55; [d] There were 70,000 victims in the Scottish Civil War of 1644-51; [e] There were 10,000 British POW victims in the Death Railway Holocaust of forced laborers on the “Siam-Burma Railway” in 1942-47; [f] There was an unknown count of victims in the Holocaust of Scottish Highland Clearances in 1750-1860; and [g] There were millions of British victims in the Abortion Holocaust, and in the Charles-III-guided COVID-PHARMA GENOCIDE;
- 4.
5. Two major perpetrators of the COVID-PHARMA GENOCIDE are the “Illuminati” bloodlines Rockefeller and Windsor, who are the chief string-pullers of the WHO, WEF, and UN. So, Britain played a key role yet again;
6. The REASON Britain's 100 Holocausts are still COVERED UP is because the “new” world order is really the continuation of the British Empire; and **the oligarchs do not want the slaves realizing that the “new” world order is really all about GENOCIDE, and in particular the genocide of most of the world's slave populace.** The “new” world order views (shelters) Britain as its “embryo of world [tyrannical] government”;
7. Most British people are totally ignorant of Britain's 100 Holocausts because the British people are probably the most effectively brainwashed victims on Earth, thanks to their “Departments of No Ed” and to the BBC;
8. The BBC is the most effective brainwashing machine in history. The BBC would have you believe that the British Empire came about not by murder, theft, or deception, but instead by “BRITISH WIT AND CHARM”;
9. Even before the BBC, the British Regime fostered evil warmongers like Thomas Hobbes, funded by the Cavendish “Illuminati” bloodline, to brainwash British slaves into believing oxymoronic ideas like “war is the natural state of man”. But, in reality, human survival is based on cooperation, and war is wholly aberrant;

10. When the world's population first surpassed 1 billion around 1800, the British Regime, and the "Illuminati" in general, were appalled. They reacted by introducing a strict policy of Malthusianism (a euphemism for genocide) so as to "correct" this "terrifying" trend. And they have been successfully genociding ever since;
11. In Ireland, the British Empire and the "Holy" Reformation revoked all rights, including personhood, from all Irish Catholics except for five Gaelic "bluebloods" called "Quinque Sanguinum" (O'Neill, O'Brien, O'Connor, O'Loughlin and Kavanaugh-McMurrough). British "law" defined most Irish Catholics as "Livestock" till 1829;
12. Britain honed its talents for genocide in Ireland, where it halved the Irish population FOUR times (which until 1550 was always comparable to England's), in 1558-93, in 1649-53, in 1845-52, and in 1852-1910 (the first three cases by classic genocide, but the fourth halving largely by expulsion). The English monarchy turned psychopathic around 1500, and murdered its own next-door neighbor several times over, with fertile Ireland suffering a total of TEN Holocausts, and the Irish population halved four times. Is it any wonder that the Irish still today refer to the British flag as "the Butcher's Apron", and to the English monarch as "the Beast"? And today too, the Irish still use their unique phrase "After All They Did To Us" to recap those 750 "happy" years;
13. But the world ignored the ten Irish Holocausts, with very little intervention to save the Irish, even by the Catholic Church. What was the result of nonintervention? The way of Ireland became the way of the world;
14. When Anglicanism was founded in 1559-71, it studiously incorporated the theological "justification" for the theft of Ireland's resources and the genocide of the Irish, by redefining the Irish as "idolatrous" "Canaanites" and the British as "righteous" "Israelites", and misusing a great deal of Old Testament Scripture to "justify" the slaughter or expulsion of the Irish, despite the fact that the Irish are a Celto-Germanic people related to the Scots, Manx, Norwegians, and Icelandics. This gigantic case of Mistaken Identity persists in the British-Israel Mythology to this day, a false mythology that is still being upheld by Talmudic Freemasonry. In 1845, John Henry Newman explained his defection from Anglicanism to Catholicism by his fear that the Anglican Church was soon in danger of becoming totally poisoned from stem to stern by the British-Israel Mythology;
15. Anglicans immediately began calling Elizabeth I "the English Deborah", whose "religious" "duty" as a "good" "Israelite" was to murder or expel all "idolatrous" Irish "Canaanites". Later, "Puritan" Cromwell styled himself "the English Joshua", who had the same "religious" "duty". Later, the de-facto Jew Victoria and de-facto Jew Edward VII joined the same "sacred" "mission" after falling hook-line-and-sinker for British-Israel Mythology. Today, ZioFascist Netanyahu is still using the Old Testament to "justify" murder, theft and utter deception;
16. Moreover, the benefit of hindsight shows how the satanic project of Zionism really began in 1500s England. In fact, the whole lineage of the Talmudic "new" world order started with Proto-Zionist Elizabeth I, flowed on with Proto-Zionist Oliver Cromwell, and continued with Zionist Jews Victoria and Edward VII, the latter being the architect-in-chief of the German Holocaust of 39 million civilians, and it continues today under ZioFascist Netanyahu, whose role as "Moshiach ben Yosef" was probably assigned him by the satanic CHABAD in this 1990 ritual <https://www.bitchute.com/video/ultpDaGBqmR8/v>, his "mission" being to prepare the way for the final Antichrist (entitled "Moshiach ben David"). But, in fact, Zionism has always been a British Rosicrucian-Freemasonic project for installing the Antichrist in Jerusalem, a project that merely uses Jews as its Willing Dupes. In truth, Zionism is 500 years old, and it grew out of the "Holy" English Reformation. British Proto-Zionists included Elizabeth I, John Dee, Francis Bacon, Henry Spelman, "Puritan" Cromwell, John Sadler (a key henchman of Cromwell's), William Blake, George Byron, Henry John Temple ("Lord Palmerston") ... It was really Talmudic British-Israel Mythology that gave the Irish, and other, Catholics a meager life or death in Ireland, Britain, the USA, Canada, Australia, New Zealand, but not on the Continent or in South America;

17. It is very significant that London's Freemasonic lodge QUATUOR CORONATI founded Political Zionism and Nazism in 1870-1910, as two sides of a Hegelian Dialectic from which Zionism was to emerge as "victor". It was really Britain's fostering of Political Zionism that culminated in today's ZioFascist mentality, which still is the core mindset of the Talmudic "new" world order, and also the primary driver of "Team Antichrist".
18. The offensive against the Catholic Church was always led by British Talmudic Freemasonry. In his 1885 book "War of Anti-Christ with the Church and Christian Civilization", Monsignor George Francis Dillon published a translation of documents from the Freemasonic lodge ALTA VENDITA that had previously been uncovered by French journalist Jacques Crétineau-Joly. In them, the ALTA VENDITA, the highest lodge of the Italian Carbonari, backed by Britain, declared openly that its **"ultimate end is that of Voltaire and of the French Revolution, namely the final destruction forever of Catholicism, and even of the Christian idea"**. Freemasonic "New Age" magazines of the early 1900s openly described Freemasonry's struggle against the Catholic Church as a "war". That is why Freemasonry worked hard to undermine the Church, especially after the Conclave of Oct 1958. On 24 June 1917, the pagan festival of the summer sun, British Freemasons celebrated their bicentennial by marching in Saint Peter's Square. The afterward-canonized Maximilian Kolbe was present that day and he personally witnessed at least one banner proclaiming **"Satan Must Reign in the Vatican. The Pope Will Be His Slave"**. And that is exactly what "Team Antichrist" is on the cusp of achieving just over one century later in this "Age of Antichrist". In 1937, top 33rd-degree Freemason Albert Lantoine wrote an open letter to Pope Pius XI titled "Lettre Au Souverain Pontife", in which he proposed a "truce" but also confirmed that Freemasons are operating in the service of Satan. In it, Lantoine stated: **"We are the servants of Satan. You, the guardians of truth, are the servants of God. These two complement one another. Each needs the other"**. But Pope Pius XI turned down Lantoine's offer. It is truly vital to bear in mind whom Britain, as the single most Freemasonic nation on Earth, is serving;
19. In the twentieth century, Britain also played the leading role in BOTH Jewish Holocausts (in 1918-21 and in 1941-45). In the first, Zionist Britain financed the Bolshevik-Zionist "revolution" and the genocide of millions of Orthodox Christians that ensued, but in reaction, pogroms killed 130,000 Jews. In the second, Britain and the USA bombed Germany's infrastructure so severely that this prevented food and medicine from reaching the labor-camps, and that led to 104,572 Jews dying not by genocide but by DISEASE, as the Red Cross originally certified in 1946. But Zionist Britain covered up the first Jewish Holocaust completely, and blamed the second solely on Germany; yet both cases were more awfully degenerate Zionist and British deception;
20. In the post-WW2 period, Britain also played a leading role in the Arab-Semitic Holocaust, in which Zionist powers (IL, US, GB, EU) genocided 6.1 million Arabic Semites in 1948-2023 (including 3.8 million Arabic Semites of Iraq, 1 million Arabic Semites of Palestine, and 0.5 million Arabic Semites of Syria);
21. Since 1871, the US Corporation has been owned by the Bank of England. Thus, Britain controls or owns the USA, and remains the senior partner in the "special" relationship, and the central brain of "Team Antichrist";
22. Since 1871, the USA has stayed a colony of Britain, which controls the USA financially through the NY Fed, politically through the CFR, and culturally through the Tavistock-Hollywood combine. Thus, although not all of the Holocausts led by the USA involved Britain, the USA was at all times being controlled ultimately from London. And that means Britain was complicit in the death-toll of 5 million in the Holocaust of the Vietnam War in 1955-75, and in many Holocausts in which the USA led the charge, but Britain "only" called the tune;
23. Communist Russia was really a colony of Britain and the USA. In 1917-91, London's Marxist Fabian Society held a permanent desk in the Kremlin to help guide the progress of communism for the London-NY-Alliance. Hence, many Holocausts "credited" to Communist Russia were given generous British and US financing. In 1945-90, the sole-dictator of

communist Russia was Victor Rothschild in London, who “worked remote”. The death-tolls included [a] 77 million in the Bolshevik-Zionist genocide after the Rothschild-sponsored coup of 1917, including 10 million in the Ukrainian Holocaust by Food Removal at Gunpoint, officially called the Holodomor, in 1932-33, which US+GB helped to cover up; [b] 1.7 million in the Kazakh Holocaust by Food Removal in 1931-33; [c] 1.6 million in the Russian and Asian Holocaust in the Russian-Afghan War of 1979-89; [d] 1 million in the Multinational Holocaust during the massive population transfers in communist Russia in 1930-52, and [e] 1 million in the Tatar Holocaust in 1921-22. Plainly, Britain was complicit in all of these;

24. Communist China was also set up and controlled by the West. Mao Zedong was a Freemason of the lodge “Yale in China”, an offshoot of Skull & Bones. That means that Britain and the USA also played key roles in the Chinese Holocaust of 1949-69, in which 100 million died, with the era of Forced Famine in 1958-62 also;
25. These other huge Holocausts involving Britain show that the list of “only” 100 is awkwardly incomplete. So, can the whole world breathe a sigh of “relief” that Britain is leading the establishment of the Talmudic “new” world order? A “kind” and “gentle” nation that is run by “decent chaps”; a “righteous” nation or “a paradigm of virtue” that occupies, and can “never” be displaced from, the pedestal titled “moral” “high” ground? If you ask the Irish, they will tell you that Britain already ran the “new” world order, and even ran the “Own Nothing And Be Happy” slogan, in Ireland for 750 years; so the Irish are pretty certain to answer you: HECK NO;
26. After WW1, most industrial-genocide was delivered from the air by the British Air Force, founded on April Fools’ Day 1918 but, by an “amazing” “coincidence”, not yet classified as a terrorist organization by the UN;
27. Richard Grove coined the cool term “GRAND THEFT WORLD” for the endeavors of the Zionist London-NY-Alliance or Zionist Cabal (the English monarchy, the City of London, the “Monopoly Capitalists” of Wall Street (often called the “Illuminati” bloodlines), and the House of Rothschild) to conquer and own the world. 500 years ago, the British Empire set out to quite literally STEAL THE WORLD and it is today frighteningly close to achieving the final completion of the very same 500-year-old “GRAND THEFT WORLD” Plan;
28. **Britain is also the MASTER of inventing, running and maintaining real-world Monty Python Sketches but with most of the audience hopelessly unable to spot the surreal DECEPTION, IRONY, or SATIRE;**
29. One British Monty Python Sketch is NEVER to classify the British Air Force or the British Navy as terrorist organizations, and never to classify the English monarch, Tony Blair, Winston Churchill et al, as terrorists;
30. Another British Monty Python Sketch is classifying the 12 years of NSDAP Germany as “evil” but the 500 years of the British Empire, and its genocide of over 300 million victims and counting, as “good”. This simply MUST qualify as absolutely **the single FUNNIEST real-life British Monty Python Sketch of all time;**
31. Another British Monty Python Sketch came in 1655, when poet John Milton (who was blind in more ways than one) wrote a sonnet, and hymn, after 2,000 forewarned Protestants died in Piedmont, but wrote NO sonnet, and NO hymn, when his good friend, “Puritan” Cromwell, halved the Irish population by slaughtering 600,000 Irish Catholics and expelling another 300,000 as slaves. Of course, Milton’s “righteous” indignation began: “Avenge, O Lord, thy slaughtered saints, whose bones lie scattered on the Alpine mountains cold”;
32. **You have just GOT to belly-laugh at the sheer WIZARDRY and AUDACITY of Britain’s avalanche of real-world Monty Python Sketches. Why does it ALWAYS sound like a Monty Python Sketch when a British puppetician stands up to lecture the world on any subject under the sun?** Such as “safe and effective”, “our common future”, “build back better”, the “need” for a “new” world order, “weapons of mass destruction”, “two weeks to flatten the curve”, “the new normal”, “you will own nothing and be happy”, “coalition of the willing” ...? “As England sinks, and only the English mountain peaks remain above the water surface, a simultaneous earthquake will cause a new country to rise out of the ocean. This land was there before ... [implying that Irlmeier is referring to the legendary ‘Atlantis’ and also echoing Merlin’s ancient prophecy whereby Proud Albion would one day meet its grave in the waves]”.

Translation:

“England will be punished for everything. I see a big black casket, but no one is inside. Then fire, then smoke, and THAT WAS IT for England” [written in a southern dialect of German, such as Bavarian or Austrian].

CONCLUSIONS

Although England only occupies around 62 percent of the island of Britain, the German language, especially in its usage prior to 1970, very often takes the word “England” to refer to the entire island of Britain. Hence, we need to interpret any German-language prophecies about England as likely in fact referring to the whole island of Britain, especially where such prophecies are older than around 1970.

Recap of the three prophecies just mentioned:

1. Padre Pio did NOT explicitly prophesy that Britain would sink beneath the waves in these End Times. But, he did prophesy that a major [or large] country will simply disappear [although here, others point to Japan];
2. Bavarian prophet Alois Irmaier did say that Britain will go under, leaving only the topmost mountain peaks;
3. A third, anonymous, probably either Bavarian or Austrian, prophet stated explicitly in roughly Oct 1945 that Britain would “go under for its sins”.

Nobody, and that means ABSOLUTELY NOBODY, knows the future. But all of these statements just happen to STRONGLY echo Revelation 18, because they describe the sheer suddenness with which some “major country” might just vanish. **BIG QUESTION: When Revelation 18 says the following, is it in fact referring to BRITAIN?**

“FALLEN, FALLEN IS BABYLON THE GREAT. Woe to you, once great and mighty city of Babylon! For in just one hour your judgment has come ... And the light of a single lantern will shine in you no more”.
