

# Beware of any Government Healthcare Patriot Act And Its Links to ID2020

It is difficult to write about any specific facet of Global Government coming and not bring in related issues that overlap or are connected in some way that does not impact our lives. Such is the case of that piece. The American people are being played like a well-tuned Stradivarius violin in the hands of the maestro.

Before getting to the nitty-gritty here, consider this about the virus that has the world in an uproar.

## **Medical Abstract**

The human coronavirus (HCoV) contains HCoV-229E, HCoV-NL63, HCoV-OC43, HCoV-HKU1, SARS-CoV and MERS-CoV. HCoV-229E, HCoV-NL63, HCoV-OC43 and HCoV-HKU1 are pathogens of common cold. During 2002-2003, a new coronavirus, the SARS-CoV, was found to be the cause of an acute, severe frequently fatal respiratory disease with prominent systemic symptoms (severe acute respiratory syndrome). The outbreak originated in southern China, probably following transmission from an animal in animal markets or bats to humans. In 2012, some cases of novel coronavirus infection were reported in Arabian Peninsula with pneumonia and acute kidney injury. This novel coronavirus has been named Middle East respiratory syndrome coronavirus (MERS-CoV). The virus probably has come from camels and bats. I describe here about coronaviruses that have wide disease spectrum, from common colds to severe fatal illness as emerging infectious diseases.

The public have been lied to by Dr. Anthony Fauci and Dr. Deborah Birx and led to believe they are going to die, if they do not do what the CDC and WHO tells them. Six years earlier, Dan Butler (1955-2018) wrote a piece predicting a media driven pandemic campaign that would be used to strip us of our Constitutional rights. Into this mix, I add here a quick summary of coup d'états from noted historians Nesta Webster, Antony Sutton, Aleksandr Solzhenitsyn, and many others. Communist coup d'états all begin with a Reign of Terror:

- The French Revolution opened its Reign of Terror by publicly guillotining aristocrats, government officials, and priests. After decapitation, their heads were placed on spikes and paraded through the streets of Paris. Unable to think, Parisians were traumatized, paralyzed, and helpless.

These Zionist communist revolutions happened well before the rise of our present modern media establishment. Almost more baffling than the illness will be the fact that it will suddenly vanish as quickly as it arrived, attack again ten years later and then vanish completely."*

More recently, the movie *Contagion* dramatized the rapid progress of a lethal airborne virus that kills within days. As the fast-moving epidemic grows, the worldwide medical community races to find a cure while controlling the panic that spreads faster than the virus itself. In the movie, ordinary people struggle to survive in a society coming apart. The movie was and is "Predictive Programming".

What really grabbed my attention, however, was that Dan Butler (nom de plume Richard Evans) predicted the current Coronavirus reign of a terror campaign in 2014. (See: *Ebola - Another Illuminati Psy Op?*)

Dan was light years ahead in his recognition of MSM's use of Predictive Programming. Amazingly, Dan even foretold the legal concept that would be used" EXECUTIVE ORDER 13295. In 2005, President George W. Bush asked, *"If we had an outbreak somewhere in the United States, do we not then quarantine that part of the country? And how do you, then, enforce quarantine?"*

As reported way back in the first issue of Gizmo, US-based Digital Angel has produced the VeriChip, an implantable computer chip which monitors human biometric functions and transmits the data with GPS technology. The VeriChip has been approved since 2004 for human medical use by the Food and Drug Administration (FDA) of America, opening up the age of implantable technology.

The VeriChip system is already being used in a variety of innovative solutions, including monitoring the vital stats of at-risk patients, farm animal management systems, locating stolen property, managing commodity supply chains, monitoring the location of parolees and providing a tamper-proof means of identification for enhanced e-commerce security.

The FDA's green light of the VeriChip will help doctors access stored medical information about their patients and speed delivery during medical emergencies. The chip itself does not contain medical records but an access code that can be scanned and revealed by a hand held scanner. VeriChip is not an FDA-regulated device with regard to its security, financial, personal identification or safety applications.

The VeriChip Health Information Micro-transponder System consists of an implantable RFID micro-transponder, an inserter, a proprietary hand-held scanner, and secure database containing the patient approved healthcare information. About the size of a grain of rice, VeriChip is a subdermal radio frequency microchip. Once inserted under the skin in a brief outpatient procedure, the VeriChip cannot be seen by the human eye. Each VeriChip contains a unique 16-digit verification number that is captured by briefly passing a proprietary scanner over the insertion site. The captured 16 digit number links to the database via encrypted Internet access. The previously stored information is then conveyed via the internet to the registered requesting healthcare provider.

With the VeriChip invisible to the naked eye, health care workers may soon have to scan unconscious patients as part of the normal hospital routine. The company hopes the VeriChip will be utilized by patients suffering from ailments like Alzheimer's and diabetes or who undergo intensive treatments like chemotherapy and need constantly updated medical data. Implantation of the VeriChip is expected to cost between US \$150 to \$200 and takes less than twenty minutes. That cost has been gradually declining with the passing of time.

Microsoft, the ID2020 Alliance, universal digital identification and you has been on the front burner to bring you universal identity. In 2017 Microsoft joined ID2020, a global Alliance whose goal is to create universal digital identities for everyone. What are the social, economic and ethical implications of such an initiative?



Our digital activity increasingly parallels our real-world activity. Participation in the modern economy, the ability to buy and sell, attain employment, healthcare, social services and more are virtually impossible without a digital identity. In May of 2016, at the United Nations Headquarters in NY, ID2020, an alliance of governments, non-profits, academia, over 150 private sector companies and 11 United Nations agencies collaborated on how to provide a unique digital identity to everyone on the planet.



Most coverage of the ID2020 Alliance focuses on its noble objective to provide digital identities to the over one billion refugees, women, children and others without *any* form of identification. The message of providing digital identification for this "invisible" portion of the earth's population to enable their participation in society places a human face over the true mission. It also creates a rallying point that this open alliance hopes other entities will, like Microsoft, embrace and become a part of this global effort.

The fundamental mission of creating a universal identification system that incorporates every person on the globe, using modern technology and the support of various governments, financial institutions and more is the goal hidden behind the humanitarian cause.

### **The ID2020 Alliance and its 2030 goal**

According to the Alliance's Governance material "by 2030 it aims to have facilitated the scaling of a safe, verifiable, persistent digital identity system, consistent with the Sustainable Development Goals" agreed upon by the United Nations." Its short-term focus toward that goal is the development and testing of the best technological solutions for digital identity; and working with governments and other entities in their implementation. The focus on the 1.5 billion people without identification is part of that short-term vision.

The long-term vision revolves around the Alliances "Case for Action" which states a convergence of trends provides an unprecedented opportunity to make a coordinated, concerted push towards the goal of universal digital identity. Those trends include

political accord among United Nations members, growing global connectivity, emerging technologies and global calls for a new model of identity.

- **Political Unity:** In 2015 all United Nations countries made a global commitment to provide legal identity for everyone by 2030.
- **Global connectivity:** Smart device proliferation allows new registration methods and enables consistent interaction with identity data.
- **Emerging technology:** Block-chain technology, like that used with Bitcoin, and into which Microsoft has invested to create a decentralized id (DID) make secure and verifiable tech accessible to the masses.
- **New Identity Model:** Consumers want a seamless and secure digital experience.



Microsoft, in a recent announcement regarding using blockchain technology for decentralized identification further articulated its support of this initiative stating, "Each of us needs a digital identity we own, one which securely and privately stores *all* elements of our digital identity."

### **Microsoft, blockchain and universal ids**

In its announcement confirming its position as a founding member of the ID2020 Alliance Microsoft shared that it, developers and Alliance partners would be collaborating on a blockchain-based, open source identity system. This system would allow interoperability of people, apps, products and services across cloud providers, other blockchains and organizations.

Microsoft's goal is to help establish universal and scalable standards for these decentralized digital identities using blockchain technology. In a blockchain information exists as a shared database that is consistently reconciled. Blockchain data doesn't exist in a centralized location but is hosted on millions of computers across the internet. The Alliance is using this secure and virtually "unhackable" system to create a decentralized identity framework for the world's population.

If blockchains sound familiar, they should. Wallet apps like those used to buy things with popular cryptocurrencies like Bitcoin are the user interface most people associate with blockchain technology. This technology has secure identity management at its core. It is upon this tech that Microsoft and the Alliance are evolving applications for global identity management.

**This is about a global community and economy**



Mobile technology is becoming increasingly important as a tool for proof-of-identity in various transaction scenarios including buying and selling merchandise online or in person, using mass transit, opening hotel room doors, participating in amusement parks and much more. Our smartphones are currently the primary portal intricately interweaving our digital identities with our physical world.



Understanding this, the GSMA, an alliance of nearly 800 mobile operators, [is seeking to simplify SIM card registration](#) by promoting flexible approaches towards proof-of-identity requirements for forcibly displaced people so they can access mobile services, SIM-based energy services and wallets.

This onboarding of even the disenfranchised onto the digital landscape is paramount to the ID2020 Alliance's goal to provide a universally accepted identification system for everyone on the planet. It is important to note this identification system's objective is to create the foundation to unify the world's citizen's participation in a global community and universal digital economy. Secure and verifiable identity, as with any digital transaction, is foundational to this vision.

### **Obvious concerns**

The alliance stresses that digital identity is the cornerstone of international development and believes a digital identity should be with a person from birth to death. This objective being pursued by a global collaborative raises many ethical concerns.

As the digital landscape becomes more pervasive, the lines between the physical and real world continue to blur. If the lack of a digital identity under the current paradigm limits participation in the modern economy, the lack of the same under a singular globally recognized system could prevent participation entirely.

If the Alliance's goal is a globally recognized digital identity for everyone from birth to death, will that become a global mandate? How will it be enforced and by whom? What happens to those individuals who are unwilling to participate? Will they be persecuted? And how will the implementation of identification evolve with technology beyond smartphones? Will wearables, implants like those being used in Swedish subways or some form of digital tattoo become the norm?

As more and more transactions become digital in nature and are built around a single global identification standard, supported by Microsoft, the question of who will govern this evolving global community and economy becomes relevant. Especially since nonparticipants in this system would be unable to buy or sell goods or services. We may earn a commission for purchases using their links.

For weeks, talking heads have been promoting the liability-free vaccine(s) that will save the world—so Bill Gates and Tony Fauci proclaim—from what Gates has now dubbed “Pandemic I.” As Microsoft News peddles self-congratulatory stories about the Gates Foundation’s reorientation of its priorities to devote “‘total attention’ to the pandemic,” Fauci—making the rounds of talk shows—pledges that a vaccine will make its debut in January 2021. Not to be outdone, the White House has now unveiled “Operation Warp Speed”—a joint pharmaceutical-government-military effort aimed at “substantially shrinking the development time for a vaccine”—and President Trump promises one by the end of the year.

Planet-wide COVID-19 vaccination—the overt objective that has all of these players salivating in anticipation—ignores a number of irrefutable obstacles. For one, the RNA virus being targeted, SARS-CoV-2, already “has mutated into at least 30 different genetic variants.” The variants include 19 never seen before as well as “rare changes that scientists had never imagined could happen.” Knowledge about these mutations may prove useful to clinicians wanting to better tailor their COVID-19 treatments, but the proliferation of mutations makes the chances of developing an effective vaccine immensely more uncertain. This ignores the reality of a bio-engineered bio-weapon that was introduced with the Wuhan released virus.

Not to worry, say the entities funded by Gates (and also the Pentagon). Scientists working in the burgeoning field of synthetic biology are confident that they can “outdo” and outsmart nature using next-generation vaccine technologies such as gene transfer and self-assembling nanoparticles—along with invasive new vaccine delivery and record-keeping mechanisms such as smartphone-readable quantum dot tattoos. Does it matter that the researchers who have been experimenting with these approaches have never been able to overcome “nasty side effects”? Apparently not! Aided and abetted by the generous Gates and military funding, high-fanfare COVID-19 vaccine planning is proceeding at a quick pace.

Researchers reiterated this point ... that for most emerging virus vaccines, the main obstacle is not the effectiveness of conventional approaches but the need for more rapid development and large-scale deployment. Speed, not safety!

From a manufacturing standpoint, vaccine makers—and particularly those making viral vaccines—have long chafed at the limitations of traditional vaccine technologies, which rely on processes that necessarily entail “a considerable lag time between antigen production and vaccine delivery.” Researchers reiterated this point again in 2018, writing in *Nature Reviews Drug Discovery* that “for most emerging virus vaccines, the main obstacle is not the effectiveness of conventional approaches but the need for more rapid development and large-scale deployment.”

In the 1980s, manufacturers were elated when scientists developed new genetic engineering techniques (recombinant DNA technology) that—through the use of “expression systems” (bacteria, yeast, insect cells, mammalian cells or plants such as tobacco)—made it possible to jumpstart vaccine production and produce so-called “subunit vaccines.” The hepatitis B vaccine was the first to employ this “entirely new” vaccine production approach, and a number of the COVID-19 vaccines currently in the works are deploying these techniques. However, a complicating factor of subunit vaccines is that they must be bundled with “immuno-potentiating” adjuvants that tend to trigger an imbalanced immune response.

Desirous of streamlining vaccine technology still further and enabling vaccine stockpiles in an even shorter time frame, researchers began tinkering in the mid-1990s with nucleic acid vaccines, which include DNA vaccines and messenger RNA (mRNA) vaccines. As a form of gene therapy, both represent a significant departure from

classical vaccines. Whereas the latter introduce a vaccine antigen to produce an immune response, nucleic acid vaccines instead send the body instructions to produce the antigen itself. As one researcher explains, the nucleic acids “cause the cells to make pieces of the virus,” with the goal being that the immune system then “mounts a response to those pieces of the virus.”

Researchers quickly learned that both the DNA and mRNA vaccine options have serious downsides, and as a result, vaccines of this type have never been licensed. Nonetheless, almost one-fourth (20/83) of the vaccines listed by the World Health Organization as COVID-19 “candidate vaccines” as of April 23—including two of the leading contenders—are DNA (Inovio) or mRNA (Moderna) vaccines.

DNA vaccines, by definition, come with the risk of integration of exogenous DNA into the host genome, which may cause severe mutagenesis and induced new diseases.

DNA vaccines are intended to penetrate all the way into a cell’s nucleus. According to one biotech scientist, *“This is an incredibly difficult task given that our nuclei have evolved to prevent any foreign DNA from entering (Think viruses!).”* Not surprisingly, then, when some DNA vaccines made it into clinical trials in the late 2000s, they were plagued by “suboptimal potency.” Scientists then came up with the idea of solving this problem by augmenting vaccine delivery with “electroporation”—electric shocks applied to the vaccine site (using a “smart device”) to make cell membranes more permeable and force the DNA into the cells. The improvements in vaccine efficacy were significant enough that electroporation remains a key design feature of some COVID-19 vaccine candidates today, including the Moderna vaccine that is now speeding toward Phase 2 clinical trials.

A second aspect of DNA vaccines—their gene-altering properties—is even more troubling and remains unresolved. DNA vaccines, by definition, come with the risk of “integration of exogenous DNA into the host genome, which may cause severe mutagenesis and induced new diseases.” Framed in more understandable terms, “disruption from DNA is like inserting a foreign ingredient in an existing recipe, which can change the resulting dish.” The permanent incorporation of synthetic genes into the recipient’s DNA essentially produces a genetically modified human being, with unknown long-term effects. Speaking of DNA gene therapy, one researcher has stated, “Genetic integrations using viral gene therapies . . . can have a devastating effect if the integration was placed in the wrong spot in [the] genome.” Discussing DNA vaccines specifically, the Harvard College Global Health Review elaborates:

Potential side effects could include chronic inflammation, because the vaccine continuously stimulates the immune system to produce antibodies. Other concerns include the possible integration of plasmid DNA into the body’s host genome, resulting in mutations, problems with DNA replication, triggering of autoimmune responses, and activation of cancer-causing genes.

Because mRNA vaccines are “particularly suited to speedy development,” it is perhaps unsurprising that they are attracting attention as the “coronavirus frontrunners.” mRNA vaccines can reportedly generate savings of “months or years to standardize and ramp up . . . mass production.” Making lemonade out of lemons, insiders casually state that “while no mRNA vaccine has ever been licensed, the threat of a pandemic is a great incentive to accelerate their progress.”

Companies are enamored of the mRNA approach despite observations that the large mRNA molecules are “intrinsically unstable,” “prone to degradation” and may over activate the immune system. On the plus side, from vaccine scientists’ standpoint, mRNA vaccines need only reach the cell cytoplasm rather than the nucleus—an apparently “simpler technical challenge”—although the approach still demands “delivery technologies that can ensure stabilization of mRNA under physiological conditions.” Formulations such as Moderna’s mRNA-1273 vaccine tackle these challenges by using “chemical modifications to stabilize the mRNA” and liquid nanoparticles to “package it into an injectable form.”

mRNA approaches seem to attract researchers with a highly mechanistic view of human beings. One such individual praises mRNA for its “inherent ‘programmability,’” stating “Much like [a] computer [operating system], mRNA therapy can reprogram [one’s] body to produce its own therapies” [emphasis in original]. The CEO of Moderna describes mRNA approaches—which use “custom-built” strands of mRNA to “turn the body’s cells into ad hoc drug factories”—as being “like software: You can just turn the crank and get a lot of products going into development.” Likewise, the journal *Nature* (commenting on mRNA technology from “a biotech and industrial perspective”) enthuses that the approach “allows rapid refinement with almost limitless combinations of derivatives.”

Vaccine researchers familiar with both DNA and mRNA vaccines like to play up mRNA vaccine safety, citing the fact that the vaccines do not have to penetrate the cell nucleus. However, with years of mRNA vaccine experimentation behind them, none of these researchers has yet achieved licensure. Why? One answer may be that in preclinical studies, mRNA vaccines have displayed an “intrinsic” inflammatory component that makes it difficult to establish an “acceptable risk/benefit profile.” mRNA enthusiasts admit that there is, as yet, an inadequate understanding of the inflammation and autoimmune reactions that may result. This raises many questions about what will happen if regulators grant the manufacturers of COVID-19 mRNA vaccines their wish for “a fast-track process to get mRNA vaccines to people sooner.”

Racing toward profits is the primary motivation in all of this effort to bring the world a perfect vaccine. Bill Gates was exposed for offering a \$10-million bribe to a May 4<sup>th</sup>, 2020 news report.

The story began in January 2018, when Bill Gates pledged USD \$45 million to the health initiative in Burkina Faso. Some felt that the funds were a decoy to cover bribery to top government officials for allowing the program to release the [GMO mosquitoes](#) in Burkina Faso. The GMO mosquitoes were programmed at Imperial College London under a grant from Bill Gates to sterilize natural mosquitoes and humans across the African continent over time.

Fast forward to 2020, when “bad news about the coronavirus is good news for Moderna stock.” Other biopharma companies formerly on the skids are likewise poised to make record profits from COVID-19.

As biopharma pursues its unfettered, medical-ethics-be-damned race toward a COVID-19 pot of gold, the public needs to take a critical look at the industry's disincentives for safety and also take a firm stand against the horrifying prospect of coronavirus vaccine mandates.
