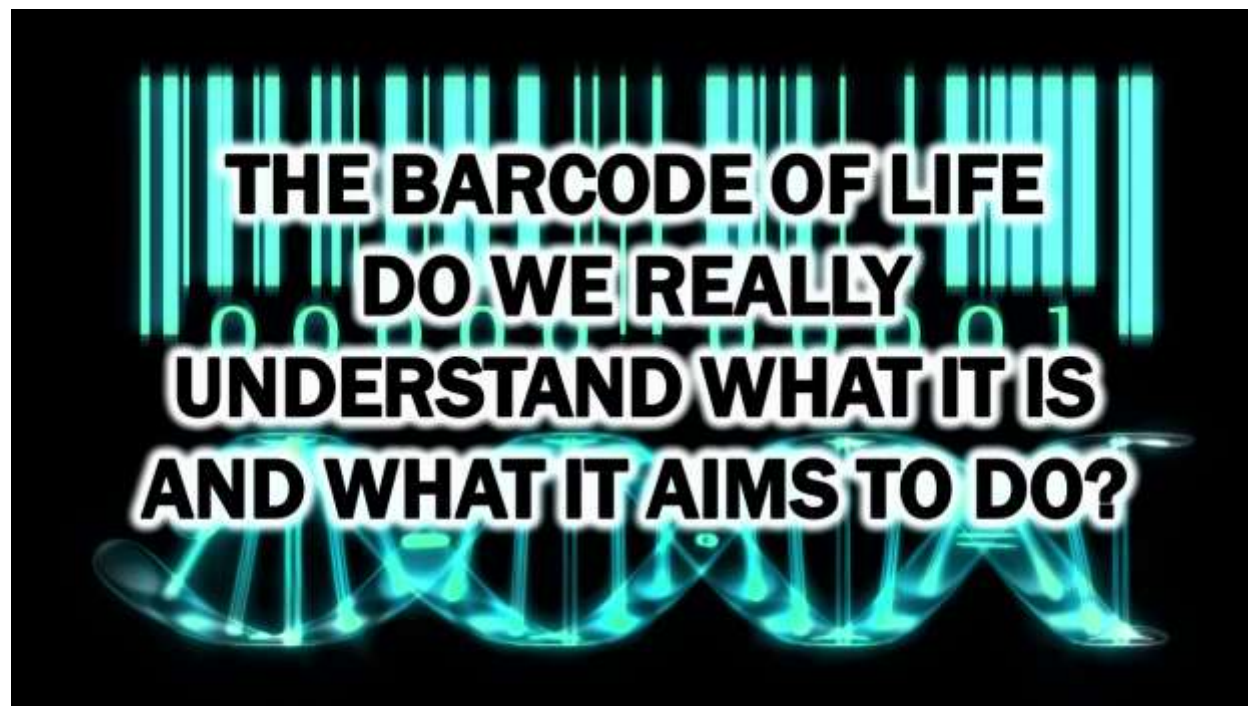

So, what do they mean and have any of us asked what IBOL is really about?

Celeste Solum, a former [FEMA](#) operative, has done extensive research into IBOL, how it fits into the bigger picture and what it means for us and our world. At the time of her interview the World Economic Forum (“WEF”) was having their [Pioneers of Change Summit](#) which is relevant as it demonstrates how an overarching plan is unfolding. In fact, anyone going to the WEF web site is blown away with the many levels of the New World Order Plan. The WEF web site confirms this has been in the works for years, perhaps decades.

Celeste Solum begins her interview with this statement, “Anyone who has taken a Covid test – they have placed a magnetic beacon – you have been tagged, you have been barcoded. Firstly, are the three Asilomar Conferences.

In the first Asilomar Conference. In the early 1970s scientists were only just learning how to manipulate DNA from various sources into combinations that were not known to exist naturally. Scientists who were concerned about this new line of experimentation called for a worldwide moratorium on the work, followed by an international conference of experts at which the nature and magnitude of the risks could be assessed. The conference, held in 1975, became known as *The Asilomar Conference on Recombinant DNA*. It was agreed that the research should continue but under stringent guidelines.

The second Asilomar Conference. In 2010, *The Asilomar International Conference on Climate Intervention Technologies*, was held where 200 scientists gathered in an attempt to determine how research into geoengineering should proceed. What emerged from the conference were some unexpected lessons about the possibilities and pitfalls of manipulating the earth’s climate to offset global warming.

The third Asilomar Conference. In 2017, [The Asilomar Conference on Beneficial AI](#), brought more than 100 thought leaders and researchers in economics, law, ethics, and philosophy together to address and formulate principles of beneficial AI. Its outcome was the creation of a set of guidelines for AI research – the [23 Asilomar AI Principles](#).

Secondly, there is IBOL

IBOL is a Rockefeller initiative which aims to barcode and tag all life. The Rockefeller University describes The Barcode of Life as “a short DNA sequence, from a uniform locality on the genome, used for identifying species;” and, DNA barcoding as “an emerging global standard for identifying species.”

[The Consortium for the Barcode of Life \(“CBOL”\) is an international initiative devoted to developing DNA barcoding as a global standard for the identification of biological species.](#) CBOL has more than 29,000 users, and 130 member organizations from more than 200 countries. It has on file 720,869 Barcode Index Numbers Species Proxies.

The Barcode of Life Data System is designed to support the generation and application of DNA barcode data. It is part of IBOL goal to tag and identify all life forms. It currently has on file 9,454,552 DNA Barcodes in its library.

They are changing the practice and science of taxonomy. Taxonomy is the science of naming, describing and classifying organisms and includes all plants, animals and microorganisms of the world.

Since ancient times, life on earth was classified by the Linnaean system where living organisms are classified into groups depending on their structure and characteristics. This system was developed in the 18th century by Carl Linnaeus. Although Linnaeus is now considered the father of taxonomy, his success rested on the work of his predecessors. So, the Linnaean system actually dates back to the time of Aristotle, possibly earlier, where life is classified in taxonomical rank, in groups, within a hierarchy.

To accommodate a plethora of new species – aliens, reanimation of extinct species and entities, genetically modified organisms, and synthetic biology – a new system was coined by Julian Huxley in 1957 – one based on [clade](#) instead of rank. The idea of “a clade” did not exist before Charles Darwin and his evolutionary taxonomy. It’s unlikely that Johns Hopkins was unaware of the implications when they named a 2018 pandemic tabletop exercise “[Clade X](#)”. A clade consists of an organism and all of its descendants. For example, the shared ancestor of apes and that entire species-descendant species would comprise a “clade.” The term “clade” comes from the Greek “*klados*,” for “branch.” It’s useful to think of a clade as being one “branch” on the tree of life, where the common ancestor is the place that the branch split from the main trunk.

What *Clade X* revealed was that a committee had spent ten years making a new classification for life called the [PhyloCode](#). *“In the Linnaean system a human was a human, a bird was bird, and a reptile was a reptile – everybody could clearly see it, it was common sense. The PhyloCode makes room in the tree to mix and match: for lots of hybrids, synthetics, demons, spirits, synthetic life forms, aliens, whatever new species they knew was going to be in a [cosmic ray high](#) – which we are in right now – which tends to mutate all life forms. They knew this was coming because it is on a cycle. It was on a 12,000-year cycle,”* Celeste Solum explained. She goes on to say if anyone wants to learn what the government knows about the mutation of all life there is a book, *‘The Adam and Eve Story’*, written by a CIA agent. This book was declassified approximately three years ago, *“you can find the sanitized version of this story at the CIA Reading Room,”* Celeste Solum said.

In another article I shared the once held CIA secret, the fact that the Sun Nova's every 12,068 years. Since we are just 25 years away there is a grand plan to catalog every living thing. A Nova of the Sun will occur in 2046.

Deep in the bowels of an icy mountain on an island above the Arctic Circle between Norway and the North Pole lays a resource of vital importance for the future of human-kind. It's not coal, oil or precious minerals, but seeds.

Millions of these tiny brown specks, from more than 930,000 varieties of food crops, are stored in the Global Seed Vault on Spitsbergen, part of Norway's Svalbard archipelago. It is essentially a huge safety deposit box, holding the world's largest collection of agricultural biodiversity. "Inside this building is 13,000 years of agricultural history," says Brian Lainoff, lead partnerships coordinator of the Crop Trust, which manages the vault, as he hauls open the huge steel door leading inside the mountain. Secretly, this seed vault is intended to restart human life form after the Sun Nova's in 2046, and the next ice age melts. The problem is that might be as long as a thousand years after the Sun melts the forecasted 4,000-ft. of ice that will cover the Earth.



The PhyloCode has rearranged classifications. Humans are in the same family as arthropods, dinosaurs and birds. *It mixes and matches and makes no sense. But this is by design because with genetic modification they are mixing the species like crazy. No longer will any life from be pure. Their goal is to taint every single life form,* Solum said. And, why would they do that? Because they cannot patent something from the "old world", in other words natural life forms, Solum said, they can only patent a new life form.

The nations unite under one code

The World Organization for Animal Health (“OIE”) is essentially the United Nations (“UN”) management of life on earth. There is a Terrestrial Animal Health Code (“TAHC”) in which humans are included as animals. There is also an Aquatic Animal Health Code dealing with life under the sea.

From OIE’s “Codes and Manuals” landing page, select “Terrestrial Manual” from the left-hand side menu, and surprisingly it opens a page titled “*Manual of Diagnostic Tests and Vaccines for Terrestrial Animals.*” It states the manual “*aims to facilitate international trade in animals and animal products and to contribute to the improvement of animal health services world-wide.*” Either of the previous statements on their own is bizarre but it becomes alarming considering the TAHC includes humans as animals.

The UN’s Food and Agriculture Organization (“FAO”) has a manual, “Stamping Out”, which outlines how to dispose of animals for disease eradication. It gives procedures of how to dispose of different species using, for example, firearms and gaseous or injectable agents. Although it does not mention the human species, we must remember the TAHC includes humans as animals. At the moment the medical codes, which were renewed in the last couple of years, permit humane killing by gassing, guillotine or being stabbed by a sharp object such as a syringe. And doctors will get paid for it.

According to Solum, there are military documents which distinguish between the “old humans” and the “new humans.” The UN’s Agenda 21, and its successor [Agenda 2030](#), has been brought forward. It sounds like science fiction?

For the sake of brevity, let us consider only a few of the things we already know. Keep in mind only a fraction of the technological advancements and what is already in play is in the public domain, and new pieces of the puzzle are “coming out” all the time.

Transhumanism. According to the UK government, [The Fourth Industrial Revolution “is characterized by a fusion of technologies – such as artificial intelligence, gene editing and advanced robotics.”](#) In other words, it is characterized by transhumanism. According to the Chicago Council on Global Affairs, and as a basis of an event in May 2019, [The Fourth Industrial Revolution had already begun](#). One speaker at the event was Klaus Schwab, Founder and Executive Chairman of the WEF.

Klaus Schwab has said: The Fourth Industrial Revolution will [“lead to a fusion of our physical, digital and biological identity,”](#) Chicago Council on Global Affairs, May 2019

New life forms. In 2010, Dr. Craig Venter created the world’s [first synthetic life form](#). In January 2020, a research team of roboticists and scientists published their recipe for making a new lifeform called [xenobots](#). [In 2019, a Spanish scientist claimed to have grown the world’s first-ever human-monkey hybrid](#). Covid-19 was a “synthetic” virus, and you need to understand what that means. It was created on a computer screen! You might consider it like when you last took your vehicle to the garage for an oil change, you may have switched from petroleum-base engine oil to the synthetic oils. Synthetic engine lubricants began in 1929 but only became popular in the last few decades. The future is all about the “new” or “synthetic” life form.

Advancement of technologies. [Neuro technologies are based on various tools](#) to access and affect structures and functions of the brain that may be involved in cognition, emotion and behaviors. And they are far more advanced than we can imagine. In 2021, [tiny robots](#) were developed that would precisely deliver drugs to the central nervous system. And, a quick browse of a 2001 NASA document, [‘Future Strategic Issues/Future Warfare \[Circa 2025\]’](#), reads like science fiction. [As does a Pentagon briefing in 2005 regarding a project to develop a “virus” or “vaccine”, by targeting an area in the brain, against religious fundamentalism.](#)

In 2005, a Pentagon briefing was held by an unknown scientist on removing the so-called “god gene” – “Funvax” A leaked cell phone video shows Bill Gates doing a presentation on the “Funvax”.

Covid technologies deployed. [Graphene has been found in Covid injections and in face masks.](#) Once integrated with neuron cells graphene oxide nanoparticles act as nano biosensors which have two functions, namely: collect electrical signals of our impulses and thoughts or brain mapping; and, neuro-modulate our behaviors, emotions and feelings.

A scientific study has confirmed that [mRNA can alter your DNA.](#) The Pfizer/BioNTech and Moderna “vaccines” are RNA injections, these transfect their RNA into the cytoplasm of our cells. Through a process called reverse-transcription, injected RNA integrates into our DNA. The Oxford/AstraZeneca and Johnson & Johnson “vaccines” are DNA, or viral vector, injections, which transfect DNA into the nucleus of our cells. The bottom line is to “upgrade” or change your God-given DNA.

Do Celeste Solum’s claims seem so outlandish now?

Completed in April 2003, the Human Genome Project (HGP) gave us the ability to read nature’s complete genetic blueprint for a human. On April 14, 2003, the International Human Genome Sequencing Consortium announces the successful completion of the Human Genome Project. This was more than two years ahead of schedule. [As I noted, the Covid-19 virus was created for the Vaxx.](#) It was the only way the powers at be could get a world population to take a Vaxx for something unknown and labeled as a pandemic sufficient enough to scare people into thinking Covid-19 was like AIDS or Ebola. These people began an earnest attempt to get people to provide their DNA through promoting the idea you might be a relative of a famous person in history. Since about 2015, DNA testing kits were being offered to the public. “23 and Me” sells a DNA kit for \$99.

“Simply provide your saliva sample from home. Mail it back to our lab in the same kit it came in—the postage is pre-paid. We bring your genetics to you!”

It really sounded good until I was reading reports that “23 and Me” were sharing their samples with the FBI, who have other reasons for wanting people’s DNA. [What many thought to be a lark and fun to learn if they were related to a famous person, really had nefarious objectives piggybacked onto those DNA samples.](#)

This international effort to sequence the 3 billion DNA letters in the human genome is considered by many to be one of the most ambitious scientific undertakings of all time, even compared to splitting the atom or going to the moon.

[The finished sequence produced by the Human Genome Project covers about 99% of the human genome’s gene-containing regions, and it has been sequenced to an accuracy of 99.99%.](#) In addition, to help researchers better understand the meaning of the human genetic instruction book, the project took on a wide range of other goals,

from sequencing the genomes of model organisms to developing new technologies to study whole genomes.

Besides delivering on the stated goals below, the international network of researchers has produced an amazing array of advances that most scientists had not expected until much later. These "bonus" accomplishments include: an advanced draft of the mouse genome sequence, published in December 2002; an initial draft of the rat genome sequence, produced in November 2002; the identification of more than 3 million human genetic variations, called single nucleotide polymorphisms (SNPs); and the generation of full-length complementary DNAs (cDNAs) for more than 70 percent of known human and mouse genes.

It's been 20 years since scientists published the first draft of the human genome. Since its launch in the 90s, the HGP fundamentally altered how we understand our genetic blueprint, our evolution, and the diagnosis and treatment of diseases. It spawned famous offspring, including gene therapy, mRNA vaccines, and CRISPR. It's the parent to HGP-Write, **a global consortium that seeks to rewrite life.** What we have been put through the past 22-months has everything to do with the "rewriting of life."

Yet as genome sequencing costs and time continue to decline, the question remains: what have we actually learned from the HGP? After two decades, is it becoming obsolete, with a new generation of genomic data in the making? And with controversial uses such as designer babies, human-animal chimeras, organs-in-a-tube, and shaky genetic privacy, how is the legacy of the HGP guiding the future of humanity? Science has advanced to the point now that rivals the Creator's role referred to in Isaiah 14:13-14. Man now controls the creation process!

"For thou hast said in thine heart, I will ascend into heaven, I will exalt my throne above the stars of God: I will sit also upon the mount of the congregation, in the sides of the north: ¹⁴I will ascend above the heights of the clouds; I will be like the most High."

In a special issue of 'Science', scientists across the globe took a deep dive into the lessons learned from the world's first biomedical moonshot. *"Although some hoped having the human genome in hand would let us sprint to medical miracles, the field is more an ongoing relay race of contributions from genomic studies,"* wrote 'Science' senior editor Laura Zahn.

Decoding, reworking, and potentially one day augmenting the human genome is an ultra-marathon, buoyed by potential medical miracles and fraught with possible abuses. China has stated their plans to create "super soldiers" through "synthetic biology."

"As genomic data and its uses continue to balloon, it will be critical to curb potential abuse and ensure that the legacy of the HGP contributes to the betterment of all human lives," wrote Drs. Jennifer Rood and Aviv Regev at Genentech in a perspectives article for the issue.

An Apollo Program to Decode Life

Big data projects are a dime a dozen these days. A global effort to solve the brain? Yup. Scouring centenarians' genes to find those that lead to longevity? Sure! Spitting in a tube to find out your ancestry and potential disease risks—the kits are on sale for the holidays! Genetically engineering anything—from yeast that brew insulin to an organism entirely new to Earth—been there, done that!

These massive international collaborations and sci-fi stretch goals that we now take for granted owe their success to the HGP. It's had a profound effect on biomedical research.

Flashback to the 1990s. "Pulp Fiction" played in theaters, Michael Jordan owned the NBA, and an international team decided to crack the base code of human life.

The study arose from years of frustration that genetic mapping tools needed better resolution. Scientists could roughly track down a gene related to certain types of genetic disorders, like Huntington's disease, which is due to a single gene mutation. But it soon became clear that most of our toughest medical foes, such as cancer, often have multiple genetic hiccups. With the tools that were available at the time, solving these disorders was similar to debugging thousands of lines of code through a fogged-up lens. **The disorder known as Huntington's disease is where genetics and I became forever a student of genetics.** In 1966, my wife was expecting our first child and was experiencing epileptic seizures and after a series of tests was subsequently diagnosed with Huntington's disease. **Since that turning point in my life, I have been engaged in a life-long study of the Code of Life! I might as well have changed my vocation from that point as genetics has dominated my spare time over the decades since.** My pastor's library contains a significant presence of books on what we refer to as the Code of Life.

Ultimately, the pioneers realized we needed an "infinitely dense" map of the genome to really begin decoding, said the authors. Meaning, we needed a whole picture of the human genome, at high resolution, and the tools to get it. Before the HGP, we were peeking at our genome through consumer binoculars. After it, we got the James Webb space telescope to look into our inner genetic universe.

The result was a human "*reference genome*," a mold that nearly all biomedical studies map onto, from synthetic biology to chasing disease-causing mutants to the creation of CRISPR. Massive global consortiums, including the 1000 Genomes Project, the Cancer Genome Atlas, the BRAIN Initiative, and the Human Cell Atlas have all followed in HGP's steps. **As a first big data approach to medicine, before the internet was ubiquitous, HGP laid out a new vision for collaborative science by openly sharing data from labs across the globe—something Covid-19 vaccines have benefited from.**

Yet as with AOL, CDs, and Microsoft FrontPage, HGP may be a legacy product from a bygone era. I would estimate that I have read four hundred scientific papers on the HGP and related genetic issues.

The Next Generation

The first relatively finished reference genome was published in 2003. Yet two core questions at the heart of the HGP remain. One, what exactly should be considered a “complete reference”? Two, how can it be decoded to benefit humans?

“Reference” is an ambiguous idea in the age of increasingly cheaper genome sequencing. The original reference was what science considered an “average” human. It wasn’t, but the reference genome did focus on mapping the most common variants in a gene. Yet it’s increasingly obvious that humans are wildly diverse in our genetic differences, which could—for example—have a say in our longevity.

“Capturing the ever-growing genetic diversity of humans requires profiling a more diverse set of genomes,” said the authors. “Ultimately, although highly useful, a single reference genome is inherently biased.” Your genealogy results from consumer kits, for example, could be on point or off base, depending on your race and the genetic background of their reference samples. For now, it’s mostly people with European ancestry. I have been asked to provide cheek swaps at least a half-dozen times. I long-ago vowed never to surrender my DNA. The importance of that decision proved a wise decision since every person tested for Covid-19 or submitted to the Vaxxes gave away their individual identity. It is a very complex matter and its importance is not a minor issue since the CCP has been acquiring that data from DNA ancestry agencies.

How exactly do they get this sensitive information? Buying American companies which have DNA profiles, subsidizing DNA analysis for ancestry companies, and hacking. Some 50-million have had their DNA tested. Would you want your DNA or other healthcare data going to an authoritarian regime with a record of exploiting DNA for repression and surveillance? For years, the People’s Republic of China (PRC) has collected large healthcare data sets from the U.S. and nations around the globe, through both legal and illegal means, for purposes only it can control. While no one begrudges a nation conducting research to improve medical treatments, the PRC’s mass collection of DNA at home has helped it carry out human rights abuses against domestic minority groups and support state surveillance. The PRC’s collection of healthcare data from America poses equally serious risks, not only to the privacy of Americans, but also to the economic and national security of the U.S.

The Value of Your DNA

It has designated biotech as a “strategic emerging industry” and prioritized state support for its biotech industry in national plans like the Made in China 2025 plan.
- The PRC understands the collection and analysis of large genomic data sets from diverse populations helps foster new medical discoveries and cures that can have substantial commercial value and advance its Artificial Intelligence and precision medicine industries.
- In 2016, the PRC announced a \$9 billion, 15-year project to collect, analyze, and sequence genomic data to become a global leader in precision medicine—a process designed to provide tailored treatments based on the genetic makeup and environment and lifestyle of individual patients.
- With the COVID-19 pandemic, the PRC aggressively marketed Chinese COVID-19 testing kits around the world, along with laboratories to support COVID-19 testing. By August 2020, China’s leading genomics company, BGI, said it had sold test kits to 180 countries and established labs in 18 countries in the past six months.
- According to the U.S.-China Economic and Security Review Commission, these COVID-19 labs have been providing Chinese researchers with access to healthcare data from around the globe. Despite their aggressive pitches to U.S. states, there is no evidence Chinese companies have been able to establish such COVID-19 labs in the U.S.

China’s Access to U.S. Healthcare Data

- Nevertheless, the PRC has for years been able to gain access to U.S. healthcare data, including genomic data, through a variety of channels, both legal and illegal.
- U.S. healthcare data may be particularly attractive and valuable to China because of the ethnic diversity of the U.S. population. And compared to other nations, the U.S. has fewer safeguards on medical and healthcare data, including data for research purposes.⁶ U.S. safeguards focus primarily on privacy, not national security, which creates vulnerability for foreign actors to gain access to data on U.S. persons.
- Over the years, Chinese companies have taken advantage of this environment by investing in U.S. firms that handle sensitive healthcare and other types of personal data, providing them entry to the U.S. market and access to this data.

- For instance, China's BGI purchased U.S. genomic sequencing firm Complete Genomics in 2013. In 2015, China's WuXi Pharma Tech acquired U.S. firm NextCODE Health to later form WuXi NextCODE Genomics.
- Chinese companies have also gained access to U.S. healthcare data by partnering with hospitals, universities, and other research organizations in America. These U.S. entities routinely seek low-cost genomic sequencing services for their facilities, which Chinese biotech firms can often provide due to Chinese government subsidies. (In February 2020, BGI said it could sequence a human genome for just \$100) These partnerships allow U.S. entities to expand their research capabilities, while Chinese firms gain access to more genetic data on more diverse sets of people, which they can use for new medical products and services.
- A 2019 report found at least 15 Chinese companies that were either headquartered in China with a U.S. presence, or wholly located in China, were licensed to perform genetic testing or whole genomic sequencing on patients in the U.S. healthcare system, giving them direct access to the genetic data of patients in the U.S.
- Finally, the PRC has gained access to U.S. healthcare data through illicit means, including theft of research and cyberattacks.
- Among the most notorious examples was the 2015 hack of U.S.-based health insurer Anthem, Inc., in which data on some 78.8 million persons was stolen from Anthem's computer networks, including health identification numbers, names, Social Security numbers, employment and income data and other information. A U.S. Justice Department indictment in 2019 charged two individuals based in China for the hack of Anthem and three other U.S. companies.

China's History of DNA Exploitation

- Concerns over the exploitation of healthcare and genomic data by the PRC are not hypothetical. **The PRC has a documented history of exploiting DNA for genetic surveillance and societal control of minority populations in Xinjiang, China.**
- Specifically, the PRC government has established a high-tech surveillance system across Xinjiang, as part of a province-wide apparatus of oppression aimed primarily against traditionally Muslim minority groups. An initiative launched by the PRC government in 2014 has been used to justify the collection of biometric data from all Xinjiang residents ages 12 to 65. Authorities have collected DNA samples, fingerprints, iris scans, and blood types. The biometric data is linked to individuals' identification numbers and centralized in a searchable database used by PRC authorities.
- Specific abuses by the PRC government as part of this effort include mass arbitrary detentions, severe physical and psychological abuse, forced labor, oppressive surveillance used arbitrarily or unlawfully, religious persecution, political indoctrination, and forced sterilization of members of minority groups in Xinjiang. All told, the PRC

government in Xinjiang has detained more than 1 million members of Muslim minority groups in internment camps for Communist Party indoctrination since 2017.

- In July 2020, the U.S. Department of Commerce sanctioned two subsidiaries of China's BGI for their role in conducting genetic analysis used to further the PRC government's repression of Uyghurs and other Muslim minority groups in Xinjiang.
- Over the past decade, China's BGI has partnered with many research and healthcare entities in America to provide them with genomic sequencing services, while also gaining access to health records and genetic data on people in the U.S.

Implications for Privacy and U.S. National Security

- China's access to U.S. healthcare and genomic data poses serious privacy and national security risks to the U.S.
- Through its cyber intrusions in recent years, the PRC has already obtained the Personal Identifying Information (PII) of much of the U.S. population.
- Recent breaches attributed to the PRC government or to cyber actors based in China include the theft of personnel records of roughly 21 million individuals from the U.S. Office of Personnel Management; the theft from Marriott hotels of roughly 400 million records; the theft of data from Equifax on roughly 145 million people; and the theft of data from Anthem on roughly 78 million people.
- Furthermore, under the PRC's national security laws, Chinese companies are compelled to share data they have collected with the PRC government. Article 7 of China's 2017 National Intelligence Law, for instance, mandates that all Chinese companies and citizens shall support, assist, and cooperate with Chinese national intelligence efforts, and guard the secrecy of any national intelligence work that they are aware of. There is no mechanism for Chinese companies to refuse their government's requests for data.
- The combination of stolen PII, personal health information, and large genomic data sets collected from abroad affords the PRC vast opportunities to precisely target individuals in foreign governments, private industries, or other sectors for potential surveillance, manipulation, or extortion.
- For instance, vulnerabilities in specific individuals revealed by genomic data or health records could be used to help target these individuals.¹⁸ Data associated with an embarrassing addiction or mental illness could be leveraged for blackmail. Combine this information with stolen credit data indicating bankruptcy or major debt and the tools for exerting leverage increase. Such data sets could help the PRC not only recruit individuals abroad, but also act against foreign dissidents.

Economic Implications for the United States

- Aside from these immediate privacy risks, China's access to U.S. health and genomic data poses long-term economic challenges for the United States.
- The PRC's acquisition of U.S. healthcare data is helping to fuel China's Artificial Intelligence and precision medicine industries, while the PRC severely restricts U.S. and other foreign access to such data from China, putting America's roughly \$100 billion biotech industry at a disadvantage.
- Over time, this dynamic could allow China to outpace U.S. biotech firms with important new drugs and health treatments and potentially displace American firms as global biotech leaders.
- Although new medicines coming out of China could benefit U.S. patients, America could be left more dependent on Chinese innovation and drug development for its cures, leading to a transfer of wealth, co-opting of new businesses and greater job opportunities in China.

"The HGP and its legacy must serve humanity as a whole, not neglecting those who are currently underrepresented in biological research," the team said.

Then there's making sense of it. The HGP itself decoded the genome but didn't provide an understanding of it - such as what genetic elements actually do, how they work together, and how they contribute to health and disease.

We're getting there, but slowly. We've found genes that protect against Alzheimer's, and genes that contribute to cancer and muscle disorders. Using a popular method called GWAS (genome-wide association study), scientists are increasingly capable of fishing out gene variants - often hundreds at a time - that play a role in more complex disorders such as autism. But teasing out how bucket loads of genes affect any disease remains difficult. With the rise of machine learning and AI, however, the authors said, we have a powerful tool to begin *"unpacking its secrets to affect health."* This information works both ways, positive or negative.

What's next? Thanks to ongoing massive whole genome sequencing projects, we could be shedding the veil of HGP's "average" human and entering a new era of multiple reference genomes - or *even personalized ones*. With this would come massive concerns around privacy. The Golden State Killer case, though it had a "happy" ending in that it was ultimately solved, relied on a free and public genealogy database that people may not have knowingly agreed to partake in. Unexpected findings related to long-lost relatives, or paternity issues, a high risk of serious diseases, or our own heritage, especially if shared with third parties, could damage relationships or even overthrow our sense of self. *Consider how insurance companies can use such information to preclude an individual from obtaining life insurance or be disqualified from employment based upon your genetic profile, or require higher insurance premiums for said insurance coverage.*

From the idea of a reference genome to a smorgasbord of genetic tools, HGP's legacy is here to stay. As we move towards a more "snowflake" era of genomics—one that stresses individuality either for mixed-and-matched groups or individuals—the original goal remains the same.

The project left us with a major mission, still relevant even 20 years later, and the authors said. *We need to better understand how to wield our genetic blueprints, both common and rare, to "promote human health and treat disease" - for all of humanity.*

As this larger story has been unfolding over the past two years, the underlying story is convoluted in such a way as to totally confuse the world. *The Covid-19 crime is more of a three-strand rope binding the issues into an enigma virtually inseparable. Covid-19 was created from "synthetic biology", on a computer in a laboratory.* Stop and think about what I just stated and what that really means, Covid-19 was not a novel virus, not a rogue virus, but was created by combining genetic genome fragments, hence creating a "new" virus.

Professor Juliano added *"If you or I were injured, say our hands were cut off, there's a specific genetic program that is activated and is required to heal the wound, but the hand wouldn't grow back. That same genetic program is activated after*

injury throughout the animal kingdom, but in some cases, instead of triggering scarring, it triggers regeneration and thus the missing body part is replaced.”

Stem cells are the cornerstone of any living entity. As the embryo grows, stem cells take on individual characteristics. Over time they lose their ability to replace aging cells and eventually die. Conversely, the Hydra stem cells regenerate and are also known as Hydra the eternal embryo. Somehow the Hydra is able to keep its genome while experiencing large scale cell division. The Hydra is in a constant state of rebirth.

So what is the purpose of injecting Hydra Vulgaris into the human body? Could it be consuming the nervous system? Considering each Hydra has four to twelve tentacles which extend from its mouth, grabbing ahold of an internal food source isn't an obstacle. The WI-38 female stem cell line was extracted from the lung tissue of an aborted three month old female fetus. On December 8, 2020, Britain was the first Western country to start “immunizing its population.” Two weeks later, just a few days before Christmas, Britain grasped that it was in serious trouble. On December 19, 2020, PM Boris Johnson admitted that British scientists had identified a new Covid-19 mutant that is ‘70% more transmissible’ than its ancestors. Where is the proof of such a claim? Today, in the biggest Israeli news outlet *News12*, Israeli computer scientists revealed that **the British Mutation is about to become the dominant Covid-19 strain in Israel.** You may wonder how the British mutant strain managed to make *Aliya* (*ER: reference to Jews ‘returning’ to Israel*) and settle so comfortably in the Jewish State. The *News 12* article may answer the question:

*“Cases in Israel aren’t rising uniformly: there is a significant slowdown in the (Israeli) Arab sector, which in the past was the main area of concern. **On the other hand, there is a major outbreak in the (Jewish) ultra-Orthodox sector.** This week 1.3% of all ultra-Orthodox came out verified, and the rate of increase in cases of children (63%) this week was almost double that of adults. Among the ultra-Orthodox sector, there was a **16-fold** increase in the number of verified people within four weeks: this is a doubling every week – from 100 verified people per day (per million people) to 1,600 verified people, and all within a month. Such a growth rate is not seen throughout the plague and is probably due at least in part to the British mutant. **It is estimated that the British mutant is about 20% of all ultra-Orthodox verified.**”*

This must raise eyebrows. Why would the British mutant strain spread so vastly amongst orthodox Jews? Why doesn’t it spread as quickly in the Arab population?

We may be able to stumble upon a very crucial piece of information here. Israeli Arabs may be doing better on the Covid-19 front because **many of them seem to be reluctant about the vaccine.** The Israeli *'Marker's'* headline on 27 December stated: *"A cause for concern: (Israeli) Arabs do not come to get vaccinated."* The *'Marker'* pointed out that Jewish citizens from all over Israel travel to Arab villages and cities to receive the vaccines that were designated to Arabs. According to a duty manager of a vaccination center in Nazareth, **70-80% of those who come to receive the vaccine were Jewish.** Some of them travel as much as 50 km to do so.

But the story doesn't end here. On January 3, the Israeli news website *Walla* reported that *"the ultra-Orthodox are leading the population vaccination campaign."* *Walla* confirmed that 'the percentage of people vaccinated against corona among ultra-Orthodox society is higher than the rest of the population of all ages.'

It is beyond me why the Israelis decided to become guinea pigs in this reckless unscientific experiment in human lives. In Israel, the Jewish homeland where the situation was under control and is evidently improving (in early 2020), there is an exact count of Jews who have passed away from the Coronavirus. Reports say that of the almost 300 victims who have passed away, about 70% are from the Haredi sector. Recently there were news reports that in France between 1,000 to 2,000 French Jews have succumbed to the Coronavirus.

The situation in the USA is most serious. As of May 2020 in America almost 100,000 people died of Covid-19 and probably thousands of Jews in areas of Jewish concentration, but Jewish people are afraid to know the real numbers!

United Kingdom, the British Jewish Board of Deputies keeps track of the number of Jews in Britain who have passed away, now approaching about 400. There was a report in an Israeli Haredi news source Pesach time 2020 that about 700 Orthodox Jews in the United States passed away from the Coronavirus. That was a report from Israel. It was not widely known, let alone reported in the USA.

In America it is possible to Google "how many Americans have died from the coronavirus" and there are immediately detailed reports of the number of dead, infected, recovered overall and state by state. At the time of this writing, May 2020, the official figure of those who have died in America from Covid-19 is approaching 100,000! More than 20,000 in New York State and about 10,000 in New Jersey. No one is hiding the truth from anyone, but not so in the Orthodox world.

I cannot help but compare the war we are waging against this malicious virus to the Holocaust. Although numerically there is no comparison, thank G-d, imagine if people found it "too disturbing" to hear how many Jews perished in the Holocaust, or how many died in various camps and ghettos in towns connected with survivors? If it is not "too disturbing" to "never forget" the Six Million victims of the Holocaust, so why is it "too disturbing" to be kept informed and made aware, and mourn for the victims of the Coronavirus?

What does this avoidance and lack of critical information reveal? There are a number of possibilities:

- The most basic reason given is that the various government authorities in the United States do not monitor or count victims by religion. Fair enough. A non-Jewish government is not obligated to do this. But why shouldn't Jewish organizations, academics and communities do that? Many a Jewish study, or study of Jews, has*

published reports of all sorts of detailed facts. Many community organizations have the staff and capability of keeping count of everything from homeless, to jobless, and numbers of students in Jewish school and yeshivas, so why not keep tabs of those who have fallen victim to the Coronavirus crisis in the midst of the crisis itself?

•Fear and denial of reality. American Jews, like Americans generally are sunny-side-up positive thinkers, and they don't like dealing and confronting the "D" word.

•The splits and schisms between the various communities are a basic reason. Each group, such as the Yeshivish world, in Lakewood and Flatbush, the Hasidim are divided between each other. Satmar doesn't know what goes on in Lubavitch, Boro Park doesn't know what goes on in Flatbush, Monsey and Kiryas Joel are worlds apart, Sefardim live a life apart from Ashkenazim, life in the Five Towns is split off from life in Lakewood, not to mention that the Haredi world is cut off from the Modern Orthodox world, and the Orthodox world is isolated from the secular Jewish world in America. So news, or lack thereof, about Jewish victims of the Coronavirus is a reflection of the socio-economic, cultural, geographic, and religious splits that exist on the ground.

•Lack of any central body to do the job, like the Israeli government in Israel or the Board of Deputies in Britain. But this is not totally true because each large grouping in America has its centralized bodies and its official or unofficial information arms. There is the OU and the RCA, that keeps track of lots of things when they need to. There is the Agudah with its multiple branches with professionals who can dig up figures to argue any case in need. Satmar and Lubavitch have central rabbinical and communal organizations with powerful bureaucratic reach, all these could at least keep track of the numbers in their communities who have passed away that would help the living measure the seriousness of the pandemic and the need to continue with precautionary measures. It should not be too difficult for Yeshiva University and Touro College, both under Orthodox auspices, to find expert sociologists and analysts to compute the number of Coronavirus casualties in America.

•Bottom line, the reality is that the Jewish people is as disunited during this time as it is in "the real world". There is nothing now of the spirit in the Jewish world such as when Israel went through the 1967 Six Day War. Do you know how many Jews died in the Six Day War? Look it up. About 800. And how many Jews have died from the Coronavirus? In Israel almost 300, in Britain about 400, in France 1,000 to 2,000, and in America, let's say not less than in France, so that is another 1,000 to 2,000 or more. More victims than the 3,000 people who died in the 9/11 attacks (obviously they were not all Jews either, but we know exactly how many died and their names have been memorialized in print and their names carved in stone in the 9/11 Memorial. Our current numbers of dead Jews is a lot for one Mageifa (plague) in LESS than three months, since March 2020. And yet, the Jewish leadership and media in America ignore stating the obvious facts and making everyone aware of the scope of this modern-day plague in our midst."

Early on in the Covid-19 issue, public health officials were reporting that blood-type AB seemed to have an affinity relationship. We are not informed pertaining to such data

these days. In fact, there is nothing about whether Covid-19 was ever pre-disposed to specific ethnic groups. In genetic studies being conducted by the CCP at Wuhan, China there were indicators where the CCP was active in locating racial genome that would enable them to attack a specific racial "Phenotype". Combine that with the EU numbers of 25,248 deaths reported over roughly the same time period till September 18, 2021, and the numbers jump to over a quarter million. Thus, it's safe to assume that millions around the world have already died as a result of Big Pharma kill shots.

Nobel prize winner Dr. Luc Montagnier, who discovered HIV recently submitted a sworn affidavit to the International Criminal Court, concluding:

The Christian web site “Got Questions.com” offers this answer:

Answer: Why does the world hate the Jews? Why is anti-Semitism so rampant in so many different nations? What is so bad about the Jews? History has shown that at various times over the last 1,700 years the Jews have been expelled from over 80

different countries. Historians and experts have concluded there are at least six possible reasons:

- Racial Theory – the Jews are hated because they are an inferior race.
- Economic Theory – the Jews are hated because they possess too much wealth and power.
- Outsiders Theory – the Jews are hated because they are different from everyone else.
- Scapegoat Theory – the Jews are hated because they are the cause for all the world's problems.
- Deicide Theory – the Jews are hated because they killed Jesus Christ.
- Chosen People Theory – the Jews are hated because they arrogantly declare they are the “chosen ones of God.”

Is there any substance to these theories?

- With respect to the racial theory, the truth is that the Jews are not a race. Anyone in the world of any color, creed or race can become a Jew.
- The economic theory citing that the Jews are wealthy doesn't hold much weight. History has shown that during the 17th through the 20th centuries, especially in Poland and Russia, the Jews were desperately poor and had very little, if any, influence in business or political systems.
- As for the outsiders' theory, during the 18th century, the Jews desperately tried to assimilate with the rest of Europe. They had hoped that assimilation would cause anti-Semitism to disappear. However, they were hated even more by those who claimed the Jews would infect their race with inferior genes. This was especially true in Germany prior to World War II.
- As for the scapegoat theory, the fact is that the Jews have always been hated, which makes them a very convenient target.
- As for the idea of deicide, the Bible makes it clear that the Romans were the ones who actually killed Jesus, though the Jews acted as accomplices. It wasn't until a few hundred years later that the Jews were cited as the murderers of Jesus. One wonders why the Romans are not the ones hated. Jesus Himself forgave the Jews -(Luke 23:34). Even the Vatican absolved the Jews of Jesus' death in 1963. Nevertheless, neither statement has diminished anti-Semitism. The RCC absolution undoubtedly came years too late to have made much of a difference.

• As for their claim to being the “chosen people of God,” the Jews in Germany rejected their “chosen-ness” status during the latter part of the 19th century to better assimilate into German culture. Nevertheless, they suffered the Holocaust. Today, some Christians and Muslims claim to be the “chosen people” of God, yet for the most part, the world tolerates them and still hates the Jews.

In the Book of Job, we saw that Job was tested for a time, however when it was all over, God rewarded him. God set things right. Scripture says Job was rewarded double for his losses.

- When Israel decided to worship the Golden Calf at Mt. Sinai.
- When Israel decided to stay in the wilderness rather than go into Canaan.
- When Moab tried to destroy Israel and stop them from entering Canaan.
- When the Canaanites amassed all their armies to destroy the invading Israelites.

- When the surrounding nations tried to destroy Israel during the time of the Judges.
- When the surrounding nations tried to destroy Israel during the time of the kings.
- When the Assyrian army destroyed Israel and much of Judah.
- When the Babylonian army destroyed the Temple and Jerusalem.
- When the refugees from Babylon and Persia were restoring the Temple and Jerusalem
- When Haman attempted to destroy all the Jews throughout the Persian Empire.
- When the Greco-Syrian forces tried to Hellenize Judea under Antiochus Epiphanes
- When the Roman army destroyed Judea and Jerusalem twice (70 AD and 135 AD)
- When the Jewish people were scattered and persecuted throughout the world for 2,000 years.
- When Hitler organized the Holocaust and destroyed over Six million Jews.
- When the Jews attempted to return to Israel against extensive international opposition.
- When Israel declared its independence in 1947 and was invaded by Egypt, Jordan, and Syria.
- When Israel was invaded in 1967 and 1973 by its surrounding neighbors
- When Israel was disrupted by numerous intifadas from Palestinians and Jihadists.
- When Hamas hurled thousands of rockets from Gaza into Israel in 2014.

So we see, for 4,000 years the Jewish people have faced relentless persecution, opposition and attempts to annihilate and destroy them. not receive Him until after the Rapture of the Church and the Seven Year Tribulation. Thus, when Israel receives Jesus Christ, this will usher in the events that spell the doom of Satan.

From Satan's point of view, he must keep Israel from surviving to the point in time when they will be ready to receive Jesus as their long awaited Messiah/Redeemer. They had a great opportunity to receive Him at His First Coming, but as John states:

¹¹“He came to His own, and those who were His own did not receive Him. ¹²But as many as received Him, to them He gave the right to become children of God, even to those who believe in His name.” -(John 1:11-12).

Israel did not recognize its great ***“hour of visitation”*** when Jesus came the first time, but when He comes again, the nation of Israel as a whole that survives the Tribulation will at last be ready, willing and eager to receive Him as Savior and Lord. Those who survive will be the last “Remnant” of the original blood-line of Abraham, Isaac, and Jacob.

Thus Satan has strived mightily to destroy Israel through the centuries up until this present time so that there would be no Israel to invite Jesus to return to the earth. Why hasn't Satan been able to accomplish his repeated purpose to kill off this small nation of only a few million people? **It is because God has promised to preserve His covenant nation forever, as Jeremiah so eloquently explains:**

³⁵“Thus says the LORD, Who gives the sun for light by day, And the fixed order of the moon and the stars for light by night, Who stirs up the sea so that its waves roar; The LORD of hosts is His name: ³⁶If this fixed order departs From before Me,” declares the LORD, Then the offspring of Israel also shall cease From being a nation before Me forever.” -(Jeremiah 31:35-36).

God here states what it would take to destroy Israel. One would have to first destroy the sun, moon and stars. Once that had been accomplished then, and only then, could someone go about destroying Israel. This future prophecy draws closer each day. The last time I looked, the Sun, Moon and stars were still functioning, so that must mean Israel has not ceased being a nation.

Satan wants to destroy Israel so that he can keep God from sending him into eternal perdition, but God will not allow Satan to destroy His Chosen Nation. Israel is the apple of God's eye, so it must survive as a nation before Him for all time.

The devotional site *“Grace Through Faith”* noted this:

“Satan tried to prevent Jesus from coming to the earth by contaminating the human genome. One of the reasons for the Flood was to wipe out the hybrid-humans produced by the fallen angels mating with human women. Noah and his family were the only genetically uncontaminated humans. Through Herod's decree to kill all male boys 2 and

younger, Satan tried to destroy Jesus again but failed. Now that Jesus has won for mankind the chance for eternal life and Satan has been defeated, why is Satan still trying to destroy the Jews via the Holocaust and now through another oncoming Mideast war? It can't just be a supernatural hissy fit. Satan must see a way to avoid his ultimate destruction if he can kill the Jews."

In Hosea 5:15 there's a prophecy of the Lord's return to heaven after being rejected by Israel. It says.

"Then I will go back to my place until they admit their guilt. And they will seek my face, in their misery they will earnestly seek me."

A few days before His crucifixion Jesus said, ***"Look, your house is left to you desolate. For I tell you, you will not see me again until you say, 'Blessed is He who comes in the name of the Lord'"*** -(Matthew 23:39).

Scholars have interpreted these verses to mean that Jesus will not return to Earth until Israel officially petitions Him to do so. They speculate that Satan believes if he can wipe out Israel before that happens he can prevent the Lord's return. I ask you, is this not what is happening again: **Satan is still trying to prevent Jesus from coming to the earth by contaminating the human genome, this time with the poison syringe needle using DNA changing toxins?** As Anthony Patch puts it bluntly, to take the Vaxx is to identify you with the kingdom of Satan and that has eternal implications!

This may be why we're seeing such a rapid increase in the frequency and intensity of anti-Semitism in the world today. If so, it's another sign that the end is near.
