

Covid-19 is A Bioweapon

Part 2

By March, 2020, it was known by scientists world-wide that the Coronavirus, later designated Covid-19, was a bioweapon and at least three strains of it had been released around the world. The Google-owned video hosting platform, YouTube, has removed over 500,000 videos that cast doubt on the official COVID-19 narrative over the past year. "We've continued to make updates to our COVID-19 policies to stay current with the science, and we've removed more than more than half a million videos under these policies since February," she added.

Wojcicki made it clear that pushing Big Pharma's experimental vaccines is a driving force behind her censorship agenda. This is part of the mad rush to stick as many people with the shots as quickly as possible before the many negative side-effects can be fully understood.

“We want to help people understand the importance of vaccinations by connecting them with timely information to make informed decisions,” she wrote.

Big League Politics reported last year when YouTube announced their censorship policies, which mandated the removal of all information not approved by the disgraced globalist World Health Organization (WHO):

YouTube CEO Susan Wojcicki announced during an appearance on CNN that all information contradicting the official narrative from the discredited and disgraced World Health Organization (WHO) will be scrubbed from the popular video-sharing platform.

Wojcicki talked about how her platform will be *“raising authoritative information”* and *“removing information that is problematic.”*

“Of course, everything that is medically unsubstantiated, so people saying like ‘take Vitamin C’, ‘take turmeric’, those all will cure you. Those are examples of things that would be a violation of policy,” she explained.

A doctor sent this letter below to his patients advising them to not take the vaccine:

From Frank Shallenberger, MD, HMD

Dear Patients and Friends,

Last week I must have been asked 20 times about the new COVID vaccines. Here are my thoughts. Please pass this information onto many as you can. People need to have fully informed consent when it comes to injecting foreign genetic material into their bodies.

1. *The COVID vaccines are mRNA vaccines. mRNA vaccines are a completely new type of vaccine. No mRNA vaccine has ever been licensed for human use before. In essence, we have absolutely no idea what to expect from this vaccine. We have no idea if it will be effective or safe.*

2. *Traditional vaccine simply introduce pieces of a virus to stimulate an immune reaction. The new mRNA vaccine is completely different. It actually injects (transfects) molecules of synthetic genetic material from non-humans sources into our cells. Once in the cells, the genetic material interacts with our transfer RNA (tRNA) to make a foreign protein that supposedly teaches the body to destroy the virus being coded for. Note that these newly created proteins are not regulated by our own DNA, and are thus completely foreign to our cells. What they are fully capable of doing is unknown.*

3. *The mRNA molecule is vulnerable to destruction. So, in order to protect the fragile mRNA strands while they are being inserted into our DNA they are coated with PEGylated lipid nanoparticles. This coating hides the mRNA from our immune system which ordinarily would kill any foreign material injected into the body. PEGylated lipid nanoparticles have been used in several different drugs for years. Because of their effect on immune system balance, several studies have shown them to induce allergies and autoimmune diseases. Additionally, PEGylated lipid nanoparticles have been shown to trigger their own immune reactions, and to cause damage to the liver.*

4. *These new vaccines are additionally contaminated with aluminum, mercury, and possibly formaldehyde. The manufacturers have not yet disclosed what other toxins they contain.*

5. *Since viruses mutate frequently, the chance of any vaccine working for more than a year is unlikely. That is why the flu vaccine changes every year. Last year's vaccine is no more valuable than last year's newspaper.*

6. *Absolutely no long term safety studies will have been done to ensure that any of these vaccines don't cause the cancer, seizures, heart disease, allergies, and autoimmune diseases seen with other vaccines. If you ever wanted to be guinea pig for Big Pharma, now is your golden opportunity.*

7. *Many experts question whether the mRNA technology is ready for prime time. In November 2020, Dr. Peter Jay Hotez said of the new mRNA vaccines, "I worry about innovation at the expense of practicality because they [the mRNA vaccines] are weighted toward technology platforms that have never made it to licensure before." Dr. Hotez is Professor of Pediatrics and Molecular Virology & Microbiology at Baylor College of Medicine, where he is also Director of the Texas Children's Hospital Center for Vaccine Development.*

8. *Michal Linial, PhD is a Professor of Biochemistry. Because of her research and forecasts on COVID-19, Dr. Linial has been widely quoted in the media. She recently stated, "I won't be taking it [the mRNA vaccine] immediately – probably not for at least*

the coming year. We have to wait and see whether it really works. We will have a safety profile for only a certain number of months, so if there is a long-term effect after two years, we cannot know.”

9. In November 2020, The Washington Post reported on hesitancy among healthcare professionals in the United States to the mRNA vaccines, citing surveys which reported that: “some did not want to be in the first round, so they could wait and see if there are potential side effects”, and that “doctors and nurses want more data before championing vaccines to end the pandemic”.

10. Since the death rate from COVID resumed to the normal flu death rate way back in early September, the pandemic has been over since then. Therefore, at this point in time no vaccine is needed. The current scare tactics regarding “escalating cases” is based on a PCR test that because it exceeds 34 amplifications has a 100% false positive rate unless it is performed between the 3rd and 5th day after the first day of symptoms. It is therefore 100% inaccurate in people with no symptoms. This is well established in the scientific literature.

11. The other reason you don’t need a vaccine for COVID-19 is that substantial herd immunity has already taken place in the United States. This is the primary reason for the end of the pandemic.

12. Unfortunately, you cannot completely trust what you hear from the media. They have consistently got it wrong for the past year. In getting back to the real truth on the alleged virus, in part 1 revealed the findings of research scientists from Australia, France, India, and China. In this segment we will address the issue of “Gain of Function”.

In an Executive Summary, Gain of Function (GOF) research involves experimentation that aims or is expected to (and/or, perhaps actually does) increase the transmissibility and/or virulence of pathogens. Such research, when conducted by responsible scientists, usually aims to improve understanding of disease causing agents, their interaction with human hosts, and/or their potential to cause pandemics. The ultimate objective of such research is to better inform public health, and preparedness efforts and/or development of medical countermeasures. Despite these important potential benefits, GOF research (GOFR) can pose risks regarding biosecurity and biosafety. GOFR is a subset of “dual-use research” – i.e., research that can be used for both beneficial and malevolent purposes.

Whereas the dual-use life science research debate has largely focused on biosecurity dangers associated with potential malevolent use of research, the GOFR debate has more explicitly focused on risks involving both biosecurity and biosafety-the point being the creation of especially dangerous pathogens might pose highly significant biosafety risks that are dependent of, and perhaps more feasible to measure/assess than, risks associated with malevolent use.

Biosafety labs are classified according to risk-level. BSL-1 being low-risk microbes, BSL-2, BSL-3, and the BSL-4 healing with increased levels up to high risk microbes. In my series on Mycoplasma, I believe it was in Part 4 which has some 81 pages of data on the U.S. military history of creating bioweapons. Mycoplasma for those of you unfamiliar with pathogens is the smallest form of decomposition/composting of death. Mycoplasma has been sprayed upon the U.S. and other countries since 1996. Early samples of chemtrail spraying collected contained Mycoplasma. One can in jest it by breathing it in or consuming it from tainted water and food. You could get it from your pets that licked you since they all eat grass; you can even track it into your homes from outside. I never thought much about what Mycoplasma was from 1996 until about 2010, when I began a deeper study of the actual contents of the Chemtrail “soup” being sprayed on us like cockroaches. It is not something that you want to take lightly. Many researchers have associated it with and believe it is the real cause of cancer and other life-threatening diseases.

By following controversy surrounding research, published in 2012, that led to the creation of highly pathogenic H5N1 (avian) influenza virus strains that were airborne transmissible between ferrets-and more recent exports of biosafety mishaps involving anthrax, smallpox, and H5N1 in government laboratories-in 2014 the administration of U.S. President Barack Obama called for a “pause” on funding (and relevant research with existing U.S. Government funding) of GOF experiments involving influenza, SARS, and MERS viruses in particular.

This pause applies specifically to experiments that “may be reasonably anticipated to confer attributes ... such that the virus would have enhanced pathogenicity and/or transmissibility in mammals via the respiratory route” (White House 2014). With announcement of this pause, the U.S. Government launched a “deliberate process ... to address key questions about the risks and benefits of gain-of-function studies” (White House 2014) to inform future funding decisions-and the National Science Advisory Board for Biosecurity (NSABB) was tasked with making recommendations to the U.S. Government on this matter.

The question arises regarding ongoing research into the development one or more vaccines for COVID-19, as to why the deliberate actions toward an increase in “gain of function”, when the stated purpose of vaccine is to reduce the cases of morbidity and mortality.

In summation, following examination of this and further research papers, it is not simply to spread 2019-nCoV/COVID-19, but to target and permanently change he DNA of every person. This accomplished through a global vaccination mandates.

It must be kept in mind, a vaccine by its very nature is derived from and designed to function in a manner coinciding with that of the virus itself. Current research and development specific to 2019-nCov/COVID-19 is primarily based upon the DNA and RNA of this virus.

The tragedy of the lockdown has been in the toll of needless deaths and suicides. Clark County, NV, location of Las Vegas, has experienced an epidemic of young people committing suicide. By December, eighteen students in the district had taken their own lives; an early-warning mental health system embedded within computers and tablets issued to students for remote learning received 3,100 alerts since schools shuttered their doors last March.

Government data show a 24% increase in the number of children who arrived in emergency departments with mental health issues from mid-March through mid-October, compared with the same period in 2019.

Nationwide, tens of millions of students have been thrown into a new distance-learning environment that has resulted in many extracurricular activities being canceled. Recreational spaces have closed, sports canceled, and playdates shifted to Zoom calls, resulting in many kids developing mental issues, especially in Clark County.

Mike Adams posted this on his web site Natural News 1/27/2021. It covers the corrupt director of the NIAID, Jesuit Dr. Anthony Fauci. I wrote several articles in the summer of 2020 on the evil Jesuit Dr. Fauci. I share Mike Adams, the Health Ranger’s report on how he serves the Jesuit popes, Francis and his (black pope) counterpart Arturo Sosa.

It has direct relevance since I am dealing with the issue of “GOFR” “gain of function research.

“An investigation into the origin of covid-19 has uncovered a final trail of evidence that directly links Dr. Anthony Fauci and the National Institutes of Allergy and Infectious Diseases (NIAID) to get unethical gain-of-function research on coronaviruses. The gain-of-function research that was conducted at the Wuhan Institute of Virology in Wuhan, China was intended to engineer highly contagious viruses “to learn about treatments and vaccines” to understand how to respond to an actual outbreak. The team that made this research possible was America’s very own public health experts at the NIAID, led by none other than Dr. Anthony Fauci, the number one expert in infectious diseases and leader of the federal coronavirus task force.

Dr. Fauci continued gain of function coronavirus research by secretly subcontracting it.

The original gain-of-function research goes back ten years, with a Netherlands study that involved ferrets. The researchers wanted to see if coronaviruses could be genetically manipulated so they could be transferred through the air. After demonstrating airborne transmission with ferrets, the researchers wanted to replicate contagion in humans. This opened up an entirely new, controversial science that involved manipulation in the genetic code of viruses.

It was Dr. Fauci and the NIAID who funded the first ferret study. Ten years ago, Fauci co-wrote an op-ed in the Washington Post praising the research as “a risk worth taking.” He wrote, “Important information and insight can come from generating a potentially dangerous virus in the laboratory...”

The Wuhan virologists found that they could force an influenza virus to mutate and spread via aerosol droplets by injecting the virus from one ferret to another. By engineering the most lethal viruses in a laboratory setting, researchers believed they could better understand how to invent treatments and vaccines in the case of a real outbreak.

The Obama Administration put a halt on gain-of-function virology research in 2014, for fear of viruses leaking from the laboratory. This opened up an opportunity for Dr. Anthony Fauci to subcontract gain-of-function research on coronaviruses. Fauci concealed ongoing research through New York’s Eco Health Alliance. Dr. Fauci funded a project there to learn about the risk of new coronaviruses, and how they could emerge from wild animals to rapidly infect humans.

Dr. Fauci used the cover of EcoHealth Alliance to subcontract the research to China’s Wuhan Institute of Virology. In order to continue receiving money, the head of the Wuhan lab, Dr. Shi Zhengli, reported back to Fauci on the progress they were making on coronaviruses.

Dr. Fauci commissioned Eco Health to find out what viruses could infect both animals and humans, using experimental genetic studies and virus infection experiments across a range of cell cultures from different species and humanized mice. Fauci commissioned and funded Peter Daszak, the zoologist who first discovered the bat origin of SARS ten years ago. Daszak off-shored a key part of the research to the Wuhan Institute of Virology under lab director Shi Zhengli, who was responsible for collecting bat samples.

Fauci ordered the Institute to collect several samples of bat feces in caves. After isolating several coronaviruses from the bat feces, the Chinese virologists analyzed and sequenced their genetic information. Finally, they built genetically engineered viruses, or chimeras, and they went on to infect human cells, showing how the man-made viruses replicated. These genetic changes unlocked a unique doorway that allowed the virus to infect human cells with ease. The virus is known to attach to human cells ten to twenty times tighter than the first SARS virus.



“Until now, the only reporting of Dr. Fauci’s role in all of this has been his funding of the Wuhan lab in general,” said Steve Hilton, Fox News journalist. “But tonight we can go further thanks to this paper. We can see the specific activity that Dr. Fauci funded and it is terrifying — so terrifying that after we reached out to NIH this paper was mysteriously taken off-line on Friday for a while. But we downloaded it weeks ago.” Hilton is calling on Fauci to step down from his role as chief science advisor to the Biden administration until Americans can learn more about Fauci’s role in the covid-19 pandemic. Fauci must be held to account for off-shoring and guiding unethical, banned gain-of-function virus research.

The Chief epidemiologist of Chinese CDC admits: 'They didn't isolate the virus'. No – they have never seen the alleged 'virus' code or isolated 'it' from other genetic material, bacteria and toxins in a laboratory – instead they created a computer-generated fiction to terrify the world into accepting fascism.

The stated intent of pharmaceutical companies involved in the production of these vaccines is to elicit a low level response by the human immune system. In past vaccines, weakened (attenuated) forms of a virus served this purpose, with recipients experiencing milder signs and symptoms of the disease.

In the instance of DNA and RNA-based vaccines, the goal is the suppression of protein(s) from within the cytoplasm of a host cell. These are then recognized by the human immune system, which responds by producing antibodies specific to them.

What has not been made transparent to the deliberate inclusion of this:

“18 RNA fragments of homology equal or more than 80% with human or simian retroviruses have been found in the COVID-19 genome.”

This means, the vaccine(s), as with such treatments derived from an original virus, likewise contains 18 RNA fragments having the same structural features and pattern of genes (homologous) found in human or simian (apes/monkeys) retroviruses (*any of a group of RNA viruses which insert a DNA copy of their genome into the host cell in order to replicate, e.g., HIV.*) The 18 RNA fragments represent 80% of the HIV genome sequence!

Does this necessarily result in a person contracting HIV from such a vaccine? Not necessarily, since the entire RNA genomic sequence is not included, only fragments according to the research findings of Dr. Luc Montagnier and his co-researcher Jean Claude Perez. And this inverse is true with respect to those previously infected with HIV and retroviral alterations of their DNA. Their DNA has not undergone the same changes as those to be initiated by the upcoming vaccines.

It seems reasonable to expect these and other researchers with similar findings to be unsure as to what extent these changes to host DNA will manifest. However, **it is their opinion, based upon the scientific evidence obtained, 2019-nCoV/COVID-19 is indeed a man-made virus:**

Dr. Luc Montagnier and Jean Claud Perez state, **“Everything converges toward possible laboratory manipulations of the genome of COVID-19, but also, very probably much older SARS, with perhaps this double objective of vaccine design and of “gain of function” in terms of penetration of this virus into the cell.”**

Based upon what we have learned from Dr. Luc Montagnier, further research by him and others will yield conclusive evidence of significantly greater changes to human DNA

through the administration of 2019-nCoV/COVID-19 based vaccines, than simply the expression of proteins and enhancements of transmissibility.

The question arises with respect to enhanced virulence and infectivity: is the goal to increase lethality, or simply to vaccinate the global population? We cannot with certainty rule out either or both in this case largely upon the censorship and pressure to squash the dissenters. If only to vaccinate, then to what end? Recall, a retrovirus is any group of RNA viruses (including HIV) which inserts a DNA copy of their genome into the host cell in order to replicate itself.

To permanently alter everyone's DNA is a logical conclusion based upon the global scientific, academic, and corporate, media, and political, sociological, economic, and even theological movements coalescing upon this fine needle-point focus.

The tip-of-the-spear vaccine research and development is not DNA-based, rather RNA. Specifically, messenger RNA (mRNA), according to Pfizer and Moderna. This is concurrent with discoveries of inclusions as presented by Dr. Montagnier and Jean Claude Perez.

At the present the following corroborating evidence the 2019-nCoV/COVID-19 virus was created by man in one or many laboratories.

Li-Meng Yan, MD, PhD, and four Chinese virologists state: *“Many questions remain unanswered about the origin of SARS-CoV-2. Prominent virologists have implicated in a ‘Nature’ Medicine letter that laboratory escape, while not being entirely ruled out, was unlikely and that no sign of genetic manipulation is present in the SARS-CoV-2 genome. However, here we show that genetic evidence within the spike gene of SARS-CoV-2 genomic (restriction sites flanking the RBM (Ed. Note: RNA binding motif proteins, also RBP, RNA binding protein); tandem rare codons used at the inserted furin-cleavage site) does exist and suggests that the SARS-Cov-2 genome should be a product of genetic manipulation. Furthermore, the proven concepts, well-established techniques, and knowledge and expertise are all in place for the convenient creation of this novel coronavirus in a short period of time.*

Li-Meng Yan states, *“Motives aside, the following facts about SARS-CoV-2 are well-supported:*

- 1. If it was a laboratory product, the most critical element in its creation, the backbone/template virus (ZC45/2XC21), is owned by military research laboratories.*
- 2. The genome sequence of SARS-CoV-2 has likely undergone genetic engineering through which the virus has gained the ability to target humans with enhanced virulence and infectivity.*

3. *The characteristics and pathogenic effects of SARS-CoV-2 are unprecedented. The virus is highly transmissible, onset-hidden, multi-organ targeting, sequence-unclear, lethal, and associated with various symptoms and complications.*
4. *SARS-CoV-2 caused a world-wide pandemic, taking hundreds of thousands of lives and shutting down the global economy. It has a destructive power like no other.*

A Novel virus refers to a virus not seen before. It can be a virus that is isolated from its natural reservoir or isolated as the result of spread to an animal or human host where the virus had not been identified before. It can be an emergent virus, one that represents a new virus, but it can also be an extant virus, one that has not been previously identified. The Coronavirus is not "new." It has been studied for nearly 20 years.

On April 25th 2003, the US CDC filed the patent, number US7776521B1 on the "coronavirus transmitted to humans." Under 35 U.S.C. law, a natural, or nature virus is prohibited from being patented. Either the SARS, Coronavirus is manufactured, or it is natural, therefore making a patent on it illegal, if it was manufactured it is a violation of the biological and chemical weapons treaty and if it is nature, well, filing a patent on something of nature is illegal, so either outcome is illegal. Why has this not been prosecuted by the Department of Justice?

In the Spring of 2007, the CDC filed a petition with the U.S. patent office to keep their application "confidential and private." They actually not only filed patents on the virus but, also filed patents on its detection and a kit to measure it. Because of that CDC patent, they, the CDC had gained the ability to control who was authorized and who was not to make independent inquiries into the Coronavirus. They had the motive and most of all they had the monetary gain from turning the Coronavirus from a pathogen to a profit. The CDC holds 27 patents from which they earn more than \$5-billion in yearly earnings.

Somewhere between 2012 and 2013 something happened, the federal funding for research into the virus which was feeding into places such as Harvard, Emory and the UNC-Chapel Hill suddenly became impaired by something that happened at the National Institute of Health, (NIH). The NIH got this "little moment of clarity," and said, "*We think something you are doing is wrong.*" In 2013, once again, the NIH said research on the Coronavirus should be suspended. The NIH had a moral, social and potentially legal reason to object to Coronavirus research but the letter which was sent to the researchers essentially said you're receiving notice that we are telling you to "STOP," and now on the bottom of the page we are going to qualify what stop means, which is "KEEP GOING" but when the heat gets hot in 2014-15, offshore the research, you fund the Wuhan Institute of Virology to do the stuff which is getting a little edgy with respect to its morality and illegality.

The Wuhan National Biosafety Laboratory is the only lab in China designated for studying dangerous pathogens like SARS and Ebola. On December the 24th 2019, laboratory bosses accepted an annual management review with the object to ensure the implementation of the management principles and quality objectives of the laboratory safety system, and to maintain the suitability, adequacy and effectiveness of the system. A week later on the day the U.S. Embassy was attacked in Iraq, The World Health Organization (WHO) alerted by Chinese authorities, of a string of pneumonia-like cases in Wuhan, a city of 11 million people. Patients were quarantined and work began on identifying the origin of pneumonia. The U.S. Centers for Disease Control and Prevention (CDC) identified a seafood market suspected to be at the center of the outbreak. The market was closed on Jan 1, 2020.

GENOCIDE

According to *'The Daily Mail'*, on its January 2018 opening, biosafety experts and scientists from the US expressed concerns that a virus could escape the lab. In 2004, a SARS virus 'leaked' from a lab in Beijing. Just over a year after the outbreak has hit 100 million cases and killed more than 2 million unfortunate people, the world's economy is in tatters, poverty for many people is already a reality, riots are springing up everywhere and the future looks bleak.

Along with the issue of seeking people to take a vaccine which is not a vaccine but rather a “delivery” system, is like playing Russian roulette with a loaded gun, but it contains a hidden extra bullet that the public has not been informed about.

There is information out there that that claims otherwise. For example, an HHS pilot study conducted by the Federal Agency for Health Care Research found that 1 in every 39 vaccines in the United States caused some type of injury, which is a shocking comparison to the 1 in every million claim. The Vaccine Injury Compensation Program (VICP) protects the vaccine manufacturers (pharmaceutical companies) from any liability, and the money comes out of the taxpayer’s pocket. In the United States, the VICP has paid out more than \$4 billion dollars due to vaccine injuries. Since 2015, the program has paid out an average total of \$216 million to an average of 615 claimants each year.

When it comes to the COVID-19 vaccine, those who are injured will not be eligible for compensation under the VICP. An article recently published in the *‘New England Journal of Medicine’* explains,

The United States has developed a robust system for vaccine-injury compensation to alleviate the burdens of adverse medical consequences of vaccines. But this system will be unavailable to people who receive Covid-19 vaccines during the declared public health emergency. All potential vaccine recipients, and especially people in high-risk communities, therefore face a dilemma: should they risk becoming infected or risk having a vaccine injury without sufficient access to compensation? The public does not know this important information, and nor has anyone made that feck known.

The declaration of a public health emergency by the Department of Health and Human Services in March 2020, however, resulted in exclusion of Covid-19 vaccine injuries from the VICP. This declaration triggered the Public Readiness and Emergency Preparedness (PREP) Act, a federal law that requires that all people injured by vaccines given as countermeasures during a declared emergency bring claims under only the Countermeasures Injury Compensation Program (CICP). The CICP is far less generous and less accessible than the VICP. It compensates people for only the most serious injuries, has a higher burden of proof than the VICP, it has a 1-year statute of limitations after the date of vaccination, and limits awards for damages. For example, the CICP limits lost-income recovery to \$50,000 for each year out of work and doesn’t include compensation for pain, suffering, or emotional distress. As of January 22, 2021, there had been 329 deaths recorded as the result of receiving the Covid-mRNA injection! 50% were individuals over the age of 75. Previous studies have shown that less than 1% of reactions are ever reported to health agencies.

As a result, people who are vaccinated during the declared public health emergency will be less likely to obtain compensation for injuries associated with Covid-19 vaccines than they would be for injuries from vaccines included in the VICP. Furthermore, the process for pursuing compensation will be lengthier, more difficult, and more expensive because reimbursement for attorneys’ fees is unavailable. People vaccinated during a declared

public health emergency can never pursue injury claims under the VICP, even if their symptoms manifest or are linked to the vaccine after the declaration is lifted.

The Chinese scientists, Li-Meng Yan and her team stated that judging from the evidence that we and others have gathered, we believe the finding the origin of SARS-CoV-2 should involve an independent audit of the WIV P4 laboratories and the laboratories of their close collaborators. Such an investigation should have taken place long ago and should not be delayed any further.

We also note that in the publication of the chimera virus SHco15-ma15 IN 2015, the attribution of funding of Zhengli Shi by the NIAID was initially left out. It was reinstated in the publication in 2016 in a corrigendum, perhaps after the meeting in January 2016 to reinstate NIH funding for “gain-of-function” research on viruses. This is an unusual scientific behavior, which needs an explanation for.

What is not thoroughly described in this respect is the various evidence indicating that several coronaviruses recently published (RaTH1318, RmYN0230, and several pangolin coronaviruses 27-39, 31) are highly suspicious and likely fraudulent. These fabrications would serve no purpose other than to deceive the scientific community and the general public so that the true identity of SARS-CoV-2 is hidden.

Although exclusion of details of such evidence does not alter the conclusion or the current report, we do believe that these details would provide additional support for our contention that SARS-CoV-2 is a laboratory-enhanced virus and a product of gain-of-function research. They plan a follow-up report focusing on such additional evidence is now being prepared and will be submitted shortly.

Dr. Luc Montagnier and Jean Claude Perez provides added details to the evidence supporting Li-Meng Yan (MD, PhD), et.al..

- Why could Covid-19 come from Laboratory manipulations? The following 4 proofs concern differences with respect to SARS either common to COVID-19 and bat RaTG13, or facts radically differentiating these 2 sequences of which it is claimed that the first (COVID-19) comes from a natural evolution of the second (bat RaTG13). We have ranked these 4 proofs in ascending order of importance according to our point of view.
 - 1) Four EIE formally distinguishes COVID-19 and bat RaTG13 genome from all other SARS or bat genomes. However, their level of HIV/SIV homologies appears much more affirmed for COVID-19 than bat RaTG13, as if these EIE fragments had recently been “re-injected” into the COVID-19 genome.
 - 2) Natural deletions (USA WA Seattle state) apply in priority to EIE inserts (HIV Kenya etc..),

- 3) Synonymous codons mutations within the 1,770 bases regions of the Spike, which simulates a natural evolution of bat RaTG13 towards COVID-19 while maintaining the optimally obtained in amino acid values, probably from “gain of function” Laboratory experiments (optimality common to both RNA sequences COVID-19 and bat RaTG13).
- 4) “PRRA” amino acids were inserted exactly on the Spike location already theoretically optimal on both COVID-19 and RaTG13 (of which it constitutes the main difference).

As you correlate the findings within these two respective papers, it should be emphasized the coronavirus bat RaTG13/RaTG1318 (same) and 2019-nCoV/COVID-19 are formally distinguished from all other coronaviruses. With the additional findings of Li-Meng Yan (MD, Ph.D), et al. specific to the origin of bat RaTG13/RaTG1318 as being **“highly suspicious and likely fraudulent.”** Of which, it is claimed 2019-nCoV/COVID-19 comes from a natural evolution of bat RaTG13/RaTG1318.
