Dr. Fauci Concedes the Coronavirus Mortality Rate May Be Much Closer to a Very Bad Flu. The case fatality rate is far, far lower than we've been lead to believe.

On Thursday Dr. Fauci co-authored a report on the coronavirus in the *'New England Journal of Medicine.'*

The report, entitled "Covid-19 — Navigating the Uncharted", it was co-authored by Anthony S. Fauci, M.D., H. Clifford Lane, M.D., and Robert R. Redfield, M.D.

Here's a direct quote from that report:

"If one assumes that the number of asymptomatic or minimally symptomatic cases is several times as high as the number of reported cases, the case fatality rate may be considerably less than 1%. This suggests that the overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza (which has a case fatality rate of approximately 0.1%) or a pandemic influenza (similar to those in 1957 and 1968) rather than a disease similar to SARS or MERS, which have had case fatality rates of 9 to 10% and 36%, respectively. "

Please note that the case fatality rate is not ten percent, not five percent, not even one percent, but far, far lower than that. According to the authors, the case fatality rate is only 0.1 percent (only one-tenth of one percent). Dr. Fauci is the main voice that has the ears of President Trump, and who continues to be the gatekeeper on virology and infectious diseases. In reality, Dr. Fauci took a \$100-million grant from Microsoft founder William Gates, a hundred million reasons to lie and deceive.

Fauci's Research Fraud Endangers Every Life In America and Will Lead to the Complete Collapse of the Economy

Below are the key excerpts from the so called study:

If one assumes that the number of asymptomatic or minimally symptomatic cases is several times as high as the number of reported cases, the case fatality rate may be considerably less than 1%. This suggests that the overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza (which has a case fatality rate of approximately 0.1%) or a pandemic influenza (similar to those in 1957 and 1968) rather than a disease similar to SARS or MERS, which have had case fatality rates of 9 to 10% and 36%, respectively.

The efficiency of transmission for any respiratory virus has important implications for containment and mitigation strategies. The current study indicates an estimated basic reproduction number (R0) of 2.2, which means that, on average, each infected person spreads the infection to an additional two persons. As the authors note, until this number falls below 1.0, it is likely that the outbreak will continue to spread. Recent reports of high titers of virus in the oropharynx early in the course of disease arouse concern about increased infectivity during the period of minimal symptoms.

Let's sum up Fauci's so-called findings: His co-authored "study" states that the transmission rate is only 2.2. That flies in the face of the Italians and the Chinese whose rates were clearly reported between 5.5 and 6.5.

Fauci et al also stated that the death rate was the same as the flu and that number was placed at 0.1%. Please keep in mind that I have extensive academic experience in research and statistics at both the college and university level. In short, I know my way around this type of material. I am not claiming intellectual superiority to Fauci et al. However, I can easily recognize fake research based on poorly defined and operationalized terms and concepts and this precisely what we have here. In short, I recognize Fauci's attempt at getting away with academic fraud in the name of a political agenda. Laymen might refer to this as the bravo sierra of research.

Below are some of the academic issues I have with Fauci's publication and his so-called "research".

1. I am referring to this as a so-called study because I cannot find any original research on the current COVID-19 situation in America. The data sets are missing. The article, not study, refers to other research and documents said research to arrive at the numbers presented (0.1% death rate and 2.2 transmission rate). This is not a research study of any significance; it is a review of research studies.

2. The conclusions of the research defy even the most simple of research concepts, such as face validity. Face validity answers such questions as what does the research look like and what kind of research conclusions do we THINK we can draw? It is a common sense estimate. And the face validity of this article is an unmitigated joke and any former student of mine would not have gotten out of the midterm with this kind of sloppiness. The conclusion of the article failed to address the fundamental concepts of preventing transmission at the base level. Social distancing of 6 feet does not successfully mitigate the issue of transmissibility. The airborne particles can be transmitted several feet by such things as sneezing is an ignored issue in the Fauci et al article. Common sense would dictate that the wearing of a mask when one is in the presence of others should be required. This is such an obvious omission from Fauci's et al recommended mitigation strategies. One has to question the sincerity of the so-called interventions listed in the Fauci et al article. Also, how does Fauci et al know the death rate since they do not know the true infection rate? This is would like saying that a batter in baseball is a good hitter because he has 100 hits. That is an irrelevant statistic unless one knows how many at bats the hitter has had. The same exact principle should be applied to the death rate. In order to calculate the death rate, the only way one can be reasonably sure of the death rate is to know how many people are infected and contrast that figure with the number of who have died.

This so-called study may contain citations and be published in the New England Journal of Medicine but it is not research and it cannot accurately estimate the transmission rate and the death curve. The failure to recommend wearing of masks, from what we know, would prevent a lot of the transmission because a social distancing of 6 feet does not cover the potential distance a simple sneeze. This is an absolute oversight which is inexcusable. And the concept is so basic and simple, that it is difficult to believe that this oversight occurred by

accident. Am I saying that this is an example of research fraud? This article is the poster child for fraud.

In contrast, I turned to Mike Adams' figures which are unclouded from the Democratic Party perspective, unlike Dr. Fauci. I posed the question to Mike about the transmission rate and he quickly corrected me. He said the velocity of spread is the issue and his data shows the infection rate is doubling every three days.

As a point of definition, the velocity rate at this point in time, is the key figure. Since we are in the beginning phase of the spread of the virus, how fast the virus spreads (i.e. the velocity rate) is one of two key issues that should be researched and Fauci et al are totally ignoring the topic. The other key element in the early days of the spreading of a virus would be the preliminary death curve estimates, in which I have already stated that one cannot know the rate unless we know the infection rate. Get ready for this revelation; one cannot know the death rate unless EVERYONE is tested. Unless we are serious about testing everyone, we are not serious about fully understanding and treating the virus.

From the available research, it is clear that the following must occur if we are serious about first, understanding the virus from a statistical and research perspective:

1. Everyone must be tested.
2. Everyone in public must wear a mask.
3. Finally, as Mike Adams points out, the velocity rate must be understood.

If we do not know the velocity rate, we do not know how fast it is spreading. CV-19 clearly spreads much faster than the flu, and not understanding this along with taking common sense preventative actions, means that many people are going to die that do not have to. Predictably, this will lead to more calls for longer and more complete quarantines and guarantee an absolute economic collapse from which there will be no return.

At the end of the day, it is difficult to believe that the CDC's goals are connected to ending the CV-19 threat as quickly as possible. It strongly appears that the CDC is dedicated to spreading this virus. And this where we turn back to the politics of the issue.

The continued spreading of the virus benefits Democrats because our ineffective mitigation efforts are crushing the economy. Fauci's contrived ignorance will lead to more deaths and calls for much longer confinements of the public. The effect on the economy will be catastrophic and this endangers Trump's re-election and places the future of the Republic and our civil liberties at risk.

I work in the healthcare field.

Here's the problem: we are testing people for any strain of a Coronavirus, not specifically for COVID-19. There are no reliable tests for a specific COVID-19 virus. There are no reliable agencies or media outlets for reporting numbers of actual COVID-19 virus cases. This needs to be addressed first and foremost. Every action and reaction to COVID-19 is based on totally flawed data and we simply cannot make accurate assessments.

This is why you're hearing that most people with COVID-19 are showing nothing more than cold/flu like symptoms. That's because most Coronavirus strains are nothing more than cold/flu like symptoms. The few actual novel Coronavirus cases do have some worse respiratory responses, but still have a very promising recovery rate, especially for those without prior issues.

The 'gold standard' in testing for COVID-19 is laboratory isolated/purified coronavirus particles free from any contaminants and particles that look like viruses but are not, that have been proven to be the cause of the syndrome known as COVID-19 and obtained by using proper viral isolation methods and controls (not the PCR that is currently being used or serology/antibody tests which do not detect virus as such). PCR basically takes a sample of your cells and amplifies any DNA to look for 'viral sequences', i.e. bits of non-human DNA that seem to match parts of a known viral genome.

The problem is the test is known not to work.

It uses 'amplification' which means taking a very tiny amount of DNA and growing it exponentially until it can be analyzed. Obviously any minute contaminations in the sample will also be amplified leading to potentially gross errors of discovery.

Additionally, it's only looking for partial viral sequences, not whole genomes, so identifying a single pathogen is next to impossible even if you ignore the other issues.

The Mickey Mouse test kits being sent out to hospitals, at best, tell analysts you have some viral DNA in your cells. Which most of us do, most of the time. It may tell you the viral sequence is related to a specific type of virus - say the huge family of coronavirus. But that's all. The idea these kits can isolate a specific virus like COVID-19 is nonsense.

And that's not even getting into the other issue - viral load.

If you remember the PCR works by amplifying minute amounts of DNA. It therefore is useless at telling you how much virus you may have. And that's the only question that really matters when it comes to diagnosing illness. Everyone will have a few viruses kicking round in their system at any time, and most will not cause illness because their quantities are too small. For a virus to sicken you, you need a lot of it, a massive amount of it. But PCR does not test viral load and therefore can't determine if an osteogenesis is present in sufficient quantities to sicken you.

If you feel sick and get a PCR test any random virus DNA might be identified even if they aren't at all involved in your sickness which leads to false diagnosis.

And coronavirus are incredibly common. A large percentage of the world human population will have covi DNA in them in small quantities even if they are perfectly well or sick with some other pathogen.

Do you see where this is going yet? If you want to create a totally false panic about a totally false pandemic, pick a coronavirus.

They are incredibly common and there are tons of them. A very high percentage of people who have become sick by other means (flu, bacterial pneumonia, anything) will have a positive PCR test for covi even if you're doing them properly and ruling out contamination, simply because covis are so common.

There are hundreds of thousands of flu and pneumonia victims in hospitals throughout the world at any one time.

All you need to do is select the sickest of these in a single location - say Wuhan - administer PCR tests to them and claim anyone showing viral sequences similar to a coronavirus (which will inevitably be quite a few) is suffering from a 'new' disease.

Since you already selected the sickest flu cases a fairly high proportion of your sample will go on to die.

You can then say this 'new' virus has a CFR higher than the flu and use this to infuse more concern and do more tests which will of course produce more 'cases', which expands the testing, which produces yet more 'cases' and so on and so on.

Before long you have your 'pandemic', and all you have done is use a simple test kit trick to convert the worst flu and pneumonia cases into something new that doesn't actually exist.

Now just run the same scam in other countries. Making sure to keep the fear message running high so that people will feel panicky and less able to think critically.

Your only problem is going to be that - due to the fact there is no actual new deadly pathogen but just regular sick people, you are mislabeling your case numbers, and especially your deaths, are going to be way too low for a real new deadly virus pandemic.

But you can stop people pointing this out in several ways.

1. You can claim this is just the beginning and more deaths are imminent. Use this as an excuse to quarantine everyone and then claim the quarantine prevented the expected millions of dead.
2. You can tell people that 'minimizing' the dangers are irresponsible and bully them into not talking about numbers.
3. You can talk crap about made up numbers hoping to blind people with pseudo-science.
4. You can start testing well people (who, of course, will also likely have shreds of coronavirus DNA in them) and thus inflate your 'case figures' with 'asymptomatic carriers' (you will of course have to spin that to sound deadly even though any virologist knows the more symptom-less cases you have the less deadly is your pathogen.

Take these 4 simple steps and you can have your own entirely manufactured pandemic up and running in weeks.

They cannot "confirm" something for which there is no accurate test.

Comment: We cannot verify this anonymous claim about the specificity of the tests being conducted on people, though we welcome testimony from anyone knowledgeable about such testing. It is known that the first batch of test kits sent out to US hospitals by the CDC were completely useless.

The issue of precise testing and thus precise COVID-19 infection rates has become largely irrelevant now because many countries have stopped testing anyway - their healthcare practitioners have been directed to 'confirm' COVID-19 cases based on symptoms and administrative methods.

One way or another, **this is indeed a manufactured pandemic.**

We do think, however, that there is something real at the core of it; this COVID-19 may have been a genetically tweaked coronavirus that was never meant to 'get out', and now that it has, the Powers That Be are desperately trying to minimize the global population's exposure to it.

Most people assume that that's because Big Brother loves them, but what if the virus in fact presents a threat to their power and control and not to the general population?...



Billionaire globalist Bill Gates recently partook in an “ask me anything” session on Reddit, where users were free to ask him anything he would do his best to respond.

Of course most of the conversation centered on the coronavirus, and the tech magnate is now all of a sudden some kind of medical and sociology expert.

During this AMA session, Gates suggested that we may need to lock down, or “shut down” as he prefers to call it, needs to last upwards of 10 weeks, and there are many references to it lasting as long as 3 months, or even 18 months until vaccines come out.

Some people are trying to newspeak the lockdowns by calling it a “suppression strategy.”

Here are just a few of the highlights from the AMA:

Question: Bill, I read the Imperial College COVID-19 Response Team report as well as this explanation in a historical context.

Essentially, it says that by doing nothing, 4 million Americans die. Through the mitigation strategy – i.e. social distancing and “flattening the curve” – it says that 1.1-2 million Americans will die. However, it also says that the suppression strategy, or “shutting everything down for 18 months” – will lead to only a few thousand people dying.

Do you agree with these numbers, and if so, is there any excuse for not immediately issuing a shelter in place order for the entire country?

Answer: Fortunately it appears the parameters used in that model were too negative. The experience in China is the most critical data we have. They did their “shut down” and were able to reduce the number of cases. They are testing widely so they see rebounds immediately and so far there have not been a lot. They avoided widespread infection. The Imperial model does not match this experience. Models are only as good as the assumptions put into them. People are working on models that match what we are seeing more closely and they will become a key tool. A group called Institute for Disease Modeling that I fund is one of the groups working with others on this.

Question: What about the current crisis worries you the most? What gives you the most hope?

Answer: The current phase has a lot of the cases in rich countries. With the right actions including the testing and social distancing (which I call “shut down”) within 2-3 months the rich countries should have avoided high levels of infection. I worry about all the economic damage but even worse will be how this will affect the developing countries that cannot do the social distancing the same way as rich countries and whose hospital capacity is much lower.

Question: Do you think there’s any chance of the US doing a staggered approach (with respect to social distancing measures and school closings) to keep the load at health care facilities manageable? I saw this idea presented in the recent paper from Imperial College and I’m curious what your thoughts are.

Answer: I think people in the US will be able to largely isolate for 2-3 months. If they can access testing including a home test kit then they will understand who is infected. I keep saying how important the testing piece is.

It’s easy for Bill Gates, who recently became a centi-billionaire, to shelter in place in his giant mansions, tennis courts, pools, and acreage. The rest of us peasants? Not so much. But Gates has no idea what it’s like to live as a normal person. Some people brought this up, that the lives lost from an economic catastrophe would be more than those lost by the Covid-19 pandemic, such as this comment:

There is a wide misconception about the feasibility of storing months’ worth of food while living paycheck to paycheck.

Not to mention, now your employer is closed due to the coronavirus.

The recession will inevitably be more damaging to the America Worker than the coronavirus itself.

Because one does not show a temperature proves little. Determination of whether one has or does not have the COVID-19 requires a DNA swab and blood work, which may take up to a week to get results. One of the dangers of the COVID-19 is that it has an incubation period of at least two weeks, and some suggest longer. Do you begin to see signs of deception in all of this hysteria.



It is the gross overreaction of certain government and business leaders to the Wuhan Coronavirus of 2020, otherwise known as COVID-19; that is the danger to the United States, not the virus itself. The abundance of data show that the virus is far less dangerous than the seasonal flu, and if the overreaction is not stopped and reversed immediately, it will severely damage the economy and the lives that depend on it.

Number of people who will die of COVID-19 illness will be a small fraction of those who die of the flu every season.

The Center for Disease Control (CDC) estimates that during the 2019-2020 flu seasons since September 29, 2019 approximately 23,000-59,000 have died of the flu out of 231,654 confirmed cases. That's a confirmed case fatality rate (CCFR) of roughly 10% to 25%. As of March 26, there have been 1,305 fatalities among 86,043 confirmed cases of COVID-19 in the United States. That is a CCFR of about 1.5%—which is only 6% to 15% of the CCFR of the flu. However, because most people with non-life threatening symptoms don't present themselves to health facilities to be tested or counted for statistics, the CCFR for both illnesses vastly overestimate the actual chance of dying if infected: the infection fatality rate (IFR). To calculate the IFR, the number of fatalities is divided by the estimated number of people infected.

So how can we know what the IFR is for contracting COVID-19? If people who manifest similar symptoms are both hospitalized and tested for COVID-19 as they would be for the flu, then we can make a rough comparison between them. It is estimated by the CDC that about 38 to 54 million people have contracted the flu during the 2019-2020 season. If we divide the flu fatalities stated previously, by the estimated number of infections, it would mean a flu IFR that ranges from about 0.04% to 0.16%.

If we know that the CCFR of COVID-19 is about 6% to 15% of the CCFR of the flu, then the IFR of COVID-19 is most likely a similar fraction of the IFR of the flu: 6% to 15% of 0.04% to 0.16% results in an IFR for COVID-19 of approximately 0.002% to 0.02%. By that fatality rate, if a similar number of Americans contract COVID-19 as contract the flu, the total number of fatalities in the U.S. from COVID-19 would be between 760 and 10,800—almost all of whom would be very elderly and infirm or immune compromised. That is only between one in 30,000 and one in 400,000 of all Americans. Even after the virus has run its entire course, under the worst case scenario, you would be much more likely to be struck by lightning in your lifetime than die from COVID-19.

Given those numbers, it becomes clear that the number of people who will die of COVID-19 illness will be a small fraction of those who die of the flu every season. So we should be asking questions that the hysteria promoting media are apparently avoiding:

- Why haven't states or the federal government ever taken these kinds of measures before for any other illness in history?
- If the country is not shut down because of the flu, and wasn't for the H1N1 swine flu of 2009, why shut it down for COVID-19?
- How do the confirmed case rates of growth and fatality rates of growth in states with business closures compare with states without business closures?

•What kind of effect can we expect the economic destruction caused by restrictions to have on long term health and mortality, including suicide?

•Wouldn't it make more sense to encourage the vulnerable to self-isolate, than to close businesses and restrict everyone?

•If there is a cure (hydroxychloroquine/azithromycin) and a vaccine, why continue the restrictions?

•Are these the kind of measures we can expect from now on for the seasonal flu or outbreaks of similar illnesses which regularly occur several times per decade? If not, why not?

•If COVID-19 can remain viable on surfaces for days, what is the likelihood of not coming into contact with the virus when grocery stores, hardware stores, banks, and post offices remain open and people still handle store items, shopping carts, money, credit card terminals, and the daily mail?

•If shopping at grocery stores is allowed, why is shopping at any other store different?

•How is it moral to have the government prevent small businessmen and their employees from earning a living and then demand of them the tax money to pay government employees who are not working during that same period?

•Where can people find the constitutional authority for the federal or state governments to shut down businesses, and restrict gatherings and internal travel?

•What are the limits to government powers under a declaration of emergency?

A state-by-state examination of the graphs of COVID-19 confirmed cases and fatalities indicates no correlation between the imposition of business shutdowns and either the growth rate of infection or the growth rate of fatalities. On the other hand, it is well documented that economic decline leads to a decline in health and life expectancy. That makes sense. Wealth is dependent on productivity. Higher productivity creates a greater abundance of goods and services on which our health depends, which makes them more affordable: the basic resources we need, the quality of our medical care, the quality of our place of residence, greater freedom to engage in professions that are less hazardous or stressful, and time-off for relaxation and self-improvement. Sudden economic decline, particularly business failure, bankruptcy, and unemployment are also significant contributors to death by suicide. Ultimately, our health depends on our ability to keep doing, without interference, what each one of us does best.

Health will not be the only casualty of the overreaction, so will the American way of life and what we are conditioned to tolerate. Freedom to do what we do best as individuals and to trade freely with others with reliable currency, under a reliable system of laws that protect

our rights, is the reason that Americans enjoy such a high standard of living in general. So far, various leaders in both major parties have undermined all of those things. Americans are being threatened with arrest for going to work, going to church, operating and patronizing businesses, and being told that their currency will be inflated to pay companies and individuals for doing nothing—none of which have any basis in the federal or state constitutions. Those on the left are already calling for using this opportunity to nationalize industries, socialize medicine, explode the debt, universalize the welfare state, and to violate constitutional rights and liberties. If we allow these un-American precedents to be set over the pretext of dealing with an illness that could be less dangerous than the flu, is there any reason to believe that the American way of life and our current standard of living is likely to continue?

Whatever your talent, skill, job, or business, do you believe that government interference helps you produce more and better goods or services at a lower cost? If not, then how would the emergence of a new virus change that? If the mandates, closures, and restrictions were not imposed, there would be no panic. Individuals and businesses would always move to fill any need, whether it be treatments and supplies for a fighting a disease, or new demand for certain household goods. Any shortages of ventilators, hospital beds, treatments, tests, and cures are the result of the heavy regulation over the field of medicine—many of which have come to the public's attention due to the announcements of the temporary easing of some of them. The shortages in masks, toilet paper, and shelf-stable food items are caused by anti-gouging laws. Without them, prices could be temporarily raised to meet demand and discourage hoarding. What is worse, finding what you need at a temporarily elevated price, or not finding what you need at any price? Virtually everywhere you see shortages, government interference is responsible. Make no mistake: it is not the virus that is causing economic destruction: it is the government.

Many individuals and small businesses cannot survive weeks of no income. Not only will the proposed handouts not make up for their staggering losses, incurring debt to distribute printed "stimulus" or bailout money will cause even further economic destruction from inflation. If the state and federal governments ruin the economy with their overreaction, people will lose their jobs and businesses, goods and services will become more expensive, and quality of life will diminish. Time wasted in mandated idleness can never be recovered.

Many people will be misled to believe that the same government policies that caused the problems should be increased to solve them. That will make the adoption of a total welfare state, socialism, and a centrally planned economy more likely: all of which will permanently decrease quality of life and increase mortality far beyond what COVID-19 would ever have caused.

Our enemies are watching closely

Also, our enemies are watching closely. If we paralyze ourselves and destroy our economy because of something that is not even as bad as the flu, they must be imagining what would we do to ourselves if the virus had been more deadly. What reason would they have to not use that form of attack? This kind of weakness must not be shown to our enemies.

The precedent should never be set that this is the way to deal with a new contagious disease: putting people in a panic with grim tones and dour faces, getting people accustomed to dictatorial edicts, violating people's constitutional rights with shutdowns and travel restrictions, increasing debt for "stimulus" and bailouts, and getting people used to receiving checks for doing nothing. It would be much better instead for the government to do nothing. That way, they won't further interfere with the ability of the free market to meet people's needs, including solving the problems caused by this illness or any other illness.

If politicians feel the urge to deflect media criticism by taking action, they should take the opportunity to make it clear to the American people that they have determined that COVID-19 is less dangerous than the flu, immediately approve the existing vaccine and cure (hydroxychloroquine/azithromycin) for immediate use, repeal anti-gouging laws, and cut or eliminate the payroll tax. They should also immediately end all restrictions, and call off the bailouts, handouts, and "stimulus" bills. In fact, every American should contact their governors, congressional representatives, and the White House and insist on those things.

Now is not the time for passive acceptance. Our health, wealth, liberty, and way of life are at stake, and so is our country.

There is a screengrab of the Haofeng Electronic Technology Co. in China (not included in this post). After one member sends three laughing emojis, Zhang continues to say, *"Isn't that a great idea? Without using one single slider, we make money, as well as make peace for the world."*

Another member says *“No, we don’t want to make money from Americans. Let them help and rely on themselves.”*

The article had a link to information on the company. Defective CDC meters, false positives, and now tampered thermometers all contribute to a situation that magnifies incompetence, ineptness, and sloppy medicine. Why should anyone believe anything the CDC, WHO, and NIH has to say about what has been engineered as a bio-weapon.

Censors on the Internet have been tightening down on Internet news, such as Mike Adams, the Health Ranger, and all reports about the 5G roll out. The very act of censorship merely confirms our suspicion about control of information.

As I was typing this, my wife asked me if the shutdown had been extended. A friend had told her the shutdown had been extended, and when I checked to verify, sure enough it had been extended two more weeks. No real surprise as I felt the initial two weeks was a matter of conditioning people’s minds to the seriousness of what is coming. Most people can do two weeks with minor adjustments, but longer and you get into bigger issues.

The effects of CV have been to shut the world down for an unknown period. With schools, shops, hotels, airlines and factories, etc., all closed, most countries are not producing anything currently. This total lockdown will not only be devastating for the world economically. It could lead to more people suffering due to hardship, famine and health problems with lack of essential items like medicines and food. I pointed this out already 3 weeks ago, but politically and humanely this solution has not been considered acceptable.

What the world is now encountering is the perfect storm. That the debt infested global economy would one day come to an abrupt halt has been clear for a while as I have written in many articles. But instead of a gradual downturn, the world economy is now going to experience a fast and devastating collapse which will lead to a decline in real terms of most assets like stocks, property and debt by more than 90%. Real terms means measured in constant purchasing power like gold.

In the Dow for example, we have just seen on the quarterly chart a downturn in the MACD indicator from a very high level. This is a very important trending signal which indicates that we are likely to see at least 10 years downtrend in stock markets. The alternative is that we will see a very rapid decline in the next 6-24 months and then the index going along the bottom for a decade or more.

Central banks around the world have so far committed \$12 trillion of direct support via money printing. In addition global fiscal stimulus or tax reductions of \$5 trillion have been committed by governments. But these amounts are just a drop in the ocean. Just take a company like Volkswagen. They are now experiencing a cash drain of \$2.2 billion per week. If we multiply that by factories and businesses around the world plus assistance to individuals,

we will soon see liquidity requirements of \$10s followed by \$100s of trillions as the financial system implodes.

If we take the Fed as an example, it has cut rates to zero and already expanded its balance sheet by \$700 billion to \$5.5 trillion since September 2019. Another \$2 trillion have been committed but that is just the start. Just to remind ourselves, during the 2006-9 crisis the Fed's balance sheet only grew by \$1.2 trillion to \$2 trillion in 2009. We will most likely see the balance sheet grow by \$ trillions in the next few weeks.

Surging national debts and unlimited money printing has always been the inevitable end to periods of excesses. We are now seeing not only the end of a 100 year cycle since the Fed was created, but also the end of a 300 year cycle since John Law and the Mississippi Bubble in France in 1716-20. We could even be at the end of a 2,000 year cycle from the Roman Empire but that only future historians will know.

In 1757, France lost a war against Prussia. The French king Louis XV had a mistress called Mme de Pompadour. When France lost the war she said to the king: "Après nous le déluge" – After us the flood, meaning that the loss of the war would mean chaos and destruction for France. And it did of course as 30 years later the French Revolution took place.

The situation is now the same with Powell and Lagarde flooding the world with worthless money and the people virtually drowning. Many countries are likely to experience social unrest and possibly also revolutions.

The end of the current cycle is textbook finance. Bubbles everywhere, major problems in the global economy with economic and financial pressures plus a pandemic that has hit the whole world, all simultaneously. Such is considered the "Perfect Storm!" I repeat my premise that this was a "Plan-Demic!"

Next come pressures in the currency system as all currencies are debased but not quite at the same time. They will all reach their intrinsic value of zero as central banks flood the world with unlimited amounts of money.

Hyperinflation will follow and then a collapse of the financial system as we know it today. No one must believe that SDRs (Special Drawing Rights) issued by the IMF will make any difference to a bankrupt system. SDRs are just a different form of paper money and a reset based on new SDRs issued will have a life of a few months maximum before it all collapses again. The next reset thereafter will be disorderly and dramatic as central banks lose total control...

Just a few words about the EU. It is no longer the European Union but the European Disunion. All the illusions of grandeur have gone and each European Disunion country is now fighting for its own survival. There is no coordination and no cross border assistance in connection with Coronavirus. Italy, Spain and France are on the verge of collapse but are getting no aid

from Germany. The European banking systems under massive pressure and will most probably fail or be seriously impaired in the next 6-12 months.

So we are looking at a truly global crisis which will have irreparable repercussions for the world for a foreseeable future. I'm not hearing anyone saying it but there is only one answer to all of this, and God does have a plan. Man has refused to believe it and accept it as the Good News. I don't hear many Christians saying it, they have been banned from their local churches. The extent of this has yet to be felt by humanity.

Now is the time to wake up and recognize the Bible predicted this nearly 2,000. If you do not recognize it, be aware that this could be hours away from God's Judgment upon a disobedient evil world. It is not too late to ask God to forgive you of your sins, and that you repent now. Ask God for forgiveness now and plead the blood of the Lamb of God! You just might be the last person redeemed before the door closes. The Bible offers us parables which address the theme of the last late comer to be redeemed.
