

# The Chino-Americana Virus Plot Revealed:

In part 1, I opened with evidence that the U.S. and Chinese scientists **were plotting to form a new coronavirus before the pandemic erupted**, leaked proposals reveal.

“Last month, a grant application submitted to the U.S. Defence Advanced Research Projects Agency (DARPA) **showed that an international group of scientists had intended to mix genetic data of similar strains to form a new virus.**”

**The grant application was made in 2018 and leaked to Drastic, the pandemic origins analysis group.**

Publicly, there is no mention or reference that Covid-19 is a “Bioweapon”, and yet no one, public health, politician, virologist, in the U.S. as best I can find that has been open enough to suggest or state that to be the case. Even the Senator Rand Paul hearings never brought up this term “Bioweapon”. He should know as I have told him enough but he appears to not want to use that term!

The first person to publish that information was by Anthony Patch, who reported in his publication *'Entangled'* magazine that **Covid-19 was a "Retrovirus"**. Anthony Patch, a Canadian citizen even went so far as to print the genetic genome of the sequences of spike proteins of 201-nCov (Wuhan-HU-1), Accession NC\_045512) and of SARS CoV (GZ02, AccessionAY390556) were aligned using MultiAlin software. **Four locations were identified in which methodical insertions of three HIV1 and one of SARS2 was made. 18 fragments of the HIV1 virus were "inserted" along with 4 fragments of SARS2, into the virus now being called Covid-19.** At this precise reference point the Coronavirus, not much more than an ordinary cold virus, was **"weaponized"** and became a **"Bioweapon"**.

First thing we need to know is what is a Retrovirus? A Retrovirus definition says it is any of a family of RNA viruses that have an enzyme (reverse transcriptase) capable of making a complementary DNA copy of the viral RNA, which then is integrated into a host cell's DNA. The family includes a number of significant pathogens, typically causing tumors or affecting the function of the immune system, e.g. HIV.

The first report of such manipulated efforts were reported by a group of Indian scientists who, under pressure by one Dr. Anthony Fauci of the NIAID threatened the group future loss of research funds if they did not retract their scientific paper. The group of Indian scientists put forward their paper back in March of 2020. Despite being retracted under Dr. Fauci's pressure, the contents of the paper, genomic data, was confirmed to be correct by the 2008 Nobel Peace Prize recipient for discovering HIV, Dr. Luc Montagnier.

Dr. Luc Montagnier's words were: **"THIS VIRUS WAS MANIPULATED METICULOUSLY, IT'S NOT NATURAL."**

The conclusion of these scientists and others cited are; **the genome of 2019-nCoV/COVID-19 was man-made in a laboratory and contains not simply 4 inserts as cited by Prashant, et. al, but `8 of human or simian retroviruses (HIV-1).** What I find amazing is that our government spent \$40-million taxpayer dollars to do it. As the Indian scientists exposed it, the perpetrators simply added two other known viruses (HIV1 and SARS2) with the basic cold virus to create their alleged pandemic.

With respect to the "gain-of-function" objective, this is for the purpose of increasing the rate of infection, the pathogenic transmissibility (mobidity) of a virus within a host population. This is leveraging the natural processes of a virus in increasing the quantity of infected hosts, without killing them off.

I believe we can see that **Dr. Anthony Fauci should really go down in history as one of the primary initiators of the Covid pandemic, being that he was a director of the NIAID and the National Institutes of Health (NIH) while overseeing the funding of Gain of Function research on corona-viruses at the Wuhan Lab in China.** This is the same research that Fauci blatantly lied about to congress on multiple occasions. And, the

Wuhan lab is the same lab that evidence suggests was the ground zero source of the Covid-19 outbreak. Dr. Fauci's stonewalling during Senate hearings is indicative of crimes against humanity!

It is important to note that it was Dr. Fauci and the NIH that LIFTED the ban on gain-of-function research on deadly viruses in 2017, and it was well known around this time that the Level 4 Wuhan lab in China was not secure.

If anyone is responsible for global Covid deaths, it is Dr. Fauci, the Chinese government and anyone else involved in that gain-of-function research which is primarily used to WEAPONIZE viruses under the guise of creating "therapeutics." Gain-of-function research was originally banned under the Biological Weapons Convention which went into effect in 1975, unless it was being used for therapeutics. Now ALL gain of function research that is revealed publicly is labeled as therapeutics even if it is actually designed to produce biological weapons. This is sometimes referred to as "dual use research."

In fact, we know to the precise penny how much money was spent by our government for this, what amounts as crimes against humanity, to be around \$40-million dollars. Yes, our government funded this research for years!

The U.S. Health and Human Services began funding research in 1999, looking at infectious diseases. Our government, military, public health, and academia sit at the top of everything that exists today. From 2000 onward, the government has spent millions of tax dollars to fund research, experiments, on the very thing that keeps anyone from coming forward and telling the truth about Covid-19 being a "bioweapon". They are all responsible and complicit for the crisis that exists today.

**It will explain why they want to vaccinate every person on this planet as well. They have to cover-up their crimes and pressuring the public to be vaxxed is simply part of the crime and cover-up that is underway. The virus is not the weapon; it is the spike protein that has been inserted into the vaxxes! I have said numerous times, "The virus was created for the vaccine!" Now we know this with total certainty! The proof is found in the documents shared throughout this article.**

Dr. Anthony Fauci became the "lightning rod" in all of this because he was the "bagman" for the dishing out the millions of dollars; however, he is just the tip of the iceberg, and knows he is protected from being prosecuted. He has the evidence on all those instrumental in the various agencies work on "gain-of-function". While most people know believe that SARS-CoV2 first appeared in 2019, the evidence shows that COVID-19 was being manipulated from Wuhan, China in 2006, and the work was being conducted and funded by the U.S.A. and it was being funded by U.S. agencies with taxpayer dollars.

Peter Daszak's EcoHealth Alliance has hidden almost \$40-million in Pentagon funding and militarized pandemic science. If you do not think the U.S. federal government has a

track record of conducting unauthorized nonconsenting research upon its citizens and military, then you have not been looking at the records and history.

It is important that you understand that anything developed for use on an adversary enemy, can also be used against a nation's own population. The frequent example that I focus on when explaining this dilemma is the ADS or Active Denial System where **5G** wireless energy is used to break-up protestors or unwanted crowds. The Active Denial System (ADS), is supposedly a non-lethal, directed-energy weapon developed by the U.S. military, designed for area denial, perimeter security and crowd control. Informally, the weapon is also called the heat ray since it works by heating the surface of targets, such as the skin of targeted human beings. Less known is the fact that it can create greater damage and result in death!

The U.S. has a **National Debt of \$28,856,493,500,000** of “on-book” debt, but there is a much larger number that we refer to as “off-book” debt, in the form of **unfunded obligations**. **These are approximately \$222-trillion dollars, or nearly 10X the National Debt.** Senator Tom Coburn of OK stated back in 2013 when studying the Obama Affordable Care Act, the nation had just over \$126 trillion in unfunded liabilities for three programs — Social Security, Medicare and the Medicare prescription drug program. The biggest share of the total — more than \$87 trillion — belongs to the Medicare program. These three programs are considered “off-book” debt obligations. As you can see, they are not pocket change!

Our debt problems are about to get much worse. Keep these numbers fresh in your memory as they are the **motive** for killing off as many people as possible. Criminal detectives begin their investigating by focusing their work on the questions of the three “M’s” - a **motive**, a **means**, and a **method**!

Looking at projections by the Congressional Budget Office—Congress’ official federal scorekeeper - one sees that the federal budget is on a rapid collision course with out-of-control deficits. By 2025, the mere interest payments on the national debt are set to eclipse defense spending. For a household, this would be the equivalent of incurring credit card bill’s every month that are the same size as their mortgage payments.

The critical consideration to examine here is not actually the level of debt or the ratio of debt-to-GDP, but rather the cost of servicing the debt. This was indicative of why the Deagel Report was so important for the year 2025 projection of the U.S. population would be just 90-million. Twenty years ago I began to study the National Debt issue during the George W. Bush administration and the growing interest payments needed to avoid default. 2025 seemed so distant back then but we have nearly arrived. Empires in decline ultimately collapse due to their excess spending and taxing their people! As a sovereign state, the U.S. only has three years left to avoid collapse and there is nothing to suggest it will not happen!

China faces an equally bleak future and collapse as a global empire. The Evergrande real estate operation in China is the tip of their Lehman Bros. crack in the Chinese Yuan. The Evergrande debt crisis is an ongoing financial situation of Chinese property

developer Evergrande Group. After a letter circulated online of the company informing the Guangdong government that it was at risk of a cash crunch, shares in the company plunged in value, with impacts on global markets and a significant slow-down in foreign investment in China during August and September of 2021.

Thousands of retail investors, as well as banks, suppliers, and foreign investors are owed money by the company. As of September 21<sup>st</sup>, 2021, the developer has 2 trillion RMB (310 billion USD) in liabilities.

Evergrande's land reserves alone are large enough to house 10 million people. However, Evergrande had pursued an aggressive expansion over the last years, including ventures in electric vehicles, theme parks, energy, and many other sectors.

These leveraged investments included Ocean Flower Island, a 100 billion RMB (15.5 billion USD) project to build an artificial island in the South China Sea, plans to spend over 45 billion RMB (7 billion USD) between 2019 and 2021 in electric vehicle development, and ownership of Guangzhou F.C., China's richest football club.

On September 21, 2021, the *'Financial Times'* reported that "Evergrande used retail financial investments to plug funding gaps". In this scheme, the company raised billions of dollars through wealth management products (WMP), using that money to make up for lacks of funding in the company and re-pay other wealth product investors.

The products were highly risky, with an anonymous executive suggesting they were "too risky for retail investors and should not have been offered to them". However, they were marketed widely, with Evergrande managers pressuring subordinates to purchase products advertised at over 10% annual returns. In total, the remaining WMP liabilities stand at 40 billion RMB. It was for all intent and purpose a Ponzi scheme like that of the late Bernie Madoff who died in prison in August, 2019. His Ponzi investment scheme netted Bernie \$65 billion dollars and ultimately a prison life-sentence as well. Greed and churning the books eventually brings all schemes down, it is only a matter of time before an unplanned bump in the road that derails their elaborate schemes and plans. The Chinese are no different in the real estate market with Ponzi schemes.

Referred to as a type of supply chain finance, investors would invest money in shell companies they falsely believed to exist to supplement their working capital. As sales in the products fell, the business model of the products became unsustainable. The house of cards soon collapses.

An Evergrande executive is quoted as saying "Many people . . . might be arrested for financial fraud if investors don't get paid off. Our products were not for everyone. But our grassroots salespeople didn't consider this when making their sales pitches and they targeted everyone in order to meet their own sales targets."

Other Chinese companies have also sold wealth management products, including Baoneng, Country Garden, Sunac, and Kaisa.



### Three Red Lines

In an effort to rein in the highly indebted sector, the Chinese government enacted a “three red lines” rule to regulate the leverage taken on by property developers, limiting their borrowing based on their performance in debt-to-cash, debt-to-equity, and debt-to-assets metrics.

Evergrande is considered by analysts to be too big to fail and a Lehman Brothers–style collapse would have massive consequences on the Chinese economy and the world at large. You have no idea of these consequences but a war with the U.S. is quite likely and reason for your concern.

The new regulations greatly affected the property developer, which had historically leveraged itself heavily. So while the company’s stock price had outpaced the Hang Seng Index thirty-percent growth rate between its 2009 IPO and 2017, having multiplied eightfold, it had also become the world’s most indebted property group.

The *Financial Times* cited the director of S&P Global Ratings as stating that the developer was “so highly leveraged, it’s likely to breach all of the alleged thresholds”.

The company announced in March 2021 that it was looking to cut its debt load by 150 billion RMB (USD \$23.3 billion). Nonetheless, Evergrande was still expanding, having launched 63 new projects in the first half of 2021.

Other central and local government regulations, including mortgage lending limits, rent caps in big cities, and land auction cancellations, precipitated a slowdown in the property sector, as authorities attempt to control rising house prices.

A letter circulated online on the last week of August 2021, where Evergrande informed the government of Guangdong province that they were close to running out of cash.

The company alleges the letter has been fabricated and is “pure defamation”, and followed its circulation by a number of public announcements to reduce fears from investors and the public.

### The Default

In a statement on August 31, 2021, Evergrande warned it would default on its debts if it failed to raise enough cash to cover them. At the time, Evergrande was China’s most indebted real estate developer. It has at least three somewhat smaller companies that are on the verge of collapse.

On September 24<sup>th</sup>, Evergrande missed off-shore bond payments totaling \$83.5 million USD. While the company has 30 days to avoid defaulting on the debt, analysts feel it is unlikely to manage doing so. The crisis has profound global implications and brings shame to the CCP, they do not like to air their dirty linens and problems. They hide them with voracity.

### **Assets Sale**

In order to raise capital, the group has started to sell off some of its assets. Then on September 29<sup>th</sup>, 2021, the company sold a 20% stake in Shengjing Bank, retaining a 15% ownership share, raising 10 billion RMB (\$1.5 billion USD).

On October 4, 2021, the Cailian Press reported that rival Hopson Development was set to buy a 51% stake in the Evergrande Property Services subsidiary for around US\$5 billion.

### **Corporate Bonds Exposure**

American and European companies had significant exposure to Evergrande through their holding of corporate bonds. Ashmore Group, an emerging market specialist, owned more than \$400 million at the end of June while UBS itself owned over \$300 million. Other companies such as BlackRock held much less, with the world's largest asset manager holding just over \$18 million, and HSBC having a peak exposure of \$31 million.

On September 28, 2021, Sunac bought back \$34 million of its bonds and denied requesting government assistance. A letter, which the developer claimed was merely a draft, surfaced online arguing that recent regulations in Shaoxing intended to control property prices had left a local project unable to break even.

Last week on October 5, 2021, developer Fantasia Holdings missed a payment on a USD\$206 million bond that had matured the day before, triggering a default. Just weeks prior, the developer had assured investors it had "no liquidity issue".

The last time a financial failure of this size occurred was when the 9/11 attack on the World Trade Center in New York took place; when the Brady Bonds were to mature on **9/12/21**. I doubt anyone reading this is fully aware of the consequence of 9/11. [Misused collateral = gold security = bogus bonds = \$240 billion stolen currency]. The late President G.H.W. Bush stole \$240 billion when those Brady Bonds went up in smoke on 9/11/2001. Those Brady Bonds were set to mature on 9/12/2001, the day after the attack on the World Trade Center. Was it mere coincidence? Not in the minds of those who investigated the various crimes of 9/11. With the destruction of the WTC, physical proof of the bonds was up in smoke, and the Bond investors were out their principal and interest!

### **Potential Restructuring**

On September 22, 2021, the governments in Zhuhai and Nanshan District, Shenzhen took control of sales revenue for Evergrande's properties in a state-controlled custodial account to protect home-buyers and continue construction of the company's developments. Various provinces have been doing so since August as the developer has put hundreds of these projects on hold.

Off-shore bondholders hired Kirkland & Ellis and Moelis & Company to advise them ahead of a potential restructuring, according to the *'Financial Times'*.

Moving right along in this entire financial horror story that stands to paint a huge black eye on the CCP and China's role as a world economic power. This is where the insight of Clif High comes into providing us the larger picture background for understanding where we are at war with China. We are in a war with China, do not dismiss that fact!

Clif High did an overview in 'Flux Woo' a couple days ago which will prove beneficial to the reader about what is happening and why so. Clif is a computer programmer and analyst of linguistics revealed in Internet activity. I have listened to what Clif has said over the years and (I prefer not to use the word predictions) but his calls are validated by an accuracy level of 98-99% and so Clif is not someone to dismiss out-rightly. It takes a while to appreciate Clif in all of his vulgarity. So what I share here has a direct bearing on all of us, and so you can benefit from Clif's latest 'Flux Woo' remarks.

If we'd been told in mid-2019 that we would be living under the level of tyranny, oppression and institutional collapse that has since descended upon the world, we would not have believed it. That's why we are desperate to know the true reason why this is happening. The public knows something is wrong but they can't see how all the pieces of the puzzle come together. It's like trying to assemble a 5,000 piece puzzle without having the box cover to the puzzle.

In Clif's recent video, called 'Flux Woo' Clif High gives a thumbnail sketch of the geopolitical history that has brought us to this point and the agenda that is driving all of it. We can assess his version and put it side-by-side with all that we have previously observed and considered. I think he makes a lot of sense here and that this is a starting point towards an understanding the battlefield, the players, and what's next.

Ultimately, Clif thinks this all has to do with a dawning ice age and China's race against starvation, social chaos and potential collapse. This is what the rush is all about. I would agree with Clif and I will explain this shortly here. This is what we would call "the unknown" factor in what drives conflict or controversy. Think of it as akin to being a "missing" piece of a puzzle.

### **THE INTERNATIONAL GEOPHYSICAL YEAR**

Clif believes something major happened around 1955-1956 that rapidly spurred the creation of the International Geophysical Year, an international scientific project involving 67 countries that lasted from July 1st, 1957 to December 31st, 1958.

He says that Chairman Mao made a speech in 1958 that he thinks was a result of the Project's findings, in which he first announced that China must conquer the West and that over the next ten years, the CCP developed the plan of the "Three Pathways" for China to conquer the planet, based on Mao Zedong's premise that China must do so, in order for the CCP to survive. Clif says:

*"What they basically were going to do is destroy the West from the inside out, by making them dependent on cheap Chinese labor, subverting...our royals and leaders, by making those people dependent on the output of the cheap Chinese labor, in the*

form of bribes and participation and so on, whereas the populace in the West would be induced to buy cheap Chinese goods...and subvert our culture that way and then, a deliberate attack in the form of subversion of the media and a "Long March" through the institutions."

"So that was begun in the '60s and we're living in that world now. So all of the CCP's attack on the West – because it's not only the US – was begun during this period of time between 1958 to '68, when they solidified the Three Pathways plan."

"And that plan, in the 1970s, '79, I think, led to this professor, who was an instructing, teaching professor at the People Liberation Army's version of the War College; he started writing a cohesive plan for implementation of one of these Three Pathways, which was the subversion of the culture, such that we would be unable to fight back..."

"So Mao was aware, in 1958 of whatever it was, in 1955 or '56 that caused the International Geophysical Year to happen, because that was not organic..."

"But that effort, in 1957-1958, in the Geophysical Year set a huge chain of events going that we're living through, right now, that culminated in the Climate Change extremists, out in Britain, the Climate Change, Global Warming efforts, all of...these lies that the Powers-that-Be have been spewing out about originated came from whatever occurred in '55 or '56 that got them so spooked..."

"It basically involved a lot of mapping of the planet, poking around in the bottom of the oceans, looking up in the skies and going to Antarctica...Mainly, they ignored the Arctic..."

"So all of these people in China were working on this plan to do something relative to saving China...and in '68, they start maneuvering, via the UN...to the point where, in '69 to '70, there were contacts, even though we were technically at war with them in the proxy state wars, in Vietnam and elsewhere, the Chinese were in contact with our government very extensively through these UN backchannels, leading up to the point where Nixon announced that he's going to go on over and have a face-to-face meeting with the ChiComs there."

"He announced it in '71 and he went there in, like May of '72...It was already a done deal, it was only a PR thing. It was not any negotiations or any of that. In fact, they may have just been negotiating the details of some of these 700 factories that they were having built."

"So they knew, probably as early as '68, because of the cooperation between the U.S. Deep State and the Chinese Deep State, they knew that they were going to offshore all of our jobs and gut out as much of the West as they could, in favor of China."

"And so, they did it to the US, they did it to Australia, they did it to New Zealand, Britain, most of Western Europe, etc. have been hollowed-out for manufacturing by converting

everything over to the Chinese, as a result of this effort, that I say had been planned for 10 years.” “They” in this case are the Global Elite, “Committee of 300”, the International bankers, the Vatican, Jesuit/Freemasonry, etc.

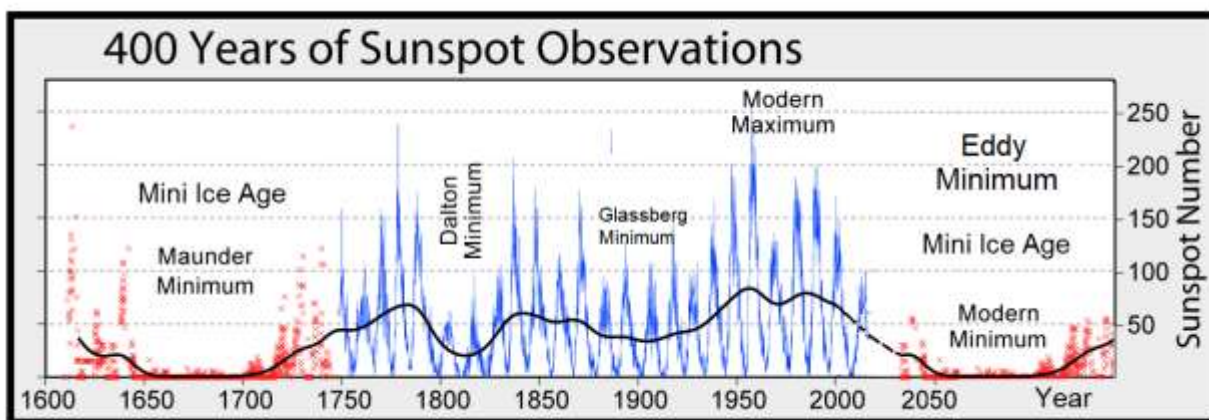
"And then...this professor writes the book, 'Unrestricted Warfare' and he basically talks about killing off 200+ million people in the United States... “

"They were going to do it with a **bioweapon**, they were going to do it by having 40 years of destroying our culture ahead of time, so that we can't fight the bioweapon, because we'll be hamstrung by them having captured the power elite and all of our institutions, especially including the media, which will allow them to control our response to the **bioweapon**, so that nobody will ever know that the Chinese released it and they won't have to worry about it.”

### THE IMPENDING ICE AGE & FOOD CRISIS

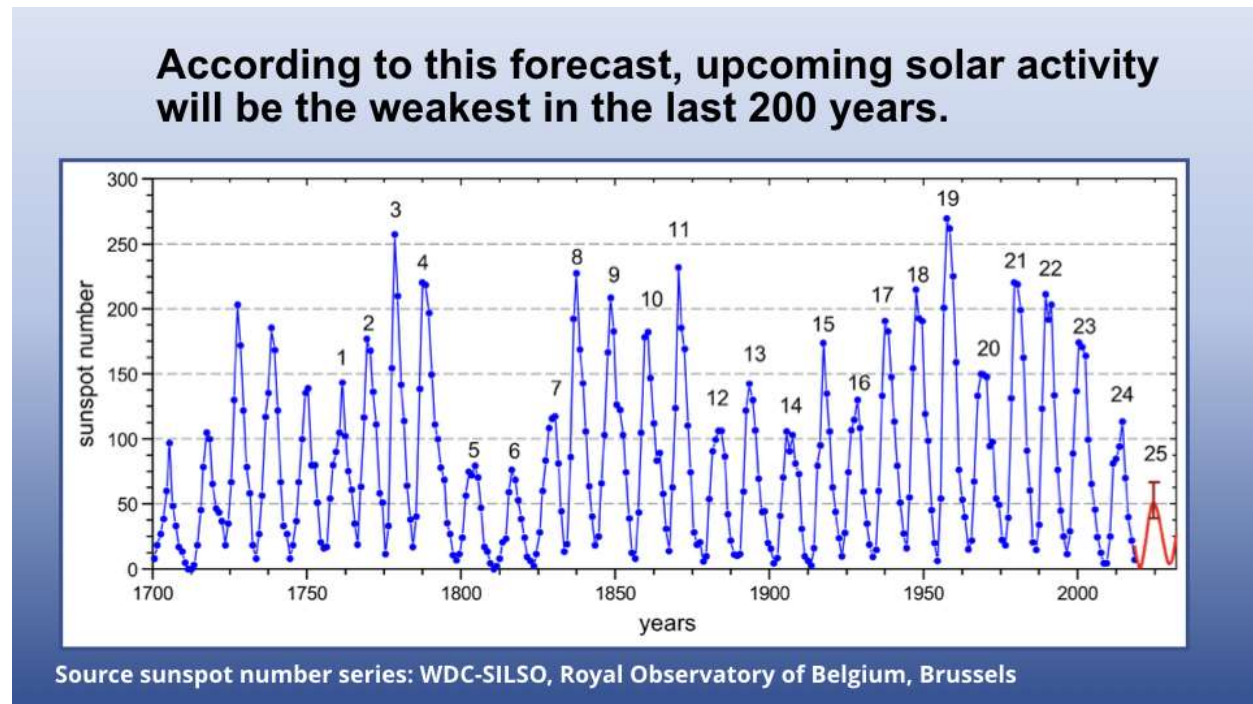
"In the '90s, the CCP recognizes that their population levels will inevitably lead to a food crisis...This definitive food crisis is known to be connected to Solar System changes and a Grand Solar Minimum.” The Sun is the real cause of global warming or climate change, whatever label you want to call it by.

As to why all this is so significant is found in the research work and focus of a geologist by the name of Douglas Vogt. Doug Vogt has a theory, and it is well-documented to be credibly sound and believed by many in the scientific community, that **the Sun Nova's every 12,068 years**. Doug notes evidence worldwide of the Sun's Nova going back for several time periods at precise 12,068 year intervals. **According to Doug Vogt's mathematical data, the next Nova takes place in the fall of 2046**. This is the real cause of global warming and once the Sun Nova's, it will wipe out all life form in its path and the Earth will be covered by a layer of ice several thousand feet deep, depending on which portion of the planet that is most affected by the Sun's Nova.



If you are familiar with the Sun's 11 year solar cycle you will have a basic understanding of what I am referring to here. This chart alludes to the coming Mini Ice Age, but according to Doug Vogt, it will be larger than anyone can imagine. The Earth's geological record indicates that we are just 25 years away from the next Nova event.

When the Sun Nova's its internal clock trips an explosive outburst sending energy and debris out in all directions. In the fall of 2046, the effects of the Sun's Nova will stop the Earth's rotation from west to east, stand still for 8 to 10 hours, and then begin to rotate in the opposition direction, from east to west. There is no need here to go into what all occurs during this Nova event. But it is not good for life as we know it!



Doug Vogt is the author of several books, and the one I have read was *'God's Day of Judgment: The Real Cause of Global Warming'* published in 2007. I do not know if Clif High is familiar with Doug Vogt or his work but he understands what the Grand Solar Minimum is all about. Clif High is a computer programmer and analyzes linguistic patterns in the data-sets of communications. That may not mean a whole lot to you but he can interpret the meanings of language, trends, crisis points, inflection points, and in how events play out in the larger society. It is his targeted accuracy that most of us who follow Clif High continue to pay very close attention to what he says.

According to Catherine Austin Fitts and Dr. Mark Skidmore of Michigan State University, the powers at be have stolen \$21-trillion dollars from the U.S. Treasury to fund space programs, but more likely that money went into building DUMB bases. These are "Deep Underground Military Bases". The program began in earnest after the first legitimate trip to the moon. In the brief few minutes on the moon's surface the astronauts spent on the moon, they were looking specifically for evidence of previous Nova's of the Sun. They discovered that the moon craters were covered and littered with silicate glass beads, an indicator of previous Nova's of the Sun, according to Doug Vogt. All of the astronauts that went to the moon were required to sign "NDA's" or Non-Disclosure-Agreements on what they found on the moon's surface. Silicon is in fact the main

constituent of 95% of the rocks on earth, and 2.8 billion million tons of it is currently to be found in the ocean as dissolved silica.

The information that has leaked out over the last few decades by government contractors who worked on the construction of these DUMB tunnel system contend that the country is crisscrossed with a network of deep underground bases and tunnels. Why so and for what purpose? Doug Vogt said that the CIA was entrusted with the information on the discovery of the Sun's Nova and it quickly became the impetus to save the elite in a coming Nova of the Sun. It was as Doug Vogt says, "the greatest single secret" until Douglas Vogt and others began publishing their findings.

Interestingly, there is a place in India that suggests a previous civilization had achieved the level of splitting the atom. Today to the eastern edge of the great Thar desert, where sits the ancient city of Jodhpur, India and ancient radiation from what is believed to be a nuclear blast. According to a story backed up by numerous articles online, indisputable evidence of an ancient nuclear war can be found throughout the region. Some of it sounds rock solid and indisputable. Could it possibly be true that the ancients figured out atomic weapons, 8-12,000 years ago? Doug Vogt's research confirms it to have been a real possibility!

To summarize the most popular version of the tale: a short distance west of Jodhpur is a region where radioactivity is so great that residents have long had high rates of cancer and birth defects, and that has now been cordoned off by the government. In addition, an ancient city has been excavated that shows half a million people were killed by an atomic blast the size of the Hiroshima bomb. Archaeologist Francis Taylor is quoted as having said:

*"It's so mind-boggling to imagine that some civilization had nuclear technology before we did. The radioactive ash adds credibility to the ancient Indian records that describe atomic warfare."*

The ancient records he's referring to are from a great Sanskrit epic of ancient India titled the Mahabharata. It appears to describe a nuclear war: A single projectile charged with all the power in the Universe... An incandescent column of smoke and flame as bright as 10,000 suns, rose in all its splendor... It was an unknown weapon, an iron thunderbolt, a gigantic messenger of death which reduced to ashes an entire race.

The evidence findings of Doug Vogt and Jodhpur, India confer considerable support for what Clif High talks about next.

*"So, the CCP knew, in the '90s that it wasn't going to be Global Warming. They knew that there would come a time, when they were going to be facing, basically – as I've been saying since 2000 or so – an ice age."*

*"They were preparing for the impact of the food crisis on their population. If we fast-forward to today, we have that food crisis now.."*

*"In the 1990s, the CCP realizes they're going to have to feed their populace or their populace rebels. And they also recognize that there was some unknown period of time that we were going to reach this Grand Solar Minimum and its effects."*

*"And we're having those effects now."* Remember, **2046** is only twenty-five years away!

China has been losing incrementally more of their crops due to climate change from the impending ice age and it could lose as much as 50% of the harvest this year. If this loss translates into 50% of the country, or 700 million people not eating and who have nothing to lose by overturning the CCP that could spell trouble for the latter.

Independent of the above, the Petrodollar is crashing, the Chinese have been de-dollarizing their assets and Clif says they're in the middle of double-crossing the Power Elite, globally. They were only in league with them as a sucker play and they are reneging on all of their agreements.

China's got a food problem, a huge one at that, they need to take over the United States in order to turn it into a giant farm to ship food back to China. Clif says they made a deal with the Russians in the '70s, where China would get Newfoundland, New Brunswick, all of the US and the northern half of Mexico and Russia would get Alaska and the rest of Canada.

*"The idea is, if you read their literature, the Han Chinese propose a Chinese-only planet, with the exception of a few slave races. They seem to favor slave races out of Africa...but in the last few years, there seems to be a lot of souring on that."*

*"The idea was they would keep their Asian, phenotypically-related cohorts around, as they decided which ones were good and which ones were bad. But they wanted to get rid of all the whites, totally and all the indigenous populations, except in Africa, they would keep Africa as a breeding ground for slaves, that's the idea of the Han Chinese."*

*"So it would be a Chinese-only world. And in order to accomplish this, they had this particular plan [COVID]."* Think of the second **"M"** here as **Method!**

Clif says it's a matter of 4 or 5 years before there's observable evidence of an ice age. As the result of the Grand Solar Minimum, the Sun's magnetosphere shrinks, which allows more cosmic rays to strike the Earth, which results in nucleation and high precipitation and potentially even the creation of "Star Water", such as some theorize to be the source of the rains that caused the Flood of Noah.

These same cosmic rays proceed to the Earth's core, which Clif believes is not made of iron but of plasma and which becomes excited by cosmic radiation, causing the plasmid core and consequently the Earth to expand and of course, increased volcanic activity, such as we've been seeing. Doug Vogt states that increased seismic volcanic and earthquakes are to be expected as we get closer to the **2046** date.



If there's good news in any of this, it's that we are safe from Chinese nukes and they don't want to set off an EMP to take out our electric grid, because they need our land to farm and they need to have everything working so that they can plug-and-play, before their people starve.

"So, it's a real complex problem for the Chinese. They need...bare minimum, 200 million Americans gone...But they can't do an invasion, because we're all armed...They can't do any kind of damage that would risk damaging the nuke plants."

"It's a very precarious kind of a takeover that they've got to engineer. They've got to have our society crash down just enough to the point where we're not a problem and they can come on in and take over the nuke plants and then wipe out the rest of us and they don't want us to collapse so much that all the nuke plants go ahead of that and pollute the whole area..."

### THE BIOWEAPON

"And so that brings us to their attack. So, they release COVID. That wasn't really the weapon. The spike protein in the weapon and...it's complicated, but our power elites handed over to the Chinese blackmail material and the Chinese took it and blackmailed them, got them involved in the whole plan." The U.S. government had the motive, China had the method, and they both have the means to pull off this crime against humanity!

"They're captured, just as our media is captured, the courts are captured, Congress is captured, the electoral processes are captured and Biden is captured. All the sh\*t's been captured by the Chinese, because they have actually taken over all of our medium-level global minions, in concert with the upper high-level global elites, the Illuminati, the real Deep State players."

"But a lot of our Deep State players are now captured by the Chinese. They were f\*ers and evil anyway, so it doesn't matter much; they're still doing their f\*ery and their evilness but now they're doing it for the Chinese on the behalf of the Chinese, where before, they weren't, really so much."

"So now, we've got the media captured, they've released their bioweapon, they've stolen our elections digitally and through other fraud, both nationally and regionally since 2004. They captured the Congress, the courts, the executives, the school systems, had us appoint incompetent military leaders, they've deliberately had us do foreign policy errors [like the Afghanistan withdrawal]..."

"They're going to have us do a lot more of it. This isn't done. This is all part of their plan. They've got us in a supply system failure that they're engineering now. There's no real reason for the supply system to fail, they're just engineering it all, because they've got to get us all out now, because of what's going on in their world relative to 2021 [crop losses]."

*"And if there isn't a resolution, then they know for sure in 2022...there will be more floods, the Three Gorges Dam will be under greater pressure. It may go and even if it doesn't, they're going to have so much in the way of floods and damage that they will harvest maybe one third of their crops...in 2022, which means they've got to take their food from somebody else, somewhere, some way and they're not willing to pay for it..."*

### **THE SOC**

*"The only way that this works is if nobody knows that the Chinese attacked us; the CCP deliberately released the bioweapon. That's why they work so hard, with Fauci and all the other f\*ers, all the captured, blackmailed employees of the United States government. That's why the Chinese and the CCP and these f\*ers work so hard to try and engineer that we would not understand that this bioweapon was deliberately released." This rounds out our Criminal investigative three "M's", "Method!"*

*"Because, if we can all point to China, then this plan does not work. It only works if we think it's...natural and organic and that our power elites are just f\*ing-up. It only works if we just think Biden is so stupid and dementia-ridden that he's doing this for our health, because he believes that, as opposed to deliberately crashing our healthcare system so that many more people will die in the United States in this coming year..."*

*"It only works if we don't know that the Chinese have told Trudeau to stop Canadians from going over the border, so that they can kill them in Canada. See, they've got to isolate all the countries. You can't know what's going on in all the other countries. It pisses them off that we know what's going on, to some degree in Australia, just as it pisses them off that other countries are now forming these common bonds of suffering under the CCP attack on the whole f\*ing planet..."*

*"And all of this sh\*t's going to get worse but I'm of the opinion that none of this stuff's going to work out in the fashion that the elite and the CCP want and that's because there was, in 1963, in the Kennedy Assassination, we have this Self-Organizing Collective (SOC) that formed."*

The SOC put Trump in place and stopped them from stealing the Election, the way they had since 2004, when they stole county elections and installed some 30,000 assets at those levels. They stole the 2008 elections to get Obama in, who was supposed to do away with the 2nd Amendment, with the endless false flags he ran. The Democrats had a twenty-year plan to transform the U.S. into a communist-socialist State. Trump's election derailed the twenty-year plan.

*"The CCP will not invade as long as the U.S. populace has weapons. The only way they can come is under the guise of UN troops, which would only work for so long before we began to shoot them."*

*"They had planned for us to go to war with North Korea and have North Korea nominally win the war, according to our captured press, who would show our aircraft carriers*

*sinking and tell us that we lost and so we'd have to surrender the Constitution, which gets rid of the Second Amendment and then the Chinese would come in and take over."*

*"Hillary was supposed to do all of this during her 8 years and they're behind schedule and about to starve." Clif thinks the CCP is losing. "The coronavirus was not as deadly as they'd hoped because we have higher vitamin D levels than they thought. The failure of the coronavirus is why they launched the vaxxine."*

*"The people who are dying of COVID have vitamin D levels under 20 ng/ml. If you have levels over 47 ng/ml, you are immune to the coronavirus. No virus is any stronger or communicable than any other against a healthy immune system."*

*"The Mainstream Media is the only thing that's really keeping this going and they are dying and are about to experience complete narrative collapse before the end of this month." Clif was referencing the month of October, 2021. He suggests huge change and upheaval is just ahead.*

*"When that happens, everything changes...The SOC can get a lot more stuff done, because they're not constantly running into this battle in the information wars. They'll be able to flood the place with information and change minds and things change very rapidly, because they won't have a lot of pushback to the information they'll be providing to us. At that point, things will change very rapidly..."*

*"By the time we get into January, we will have confirmation that the SOC has, indeed engineered all of this stuff, to the point where we have our first ability to take a deep breath, relax [and say] OK, we're going to win this. It's going to be ugly but we're going to survive and we'll be able to pull out of this..."*

*"We have crop failures in the U.S. but we don't have to have crop failures. We can seize lands from Bill Gates...If they seize his assets because he's in league with all of these f\*ers and he's a non-military combatant...then, they take his assets and we have all this farmland restored and we put it back to work."*

Food shortages are now becoming clearly evident throughout the United States. For over a hundred years, this nation not only fed itself, we fed much of the world. Now look at what American shoppers are seeing when they go to a local supermarket -- empty shelves. It has been government agencies responsible for the shutting down of planting crops in the agricultural valley of California, and ranching around the country. **The Department of Agriculture has been paying farmers across the country a 50% bonus NOT to plant their crops this past summer.** It is part of a plan to undermine our ability to be self-supporting for food sources.

The Deep State stole the election and got Joe Biden sworn-in to office on January 20. We know that China played a huge role in the stealing of the election for Joe Biden. Dominion voting machines were virtually in every precinct in the U.S. They are a CCP company and real-time voting data was being tracked that showed heavy CCP

Historically, the start of most wars has not been a surprise. Usually, there is a very clear build up before hostilities begin, and we are seeing the same pattern today.

For example, by now it should be exceedingly clear to everyone that Israel and Iran will be going to war. Both sides have been talking about the coming conflict for years, and

everyone knows who has been causing the "mystery explosions" inside Iran and everyone knows who has been attacking Israeli commercial ships.

A "shadow war" has already been going on for quite some time, and at some point missiles will start flying back and forth between the two countries. Likewise, by now it should be exceedingly clear that China very much wants to invade Taiwan.

"Reunification" is a top national priority for the CCP, and as you will see below, we are being warned that Xi Jinping has apparently decided that Taiwan is *"not a problem that will be passed down to the next generation"*.

From a U.S. perspective, the goal is to delay these conflicts for as long as possible. But China just keeps getting more and more aggressive with Taiwan. In fact, the Chinese military sent 77 military aircraft into Taiwan's air defense identification zone on Friday and Saturday. Daily the Chinese air force intrudes into Taiwan air space in provoking a response to which they will then respond with a massive air and missile attack.

Taiwan has reported a record number of incursions by Chinese warplanes into its air defense identification zone (ADIZ) for nearly a week daily in a row, Taiwan's Ministry of National Defense said on Saturday night. The self-governing island said a total of 39 Chinese military aircraft entered the ADIZ on Saturday, one more than the 38 planes it spotted on Friday.

This shocking provocation led one British news source to boldly declare that China and Taiwan *"are on the brink of war"*, and that isn't too far from the truth. The Chinese air force intrusions into Taiwan air space are probing for weak points in the event of a real attack.

In response, the head of Taiwan's government had some very tough words for the Chinese... *"China has been wantonly engaged in military aggression, damaging regional peace," said Taiwan Premier Su Tseng-chang on Saturday.*

And she also referred to the fact that Taiwan is depending on the United States to protect it from China. Japan has pledged to support Taiwan and although the U.S. has a treaty to defend Taiwan, China saw the abandonment of Afghanistan as a "Green" light to begin and take Taiwan. The Afghanistan debacle played into the hands of Xi and his plans.

*"The U.S. commitment to Taiwan is rock solid and contributes to the maintenance of peace and stability across the Taiwan Strait and within the region," he added. "We will continue to stand with friends and allies to advance our shared prosperity, security, and values and deepen our ties with democratic Taiwan."*

When China finally invades Taiwan, the U.S. and China will instantly be in a state of a hot war, and everyone understands this.

At one time the Chinese had hoped to peacefully "reunify" with Taiwan like they did with Hong Kong, but that has been off the table and is out of the picture now. CCP leaders have realized that they are going to have to take Taiwan by force, and so they are looking for an opportunity. It has been almost a year ago Chinese soldiers in the area facing Taiwan were told to write letters home to their families and say their goodbyes as they prepared for war plans to invade Taiwan..

With a feeble doppelganger standing in for the brain-dead Joe Biden in the White House and with the American people deeply tired of wars, this may be the best chance that the CCP is going to get, and they certainly realize this. Nancy Pelosi let the cat out of the bag two weeks ago by mentioning former President Obama is running the "pretend" White House show.

So could the CCP pull the trigger on an invasion in the months ahead? They may have to because of their own financial problems at home with a hungry 1.4 billion people. Two years of huge crop losses at home from flooding, has a nation of grumbling Chinese citizens. For example, a group of six eating out at a restaurant can only order for five, with the sixth person required to share from the other five.

There is no doubt that "weather warfare" has been used, both in the case of China but also in the case of the U.S. west coast and heart land region. Peter Kirby in his book, *'Chemtrails Exposed: A New Manhattan Project'*, drills down into the players behind aerial spraying toxic poisons and chemicals on the U.S. They are integrated into the Agenda 2030 Eugenics program to "Depopulate" the planet of 7 billion people through the use of *'Silent Weapons for Quiet Wars'*.

But the clock is ticking, because as I noted above, we are being told that Xi Jinping has determined that Taiwan "is not a problem that will be passed down to the next generation".

However, President Xi Jinping in China has previously expressed his aims to annex the island by suggesting there is *"no room for any form of Taiwan independence."*

Dr. Nick Bisley, from La Trobe University in Australia said: *"Xi Jinping has made a very public and very clear signal that says Taiwan is not a problem that will be passed down to the next generation."*

Meanwhile, the game of nuclear chicken that Iran and Israel are playing is rapidly approaching a moment of truth.

Just like his predecessor, Israeli Prime Minister Naftali Bennett has promised to never allow the Iranians to develop their own nuclear weapons, and everyone agrees that day is now closer than ever. The following comes from an Israeli news source.

In his speech to the UN General Assembly last week, Prime Minister Naftali Bennett declared that *"Iran's nuclear program has hit a watershed moment, and so has our*

*tolerance. Words do not stop centrifuges from spinning... We will not allow Iran to acquire a nuclear weapon."*

With quite dramatic candor, meanwhile, IDF Chief of Staff Aviv Kohavi publicly declared (in January) that the IDF was preparing fresh "operational plans" for a potent military strike; (in August) that Iran's nuclear progress has prompted the IDF *"to speed up its operational plans,"* with a fresh budget to do so; and (in September) that the IDF has *"greatly accelerated"* preparations for action against Iran's nuclear program.

Needless to say, a full-blown war between Israel and Iran would also throw the entire globe into a state of chaos, and it is coming. In fact, a top Iranian official just said that *"war with Israel has already started"...*

*"The war with Israel has already started,"* Iranian Foreign Ministry spokesman Saeed Khatibzadeh told Maariv. *"Israel has carried out attacks that were intended to destroy our nuclear program for peaceful purposes. It murdered nuclear scientists and harmed the Iranian people. Iran is accused of terrorism, but there is no good or bad terrorist. The whole crisis in the region is Israel's fault."*

If either of the wars discussed in this article were to fully erupt before the end of this calendar year, economic activity all over the planet would be greatly affected and it would make global supply chain problems far, far worse than they are now.

In addition, global financial markets would almost certainly go totally haywire. Much more importantly, in either case the U.S. would find itself involved in a new war. **The fact that both wars could begin simultaneously should not be ruled out. Such a scenario is far more likely than not since China, Russia, and Iran are ideologically and treaty wise are linked tightly in opposition to what they consider the Big Satan and the Little Satan.**

If China invades Taiwan, the U.S. military would instantly be forced into action, and if Iran and Israel go to war the U.S. would be strained to assist in a two-front war. The U.S. military has degraded with such things as Critical Race Thinking, mandating of vaxxes for the military, and diminished morale issues related to the clown that is pretending to be the president. Even with the largest military budget, it is apparent that the U.S. Navy is stretched thin with such things of restricting Navy home port operations to Monday through Sunday operations only so as to not require overtime for contractors.

As I entered this information, there are 60,000 Haitians illegal immigrants, mostly Haitians, are anticipated to pour over the border into the United States in the coming weeks, and a second caravan is waiting in the wings, ready to launch an even more devastating assault on the country. The system is overwhelmed and unable to screen, vet, or determine the health of the invaders. No country can absorb this many immigrants monthly without a collapse of the social network to do what a country needs to do to insure the security and safety of the U.S. population and its borders. Every measure that was in place by the Trump administration has been

reversed and removed by the Democrats and are likely being orchestrated by Barack Obama and his Chinese CCP friends.

As Clif High pointed out, the CCP has already deeply embedded itself with the social and political fiber of the country. That was clear long before the release of the Covid-19 since the CCP at the Wuhan Lab was conducting its own “gain-of-function” efforts with the help of Dr. Robert Barrick of the UNC at Chapel Hill, NC, Dr. Peter Daszak’s Ecohealth Alliance, and others being funded by and through Bill Gates, Drs. Robert Redfield, and Anthony Fauci.

Peter Daszak’s Ecohealth Alliance hid almost \$40-million in Pentagon funding and militarized pandemic science. To be specific, there are grants and contracts showing that **\$38,949,941** was given by the U.S. DoD. The funding goes way beyond merely working on Gain-of-Function for SARS-CoV2. This funding paid for work on a number of viruses, raising serious concerns about new pandemics resulting from Gain-of-Function work.

Nothing speaks more clearly about this research and violations of the Biological Weapons Convention treaty than the use of terms like *‘weapons of mass destruction’* and nothing says biological weapons more than funding from the Department of Defense.

What new pandemic now awaits humanity given this Gain-of-Function funding by the DoD and other federal agencies, including SARS-CoV2 and other viruses, bacteria, and biologic pathogenic agents?

All of what I have shared here in Part 2 paints a pathetic picture of a Satanic sinister group of people in power that have **Motive, Means, and Method** to wage war upon its own citizens. What follows in this expose further makes my case.

### **PLANDEMIC CRIMINALS – INDICTABLE EVIDENCE**

Dr. Richard M. Fleming has given all the indictable evidence needed to start arresting and convicting the criminals behind the current plandemic that has devastated the entire world economically and has killed and maimed millions globally.

His new book: *‘Is COVID-19 a Bioweapon, A Scientific and Forensic Investigation’* provides the blow-by-blow plan to create a viral bioweapon of mass destruction. He provides the proof of the U.S. sources of funding to the criminals who set out to violate all laws concerning gain-of-function biological research to create a laboratory created synthetic virus that was designed to kill as many people as possible.

He offers the original documents that prove Dr. Anthony Fauci and his gang of bio-criminals at the National Institutes of Health (NIH), the Center for Disease Control and Prevention (CDC), and many other U.S. Federal agencies used to gain grants and patents to turn public laboratories into killing machines with US taxpayer money. He



also gives the dates and contents of publications wherein these criminals brag about their research to the world without shame and with seeming impunity.

Below the reader will find the summarized and condensed excellent work of Dr. Fleming into a readable form for layman who might not be familiar with medical terms concerning this deadly research. Make no mistake about it, your government wants you dead and they are not ashamed to let you pay for your own demise.

Fleming does not draw conclusions or demand judicial action to be taken against these “war actors”, but you will yourself, no doubt, come to the same conclusions that we did when presented with the overwhelming evidence that shows the broad trail of crimes that have led to our current world dilemma. Dr. Fleming’s book confirms and validates everything I have been saying relative to “Depopulation”.

You will surely ask the question, Why aren’t these criminals in jail and being held accountable for their consciously perpetrated crimes? This question, which is inevitable, needs to be addressed by law enforcement, the Department of Justice, the U.S. Congress, the president of the United States and any honest judges left in this country to defend U.S. Civil Rights and the United States Constitution. These crimes must be prosecuted if freedom and life as we know it are to continue to go on in America. As Dr. David Martin presented this past year some 4,000 pages of patents, going back over twenty-years, our government is complicit in criminal activities in which the Vaxxes are harming and killing multiple thousands.

In **2002**, following the SARS-CoV-1 outbreak in China, Dr. Shi Zhengli-Li and colleagues at the Wuhan Institute of Virology began investigating how SARS-CoV-1 was transmitted. In particular Zhengli was interested how SARS-CoV-1 was transmitted from person to person. To do this, she developed chimeric (Gain-of-Function) coronaviruses using human immunodeficiency, virus-based pseudo virus systems (laboratory man-made viruses) using the cell lines of people, civet cats, and horseshoe bats.

In March **2004**, the U.S. Health and Human Services agency announced that it was going to create the National Science Advisory Board for Biosecurity to be managed by the National Institutes of Health, thus consciously violating US laws prohibiting such research.

In **2005**, Dr. Ralph Baric published a paper declaring he could alter the genome of coronaviruses. In 2006, using chimeric (Gain-of-Function) research, Chinese scientists in Wuhan reported their ability to combine parts of four different viruses into a single viral genome.

They combined parts of four viruses: hepatitis C, human immunodeficiency virus (HIV-1, AIDS), SARS-CoV-1, and SARS-CoV-2. Thus, COVID-19 was made in a laboratory as an attempt to kill human beings.

When the Swine Flu vaccine of the mid-1970s produced neurological damage, including Guillain-Barre syndrome, following the first twenty-five deaths, the swine flu vaccine and vaccination program was stopped by the U.S. Government.

Today the Vaccine Adverse Event Reporting System (VAERS) shows sixteen thousands of deaths following SARS-CoV-2 vaccinations with over 600,000 experiencing severe adverse effects, and yet, this CDC provide data has not ended the use of COVID vaccines (DNA manipulation fake-vaccine) and the harmful vaccination program killing and harming Americans.

Two published papers looking at the consequences of the SARS-CoV-2 spike protein penetrating the brain of humanized mice and rhesus macaques show brain inflammation, mad cow disease (Spongiform encephalopathy), and Alzheimer disease. (Mariano Caroosino et al., January 2021 & Ingrid HCHM Philippens et al., May 5, 2021.) In other words, even though all of the mice showed damaging inflammation in their lungs, all the animals died due to brain damage with the virus entering the brain through the olfactory system (nose).

It is critical to understand that it makes no difference whether the spike protein of SARS-CoV-2 is introduced into the body via person-to-person transfer or via injection of biologicals (vaccines), the net effect is the same.

In **2012**, an investigation into Gain-of-Function research resulted in a voluntary moratorium that lasted almost one year and ended in January 2013 due to the dangers of biological experimentation concerning all viruses.

In **2014**, shortly thereafter, Dr. Ralph Baric and Chinese researchers published a paper demonstrating the differences between spike proteins that can infect bats and those capable of infecting people.

This research was funded by National Institutes of Health grants RO1AI089728 and R21AI109094. In October of 2014, only one year after lifting the moratorium, the Obama Administration placed a ban on Gain-of-Function research after it was discovered that the CDC had accidentally exposed workers to Anthrax and “unwittingly” shipped out samples of influenza virus contaminated with the deadly H5N1 virus.

In **2015**, Dr. Ralph Baric and Zhengli both announced they had “reengineered, through Gain-of-Function, the spike protein of coronavirus so they could infect human cells.” (Y. Yang et al., Journal of Virology 89, no 17, 2015)

This research was paid for by NIH grants RO1AI089728 and RO1AI110700. Recommendations for the oversight of Gain-of-Function research were made on April 7, 2016, and approved on March 15, 2016, by the National Science Advisory Board for Biosecurity. Dr. Anthony Fauci is an ex officio member of that board. But this notwithstanding, the research moved forward in America and China.

## **Laws Concerning Gain-of-Function Research**

The U. S. law that will put bioweapon makers and funders into jail is:

**United States Federal Code 12 U.S.C. Chapter 10–175** – which expressly prohibits such biological weapons and makes it a criminal offense.

“175. Prohibitions with respect to biological weapons

(a) In General. – Whoever knowingly develops, produces, stockpiles, transfers, acquires, retains, or possesses any biological agent, toxin, or delivery system for use as a weapon, or knowingly assists a foreign state or any organization to do so, or attempts, threatens, or conspires to do the same, shall be fined under this title or imprisoned for life or any term of years, or both.”

Other provisions for prosecution of bioweapon makers, producers, conspirators:

**Biological Weapons Convention Treaty of 1969** – signed and ratified by the United States of America in 1972. It is a violation of the treaty to develop, acquire, retain, or produce any biological agent or toxin that has no justification for prevention or peaceful purposes.

**The Nuremberg Code 1947** – includes such principles as informed consent, absence of coercion, properly formulated scientific experimentation, and demands beneficence towards experiment participants.

**International Covenant on Civil and Political Rights-1976** – provides for respect for civil and political rights of individuals, including the right to life, freedom of religion, freedom of speech, freedom of assembly, electoral rights, and rights to due process.

**In October of 2014, the US government issued a policy statement regarding Gain-of-Function research including the following restrictions:**

“New [US government] funding will not be released for gain-of-function research projects that may be reasonably anticipated to confer attributes to influenza, MERS, or SARS viruses such that the virus would have enhanced pathogenicity and/or transmissibility in mammals via the respiratory route.” From all that we know, it would appear no one read the 2014 policy statement. They had a decade to read it!

## Timeline of Crime

We can find the criminals behind the pandemic by looking at publications and documents from the Department of Defense, National Institute of Health (National Institute of Allergy and Infectious Diseases), Centers for Disease Control and Prevention, Food and Drug Administration, Health and Human Services, National Science Foundation, EcoHealth Alliance, U. S. Agency for International Development, Department of Commerce, Department of Agriculture, Department of the Interior, U. S. Patent and Trademark Office, National Biosurveillance Integration Center, and other federal agencies. When ordered to stop the work they chose to job out “Gain-of-Function” work to the not-so-friendly CCP.

**1974** – The first reported genetically altered (Gain-of-Function) virus QB phage was created.

**1985** – Dr. Ralph Baric began working with coronaviruses in the mid-1980s. In 1985, while at the University of California (UCLA) conducted research on recombinant viruses, including coronaviruses which was paid for by the National Science Foundation and U. S. Public Health and Human Services agency (HHS) by grant A1 19244.

**2000** – Researcher in Spain and Paul Ahlquist from the University of Wisconsin showed how combining complementary DNA with nuclear expression of RNA allowed the researchers to develop a synthetic virus. The spike protein of the virus was replaced with the spike protein from another virus creating a chimeric (Gain-of-Function) virus that infected the gastrointestinal system of pigs. The researchers discovered this could now be done with dogs, cats, and humans.

**2000** – With funding from NIH (Grant A1 239476) Ralph Baric and others enhanced a transmissible gastroenteritis virus. This infective transmissible virus, produced synthetically in a laboratory, was indistinguishable from the wild-type virus.

**2001** – German researchers used smallpox virus DNA to produce an infectious coronavirus using restriction enzymes that work like molecular scissors to cut DNA and ligate it into a vector. (Masters, 1999; Almazan et al., 2000; Yount et al., 2000). With this DNA manipulation, it became possible to rapidly generate a large collection of genetically modified coronaviruses. Expression of multiple subgenomic mRNAs in infected coronaviruses formed the basis of creating vector systems, each encoded with heterologous protein. These features could then be exploited in the development of a new class of RNA vaccine vectors.

**2001** – In May, Dr. Ralph Baric and colleagues applied for a patent to manipulate genes and profit from genetic manipulation of plants, animals, bacteria, and viruses – including coronaviruses. The patent was granted on July 15, 2003. This research was supported by U. S. taxpayer monies.

**2003** – Dr. Ralph Baric and others published research funded by NIH (grants A123946, GM63228, A126603) showing they could rescue SARS-CoV Urbani viruses by using

reverse genetics. They then could fully clone SARS viruses. This process increased the infectivity for SARS-CoV-2 and has been shown to insert its genetic sequence into the human DNA. This research was funded by the NIH (1U19AI131135-01, 5R01MH104610-21).

**2006** – Chinese researchers spliced four target cDNA segments together to form a single 1,200-nucleotide-long RNA sequence. This chimeric (Gain-of-Function) sequence included combining hepatitis C viruses, human immunodeficiency virus (HIV-1 AIDS), and SARS-CoV-2.

**2007** – In May, a patent was granted for isolation of human SARS-Co-V-1 to the U. S. Department of Health and Human Services agency (HHS). This established the polymerase chain reaction (PCR) test to find the virus. In April, 2020, the FDA issued an umbrella Emergency Use Authorization for PCR testing of SARS-Co-V-2.

**2007** – Dr. Zhengli and colleagues in Australia demonstrated that insertions placed in spike proteins made it possible for SARS-CoV to infect human cells.

**2013** – Dr. Baric and colleagues discovered four critical genes that were expressed following SARS-CoV infections that created lung damage through fibrin that caused blood clotting. This was funded by NIAID, NIH, HHS, and the National Center for Advancing Translational Sciences (HHSN272200800060C; 5UL1RR02414).

**2014** – In March, Dr. Baric applied for an international patent for the Methods and Compositions for Chimeric (Gain-of-Function) Coronavirus Spike Proteins with support from NIH grant U54AI057157.

**2014** – Dr. Li Meng Yan discovers that SARS-CoV-1 was a genetically modified (Gain-of-Function) virus that was a bioweapon developed by the Chinese Communist Party, with SARS-CoV-2 being the upgraded version of this bioweapon.

**2015** – Baric and Zhengli received funding from Dr. Peter Daszak of EcoHealth Alliance and NIH to publish their research that had used reverse genetics to generate a pathogenic chimeric virus, formed from parts of various animals, that could not be controlled by the use of drugs and could cross the blood-brain barrier of humans. They concluded that these viruses were able *“to replicate in human airway cultures, cause pathogenesis, and escape current therapeutics.”* Further funding for this bioweapon came from National Natural Science Foundation of China, the Wuhan Institute of Virology, University of North Carolina, University of Texas Medical Branch, USAID, and the U. S. Central Intelligence Agency (CIA).

**2015** – In September, Zhengli and Baric reengineered, through mutations (Gain-of-Function), the spike protein of MERS to increase infectivity of humans through viral entry into human cells. (NIH Grants RO1AI089728, RO1AI110700).

**2015** – Dr. Peter Daszak and EcoHealth Alliance denounce a laboratory origin of this virus insisting on a zoonotic (animal) origin of this bioweapon.

**2012** – In January, Dr. Peter Daszak leads the World Health Organization “team of experts” to the Wuhan Institute of Virology and insists the great amount of missing documents concerning SARS-CoV-2 was irrelevant. No connection between SARS-CoV-2 and the Wuhan laboratory was found by Daszak’s team.

**This timeline of crime is proof positive of the crimes against humanity that the Cast of Criminals and their agents have committed by creating a biological Weapon of Mass Destruction.**

**The time has come for them to answer for their crimes.**
