

## Ex-Russian Intel Officer Says COVID-19 is Part of the Depopulation Agenda

The first part of this article is from the transcribed testimony of an ex-Russian military intelligence officer. Makia Freeman is a freelance writer and has transcribed the text, and it corroborates something relevant to 5G technology roll out that has implications that I have addressed in my article **“5G The Ultimate Directed Energy Weapon System – Part 3”**. I posted that article on June 3, 2020.

The Coronavirus Depopulation Agenda is exposed in this revealing interview with an ex-Russian military intelligence officer.

I have taken the time to transcribe it in full below, using the translation provided by YouTube translator Inessa S, whose work I trust and value (and have been following for years).

## **Testimony of Russian ex-Military Intelligence Officer on Coronavirus Depopulation Agenda**

Interviewer (I): Today we have Vladimir Kvachkov as our guest, a Colonel of the GRU (Military Intelligence Officer), a public figure, with a PhD in military science. Vladimir Vasilievich Kvachkov

(V): Good afternoon.

I: Yes, good afternoon, Vladimir Vasilievich. I know you served, among other things, as the leading researcher for the Centre for Defence and Strategic Studies of the General Staff of the Armed Forces. Considering your expertise, what do you make of the coronavirus phenomenon?

V: It's exactly this perspective that you need to examine it from. Not from the public health perspective, nor epidemiology, etc. The coronavirus phenomenon that they falsely deem a pandemic needs to be examine from the perspective of global powers.

Religious, political, financial, economic and national. The coronavirus phenomenon, the so-called pandemic – and let me tell you, there's no pandemic, it's all a lie – needs to be considered as a global, strategic special operation. This is exactly how you need to think of this thing. These are command and staff exercises of the world's behind-the-scenes powers on controlling humanity. This is what the goal of this coronavirus is.

I'll repeat it once again. We have little faith in God and even less so in the existence of Satan, the enemy of the human race. So, the aim of the behind-the-scenes Zionist and financial powers is reducing the world's population. It's their idée fixe.

They think there's too many of us ordinary people in the world. There should be around 100 million of their kind and a maximum of 1 billion people on Earth to serve them. Then they'll be living in abundance here on Earth.

Because, us the people, the earthlings – there's too many of us for the behind-the-scenes world powers.

This is why the coronavirus and the financial crisis that has emerged almost immediately – they're inextricably tied to one another. The aim is to stop people's movement around the world, to curtail political freedoms.

In political terms, it would be practically impossible to do all that. There are differences in constitutions. Whether they're being implemented or not – that is a different question.

However, there are some political rights that people are accustomed to and they believe they theirs to have forever.

The first attempt to take away those rights from people happened on September 11th, 2001. Not many seem to remember that, after the so-called attack on WTC towers, Pentagon and White House in the USA, the global war on terrorism was declared.

Let's remember, in order to understand what the coronavirus is now, let's analyze that first attempt – the declaration of war on humanity that was disguised as a war on terrorism. That was 19 years ago. The behind-the-scenes world powers created the events of September 11, 2001.

Now they need another excuse for greater control and takeover of humanity. That's how they came up with the coronavirus. Basically, to put it this way, that's not a pandemic, not an epidemic.

Even now, I literally looked at the data this morning, 300 people in the world die from it daily. You can imagine what kind of scale this is.

Of course, I'm sorry about each person who dies, but 300 people across 7.5 billion people – that's basically nothing.

These command-and-staff exercises of the behind-the-scenes world powers have an aim to limit different political rights and make people afraid. The fools are already grabbing food in shops here. Millet, buckwheat, etc.

I: Toilet paper?

V: Yeah, even toilet paper? God! Why? The goal is to scare people. Once again, these are command-and-staff exercises of the behind-the-scenes Zionist and financial liberal world powers with the aim of limiting the political rights that people are basically accustomed to having, especially in Western Europe. That's their second goal.

The first goal is to reduce the population numbers on Earth. That's their Satanic goal.

The second, political goal of the behind-the-scenes world powers is to seize power.

The third goal is related to finances and power over the economy.

Financial, as we already know, at least those who are interested in this ... Now, for every product that exists – please, give me your pencil. Okay. Let's say this pencil costs 1 ruble or 1 dollar – let's say its 1 dollar.

For this pencil, it was issued 20 times the amount – in money, in promissory notes, equities and other financial derivatives. That means, if you take the real value of this pencil, it comes with 20 different papers that carry 20 times the value.

Accordingly, all the financial and economic relations have gone from the real economy to this virtual economy. It's a financial bubble that exists now and which encompasses, I

think, 1 quadrillion and 200 trillion dollars. It's a complete financial bubble. It needs to be deflated.

FRS, the Federal Reserve System, literally some days ago, that was in February, I think – they introduced a zero percent interest on deposits.

Now, in many countries, it's even a negative interest rate – that is, you deposited 100 dollars and you get 90 or 95 dollars. But at least you're still going to get it. So, we're already getting negative interest rates on deposits. So, that wealth has to be deflated. How will it be deflated?

Again, through this artificial international ... we see the economy has crashed, it's clear, accordingly – we can't meet your domestic demand like we did before, you need to tighten your belts etc.

Now is a very important moment. Note, it allegedly started in China. Even though the Chinese are now adamant and report that the coronavirus was created artificially. It has an artificial origin – it's been proven scientifically already.

Of course, in every virus, seeing that it's the simplest kind of microorganism – as far as I remember – mutations can happen, but they're of an accidental nature.

And when you take the RNA molecule, not DNA – they have RNA – and there's a part of the genome that's clearly been carved out and another one inserted in its place – and this happens 3 or 4 times ...

It is perfectly obvious that the Chinese scientists have figured this out – it was artificially created and purposely spread, initially in Wuhan.

They had 2 kinds, 2 viral strains. Okay now. And what about Italy, what happened there? How come a strain that is even more dangerous than the Chinese one suddenly appears in Italy? I think now they have a few thousand infected and around 1000 have already died.

But again, 100x more people die in Italy from flu, pneumonia, scrofula and hepatitis. But we don't talk about that. Instead, we are being served special political information propaganda, psycho-informative propaganda.

Special psycho-informative operation of the world globalist mass media that is serving the behind-the-scene Zionist liberal powers that are creating this terror right now. This is why we need to deal with this phenomenon as we would with a special operation that is conducted in the form of command and staff exercises. Now they're looking – who's obeying and who's not.

In China, they introduced strict measures. But, then comrade Xi went to Wuhan and put the pro-American party faction who took that road in their place. In China, not everything is smooth there.

They have, let's call them that – a pro-Chinese (patriotic) faction, that's somewhat close to us, which is associated with Xi Jinping. And there are obviously pro-American ex-Komsomol members that are money-oriented or simply put – have their focus on the 'dough' (money). And they, of course, tried to use the coronavirus in Wuhan to gain certain economic and political benefits.

Comrade Xi put them all in their place and, consequently, it was over with the virus in China. And then it started in Europe. Accordingly, we as a military intelligence, look at "who" (it is obvious) and "where" (it is also obvious).

Europe and China are 2 geo-economic adversaries of the USA. And this is where they injected this virus.

This virus also has a 4th dimension as well – the economic one. The first is the religious one – destruction of people on Earth, reducing the population numbers. The second one is to establish political control over humanity.

The third one is the financial deflation of that gigantic financial bubble. And the fourth dimension is the elimination of their geo-economic competition.

This I'm telling you from the perspective of an officer from the Defence and Strategic Studies of the General Staff of the Armed Forces. This is my assessment of the current epidemic.

I: Vladimir Vasilievich, you spoke with clarity, you laid it out military style. Can you give us any military predictions for the nearest future?

V: In connection to the coronavirus?

I: Yes. What do you think, which countries could expect pressure next?

V: Russia, of course. It's going to be Russia, surely. Because ... for America, Russia isn't an economic competitor.

Now, the main efforts of the behind-the-scenes world powers are focused on causing disruption in China and Western Europe. And Russia is their target on 2 accounts: they want to reduce our population numbers and cleanse our territory. That is still to come. Yes.

I: Of course, we would like to hear your opinion regarding a practical plan of action, how to act, how to protect oneself, some recommendations. Maybe it's not your field of expertise (of what to do), but maybe you could tell us something.

V: I'm, of course, no epidemiologist. Although, you could say I'm a parasitologist, because you have to be one in order to understand the power structures in Russia.

So, I'm speaking as a military doctor – epidemiologist and parasitologist. Until we're able to get rid of our internal parasites who rule over us, we won't be able to tackle other parasites.

### **Key Points of his Account**

This ex-intelligence officer's perspective is very interesting for a number of reasons. He names 4 agendas at play here: the coronavirus depopulation agenda, the restriction of freedom and rights, the financial agenda (deflating the bubble, crashing the economy) and the geopolitical and geo-economic agenda.

He names the Zionists as part of the shadowy group that is running the world and behind Operation Coronavirus. He refers to it as an exercise, in alignment with [Mike Pompeo's admission of this as a live exercise.](#)

He recognizes from the few people dying that this is no way a genuine pandemic. He sees that this as a continuation of what started in 2001 with the 9/11 false flag op (as I discussed in [The New War on Bioterror](#)) – the next phase in their NWO quest to create a global government.

He believes in the evidence pointing to the coronavirus as a deliberately created bioweapon, used to hurt China and Europe.

This last point is the only one I have some reservation about, since it assumes there is a "virus" spreading around the world and we can also see that the economic impact upon the US (not just China and Europe) has been massive (especially since mid-March).

Nonetheless, this is a worthwhile account from someone who has seen through the lies.

In my series of articles **"Wuhan was a Test Run for Weaponized 5G,"** a major point I was sharing was that this was a Rothschild/Anglo/Zionist/Jesuit operation designed to provoke a war between China and the U.S. The House of Rothschild's historically have been behind all the major wars of the world, as they enrich their coffers by loaning money to both parties of a war, first to buy munitions and weapons of war, and secondly through funds for reconstruction. This has always been the Zionist Rothschild's modus operandi! As the "Fiduciary Agent" for the Vatican, they are partners in crime.

The statements by Mike Pompeo (Sec. of State), a Christian Zionist, suggests that he was aware of what game the Rothschild's are running here. In previous articles, I noted that the Pirbright Institute in Surrey, UK is a Rothschild-owned lab and has been involved in modifying or weaponizing virus pathogens. There is a relationship between U.S. BLS4 labs, the CDC, the NIAID, and Canadian BLS4 labs with the Pirbright Institute. In addition, the U.S. operates bio-lab operations in some 24 foreign countries.

The Pirbright Institute holds a joint patent with Bill Gates since 2017 on the Coronavirus. On their facilities, the Pirbright Institute operates 25 satellite dish antennas for down link and up link of data telecommunications. The hi-jacking and modulation of China's 5G technology was an easy intervention from the UK with no obvious tie to the Anglo/Zionist Cabal. Through a few modulation steps the Brits could instantly flip the switch and kill a whole lot of people, for which the Chinese authorities were scratching their heads as what happened. As time passed, the blame accusations and counter claims sparked a war of words. The end agenda was to escalate the war of words to one of nuclear retaliation. A classified Pentagon document alludes to fear of a Chinese "EMP" attack on mainland U.S. as being imminent!

I have said from the moment it first became known when the Diamond Princess cruise ship passengers began to experience symptoms of this virus, there was much more to this story than what was the claim of a virus known to be as common as the cold. The virus was being used as a cover story to confuse the public and authorities, of something even more insidious. I called it early on as "an extinction-level event" and see no evidence to call it anything less.

Various independent researchers around the web, for weeks have highlighted the Coronavirus-5G link despite the fact that Google (as the self-appointed NOW Center-in-Chief) to do its best to hide and scrub all search results showing the connection. The Internet censors have blocked me for six months from downloading specifics, a strong indicator they do not want facts becoming public.

The Coronavirus 5G connection doesn't mean the bio-weapons connection is false (it's not a case of either-or), but rather broadens the scope of the entire event. Wuhan, China was one of the test cities chosen for China's 5G rollout; China went live on October 31<sup>st</sup>, 2019, almost exactly 2 months before the Corona virus outbreak began.

Meanwhile, many scientific documents on the health effects of 5G have verified that it causes flu-like symptoms. This article reveals the various connections behind the Corona virus phenomenon, including how 5G can exacerbate or cause the kind of illness you are attributing to the new virus. The rabbit hole is deep!

Many people around the world, including concerned citizens, scientist and even governmental officials, are becoming aware of the dangers of 5G.

This is why it has already been banned by many places worldwide, such as Brussels (home of the EU/NATO), the Netherlands, and parts of Switzerland, Ireland, Italy, Germany, the UK, the USA, Australia, and Israel.

After all, 5G is not just the next generation of mobile connectivity after 4G; it is a radical and entirely new type of technology – a military technology used on the battlefield that is now being 'deployed' (military term) in the civilian realm. Its military potential has been known since the 1950s.

It is phased array weaponry being sold and disguised to the public as primarily a communications system when the frequency bands it uses (24-Gigahertz – 100+ Gigahertz including MMW (millimeter waves)) are the very same ones used by our own military in Active Denial Systems and LRAD used to disburse protestors and crowd control.

Even mainstream Wikipedia describes Active Denial Systems as Directed Energy Weapons (DEW); it disburses crowds by firing energy at them, causing immediate and intense pain, including a burning sensation of the skin. Military officials demonstrating these weapons fail to mention when they say it does no harm that it is capable of doing far greater damage when modulated, even capable of eliminating those it is used on.

We know that directed energy weapons (DEW) are behind the collapse of the Twin Towers on 9/11 and the fake California “wildfires” of 2018 and 2019.

The effects of 5G include increased cancer risk, cellular stress, increase in harmful free radicals, genetic damages, structural and functional changes of the reproductive system, learning and memory deficits, neurological disorders, and negative impacts on general wellbeing in humans. Damage goes well beyond the human race, as there is growing evidence of harmful effects to both plants and animals.

If you listen to Mark Steele and Dr. Barrie Trower, you will get an idea of the horrifying effects of 5G.

In 1977, 5G was tested on animals in hopes of finding a weapon. The results were severe demyelination – stripping the protective sheath of nerve cells. Some nations are now noticing a 90% loss of insects (including pollinating insects like bees) which congregate around lamp-posts where 5G is installed.

If you dig deep enough, some disturbing connections arise between 5G and the men who developed or are developing vaccines for novel viruses like Ebola, Zika, and the new Corona virus COVID-19.

In a fantastic piece of research, an author under the pen name of Annie Logical wrote the article “Corona Virus Fakery and the Link To 5G Testing” that lays out the Coronavirus 5G connection. There is a ton of information, so I will break it all down to make it more understandable.

From October 18-27<sup>th</sup>, 2019, Wuhan hosted the Military World Games and specifically used 5G (for the first time ever) for the event. Also on October 18<sup>th</sup>, 2019 in New York, the Johns Hopkins Center in partnership with the World Economic Forum (WEF) and the Bill and Melinda Gates Foundation hosted Event 201 – “A Global Pandemic Exercise” which is a simulation of a pandemic.

Guess what virus they happen to choose for their ‘simulation’? **A coronavirus!** Guess what animal cells they use? **Pig cells!**



(COVID-19 was initially reported to be derived from a seafood market, and the fish there are known to be fed on pig waste).

Event 201 includes the UN (Since the WEF now has a partnership agreement with the UN, Big Pharma (Johnson and Johnson), Bill Gates (key figure in pushing vaccines, human microchipping and Agenda 2030) and both China and America's CDC.

Participants in Event 201 recommend that governments force social media companies to stop spread of 'fake news' and that ultimately the only way to control the information would be for the WHO (world Health Organization, part of the UN) to be the sole central purveyor of information during a pandemic.

On January 24<sup>th</sup>, 2020, U.S. biotech and pharmaceutical company Inovio received a \$9-million grant to develop a vaccine for the coronavirus. Inovio got the money grant from the Coalition for Epidemic Preparedness Innovations (CEPI), however, they already have an existing partnership with CEPI; in April 2018 they got up to \$56 million to develop vaccines for Lassa Fever and Middle East Respiratory Syndromes (MERS).

CEPI was founded in Davos by the governments of Norway and India, the Wellcome Trust ... and the participants of Event 201: the Bill and Melinda Gates Foundation and the WEF, CEPI's CEO is the former director of BARDA (U.S. Biomedical Advanced Research and Development Authority) which is part of the (HHS) Health and Human Services.

Invio claimed they developed a coronavirus vaccine in 2 hours! On the face of it such a claim is absurd; what is more likely is that they are lying or that they already had the vaccine because they had the foreknowledge that the coronavirus was coming and was about to be unleashed.

So who owns and runs Inovio? Two key men are David Weiner and Dr. Joseph Kim. Dr. Weiner was once Kim's university professor. Weiner was involved with developing a vaccine for HIV and Zika.

Kim was funded by Merck (a large Big Pharma company) and produced something called Porcine Circovirus (PCV-2 and PCV-2). As mentioned above, there is a link between pig vaccines, pig DNA and the Corona virus; Annie Logical notes that it "has long been established that seafood in the area is fed on pig waste."

Kim served 5-year tenure as a member of the WEF's Global Agenda Council – yet another organ pushing the New World Order One World Government under the banner of Agenda 2030 Global Governance.

Weiner is an employee and advisor to the FDA, is considered a DNA technology expert and pioneered a new DNA transference method called **electroporation** – a microbiology technique which uses an electrical pulse to create temporary pores in cell,

membranes through which substances like chemicals, drugs, or DNA can be introduced into the cell.

Learn that word well, as this technique can be used to administer DNA vaccines, which inject foreign DNA into a host's cells that changes the host's DNA. This means if you take a DNA vaccine, you are allowing your DNA to be changed!

As if vaccines weren't already horrific enough ... but here's the kicker: **electroporation** uses pulse waves. Guess what else uses pulsed waves? 5G! This is either a startling coincidence or evidence or a sinister Corona virus 5G-connection. Annie writes: "The same action that 5G technology uses in pulsed waves and the coronavirus was reported to have started in an area in China that had rolled out 5G technology."

Do not forget that China vaccinated its entire nation with a vaccine in September of 2019.

So we can see how geneticists using scientists are tampering with the building blocks of our existence and what is disturbing is that Prof. Weiner is a HIV pioneer and we know that soon after the Polio vaccines were given to millions in Africa that HIV emerged. They have perfected the art of injecting animal or bird DNA into human chromosome which alters our DNA and causes things like hemorrhaging, fever, cancers, and even death.

Speaking of HIV (which is not the same as AIDS, but that is another story), remember also that a group of Indian scientists put out their research that the virus was manmade and had HIV inserts.

They found that 4 separate HIV genes were randomly embedded within the coronavirus. These genes somehow converged to create receptor sites on the virus that were identical to HIV, which was a surprise due to their random placement.

They also specifically stated that this was not likely to happen naturally ("unlikely to be fortuitous in nature"). In yet another example of egregious censorship, these scientists were pressured to withdraw their work.

Consider the implications of this for a moment. The technology exists to use EMF's to open your very skin pores and inject foreign DNA into your bloodstream and cells.

This is an extreme violation of your bodily sovereignty, and it can have long-term effects, because of genetic mutation – changing your very DNA which is the biological blueprint and physical essence of which you are.

What if 5G mimics **electroporation**? What if 5G can do on a large scale what electroporation does on a small scale? We already know that 5G has the potential to be mutagenic (DNA-damaging).

The frequencies that 5G uses, especially 75-100-Gigahertz, interact with the geometrical structure of our skin and sweat ducts, acting upon them like a transmission reaching an antenna, and fundamentally affecting us and our mood.

What if 5G is being used to open up the skin in Wuhan, China so as to allow the new bio-weapon coronavirus to infiltrate more easily?

So, what's the bottom of the coronavirus-5G rabbit hole? I would suggest we find mandatory vaccine agenda, the depopulation and transhumanist agenda (via DNA vaccines).

The key figures and groups who appear to have planned this already have the vaccine in place, just as they did for the other epidemics that fizzled out (SARS, Ebola, and Zika). Dr. Weiner even has links to HIV/AIDS, along with Dr. Anthony Fauci, and if you dive into that as Jon Rappoport did, you find gaping holes in that story. It's the same epidemic / plandemic game played out every 2-3 years. There's a couple of versions.

**In the first version, you invent a virus, hype it up, get people scared, do ineffectual and inconclusive tests (e.g., like the PCR test which measures if a viral fragment is present but doesn't tell you the quantities of whether it would actually causing the disease), inflate the body count, justify quarantine/martial law and brainwash people into thinking they have to buy the (toxic) vaccine and introduce mandatory vaccinations. You don't even need a real virus or pathogen for the version.**

**In the second version, you create a virus as a bio-weapon, release it as a test, pretend it was a natural mutation, watch how many people it kills (which helps with the eugenics and depopulation agendas), again justify martial law, again justify the need for mandatory vaccines and even pose as the savior with vaccine that stops it.**

**As a variation on this second version, you can even develop a race-specific bio-weapon so as to reduce the population of rival nations or enemy races as a geo-political strategy.**

This article suggests that the Coronavirus targeted Chinese people / Asians more than others, and certainly the official death count attests to that, although it's always hard to trust governmental statistics. Annie Logical gives her take:

But first, we learned from Chinese insider sources that the Chinese telecoms reported 21 million fewer cell-phone accounts by February/March of 2020. China was from all information, the most developed cell-phone country in the world for buying and selling, and its introduction of the "QR" cell-phone ID. It's unlikely that 21 million Chinese all of a sudden decided they no longer wanted to use their cell-phones to buy the necessities of life. So, it is safe to say, that the missing 21-million cell phone accounts suddenly

died!. Also, this writer suggests it was the second version above used to attack Wuhan, China, a model city for the debut of 5G.

This is where the Rothschild/Anglo/Zionist/Jesuit agenda came into play to provoke a war between China and the U.S. The Rothschild-owned Pirbright Institute in Surrey, UK, through their intricate satellite-link hijacked the Chinese main 5G stations and modulated [turned up the energy level to the range 60-Gigahertz], dropping hundreds of thousands and likely millions in their own foot-prints instantly. Remember 5G is first and foremost a weapons system, and secondly, at 60-gigahertz energy consumes 98% of the oxygen of its victims. Thirdly, all Chinese were vaccinated in September of 2019, and specific batches of vaccines were likely given to specific individuals the CCP considered to be politically threats, such as Christians and political radicals.

Data suggests that the Christian community home church in China is as large as 375-million. The fact that the CCP has been attacking the Christian community, and destroying churches, as well as secret home churches, has been a well-known fact for the past three years. Even the Vatican acquiesced and permitted the CCP to choose Catholic cardinals for the millions of Roman Catholic Chinese people.

**Now, back to Annie Logical:** “The con job goes like this.

Step 1) poison the population purposely to create disease that does not and would not occur naturally.

Step 2) parlay the purposely created disease as being caused by something invisible, outside the realm of control or knowledge of the average person.

Step 3) create a toxic vaccine or medication that was always intended to further poison the population into an early grave.

Step 4) parlay the vaccine or medication poisoning as PROOF the disease, which never existed, is much worse than anticipated.

Step 5) increase the initial poisoning, which is marketed as a fake disease, and also increase the vaccine and medication poisoning, to start piling the bodies into the stratosphere.

Step 6) repeat as many times as possible upon an uninformed population because killing a population this way (the art of having people line up to kill themselves with poison ... known as a “soft kill” method) is the only way to make sure such eugenic operations can be executed on a mass scale and in plain sight.”

**DNA vaccines** are a disturbing new advancement for trans-humanism. After all, the objective of the transhumanist agenda is to merge man with machine, and in doing so, wipe out what fundamentally makes us human, so we can be controlled and overtaken by a deeply sinister and negative force.

It's all about changing us at the fundamental level, or attacking human sovereignty itself. DNA vaccines fit right in with that – literally changing your DNA by forcefully inserting foreign DNA to change your genetics, with consequences no one could possibly fully foresee and predict.

## **One Last Coronavirus – 5G Connection**

Finally, I will finish with another coronavirus-5G connection. The word coronavirus itself refers to many kinds of viruses by that name, not just COVID-19.

**Guess who owns a patent for a corona virus strain that can be used to develop a vaccine? The Pirbright Institute. And guess who partially owns them? Bill Gates!**

As you can read my other articles, Pirbright is being funded in their vaccine development endeavors by a British company “Innovate UK” ... who also funds and supports the rollout of 5G. Innovate UK ran a competition in 2018 with a £15-million share out to any small business that could produce vaccines for “epidemic” potential.

## **The Motivation To Hype And The Motivation To Downplay**

History has shown that in cases of epidemics (or fake epidemics) there is almost always a morass of conflicting reports and contradictory information. In such situations, it can be very difficult to get to the bottom of the matter and find the truth. The conflict stems from the different motivations of nations, governments and other interested groups, and individuals.

Essentially, there are 2 main motivations: the motivation to hype (exaggerate and use fear to grab attention, sell something, make a group look bad/incompetent, make people scared, make the public accept mandatory vaccination and martial law) and the motivation to downplay (cover up) and hide the true extent of their damage, morbidity or mortality so as to appear competent and to control, to lessen possible anger, backlash or disorder).

Sometimes, these 2 motivations may drive the behavior of the entire group, e.g., in the case of draconian quarantine rules) and the motivation to downplay (so as to appear in the eyes of its people and the rest of the entire world to have the situation under control, to ensure saving face, credibility, and a good reputation).

## **Final Thoughts On The Coronavirus 5G Connection**

Governments around the world have experimented with bioweapons both on their own citizens and foreign citizens, and even sold that research to other governments for their own benefit (e.g., Japan's notorious Unit 731 which developed bioweapons in China, only to hand over the research to the U.S. after losing World War 2).

Hastings body was cremated after the official autopsy – against the wishes of the family.

Hours before he died, Hastings told friends he was under investigation by the FBI for a story he was doing about Obama's then terrorism czar, who later became the head of the CIA: John Brennan, architect of the black ops assassination program.
