Germany's federal government and mainstream media are engaged in damage control after a report that challenges the established Corona narrative leaked from the interior ministry.

Some of the report key passages are:

- The dangerousness of Covid-19 was overestimated: probably at no point did the danger posed by the new virus go beyond the normal level.
- The people who die from Corona are essentially those who would statistically die this year, because they have reached the end of their lives and their weakened bodies can no longer cope with any random everyday stress (including the approximately 150 viruses currently in circulation).
- Worldwide, within a quarter of a year, there have been no more than 250,000 deaths from Covid-19, compared to 1.5 million deaths [25,100 in Germany] during the influenza wave 2017/18.
- The danger is obviously no greater than that of many other viruses. There is no evidence that this was more than a false alarm.
- A reproach could go along these lines: During the Corona crisis the State has proved itself as one of the biggest producers of Fake News.

So far, so bad. But it gets worse.

The report focuses on the "manifold and heavy consequences of the Corona measures" and warns that these are "grave".

More people are dying because of state-imposed Corona-measures than they are being killed by the virus.

The reason is a scandal in the making:

A Corona-focused German healthcare system is postponing life-saving surgery

and delaying or reducing treatment for non-Corona patients.

Berlin is in Denial Mode. The scientists fight back.

Initially, the government tried to dismiss the report as "the work of one employee" and its contents as "his own opinion" - while the journalists closed ranks, no questions asked, with the politicians.

But the 93-pages report titled "Analysis of the Crisis Management" has been drafted by a scientific panel appointed by the interior ministry and composed by external medical experts from several German universities.

The report was the initiative of a department of the interior ministry called Unit KM4 and in charge with the "Protection of critical infrastructures".

This is also where the German official turned whistleblower, Stephen Kohn, work(ed), and from where he leaked it to the media.

The authors of the report issued a joint <u>press release</u> already on May 11th, berating the government for ignoring expert advice, and asking for the interior minister to officially comment upon the expert's joint statement:

"Therapeutic and preventive measures should never bring more harm than the illness itself. Their aim should be to protect the risk groups, without endearing the availability of medical care and the health of the whole population, as it is unfortunately occurring"

"We in the scientific and medical praxis are experiencing the secondary damages of the Corona-measures on our patients on a daily basis."

"We therefore ask the Federal Ministry of the Interior, to comment upon our press release, and we hope for a pertinent discussion regarding the [Corona] measures, one that leads to the best possible solution for the whole population" At the time of writing, the German government had yet to react.

But the facts are - sadly - vindicating the medical experts' worries.

On May 23 the German newspaper <u>Das Bild</u> titled: "Dramatic consequences of the Corona-Measures: 52,000 Cancer Ops delayed."

Inside, a leading medical doctor warns that "we will feel the side-effects of the Corona crisis for years".

Shooting the Whistleblower. Ignoring the Message.

As <u>Der Spiegel</u> reported on May 15th: "Stephen Kohn [the whistleblower] has

since been suspended from duty. He was advised to obtain a lawyer and his work laptop was confiscated."

Kohn had originally leaked the report on May 9th to the liberal-conservative magazine <u>*Tichys Einblick*</u> one of Germany's most popular alternative media outlets.

News of the report went mainstream in Germany during the second week of May but already in the third week media and politicians alike stopped discussing the issue by refusing to comment upon it.

Emblematic was the approach taken by Günter Krings, the representative for Interior Minister Horst Seehofer - the whistleblower's boss:

Asked if he would treat the document seriously, Krings replied:

"If you start analyzing papers like that, then pretty soon you'll be inviting the guys with the tin foil hats to parliamentary hearings."

Men in tin foil hats - Aluhut in German - is a term used to describe people who believe in conspiracy theories.

Indeed one article by Der Spiegel addressing the Corona protest movement and the consequences of the leaked report contained the word *"conspiracy" no* fewer than 17 times!

And no discussions of the issues raised by the report itself.

Outside Germany the news has virtually gone unreported.

The Protest Movement - or "Corona-Rebellen".

Germans begun demonstrating against Lockdowns as early as April.

And thousands of citizens keep showing up at demos every week-end, even as the government is easing the restrictions.

The demos are not merely against restrictions, which have actually been comparatively mild compared to many other Western countries.

The demos question the entire Corona Narrative, and even more its principals, especially the role Bill Gates is playing, as the WHO second biggest donor (the first one since Trump suspended U.S. contribution).

Roman Catholics have been thriving at the CIA since its earliest days. Who knew?

From The Catholic Herald:

The CIA is the best known of the 17 agencies that comprise the American intelligence community. It has earned itself nicknames like "Catholic Intelligence Agency" and "Catholics In Action". It's worth exploring why.

No official statistics exist on Catholics in the CIA or any other American intelligence agency. But one interesting clue is the relatively high number of Catholics who have served as director of the agency.

The United States is a country in which – with the recent exception of the Supreme Court – Catholics have never dominated the highest offices. Only one out of 44 US Presidents has been Catholic. The first and only Catholic Vice President was Joe Biden. Before John Kerry, the last Catholic Secretary of State was Alexander Haig, who left the post in 1982. Catholics are a rarity in other top positions such as Secretary of Defense.

By contrast, three out of the last five CIA directors have been Catholic: Michael Hayden, Leon Panetta, and the criminal John Brennan. Looking back, a number of Catholics led the agency in critical periods during the Cold War. (There were no Catholic directors in the 1990s.)

Some of the most influential directors in CIA history have been Catholic – men such as Walter Bedell Smith, John McCone, William Colby and William Casey. They were not just casual Catholics. They were devout Mass-goers – in many cases, members of groups like the Knights of Malta. The conspiracy theorists usually start there, with nefarious plots about the Vatican steering world affairs. Of course, they never ask why an all-powerful Vatican can't engineer more Catholic presidents.

The CIA has been commonly referred to as the 'Catholic Intelligence Agency' due to all of the Catholic members in lead positions throughout the intelligence community – but that's just the sugar coated explanation. Let us uncover the more esoteric connections unknown to the general public until now. The symbol on the CIA shield is known as the Vergina Sun.

The Vergina Sun is formed by sixteen triangular rays which radiate into a 16pointed star. The symbol was found on ancient Macedonian army shields as well as on the tomb (shown on the Golden Funerary Casket – image above) of Greek King Philip II of Macedon, the father of Alexander the Great III who conquered the entire known world'.



The monstrance features the Vergina Sun (note it's 16 points) as well as a symbol of fertility in its central point of focus – the crescent moon (a symbol highly

prevalent in the culture and religion of Islam). The Roman Catholic church has also been found to have this symbol of Sun worship and fertility on their altars. Altars are used for offerings.

In 2018 when Archbishop Vigano called out Pope Francis for covering for former Washington, DC Archbishop McCarrick as a pedophile the global hunt for Carlo Maria Viganò commenced currently underway by the Vatican's security services has renewed interest in the intelligence capabilities of the smallest yet oldest government on earth. While the intelligence resources of the Vatican City State cannot be said to be comparable in funding or cutting-edge technology of the CIA, GRU or MSS, one would make a fatal mistake in underestimating the far reach, experience and capabilities of what many experts and historians consider being the world's most discreet but greatest intelligence service.

Now-disgraced retired cardinal of Washington, DC Theodore McCarrick was permitted to live out his role as a bishop over the past thirty years despite the fact that some bishops knew him to be guilty of sexually abusing seminarians.

Since McCarrick revelations by the Archdioceses of New York and Newark, that McCarrick was found to have credible allegations of sexual predation against a minor, and two adult males, there can be little doubt that the American hierarchy was aware of allegations of his past salacious and sexually exploitative misconduct.

Why did Newark Cardinal Joseph Tobin and Bishop James F. Checchio, of Metuchen, New Jersey, not release the decades-old McCarrick settlement information immediately to protect potential victims? Joseph Tobin has been Cardinal of Newark since January 2017, and Bishop Checchio has been Bishop of Metuchen since May 2016. The first obligation of a Cardinal and bishop is to review the clergy abuse settlements and claims to ensure the safety of Catholics. Surely, complaints against Cardinal McCarrick would have drawn their immediate attention!

Yet, Cardinal Ted McCarrick rose to the highest levels of the Catholic hierarchy and, apparently none of his brother Bishops or Cardinals stepped forward as a whistleblower to protect unsuspecting boys and young males.

During the day, as Cardinal of the powerful Washington, D.C. archdiocese, Cardinal McCarrick rubbed shoulders with the political power elite. He celebrated the prestigious Red Mass where members of the U.S. Supreme Court, Congress, and political elites attended every year. Cardinal Ted McCarrick concelebrated funeral masses for the rich and politically famous, like Sen. Ted Kennedy and Beau Biden, Vice President Joe Biden's son. He was the go-to Cardinal for the rich and powerful.

His days were busy cultivating contacts, doing favors for the rich and powerful of business, government and politics. He traveled around the world for Catholic

Relief Services. "Uncle Ted" McCarrick was the ultimate insider Prince of the Church. It's no wonder that an "influential Italian gentleman" urged him to lobby for Pope Francis' election, as McCarrick himself related in an October 2013 talk at Villanova University.

For years, the McCarrick misconduct stories surfaced and, then, seemingly retreated into oblivion. Yet, one theme prevailed in the persistent allegations: prelates and people were informed, and no one in power did anything. The DC power brokers, New York elite, and mainstream media colluded with the Catholic hierarchy in a conspiracy of silence to protect McCarrick for nearly half a century. No one spoke about the credible findings and settlements with McCarrick victims.

Despite his abuse of seminarians, Cardinal McCarrick continued to have regular access to them, even staying in the seminary while visiting Rome. In his Villanova speech, Cardinal McCarrick reveals that during the conclave he stayed at the North American College (NAC) Seminary in Rome.

McCarrick residing at the seminary dormitory is like the fox guarding the chicken coup. Rod Dreher highlights McCarrick's risk to seminarians and that the Vatican was repeatedly warned about him. In his article, *"Cardinal McCarrick is a Molester"*, Dreher describes the allegations surrounding McCarrick's sexual predatory modus operandi:

It had been rumored at the time that Theodore McCarrick, the Archbishop of Newark, was going to be moved to Washington, DC, and to be made a cardinal. This group traveled to Rome to warn the Vatican that McCarrick was a sexual harasser of seminarians. The story this priest shared with me was that McCarrick had a habit of compelling seminarians to share his bed for cuddling. These allegations did not involve sexual molestation, but were clearly about unwanted sexual harassment.

Over the decades, many others alleged and warned about McCarrick's predatory predilection for seminarians. The prominent sociologist and clergy abuse expert and author, Richard Sipe, wrote a passionate plea to Pope Benedict about McCarrick's alleged predatory sexual conduct.

The fabled Nazi hunter Simon Wiesenthal is quoted as having said in an interview that "the best and most effective espionage service in the world belongs to the *Vatican.*" It is for no small reason that Archbishop Viganò, the Vatican's most wanted man, is on the run and has gone into hiding.

The true name of the Vatican's clandestine intelligence service is Santa Alleanza ("Holy Alliance") or L'Entità ("The Entity") according to Allen Dulles, the first director of the CIA. With motto being *Cum Cruce et Gladio* ("With the Cross and

Sword"), it is said to have been created by Pope St. Pius V in 1566 in order to gather intelligence from the court of Elizabeth I and obtain her overthrow from power. This was long before the CIA even conceived of overthrowing governments.

Some say that the Vatican's counter-espionage section is the Sodalitium Pianum of the turn of the last century that everyone thought had been disbanded. For one to focus, however, on official names and structures is to miss the forest for the trees when it comes to the Vatican's intelligence network.

Those who have difficulty believing that cassock-attired clerics comprise the world's greatest intelligence network fail to recall just how it was the papacy, the most powerful institution in history, that invented and developed to great success the Catholic Church's tip-of-the-spear agency to investigate and gather information pertaining to dangerous sects threatening the stability of the Church, societies and kingdoms: the Papal Inquisition.

While statutorily established to investigate and bring to judgment those guilty of the civil and canonical crime at the time that was heresy, the inquisitors general and their eight-man teams were obliged by circumstances of history to develop sophisticated networks of capable informants who would excel at acting as true spies. Although the Inquisition as an internal intelligence "agency" of vast resources no longer exists, the Vatican still has two other, more "discreet" but highly effective networks of external spies that form parts of the Secretariat of State's Section for the Relation with States ("S.RR.SS.") and new Section for Diplomatic Staff.

Towering above the Piazza della Minerva in Rome, in what may appear to be just another ancient Roman palace, lies the Pontificia Accademia Ecclesiastica, or Pontifical Ecclesiastical Academy, the Vatican's diplomatic and much softer equivalent to the CIA's Camp Peary — "The Farm." There, the cream of the crop of the Roman Catholic Church's priests are sent by their bishops to be trained to be members of what is still considered to be one of the world's elite corps of diplomats, the apostolic nuncios of the Holy See. Archbishop Carlo Maria Viganò was graduate no. 1447 of the Accademia's class of 1971 — "old school" in training prior to the fall of the Berlin Wall and the dissolution of the Soviet Union.

Most Catholics don't realize that the principal gatherers of intelligence on the part of the Holy See are the apostolic nuncios and their diplomatic staff, just like the ambassadors and staff of embassies that are deployed around the world by every nation-state. The only difference is that the Holy See does not have any intelligence officers to declare "officially" to their host countries.

If Viganò is afraid for his life to the point where he has to destroy his cell phone and go into hiding overseas, it is not only out of fear of being tracked down by a staffer of the apostolic nunciatures and missions of the Holy See spread throughout the world — the "long arm" of the Secretariat of State that has ordered discovery of Viganò's whereabouts — but also if not principally out of dread for the intelligence capabilities of the Vatican City State's paramilitary Corps of Gendarmes of the Vatican City State currently led by Domenico Giani. An ex-officer of Italy's much-feared financial police force called the Guardia di Finanza, the current Commandant of the Corps and Inspector General of the combined police and security forces of the Vatican City State is also the lead bodyguard of Pope Francis, just as he was for Pope Benedict. Every member of the Police and Security Forces of the Corps of Gendarmes, just like every member of the fabled Swiss Guards, is a former member respectively of Italy or Switzerland's military or police forces.

When Archbishop. Viganò served as secretary general of the Vatican City State, General Giani reported to him. Now, in a dramatic turn of events, it is Giani who has been ordered by his superiors not only to ensure the personal security of the Pope, but equally coordinate in the hunt for Viganò.



In 2008, the Vatican City State joined INTERPOL, the world's largest international association of police forces with offices based in 192 countries. As a result, the Vatican now has access to tremendous resources and databases through its official police contacts and INTERPOL office locations throughout the globe. The Vatican intelligence services even have a *Gruppo Intervento Rapido* (GIR), or "rapid-intervention group," which is known to possess highly sophisticated and innovative technological and logistical assets used in the furtherance of its assignments.

It is not generally known to Catholics just how well inserted ideological Freemasons are into the intelligence services of the military apparatus of Italy and other European nations.

The greatest danger to the life of Archbishop Viganò is said to arise from Freemasonic elements of the Santa Alleanza or Entità possessing absolutely no moral scruples who will do everything in their power to prevent the archbishop from making any additional disclosures not only embarrassing to the Holy See, but even more, capable of destroying the reputations and concrete chances of certain cardinals from being elected to the Throne of St. Peter.

Outside of Italy, and even inside the country, it is not generally known to Catholics just how well inserted ideological Freemasons are into the intelligence services of the military apparatus of Italy and other European nations, and consequently the Vatican City State, which derives a number of its police, security and intelligence forces from among those nations' ranks.

While it is known that powerful groups of Freemasons such as Propaganda Due ("P2"), who in the past had successfully infiltrated Vatican institutions such as the Institute for the Works of Religion (Vatican bank), have been disbanded by the Italian government, it is not known to many that successor groups of dangerous ideological Freemasons have succeeded in reconstituting themselves under different labels and taking control of key dicasteries of the Roman Curia. Viganò and his heroic whistleblowing pose more than a threat to him personally, they pose a very real and credible threat to entire networks of very talented individuals who will stop at nothing to destroy the Catholic Church as we know it from within, once and for all.

The Vatican's search for Viganò, therefore, was not so much a mission of the Santa Alleanza to accomplish than an exercise of unholy powers to fulfill.

For centuries, the mere mention of any violation of a "Secret of the Holy Office" was held to be something nefas — evil — abhorrent even to the imagination on the part of any true servant of the Vicar of Christ on Earth laboring in the Roman Curia. Then comes along Abp. Carlo Maria Viganò, seasoned Vatican diplomat and former papal nuncio to the United States, who, in one fell swoop of penning his testimony, has done the unthinkable: apparently violate not once, but

repeatedly the oath of pontifical secrecy he was solemnly administered to observe when he first assumed office in the Secretariat of State.

The question now is, can Viganò be prosecuted successfully in a court of law for what he and many say was such needed action, but what others would argue constitutes the nefarious crime of periurium — perjury?

To the knowledge of ecclesiastical historians, never before has such a highranking former papal legate of the Roman Pontiff divulged so many sensitive state secrets to so many people in such great detail in so short a period of time. The repercussions of Archbishop. Viganò's actions were not just immediate in effect but are long-lasting in consequence. Many other dipendenti of the Roman Curia have knowledge of many, many things pertaining to their colleague officeholders.

The oath of pontifical secrecy that Archbishop. Viganò, as a member of the Secretariat of State of the Holy See and its diplomatic corps, has taken is the following [draft translation from Latin]:

I, standing before His Eminence the cardinal secretary of state, having touched the sacrosanct Gospels of God, promise that I will faithfully observe the pontifical secret in causes and matters which are to be treated under the same secret, such that in no manner whatsoever, under any pretext, either for a greater good, or for a most urgent and most grave reason, permit myself to violate the aforesaid secret.

I promise to observe the secret, as referenced above, even in causes and matters that have been completed, for which such a secret is imposed. Whereas if in some case it should happen that an occasion bring me to have a doubt about the obligation of the aforesaid secret, I will interpret [it] in favor of the same secret. In like manner, I know that a transgressor of this kind of secret commits a grave sin.

So help me God, and these His Holy Gospels, which I touch with my own hands."

According to art. 36, § 1 and § 2 of the Vatican's General Regulation of the Roman Curia, all those who work in the Roman Curia are bound to observe pontifical secrecy regarding any matter of which knowledge they gain by reason of their service of the Holy See.

Does this mean that Archbishop. Viganò necessarily committed a mortal sin and canonical crime(s) for his having violated pontifical secrecy?

The patron saint of moral theologians and Doctor of the Church, St. Alphonsus de Liguori, has written the following opinions in his magnum opus, his Theologia Moralis [draft translation]:

"One may manifest a committed secret [secretum commissum], at least without grave sin: ... 4°. Out of a just reason, namely if observing the secret might lead to damnum commune [harm to the common good] ... because in this case, the order of charity postulates that it may be revealed: wherefore even if you might have taken an oath, in this case, you may divulge [the committed secret]. ... [III, 970] No one is bound by a secret, even should it have been promised by oath, when the secret leads to damnum commune [VI, 698].

"Common good" is the highest good of all, that inuring to the republic, or in ecclesiastical equivalence, the bonum ecclesiae.

And how many other evil pastors is Francis still continuing to prop up in their active destruction of the Church!

In order to escape canonical liability for having violated the pontifical secret, and this multiple times, as it is being alleged by Cardinal. Pietro Parolin, Abp. Viganò would have to show that he committed only apparent, not true perjury, due to the supreme need to protect harm to the bonum commune ecclesiae, the common good of the Church.

In this testimony, Viganò writes:

These homosexual networks, which are now widespread in many dioceses, seminaries, religious orders, etc. act under concealment of secrecy and lies with the power of octopus tentacles, and strangle innocent victims and priestly vocations, and are strangling the entire Church. ... And how many other evil pastors is Francis still continuing to prop up in their active destruction of the Church!

Provided that Archbishop Viganò could prove the veracity of the above to the judges of the Tribunal of the Vatican City State or Commission of the Secretariat of State competent to adjudicate the alleged crimes for which he could be prosecuted, the former ambassador stands a very good chance, at least theoretically, of being able to escape punishment for his having risked every-thing, including his own spiritual salvation, in defense of the common good of the Church.

On 15 November 2018, it was revealed that a civil court in Milan, Italy had issued a ruling in October 2018 which ordered Viganò to surrender €1.8 million euro of inheritance, plus interest and legal fees, to his brother Father Lorenzo Viganò. He had been managing his brother's inheritance since their father's death in 1961 and was ordered to pay back his brother Lorenzo, a Jesuit biblical scholar and priest of the Italian Diocese of Pavia who has resided in Chicago, and whom he has also long been on bad terms with, compensation for the money which he used allegedly from Lorenzo's share in the inheritance, along with interest and

legal fees. The money which Lorenzo received accounted for half of what Viganò collected from the inheritance. Lorenzo had previously filed a lawsuit against Viganò in 2010 as well, but later dropped his first case in 2014 after Viganò agreed to donate \$180,000 to a children's hospital in Tanzania where a daughter of their sister Rosanna Viganò was working, and also return to Rosanna 8,600 euro (\$11,000) used in 1983 in order to buy an apartment.

Archbishop Viganò's critics allege he sought to use Lorenzo's health problems, which resulted from a stroke, as a reason to avoid taking the position as nuncio to the United States, claiming that he needed to care for his brother, whereas the real reason was that Viganò was seeking to obtain better access to the family's possessions, which he would get by remaining in Rome.

Archbishop Viganò denied the accusations. His supporters said they were a smear campaign designed to discredit him. The siblings of the Archbishop have come forward in a press release to support his innocence in the case against their brother Lorenzo.

Although his name has disappeared from the Italian and Catholic newspapers, Undoubtedly the hounds of the pope continue to chase down any and all leads that would bring retribution and his demise.
