CRISPR

The Technology That Changes & Re-Writes Your DNA

Part 1

If you got a Covid-19 vaccine, you got something other than a vaccine. When you find out what you really had injected into your arm, you have serious reason for concern. The so-called vaccine is not a vaccine, and legally cannot be promoted as a vaccine. It is "Gene Therapy".

Several prominent physicians, doctors, *Sons of Liberty Media,* Health and Wellness expert Kate Shemirani, her colleague Dr. Kevin Corbett, and I have postulated that the current experimental mRNA injection for coronavirus, aka COVID-19, could alter one's genetic code or DNA. Bill Gates stated it, which was included in the video "Human Genome 8 and mRNA Vaccine" on Brighteon.com. It is one reason the term "experimental human genome altering mRNA injection" has been used to describe the jab being foisted onto the mostly unsuspecting public. They are not about to tell the public about CRISPR and 5G and the fact the mRNA does not have a "kill" switch!

While many in the media, Dr. Anthony Fauci and his merry band of chronic liars, and "fact checkers" have declared this claim as false, a video of a TEDx Beacon Street talk by Tal Zaks, chief medical officer of Moderna, Inc., one pharmaceutical company manufacturer of the experimental mRNA technology injection, confirms mRNA injection for COVID-19 *can* change your genetic code or DNA. This TEDx Beacon Street talk occurred in 2017. H/T to YouTube channel Silview Media Backup Channel.

Zaks calls it "hacking the software of life". In the first minute of the video Zaks states, "we've been living this phenomenal digital scientific revolution, and I'm here today to tell you, that we are actually hacking the software of life, and that it's changing the way we think about prevention and treatment of disease." [Emphasis mine.] He even repeats that they (Moderna) think of it like an "operating system", which the Moderna website indicates as "Our Operating System". He is equating it to a computer program!

At one minute in, Zaks states, "In every cell there's this thing called messenger RNA or mRNA for short that transmits the critical information from the DNA in our genes to the protein, which is really the stuff we're all made out of. This is the critical information that determines what the cell will do. So we think about it as an operating system. So if you could actually change that, if you could introduce a line of code, or change a line of code, it turns out, that has profound implications for everything, from the flu to cancer." You have no idea to the length he is referring to about CRISPR/Cas9!

When "changing" a line of code or "introducing" a line of code" (referring to DNA), the "code" or DNA is then altered, meaning the individual or "subject" has now had their genome changed to what the "scientists" have coded. The individual or subject is no longer a creation of God but a creation of man, meaning the individual or subject could be the object of a "patent". He goes on to say, the mRNA would tell the cells to "code" for the protein of the "virus". This "viral protein" is foreign to the body. The individual's body is making a foreign protein the immune system is to attack. When the body makes a protein the immune system then attacks, your immune system is attacking a protein your body is making, meaning what is occurring in an "auto-immune response" or "auto-immune disease".

This has been repeated a number of times by experts, physicians, nurses and countless others. As readers can see, none of us were "whistling Dixie". Zaks talks about turning this system on; <u>however</u>, there is no way to turn it off. When do the cells know to stop making this "viral protein"? The cells don't; therefore, this continues for the duration.

In a normal vaccine, the immune system attacks the limited amount of "particles" in the adjuvant to produce antibodies or immune response that the body can recognize at a later time if the individual comes in contact with the same or similar "particle".

The study Zaks cites at the 3:12 minute mark can be found and read here. The abstract is contained on the NIH Pub Med Library website. In the full test of the study on ResearchGate, the mention of "Luciferase" occurs on page 10. A crucial piece of information in this study is contained on page 4 – "Ferrets immunized with 200 micrograms and challenged [exposed to influenza H7N9 via IN (intranasal)] on day 49 had viral loads below the level of detection". If a viral load was "below the level of detection", two questions emerge: 1) did the ferrets even contract H7N9 through intranasal challenge; and, 2) if a viral load is below the level of detection, how do you know the animals even had a viral load? This would bring into question the efficacy of the injection.

Moreover, the studies Zaks cites as occurring in humans only lasted approximately 18 months. They were stopped because the animals in the study all died!

At about the 4:00 minute mark, Zaks begins discussing mRNA vaccines for cancer. Immediately following that, Zaks discusses a children's condition where a gene or "code" is missing that causes production of a certain enzyme critical for metabolism where the current treatment is to transplant an entire organ – in this case, the liver. Zaks proposes to inject mRNA that codes for the missing gene, a gene contained in DNA on the human genome, it would "correct" the genetic defect.

Ask this question: what causes the cells/body to produce needed enzymes/proteins? Zaks answers that by saying the genetic code or DNA. So, mRNA has to alter a genetic code or the DNA for the body to produce the proteins of COVID-19 for the body to mount an immune response.

Out of the words of Tal Zaks of Moderna, mRNA can alter the human genome. Whether by design or "unintended consequences", this technology is being used to do just that. He calls this "information therapy"; although, some would call it "mad science". In attempts to "rewrite" genetic code to correct defects, studies have shown there were "cascading failures". In other words, changing one "defective gene" in one genome caused other genes to "fail" or cause problems. And, it was not just one subsequent gene becoming defective, but many. This is more than likely why there are over 400 adverse events surrounding the experimental mRNA injection.

So, the next time someone claims these "vaccines" do not alter the human genome or DNA; you can refer that individual to Tal Zaks of Moderna, Inc. who claims otherwise.

For nearly a year now, I have been told by many people that you cannot change our DNA. My daughter-in-law thinks I do not know what I am talking about. She refused to read the evidence revealed by Moderna in 2020 that states their vaccine is in fact, "A Delivery System". When I first read the Moderna statement last summer, my first question was, what is it that they are going to deliver in their "Delivery System."

In the many articles that I have written on 5G EM wireless communications and Covid-19, I shared how 5G EM wireless energy could be beamed into the human cells through a process called "Electroporation". 5G EMF is part and parcel of the military ADS or "active-denial-system". Below is a larger truck mounted version of this ADS.



Informally, the weapon is also called the heat-ray since it works by heating the surface of targets, such as the skin of targeted human beings. Raytheon had marketed a reduced-range version of this technology. The ADS was deployed in 2010 with the

United States military in the Afghanistan War, but was withdrawn without seeing combat. There are smaller versions mounted on the smaller Humvee platform.

The ADS works by firing a high-powered (100 kW output power) beam of 95 GHz waves at a target, which corresponds to a wavelength of 3.2 mm. The ADS millimeter wave energy works on a similar principle as a microwave oven, exciting the water and fat molecules in the skin, and instantly heating them via dielectric heating. One significant difference is that a microwave oven uses the much lower frequency (and longer wavelength) of 2.45 GHz. The short millimeter waves used in ADS only penetrate the top layers of skin, with most of the energy being absorbed within 0.4 mm (1/64th inch), whereas microwaves will penetrate into human tissue about 17 mm (0.67 inch). Although described as a non-lethal crowd repelling weapon, it can deliver lethal energy if needed. It can kill you if needed!

My daughter-in-law is dead wrong but she chose to get the "vaccines" anyway. The hospital at which she works likely insisted that hospital employees be vaccinated for the "imaginary" Covid-19 virus. Enabling Drug Discovery & Development



We have a dedicated team of several hundred scientists and engineers solely focused on advancing Moderna's platform technology. They are organized around key disciplines and work in an integrated fashion to advance knowledge surrounding mRNA science and solve for challenges that are unique to mRNA drug development. Our mRNA Medicines – The 'Software of Life'

When we have a concept for a new mRNA medicine and begin research, fundamental components are already in place.

Generally, the only thing that changes from one potential mRNA medicine to another is the coding region – the actual genetic code that instructs ribosomes to make protein. Utilizing these instruction sets gives our investigational mRNA medicines a software-like quality. We also have the ability to combine different mRNA sequences encoding for different proteins in a single mRNA investigational medicine. [This is done with 5G and CRISPR.]

We are leveraging the flexibility afforded by our platform and the fundamental role mRNA plays in protein synthesis to pursue mRNA medicines for a broad spectrum of diseases.


Within a given modality, the base components are generally identical across development candidates - formulation, 5' region and 3' region. Only the coding region varies based on the protein/s the potential medicine is directing cells to produce.

Learn how our <u>Research Engine</u> and <u>Early Development Engine</u> are enabling us to fully maximize the promise of mRNA to meaningfully improve how medicines are discovered, developed and manufactured.

Overcoming Key Challenges

Using mRNA to create medicines is a complex undertaking and requires overcoming novel scientific and technical challenges. We need to get the mRNA into the targeted tissue and cells while evading the immune system. If the immune system is triggered, the resultant response may limit protein production and, thus, limit the therapeutic benefit of mRNA medicines. We also need ribosomes to think the mRNA was produced naturally, so they can accurately read the instructions to produce the right protein. And we need to ensure the cells express enough of the protein to have the desired therapeutic effect.

Our multidisciplinary platform teams work together closely to address these scientific and technical challenges. This intensive cross-functional collaboration has enabled us to advance key aspects of our platform and make significant strides to deliver mRNA medicines for patients.



The mapping of the Human Genome was finished about the beginning of the new millennium. An initial rough draft of the human genome was available in June 2000 and by February 2001 a working draft had been completed and published followed by the final sequencing mapping of the human genome on April 14, 2003. You may have heard about CRISPR or CRISPR/Cas9, a powerful gene-editing tool that allows scientist to edit our DNA. CRISPR is used in GMO crops, animals, and humans!

But how did the CRISPR technology come about? CRISPR was discovered in the span of several years and mostly by accident. Following is a chronological order of CRISPR discovery. CRISPR is the result of discovery and invention. It was unveiled in January, 2013 — Feng Zhang, from Broad Institute of MIT and Harvard, McGovern Institute for Brain Research at MIT, Massachusetts. He showed that the CRISPR system can be programmed to be used as a gene-editing tool. Also, it can be used in higher organisms, as he used it in humans and mouse cell lines. This was preceded by ten years of experiments and discoveries in the field of genetics.

Experiments and work in the area of gene therapy has been ongoing in labs around the world for a decade. My interest in CRISPR technology began in March, 2020 following the outbreak or release of a virus in Wuhan, China. 2013 is sort of the launching of genetic engineering in the field of DNA. There is solid reason to believe that the ability to change your DNA and or re-write human DNA has advanced much further than what the general public seems to know at this point in time. The elite plan is to microchip the world! This comes in the second phase of the vaccination process of Bill Gates QuantumDot/Hydrogel ID2020. The Covid-19 vaccines insert a third strand of one's DNA through the mRNA package. Yearly booster shots will be required to fake out the human immune system.

God built into the human body a perfect immune system which attacks invasive sicknesses, viruses, and other unhealthy invaders. In order for the "Mark" of the Beast to be implanted into the body, God's immune system has to be tricked into believing that any injection is "natural". This is the primary reason for Covid-19. Before CRISPR can be used to treat cancer in humans, we need to make sure it's both safe and effective. This means some big things need to be figured out before any of these treatments are made available to humans. There is a concern that CRISPR could actually cause cancer through off-target knockouts or errors made by the cell's repair system. Not surprisingly, both of these risks increase when multiple genes are edited at once. In addressing these issues, scientists are working on better ways to deliver the Cas9 complex to cells.

When I began researching on how 5G EM wireless energy could be beamed into the pours of a person's skin, I was stunned to learn about the process known as Electroporation, and could see the connection that 5G technologies could be then used as a weapon to control and even eliminate humans. I began reading patents and research papers on Gene Editing. And so my learning curve began to expand my horizon. I can confirm everything that I have written over the past couple years about 5G and later the Corona virus was spot on! Right now, the most common way for CRISPR/Cas9 to get into a cell is to hitch a ride with that ancient bacterial enemy – the virus. Viruses are good carriers because they make a living off of infecting cells and incorporating their own DNA into their hosts' genomes. The viruses used in gene editing don't cause disease in humans because the viral genes have been removed to create something called a vector. But viral vectors still have limitations: they can only carry a small amount of DNA, they stick around for a long time, and they can produce an immune response, and they sometimes start messing with the DNA in places they have no right to be.

For all of these reasons, scientists are working on alternative ways for Cas9 to catch a ride into target cells. Some alternative delivery mechanisms include:

- Nanoparticle: The idea behind this method is to wrap Cas9 into a super-tiny
 package that gets piggy-packed into the cell on the back of something that can
 easily travel through the channels in the cell membrane, like a fat molecule or
 gold particle.
- Light: This method also uses nanoparticles, but in this case, they're light-activated. Once inside the nucleus, the nanoparticles hang on to Cas9 until light is shown on the cell. Only then is Cas9 set free to get to work editing genes.

- Electric shock: A zap of electricity can relax cells enough to let Cas9 in without the need for any vehicle at all.
- Microinjection: Exactly as it sounds, this method involves giving the cell an injection with a microscopic needle. Microinjection is commonly used to create animal models, in plants, the CRISPR system is more likely to be blasted directly into the cell with a gene gun.

Electroporation describes the third above, electric shock. Choosing the best delivery vehicle depends on what cell type you are targeting and whether it's inside the body or outside the body. When using CRISPR to treat human disease, it is important to make sure the Cas9 package is delivered to the right place; miss, and the therapy could have unintended consequences. You do not want to knock out receptiors in the wrong immune cells, for example. Ideally, doctors would also like to have a "kill switch" to control the Cas9 once it gets into the cell. That way, it could be shut down if anything goes wrong or when it's no longer needed. This is why the present vaccines being promoted for the Covid-19 are of great concern. As Dr. Judy Mikovitzs, Dr. Sherri Tenpenny, Dr. Andy Wakefield, Dr. Andrew Kaufman, Dr. Stefan Lanka, and so many others around the world are worried. There is no "kill switch" in their vaccines!

It is this issue that these doctors believe millions will die. Once given the shots, 20% of the nation are now vaccinated with one of the so-called vaccines as of mid-March, 2021. Dr. Sherri Tenpenny says that deaths will skyrocket from the 3rd month out from the vaccination through the first year. Most people will die within five years, and some may survive up to twenty years. What determines how long one lives has to deal with a combination of things: a healthy immune system to begin with, and overall health. So if a person is young, healthy, and avoids health issues, they will live longer. However, if the person is exposed to a variety of factors, such as environment, pollutants, health conditions, and a weakened immune system, they are prone to overwork their immune system and develop autoimmunity issues, life will be diminished as the immune system tires and wears out from abuse.

This is further complicated by the fact that 18 fragments of the HIV1 were intentionally inserted in the virus that was released into the public in China. Those 18 fragments constituted 80% of the HIV1 payload. Although it does not mean a person will contract HIV1, they are at greater risk of getting sick over time and overworking their natural immune system, and early death. 

CRISPR sequences are characterized by clusters of identical repeats interspaced with non-identical segments called spacers. These prokaryotic DNA elements are derived from viruses when they attack the prokaryote. Subsequently, these DNA sequences are involved in adaptive immunity against invasive genetic elements, including viruses and plasmids. The CRISPR segments, along with certain enzymes, constitute a basis of a powerful gene-editing system. Thus, in the modern biological fields, the term CRISPR denotes more of a genome-editing tool than just the gene sequences coding for immunity in bacteria.


CRISPR is, therefore, revolutionizing modern biotechnology and molecular biology. Studies have shown that the CRISPR system is present in nearly 40% of bacteria and 90% of archaea. But with the applications of biotechnology, this natural feature of prokaryotic organisms is becoming a much larger tool to disseminate its applications of genome editing to wide range of organisms including baker's yeast (Saccharomyces cerevisiae), Candida albicans, Drosophila melanogaster, ants, mosquitoes, nematodes, plants, mice, monkeys, etc. and even human embryos. The CRISPR/Cas9 has become as much consequential as the zinc finger nucleases and TALEN proteins. While many pre-existing genome editing companies have adopted CRISPR, a large number of

CRISPR startups have been established throughout the globe. Don't let the technical language scare you, it's not as complex as it sounds.



From agriculture and food technology to pharmaceuticals and therapeutics, CRISPR is truly transforming the realm of biotechnology. When Bill Gates revealed his plan last year for the QuantumDot/Hydrogel ID2020, it was through his grants and investments in biotech companies that has brought to market the "Mark" of the Beast. The Gates family have a history of involvement with Eugenics and Planned Parenthood, and so it came as no real surprise how he bragged on his new ID2020. Bill Gates has a reprobate mind. That was evident in testimony he gave in an Anti-Trust trial against

Microsoft years ago. His testimony was evasive and cunning at points where he was parsing his words much like former President Clinton did when he parsed the little word "is". Also, Bill Gates has deep ties and connections with the Defense Department and the CIA on projects designed and intended to harm people.



The phrase "reprobate mind" is found in Romans 1:28 in reference to those whom God has rejected as godless and wicked. They "suppress the truth by their wickedness," and it is upon these people that the wrath of God rests -(Romans 1:18). The Greek word translated "reprobate" in the New Testament is adokimos, which means literally "unapproved, that is, rejected; by implication, worthless (literally or morally)."

Bill Gates portrays a façade of being a philanthropist to charity and needy causes, which serves as cover for an otherwise evil agenda, to reduce population growth through vaccines corrupted with contaminants designed to kill and maim. At the winter meeting of the world elite in Davos, Switzerland, a year ago, he made the statement that his investments in vaccines has been a 20 to 1 success story, in terms of profits.

The Moderna and Pfizer vaccines are not vaccines in the legal definition of what a vaccine is supposed to do. According to Dr. David Martin, these manufacturers had to disguise their treatments as vaccines in order to fit them under the 1905 Jacobson v. Massachusetts U.S. Supreme Court case, a ruling that has been interpreted [some say misinterpreted] as a license for states to mandate vaccines during health emergencies.

"Let's make sure we're clear on something. Let's stipulate that this is not a vaccine. We need to be very clear that we're using the term vaccine to sneak this thing in under public health exemptions. This is not a vaccine. This is an mRNA, packaged in a fat envelope, delivered to a cell. This is a medical device designed to stimulate the human cell into becoming a pathogen creator. It is not a vaccine. Vaccines are actually a legally defined term. And they're a legally defined term under public health law. They're a legally defined term under CDC and FDA standards, and a vaccine specifically has to stimulate, both an immunity within the person receiving it but it also has to disrupt transmission. And that's not what this is. They have been abundantly clear in saying that the mRNA strand going into the cell is not to stop transmission. It is a treatment. But if, it was discussed as a treatment it would not get the sympathetic ear of the public health authorities because then people would say well what other treatments are there?"

"The use of the term vaccine is unconscionable for both the legal definition of it, but also because it actually is the sucker punch to open and free discourse, because by saying 'vaccine' you dump it into a thing where you could be anti or pro 'the therapy,' but if you actually talked about it as a therapy, and remember, and people forget this, Moderna was started as a chemotherapy company for cancer, not a vaccine manufacturer for SARS-COV2. If we said we're going to give people prophylactic therapy for the cancer they don't have, you'd be laughed out of a room, because that's a stupid idea. That's exactly what this is. This is a mechanical device in the form of a very small packet of technology that is being inserted into the human system to activate the cell to become a pathogen-manufacturing site."

"And I refuse to stipulate in any conversations that this is in fact a vaccine issue. The only reason why the term is being used was to abuse the 1905 Jacobson case that has been misrepresented since it was written. And if we were honest with this we would

actually call it what it is. It is a chemical pathogen device that is actually meant to unleash a chemically pathogen production action within a cell. It is a medical device, not a drug, because it meets the CDRH [Center for Devices and Radiological Health] definition of a medical device. It is not a living system, it is not a biologic system [as it would be if it were a vaccine]. It is a physical technology. It happens to just come in the size of a molecular package."

"So we need to be really clear on making sure we don't fall for their game, because their game is if we talk about it as a vaccine then we're going to get into a vaccine conversation. But this is not, by their own admission, a vaccine. As a result it must be clear to everyone listening that we will not fall for this failed definition, just like we won't fall for their industrial-chemical definition of health, because both of them are functionally flawed and are an explicit violation of the legal construct that is being exploited."

"I get frustrated when I hear activists and lawyers and everybody else say, 'we're going to fight the vaccine.' If you stipulate that it's a vaccine you've already lost the battle. It is not a vaccine."

At the heart of the criticism of the Moderna and Pfizer so-called vaccines is the issue of absence of a "kill switch" to turn off the gene therapy process when it has done its job.

It was used for the first time in humans in 2016 and a trial is underway in the United States to use the experimental technology to treat a dozen patients with sickle cell disease, a group of inherited blood disorders.

Why has it been controversial?

While it has immense potential to transform our lives, the technology has raised many ethical questions. I will identify these issues later which raise concern about the use of CRISPR/Cas9.

Chinese scientist He Jiankui was jailed for three years in 2019 after announcing that twin girls had been born with modified DNA to make them resistant to HIV, which he had managed using the gene-editing tool CRISPR/Cas9 before birth.

An associate professor at the Southern University of Science and Technology in Shenzhen at the time, he said that he was "proud" of the achievement. But he was condemned by many of his peers, with the experiment labeled "monstrous," "unethical" and a "huge blow" to the reputation of Chinese biomedical research.

Claes Gustafsson, secretary of the Nobel committee in chemistry and a professor of biochemistry and biophysics at Stockholm University, said that with "every really powerful technology, in life sciences or elsewhere, there's a possibility of misuse."

"Clearly this Chinese researcher was way out of line in applying it in this particular way," he told CNN.

"Everyone has agreed that it cannot be used for germ line engineering. You can't make heritable changes to human DNA. That is far too uncertain at this point," added Gustafsson. "There are specific genetic diseases you can think of curing for the individual but not in a heritable way."

Scientists have called for a moratorium on human germ line editing, while efforts are being made to better regulate use of the technology. An international commission said in September it was too early for gene-edited human embryos to be used to create a pregnancy.

Doudna has expressed deep concern about He's work, telling CNN it was not medically necessary and there was no way to defend using an experimental technology when there were established ways of avoiding HIV transmission.

We've barely begun to understand how CRISPR works in the natural world. Microbes use it as a sophisticated immune system, allowing them to learn to recognize their enemies. Now scientists are discovering that microbes use CRISPR for other jobs as well. The natural history of CRISPR poses many questions to scientists, for which they don't have very good answers yet. But it also holds great promise. Doudna and her colleagues harnessed one type of CRISPR, but scientists are finding a vast menagerie of different types. Tapping that diversity could lead to more effective gene editing technology, or open the way to applications no one has thought of yet.

Biotech companies which use living organisms to produce drugs and other products are some of the biggest traded companies on the stock market today. In fact, some are so invested in CRISPR that they have worked the technology into their corporate names! And each of the three largest publicly traded companies has over a \$billion invested in them, even though they are all just in the research and development phase. In simple terms, none of them have anything to sell at this point.

The concept of CRISPR is essentially the old newspaper editing term "Cut and Paste".

As CRISPR started to give up its secrets, Doudna got curious. She had already made a name for herself as an expert on RNA, a single-stranded cousin to DNA. Originally, scientists had seen RNA's main job as a messenger. Cells would make a copy of a gene using RNA, and then use that messenger RNA as a template for building a protein. But Doudna and other scientists illuminated many other jobs that RNA can do, such as acting as sensors or controlling the activity of genes.

Before the discovery of CRISPR, all the defenses that microbes were known to use against viruses were simple, one-size-fits-all strategies. Restriction enzymes, for example, will destroy any piece of unprotected DNA. Scientists refer to this style of defense as innate immunity. We have innate immunity, too, but on top of that, we also

use an entirely different immune system to fight pathogens: one that learns about our enemies.

This so-called adaptive immune system is organized around a special set of immune cells that swallow up pathogens and then present fragments of them, called antigens, to other immune cells. If an immune cell binds tightly to an antigen, the cell multiplies. The process of division adds some random changes to the cell's antigen receptor genes. In a few cases, the changes alter the receptor in a way that lets it grab the antigen even more tightly. Immune cells with the improved receptor then multiply even more.

This cycle results in an army of immune cells with receptors that can bind quickly and tightly to a particular type of pathogen, making them into precise assassins. Other immune cells produce antibodies that can also grab onto the antigens and help kill the pathogen. It takes a few days for the adaptive immune system to learn to recognize the measles virus, for instance, and wipe it out. But once the infection is over, we can hold onto these immunological memories. A few immune cells tailored to measles stay with us for our lifetime, ready to attack again.

CRISPR, microbiologists realized, is also an adaptive immune system. It lets microbes learn the signatures of new viruses and remember them. And while we need a complex network of different cell types and signals to learn to recognize pathogens, a single-celled microbe has all the equipment necessary to learn the same lesson on its own.

So when Tal Zaks, CEO of Moderna calls it "hacking the software of life". In the first minute of the video Zaks states, "we've been living this phenomenal digital scientific revolution, and I'm here today to tell you, that we are actually hacking the software of life, and that it's changing the way we think about prevention and treatment of disease.", he is saying that we are playing God!

And as scientists discover more tasks that CRISPR accomplishes in nature, they may be able to mimic those functions, too. Doudna is curious about using CRISPR as a diagnostic tool, searching cells for cancerous mutations, for example. "It's seek and detect, not seek and destroy," she said. But having been surprised by CRISPR before, Doudna expects the biggest benefits from these molecules to surprise us yet again. "It makes you wonder what else is out there," she said.

Former world middleweight boxing champion and legend Marvin Hagler has reportedly died at the age of 66 yesterday. Earlier in the day Saturday, fellow boxing legend Thomas "Hitman" Hearns, who fought in the ring against Hagler in the 1980s, asked fans to pray for Hagler via his Instagram account, because he was in the ICU following an experimental COVID shot. The research was banned by the Obama Administration in October 2014, but was soon off-shored to China with grants coming from the NIH.

U.S. diplomats warned Washington about inadequate safety of Wuhan Institute of Virology in 2018

Rogin reveals that the U.S. Embassy in Beijing "took the unusual step of repeatedly sending US science diplomats to the WIV" in 2018 and sent two warnings back to Washington about the "inadequate safety of the lab." The American diplomats were shocked that the lab "didn't have enough properly trained technicians to safely operate their BSL-4 lab." It's no coincidence that a new coronavirus outbreak began in the exact same city that spent years studying coronavirus gain-of-function, with the largest collection of bat coronaviruses in the world, including the closest known relative of SARS-CoV-2!

In his brave pursuit for the truth, Rogin revealed in-depth insight from top U.S government officials who have evidence of dangerous Chinese "gain-of-function" research on coronaviruses that went above and beyond the "gain-of-function" research that was openly discussed with U.S. universities and institutions. Rogin revels that Chinese researchers were taking more risks in the lab, risks that governments did not understand at the time. The Chinese scientists ultimately found a way to engineer coronavirus spike proteins to exploit the ACE2 receptor in human lung cells. (Related: China rewrites COVID history, purges 300 studies linking virus to Wuhan lab.)

The Chinese military classified some of their most dangerous gain-of-function research

One of the more suspicious studies came from Beijing researchers affiliated with the Academy of Military Medical Science. In June 2020, the researchers published a new model for studying SARS-CoV-2, one that uses the CRISPR gene editing tool to alter mice lung cells. The scientists equipped the mice with the ACE2 receptor from human lung cells. This is the same receptor that they learned how to exploit with modified coronaviruses, using enhanced gain-of-function properties.

Upon further investigation, U.S. officials found evidence that this research was taking place in the lead-up to the original SARS-CoV-2 outbreak in China. The research was previously undisclosed, and Chinese researchers continued to deny it was taking place. Before the Trump Administration left office, the State Department wrote in a January 15th statement that the WIV had only disclosed some of its participation in "gain-offunction" research, but failed to disclose their work on RaTG13, which was classified laboratory animal experimentation, conducted on behalf of the Chinese military since 2017.

"This was just a peek under a curtain of an entire galaxy of activity, including labs and military labs in Beijing and Wuhan playing around with coronaviruses in ACE2 mice in unsafe labs," a senior US official told Rogin. "It suggests we are getting a peek at a body of activity that isn't understood in the West or even has precedent here."

While Josh Rogin at the Washington Post provides us insights to the Wuhan laxity in security, it fails to answer some of the issues relative to the 5G "smart" city roll out, deaths of millions, many recorded on the cell phones of Chinese residents, the involvement of MI6 and the CIA, the ownership of a vaccine facility owned by George Soros, and the Johns Hopkins Event 201 among other important connections.

Robert F. Kennedy, Jr. offers important insights to this entire scan-demic. <u>In October 2019</u>, shortly before the COVID outbreak, Gates and other powerful individuals began planning how to censor vaccine safety advocates from social media during a table-top simulation of a worldwide pandemic, known as Event 201.

Before the COVID-19 outbreak in the U.S., <u>Bill Gates organized four simulations of a</u> worldwide coronavirus pandemic.

Over the last two weeks, Facebook and other social media sites have deplatformed me (RFK Jr.) and many other critics of regulatory corruption and authoritarian public health policies. So, here is some fodder for those of you who have the eerie sense that the government/industry pandemic response feels like it was planned — even before there was a pandemic.

The attached document shows that <u>a cabal of powerful individuals did indeed begin planning the mass eviction of vaccine skeptics from social media in October 2019, a week or two before COVID began circulating.</u> That month, Microsoft founder Bill Gates

organized an exercise of four "table-top" simulations of a worldwide coronavirus pandemic with other high-ranking "Deep State" panjandrums. The exercise was referred to as Event 201.

Gates' co-conspirators included representatives from the World Bank, the World Economic Forum (Great Reset), Bloomberg/Johns Hopkins University Populations Center, the Centers for Disease Control and Prevention, various media powerhouses, the Chinese government, a former Central Intelligence Agency/National Security Agency director (there is no such thing as a former CIA officer), vaccine maker Johnson & Johnson, the finance and biosecurity industries and Edelman, the world's leading corporate PR firm.

At Gates' direction, these eminences role-played members of a Pandemic Control Council, <u>war-gaming government strategies for controlling the pandemic, the narrative and the population</u>. Needless to say, there was little talk of building immune systems, off-the-shelf remedies or off-patent therapeutic drugs and vitamins, but lots of chatter about promoting uptake of new patentable antiviral drugs and vaccines.

But the participants primarily focused on planning industry-centric, fear-mongering, police-state strategies for managing an imaginary global coronavirus contagion culminating in mass censorship of social media.

Oddly, <u>Gates now claims that the simulation didn't occur</u>. On April 12, 2020, Gates told BBC, "Now here we are. We didn't simulate this, we didn't practice, and so both the health policies and economic policies, we find ourselves in uncharted territory."

Unfortunately for that whopper, the videos of the event are still available across the internet. They show that Gates and team did indeed simulate health and economic policies. It's hard to swallow that Gates has forgotten.

Gates's Event 201 simulated COVID epidemic caused 65 million deaths at the 18-month endpoint and global economic collapse lasting up to a decade. Compared to the Gates simulation, therefore, the actual COVID-19 crisis is a bit of a dud, having imposed a mere 2.5 million deaths "attributed to COVID" over the past 13 months.

The deaths "attributed to COVID" in the real-life situation are highly questionable, and must be seen in the context of a global population of 7.8 billion, with about 59 million deaths expected annually. The predictions of decade-long economic collapse will probably prove more accurate — but only because of the draconian lockdown promoted by Gates.

Gates' Event 201 script imagines vast anti-vaccine riots triggered by internet posts. The universal and single-minded presumption among its participants was that such a crisis would prove an opportunity of convenience to promote new vaccines, and tighten controls by a surveillance and censorship state.

Segment four of the script — on manipulation and control of public opinion — is most revealing. It uncannily predicted democracy's current crisis:

- •The participants discussed mechanisms for controlling "disinformation" and "misinformation," by "flooding" the media with propaganda ("good information"), imposing penalties for spreading falsehoods and discrediting the anti-vaccination movement.
- •Jane Halton, of Australia's ANZ Bank, one of the authors of Australia's oppressive "no jab, no pay" policy, assured the participants that Gates Foundation is creating algorithms "to sift through information on these social media platforms" to protect the public from dangerous thoughts and information.
- •George Gao, the prescient director of the Chinese Center for Disease Control, worries about how to suppress "rumors" that the virus is laboratory generated: "People believe, 'This is a manmade'... [and that] some pharmaceutical company made the virus."
- •Chen Huang, an Apple research scientist, Google scholar and the world's leading expert on tracking and tracing and facial recognition technology, role-plays the newscaster reporting on government countermeasures. He blames riots on anti-vaccine activists and predicts that Twitter and Facebook will cooperate in "identify[ing] and delete[ing] a disturbing number of accounts dedicated to spreading misinformation about the outbreak" and to implement "internet shutdowns ... to quell panic."
- •Dr. Tara Kirk Sell, a senior scholar at Bloomberg School of Health's Johns Hopkins Center for Health Security, worries that pharmaceutical companies are being accused of introducing the virus so they can make money on drugs and vaccines: "[We] have seen public faith in their products plummet." She notes with alarm that "Unrest, due to false rumors and divisive messaging, is rising and is exacerbating spread of the disease as levels of trust fall and people stop cooperating with response efforts. This is a massive problem, one that threatens governments and trusted institutions."

Sell reminds her fellow collaborators that "We know that social media is now the primary way that many people get their news, so interruptions to these platforms could curb the spread of misinformation." There are many ways, Sell advises, for government and industry allies to accomplish this objective: "Some governments have taken control of national access to the Internet. Others are censoring websites and social media content and a small number have shut down Internet access completely to prevent the spread of misinformation. Penalties have been put in place for spreading harmful falsehoods, including arrests."

•Matthew Harrington, CEO of Edelman Public Relations agrees that social media must fall in line to promote government policy: "I also think we're at a moment where the social media platforms have to step forward and recognize the moment to assert that they're a technology platform and not a broadcaster is over. They in fact have to be a participant in broadcasting accurate information and partnering with the scientific and

health communities to counterweight, if not flood the zone, of accurate information. Because to try to put the genie back in the bottle of misinformation and disinformation is not possible."

- •Stephen Redd, the Admiral of the Public Health Service, has the sinister notion that government should mine social media data to identify people with negative beliefs: "I think with the social media platforms, there's an opportunity to understand who it is that's susceptible ... to misinformation, so I think there's an opportunity to collect data from that communication mechanism."
- •Adrian Thomas of Johnson & Johnson announces "some important news to share from some of "our member companies [Pharma]": We are doing clinical trials in new anti-retrovirals, and in fact, in vaccines!" He recommends a strategy to address the problems to these companies when "rumors were actually spreading" that their shoddily tested products "are causing deaths and so patients are not taking them anymore." He suggests, "Maybe we're making the mistake of reporting and counting all the fatalities and infections."
- •Former CIA deputy director, Avril Haines unveiled a strategy to "flood the zone" with propaganda from "trusted sources," including "influential community leaders, as well as health workers." He warns about "false information that is starting to actually hamper our ability to address the pandemic, then we need to be able to respond quickly to it."
- •Matthew Harrington (Edelman CEO) observes that the Internet which once promised the decentralization and democratization of information now needs to be centralized: "I think just to build a little bit on what Avril said, I think as in previous conversations where we've talked about centralization around management of information or public health needs, there needs to be a centralized response around the communications approach that then is cascaded to informed advocates, represented in the NGO communities, the medical professionals, et cetera."
- •Tom Inglesby (John Hopkins biosecurity expert advisor to the National Institutes of Health, the Pentagon and Homeland Security) agrees that centralized control is needed: "You mean centralized international?"
- •Matthew Harrington (Edelman) replies that information access should be: "Centralized on an international basis, because I think there needs to be a central repository of data facts and key messages."
- •Hasti Taghi (Media Advisor) sums up: "The anti-vaccine movement was very strong and this is something specifically through social media that has spread. So as we do the research to come up with the right vaccines to help prevent the continuation of this, how do we get the right information out there? How do we communicate the right information to ensure that the public has trust in these vaccines that we're creating?"

- •Kevin McAleese, communications officer for Gates-funded agricultural projects, observes that: "To me, it is clear countries need to make strong efforts to manage both mis- and disinformation. We know social media companies are working around the clock to combat these disinformation campaigns. The task of identifying every bad actor is immense. This is a huge problem that's going to keep us from ending the pandemic and might even lead to the fall of governments, as we saw in the Arab Spring. If the solution means controlling and reducing access to information, I think it's the right choice."
- •Tom Inglesby, director of Bloomberg's Johns Hopkins Center for Health Security concurs, asking if "In this case, do you think governments are at the point where they need to require social media companies to operate in a certain way?"
- •Lavan Thiru, Singapore's Finance Minister suggests that the government might make examples of dissidents with "government or enforcement actions against fake news. Some of us, this new regulations are come in place about how we deal with fake news. Maybe this is a time for us to showcase some cases where we are able to bring forward some bad actors and leave it before the courts to decide whether they have actually spread some fake news."

It is hard for the regulators to keep up with the rapid pace of development. This is especially true since they are under a lot of pressure from shareholders that are banking on the success of a company's product. Switzerland has more billionaires per capita than any other country in the world. It is home to many biotech companies that you have never heard of.

How do we make sure that regulators do their jobs properly? And if a CRISPR treatment does get approved, how do we educate everyone on the potential harms and benefits?

All medicine has side effects. You have seen those commercials listing all of the things that might happen to you if you take a certain medication. But with that type of medication, the side effects usually disappear once you stop taking it. But with CRISPR-Cas9 errors are incorporated into the human genome. This means that not only is the change permanent, but it also gets copied every time that cell divides. This is the scary side of CRISPR-Cas9 and gene therapy. This cannot be undone, permanent means exactly what it says!

Now consider this before you make your decision. The White House will soon unveil a wide-reaching public relations campaign aimed at boosting vaccine confidence and uptake across the U.S. This is making its debut next week.

This television, radio, and digital advertising blitz, set to kick off within weeks, will focus on Americans outright skeptical of vaccines' safety or effectiveness as well as those who are potentially more willing to seek a Covid-19 immunization but don't yet know where, when, or how. Specifically, this campaign will target three groups in which access, apathy, or outright skepticism may pose a barrier to vaccinations: young people, people of color, and conservatives, according to a Biden aide. Congress and the administration have set aside over \$1.5 billion for the effort.



Using the CDC's own records, we should be asking the question, Why the urgency? The likes of Dr. Fauci and Dr. Birx and Dr. Redfield are like someone yelling fire in a movie theater. Their own data discredits their rhetoric. <u>Clearly it suggests something</u> far more sinister than a virus not much worse than a bad cold or flu.

The effort highlights a looming and under-appreciated public health challenge: Though millions of Americans are currently clamoring to receive a Covid-19 vaccine, in a few short months, or even weeks, the opposite may be true. Instead of scrambling to manufacture doses, the government may soon be scrambling to find arms willing to receive them.

While the administration Covid-19 response advisers organizing the effort are broadly optimistic, they and many public health experts fear that without winning buy-in from a critical, final slice of the population, the effort could fall short of its goal: effectively ending the country's coronavirus crisis. How can they call this a crisis, where is the evidence, not the B.S. coming from the media, and dishonest health officials.

"I'm worried about the 15% of Americans who say they will not take the vaccine," said Sten Vermund, the dean of the Yale School of Public Health. "And about 8% or 9% of Americans say, 'I will take it if they make me, if my job forces me to.' So that's about 23% or 24%, and that's flirting with the level we need to get to herd immunity."

The rollout fulfills one of Biden's first promises in office. He pledged on January 21 to kick off an "<u>unprecedented vaccination public health campaign</u>" aimed at convincing every American adult to seek a Covid-19 immunization.

As for the specific content, administration officials said they were mindful that appeals directly from President Biden or Dr. Anthony Fauci are not likely to sway vaccine-hesitant people. As a result, they are expected to recruit both celebrities and trusted local officials to advance the pro-vaccine message.

Dorit Reiss, a law professor at the University of California, Hastings, whose research focuses on vaccine policy and ethics, explained why Biden and his lieutenants may not always be the best suited to spread the word. This reveals the length they will go to coerce people into rolling up their sleeve.

"Messaging from the Biden administration might not be where conservative communities would look for guidance," she said. "It's community leaders that you want to get on board, and it might be better for the federal government to provide funding for a variety of willing community leaders to address those communities instead." To that point, the plan includes a major emphasis on community-level messaging: Federal officials have already allocated more than \$500 million for local efforts to recruit local leaders and community organizations to encourage vaccine uptake and ensure racial equity in the vaccine distribution effort.

On a national level, White House officials declined to share details of what form many of the ads will take, or, in particular, whose voices they'll highlight. But in a hint of the strategy, top administration officials have been already deployed to spread the word. Vice President Kamala Harris, the first so-called Black and South Asian woman elected to the White House, has spent much of the past three weeks conducting in-person outreach, TV appearances, and radio interviews, in many cases geared specifically toward boosting vaccine uptake in Black communities. This is a lie, Kamela Harris is no more black than Nancy Pelosi. But what it does prove is their choreographed efforts to exploit race and ethnicity to get them to take a shot for a non-confirmed virus. Maybe they are using "modern math" taught in schools to sell this scam!

Convincing Americans that the current vaccines are safe and effective, experts say, could make the difference between a country with widespread immunity and one in which the disease continues to spread, albeit more slowly.

It is already clear that the White House is not deploying a one-message-fits-all strategy. Marcella Nunez-Smith, the Yale physician-researcher advising Biden on health equity, appeared last month on "The Shade Room", an online outlet geared toward Black viewers, and Anthony Fauci, the top government infectious diseases researcher, has conducted interviews with several Spanish-language news and entertainment outlets.

The administration has even deployed Francis Collins, the longtime director of the National Institutes of Health, to address one of the demographics that early surveys show is most likely to decline a Covid-19 vaccination: white, conservative, evangelical Christians. (According to a recent Marist poll, the three most vaccine-hesitant demographics are supporters of former President Donald Trump, Republicans, and white evangelical Christians, at 47%, 41%, and 38% likely to decline a vaccine, respectively.)


A supposedly Christian himself, Collins cast the vaccines as a "gift from God" in an interview with the Christian Broadcasting Network, and stressed that the Catholic Church has endorsed the use of Johnson & Johnson's vaccine despite its use of a cell

line that originated from an abortion procedure decades ago. Let's be serious, this is a gift from the devil!

The White House's announcement of the PR blitz will come just days after it decreed that by May 1, all state and local governments would be required to make all American adults eligible to sign up for vaccine appointments. The U.S. is currently administering over 2 million doses daily. Just over 10% of the population is fully vaccinated, and roughly 20% has received at least one vaccine dose.

But even as the vaccine rollout continues, some experts have fretted that when it comes to the PR campaign, there's no time to waste. In recent weeks, White House aides including Nunez-Smith and Cameron Webb, another physician advising Biden's pandemic response on equity issues, have work-shopped the plan with the Department of Health and Human Services, the Centers for Disease Control and Prevention, and local community leaders.

"I've been hosting roundtables with key constituencies to make sure that we get that effort right," Nunez-Smith said during a press briefing last week. "We're building relationships with trusted messengers, all over the country, to make sure they have the best information possible to share with their communities."



Think about it closely. This virus had a recovery rate of 99.95% without a vaccine. Never has there been such a concerted effort in the history of medicine to devote this

degree of promotion, money, and people to get an "experimental" unproven therapy. The fact that Pfizer's first experiments on animals was stopped because the test animals all died is proof-positive that humans will die as well. Pfizer, Moderna, J&J, and Astrazeneca have paid billions in fines for their past crimes. They are asking the public to play "Russian Roulette" with a bullet in every slot of the cylinder-chamber.

Much of the project's funding comes from the sweeping \$1.9 trillion Covid-19 relief bill Biden signed last week.

The administration has also already pledged over \$500 million in additional funds to address vaccine uptake, health literacy, and equity in the vaccine distribution, including \$250 million to fund local health literacy projects and another \$255 million for the CDC to fund local government efforts to focus on equity and confidence in underserved communities.

Upon taking power in January, the administration also inherited a third funding stream meant for Covid-19 mitigation and prevention efforts: a \$250 million contract that the Trump administration inked with the Virginia-based PR firm Fors Marsh months ago. That campaign, which began under President Trump and has continued under the Biden administration, has helped to fund Spanish-language radio commercials, ads in newspapers serving the Black community, and other Covid-19 mitigation outreach work. Taken all together, federal efforts to promote vaccine uptake total nearly \$2 billion.

The Biden administration will also have backup from the nonprofit world. It's working with the Ad Council, a nonprofit agency that has partnered with the government on PSAs meant to reduce drug and tobacco use, on a \$50 million campaign meant to sell Americans on vaccine safety and effectiveness. The Creative Coalition, another nonprofit, has also won buy-in from a collection of celebrities, corporate executives, and prominent public health figures for its own vaccine-focused campaign.

Those campaigns have largely relied on the same strategies foreshadowed by Biden aides. Much of the Ad Council's early effort, which consists of TV commercials, radio and print ads, and digital messaging, has stayed away from celebrities but nonetheless focused on Black and Spanish-speaking communities.

At a virtual kickoff dinner for the Creative Coalition campaign, meanwhile, Rochelle Walensky, the CDC director, said it would seek to "<u>harness the power of influencers in building vaccine confidence</u>." Dr. Fauci called celebrities' ability to build vaccine trust "extraordinary." Dr. Fauci is such a liar, and a Jesuit liar to boot!

In light of recent data, however, public health experts and Biden officials acknowledge that messaging to white conservatives — in other words, those least likely to view the new administration as credible — might pose the biggest hurdle to achieving true, population-wide immunity.

"When Magic Johnson said: 'I have HIV, I got tested, and I am going to keep my family safe, I'm going to take antiretroviral drugs,' we saw HIV testing rates go up the day after his announcement," said Vermund, the Yale public health dean, who is advising the Creative Coalition effort. "It may take Donald Trump as a celebrity, saying, 'I got the vaccine, I feel great.' It may take a different kind of celebrity to reach the conspiracists and the anti-vax folks who are militant in that space." (On Sunday, Dr. Fauci called for Trump to encourage his supporters to get vaccinated, calling such a message a potential "game-changer.") Well, Donald Trump came out on Fox News, on March 16th and did exactly that. Trump's integrity has taken a hit with that he has become a Judas goat!

Ask yourself, how much did they pay Trump to say that on Fox News? With \$2-billion to spend on advertising, I suspect that maybe the Rothschild's will cancel some of his \$300-million in real estate loans he owes the Rothschild's banks!

During an interview on Fox Primetime with host Maria Bartiromo, President Donald Trump made it absolutely clear that he recommends the Covid-19 vaccine shot to his supporters, even those who are reluctant or worried about potential side effects. Trump's advice comes just days after Biden medical advisor Anthony Fauci begged him to tell his supporters to take the vaccine.

"I know that you received the vaccine, Mrs. Trump also got the vaccine, would you recommend to our audience that they get the vaccine then?" Bartiromo asked.

"I would. I would recommend it and I would recommend it to a lot of people that don't want to get it and a lot of those people voted for me, frankly, but again, we have our freedoms and we have to live by that and I agree with that also," President Trump said. "But, it is a great vaccine. It is a safe vaccine and it is something that works."

The messaging and public health experts behind the federal campaign and both nonprofit efforts have recognized, however, that their initiatives carry an inherent obstacle: Regardless of which community they're addressing, a brief word from a celebrity or politician is unlikely to be effective on its own.

Part of the Creative Coalition's mission, said the group's CEO, Robin Bronk, is to recognize the ineffectiveness of simply parachuting into communities for a one-off celebrity cameo — a message she said the nonprofit and federal efforts would do well to bear in mind.

"We call it 'red carpet-bagging,' meaning that if you blow in and blow out for something, it's not authentic, and it's going to do more damage to the issue," Bronk said. "Sometimes we don't get involved in issues, particularly because getting the Hollywood community into it would do more harm than good. It's not just throwing a celebrity up getting an arm jabbed — we have to be thoughtful.





Leana Wen, an emergency physician and visiting professor at George Washington University Milken Institute School of Public Health, and the previous health commissioner for Baltimore is leading that charge.
