At Least Eight Carnival Guests Test Positive for COVID-19 on Carnival's Mardi Gras

At least eight (8) Carnival Cruise Line guests who have tested positive during the first two weeks on the Carnival 'Mardi Gras' sailings. Of course, Carnival Cruise Line has not disclosed these cases or other cases on the ship. The only question is how many other passengers and crew members tested positive during these two cruises. Last week, Florida Today published an article by Dave Berman titled As Cruise Ship Passengers and Crew Contract COVID-19, Cruise Lines Upgrade Their Protocols.



The article states that "three passengers tested positive for COVID-19 at the end of the recent inaugural seven-night sailing from Port Canaveral of Carnival Cruise Line's newest and largest ship, the 'Mardi Gras'." It is less than clear whether Carnival or the home port (Port Canaveral) disclosed the positive cases.

Port officials at Port Canaveral explained to the newspaper that “two of the passengers were children who did not have the COVID-19 vaccine, and the third was a vaccinated parent of one of the children . . . .”

There were at least that many COVID infected passengers on the next cruise on this Carnival ship, which left Port Canaveral on August 7th and returned August 14th. This is the particular voyage during which cruise vlogger [Dee of the vlogging partners Dee and Jay \(who operate the popular “ParoDeeJay” YouTube page\) became infected with COVID](#). A couple on the same cruise subsequently advised me that they and another couple all tested positive after leaving the *Mardi Gras*, and again re -tested positive on a repeat test (See, [comment section of article](#)). Their complaints appear to have been ignored when the couple contacted Carnival Cruise Line after the cruise: Jim Walker reported:

- “We tried to contact Carnival on Saturday to no answer even on Emergency number and sent an email to their customer care. This morning we called reservations and reported it and they said they were sending it to the resolution department. We still have not heard from anyone at Carnival. How many more are there and shouldn’t Carnival be engaging?”

This past week, [26 crew members on the Carnival Vista tested positive for COVID-19, one guest died](#) after a medical evacuation from the port in Belize to the U.S., and [one became very ill](#) and was in a hospital ashore in Belize. Other guests undoubtedly became infected but Carnival summarily dismissed the seriousness of the outbreak claiming that it was managing just a “small number” of infected people.

Last week, the [Sun Sentinel newspaper](#) in Fort Lauderdale inquired into the number of COVID-19 cases on Carnival’s cruise ships. A Carnival representative responded by stating “ . . . ***we are not reporting specific numbers.***”

Over the last twenty years, Carnival Cruise Line and its parent Company, Carnival Corporation, have struggled with basic traits of honesty and transparency. The disclosure of the true number of guests and crew infected with COVID-19 would go a long way to begin in regaining the public’s trust. Of course, Carnival Corporation has been convicted of not only [numerous environmental crimes](#) in continuously polluting the air and water for the past decade but has repeatedly been convicted of lying to the U.S. Coast Guard and U.S. Department of Justice. Unfortunately, this cruise line is a recidivist corporate felon which lies when it would do better to simply tell the truth.

### **Carnival’s Diamond Princess Cruise Ship Delays Return to Sailing to Spring**

Aug 25 (Reuters) – The ‘*Diamond Princess*’ cruise ship, which became the earliest hotbeds for coronavirus infections when the pandemic broke out last year, will delay its return to sailing to spring of 2022, vessel operator Princess Cruises said on Wednesday.

Carnival Corp-owned Princess Cruises said it had canceled the ship's planned fall cruise in South America that was meant to mark its return to service. It also canceled the ship's Antarctica voyage that was set for spring next year.

The ship will now instead return next year for a season of sailings in Japan, the country where it was stranded in last year following hundreds of infections onboard. At the time, the ship had the biggest concentration of cases outside China.

Carnival did not respond to a request for comment on the reason for the delay in the resumption of cruises by '*Diamond Princess*'.

A passenger on one of the company's cruise ships, the Carnival Vista, died earlier this month after testing positive for COVID-19.

Princess Cruises, which restarted sailing last month, also delayed the return of service for its '*Island Princess*' cruise ship.

put up a thousand satellites by this time. That is but a token of what his plans are for his SpaceX satellite network.

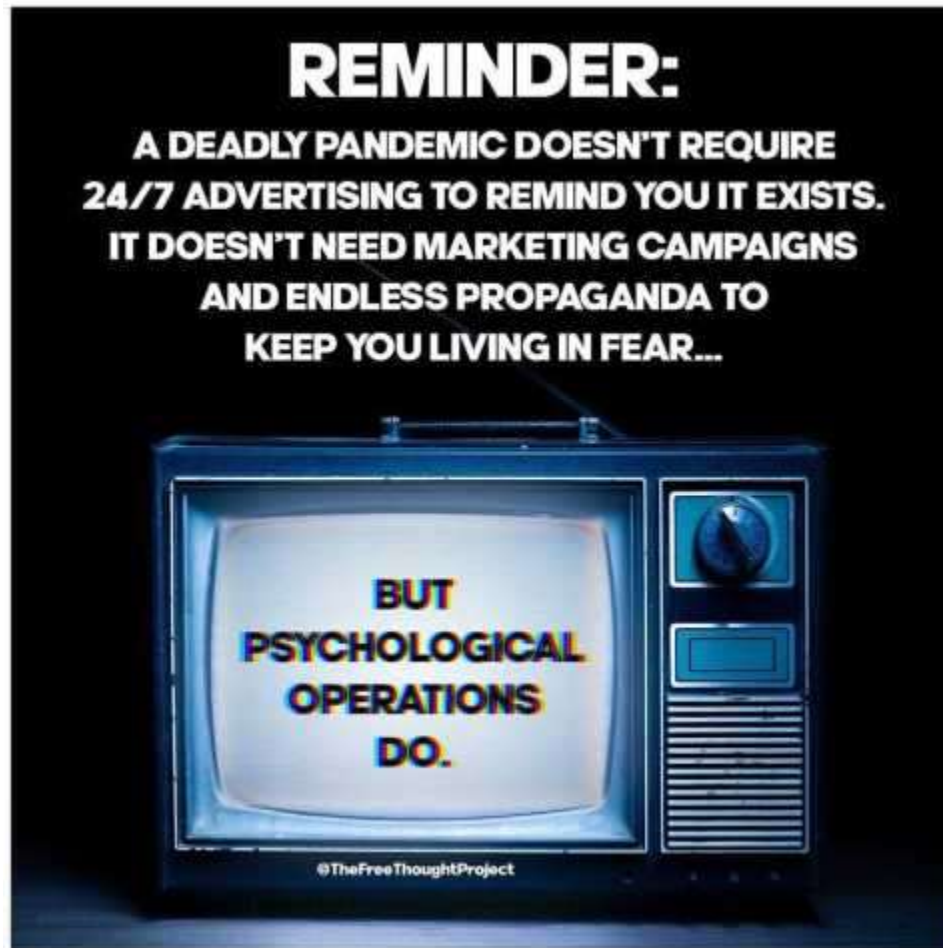

**5G** technology was first installed on cruise ships in the fall of 2019. It became a marketing feature for the cruise lines to sell cruise bookings by offering to provide their passengers wireless communications 24/7 from any location in the world, even in the formerly unavailable regions of the Arctic or Antarctic waters. Competition dictated that all cruise ship operators invest in this technology. Cruisers want to be in instant contact, be it their cell phone, media, or data; this immediate access to the world is a major sales feature.

The problem that has continued to plague the cruise industry is that those white globes atop a cruise ship's top deck are extremely harmful for passengers and cruise employees. It becomes even more of a problem with people with previous existing health conditions. Case in point was the *'Diamond Princess'* that brought this issue to the forefront and global media attention. **The 14 passengers who died on the Diamond Princess in early 2020 were in their 70s and 80s.** Between February 3<sup>rd</sup> and March 5<sup>th</sup> 2020, a total of 696 passengers got sick and were confirmed as diagnosed with Covid-19. During this period the ship was quarantined and passengers were restricted to their cabin staterooms. During the quarantined period, the passengers and crew were "Petrie" dish lab rats. As the days passed, the number of confirmed cases steadily rose from 10 to 705.

The outside world were given the impression by the media that a so-called novel virus had broken out and that people were dying and quarantined on a ship that no port would allow them to dock and disembark. This daily news diet of fear-mongering for a month fed the agenda perfect for an agenda of some evil people. What happened is known as the **Hegelian Dialectic** in real-time. In the *'Diamond Princess'* case, the **“Problem”** was an alleged rogue virus. The *'Diamond Princess'* departed from the Port of Yokohama on 20 January 2020 for a round-trip billed as a tour of Southeast Asia during the Lunar New Year period, with 2,666 passengers and 1,045 crew on board.

An 80-year-old passenger from Hong Kong, China, had embarked in Yokohama on 20 January. He had been in Shenzhen, Guangdong Province, China on 10 January, then returned to Hong Kong and flew to Tokyo on 17 January to board the ship. He

developed a cough on 19 January, but he went on board. He left the cruise when the ship reached Hong Kong on 25 January.

The cruise continued. On 31 January, the ship docked in Taiwan, which according to Vice Premier Chen Chi-mai was "the earliest country to activate epidemic prevention measures against this disease." A paper in the *Journal of Medical Internet Research* authored by Chen, describes how the passengers of the COVID-19 stricken cruise ship were later traced using mobile phone geolocation, and how their 627,386 contacts were alerted through text messaging.

On 1 February, the ship called at Naha Port in Okinawa and was quarantined. On the same day, the 80-year-old man who disembarked in Hong Kong six days earlier tested positive for COVID-19. Having a fever, he went to the hospital and got tested. Hong Kong's Department of Health immediately contacted the agent of the ship's operating company, but the ship did not immediately inform the passengers and they were notified about that on 3 February, two days later. Over the next few days, the cruise ship had shows and dance parties as usual and also continued to open public facilities that attract large crowds, including fitness clubs, theatres, casinos, bars, and buffet-style restaurants.

On the evening of 3 February, the cruise ship returned to Yokohama Port and anchored off the coast of Daikoku Pier without docking. The Japanese government decided to re-quarantine the ship unusually because there may be infected persons. Officials of the Ministry of Health, Labour and Welfare boarded the ship for quarantine.

On 4 February, tests revealed infections of 10 out of 31 people tested. The authorities immediately decided to isolate all passengers on board for 14 days. On 5 February, the authorities announced positive test results for SARS-CoV-2 for 10 people on board, the cancellation of the cruise, and that the ship was entering quarantine for 14 days based on World Health Organization guidelines. A total of 3,700 passengers and crew were quarantined by the Japanese Ministry of Health, Labour and Welfare for what was expected to be a 14-day period, off Yokohama.

On 7 February, the total number of people on board with confirmed SARS-CoV-2 infections grew to 61. Another three cases were detected on 8 February, bringing the total to 64. On 9 February, six cases were detected, while another 65 were detected on 10 February, bringing the total to 135. The numbers overwhelmed local medical facilities, and stricken passengers were divided into three groups according to condition, and evacuated to suitable locations, allowing intensive care to perform as intended. On 11 February, 39 more people tested positive for the virus, including one quarantine officer, bringing the total to 174. Passengers with confirmed cases were reported to be taken ashore for treatment. On 13 February, 44 more people tested positive for the virus, bringing the total to 218. On 15 February 67 more people were reported to be infected, bringing the total to 285. On 16 February 70 more people were reported to be infected, bringing the total to 355. The next day on 17 February, the Ministry of Health, Labour and Welfare confirmed 99 more cases, raising the total to 454, 33 of whom were

crew members. On 18 February, another 88 cases were confirmed, bringing the total to 542.

On the morning of 17 February (Japan time), two U.S. government-chartered planes departed for the United States, carrying hundreds of U.S. citizens who were passengers of the cruise ship. Among about 400 cruise passengers, 328 boarded the planes, excluding those who expressed their intention to stay on the ship and 44 under treatment in Japan. The U.S. government initially asked Japan to keep them on board for 14 days based on the CDC guideline despite the proposal by the Japanese government to bring American passengers back home early. The U.S. government, however, changed its policy to return home on 15 February. The first plane landed at Travis Air Force Base in California at midnight on 16 February (U.S. time), and the other plane landed at Joint Base San Antonio in Texas on the early morning of 17th (U.S. time). Canada, Hong Kong, Australia and Italy also followed the United States within a few days. There were 164 Australian passengers, of which 24 were infected, and all Australian passengers were sent for 14 days quarantine to Darwin.

On 18 February, Michael J. Ryan, Executive Director of the World Health Organization's Health Emergencies Programme, said that Japan's measures to quarantine passengers and staff on board at the Yokohama Port for two weeks were preferable to having them scattered throughout the world. However, he said that he was disappointed at the continued increase in the number of infected people.

On 18 February, Kentaro Iwata, an infectious disease expert at Kobe University, uploaded a video on YouTube in which he raised questions about the measures taken to prevent epidemics on the "*Diamond Princess*" shortly after boarding the ship. He removed it on 20 February.

On 19 February, passengers with negative test results began to disembark. On 20 February, the World Health Organization's Director-General reported the total number of the cases outside of China to be 1,076, and stated that over half of these cases occurred among the passengers on the '*Diamond Princess*'. By late March, it was stated that 712 of 3,711 people on the '*Diamond Princess*', or 19.2%, had been infected by COVID-19.

In early March 2020, Indonesia evacuated 69 Indonesian crew of '*Diamond Princess*', after their COVID-19 test results in Japan were negative. However, an Indonesian naval hospital ship bringing them to Sebaru Island for a mandatory quarantine period had two crew ill. All were tested again; 67 passed the second test, but two did not and were retested with a more accurate, different test, with one negative and one positive result. The 68 people with negative tests disembarked at Sebaru Island for observation and the



one positive case was evacuated by helicopter to Persahabatan Hospital. Eventually, all 69 crew members received negative COVID-19 test results.

On 16 May, 'Diamond Princess' departed from the Port of Yokohama and began sailing to Port Dickson, Malaysia. Notice in the picture below that you can see four large white globes, two near the back side and two forward located near the outside of the ship. These large globes are protective covers intended to keep the **5G** communications transceiver antenna free of obstructions. These obstructions include, fog, rain, mist, dust, snow, ice, and even cloud cover. The **5G signal spectrum is a point-to-point narrow band**. Something as simple as a sheet of copy paper can obstruct and break the wireless signal of **5G EMR**. Conventional cell towers use a signal spectrum that use a wide-band 120-degree broadcast range. 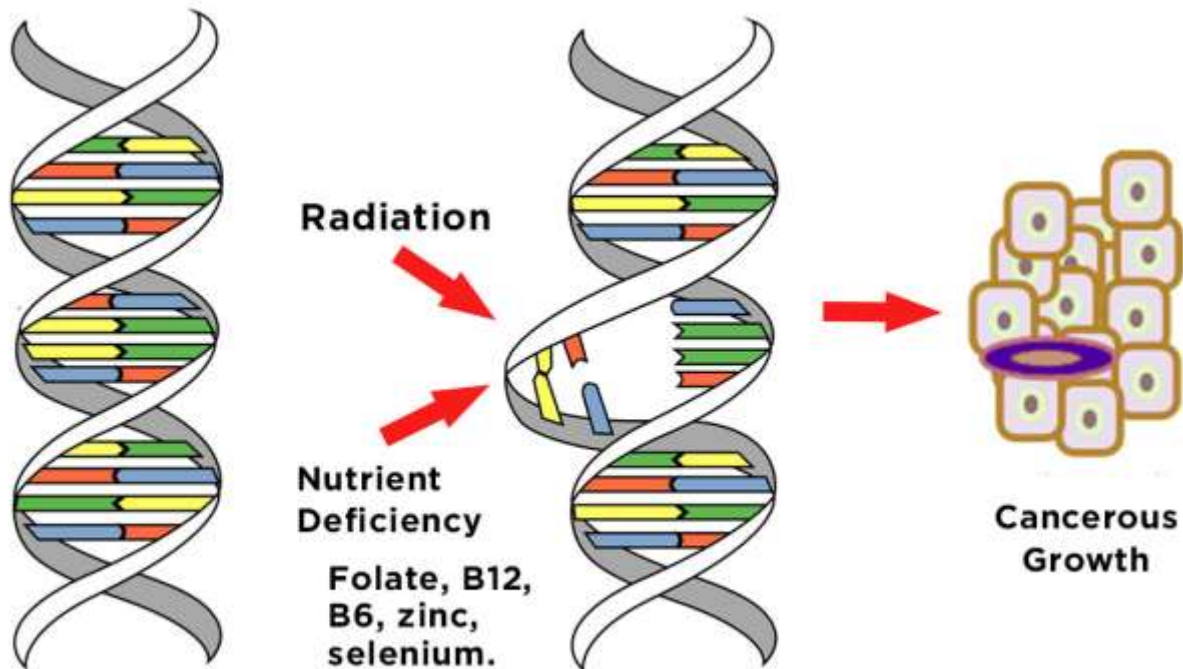

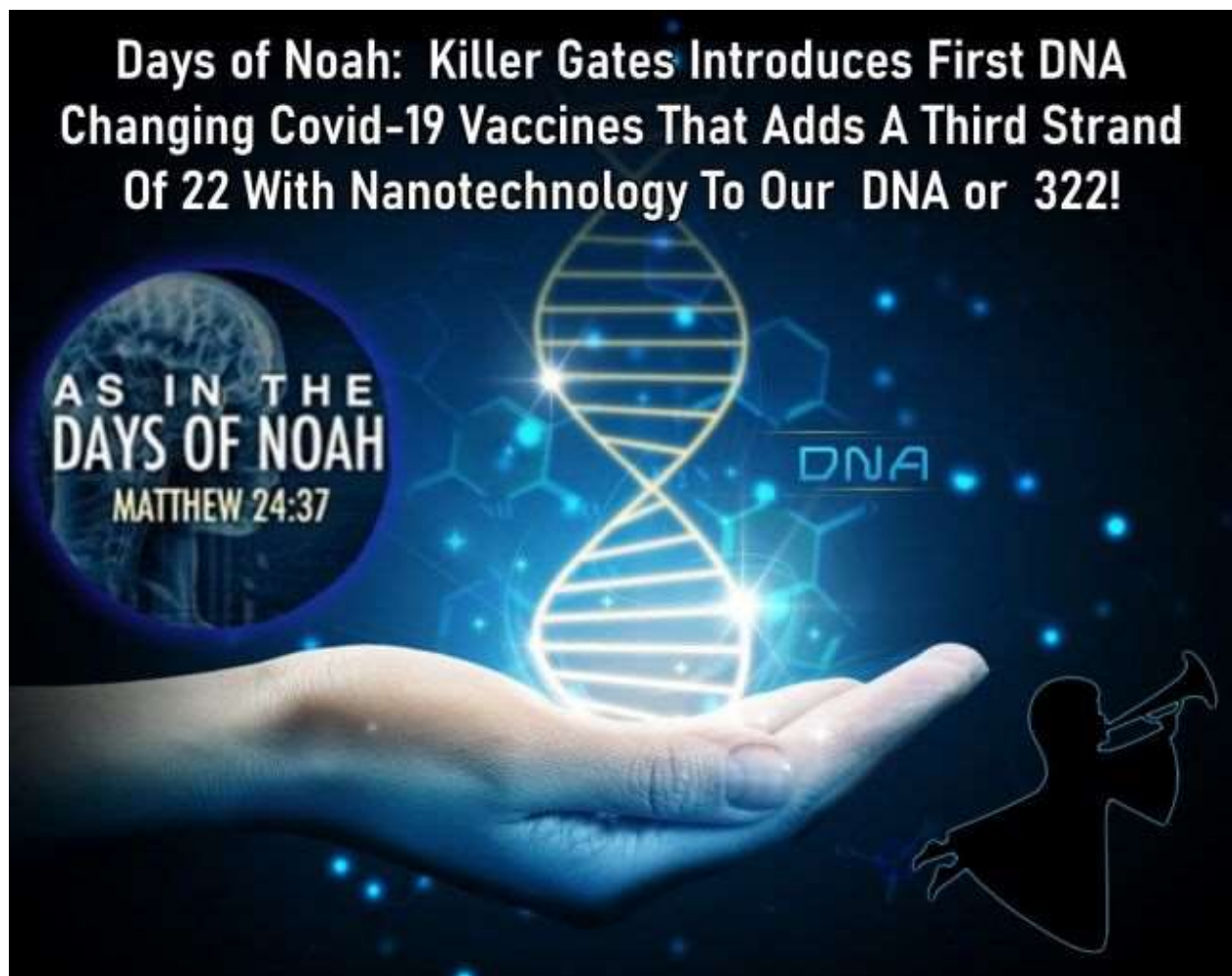

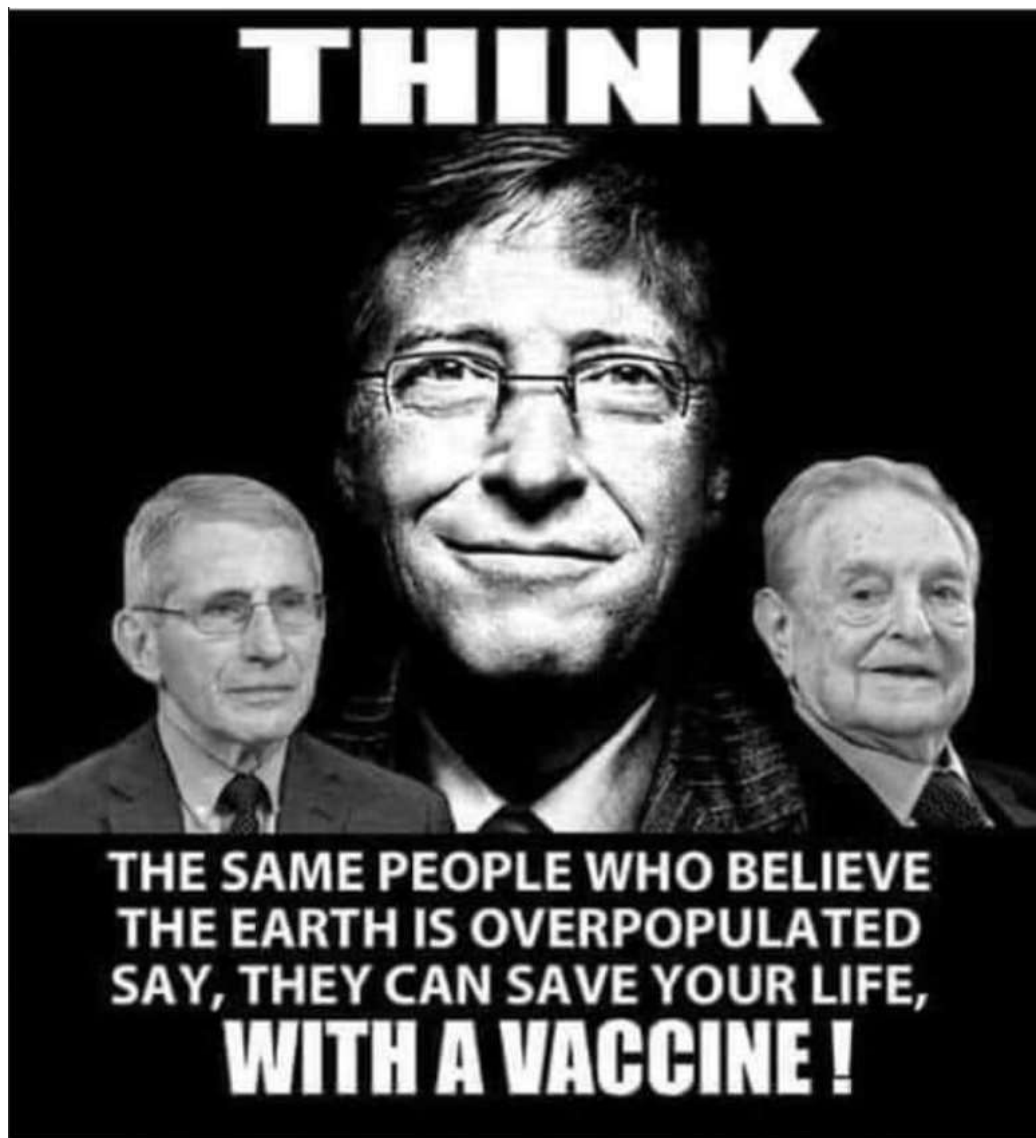

disclosure of all ingredients and in some cases mandated by governments or employers in violation of individual human rights under the Nuremberg Code of 1947.

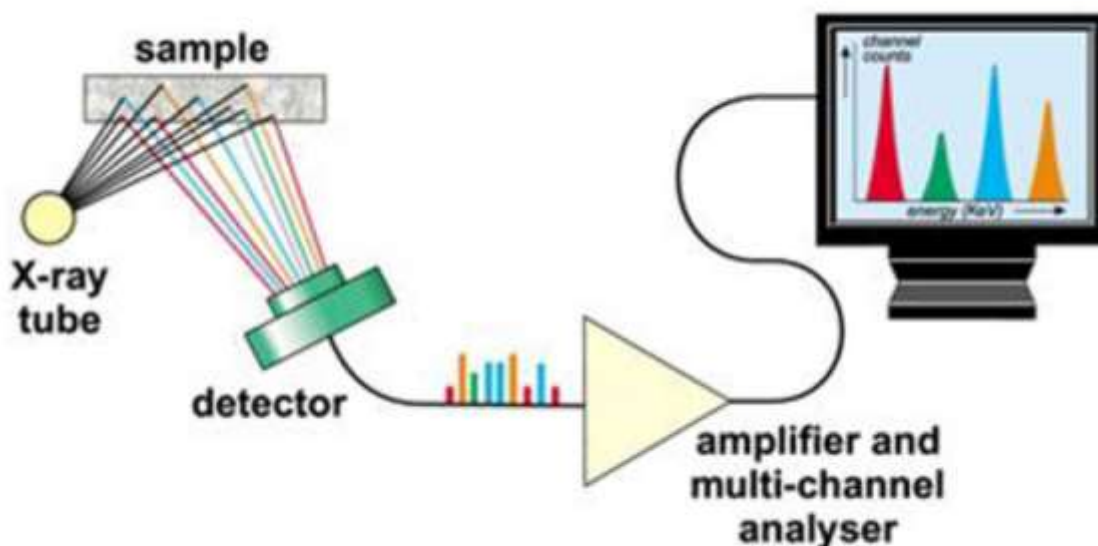

Carnival Cruise Line. James Walker posted that the *'Carnival Panorama'* returned to its home port of Long Beach, California yesterday from a seven-day cruise with multiple cases of COVID-19 according to a guest who sailed on the cruise ship (and wishes to remain anonymous) who sent this message:



***"The 'Carnival Panorama' just returned to Port of Long Beach, there were multiple covid cases onboard, with a lot of passengers being disembarked on some ports of call accompanied by medical personnel."***

Last week, the Carnival cruise ship visited the Mexican ports of Cabo San Lucas, Mazatlan and Puerto Vallarta before returning yesterday (August 28th) from its first cruise since Carnival was forced to suspend cruise operations last year at the beginning

of the COVID-19 crisis. The ‘*Carnival Panorama*’ had its inaugural sailing on December 11, 2019.

The cruise ship returned to the U.S with positive COVID-19 cases notwithstanding the fact that Carnival claimed that at least 95% of its passengers were vaccinated, as it told the Mexican government last week.

Mr. Walker said, *“I have also heard from guests on different Carnival cruise ships who tested positive after returning home from cruises who tried to contact Carnival and had to leave a message with sales representatives that they tested positive for COVID-19. Another couple left a tweet to this effect on Twitter and commented that other guests tested positive as well.”*

According to a local newspaper in Long Beach, the [Long Beach Post News](#), the *Carnival Panorama* experienced what it vaguely called a “technical problem” reducing the speed of the cruise ship. The newspaper referred to a Carnival Facebook private page called the CARNIVAL PANORAMA CRUISE PAGE, which shared a letter from Carnival explaining that the *Panorama* was “*experiencing an issue that is affecting the ship’s maximum cruising speed.*”

The newspaper mentioned Carnival’s recently implemented [HAVE FUN. BE SAFE. COVID-19 GUEST PROTOCOLS](#) including “*requiring proof of vaccination for the vast majority of guests and regular testing for others. Panorama’s entire 1,400-member crew is fully vaccinated, according to the company’s website. All passengers, regardless of vaccination status, must present a negative COVID-19 test result from within three days of embarkation. Unvaccinated guests must take another test prior to embarkation and a third test 24 hours into the voyage if the cruise is longer than four days.*” AXIOS reported last week that Carnival announced new mask guidelines, which say that all guests are required to wear masks indoors.

[Carnival’s COVID protocols](#) state that:

“Vaccinated guests are not required to maintain physical distance on board the ship. It is recommended that unvaccinated guests maintain physical distancing as follows:

- Outdoors – Remain at least 3 feet from others when not wearing a mask and not in your cruise companion group.”

This cruise line’s “HAVE FUN, be safe” protocols in practice have been criticized as too heavy on “HAVE FUN” and too little on “be safe.” A [video posted on Carnival Senior Cruise Director John Heald Facebook page](#) shows the cruise director on the *Carnival*



*Panorama* standing in front of hundreds of guests crowded together on the (exterior) Lido deck, many without masks.

[Comments](#) left on the John Heald's page are split between those who complained that the gathering was unsafe and negligent and those defending the reckless spectacle which essentially said "*if you don't like it, stay home.*" Included in the latter category were attacks on Dr. Fauci and the usual comments typical of COVID skeptics and deniers that masks allegedly don't work:

- . . . if this 5 second moment is a turn off for u, do everyone a favor and stay home.
- . . . you do know they just proved yesterday that these masks do nothing.
- . . . seriously stay home if you are worried. It's your choice just as its theirs, there is absolutely no proof that the masks work . . .
- . . . This is never going away. They will only come up with different names for this. Stop your mask bs already. Stay the heck home if your worried. IT'S NEVER GOING AWAY!
- . . . you know you have the choice to stay home and be all safe in your bubble.
- . . it just shows what a joke the mask mandate is. Nothing more than a misleading visual they have no legitimate function.
- Let them stay home and we will just keep having a great time!!
- Don't like it, stay home.
- If you don't like it... don't sail.
- So glad everyone is having fun, we are back !! This is why we cruise !
- This looks amazing!! Can't wait until September 6 on Sunrise. So glad you all were having a great time! I see with these comments there's a lot of jealous people trying to bring the hate to the party 🙄🙄🙄🙄

These comments expressing concern for the crowded space and absence of social distancing were usually met with vitriolic attacks.

- "This looks scary and irresponsible."
- "They say a picture is worth a thousand words. This one screams unsafe."
- "If cruising is stunted at all. It will be because Carnival already has a death on its hands and there may be more with this kind of thing going on. This is GROSS NEGLIGENCE."

Carnival Cruise Line failed to reveal any information regarding the number of infected guests or crew members on this ship.

When the ‘*Carnival Panorama*’ last sailed from Long Beach in March of 2020, it kept its passengers on board the ship when it returned to Long Beach after a week-long voyage to Puerto Vallarta, Mazatlan and Cabo San Lucas because a single guest was transported off the ship to be tested for coronavirus. The Centers for Disease Control and Prevention (CDC) made the decision to hold passengers on the ship pending the results of a single COVID-19 test. The test turned out to be negative. Passengers were quoted in the [Long Beach Post News](#) as saying that they were “*glad the cruise line was being careful.*”

Seventeen months later today, it is clear that [Carnival is refusing to disclose the total number of crew and guests infected with COVID-19 on any particular cruise and is sloughing off direct responses to such inquiries from the media.](#)

Carnival recently demonstrated a lack of transparency in responding to media inquiries into the extent and number of COVID-19 outbreaks on several Carnival ships. Regarding the COVID-19 outbreak on the ‘*Carnival Vista*’, for example, at least one guest died of COVID-19, one was seriously sickened and went ashore in Belize, an unknown number of others were infected, and at least forty-two crew members tested positive for COVID-19 over a two week period. But Carnival initially falsely characterize that it was managing only a “small number” of positive cases on the ship. Several national newspapers, such as [Axios](#), eventually characterized the true number of COVID-19 cases on the *Carnival Vista* as “*the biggest outbreak of coronavirus cases since cruises resumed in the U.S. and Caribbean last June.*”

After leaving one ‘*Carnival Vista*’ passenger with COVID-19 alone in a sub-standard hospital alone in Belize and sailing on to the next port (Cozumel), Carnival belatedly claimed that “*it was highly unlikely Ms. Tackett contracted the coronavirus aboard the ship . . .*” although her symptoms began 4 days into the cruise which was consistent with the incubation period explained by the CDC which can begin as early as 2 days. Could Ms. Tackett, 77, have died from **5G EMR** wireless radiation poisoning? Do not expect Carnival Cruise to own up to the issue of **5G EMR** that will not go away!

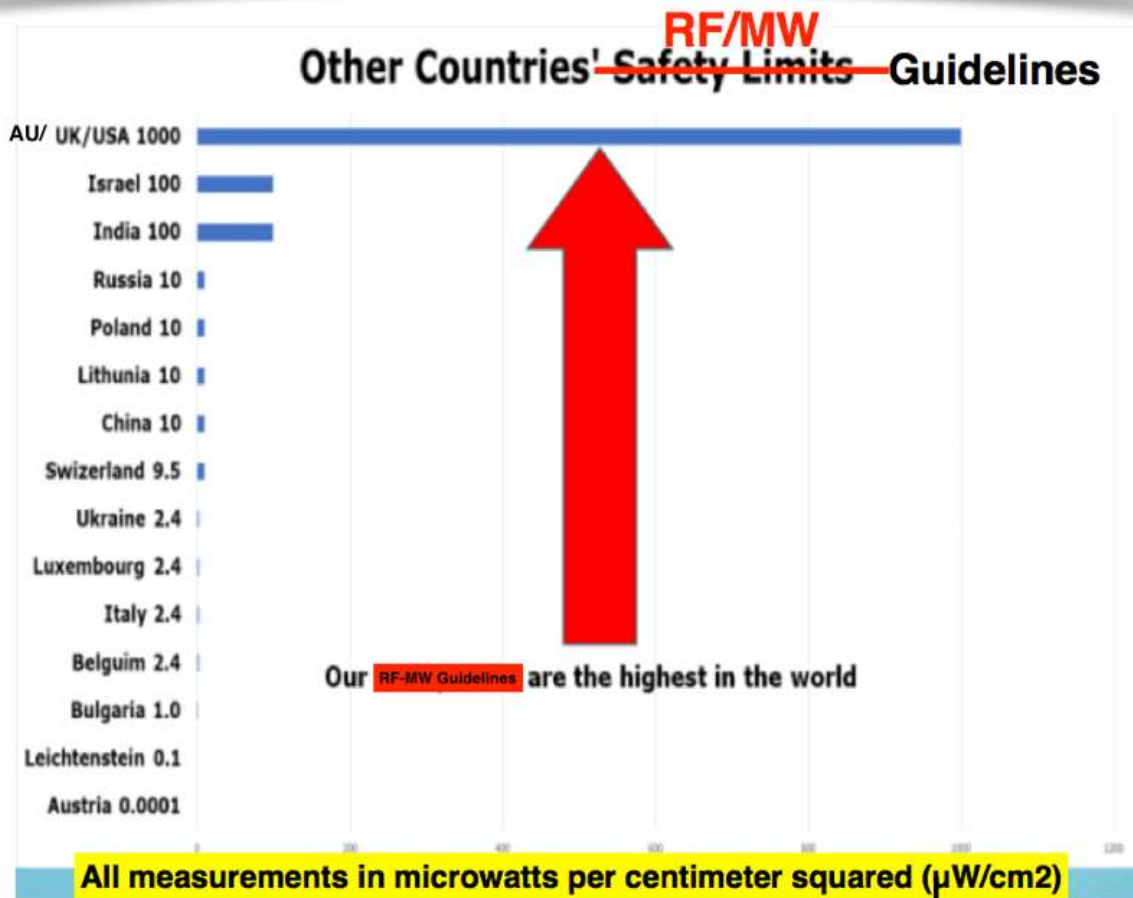

The promise is that speeds will be from 10 to 100 times faster than 4G running primarily on millimeter-wave (MMW) bandwidth. According to EMF author Lloyd Burrell, the signals will likely be weaker since the wavelengths do not penetrate buildings and tend to be incorporated into rain and plants. To adjust, the **5G** network will use:

*“... smaller cell stations (and the technology of beamforming) that’ll scramble/unscramble and redirect packets of data on a no-interference path back to us. This could mean wireless antennas on every lamp post, utility pole, home and business throughout entire neighborhoods, towns and cities.”*

This requires a new infrastructure mounting **5G** cell stations on existing structures, such as utility poles. During U.S. Senate hearings on the topic, when asked about the safety studies on these small cell stations, representatives from the industry stated they were not aware if any such studies existed.

**5G EMR** will not replace 4G; it will accompany 4G for the near future and possibly over the long term. If there are synergistic effects from simultaneous exposures to multiple types of RFR, our overall risk of harm from RFR may increase substantially. Cancer is not the only risk as there is considerable evidence that RFR causes neurological disorders and reproductive harm, likely due to oxidative stress.
