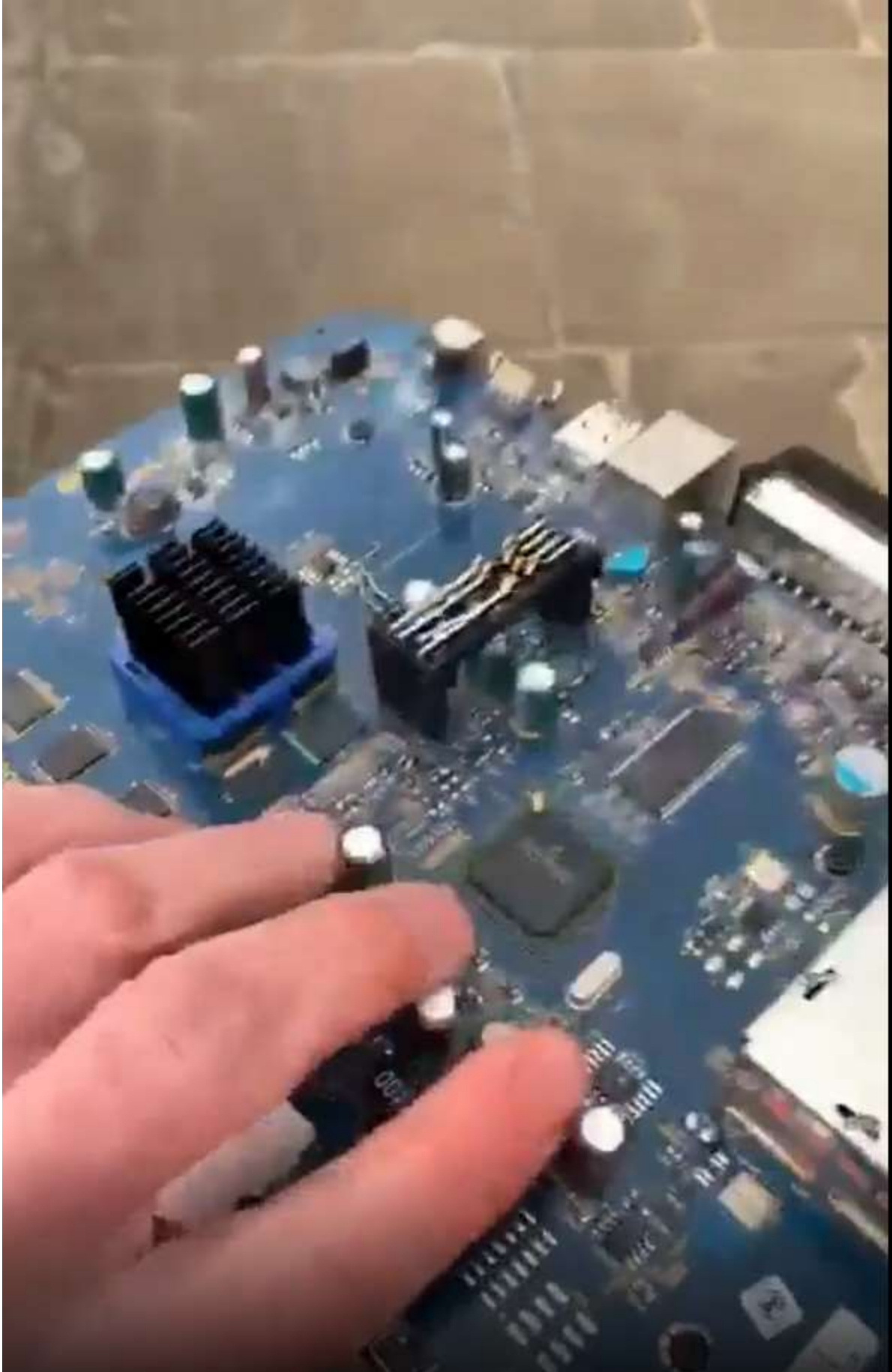
As They Say, You Can't Make This Stuff Up!

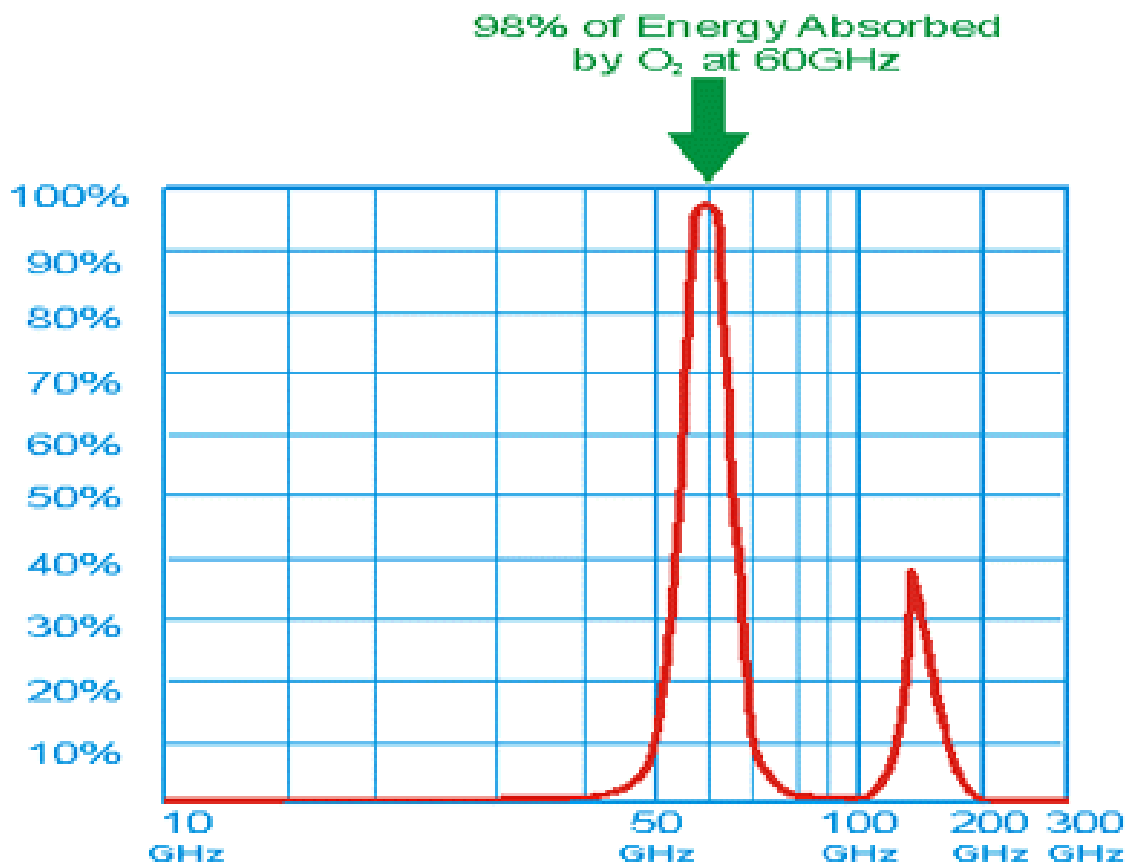

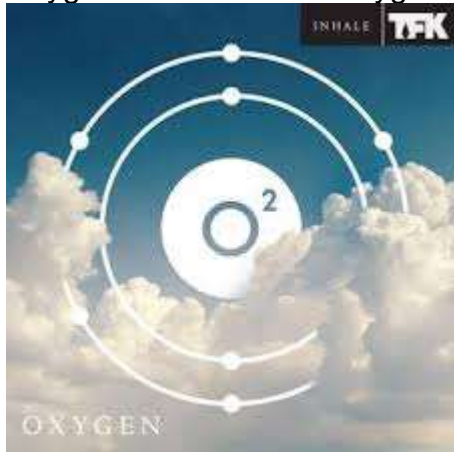

From the book '**Magnetobiology**', Underlying Physical Problems. Effects of electromagnetic fields on living organisms.

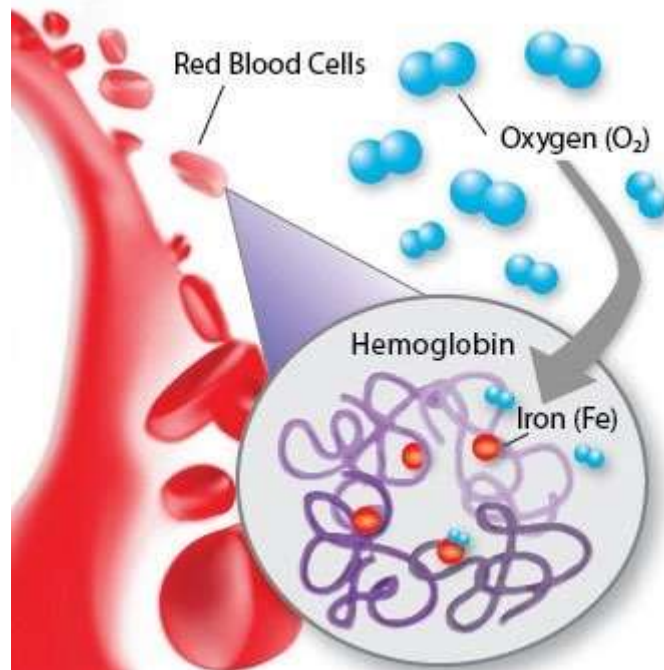
Oxygen the atom is O. Oxygen the molecule is O². Two atoms together.

Wireless at 60 GHz Has Unique Oxygen Absorption Properties

The demand for bandwidth is growing at a rapid pace. International Data Corporation projects that Internet commerce in the United States will grow from \$74 billion in 1999 to \$708 billion in 2003, with the number of computer users more than doubling from 81 million to 177 million in the U.S. alone. Due to the tremendous expected growth, reliable fiber optic networks must be installed quickly.

Short haul, high-density deployments of wireless communications devices are required in metropolitan areas and business parks throughout the United States. Most often, office buildings though not physically linked to the fiber backbone are within one half mile of a local fiber trunk. Wireless communication devices operating at higher frequencies, such as 60GHz, allow businesses to link to the fiber easily, without the cost and time delays associated with physical fiber installation.

Due to the increased bandwidth demands and the scarcity of microwave frequency allocations, the wireless communications industry is beginning to focus on higher, previously unallocated portions of the spectrum in the millimeter wave frequencies from 40GHz to 300GHz. Due to the high levels of atmospheric RF energy absorption, the millimeter wave region of the RF spectrum is not usable in long haul, wireless communications segments. However, for short haul, "last mile" segments, the expanded RF data bandwidth available in the millimeter wave region makes it possible for high speed connectivity.

Figure 1 illustrates the atmospheric absorption for millimeter wave frequencies. At the millimeter wave frequency of 60GHz, the absorption is very high, with 98 percent of the transmitted energy absorbed by atmospheric oxygen. While oxygen absorption at 60GHz severely limits range, it also eliminates interference between same frequency terminals.

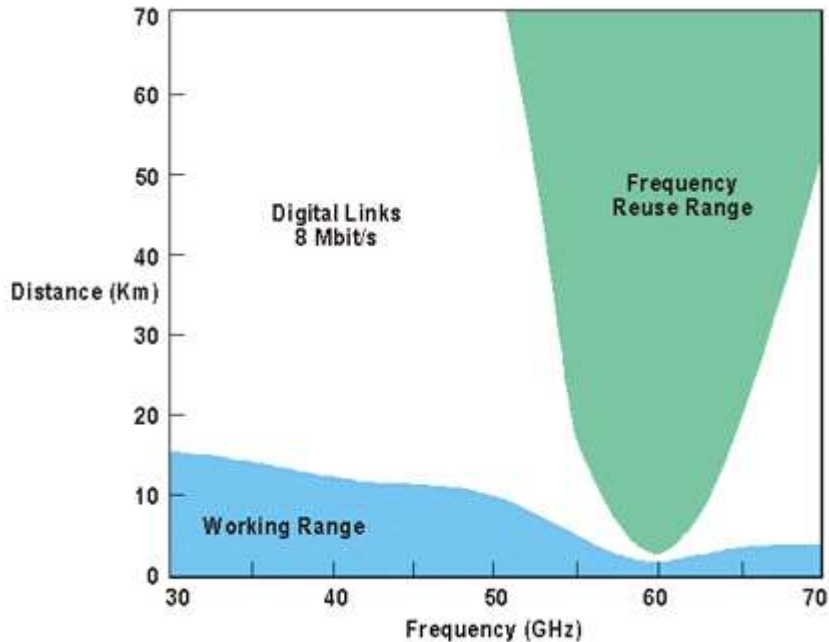


Figure 2: Frequency Reuse Source FCC Bulletin 70A

The benefit of Oxygen absorption relative to frequency re-uses is detailed in Figure 2. Figure 2 illustrates the distance relationship between the 60GHz frequency reuse range, the green region, and the traditional range, the blue region. Oxygen absorption makes possible the same-frequency reuse within a much localized region of air space. **Operation within the 60GHz millimeter wave spectrum enables very dense interference free deployment of same frequency radio terminals.**

A 60GHz communications system must overcome the effects of oxygen absorption, 16dB/KM. In order to operate reliably at even short ranges, a much focused, narrow-beam antenna must also be employed to increase the level of signal available to the target receiver.

Traditional wireless communications systems operating in the lower frequency ranges of 600 MHz to 40 GHz often interfere with each other when placed too closely together. This interference, due to the dispersion and uncontrolled propagation of RF energy through the atmosphere is minimized by FCC frequency coordination, licensing and through the implementation of interference avoidance techniques such as spread-spectrum modulation.

FCC Licensing precludes dense deployment through the limited number of regional licenses granted and spread-spectrum techniques have proven only marginally effective, as the **overall noise floor has risen**. In the 60GHz region, the effects of oxygen absorption and the use of narrow beam antennas minimize the probability of interference between the radios.

Weather conditions have an adverse effect on all RF transmissions, especially in the millimeter wave region where severe **rainstorms can cause as much as a 20dB loss in signal strength for every kilometer of transmission**. As the distance the radio transmission increases, the fade margin needed to compensate for weather effects increases proportionately. Since radios operating at 60 GHz transmit only over short distances, the compensation for weather effects is not as great as for systems transmitting one kilometer and beyond.

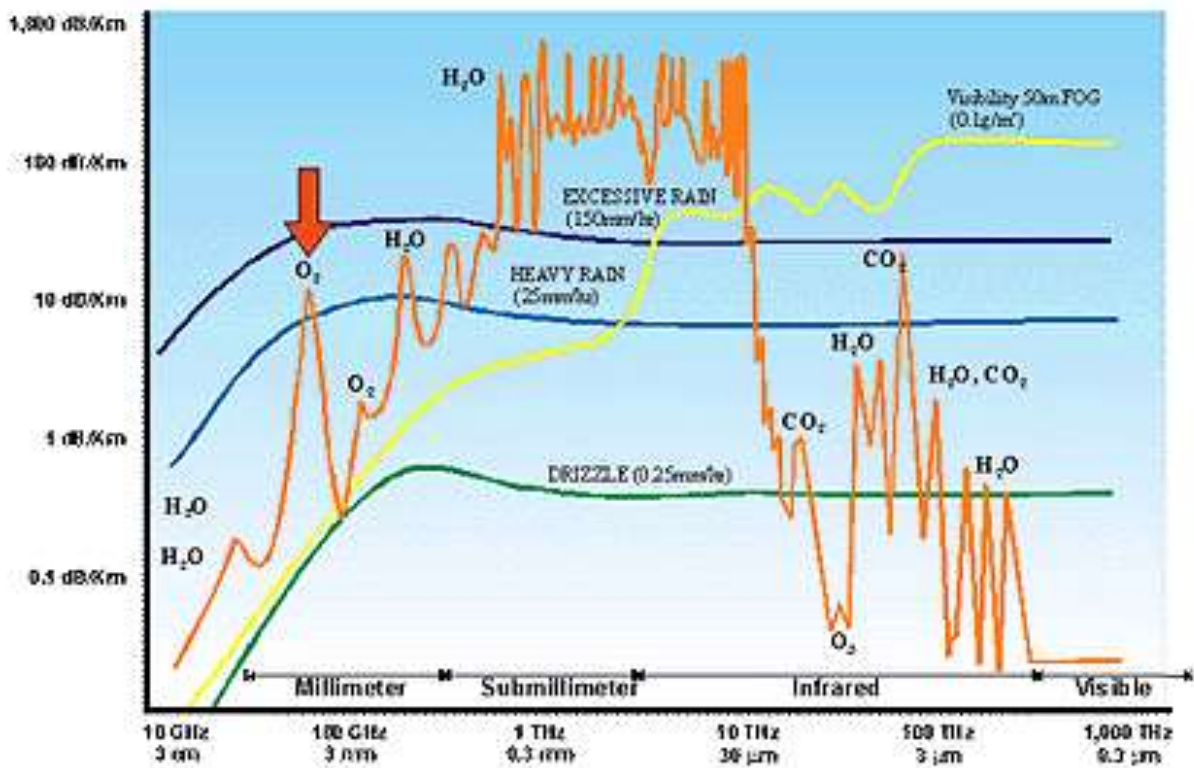


Figure 3: Atmospheric Attenuation Characteristics for Wavelengths 3 cm. to 0.3 mm. Currently, the Federal Communications Commission (FCC) has allocated the millimeter wave RF spectrum from 57.05 to 64GHz for unlicensed use under Part 15. All wireless equipment operating at 60GHz must obtain FCC Part 15 type certification. Once certified, the product can be deployed license-free throughout the United States. This unlicensed frequency spectrum allows the end-user to avoid the added cost of regional spectrum auctions held by the FCC or competition for the limited number of licensed bands.

At 60 GHz, the extremely high atmospheric absorption level is due primarily to the molecular composition of the atmosphere. Figure 3 illustrates the atmospheric attenuation characteristics for wavelengths from 3 cm to 0.3 mm.

For millimeter waves, the primary absorption molecules are H₂O, O₂, CO₂ and O₃. Since the presence of O₂ is fairly consistent at ground level, its effect on 60GHz radio propagation is easily modeled for margin budgeting purposes. In addition, the high level of attenuation from oxygen absorption makes even the worst weather-related attenuation insignificant, especially on the short paths where 60GHz systems operate. Even extremely heavy rainfall, 25mm/hr. (5dB/KM), will make only a very small percentage contribution to aggregate attenuation in the 60GHz oxygen absorption region.

60 GHz communications systems can be used for a variety of applications, including metropolitan area networks, campus networks, network backbones, network branch links, temporary emergency restoration and local access

Royal Caribbean Pledges 28 Ships as Collateral in \$3.3 Billion Bond Offer

May 13 (Reuters) – Royal Caribbean Cruises on Wednesday launched a \$3.3 billion bond offering, pledging 28 of its ships as collateral and forecast

heavy losses for the first quarter as the COVID-19 pandemic brings the sector to a virtual standstill.

Royal Caribbean, which was forced to suspend its cruises globally and cut about 26% of its U.S. workforce, said the health crisis has dented its first-quarter net income by about \$453 million.

The cruise operator's shares, which have sunk over 72% this year, fell 4% in early trading. The company expects to report a preliminary first-quarter net loss of \$1.44 billion compared to a profit of \$249.7 million a year earlier, as it prepares to write down the value of its Silversea Cruises unit and several ships by \$1 billion to \$1.3 billion.

Preliminary total revenue for the three months ended March 31 fell 16.7% to \$2 billion. The company will use the new private note offering to repay a \$2.35 billion 364-day term loan agreement with Morgan Stanley.

Earlier in May, rival Norwegian Cruise Line Holdings Ltd had raised over \$2.2 billion through debt and equity offerings, giving it the much needed funds to survive for at least the next 18 months. The company used two of its ships and two private islands as collateral for the debt offering.

Royal Caribbean declined to specify which ships it had pledged for its debt offering. It had vessels with a net book value of about \$22.7 billion as of Dec. 31, including the world's largest cruise ship – "Symphony of the Seas."

Royal Caribbean estimates its cash burn to be about \$250 million to \$275 million per month during a prolonged suspension of operations.

Satellite images reveal fleets of empty cruise ships huddled in the Caribbean and Philippines because they're unable to dock due to the coronavirus pandemic

Satellite images have revealed fleets of empty cruise liners clustering together at sea because they are unable to drop anchor at ports.

Since the coronavirus pandemic began, few industries have been hit harder than the cruise industry. The issue of radiation sickness from 5G EMF Wi-F threatens to sink the cruise industry, no pun intended.

The ships are viewed as floating petri dishes and, while passengers are no longer on them, several crew members still are.

Now, with no incoming bookings and unable to dock, many have taken to huddling together in the Atlantic, the Caribbean and the South China Sea to get out of the way of major shipping lanes.

Three groups of cruise ships, with 15 in total, are clustered together off Coco Cay and Great Stirrup Cay in the Bahamas.

Because there are not enough traditional berths to accommodate cruise ships, many have been forced out to sea.

Two ports, Coco Cay and Great Stirrup Cay, in the Bahamas where Royal Caribbean ship and Norwegian cruise liners, are storing vessels.

According to [The Drive](#), the ships are in three groups - 15 in total - that are about 30 miles apart from each other.

They have names such as Harmony of the Seas, Celebrity Edge and Azamara Pursuit.

There are also at least 12 cruise ships, such as the MV Ruby Princess, that are sitting just off the coast of the Philippines.

The Philippines Coast Guard says the cruise liners have to wait for clearance from the Bureau of Quarantine before they dock in Manila.

There are currently no passengers aboard the cruise liners, but many crew members are still onboard.

As of May 5, CNN says there are more than 57,000 crew members aboard 74 cruise ships in and around US ports, the Bahamas and the Caribbean.



Hundreds are more are stuck around the world and, because the ships can't dock, they are unable to get home. Alex Adkins, a senior stage technician on Freedom of the Seas, a Royal Caribbean ship, says he has been at sea since mid-March when last guests disembarked.

"Since then, we've had no guests and we've just been floating off the coast of Barbados," Adkins, an American, told CNN. Employees said they don't understand why they aren't free to leave ships if they've cleared 14-day quarantines.

"I'm hoping we don't get forgotten about, to be honest," MaShawn Morton, an employee for Princess Cruises, told CNN. *"It seems like nobody cares what's happening to us out here."*

Carnival Cruise Line says it plans to resume some operations in August, but Norwegian Cruise Line says there is 'substantial doubt' about its future.

“We believe the ongoing effects of COVID-19 on our operations and global bookings have had, and will continue to have, a significant impact on our financial results and liquidity, and such negative impact may continue well beyond the containment of such an outbreak,” the company's filing on Tuesday.

This is not the first time cruise ships have been pictured cloistered together.

Last week, cruise liners and cargo ships were forced to drop anchor off the Isle of Wight, in England, to avoid busy shipping lanes.

A spokesman for the UK's Department for Transport confirmed that certain ships have been given higher priority due to the crisis and cruise liners are currently low priority as they are not carrying any passengers.

The cruise industry operates at latest count 314 cruise liners, and many have postponed cruises until as early as September; however, the problem of 5G radiation sickness is not going to go away any time soon. May 16, 2020 (LifeSiteNews) – A team of Australian scientists has produced new evidence that the novel coronavirus that causes COVID-19 is optimized for penetration into human cells rather than animal cells, undermining the theory that the virus randomly evolved in an animal subject before passing into human beings, and suggesting instead that it was developed in a laboratory.

The study, which has not yet been peer reviewed, provides new but not yet conclusive evidence favoring the theory that the novel coronavirus originated not in a food market as has been claimed, but rather in a laboratory, presumably one operated by the Wuhan Institute of Virology in Wuhan, China, the city in which the first outbreak of COVID-19 occurred in December of 2019.

The lead researcher on the team says that the results represent either “a remarkable coincidence or a sign of human intervention” in the creation of the virus.

The authors of the study, led by vaccine researcher Nikolai Petrovsky of Flinders University in Australia, used a version of the novel coronavirus collected in the earliest days of the outbreak and applied computer models to test its capacity to bind to certain cell receptor enzymes, called “ACE2,” that allow the virus to infect human and animal cells to varying degrees of efficacy.

They tested the propensity of the COVID-19 virus’s spike protein, which it uses to enter cells, to bind to the human type of ACE2 as well as to many different animal versions of ACE2, and found that the novel coronavirus most powerfully binds with human ACE2, and with variously lesser degrees of effectiveness with animal versions of the receptor.

According to the study’s authors, this implies that the virus that causes COVID-19 did not come from an animal intermediary, but became specialized for human cell penetration by living previously in human cells, quite possibly in a laboratory.

The authors write that “this finding is particularly surprising as, typically, a virus would be expected to have highest affinity for the receptor in its original host species, e.g. bat, with a lower initial binding affinity for the receptor of any new host, e.g. humans. However, in this case, the affinity of SARS-CoV-2 is higher for humans than for the putative original host species, bats, or for any potential intermediary host species.”

As a consequence, they add, a “possibility which still cannot be excluded is that SARSCoV-2 was created by a recombination event that occurred inadvertently or consciously in a laboratory handling coronaviruses, with the new virus then accidentally released into the local human population.”

In a separate public statement about the research made by Prof. Petrovsky on April 17, the researcher notes that the results of his study are either “a remarkable coincidence or a sign of human intervention,” and adds that it is “entirely plausible that the virus was created in the biosecurity facility in Wuhan by selection on cells expressing human ACE2, a laboratory that was known to be cultivating exotic bat coronaviruses at the time.”

“If so the cultured virus could have escaped the facility either through accidental infection of a staff member who then visited the fish market several blocks away and there infected others, or by inappropriate disposal of waste from the facility that either infected humans outside the facility directly or via a susceptible vector such as a stray cat that then frequented the market and resulted in transmission there to humans,” he added.

The researchers recognize that other possibilities exist, but regard them as improbable. They found that the novel coronavirus has a strong, but lesser binding effect on the ACE2 receptor of Pangolins, which are mammals eaten in China as a delicacy which has often been proposed as the intermediary of the novel coronavirus between bats and humans. However, they note that the Pangolin doesn't offer a reasonable candidate for an intermediate species for human transmission, because "given the higher affinity of [the novel coronavirus] SARS-CoV-2 for human ACE2 than for bat ACE2, SARS-CoV-2 would have to have circulated in pangolins for a long period of time for this evolution and selection to occur and to date there is no evidence of a SARS-CoV-2 like virus circulating in pangolins."

A preliminary form of the study, which is currently entitled, "In silico comparison of spike protein-ACE2 binding affinities across species; significance for the possible origin of the SARS-CoV-2 virus," has been published on a repository site maintained by Cornell University, which warns that studies published prior to peer review should not be considered "established information" unless multiple experts in a given field are first consulted.

According to his university webpage, in addition to his work as a university professor, Professor Petrovsky is currently Director of Endocrinology at Flinders Medical Centre of Flinders University, and Vice President and Secretary-General of the International Immunomics Society. He is also the founder of Vaxine Pty Ltd., which is funded by the U.S. National Institutes of Health and is currently working on a COVID-19 vaccine.

In addition to Professor Petrovsky, the research team that produced the study includes Prof. Sakshi Piplani, also of Flinders University, Puneet Kumar Singh, who works with Petrovsky and Piplani at Vaxine Pty Ltd., and Prof. David A. Winkler, who teaches at the University of Nottingham in the U.K and Monash University in Australia.

Study contradicts scientists who claim "zero evidence" for lab origin of virus

The results of the study tend to contradict virologists who have claimed that the novel coronavirus shows no signs of having been produced in a laboratory, some of whom have gone so far as to dismiss such theories as "conspiracy theories." The "conspiracy theory" claim has been uncritically echoed in much, but not all, of the international media. The staff of the Wuhan Institute of Virology have repeatedly denied the virus came from their lab.

Their position has been supported by a widely-referenced letter from several scientists published in Nature Medicine on March 17, which argues against the likelihood of a laboratory generating the virus in a human cell lab culture.

The argument made by the researchers in the letter is mostly based on the claim that no genetically-close progenitor to the novel coronavirus that could be a candidate for such a process has been described in any scientific study. They also assert that "repeated

passage” of coronaviruses in cell cultures have not been mentioned in scientific literature.

However, the letter’s authors do not address the possibility that the Wuhan Institute of Virology researchers simply did not report all of their research to the public, a possibility that seems to have been reinforced in recent months by secrecy and cover-ups regarding COVID-19 research in China, and the repeated refusal of the Chinese government to participate in an international probe of the origins of the novel coronavirus.

Unless an animal version of virus is found, evidence points to “human intervention” No government entity, has formally stated that the COVID-19 is a bio-weapon, simply to acknowledge this is state it is an act of war. The public has been mis-led, obfuscated, and deceived that the virus was a natural pathogen! A total lie even at this late date in the event.

Professor Petrovsky told LifeSite in an email interview that his study indicates that *“there are some highly unusual features, including optimal human adaptation, that in the absence of identification of a close to identical virus in an animal population from which COVID19 could have arisen, would point in the direction of human intervention at some point in the evolution of COVID19.”*

He noted that, so far, researchers in China and elsewhere have not produced evidence of the presence in animals of a virus closely similar to the one that causes COVID-19 in humans, which would give credence to their theory of natural development in an intermediary between bats, which presumably originated the virus, and humans.

“If an animal vector and virus could be found then of course this would resolve the matter completely,” Petrovsky told LifeSite. *“One would have thought that the Chinese would be intensively sampling all conceivable animals trying to find such a virus to exonerate their labs. If no such intense search is going on (which I don’t know one way or the other) then the inference could be that they are not looking because they already know what they might find.”*

Richard Ebright, a molecular biologist at Rutgers University who has been critical of laboratory studies that might produce new pathogens dangerous to humans, told LifeSite that Petrovsky’s results “are plausible,” but cautioned that the results of the pre-print of the study “are from computational modelling, not from experiments, and therefore must be considered as provisional at best.”

Ebright noted that an earlier study on ACE2 receptor binding found that a bat coronavirus similar to the COVID-19 virus had strong binding power with the ACE2 of tree shrews and ferrets, making them possible animal intermediary candidates. However, the study did not compare the binding power of the virus’ animal species’ ACE2 receptors with the binding power with humans, as does Petrovsky’s study. Moreover, it did not use a gene sequence from an early version of the novel coronavirus

itself, as does Petrovsky's study, but rather used the gene sequence of a similar bat coronavirus reported by the Wuhan Institute of Virology, called RaTG13.

Ebright told LifeSite that he believes that multiple physical experiments that will ultimately determine if the novel coronavirus is optimized for binding with human cells are *"probably underway in multiple locations,"* although he did not cite any specific studies.

What is needed, according to Prof. Petrovsky, is a thorough international investigation into the true cause of the COVID-19 outbreak, something the Chinese government has repeatedly refused.

"Whilst the facts cannot be known at this time, the nature of this event and its proximity to a high-risk biosecurity facility at the epicentre of the outbreak demands a full and independent international enquiry to ascertain whether a virus of this kind of COVID-19 was being cultured in the facility and might have been accidentally released," wrote Petrovsky on April 17.

One of the greatest disparities of the entire COVID-19 scam-demic is that of the numbers of cases and the number of deaths in New York City.

As of May 15, there were nearly 350,000 COVID-19 cases in New York and more than 27,500 deaths, nearly a third of the nation's total. The corresponding numbers in California: just under 75,000 cases and slightly more than 3,000 deaths. In New York City, the country's most populous and densest, there had been just under 20,000 deaths; in San Francisco, the country's second densest and 13th most populous, there had been 35. Only New York was one of the four world cities debuted as a 5G city.

New York City remains the epicenter of the United States' coronavirus outbreak with just under 20,000 deaths as of May 15. The differing outcomes will be studied for years, as more is learned about the virus, its unique qualities, its varying strains, its specific impact on certain populations, and the role of factors like poverty, pre-existing health problems and public transportation in its spread and lethality.

California, if twice as populous as New York, does not have nearly as many people living on top of one another; despite San Francisco's density, it does not have millions of people packed into subways and buses the way New York City does. New York City is home to far more African Americans, a population hit hard by the virus.

But the timing of New York's shutdown undeniably played a role in the dire human toll the virus has exacted. In April, two prominent experts said in a New York Times opinion article that their research showed that had New York imposed its extreme social distancing measures a week or two earlier, the death toll might have been cut by half or more. The rhetoric still does not cover for the 5G issue and although being discounted for the benefit of the telecom industry, New York and at some future date, the data will have to be explained away.

Asked if Cuomo questioned the accuracy or integrity of the findings on how many deaths might have been prevented with an earlier imposition of the statewide shut down, a spokesman wrote:

“Our job is to make policy decisions based on the facts and data we have at the time and that’s exactly what we did. We needed the public’s buy-in, which is what happened, and how we ultimately flattened the curve.”

In recent days, Cuomo has said he wished he had been quicker to see the threat, “blow the bugle” and take action, only to all but instantly shift tone and cast blame everywhere: at international and U.S. health agencies; at the federal government; at news organizations. *“Governors don’t do global pandemics,”* Cuomo said.

In an interview, a senior Cuomo administration official, authorized to speak but not be named, defended the timeliness of New York’s response to the virus. He said the administration had closely followed a variety of models showing the evolving scope and impact of the spread and had calibrated its actions accordingly. The governor, he said, had conducted an orderly unwinding of a giant economy and a state of 20 million people. Each measured step — closing schools, gradually reducing the state’s daily workforce — had been undertaken to limit panic and gain the public’s compliance with developments that could upend lives and diminish and damage a great city.

The official asserted that, from the discovery of the first positive COVID-19 case in the state on March 1 to the shutdown on March 22, New York had acted faster than any other state.

“Three weeks, 20 million people,” the official said. “Insane.”

The official noted that California’s first case surfaced on Jan. 26, its first death occurred March 4 and its statewide shutdown went into effect March 19, a span of almost two months.

Marc Lipsitch, a Harvard professor of epidemiology and the director of the Center for Communicable Disease Dynamics, created one of the first modeling tools used in the U.S. for the COVID-19 pandemic. The model was available to both city and state officials in New York in February, a full week before the first confirmed New York case. The state said the Lipsitch model was not one they looked at for guidance. The city did make use of it, and concluded that just a couple of dozen sick people in New York could ultimately produce more than 100,000 cases by the middle of April, which is quite close to what happened.

For New York and California, the clock for quick and prudent action in the fight against COVID-19 began ticking no later than Jan. 17, when the federal government announced it would begin screening passengers arriving in both states from China. The virus had been found outside China and would soon be discovered in dozens of countries. New

York and California were known destinations for a steady stream of weekly travelers from China. The Jan. 26 announcement of California's first case surprised no one.

If California's lower infection and death totals could owe to a wide variety of still undetermined factors, the state's efforts, especially its partnership with San Francisco, were marked by both cooperation and a degree of daring. The elected officials turned to their health experts for advice, and they trusted and followed it.

By late February, Cuomo seemed to have begun apprehending the growing threat. He had company. Frieden, who had served as the New York City health commissioner for a decade and had helped oversee the response to the H1N1 flu pandemic in 2009, wrote publicly that COVID-19 was already approaching the category of "severe" pandemic. Frieden argued that more aggressive, even radical, interventions to limit people's interaction had to be on the table.

The Cuomo administration official said that by then Cuomo's designated inner circle — his health commissioner, his budget director, his closest aide and an old hand who would return to Cuomo's side from his position in academia — were conferring every day, dozens of times.

Cuomo on Feb. 26 announced that the state's highly regarded laboratory had developed a test for the virus, and he was seeking federal approval to begin using those tests. He said the state Health Department had \$40 million to hire additional staff as well as procure equipment "and any other resources necessary to respond to the potential novel coronavirus pandemic."

And so when the March 2 news of community spread surfaced in New Rochelle, Cuomo urged calm. The state, he proudly noted, had successfully confronted a wide variety of health scares over the years.

"We are fully coordinated, and we are fully mobilized, and we are fully prepared to deal with the situation as it develops," Cuomo said, *"This isn't our first rodeo."*

New York had a detailed plan on preparing for and responding to a pandemic, first produced by the state Health Department in 2006. After 9/11, the federal government had funded state and local efforts meant to better protect the country from a wide variety of threats, from terrorism to hurricanes to bio-warfare to infectious disease outbreaks. New York used the money and the moment to address a possible pandemic.

New York's plan anticipated that a flu-like disease would likely sicken large numbers of people and overwhelm the health care system; and since outbreaks could occur simultaneously throughout the country, localities would need to rely on their own resources to respond. It noted that health care workers and first responders would be at high risk of illness, further straining the health system.

But while the report's subsequent pages of charts and subsections tackle a raft of issues — legal authorization to impose limits on public events; the creation of an “incident command system” that would coordinate efforts from a range of state agencies — there are few specifics on what officials should do to prevent or mitigate the potential calamities the report presciently predicted.

The document simply says it's up to hospitals and local authorities to develop plans that turn the document's vision for adding hospital beds and protecting health care workers and first responders into reality.

Dowling, the Northwell CEO and a trusted adviser to Cuomo who said he didn't even know the document existed, said, “*A plan on a piece of paper that doesn't have an operational part means nothing,*” Dowling said.

Asked about Dowling's remarks, and whether hospital officials statewide were aware of the plan, Bruno, the Health Department spokesman, said “representatives from all responding services to the multi-service plan meet several times throughout the year to review and update the plan.”

Stanley Brezenoff, a legendary New York public servant who was head of New York City's Health and Hospitals Corporation under Mayor Ed Koch, and who has been called on in times of crisis by mayors and governors, said the state's response plan seemed noble enough on its face.

“It's one thing to have a kind of check-the-boxes planning,” Brezenoff said. “But it needs to go to the next level and become concrete. If we need 200 more hospital beds, what does that entail? Plans, tabletop exercises. These can easily fall into empty exercises. Turning them into being useful is the challenge.”

State Health Department officials have said that the plan had been useful in 2009 during the H1N1 pandemic, a threat that turned out to be less damaging than first feared, and that it had been regularly updated since. Bruno said the department had participated in a variety of drills with federal and local authorities meant to better prepare for a pandemic.

The document is emphatic on several points, not least the need for a state stockpile of emergency equipment.

One former senior Health Department official said he remembers the creation of the stockpile around the time the 2006 plan was issued. He said he recalled it contained things like medicine for the common flu, but he didn't think it included sophisticated equipment such as ventilators.

By March 5, the number of COVID-19 infections in New York City were doubling every five or six days, and officials within the city's Health Department had become increasingly frustrated at what they regarded as the mayor's failure to comprehend the

size and nature of the crisis. That day, he'd issued a press release expressing confidence that the city could still "beat this thing."

Interestingly this week, the United States Senate voted to allow government agencies to access your browsing history without a warrant. The first of the new contact tracing program was recently unveiled in Massachusetts in partnership with Partners in Health, an NGO with links to US regime change operations, big pharma and the Clinton Foundation and George Soros. Tell me this wasn't planned months ago. Be mindful of those folk coming to your door with Q-tips to swab your cheek. They are dualpurposed: give you the pathogen and to steal your DNA!

Last week, the State of Massachusetts began implementing a contact tracing program in partnership with a Boston-based organization with ties to the biggest names in big pharma, the George Soros' Open Society and the Clinton Foundation. Those ties go back decades and include U.S. intelligence assets and regime-change operations in Haiti including Operation Uphold Democracy, in which American troops invaded the Caribbean nation to clean up after the CIA-sponsored coup against Jean-Bertrand Aristide.

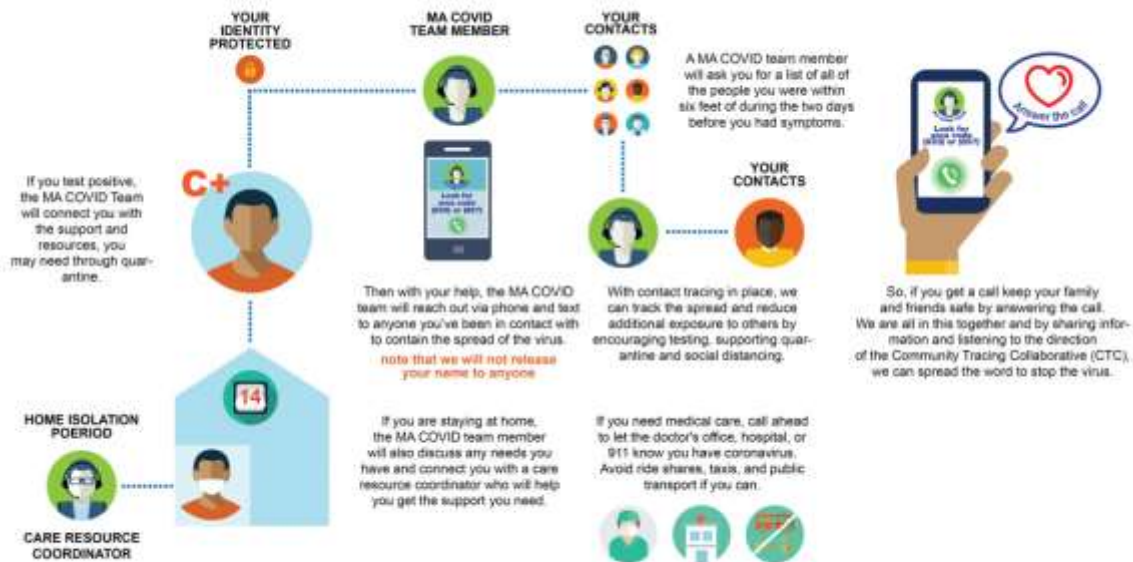
In April, Massachusetts Governor Charlie Baker announced the partnership, called the COVID-19 Community Tracing Collaborative, with Partners in Health (PIH), a non-profit organization with highly questionable patronage and an even more dubious history.

The program will be led by PIH's chief medical officer, Dr. Joia Mukherjee, who described the goals of the contact tracing initiative as well as some of the authorities granted to PIH by the state of Massachusetts to NPR, such as making assessments about whether families have "the ability, the space, the food needed, the employment, the money to safely quarantine" and assigning social service assistants in case they fail to meet the necessary criteria.

The disturbing implications are clear. But, just in case it escaped any NPR listeners, Dr. Mukherjee made it abundantly clear when she tried to assuage the concerns of a Massachusetts contact tracer about parents who might be "infecting their children." Mukherjee assures listeners that PIH will be there to help families who "cannot separate themselves from their children easily".

The Massachusetts state website has published a guide and overview of the program, containing cursory insight about the protocols contact tracers and contacted homes are to follow and it reads like something out of the 1985 dystopian sci-fi thriller "Brazil."

The graphic below from the MA state website demonstrating how the community contact tracing program will work. Be aware of what the folks coming to your door with the Q-tips in hand!



The process begins with a phone call in which you are asked for “a list of all of the people you were within six feet of during the two days before you had symptoms.” It then states that contacted people are free to report anyone else they believe should have a visit from the PIH, asking for their phone numbers “so they can be called and cared for.”

But who is Partners in Health, besides a Boston-based 501(c)3 non-profit founded by a few “ordinary people with an extraordinary ambition”? A look into its background uncovers a dark history intricately linked to the 1994 American invasion of Haiti called “Operation Uphold Democracy,” an operation Mintpress touched on in coverage of the attempted deportation of CIA-backed war criminal, Emmanuel “Toto” Constant.

Unsavoury links to unsavoury people! In a book written by a former United States Army Military Intelligence lieutenant about the NGO’s origins, the author relates that then 23-year Paul Farmer – one of the five founders of Partners in Health – “clearly considered himself a champion of human rights.” The telling passage describes how the young doctor-to-be challenges a U.S. Army captain about the release of a local sheriff named Nerva Juste.

Farmer wanted Juste in U.S. custody, arguing that “preventative detention” was necessary in a country that had “no functioning legal system.” As Farmer was somehow advising U.S. military personnel on proper strategy, his future co-founder was also in Haiti and barely 18 years of age.

Ophelia Dahl, the daughter of renowned British novelist and intelligence officer serving as a liaison between Churchill and FDR, had arrived in Haiti as a “volunteer working with an ophthalmic organization with some handicapped children in Port au Prince.” Dahl eventually met Farmer and later formed PIH with their other very “ordinary” founding partners: Jim Yong Kim, the twelfth president of the World Bank, Tom White, Boston’s “greatest philanthropist” and Todd McCormack, corporate VP of a “sports, fashion and events powerhouse” that would later be purchased by business magnate Ari Emanuel in 2014.

Laurent Gillieron | AP Emanuel’s two brothers, Rahm and Ezequiel “Zeke” Emanuel are, of course, intimately tied to the Clintons, with Rahm serving in the same White House as Hillary Clinton under Barack Obama and Zeke Emanuel, a medical anthropologist just like Paul Farmer, widely considered to be the “architect” of the Affordable Care Act (ACA). The Clinton nexus appears to be strong at PIH as evidenced by one of their most well-known board members: Chelsea Clinton.

The “ophthalmic organization” Dahl cites was an American NGO run by the sixth bishop of Upper South Carolina of the (EDUSC), Rev. William A. Beckham, in partnership with local Haitian cleric, Father Fritz Lafontant. Farmer and Dahl met at one of the NGO’s many healthcare-centered missions that had gotten underway just two years earlier.

The Episcopal church organized “medical trips” to the remote village of Cange in Haiti and began financing engineering projects in the community to provide clean water. Later, a Clemson University program called CEDC (Clemson Engineers For Developing

Countries) partnered with the EDUSC and continues to work in concert with them and Partners in Health after its founding in 1987.



The relationship between Farmer and the Clinton Foundation spans decades. PIH has “worked with the Clinton Giustra Enterprise Partnership (CGEP) to stimulate entrepreneurship for smallholder farmers in Haiti,” in addition to similar projects “throughout Africa, from Liberia to Rwanda.” The organization has even built clinics on the Island in partnership with the Clinton Global Initiative.

With such an intimate connection revolving around the Clinton Foundation’s healthcare projects, it should come as no surprise that PIH’s biggest donors and partners feature some of the largest pharmaceutical corporations currently set to profit from the COVID-19 pandemic, including Eli Lilly and Co., Johnson & Johnson and Pfizer among many more.

Also found on the list of foundation partners, both public and private, are the Bill & Melinda Gates Foundation, the Inter-American Development Bank, USAID, WHO, GE, IBM and a host of others.

The George Soros's Open Society Institute donated \$3 million to PIH for a "community-based program" in Africa back in 2007 and in 2014, Soros donated another \$4 million to PIH to build an Ebola-treatment center in Liberia, Africa. The Liberian project was anchored by a "coalition" put together by PIH-founder, Jim Yong Kim, which included Director-General of the WHO, Margaret Chan, CDC Director Tom Frieden and Francis Collins, Director of the National Institute for Health, who claimed to have been motivated to start the project by a collective dismay over "the global response".

The contact tracing program being rolled out in Massachusetts by PIH is, logically, informed by the many years the organization has been practicing their healthcare engagement methods throughout the world, and in particular Haiti and developing African nations. Following a pattern used when the first policing innovations were tested out by U.S. military forces in the Philippines at the turn of the twentieth century, social control mechanisms are now being imported stateside after being thoroughly tested elsewhere.

PIH, and founder Paul Farmer in particular, understand exactly how to bring about "sustainable health systems" as he claims PIH has done in places like Guinea, Liberia, and Sierra Leone. Oddly, in a post published on the Open Society website, Farmer appears to be opposed to quarantine, conceding that doing so "slows the flow of food and labor" and can "touch off longer, more complex health crises." While he is referring here to African farmers, the same principle surely holds for even the most advanced economies like the United States.

Paul Farmer is a complex fellow. In his PIH biopic, "Mountains Beyond Mountains," claims the Farmer not only chided a U.S. military captain about his operational choices, but also pointed out that he found it unacceptable that "a high official of the junta" had received training at the infamous School of the Americas. The author never makes clear what context Farmer was speaking in.

One thing that stands out in what I am sharing here, and that is the "Warp Speed" all these steps being made in the name of public safety and health. Where do we know that term from "peace and safety"? ***"For when they shall say, Peace and safety; then sudden destruction cometh upon them, as travail upon a woman with child; and they shall not escape."*** -(1st Thessalonians 5:3).
