**The US has reported its highest one-day Covid-19 death tally: Over 2,800**

More than 2,800 [Covid-19](#) deaths were reported for Wednesday, December 2, 2020 in the United States -- the most the country has ever reported in a single day -- as health care officials say their staff and facilities are struggling to support burgeoning numbers of patients. I ask you, does that sound like a pandemic. In a country of approximately 327,000,000 people, 10% would be 32,700,000, and 1% would be 3,270,000. What percentage would 2,800 be, see below in the box.

### **The latest on the coronavirus pandemic and vaccines**

The number of Covid-19 patients in US hospitals Wednesday -- 100,226, according to the COVID Tracking Project -- also is the highest reported on a given day during the pandemic.

One-day death totals can draw from delayed reports across several days. Still, recently soaring daily rates of infections and hospitalizations has various experts [predicting](#) the daily death count could regularly surpass 2,000 or 3,000, and perhaps approach 4,000.

The country's daily average of Covid-19 deaths across a week is 1,654 -- above its summer high of around 1,130 but lower than the pandemic peak above 2,240 in late April, 2020.

*"By this time next week, we are going to be talking about 3,000 deaths a day -- that's 9/11 every single day,"* Dr. Jonathan Reiner, a cardiologist and professor of medicine at George Washington University, told CNN on Wednesday. Dr. Reiner guesstimate would still be lower than 1 per county in the USA! That is not a pandemic.

The death count reported Wednesday was **2,804**, surpassing the previous one-day high of **2,603** set on April 15, according to Johns Hopkins University data. Earlier, JHU's total for Wednesday was higher -- but that count was corrected Thursday morning because of an error found in one state's tally.

That **2,804** figure is fewer than the number of counties in the USA. There are **3,143** counties in the 50 U.S. states. Even the record of **2,603** set on April 15<sup>th</sup> is fewer than One per county. This past Wednesday deaths charged to Covid-19 of **2,804** is just **0.00085749%**. Statistically this is not even significant. If the death rate was just **1.0%**, it would mean that 327,000 people would have died Wednesday. That would be significant.

Daily coronavirus cases and hospitalizations also have been soaring -- prompting CDC director Dr. Robert Redfield to [say Wednesday](#) that the winter months are likely *"going to be the most difficult time in the public health history of this nation."* Jesuit Dr. Robert Redfield knows how to lie, exaggerate, and obfuscate the truth. This is part of a Jesuit's training.

The 911 emergency call system is "at a breaking point," the American Ambulance Association, which represents all of the nation's ambulance services, said in a letter Wednesday.

*"Without additional relief, it seems likely to break, even as we enter the third surge of the virus in the Midwest and West," the letter said.*

As for cases: The country's average number of new daily Covid-19 cases across a week was 164,103 Wednesday -- nearly 2.5 times the summertime peak in July, JHU data show.

Los Angeles tells residents to 'cancel everything' States across the US are racing to catch up with the skyrocketing number of coronavirus hospitalizations.

If the virus continues to spread at its current, unprecedented rate, Los Angeles will run out of hospital beds by Christmas, Mayor Eric Garcetti warned in a Wednesday news conference. He called on residents to *"hunker down"* and *"cancel everything"* to help stop the spread.

### **CDC will decrease coronavirus quarantine time from 14 to 7-10 days**

*"The public health condition of our city is as dire as it was in March in the earliest days of this pandemic,"* he said, adding that the number of daily infections in Los Angeles has tripled since early November and hospitalizations are at a new peak.

In southwestern Kansas, there are no staffed ICU beds available, Gov. Laura Kelly said Wednesday. *"While case numbers may have dipped slightly, the strain on our hospitals and health care workers has not,"* she said.

Coronavirus hospitalizations in Nevada have been climbing daily since November, with few exceptions, and were at a peak Wednesday with 1,652 people hospitalized, the state's data dashboard showed.

100 million in US could be vaccinated by February. There may still be a ways to go before the wider public has access to a coronavirus vaccine, but developments are moving quickly. This is all fear-mongering on steroids!

By February, 100 million Americans could be vaccinated against Covid-19, Moncef Slaoui, chief adviser to the federal government's Operation Warp Speed vaccine effort, said Wednesday.

*"All the investments we have made in scaling up and starting to stockpile manufacturing of the vaccines allow us to stay confident that we will be able to distribute 20 million vaccines, enough to vaccinate 20 million people in the US in December,"* Slaoui said in a news briefing.

If Pfizer and Moderna win US Food and Drug Administration emergency use authorization in December, they could distribute 40 million doses of the vaccine by the end of the month, US officials have said. Each vaccine requires two doses, so that's enough to fully vaccinate 20 million people.

*“Slaoui expected 60 million more vaccines by the end of January,” he said.*

An FDA panel is expected to meet about whether to authorize the Pfizer and Moderna vaccine candidates on December 10 and December 17, respectively.

Assuming the vaccines are authorized, the first shipments could happen December 15 and 22, respectively, according to an Operation Warp Speed document.

A CDC panel recommended Tuesday that health care and long-term care workers get inoculated first.

Dr. Paul Offit, a member of the FDA's vaccine advisory group, said Wednesday that technology could help ramp up vaccine production enough to cover the global population.

*“You really can, I think, in a couple years, be able to make enough vaccines to vaccinate 7 billion people,” he said. “There's no reason to think that couldn't happen.”*

Vaccine trials for children set for 2021. Though vaccines are on the way, they have only been studied in adults and children older than 12. Trials for younger children could start early next year, Dr. Francis Collins, the director of the National Institutes of Health, said Wednesday. *We “very definitely need to get there,” Collins told CNN's Wolf Blitzer.*

### **Dr. Leonard Horowitz Files COVID-19 Vaccine Lawsuit to Block FDA's Approval of Pfizer and Moderna's “Genetic Therapies”**

**Ft Myers, FL (12-3-20; MedicalVeritas.org)**—A world leading vaccine risk analyst, [Dr. Leonard G. Horowitz](#), has filed a [COVID-19 vaccine lawsuit](#) in the United States District Court for the Middle District of Florida to oppose the FDA's approval of Pfizer and Moderna vaccines until the companies, alleged to have falsely advertised safety, perform tests on the genetic impacts admittedly neglected by the companies.

#### **“Vaccinations” or “Genetic Intoxications”?**

Not actually “vaccines” in the traditional sense, but “genetic therapies” according to the companies, the court is asked to enjoin the government from approving and distributing the injections due to neglected genetic safety science and inadequate testing.

“Genetics (specified analyses) are not evaluated in this study,” the Pfizer Protocol admitted. The same is true for the Moderna vaccine.

Dr. Horowitz's [84-page lawsuit](#) holds Pfizer and Moderna vaccine advertisers and distributors accountable for false advertising of the vaccines' safety under [Florida's](#)

[unfair and deceptive trade act](#) and [whistleblower law](#). Eight claims are brought by the whistleblowing doctor and litigator who has asked the court for a number of “remedies” besides the injunction.

One of Horowitz’s remedies would require Defendants to supplement their COVID-19 vaccine trials to assess the risks of genetic alterations to human DNA and viral genes.

“The injunction should require Defendants to . . . assess the risks of genetic ‘reassortments’ of latent DNA and RNA tumor viruses in medically or immune compromised people,” the lawsuit pleads.

“The injunction should require the federal government to suspend its acquisition of the Defendants’ COVID-19 vaccines until such a time as the aforementioned safety concerns are studied and resolved by supplemental trials, the results of which are candidly published,” the doctor added.



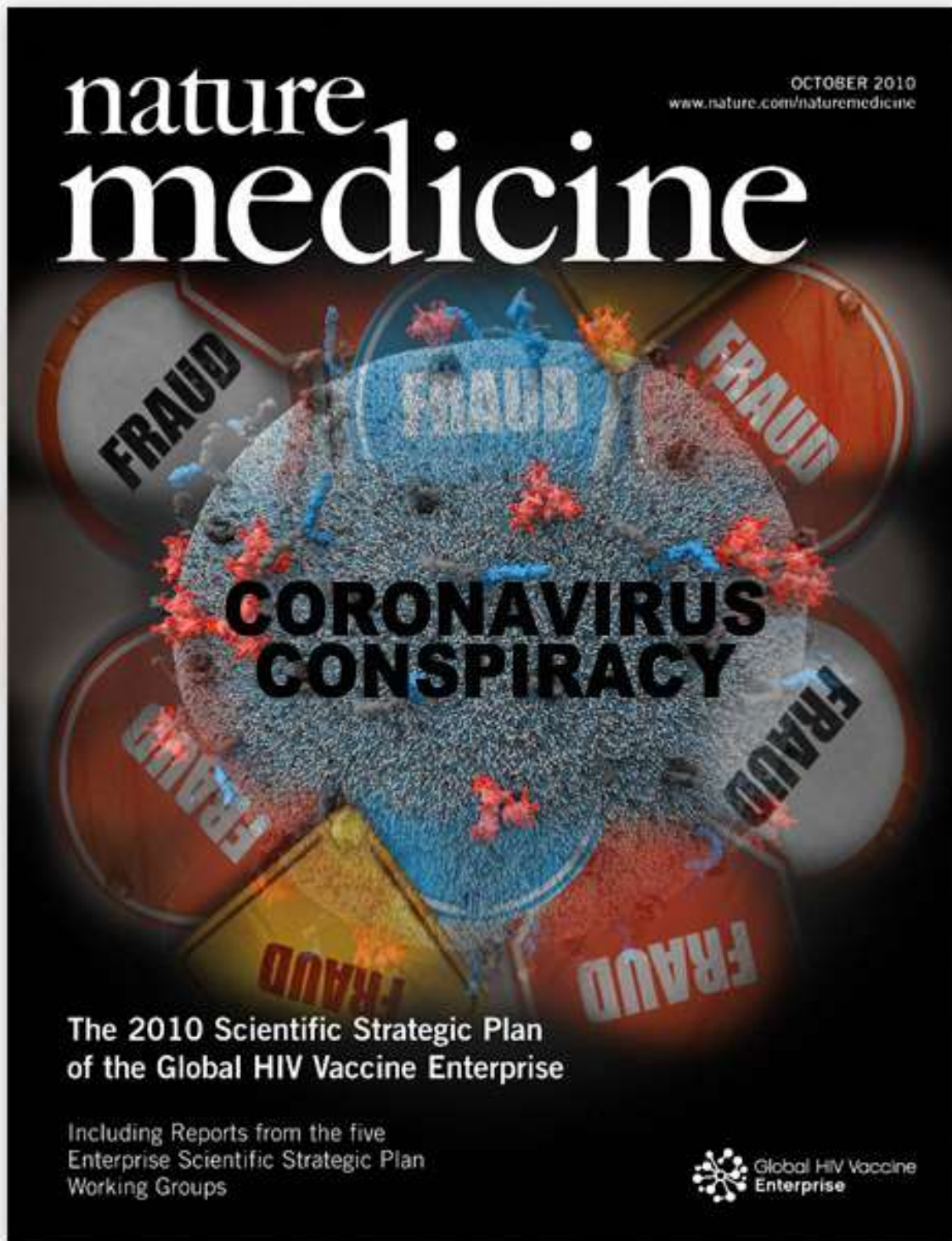
### **False Safety Advertising Might Worsen Outcomes**

Dr. Horowitz’s complaint raises criminal concerns beyond consumer fraud by Pfizer, Moderna, their advertisers and distributors at Hearst Corp and Henry Schein, Inc. There is a broader financial and media enterprise involved.

The complaint reminds the court of [Pfizer’s criminal fine of \\$2.3 billion](#)—the largest health care fraud settlement in history for complicity in causing the opioid crisis.

Advertisements filed with the court proclaim safety of the mRNA vaccines without “reasonable justification.” This evidences “deceptive trade” according to the complaint.

The whistleblower argues that the Defendants “omitted material facts in advertisements implying safety had been ‘observed’ in these mRNA genetic studies whereas the official protocol stated: ‘No testing of the participant’s DNA will be performed’ (p. 52).”



“This neglect happened even though the virus’s ‘spike protein’ attachment mechanism was genetically reconfigured in the Pfizer and Moderna labs.




The alleged neglect of genetic safety studies occurred even though the therapeutic impact of the mRNA targets DNA production of spike protein antigens to induce antibody production demonstrating “DNA modulation and trickery,” the lawsuit explains.

Horowitz expressed most concern that, “Officials concealed the risk of Pfizer and Moderna’s genetic sequences recombining with other viruses in humans or the environment, increasing the risk and likelihood of additional ‘novel’ outbreaks and disastrous pandemics.”

### **Conflicting Interests Evidence the COVID-19 ‘Lab Virus’ is Linked to HIV/AIDS.**

The complaint alleges that COVID-19 virus’s hyper-transmissibility sourced from the “spike protein” that contains four gene sequences from the AIDS virus, HIV-1.

Prashant Pradhan and eight more widely respected scientists used IBM’s Watson computer to make that [published discovery](#), then “withdrew” the science paper due to ‘political pressure’

Among several facts supporting Horowitz’s claim of “civil conspiracy,” another group of researchers led by Xiao Li, a structural virologist at the University of Texas, El Paso, [smeared Pradhan’s science](#) paper and confused the facts.

But, Li et. al.’s publication came with gross conflicting interests that the authors concealed, much like the safety risks of the mRNA injections, Horowitz informed the court.

This is best explained by Pfizer’s long history of financing Xiao’s University of Texas and cancer virus studies conducted there. These included researching enzymes active in cancer induction versus genetic repair.



Fauci is identified in multiple advertisements as a leading governmental endorser of Pfizer and Moderna vaccines, claiming the new vaccines were adequately proving safe.

But years earlier, in 2012, two years before the federal government's moratorium on risky 'gain of function' coronavirus studies that were ongoing at the UNC, Dr. Fauci expressed reasonable concern. He appeared to encourage a 'voluntarily' shut down of the UNC lab in 2014 in support of the 'moratorium.'

Writing in the journal of the [American Society for Microbiology](#), Fauci announced, *"The voluntary moratorium on gain-of-function research related to the transmissibility of highly pathogenic H5N1 influenza virus should continue, pending the resolution of critical policy questions concerning the rationale for performing such experiments and how best to report their results. . . ."*

Unfortunately, "critical policy questions" were never adequately answered, and "how best to report their results" succumbed to censorship.

Fauci then circumvented the issues in favor of his involvement in the COVID-19 disease enterprise that includes his personal financial interests in related patents.

Quoting the complaint, ["Dr. Fauci on WebMD"](#) stated his confidence that the Pfizer vaccine would reach the 'required safety milestone' which is a bar that Fauci knew was set so *low* that it neglected 'Genetics (specified analyses)' 'not evaluated in this study,' according to the trial Protocol that Fauci undoubtedly was required to read prior to making that statement. . . .

*"Dr. Fauci is also a co-patent holder on technology that may very well be used by Moderna that is in the business of manufacturing mono-clonal antibodies, and vaccines that target cells to produce those antibodies."* These technologies "may be used to fight HIV/AIDS and COVID-19," the complaint states.

*"Dr. Fauci's Patent number: 6911527, regards 'HIV related peptides' involved in the manufacturing and therapeutic utility of the Pfizer and Moderna COVID-19 vaccines. . . .  
"Moreover, although Dr. Fauci denies or conceals these facts, he is well-aware that the COVID-19 virus is widely recognized in the scientific community as being a 'lab virus' recombinant, (what Dr. Fauci has called a 'reassortment') that is highly transmissible because it contains four (4) genes from the AIDS virus that comprise a large part of the attachment protein called the 'spike protein' or 'S protein.'"*

That spike protein is the "gain-of-function" component to the mutant's assembly, Horowitz evidences.

The complaint further states, *"Much like Dr. Fauci concealed his conflicting commercial interests as a co-patent holder in this technology, he has similarly concealed the COVID-19 virus and disease's relationship to HIV/AIDS science."*



### **Dr. Fauci's Conflicting Interests**

This is “*foundational to Pfizer and Moderna’s mRNA vaccines that target immune cells using the same or similar ‘spike protein’ comprised substantially of HIV-1 genes.*”

On-or-about November 18, 2020, it was discovered that the [Bill & Melinda Gates Foundation](#) and [National Institutes of Health](#) financed the [EcoHealth Alliance that orchestrated a contrived statement by 27 prominent scientists](#) condemning “conspiracy theories” that asserted the COVID-19 virus was not natural, as Pradhan’s group concluded.

E-mails obtained by whistleblowers, however, showed that EcoHealth Alliance’s President, Peter Daszak, drafted [The Lancet statement](#) to conceal the actual conspiracy administered by industry leaders hiding the laboratory engineering of HIV/AIDS and the SARS-Coronavirus/HIV gain-of-function lab-recombinant.

These facts corroborate Horowitz’s civil conspiracy claim against the co-Defendants. *The Lancet* fraud further evidences the criminal complicity committed by agents and agencies within the Pfizer/Moderna pharmaceutical enterprise that also targets “anti-vaxxers” and “vaccine hesitant” persons and groups, the complaint reveals.



### **The Defrauding of People Worldwide**

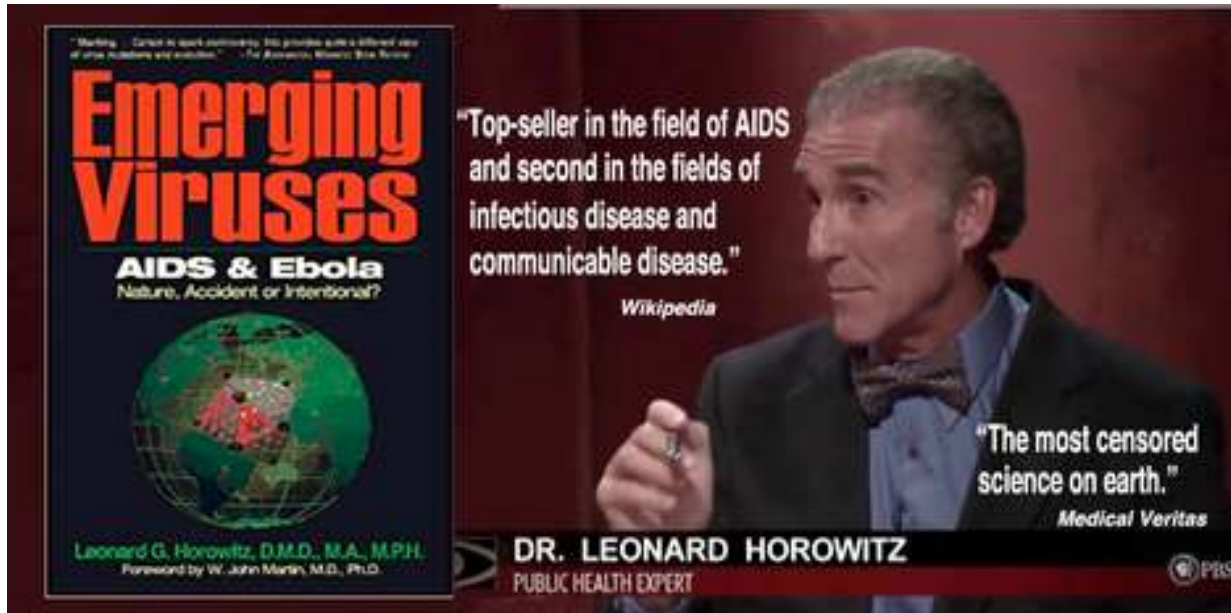
Horowitz's lawsuit claims that Pfizer and Moderna fraudulently concealed their complicity in a "civil conspiracy" defrauding citizens and governments worldwide, including the United States Government, to gain the companies' pre-sale of COVID-19 "genetic therapies."

Allied media hyped fear to produce 'germaphobia' to sell the "game changer" mRNA "vaccines." These deceptively addressed the pandemic emergency—a disaster that the defendants' extensive healthcare enterprise is suspected of triggering.

Given Pfizer's criminal history and complicity in the profitable and deadly "opioid crisis," Horowitz's COVID-19 lab origin accusation is reasonable.

At minimum, Pfizer's defense hinges on refuting, censoring, or evading science such as what Pradhan's group published.

### The Whistleblower and His Claims

Dr. Horowitz is a Harvard-trained Editor-in-Chief of MedicalVeritas.org. He is also a registered “Criminal Justice Act (CJA) Expert” investigator in medical/legal proceedings.

According to Amazon.com and *Wikipedia*, the doctor’s book, [\*Emerging Viruses: AIDS & Ebola—Nature, Accident or Intentional?\*](#), has been the “top-seller in the field of AIDS and second in the fields of infectious disease & communicable disease” for the past quarter century.

Scientific reports comparing HIV/AIDS genes to those in the COVID-19 virus’s “spike protein” raised the whistleblower’s concern and prompted his investigation of the companies’ safety testing procedure.

The doctor/whistleblower’s lawsuit includes five claims in addition to three for unfair and deceptive trade.

The complaint also advocates for consumer health and safety, as well as the doctor’s own interests as a health science entrepreneur. His employment by Henry Schein, Inc., and Schein’s participation in the “Event 201” coronavirus pandemic “exercise” in October, 2019, gave Horowitz standing to bring this lawsuit on his and the public’s behalf.

Horowitz’s claims against Hearst for unfair competition and “tortious interference with prospective economic advantage” concern the suppression of Horowitz’s [\*OxySilver™ with 528\*](#)—a vaccine and antibiotic alternative for people who can’t or won’t consume drugs or vaccines for medical or religious reasons.

The complaint additionally advocates for bringing alternative medicines called “anti-oxidants” to market that have been ignored or suppressed by the Defendants’ monopolistic enterprise.

In a final request, the court is asked to order the defendants to pay for a mass public education campaign encouraging natural anti-oxidants for boosting life-saving immunity against COVID-19 and other illnesses.

Johns Hopkins University keeps a tracker of Covid cases around the world and the U.S. This site is used to scare people into staying in their homes and shut off from the real world. So when a study from Johns Hopkins comes out, showing no increase in deaths in 2020 related to prior years, the study has to be taken down.

The Gateway Pundit reported back in August that according to the CDC only 6% of all deaths labeled as COVID deaths are solely related to the virus. The remaining deaths have on average at least 2 – 3 comorbidities present.

The report on the actual COVID numbers went viral and was even retweeted by President Trump. **Over the weekend, a [study was published by Johns Hopkins](#) claiming that COVID-19 has ‘Relatively No Effect on Deaths’ in U.S.**

**Unfortunately, shortly after being published, the report was deleted from the web.** However, the report was [retrieved using the Way-Back Machine](#) and this is in part what was reported:

*Genevieve Briand, assistant program director of the Applied Economics master’s degree program at Johns Hopkins University, critically analyzed the impact that COVID-19 had on U.S. deaths. According to her, the impact of COVID-19 on deaths in the United States can be fully understood by comparing it to the number of total deaths in the country.*

*According to study, “in contrast to most people’s assumptions, the number of deaths by COVID-19 is not alarming. In fact, it has relatively no effect on deaths in the United States.”*

The report says:

*After retrieving data on the CDC website, Briand compiled a graph representing percentages of total deaths per age category from early February to early September, which includes the period from before COVID-19 was detected in the U.S. to after infection rates soared.*

***Surprisingly, the deaths of older people stayed the same before and after COVID-19. Since COVID-19 mainly affects the elderly, experts expected an increase in the percentage of deaths in older age groups. However, this increase is not seen from the CDC data. In fact, the percentages of deaths among all age groups remain relatively the same...***

*...When Briand looked at the 2020 data during that seasonal period, COVID-19-related deaths exceeded deaths from heart diseases. This was highly unusual since heart disease has always prevailed as the leading cause of deaths. However, when taking a closer look at the death numbers, she noted something strange. As Briand compared the number of deaths per cause during that period in 2020 to 2018, she noticed that instead of the expected drastic increase across all causes, there was a significant*



*decrease in deaths due to heart disease. Even more surprising, as seen in the graph below, this sudden decline in deaths is observed for all other causes.”*

### 2. Provoke a Terrified Reaction



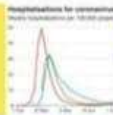

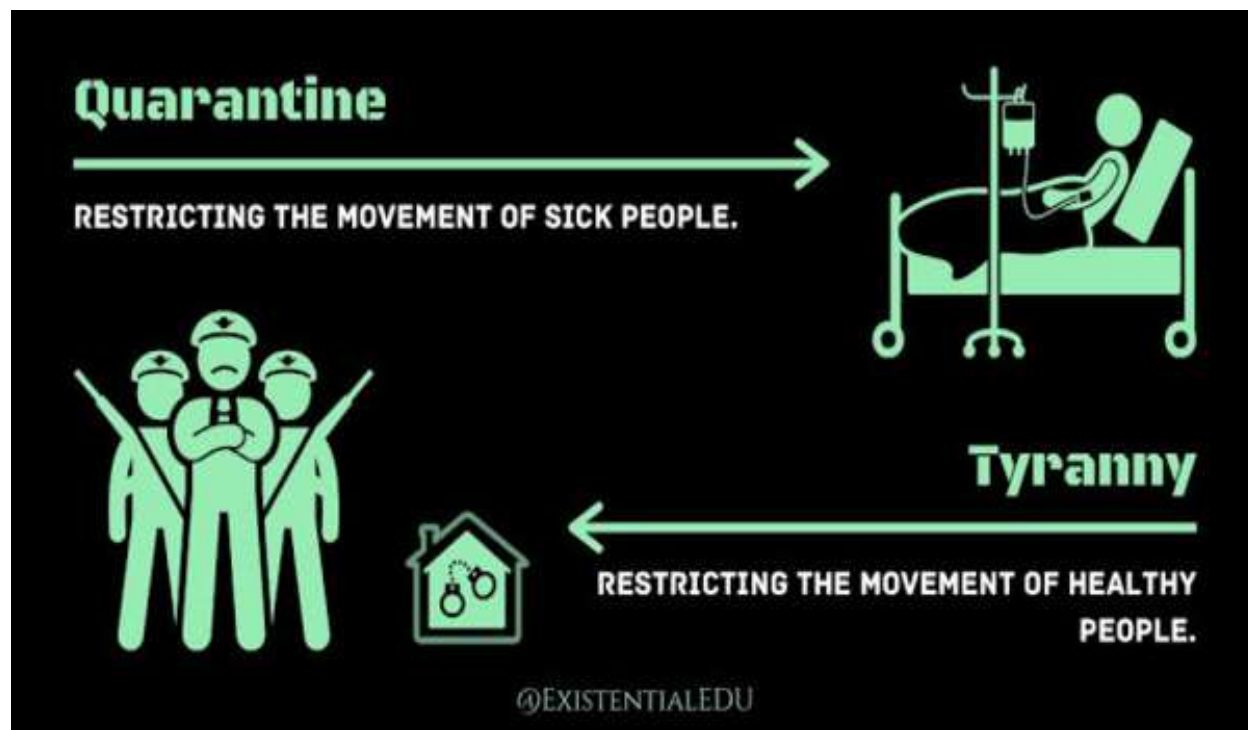
### 12. Arrive at the Totalitarian New World Order

### **Abstract**

Most patients with COVID-19 disease caused by the SARS-CoV-2 virus recover from this infection, but a significant fraction progress to a fatal outcome. As with some other RNA viruses, co-infection or activation of latent bacterial infections along with pre-existing health conditions in COVID-19 disease may be important in determining a fatal disease course. *Mycoplasma* spp. (*M. pneumoniae*, *M. fermentans*, etc.) have been

routinely found as co-infections in a wide number of clinical conditions, and in some cases this has progressed to a fatal disease. Although preliminary, *Mycoplasma pneumoniae* has been identified in COVID-19 disease, and the severity of some signs and symptoms in progressive COVID-19 patients could be due, in part, to *Mycoplasma* or other bacterial infections. Moreover, the presence of pathogenic *Mycoplasma* species or other pathogenic bacteria in COVID-19 disease may confer a perfect storm of cytokine and hemodynamic dysfunction, autoimmune activation, mitochondrial dysfunction and other complications that together cannot be easily corrected in patients with pre-existing health conditions. The positive responses of only some COVID-19 patients to antibiotic and anti-malaria therapy could have been the result of suppression of *Mycoplasma* species and other bacterial co-infections in subsets of patients. Thus it may be useful to use molecular tests to determine the presence of pathogenic *Mycoplasma* species and other pathogenic bacteria that are commonly found in atypical pneumonia in all hospitalized COVID-19 patients, and when positive results are obtained, these patients should be treated accordingly in order to improve clinical responses and patient outcomes.
