

The Coronavirus Scare Is A Power & Control Operation?

Part 1

Note carefully that I used the word “**IS**” and not “**WAS**” because this it is merely the beginning of an ongoing war, part of a globalist program of **Depopulation**. Over-population is the number ① issue in the world today, and has been for fifty years. If you fail to learn your lesson, you are likely to be culled through fraud and deception. This tyranny is being carried out in the name of safety, but it is a brilliant plan that can cost you your life!

Governments have used psychological warfare throughout history to manipulate public opinion, gain political advantage, and generate profits. Western governments have engaged in such tactics in the war on terrorism as well as in its predecessor, the war on communism.

In both cases, [state-sponsored terrorism](#) and propaganda were used to distort the public’s perception of the threats, leading to increased governmental control of society and huge financial benefits for corporations. It appears that the same kinds of effects are being seen as a result of the COVID-19 pandemic. Many of the features and outcomes seen in the war on terrorism and the war on communism are evident in this new “war on health concerns.”

Therefore, it’s reasonable to wonder if the extreme response to COVID-19, and its associated virus SARS-COV-2, could be another psychological operation against the public. Considering facts about the disease and the disproportionate response emphasizes the possibility. If COVID-19 has been co-opted for manipulation of the public, through hyping the threat and pushing exploitive solutions, who is behind it and who benefits?

Let’s first review what features and outcomes the “coronavirus scare” shares in common with the “red scare” that drove the perceived threat of communism and the “Muslim scare” behind the perceived threat of terrorism. Here are a dozen characteristics that these perceived threats share.

- Fear-based and globally directed
- Media saturation with bias toward fear
- Data manipulation and propaganda
- Censorship of opposing views
- Intelligence agency control of information
- Preceded by exercises mimicking the threat
- Series of claims made that are later proven false

- Response threatens democracy
- Large increase in wealth and power for a few; increase in social inequality
- Increased government control of the public and reduced individual freedoms
- Response kills far more than the original threat
- Evidence for manufactured events (see below)

There are also differences between the COVID-19 pandemic response and the “wars” on communism and terrorism. One difference is that, for the virus, agencies dedicated to public health have taken the lead. Although the central characters that hyped the communism threat and the terrorism threat were sometimes the same people, they tended to represent military, diplomatic, or intelligence agencies.

The primary actors driving the coronavirus lockdowns and associated control mechanisms are political leaders. However, the directives being acted upon come from the World Health Organization (WHO), an agency of the United Nations ostensibly responsible for international public health. Others controlling the coronavirus scare are national health agencies, most notably the US Centers for Disease Control and Prevention (CDC) and the United Kingdom’s National Health Service (NHS).

Are these agencies acting solely in the interest of public health?

The WHO

The common impression is that the entire matter began in reaction to events in China but even that is not clear. For example, the virus is said to have originated in the city of Wuhan and the first, limited, lockdown occurred in that area from January to March.

China has since said that it warned the WHO about the virus during the first week of January. However, it is known that U.S. intelligence agencies were aware of the potential outbreak even before that, in November 2019, possibly earlier. A Chinese spokesman later suggested that the U.S. military might have brought the virus to Wuhan during the military games held there in October.

The first instance of an entire country being locked down for the coronavirus was in Italy. This occurred on March 9th based on advice from the Italian government’s coronavirus adviser Walter Ricciardi, who said, *“The situation risks going out of control and these measures are necessary to keep the spread at bay.”*

Ricciardi, a WHO committee member, later admitted that Italy had inflated the death counts from the virus, stating:

“The way in which we code deaths in our country is very generous in the sense that all the people who die in hospitals with the coronavirus are deemed to be dying of the coronavirus.”

Recently, Walter Ricciardi has walked that story back, and has said it was a scam, and that they would no longer be part of the scenario of the UN-WHO.



Many have also noted the inordinate influence of billionaire Bill Gates on the activities and direction of the WHO. As of 2017, this influence was seen as troubling, with health advocates fearing that:

"Because the Gates Foundation's money comes from investments in big business, it could serve as a Trojan horse for corporate interests to undermine WHO's role in setting standards and shaping health policies."

Gates has been called a ruthless schemer by his Microsoft co-founder Paul Allen and Allen is not alone in that assessment.

Despite engaging in a costly "public charm offensive," Gates is seen by many as a predatory and monopolistic opportunist hiding behind a false front of philanthropy. With regard to the coronavirus scare and Gates' stated goal of vaccinating the entire world population, however, people should be most concerned that he has worked diligently on mechanisms of population control.

Gates newest vaccines are according to an English vaccine whistle-blower from Glaxo Smith Kline: *New vaccine could well cause sterility in 97% of women... While also affecting men's sexual organs too... (Clear medical explanation)... Delayed reaction until 7-10 yrs. later... The antigen HCG and LOH are in the new vaccines by Glaxo Smith*

Kline, 61% of women test recipients were made sterile! The Gates Foundation gave several grants totally £28 million pounds to several U.S. academics for these new vaccines.

Of course, no one person controls the world yet so who is supposed to be running WHO, apart from Bill Gates? The face of the WHO is Dr. Tedros Adhanom, the director-general of the organization. Tedros has a poor history of ethics in leadership, with many accusations having been made against him including that he covered-up epidemics in the past.

Alarms about Tedros began to go off immediately after his appointment in 2017, when he named Robert Mugabe, the former dictator of Zimbabwe, as a goodwill ambassador to the WHO. Mugabe's rule over Zimbabwe was dominated by "murder, bloodshed, torture, persecution of political opponents, intimidation and vote-rigging on a grand scale." This appointment indicated that Tedros' judgment of goodwill was dubious at best.

A letter from a group of American doctors that same year described why Tedros has become known as "[Dr. Cover Up.](#)"

They wrote:

"Your silence about what is clearly a massive cholera epidemic in Sudan daily becomes more reprehensible. The inevitable history that will be written of this cholera epidemic will surely cast you in an unforgiving light."

They added that Tedros was "*fully complicit in the terrible suffering and dying that continues to spread in East Africa.*"

Problems at WHO didn't start with Tedros, however.

After the H1N1 pandemic of 2009, evidence came to light that the WHO had exaggerated the danger and had spread fear and confusion rather than helpful information. It was later learned that "*Italy, Germany, France and the U.K. made secret agreements with pharmaceutical companies*" that "*obliged the countries to buy vaccinations only if the WHO raised the pandemic to a level 6.*"

The WHO then proceeded to change its guidelines for defining a pandemic in order to accommodate those contracts, thereby increasing the public's fear despite the fact that the pandemic never became a serious threat.

Although WHO has been praised for its work to reduce some illnesses like polio, it has also been found that drugs and vaccines recommended by WHO have been "*found to be harmful and without significant clinical effect.*"

A comprehensive view suggests that the WHO is more of a corporate interest agency than an organization committed to preserving public health. That's not surprising due to the fact that 80% of WHO's funding comes from "voluntary contributions" provided by

private donors including pharmaceutical companies and industry groups like Bill Gates' Global Alliance for Vaccines and Immunization (GAVI). Bill Gates was the second largest funder behind the U.S. of the WHO!

And since the worldwide response to COVID-19 has been directed and coordinated by an organization that works on behalf of multi-national corporations that stand to benefit, the idea that the coronavirus scare could be a psychological operation seems plausible.

The CDC

In the U.S., the CDC is also heavily influenced by corporate and political interests. This became clear when, in 2016, a group of senior scientists within the CDC filed an ethics complaint against the agency making that exact claim. They wrote:

It appears that our mission is being influenced and shaped by outside parties and rogue interests."

The scientists noted that, in order to pursue political objectives, "*definitions were changed and data cooked*" at CDC, even to the point of misrepresenting data to the U.S. Congress.

Like the WHO, the CDC has a history of pushing harmful vaccines. An example was covered in a [60 Minutes episode](#) exposing the harm done by the Swine Flu vaccine in 1976 and CDC's urging that all Americans be injected with that harmful vaccine. The report revealed that the illness was hyped based on very questionable data and the vaccine caused neurological damage.

The current Director of CDC is retired US Army doctor Robert Redfield, who is known for having led the Pentagon's disastrous response to HIV-AIDS in the 1980s.

"A devout Catholic, Redfield saw AIDS as the product of an immoral society. For many years, he championed a much-hyped remedy that was discredited in tests. That debacle [led to his removal](#) from the job in 1994."

Public health reporter Laurie Garrett remarked:

"Redfield is about the worst person you could think of to be heading the CDC at this time. He lets his prejudices interfere with the science, which you cannot afford during a pandemic."

The CDC is an agency within the department of Health and Human Services (HHS). Alex Azar, a lawyer and former pharmaceutical company executive, was appointed as Secretary of HHS in 2017. Azar has deep connections to the pharmaceutical industry and is known for having engaged in price gouging with his former employer.

Azar is also known for leading the HHS response to the anthrax scare of 2001, the first known bio-terrorism attack on the United States. The anthrax attacks were targeted against members of Congress and the media that were dissenting voices in the national

discussion about the Patriot Act, the oppressive legislation introduced immediately after the 9/11 attacks.

Although Muslims were first blamed through highly questionable evidence, it was ultimately found that the weaponized anthrax came from [U.S. military laboratories](#).

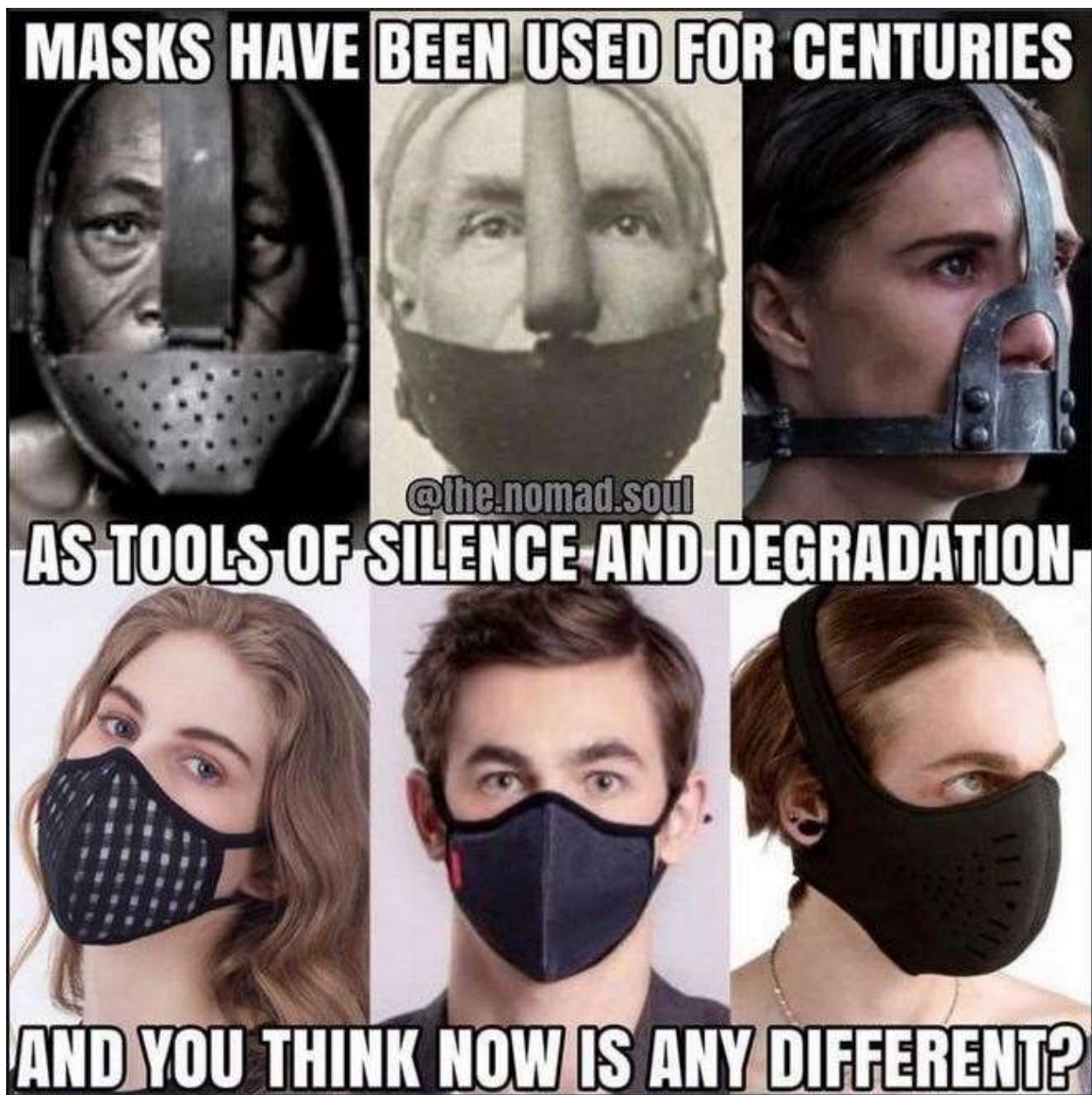
Azar was instrumental in defining the National Biodefense Strategy in 2018, working [closely with John Bolton](#), Trump's National Security Advisor. Bolton, a neocon and member of the Project for a New American Century (PNAC), has a long history of pushing authoritarian policies and war.

Fauci or a dog dressed as a doctor?

His tenure of 36 years at the NIAID reaps him millions in royalties from patents he holds at the CDC, a private corporation, and not a government agency.



In the U.S. the person most visibly in charge of the COVID-19 response is Anthony Fauci, who is the long-time director of the National Institute of Allergy and Infectious Diseases (NIAID). Like Redfield, Dr. Fauci is a devout Catholic and has said that values he learned in his Jesuit education continue to guide him. That is an ominous statement when you know the Jesuit values.

After weeks of Fauci having led the coronavirus response in the US, it was learned that his NIAID had funded [“gain of function” research](#) at the Wuhan laboratory where the SARS-COV-2 virus is suspected of having originated. The term “gain of function” simply means to make the virus more lethal, to kill larger numbers of people. Fauci’s

response to questions about that inexplicable coincidence was simply to denounce “conspiracy theories” rather than addressing the questions directly, much as others did when questioned about 9/11 foreknowledge.

Whether SARS-COV-2 was genetically engineered in a laboratory, like the NIAID-funded Wuhan lab, is a subject that has become of [interest to many scientists](#).

The Wuhan laboratory is not the only place the U.S. supports work like this, however, as the Pentagon funds such labs in 25 countries across the world. Located in places such as Eastern Europe, the Middle East, South East Asia, and Africa, these labs isolate and manipulate viruses like the bat coronaviruses from which SARS-COV-2 originated. [This bat-research program](#) is further coordinated by a group called EcoHealth Alliance.

The manipulation of viruses for “gain of function” at US funded labs is, like the origin of the weaponized anthrax at U.S. labs, evidence that bio-terrorism and pandemics can be manufactured events. This is another way in which the coronavirus scare could reflect the war on terrorism and war on communism, both of which were driven by manufactured terrorist events.

It is remarkable that Fauci funded work to manipulate coronaviruses then became the voice of the coronavirus pandemic response while also working closely with Bill Gates’ GAVI initiative. Fauci has boasted that NIAID and GAVI work together to push vaccines with *“outright collaboration between us in setting the standard of what is needed.”*

This makes it easier to see that a new pattern of hyped pandemics resulting in increased population control and global vaccinations is not only possible but would be a very lucrative business model.

The NHS and Corporate Nations

By now it’s well known that the initial projections for deaths due to COVID-19 were massively over-estimated and one academic paper was responsible for the panic. The lead author of that paper, Neil Ferguson of Imperial College, has since resigned in disgrace from his government advisory position. Much like the US government’s explanation for destruction of the World Trade Center buildings, his estimates were based on computer models that cannot be shared with the public.

As in the US, UK intelligence agencies have taken a leading role in managing the coronavirus scare. The terrorism expert who is expected to be the next chief of MI6 was selected to lead a new [“biosecurity centre”](#) to evaluate the coronavirus threat and “enable rapid intervention.”

Additionally, the UK intelligence agency known as Government Communication Headquarters (GCHQ) was granted powers over the [NHS’s computer systems](#). GCHQ is known for engaging in illegal activities related to population control mechanisms such as [mass surveillance](#).

Totalitarian outcomes are further enabled with billionaire Peter Thiel's CIA-initiated company Palantir managing the databases used by both the CDC and UK's NHS that drive COVID-19 decision making.

For perspective, in 2009, Thiel said, *"I no longer believe that freedom and democracy are compatible,"* providing another clue that public health and awareness are not the main priorities behind the coronavirus scare.

The data behind the COVID-19 pandemic was never reliable, with test kits being inaccurate, government policies inflating the death counts, and the media focusing solely on fear-based predictions that are repeatedly proven false. Recently, scientists and government leaders from other countries, including Russia, Germany and Denmark, have begun speaking out about how the coronavirus threat has been exaggerated. Sweden proved to be an "odd man out" by their refusing to require their people to be "locked down".

The outcomes of the coronavirus scare have included huge windfalls for billionaires, financial institutions, and corporations. Legislation being passed in response to COVID-19 is largely beneficial to corporate interests. The outcomes for everyone else have been fear, unemployment, poverty, loss of freedoms, grave risks to democracy, and death.

How this is possible is related to the fact that governments, and the nations they represent, are no longer what they were. In many ways, corporations have replaced governments as the drivers of public policy and, as with Peter Thiel's Palantir, the public's interest is not their concern. Meanwhile, over two dozen companies have become larger and more powerful than many national governments.

As a result, governments are now false fronts for corporations and the decisions they make, for example to lockdown citizens and remake their economies are driven by profit-based strategies indifferent to public interests.

In summary, the features and outcomes of the Corona virus scare reflect those of previous psychological operations including the war on terrorism and its predecessor, the war on communism.

The people and agencies driving the Corona virus scare have a history of unethical behaviors, including hyping pandemics to push vaccines, and appear to seek long-term profits through implementation of a highly controlled society. Therefore, the response to COVID-19, if not the virus itself, can be seen as a psychological operation used to drive those outcomes.

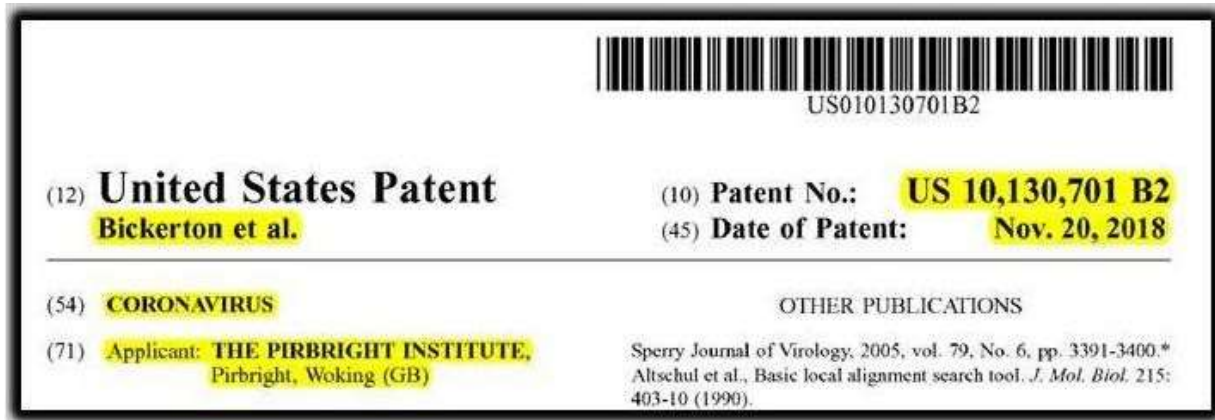

As head of [MI6](#) Sir Richard Dearlove was closely involved in the decision making that led to the wars in Afghanistan and Iraq. He was well aware that Iraq posed no threat and that evidence was being fabricated to support the case for war. On 23 July 2002, Richard Dearlove attended a meeting with senior British officials to discuss Britain's potential role in the invasion of [Iraq](#). Having met with George Tenet several days before, Dearlove said that during his visit he noticed a "perceptible shift in attitude. Bush wanted

to remove Saddam, through military action, justified by the conjunction of "terrorism" and [WMD]. But the intelligence and the facts were being fixed around the policy." Furthermore, he stated that Bush's [National Security Council](#) indicated it "*had no patience with the UN route, and no enthusiasm for publishing material on the Iraqi regime's record.*" He also noted that there "*was little discussion in Washington of the aftermath after military action.*"

On February 4, 2003 [George Tenet](#) called his [CIA](#) agent [Tyler Drumheller](#) at home and asked for Dearlove's phone number. Tenet wanted to get Dearlove's approval to use British intelligence in [Colin Powell](#)'s speech to the UN which was to take place the next day. According to Pulitzer prize-winning author Ron Suskind, that month Dearlove met with [Tenet](#) to brief him on intelligence acquired by MI6 from [Tahir Jalil Habbush](#). According to this intelligence, [Saddam Hussein](#) had ended his nuclear programme in 1991 — the same year that he destroyed his chemical weapons programme — and

ended his biological weapons programme in 1996. The Whitehouse buried the report and hid the [Habbush](#) information with the knowledge and acquiescence of Dearlove and MI6.



Sir Richard Dearlove has links to several key players involved in the Trump-Russia investigation, including Christopher Steele, Stefan Halper and Michael Flynn. Despite that, Dearlove, the former head of MI6, has largely avoided media scrutiny, or that of American lawmakers probing the origins of the Russia investigation. Dearlove's contacts with Steele, the dossier author, also have parallels to the former spy chief's links to another "dodgy dossier."

Despite the fact that Sir Richard Dearlove has been retired from MI6 for quite some time, he seems to be still very active playing a major role in the Queen's efforts to bring down President Trump. He is well-connected to the House of Rothschild, who chose to use the Corona virus release as a provocation for war with the two major economies of the world.



Sir Richard Dearlove has avoided scrutiny during the Russia probe, despite having links to several of the former spies, government informants and targets involved in the U.S. government's collusion investigation.

Sir Richard Dearlove, who served as chief of MI6 from 1999 to 2004, had contact during the 2016 campaign with dossier author Christopher Steele. He is also a close colleague of Stefan Halper, the alleged FBI and CIA informant who established contact with several Trump campaign advisers. Dearlove and Halper attended a Cambridge political event in July 2016 where Halper had his first contact with Trump campaign adviser Carter Page.

The retired British spymaster also hosted, along with Halper, an event at Cambridge in 2014 attended by Michael Flynn, who served at the time as director of the Defense Intelligence Agency. Dearlove and Halper are reported to have expressed concerns about Flynn's contacts at the event with Svetlana Lokhova, a Russia-born student at Cambridge. Those warnings were somehow shared with American intelligence.

Despite his presence at those key junctures, Dearlove has mostly dodged media attention, as well as that of American lawmakers investigating the origins of the Russia probe. That's perhaps a testament to Dearlove's 38 years in MI6.

Dearlove is best known internationally for his links to a dossier, though not the one authored by Steele, a former MI6 officer.

Dearlove was head of MI6 when the British government peddled a report alleging that Saddam Hussein had weapons of mass destruction. The British government, led by Prime Minister Tony Blair, used the dossier as a pretext to launch a war against Iraq.

Sir John Chilcot, who investigated the Iraq intelligence failures, faulted numerous British officials, including Dearlove, for failing to thoroughly vet the so-called “dodgy dossier” before endorsing it to other British government officials.

“Sir Richard Dearlove’s personal intervention, and its urgency, gave added weight to a report that had not been properly evaluated and would have colored the perception of ministers and senior officials. The report should have been treated with caution,” Chilcot said in his report, published in 2016.

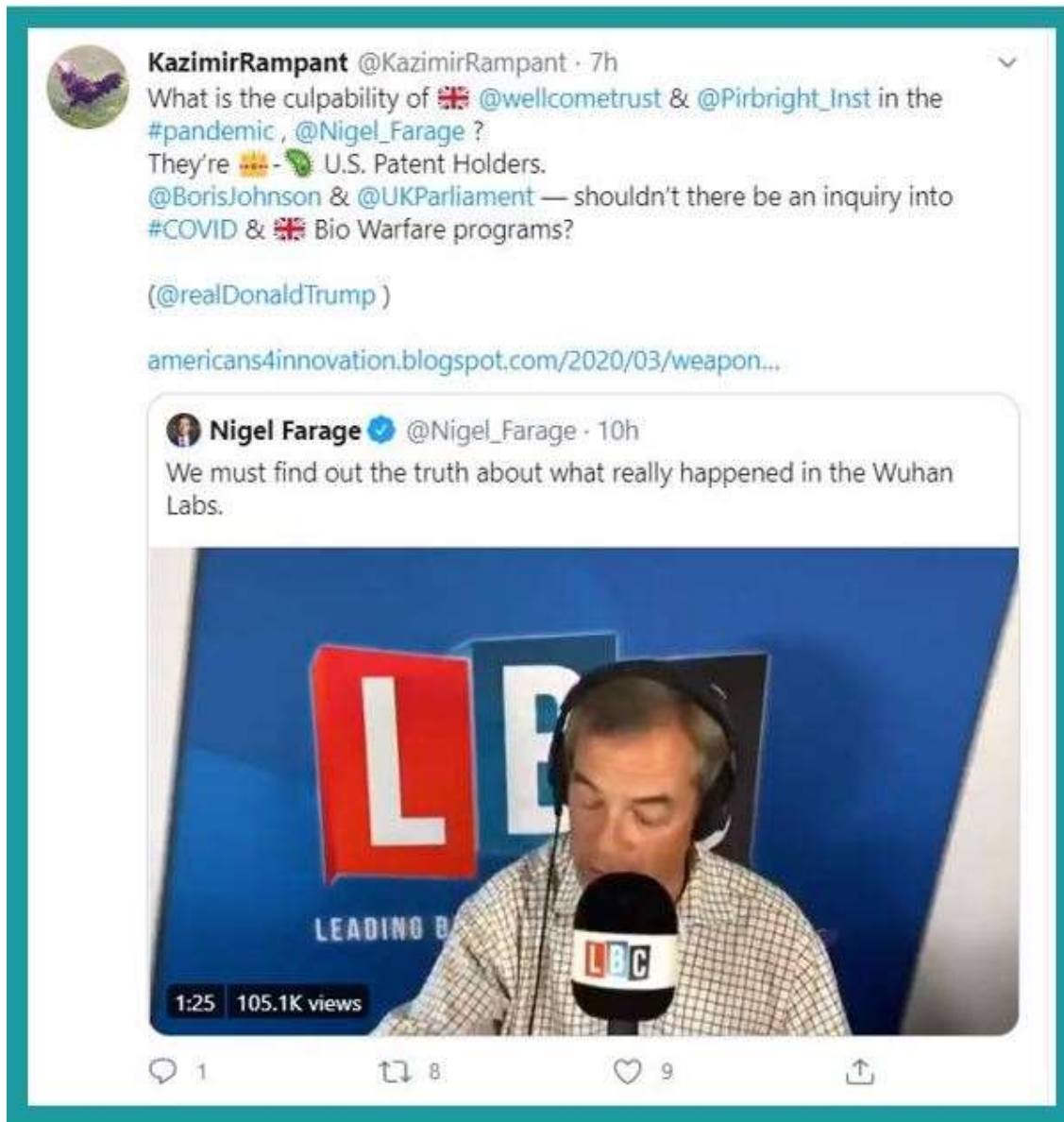
Despite those positive reviews of Steele, many of the ex-spy’s allegations have been undermined in recent months. Special counsel, and former FBI Director Robert Mueller found there was no collusion between the Trump campaign and Russian government. Sir Richard Dearlove appears to have been the Queen’s right-hand man in helping the Deep State DNC effort to the attempted removal of President Trump over the past three years.

Let the Anti-Defamation League of B'nai B'rith teach you how they have saddled 45 states with hate laws capable of persecuting Christians: The ADL, the JDL, and B'nai B'rith are deeply involved in the this phase of the global agenda to bring down the U.S., and are exploiting issues, racial discord and urging domestic terror and violence toward their end goal.

The B'nai B'rith masquerades as a “human rights” organization. In fact, they do not allow non-Jewish Freemasons to join.

The B'nai B'rith has no mandate to represent the Jewish people. Politicians fear the retaliation of these [B'nai B'rith, ADL, JDL] groups since they will fund and support opposition to a candidate for office that is unfriendly to the Zionist causes. SUBVERSION OF THE WEST

The B'nai B'rith-ADL is probably active in your city. It approaches local schools, private companies, and professional associations offering indoctrination in "diversity" and "hate crimes." It trains the local police in political crimes. "Hate" is anything or anyone that interferes with the world government agenda, partly listed on the ADL website.

The B'nai B'rith is part of the Masonic Scottish Rite Order established in 1843. Its militant arm, the "Anti-Defamation League" (ADL) was formed in 1913, the same year as the U.S. Federal Reserve.

8. America Coming Together: Soros gave nearly \$20 million to this 527 group with the express purpose of defeating President Bush. A massive get-out-the-vote effort, ACT door-to-door canvassing teams included numerous felons, its voter registration drives were riddled with fraud, and it handed out incendiary fliers and made misleading taped phone calls to voters. Call it — once again — under-the-radar influence.

Politico in 2018 described the process:

“Kevin Rodriguez, a 19-year-old aspiring singer in tight jeans and gray-and-white Nike high tops, had never heard of the powerful progressive donor group Democracy Alliance. But he is a key part of the secretive billionaire club’s plot to flip the Sun Belt. The donor clique, which counts George Soros and Tom Steyer among its members, is quietly giving funds to a handful of local grassroots groups like Rodriguez’s employer, Living United for Change in Arizona.”

It’s a strategy aimed at quietly taking down President Donald Trump, one “new voter in rapidly diversifying states across the southern U.S.” at a time, as Politico wrote. (...)

In Davos, he announced the infusion of \$1 billion into a new Open Society University Network to fund schools around the world — to “educate against nationalism,” is how the Financial Times reported it.

In other words: to train the next generation in the evils of sovereignty — to teach the emerging youth how to become good obedient citizens of the world.

There has never been a greater opportunity to deploy one vaccine against so many people. So it's certainly not out of line to consider a "dual use."

I have already covered the devastating effects of experimental RNA/DNA vaccine technologies—both of which could be launched with a COVID vaccine. Putting that aside for the moment, could the vaccine serve another purpose?

In this article, I raise questions. Questions about the potential covert use of nanotechnology in the COVID vaccine.

From lexico.com: nanotechnology: "The branch of technology that deals with dimensions and tolerances of less than 100 nanometers, especially the manipulation of individual atoms and molecules."

Are researchers interested in marrying nanotechnology and vaccines?

Here is a quote from *'Frontiers in Immunology'*, January 24, 2019, "Nanoparticle-Based Vaccines Against Respiratory Viruses": A new generation of vaccines based on nanoparticles has shown great potential to address most of the limitations of conventional and subunit vaccines. This is due to recent advances in chemical and biological engineering, which allow the design of nanoparticles with a precise control over the size, shape, functionality and surface properties, leading to enhanced antigen presentation and strong immunogenicity. This short review provides an overview of the advantages associated with the use of nanoparticles as vaccine delivery platforms to immunize against respiratory viruses..." [such as the purported COVID-19 virus?]

Here is another quote, also from *'Frontiers in Immunology'*, October 4, 2018, "Nanoparticle Vaccines Against Infectious Diseases": In the last several years, the use of nanoparticle-based vaccines has received a great attention to improve vaccine efficacy, immunization strategies, and targeted delivery to achieve desired immune responses at the cellular level...Nano-carriers composed of lipids, proteins, metals or polymers have already been used...This review article focuses on the applications of nano-carrier-based vaccine formulations and the strategies used for the functionalization of nanoparticles to accomplish efficient delivery of vaccines in order to induce desired host immunity against infectious diseases."

There can be no doubt that nanotechnology is, indeed, very much involved in cutting-edge vaccine research.

Now let's shift into another use of nanotech.

Here are astonishing quotes from the journal *'Nano Today'*, from a 2019 paper titled: "Nanowire probes could drive high-resolution brain-machine interfaces." Its authors are Chinese and American:

"...advances can enable investigations of dynamics in the brain [through nano-sensor-implants] and drive the development of new brain-machine interfaces with unprecedented resolution and precision."

"...output electrical signals of brain activity or input electrical stimuli to modulate brain activity in concert with external machines, including computer processors and prosthetics, for human enhancement..."

Aside from research into prosthetics and, perhaps, the reversal of certain paralyses, this avenue of investigation also suggests "modulation" of the brain remotely connected to machines, for the purpose of control.

Modulation...such as control of basic thought-impulses, sensations, emotions?

ONE: Nano-sensors, implanted in the body and brain, would issue real time data-reports on body/brain functioning to ops centers.

TWO: And from those ops centers, data—including instructions—would be sent back to the nano-sensors, which would impose those instructions on the brain and body.

If this seems impossible, consider nanotech research aimed at improving the use of prosthetics. In that field, imposing instructions on the body/brain appears to be the whole point.

The question is: how far along the road of development is this technology? I can only say we are seeing the public published face of nanotech. What lies behind it, in secret research, is a matter for estimation and speculation.

I offer one speculation: the "promotion" of the social agenda of collectivist thought, through nanotech. Utilizing the Internet of Things, an attempt would be made to hook up and "harmonize" many, many brains with one another. Same basic feelings, same impulses—shared.

Who would be interested in such a program? Think Chinese government, DARPA (the technology arm of the Pentagon), and numerous other international actors. Think Rockefeller medical researchers. Think technocracy and Brave New World.

SUPPOSE, THROUGH A COVID VACCINE, NANOTECH COULD BE INSERTED INTO BODIES AND BRAINS OF THE GLOBAL POPULATION? As a grand control "experiment." Is that too far-out an idea?

Here is an interesting quote from a 3/11/20 S&P Global article, “Early-stage nanotechnology poised for ‘inflection point’”:

“One of the most pressing global healthcare challenges in 2020 is the coronavirus outbreak and Moderna Inc....is on the front line of vaccine development for this new biological threat.”

“Moderna’s nanoparticle-driven science uses genetic engineering to trigger cells to create proteins that prevent certain infections. Its vaccines for Zika virus and influenza have already progressed to early clinical stages...”

If Moderna’s COVID vaccine is indeed using nanoparticles, I have not seen this mentioned in current press reports.

The S&P Global article states, *“One of the leaders in the field of biological nanotech engineering is Massachusetts Institute of Technology professor Robert Langer, who has helped found about 40 companies based on technology created and developed in his Langer Lab...Moderna Inc., one of the companies Langer helped found...”*

Does Moderna’s COVID vaccine use nanoparticles? If so, what can these particles actually do? These are pressing questions that need to be answered.

I offer two backgrounders I wrote several months ago. They involve the flood of highly significant scientific research across borders.

BACKGROUND ONE: Behind the explosive Charles Lieber nanotech scandal. Once upon a time, they called it espionage. Then they called it “illegal technology transfer.” Then they casually and admiringly called it Globalism.

Imagine this.

A cutting-edge technology, which has applications for weaponry, transportation, medicine, artificial intelligence, surveillance, mind control...is being openly shared between the US and China. And by implication, who knows how many other nations?

As just one example, tiny sensors would, up the road, be placed inside the human body. These sensors would automatically monitor and report thousands of changes, in real time, in the body—as a way of diagnosing diseases.

The sensors will transmit all this information, through the emerging Internet of Things—using the 5G pipeline — to medical centers — where AI corporate and government analysts will make the disease diagnoses and prescribe treatments.

Eventually, a few billion people (patients) would, through these sensors in their bodies, be hooked up to the 5G Internet of Things.

—HOWEVER, as I’ve reported many times in these pages, the standard definitions of diseases and disorders are often incorrect, or even invented. But because the future

system I've just sketched is automated, the patient is enclosed in a fake and dangerous bubble. Among other problems, the disease treatments, the drugs and vaccines, are toxic.

What is the technology that is on the way to producing these body sensors?

Nanoscience. Nano-engineering

One of the leading nanoscience researchers in the world was recently arrested on a charge of concealing his connections to China.

Major US science star busted by the feds.

Dr. Charles Lieber, now suspended by Harvard, is the University's chairman of the chemistry department.

I have read two articles from a foreign news outlet headlined with the claim that Lieber stole and smuggled the "new coronavirus" from the US to China. In both cases, the text of the articles mentioned nothing about such a theft. I'm not writing this article about "coronavirus." I've been writing many articles rejecting the premise of an "epidemic" caused by the "virus."

I decided to look into this situation, because Dr. Lieber does apparently have big-time connections to China. Sharing research on his specialty, nanoscience, with China would be one more case of "technology transfer."

Bloomberg News, February 12, 2020: "Lieber's arrest on Jan. 28 came in connection with his dealings in China. He hasn't been charged with any type of economic espionage, intellectual-property theft, or export violations. Instead, he's accused of lying to U.S. Department of Defense investigators about his work with the People's Republic..."

"...by targeting Lieber, the chairman of Harvard's chemistry department and a veritable ivory tower blue blood, prosecutors struck at the crimson heart of the academic elite, raising fears that globalism, when it comes to doing science with China, is being criminalized."

"According to a government affidavit, signed by a Federal Bureau of Investigation agent named Robert Plumb, Lieber signed at least three agreements with Wuhan Technology University, or WUT, in central China. These included a contract with the state-sponsored Thousand Talents Plan—an effort by Beijing to attract mostly expatriate [Chinese] researchers and their know-how back home—worth a total of about \$653,000 a year in pay [to Lieber] and living expenses for three years, plus \$1.74 million [to

Lieber] to support a new 'Harvard-WUT Nano Key Lab' in Wuhan. The government offered no evidence that Lieber actually received those sums... Lieber also deceived Harvard about his China contracts, the [federal] affidavit said.”

“Whatever extracurricular arrangements Lieber may have had in China, his Harvard lab was a paragon of U.S.-China collaboration. He relied on a pipeline of China’s brightest Ph.D. students and postdocs, often more than a dozen at a time, to produce prize-winning research on the revolutionary potential of so-called nanowires in biomedical implants. Dozens of Lieber’s 100 or so former lab members from China have chosen to stay in the U.S. Many now lead their own nanoscience labs at top universities, including Duke, Georgia Tech, MIT, Stanford, University of California at Berkeley, and UCLA.”

I'd say that's a pretty big technology-transfer WOW right there.

“In the 1990s and 2000s, as Lieber’s achievements and stature were taking off, U.S. research institutions and grant makers pumped money and moral support into expanding the burgeoning collaborations between scientists in the U.S. and other countries, particularly China. The new paradigm was globalization, China was an emerging economic power, and Lieber’s lab became an exemplar of pan-Pacific collaboration. “

Another WOW. Not a leak of information. A flood!

“A more controversial Lieber protégé is Liqiang Mai, the international dean and chair of materials science at WUT, the little-known school in Wuhan that prosecutors allege recruited Lieber to be a 'strategic scientist' in 2011, for \$50,000 a month. Mai, who hasn't been named in any U.S. filings against Lieber, earned a doctorate at WUT in 2004 and worked as a postdoc in Lieber’s lab from 2008 to 2011, according to Mai’s WUT online bio....”

How big a star is Lieber? Wikipedia: “Charles M. Lieber (born 1959) is an American chemist and pioneer in the field of nanoscience and nanotechnology. In 2011, Lieber was recognized by Thomson Reuters as the leading chemist in the world for the decade 2000-2010 based on the impact of his scientific publications. Lieber has published over 400 papers in peer-reviewed scientific journals and has edited and contributed to many books on nanoscience. He is the principal inventor on over fifty issued US patents and applications, and founded the nanotechnology company Nanosys in 2001 and Vista Therapeutics in 2007. He is known for his contributions to the synthesis, assembly and characterization of nanoscale materials and nanodevices, the application of nanoelectronic devices in biology, and as a mentor to numerous leaders in nanoscience. In 2012, Lieber was awarded Israel’s Wolf Prize in Chemistry.”

‘Chemistry and Engineering News’, January 28, 2020: “In addition, Lieber allegedly signed a contract that obligated Harvard to become part of a cooperative research program that allowed WUT [Chinese] scientists to visit the university up to two months each year. The [federal] complaint says he did not inform university officials of the agreement, which was for ‘advanced research and development of nano wire-based lithium-ion batteries with high performance for electric vehicles’.”

Another “technology transfer” of great value.

“...the NIH [US National Institutes of Health, a federal agency] asked Harvard about whether the university or Lieber failed to disclose his financial relationship with China. Lieber has been a principal investigator on at least three NIH grants totaling \$10 million since 2008. After interviewing Lieber, Harvard [incorrectly, supposedly based on Lieber’s statements] responded to the NIH that he [Lieber] had ‘no formal association with WUT [Wuhan Institute of Technology]’ and ‘is not and has never been a participant in’ the [Chinese] Thousand Talents program.”

NIH has strict regulations about its researchers disclosing their conflict-of-interest connections. The feds obviously believe Lieber has failed to report his China connections to NIH. This would become a factor in his prosecution.

Lieber was operating a robust center at Harvard: Lieber Research Group. Its focus is nanoscience and nanotechnology. So it’s natural to ask, what kind of research findings would be shared with China?

On the Group’s website, there is this, right off the bat: *“We are pioneering the interface between nanoelectronics and the life sciences...sensors for real-time disease detection...”*
