“As an American who grew up in the 1940s and 1950s I wonder what became of my country. We were a homogeneous Christian people proud of our history. We were unified with a common language, prayer in public schools, and monuments to dead white men. We were safe in our homes and schools, in our streets, and on public transportation. A five-year old child could walk to school safely. Public schools were good. Teachers had degrees in the subjects they taught, not in something called education. We looked to the future with optimism.

What happened to my country? It was torn apart by bitchy white liberals, by the influence of Jewish Marxists known as the Frankfort School, and by the 1965 immigration act that turned the United States into a Tower of Babel. These developments launched the denunciation and “unmasking” that branded America as “racist,” “exploitative,” and “misogynist.” Today our history is a compendium of crimes as the New York Times 1619 Project, now taught in public schools, illustrates.

Restitution set in, with the result being that white American citizens, especially heterosexual white males, have become second class citizens against whom it is legal to discriminate in university admissions, hiring, and promotion. White students and employees are also required to be re-educated in “sensitivity training,” but no other race has to be sensitive toward white people.

The family is routinely invaded by the state, especially the neo-Nazi Child Protective Services empowered to seize children from parents on accusation alone.

In the 1940s and 1950s no one would have tolerated any of this. What became of these Americans?

If it had happened all at once, it would have been stopped. But it happened gradually over time, with various wars and economic crises to pull people together and perpetuate the image of unity and constitutional principles. July 4 celebrations served the same purpose.

The destruction of America was an incremental process. As each decade passed a bit more of America eroded until today little is left.

In less than two years from February 2021 to October 2022, President Biden allowed 1.4 million immigrant-invaders to walk across the US border with Mexico. These immigrant-invaders were given work permits while they await their green cards giving permanent residency. How far our country has collapsed! An immigrant-invader can walk across the border, get a job as a police officer, and arrest you, especially if you are a Trump supporter who wanted a wall built to keep him out.

This is bad, but it gets worse. Increasingly I see reports that Democrat states, such as California and New York, are allowing non-citizens to vote in elections. As far as I can tell the voting is limited to local elections, as the blue cities cannot override state and federal voting requirements. But the same collapse that results in non-citizens voting in local elections will manifest itself, eventually legally, not just fraudulently as present, in state and federal elections.

So, what does it mean any longer to be an American citizen? The Democrats permit millions of people to come into your country where they displace you by exercising your rights of citizenship without being citizens.

Don't expect white leadership to do anything about it. White leadership has collapsed across the board in every country. Take something as simple as the Brownies, the female equivalent of the Cub Scouts, the organizations for younger kids before becoming Girl Scouts and Boy Scouts.

It is the who's who of the most radical globalists descend upon the picturesque ski resort town of Davos, Switzerland for the World Economic Forum (WEF) annual meeting, up to 5,000 soldiers from the Swiss army will be deployed to offer military support to the civil authorities of the canton of Graubünden, who are responsible for securing the summit's premises and its participants.

In a statement released Friday, January 6th, the Swiss Defense Department (VBS) said that the Federal Assembly, the country's parliament, had approved the deployment of the Swiss army contingent to ensure the security of thousands of participants, the Swiss German-language newspaper '*Blick*' reports. This year's deployment is part of a three-

year commitment, from 2022 to 2024, by Parliament to support these high profile civic activities.

This plan of Mass Murder has been presented in today's article posted at the web site '*State of the Nation*' on January 14, 2023, which I share below.

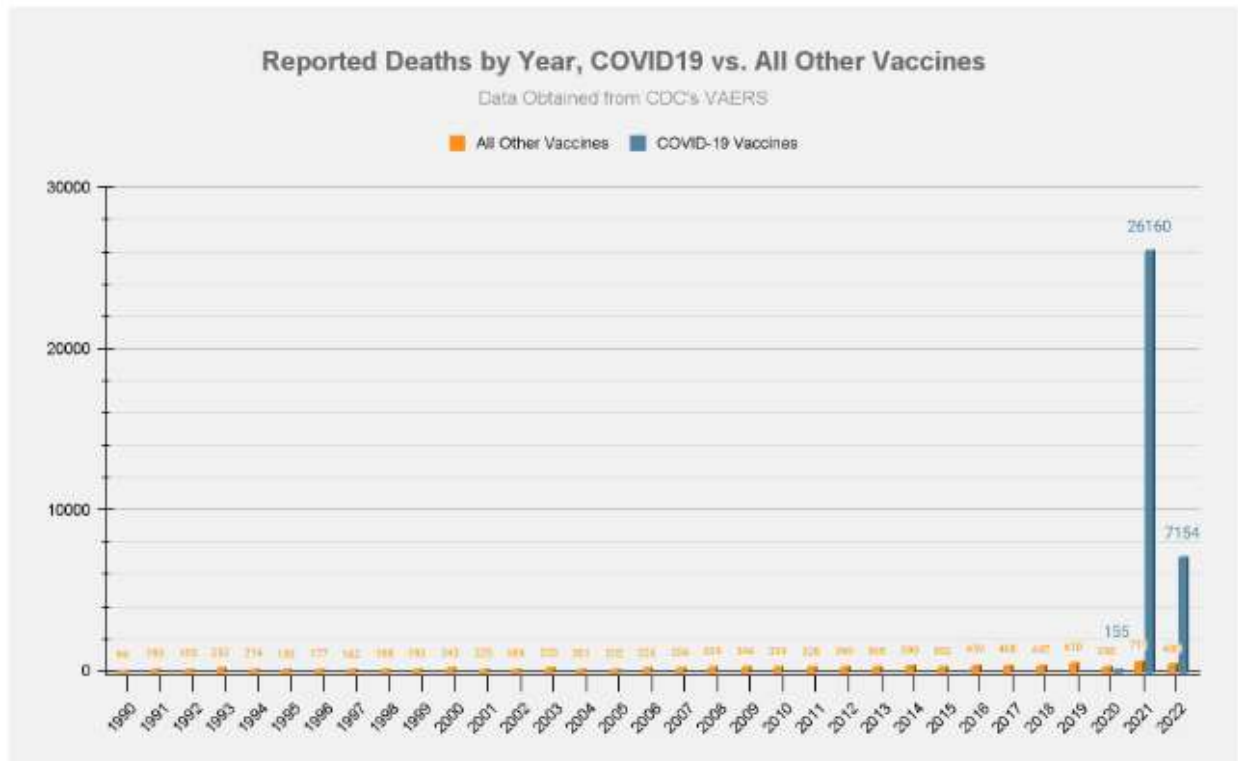

There are years of documents, contracts, research, experiments, that confirm without question that the U.S. military-government-industrial-health complex is waging a war against its own citizens. 5th-Gen Warfare Terms and Tactics

"The deliberate manipulation of an observer's context in order to achieve a desired outcome."

Dr. Robert W. Malone posted an op-ed piece that perfectly spells out what you and I are facing.

"The basic idea behind this term [fifth-generation warfare] is that in the modern era, wars are not fought by armies or guerrillas, but in the minds of common citizens."

So, what is fifth generation warfare and why does it matter?

5th-Gen warfare is an extension of Asymmetric and Insurgent Warfare strategies and tactics, whereby both conventional and unconventional military tactics and weapons are incorporated and deployed, including exploitation of political, religious and social causes. This new gradient of warfare uses the internet, social media and the 24 hour news cycle to change cognitive biases of individuals and/or organizations. It can be conducted by organized or unorganized (ergo decentralized) groups; it may be led by nation states, non-nation state actors and organizations, non-governmental organizations or even individuals. A key characteristic of 5th Gen warfare is that the nature of the attack is concealed. The goal is to disrupt and defeat opponents by creating new cognitive biases.

The most effective 5th Gen warfare strategies employed by those lacking integrity are not purely based on pushing false narratives, mis- or dis-information. The most effective

strategies mix truth with fiction, and act to increase confusion and disorder in the thoughts and minds of those being targeted, so that they are not sure what or whom to believe.

Some have written that the term 5th-Gen warfare should only be applied to those opponents with fewer resources (asymmetric warfare), but this is not consistent with current practice. Large and small governments, transnational corporations, globalist organizations as well as ordinary citizens have learned how effective the 5th-Gen toolkit is and have utilized 5th-Gen warfare tactics to their advantage.

Abbot's seminal "[Handbook of 5GW](#)", published in 2010, states that:

"The very nature of Fifth Generation Warfare is that it is difficult to define."

"Any sufficiently advanced technology is indistinguishable from magic -Arthur C. Clarke."

With this essay, Dr. Robert Malone, MD, MS says his goal is to give you the tools to both recognize 5th-Gen warfare tactics and to help the reader learn to use these tools for him or herself in surviving the *"information warfare"* you are being subjected to, and to begin to master these methods and become a warrior in the 5th Gen battles that lie ahead.

Just to be clear, the concept of 5th generation warfare as being traditional *"warfare"* is not accurate. When the term "war" is applied, the concept of a physical war as a battle for territory using kinetic weapons looms large. This is not the case with 5th-Gen warfare.

For my own use here, I find the term fifth-generation psyops as being perhaps more accurate for what is happening across the web. But 5th-gen warfare is the term people know, so there is. When a collaborative or synchronized 5th-Gen psyops program is being referred to, then I will use that term when appropriate.

There is also the small point that although "5GW" or 5G warfare is commonly used, this term can often confuse those first encountering 5th-Gen warfare terminology, who confuse 5th Gen warfare with **5G** technologies (cell phone tower tech). For this reason, I am going to try to avoid using "5GW" acronyms in the future.

This may all seem esoteric, but words and definitions matter.

The [5GW Hand book](#) goes on to define fifth generation warfare as:

- **A war of information and perception**
- **Targets existing cognitive biases of individuals and organizations**
- **Creates new cognitive biases**
- **Is different from classical warfare for the following reasons:**
 - **Focuses on the individual observer / decision maker**
 - **Is difficult or impossible to attribute**
 - **Nature of the attack is concealed**

The [Radio Research Group/grey dynamics](#) has developed an excellent example list of 5th-Gen warfare weapons, tactics, and technologies. I have expanded on that list and added definitions for the lay person.

- Misinformation (Data Driven)
 - Deepfakes (Deepfakes are synthetic media in which a person in an existing image or video is replaced with someone else's likeness. While the act of creating fake content is not new, deepfakes leverage powerful techniques from machine learning and artificial intelligence to manipulate or generate visual and audio content that can more easily deceive - Wiki)
- Cyberattacks
 - Honey pots (not the sexual entrapment kind)
- “Social engineering” (Social engineering is any manipulation technique that exploits human behavior and error in order to gain access to sensitive or confidential information. Where some scammers would steal someone’s personal information, social engineers convince their victims to willingly hand over the requested information like usernames and passwords.) “Nudge” technology is actually applied social engineering.
- Social media manipulation (Data Driven)
 - Decentralized and highly non-attributable psychological warfare (memes, fake news).
 - Controlled opposition, disruptors and chaos agents. Historically, these tactics involve a protest movement that is actually being led by government agents. Nearly all governments in history have employed this technique to trick and subdue their adversaries. However, in 5th-Gen warfare, controlled opposition often may come in the form of disruptors and chaos agents. Either “real” people or bots that generate outrageous claims that delegitimize a movement (examples currently may (or may not be); “snake venom in the water” or “everyone is going to die who took the vaccine within two years”. Another tactic is placing agents of chaos whose job is to basically disrupt organizations and events. This may also come in the form of “reporters” who assert fake or highly exaggerated news stories, and who most likely are funded by the opposition. “Undermine the order from the shadows ” is the tactic here.
- Mass surveillance
 - Open-source intelligence
 - Open-source intelligence (OSINT) is the collection and analysis of data gathered from open sources (covert and publicly available sources) to produce actionable intelligence.
 - Tracking surveillance software (such as COVID trackers and cell phone keyword searches).
 - Commercially available Social media analytics.
 - The use of publicly available raw data and surveys to sway public opinion by use of memes, essays and social media posts.

- Grey and dark market Data Sets (a grey market or dark market data set is the trading of information through distribution channels that are not authorized by the original manufacturer or trade mark proprietor).
- Commercially available Satellite / SA imagery
- Commercially available Electromagnetic intelligence
- Cryptographic backdoors (this is any method that allows an entity to bypass encryption and gain access to a system).
- Electronic warfare, with the rapid reduction in cost and availability thereof
 - Open source encryption/ DeFi (decentralized finance)
 - “Community technology (Community technology is the practice of synergizing the efforts of individuals, community technology centers and national organizations with federal policy initiatives around broadband, information access, education, and economic development” -[Wiki](#))
 - Low cost Radios
- Traditional protest tools combined with 5th-gen warfare. An example would be a large rally combined with social media tools to create synergy or opposition for a movement.
- The synergistic use of mixed media to build excitement or to create outrage.

So, although the list is extensive, the truth is that only a subset of these tools are available to poorly resourced individuals and groups. However, these groups may compensate for the deficit by leveraging popularism.

The good news is that some of the most effective 5th Gen warfare tools are the ones that cost the least. Decentralized and highly non-attributable psychological warfare and community synergy are two methods that can be utilized by individuals and groups to make a difference.

Asymmetric warfare is a conflict in which the opponents' resources are uneven. When it is the people against a government or governmental policy, the people have numbers behind them, but typically fewer technology, financial, and physical assets (vehicles, kinetic weapons, intelligence gathering capabilities). Late 20th (Viet Nam, for example) and current 21st century (Afghanistan et al) history of warfare clearly demonstrates that by coordinating their efforts, very effective asymmetric battlefield campaigns can be deployed.

Another recent example involves shifting the vaccine narrative to acknowledge that post-COVID vaccination myocarditis occurs in athletes and children. In the case of this example, when a new victim is identified, posts are shared both openly and via semi-private direct message to influencers, and the word spreads very quickly. These posts reach not only those who already believe that there is a problem, but those who are unaware. This is why social media has taken to extreme censorship over such posts and even direct messaging (and as now verified by many). Unfortunately, at the operational heart of these anti-free speech policies we often find agents of the U.S. government.

This tactic has also been utilized by the World Economic Forum - as they have enlisted almost 10,000 "*global shapers*," that is people under thirty to spread their messages of a new world order based on transnational corporations effective climate change solutions worldwide. The WEF program is failing because the messages are stagnant and often are not culturally aligned with the intended audience- they come across as "*fake*", contrived, and lacking integrity. In the fast paced news cycle of 5th-Gen warfare, the message must be seen as genuine, and to move as fast as the ever changing news stories and narrative. Understanding 5th-Gen warfare is critical is fighting effectively in this battlespace of minds, ideas and memes.

With a 5th-Gen warfare campaign, it is easy to change the target. Just follow the social media posts, news stories from alternative sources, trends and go! Anyone can play. Just be aware that a false flag operation often does more harm than good.

This is a big reason why once the U.S. government (or WHO, or WEF) identifies and censors messaging content, the message much change rapidly. The government goes after individuals to silence and defame because 5th-Gen warfare is working against the interests of the Administrative State and their allies. By taking away one's right to post, as well as licenses, political posts, etc., they are acting to block 5th-Gen campaigns.

The focus on decentralized action, of a leaderless battlespace, effectively forces the forces that seek to advance and insert a false narrative into susceptible minds to play "*whack-a-mole*", because there are too many autonomous actors or apparent "leaders". In this case, as one person is taken down, another rises. This is where being a "*shape shifter*" is adaptive. Be ready to change social media platforms, handles, email accounts, etc. This is how I survived and thrived when de-platformed from Twitter, Facebook and Linked-in and defamed by almost every single mainstream media corporation.

It can be helpful to keep a separate identity from your social media accounts. Use emails that aren't tied to your personal affairs for social media.

But we also have to be smart. Which is to say don't be stupid. For instance, don't play that quiz game based on your name and date of birth, don't respond to emails that need personal information, etc. No Nigerian Prince is going to send you millions of dollars. So learn to recognize pfishing and other strategies employed by con artists.

Challenge authority when it is wrong. Don't allow yourself to be bullied. Don't give up, and don't get depressed.

In this essay, I have intentionally not written about the battles ahead or what we are fighting for. Except to say that we all know that we are fighting for now is for our very sovereignty. For preventing ourselves and our children from becoming indentured servants to self-appointed centralized global masters of the Universe.

These are tools that are just too seductive for large entities not to use. Do not expect these tactics to stop. The digital spying will continue to be relentless. Our job is to understand the terrain, the tools and the tactics.

The term for 5th-Gen warfare is war. This is not a “nice” game, with rules that we all agree to. There are no rules in 5th-Gen warfare, only tactics and strategy. Nothing is “fair”, and your mind, thought, and emotions are the battlefield.

That said, I chose to have rules for myself, and expect those that I work with to adhere to these same rules.

I stand by my ethics. I don't lie. I don't cheat and I don't break the law. I seek to maintain personal integrity, and respect others, and act to heal and build community wherever I can. If I break these rules for myself, I will never be able to claim victory.

This is a war for my mind, your mind, our children's minds, and our collective minds.

Stay true.

Stay sovereign. Remain a patriot.

Don't be a victim. Be a 5th Gen warrior for truth, and for the sake of our children, and for their children.

Never forget, the **Truth is like a Lion**. Set it free, and let it defend itself.

Dr. Malone is a sharp guy, intelligent, but we cannot be completely sure that he is not acting as controlled opposition, and so it comes down to knowing them by their works as much as their words.

The mRNA vaccines have long been funded and researched before Trump was ever elected, and are partially owned by the government, according to official documents.

On May 15th, 2020, President Donald Trump and his administration launched [Operation Warp Speed \(OWS\)](#), a move that directed a slew of federal government divisions to devote time, money, and resources – in a public-private partnership – to rapidly develop “safe and effective” vaccines to prevent the transmission of Covid-19, along with distributing and administering them.

In a joint [explanation](#) by the Department of Health and Human Services (HHS) and the Department of Defense (DoD), the two federal departments further detailed the purpose of OWS:

Operation Warp Speed (OWS) aims to begin delivery of 300 million doses of a safe, effective vaccine for COVID-19 by January 2021, as part of a broader strategy to accelerate the development, manufacturing, and distribution of COVID-19 vaccines, therapeutics, and diagnostics (collectively known as countermeasures).

OWS will allow countermeasures such as a vaccine to be delivered to patients more rapidly while adhering to standards for safety and efficacy.

Rather than eliminating steps from traditional development timelines, steps will proceed simultaneously, such as starting manufacturing of vaccines and therapeutics at industrial scale well before the demonstration of efficacy and safety as happens normally. This increases the financial risk, but not the product risk.

And even though OWS was announced on May 15th, the government admits that they were already working with some pharmaceutical companies to develop a vaccine – including a \$483 million grant to Moderna on April 16th, and \$456 million in funds for Johnson & Johnson’s (Janssen) on March 30th.

However, it appears the Trump administration was already working with the pharmaceutical giant Moderna to create a mRNA vaccine before OWS was launched, and even before a single case of Covid-19 was reportedly confirmed in the United States.

On November 16th, 2020, roughly a few weeks before the first round of Americans were the first to get vaccinated, Donald Trump’s daughter Ivanka – a senior advisor for her father, and was also the director of the Office of Economic Initiatives and Entrepreneurship – made a statement on Twitter following Moderna’s announcement of the efficacy results of their shot.

In response to someone’s criticism of Donald Trump and the administration trying to take credit for the development of the vaccines, saying only Pfizer and Moderna should get the glory, Ivanka responded with this:

Fact Check: This Moderna/NIH vaccine is literally the one that President @realDonaldTrump partnered with Moderna to create on January 13, 2020... I repeat January 13th, 2020.

Just be happy. This is great news for America and for the world!



So apparently, taking Ivanka at her word, this seems to be a rather big fly in the ointment concerning the development of the mRNA vaccines; that the Trump administration was already aware of the mRNA tech, the development of the shots, and a partnership with Moderna that was already in place an entire week before the first purported case of Covid-19 was confirmed (January 20th, 2020).

However, many people did not seem to truly acknowledge and comprehend what Ivanka was admitting to, but rather blasted her and Donald for essentially knowing about the ‘threat’ of the virus but chose not to alert people sooner, attributing hundreds of thousands of deaths to Trump’s perceived carelessness.

“But these tweets and more are beside the point in the much grander scheme of it all: it means these vaccines were not developed at “warp speed” like the administration says it was.”

Howbeit the ‘WinePress’ had already reported that the Trump administration was already prepping for a “pandemic” in advance before 2020. In 2019 Donald Trump initiated what was called “Crimson Contagion:” a pandemic simulation event identical to the likes of the infamous Event 201 simulation, that prophesized a deadly and highly infectious “new coronavirus” to sweep the globe, where many of the measures practiced in advance came to pass.

This Crimson Contagion event ultimately culminated with President Trump signing an executive order on September 19th, 2019, to produce new influenza vaccines in conjunction with the same groups involved in OWS, *“to advance the development of new, broadly protective vaccine candidates that provide more effective and longer lasting immunities; and to support the promotion of increased influenza vaccine immunization across recommended populations,”* the executive order reads.

Furthermore, The ‘Wine Press’ documents that what would later become the \$6.2 trillion CARES Act Trump signed in late-March as the lockdowns commenced, was already drafted as early as January 24th, 2019, and was ready to be voted upon by the Senate in July, but was then picked-up in March of 2020.

But as concerning Ivanka’s statement, what she said is indeed true.

According to an official [press release](#) from Moderna, published on March 16th, 2020, they do confirm this partnership was legitimate.

The mRNA-1273 is an mRNA vaccine against SARS-CoV-2 encoding for a prefusion stabilized form of the Spike (S) protein, which was selected by Moderna in collaboration with investigators from the Vaccine Research Center (VRC) at the National Institute of Allergy and Infectious Diseases (NIAID), a part of NIH. Manufacture of the first clinical batch was funded by the Coalition for Epidemic Preparedness Innovations (CEPI).

On January 11, 2020, the Chinese authorities shared the genetic sequence of the novel coronavirus. On January 13, 2020 the VRC and Moderna's infectious disease research team finalized the sequence for the SARS-CoV-2 vaccine and Moderna mobilized toward clinical manufacture. The first clinical batch was completed on February 7, 2020 and underwent analytical testing; it was shipped on February 24, 2020 from Moderna and delivered to NIH from the Company's manufacturing facility in 42 days from sequence selection.

The company said in their press release, *"Moderna Announces First Participant Dosed in NIH-led Phase 1 Study of mRNA Vaccine (mRNA-1273) Against Novel Coronavirus"*.

However, be that as it may, the United States was already investing and aiding in research to develop and test mRNA tech well before Trump became President in 2017.

On September 7th, 2016, – the final months of the Obama administration – [Genetic Engineering & Biotechnology News \(GEN\)](#) reported that Moderna received a \$125 million grant from the Biomedical Advanced Research and Development Authority (BARDA) to develop an mRNA vaccine to protect against the Zika virus, a virus that is transmitted by mosquitoes.

Furthermore, GEN reported that Moderna had already received funding from the Defense Advanced Research Projects Agency (DARPA), along with the Bill & Melinda Gates Foundation. They also received \$474 million in equity financing from undisclosed *"existing institutional investors and world-class strategic pharmaceutical partners as well as participation of new institutional investors from the United States, Europe and Asia."*

We plan to initiate a Phase I study within the next several months. We believe our mRNA vaccine technology offers potential advantages in efficacy, speed of development, and production scalability and reliability, which may position Moderna as a leader in preparing for and responding to infectious disease threats, such as Zika. Moderna CEO Stéphane Bancel said in the statement.

These partnerships extend farther than that.

In a since-deleted [press release](#) on Moderna's website, October 2nd, 2013, the pharmaceutical giant revealed that they had received a \$25 Million grant from DARPA to develop the mRNA technology itself.

'(DARPA) has awarded the company up to \$25 million to research and develop its messenger RNA therapeutics™ platform as a rapid and reliable way to make antibody-producing drugs to protect against a wide range of known and unknown emerging infectious diseases and engineered biological threats,' Moderna said in the press release.

This grant is part of a DARPA program called ADEPT: PROTECT (Autonomous Diagnostics to Enable Prevention and Therapeutics: Prophylactic Options to Environmental and Contagious Threats). The goal is to develop platform technologies that can be deployed safely and rapidly to provide the U.S. population with near-immediate protection against emerging infectious diseases and engineered biological weapons, even in cases when the pathogen or infectious agent is unknown.

Moderna further explained,

We are honored to be chosen by DARPA for this important grant, which will greatly accelerate our efforts to develop antibody messenger RNA therapeutics™ to combat a wide range of infectious diseases.

We were awarded this major grant after an intense and rigorous scientific review, and it is a testament to our team's progress and to the profound implications of messenger RNA therapeutics™ that our work was funded. We look forward to further expanding the development of our platform into this critically important new therapeutic area.

Stéphane Bancel said

However, besides all of this, official government records indicate the federal government may actually own some of the rights to the mRNA, and do not necessarily need to rely on Moderna and others.

After combing through tons of [documents](#) that detail the government's involvement with mRNA and other coronavirus-related therapeutics, [Public Citizen](#) came to this conclusion:

The U.S. government may jointly own a potential coronavirus vaccine. The National Institutes of Health (NIH) has played a critical role in coronavirus research for years. Building off this work, federal scientists have helped design and test mRNA-1273—a vaccine candidate developed in partnership with Moderna.

The federal government has filed multiple patents covering mRNA-1273. In this report, we describe two patent applications that list federal scientists as co-inventors. If the government successfully pursued its patent filings, the resulting patents would likely confer significant rights. We also review recently disclosed contracts between NIH and

Moderna. The agreements suggest that NIH has not transferred its rights, but instead maintains a joint stake.

The U.S. government may jointly own a potential COVID-19 vaccine. At least two patent applications that appear essential to the vaccine name federal scientists as inventors, giving the U.S. government ownership if the patents are granted. Collaboration agreements also support the government's ownership stake in mRNA-1273.

Co-ownership provides significant rights. For example, assuming there were no other monopolies, the government could make, use, or sell the technology without the consent of Moderna. It could also license the technology to others, including other vaccine manufacturers or the World Health Organization, without the consent of Moderna.

Simply put: the United States has long since been working on and funding the development of the mRNA technology.

Multibillionaire philanthropist and investor Bill Gates, who has invested plenty of time and money into mRNA, has said that for the "next pandemic" there will be plenty of "mRNA factories" ready for it.

The Food and Drug Administration (FDA) no longer requires drugs to be tested on animals before moving to human trials, according to a provision in the omnibus spending bill recently signed by President Joe Biden.

The FDA Modernization Act 2.0, introduced by Republican Kentucky Senator Rand Paul, was signed into law December 29th and waives the requirement that drugs must be tested on animals for FDA approval. The FDA told NPR on Thursday it is now moving forward with implementing the provisions of the bill, including waiving the animal testing requirement. **By Senator Paul’s action we now know he has sold out to the government plan to exterminate the citizens of the U.S.A.!** The FDA has shown to be corrupt and dishonest at the least in the ongoing issue with Covid vaxxes. Senator

Rand Paul cannot deny the evidence and his co-sponsoring this bill confirms he can be bought at a price like any other politician in the government.

Companies can still opt to test drugs on animals before moving to human trials if they wish to do so. But the waiver of the requirement will allow them to explore alternatives that advocates say are more humane and potentially less expensive.

“This signals a radical shift in the way drugs and treatments are developed,” People for the Ethical Treatment of Animals (PETA) said in a statement. *“The U.S. Food and Drug Administration (FDA) will be allowed to consider superior, non-animal drug testing methods, instead of requiring deadly and scientifically bogus animal tests.”*

The issue brought unlikely allies together, with PETA praising the conservative firebrand Senator Paul (traitor) for introducing the legislation alongside Democratic New Jersey Sen. Cory Booker.

“The inclusion of this bipartisan effort is a step toward ending the needless suffering and death of animal test subjects – which I’m glad both Republicans and Democrats can agree needs to end,” Paul said.

Rand Paul has been a leading advocate in Congress against government spending on, and requirements for, animal testing. He was also praised by Wayne Pacelle, president of Animal Wellness Action and the Center for a Human Economy. *“The FDA Modernization Act 2.0, to eliminate an archaic and debilitating government mandate for animal testing of experimental drugs, simply would not have become law without Rand Paul’s leadership, persistence, and medical background,”* Pacelle said.

Taxpayers bankroll roughly \$20 billion worth of animal testing per year, according to government watchdog group White Coat Waste Project.

Is there evidence that the SARS-CoV-2 'virus' requires electrophoresis mRNA technology to infect humans and produce spike proteins? Electrophoresis is the movement of charged particles in a fluid or gel under the influence of an electric field.

The progeny (or virions) are the SARS-CoV-2 and the WIV1-CoV spike proteins.

WIV1-CoV is the mRNA code merged with/encapsulated in 'lipid' nanotechnology to produce a more pathogenic spike protein (prefusion spike WIV1-2SP) than the virions of the original SARS-CoV-2 sequence. It would have been helpful if Dr. Andrew Huff from EcoHealth Alliance had explained this as well as the role of the lipid nanotechnology (mRNA electrophoresis) in his testimony submitted to the Senate.

Not only is it clear that electrophoresis is required for mRNA sequences ('synthetic RNA viruses') to infect cells from Dr. Baric's PNAS publication, it is also clearly stated in PFIZER's BLA (biological license application), approved by the FDA on August 23, 2021 the mRNA is a code for the spike protein.

Per PFIZER's FDA-approved BLA, PFIZER states that, *"The mRNA in COMIRNATY is.....encoding the full- length SARS-CoV-2 spike glycoprotein derived from the Wuhan-Hu-1 (WIV1) isolate...RNA sequence is codon- optimized and contains two proline mutations (2P)... which ensures....optimal trimerized pre-fusion confirmation (S-2P)."*

"The mRNA in COMIRNATY encodes for the SARS-CoV-2 spike glycoprotein, WIV1-2SP." - PFIZER's FDA BLA Submission for FDA Approval, FDA-approved on August 23, 2021

At a very basic level the 'spike proteins' that are produced by SARS-COV-2 mRNA and WIV1-CoV RNA are the bioweapons that originally caused COVID-19. However, the 'COVID-19 spike proteins' are only one element of the Ai bioweapons that are causing disease, disabilities and death across America and around the globe.

COMIRNATY mRNA vaccines (including boosters) deliver these Ai bioweapons. The WIV1-S-2P spike protein bioweapon shares U.S. Patent 0061185 A1 with other CoV-S-2P spike protein bioweapons.
