\$1,000,000 to forecast Vaccine Misinformation narratives

On 20 October 2022, the CDC published a grant opportunity to develop a public health tool to predict the virility of vaccine misinformation narratives. The application closed a few days ago.

Yes, what follows is another example of our government and probably other countries as well are involved in trying to suppress, censor, and block truth from being revealed by calling it fake news.

The purpose of the \$1,000,000 grant is *"to conduct research to develop and pilot a predictive model and tool to aid...in identifying emerging vaccine misinformation about recommended vaccines, including COVID-19 vaccines, that is likely to spread and have a high potential for impacting vaccine confidence"*. It will enable public health agencies to identify misinformation before it spreads or impacts people's health decisions.

According to the proposal, evidence for the negative impact of misinformation continues to grow. Therefore, this proposal has the potential to impact the [Healthy People 2030](#) scheme by ensuring people get vaccinated. Healthy People 2030 sounds and looks suspiciously like something from Agenda 2030 but equally this might just be someone jumping on the bandwagon. However, one of the developmental objectives is to *"increase the proportion of immunization information systems that track adult immunizations across their lifespan"* which sounds a lot like vaccine passports. Maybe not but unfortunately these things need keeping an eye on these days.

The CDC estimates that “COVID-19 misinformation and disinformation caused \$50-\$300 million per day in additional medical costs, monetized lives lost and morbidity, and economic costs”. Therefore, they want this new tool to increase vaccination rates and disseminate accurate scientific messages.

There are 3 phases to successfully complete the proposal:

- Phase 1 – Develop a predictive model that identifies misinformation. To do this they will look at old data to find topics (such as vaccine safety and fertility), the types of people sharing this information and the relationship to societal concerns (e.g. personal liberty);
- Phase 2 – Develop a tool that can be used to priorities the response to misinformation.

- Phase 3 – Pilot and evaluate the tool (that can be used at federal, state, local, tribal and territorial public health agency levels)

Now, I'm all for getting rid of misinformation. In an ideal world I just want to be reading facts, more facts with a few more facts sprinkled on top. However, this isn't an ideal world and unfortunately, over the last few years, much of the misinformation has come from the CDC itself.

So a 'Minority Report' style system that will identify vaccine misinformation pre-crime and eliminate it before it can get out will only add to public distrust.

A Soviet-style public health propaganda set-up is not going to increase vaccine take-up. The only way to do that is to provide transparent data and allow hypotheses to formulate. These can quite easily be shut-down with accurate and open data.

What does increase vaccine hesitancy, is not having a truly independent body to analyse pharmaceutical data and then trying to bury that data for 75 years. Misinforming the public that they are going to die without a vaccine was the most harmful thing they could have done to trust in public health. Along with the suppression of adverse event signals, harms and deaths. However rare they may or may not be, by hiding just one of these causes the public to question what else is being hidden.

So I would like to claim the \$1,000,000 to reduce vaccine misinformation with the following steps:

- Firstly produce a product that actually does what it is supposed to do;
- Conduct proper trials that look at short, medium and long term risks;
- Create a truly independent body that not only analyses the data it's provided with but tests the products themselves;
- Remove propaganda such as '95% effective' or 'safe and effective';
- Don't conduct studies on how to manipulate the population into taking vaccines;
- Don't force anybody to take a vaccine (by use of the psychological techniques above or through vaccine passports);
- Don't use fear to convince people they are going to die without being vaccinated;
- Don't suppress safety-signals;
- Don't gaslight the vaccine injured or families with members killed by vaccines;
- Remove the product from the market as soon as any safety signals, injuries or deaths occur. Explain clearly and openly what has been found and why the product has been removed;
- Don't label anybody concerned about big pharma corruption or vaccine safety a conspiracy theorist or worse.

There you go. You don't need any fancy and expensive systems to get people vaccinated. Just follow the steps above. But unfortunately, if your product isn't up to scratch, you won't make any money. You can send my \$1,000,000 cheese in the post. Thanks.

So many calamities, quandaries, and mysteries swirl in the zeitgeist these days that life in the USA feels like swimming against a rising tide of poisoned guacamole. Nothing has been able to stop that green spewage from the political Left, especially as it desecrates our very language to turn everything up, down, and everything inside, outside. You end up drowning the consensus about reality under the muck. Now, finally, there are political forces gathering to oppose all this deliberate malice and deceit and they will need something like a fire-hose to clean the joint up.

The outstanding feature of this political illness has been the utter lack of accountability for gross insults against the public interest — that is, things that really matter. As Congresswoman Ilhan Omar once put it so obliquely, *"some people did some things."* Yes, people are at the bottom of all this mischief against the country and none of them have had to answer for any of it yet. Will it matter if they do?

It may not correct all the disasters of recent past years, but it may prevent more disasters ahead as the nation struggles with epic changes to the business model for running everything in this land. Some people will have to do a lot of things to straighten out our agenda.

Everyone is aware by now that the new Congress is assembling several committees to attempt just that. One is the aptly-named panel on the Weaponization of the Federal Government. That's an excellent name for it because the officials running the engines of state have carried out a war against the people. It is, after all, supposed to be a government of, by, and for the people, not a government against the people. Where to even start?

Former US attorney and chief-of-staff to the SecDef, Kash Patel, had a good idea: start with the latest insult to the country. Haul in the newly-appointed special counsel assigned to the *"Joe Biden"* purloined document scandal. His name is Robert Hur. He was a top aide to Deputy Attorney General Rod Rosenstein at the height of RussiaGate, and liaison to the Robert Mueller operation. Mr. Hur participated in filing falsified warrants based on Steele Dossier nonsense to the FISA court. He should have been accountable for that.

He's not fit to serve as any sort of legal arbiter in a national scandal. He was not appointed to shed any light on the issue, but to bury it under a load of procedural equestrian excrement, in particular, the dodge that questions about *"ongoing*

investigations” can’t be answered. Let’s disarm that weapon from the get-go. And why not appoint Mr. Patel chief counsel to the Weaponization of Government Committee?

Another person who must answer right away is CDC Director Rochelle Walensky because her agency is still aggressively pushing mRNA shots strongly implicated in causing injury and death among the American people. There are no more obvious weapons against the people than these deadly products retailed by Pfizer and Moderna. The government’s “*vaccination*” crusade has to stop ASAP. Not one more dose of the stuff should be given to anybody. An audit needs to be run on the CDC’s data base to determine exactly how it was manipulated to hide the facts about “*vaccine*” injuries and deaths.

The public should also hear why Ms. Walensky’s CDC promoted “*incentive payments*” to hospitals for each patient who died testing positive for Covid-19 (not necessarily from Covid-19). The payments per patient ranged wildly, state by state from \$18,000 (NJ) to a whopping \$471,000 (WVa). Why was that? The payments amounted to a bonanza for hospital administrators, who were incentivized not only to misattribute cause-of-death — the proverbial motorcycle crash victim who tests positive — but to let people die on ventilators.

The Weaponization of Government Committee might also subpoena FDA Commissioner Robert M. Califf and his two predecessors during the Covid-19 event, Janet Woodcock and Stephen Hahn. The country needs to hear what they knew about the operation that produced the “*vaccines*” with such astonishing speed — as if these products were somehow in development before Covid-19 even appeared on the scene. They also need to answer about the shenanigans behind the following: the fudged and expedited “*vaccine*” trials; the demonization and virtual outlawing of existing safe and effective FDA-approved drugs for early treatment, ivermectin, hydroxychloroquine and other meds; the promotion of toxic remdesivir as a primary therapy for C-19; and the initiation and extension (for three years) of an emergency use authorization that shielded the drug companies from liability while injuries and deaths mounted.

Obviously, there are many other channels of inquiry waiting to be explored in the government’s war against the people, especially the lingering questions about election interference and the official censorship of news. The excellent writer who goes by Sundance at The Last Refuge website made some capital suggestions for going forward with these inquiries: one is to rely primarily on witness testimony rather than on documents that federal officials will surely do everything possible to hide. Don’t turn this into a futile battle over the docs. Let’s just hear what the people-in-charge have to say.

Secondly — and this may be hard for many angry, injured people to swallow — immunize witnesses against prosecution, to give them no incentive to hide what they know, what actions they carried out, and who told them to do it. Give them this immunity, Sundance wrote, in the interest of maximum transparency — because punishment of these characters is less important than showing the people of this

country how far off the rails we have gone, and how to get back on. It may not be optimally satisfying, but it's an argument worth pondering.

Sasha Latypova joins Dr. Jane Ruby, first to quickly address ongoing [potentially defamatory statements from Karen Kingston](#), before moving on to discuss her investigations with specialists at the Enigma Group.

Dr. Jane Ruby is as aghast as I am at Karen Kingston's recent behavior. For nearly a week, Karen has guested on as many podcasts as possible and she has raged all over social media, tacitly accusing Sasha of promoting a PSYOP on behalf of Pfizer in order to demoralize and to discourage people from suing the pharmaceutical giant.

This is patently false. Sasha is not discouraging anyone from suing Pfizer but she does suggest that if you *only* go after Big Pharma, you're not going to stop the crimes against humanity or ensure the prosecution of all those responsible.

Karen puts the bulk of her [Substack posts](#) behind a paywall but she seems to be saying that Bad Pfizer defrauded the Poor Little U.S. Government, while Sasha and her collaborator, Katherine Watt are saying that Pfizer's DoD contract Federalized them and made them into a de facto government entity, which she believes explains why [they demanded that sovereign nations put up their military bases as collateral to them](#).

This might also explain why, when [Aaron Siri](#) was arguing in court to get the Pfizer clinical trial data released, which they wanted to hide for 75 years, Pfizer's lawyers weren't even present in court. It was Department of Justice lawyers representing Pfizer.

People asked why the DOJ was defending Pfizer's commercial interests. Could it be because the commercial interests weren't really Pfizer's, they were actually the U.S.

Government's?

Sasha and Dr. Jane talk about how the model for drug manufacturers to weather the storm of COVID class action lawsuits was created by Big Tobacco in the 1990s, culminating in the [1998 Master Settlement Agreement](#) between major tobacco companies and 46 state attorneys general.

Big Pharma has all the money in the world to pay massive settlements. In 2009, Pfizer paid out [\\$2.9 billion, the second largest pharmaceutical settlement in history](#). Nobody has gone to jail in these cases.

MEDICAL COUNTERMEASURES (MCMs) & OTAs

After the [FDA approved the Pfizer "vaccine"](#) in August of 2021, Sasha looked to see if it had been added to the [National Vaccine Injury Compensation Fund](#) – and she saw that it had not. She wondered why, because if it were an approved vaccine, it should've been on the list.

It was at this time that she discovered that the injections are technically being classified as "countermeasures" – not as "vaccines" – and when she also found a 2-page document advising that those injured by countermeasures must file within one year to receive ["countermeasure compensations"](#). She saw that only 40 such claims had ever been paid out, which meant that nobody knew about this and/or they didn't pay out.

The term, "countermeasure" appears all over Pfizer's contracts with the DoD – as well as in the PREP Act and in other laws that have surreptitiously effectuated [the legal dismemberment of the United States](#) over the past several decades, as charted by Katherine Watt.

In Pfizer's Other Transaction Authority contract ([OTA](#)) with the DoD, the term, "medical countermeasure" aka "MCM" refers to the injectables to be manufactured. Sasha says, "That's how I found the term, 'countermeasure'. It's extremely poorly-defined... typically, [countermeasures are] associated with weapons and that's because that's what the DoD orders."

In other words, the so-called "vaccines" were contracted using the same framework that the DoD uses to purchase weapons. Because that's what they are.

Through the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020, the American Rescue Plan Act of 2021 and other supplemental legislation, [over \\$4 trillion was distributed](#) among hundreds of companies (mostly pharmaceutical) to produce emergency products in response to the COVID-19 "pandemic", including PPE (masks, etc.), plus the bioweapon countermeasures being promoted as "vaccines".

[OTAs](#) enable the bypassing of regulations, the suspension of regulations and the maintaining of secrecy, including from other branches of the government.

She says these countermeasures are not normal pharmaceutical products and they're not regulated as such. The DoD can order them from private manufacturers and if they're administered under a Public Health Emergency and under Emergency Use Authorization, then they're not subject to pharmaceutical regulation.

This is why, when Pfizer was sued for committing fraud during their clinical trials, they claimed they weren't contracted to manufacture an FDA-regulated product and in their [Motion to Dismiss Brook Jackson's fraud lawsuit](#), Pfizer attached their OTA contract, saying in effect, that they had no obligation to conduct valid clinical trials, because the only goods and services they were providing to the US Government, according to their OTA contract were a "large scale manufacturing demonstration for a prototype".

While these contracts contain language about maintaining [Good Manufacturing Practices \(cGMP\)](#) and about obtaining FDA approval, Sasha says, "Those are just words for distraction. They have no enforcement power."

"When you get to the Scope of the contract, the Scope has an explicit clause, saying that the preclinical, the clinical trials and Good Manufacturing Practice compliance are out of the Scope of the contract and the Government explicitly is not paying for it. Meaning that the Government is not ordering it and there's no meaningful way to enforce those things."

And because there's no cGMP, there's no saying what's actually in the shots, which is also why they're called "large scale manufacturing demonstration for a prototype".

PFIZER'S SUPPLY CHAIN

Sasha has interviewed workers on Pfizer's assembly line and she's found that the operation is so compartmentalized, that they have no idea what they're doing.

Sasha says:

"The drug substance gets made in [Rentschler, in Germany](#) or [Puurs, Belgium](#), then it gets shipped in biobags to [Andover](#) or [Chesterfield](#) or [Kalamazoo](#) and those people mix it, without knowing what's in the biobag. They mix it and they make the finished product and then they ship it to another place – or either they fill-finish it in their own facility or they ship it to Kansas to fill-finish or some other supplier and the same thing goes for all of them."

"There are literally hundreds of suppliers all over the world and there's this cross-shipping and no traceability – and the entire supply chain is owned by DoD, so they can insert, at any time whatever they want."

"So, as you are aware of that Coast Guard case in Alaska...the DoD tried to pass a few batches or trays of this product – which is EUA – as ["FDA-approved"] Comirnaty®, to overcome the Service members' resistance, based on the fact that this is EUA and cannot be mandated. So they pretended, 'We have the real deal!' but the real deal came from an unlicensed plant, not licensed to do cGMP, so it couldn't be Comirnaty®. So they just literally mislabeled them and tried to pass them off – I assure you, they do this all the time."

"And also, CDC also put those FW series – I think it's like five batches of FW, so one of them was in Alaska – they put them on their list as if released in the United States but I have shipment information from Pfizer, right down to the zip codes and no Comirnaty® products have been shipped."

"So, those FW batches that CDC claims they released, they don't appear in the shipments and they don't appear in VAERS."

Just wow. Jaw-dropping fraud and villainy...

WHY IS THE GOVERNMENT TRYING TO KILL US?

Dr. Jane then asks Sasha why our government is trying to kill us and she answers that most of the employees at government agencies, like the FDA and at Pfizer are unaware of what they're participating in, although she suspects many are beginning to wake up.

She believes that those at the top are aware of what they're doing and that they've been captured by the Globalists, who openly discuss population control at venues such as the World Economic Forum, which is convening at Davos, Switzerland this week.

Sasha jokes that the Brandon Regime "can't run fast enough" in their desperation to make the [WHO's International Health Regulations \(IHR\)](#) legally-binding, which would formally codify the WHO's authority to arbitrarily declare pandemics and lockdowns.

She says that states need to look at this very carefully, in order to disrupt the economic depredations of the Globalists. She recommends that people visit [James Roguski's Substack](#) to familiarize themselves with the Fascist peril of the [WHO and their IHR](#) and what actions we can take to defeat these.

Whereas, back in 2020, the WHO issued "recommendations" and our CDC issued "recommendations" – and it was supposedly the overzealous school boards who masked the children – she says that in the next round, which the WHO will be implementing in months, they want to make the IHR legally-binding, not just recommendations. It would be a much more brutal execution of the same tyranny than what we experienced before, because the mandates would now be law and much harder to fight.

These Fascist, foreign encroachments into our law are unrelenting and she says that's why it's so important that we be proactive, speak up and write to our legislators, at all levels, because at every level, legislators and administrators have the power to interfere with this agenda.

WHY DID PFIZER WANT MILITARY BASES AS COLLATERAL?

Some may recall the crazy stories that came out in 2021 about Pfizer's secret contracts with various governments; how in the case of Argentina, [Pfizer demanded the nations' bank reserves, military bases and embassy buildings](#) as collateral against claims of vaccine damage from their citizens. Dr. Jane asks Sasha why Pfizer would want to own the military bases of countries all over the world?

Sasha directs people to a recent [Substack post from Katherine Watts](#) that deals with this topic. Watts explains how when people say "Pfizer", they think "*private pharmaceutical company*", however, in these contracts for COVID countermeasures, Pfizer is acting as a government entity.

Sasha explains:

"The Government kind of captured them, as they did with other companies that I mentioned for these COVID countermeasures. They're essentially a private business fused with the government, having government sovereign protection for their actions, as long as they follow orders from the Government..."

"So the ridiculousness of a private U.S. manufacturer going to a foreign sovereign government and telling them that, 'You will buy this. You cannot test it. You cannot ask questions. You will pay, regardless of whether we deliver or not. If your citizens are injured and sue you and win, then you pay and if you can't pay, you give us your military assets.'

"So, people were like, 'How insane is that?!' and 'Why would Pfizer want military assets?' Well, that's why. Because it's not Pfizer, as the private pharmaceutical company. It's Pfizer, as part of the U.S. Government. The U.S. Government wants those bases..."

"They felt that they had enough enforcement power to force 100+ countries in the world to suspend their national legislation, because it also says that, 'You cannot change your laws in the country to alter the liability issues, in regard to this contract.'

"So...a pharmaceutical company goes and dictates to all of these countries in the world, that they cannot practice their own legislative power. That's not Pfizer. That's the US Government!"

We saw similar levels of profound, systemic treason in the [Konnech "voting software" \(datamining\) case](#), which revealed that the CCP and the Chinese military

may already have the keys in their hands to the entire United States infrastructure, and to every moving part of our daily existence – with the support and the blessing of the U.S. Military and the Federal Government.

As has long been evident for those with the eyes to see, the U.S. Government and the U.S. military do not represent or defend the People of the U.S., they do the bidding of the central bankers; the Globalists.

FBI Has Gone Off the Rails

Importantly, we now have proof that the FBI has been acting as the key instigator and implementer of the government's illegal censorship of Americans' political and medical views. The agency has also, on a regular basis and for unknown purposes, asked Twitter to reveal the location of specific Twitter users, such as actor Billy Baldwin.

What's more, internal Department of Homeland Security (DHS) memos, emails and documents show the DHS has worked on expanding its influence over tech platforms for years, so, government censorship is not something that came about in response to the COVID crisis. Nor is the censorship limited to COVID or public health information in general.

Evidence shows the FBI has actively interfered in multiple elections — all while inventing the narrative that foreign nations were doing the interfering.¹ As noted by Sen. Josh Hawley, R-Mo., these kinds of activities are "the biggest threat to our constitutional democracy today."²

As just one example, we now know the FBI plotted to quench the Hunter Biden laptop story well before the first report about it was published. In collaboration with Twitter, Facebook and the Aspen Institute, the FBI held a tabletop exercise to practice the shaping of the media's coverage of a potential "hack and dump" operation involving Hunter Biden material.^{3,4} As reported by the New York Post:⁵

"[The] drill was put into practical use weeks later, when The Post broke the news about Hunter Biden's infamous laptop — which was either ignored or downplayed by most mainstream news outlets and suppressed by both Twitter and Facebook."

There's also evidence showing the FBI has been shielding Hunter Biden and working with social media to censor bad press about him as far back as 2018.⁶ That job was probably made easier by the fact that reportedly former FBI agents work at both Twitter and Facebook.

For example, Jim Baker spent three decades with the FBI before becoming Twitter's head lawyer,⁷ and Facebook employs no less than 115 "former" employees of the FBI, CIA, NSA and other intelligence agencies, most of who now work in Facebook's content moderation department.⁸

Twitter Paid to Censor Americans and Promote U.S. Propaganda

Disturbingly, we now also have evidence showing that while Twitter insisted it was cracking down on covert government propaganda accounts, they only tracked down and banned foreign government-affiliated propaganda while working hand in hand with the U.S. Department of Defense to aid U.S. intelligence agencies in their efforts to influence foreign governments using fake news, computerized deepfake videos and bots.⁹ As reported by The Intercept:¹⁰

"Behind the scenes, Twitter gave approval and special protection to the U.S. military's online psychological ops. Despite knowledge that Pentagon propaganda accounts used overt identities, Twitter did not suspend many for around two years or more. Some remain active ..."

In 2017 a U.S. Central Command (CENTCOM) official sent Twitter a list of 52 Arab language accounts 'we use to amplify certain messages.' The official asked for priority service for six accounts, verification for one and 'whitelist' abilities for the others." Whitelisted accounts have a "validated" status similar to that of the blue check mark, which ensures they are promoted in searches. These accounts also don't get shadow-banned or limited by other means. Adding insult to injury, the FBI has been using taxpayer dollars to pay Twitter for their censorship and propaganda services — more than \$3.4 million between October 2019 and February 2021 alone.¹¹

Congressional Members Involved in Censoring Americans

The FBI has not acted alone, however. Far from it. The Twitter files reveal members of Congress have a direct line to Twitter and have had accounts suspended on their behalf and content removed at their whim. As reported by [MSN](#):¹²

"... Taibbi ... reported that Twitter 'received an astonishing variety of requests from officials asking for individuals they didn't like to be banned.' An example he shared was one sent in November 2020 by [Rep. Adam] Schiff's office, who contacted Twitter hoping the tech giant would take action regarding 'alleged harassment from QAnon conspiracists' against Schiff's staff, including aide Sean Misko.

'Remove any and all content about Mr. Misko and other Committee staff from its service — to include quotes, retweets, and reactions to that content,' the request to Twitter read. 'Suspend the many accounts, including @GregRubini and @paulsperry, which have repeatedly promoted false QAnon conspiracies.'"

Other government leaders have been less clandestine in their censoring operations. [Sen. Elizabeth Warren](#), for example, wrote an open letter to Amazon demanding they ban my book, "The Truth About COVID-19."

Similarly, two state attorneys general, [Letitia James and William Tong, publicly threatened social media companies](#) with legal ramifications if they refused to censor the "Misinformation Dozen." [President Joe Biden also publicly called on social media platforms to ban my accounts](#). But it gets worse.

Government Has Been Weaponized Against the People

Discovery documents from a [lawsuit against the White House](#)¹³ filed by the attorneys general of Missouri and Louisiana (Eric Schmitt and Jeff Landry) show at least 67^{14,15} federal employees across more than a dozen agencies are engaged in these kinds of illegal censorship activities. Consultants from the strategic communications and marketing firm Reingold¹⁶ were also hired to manage the government's collusion with social media in this intentional effort to violate our Constitutional right to free speech.

A Look Inside the White House Censorship Machine

In a January 8, 2023, op-ed for The Wall Street Journal, Jenin Younes and Aaron Kheriaty reviewed a series of emails between White House digital media director Rob Flaherty and a Facebook executive, illustrating how the White House pressured the company to censor and remove vaccine content even though Facebook itself characterized the material as "often-true content."¹⁷

"Newly released documents show that the White House has played a major role in censoring Americans on social media. Email exchanges between Rob Flaherty ... and social-media executives prove the companies put COVID censorship policies in place in response to relentless, coercive pressure from the White House — not voluntarily." Flaherty also demanded Facebook limit the spread of viral content on WhatsApp, a private messaging app with broad reach among "immigrant communities and communities of color." In the end, Facebook acquiesced to all of Flaherty's demands to prevent the spread of vaccine hesitancy and control political speech. As noted by Younes and Kheriaty:¹⁸

"President Biden, press secretary Jen Psaki and Surgeon General Vivek Murthy ... publicly vowed to hold the platforms accountable if they didn't heighten censorship. On July 16, 2021, a reporter asked Mr. Biden [about] his 'message to platforms like Facebook.'"

He replied, 'They're killing people.' Mr. Biden later claimed he meant users, not platforms, were killing people. But the record shows Facebook itself was the target of the White House's pressure campaign."

White House Pressured Google and YouTube to Do Its Bidding

Flaherty also had Google in his crosshairs, and accused YouTube of "'funneling' people into vaccine hesitancy," adding that this concern was "shared at the highest (and I mean the highest) levels of the White House."

"These emails establish a clear pattern," Younes and Kheriaty write. "Mr. Flaherty, representing the White House, expresses anger at the companies' failure to censor COVID-related content to his satisfaction. The companies change their policies to address his demands. As a result, thousands of Americans were silenced for questioning government approved COVID narratives."

Two of the Missouri plaintiffs, Jay Bhattacharya and Martin Kulldorff, are epidemiologists whom multiple social-media platforms censored at the government's behest for expressing views that were scientifically well-founded but diverged from the government line — for instance, that children and adults with natural immunity from prior infection don't need COVID vaccines ...

The First Amendment bars government from engaging in viewpoint-based censorship. The state-action doctrine bars government from circumventing constitutional strictures by suborning private companies to accomplish forbidden ends indirectly.

Defenders of the government have fallen back on the claim that cooperation by the tech companies was voluntary, from which they conclude that the First Amendment isn't implicated. The reasoning is dubious, but even if it were valid, the premise has now been proved false.

The Flaherty emails demonstrate that the federal government unlawfully coerced the companies in an effort to ensure that Americans would be exposed only to state-approved information about COVID-19. As a result of that unconstitutional state action, Americans were given the false impression of a scientific 'consensus' on critically important issues around COVID-19."

Weaponization of Government Select Committee Impaneled

Taken together, the revelations from the Twitter files and this lawsuit clearly demonstrate that most, if not all, aspects of the U.S. government have been secretly weaponized to undermine and circumvent the Constitutional rights of the people. It's much more serious than what I thought at the beginning. ~ Matt Taibbi

As noted by Taibbi in his Fox News interview:

"This is not a partisan story. It's a story about the architecture of the intelligence community and law enforcement getting its hands on speech, and on the ability of people to communicate with one another through platforms like Twitter and Facebook. And they're doing this in a very profound way — it's much more serious than what I thought at the beginning ..."

While the danger we're in as a nation is far more dire than anyone suspected, there is some good news. A new select committee, chaired by Rep. Jim Jordan, has been launched to investigate the weaponization of government, the politicization of the FBI and the DOJ's investigation into and harassment of parents who spoke out against COVID mandates, critical race theory and the sexualization of their children at school board meetings. As reported by The Post Millennial:¹⁹

"This investigative panel will demand emails and correspondence between the Biden administration and big tech companies, and follows the massive revelations that came to light through the recent release of the Twitter files. Newly minted House Speaker Kevin McCarthy ... was asked to form the committee as part of the negotiations that brought him to power ..."

The probe into communications between tech giants and President Biden's aides will look for government pressure that could have resulted in censorship or harassment of conservatives — or squelching of debate on polarizing policies, including the CDC on COVID ..."

While it's likely that government personnel and agencies will try to ignore the committee's requests for information, the committee does have subpoena power, and hopefully will not be too timid to use it.

Unfortunately, since the GOP does not control the Senate, it's unlikely they'll be able to pass any new laws based on the committee's findings. That said, legislation to penalize government censorship has already been introduced, and you can help push it forward by asking your representatives to support it.

Support Legislation to Penalize Government Censorship

The Protecting Speech from Government Interference Act²⁰ (HR.8752), introduced by three Republican House Representatives on the House Oversight and Reform, Judiciary, and Commerce committees, including Jordan, is specifically aimed at preventing federal employees from using their positions to influence censorship decisions by tech platforms.

The bill would create restrictions to prevent federal employees from asking or encouraging private entities to censor private speech or otherwise discourage free speech, and impose penalties, including civil fines and disciplinary actions for government employees who facilitate social media censorship.

While the U.S. Constitution clearly forbids government censoring and restricting free speech, HR. 8752 could be a helpful enforcement tool — and we clearly need enforcement, seeing how more than a dozen agencies are flouting the Constitution and have done so for years. People might tend to think twice, though, when they know there's a personal price to pay.

WHEN Dominic Cummings testified before Parliament in June 2021 and he was asked about the UK Covid Vaccine taskforce, he said: 'What Bill Gates and people like that said to me and others at No 10 was, "You need to think of this much more like some of the classic programmes of the past – the Manhattan Project in World War Two or the Apollo programme – and build it all in parallel. Dr. Robert Kadlec, the Assistant Secretary for Preparedness and Response (ASPR) in the US Department of Health and Human Services (HSS) was a panelist. During the discussion Kadlec said, 'It's time to say "[Go big, or go home](#)" on this issue.' Covid-19 gave him just the opportunity to implement this Manhattan Project as appears to have been intended.

Kadlec founded the Biodefense Commission in 2014 when he was a consultant to one of its donors, the vaccine manufacturer [Emergent Biosolutions](#). The Hudson Institute, a think tank co-founded by Herman Kahn of the Rand Corporation, the pioneer of war gaming who was satirized as Dr. Strangelove in Stanley Kubrick's film of the same name, [is the Commission's fiscal sponsor](#).

On Wednesday December 4, 2019, the House Committee on Energy and Commerce held its annual hearing on US public health preparedness and response for seasonal and pandemic influenza. Testifying before it were [Dr. Anthony Fauci of the National Institute of Allergy and Infectious Diseases, Dr. Nancy Messonnier from the Centers for Disease Control \(CDC\), Dr. Peter Marks from the Food and Drug Administration \(FDA\) and Kadlec](#).

Seventy-six days earlier, on September 19, 2019, an Executive Order on Modernizing Influenza Vaccines in the United States to Promote National Security and Public Health had been signed by President Trump, directing the National Institutes of Health (NIH), the Biomedical Advanced Research and Development Authority (BARDA), the CDC and the FDA to 'accelerate the adoption of improved influenza vaccine technologies'. The Departments of Health and Human Services and the Department of Defense were to [propose a plan and a budget for this effort within 120 days](#), in other words, before January 17, 2020.

The White House said: 'Unfortunately, many of the vaccines we use today are produced overseas, using time-consuming, egg-based technology, which limits their effectiveness and makes production too slow to effectively combat a potential deadly influenza pandemic.'

Fauci may be the best known of the four witnesses but Kadlec is by far the most consequential. Kadlec, a retired US Air Force Colonel, and former Director of Biosecurity Policy in the George W Bush Administration, is the principal architect of 21st century US biosecurity policy. He said in his testimony: ['ASPR's mission is to save lives and protect Americans from 21st century health security threats.'](#)

As a member of Bush's Homeland Security Council he drafted the [2004 National Biodefense Policy](#) for the 21st Century. He was the instigator behind the 2004 Project

Bioshield Act that created a strategic national stockpile of anthrax and smallpox vaccines (manufactured by his Biodefense Commission's funders). In 2005, as staff director to Senator Richard Burr's Subcommittee on Bioterrorism, he drafted the 2006 Pandemics and All-Hazards Preparedness Act (PAHPA, pronounced 'Papa'). This act created the Biomedical Advanced Research and Development Authority (BARDA) and the Assistant Secretary of Preparedness and Response (ASPR) position. The ASPR controls the national stockpile of smallpox and anthrax vaccines and other public health emergency medical equipment such as ventilators. During emergencies this Assistant Secretary has expansive powers [enabling him or her to act as the single point of control coordinating national response](#). Kadlec was confirmed as ASPR in August 2017 after being recommended to President Trump by Senator Burr.

At the December 4, 2019 meeting of the House Committee on Energy and Commerce, Kadlec was asked what his department was doing to enhance American manufacturing capacity. He said: 'On the issue of vaccines alone, I think the key thing is, I can't go into the particulars but we're going to have an announcement here shortly that will indicate some investments domestically to expand some of our newer technologies for vaccine manufacturing and I think the key thing there is, we are actively pursuing this in accordance with the executive order.'

Fauci testified that pursuant to Trump's executive order his agency, the National Institute for Allergy and Infectious Disease (NIAID), was conducting and supporting research into new platform technologies including mRNA. Fauci said: 'State-of-the-art technologies could be used to develop universal influenza vaccines as well as [improve the speed and agility of influenza vaccine manufacturing](#).'

When Kadlec was asked what the benefits were to the American people of investing in platform technologies such as mRNA he said: 'The availability of such platform-based approaches would transform national preparedness against currently known threats as well as newly emerging threats in the future.' Citing the ASPR/BARDA funded development of a Zika vaccine made using mRNA technology he went on: '[This technology has promise as a rapid platform for a number of infectious diseases, including influenza and novel diseases that may emerge in the future](#).'

The Zika vaccine he referred to was being developed by Moderna, the US-based mRNA gene-therapy biotech. It didn't have an influenza vaccine in development but it was actively working with Fauci's NIAID to develop a 'jointly owned coronavirus vaccine'. A prototype of this vaccine was sent to Dr. Ralph Baric, the leading coronavirus expert who has worked collaboratively with Dr. Shi Zhengli of the Wuhan Institute of Virology, for animal testing on December 17, 2019.

Moderna's European rival BioNTech announced in August 2018 that it was in collaboration with Pfizer to develop an mRNA flu vaccine. It was aiming to move this from the preclinical stage to phase 1 trials by the end of 2020. Professor Dr. Ugur Sahin, co-founder and CEO of BioNTech said: 'A significant presence in infectious disease supports our goal of building a [global immunotherapy company that provides](#)

[more effective and precise immune-mediated approaches for the prevention and treatment of serious illnesses, such as the prevention of flu and the treatment of cancer.](#)

BioNTech diversified from developing cancer therapies – none of which was successfully licensed – into vaccines after a provision in a 2009 EU directive intended to enable genetic engineered viruses to be used in vaccines was identified in 2016 and interpreted by them and others as a regulatory loophole enabling gene therapies directed at infectious diseases to circumvent the more stringent and onerous Advance Medicines Clinical Trials protocols. In 2020, this flu vaccine research was pivoted to Covid vaccine research.

Using this regulatory back door, both the UK Medicines and Healthcare Regulatory Agency (MHRA) and the European Medicines Agency (EMA) evaluated BioNTech's mRNA Covid gene therapies as run-of-the-mill vaccines. The mRNA gene therapies contain no viruses; instead they genetically modify the recipient, reprogramming their cells to produce a protein from the virus that will stimulate their immune system to create a response against the virus, meaning the EU directive should not have been applicable.

During the launch of Coalition for Epidemic Preparedness Innovations (CEPI) at Davos in January 2017, Gates enthusiastically promoted mRNA vaccines. 'Now there's a new class of vaccine, DNA / RNA vaccine that we hope we can just change a small part of it, and so the manufacturing facility would already be there, the trials you would go through would be very quick. You would understand what end point, what correlate you want and so in an emergency, the regulators would understand what sort of protocol we're going to use,' said Gates.

'With Ebola we had a scientific challenge that these platforms weren't ready, we didn't understand which country, what type of indemnity, and so there was a lot of fumbling around. It's only by fixing those regulatory uncertainties and using these new platforms that we have a chance of getting that time to be less than a year.'

Gates's foundation took an equity stake in BioNTech ahead of its October 2019 US stock market launch. When he was asked in 2017 about the danger of these platform vaccines making people less well, he said: 'You are right that the safety threshold is really, really extremely high because we have to maintain the reputations of all the vaccines, convince parents in all these countries that these shots are really there to help your child out. Anything that you do to healthy people is going to have a tougher standard than, say, a new cancer drug, where if you don't have the new drug, the outcome is going to be quite negative.'

This tougher standard was soon forgotten. The Pfizer/BioNTech product was pushed into use by the UK Medicines and Healthcare Regulatory Authority (MHRA) on December 2, 2020 using a 'compassionate use' mechanism called a Temporary Use Authorization to bypass the European regulator during the last month that the UK was

under European Union law. MHRA reviewed only a few hundred pages of summary data, not the full dossier.

The FDA has a pathway for accelerated approval of [‘vaccines licensed in other countries with competent regulatory authorities.’](#) p21 Emergency Use Authorization of the Pfizer/BioNTech vaccine as provided for under the 2004 Project Bioshield Act quickly followed in the US on December 11, 2020 and the European Medicines Authority (EMA) fell into line on December 21. Kadlec’s long-desired Manhattan Project was now detonating.

As I said in the second part of this history by which a number of elements have been working at pulling off the Genocidal Extermination of humanity through asymmetrical warfare, deception, obfuscation, distraction, dis- and mis-information so as to keep the public in a fog. Yuval Noah Harari was interviewed on CBS 60-Minutes last October, 2021. This bone-chilling interview by Anderson Cooper, suddenly struck me as another case for big government’s excuse to use the ability of “Gene Editing” as their secret weapon to cull the world population; and I have got the transcript of that 60-Minutes segment, which follows. and for which everyone on the planet has now become a target of genocidal extermination. You have a bullseye on your back and this will tell you why so!

When Yuval Noah Harari published his first book, *‘Sapiens,’* in 2014 about the history of the human species, it became a global bestseller, and turned the little-known, Israeli history professor into one of the most popular writers and thinkers on the planet. But

when we met with Harari in Tel Aviv this summer, it wasn't our species' past that concerned him, it was our future. Harari believes we may be on the brink of creating not just a new, enhanced species of human, but an entirely new kind of being - one that is far more intelligent than we are. It sounds like science fiction, but Yuval Noah Harari says it's actually much more dangerous than that.



Anderson Cooper: *You said, "We are one of the last generations of Homo sapiens. Within a century or two, Earth will be dominated by entities that are more different from us than we are different from chimpanzees."*

Yuval Noah Harari: Yeah.

Anderson Cooper: *What the hell does that mean? That freaked me out.*

Yuval Noah Harari: *You know we will soon have the power to re-engineer our bodies and brains, whether it is with genetic engineering or by directly connecting brains to computers, or by creating completely non-organic entities, artificial intelligence which is not based at all on the organic body and the organic brain. And these technologies are developing at break-neck speed.*

Anderson Cooper: *If that is true, then it creates a whole other species.*

Yuval Noah Harari: *This is something which is way beyond just another species.*

Yuval Noah Harari is talking about the race to develop artificial intelligence, as well as other technologies like gene editing - that could one day enable parents to create smarter or more attractive children, and brain computer interfaces that could result in human/machine hybrids.

Anderson Cooper: *What does that do to a society? It seems like the rich will have access whereas others wouldn't.*

Yuval Noah Harari: *One of the dangers is that we will see in the coming decades a process of-- of s-- of-- greater inequality than in any previous time in history because for the first time, it will be real biological inequality. If the new technologies are available only to the rich or only to people from a certain country then Homo sapiens will split into different biological castes because they really have different bodies and-- and different abilities.*

Harari has spent the last few years lecturing and writing about what may lie ahead for humankind.

Harari at Davos in 2018: *In the coming generations we will learn how to engineer bodies and brains and minds.*

He has written two books about the challenges we face in the future -- "Homo Deus" and "21 Lessons for the 21st Century" -- which along with "Sapiens" have sold more than 35 million copies and been translated into 65 languages. His writings have been recommended by President Barack Obama, as well as tech moguls, Bill Gates, and Mark Zuckerberg.

Anderson Cooper: *You raise warnings about technology. You're also embraced by a lot of folks in Silicon Valley.*

Yuval Noah Harari: Yeah.

Anderson Cooper: *Isn't that sort of a contradiction?*

Yuval Noah Harari: *They are a bit afraid of their own power. That they have realized the immense influence they have over the world, over the course of evolution, really. And I think that spooks at least some of them. And that's a good thing. And this is why they are kind of to some extent open to listening.*

Anderson Cooper: *You started as a history professor. What do you call yourself now?*

Yuval Noah Harari: *I'm still a historian. But I think history is the study of change, not just the study of the past. But it covers the future as well.*

Harari got his Ph.D. in history at Oxford, and lives in Israel, where the past is still very present. He took us to an archeological site called Tel Gezer.

Harari says cities like this were only possible because about 70,000 years ago our species - Homo sapiens - experienced a cognitive change that helped us create language, which then made it possible for us to cooperate in large groups and drive Neanderthals and all other less cooperative human species into extinction.

Harari fears we are now the ones at risk of being dominated, by artificial intelligence.

Yuval Noah Harari: *Maybe the biggest thing that we are facing is really a kind of evolutionary divergence. For millions of years, intelligence and consciousness went together. Consciousness is the ability to feel things, like pain and pleasure and love and hate. Intelligence is the ability to solve problems. But computers or artificial intelligence, they don't have consciousness. They just have intelligence. They solve problems in a completely different way than us. Now in science fiction, it's often assumed that as computers will become more and more intelligent, they will inevitably also gain consciousness. But actually, it's-- it's much more frightening than that in a way they will be able to solve more and more problems better than us without having any consciousness, any feelings.*

Anderson Cooper: *And they will have power over us?*

Yuval Noah Harari: *They are already gaining power over us.*

Some lenders routinely use complex artificial intelligence algorithms to determine who qualifies for loans and global financial markets are moved by decisions made by machines analyzing huge amounts of data in ways even their programmers don't always understand.

Harari says the countries and companies that control the most data will in the future be the ones that control the world.

Yuval Noah Harari: *Today in the world, data is worth much more than money. Ten years ago, you had these big corporations paying billions and billions for WhatsApp, for Instagram. And people wondered, "Are they crazy? Why do they pay billions to get this application that doesn't produce any money?" And the reason why? Because it produced data.*

Anderson Cooper: *And data is the key?*

Yuval Noah Harari: *The world is increasingly kind of cut up into spheres of-- of data collection, of data harvesting. In the Cold War, you had the Iron Curtain. Now we have the Silicon Curtain between the USA and China. And where does the data go? California or does it go to Shenzhen and to Shanghai and to Beijing?*

Harari is concerned the pandemic has opened the door for more intrusive kinds of data collection, including biometric data.

Anderson Cooper: *What is biometric data?*

Yuval Noah Harari: *It's data about what's happening inside my body. What we have seen so far. It's corporations and governments collecting data about where we go, who we meet, what movies we watch. The next phase is surveillance going under our skin.*

Anderson Cooper: *I'm wearing a, like a tracker that tracks my heart rate, my sleep. I don't know where that information is going.*

Yuval Noah Harari: *You wear the KGB agent on your wrist willingly.*

Anderson Cooper: *And I think it's benefiting me.*

Yuval Noah Harari: *And it is benefiting you. I mean, the whole thing is that it's not just dystopian. It's also utopian. I mean, this kind of data can also enable us to create the best health care system in history. The question is what else is being done with that data? And who supervises it? Who regulates it?*

Earlier this year, the Israeli government gave its citizens' health data to Pfizer to get priority access to their vaccine. The data did not include individual citizens' identities.

Anderson Cooper: *So what does Pfizer want the data of all Israelis for?*

Yuval Noah Harari: *Because to develop new medicines, new treatments you need the medical data. Increasingly, that's the basis for how-- for medical research. It's not all bad.*

Harari has been criticized for pointing out problems without offering solutions, but he does have some ideas about how to limit the misuse of data.

Yuval Noah Harari: *One key rule is that if you get my data, the data should be used to help me and not to manipulate me. Another key rule, that whenever you increase surveillance of individuals you should simultaneously increase surveillance of the corporation and governments and the people at the top. And the third principle is that, never allow all the data to be concentrated in one place. That's the recipe for a dictatorship.*

Harari speaking at The Future of Education: Netflix tells us what to watch and Amazon tells us what to buy. Eventually within 10 or 20 or 30 years such algorithms could also tell you what to study at college and where to work and whom to marry and even whom to vote for.

Without greater regulation, Harari believes we are at risk of becoming what he calls "hacked humans."

Anderson Cooper: *What does that mean?*

Yuval Noah Harari: *To hack a human being is to get to know that person better than they know themselves. And based on that, to increasingly manipulate you This outside system, it has the potential to remember everything. Everything you ever did. And to analyze and find patterns in this data and to get a much better idea of who you really are. I came out as gay when I was 21. It should've been obvious to me when I was 15 that I'm gay. But something in the mind blocked it. Now, if you think about a teenager*

today, Facebook can know that they are gay or Amazon can know that they are gay long before they do just based on analyzing patterns.

Anderson Cooper: *And based on that, you can tell somebody's sexual orientation?*

Yuval Noah Harari: *Completely. And what does it mean if you live in Iran or if you live in Russia or in some other homophobic country and the police know that you are gay even before you know it?*

Anderson Cooper: *When people think about data they think about companies finding out what their likes and dislikes are but the data that you're talking about goes much deeper than that?*

Yuval Noah Harari: *Like, think in 20 years when the entire personal history of every journalist, every judge, every politician, and every military officer is held by somebody in Beijing or in Washington? Your ability to manipulate them is like nothing before in history.*

Harari lives outside Tel Aviv with his husband, Itzik Yahav. They have been together for nearly 20 years. It was Yahav who read Harari's lecture notes for a history course and convinced him to turn them into his first book – 'Sapiens.'

Itzik Yahav: *I read the lessons. I couldn't stop talking about it. For me, it was clear that it could be a huge bestseller.*

Yahav is now Harari's agent, and together they started a company called Sapienship. They are creating an interactive exhibit that will take visitors through the history of human evolution and challenge them to think about the future of mankind.

Harari also just published the second installment of a graphic novel based on 'Sapiens.' And he's teaching courses at Israel's Hebrew University in ethics and philosophy for computer scientists and bioengineers.

Harari teaching: *When people write code, they are reshaping politics and economics and ethics, and the structure of human society.*

Anderson Cooper: *When I think of coders and engineers, I don't think of philosophers and poets.*

Yuval Noah Harari: *It's not the case now, but it should be the case because they are increasingly solving philosophical and poetical riddles. If you're designing, you know, a self-driving car, so the self-driving car will need to make ethical decisions. Like suddenly, a kid jumps in front of the car. And the only way to-- to-- to prevent running over the kid is to swerve to the side and be hit by a truck. And your own-owner who is asleep in the backseat will-- might be killed. You need to tell the algorithm what to do in this situation. So you need to actually solve the philosophical question, who to kill."*

Last month the United Nations suggested a moratorium on artificial intelligence systems that seriously threaten human rights until safeguards are agreed upon, and advisers to President Biden are proposing what they call a "bill of rights" to guard against some of the new technologies. Harari says just as Homo sapiens learned to cooperate with each other many thousands of years ago, we need to cooperate now.

Yuval Noah Harari: Certainly. Now, we are at the point when we need global cooperation. You cannot regulate the explosive power of artificial intelligence on a national level. I'm not trying to kind of prophesy what will happen. I'm trying to warn people about the most dangerous possibilities, in the hope that we will do something in the present to prevent them.
