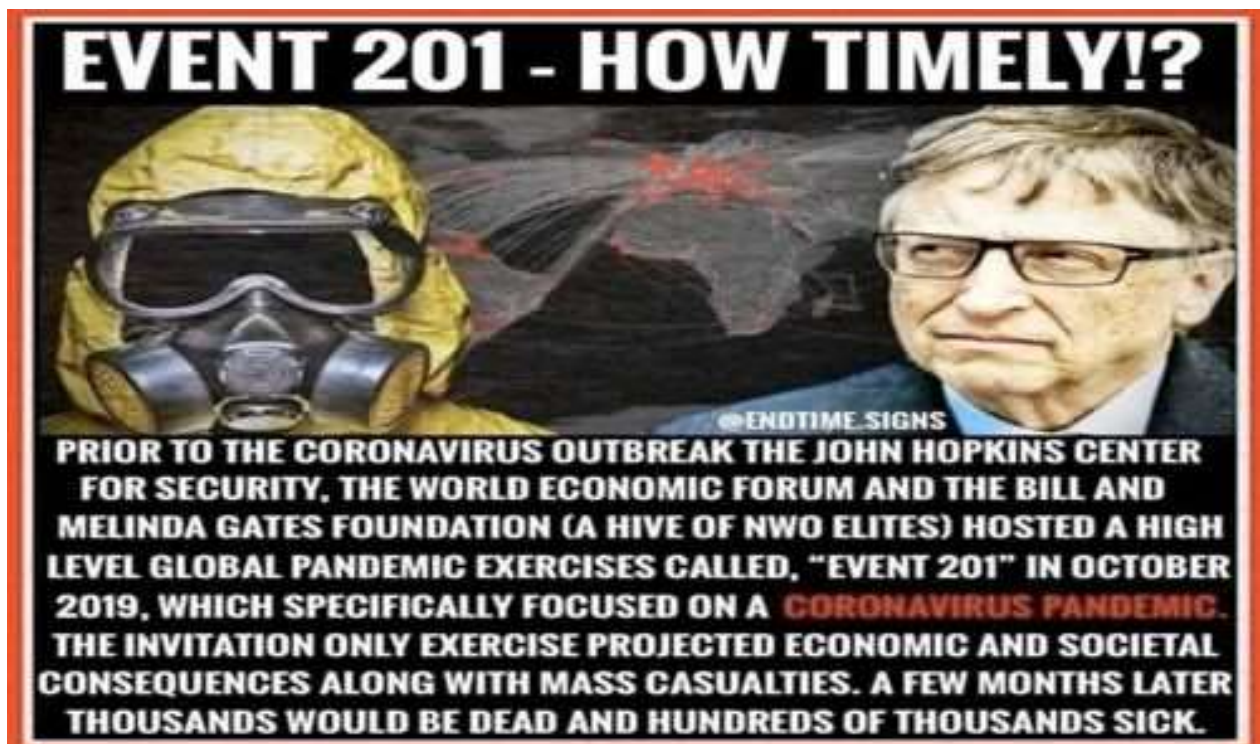

*A document drawn up by the Food and Drug Administration (FDA), listing the possible side-effects from a COVID-19 vaccine, includes strokes, encephalitis, auto-immune disease, birth defects, and Kawasaki disease among the potential side-effects to be monitored.*

*A slideshow presentation compiled by the FDA in October contains an extensive list of possible side effects which are to be monitored in conjunction with administering a COVID-19 vaccine. There is to be both passive and active surveillance of side effects related to the vaccine. Under the former system, the FDA is to partner with the Centers for Disease Control (CDC) to manage the Vaccine Adverse Event Reporting System (VAERS), whereby individuals report adverse side effects to their health care provider.*

#### Legal immunity for vaccine producers

*And due to a little-known federal law from the 1980s, pharmaceutical companies cannot be sued in court if their vaccines injure or kill someone. Instead, people injured or killed by vaccines (or their relatives) must use the National Vaccine Injury Compensation Program, which was created in 1986. It protects pharmaceutical companies from lawsuits related to vaccine injuries or deaths.*

*"It was created after lawsuits against vaccine companies and health care providers threatened to cause vaccine shortages and reduce U.S. vaccination rates, which they believed could cause a resurgence of vaccine preventable diseases," Children's Health Defense explains.*

While politifact and numerous mainstream news media stories have attempted to 'kill off' those claims, reporting that [alternative health websites are spreading false claims](#) about the vaccine, they also use 'Facebook fact checkers' in an attempt to debunk those claims, despite the FDA's own PDF listing those possible 'adverse effects' which we've embedded at the very bottom of this story.

Interestingly enough Robert F. Kennedy, Jr., counsel for the Children's Health Defense organization posted this report on the "Defender Page" on the same date. This report is most disturbing and anyone reading my articles on the pathogen ***Mycoplasma*** will see how simple it is for ***Mycoplasma*** to be introduced into the vaccine manufacturing process.

When the term Cancer Cells is mentioned, we are really talking about the precursor actually known as ***Mycoplasma***, the bacteriological pathogen that when activated, by internal as well as external factors, will be called Cancer. ***Mycoplasma*** has been the secret pathogen bioweapon of the U.S. military biological warfare, and public health agencies for more than seventy years has been an unspoken and unknown element which ultimately becomes consequential to the human body as aging occurs and labeled by many diseases and names introduced into the vocabulary of everyday people.

At least \$159-billion dollars a year are raised for cancer research and the FDA itself refuses to allow proven treatments to be administered in the United States for those with cancer. The FDA will prosecute with the full force of the FBI and any agency those who offer cancer therapy whether it be Laetrile (Vitamin B-17), or IV-Hydrogen-Peroxide, or IV-Vitamin D3 or IV-Vitamin C. These are legal in Mexico and many go to clinics in Mexico for treatment of Cancer. \$159-billion bucks is a hefty financial reason to persecute and block alternative proven cures. Whose interests are the FDA looking out for? Not the public as I read the literature!

Laetrile has been center stage among alternative cancer treatments and non-traditional medicine for decades. Government agencies have alternately described it as harmless, with nothing to offer patients beyond a positive placebo effect, and as dangerous, because of the cyanide that is part of its core components.

Advocates, on the other hand, point to a history of successful treatments, the lack of any proven toxic episodes, freedom of choice issues, and other factors as reasons why it should be legal and available. Lindsey Williams posted a video earlier this year about his trip to a clinic in Mexico to treat his problem, but undefined, and telling of his cure. I suspect he did not mention what his health issue was for legal reasons. None the less, the American Cancer Industry has had a free-reign in promoting its chemical and chemo-therapies at hefty prices. I have been told a single chemo package costs the doctor \$50K. In case you are not familiar with the name Lindsey Williams, he was the chaplain for the Alaska pipeline when it was built several decades ago. He also wrote the book, *'The Energy Non-Crisis'* in 1980.

The Cancer industry is not so much about a cure as much as it is in creating customers. This industry also helps to hide the truth about ***Mycoplasma***. So as much as the military want to keep secret their biological weapons program, in which they engineered and weaponized during the final days of WW2 and following; and, the American Cancer industry chooses to hide the secret of ***Mycoplasma*** which is the precursor to Cancer and many other diseases.

The present concerns people have over a vaccine for the alleged Covid-19 virus has brought us full circle to the total crime of what has been placed in vaccines since the days of the Salk/Sabin polio vaccines. Millions vaccinated for polio got an extra gift in the way of SV-40, which included cancerous cells from monkeys. SV40 stands for Simian Virus 40.

SV40 was the 40th virus found in Rhesus monkey kidney cells when these cells were used to make the polio vaccine. This virus contaminated both the Inactivated Polio Vaccine (IPV) created by Dr. Jonas Salk and the Oral or "Live" Polio Vaccine (OPV) created by Dr. Albert Sabin.

In 1961, SV40 was discovered by Dr. Bernice Eddy of the National Institute of Health; Division of Biologics when she took the material used to grow polio vaccines and injected it into hamsters. Tumors grew in the hamsters. Her discovery was subsequently validated by Drs. Maurice Hilliman and Benjamin Sweet of Merck.

Upon the discovery that SV40 was an animal carcinogen that had found its way into the polio vaccines, a new federal law was passed in 1961 that required that no vaccines contain this virus. However, this law did not require that SV40 contaminated vaccines be thrown away or that the contaminated seed material (used to make all polio vaccines for the next four decades) be discarded. As a result, known SV40 contaminated vaccines were injected into children up until 1963. In addition, it has been alleged that

there have been SV40-contaminated batches of oral polio vaccine administered to some children until the end of the 1990's.

Did the CDC admit 98 million Americans received the polio vaccine between 1955 and 1963 when it was "contaminated with cancer-causing virus 'SV 40'"? **No**, that mis-states what the public health agency said and over-states the number exposed to SV40. *"At most, millions of people were given a vaccine that was contaminated with "SV 40" but there is no evidence it caused cancer in the people who had received it who subsequently were diagnosed with cancer. In reports shared with the public, the U.S. Centers for Disease Control and Prevention explained 10% to 30% of 98 million polio vaccines administered those years were contaminated with "simian virus 40 (SV40)," and declared there was "no causal association between receipt of SV40-contaminated polio vaccine and development of cancer."*

As we look at the past, it has proven more than once that the CDC and other health agencies cannot be trusted. Blunders, mistakes, and perhaps intentions have provided us virtually little comfort to trust any health agency regarding the present or the future. Transparency has not been a forthright priority with the government when it comes to any of their poisons and alleged cures. If in doubt, I recommend the book by Dr. Vernon Coleman, a UK physician: *'Anyone Who Tells You Vaccines Are Safe and Effective is Lying'*. The report below provides more information about these poison soups people are supposed to trust!

The polio vaccines used in the late 1950s and early 1960s were contaminated with a virus called Simian virus 40 (SV40) present in monkey kidney cells used to grow the vaccine. Subsequently, investigators found SV40 DNA in biopsy specimens obtained from patients with cancers such as mesothelioma (lung), osteosarcoma (bone) and non-Hodgkins lymphoma (lymph nodes). However, several facts should be noted:

SV40 was present in cancers of people who either had or had not received the polio vaccines that were contaminated with SV40. SV40 has not been present in any vaccine since 1963. At least this is the government's narrative line.

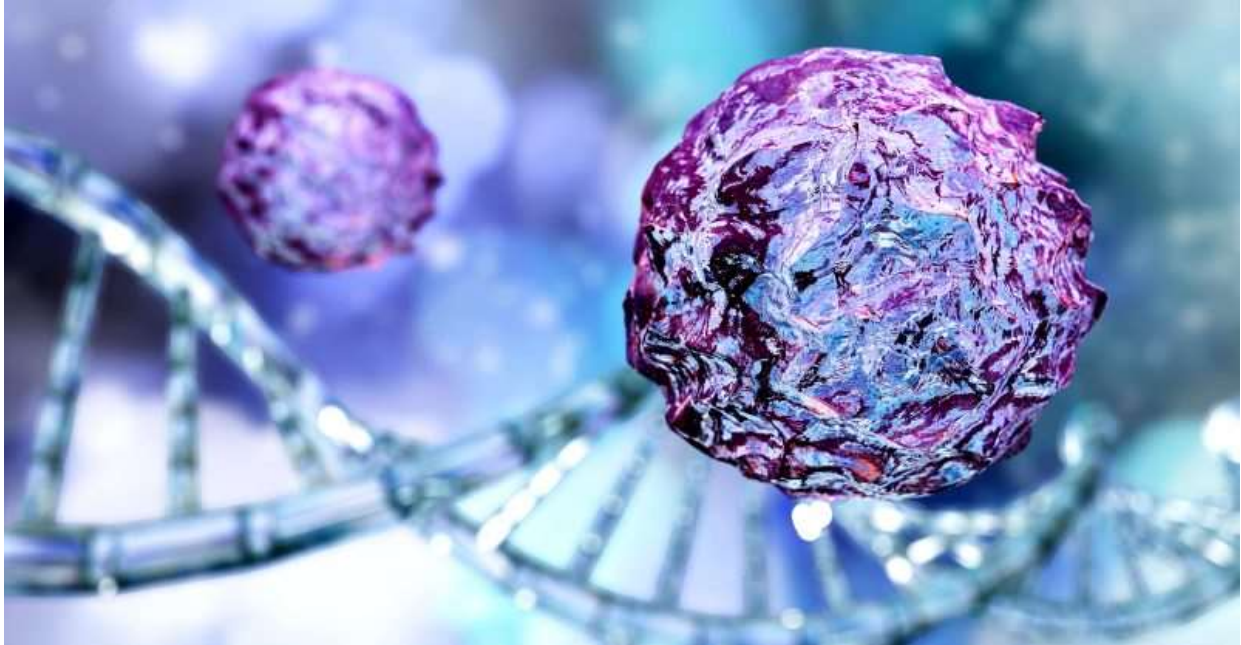
People with cancer who were born after 1963, when SV40 was no longer a contaminant of the polio vaccine, were still found to have evidence for SV40 in their cancerous cells, but there has never been adequate proof that SV-40 was removed entirely. The FDA and those agencies we are supposed to believe continue to fail in transparency that the public health is secure. The government attempted to use epidemiologic studies as proof that do not show an increased risk of cancers in those who received polio vaccine between 1955 and 1963.

### **Sausage Making at FDA: How Human Cancer Cells Got Into Vaccines**

In a 2012 meeting, the FDA voted to allow the use of human fetal cells and adult human tumor cells in vaccines, despite acknowledging the many risks, including those vaccine recipients might later develop cancer.

While I was at FDA, drug reviewers were clearly told not to question drug companies and that our job was to approve drugs ... If we asked questions that could delay or prevent a drug’s approval — which of course was our job as drug reviewers — management would reprimand us, reassign us, hold secret meetings about us or worse ... When you are able to dig in, if you found issues that would make you turn down a drug, you could be pressured to reverse your decision, or the review would then be handed off to someone who would simply copy and paste whatever claims the company made in the summary document ... I believe I also have documentation of falsification of documents, fraud, perjury and widespread racketeering, including witnesses tampering and witness retaliation.” — (Ronald Kavanagh, Ph.D., pharmacist who reviewed medications for the FDA from 1998 to 2008)*

### **Vaccines and related biological products advisory committee today**

Today — Thursday, Dec. 10 — the Vaccines and Related Biological Products Advisory Committee (VRBPAC), which is the U.S. Food and Drug Administration’s (FDA) internal panel that licenses new vaccines as “safe and effective,” will meet to consider [Pfizer’s](#)



[COVID vaccine](#). VRBAC will meet in one week, [Dec. 17](#), to consider approval of the [Moderna](#) vaccine.

The damning safety studies in [Pfizer's](#) late release clinical trial data dump, and the severe (life-threatening) [allergic reactions](#) that bedeviled the vaccine's UK rollout, have raised red flags and public anxiety about the safety of the companies' mRNA vaccines. Anthony Fauci has addressed growing skepticism about [COVID](#) vaccines and the [Operation Warp Speed](#) program, by reassuring the public that "VRBPAC" is an "independent panel of leading experts" whom the public can absolutely trust to assure vaccine safety.

In order to help you make your own conclusion about how reliably VRBPAC will protect your health, I excerpt below the transcripts from the cavalier, ignorant and astonishingly unethical deliberations during the 2012 VRBPAC meeting where panelists voted unanimously to allow use of human tumor cells in vaccines. I urge you to read and make up your own mind whether you want to place your health — and perhaps your life — in the hands of these reckless charlatans and irresponsible clowns.

### **How FDA originally approved use of fetal cells in vaccines**

FDA allows both [human fetal cells](#) and adult human tumor cells in vaccines. Both types have cancer risks. While both Pfizer and [Moderna](#) tested their mRNA vaccine using fetal cells, there are no fetal cells, cell debris or DNA in their final products.

However, according to company documents, Johnson and Johnson (Janssen) and Altimune's COVID vaccines are manufactured in the human fetal cell line PER-C6, and thus the final vaccine products will contain cellular debris and DNA fragments from these cells. Researchers harvested these cell lines from the eyeball of an 18-week-old human fetus aborted in 1985, and then rendered them immortal by making them cancerous.

The [AstraZeneca](#), Cansino, Gamayela, Vaxart, LongComm and Upitt vaccines are manufactured in the human fetal cell line HEK293, and thus the final vaccine products will contain cellular debris and DNA fragments from the fetal HEK-293 cell line. Scientists harvested this cell line from the kidney of a female Dutch fetus legally aborted in 1973 and then immortalized the cells by rendering them cancerous.

Normal primary cells, which are unable to replicate indefinitely, ultimately die. Immortalized cell lines are derived from known malignant cancer cells such as those obtained from [Henrietta Lacks](#) (HeLa) or created in the laboratory by introducing viral oncogenes or chemical exposures capable of mutating normal primary cells into immortal tumor cells.

According to FDA's "The Pink Sheet" dated Nov. 29, 1999, for two decades the agency has been acutely aware of the inherent risks of using immortalized cell lines for vaccine development. The FDA CBER Director Dr. Peter Patriarca, M.D. explained that continuous cell lines are used for their ability to self-propagate, making them an ideal

substrate on which to grow viruses, “the worst thing we are concerned about is ... malignancy, because some of these continuous cells have the potential for growing tumors in laboratory animals.”

Patriarca further conceded that “the technology to make these vaccines actually exceeds the science and technology to understand how these vaccines work and to predict how they will work.” This dire “black box” conundrum that Patriarca described in 1999 is even more acute today with the urgent pressure to develop COVID vaccines before manufacturers have tested them in animals or subjected them to long-term safety studies.

### **12 Reasons to Reject Vaccination**

The *'New England Journal of Medicine'*: Chief Editor Marcia Angell MD., “*It is simply no longer possible to believe much of the clinical research that is published, or to rely on the judgement of trusted physicians or authoritative medical guidelines*”. Lancet Chief Editor Richard Horton, “*... much of the scientific literature, perhaps half, may simply be untrue.. flagrant conflicts of interest.. science has taken a turn towards darkness.*”

1. Manufacturers list vax ingredients as mercury, aluminum, insect cells, squalene, pig gelatin, phenol, Simian (SV40) virus, hydrochloric acid, cow fetus, formaldehyde, cancer tumors, aborted baby cells, sorbitol & monkey cells. Vaccine contaminants include lead, cyanide, tin, arsenic, urea (urine waste).
2. Manufacturers warn vax side effects include polio, cot death [SIDS], paralysis, cancer, encephalitis, multiple sclerosis [MS], autism, convulsions, meningitis, anaphylaxis and death. Claiming vax protect us from disease is contradicted as authorities report vaccinated patients can catch disease from – and also infect – both the vaxed and unvaxed. Impossible if vax work.
3. No vax has ever been scientifically tested (double blind, randomized, long- term, inert placebo study) to show: a) if vax work, b) safety, and c) which group is healthier. The US Health Department was exposed in a landmark 2018 court loss after claiming for 32 years that vax were safe, despite having no proof and never once doing the legally required annual safety research ordered by Congress.
4. Vax ignores 18 critical, life-saving medical & legal requirements. Before any vax, the patient’s current illness, medical history, age, sex, weight, allergies, race & medications should be examined and a risk-benefit analysis done. Their doctor must disclose all ingredients, a list of harmful effects (up to 140 per vax) & get informed con- sent. A written prescription is essential & must identify the doctor, patient (never groups) and list the disease, vaccine, dose and duration.
5. The main cause of disease is toxemia/ blood poisoning from ingesting drugs and adulterated, processed, chemicalized, irradiated, GE, artificial food/drink. Our bodies are self-healing, needing rest, sunlight, pure water/air, fresh organic food (often raw), exercise, sleep, fasting, doing what we love and a positive outlook:

none offered by the trillion dollar medico/pharma industry. These traditional laws of health & disease contrast medical training, which is based on suppressing & removing symptoms with perilous and costly chemotherapy, surgery, radiation and drugs, not on understanding and teaching the above conditions our bodies need to eliminate toxins and self-repair. Our choices result in either vigorous health or chronic illness.

6. Autism exploded from 1 in 10,000 to 1 in 25 (2020) after the MMR [Measles/Mumps/Rubella] vax began in the U.S. in 1974. Drug Co. Sanofi Pasteur warned: 'Adverse events include autism.' Dr. H. Wang, Director Special Needs Children, reported in 2005: 'The autism rate for Amish [who don't vax] in Ohio was 1 in 15,000.' In 2004, CDC [Centers for Disease Control] researchers found a huge rise in autism in African American boys under age 3 after MMR vax. Sen/Scientist Dr. William Thompson admitted his CDC team falsified and then tried to erase this proof that vax causes autism. U.S. laws bar vax Co's being sued. In the tax funded 'Vax Court' with U.S. \$4.4 billion [\$6.16 Aust] damages awarded, in 83 trials the court found vax caused autism.
7. A U.S. Health Dept. study by Harvard Medical School found less than 1 per cent of vax injuries/ deaths are reported. Doctors & scientists who expose vax harm are vilified, defunded, persecuted and are not published – actions that ignore 200 years of other medical disasters: thalidomide, mercury, lead, dioxin, childbed fever carnage [doctors refusing to scrub up], asbestos, DES, Medical Journals endorsing smoking, Prozac, ECT, Vioxx, lobotomy, CFS, fluoridation, dieldrin, etc. All were claimed, as are vax, to be safe and effective despite proof of injury and death to millions of people & multi-billions in public costs. In Australia, authorities reveal that every year, at least 18,000 deaths and 50,000 permanent injuries are caused by doctors, drugs, vax & in hospitals. 8. Medicine and vax are based on a refuted theory about germs by Louis Pasteur who plagiarized [stole from] and misinterpreted the brilliant scientist Dr. Antoine Béchamp, who demonstrated disease is caused by toxemia: (a buildup of metabolic waste/ toxins). 9. Worldwide government statistics show infectious diseases e.g. chickenpox, Flu, measles, polio, TB, smallpox, etc. were in major decline decades before widespread vax due to improvements in hygiene. Medical historians record disease causes as rats, slums, fouled water (animal/ human waste), diseased milk, poverty, polluted air, malnutrition, child labor & despair. In declaring vax 'unavoidably unsafe', the US Congress confirmed that as there are no guaranteed vax benefits, all vaccines are experimental. Despite this, Australia's 2020 Vaccine Schedule is: 50 vax by age six; 73 by age 18 and 150 vax by age 65.
11. Every vax injects and infects us with disease. The result is that disease epidemics occur almost exclusively in vaxed regions. Independent studies show the claim that herd immunity prevents epidemics if 95% of people are vaxed is a lethal error. England, 1871-72: with 98% of ages two to 50 vaxed with smallpox – 45,000 died of smallpox. Germany had 96% vaxed & 125,000 smallpox deaths. In 1940, Germany made Diphtheria vax compulsory. By 1945 diphtheria cases had soared from 40,000 to 250,000.

Most reading this may miss the central point of this article, and that is the suspicion is that the **Mycoplasma was engineered to be a bioweapon.** Due to the nature of its tiny size, lab work and studies of ill people, Mycoplasma has been an overlooked source of the real problem. ***"I believe the chemtrails are responsible for a chemical intoxication of the public, which would then cause a general immune suppression, low grade to high grade, depending on exposure. The immune dysfunction allows people to become susceptible to opportunistic infections, such as this mycoplasma and other opportunistic infections",*** says Dr. Horowitz.

In Part 12 of this series, I noted that Dr. Horowitz confirmed this fact in a **United States Patent #5,242,820, issued on September 7, 1993 [Pathogenic mycoplasma].**

Abstract The invention relates to a novel pathogenic mycoplasma isolated from patients with Acquired Immune Deficiency Syndrome (AIDS) and its use in detecting antibodies in sera of AIDS patients, patients with AIDS-related complex (ARC) or patients dying of diseases and symptoms resembling AIDS diseases. The invention further relates to specific DNA sequences, antibodies against the pathogenic mycoplasma, and their use in detecting DNA or antigens of the pathogenic mycoplasma or other genetically and serologically closely related mycoplasmas in infected tissue of patients with AIDS or ARC or patients dying of symptoms resembling AIDS diseases. The invention still further relates to a variety of different forms of vaccine against mycoplasma infection in humans and/or animals.

In the period following the granting of this patent, aerial spraying commenced in earnest 365 days a week, around the clock. During the period from 1998 to 2010, I would take

our dog out for his last outing of the night usually around 11:30 to midnight, and on clear moon-lit nights, I could see aircraft spraying their poison soup.

Of course, the most logical question about this unsavory list of noxious ingredients is: "Why are there so many known toxins included in the mix?"

More specifically, the preponderance of barium salt (barium chloride) and alumina (aluminum oxide), which are said to exist in the greatest concentration in chemtrails, is particularly alarming. Why? Because barium is well known to decrease and/or impair immune function. Aluminum oxide has its own set of problems, especially when inhaled in certain concentrations over prolonged periods of time. Aluminum, in any form, is not very easy for the body to detoxify, especially when it finds a home in the lungs.

What's the point? The point is to dramatize just how much the geo-engineers are out of their league ... as well as out of control. The situation is quite similar to the physicians of the world who for decades over-prescribed antibiotics, only to create pervasive

Every fall the public is encouraged to take a flu shot and there is no definitive proof that the flu shot administered is the right one.
