

Depopulation

#1 Global Issue Since 1968

Part 2

It comes as a great shock to many Americans to learn that their government wants them dead. It was the case for me back in the early 1980s. The media is so scripted that for the most part it would seem the government loves us. If that were the case, why do you suppose the government uses your Birth Certificate as collateral for borrowing money from the International Monetary Fund (IMF)? There was a time when a baby was born; the parents did not have to get the child a Social Security Number until that child needed working papers at 14, in order to get a part-time job.

I got my Social Security Number at 14, in order to work as a stock clerk at my local Giant Eagle Supermarket. The minimum wage was .38 cents an hour as well. Today, if you have a child born in a hospital, don't try to slip out the side door and leave the hospital without registering or until the paperwork is completed for your baby's SSN. To hook parents into registering their dependents, they made it mandatory all children be registered for their SSN, in the government's (carrot or stick tactic to get compliance) parents could not claim little Bobby or Nancy unless they provided their SSN on that 1040 income tax return.

In 1935, when the Social Security Administration was signed into law, most people did not live to 65, so when the Roosevelt introduced the Old Age & Survivor's Benefits program into law, they knew beforehand that few would live long enough to receive much of what they paid in in the way of employee payroll withholdings. I am one of those the government regrets has lived twenty years past retirement age of 65. I chose to take Social Security at 62 for other reasons but the fact is the government has a problem. It did not just begin when President Clinton and Bush stole the employee's payroll withholdings to pay for the stupid wars on behalf of the Rothschild's. We would not know this until bumbling George W. Bush made the statement that there was no Social Security Trust Fund.

The news media had given extensive coverage to the Social Security debate in the 2000 election campaign, and to President Bush's early promises to not raid the trust fund. However, Bush's failure to honor his promises, with regard to Social Security, just never seemed to get much news coverage, leaving most Americans to believe that the raiding of the trust fund ended after George W. Bush took office. On the contrary, Bush raided and spent a total of \$1.37 trillion of Social Security surplus during his eight years as president. In his last year, he spent \$192.2 billion, which averages out to more than \$526 million per day.

During a speech on April 5, 2005 in Parkersburg, West Virginia, Bush openly admitted to the fact that all of the Social Security surplus revenue had been spent. He said, "There is no trust fund, just IOUs that I saw firsthand that future generations will pay—will pay for either in higher taxes, or reduced benefits, or cuts to other critical government programs." Bush's words in this speech bore little resemblance to what he had said about Social Security during the 2000 campaign. But his motives were different in 2005. He was trying to sell his privatization plan, and he thought that by spilling the truth he might further his effort to privatize Social Security.

There would be no Social Security funding problem for at least the next 25 years, if the government had not raided the trust fund. If the trust fund held the \$2.5 trillion of surplus Social Security revenue, in the form of real marketable bonds, as it should, it could continue to pay full Social Security benefits until at least 2037. So the obvious solution is for the government to make arrangements to repay the \$2.5 trillion it owes to the trust fund.

Full retirement age, or FRA. (FRA is currently 66 and is gradually rising to 67 for people born in 1960 or later.) Only then do you qualify for 100 percent of your basic monthly benefit. Keep your eyes on the government as they want to push this to age 70, and I bet it will happen.

This all relates to my premise that the world elite and governments around the world all want ways that will lead to our early demise. Many years ago Lonnie Wolfe, a reporter for the UK publication EIR wrote an interesting article on our own President Jimmy Carter, who by the way was the hand-picked candidate of the late David Rockefeller, of seven heart-transplant fame.

The EIR Special Report was published in March 10, 1981. Investigations by EIR uncovered a planning apparatus operating outside the control of the White House whose sole purpose was to reduce the world's population by 2 billion people through war, famine, disease and any other means necessary.

This apparatus, which included various levels of the government, was determining U.S. foreign policy. In every political hotspot - El Salvador, the so-called arc of crisis in the Persian Gulf, Latin America, Southeast Asia and in Africa - the goal of U.S. foreign policy is population reduction.

The targeting agency for the operation was the National Security Council's Ad Hoc Group on Population Policy. Its policy-planning group was in the U.S. State Department's Office of Population Affairs, established in 1975 by Henry Kissinger.

This group drafted President Carter's administration's Global 2000 Report, which calls for global population reduction, and the same apparatus is conducting the civil war in El Salvador as a conscious depopulation project.

"There is a single theme behind all our work-we must reduce population levels," said Thomas Ferguson, the Latin American case officer for the State Department's Office of Population Affairs (OPA). "Either they [governments] do it our way, through nice clean methods or they will get the kind of mess that we have in El Salvador, or in Iran, or in Beirut. Population is a political problem."

Once population is out of control it requires authoritarian government, even fascism, to reduce it. *"The professionals," said Ferguson, "aren't interested in lowering population for humanitarian reasons. That sounds nice. We look at resources and environmental constraints. We look at our strategic needs, and we say that this country must lower its population - or else we will have trouble."*

"So steps are taken. El Salvador is an example where our failure to lower population by simple means has created the basis for a national security crisis. The government of El Salvador failed to use our programs to lower their population. Now they get a civil war because of it.... There will be dislocation and food shortages. They still have too many people there."

Civil wars are somewhat drawn-out ways to reduce population, the OPA official added. *"The quickest way to reduce population is through famine, like in Africa or through disease like the Black Death,"* all of which might occur in El Salvador.

Ferguson's OPA monitors populations in the Third World and maps strategies to reduce them. Its budget for FY 1980 was \$190 million; for FY 1981, it will be \$220 million. The Global 2000 Report calls for doubling that figure.

In 1975, OPA was brought under a reorganized State Department Bureau of Oceans, International Environmental, and Scientific Affairs - a body created by Henry Kissinger.

The agency was assigned to carry out the directives of the NSC Ad Hoc Group. According to an NSC spokesman, Kissinger initiated both groups after discussion with leaders of the Club of Rome during the 1974 population conferences in Bucharest and Rome.

The Club of Rome, controlled by Europe's black nobility, is the primary promotion agency for the genocidal reduction of world population levels. The Ad Hoc Group was given "high priority" by the Carter administration, through the intervention of National Security Adviser Zbigniew Brzezinski and Secretaries of State Cyrus Vance and Edmund Muskie.

According to OPA expert Ferguson, Kissinger initiated a full about-face on U.S. development policy toward the Third World. *"For a long time,"* Ferguson stated, *"people here were timid"*. They listened to arguments from Third World leaders that said that the best contraceptive was economic reform and development. And so we pushed development programs, and we helped create a population time bomb. That term "population time bomb" came from Dr. Paul Ehrlich's book, *'The Population Bomb'*,

published in 1968, when the world population was only 3.5 billion compared to 7.8 billion in 2020. Back in 1968 I was a college junior and the book was required reading in both political science and sociology courses. It was required reading in an Ethics course I took when I was a seminary student at Pittsburgh Theological Seminary, so I was well indoctrinated with the population topic. Academia has obsessed with this issue for the next few decades and I can tell you that this is what underlies Bill Gates agenda to vaccinate the whole world. In his deception and lies, he sees himself as a hero rather than the villain.

"We are letting people breed like flies without allowing for natural causes to keep population down. We raised the birth survival rates, extended life-spans by lowering death rates, and did nothing about lowering birth rates."

That policy is finished. We began saying with Global 2000 and in real policy that you must lower population rates. Population reduction and control is now our primary policy objective - then you can have some development.

Accordingly, the Bureau of Oceans, International Environmental, and Scientific Affairs has consistently blocked industrialization policies in the Third World, denying developing nations access to nuclear energy technology - the policies that would enable countries to sustain a growing population.

According to State Department sources, and Ferguson himself, Alexander Haig is a "firm believer" in population control.

"We will go into a country," said Ferguson, "and say, here is your goddamn development plan. Throw it out the window. Start looking at the size of your population and figure out what must be done to reduce it."

'If you don't like that, if you don't want to choose to do it through planning, then you'll have an El Salvador or an Iran, or worse, a Cambodia.'

According to an NSC spokesman, the United States now shares the view of former World Bank President Robert McNamara that the *"population crisis"* is a greater threat to U.S. national security interests than *"nuclear annihilation."*

"Every hot spot in the world corresponds to a population crisis point," said Ferguson who would rename Brzezinski's arc of crisis doctrine the *"arc of population crisis."*

This is corroborated by statements in the NSC Ad Hoc Group's April 1980 report. There is *"an increased potential for social unrest, economic and political instability, mass migration and possible international conflicts over control of land and resources,"* says the NSC report. It then cites *"demographic pressures"* as key to understanding, *"Examples of recent warfare in India, Pakistan, Bangladesh, El Salvador, Honduras, and Ethiopia, and the growing potential for instability in such places as Turkey, the Philippines, Central America, Iran, and Pakistan."*

Through extraordinary efforts, the Ad Hoc Group and OPA estimate that they may be able to keep a billion people from being born through contraceptive programs.

But as the Ad Hoc Group's report states, the best efforts of the Shah of Iran to institute "clean programs" of birth control failed to make a significant dent in the country's birth rate. The promise of jobs, through an ambitious industrialization program, encouraged migration toward "overcrowded cities" like Teheran. Now under Ayatollah Khomeini, the "clean programs" have been dismantled. The government may make progress because it has a program,

Unbeknownst, at least publicly, behind the back of the President, Ferguson and others involved with the OPA and NSC group maintained that the United States will continue a foreign policy based on a genocidal reduction of the world's population.

"We have a network in place of co-thinkers in the government," said the OPA case officer. *"We keep going, no matter who is in the White House."*
