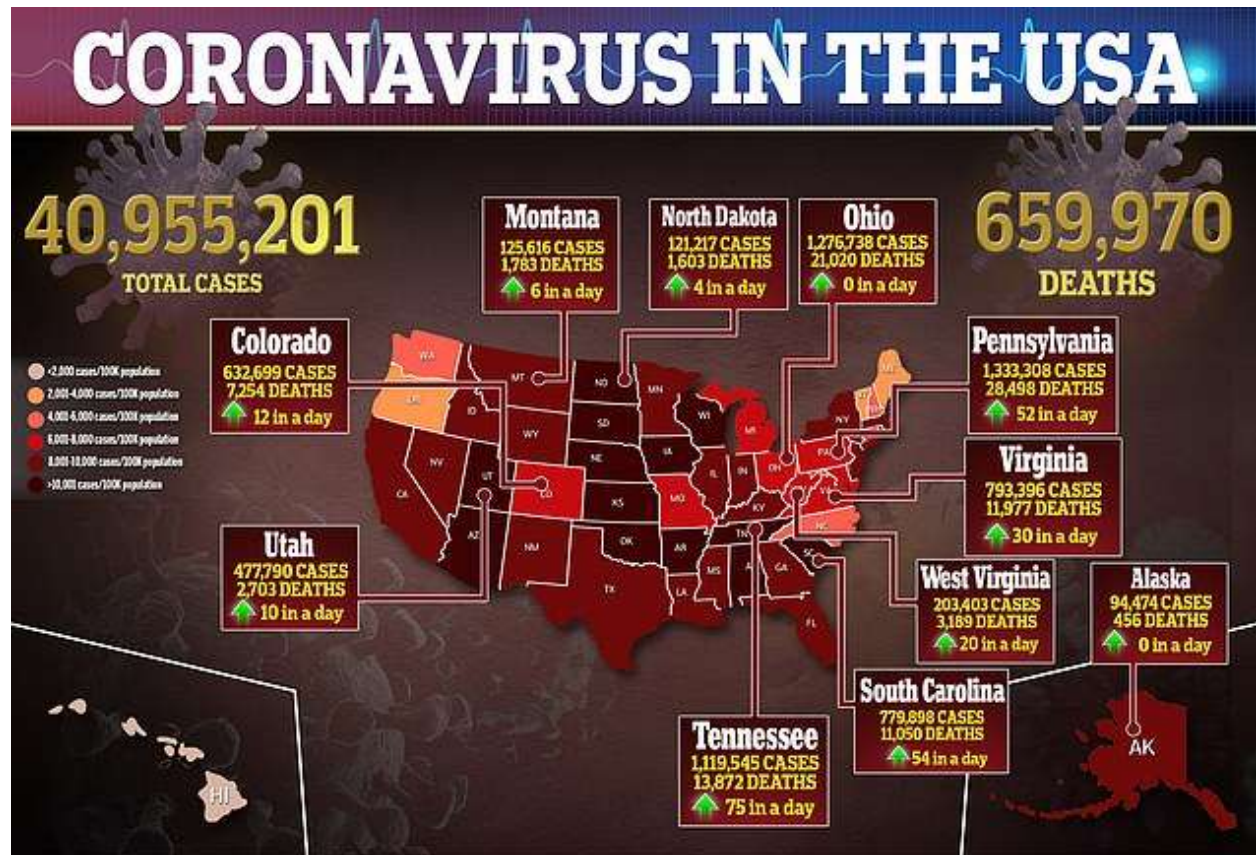

### The Big Question: How Accurate Are These Numbers?

The above map and data was posted on Monday, September 13<sup>th</sup>, 2021 on the UK 'Daily Mail' newspaper web site. This is an excellent snap shot of nebulous and irrelevant information. It is a vague effort to intimidate and scare people but with inadequate information or relevant reference points. This map fails to show any significance of data for the states they singled out, such as what date of these cases, their meaning, and at best it is very deceptive.

This past February 14, 2021 was the last date where there was more than a single death per county (3,142 counties) in the U.S. from Covid-19. There are 3,142 counties in the U.S. This is an important data point to be aware of because you can then determine the true severity of a health crisis. Of that number of counties, there are 100 counties in the U.S. with a major city and a population greater than 1 million.

Six months since the February 14<sup>th</sup> date, on September 11<sup>th</sup>, 2021, the deaths attributed to Covid hit the "magic" number of at least 1 death per 3,142 counties, with a total of 3,709 deaths. The next day, September 11<sup>th</sup> it dropped back down to 1,939, and on

September 12<sup>th</sup>, it declined further to 475 deaths. I track the daily data released by the CDC and government health agencies, watching for trends, anomalies, or irregularities and suspect numbers. **This pictograph that was posted is intended to frighten the public.** The source has randomly selected different states yet lacks any reason for the selection or their relevance. If anything that it represents we should see it as a diversion or distraction obfuscation to confuse and frighten the public.

### **New Study Shatters Narrative Surrounding COVID Hospitalizations**

**FROM TOWN HALL:** Most notably, the study conducted by a team of researchers from Harvard Medical School, Tufts Medical Center, and the Veterans Affairs Healthcare System, **found that many of those "hospitalized with COVID" are not the dire situations hyped by liberal media and leading Democrats.** The main narrative-shattering takeaway researchers arrived at: **"Roughly half of all the hospitalized patients showing up on COVID-data dashboards in 2021 may have been admitted for another reason entirely, or had only a mild presentation of disease."**

**Rather than the overwhelming horror stories** of normally healthy individuals being admitted with COVID who are soon intubated and put on a ventilator before their body finally succumbs to the virus, there are a lot of people — almost half, in fact — who happen to be in hospitals \*with\* COVID, but not necessarily \*due to\* COVID or at risk of dying from the virus. Yes, those tragic situations do still happen, but it's happening less frequently than many seem to want Americans to think.

*Instead of each "COVID hospitalization" reported being a life-and-death situation that mandates a drastic reaction, the numbers can come from a number of scenarios. Perhaps someone is getting treatment for cancer and, when admitted, they test positive for COVID but remain asymptomatic, for example. Also included are psychiatric admissions entirely unrelated to COVID.*

**Here's how researchers reached their conclusion after analyzing electronic hospital records for roughly 50,000 COVID hospital admissions at more than 100 VA hospitals nationwide:**

***They checked to see whether each patient required supplemental oxygen or had a blood oxygen level below 94 percent. (The latter criterion is based on the National Institutes of Health definition of "severe COVID.") If either of these conditions was met, the authors classified that patient as having moderate to severe disease; otherwise, the case was considered mild or asymptomatic.***

**And for patients** who were vaccinated against the Wuhan coronavirus, the percentage of COVID hospitalizations for those with mild or asymptomatic cases rose to 57 percent. But, another panic-busting finding from the study: ***unvaccinated patients have also been showing up with less severe symptoms, on average, than earlier in the pandemic: The study found that 45 percent of their cases were mild or asymptomatic since January***

21." That positive development, according to one of the study's co-authors, is due to patients being younger and more likely to have had COVID previously. [READ MORE](#).

Because of the countless vectors of dissemination of the COVID-19 bioweapon, as well as the numerous methods of Covid propagation, controlling this wholly manufactured pandemic is a function of shutting down the military-grade bioweapon labs. The last to be deployed and most important bioweapon in their arsenal is the COVID-19 vaccine. Because its efficacy to both, cause death and/or serious debilitation, the

various Covid injections are the integral element in this ELE plot, which is why there is such an overwhelming global push to vaccinate every person on the planet.

In view of how highly experimental the vastly different vaccines truly are, it's clear that each is being beta tested in different countries and within different bloodlines. ### **PATHOGENIC MYCOPLASMA**

#### **A Common Disease Agent Weaponized**

There are 200 species of Mycoplasma. Most are innocuous and do no harm; only four or five are pathogenic. Mycoplasma fermentans (incognitus strain) probably comes from the nucleus of the Brucella bacterium. This disease agent is not a bacterium and not a virus; it is a mutated form of the Brucella bacterium, combined with a visna virus, from which the mycoplasma is extracted.

The pathogenic Mycoplasma used to be very innocuous, but biological warfare research conducted between 1942 and the present time has resulted in the creation of more deadly and infectious forms of Mycoplasma. Researchers extracted this mycoplasma from the Brucella bacterium and actually reduced the disease to a crystalline form. They "weaponized" it and tested it on an unsuspecting public in North America.

Dr. Maurice Hilleman, chief virologist for the pharmaceutical company Merck Sharp & Dohme, stated that this disease agent is now carried by everybody in North America and possibly most people throughout the world. Note that statement well!

Despite reporting flaws, there has clearly been an increased incidence of all the neuro/systemic degenerative diseases since World War II and especially since the 1970s with the arrival of previously unheard-of diseases like chronic fatigue syndrome and AIDS.

According to Dr. Shyh-Ching Lo, senior researcher at The Armed Forces Institute of Pathology and one of America's top mycoplasma researchers, this disease agent causes many illnesses including AIDS, cancer, chronic fatigue syndrome, Crohn's colitis, Type I diabetes, multiple sclerosis, Parkinson's disease, Wegener's disease and collagen-vascular diseases such as rheumatoid arthritis and Alzheimer's.

Dr. Charles Engel, who is with the U.S. National Institutes of Health, Bethesda, Maryland, stated the following at an NIH meeting on February 7, 2000: "I am now of the view that the probable cause of chronic fatigue syndrome and fibromyalgia is the mycoplasma..."

Robert Scott said, "I have all the official documents to prove that mycoplasma is the disease agent in chronic fatigue syndrome/fibromyalgia as well as in AIDS, multiple sclerosis and many other illnesses." Of these, 80% are U.S. or Canadian official government documents, and 20% are articles from peer-reviewed journals such as the 'Journal of the American Medical Association', 'New England Journal of Medicine' and the 'Canadian Medical Association Journal'. The journal articles and government documents complement each other.

### **How the Mycoplasma Works**

The mycoplasma acts by entering into the individual cells of the body, depending upon your genetic predisposition.

You may develop neurological diseases if the pathogen destroys certain cells in your brain, or you may develop Crohn's colitis if the pathogen invades and destroys cells in the lower bowel.

Once the mycoplasma gets into the cell, it can lie there doing nothing sometimes for 10, 20 or 30 years, but if a trauma occurs like an accident or a vaccination that doesn't take, the mycoplasma can become triggered.

Because it is only the DNA particle of the bacterium, it doesn't have any organelles to process its own nutrients, so it grows by up-taking pre-formed sterols from its host cell and it literally kills the cell; the cell ruptures and what is left gets dumped into the bloodstream. It is the perfect silent weapon for quiet wars! No "smoking" gun or shell casings.

## **CREATION OF THE MYCOPLASMA A Laboratory-Made Disease Agent**

Many doctors don't know about this mycoplasma disease agent because it was developed by the U.S. military in biological warfare experimentation and it was not made public. This pathogen was patented by the United States military and Dr. Shyh-Ching Lo. Robert Scott has a copy of the documented patent from the U.S. Patent Office.

All the countries at war were experimenting with biological weapons. In 1942, the governments of the United States, Canada and Britain entered into a secret agreement to create two types of biological weapons (one that would kill, and one that was disabling) for use in the war against Germany and Japan, who were also developing biological weapons. While they researched a number of disease pathogens, they primarily focused on the Brucella bacterium and began to weaponize it.

From its inception, the biowarfare program was characterized by continuing in-depth review and participation by the most eminent scientists, medical consultants, industrial experts and government officials, and it was classified **Top Secret**.

The U.S. Public Health Service also closely followed the progress of biological warfare research and development from the very start of the program, and the Centers for Disease Control (CDC) and the National Institutes of Health (NIH) in the United States were working with the military in weaponizing these diseases. These are diseases that have existed for thousands of years, but they have been weaponized—which means they've been made more contagious and more effective. And they are spreading.

The Special Virus Cancer Program, created by the CIA and NIH to develop a deadly pathogen for which humanity had no natural immunity (AIDS), was disguised as a war on cancer but was actually part of project MKNAOMI. Many members of the Senate and House of Representatives do not know what has been going on. For example, the U.S. Senate Committee on Government Reform had searched the archives in Washington and other places for the document titled "The Special Virus Cancer Program: Progress Report No. 8", and couldn't find it. Somehow they heard Robert Scott, a high school teacher had it, called him and asked him to mail it to them. Imagine: a retired schoolteacher being called by the United States Senate and asked for one of their secret documents! The U.S. Senate, through the Government Reform Committee, is trying to stop this type of government research.

Brucella is a disease agent that doesn't kill people; it disables them first. But, according to Dr. Donald MacArthur of the Pentagon, appearing before a congressional committee in 1969, researchers found that if they had mycoplasma at a certain strength—actually, 10 to the 10th power—it would develop into AIDS, and the person would die from it within a reasonable period of time because it could bypass the natural human defenses. If the strength was 10 to 8, the person would manifest with chronic fatigue syndrome or fibromyalgia. If it was 10 to 7, they would present as wasting; they wouldn't die and they



wouldn't be disabled, but they would not be very interested in life; they would simply waste away.

This Brucellosis Mycoplasma thrives on Cholesterol. In its dormancy, it is somehow watching, four things in the body;

1. Oxygen blood level
2. pH level
3. Immune system
4. Stress factor

### **NOVIO'S ELECTRICAL DEVICE ZAPS A COVID-19 VACCINE INTO THE BODY**

Can a handheld gadget usher in a new era of vaccines? Get ready for another one of the new devices that can induce a vaxx into the human body! However, it can do much more as we will see.

It took a global pandemic to accomplish one of the most significant advances in the history of vaccinology: widespread, commercial deployment of vaccines derived from nucleic acids. As of this writing, hundreds of millions of people have been vaccinated against SARS-CoV-2, the virus that causes COVID-19. And most of those shots have been the Pfizer–BioNTech and Moderna offerings, which are both of a type known as an mRNA (messenger RNA) vaccine. They are really “gene” therapy!

Conceived decades ago but released to the public for the first time during the pandemic, mRNA vaccines so far are living up to their promise. Both the Pfizer and Moderna vaccines supposedly have proven to be about 95 percent effective against the novel coronavirus. Even that percentage has been questioned as an exaggeration of the truth. In addition, this kind of vaccine can be tweaked with relative ease to target new variants of a virus, and its production does not rely on items that can be difficult to produce quickly in enormous quantities. And yet, a couple of drawbacks of mRNA vaccines have also been widely noted over the past eight months: They depend on deep-freeze supply chains and storage, and they can produce significant side effects such as fever, chills, and muscle aches.

So hopes remain high for another kind of nucleic-acid vaccine, one that makes use of DNA rather than mRNA. DNA-based vaccines have most of the advantages of mRNA vaccines, yet they produce no significant side effects—and, crucially, they don't need to be refrigerated. These attributes could make these vaccines a boon to rural and low-resource regions. “If we really have to vaccinate 7 billion people, we might just need every possible technology,” says Margaret Liu, chairman of the board of the International Society for Vaccines.

**Inovio's device uses a technique called electroporation to sneak a DNA vaccine into cells.** Kate Broderick, Inovio's senior vice president of R&D, has been working on this technique for years, but the pandemic provided both motivation and funding to accelerate development.

DNA vaccines come with a major challenge, however. When administered with an ordinary hypodermic needle, they've conferred only weak immunity, at best, in many human studies. But if a small, ambitious Pennsylvania company backed by the U.S. Department of Defense succeeds in its clinical trials, DNA vaccines—enabled by a new delivery technology—could soon join the fight against COVID-19, and a host of other viral illnesses.

The company, Inovio Pharmaceuticals, is using a technique known as **electroporation**, in which an electrical pulse (**5G wireless energy**) applied to the skin briefly opens channels in cells to allow the vaccine to enter. After a standard vaccine injection, Inovio's electroporation device, which looks like an electric toothbrush, is held against the skin. At the press of a button, a weak electric field pulses into the arm, opening channels into the cells. The tool gives DNA vaccines the boost they need to work in humans—or so the company says. **It's an engineering solution to a biological problem.** I have discussed this issue of electroporation in recent articles on **5G** as a device that delivers an invisible bullet to its victims.

With its overseas warfighters in mind (that's what the public has been told), **the U.S. Department of Defense (DOD) has backed Inovio's approach with a US \$71 million contract to scale up the manufacturing of its electroporation device**, and an undisclosed sum to cover phase 2 and 3 studies of the company's COVID-19 vaccine. And **the Bill and Melinda Gates Foundation gave the company \$5 million as part of an effort to increase equitable access to COVID-19 vaccines.** Be mindful that anything created for warfare against an adversarial nation can just as easily be deployed against its own citizens. That has been a fact regarding the Dr. Fauci Gain-of-Function being kept from the public eye. DARPA, CIA, and the DOD have used advanced technology to be used against the U.S. public.

Inovio is now finishing phase 2 studies that are testing the vaccine's safety and efficacy on relatively small groups in the United States and China, and those results are imminent. In the meantime, the company has ramped up manufacturing with a plan to supply hundreds of millions of COVID-19 vaccine doses to the global population, should the vaccine prove successful.

But here's the rub: **The electroporation tool is essential to Inovio's vaccine, but it also adds a layer of complication.** It's both an enabler and a handicap. Inovio must manufacture not only the vaccine but also the device and its disposable tips. Any vaccination site planning to administer Inovio's vaccine will need not only the device but also people who know how to use it. The public will have to develop trust in a new apparatus. And all of this will have to happen during a pandemic and a frenzied vaccine

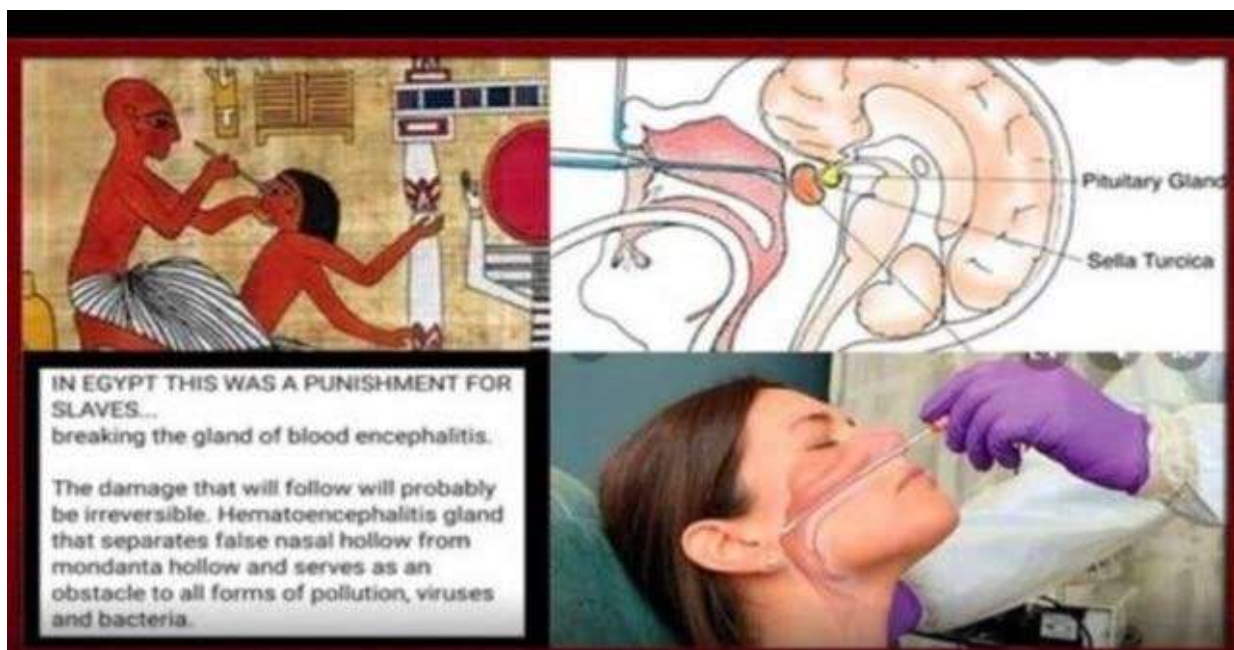
rollout characterized by rampant misinformation and, in some quarters, an unwillingness to be vaccinated.

Given that backdrop, the idea of complicating mass vaccinations with an electric device has drawn skepticism. *“This is not standard methodology for giving vaccines,”* notes John Moore, an immunologist at Weill Cornell Medicine, in New York City. The technique might work, but *“how practical it is is another question entirely,”* he says.

Neither the skeptics nor tough questions from regulators have deterred Inovio. Nor has the fact that, despite more than a decade of research and development in other disease areas, the company has yet to bring a DNA vaccine to market. It did not stop the DoD and Bill Gates from investing in the project! These are hardly normal times. The coronavirus has propelled many other novel technologies, medicines, and vaccines into the mainstream, and in the process has created massive business success stories. Inovio is betting that its technology will make it into that elite group of pandemic-era winners.

**Newly Released Documents Show Fauci Was ‘Untruthful’ About Wuhan Coronavirus Research, Infectious Disease Expert Says**

A trove of newly released documents detailing U.S.-funded coronavirus research in China prior to the COVID-19 pandemic shows that Dr. Anthony Fauci was “untruthful” when he claimed that his agency did not finance gain-of-research in Wuhan, an infectious disease expert said Sunday.

Documents published by [The Intercept](#) on Sunday two weeks ago show that Fauci’s organization, the National Institute of Allergy and Infectious Diseases (NIAID), provided federal funds to the U.S. nonprofit group EcoHealth Alliance and the Wuhan Institute of Virology to construct laboratory-generated SARS and MERS-related coronaviruses that demonstrated enhanced pathogenicity in humanized mice cells, according to Rutgers University professor of chemical biology Richard Ebright.



*“The documents make it clear that assertions by the [National Institutes of Health] Director, Francis Collins, and the NIAID Director, Anthony Fauci, that the NIH did not support gain-of-function research or potential pandemic pathogen enhancement at WIV are untruthful,”* Ebright said in a [tweet](#) Sunday evening.

Fauci said during a [congressional hearing](#) in May that the NIH and NIAID “*categorically have not funded gain-of-function research to be conducted at the Wuhan Institute of Virology.*”

Ebright and other experts have described EcoHealth Alliance’s work with the WIV as gain-of-function research. Ebright previously told the Daily Caller News Foundation that the NIH has “**systematically thwarted**” the federal government’s oversight of dangerous pathogen research by failing to flag research grants for review by a Department of Health and Human Services review board. Fauci’s insistence that the EcoHealth Alliance research grant with the WIV did not involve gain-of-function research led Republican Sen. [Rand Paul](#) to send a criminal

referral to the Department of Justice in July to investigate whether Fauci lied before Congress.

Ebright said Sunday that the documents published by [The Intercept](#) show that one of the novel SARS-related coronaviruses created at the biosafety level 3 labs at Wuhan University Center for Animal Experiment was proven to be more pathogenic to humanized mice than the original virus from which it was constructed.

The documents also show that the NIAID-funded research in Wuhan supported the construction of novel MERS-related coronavirus, Ebright said.

### **‘We’re Not Done Yet’: Biden To Announce More Pandemic Measures**

US Surgeon General Dr. Vivek was saying [‘masks don’t work’](#)... wait [just kidding](#)! Murthy on Sunday defended the Biden administration’s new Covid vaccine mandates – calling them an *“appropriate legal measure”* to keep people safe.



Murthy, a known flip-flopper, also “*challenged the notion that Biden’s new policies reflect a flip-flop from the idea that vaccination should not be mandated,*” saying that they were simply responding to a situation “*that’s changed due to the Delta variant,*” according to [Politico](#).

“**There will be more actions that we continue to work on, especially in the global front,**” he added.

*“We also know this virus transcends borders ... That’s why, even as we execute this plan at home, we need to continue fighting the virus overseas, continue to be the arsenal of vaccines.”*

Testing via Mosquito Vector in Punta Gorda, Florida

A report from The *‘New England Journal of Medicine’* reveals that one of the first outbreaks of chronic fatigue syndrome was in Punta Gorda, Florida, back in 1957. It was a strange coincidence that a week before these people came down with chronic fatigue syndrome, there was a huge influx of mosquitoes.

The National Institutes of Health claimed that the mosquitoes came from a forest fire 30 miles away. The truth is that those mosquitoes were infected in Canada by Dr. Guilford B. Reed at Queen’s University. They were bred in Belleville, Ontario, and taken down to Punta Gorda and released there.

Within a week, the first five cases ever of chronic fatigue syndrome were reported to the local clinic in Punta Gorda. The cases kept coming until finally 450 people were ill with the disease.

#### Testing via Mosquito Vector in Ontario

The Government of Canada had established the Dominion Parasite Laboratory in Belleville, Ontario, where it raised 100 million mosquitoes a month. These were shipped to Queen's University and certain other facilities to be infected with this crystalline disease agent. The mosquitoes were then let loose in certain communities in the middle of the night, so that the researchers could determine how many people would become ill with chronic fatigue syndrome or fibromyalgia, which was the first disease to show.

One of the communities they tested it on was the St Lawrence Seaway valley, all the way from Kingston to Cornwall, in 1984. They let out hundreds of millions of infected mosquitoes. Over 700 people in the next four or five weeks developed myalgic encephalomyelitis, or chronic fatigue syndrome.
