

Depopulation

#1 Global Issue Since 1968

Part 4

Four decades ago, the Club of Rome predicted looming economic collapse in its iconic report '*The Limits to Growth*'. An update of the analysis sees much the same picture. We are there, by design. The elite agenda is nearly all out in the open at various sites that understand the turbulent times ahead.

On the eve of one of the twentieth century's most notable economic shocks - the 1973 oil crisis - an influential group of researchers released a now-iconic report entitled '*The Limits to Growth*'.

The work, which received wide attention and proved controversial, painted a bleak picture of humanity's future. Left unchecked, it said, economic and population growth would deplete the planet's resources and cause economic collapse around 2070.

More than four decades later, the report's main conclusions are still valid, according to a group of independent researchers who have updated the work using more-sophisticated analytical tools.

Like the 1972 report, the latest work was commissioned by the Club of Rome, a group of liberal scientists, economists and industrialists that was founded in 1968.

The update ([Transformation is Feasible - How to Achieve the Sustainable Development Goals within Planetary Boundaries](#)), released on October 17, 2012 in Rome for the club's 50th anniversary, makes for a sobering read.

Although its conclusions are not quite as drastic as those of the original report, it says that humanity finds itself in something of a catch-22.

Business-as-usual or accelerated economic growth will mean that the world will not be able to meet the United Nations' *sustainable development goals* (SDGs) - a suite of social, environmental and prosperity targets for 2030 - the authors conclude.

And even if governments were to substantially strengthen what the authors call "conventional" policies to meet social goals such as the eradication of poverty and hunger, and achieving quality education for all, they would be in danger of missing environmental goals.'

"There is high risk for pushing the Earth's life supporting systems beyond irreversible trigger-points by 2050," the report says.

"It is quite disturbing to see that we're still facing the same dilemma the Club of Rome described almost 50 years ago," says Julia Steinberger, an ecological economist at the University of Leeds, UK.

Conventional policies won't do

The original report was a quantitative analysis based on a computer model that calculated likely future outcomes for the world's economy. Criticism focused mainly on the authors' assumptions about how long natural resources would last.

Some economists called the book's pessimistic conclusions "irresponsible nonsense", while others criticized the validity of the model - World3, a dynamic economic model developed by US economist **Dennis Meadow**, co-author of the report - that the authors had used to predict energy consumption, pollution and population growth.

The latest version of the report was compiled by researchers with the Stockholm Resilience Centre and the BI Norwegian Business School in Oslo.

They used an Earth-system model that combines socio-economic and biophysical variables, alongside a wealth of historical and new socio-economic data, to draw up their conclusions.

This model's elements interact with the passage of time, and it is much more robust than World3, says Steinberger.

The researchers found that the world is currently on track to meet only 10 of the 17 SDGs by 2030. Efforts to satisfy social SDGs with conventional policy tools will come at the price of unsustainable or wasteful use of natural resources such as water, land and energy.

Hence, environmental goals, including stabilizing climate, reducing pollution and maintaining biodiversity, could fall by the wayside, they say.

To prevent human civilization from more environmental damage than it might be able to endure, the authors call on world leaders to consider policies that they deem unconventional.

Only more extreme economic and behavioral changes will allow the world to achieve all 17 SDGs together, the authors say.

These policies might include rapid phase-out of fossil fuels, greater use of family

planning to stabilize populations, and actively encouraging the reduction of wealth inequality so that the richest 10% of people take no more than 40% or so of income.

The report is a vindication of the Club of Rome's initial world view and a welcome alternative to mainstream economics' focus on growth and equilibrium, says Steinberger.

"Most of The Limits to Growth's original conclusions still hold true," said Johan Rockström, a sustainability researcher at the Stockholm Resilience Centre and a co-author of the report, at its release.

"This is scientifically satisfactory, but for societies it's not."

The Club of Rome issued a Confidential Report, dated September 17, 1973 by Mihajlo Mesarovic and Eduard Pestel, Directors. The Confidential Report focused on the global structuring of the nations. The essence of the plan was to create 10 regions of governance. ***“And the ten horns which thou sawest are ten kings, which have received no kingdom as yet; but receive power as kings one hour with the beast.”*** -(Revelation 17:12). This allusion is also found also in Daniel 7:24). The Club of Rome report leaves no doubt this is the reference of Revelation 17:12).

1. Motivation and Objectives

The world problematique formulated by the CLUB OF ROME is not only global in nature, involving factors traditionally considered as unrelated, but also points to the crisis situations which are developing in spite of the noblest of intentions and, indeed, as their corollary.

To point out the problematique and the spectrum of critical and traumatic situations it entails is not enough; the acceptance of the reality of the problematique **MUST BE FOLLOWED BY CHANGES IF THE CONCERN IS NOT TO REMAIN PURELY ACADEMIC.**

It is necessary, therefore, to present the issues within the problematique in specific and relevant terms which requires regions interpretation of the global issues. Furthermore, a basis should be provided for the resolution of conflicts (inevitably accompanying the problematique-type situations) through cooperation rather than confrontation.

These factors have provided the motivation for initiation of the Strategy for Survival project which calls for the construction of a regionalized and adaptive model of the total world system with the following specific objectives:

- i. TO ENABLE THE IMPLEMENTATION OF SCENARIOS FOR THE FUTURE DEVELOPMENT OF THE WORLD SYSTEM which represents visions of the world future stemming from different cultures and value systems and reflecting hopes and fears in different regions of the world.

- ii. To develop a planning and options-assessment tool for long-range issues, and thereby TO PROVIDE A BASIS FOR CONFLICT RESOLUTION by cooperation rather than confrontation.

2. Basic Structure of the Model

The basic characteristics of the model are:

- I. THE WORLD SYSTEM IS REPRESENTED in terms of interacting regions with provisions made to investigate any individual country or sub-region in the context of regional and global development.

Presently the world system is represented BY TEN REGIONS:

- NORTH AMERICA
- WESTERN EUROPE
- EASTERN EUROPE
- JAPAN
- REST OF DEVELOPED WORLD
- LATIN AMERICA
- MIDDLE EAST
- REST OF AFRICA
- SOUTH AND SOUTH EAST ASIA
- CHINA

- II. In order to be able to deal with the complex of factors involved in problematique in a way which is sound, credible and systematic, a hierarchical structure has been adopted for the model in which each level in the hierarchy represents the evolution of the world system within a context defined by a given set of laws and principles.

Specifically, the levels involved are:

- GEO-PHYSICAL
- ECOLOGICAL
- TECHNOLOGICAL (MAN-MADE ENERGY AND MASS TRANSFERS)
- ECONOMIC
- INSTITUTIONAL
- SOCIOPOLITICAL
- VALUE-CULTURAL
- HUMAN-BIOLOGICAL

Such an approach enables an optimal use of confirmed scientific knowledge and available data

- III. An adequate view of the conditions in which the problematique is emerging and under which the solutions must be found require the recognition of the purposive aspects of the human community and adaptiveness of human beings.

The model of the world system will have, therefore, two parts:

- i. the so-called causal part, representing dynamical processes which follow historical patterns of development
- ii. the so-called goal-seeking part which represents purposive changes under new conditions. The goal-seeking part in turn includes two levels:
 - the decision-making or actions level
 - the norms level

The former represents the purposive response of the system while the latter represents the values and norms which constrain and condition such a response.

3. Progress in the Model Construction

The construction of the model as described in Sec. 2 and with the objectives as specified in Sec. 1 is certainly a rather complex task and the research is organized to proceed in parallel in several directions.

The overall assessment of the model status is the following:

The model has been developed up to the stage where it can be used for policy analysis related to a number of critical issues, such as:

- energy resources utilization and technology assessment
- food demand and production
- population growth and the effect of timing of birth control programs
- reduction of inequities in regional economic developments
- depletion dynamics of certain resources, particularly oil reserves
- phosphorus use as fertilizer
- regional unemployment
- constraints on growth due to labor, energy or export limitation, etc.

Specific developments which enable use of the model as described above include the following:

1. A COMPUTER MODEL OF THE WORLD ECONOMIC SYSTEM HAS BEEN DEVELOPED AND VALIDATED BY AN EXTENSIVE SET OF DATA. The model has two levels - macro and micro.

On the MACRO LEVEL the model of each region INCLUDES THE GROSS REGIONAL PRODUCT, TOTAL IMPORTS AND EXPORTS, CAPITAL AND LABOR PRODUCTIVITY AND VARIOUS COMPONENTS OF FINAL DEMAND SUCH AS PUBLIC CONSUMPTION, GOVERNMENT EXPENDITURE, AND TOTAL INVESTMENT.

ON THE MICRO LEVEL EIGHT PRODUCTION SECTORS ARE RECOGNIZED:

- AGRICULTURE MANUFACTURING

- FOOD PROCESSING
- ENERGY
- MINING
- SERVICES
- BANKING AND TRADE
- RESIDENTIAL CONSTRUCTION

The input-output framework is used for the intermediate demands. A FULL SCALE MICRO TRADE MATRIX ALSO HAS BEEN DEVELOPED.

2. A WORLD POPULATION MODEL HAS BEEN CONSTRUCTED IN TERMS OF THE SAME REGIONS AS THE ECONOMIC MODEL. The model has been validated by the data available. In each region the population structure is represented in terms of four age groups with appropriate delays which make possible assessment of population momentum and assessment of the effectiveness of implementation of various population control measures.
3. AN ENERGY MODEL HAS BEEN CONSTRUCTED which gives for each region the consumption and production of energy and interregional exchange of energy resources as a function of economic factors.

Energy is treated both in composite terms and in reference to individual energy sources, namely solid fuel, liquid fuel, nuclear, gas and hydro.

4. A FOOD PRODUCTION AND ARABLE LAND USE MODEL HAS BEEN CONSTRUCTED which allows the assessment of a number of food related issues including:
 - the need and availability of phosphorus required for intensive agriculture
 - THE CONSEQUENCES OF TIMING AND MAGNITUDES OF NATURAL DISASTERS SUCH AS DROUGHT, CROP FAILURE DUE TO DISEASE, ETC.
5. A MAJOR CONCERN IN THE APPLICATION OF THE COMPUTER MODEL is its proper utilization so as to avoid dependence on the deterministic aspects of model operation. In order to avoid this interactive method of computer simulation analysis has been developed.

THE METHOD REPRESENTS A SYMBIOSIS OF MAN AND COMPUTER IN WHICH THE COMPUTER PROVIDES THE LOGICAL AND NUMERICAL CAPABILITY WHILE MAN PROVIDES THE VALUES, INTUITION AND EXPERIENCE.

The method utilizes an option specification and selection program which enables the policy analyst or decision-maker to evaluate alternative options on various levels of the decision process, i.e., with respect to goals, strategies, tactical and implementation factors.

SPECIAL ATTENTION IS PAID TO THE NORM CHANGING PROCESSES.

6. Progress in Application. THE MODEL HAS BEEN USED both for the assessment of alternative scenarios for future regional and global developments (under different regional conditions) as well as in the interactive mode selection of policy options (specifically for the energy crises issues in developed regions).

OUR EFFORTS IN THE IMMEDIATE FUTURE WILL BE CONCENTRATED ON FURTHER USE OF THE ALREADY DEVELOPED MODEL.

THE PLANS INCLUDE EMPHASIS IN THE FOLLOWING THREE DIRECTIONS:

- i. Assessment in the changes over time of the span of options available to solve some major crisis problems.
- ii. IMPLEMENTATION of the regional models in different parts of the world and their connection via a satellite communication network for the purpose of joint assessment of the long term global future by teams from the various regions.
- iii. Implementation of the vision for the future outlined by leaders from an underdeveloped region in order TO ASSESS with the model EXISTING OBSTACLES AND THE MEANS WHEREBY THE VISION MIGHT BECOME REALITY.

Since 1954, the European Union has become a reality. That is not to say it has been successful. To the contrary, the EU is flawed and balance has yet to be achieved due the major issue of currency inequity. The German/Vatican introduction of Muslims from the Middle East has further abrogated open wounds from the World War II era. This has led to cultural and ethnic undermining of European culture in such a way as to create more disharmony than cohesiveness throughout Europe. Paris today is the scum of France.

Will the global elite continue to divide the world? Today, the creation of an African Union is underway. As with the European Union, the African Union is to have a common currency, along with a unified military.

As Jerome Corsi reports,

"Advancing the movement toward economic and political globalism, the African Union is moving down the path of regional economic integration, with the expected end result of continental economic and political integration."

"And while the AU is still in a formative state, it's already officially designated by an emblem, a flag, an anthem, a central bank, and unified continental military force."

"The goal of the African Central Bank is to create an African Single Currency. African Union planners are currently calling the African continental currency the 'Gold Mandela.'"

The creation of regional currencies, and the removal of "unwanted currencies" are necessary, according to Benn Steil.

Writing in the Council on Foreign Relations publication, *'Foreign Affairs'*, Steil states that,

"The world needs to abandon unwanted currencies, replacing them with dollars, euros, and multinational currencies as yet unborn."

"Countries should abandon monetary nationalism," says Steil.

Members of the Council on Foreign Relations have made statements regarding the goals of the Council, which mirror current agendas of the group.

"The Council on Foreign Relations is the American Branch of a society which originated in England... (and) ...believes national boundaries should be obliterated and one-world rule established."

"The main purpose of the Council on Foreign Relations is promoting the disarmament of U.S. sovereignty and national independence and submergence into an all-powerful, one world government."

In 1999, the Bilderberg group met in Sintra, Portugal, where they discussed plans for a new economic world order. Thanks to Jim Tucker's infiltration of the secretive group, we are able to get an idea of what was talked about inside the meeting. The late Jim Tucker made it his task to attend every annual Bilderberg group meeting. Jim Tucker died a few years ago and snooping out the annual gathering.

Writing in his book, *'Bilderberg Diary'*, Tucker says,

"Kenneth Clarke, a member of the British Parliament and former chancellor for the exchequer, had called for a new 'international financial architecture' at the 1999 meeting of Bilderberg. The world should have three major regional currencies, Clarke told his Bilderberg colleagues. The first is already on the world scene: The European Euro.

And Britain will join in the European common currency, he said. Clarke said he would like to see the pound grow weaker to facilitate Britain's entry into the common currency... The next step is toward a second great regional currency in the Western Hemisphere, Clarke said. The Brexit by the UK has damaged that goal.

The 'amerijo' will come about by the 'dollarization' of Latin America."

Tucker continues,

"Bilderberg colleagues agreed that the emerging regional currencies, which will be identified with no specific country, will do much to eliminate "nationalism" and the "antiquated notions of sovereignty."

The elite's plans have changed slightly over the years, but at their core they remain the same. The "amerijo" discussed by Bilderberg in 1999 appears to have transformed into the common currency for North America called the "Amero," as coined by Herbert Grubel, and supported by Robert Pastor.

Steve Previs spoke of the Amero and it's far reaching implications for Canada, Mexico and the United States on CNBC.

The proposed North American Union has not been popular among informed Americans and Canadians.


This has not gone un-noticed to the elite. As reported here last week (see below report), a conference was held in 2002 during which recommendations were given by CFR members on how to best propagandize Americans into a "North American Consciousness."

The ultimate goal?

In 1973 the Club of Rome issued a report titled the *"Regionalized and Adaptive Model of the Global World System."* In this report a map is shown which divides the world into 10 political/economic regions. The very map created in 1973 appears below on the next page.

Will the North American Union fall in line with the elite's ultimate goal? Only time will tell. When President Trump removed the U.S. from the Trans Pacific Partnership, he set back the globalist agenda, at least in the short range. Keep in mind with a national election every four year, the U.S. is only one election away from a major change,

In 1973, a computer program was developed at MIT to model global sustainability. Instead, it predicted that by 2040 our civilization would end.



The prediction, which recently re-appeared in Australian media, was made by a program dubbed World One.

It was originally created by the computer pioneer Jay Forrester, who was commissioned by the Club of Rome to model how well the world could sustain its growth.

The Club of Rome is an organization comprised of,

- thinkers
- former world heads of states
- scientists
- UN bureaucrats,

...with the mission to,

"promote understanding of the global challenges facing humanity and to propose solutions through scientific analysis, communication, and advocacy."

What World One showed was that by 2040 there would be a global collapse if the expansion of the population and industry was to continue at the current levels.

As reported by the Australian broadcaster ABC, the model's calculations took into account trends in,

- pollution levels
- population growth
- the amount of natural resources
- the overall quality of life on Earth

The model's predictions for the worsening quality of life and the dwindling natural resources have so far been unnervingly on target.

In fact, 2020 was the first milestone envisioned by World One. That's when the quality of life is supposed to drop dramatically.

The broadcaster presented this scenario that will lead to the demise of large numbers of people:

"At around 2020, the condition of the planet becomes highly critical."

If we do nothing about it, the quality of life goes down to zero. Pollution becomes so seriously it will start to kill people, which in turn will cause the population to diminish, lower than it was in the 1900.

"Sovereignty of nations is no longer absolute," King told ABC. "There is a gradual diminishing of sovereignty, little bit by little bit. Even in the big nations, this will happen."

How did the program work?

World One, the computer program, looked at the world as one system.

The report called it,

"an electronic guided tour of our behavior since 1900 and where that behavior will lead us."

The program produced graphs that showed what would happen to the planet decades into the future. It plotted statistics and forecasts for such variables as population, quality of life, and the supply of natural resources, pollution, and more.

Following the trend lines, one could see where the crises might take place.

Can we stave off disaster? I would not put money on this from the chart below.



2. Provoke a Terrified Reaction





Q: What do you consider the leading threat to the environment?

A: *"Human population growth is probably the single most serious long-term threat to survival. We're in for a major disaster if it isn't curbed--not just for the natural world, but for the human world. The more people there are, the more resources they'll consume, the more pollution they'll create, the more fighting they will do. We have no option."*

"If it isn't controlled voluntarily, it will be controlled involuntarily by an increase in disease, starvation and war."

Address to the Joint Meeting of the All-Party Group on Population and Development and the All-Party Conservation Committee in London, March 11, 1987.

"I do believe... that human population pressure--the sheer number of people on this planet - is the single most important cause of the degradation of the natural environment, of the progressive extinction of wild species of plants and animals, and of the destabilization of the world's climatic and atmospheric systems."

“The simple fact is that the human population of the world is consuming natural renewable resources faster than it can regenerate, and the process of exploitation is causing even further damage. If this is already happening with a population of 4 billion, I ask you to imagine what things will be like when the population reaches six and then 10 billion... “

“All this has been made possible by the industrial revolution and the scientific explosion and it is spread around the world by the new economic religion of development.”

Address at the Salford University Degree Ceremony, July 16, 1973.

“There may be disagreements about the time scale, but in principle there can be little doubt that the population cannot go on increasing indefinitely. Resources presently being used will not last forever and pollution in its broadest sense, unless severely checked, is bound to increase with population and industrial activity.”

“Sustainable Development” is **code-words** for “Depopulation” by any and all means possible! It is an integral part of Agenda 21 and Agenda 2030, etc.

Back in 2013, after Prince Charles endorsed the conclusions of their study, Paul Ehrlich, author of *‘The Population Bomb’* twittered *“I wish our leaders were as far-sighted”*, ...to which one of Ehrlich’s followers responded, *Suicide on a grand scale needs reconsidering.*” In their latest study entitled *‘Can a Collapse of Global Civilization be Avoided?’*, biologists Paul R. Ehrlich and his wife repeated their decade-long mantra, namely that global population growth is certain to collapse civilization as a whole, and only a concerted global effort to reduce fertility may avert the feared catastrophe.

Comments such as these really show that morality is nowhere to be found in the vicinity of these neo-Malthusian characters. The fact that Prince Charles felt compelled to endorse the conclusions of this report only reaffirms that his lineage is still of the opinion that people are a scourge on the earth, or as his father Prince Philip stated, a plague.
