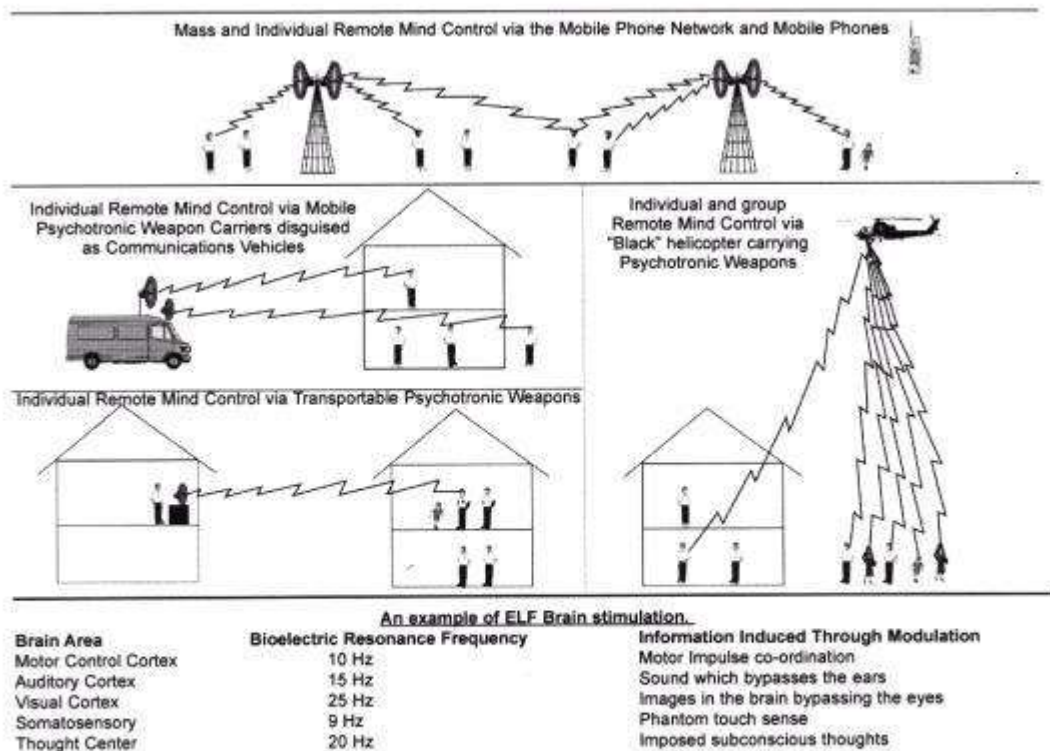

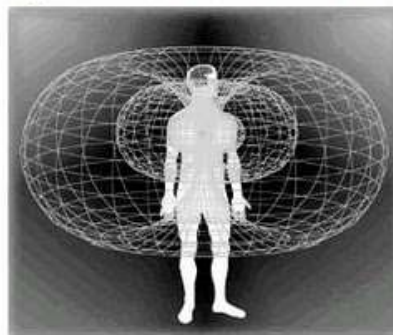
Journalist Curtis Waltman was writing to the Washington State Fusion Center (WSFC), a joint operation between Washington State law enforcement and the federal government to request information about Antifa and white supremacist groups. He got responses to the questions he asked, but also a file titled “EM effects on human body.zip.” Inside, were documents like this:

**Spectrum:** Emission or wave propagation (Electronic Signal). To make communication, to identify any object emitting frequency. Human body emit very Low electronic signal as temperature/heat (Brain Wave - Delta, Theta, Alpha, Beta, Gamma etc).

- Bio\_Electromagnetic Field which is unique for every human body.

This is Electronic signal frequency ID of each object.

Radar Electronic signal detect the object(Human Body) for modulation human brain wave.

At least some of the images appear to be [part of an article in Nexus magazine](#) describing a 1992 lawsuit brought by one John St. Clair Akewi against the NSA. Akewi claimed that the NSA had the “ability to assassinate US citizens covertly or run covert psychological control operations to cause subjects to be diagnosed with ill mental health” and was documenting their alleged methods.

‘Nexus’ was, and still is, an Australian magazine focused on the unexplained, conspiracy theories, alternative medicine and the like. It covered Akewi’s case in 1996 but was unable to get Akewi to discuss it further: “I tried ringing Mr. Akwei to find out what was the out-come, if any, of his court case. He firmly but kindly told me that he could not speak about anything to do with the case over the phone and hung up,” reads an editor’s note at the end of the article.

The federal government has absolutely [experimented with mind control](#) in a variety of methods, but the documents here do not appear to be official.

Waltman had no idea why these documents were included in his request and isn't sure why the government is holding them. The WSFC did not respond to requests for more information."

Last week, End Times author Paul McGuire claimed on his [radio show](#) that the United States government has mind-control technology that can be used to "cause a mass riot where people are angry or hear voices," and was used during the Gulf War to convince Iraqi soldiers that God had told them to surrender.

McGuire, co-author of the book *'Trumpocalypse: The End-Times President, a Battle Against the Globalist Elite, and the Countdown to Armageddon,'* was discussing the supposed dangers presented by **5G** technology when he claimed that the government's mind-control technology can be activated through AM radio waves, as well as cellphone signals.

According to McGuire, the American military used this technology during Operation Desert Storm. McGuire referred to it as "voice to God" technology, claiming that mind-control messaging conveyed through the radio frequency caused Iraqi soldiers to hear voices urging them to surrender to the American forces.

*“The American military, using mind-control technology, attached an invisible rider on the AM frequency ... that all these extremist Muslims would be listening to,” McGuire said. “And they knew that American soldiers wouldn’t be listening to this station because Americans don’t speak the language and they wouldn’t be into the music, so they were able to target the population.”*

He continued, *“The rider frequency that they attached on the AM signal frequency contained what is called ‘voice to God’ technology where all the people listening to this music station, Iraqi music station, actually heard in their heads, they couldn’t hear it audibly, but they heard the voice of God commanding them to surrender to the Americans and commanding them to lay down their weapons.”*

McGuire warned his listeners that the same thing *“could be done not just with an AM signal but with a cellphone signal.”*

In a couple of articles where I was writing about **5G** wireless energy, I noted that it is possible to control a population with putting voices into the minds of people. People might have scoffed at Paul McGuire’s remarks; however, I can tell you this technology is quite real. Dr. Barry Trower, a former UK specialist in radar and electronics knows with certainty of this capability and has spoken of it in videos over the past decade.

What if the government could change people’s moral beliefs or stop political dissent through remote control of people’s brains?

Sounds like science fiction, right? Well, a leaked document reveals that the U.S. government, through DARPA research, is very close to accomplishing this.

Activist Post was recently contacted by an anonymous whistleblower who worked on a secret ongoing mind-control project for [DARPA](#). The aim of the program is to remotely disrupt political dissent and extremism by employing *“Transcranial Magnetic Stimulation”* (TMS) in tandem with sophisticated propaganda based on this technology. TMS stimulates the temporal lobe of the brain with electromagnetic fields.

The program, conducted by The Center for Strategic Communication, is based at Arizona State University. The DARPA funding for this project can be confirmed on the ASU website. The head of the project, Steve Corman, has worked extensively in the area of strategic communication as it applies to terrorism and “extremism” – or what could be called *“the war of ideas.”*

Corman’s latest project *Narrating The Exit From Afghanistan* and his many presentations make it quite obvious that the mission is to shape the narrative and

literally change people's minds. Lest one believe it will be contained to overseas extremists, we should keep in mind that the word *extremist* is increasingly used domestically. The *dissenters* of yesterday could easily become the *terrorist sympathizers and supporters of political violence* tomorrow. This DARPA research brings about many ethical questions and dilemmas. Mainly, this research aims to literally induce or disrupt the operation of narratives within the brain. In other words, this research aims to stop individuals from thinking certain thoughts and make others believe things they normally would not believe. This research has tremendous interrogation possibilities and could potentially be used to more successfully spread propaganda or stop political upheaval to an unsuspecting public.

This research is being conducted by The Center for Strategic Communication at ASU and is entitled [“Toward Narrative Disruptors and Inductors: Mapping the Narrative Comprehension Network and its Persuasive Effects”](#) A detailed overview of the project can be found in the document below. Highlights include:

- In phase 3 of the research, the research group will *“selectively alter aspects of narrative structure and brain functions via Transcranial Magnetic Simulation (TMS) to induce or disrupt selected features of narrative processing.”* (Page 16, emphasis added)

TMS is a very powerful tool used to impair the brain functioning of individuals. See the videos below for a brief demonstration of the effects of TMS.

- Once the research group determines which parts of the brain are associated with cognitive reasoning and narrative comprehension, they will attempt to impair those sections in order to “create a fundamental basis for understanding how to disrupt or enhance aspects of narrative structure and/or brain functioning to minimize or maximize persuasive effects on subject proclivity to engage in political violence.” (Page 23)
- Once it is determined that disruption of certain portions of the brain can enhance persuasive messaging, individuals can be persuaded to do things they normally would not do and believe things they normally would not believe. This could include something as simple as telling a closely guarded secret, to believing in government propaganda, or even committing a violent act. The group writes on page 26, *“once we have produced a narrative comprehension model [i.e., how individuals comprehend stories and persuasive messages], end users [aka the government] will understand how to activate known neural networks (e.g., working memory or attention) and positive behavioral outcome (e.g., nonviolent actions) nodes with strategic communication messages as a means to reduce incidences of political violence in contested populations.”* The group will investigate *“possibilities for literally disrupting the activity of the NCN [narrative comprehension network] through Transcranial Magnetic Stimulation.”* (page 30) [text added]

- The group is so confident that they will be able to induce or disrupt the operations of narratives in the brain, that they say on page 26 that the research “*offers the capability to induce or disrupt the operation of narratives in the brain, and develops the capability to induce narrative validity [i.e., the believability of a particular narrative/message], transportation [i.e., the ability to be engaged by a narrative], and integration [i.e., associating a particular narrative with a larger, more culturally specific narrative] with certainty.*” [text added]
- The group gives the following example of this projects usefulness: “*If it is the case that activation in one particular neural network enables people to connect personal narrative to master narratives [i.e., cultural narratives], by disrupting activity in that brain area, we should be able to selectively impair that specific aspect of narrative processing while holding other meaning making processes constant, effectively creating a ‘narrative disruptor.’ Not only would this be an important finding in the science of neural networks and narrative persuasion, but would also have considerably practical and strategic importance.*” (page 40) [text added]

Essentially, the research aims to literally disrupt how people think and comprehend ideas and messages.

- Further, and perhaps even more terrifying, on page 40, the group writes, “*Mechanical disruptions of narrative processing may be, ultimately, replicated in through targeted strategic communication campaigns that approximate the narrative disruptions induced via magnetic stimulation.*” So, after figuring out which parts of the brain are activated by particular persuasive messages and propaganda, the government can test out messages that only activate particular portions of the brain and not others, in order to persuade individuals to believe or not believe something. Essentially, they are attempting to [modify brain functioning](#) without TMS, and only words. One can only imagine the strategies the government could use with this technology. They could make the public believe almost anything that suits their needs. It could literally lead to mass brainwashing.

But what does this mean, practically? It means that if this research succeeds, the government will be able to modify how one personally thinks. They could strap you in a chair, put a machine to your head, turn off parts of your brain, introduce a persuasive message, and make you believe it.

Further, through extensive research, they may be able to replicate the machine’s brain disrupting functioning simply through carefully crafted and researched persuasive messages and propaganda. They can use brain imaging to determine which portions of the brain are activated when a particular message is presented to an individual, and if the “right” portions are activated, they know the message will circumvent one’s mental reasoning and lead to almost automatic acceptance. With enough data, the government

could spread propaganda through the media that people will almost automatically believe, whether it is true or not.

In terms of interrogation possibilities, Transcranial Magnetic Stimulation can be forced upon individuals to make them believe certain things, say certain things, and perhaps admit to acts they did not actually commit (as the TMS can induce narrative validity), or commit acts they normally would not commit.

The government is literally trying to brainwash the public. This is not science fiction. Technology has made it possible to induce and disrupt cognitive functioning in individuals. In the future, your thoughts may not be your own, but ones that have been implanted into your brain through exceedingly successful and validated propaganda.

Meeting notes indicate concern about how the project will be perceived, particularly the focus on the Christian/Muslim element. A few years ago Bill Gates of Microsoft delivered a presentation to a group of CIA people showing the way how the spiritual or faith belief could be changed by removing a specific portion of the brain referred to as the God gene.

[Toward Narrative Disruptors and Inductors: Mapping the Narrative Comprehension Network and its Persuasive E...](#)

The web site "Live Science" wrote an article in May, 2019 about the serious nature of DARPA's research.

DARPA, the Department of Defense's research arm, is paying scientists to invent ways to instantly read soldiers' minds using tools like genetic engineering of the human brain, nanotechnology and infrared beams. The end goal? [Thought-controlled weapons](#), like swarms of drones that someone sends to the skies with a single thought or the ability to beam images from one brain to another.

This week, DARPA (Defense Advanced Research Projects Agency) announced that six teams will receive funding under the Next-Generation Nonsurgical Neurotechnology (N3) program. Participants are tasked with developing technology that will provide a

two-way channel for rapid and seamless communication between the human brain and machines without requiring surgery.

"Imagine someone who's operating a drone or someone who might be analyzing a lot of data," said Jacob Robinson, an assistant professor of bioengineering at Rice University, who is leading one of the teams. [[DARPA's 10 Coolest Projects: From Humanoid Robots to Flying Cars](#)]

*"There's this latency, where if I want to communicate with my machine, I have to send a signal from my brain to move my fingers or move my mouth to make a verbal command, and this limits the speed at which I can interact with either a cyber system or physical system. So the thought is maybe we could improve that speed of interaction."*

That could be crucial as smart machines and a tidal wave of data threaten to overwhelm humans, and could ultimately find applications in both military and civilian domains, Robinson said.

### **Advancing mind control**

While there have been breakthroughs in our ability to read and even write information to the brain, these advances have generally relied on brain implants in patients, allowing physicians to monitor conditions like epilepsy.

Brain surgery is too risky to justify such interfaces in able-bodied people, however; and current external brain-monitoring approaches like electroencephalography (EEG) — in which electrodes are attached directly to the scalp — are too inaccurate. As such, DARPA is trying to spur a breakthrough in noninvasive or minimally invasive [brain-computer interfaces](#) (BCIs).

The agency is interested in systems that can read and write to 16 independent locations in a chunk of brain the size of a pea with a lag of no more than 50 milliseconds within four years, said Robinson, who is under no illusion about the scale of the challenge.

*"When you try to capture brain activity through the skull, it's hard to know where the signals are coming from and when and where the signals are being generated," he told Live Science. "So the big challenge is, can we push the absolute limits of our resolution, both in space and time?"*

### **Genetically tweaking human brains**

To do this, Robinson's team plans to use viruses modified to deliver genetic material into cells — called viral vectors — to insert DNA into specific neurons that will make them produce two kinds of proteins. [[Flying Saucers to Mind Control: 22 Declassified Military & CIA Secrets](#)]

The first type of protein absorbs light when a neuron is firing, which makes it possible to detect neural activity. An external headset would send out a beam of infrared light that can pass through the skull and into the brain. Detectors attached to the headset would



then measure the tiny signal that is reflected from the brain tissue to create an image of the brain. Because of the protein, the targeted areas will appear darker (absorbing light) when neurons are firing, generating a read of brain activity that can be used to work out what the person is seeing, hearing or trying to do.

The second protein tethers to magnetic nanoparticles, so the neurons can be magnetically stimulated to fire when the headset generates a magnetic field. This could be used to stimulate neurons so as to induce an image or sound in the patient's mind. As a proof of concept, the group plans to use the system to transmit images from' [the visual cortex](#) of one person to that of another.

*"Being able to decode or encode sensory experiences is something we understand relatively well," Robinson said. "At the bleeding edge of science, I think we are there if we had the technology to do it."*

### **Talking to drones**

A group from the nonprofit research institute Battelle is taking on a more ambitious challenge. The group wants to let humans control multiple drones using their thoughts alone, while feedback about things like acceleration and position go directly to the brain. *"Joysticks and computer cursors are more or less one-way devices,"* said senior research scientist Gaurav Sharma, who leads the team. *"But now we're thinking of one person controlling multiple drones; and it's two-way, so if the drone is moving left, you get a sensory signal back into your brain telling you that it's moving left."*

The group's plan relies on specially designed nanoparticles with magnetic cores and [piezoelectric outer shells](#), which means the shells can convert mechanical energy to electrical and vice versa. The particles will be injected or nasally administered, and magnetic fields will guide them to specific neurons.

When a specially designed headset applies a magnetic field to the targeted neurons, the magnetic core will move and exert stress on the outer shell to generate an electrical impulse that makes the neuron fire. The process also works in reverse, with electrical impulses from firing neurons converted into tiny magnetic fields that are picked up by detectors in the headset.

Translating that process into controlling drones won't be simple, admits Sharma, but he's relishing the challenge DARPA has laid out. *"The brain is the final frontier in medical science,"* he said. *"We understand so little of it, which is what makes it very exciting to do research in this area."*

I remember the late Jim Keith writing about experiments into remote mind control technology. - The large black top of the Federal Building in San Francisco looks like a giant air-conditioning vent, 50 feet tall, comprising the entire top of the building. It is actually a radar, microwave, and radio transparent shield for an array of communications devices on the roof of the building. Such "blinds" on top of government

buildings are nothing unusual, it isn't necessary to visually remind everybody that such buildings also are likenesses of Orwell's Ministry of Information (read, CIA).

The bottom line of this short article should serve as reminder that one needs to be aware that **5G** technology provides enhanced abilities to do things that once were in the realm of science fiction. Recently it was noted some people who were solid resisters of the toxic vaxx gene-therapy have experienced thoughts that encouraged them to get the shot and that it was not that big of a deal. Such a radical change in one's view could be the result of various vectors but because of Electroporation we know that DNA and pathogenic nanoparticles are in fact possible, and have been used to eliminate people. Dr. Kathleen Horton was one of those singled out for elimination.

Dr. Horton realized that during her time at the University of Oxford, she had become the victim of criminal operations by MI5, which used her in non-consensual human experimentation and covert sex trafficking. Upon this realization, she took MI6 (called SIS these days), MI5 and GCHQ to court but was thwarted by the defendants who sabotaged her case in every possible way, including a death threat on the way to court in London that MI6 executed with an assassination attempt 3 days later in Switzerland. In the end, the court case was "terminated" and attempts were made to make it disappear off the record.

After this experience, Dr. Horton tried to withdraw but the attacks only escalated further until it became clear that they would not stop until the Secret Services would have succeeded in murdering Dr. Horton.

In an attempt to understand what was happening, Dr. Horton travelled to Manchester to attend the court case of Dr. Stephen Frost v MoD at the end of October 2016. There, Dr. Horton was brutally assaulted in the hotel room with Directed Energy Weapons. Upon reporting the assault to police the Greater Manchester Police lied to Dr. Horton and sent her back to her hotel room promising to send a police officer to the scene. There, MI5 waited until they expected her to have gone to bed and then staged criminal intimidation theatre by faking the call out of a "mental health ambulance" (no such thing existence in the UK) and pretended to try to section Dr. Horton.

After this experience, Dr. Horton went public on the Richie Allen Show about the Directed Energy Weapon assaults on her by the Secret Services. Through this publicity, she was put into contact with several other women, including Karen Melton-Stewart, who had worked almost 30 years for the NSA and had become a whistleblower about internal corruption. Through the exchange it became clear that the Secret Service criminality was identical between the US and Europe and there were indications that it was founded on a global genocide programs run by the Secret Services worldwide for "population control" and "sustainability".

In May 2017, through the work of the Joint Investigation Team, Dr. Horton discovered that she had been covertly implanted with military bio-technology and neurotechnology and used as a torture and mutilation slave for almost two decades.

In spring 2016, when the physical attacks with Directed Energy Weapons on her became insane, Dr. Horton fled to London and was desperately seeking an emergency injunction from the London High Court against British Intelligence. Her court case

was violently sabotaged by British Secret Services who committed every imaginable criminal act to stop her litigation and disappear it off the record:

- The court case was not listed on the day as it should have been.
- The High Court did not give the case a case number. (This is why the first two transcripts do not appear with a case number).
- The transcripts of the hearing were falsified by British Intel to remove questions by the judge and Dr. Horton's answer.
- British Intel's barrister openly lied to the court.
- Dr. Horton received a death threat on the way to the first hearing and survived an assassination attempt 3 days later. The number 3 (and the number 7) is often used as cartel-signaling by Intel.
- At the 3rd hearing Judge Holgate terminated the case as "frivolous or vexatious" and used the pretext that it was not even a case to start with because, allegedly, it didn't contain a claim. The reason for the lack of claim was that none of Dr. Horton's court documents had the title "Particulars of Claim". This judgement went against the previous two High Court judges, Justice Spencer and Justice Edis, who did not have a problem recognizing the content of the claim. It also went against the rule that when litigants are forced to represent themselves more attention has to be given to content than form by the judge. This rule was confirmed to Dr. Horton by an internationally known war crimes judge.

In retaliation just for daring to approach the High Court, Dr. Horton received a death threat from MI6 who were reading her email live and listening to all her phone conversations and knew that she was travelling to London to go to the High Court. An MI6 agent approached her in gas-lighting theatre on her way from Heathrow airport to her hotel after midnight, and after involving her in small talk said out of the blue "*there is crime in every country, in some it is just well hidden*"; he repeated that sentence and after a meaningful pause he asked "*Did they kill Diana?*", making a reference to Princess Diana and her death that pointed to MI6 as her killers. The implication was that if MI6 was willing to murder a Princess, they would just as easily murder Dr. Horton.

Straight after the first hearing of her court litigation, MI6 stalked Dr. Horton demonstratively all the way back to her hotel. There, the attackers waited until she came out of her shower wrapped in a towel before assaulting her with intense machine-gunning from Directed Energy Weapons into the back of her head so that she collapsed

from pain. The emphasis on nudity and humiliation in Secret Service attacks is a recurring theme in the victim cases and appears to result from mental illness, sexual depravity and sadistic psychopathy that is rampant in Western Secret Services and the military. The attackers repeated the attack a second time when Dr. Horton's husband arrived back at the hotel as she stood up to tell him what had happened. She collapsed again in pain in front of her husband from the agonizingly painful machine-gunning.

Three days later, Dr. Horton and her husband survived an assassination attempt on the Swiss motorway as Dr. Horton, the driver of the car, was machine-gunned in the head as from a car in front as they were travelling at 100km/h through a tunnel. Had Dr. Horton lost consciousness during the attack as intended, she and her husband would have crashed in the tunnel and likely died in an accident reminiscent of the death of Princess Diana.

On the day of the attack, a life-size black plastic goat was placed by Ms. Nitschke a neighbor of Dr. Horton on a flat roof of a neighboring property in a prominent place that could be seen from almost every room of Dr. Horton's home. Comparison with other victim cases identifies this as a Satanic symbol of death that the Secret Services like to harass their victims with. Subsequently, the mutilation of Dr. Horton with Directed Energy Weapons became even more psychopathic.

### **Investigative Research**

As a result of the refusal by the police and the courts to assist, Dr. Horton was forced to investigate these rampant crimes herself. She came across the testimony of hundreds of victims online who were begging for help like her on YouTube, Facebook on Twitter. All of them were being mutilated like she was and had also been maliciously treated by the authorities. It was at that point that Dr. Horton realized that **the police, judiciary and secret services are all knowingly complicit in a global Nazi extermination program that is using Directed Energy Weapons to place victims into invisible concentration camps and commit silent genocide.**

Dr. Horton gradually realized that she, as well as her family and friends, were being used as target practice for modern military weapons and subjects of human experimentation with non-consensual body implants and neurotechnology. The crimes against her and her family and friends were committed with egregious impunity because all police services, Intelligence Agencies and courts were in *Deep Capture* by a global criminal network that owned the Secret Services and had infiltrated every area of public life.

Dr. Horton as well as her family members and those of her friends experienced brutal assaults and survived assassination attempts. Dr. Horton was permanently mutilated and repeated brutal premeditated assaults and had to begin fighting for her life.

Dr. Horton also discovered that she had been non-consensually implanted without her knowledge with microchips. The radio-frequency emissions from these illegal chip implants that form an interconnected system, called a *Body Area Network* in the

scientific literature, were measured by experts in a professional Faraday cage at a Belgian university.

She also discovered that members of her family and friends had equally been implanted.

Dr. Horton has begged for help from the human rights charities, Swiss & UK & German police, Swiss criminal police, Swiss military police, the German Federal Crime Squad BKA, the Swiss & UK Attorney Generals, the UK Investigatory Powers Tribunal, the Heads of MI5 & BND and the German ambassador to Switzerland. All committed dereliction of duty by refusing to help. The police even took active steps to intimidate her.

### **The Joint Investigation Team**

As a result of having been let down by all law enforcement agencies in 3 countries and having come across so many victim reports that it became clear that there were larger genocide programs in action in Europe and the U.S, Dr. Horton linked up with 4 other high-profile women who were victim of these attacks and founded the [Joint Investigation Team US-Europe](#) looking into Directed Energy Weapons, military neuro/biotechnology and systemic corruption.

The Joint Investigation Team (JIT) publishes a weekly public interest broadcast where they report about the ongoing investigation and the crimes committed by the Secret Services and the military, called the [Techno Crime Fighters' Forum](#) which is broadcast Thursday's at 11am-1pm ET / 4-6pm UK time / 5-7pm CET.

### **The Assaults & Mutilation**

Since 2011, Dr. Horton has been stalked and harassed continuously. Her private life has been under intrusive and overt surveillance and interference. All her communications (voice, phone, email etc.) have been intercepted and sometimes overtly acted upon by agents. Furthermore:

- Her home was broken into countless times.
- Her computers were hacked.
- Her website was sabotaged and her email was service taken offline.
- Her private sex life was commented on by strangers in the street.
- Two of her business endeavors was destroyed.

- Since January 2016, she is being mutilated with Directed Energy Weapons 24/7.

### **Directed Energy Weapons**

The microwave beams from Directed Energy Weapons with which Secret Services target their victims, which number in the hundreds of thousands, are invisible, penetrate walls and are so intense that it hurts. Imagine putting your hand in your microwave; then focus that into a beam and aim it at your face.

Most of the time, Dr. Horton is assaulted inside her home. However, she is also being attacked spectacularly in public. Dr. Horton is shot at painfully from tail-gating and swarming cars of members of the criminal networks. Dr. Horton is also assaulted at professional venues. (For example, when she attended a HR & consultancy fair, *Personalmesse-Nord*, in Hamburg in April, she was literally shot in the head twice! The second time, it was so intense that she lost control of her right eye-lid and it began to flutter with the muscles around her eyes contracting uncontrollably.

### **What on Earth are Directed Energy Weapons?**
