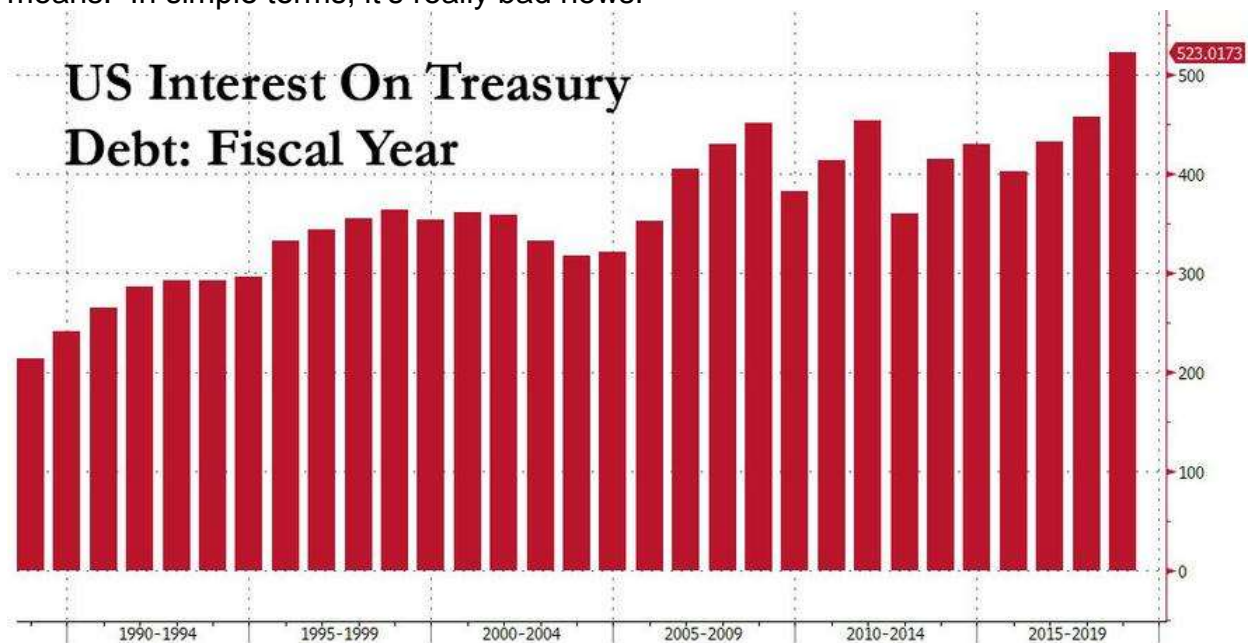


The End of the (Rothschild Ponzi Scheme) U.S. Federal Reserve Bank Will Not Occur!

As the market's attention gradually turns to rising rates and interest expense, one number that will stick out is the following: in 2018 the amount spent on interest on US federal debt hit a record high of just over **\$523 billion**. Anyone with a variable-rate interest loan (business, mortgage, credit card) will completely understand what this means. In simple terms, it's really bad news!



The federal government Fiscal Year runs from October 1st to September 30th and so we are three-fourths of the way through Fiscal Year 2019.

Another problem is that this rate is artificially low as it reflects historical funding cost as the average 10Y yield for all of 2017 was close to 2.3%. Compare that to current yield of 3.23%, which is already 39% higher. With sharp rate moves higher across the curve every incremental auction which will roll over debt into a much higher cash interest expense. If you pay much attention to President Trump's jaw-boning the Federal Reserve System in recent months about interest rates, this will help you understand President Trump using his bully pulpit to pressure the Fed to lower rates.

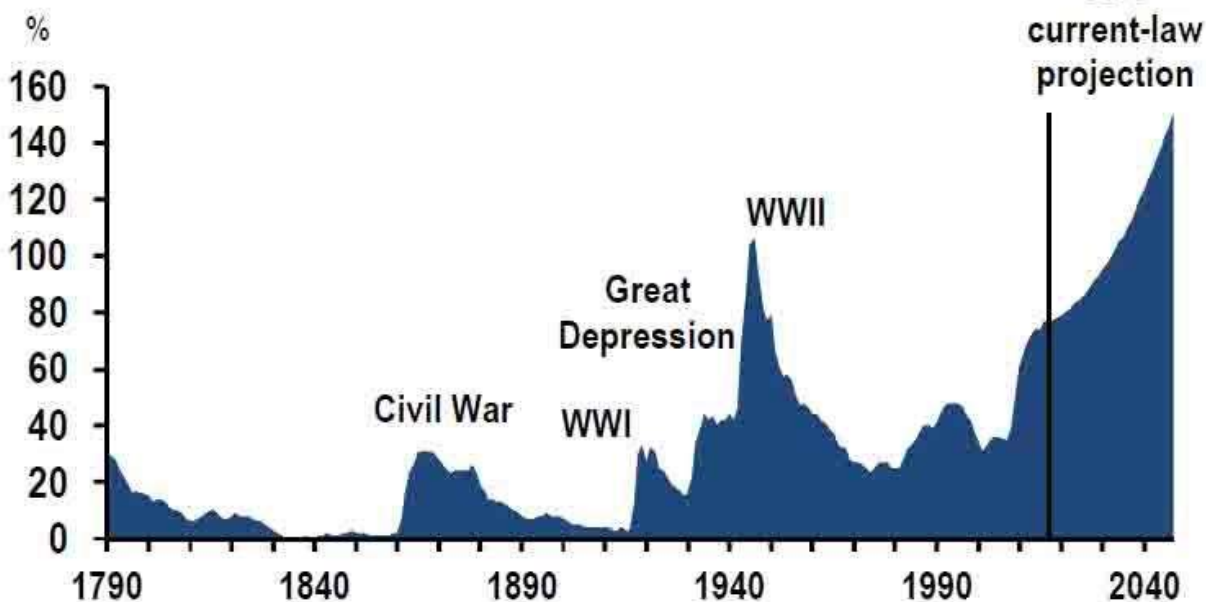
We keep hearing that President Trump plans to take over the Fed, i.e., nationalize the Fed. It is possible, but only if you have the assets to keep from being foreclosed on, otherwise the House of Rothschild will eventually want to execute asset forfeiture proceedings. The other option has to do with what I was addressing in my

series, **"There Are No Statute of Limitations on Fraud!"** As I noted in the closing chapters of the series, I came to the conclusion that President Trump was doing one of two things, deliberately accelerating the death spiral or complicit with the Rothschild's, and that President Trump was merely doing what previous presidents were doing before, intentionally bankrupting the nation. Elder Bush 41, Clinton, Son Bush 43, and Obama were doing exactly what someone planning on filing for bankruptcy would do; i.e., go out and max out their credit cards. In personal bankruptcy, these kinds of debts are not likely to go after what one used their credit cards to purchase. Bankruptcy courts go after real assets, large ticket items, i.e. real estate, houses, cars, boats, RV's, camping trailers, vacation property, etc. President Trump certainly has shown no indication of concern about the national debt at **\$21.4-Trillion** dollars as of May 16, 2019.

In fact several news sites on the Internet have reported, *"Sources close to the president say he has repeatedly shrugged it off, implying that he doesn't have to worry about the money owed to America's creditors—currently about \$21 trillion—because he won't be around to shoulder the blame when it becomes even more untenable."* [12/5/18, 'The Daily Beast']. Such an attitude reveals a dishonest man, i.e., president!

And that assumes no incremental supply, which of course is false: already the U.S. Treasury plans to borrow \$770 billion in the second half of 2018, a 60% increase from the same period last year.

Figure 1: National debt as fraction of GDP



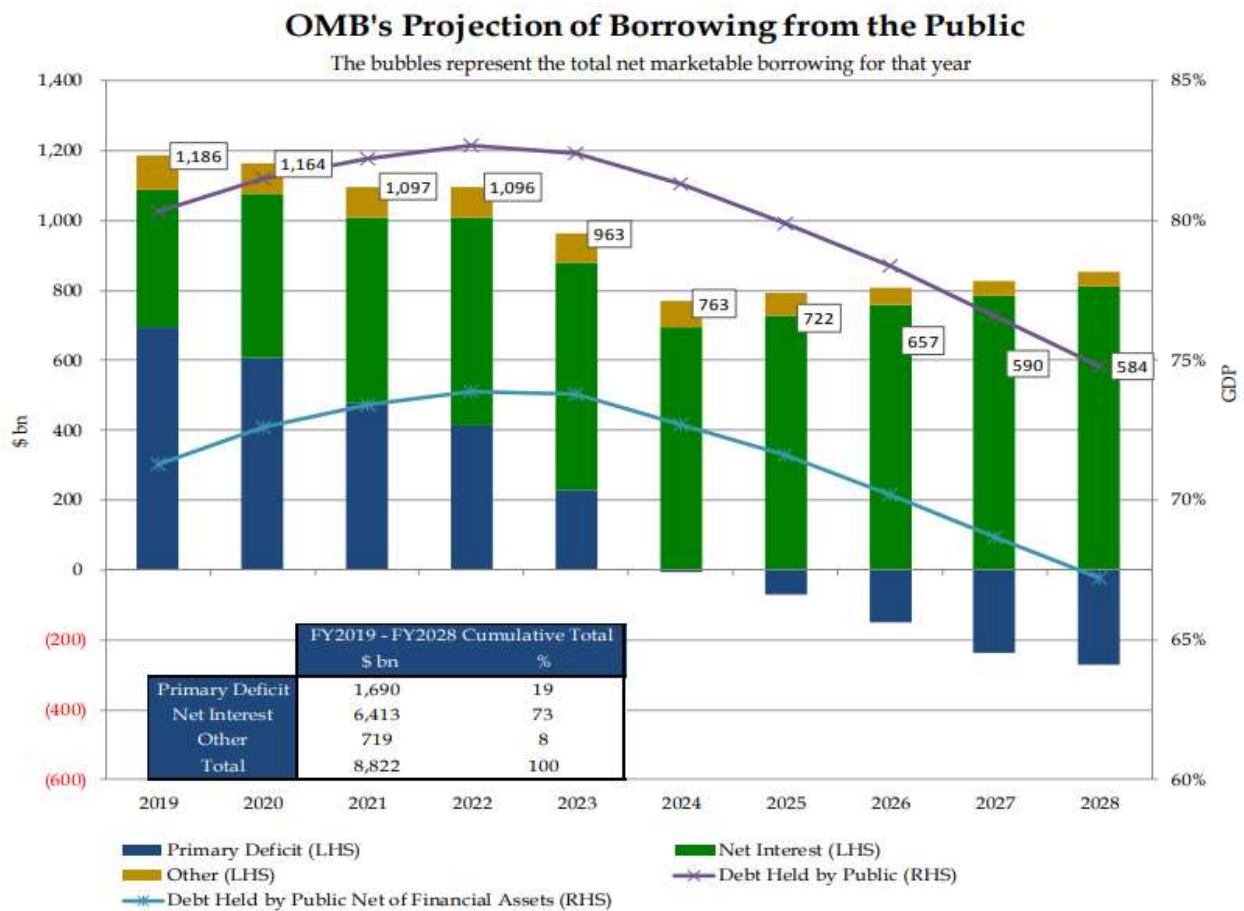

The net impact is "dramatic": BlackRock estimates that the net supply of Treasury securities, will more than double this year, to over \$900 billion, and rise to nearly **\$1.2 trillion in 2019**. The market hasn't had to digest that much government debt

since 2010 when the Fed was monetizing the bulk of the US deficit; this time around it's the opposite and starting this month, the U.S. Central Bank increased the pace at which it shrinks its holdings of Treasury and federal agency bonds to \$50 billion a month, adding to supply pressures. Furthermore, at recent bond auctions, few buyers showed up to buy our bonds.

The bottom line: now that the bond vigilantes appear to have woken up from the decade-long slumber, a pernicious positive feedback loop has emerged, one where higher rates lead to more focus on the surge in underlying debt, which in turn brings more attention to rising interest rates, which spooks buyers who demand even higher interest rates as the cycle restarts.

Where and when does it end? Instead of answering, below we show the CBO's latest baseline case (the pessimistic one is far worse). It is self-explanatory.



According to the U.S. Treasury Department's Office of Debt Management, the U.S. government is just **five years away from the point of no return**. With the national debt spiraling quickly out of control, there are only a few years left before every single dollar the government borrows will go toward funding interest payments on the national debt.

'ZeroHedge' explains the significance of what the chart shows as the Primary Deficit, indicated as the blue portion of the bars in the chart, swings from positive to negative beginning in 2024.

As part of today's Treasury Presentation to the Treasury Borrowing Advisory Committee, there is a chart showing the Office Of Debt Management's forecast for annual U.S. debt issuance, broken down between its three component uses of funds: Primary Deficit, Net Interest Expense, and "Other."

That chart above is troubling because while in 2019 and 2020 surging U.S. interest expense is roughly matched by the other deficit components in the U.S. budget, these gradually taper off by 2024, and in fact in 2025 become a source of budget surplus (we won't be holding our breath).

But what is the real **red** flag is that starting in **2024**, when the primary deficit drops to zero according to the latest projections, all U.S. debt issuance will be used to fund the U.S. net interest expense, which depending on the prevailing interest rate between now and then will be anywhere between \$700 billion and \$1.2 trillion or more.

In short: in the stylized cycle of the US "Minsky Moment", the US will enter the penultimate, Ponzi Finance, phase - the one in which all the new debt issuance is used to fund only interest on the debt - sometime around in **2024**. [A Minsky moment is a sudden major collapse of asset values which is part of the credit cycle or business cycle. Such moments occur because long periods of prosperity and increasing value of investments lead to increasing speculation using borrowed money. The spiraling debt incurred in financing speculative investments leads to cash flow problems for investors.]

Once we reach that point, the government will have reached the "**death spiral**," a point at which the complete collapse of the government and financial system is imminent.

Cities and territories in the United States that have crossed that "event horizon" to the crisis point. They have all either gone through bankruptcy proceedings or their equivalent, or they have implemented major fiscal reforms that reversed their fiscal deterioration, wherein the best-case scenarios, they acted to restrain the growth of their previously out-of-control spending to restore their fiscal health.

Don't hold your breath that the U.S. government will quell its spending habits.

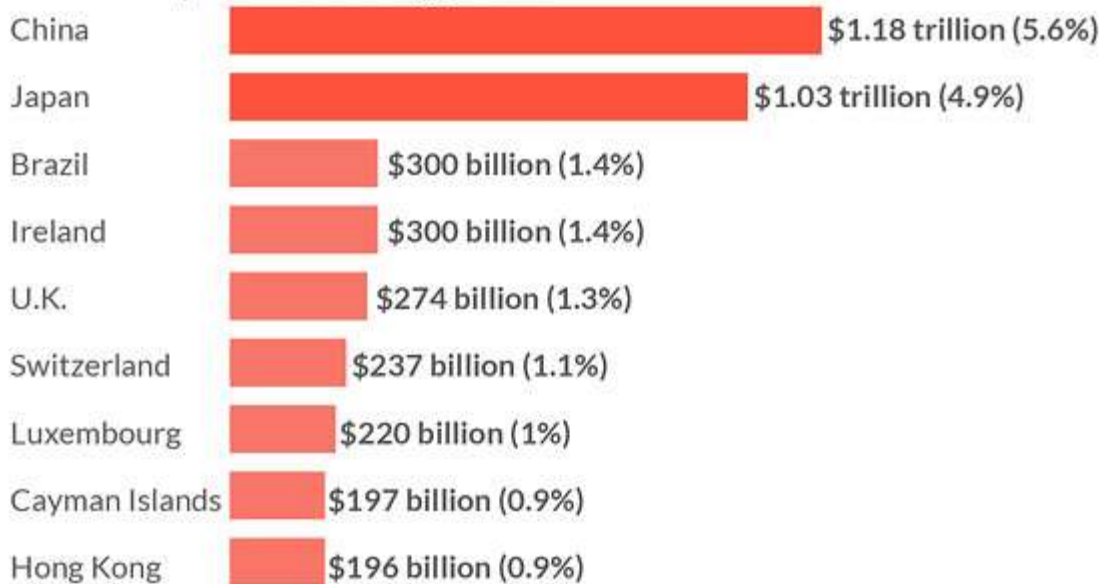
Let's take a look at who owns the U.S. national debt. The U.S. government, for its part, owned \$5.73 trillion in debt, mostly via Social Security and federal pension funds. This is money borrowed from the Social Security Trust Fund and Federal/Military pension funds. Keep in mind, payback to the citizen will be in cheaper inflated dollars (worth less in real purchase power). The Bush and Clinton administrations took all the Social Security Trust Fund, and government pensions to pay for the wars from 1991 onward. They issued IOU's in the form of Treasuries = to what existed in those funds. No problem, right! **Wrong!** Those bonds are nothing more than IOU's and if the

government is broke, they are not redeemable. In theory, it looks good only on a balance sheet. In reality, it's not worth the paper it's printed on!

The Federal Reserve (i.e., Rothschild banks) owned \$2.38 trillion in debt, but it trimmed its holdings by \$85 billion since June 2017. The Fed last year began to partly sell off the vast hoard of Treasuries it snapped up to lower interest rates and flood the economy with cash during and immediately after the Great Recession. Since the Federal Reserve is owned by the House of Rothschild's banks, they are the second largest holder of the U.S. national debt. Keep in mind, China has been threatening to cash in its U.S. bonds. Russia has been unloading U.S. bonds for a couple years at this point in time.

President Trump's cavalier attitude on money, particularly when it is not impacting his pocketbook, when it comes to debt is a serious concern for the country. Most people are dependent upon their Social Security and government or military pensions. A strong ego is not egotistical in the common-sense usage of the expression "big ego," but indicates accurate intuition, street-smart intelligence, and judgement. Strong enough to withstand the attacks of bitter Democrats who never thought Trump would win the presidency. He was strong enough to take on "the swamp" of Washington politics, politically correct liberal university professor enemies, and a massively anti-Trump and vicious liberal American press. Even smiling, hypocritical "Trojan Horse" Republican party enemies like John McCain and Mitt Romney were targets of Trump's withering un-presidential tweets.

The Presidency ages anyone and everyone in that office, by the impossible demands, expectations, and decisions; not to mention the ominous reality of leadership judgment when confronted with bureaucracy. The Trump Empire appears to have many suspicious questions of where from he gets his money; I have been researching for almost three years and doubt that anyone can identify them all. One thing I am sure of is that President Trump is not who you might think he is. What is evident is that President Trump is complicit with the Rothschild's and the Rothschild-banking octopus tentacles that at the least raise serious question about the leverage control the Rothschild's have over President Trump. I will highlight some of the deals that serve to illustrate his vulnerability and how he could be easily leveraged, if not compromised to help those he is beholden to as a debtor to the Zionist Rothschild's. Think of this in the form of a hypothetical question: If someone offered to pay off your mortgage and all your debts, but not without a caveat, what would you do?

'Forbes' magazine pointed out that America's first billionaire president was riding into the White House with populist support -- and he's bringing some billionaire friends with him in the process. One of them is distressed-asset investor Wilbur Ross, who is Trump's pick for Commerce Secretary. The two have a history that spans more than 25 years.

Trump made a bold bet on Atlantic City when he opened a third casino there -- the colossal Taj Mahal -- in April, 1990. Even riskier: He financed the project with \$675 million in junk bonds at a 14% interest rate. Within months Trump was struggling to make the massive bond payments as Atlantic City floundered. This deal reveals a careless attitude about finances. It reveals a serious flaw in evaluating the “risk” factor.

In stepped Wilbur Ross, then head of Rothschild Inc.’s bankruptcy advising team, to represent bondholders, who were pondering forcing the casino into involuntary bankruptcy and ousting Trump. Ross reportedly saw crowds pressed against Trump’s limo windows to get a peek at the mogul, and realized the value of Trump’s celebrity image. So, now we see where leverage begins to come into the mix!

He struck a prepackaged bankruptcy deal: Trump would give up 50% of his stake in the Taj Mahal but would receive better debt terms and would remain in control. The Donald was back in business. He ultimately made similar deals for his other troubled properties and climbed out of debt and back onto the ‘*Forbes*’ 400.

Wilbur Ross went into private equity in 2000, forming WL Ross & Co. He still runs it, but he sold it to investment firm Invesco in 2006 for some \$375 million. In 2013 Invesco partnered with Trump’s son-in-law, Jared Kushner, and others to buy 5 industrial properties from the Jehovah’s Witnesses in Brooklyn for \$240 million. Jared sought a “deep pockets” sugar daddy to bail him out. Guess where he went to seek help after he overpaid for the “666” Fifth Avenue, New York City property.

Nearly all of Trump’s wealth is tied up in real estate, but he has also owned stocks. One holding, according to a May 2016 filing: \$250,000-\$500,000 worth of Invesco European Growth Fund Class Y shares. (Trump claims to have sold his stock holdings in June, though he has not provided evidence to support the claim.)

Trump and Ross are also neighbors in both Florida and New York. Not only is Ross’ 16,000-square-foot home just up the road from Trump’s 126-room Mar-a-Lago club in Palm Beach, but the two also share a 57th-Street address in Manhattan. Ross’ penthouse is just two blocks from the president’s Trump Tower triplex. In noting Trump Tower, I should mention that recently the price of condos at Trump Towers are being discounted by 20%, a consequence of New York City’s crushing tax rates and abundance of empty real estate.

For those seeking influence in Washington, the president’s cabinet is the highest echelon. While concerns about potential conflicts of interest mount, one person who will have the Commander-in-Chief’s ear is his billionaire pal Wilbur Ross. Will Trump and Ross’ latest deal be good for America’s balance sheets, or their own? Wilbur Ross and Steve Mnuchin are in the President’s Cabinet courtesy of President Trump’s chief benefactor, the House of Rothschild! They are Rothschild watchdogs keeping tabs on the Rothschild’s interests.

TRUMP AND FRIENDS EXPOSED - 'ROTHSCHILD CONNECTIONS'

The FBI Mueller Report never produced any proof of collusion with the Russian government; however, their ineptness, and need to cover Mueller's own tracks of criminal activities of the past 18 years, failed to remove Donald J. Trump from the presidency apparently ignored the Trump ties to Russian-Zionist deep pockets. Robert Mueller has so much of his own baggage of corruption and criminal activity that he could not do a real honest investigation. Robert Mueller is linked to the Clinton Uranium-1 deal, in which he personally delivered samples to President Putin. If I could find out about the Bayrock Group, of which Donald Trump owes \$560 million to Blackstone/Bayrock, a so-called collective of Russian oligarchs that have heavy sway over the Russian government and Vladimir Putin, so could Robert Mueller. The Bayrock Group is a private real estate investment and development firm specializing in luxury residential, commercial and mixed use projects. Through its affiliated entities, Bayrock has made investments in transactions comprising real estate assets valued in excess of \$2.5 billion. Bayrock's flexible investment strategy allows it to pursue investments in a variety of sectors and markets.

In a series of interviews and a lawsuit, a former Bayrock insider, Jody Kriss, claims that he eventually departed from the firm because he became convinced that Bayrock was actually a front for money laundering.

Kriss has sued Bayrock, alleging that in addition to laundering money, the Bayrock team also skimmed cash from the operation, dodged taxes and cheated him out of millions of dollars. Felix Sater and others at Bayrock would not comment; in court documents they have contested Kriss's charges and describe him, essentially, as a disgruntled employee trying to shake them down.

But Kriss's assertion that Bayrock was a criminal operation during the years it partnered with Trump has been deemed plausible enough to earn him a court victory: In December, a federal judge in New York said Kriss's lawsuit against Bayrock, which he first filed nine years ago, could proceed as a racketeering case. *"(I have my own history in court with the president. Trump sued me in 2006 when I worked at the 'New York Times', alleging that my biography, 'Trump Nation,' had misrepresented his business record and his wealth. Trump lost the suit in 2011; my lawyers deposed him and Sater during the litigation. Trump's representatives didn't respond to repeated interview requests for this column.)"*

Trump has said over the years that he barely knows Sater. In fact, Felix Sater — who former Bayrock employees say met frequently with Trump in the Trump Organization's New York headquarters, once shepherded the president's children around Moscow and carried a Trump Organization business card — apparently has remained firmly in the orbit of the president and his closest advisers.

Felix Sater made the front page of the *'New York Times'* in February for his role in a failed effort — along with Trump's personal attorney, Michael Cohen — to lobby former National Security Adviser Michael Flynn on a Ukrainian peace proposal.

James Comey was still Trump's FBI director when he testified before the House Intelligence Committee in March about Russian interference in the 2016 election. During that hearing, Comey was asked if he was "aware of" Felix Sater, his criminal history and his business dealings with the Trump Organization. Comey declined to comment.

It's unclear whether Sater and Bayrock were part of Mueller's investigation. But Mueller has populated his investigative team with veteran prosecutors, expert in white-collar fraud and Russian-organized-crime probes. One of them, Andrew Weissmann, once led an FBI team that examined financial fraud leading to the demise of Enron. Before that, Weissmann was a prosecutor with the U.S. attorney's office in Brooklyn and part of a team that prosecuted Sater and mob associates for investment scams in the late 1990s.

However the Mueller probe unfolds before the public eye, a tour of Trump's partnership with Bayrock exposes a number of uncomfortable truths about the president's business history, his judgment, and the possible vulnerabilities that his past as a freewheeling dealmaker — and his involvement with figures like Felix Sater — have visited upon his present as the nation's chief executive.

Felix Sater was born in the Soviet Union in 1966 and emigrated with his parents to the heavily Russian enclave of Brighton Beach, Brooklyn, when he was about eight years old. He attended Pace University before dropping out when he was 18, then found his way to Wall Street where he worked as a stockbroker.

His early years on Wall Street, according to the recollections of his one-time business partner, Salvatore Lauria, were flush. By his mid-20s, Sater was collecting expensive watches, spending thousands of dollars on Zegna suits and buying luxury cars. That all came to a brief halt in 1993 when he was sent to prison for using the stem of a broken margarita glass during a bar fight two years earlier to attack another stockbroker; Sater's victim needed 110 stitches to hold his face together.

When Sater emerged from prison 15 months later, he found his way back into trouble. With a group that included Lauria (who admits to having had ties to organized crime figures and grew up in New York as a close friend of a prominent Mafia boss), Sater opened an investment firm on the penthouse floor of 40 Wall Street, a Trump-owned building in Manhattan. From there, according to federal prosecutors, Sater and his team set about laundering money for the mob and fleecing about \$40 million from unwitting and largely elderly investors, a number of whom were Holocaust survivors.

By the time law enforcement authorities eventually caught on to the 40 Wall Street operation, Sater had fled to Russia. Lauria visited him there.

Sater "was always hustling and scheming, and his contacts in Russia were the same kind of contacts he had in the United States," Lauria wrote in a 2003 memoir, "The Scorpion and the Frog." "The difference was that in Russia his crooked contacts

were links between Russian organized crime, the Russian military, the KGB, and operatives who played both ways, and sometimes three ways."

Sater, who had been charged with racketeering and money laundering by the U.S. attorney's office in Brooklyn in connection with the 40 Wall Street scam, eventually decided to return to America and face those charges. He had a card to play, however: his knowledge, gleaned from contacts in Russia, about a small stock of Stinger anti-aircraft missiles loose on the black market in Afghanistan that were of interest to U.S. intelligence officials.

Sater told authorities that he could use his Russian contacts to buy the Stingers and, according to court filings in Kriss's lawsuit and other accounts, a deal was struck in December 1998. Sater pleaded guilty to federal fraud charges and then entered into a cooperation agreement with the government that sealed court records in the case and allowed his sentencing to be postponed for 11 years. (Sater would ultimately only pay a \$25,000 fine and never go to prison.) The Bayrock story was detailed in Bloomberg News back in 2017, this portion of the story was but a snippet portion of the larger sordid business relationship between Donald J. Trump and his Zionist Russian Mafia partners,

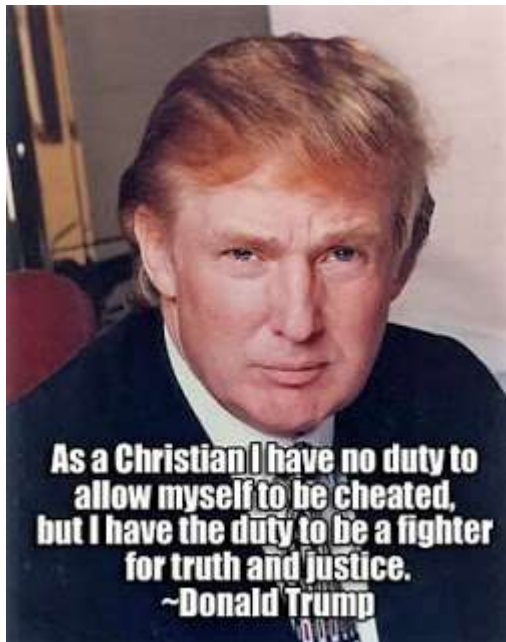

- An intense nationalism and resentment at national humiliation
- A "popular elitism" that promises every citizen that they're part of "the best people of the world."

Both can be seen as puppets of the Powers-That-Be.

Who is **THE REAL TRUMP? TRUMP; CLINTON; JEWISH MAFIA; CIA SEX RINGS.**

This is but a smattering of comments by a wide range of individuals capable of making assessments about the 45th President of the U.S. The diversity of views in many ways describes someone that is an enigma. As I said before, Donald J. Trump is not who you think he is! While we know a lot about him, we really do not know the man for which so many voted for. I can say that I could not have voted for him, even though he was the lesser of two evils! His decisions are unpredictable.

President Trump recently issued a full pardon to Conrad Black, a Canadian newspaper mogul who was convicted in 2007 of fraud and obstruction of justice. Black has said he is a friend of Trump's and wrote a book last year called *'Donald J. Trump: A President Like No Other.'*

Black was found guilty in 2007 of attempting to embezzle millions of dollars from newspapers he owned, though two of his three fraud convictions were later voided. He was also ordered by the Security and Exchange Commission to pay back \$4.1 million in restitution and banned from being a director of an American company.

Among the papers Black owned was *'The Jerusalem Post'*, until his company sold it and others in 2004 after the accusations of embezzlement first arose.

Trump has used his clemency powers a few times before; for example, in 2017 he commuted the sentence of former kosher meat mogul Sholom Rubashkin, who was convicted of bank fraud; and, in 2018 he pardoned former George W. Bush administration official Scooter Libby, who was found guilty of obstructing an investigation into who blew the cover of C.I.A. agent Valerie Plame.

To really understand President Trump, we have to look at his actions, what he does, thus proving the old adage that actions speak louder than words. This is why when the *'Israel Today'* reported that the President had converted to Zionist-Chabad-Judaism my concerns spiked. You need to understand that converting from being a Presbyterian to Chabad-Judaism is no minor insignificant matter like a Methodist becoming a Baptist. The Netanyahu government has announced a new settlement on the Golan Heights will be named for President Trump. More important are the radical nature of the Zionist-Chabad messianic obsession and the building of the third temple in Jerusalem! They will risk war to bring about their messiah, and believe me, he isn't Yeshuah, Jesus Christ!

Interestingly, the whole "Q" issue added to the mystique that engulfs Donald J. Trump, when "QAnon" referred to as a cult led by the Rothschild family which has been a critical part of this global control system. What was "QAnon" telling us? Are the puppet masters, the Rothschild's, the Saudis, and George Soros Satan worshippers? At the apex of this Satanic cult are the Rothschild's, according to "QAnon." There have been rumors in circulation in books and on the Internet, that 'Pindar' should be the head of the Illuminati on Planet Earth, and perhaps even a full blooded Draco alien from the lower 4th dimension. This is what Leo Zagami, former high ranking Illuminist has to say about 'Pindar': "The most

important military citadel in central London - and arguably in Britain - is 'Pindar', a bunker built beneath the Ministry of Defence on Whitehall. Its construction, which took ten years and reportedly cost £126.3 million, finally came to a conclusion in 1994, but 'Pindar' became operational two years earlier, in 1992." The high cost became the subject of some controversy in the early 1990s. Much of the cost overrun was related to the facility's computer equipment, which proved extremely difficult to install due to the very limited degree of physical access to the site.

'Pindar's main function is to serve as a crisis management and communications center, principally between the MOD headquarters and the actual center of military operations, the Permanent Joint Headquarters in Northwood. It is reported to be connected to Downing Street via tunnels under Whitehall. Although it has been rumored that it connects to some secret underground transport system, Armed Forces Minister Jeremy Hanley told the House of Commons on 29 April 1994 that "the facility is not connected to any transport system." Although 'Pindar' is very definitely not open to the public, it has had some very limited public exposure. This came in the 2003 BBC documentary on the Iraq conflict, 'Fighting the War', in which BBC cameras were allowed into the facility to film a small part of a teleconference between ministers and military commanders.

I think it started with one of David Icke's books; it could have been *'The Biggest Secret'* if I remember correctly. Icke was throwing out this question in the book, more or less asking the readers, if anyone knew who 'Pindar' is. David had received some information that 'Pindar' could be the Illuminati Grand Master.

All this corroborates what "QAnon" revealed about the Rothschild's being the leaders of a cult followed by the puppet masters. Prior to his death in 2007, Guy De Rothschild arranged for leadership of the Rothschild family to be passed on to his son, David Rene de Rothschild, in 2003. Recently David de Rothschild announced on April 17, 2018 that leadership of various Rothschild companies would in turn be passed on to his son, Alexandre de Rothschild.

According to what "QAnon", Leo Zagami, and Dr. Bill Deagle have revealed, it can be concluded that the role of 'Pindar' (Satanic cult leader) had passed on from Guy to David de Rothschild, and that Alexandre is being groomed to take over the position at some point.

Who is 'Pindar' you ask? The leader of the Earth's Illuminati is called the 'Pindar'. The 'Pindar' is a member of one of the 13 ruling Illuminati families, and is always male. The title, "Pindar", is an abbreviation term for "Pinnacle of the Draco", also known as the "Male MEMBER of the Dragon". Symbolically, this represents the top of power, control, creation, penetration, expansion, invasion, and fear. The holder of this rank reports to the pure bred Reptilian leader in the inner Earth. The UK national symbol is the "Red Dragon". The UK dominates in the world in terms of the "Occult". The true current 'Pindar' is the head of the Rothschild family, as has been for several hundred years. He is based in Germany near Frankfurt, since in the late 1970s,

“QAnon” refers to a temple on Epstein’s island with underground levels that the Satan worshiping Rothschild’s, Saudis and George Soros, along with their followers and compromised politicians, regularly visit. Compromised politicians include the Clinton’s, who are deeply involved in events at Epstein’s island as evidenced by Bill Clinton’s frequent visits there – 26 of which have been documented in flight logs.

“QAnon” refers to how the Clintons were compromised by Soros, and how evil they became through their association with the Rothschild’s: What kind of “EVIL” activities are performed Epstein’s island, the Rothschild’s Black Forrest estate, and other locations like Bohemian Grove, California? “QAnon” said that the Saudis are in control of sex and child trafficking. There are multiple witnesses that describe Satanic ceremonies that involve child sacrifice. John DeCamp, a former state senator for Nebraska, wrote ‘*The Franklin Coverup: Child Abuse, Satanism and Murder in Nebraska*’ (1992), which provides the most well documented and researched book detailing child abuse and ritual sacrifice at Satanic events all over the United States. The book intimated a tie directly into the George H.W. Bush White House. In interviews, George W. Bush related how his father abused him.

In an article where he summarized multiple interviews with children who survived the abuse and Satanic ceremonies, John DeCamp wrote:

“The essence of the story the children told, was that they were used in a coordinated ring of child abuse. When I say child abuse, I don’t mean the traditional child abuse that social workers yak about, but serious, big league abuse of children. They are used as drug couriers, as sexual objects to compromise this or that politician or businessman. They are used in the most gross fashion possible, including ritual murder and things like that. I am talking about the most unbelievable things, which I still have difficulty believing. But having seen enough evidence, I know they exist, in an organized fashion, and not committed by the sleazes in the bars and the guys in the alley. I’m talking about the most prominent of citizens, the most respectable.”

DeCamp gave an example in his book, of how young children are exploited at Satanic ceremonies held at private locations such as Bohemian Grove:

“Paul was taken by Larry King [not the talk show host] and others to a wooded area in California – identified after publication as the Bohemian Grove. There Paul and another boy were forced to do sex acts with and to consume parts of a child whom they had watched being murdered by the cultists. The body was to be disposed of by “the men with the hoods.”

Was “QAnon” signaling that President Putin is fully aware of the Satanism practiced by the puppet masters – Rothschild’s, Saudis, and George Soros – and that there is secret coordination between U.S. military intelligence and Putin in responding to the Deep State. One has to wonder if this is why Russia has repeatedly stood down its military forces despite U.S. military provocations in Syria, Ukraine, and elsewhere in

Russia's sphere of influence. It would seem that Putin knows that the Deep State is intent on fomenting World War III.

Putin is also well aware that the Deep State has been pressuring Trump from the beginning of his administration, and now blackmailing Trump through material acquired from the Cohen raid. Nevertheless, Putin/Russia and Trump/US military intelligence are somehow coordinating to prevent any military clashes that could quickly escalate out of control due to deep state actors embedded within each of their administrations.

"QAnon's" revelations have been very helpful in understanding the puppet masters behind the Deep State, their connection to a Satanic cult that has compromised political systems in the U.S. and around the world, and how President Trump and the U.S. military intelligence are secretly coordinating with Putin's Russia to deal with these multifaceted challenges.

What is most troubling in all of this is the fact that CNN has known about the Trump conversion to Zionist-Chabad-Judaism for more than two years according to what *'Israel Today'* revealed in April of 2019, and furthermore, CNN did not release the report, and yet CNN has been leading the media attack on the Trump presidency. Even though President Trump's passport says that he is Jewish, however, Vladimir Putin is also a practicing Russian Orthodox Catholic.

Something does not make sense here. CNN could have caused a huge uproar among Christians by reporting the President's conversion to Zionist-Chabad-Judaism. It could have profound implications for President Trump's foreign policy and to a lesser degree his domestic policy. What is CNN's real agenda in sitting on this news story? Perhaps, since President Trump was the Rothschild-controlled opposition candidate, they [CNN] are sold out to the Rothschild-controlled media. The media gives the public just what the elite want them to read and hear. Six conglomerates control the entire spectrum of news and entertainment.

The real power behind the United States is the Rothschild banking family, which can trace its roots to 1743 when Moses Amschel Bauer put the red hexagram above his doorway.

That was also the year his son Mayer was born in Bavaria. In 1760 Mayer would change the family name from Bauer to Rothschild after that red hexagram sign ('Rot is German for 'red' and 'Schild' means 'sign').

Mayer Rothschild continued his father's money lending business and also got into the business of hiring out Hessian mercenaries to foreign countries at war, resulting in vast profits for the family.

Loaning to governments directly was the logical next step, mainly because it was more profitable than loaning to individuals. After all, a nation's taxes were much more likely to come through and pay the debt than an embattled businessman's profits.

Seeing a way to control world governments through debt, Rothschild developed a system based on the Rabbinical Jewish book, the Talmud. Talmudists are Jews that follow the teachings of the Talmud, which is one form of Jewish law, and one that many claim is anti-Christian and sexually immoral.

The nation of Israel was created in 1948 with a new flag showing what is referred as the Star of David, a symbol that had come about in the 1600s and which the Zionists adopted as their symbol in 1897.

The Star of David is totally misleading, as King David never had a star symbol. His son, King Solomon, used the symbol when he ruled the Kingdom of Israel during the 900s BC, however, and that's where we'll begin.

The six-pointed star symbol is an ancient sign of “magic, witchcraft, sorcery and occultism” as well as the casting of horoscopes and reading of the zodiac. It has a sexual meaning, the generative powers of male-female union, of two triangles, one right-side up, and one upside down.

Solomon was thought to have turned away from God, which led to Israel's destruction. One of the reasons for that may have been the use of his star symbol, which was associated with Remphan, an ancient Egyptian 'star' god.

The symbol was also that of the worshippers of Moloch, a god of the Ammon people, who were a neighboring nation of Israel in the 900s BC.

Moloch encouraged child sacrifice, typically by the parents. Solomon had many temples built for his foreign wives, and “pagan abominations” were worshipped there, including idols to Moloch.

The star symbol, or hexagram, helped with this. It had six points that formed six equilateral triangles, something that allowed the insides to form a six-sided hexagon. This leads to 6 points, 6 triangles and 6 sides... or “666”, the “Mark” of the beast.

All of this was associated with Moloch, or what we'd today consider Satan. Moloch was a false god that tempted Solomon, leading to the downfall of Israel, the

Babylonian Captivity, and subsequent exile of the Jewish people, both those that were innocent and the idolaters.

How it happened was that Israel fell apart into two different countries in 930 B.C., the Kingdom of Israel to the north and the Kingdom of Judah to the south.



Sometime in the 720s B.C, the Assyrians invaded the Kingdom of Israel and defeated it. The Assyrians hung on until 605 B,C, and the Israelis in Judah did the same until the Babylonians swallowed up their state about fifteen years later.

At that point the Jews found themselves exiled until Assyrian king Nebuchadnezzar conquered Jerusalem in 586 B,C, setting the groundwork for the Jews' return in 539 B,C.

The continued journey of the Jewish people is much too long of a story to explore here, but elements of their story are important to our own, and important if we're to understand how the world truly operates today.

In the 1200s A.D. the Mongols were pouring out of Asia and killing or enslaving all that they came across. Part of their enslavement was mental more than anything, and consisted of converting to the Jewish faith.

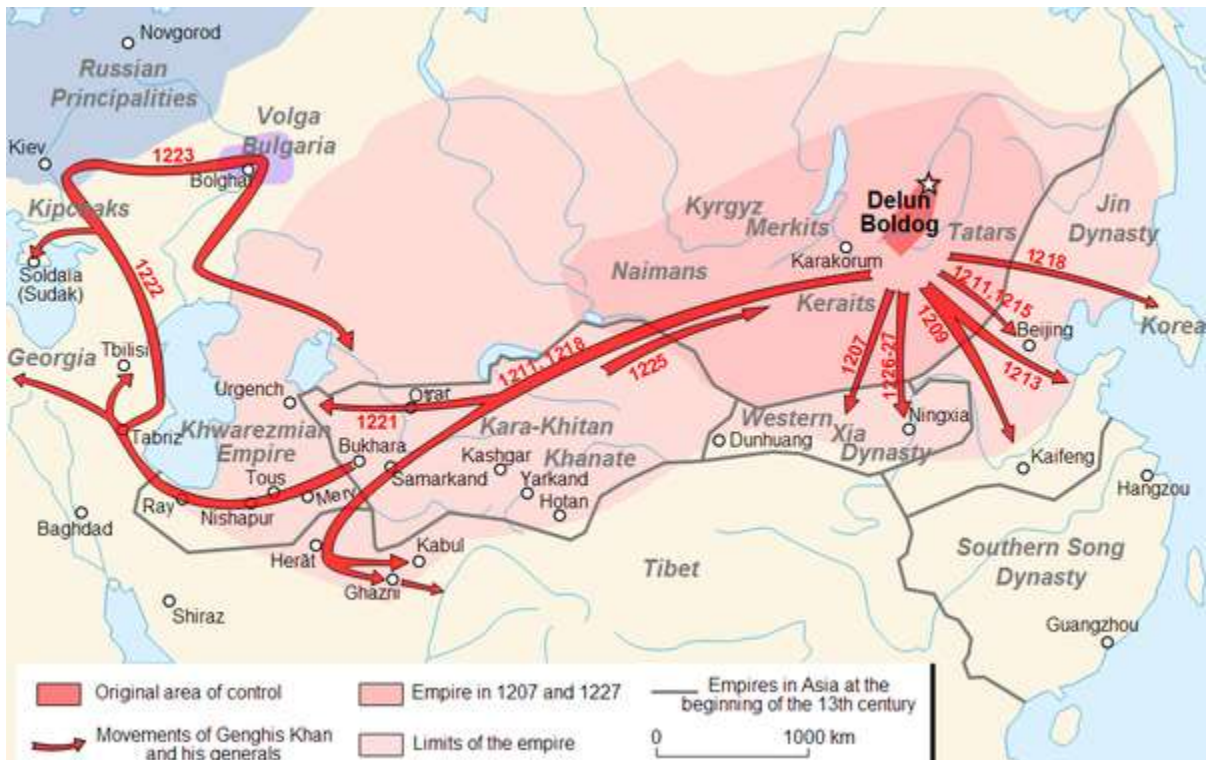
Many that converted didn't want to, and these people became the basis of the Ashkenazi Jews, a group that many believe rejects Jesus and accepts Satan.

The real power behind the Ashkenazi Jews is the Rothschild banking family, which can trace its roots to 1743 when Mayer Bauer was born in Bavaria. That was also the same year his father had put the red hexagram above their doorway. Seventeen years later they'd be known as the Rothschild family. These are the people Jesus Christ was referring to in Revelation 2:9 and 3:9.

Many believe the Talmud is the opposite of the Torah. While the Torah worships God, the Talmud worships Satan. The Rothschild's used a twisted form of the Jewish Talmud to create satanic teachings that formed the basis of his secret organization, the Illuminati.

In 1776 the organization was complete and Rothschild used his associate, Adam Weishaupt, to infiltrate the Continental Order of Freemasons so that Illuminati doctrine would appear in their lodges all over Europe, and later the world.

Freemasonry can trace its origins back to 1400 B.C. when the Egyptian Pharaoh Akhenaton built a temple in El-Amarna that became the first “mystery school,” a place where “human sacrifice and mind control were common” with “initiation rites identical to those of modern Freemasonry.”

Akhenaton was also the pharaoh that moved Egypt from polytheism to monotheism, a system of worshipping just one god. It would be nearly a thousand years later that those mystery school ideas came to Greece. It was during the time of Erechtheus, who was known as the “earth-born king of Athens” and was raised by the Greek goddess Athena, so it’s claimed. From the Greek world the ideas circulated, heading to the Romans to become the “Mysteries of the Mithras,” or sometimes “Mysteries of the Persians.”

Those ideas lasted from about 68 B.C. to around 500 A.D. They changed considerably during that time, and two dominant schools of thought developed – the Serapis and the Mithras.

The Serapis spread east toward Persia while the Mithras spread west toward the fledgling nation-states of Europe, both eventually incorporating aspects of Christianity.

Serapis was eventually suppressed in Rome in 391 but it morphed into Zoroastrianism in Persia. Mithras slowly took on more of the aspects of Gnostic thought in the West.

As the Dark Ages took hold after the fall of Rome in the mid-400s the old mystery school ideas morphed with Christianity and eastern belief systems to take on the rudimentary form that Freemasonry has today.

The secret society continued up through the time Charlemagne was named the first Holy Roman Emperor in 800 A.D. The first mention of a Freemason temple on official records was in York in 926 A.D. under King Athelstan.

Freemasonry also began to take on influence from the Jewish mysticism as it cemented itself into the Kabala around 1100 A.D.

In 1620 we have records of Freemasons in London, and a short time later a strong sect rose up in Scotland. It wasn't until 1717, however, that modern Freemasonry came into being, and at least that's the accepted version.

Many Freemasons will claim their belief system goes all the way back to King David in Israel and the Temple of Solomon, and it's likely there's some truth in that. However, it wasn't until 1717, however, that four lodges in Great Britain formed together to become the first Grand Lodge of England. These were the first official Freemasonry lodges, and America saw its first in Philadelphia in 1730.

Of the thirty-nine men who signed the American Declaration of Independence in 1776, thirteen of them were Freemasons, or 33%. America has had many presidents that can call themselves Freemasons. "Every US President since FDR has been a 33rd Degree Illuminated Mason, except Ronald Reagan," who "was given the honorary title, and John F. Kennedy, who was assassinated."

Scottish-Rite Freemasonry is a complex society with thirty-three degrees of advancement. Beyond the first three degrees of the Blue Lodge, "To achieve advancement to one higher degree, members are asked to spit on a cross," "Those who refuse are congratulated while those who accept are advanced to the next level because they did what they were told." In the Rites and Rituals of the 19th degree, the Lodge brother is told that their god is Lucifer!

What's more, each Masonic Lodge is officially warranted by the British government, meaning all Freemasons the world over are swearing fealty to that nation when they give their vows and say their rites. Lower level initiates don't know this darker side of Masonry and spend their time planning charity circuses and parades, ostensibly to divert people's attention from the Illuminati plans for global dictatorship... the most corruptible men advance to the higher degrees of Masonry. The highest authority of Freemasonry is Prince Charles of Wales and the 'Order of the Garter'.

Freemasonry wasn't popular everywhere, however, and a lot of that had to do with the fact that well-off and wealthy men always seemed to be members. In 1822 Czar Alexander had banned Freemasonry from Russia. It's rather ironic, as a Russian would give us the Freemason connection to the Knights Templar. The Knights Templar is another organization involved, and one that has grand designs on the world. The Templars were influenced heavily by Gnostic thought and the world knows about their crazy schemes because of an event in 1884. That's when a Russian general's daughter, Justine Glinka, paid 2,500 francs to Joseph Schorst, a member of a Freemason guild in Paris, to obtain a book called *'The Protocols of the Wise Men of Zion'*. That French Freemason guild was in reality the Knights Templar sect known as the Priory of Sion, which had been created in 1099 on Mount Zion in Jerusalem to "guard such relics as the Shroud of Turin, the Ark of the Covenant, and "the Hapsburg family's Spear of Destiny which was used to kill Jesus Christ as he hung on the cross." Most of that loot, if any of it even existed, was seized from beneath Solomon's Temple during the Crusades and then secreted back to Europe for safekeeping.

All of this is related to preserve the Holy Grail bloodline, or Sangreal, of Jesus Christ which they believe is carried forth by the French Bourbon royalty, the Merovingian family. The Priory of Sion elite believe Jesus faked his death with the help of certain herbs, then married the administer of those herbs, Mary Magdalene. This is part of the Big Lie that Royalty has taught people for several hundred years since the 5th century. I have noted the books by Laurence Gardner, *'Bloodlines of the Holy Grail'* and Tim Cohen's book, *'Antichrist and a Cup of Tea'* in my articles "**The Nearness of the Rapture**" and "**No Statute of Limitations on Fraud**".

The Priory believes the couple fled to southern France and had numerous children. During the 5th century, the theory goes, Jesus' descendants married into the Frank royalty from which France takes its name, thus creating the Merovingian dynasty.

The Priory believes that Jesus eventually died in Kashmir, Pakistan. His bloodline – the Holy Grail – lives on, however, and it's through the Hapsburg line. The Hapsburg family started on the Habichtburg estate in Switzerland in 1020. The Holy Grail is not a cup or chalice, as many hint. Something that is revealed in the more than a dozen books of Laurence Gardner is the Holy Grail is the "bloodline". Having read them all, it is my belief that Laurence Gardner was commissioned to write his books for the House of Rothschild, who will bring forth their "false" messiah, the Antichrist.

The Zionist-Chabad-Lubavitchers mission is to bring forth their messiah; but as the Bible makes it clear, he will be a "false" fraud messiah. From Tim Cohen's book *'Antichrist and a Cup of Tea'* the Jewish messiah will be Prince Charles of Wales. The main point of Laurence Gardner's *'Bloodlines of the Holy Grail'* also is that Prince Charles of Wales will be this "false" messiah! Those who have not read Laurence Gardner's and Tim Cohen's books will laugh at this as being preposterous. If they only had read Laurence Gardner and Tim Cohen's works! Tim Cohen shows 57 points of congruence from the Bible associated to Prince Charles!

This is the point where the conversion of President Donald J. Trump to Zionist-Chabad-Judaism becomes a critical link in this larger story. As President, Donald J. Trump is the Commander-in-Chief, is in the position to execute a plan that will launch a war on Iran and Syria.

Israel minted the Trump-Cyrus coin in both gold and silver, honoring Donald J. Trump and Israel's "seventy" year anniversary, following President Trump's recognition of Israel as a legitimate state, and his recognition of Jerusalem as its capital.



On page 35 is a clearer picture of the new Trump coin cast in the image of Cyrus the Great. The Israelites and Judeans had rebelled against God for centuries and He ultimately sent them into captivity for their disobedience for "seventy" years. He initially allowed the Assyrians and then the Babylonians to punish his people. Eventually, He decided to allow the Persian people to conquer the Babylonians so that they could rule over His people. God allowed Cyrus the Great to govern His people so that He could send them back to their homelands in order to rebuild their temple and to worship Him in truth once again.

In Ezra 1 God reveals to Cyrus the Great that he is to rebuild the Temple of the Lord which is also known as Solomon's Temple. He also told him to send the Judeans back to their homelands in order to carry out this task. Cyrus then supplied the Jewish people within his kingdom with the supplies that they needed and he also gave back the treasures that were removed from the temple when the Babylonians defeated them. Since he ruled over most of the kingdoms that surrounded Judah he informed their officials that they were not to interfere with the Jews project. Many of the kingdoms complied with his edict, but there were some that didn't follow his instructions.

Cyrus the Great was born around 600 B.C. and he ruled the Persian Empire around 559 B.C. During his reign he conquered the Medians, the Babylonians, Lydia and he controlled all of the territories and minor kingdoms that were possessed by Babylonians. Cyrus didn't remove the customs or governments of the people that he

ruled; he designed his government to work in collaboration with them. As long as they paid their tribute, taxes and homage, he allowed them to live in peace, to worship as they pleased and pray to their own deities. The Roman Empire learned well the lessons of Cyrus and adopted most of his measures and policies.

King Cyrus was married to Cassandane who was said to have loved him very deeply. Her devotion is supposed to have been so deep that she loved him more than her own life. King Cyrus also had four children. Cambyses II, Bardiya, Atossa, Artystone and another daughter whose name is not mentioned. He loved his family and he was known as a great ruler to his people. This is why the people gave him the name of "Cyrus the Great". To some, he was a liberator and to others a savior. The Jewish people referred to him as a righteous king.

He developed and controlled the trade routes between the various empires he dominated. King Cyrus also conquered Turkey, Arabia, Georgia, Indus River, Kazakhstan, Kyrgyzstan, Pakistan and Oman. He knew how to rule his empire well and through his efforts the Persian Empire had come to influence the Middle East for at least 1000 years. Many Iranian people from the modern era refer to Cyrus as "Father" because of the great influence that he has had on their culture and society over the years. Cyrus the Great was buried in the ancient city of Pasargadae in 530 B.C. which is located in modern-day Iran.



Biblical References:

- 2nd Chronicles 36: 23 - King Cyrus acknowledges that God has allowed him to conquer the world.
- Ezra 1 - King Cyrus authorizes the people of Judah to return back to their land in order to rebuild God's temple.

It becomes understandable why Zionist-Chabad-Judaism has latched onto the one they believe will be instrumental in building the Third Temple, in the person of Donald J. Trump! President Trump has recognized Israel as a sovereign state; Jerusalem as Israel's eternal capital; he has recognized Israel's control over the conquered Syrian Golan Heights. But there is more here than you may understand.

Dr. Thomas Horn, in an appearance on Gary Stearman's television program, May 5th, 2019, "*Prophecy Watchers*", and in his appearance, he reported that two senior Chabad Jewish rabbis came all the way from Israel to the White House to tell Trump that God put him in office to build the Third Temple. They called Trump a modern-day Cyrus, to lead the building of their Third Temple. As vain as President Trump is, he has fallen for their schmoozing and stroking his ego buttons! Donald J. Trump is a con-artist but Benjamin Netanyahu is the king of con-artists. Striking a coin to honor Donald J. Trump would be like winning a Nobel Peace Prize in pandering to Trump's vanity!

Behind the Zionist-Chabad-Lubavitchers, is their financial King, the House of Rothschild; they control directly 75% of the world's wealth and as much as 90% when you factor in indirectly, with Rothschild' central banks in 189 countries, all but Cuba, Iran, North Korea, and Syria. We should add Russia to this list since President Putin threw the Rothschild's out of Russia two years ago by paying off the Russian debt. The Rothschild's are the experts at setting up Trusts, and tax-exempt foundations, through which they actually pay almost nothing in taxes to the countries they operate in.

But before moving on, there is something that few will understand the prophetic significance. This is often overlooked but an important prophecy in Isaiah which spoke of Cyrus, more than a century-and-a-half before Cyrus was born. One of the truly astounding prophecies of the Bible is found in the last verse of Isaiah 44, together with 45:1ff., It has to do with Cyrus, king of Persia. According to the historian Herodotus (The Histories i.46), Cyrus was the son of Cambyses I. He came to the Persian throne in 559 B.C. Nine years later he conquered the Medes, thus unifying the kingdoms of the Medes and the Persians.

Cyrus is mentioned some **23X** times in the Old Testament. Isaiah refers to Cyrus as Jehovah's "**shepherd,**" the Lord's "**anointed,**" who was providentially appointed to facilitate the divine plan. God would lead this monarch to "**subdue nations**" and "**open doors**" (an allusion to the Jews' release from Babylonian captivity). He would make "**rough places smooth,**" i.e., accommodate the Hebrews' return to their Palestinian homeland. He would ultimately be responsible for the rebuilding of Jerusalem and the reconstruction of the temple.

Amazingly, the king would accomplish these noble tasks even though he did not “know” Jehovah -(Isaiah 45:4, 5). In other words, though he was a pagan in sentiment and practice, yet, as an unconscious tool in the hands of the Lord, he would contribute mightily to the Jewish cause, and so, indirectly, to the coming of God’s greater Anointed, Jesus of Nazareth. Many Jews equate President Trump as a modern-day Cyrus.

The fulfillment of these plain and specific predictions is set forth in 2nd Chronicles 36:22, 23 and Ezra 1:1-4, 7, 8; 3:7; 4:3. The ‘*Encyclopedia Britannica*’, an unlikely source, acknowledges that “in 538 B.C. Cyrus granted to the Jews, whom Nebuchadrezzar had transported to Babylonia, the return to Palestine and the rebuilding of Jerusalem and its temple” (1958, 940).

H. G. Wells, in his book, ‘*The Outline of History*’, concedes that the Jews “returned to their city, Jerusalem” and “rebuilt their temple there under the auspices of Cyrus,” the Persian monarch (1931, pg. 253).

What many people do not realize in reading Isaiah 44:28ff is that this heathen ruler was named by the prophet long before the monarch was even born. Isaiah prophesied in the reigns of Uzziah, Jotham, Ahaz, and Hezekiah (1:1). His ministry thus occurred in the latter portion of the eighth century B.C. (ca. 740 – 701 B.C.). **This was approximately one hundred fifty years before Cyrus came to the throne!**



The Cyrus Cylinder is a barrel shaped cylinder made of clay discovered by the Assyro-British archaeologist Hormuzd Rassam in March, 1879. It dates from the 6th century B.C. in the ruins of Babylon in Mesopotamia (modern Iraq).

It is currently housed in Room 55 of the British Museum in London. What is interesting to note is the text on this cylinder.

The text which was written in Babylonian script mentions the conquest of Babylon by Cyrus in 539 B.C. The declarations were made by Cyrus himself. The British Museum has translated this in English and you can read it on their website.

We know through archaeological proof such as the Cyrus Cylinder and also through other non-Biblical writings that Israel was captured by Babylon and the Jews were taken as slaves to Babylon in 609 B.C. About 70 years later Babylon was captured by Cyrus of Persia and he allowed the Jews to return back to Israel in 539 B.C.

The book of Isaiah was recorded about 170 years before King Cyrus set free Israel. It was written even before he was born. How amazed Cyrus was when he read this Scripture! Being deeply shocked, Cyrus did the things prophesied in the Bible.

However, the prophecies about Cyrus contain some still remaining, not being fulfilled yet. Then by whom these prophecies will be fulfilled perfectly?

Isaiah 41:17-18 ...***“I, the God of Israel, will not forsake them. I will make rivers flow on barren heights, and springs within the valleys. I will turn the desert into pools of water, and the parched ground into springs.”***

This is part of the prophecy about Cyrus. But who in the world can make it possible? The Bible says only God is able to become the source of the water of life and He who to come as a prophetic Cyrus in the east will fulfill the prophecy above. - (Isaiah 41:2-4).

It was not coincidence that Cyrus set Israel free. God concealed a secret about God's Second Coming in the Cyrus Cylinder. That concealed fact alludes to profound implications for the world today! Now it's time to break the seal of prophecies about Cyrus. The Bible says we are captured by the spiritual Babylon, just like Jews were captured in Babylon. The first thing we should do is to meet a spiritual Cyrus – the second coming Christ – who comes in the east to accomplish the prophecies about Cyrus complete.

When the Cyrus Cylinder was discovered in 1879 and appeared in public, these Scriptures above were proved to be historically true and all human doubts melted away.

Incredible declarations of this nature have led critics (who reject the possibility of predictive prophecy) to suggest that these portions of the book of Isaiah were added much later—after the fact, as it were. If that were so, it would violate the Heptadic

Design Feature of Scripture, which by the way refutes it simply as untrue! Read my eBook, ***'The Inspired Word of God; Mathematically Proven True'***. The Heptadic Design Feature of the Bible is a mathematical system that Self-Authenticates the Real Author of the Bible. I dealt with the evidence that shows the book of Isaiah was written by a single author, not two, not three as some suggest. The book of Isaiah is a miniature Bible, with each of the 66 chapters outlining the theme of the 66 books from Genesis to Revelation. God has left His signature all over the Biblical text of the Bible.

All of these promises assume that Jerusalem and the cities of Judah have been razed, that the temple is no longer standing, that Cyrus is on the scene and swiftly growing in power, and that the return of the exiles is imminent.

Critics argue, if such is the case, then this material could not possibly have been written by the prophet Isaiah since he died long before these events transpired. The critics, in spite of their claim of a conservative approach to the book, clearly reflects their opinion that this portion of the book of Isaiah was authored by a writer of the sixth century B.C.).

Against such a viewpoint we have the assurance of Scripture itself. Earlier, in Isaiah 41:25ff, Isaiah had spoken of the coming of ***"one . . . from the rising of the sun."*** Though not called by name, the allusion is clearly to Cyrus, who would bring good tidings regarding Jerusalem. In Isaiah 41:26, Isaiah makes it plain that the mission of Cyrus was a matter of prophecy, not educated speculation. It is a reflection of compromised faith to postulate a late date for these prophecies.

Finally, as an interesting sidelight, we note that Josephus, the Jewish historian, stated that the Jews in Babylonian captivity showed Cyrus the prophecies of the Old Testament Scriptures which contain his name and described his role in the scheme of God. The historian says that it was this circumstance that motivated the ruler *"to fulfill what was written"* (*'Antiquities of the Jews'* 11.1.2), and thus to issue his edict permitting Israel's return to her homeland.

Excavations at Babylon (1879 – 1882) led to the discovery of a clay barrel, known as the Cyrus Cylinder, which contained a marvelous historical confirmation of the Biblical narrative. It portrays the benevolent policies of Cyrus in the following fashion: ***"All of their peoples I gathered together and restored to their dwelling-places"*** (see Price 1902, 234).

Most people will miss the significance of all of this, it is huge, and particularly so the religious world. We are witness to Biblical prophecy being fulfilled in "real time"!

When you understand the "big picture" of all this: the historical and prophetic significance of Cyrus the Great; the physical existence of the Cyrus Cylinder; the fanatical Zionist Chabad Lubavitchers, and their obsession with the building a third temple, bringing their (false) messiah forth at this time, plus all of what President Donald J. Trump has said and done; and the revelation of the reports published by *'Israel*

Today' in April, 2019; it all becomes so much larger than life. **We are witness to Bible prophecy being fulfilled in "real time!"**

When the Orthodox Jewish community in Israel concluded that President Trump was fulfilling the prophecy of Cyrus the Great from Scripture, it became evident why the Zionist Chabad rabbis were so excited to come tell the President in person that he was chosen by God to fulfill the building of the third temple, and reveal their messiah.

President Trump has a spiritual advisory group that meet with him monthly on spiritual matters. Ironically, the hucksters of survival food buckets have latched onto the Cyrus the Great theme; Jim Bakker and Lance Wallnau, according to a *'New York Daily News'* report: For only \$45 you can establish a "point of contact" with God via a gold-plated coin engraved with President Trump and King Cyrus' faces — according to the "Jim Bakker Show" at least.

The coin is being peddled by Lance Wallnau, who claims God told him people need it to pray for Trump.

"When I asked the Lord, 'Why the coin?' he said 'Because when you take the coin, it's a point of contact,'" Wallnau said in the recording. *"So your faith is being released with a million other believers to pray protection and peace and wisdom and counsel over the president of the United States and over his family."*

I'm not so sure about this scam, but there is no doubt that President Trump needs our prayers and we certainly don't need a coin to make contact with Him in the process! On the day of the crucifixion when the partition dividing the Holy of Holies was torn asunder – **"And the veil of the temple was rent in twain from the top to the bottom."** -(Mark 15:38; confirmed in Matthew 27:51).

When Jesus' Spirit left His body, the inner veil of the temple, separating the Holy of Holies from the Holy Place, was split apart. This curtain, made according to God's explicit instructions -(Exodus 26:31-33; 36:35; 2nd Chronicles 3:14), could be entered only by the high priest on the Day of Atonement. Being torn "from the top to the bottom" shows that it was God's mighty hand that split the veil. It was the final Day of Atonement, making useless all other sacrifices for sin. The Book of Hebrews gives the exposition of this concept. The curtain no longer had meaning. The way to the Holy of Holies was now being opened for all. -(See Hebrews 9:11-10:12.)

Undoubtedly the priests who served in the Holy Place saw the torn veil as they entered the temple that day and on following days. The Gospels say no more about the veil. Is it possible they kept the torn veil a secret from the people? For it to be known would tend to undermine the Levitical system from which they derived their status and their income—an interesting possibility.

The torn curtain revealed a state of *'iykhabōd*, "the glory is departed" -(1st Samuel 4:21). The one thing that made the building a true "temple" (*naos*) was the manifest presence of Jehovah, the cloud of glory called the Shekinah, from the Hebrew

shakan, "to dwell" -(Exodus 40:34, 35). The Shekinah was gone! No longer was the (nominal) temple hallowed by the manifest presence of God; it was now merely an attractive shell. It was this truth that so enraged the Sanhedrin that they summarily killed Stephen -(Acts 7:48-60).

On May 17th, 2019, Pastor Chuck Baldwin posted an article on his web site. Pastor Baldwin has stated that President Donald J. It was still, with oil being the main commodity, and the Knights Templar and Rothschild's used the religious aspects of Judaism to secure the land they needed. If people in the world, including many disgruntled world leaders, lashed out at Judaism, so much the better – it would only distract more from the true motives, global financial control through trade, finance, and commodity markets.

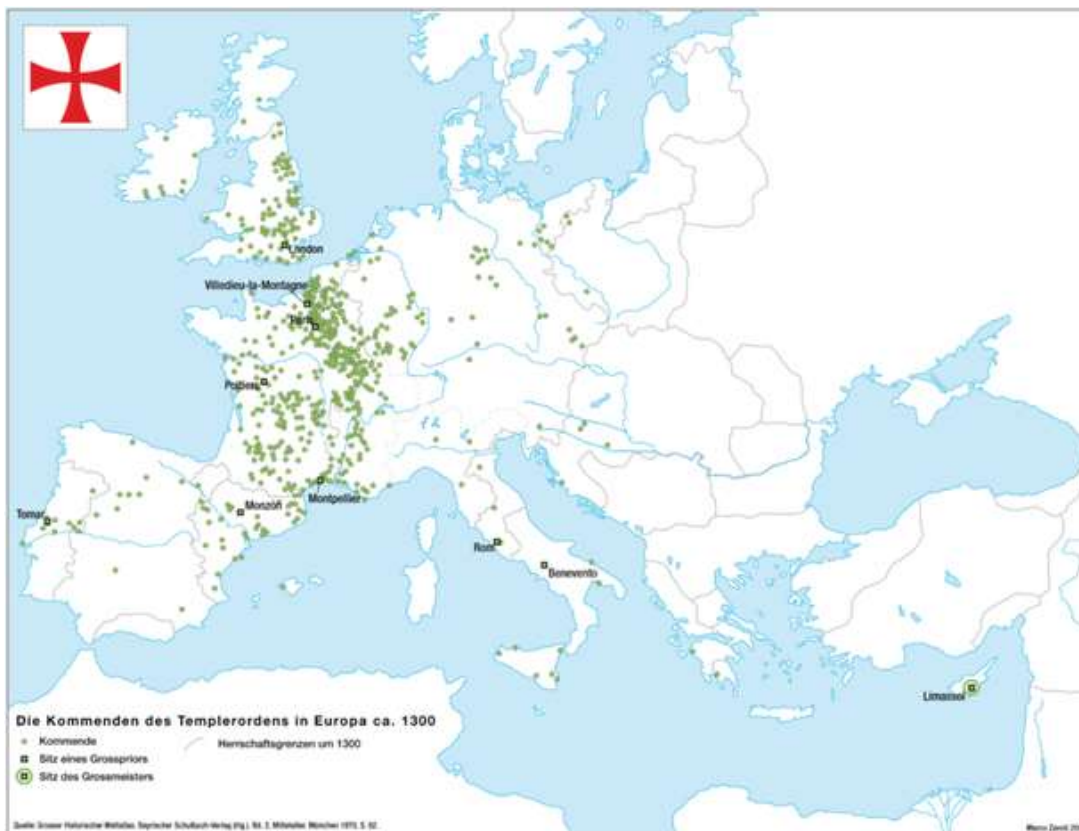
The Templars consolidated their power by legitimizing usury so they could lend from their banks. By the 1200s they'd used their extensive wealth from the Crusades and banking to build 9,000 castles across Europe.

They controlled a magnificent fleet of ships from the French port of New Rochelle and bought the island of Sicily in the late-1100s from Richard the Lionheart, though it was later overrun by Turks in 1798.

So powerful and so wealthy did the Templars become that in 1307 the king of France and the Pope both teamed up to discredit the Knights Templars, saying they used black magic and necromancy (communicating with the dead). Many of the Templars were rounded up and thrown in prison. It took place on Friday, October 13, and ever since then that day has had a bad connotation. Many of the Templars had escaped in their ships and fleeing to Portugal, then to England and Scotland. Others were said to have fled to Switzerland, later to begin the early banking activities.

By 1864 the book Justine Glincka had bought was printed up in another book and then the same happened in the 1890s. By then, however, the authorities weren't happy to hear about this, and the Russian author was arrested and tortured. The Illuminati was taking over, consolidating power, and secrecy was becoming the order of the day.

As the years went on, the Rothschild's became more daring. In 1785 they had plans in the works to start the French Revolution, but when those plans were discovered by the authorities, the Illuminati were kicked out of Bavaria. The country went so far as to send warnings to all the major European states about the Illuminati, but they were ignored, and Rothschild was now safe in Frankfurt.

Their plans for the French Revolution went forward after all, and that allowed them to stop the Catholic Church from issuing taxes as well as create favorable new

banking laws through the new nation's constitution. By 1791 Rothschild was extending his reach to America, where he convinced Alexander Hamilton to set up the First Bank of the United States with a 20-year charter.

Mayer Rothschild died in 1812, but his family was large enough to continue – he had five sons and five daughters and an immeasurable quantity of wealth, enough so that he could hold Prince William IX of Hesse-Hanau's \$3 million personal fortune in safekeeping. More Rothschild's would come and go, but their economic power and vision of a new world order under Satan remained. When the First Bank of the United States' charter was up in 1811, Congress refused to renew it. This angered the Rothschild's, who called for America to be brought back to "colonial status." Using loaned Rothschild money, England declared war on the United States, starting the War of 1812.

The idea was to bankrupt the young nation, which had little money and was looking at costs of \$10 million for just 1812 alone, mainly because 10,000 men suddenly had to be raised to fight the invading British armies funded by a group of secretive, debt-hungry bankers. Congress was able to provide the funding through increased customs duties but in 1813 revenues were only going to be \$17 million for the country, while costs would be \$36 million.

Republicans had control of Congress, and they didn't want to raise taxes so that meant more borrowing, \$19 million worth. By 1814 the country was looking at another \$30 million budget deficit and by 1815 estimates put that at \$56 million. It was clear the war could not continue and both sides sued for peace, meeting in the Flanders city of Ghent in September 1814, just two months before the Congress of Vienna began meeting to settle the Napoleonic Wars. They talked for five months, and it was agreed a Second Bank of the United States would be created. The Treaty of Ghent was signed on Christmas Eve 1814 to cement the deal.

After that his five sons centered in the major financial capitals of Europe, did their best to buy up all the various government bonds when issued, selling them off to their network of brokers at an inflated price while still paying the initial offering price to the governments. They cornered markets and saw their wealth grow exponentially. So too did the tightness of their family, as historian Niall Ferguson explains in his book *'The Ascent of Money'*:

"As their numbers grew from generation to generation, familial unity was maintained by a combination of periodically revised contracts between the five houses and a high level of intermarriage between cousins or between uncles and nieces. Of twenty-one marriages involving descendants of Nathan's father Mayer Amschel Rothschild that were solemnized between 1824 and 1877, no fewer than fifteen were between direct descendants."

Most critics lamented the Rothschild's Jewish heritage, and the family used that anti-Semitic thought to further their own ends. In time it became a shield from their

critics, those that knew their true power. That lay in their war-making abilities, a pursuit dependent upon finance and debt. *“Without wars nineteenth-century states would have had little need to issue bonds.”* America had issued a lot of bonds during the War of 1812, and total costs for the war were \$158 million for the young nation, with the army and navy eating up \$90 million of that.

The total cost of interest on the money borrowed came to \$16 million and long-term veteran’s costs equaled \$50 million. Instead of paying off the modest national debt of \$45 million that had existed in 1812, the country now was looking at a national debt of \$127 million in 1815. To the Rothschild’s, it didn’t matter if the war was won or lost, or even who was fighting. Either way, there would be debt, and interest on that debt, and they’d profit on both the destruction and reconstruction. Nations would lose, and citizens would suffer, but the bankers would have their way of life.

They had their way with America, for another national bank was created, allowing them unfettered access to the nation’s money supply through their power to control lending and interest rates. It would take until 1835 for the national debt to be paid off completely, the first and only time that occurred in American banking history.

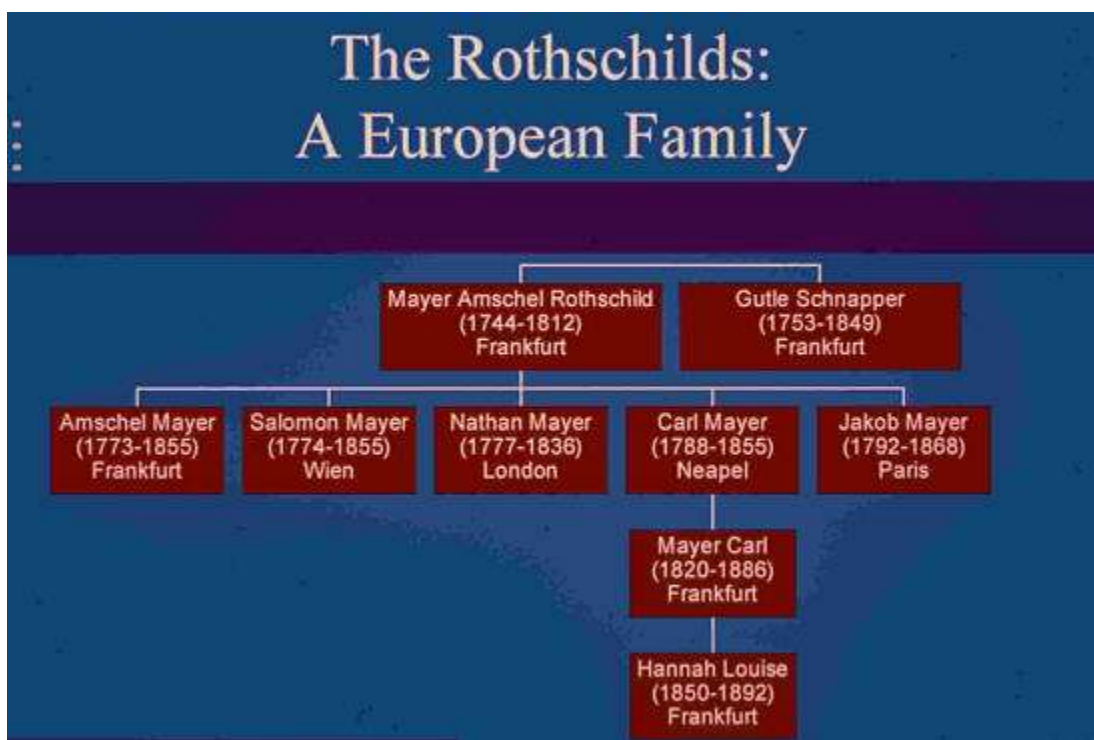


This famous quote above by Gutte Schnapper Rothschild was well-known in Europe during the late 18th and early 19th century. She was the wife of Mayer Amschel Rothschild.

It was President Andrew Jackson that would kill the second Rothschild bank in the country, the Second Bank of the United States. The Second Bank of the United States had started under another 20-year charter in 1816 and that came to an end in 1836. Before that, Jackson had consolidated the remaining \$75 million of debt held by the states and done everything he could to pay it off as fast as he could, depriving the

Rothschild's of the interest they so thought they deserved. In retaliation for Jackson's closing of the bank,

Rothschild agent Nicholas Biddle "cut off funding to the US government in 1842," which sent the country into a recession, or panic as they were still called. Jackson was a military man, one who won the Battle of New Orleans in the closing days of the War of 1812. He knew what he was up against, he had ran on the 1832 campaign slogan "*Jackson and No Bank*," and he prided himself on 'killing the bank,' as he was fond of saying of his veto to renew the bank's charter. "*You are a den of vipers*," Jackson had said of the bankers. "*I intend to expose you and by Eternal God I will route you out.*"



God may have disproved of the bankers, but **the Vatican** did not. The Rothschild's came to their rescue. In 1831 Pope Gregory XVI borrowed £400,000 from the Rothschild's, or the equivalent of \$43 million in 2014 dollars. James de Rothschild "became the official Papal banker," Gerald Posner writes in his book '*God's Bankers*', and this proved to be "*a lifeline to the church.*" From 1823/24 onward, the Vatican and the House of Rothschild were partners in crime. The Vatican commissioned the House of Rothschild to become their "Fiduciary" agents. By 1830, this relationship between the Vatican and the Rothschild's had proved to be mutually beneficial. The Vatican franchised "usury" condemned in the Bible to the House of Rothschild.

Back in America, Jackson said there would "*be a revolution by morning*" if the people knew what the bankers were doing to them. In 1832 he said that "*foreign stockholders*" controlling our currency were "*more formidable and dangerous than the naval and military power of the enemy.*" This resulted in an assassination attempt on

January 30, 1835, though the assassin's gun misfired. Jackson's will didn't, and his desire to see the foreign-owned and controlled bank's end only intensified.

Jackson's successor, President John Tyler, also refused to sign a new charter for the bank. Back in Europe the Vatican became more entwined with the Rothschild's. In 1848 Pope Gregory's successor, Pope Pius IX, borrowed 50 million francs from the Rothschild's, or \$10 million. By the end of that year it was determined that the Vatican was 142 million francs in debt to the Rothschild's, or about \$30 million. This comprised 40% of the church's total debt. The Vatican/Rothschild relationship proved to be highly successful throughout the post-Reformation period or what was known as the Counter-Reformation well into the mid-twentieth century.

Unlike the popes, all American presidents were able to keep their financial house in order, even Lincoln when he ordered the printing of Greenbacks during the Civil War instead of borrowing from foreign banks or allow another on American soil.

The National Banking Act had been passed in 1863, however, which created yet another private bank, this time under the guise of issuing war bonds. Lincoln said during his second presidential campaign that he'd veto the bill, but an assassin's bullet took him before he had the chance.

By 1899 the wealth of the Rothschild family was £41 million pound sterling, which "exceeded the capital of the five biggest German joint-stock banks put together," Still, they hungered for more. All the presidents after Lincoln had kept Jackson's pledge not to have a bank, all that is, until Woodrow Wilson swept into the White House in 1912 on a divided Republican ticket more than a united Democratic ticket. The following year saw the third and current Bank of the United States form, the Federal Reserve, which was passed with the Federal Reserve Act on December 23 of that year.

Congressman Charles August Lindbergh of Minnesota, the famous aviator's father, called it the "*greatest crime of the ages.*" The Federal Reserve was a private company, and one that had no reserves of currency. Its origins lay in the banking crisis known as the Panic of 1907.

President Teddy Roosevelt had signed the Aldrich-Vreeland Act in 1908 to study the causes of the Panic of 1907. From it came the National Monetary Commission, which was tasked with investigating what caused these banking panics that were becoming so prevalent in modern society. The result was a secret meeting with the leading bankers of the day, including Benjamin Strong, adviser to J.P. Morgan and eventually the first president of the Federal Reserve Bank of New York, at Jekyll Island in Georgia.

The rich industrialists and bankers came up with the Federal Reserve Bank of New York, which would become the leading bank of the Federal Reserve System, the institution and framework that was hammered out over those three years following the Panic of 1907. The New York Fed is by far the largest and most powerful of the 12

banks that make up the Federal Reserve. They operate 24 branches throughout the U.S.



You can read on line the two best books on the Fed, *'The Creature From Jekyll Island'* by G. Edward Griffin, and *'The Secrets of the Federal Reserve Bank'* by Eustace Mullins. How the men who conceived this system is one of the most interesting stories since Eve persuaded Adam to eat of the Tree of Knowledge of Good and Evil in the Garden of Eden.

How they managed to get the president to sign the idea into law speaks to one of my two points why there will be a war on Iran. The Untermeyer "Blackmail" was just waiting to be executed. Perhaps Woodrow Wilson didn't want a new national bank, perhaps he wanted to keep things as they had been since Jackson's days. There's a good chance that he couldn't have even if he'd wanted to.

President Wilson was visited by one Samuel Untermeyer of the Guggenheim, Untermeyer, and Marshall Law Firm. Untermeyer was well-known in the Democratic Party, he had advised the government on interpreting and enforcing income tax law, was also involved in anti-trust legislation. He believed in government ownership and helped prepare the Federal Reserve Bank Law, the Creighton Bill, Federal Trade Commission Bill and other legislation that limited the power of the trusts. However that day, he had something else on his agenda.

Mr. Untermeyer surprised President Wilson that he had been retained to bring a breach of promise action against him. He informed the President that his client was willing to accept \$40,000 in lieu of action. Untermeyer's client was the former wife of a professor at Princeton University at the same time Wilson was a professor there. Wilson did not have the money to keep this affair secret.

Untermeyer offered a caveat and volunteered to give President Wilson's former sweetheart the \$40,000 out of his own pocket on one condition: that Wilson promise him to appoint to the first vacancy on the United States Supreme court a nominee to be recommended to Wilson by Untermeyer. Wilson agreed to do so. Untermeyer kept the packet of letters to insure against any similar attempt to renege or back out of the deal.

When President Wilson was required to appoint a new member of the Supreme Court, Untermeyer recommended Louis Brandeis. A Jew had never served on the Supreme Court before. The President and Justice Brandeis became unusually intimate friends. Brandeis knew the circumstances of his appointment to the Supreme Court.

In 1914, Justice Brandeis was the most politically influential of all Zionists in the United States. He was in a powerful position to serve Jews both at home and abroad. The opportunity to perform a great service for his Zionist followers soon became available.

Justice Brandeis volunteered his opinion to Wilson that the sinking of the S.S. Sussex by a German submarine with the loss of lives of United States citizens justified the declaration of war. Relying upon the legal opinion of Justice Brandeis, President Wilson appealed to Congress to declare war on Germany April 2, 1917. It is commonly understood that Brandeis more than anyone else guided Wilson into committing America to World War I.

Having world wars was very important to the Illuminati, the secret society that the Rothschild's had created back in 1776. Nothing created more long-term debt obligations than war, and no form of debt was more secure than that backed by taxpayers. The Rothschild's profited two ways, loaning the money to start a war and then on the back end loaning money for reconstruction.

It's a lot to swallow, the truth. The Illuminati knew it would be, so that's why they set up the Anti-Defamation League in 1913, so that anyone speaking out against the Rothschild's or the Illuminati would be labeled as anti-semitic, anti-Jew. All the while, however, the nation has suffered, and slid ever more into debt.

The Federal Reserve Act of 1913 was signed into law by Woodrow Wilson on December 23, 1913. For the first time in 135 years the United States had a national bank. Before Woodrow Wilson had put the nation in war, the country had but \$3.6 billion in national debt. By 1918 that was \$14 billion and in 1919 it was \$27 billion. Today it is \$21.4 trillion. The sky is the limit.

If you don't think President Trump will start a war with Iran, think about how the personal shame of Woodrow Wilson's love letters gave us the Federal Reserve System Act signed into law. Then consider the leverage the Rothschild's have in holding nearly \$900 billion of Donald J. Trump's debt. Think about it for a bit, what would you do? Remember, as Dr. Chuck Baldwin stated, Trump is a liar! In this global game of high-stakes poker, it's show time as to who has the Royal Flush and who has a 32 offsuit!

Things settled down after that and the debt was actually paid down all through the 1920s, to \$16 billion by the time of the 1929 Crash. Interest payments of 2.5% would run to \$400 billion a year on that level of debt, a bankers' dream come true. For the Rothschild's that's exactly what it was, and the clandestine banking family was fast becoming one of the most powerful players on the world stage, and one virtually unknown. The interest on \$21 trillion dollars was \$523 billion in the last fiscal year. In four years it will more than double to \$1.2 trillion dollars.

Several recent indicators strongly suggest President Donald Trump's administration appears to be angling for a war with Iran. On Monday, *'The New York Times'* reported that the White House has been reviewing military plans against Iran. According to sources, "Acting Defense Secretary Patrick Shanahan presented an updated military plan that envisions sending as many as 120,000 troops to the Middle East should Iran attack American forces or accelerate work on nuclear weapons."

To no one's surprise, it was Trump's national security adviser John Bolton who ordered the updated plan. Bolton has made it his mission to spark a war against Iran, and he was part of the apparatus of building the false case for the disastrous 2003 U.S. war against Iraq. So hawkish is Bolton that in an interview with *'Foreign Policy'* in 2007 he said, *"Once upon a time, we knew how to do clandestine regime change. We need to reacquire that capability."* As the *'Times'* pointed out, Bolton's new review of military plans to attack Iran is reminiscent of preparations made ahead of the 2003 Iraq war.

Bolton's war plan for Iran began with the Trump administration abandoning the Obama-era nuclear deal a year ago and imposing harsh new sanctions on Iran. In mid-April, Trump designated Iran's elite Revolutionary Guard forces as a terrorist group. It was the first time a military arm of a foreign nation was placed on the list of terrorist groups. In a statement, Trump said the designation *"underscores the fact that Iran's actions are fundamentally different from those of other governments."* Then in early May, the U.S. military sent an aircraft carrier and bomber task force of four B-52's on course to Iran, which Bolton announced was *"in response to a number of troubling and escalatory indications and warnings."* He also made clear the military threat was intended *"to send a clear and unmistakable message to the Iranian regime that any attack on United States interests or on those of our allies will be met with unrelenting force."*

Marine Major-General Smedley Butler's book *'War Is A Racket'* relates that he had received two Congressional Medals of Honor, and a Distinguished Service Medal as an enforcer for the banks.

Now, Saudi Arabia, whose hatred of Iran mirrors that of Bolton, is claiming that one of its oil pipelines had been attacked by a drone causing "limited damage." The claim Tuesday came just a day after the Gulf Arab kingdom and U.S. ally said two of its oil tankers had been "sabotaged" off the coast of the United Arab Emirates, sharing photos of damage to the hull of its vessels. Reports claim the attacks were the work of drones flown by Iranian-supported Houthi rebels in Yemen and were in retaliation for Saudi Arabia's brutal U.S.-backed war in Yemen. So far it is not clear if Iran had any connection to the drone attacks, but with Bolton in charge of the U.S. Iran policy, no direct connection may be required. Even a whiff of Iranian links to aggression could be reason enough to be met with "unrelenting force."

We've been here before. Seventeen years ago President George W. Bush used the infamous term "Axis of Evil," to describe Iran, Iraq and North Korea. He claimed that Iran wanted to attack Israel with a nuclear weapon and trigger World War III. Reports emerged of the CIA funding a terrorist group in Iran, and media analysts repeatedly warned against the "impending war with Iran."

It would be helpful for you to read *'War with Iran Is America's Endgame'* by Major Danny Sjursen. Major Danny Sjursen, a *'Truthdig'* regular contributor, is a U.S. Army officer and former history instructor at West Point. He served tours with reconnaissance units in Iraq and Afghanistan. He has written a memoir and critical analysis of the Iraq War, *'Ghost Riders of Baghdad: Soldiers, Civilians, and the Myth of the Surge.'*

Bolton's last official government position before joining Trump's White House was as U.S. ambassador to the United Nations during the Bush years. Bolton, Bush and former Vice President Dick Cheney were all part of a cohort of war hawks known as the "neo-conservatives." A 2003 *'Christian Science Monitor'* article accurately described their agenda: "Neocons believe that the United States should not be ashamed to use its unrivaled power – forcefully if necessary — to promote its values around the world. Some even speak of the need to cultivate a U.S. empire." Even more ominously, the article stated, "Neoconservatives believe modern threats facing the U.S. can no longer be reliably contained and therefore must be prevented, sometimes through preemptive military action."

Although Bolton has been angling for regime change in Iran for decades, there is little appetite elsewhere for war. A poll conducted last July found strong public opposition within the U.S. for a war on Iran. America's once-trusty allies in Europe are no longer pledging blind allegiance to the United States. Negotiators working tirelessly for years to craft the Iran nuclear deal alongside U.S. representatives are now desperately trying to salvage what's left of it after Trump withdrew. Ahead of an Iran-centered meeting this week in Brussels, Britain's Foreign Secretary Jeremy Hunt warned, *"We are very worried about the risk of a conflict happening by accident, with an*

escalation that is unintended really on either side.” Secretary of State Mike Pompeo decided at the last minute to attend the meeting uninvited but failed to convince Europe that Iran was deserving of war.

Pompeo had little luck in Iraq when, during an impromptu visit to Baghdad last week, he attempted to convince Iraqi leaders that Iran was a threat. Prime Minister Adel Abdul Mahdi retorted, “Iraq is building its relationships with all on the basis of putting Iraq’s interests first,” and that his goal was to maintain balanced relationships with “friends and neighbors, including neighboring Iran.” Iraq has come out by saying it would not permit American troops to use Iraq as a staging ground for an invasion of Iran; and, would demand all U.S. troops to leave Iraq immediately.



The recent deployment of the USS Abraham Lincoln carrier to waters off Iran was purportedly in response to “specific and credible” intelligence that Iran was targeting U.S. forces in Iraq and Syria. Yet a British officer stationed in Iraq, who is part of the coalition forces there, told reporters Tuesday during a video news conference at the Pentagon: “No, there’s been no increased threat from Iranian-backed forces in Iraq and Syria.” Going to war with Iran will be a harder sell than it was to war with Iraq.

Still, none of this seems to deter Bolton or Trump. When asked about potential war with Iran, Trump told reporters, *"We'll see what happens with Iran. If they do anything, it would be a very bad mistake."* His threats are part of a pattern of aggressive language toward Iran since he took office. Joining in the collective sense of imperial hubris are Republicans like Arkansas Sen. Tom Cotton, who said in an interview that the U.S. could defeat Iran militarily in just *"two strikes, the first strike and the last strike."*

Americans vehemently opposed the 2003 Iraq war, and hundreds of thousands protested in cities around the country in conjunction with millions of others worldwide. But Bush and his neo-con allies did not care about public opposition, evidence of a real threat, or much else. They simply wanted war with Iraq, and they waged it willfully, destructively and chaotically, leaving a bloody trail of hundreds of thousands of deaths and political and regional instability. The Iraqi government did not hesitate this past week to say it would not permit the U.S. to use Iraq as a staging area for a war with Iran!

Logic will not deter the Trump bullies. Neither will a history lesson. With Bolton back in a seat of power and pushing our unhinged president toward war with Iran, we may be on the precipice of yet another deadly military disaster. Simple logic does not apply to this forthcoming war with Iran. Iran is three times the size of Iraq and 120,000 may be too conservative of a force to take down Iran.

The overriding issue, first and foremost, is to get a Rothschild central bank into Iran and Syria and to steal their gold reserves, as they have done continuously to country after country for over a century. The real reason this is not talked about in public has to do with speaking ill of the House of Rothschild. For example, Catherine Austin Fitts, publisher of *'The Solari Report'* and a frequent guest on Greg Hunter's Internet news site, *'USA Watchdog'* uses the term "Mr. Big". That said, The world right now is on the cusp of the fulfillment of Isaiah 17 and Ezekiel 38-39. According to the Ezekiel prophecy, NO nation will come to Israel's aid; this includes the United States. Exactly what will prevent America from being able or willing to come to Israel's defense, we do not know but can only speculate. It has been my opinion that the rapture itself and the subsequent aftermath of it will likely cause the complete collapse of the United States almost immediately. Something else may occur that would remove the United States from global power and prominence; an EMP attack; a natural disaster, like the eruption of the Yellowstone caldera, (map on next page).

To monitor volcanic and seismic activity in the Yellowstone area the Yellowstone Volcano Observatory (YVO) was established in 2001. YVO is partnership of scientists from the US Geological Survey, National Park Service, University of Utah, University of Wyoming, University NAVSTAR Consortium (UNAVCO) and the state Geological Surveys of Wyoming, Montana and Idaho. YVO scientists monitor Yellowstone volcano with a real time and near real-time monitoring network of 26 seismic stations, 16 GPS receivers, and 11 stream gauging stations. Scientists also collect information is on temperature, chemistry, and gas concentrations at selected hydrothermal features and chloride concentrations in major rivers. A monthly activity summary, real-time monitoring of seismicity and water flow, and near real-time monitoring of ground deformation, can

be found at the Yellowstone Volcanic Observatory website. The Yellowstone caldera is 30 x 45 miles in size, vastly larger than Mount St. Helens that erupted in Washington State in 1980. Scientists have said that if Yellowstone blows up, it will impact all of Canada and the U.S. In a recent article, the only area that would not be affected was the southernmost thirty miles of south Florida.



This destruction, along with the complete absence and inability of the U.S. to ever again be a power player on the global stage, will leave a worldwide power vacuum into which the Antichrist will step and begin his rise to global power. But Scripture is definitive on three events that define the beginning of the end!

Three events precede the Seventieth Week of Daniel, a period of 7 years:

- Rapture of the Church -(1st Thessalonians 4:13-19; 1st Corinthians 15:50-56),
- Destruction of Damascus -(Isaiah 17:1-2),
- The Russia/Turkey/Iran invasion of Israel on the Golan heights -(Ezekiel 38-39),

The time frame for this event is to be **"that day"** in verses 17:4 and 7, and as **"the day of grief and of desperate sorrow"** in verse 17:11.

While this prophecy is titled "The Burden of Damascus," it is with the larger context, both geographically and in time. At the same time that Damascus and Syria are destroyed, a larger area is impacted negatively as well. This includes Jordan and Israel. Israel is not destroyed, but it does not escape without serious consequences. Isaiah 17:4 portrays this as a condition resulting from a common war or catastrophe. This is a simultaneous event.

To be sure, Isaiah's ministry ran from 740-680 B.C. Some refute the prophecy, but it should be known that Damascus has never ceased to be a city. In the broader context of the history of Damascus we could draw from various historical sources at least a dozen reasons Isaiah 17:1 is referring to the modern day capital of Syria. Damascus will be completely destroyed and the destruction likely will be done by Israel. The nuking of Damascus is hanging by a thread over the Middle East, ready to ignite a prophetic chain of events that will engulf many nations.
