The Extinction of Species, Bill Gates & the US Military [A Jon Rappoport Report]

"Proponents have framed gene drives as a breakthrough tool for eradicating pests or invasive species. However, the Gene Drive Files reveal that these 'conservation' efforts are primarily supported by military funds."

Gene drive technology could be deployed to wipe out troublesome plant-parasites, weeds, crops, animal pests, animals, and...what about humans? Mull that over with your morning coffee.

Several years ago, UN member nations were considering a recommendation to call a moratorium on the use of gene drives. However, Bill Gates showed up to try to squash the moratorium.

The Gene Drive Files reports: "Documents received under Freedom of Information requests reveal that the Bill and Melinda Gates Foundation paid a private agriculture and biotechnology PR firm \$1.6 million for activities on Gene Drives. This included running a covert 'advocacy coalition' which appears to have intended to skew the only UN expert process addressing gene drives..."

"Following global calls in December 2016 from Southern countries and over 170 organizations for a UN moratorium on gene drives, emails to gene drive advocates received under a Freedom of Information request by Prickly Research reveal that a private public affairs firm 'Emerging Ag' received funds from the Bill and Melinda Gates Foundation to co-ordinate the 'fight back against gene drive moratorium proponents'."

There's more from the Gene Drive Files. It involves the military:

"A trove of emails (The Gene Drive Files) from leading U.S. gene drive researchers reveals that the U.S. Military is taking the lead in driving forward gene drive development."

"Emails obtained through a freedom of Information request by U.S.-based Prickly Research reveal that the U.S. Defense Advanced Research Projects Agency (DARPA) has given approximately \$100 million for gene drive research, \$35 million more than previously reported, making them likely the largest single funder of gene drive research on the planet. The emails also reveal that DARPA either funds or co-ordinates with almost all major players working on gene drive development as well as the key holders of patents on CRISPR gene editing technology."

"These funds go beyond the U.S.; DARPA is now also directly funding gene drive researchers in Australia (including monies given to an Australian government agency, CSIRO) and researchers in the UK. The files also reveal an extremely high level of interest and activity by other sections of the U.S. military and Intelligence community."

For the moment, put aside the notion of intentional extinction of species. Consider unintended consequences.

As I've shown in past articles, the latest and greatest gene-editing tools (e.g., CRISPR), which are used for gene drives, are far from slam-dunk precise, despite official assurances.

For example, this study: Genome Biology, July14, 2017, titled, "CRISPR/Cas9-mediated genome editing induces exon skipping by alternative splicing or exon deletion." An exon is "a segment of a DNA or RNA molecule containing information coding for a protein or peptide sequence." So you can see that exon skipping or deletion is a very bad outcome.

ANY gene editing done on ANY species opens the door wide to all sorts of errors and unforeseen consequences.

As for intentional destruction, we have this: MIT Technology Review, 2/8/16: "We have the technology to destroy all Zika mosquitoes."

"A controversial genetic technology able to wipe out the mosquito carrying the Zika virus will be available within months, scientists say."

"The technology, called a 'gene drive,' was demonstrated only last year in yeast cells, fruit flies, and a species of mosquito that transmits malaria. It uses the gene-snipping technology CRISPR to force a genetic change to spread through a population as it reproduces."

"Three U.S. labs that handle mosquitoes, two in California and one in Virginia, say they are already working toward a gene drive for Aedes aegypti, the type of mosquito blamed for spreading Zika. If deployed, the technology could theoretically drive the species to extinction."

"...a gene drive [gene editing] can...make mosquito populations disappear. The simplest way to do that is to spread a genetic payload that leads to only male offspring. As the 'male-only' instructions spread with each new generation, eventually there would be no females left, says Adelman. His lab discovered the Aedes aegypti gene that determines sex only last spring. The next step will be to link it to a gene drive."

Bill Gates favors this technology. So shouldn't we? After all, Bill is the number one humanitarian on the planet, right?

"The team's disease monitoring experts would look for potential outbreaks. Once it spots one, GERM should have the ability to declare an outbreak and work with national governments and the World Bank to raise money for the response very quickly. Product-development experts would advise governments and companies on the highest-priority drugs and vaccines."

Gates continues, saying that the team would coordinate with various countries to determine "how and when to implement border closures and recommend mask use."

"... Militaries regularly run war games to evaluate their readiness—we should do the same with disease threats. In most countries, these exercises can be run by local public health and military leaders, with GERM acting as an advisor and reviewer. For some low-income countries, the world should invest in building this capacity and lend resources as needed."

According to Gates, the global team will be made up of 3,000 disease experts under World Health Organization (WHO) purview and will receive around \$1 billion per year in funding.

And who better to assemble such a team than Bill Gates? After all, Gates appears to have a crystal ball into pandemics.

On October 18, 2019, just weeks before China told the world about COVID-19, the John Hopkins Center for Health Security held **Event 201** in partnership with the World Economic Forum and the Bill and Melinda Gates Foundation.

With unparalleled foresight, participants of Event 201 modelled a "<u>fictional coronavirus pandemic</u>" — almost identical to COVID-19 — that would demand a top-down global response and the collusion of various national governments and international organizations.

Gates' announcement of the GERM team coincides with the World Health Organization's drafting of a **global pandemic treaty**.

As previously reported by The Counter Signal, the pandemic treaty was introduced during a WHO **Special Session** entitled "The World Together" in December 2021.

As per the WHO, the treaty is to be upheld by the WHO's constitution, which under Article 19 "[provides] the World Health Assembly with the authority to adopt conventions or agreements on any matter within WHO's competence." [Emphasis added]

This authority was initially designed to pertain only to the WHO Framework Convention on Tobacco Control but is being expanded to include dictating Member States' future pandemic responses.

In the future, the pandemic treaty will not only ensure that member states abide by International Health Regulations but will also put the WHO in the driver's seat, so to speak. Member states, including the US and Canada, will take their orders directly from the organization.

As Conservative MP <u>Leslyn Lewis</u> explains, "The treaty includes 190 countries and would be legally binding. The treaty defines and classifies what is considered a pandemic, and this could consist of broad classifications, including an increase in cancers, heart conditions, strokes, etc. If a pandemic is declared, the WHO takes over the global health management of the pandemic."

".... "Of even more concern, if this treaty is enshrined, the WHO would be in full control over what gets called a pandemic. They could dictate how our doctors can respond, which drugs can and can't be used, or which vaccines are approved. We would end up with a one-size-fits-all approach for the entire world... A one-size-fits-all response to a health crisis doesn't even work across Canada, let alone the entire globe."

The WHO has further stated that countries disobeying regulations dictated by the WHO through their pandemic treaty <u>may need to be sanctioned</u>.

It isn't unreasonable to assume that the GERM team, as a new branch of the WHO, would oversee making sure member states comply with the pandemic treaty after the draft is finalized and member states sign-on.

The next question, then, is how the WHO and Bill Gates would be able to monitor every individual in every country to determine whether enough people are sick to justify locking a region down.

To this end, the WHO has contracted German-based Deutsche Telekom subsidiary T-Systems to <u>develop a global vaccine passport system</u>, with plans to <u>link every</u> person on the planet to a QR code digital ID.

"COVID-19 affects everyone. Countries will therefore only emerge from the pandemic together. Vaccination certificates that are tamper-proof and digitally verifiable build trust. WHO is therefore supporting member states in building national and regional trust networks and verification technology," says unit head of the WHO's Department of Digital Health and Innovation Garrett Mehl.

"The WHO's gateway service also serves as a bridge between regional systems. It can also be used as part of future vaccination campaigns and home-based records."

Thus, there will be one pandemic treaty, one GERM team, one global vaccine passport, and one World Health Organization to monitor every person on the planet.
