

## FBI Declassifies Files on the CIA's Involvement in Satanic Ritual Abuse and Child Sex Trafficking (video)



After retiring from the FBI, **Ted Gunderson** set up a private investigation firm, “Ted L. Gunderson and Associates,” in Santa Monica. In a 1995 conference in Dallas, Gunderson warned about the proliferation of secret Satanic groups, and the danger posed by the **New World Order**, a **shadow government** that controls the U.S. government.

Gunderson discovered that in the U.S. there is a secret widespread network of groups who kidnap children and infants, and subject them to Satanic ritual abuse and subsequent human sacrifice.

One of those groups is The Finders, which Gunderson said is operated by the CIA. He wrote a book on The Finders, which can still be downloaded from his website (Ted Gunderson died in 2011).

This is the same CIA group that the FBI just declassified many of the files from their investigation into The Finders, although many names remain redacted to protect the guilty. (See below.)

Gunderson traveled around the country giving lectures about his work, which included cases that led him to discover the hidden groups involved with the Satanic Occult, which included child sex abuse and child sacrifice. His general lecture was about 4 hours, but there is one lecture still available today where he condensed this down to just a little over one hour.

At the end of this lecture, Gunderson has a woman named Linda Weigand come up and give her testimony. As he introduced her, Gunderson said:

***“This is one of the most classic examples of corruption, I have ever seen. And believe me, you can tell from my lecture, that I’ve seen some pretty awful examples of corruption.”***

The vehicle that is used by the U.S. Government and the CIA to traffick these children and run these Satanic ritual abuse networks, is the government funded Child Social Services and Foster Care network, most commonly known as “CPS” (Child Protection Services).

Massive government funds exist for all 50 U.S. States that can only be collected if they meet certain quotas of children put into this system, so many children are literally kidnapped, mostly medically kidnapped, from their parents to meet the demand for children in this evil, Satanic system, which is mostly operated by **Christian Churches collecting funds from the Government.**

Many people have courageously tried to expose this evil system that exists in every state and every county within the U.S., and sadly, many of them are now dead.

In 2009, Bill Bowen released a trailer for a documentary film he was producing exposing the corruption within Child Protection Services across the United States. The film is called Innocence Destroyed.

Bill Bowen died unexpectedly the next year, in 2010, reportedly from a heart attack, before he was able to finish the film.

The segments that were completed were published on YouTube, in three different videos.

Another person who exposed the corrupt Child Protection Services network was Georgia Senator Nancy Schaefer. Before she was murdered, she had produced evidence of this corruption, and the main lecture she gave on that evidence is now hard to find on YouTube, so we have published it on our Bitchute channel.

This lecture and the report that she created cost her her career, and ultimately her life.

Another State Senator who tried to expose the corruption in CPS and child sex trafficking and was murdered in the summer of 2019 was Arkansas Senator Linda Collins-Smith.

We covered her story in 2019, and it also has ties to child sex trafficking in Arizona, which I covered on a radio show I produced back in 2019 on KFAX out of Phoenix.

Much of this very evil Satanic ritual abuse and child sex trafficking happening in the United States was exposed in 2016 by Julian Assange and Wikileaks, which was named “**Pizza Gate.**”

I believe this is the main reason why **Hillary Clinton** was thrown under the bus in 2016, because she had too many ties to this network.

### **THE FBI DECLASSIFIES FILES ON THE FINDERS AND McMARTIN PRE-SCHOOL CHILD TRAFFICKING CASES**

In 1983, a woman named Judy Johnson from the affluent California community of Manhattan Beach went to the police, claiming that her 2-year-old son had been molested by Raymond “Ray” Buckey, a 28-year-old teacher at McMartin Preschool. Police began their investigation by notifying the parents of current and former students about the possibility of sexual abuse their child.

Numerous children told similar stories of satanic animal sacrifices and sexual rituals in secret rooms at the school. By 1984, Buckey was arrested on 79 counts of child molestation. His mother was also arrested as a conspirator, as well as several other members of the Buckey family, because McMartin Preschool was owned and operated by the Buckey-McMartin family.

The children said they were warned that if they told anyone, their parents would be killed. And sure enough, just as Buckey’s trial got underway in 1986 — a trial in which Judy Johnson was a key witness — she was discovered dead in her home, cause unknown. She was just 42 years old.

Almost exactly one year later, a former police officer who served as an investigator for the defense suicided himself at home.

With Johnson dead, Buckey’s defense attorney was able to impeach her character during the trial. It was also argued that the testimony of the children had been influenced (or implanted) by the psychological examiners who interviewed them.

Ultimately, Buckey was not convicted. A second jury deadlocked in 1990, and the case was dismissed.

For six years, the police and the FBI had actively investigated the McMartin Preschool case, according to the Los Angeles Times. After they closed their file — and the Buckey family revealed they had sold the shuttered McMartin Preschool to Arnold Goldstein for the development of an office building — frustrated parents of the abused children hired the subsequently retired chief and head of the Los Angeles FBI, special agent Ted L. Gunderson (1928-2011) to continue with the investigation, and commissioned an archaeological survey.

A decade later, you could find Gunderson speaking out about the McMartin case as well as a network of child molesters and traffickers called “The Finders.”

For decades, the FBI’s files on the McMartin case and The Finders were sealed. Not anymore. The agency declassified and released its files. It shows a decade of research spanning from California to Belgium.

### **THE FBI FILES**

The investigation into the cases described cults, child sex trafficking and kompromat. In recent decades, the mainstream media has refused to report on such cases. Such cases (see below) have been “debunked” by the usual suspects that the Crime Syndicate uses for cover. But the FBI’s own investigation suggests the cases were real enough and points to cover ups.

### **A TIMELINE OF EVENTS IS IN THE REPORT.**

From the news article “Officials describe ‘cult rituals in child abuse case” by Sandra Saperstein and Victoria Churchville of The Washington Post on Feb. 7, 1987:

‘Douglas J Ammerman’ and ‘Michael Houlihan’ were arrested at odd hours at a Tallahassee park with 6 unrelated children with no understanding of modern amenities, hot water, TV or phones. The children were reportedly bug bitten, wearing old and ragged clothes and 2/6 reported to have been ‘obviously abused.

Before their arrests in the park, Ammerman and Houlihan had told police that they were teachers from Washington “transporting these children to Mexico and a school for brilliant children,” according to Hunt. When police asked the men where the children’s mothers were, “they said they were being weaned from their mothers.”

- Contact of U.S. Customs by Tallahassee PD regarding discovery of unidentified children and adult male "guardians" in city park.
- Requested contact with Washington MPD for assistance in locating possible address and relatives of children.
- Address located with assistance of MPD Intelligence Division.
- Second address identified. One residence, one warehouse.
- Search warrants obtained by MPD Intel. Warehouse site of previous MPD Intel inquiry involving classified maps of underground tunnel/sewer system, Washington, DC.
- During search warrant staging, disclosure of pending search warrant execution made by Tallahassee PD to local media (Tallahassee, FL). Tallahassee Media representative contacted D.C. media for more details. D.C. media reps peruse public information at courthouse, are waiting at search warrant sites for MPD search teams.

- Search warrants executed with MPD and two U.S. Customs agents (one at each site). FBI not involved until walk through on following day.
- Seizure of numerous documents made to include passports, telexes, computer/electronic media, correspondence, et al. (See previous material for expanded description).
- After search warrant shut down on first day, news reports carried FBI press release announcing FBI as "lead investigating agench." Day after, once search resumed, FBI agent from Washington Field Office (WFO) makes walk through of warehouse, but does not examine any seized evidence.
- Additional search warrant executed on farm in rural Virginia with support by Virginia State Police. No federal involvement. Evidence of satanic/cult ritual discovered.
- Based on observed documents, Customs agent unsuccessfully attempts to gain access to evidence for detailed analysis for use in investigating possible export, neutrality act, mann act, and child pornography violations.

Pages 4-10 shows The Finders were caught many times, but various prosecutors declined to press charges. FBI, the U.S. State Department and others helped cover it up every time.

On page 39 we learn of a request that the FBI review original first-hand docs on The Finders instead of relying on previous agents summaries or review reports. Permission would be required to see the direct evidence.

♦ On 11/1/93, a representative from the VCU met with FBIHQ Office of Liaison and International Affairs SSA [redacted] (State Department liaison) and SSA [redacted] to discuss DOJ's request that the FBI review documents from the State Department Passport Office (DOS) and the [redacted] [redacted] pertaining to "Finders." It is noted that the DOJ requested that an FBI Agent "review relevant documents firsthand, from the relevant intelligence agencies, as opposed to having to rely on the agency's summaries or review..."

On page 40 we see clues as to how the Crime Syndicate's star chamber sistema buries investigative evidence in the wrong agencies, making serious pursuit difficult. The U.S. Customs Service is the agency with briefing materials on The Finders. DOJ and FBI have to request copy of materials from USCS.

♦ On 10/28/93, a representative of the Violent Crimes Unit met with George Bergasser, Section Chief, and Attorney [redacted] [redacted] Child Exploitation and Obscenity Section, Department of Justice. Bergasser noted that DOJ had received a three-ring binder from Special Agent [redacted] U.S. Customs Service (USCS). This binder contains USCS briefing material on "Finders." They requested that the FBI contact USCS to obtain a copy of the material contained in the three ring binder.

Page 41, evidence is turned over to US Attorney District of Columbia who refused to prosecute.

File review of 7-HQ-20191 indicated that a joint investigation, conducted by the MPD and WMFO, lead to the identification and interview of the mothers of the six children, two of the fathers, and several other key members of the "finders" group. On 2/18/87, WMFO presented the results of their investigation to Assistant United States Attorney [redacted] [redacted] United States Attorney's Office for the District of Columbia, Washington, D.C., who declined prosecution for violation of title 18, U.S. Code, Section 1201 (kidnaping) and 2251 (sexual exploitation of children). WMFO SA [redacted] was the WMFO case agent in this matter.

What's worse, page 50 from 1991 shows a memo on jurisdiction. It describes how the U.S. Postal Service, the FBI and USCS carve up the turf on child crimes. USCS has jurisdiction over "interdiction and international distribution of child pornography".



Thank you for your letter dated September 13, 1991, expressing your concerns regarding the U.S. Customs Service Child Pornography Program.

The Child Protection Act of 1984 clearly defined the agency jurisdiction in this typically multidisciplined area of enforcement. The U.S. Postal Inspection Service has jurisdiction pertaining to the use of the U.S. mail to transport child pornography, the Federal Bureau of Investigation (FBI) has jurisdiction over the interstate transportation of child pornography, and the U.S. Customs Service has jurisdiction over the interdiction and the international distribution of child pornography. The statute has created a close working relationship between the agencies at the field office and Headquarters level. The point of this is that the statute has permitted a clear definition of responsibility for the respective agencies.

Recently, the U.S. Customs Service Headquarters Office of Enforcement experienced a massive reorganization. This reorganization caused the Child Pornography and Protection Unit to be integrated into the Smuggling Investigations Division. The Child Pornography and Protection Unit was a part of the General Smuggling Branch which was a part of the Smuggling Investigations Division. All Units, Branches, and Sections were eliminated during the recent reorganization. The child pornography program is now headed by the National Child Pornography Program Manager, a Senior Special Agent assigned to the Smuggling Investigations Division, Office of Investigative Programs, at Headquarters. These changes have in no way affected the manner in which child pornography investigations are being conducted by its field offices or the support that the Headquarters staff provides to these field offices. The primary functions of the Unit remain the same, that is to coordinate investigations within the U.S. Customs Service and between the U.S. Customs Service and

Note: "Recently the USCS experienced a massive reorganization. This ... caused the Child Porn and Protection Unit to be integrated into the Smuggling Investigations Division. All Units, Branches, and Sections were eliminated during the reorg," the report states.

So somebody in high authority had the power to wipe out a whole unit of agents on the cases. But those names are redacted.

Next we learn that several congressional committees were sniffing around, and that a never-aired documentary was in the works. The story of what happened here has fallen down the memory hole.

concerning these allegations to DOJ. He is concerned that several Congressional subcommittees may be looking at the "Finders" matter and that the TV documentary "48 Hours" plans to air a segment on it.

DURING OCTOBER 1993, [REDACTED] MET WITH UNITED STATES CONGRESSMAN ROSE (FLORIDA) TO DISCUSS ALLEGATIONS CONCERNING A GROUP KNOWN AS "FINDERS." BOTH CONGRESSMAN ROSE AND [REDACTED] SUBSEQUENTLY PROVIDED INFORMATION CONCERNING THESE ALLEGATIONS TO DOJ.

On page 41, the FBI report contains a link to a Washington Post article in which neighbors of one sketchy property said the residents were *"a close-knit group of feminists who liked to help people and were not a cult."*

The U.S. Attorney for D.C. declined to prosecute despite extensive evidence of abuse and satanic rituals. The case was complicated by the mothers being found, and possibly having given consent. US Attorney involved has an interesting career path to say the least.

On page 68, a D.C. police investigation concluded that a CIA employee (1950-1979) was a member of The Finders.

“At Approximately 1530 hrs, 2/18/87 Dt. [redacted] spoke with S/A [redacted] reference any contact the members of the Finders may have had with the Agency, S/A [redacted] was guarded but frank in his responses. He confirmed that [redacted] Isabelle, now deceased, was an employee of the agency from 1950 until 1971”

WW Note: Likely Isabelle Pettie. Marion David Pettie, was the leader of the cult. “Dr. Greenberg” shows up and runs obfuscation.

Marion David Pettie, who retired from the Air Force in 1956 and defined himself as a “political powerhouse,” was the guiding light of the cult. He denied any connection to the CIA—yet his late wife was an employee of the agency and his son a veteran of Air America, the opiate courier. Confidential sources told police the Finders conducted “brainwashing” sessions and “explored satanism.”<sup>8</sup>

Police in Tallahassee were called off the case after Dr. Greenberg examined the children and found “no evidence of recent physical harm.” Nonetheless, two Florida policemen stood by their statement that they’d found visible evidence of sexual abuse. The original arrest file, as one investigating Treasury agent complained in an internal report, was “classified *secret* and not available for review.” Customs service agents in Washington discovered on the group’s premises directions for kidnapping children and photographing them. Yet the case was gutted, largely due to Dr. Greenberg’s denials that children could possibly be used by an occult group with an active interest in mind control programming.

Another ritual abuse “expert,” an oft-cited debunker, has FBI credentials. Agent Ken Lanning of the Quantico Behavioral Science Laboratory has provided “skeptics”—mostly pedophiles, CIA propagandists and mind control operatives in academia and the press—with an illusory pillar of debate. (The unit had three founders hailing from the Justice Department, among them Mark Richard, who went on to become a key advisor to Janet Reno in the Branch Davidian stand-off. According to Lanny Sinkin, writing in the *Portland Free Press*: “In a recent interview, Daniel Sheehan, general counsel for the Christic Institute, noted that Mr. Richard has a long history of [closing] down investiga-

This report deals with the entire investigation concerning a group of subjects who call themselves The Finders. In December of 1986, [redacted] called the intelligence division and reported that she had information concerning a cult operating in the District of Columbia. Virginia State Investigation:

Special Agent [redacted] of the Virginia State Police stated that his organization executed search warrants at the Finders Farm in Madison County Virginia. [redacted] stated that this group appeared to be a survivalist organization with attempts to take over the city government in Culpepper Virginia. During Virginia States investigation information was revealed that bodies were buried on the farm at the Nethers, but excavation revealed nothing. However, cages were discovered on the premises that witnesses revealed were used to keep children during thier visits to the farm.

**Summary:**

It is the writers belief that the Finders organization is and has been utilized by the Central Intelligence Agency as a disinformation service spreading non essential, non-critical information to various organizations throughout the United States and overseas. This group to the most part is made up of over-educated non-achievers who lacked the inborn initiative to succeed on thier own. Therefore they fell in with a charismatic leader who gave them direction and self importance. To the most part this organization individually is harmless, However when directed and monitored by a controlling factor they are capable of destructive and illegal activities. As in any cult structure the main drive is for the group and individual values and idealogy is lost, Therefore when a member is asked to perform a task that hereto fore may have been objectionable, He or She performs this mission for the good of the group.

As to the abuse of the children; I do not think that child abuse was a planned tactic of this group, but as in any cross section of society, sick and demented subjects belong to a cult as well. Page 85 indicates another Finders property location. So far: Florida, D.C., Maryland, Virginia and Ohio. Funded: CIA Founder: CIA lifer into Satanism. Known activities: Breed and raise kids. "Shape" them. Deliver intel assignments.

Did page 214 show the redacted name of former Los Angeles FBI chief, the aforementioned special agent Ted Gunderson?

Page 69 shows that agents tried to pass a report to a contact in Europe, but the disc is intercepted and memory holed.

The next document, from pages 52 to 53, appear to be another jurisdictional grab, instructing that MPD investigative reports were to be classified secret and not to be shared with the FBI.

- Children discovered in Tallahassee were eventually turned over to individuals claiming to be parents or guardians. No further MPD, FBI or Customs involvement.
- As far as is known, no details of [redacted] involvement ever became public.

Page 99 from Nov. 12, 1993, shows the State Department asked the FBI to handle inquiries on a HQ level.

On 11/9/93, SSA [REDACTED] OLIA-FBIHQ was telephonically contacted re the status of his efforts to have both [REDACTED] U.S. STATE DEPARTMENT queried re the FINDERS. [REDACTED] had previously been requested by SSA [REDACTED] VCU-CID, to handle the inquiries on a headquarters level. [REDACTED] advised that he was drafting a letter for approval by the VCU which would be sent to the respective agencies. He further advised that [REDACTED] was assisting him in this effort.

SSA [REDACTED] was requested to advise WMFO of the results of his efforts as soon as possible.

On 11/9/93, SSA [REDACTED] advised that he was handling the review of any FCI files at FBIHQ and would advise WMFO of the results.

### **AN IMPORTANT NOTE ABOUT MCMARTIN STUDENTS AND DEBUNKERS**

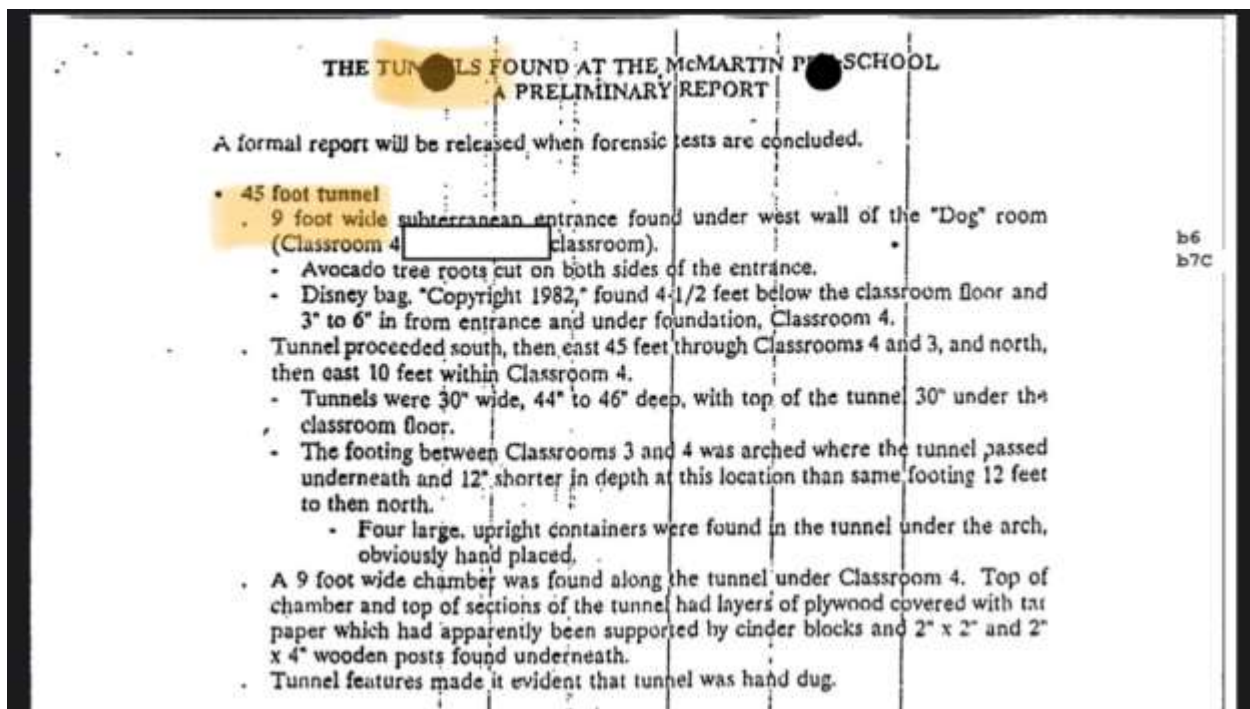

All of this has had a twist of exposure by Michael Baxter on January 21, 2023 in that the U.S. is deep into a Adrenochrome scandal in the Ukraine. This raises attention to the U.S. pushing Ukraine's leader covering Adrenochrome harvesting of children under cover of the war.

### **The Adrenochrome Crisis**

Western governments want their citizens to believe that Volodymyr Zelensky needs foreign funding—cash and weapons—to defeat or demoralize Russian forces or to

enervate them to the point they disobey Vladimir Putin's orders and forever flee Ukrainian soil. For nearly a year, Zelensky has begged incessantly for arms and cash; he's pleaded his case to the criminal Biden regime, the United Kingdom, France, Germany, and any NATO country with resources to finance his war against what he has called Russian oppression.

Since 2014, the United States has committed \$24 billion in security assistance to Ukraine, excluding the \$21 billion the U.S. sent over the last year. Zelensky has an insatiable appetite for foreign aid. He has received British tanks, U.S. Bradley Fighting Vehicles, howitzers, mobility artillery rocket systems, Stinger surface-to-air shoulder-fired missiles, and a variety of anti-tank missiles, as well as myriad small arms and ammunition. Biden also gave him lots of American dollars.

In October 2022, the White Hat partition of the U.S. military arrested then-Ambassador to Ukraine Bridget Brink after she had surreptitiously delivered \$2 billion to Ukrainian officials in Poland. That cash infusion was in addition to what the regime had put on public record. Brink's subsequent hanging, however, hasn't deterred the criminal administration from secretly funneling cash into Zelensky's greedy hands.

The question is, why does Zelensky need cash when he's already getting Western weapons?

Some monies were spent on foreign mercenaries to augment his depleted army. Zelensky has also used American dollars to bribe Russian officials to turn on Putin. But those expenditures hardly account for the clandestine billions he has gotten from the U.S., the UK, France, and Germany.

White Hats and Russian intelligence share a plausible explanation of how a sizable chunk of all that cash is being spent: financing Adrenochrome farms.

Yesterday we learned Russian Special Forces destroyed an Adrenochrome farm in Ukraine. Valiant Spetznas rescued 50 Russian children who had been kidnapped to harvest fluid from their adrenal glands, small, hormone-producing, triangular-shaped glands on top of both kidneys. Adrenal fluid is a crucial ingredient of Adrenochrome.

An FSB agent named Andrei Zakharov told news sources that one of the children, an eight-year-old boy, told a horrific tale about how his captors inserted long needles into his torso while frightening him until his lungs ran out of air from screaming and crying. The boy recounted a repetitive cycle of sleeping and then waking to see men hovering over him with long needles in their hands.

Zakharov insisted that Western Deep State paid Zelensky to allow them to build Adrenochrome warehouses in Ukraine because it had become too risky to maintain harvesting facilities in the United States. He believes there may be dozens of Adrenochrome factories in Ukraine and that the Deep State is abducting scores of Russian children to supply an endless stream of adrenal fluid.

*“Many Russian children disappear from homes in towns along the border,” Zakharov said. “At first, we thought they were being taken to be sold into child sex slavery, but now we know some are kidnapped to make Adrenochrome.”*

Producing Adrenochrome, he added, is a complicated, time-consuming endeavor. Adrenal fluid is distilled, then blended with synthetic opiates like oxycodone or fentanyl. The refined product is impermanent—it loses potency over time and must be kept chilled at 36 degrees Fahrenheit, then warmed to room temperature immediately before infusion or injection takes place.

Zakharov claims Adrenochrome produced in Ukraine is being flown in refrigerated containers to the U.S. and other Western nations.

In September 2022, Secretary of State Antony Blinken made an unannounced trip to Kyiv, where he announced almost \$3 billion worth of financial aid and weapons to help Ukraine and its neighbors during the Russian invasion. Zakharov said the FSB has irrefutable proof that Blinken left Ukraine with hundreds of liters of Adrenochrome.

Adrenochrome is said to be endemic to political and Hollywood elites, and recipients claim it prolongs life, wards off illness, and invigorates sexual prowess.

White Hats say prolonged use of Adrenochrome also causes psychosis.

As reported in April 2021, White Hats obliterated an Adrenochrome warehouse in California. A source in Gen. Eric M. Smith’s office told RRN that White Hats had found and destroyed three additional Adrenochrome storage facilities; his statement gives credence to Zakharov’s assertion that the Deep State has relocated Adrenochrome refinement overseas.

*“It’s certainly possible. They have resources to do that, and they know we’re hunting them down here. We still believe there are Adrenochrome repositories here in the United States, and we’re still searching for them,”* said our source in Gen. Smith’s office. *“Ironically, they’re waging war on fentanyl distribution while using it to make their Adrenochrome,”* he added. *“The more they use, the more they need, like any addictive drug. If the Russians are fighting to get rid of Adrenochrome, good for them. Maybe between our efforts, we can shut down the Adrenochrome market.”*
