

# BEFORE COVID-19 Panic: Bill Gates & Congressman Negotiated “Tracing Deal”

And so it begins with the first Congressional effort to codify what may be the first of many unconstitutional legislative attempts to create a totalitarian One World Government under the guise of attacking the coronavirus COVID-19. Introduced by Rep. Bobby Rush (D-III) on May 1st 2020, the [TRACE Act](#) would establish a nationwide contact and quarantine program, has been referred to the House Energy and Commerce Committee for a yet to be scheduled hearing before the Health Subcommittee. That subcommittee has a hearing scheduled for Thursday, May 14th on "[Protecting Scientific Integrity in COVID 19 Response](#)" with no published description of the hearing or list of witnesses. With 39 [co-sponsors](#), HR 6666 could be rolled into a larger CV response legislative package yet to be introduced.

### **HR 6666 a Blatant Unconstitutional Violation of the 4th Amendment**

HR 6666 grants \$100 billion to the CDC (Center for Disease Control) to establish a local mobile health unit in each community to conduct a diagnostic door to door COVID-19 testing program. With the ACLU nowhere in sight, there is no doubt of HR 6666's unconstitutionality as the Act states that such testing will take place "*at individuals' residences.*" The bill goes on to establish the effort to "*trace and monitor the contacts of infected individuals and to support the quarantine of such individuals.*"

In other words, TRACE not only allows a massive dragnet type effort to seek and find those infected in what may amount to enforced home invasions but to force compliance by requiring the names of all individuals an infected person has had contact with – all of which raises the constitutionality of the entire CV effort with the ultimate goal being mandatory worldwide vaccinations. HR 6666 is unconstitutional as it violates the Fourth Amendment which guarantees every American citizen the right to be secure in their own home. Since George Soros' \$50 million gift in 2016, the ACLU has been noticeably

AWOL on many important constitutional issues. Dr. Rashid Buttar has said that Ventura, California will be the first test location to initiate the TRACE program.



Illinois Democratic Rep. Bobby Rush has introduced the **H.R. 6666 TRACE Act**, which includes a \$100 billion grant program which would authorize the Secretary of Health and Human Services to create an army of contact tracers operating through healthcare, schools and nonprofit entities, who would perform COVID-19 diagnostic testing "through mobile health units and, as necessary, **at individuals' residences**, and for other purposes."

*"Until we have a vaccine to defeat this dreaded disease, contact tracing in order to understand the full breadth and depth of the spread of this virus is the only way we will be able to get out from under this,"* Rush says [on his website](#).  
And when will that be?

According to [Heavy](#), Rush's words echo those of Johns Hopkins Senior Scholar Dr. Crystal Watson, lead author of a [recent report](#) which concludes that **contact tracing is vital to reopening the country**.

*"In order to save lives, reduce COVID-19's burden on our healthcare system, ease strict social distancing measures, and confidently make progress toward returning to work and school, the United States must implement a robust and comprehensive system to identify all COVID-19 cases and trace all close contacts of each identified case."*

The bill's co-signers include Reps. Rashida Tlaib (D-MI), Gwen Moore (D-WI), Debbie Wasserman Schultz (D-FL), Steve Cohen (D-TN) and Republican Jefferson Van Drew of New Jersey.

In addition to the petition, Rush has received a fair amount of social media backlash, mainly out of concern for privacy.

Reactions on Twitter have ranged from Third Reich and [Hitler comparisons](#), to people suggesting that [Rush wants to hire spies](#), [make lepers of those who are identified as sick](#) and [waste money](#).

Senate Republicans [have been working on their own bill](#) focused on contract tracing privacy to "provide all Americans with more transparency, choice, and control over the collection and use of their personal health, geolocation, and proximity data (and) hold businesses accountable to consumers if they use personal data to fight the COVID-19 pandemic." -[Heavy](#)

Last week, former President Clinton, NY Governor Cuomo, Chelsea Clinton and CA Governor Newsom called for an 'army of contact tracers' to monitor citizens who have tested positive for COVID-19 and their contacts - shortly after which the Washington DC Department of Health posted job listings for **investigators with "Trace Force."**

Those who sign on will interview those who have tested positive for the virus - collecting *"demographic, clinical, social and historical data,"* while *"conducting an assessment to determine whether safe isolation can be achieved at home."* The program is a 13-month appointment.

Those who have been in contact with a positive case will be contacted to assess whether they have symptoms and require quarantine, **and will 'appropriate escalate'** cases when needed. Investigators will also use 'data management systems' to log interactions.

Meanwhile, many believe **it's too late for contact tracing to work** - and it's simply going to allow government to intrude further into the lives of Americans.

Trouble is, a mountain of scientific evidence indicates contact tracing won't work against the coronavirus. And given the virus' nature, deploying it earlier probably wouldn't have stopped the spread.

The coronavirus is fast-moving and [transmitted in multiple ways](#), such as touching contaminated surfaces like subway poles and door knobs. It can become aerosolized when someone sneezes two aisles over in the supermarket or coughs in an elevator. The virus is found in feces and may even spread when a toilet is flushed and viral particles become airborne.

**The “disease detectives” will have to ask: “Who was that at the supermarket or in the public restroom?” In many cases, they won't have an answer.**

Lancet Global Health scientists conclude that **contact tracing will work when “less than 1 percent of transmission occurred before the onset of symptoms.”** That's the opposite of the coronavirus: Victims are most contagious before or just as their symptoms begin, research indicates. By the time they are diagnosed and asked for contacts, those contacts are already infecting others. Oxford University scientists also caution that the coronavirus spreads by too many mechanisms “to be contained by manual contact tracing.” [-NY Post](#)

Contact tracing seems to be all the rage lately, but is it really just “contact tracing,” and how many laws are being broken while they surveil the country going door to door with the threat of isolation? Is this about preventing spread or is it to gather data, instill more panic, or create a false need for mail-in ballots? How far are these people willing to go, and who was instrumental in getting this rolling? How far are you willing to go to fight for your rights?

- **Bill Gates has funded Partners in Health over \$44 million between the Gates Foundation and Global Fund, and goes back decades with this group, working on numerous agendas and initiatives together. Chelsea Clinton is also on the board of trustees of PIH.**
- **There are over 60 companies rolling out tracing apps and getting people to register, while RFID/NFC syringes are being manufactured by the millions for a future vaccine.**



From early on, everyone was told that Google was working on an app that people could “voluntarily opt into” that would allow them to register their information and get notified if they come in close proximity to those who test positive for COVID-19. They portrayed it as a helpful safety tool for all (that tracks you), but they most certainly didn’t want to infringe on anyone’s privacy, so it would therefore be “voluntary” – until it wasn’t. This was merely a dipping of everyone’s toes into the pool of excrement that was coming down the pike.

**Over 60 Companies on Board**

## **Bobby Rush Has Been Busy**

- Rush has a [history](#) of pay-to-play.
- Rush was a Pastor at the Beloved Community Christian Church in Chicago, where non-profit organizations [complained](#) about Rush's inordinate amount of government aid he received. By 2013, they had racked up \$195,000 in tax delinquencies that went back a decade, including property tax, income tax, and employee withholding tax. As of 2018, five percent of Rush's congressional salary is being garnished to repay more than \$1 million he owed on a delinquent loan.
- Rush was a participant in the Aspen Institute Congressional Program for Africa's Economic, Security, and Development Challenges and the U.S. Role, which took place [August 12-19, 2019](#) in Kigali, Musanze, and Muhanga, Rwanda. There were seven other participants from the U.S. Congress, all of whom were Democrats from CA, IL, NY, and MO, except for Republican Fred Upton from Michigan, who was the former chairman of the committee on energy and commerce.

There were a handful of speakers in attendance, including Madeleine Albright who served under President Bill Clinton and received a Presidential Medal of Freedom from President Barack Obama, Peggy Clark who received a presidential award for excellence in microenterprise from Bill Clinton, and Mary Robinson the former President of Ireland from 1990-1997 who also received a Presidential Medal of Freedom from President Barack Obama.

**Who else was in attendance? Dr. Paul Farmer from Partners in Health who is running a massive scale contact tracing program in multiple states, two representatives from the Bill & Melinda Gates Foundation, and a dozen other scholars. It was a cozy group of about 45.**


