The Russian Orthodox Patriarch Kirill, the spiritual leader of the Russian Orthodox Church, said Sunday that the conflict in Donbas is a "metaphysical" battle against a godless international order that rewards governments which embrace sin and punishes those who embrace God's laws.

"For eight years there have been attempts to destroy what exists in the Donbass," Kirill said. "And in the Donbass there is rejection, a fundamental rejection of the so-called values that are offered today by those who claim world power."

"Today there is such a test for the loyalty of this government, a kind of pass to that "happy" world -- the world of excess consumption -- the world of visible 'freedom.' Do you know what this test is? The test is very simple and at the same time terrible -- this is a gay parade. The demands on many to hold a gay parade are a test of loyalty to that very powerful world, and we know that if people or countries reject these demands, then they do not enter into that world, they become strangers to it," he said.

Patriarch Kirill of Moscow, a long-time ally of Russian President Vladimir Putin, said on Sunday that the conflict in Donbas is about "a fundamental rejection of the so-called values that are offered today by those who claim world power."

The "test" of which side you are on, said Kirill, is whether your country is willing to hold gay pride parades.

"In order to enter the club of those countries, it is necessary to hold a gay pride parade. Not to make a political statement, 'we are with you,' not to sign any agreements, but to hold a gay parade. And we know how people resist these demands and how this resistance is suppressed by force," Kirill said during a sermon in Moscow.

Kirill categorized the war as a struggle of "metaphysical significance," for humanity to follow God's laws.

"What is happening today in the sphere of international relations has not only political significance. We are talking about something different and much more important than politics. We are talking about human salvation," he said.

"If we see violations of [God's] law, we will never put up with those who destroy this law, blurring the line between holiness and sin, and even more so with those who promote sin as an example or as one of the models of human behavior." Kirill said.

"Around this topic today there is a real war," he said.

Ukrainian President Volodymyr Zelensky took to Twitter [1] Sunday to express heartfelt gratitude to Facebook owner Mark Zuckerberg for taking a clear stand on the Ukraine crisis and letting users violate rules against hate speech: "War is not only a military opposition on UA land. It is also a fierce battle in the informational space. I want to thank @Meta and other platforms that have an active position that help and stand side by side with the Ukrainians."

"As a result of the Russian invasion of Ukraine we have temporarily made allowances for forms of political expression that would normally violate our rules like violent speech such as 'death to the Russian invaders.' We still won't allow credible calls for violence against Russian civilians," a Meta spokesperson said in a statement [2] March 11.

It naturally piques the curiosity why the social media behemoth is bending over backwards to violate its own longstanding regulations against hate speech to let Zelensky win the propaganda war in "the informational space" unless one takes into account the obvious fact that both Zuckerberg and Zelensky are Zionist Jews and take orders from Israel's clandestine security agencies. In 1992 Schwab established a parallel institution, the **Global Leaders for Tomorrow** school, which was re-established as **Young Global Leaders** in 2004. Attendees at the school must apply for admission and are then subjected to a rigorous selection process.

Members of the school's very first class in 1992 already included many who went on to become important liberal political figures, such as **Angela Merkel**, **Nicolas Sarkozy**, and **Tony Blair**.

This information about Ukraine's Zelensky provides an interesting overall view of just who Ukrainian President Volodymyr Zelensky really is and what he is all about. As the information indicates, he is one of Klaus Schwab's up and coming future leader for the world.

- Emmanuel Macron, the President of France

- Sebastian Kurz, who was until recently the Chancellor of Austria
- Viktor Orbán, Prime Minister of Hungary;
- Jean-Claude Juncker, former Prime Minister of Luxembourg and President of the European Commission ...
- Annalena Baerbock, the leader of the German Greens ... who is still in the running to be Merkel's successor. ...
- California Governor Gavin Newsom ...
- US Secretary of Transportation Peter Buttigleg ...
- Microsoft's Bill Gates
- Amazon's Jeff Bezos
- Virgin's Richard Branson
- Chelsea Clinton ...

All of these politicians who were in office during the past two years have favored harsh responses to the COVID-19 pandemic, and which also happened to considerably increase their respective governments' power. ... All of them expressed support for the global response to the pandemic, and many reaped considerable profits as a result of the measures. ...

Wolff believes that the people behind the WEF and the Global Leaders school are the ones who really determine who will become political leaders, although he stresses that he doesn't believe that Schwab himself is the one making these decisions but is merely a facilitator. He further points out that the school's alumni include not only Americans and Europeans, but also people from Asia, Africa, and South America, indicating that its reach is truly worldwide.

In 2012, Schwab and the WEF founded yet another institution, the "Global Shapers Community," which brings together those identified by them as having leadership potential from around the world who is under 30. Approximately 10,000 participants have passed through this program to date, and they regularly hold meetings in 400 cities. Wolff believes that it is yet another proving ground where future political leaders are being selected, vetted, and groomed before being positioned in the world's political apparatus.

Wolff points out that very few graduates of the Global Leaders school list it on their CVs. He says that he has only seen it listed on one: namely, that of the German economist Richard Werner, who is a known critic of the establishment. ...

Another thing that the Global Leaders graduates have in common is that most of them have very sparse CVs apart from their participation in the program prior to being elevated to positions of power, which may indicate that it is their connection to Schwab's institutions that is the decisive factor in launching their careers. This is most evident when the school's alumni are publicly questioned about issues that they have not been instructed to talk about in advance, and their struggles to come up with answers are often quite evident. Wolff contends that their roles are only to

act as mouthpieces for the talking points that those in the shadows behind them want discussed in public debate. ...

Wolff notes that politicians with unique personalities and strong, original views have become rare, and that the distinguishing character of the national leaders of the past 30 years has been their meekness and adherence to a strict globalist line dictated from above. ...

The WEF's current Board of Trustees includes such luminaries as **Christine Lagarde**, former Managing Director of the International Monetary Fund and current President of the European Central Bank; **Queen Rania of Jordan**, who has been ranked by Forbes as one of the 100 most powerful women in the world; and **Larry Fink**, **CEO of BlackRock**, the largest investment management corporation internationally and which handles approximately \$9 trillion annually ...

Wolff highlights that BlackRock, run by Global Leaders alumnus Larry Fink, is presently the largest advisor to the world's central banks and has been collecting data on the world financial system for more than 30 years now, and undoubtedly has a greater understanding of how the system works than the central banks themselves.

#### A possible agenda?

One of the goals of the current policies being pursued by many governments, Wolff believes, is to destroy the businesses of small- and medium-sized entrepreneurs so that multinational corporations based in the United States and China can monopolize business everywhere. Amazon, which was led until recently by Global Leaders alumnus Jeff Bezos, in particular has made enormous profits as a result of the lockdown measures that have devastated the middle class.

Wolff contends that the ultimate goal of this domination by large platforms is to see the introduction of digital bank currency. ...

Wolff further explains that the lockdowns and subsequent bailouts that were seen around the world over the past two years left many nations on the verge of bankruptcy Wolff says that two European countries are already prepared to begin using digital currency: Sweden and Switzerland. Perhaps not coincidentally, Sweden has had virtually no lockdown restrictions due to the pandemic, and Switzerland has taken only very light measures. Wolff believes that the reason for this may be that the two countries did not need to crash their economies through lockdown measures because they were already prepared to begin using digital currency before the pandemic began. He contends that a new round of lockdowns may be being prepared that will finish off the world's economies for good, leading to massive unemployment and in turn the introduction of Universal Basic Income and the use of a digital currency managed by a central bank.

The best way to combat their designs, Wolff says, is simply to educate people about what is happening, and for them to realize that the narrative of the "super-dangerous virus" is a lie that has been designed to manipulate them into accepting things that run contrary to their own interests. - Peter Thiel, billionaire member of the Bilderberg Steering Committee.
- Mark Zuckerberg, US billionaire credited with starting Facebook.
- Ben Goldsmith, English financier and environmentalist, son of James Goldsmith.
- Nikki Haley, later became United States Ambassador to the United Nations.
- Huma Abedin, termed the effective "right-hand woman" of Hillary Clinton.
- Jeremy Howard is an Australian data scientist and entrepreneur. In 2014, he started a business trying to digitize healthcare. Then at the very start of the COVID-event he organized a worldwide campaign for mandatory face masks, making face-to-face health care very difficult.
- Clare O'Neil, Australian politician. In 2019 she was considered a frontrunner for the deputy leadership during the 2019 Australian Labor Party leadership election.
- Andrew Bragg, Australian politician. He became a Senator in 2019.

- Ibram X Kendi is an American author and activist. He believes the low take-up of Black people having the COVID vaccine is due to racism.
- Vasudha Vats is a Vice president of Pfizer.
- Scott Morrison, Australian PM
- Greg Hunt, until recently Australia's Health Minister.

In the 2001 census, a third of Ukraine's over 40 million population registered Russian as their first language. In fact, Russian speakers constitute a majority in urban areas of industrialized eastern Ukraine and socio-culturally identify with Russia. Ukrainian speakers are mainly found in sparsely populated western Ukraine and in rural areas of east Ukraine.

Russian, Belarusian and Ukrainian together belong to the East Slavic family of languages and share a degree of mutual intelligibility. Thus, Russians, Byelorussians and Ukrainians are one nation and one country whose shared history and culture goes all the way back to the golden period of 10<sup>th</sup> century Kyivan Rus'.

Since 2019, after being elected president through questionable methods, Zelensky has surreptitiously been working on a clandestine project to foment a crisis with Russia on a flimsy pretext. Any other political leader with an iota of rational faculties, even somebody as rogue as his predecessor Petro Poroshenko, would promptly have agreed to the Kremlin's reasonable proposal that Kyiv must give a solemn pledge it won't join the transatlantic NATO military alliance.

Not only did he scornfully rebuff the Russian proposal but he also let Ukraine's security forces stage joint military exercises and naval drills alongside NATO forces in the Black Sea right under Russia's nose. His reckless disregard for the suffering of Ukrainian masses with whom he does not identify being a Zionist himself and suicidally provoking Russia into an armed confrontation aside, he is merely a pawn in the grand scheme of things. He received a standing ovation from the U.S. joint session of congress on March 16<sup>th</sup> in response to his request from the U.S. for help.

WASHINGTON — Ukrainian President Volodymyr Zelenskyy cited Pearl Harbor and the terror attacks of September 11, 2001 on Wednesday as he appealed to the U.S. Congress to do more to help Ukraine's fight against Russia, but acknowledged the nofly zone he has sought to "close the sky" over his country may not happen.

American Christians are asking how they can pray for the situation in Ukraine. A high-profile Southern Baptist pastor is suggesting what's called "imprecatory" prayers.

In Psalm 69, King David asked God to "pour out your wrath" upon his enemies, and "let your fierce anger overtake them" (vs. 24). During an interview last week on The Todd Starnes Show, Dr. Robert Jeffress – senior pastor of First Baptist-Dallas – counseled that it's okay to ask the same kinds of things about the injustices going on in Ukraine.

Rev. Robert (FBC Dallas) Jeffress said, "We need to pray against Russia. We need to pray against Vladimir Putin and his evil forces," said Jeffress. "People ask: Is that Christian to pray against people? You bet it is. David prayed for the destruction of God's enemies. We need to do that, too."

He pointed out that as powerful as Russia's strongman may seem at times, he's no match for the power of God – and his evil no match for God's sovereignty.

"In the end, Vladimir Putin is nothing more than a piece of lint of the pages of human history," said the pastor. "Daniel 2 says God is the one who raises kings and removes kings – and that includes Putin. He'll get rid of him when he's ready to get rid of him."

Jeffress also shared that he's often asked if the war in Ukraine might start the clock on the final countdown to Christ's return.

"... Although the end may be near, that doesn't mean the end is necessarily here," he explained. "People want to know: Do we go to our bunkers and prepare for Armageddon? Well ... maybe, maybe not. But there have been signs of Christ coming. But every day that passes we're getting closer to the end of the world, whether it's next year or 1,000 years."

Livestreamed into the Capitol complex, Zelenskyy said the U.S. must sanction Russian lawmakers and block imports, and he showed a packed auditorium of lawmakers an emotional video of the destruction and devastation his country has suffered in the war.

"We need you right now," Zelenskyy said, adding, "I call on you to do more."

In urging a steeper economic hit to the Russians, he said: "Peace is more important than income."

Lawmakers gave him a standing ovation, before and after his short remarks, which Zelenskyy began in Ukrainian through an interpreter but then switched to English in a heartfelt appeal to help end the bloodshed.

"I see no sense in life if it cannot stop the deaths," he told them.

Two days later Vladimir Putin announced: Russia To Build \$10 Billion Nuclear Sites In Iran on March 17, 2022. As part of concessions provided in the soon-to-be-announced nuclear agreement that would ensure sanctions on both countries are withdrawn, Russia's main state-controlled energy business is poised to cash in on a \$10 billion contract to build out one of Iran's most contentious nuclear sites.

Rosatom, Russia's largest energy corporation, has a \$10 billion agreement with Iran's atomic energy agency to develop Tehran's Bushehr nuclear project, according to Russian and Iranian documentation. On Tuesday, Russia and the Biden government announced that the revised nuclear accord contains carve-outs that will lift sanctions against both nations, allowing Russia to fulfil its obligations.

"We, of course, would not sanction Russian participation in nuclear projects that are part of resuming full implementation of the JCPOA," State Department spokesperson Ned Price acknowledged the agreement, which was signed in 2015. On Tuesday, Russia's foreign ministry issued a statement saying that "additions were made to the text of the future agreement on JCPOA restoration to ensure that all the JCPOA-related projects, [especially] with Russian participation, as well as Bushehr [nuclear power plant], are protected from negative impact of anti-Russian restrictions" by the United States and European Union.

As a result of American and European sanctions imposed in reaction to Russia's unwarranted special military operation in Ukraine, the relaxation of these penalties will supply a crucial stream of money for Moscow's Rosatom enterprise. The concessions to Moscow have enraged Republicans on Capitol Hill, who accuse the Biden administration of relaxing sanctions against Russia in exchange for a deal with Iran. Even while the country's war machine sweeps through Ukraine, Moscow has functioned as the US' principal mediator in negotiations. The Washington Free Beacon initially reported on Tuesday that a policy document floating amongst legislators reveals how the new nuclear pact will turn Russia into president Vladimir Putin' "sanctions evasion hub."

The administration continues, according to a State Department official who commented on the condition of anonymity to the Free Beacon "to engage with Russia on a return to full implementation of the JCPOA. As Secretary Blinken said last week, 'Russia continues to be engaged in those efforts, and it has its own interests in ensuring that Iran is not able to acquire a nuclear weapon."

Nearing the three-week mark in an ever-escalating war, Zelenskyy is using the world's leading legislative bodies as a stage to implore allied leaders to stop the Russian airstrikes that are devastating his country. It has also put Zelenskyy at odds with President Joe Biden, whose administration has stopped short of providing a no-fly zone or the transfer of military jets from neighboring Poland as the U.S. seeks to avoid a direct confrontation with Russia.

Instead, Biden delivered his own address following Zelenskyy's speech, in which he announced an additional \$800 million in security assistance to Ukraine, according to a White House official. That would bring the total announced in the last week alone to \$1 billion. It includes money for anti-armor and air-defense weapons, according to the official, who was not authorized to comment publicly and spoke on the condition of anonymity.

"Watching the Ukrainian president make the case for his country, I couldn't help but be jealous. He got a great reaction. He was basically saying, 'Please, please help me stop the invasion of my borders. I'm going to lose my nation's sovereignty if this keeps up.' I want to know how long do WE have to wait before OUR leaders are serious about protecting OUR sovereignty and securing OUR borders." (Gary Bauer of Campaign for Working Families, in an interview with American Family News)

Appearing in his now-trademark army green T-shirt as he appeals to world leaders, Zelenskyy has emerged as a heroic figure at the center of what many view as the biggest security threat to Europe since World War II. Almost 3 million refugees have fled Ukraine, the fastest exodus in modern times.

Invoking Shakespeare's hero last week, Zelenskyy asked the British House of Commons whether Ukraine is "to be or not to be." On Tuesday, he appealed to "Dear Justin" as he addressed the Canadian Parliament and Prime Minister Justin Trudeau.

Zelenskyy called on European Union leaders at the start of the war to do the politically unthinkable and fast-track Ukraine's membership — and he has continued to push for more help to save his young democracy than world leaders have so far pledged to do.

Biden has insisted there will be no U.S. troops on the ground in Ukraine and has resisted Zelenskyy's relentless pleas for warplanes as too risky, potentially escalating into a direct confrontation with nuclear-armed Russia.

"Direct conflict between NATO and Russia is World War III," Biden has said.

U.S. defense officials say they have been puzzled by Zelenskyy's demand for more warplanes. They say Ukraine isn't often flying the planes it has now, while making good use of other weapons the West is providing, including Stinger missiles for shooting down helicopters and other aircraft.

The Biden administration is looking to send Ukraine "more of what's been working well," according to an official who was not authorized to comment publicly and spoke on the condition of anonymity.

Already the Biden administration has sent Ukraine more than 600 Stinger missiles, 2,600 Javelin anti-armor systems, unmanned aerial system tracking radars; grenade launchers, 200 shotguns, 200 machine guns and nearly 40 million rounds of small arms ammunition, along with helicopters, patrol boats, satellite imagery and body armor, helmets, and other tactical gear, the official said.

Even though Zelenskyy and Biden speak almost daily by phone, the Ukrainian president has found a potentially more receptive audience in Congress. 37 Congress members and 10 senators are Jewish, and they represent a powerful voting block on behalf of the nation of Israel. Israel receives billions of dollars in U.S. aide yearly.

This won't be the first time he has appealed directly to members of the House and Senate, who have remained remarkably unified in their support of Ukraine. Nearly two weeks ago, Zelenskyy delivered a desperate plea to some 300 lawmakers and staff on a private call that if they could not enforce a no-fly zone, at least send more planes.

Livestreamed into the Capitol complex, Zelenskyy said the U.S. must sanction Russian lawmakers and block imports, and he showed a packed auditorium of lawmakers an emotional video of the destruction and devastation his country has suffered in the war.

This won't be the first time he has appealed directly to members of the House and Senate, who have remained remarkably unified in their support of Ukraine. Nearly two weeks ago, Zelenskyy delivered a desperate plea to some 300 lawmakers and staff on a private call that if they could not enforce a no-fly zone, at least send more planes.

Donald Trump literally forced four Arab states, the UAE, Bahrain, Sudan and Morocco, to sign so-called Abraham Accords lending official recognition to Israel at the coaxing of his Jewish son-in-law Jared Kushner and in order to canvass Zionist lobbies for support in the run-up to Nov. 2020 presidential elections.

Washington's principal objective in Syria's proxy war was ensuring Israel's regional security. The United States Defense Intelligence Agency's <u>declassified report</u> [3] of 2012 clearly spelled out the imminent rise of a Salafist principality in northeastern Syria – in Raqqa and Deir al-Zor which were occupied by the Islamic State from 2014 to October 2017 – in the event of an outbreak of a civil war in Syria.

Under pressure from the Zionist lobbies in Washington, however, the Obama administration deliberately suppressed the report and also overlooked the view in general that a proxy war in Syria would give birth to radical Islamic jihadists.

The hawks in Washington were fully aware of the consequences of their actions in Syria, but they kept pursuing the ill-fated policy of nurturing militants in the training camps located in Syria's border regions with Turkey and Jordan in order to weaken the anti-Zionist Bashar al-Assad government.

The single biggest threat to Israel's regional security was posed by the Iranian resistance axis, comprising Iran, Syria and Lebanon-based Hezbollah. During the course of the 2006 Lebanon War, Hezbollah fired hundreds of rockets into northern Israel and Israel's defense community realized for the first time the nature of threat that Hezbollah posed to Israel's regional security.

Those were only unguided rockets but it was a wakeup call for Israel's military strategists that what would happen if Iran passed the guided missile technology to Hezbollah whose area of operations lies very close to the northern borders of Israel.

Therefore, the Zionist lobbies in Washington persuaded the Obama administration to orchestrate a proxy war against Damascus and Lebanon-based Hezbollah in order to dismantle the Iranian resistance axis against Israel.

But following the beginning of the Ukraine crisis in 2014 after Russia occupied the Crimean peninsula and Washington imposed sanctions on Russia, the Kremlin's immediate response to the escalation by Washington was that it jumped into the fray in Syria in September 2015, after a clandestine visit to Moscow by General Qassem Soleimani, the slain commander of the IRGC's Quds Force who was assassinated in an American airstrike on a tip-off from the Israeli intelligence at the Baghdad airport on January 3, 2020.

When Russia deployed its forces and military hardware to Syria in September 2015, the militant proxies of Washington, the Zionist regime and their regional clients were on the verge of driving a wedge between Damascus and the Alawite heartland of coastal Latakia, which could have led to the imminent downfall of the Bashar al-Assad government.

With the help of Russia's air power and long-range artillery, the Syrian government has since reclaimed most of Syria's territory from the insurgents, excluding Idlib in the northwest occupied by Turkish-backed militants and Deir al-Zor and the Kurdish-held areas in the east, thus inflicting a humiliating defeat on Washington, the Zionist regime and their regional allies, Turkey, Jordan and the Gulf States.

Over the years, Israel has not only provided material support to militant groups battling Damascus – particularly to various factions of the Free Syria Army (FSA) and al-Qaeda's Syrian affiliate al-Nusra Front in Daraa and Quneitra bordering the Israel-occupied Golan Heights – but Israel's air force has virtually played the role of the air force of the terrorists and mounted hundreds of airstrikes in Syria during the decadelong conflict.

In an interview to the *New York Times* <sup>[4]</sup> in January 2019, Israel's former Chief of Staff Lt. General Gadi Eisenkot confessed that the Netanyahu government approved his recommendations in January 2017 to step up airstrikes in Syria. Consequently, more than 200 Israeli airstrikes were launched on the Syrian targets in 2017 and 2018, as revealed <sup>[5]</sup> by Israeli Intelligence Minister Israel Katz in September 2018.

In 2018 alone, Israel's air force dropped 2,000 bombs in Syria. The purported rationale of the Israeli airstrikes in Syria has been to degrade Iran's guided missile technology provided to Damascus and Lebanon-based Hezbollah, which poses an existential threat to Israel's regional security. However, after Russia provided S-300 air defense system to the Syrian military after a Russian surveillance aircraft was shot down by Syrian air defenses during an Israeli incursion into the Syrian airspace on September 2018, killing 15 Russians onboard, Israeli airstrikes in Syria have been significantly scaled down.

Following the friendly-fire incident, though Israel has mounted occasional airstrikes at the capital Damascus, in Daraa and Quneitra in southern Syria and Deir al-Zor in eastern Syria, Israeli airstrikes in northwest Syria, including Aleppo, Hamah and Homs, which is within the range of advanced missile defense systems deployed at Khmeimim Air Base near coastal Latakia, have almost entirely ceased.

Last month, the Kremlin issued an unequivocal condemnation <sup>[6]</sup> of recent Israeli airstrikes in Syria as "crude violation" of Syria's sovereignty that up until now were reluctantly tolerated by the Russian forces based in Syria's Tartus naval base and Khmeimim airbase southeast of Latakia, and also pledged that the Russian Air Force would conduct joint air patrols alongside the Syrian Air Force that would pre-empt the likelihood of further Israeli airstrikes.

"Israel's continuing strikes against targets inside Syria cause deep concern," Russian Foreign Ministry spokeswoman Maria Zakharova said. "They are a crude violation of Syria's sovereignty and may trigger a sharp escalation of tensions. Also, such actions pose serious risks to international passenger flights."

Although Israel claims its air campaign in Syria is meant to target Iran-backed militias, the airstrikes often kill Syrian soldiers. Syrian state media said one soldier was killed and five more were wounded in one of the latest Israeli attacks at Damascus, which occurred on February 9.

Russia has held talks with Israel on Syria, and said last month it would begin joint air patrols with Syria. The patrols will include areas near the Golan Heights in southern Syria bordering Israel, a frequent site of the Israeli airstrikes, and Israel is said to be considering discontinuing the strikes altogether or slowing them down significantly.

The *Times of Israel* noted that this marked a momentous change in policy for Russia: "Following the patrol, Ynet reported that Israeli military officials were holding talks with Russian army officers to calm tensions."

The report added, "Israeli officials were struggling to understand why Russia, which announced that such joint patrols were expected to be a regular occurrence moving forward, had apparently changed its policy toward Israel." The report claimed that Israel might limit its air campaign in Syria as a result of Russia's inexplicable policy reversal in Syria.

In conclusion, it favored Israel's strategic objectives to escalate the conflict in Ukraine in order to divert Russia's attention and military resources to Eastern Europe, as the Zionist regime would then get a free hand to mount airstrikes in Syria and Lebanon with impunity, and might even attempt to rekindle the decade-long proxy war alongside its Gulf Arab, Turkish and Jordanian allies in order to eliminate the security threat posed by the Iran-led resistance axis comprising Syria and Lebanon-based Hezbollah once and for all.

Russian Navy ships can be seen in satellite imagery approaching the Ukrainian Coast. The Sentinel 2 satellite image, taken at 11:47 local time, shows at least 14 vessels.

The vessels were found by Naval News with the help of Damien Symon, an independent defense analyst. Preliminary analysis of the vessels suggests 3 groups. Two are made up of combatants, and one has several landing ships. The landing ships appear to have sailed directly from their staging position off the Crimean coast. Analysts are searching the imagery for more vessels.

Over in Mariupol, the Russians are using devastating tactics that they employed during the two Chechen wars...

Rockets rained down on Mariupol, a port city on the Sea of Azov of about half a million people, over the weekend targeting residential blocks and systematically flattening suburban areas of the city. During the two Chechen wars, rather than sending troops to try and take the city, the Russian army simply flattened it with sustained shelling and then just marched in across a sea of rubble.

This is why the Russians have only encircled most of the major Ukrainian cities that they have approached so far.

It is essentially siege warfare. The Russians are cutting off supply routes, and they will relentlessly pound opposing forces until they either surrender or are wiped out.

Russia has largely achieved its objective of neutralizing the Ukrainian military, but Western governments mistakenly believe the deliberate progress designed to avoid civilian casualties reflects weakness and are funneling weapons to prolong the fighting, a former top Pentagon adviser has said.

Russian President Vladimir Putin has given strict orders from the outset to avoid civilian casualties and extensive property damage, retired US Army Colonel Douglas Macgregor told the 'Grayzone' in an extensive interview on Tuesday.

This has slowed the Russians' advance "to the point where it has given false hope both to the Ukrainians ... but seized on by people in the West, to try and convince the world that a defeat is in progress, when in fact the opposite is the case," Macgregor said.

"The war, for all intents and purposes, has been decided," the retired colonel said. "The entire operation from day one was focused on the destruction of Ukrainian forces. That's largely complete."

The Ukrainian units still active "are completely surrounded, cut off and isolated in various towns and cities," said Macgregor, including as many as 60,000 on the border with Donetsk, whose supplies are likely running out by now.

Media coverage of the fighting, however, ignores this reality and paints a picture of the Russian military being "inept" – in the words of some U.S. senators – because it didn't defeat Kiev in mere days. This is then used as an argument by advocates of NATO intervention and a "no-fly zone," but also those who wish to send more weapons to Kiev.

"It's very obvious Washington wants this to continue as long as possible, in hopes Russia would be desperately harmed. I just don't see that happening," Macgregor told 'Grayzone' on Tuesday.

The biggest problem right now is that "in the West, there is no truth. There is wishful thinking and there is this impression of success by the Ukrainians that doesn't stack up," the colonel added. "The biggest lie I've heard repeated on television is, Russian troops have been told to deliberately murder Ukrainian civilians. That's absurd, it's nonsense."

Ukrainian President Volodymyr Zelensky asked the U.S. Congress on Wednesday to send fighter jets, air defense missiles and other weapons to Kiev, as well as establish a no-fly zone over Ukraine, so his army could defeat Russia. He made the same argument to Canadian lawmakers on Tuesday.

Macgregor, however, believes that such shipments will have no effect and that Zelensky's refusal to negotiate an armistice is only going to get more Ukrainians killed. It is easy to be deceived but this war is part of the Klaus Schwab "Great Reset". As geopolitical tensions morph into a protracted conflict between NATO and the Sino-Russia axis, a second contraction may plunge the economy into stagflation.


In the years ahead, the combination of subpar growth and runaway inflation will force a global economic underclass into micro-work contracts and low-wage jobs in an emerging gig economy.

With the immiseration of a significant portion of the world's labor force looming on the horizon, this may well be a prelude to the introduction of a Universal Basic Income, leading to a highly stratified neo-feudal order.

Therefore, the World Economic Forum's ominous prediction that we will 'own nothing and be happy' by 2030 seems to be unfolding with horrifying rapidity.

## 2. The war's economic fallout will lead to a dramatic downsizing of the global workforce.



The architects of the Great Reset have anticipated this trend for a number of years and will exploit this economic turbulence by propelling the role of disruptive technologies to meet global challenges and fundamentally alter traditional business patterns to keep pace with rapid changes in technology.

Like the pandemic, disaster preparedness in the age of conflict will rest significantly on the willingness to embrace specific technological innovations in the public and private spheres so that future generations can supply the labor demands of the Great Reset.

A recurring theme in Klaus Schwab's *Shaping the Future of the Fourth Industrial Revolution* is that groundbreaking technological and scientific innovations will no longer be relegated to the physical world around us but become extensions of ourselves.

He emphasizes the primacy of emerging technologies in a next generation workforce and highlights the urgency to push ahead with plans to digitize several aspects of the global labor force through scalable technology based solutions.

Those spearheading the Great Reset seek to manage geopolitical risk by creating new markets which revolve around digital innovations, e-strategies, telepresence labor, Artificial Intelligence, robotics, nanotechnology, the Internet of Things and the Internet of Bodies.

The breakneck speed in which AI technologies are being deployed suggest that the optimization of such technologies will initially bear on traditional industries and professions which offer a safety net for hundreds of millions of workers, such as farming, retail, catering, manufacturing and the courier industries.

However, automation in the form of robots, smart software and machine learning will not be limited to jobs which are routine, repetitive and predictable.

All systems are on the verge of wholesale automation of various white collar jobs, particularly in areas which involve information processing and pattern recognition such as accounting, HR and middle management positions.

Although anticipating future employment trends is no easy task, it's safe to say that the combined threat of pandemics and wars means the labor force is on the brink of an unprecedented reshuffle with technology reshaping logistics, potentially threatening hundreds of millions of blue and white collar jobs, resulting in the greatest and fastest displacement of jobs in history and foreshadowing a labor market shift which was previously inconceivable.

While it has long been anticipated that the increased use of technology in the private sector would result in massive job losses, pandemic lockdowns and the coming disruption caused by a war will speed up this process, and many companies will be left with no other option but to lay off staff and replace them with creative technological solutions merely for the survival of their businesses.

3. The war has significantly <u>reduced</u> Europe's reliance on the Russian energy sector and reinforced the centrality of the UN Sustainable Development Goals and 'net zero' emissions which lies at the heart of the Great Reset.

# SUSTAINABLE GOALS



Policymakers marching lockstep with the Great Reset have capitalized on the tough sanctions against Russia by accelerating the shift towards 'green' energy and reiterating the importance of decarbonization as part of the 'fight against climate change'.

However, it would be very short-sighted to assume that the Great Reset is ultimately geared towards the equitable distribution of 'green' hydrogen and carbon-neutral synthetic fuels replacing petrol & diesel.

While UN SDGs are crucial to post-pandemic recovery, more importantly, they are fundamental to the makeover of shareholder capitalism which is now being vaunted by the Davos elites as 'stakeholder capitalism'.

In economic terms, this refers to a system where governments are no longer the final arbiters of state policies as unelected private corporations become the de facto trustees of society, taking on the direct responsibility to address the world's social, economic and environmental challenges through macroeconomic cooperation and a multi-stakeholder model of global governance.

Under such an economic construct, asset holding conglomerates can redirect the flow of global capital by aligning investments with the UN's SDGs and configuring them as Environmental, Social, and Corporate Governance (ESG) compliant so that new international markets can be built on the disaster and misery of potentially hundreds of millions of people reeling from the economic collapse caused by war.

Therefore, the war offers a huge impetus for the governments pushing the reset to actively pursue energy independence, shape markets towards 'green and inclusive growth' and eventually move populations towards a cap-and-trade system, otherwise known as a carbon credit economy.

This will centralize power in the hands of stakeholder capitalists under the benevolent guise of reinventing capitalism through fairer and greener means, using deceptive slogans like 'Build Back Better' without sacrificing the perpetual growth imperative of capitalism.

4. Food shortages created by the war will offer a major boon to the synthetic biology industry as the convergence of digital technologies with materials science and biology will radically transform the agricultural sector and encourage the adoption of plant-based and lab-grown alternatives on a global scale.



Russia and Ukraine are both breadbaskets of the world and critical shortages in grains, fertilizers, vegetable oils and essential foodstuffs will catapult the importance of biotechnology to food security and sustainability and give birth to several imitation meat start-ups similar to 'Impossible Foods' which was co-funded by Bill Gates.

One can therefore expect more government regulation to usher a dramatic overhaul to industrial food production and cultivation, ultimately benefiting agribusiness and biotech investors, since food systems will be redesigned through emerging technologies to grow 'sustainable' proteins and <u>CRISPR</u> gene-edited patented crops.

5. Russia's exclusion from SWIFT (The Society for Worldwide Interbank Financial Telecommunication) foreshadows an economic reset which will generate precisely the kind of blowback necessary for corralling large swathes of the global population into a technocratic control grid.



As several economists have opined, weaponizing SWIFT, CHIPS (The Clearing House Interbank Payments System) and the U.S. Dollar against Russia will only spur geopolitical rivals like China to accelerate the process of de-dollarization.

The main benefactor of economic sanctions against Russia appears to be China which can reshape the Eurasian market by encouraging member states of the Shanghai Cooperation Organization (SCO) and BRICS to bypass the SWIFT ecosystem and settle cross-border international payments in the Digital Yuan.

While the demand for cryptocurrencies will see a massive spike, this is likely to encourage many governments to increasingly regulate the sector through public blockchains and enforce a multilateral ban on decentralized cryptocurrencies.

The shift to crypto could be the dress rehearsal to eventually expedite plans for programmable money overseen by a federal regulator, leading to the greater accretion of power in the hands of a powerful global technocracy and thus sealing our enslavement to financial institutions.

I believe this war will bring currencies to parity, therefore heralding a new Bretton Woods moment which promises to transform the operation of international banking and macroeconomic cooperation through the future adoption of central bank digital currencies.

6. This war marks a major inflection point in the globalist aspiration for a new international rules-based order anchored in Eurasia.



As the 'father of geopolitics' Halford Mackinder opined over a century ago, the rise of every global hegemon in the past 500 years has been possible because of dominance over Eurasia. Similarly, their decline has been associated with losing control over that pivotal landmass.

While America tries desperately to cling to its superpower status, China's economic ascent and Russia's regional ambitions threaten to upend the strategic axial points of Eurasia (Western Europe and Asia Pacific).

The region in which America previously enjoyed uncontested hegemony is no longer impervious to cracks and we may be witnessing a changing of the guard which dramatically alters the calculus of global force projection.


Although China's ambitious Belt and Road Initiative (BRI) has the potential to unify the world-island (Asia, Africa and Europe) and cause a tectonic shift in the locus of global power, the recent invasion of Ukraine will have far-reaching consequences for China-Europe rail freight.

The Ukrainian President Zelensky claimed that Ukraine could function as the BRI's gateway to Europe. Therefore, we cannot ignore China's huge stake in the recent tensions over Ukraine, nor can we ignore NATO's underlying ambition to check China's

rise in the region by limiting the sale of Ukrainian assets to China and doing everything in its capacity to thwart The Modern Silk Road.

As sanctions push Russia towards consolidating bilateral ties with China and fully integrating with the BRI, a Pan-Eurasian trading bloc may be the realignment which forces a shared governance of the global commons and a reset to the age of US exceptionalism.

7. With speculation mounting over the war's long term impact on bilateral trade flows between China and Europe, the Russia-Ukraine conflict will catapult Israel – a leading advocate of the Great Reset – to even greater international prominence.



Israel is a highly attractive BRI market for China and the CCP is acutely aware of Israel's importance as a strategic outpost connecting the Indian Ocean and the Mediterranean Sea through the Gulf of Suez.

Furthermore, the Chinese government has for many years acknowledged the primacy of Israel as a global technology hub and capitalized on Israel's innovation capabilities to help meet its own strategic challenges.

Therefore, Naftali Bennet's mediation between Moscow and Kiev is likely to factor the instrumental role of the Belt and Road Initiative (BRI) in expanding both China and Israel's regional and global strategic footprint.

Israel's status as among the leading tech hubs of the future and gateway connecting Europe and the Middle East is inextricably tied to the web of physical infrastructures, such as roads, railways, ports and energy pipelines which China has been building over the past decade.

Already a powerhouse in auto-technologies, robotics and cybersecurity, Israel aspires to be the central nation in the millennial Kingdom and the country's tech startups are predicted to play a key role in the fourth industrial revolution.

Strengthening its evolving relationship with China amid the Russia-Ukraine crisis could help propel Israel into a regional hegemon par excellence with a large share of centralized economic and technological power converging in Jerusalem.

As Israel embarks on efforts to diversify its export markets and investments away from the United States, it begs an important question.

Is Israel in the formative stages of outsourcing its security interests away from the US and hedging its bets on the Sino-Russia axis?

8. It is now common knowledge that Digital IDs are a central plank in the World Economic Forum's Great Reset agenda and are to be streamlined across industries, supply chains and markets as a way of advancing the UN 2030 SDGs and delivering individualized and integrated services in future smart cities.

Vaccine passports were initially touted by public-private partnerships as an entry point for Digital IDs. Now that such a logic has run its course, how might the present geopolitical tensions contribute to scaling what is the key node in a new digital ecosystem?

Ukraine has traditionally been called Europe's breadbasket and alongside Russia, both nations are major global suppliers of staple grains. Therefore, the war has all the makings of a black swan for commodities and inflation.

With an economy teetering on the brink of collapse due to a global supply crunch, I believe the resulting economic tremors will trigger wartime emergencies across the world and the public will be told to brace themselves for rationing.

Once this takes place, the multilateral adoption of Digital IDs which interface with Central Bank Digital Currencies can be touted as the solution to efficiently manage and distribute household rations under an unprecedented state of emergency and exception. The Bank of England has already floated the prospect of programmable cash which can only be spent on essentials or goods which an employer or government deem sensible.

Once the issuer is granted control over how it is spent by the recipient, it will become nigh impossible to function adequately without a Digital ID, which will be required to receive food parcels and obtain a basic means of subsistence. Think UBI (Universal Basic Income).

If food inflation continues on an upward trajectory with no signs of abating, governments may institute price controls in the form of rationing and ration entries could be logged on blockchain ledgers on the Digital ID to track our carbon footprint and consumptive habits during a national emergency.

### 9. Europe is directly in the line of fire once a hybrid war between NATO and the Sino-Russia axis is underway.

The fallout from such an event could very well establish a new global security protocol according to which citizens must possess a Digital ID as a necessary national security measure.

One can imagine how accessing the internet or public services in the aftermath of a nationwide cyberattack may require citizens to use a Digital ID to authenticate that their online activities and transactions are from a legitimate and non-malicious source.

10. The economic implications of this war will be so disastrous that governments and the public sector will require a significant injection of private capital to address the financing shortfall.



This will effectively render the traditional separation of powers between central banking institutions and governments obsolete, as the former will be positioned to disproportionately influence the fiscal trajectory of nation states, whose sovereignty will be hollowed out by the wholesale capture of governments by the central banks and hedge funds.

Therefore, the nation-state model is gradually being upended by a global technocracy, consisting of an unelected consortium of leaders of industry, central banking oligarchs and private financial institutions, most of which are predominantly non-state corporate actors attempting to restructure global governance and enlist themselves in the global decision-making process.

Therefore, the future of international relations and the social, economic and political transformation which the world is presently undergoing in light of the pandemic and Russia-Ukraine conflict will not be decided through multilateralism and elected representatives of sovereign states.
