

# **Global Population Growth: A Blessing or a Curse?**

## **Part 2**

Below is the 10 Commandments of the New World Order, they are inscribed in massive granite slabs at a remote rural area of Elberton, Georgia. They are known as the Georgia Guidestones. According to 'RadioLiberty.com' "On one of the highest hilltops in Elbert County, Georgia stands a huge granite monument." Engraved in eight different languages on the four giant stones that support the common capstone are 10 Guides, or commandments. That monument is alternately referred to as The Georgia Guidestones, or the American Stonehenge. Though relatively unknown to most people, it is an important link to the Occult Hierarchy that dominates the world in which we live."Yoko Ono, the widow of John Lennon, was recently quoted as referring to the American Stonehenge, saying: "I want people to know about the stones ... We're headed toward a world where we might blow ourselves up and maybe the globe will not exist ... it's a nice time to reaffirm ourselves, knowing all the beautiful things that are in this country and the Georgia Stones symbolize that."

### **The NWO/Illuminati 10 Commandments**

The origin of that strange monument is shrouded in mystery because no one knows the true identity of the man, or men, who commissioned its construction. All that is known for certain is that in June 1979, a well-dressed, articulate stranger visited the

office of the Elberton Granite Finishing Company and announced that he wanted to build an edifice to transmit a message to mankind. He identified himself as R. C. Christian, but it soon became apparent that was not his real name. He said that he represented a group of men who wanted to offer direction to humanity, but to date, almost two decades later, no one knows who R. C. Christian really was, or the names of those he represented. Several things are apparent. The messages engraved on the Georgia Guidestones deal with four major fields: (1) Governance and the establishment of a world government, (2) Population and reproduction control, (3) The environment and man's relationship to nature, and (4) Spirituality.

In the public library in Elberton, Dr. Stanley Montieth found a book written by the man who called himself R.C. Christian. The monument he commissioned had been erected in recognition of Thomas Paine and the occult philosophy he espoused. Indeed, the Georgia Guidestones are used for occult ceremonies and mystic celebrations to this very day. Tragically, only one religious leader in the area had the courage to speak out against the American Stonehenge, and he has recently relocated his ministry.

Limiting the population of the earth to 500 million will require the extermination of nine-tenths of the world's people. The American Stonehenge's reference to establishing a world court foreshadows the current move to create an International Criminal Court and a world government. The Guidestones' emphasis on preserving nature anticipates the environmental movement of the 1990s, and the reference to "seeking harmony with the infinite" reflects the current effort to replace Judeo-Christian beliefs with a new spirituality.

The message of the American Stonehenge also foreshadowed the current drive for Sustainable Development. Any time you hear the phrase "Sustainable Development" used, you should substitute the term "socialism" to be able to understand what is intended. Later in this syllabus you will read the full text of the Earth Charter which was compiled under the direction of Mikhail Gorbachev and Maurice Strong. In that document you will find an emphasis on the same basic issues: control of reproduction, world governance, the importance of nature and the environment, and a new spirituality. The similarity between the ideas engraved on the Georgia Guidestones and those espoused in the Earth Charter reflect the common origins of both.




What is the true significance of the American Stonehenge, and why is its covert message important? Because it confirms the fact that there was a covert group intent on


The prophetic message of the Georgia Guidestones is magnified by the very first of the secular ten commandments.

As the artist's rendition above illustrates, the Georgia Guidestones are minor by any sense of the imagination. The pillars weigh in at 21-tons and the center stone at just over 10-tons, the capstone weighing at 12-ton.

Standing in the remote location of Elbert County, Georgia resides what is known as the American Stonehenge, or the Georgia Guidestones. Purposely placed in nature's grasp, undisturbed by city life, this massive monument has an alarming message to convey to the world. Although the message is a beautiful ideal—tracing its roots back to the concept of a Utopia—it also entails sinister prospects for the future of humanity.

The grand unveiling of the Georgia Guidestones occurred on March 22, 1980, more than 30 years ago. Yet, very little awareness of it really circulated, until maybe 2005 when the environmental movement became such a hot topic. Throughout this time, though no one knows who actually commissioned its construction; all that is known is that a man by the name of R.C. Christian wanted to build it. "R.C." is most likely short for "the Rose and Cross" of Rosicrucianism, which is simply the precursor to what is known as Freemasonry today. Not surprisingly a tablet not too far from the monument reads, "Let these be guidestones to an Age of Reason", which echoes the writing of one Thomas Paine, a prominent 18th century Freemason. The Precision of its Craft speaks to the "builders" imagery of Freemasonry.

To prove its message is universal, and a driving pursuit since the very beginning of civilization, 4 ancient languages are engraved on the capstone, including Babylonian Cuneiform, Sanskrit, Egyptian Hieroglyphics, and Classical Greek. The message is also translated in 8 modern languages, from English to Swahili, appearing on the 4 slabs of granite rock underneath.

There is also a highly intricate astrological significance to the Georgia Guidestones, which make it that much more ominous. There are precise notches that parallel the movement of the sun, from its solstices to its equinoxes, while its outer core marks the lunar-year cycle. There is even a stargazing hole, which locates the North Star, Polaris. And lastly, during the noon hour, the sun is positioned right at the center of the capstone, a highly symbolic occult design to say the least.

In 2008 the Guidestones were vandalized by a group of New World Order enthusiasts. Georgia has now heightened its security measures, to prevent future disturbance.

A good example of controlling the population under the guise of safeguarding nature was put forth in the Earth Charter, and the subsequent Earth Summit of 1992, which gave rise to Agenda 21, the agenda for the 21st century. Coincidentally, one year after the Earth Summit, a book was published by a premiere think tank, a non-governmental organization, called the Club of Rome. The book is called "*The First Global Revolution*", and on page 104, it states:

*"The common enemy of humanity is man. In searching for a new enemy to unite us, we came up with the idea that pollution, the threat of global warming, water shortages, famine and the like would fit the bill. All these dangers are caused by human intervention, and it is only through changed attitudes and behavior that they can be overcome. ...Democracy is not a panacea. It cannot organize everything and it is*

*unaware of its own limits. Sacrilegious though this may sound, democracy is no longer well suited for the tasks ahead."*



When I first heard about the Georgia Guidestones, there were many suggestions as to who were responsible, chief of the name suggested was that of Ted Turner, founder of CNN news network. R.C. Christian was a pseudo-name of a man who walked into the office of the Elberton Granite in June 1979, presenting his plan for the Georgia Guidestones, claiming to represent a group of individuals wanted to erect a monument. Elberton Georgia is about 90 miles northeast of Atlanta, GA. The essence of the Guidestones came seven years after *'The Population Bomb'* was published. The name of R.C. Christian remains to this day as a secret.

The general reference is prophetic speaking to a New World Order, without God. There is no denying the point that the goal spoken in stone was to reduce the world's population to 500,000,000. The language of R.C. Christian borders on the subject of eugenics, a culling of the world's population. The animosity of R.C. Christian and his destruction of any documents that would identify R.C. Christian, would keep the public guessing about the Georgia Guidestones.

Make no mistake about it, since 1972, the global elite have been working around the clock to achieve the goal of the Georgia Guidestones. The page below is from the web site Deagel.com. Highlighted in their page on the U.S., we have a stated reduction of the U.S. population from 327 million people in 2017 and a reduction to just 100 million by 2025. This huge drop in the population is not limited to the U.S. alone.



The global map above shows a population reduction of the U.S. population by 79.9%. Despite the numeric data "quantity" there is a "quality" model which has not a direct translation into numeric data. The 2014 strain of Ebola has a death rate of 50-60% but try to imagine what would happen if there is a pandemic of Ebola with hundreds of thousands or millions infected

with the virus. So far the few cases of Ebola-infected people have "enjoyed" intensive healthcare with anti-viral and breathing assistance but above all with abundant human support by physicians and nurses. In a pandemic scenario that kind of healthcare won't be available for the overwhelming number of infected leading to a dramatic increase of the death rate due to the lack of proper healthcare. The "quality" factor is that the death rate could increase to 80-90% in a pandemic scenario from the stated 50-60% rate. The figure itself is not important what is relevant is the fact that the scenario can evolve beyond the initial conditions from a 50% death toll to more than 90%. By the way, no pandemic or nuclear war is included in the forecast. On page 11 below you will find a comparison chart for 2016 and 2025 for the major nations of the world.

What if a comet hits the Atlantic that will wipe out a lot of East Coast U.S. cities where most of U.S. population is? The chain reaction (San Andreas, Yellowstone, and New Madrid) and aftermath will kill even more.

Something big is coming, and a lot of people know it. The population doesn't just disappear because of dollar collapse people will be able to sort it out via bartering etc. It has to be something big and sudden. Think Atlantis' judgement, something overnight.

As reported by *'True Activist'*, Gates has repeatedly expressed his approval for global depopulation and has funded sterilization programs; has pushed for widespread vaccination programs which have caused great harm; and believes in the implementation of so-called "death panels," which would allow authorities to decide whether someone is worthy of receiving taxpayer money to keep them alive, or if they should rather be "allowed" to die.


Gates' latest scheme is perhaps his most daring – and likely most dangerous – to date. As reported by *'Big League Politics'* (BLP), Gates is funding a study by researchers from *Harvard University* which hopes to prove that dumping millions of tons of chalk dust into the atmosphere every day could dim the sun, thereby fighting climate change. (Related: Bill Gates to roll out remote control microchip-based sterilization of women.)

As explained by *BLP*, Gates and the Harvard team got the idea for their research from a natural disaster that hit the Philippines in 1991, when Mount Pinatubo exploded: *"The disaster killed over 700 people and displaced hundreds of thousands of Filipinos, but the fall-out caused ideas to spring about in the minds of scientists. A chemical cloud was left in the stratosphere following the blast, which resulted in the discharge of 20 million tons of sulfur dioxide. Sulfuric acid rained down afterward for more than a year and reflected sunlight, which resulted in the eventual development of SCoPEX [The Stratospheric Controlled Perturbation Experiment]."*

*The Gates-funded plan will essentially replicate the aftermath of the volcano blast throughout the entire Earth if the Harvard scientists are ultimately successful in their climate-manipulation plans.*

The team's plan involves using 800 massive aircraft to dump the chalk 12 miles above the surface of the Earth each day, claiming that the shade created would reflect the sun's rays, thereby preventing global warming.

The scientists are eager to start experimenting and plan to launch their first round of chalk-bearing planes in the New Mexico desert. The initial SCoPEX experiment will cost around \$3 million and will involve dumping a small quantity of calcium carbonate dust into the atmosphere and measuring the results.



Not everyone is eager for the experiments to begin, however, and authorities have called a halt over fears that the research could backfire and cause natural phenomena like droughts and hurricanes. (Related: Bill Gates and George Soros fund Monsanto and a world depopulation agenda.)

Eminent scientists have expressed grave concerns about Gates' scheme. United Nations climate policy adviser Janos Pasztor warns, *"If you make use of this technology and do it badly or ungoverned, then you can have different kinds of global risks created that can have equal, if not even bigger, challenges to global society than climate change. Governments need to engage in this discussion and to understand these issues,"* he added. *"They need to understand the risks — not just the risks of doing it, but also the risks of not understanding and not knowing."*

One clear risk of blotting out the sun is interfering with the process of photosynthesis, without which plant and food crops could not survive and all human and animal life would be endangered. But then, perhaps that is exactly what Bill Gates, depopulation believer, is hoping for? Hitler had a depopulation agenda which he kept under wraps, until so many millions of people disappeared that the world started figuring out what was happening. What if he had come right out and announced his plan to create a master race and eliminate everyone else by

shooting them in the head with two bullets, starving them to death, or putting them in gas chambers?

This is an earlier chart of Deagle.com posted in 2016 showing on the left column side the ranking of the 23 largest countries. The U.S. was listed in first place. In the protected chart to the right shows the U.S. is listed in the 13<sup>th</sup> place. Deagle has projected the U.S. population at 64,879,000 for 2025. In the past couple years Deagle has increased the projected population from 80-million, to 90-million, and most recently to the 100-million figure above on page 7. Deagle.com is a data-based reference to important military and CIA sources. It uses figures from what is known as the CIA Directory of Nations. Regardless of whichever figure you look at suggests a very serious change of events and most alarming drop of the U.S. population.

On August 27<sup>th</sup>, 2019, a report appeared on a news site that the Mexican Military Police Battle Illegal African Migrants Attempting to Reach U.S. The Border Police, ICE, Customs, have been stopping African migrants for months at the U.S. southern border. Many were guaranteed as suspected of infection for Ebola symptoms. The global invasion to Europe and Mexico is believed to be none other than Bill Gates partner George Soros. Several countries have had enough and are shutting their borders down, Italy, Hungary, Poland, Norway, specifically.



Rothschild agent, George Soros had been working closely with Pope Francis just before and following the Muslim invasion began from the Middle East and North Africa. Years ago, I was a faithful listener to Dr. Stanley Montieth, a retired orthopedic surgeon turned activist in educating the public to the insidious plans in the works for global government. Dr. Stan was a “one-of-a-kind” and no one has stepped forward of his stature to take his place. This socially engineered genocide is happening with the full knowledge and consent of religious authorities the world over, including the Catholic Church. The human population is being culled.

The Millennium Report posted a story on May 23, 2016 sharing evidence to the fact that the real purpose of modern medicine is ‘engineered genocide’ to reduce human population through covert infertility via vaccines, GMOs and drugs. Mike Adams of Natural News.com shared it from Ontario, Canada. This hugely important paper has just been published in the *Epidemiology: Open Access science journal*. It is authored by Kevin Mugur Galalae, Founder and Director of the Center of Global Consciousness in Ontario.

In it, Galalae correctly points out that the entire medical-agricultural complex as it exists today is intentionally engineered to deliberately reduce human population. Overpopulation of the planet is a very real and very serious problem, he believes, but the current strategy of world governments to reduce human population via covert infertility, immune suppression and “death by medicine” is unethical and insufficient to achieve the desired level of depopulation.

Note carefully that he also calls for global government to force depopulation controls onto the nations of the world. This is not a recommendation that's likely to win friends among Natural News readers, but I think you need to read this information to understand what's being talked about on this subject.

Here are a few of the most important passages from the paper:

### **Involuntary sterilizations via vaccines, infertility via GMOs**

Under the cover of reproductive health involuntary sterilizations are implemented throughout the developing world through adulterated vaccines while in the developed world flu immunization programs weaken the immune systems of the old and civil servants to shorten lifespans and spare governments from meeting insolvent health care and pension plan obligations in the last stage of the demographic transition.

In the name of sustainable development, experimental carbon capture and sequestration methods as well as solar radiation management methods double as weapons against longevity by subjecting billions to unnaturally high exposure levels of heavy metals so the world's decarbonization goals are tackled from two directions, by reducing greenhouse gases in the atmosphere and increasing morbidity and mortality among the general population to proactively lower future emissions.

Poverty and hunger are used as fronts for the deployment of GMO crops that purportedly increase yields, improve nutrition and require fewer fertilizers and pesticides, but that in fact misuse the latest bioengineering advances to cause subfertility, immune deficiencies and crop failures and thus lower the population by limiting births and increasing deaths.

Unless stopped, this engineered genocide will damage the genetic and intellectual endowment of humanity and cause population collapse within 20 years, time during which the incidence and severity of NCDs will grow exponentially irrespective of health system investments and medical breakthroughs.

Galalae says the world must be radically depopulated, but it should be done through education and birth reduction, not covert medical murder

Let me state clearly and unequivocally that the objective of stabilizing the global population and bringing it down to a sustainable level is non-negotiable. Therefore, what we must do is not challenge population control, but force a change in the methods by which it has been pursued since 1945.

The greatest threat to public health is not the thoughtless abuse of alcohol and tobacco by careless individuals, but the deliberate use of endocrine disruptors and immune-depressants by desperate governments acting under the direction of the United Nations and its agencies and aided by the military-industrial complex for the sake of preserving international peace by controlling population growth.

Global conflict, war and destruction are inevitable, Galalae states, unless human population is radically reduced. That's because a greater number of people will be fighting each other over fewer resources such as water, oil, rare earth minerals, arable land, topsoil, ocean fish populations and so on.

The effort by world governments to depopulate the planet, Galalae explains, has been kept secret for a very long time. I've said some of the same things in my recent podcast *The Government's WAR on Humanity: DEPOPULATION is here*.

He calls for a global government security force to coerce nations into compliance. The solution to all this, argues Galalae, is to stop covertly poisoning the population with vaccines and GMOs, hoping to cause widespread infertility that will reduce the birth rate. Rather, he says the human population should be controlled by a new global governing force (a world government, perhaps run by the wholly corrupt United Nations or the life-hating World Health Organization):

Mankind has come to a point in history that gives us no choice and forces us to act now or perish. We have reached a point in our evolution that renders our civilization a force equal to any in nature but entirely at odds with everything in nature; an unbridled force that disrupts the hard-earned state of equilibrium our planet has held for the past twelve thousand years, time during which our species has thrived beyond imagining at unimaginable cost to all other life forms and to the very elements that make life possible.

To survive into the future we are now forced to erect a global governing structure authorized to wield global governing instruments capable of maintaining peace among men, of establishing harmony between man and nature, and of forging continuity between this and future generations. We must in other words consider not only what is good for us here and now but what is good for future generations and for all life on earth and we must act accordingly. Population control is the most important action required of us here and now if we are to save our civilization, our children and our planet. Therefore, population control must and will be declared a Planetary Security Prerogative.

In other words, while Galalae sees all the problems of bad medicine, fraudulent vaccines, toxic GMOs and a toxic food supply, he argues that the solution is an Agenda 21-style global government that forces people to obey whatever world directives on depopulation are desired by the globalists.

Although I agree with Galalae's diagnosis of what's happening today with food and medicine, I disagree with his conclusion of surrendering to a world government authority to solve these problems.

Besides, overpopulation likely won't be a problem for much longer... Humanity is going to destroy itself anyway. It is my view that humanity is going to unleash its own

Most people are unaware that one of the greatest threats to their freedom may be a United Nations program which plans to depopulate 95% of the world. The name of this plan is Agenda 21, and it was developed by the United Nations Department of Economic and Social Affairs, Division for Sustainable Development, as part of a sustainability policy.


According to the United Nations website, Agenda 21 is a "comprehensive plan of action to be taken globally, nationally and locally by organizations of the United Nations system, government, and major groups, in every area in which humans have impact on the environment".

There is a solution other than what the elite consider excess population. Why not prevent the poor - for the sake of argument, let us venture a conservative 99% of the world's population - from having children altogether, or if that isn't possible, at least vastly slow their birth rates?

"Eugenics" is a term coined in the latter part of the 19th century by Englishmen Francis Galton to describe the "science" of bettering human stock and the elimination of unwanted characteristics... and individuals. Galton proposed societal intervention for the furtherance of "racial quality," maintaining that "Jews are specialized for a parasitical existence upon other nations" and that "except by sterilization I cannot yet see any way of checking the produce of the unfit who are allowed their liberty and are below the reach of moral control."

A survey of eugenics in action begins with isolated incidents such as the sterilization of the mentally ill by American health officials in the late 1800's and the castration of children at the Pennsylvania Training School for Feebleminded Children in 1889. The movement quickly picked up momentum.



Formerly established as a study at University College in London in 1904, the first laboratory for the study of the subject was constructed by Charles B. Davenport at Cold Springs Harbor on Long Island (which, perhaps significantly, was also the location of the estates of both Dulles brothers, as well as the current headquarters of the Human Genome Organization for DNA mapping). The institute was funded in excess of \$11 million by the Harriman and Rockefellers.

Supported in America by the Eastern Establishment, eugenics was nurtured in the hotbeds of Round Table-influenced philosophy, at Harvard, Columbia, and Cornell. The subject was popularized in Germany by Ernst Haeckel, who linked romantic German nature mysticism and the unity of the Volk with clinical bio-policies later instituted by Hitler.

Haeckel believed that there was no unity among the species of mankind, since "the morphological differences between two generally recognized species - for example sheep and goats - are much less important than those... between a Hottentot and a man of the Teutonic race." In the Aryan race Haeckel saw a "symmetry of all parts, and that equal development, which we call the perfect human beauty." He also believed the "wooly-haired" peoples "incapable of true inner culture or of a higher mental development... no wooly-haired nation has ever had an important history."

Haeckel felt the purpose of the nation state was to enforce selective breeding, praising the practices of the Spartans who killed all but "perfectly healthy and strong children" and thus were "continually in excellent strength and vigor."

In 1906 a group of Haeckel's academic followers formed the influential Monist League, agitating for a German government patterned along social Darwinian lines.

By 1907 in America, Indiana passed compulsory sterilization for the mentally ill and other "undesirables," while 475 males received vasectomies at the Indiana State Reformatory.

In 1912 the First International Congress of Eugenics was held in London, including among its directors Winston Churchill, Alexander Graham Bell, Charles Elliot (President emeritus of Harvard University), and David Starr Jordan (President of Stanford University).

The National Conference on Race Betterment was convened in United States in 1914, while by 1917 fifteen American states had eugenics laws on the books, almost all of them legalizing the sterilization of habitual criminals, epileptics, the insane, and the retarded.

H.H. Laughlin, the Expert Eugenics Agent of the U.S. House of Representatives Committee on Immigration and Naturalization presented a Model Sterilization Law in 1922. This was to provide the basis for many state eugenics laws, as well as for eugenics law in Nazi Germany.

In 1928 the American Eugenics Society sponsored a contest for essays on the cause of decline in Nordic fertility, while Dr. Robie, at the Third International Congress of Eugenics, called for the sterilization of 14,000,000 Americans with low intelligence scores.

The Nazi Party in Germany passed in 1933 the "Law for the Prevention of Hereditary Diseases in Posterity," also known as the "Sterilization Law," written by professor Ernst Rudin, one of the country's leading psychiatrists. "Hereditary Health Courts" were formed, and within three years two hundred and twenty-five thousand German "undesirables" had been sterilized.

Hitler's policies have been characterized as "a rather straightforward form of German social Darwinism." Far from being original with him, his policies were expansions upon already-extant political and scientific culture.

By 1939 German policies had evolved to include euthanasia upon asylum inmates while eugenics concepts were implemented to the fullest in Nazi concentration camps during World War II.

In 1942, U.S. psychiatrist Foster Kennedy recommended the killing of retarded children. During the three year period of 1941-1943 over 42,000 people were sterilized in America.

After World War II the idea of "eugenics" was tainted in the public by its association with Nazism. The term was discarded and a facelift was performed on its parent study psychiatry, which resulted in the establishment of the World Federation of Mental Health (WFMH). Since then, this group has continued to support electroshock, lobotomization, mind control and other activities already detailed, as well as employing within its ranks many German practitioners who had been happy to further Hitlerian goals during the Second World War.

What this brief survey shows is something the popular press has chosen to ignore: eugenics programs were not the inventions of mad Nazi scientists, but that the political climate of Germany allowed a full implementation of programs part and parcel of international psychiatry and medicine. Eugenics, from its beginning, was encouraged and financed by the rich self-styled "aristocrats" of the day.

Recent programs aimed at abortion and other methods of depopulation can be traced to essentially the same Freemasonic/Round Table/Rothschild-spawned crowd; to the studies of the Club of Rome, the Trilateral Commission, and to the CFR. These groups influenced a change in U.S. policies specifically during 1966-67, when population control was adopted by the State Department as a stated goal.

The recent world depopulation push retains the flavor of eugenics bio-policy of the first half of this century in the statements of advocates such as the Eastern

Establishment's Sergeant Shriver, speaking before the Congressional Select Committee on Population in 1978: "...this Committee's interest [is] in improving the quality of life and enhancing the biological product of this society; rather than just controlling or limiting birds."



Jaffe and Dryfoos of the federally-funded Guttmacher Institute have stated that, "With the overall decline in fertility in the United States, concern has shifted from numbers of births to insuring that those children being born have fewer physical, social and economic handicaps."

It is odd that little mention of "the overall decline in fertility" finds its way into Rockefeller-subsidized literature of depopulation activists. Nor was the fact that teenage

pregnancy was at its lowest ebb in forty years brought up when federally mandated family planning and sex education in schools was enacted in 1978.

Studies have shown that sex education classes increase early sexual experimentation while doing nothing to reduce adolescent pregnancy. It has also been demonstrated that when such classes are discontinued, as in Utah in 1980, the incidence of teenage pregnancy decreases. Still, officials insist sex classes should extend from "kindergarten throughout a person's educational career." Why? Originators and administrators of the programs candidly admit that their agenda includes depopulation and eugenics.

Lester Kirkendall, a founder of the Sex Information and Education Council, wrote in 1965 that, "sex education is... clearly tied in a socially significant way to family planning and population limitation and policy..." Dr. Jane Hodgson, at the National Abortion Federation conference in 1980, was even more forthright, calling for compulsory abortion for pregnant teenagers.

The methods of sex education programs in public schools vary, but uniformly emphasize the huge expense and drawbacks of having kids, providing summaries of methods of contraception, serialization, and abortion. Students are often taken on tours of birth control clinics, where they meet the staff, fill out patients' forms, and are assured of the confidentiality of services. Children are also recruited as depopulation activists with pitches informing them, as in widely-used text *Meeting Yourself Halfway*:

"The population problem is very serious and involves every country on this planet. What steps would you encourage to help resolve the problem?

...volunteer to organize birth-control information centers throughout the country;  
...join a pro-abortion lobbying group;  
...encourage the limitation of two children per family and have the parents sterilized to prevent further births."

Much of the sex education literature portrays the nuclear family – long a cohesive political and social glue among the populace – as obsolete and statistically insignificant, while the normalcy of homosexuality and bachelorism ("Playboyism") is stressed. Children are encouraged to report in detail on conditions at home, to report parental shortcomings, and to divulge disagreements they have with their parents, opening the door to intervention by "social services."

Davis in *Economic Development and Cultural Change* says that an effective strategy in lowering the birth rate is to "lessen ... the identity of children with parents, or lessen... the likelihood that this identity will be satisfying," adding that certain trends that might bring population levels down are "very high divorce rates, homosexuality, pornography and free sexual unions..." Davis sees a positive note in "the child welfare services, which have increasingly tended to displace the father as a necessary member of the family, and the health services which have increasingly flouted parental authority

with respect to contraception and abortion." This "flouting of parental authority" is a familiar theme in sex education classes, which repeatedly emphasize the child's independence from their parents and their ability to make decisions for themselves.

The message to children, provided by proponents of sex education without the courtesy of having the parents agree upon it, is obvious; the world is awash in excess poor population, and something has to be done about it in a hurry, starting at the nearest abortion clinic.

Educator John Taylor Gatto, voted New York's Top Teacher of 1991, further comments on the mechanisms:

*"Social machinery to suppress proliferation of systematic families... has two components: one, a campaign aimed at family-formation before it commences, employing such tactics as encouragement of personal greed (best enjoyed in bachelor style, of course), public pornographic celebrations of the body parts of nubile young woman, effortless divorce, mass adoption, tolerance of sexual ambiguity, and many similar tactics. The second component aims at producing pseudo-families: small households (whether biological or synthetic) without any overriding loyalty to the common family cause. Instead, these are associations of expedience wearing the costume of affection and concern, but always on the lookout for a better deal... During the childhood phase, parents in pseudo-families are made use of by the state to transmit certain values, to maintain and discipline a new serf class composed of their own children, and to report radical cases of deviance to medical, police and re-training authorities... It is a system infused in many places with such black genius in understanding crowd control it is hard not to stand in awe of its unseen architects."*

Target populations for sterilization in the United States bear noting. According to Michael Garrity in *'Trilateralism'*, edited by Holly Sklar, American Indian women are being sterilized unbeknownst to them or against their wishes in public health clinics nationwide. Garrity also maintains, "Full blooded Indian woman are the special target of the doctors."

Ruthann Evannoff, in "Reproductive Rights and Occupational Health" in WIN, has said that, "Overall, at least 25 percent of the Native American women of childbearing age have been sterilized, although the total population numbers less than one million. Recent reports estimate that the percentage sterilized in one tribe alone, the Northern Cheyenne, is close to 80 percent."

The secret (now declassified) paper NSSM 200, "Implications of Worldwide Population Growth For U.S. Security and Overseas Interests," also known as the Scowcroft Document (authored by the CFR's Brent Scowcroft), gives insight into U.S. government plans for population reduction internationally, linking these plans to goals that have very little to do with alleviating human suffering, and everything to do with the maximization of profit.

Prepared in 1974 for the National Security Council (and remember, this is a government document, although one not likely to be offered for free in late night Public Service Announcements) NSSM 200 proposes means for the reduction of worldwide population by "concentration on key [i.e. Third World] countries," with the stated goal of reduction of population growth rate from an annual 2 percent growth to 1.7 percent.

While this might sound like an altruistic goal proposed by clear-sighted social stewards, intended to reduce suffering in countries with marginal standards of living, the study makes it clear that government interest in depopulation has nothing to do with concern for living standards in developing countries. It is because "The United States has become increasingly dependent on mineral imports from developing countries" and "endemic famine, food riots, and breakdown of social order... are scarcely inductive to systematic exploration for mineral deposits or the long-term investments necessary for their exploration." Note that the breakdown of "social order" referred to consists of the populace revolting against their living conditions.

One of the conclusions of the study is that "mandatory [emphasis added] population control measures" may be "appropriate."

Speaking of depopulation programs currently being implemented in the Third World, former Brazilian health minister Carlos Santana said, "The World Bank, through their reports of its Presidents, has always made its proselytizing for a rigid birth control policy explicit," Santana reported that included in World Bank credit packages and investment in Third World countries is an implicit agenda of depopulation, and questioned why Brazil was targeted for birth reduction, with approximately forty per cent of Brazilian woman having been already sterilized.

What the depopulators omit saying is that in Brazil most of the depopulation programs are being directed toward the native population, and that they are implementing an alternative program to the pistoleiros hired to attack small landowning families, appropriating the land for the use of large cash-croppers and the international conglomerates that are stripping the country bare.

Depopulation programs run worldwide are directed and funded by major international money interests, including McGeorge Bundy of the CFR, the architect of nuclear Mutual Assured Destruction policy; Warren E. Buffet, the second wealthiest man in the United States; and, ubiquitous when it comes to eugenics funding, the Rockefellers.

Planned Parenthood Federation of America and International Planned Parenthood Federation are Buffett-funded and run a huge abortion and sterilization network worldwide, with one subsidiary, the Brazilian Society for Family Welfare, having over 2,500 outlets in that country. It is a bit ironic but Bill Gates was Bill Gates' father, William H. Gates Sr., was the head of eugenics group Planned Parenthood. In a 2003 interview with PBS' Bill Moyers, Gates admitted that his family's involvement in

reproductive issues through the years has been extensive. What's that statement about an acorn not falling far from the tree?

American eugenics refers inter alia to compulsory sterilization laws adopted by over 30 states that led to more than 60,000 sterilizations of disabled individuals. Many of these individuals were sterilized because of a disability: they were mentally disabled or ill, or belonged to socially disadvantaged groups living on the margins of society. American eugenic laws and practices implemented in the first decades of the twentieth century influenced the much larger National Socialist compulsory sterilization program, which between 1934 and 1945 led to approximately 350,000 compulsory sterilizations. **WAKE UP!**

While, at first glance depopulation programs may seem like a good idea to promote the reduction of mouths-to-feed worldwide, what they ignore are the root causes of overpopulation. High birth rates are the direct result of poor living standards of the areas, and in countries where malnutrition has been reduced and the incidence of child-death lowered, birth rates have also lessened.

The Third World (in particular) is being forcefully relieved of natural resources and exploited for cheap labor, and is in fact no doubt seen by elite landowners and

major corporations as only maintaining maximum profitability as long as it is kept in abject poverty.

"The strategy of underdevelopment" is the term used by agriculture economist Harry Cleaver. Rather than offering the people in rich countries such as Brazil, in actuality one of the richest countries in the world, an equitable portion of profits made through the use of their resources, they are manipulated (when not killed outright) and kept at the razor edge between starvation and profitability.

Depopulation organizations propagandize that we are experiencing a crisis of epic proportions; that the world is reaching the point where it can no longer support the number of people living on it. In many instances population may in fact be economically beneficial, and tending to a long-term increase of arable land and per capita (rather than per corporation) income. Also noted is a current usage of approximately three-tenths of one percent of the planet's surface for human habitation, an amount sustainable with no limit to growth on sight.

United Nations and U.S. Department of Agriculture statistics show that world food production has increased more rapidly than population growth in recent years, while Colin Clark, former director of the Agriculture Economic Institute of Oxford University has stated that farmers could currently support seven times the current population of the Earth, or twenty-one times the current population at Japanese standards of food consumption.

Roger Revelle, former director of the Harvard Center for Population Studies estimates that current agricultural resources could provide an adequate diet for eight times the current populace, i.e. forty billion individuals, and has estimated that Africa is capable of feeding ten times its current population. Revelle quotes Dr. David Hopper, another agricultural expert:

"The world's food problem does not arise from any physical limitation on potential output or any danger of unduly stressing the environment. The limitations on abundance are to be found in social and political structures of nations and in the economic relations among them. The unexploited global food resources are there, between Cancer and Capricorn. The successful husbandry of that resource depends on the will and actions of men." Hopper pronounces "world fascism" very politely.

Politics, logistics, and transportation remain the major obstacle for the hunger issue!

Francis Moore Lappe of the Institute for Food and Development Policy maintains:

*"If the cause of hunger is neither scarcity of food, nor scarcity of land, we've come to see that it's a scarcity of democracy. That may sound rather contrived, because in the West we tend to think of democracy as a political concept. But democracy is really a principle of accountability; in other words, those making the decisions must be*

*accountable to those who are affected by them. Once we understand hunger as a scarcity of democracy, what we are saying is that from the village level to the level of international commerce, fewer and fewer people are making decisions, and more and more anti-democratic structures are being entrenched. This is the cause of hunger." And, it should be repeated, the cause of overpopulation.*

*"[Sterilization could] be applied to an ever widening circle of social discards, beginning always with the criminal, the diseased and the insane, and extending gradually to types which may be called weaklings rather than defectives, and perhaps ultimately to worthless race types."*

parents are very good at sharing the things that they were doing. And almost treating us like adults, talking about that.”

In the interview Gates says he is moved by measurable progress and on “safe birth reproductive family planning issues” he says, “There’s a measurable impact when you can go in and educate families, but primarily women, about their different choices. There’s real impact that you can have in this area. Anything to do with reproductive health.”


Although prodded more than once by Moyers, Gates refused a direct attack on President Bush’s pro-life measures such as promotion of abstinence prior to marriage. He admits that he was at one time a convinced **Malthusian**. *“You know I thought it was. Before I learned about it, I thought it was paradoxical. Well if you improve health, aren’t you just dooming people to deal with such a lack of resources where they won’t be educated or they won’t have enough food? ## **Democracy:**
