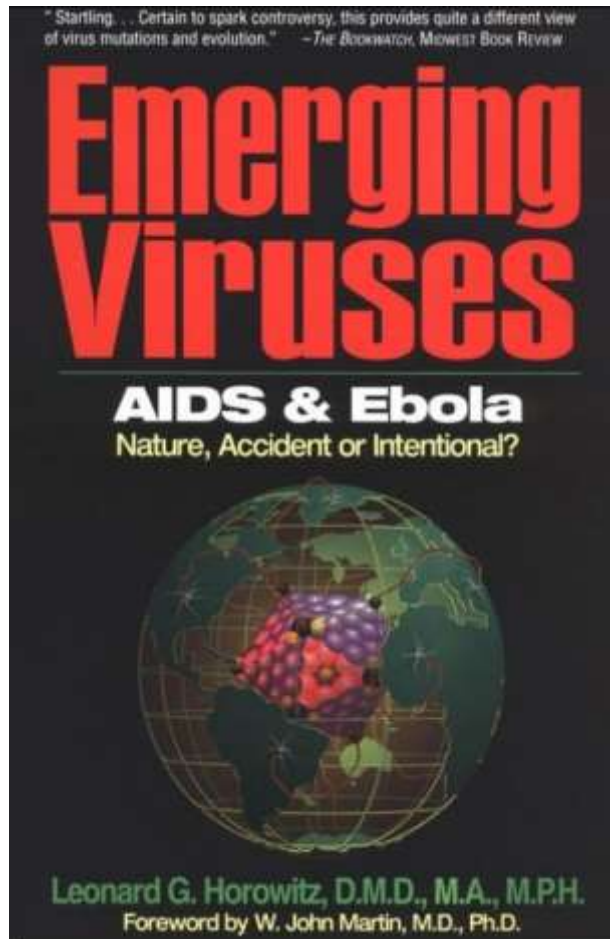


# Global Population Growth: A Blessing or a Curse?

## Part 4

One of the first books I read about depopulation was *'Emerging Viruses: Aids & Ebola, Nature, Accident, or Intentional'* by Dr. Leonard G. Horowitz. It was published in 1996. It sparked my interest in questioning the government, and to be suspicious of the forces at work in the world. This was the first in-depth exploration into the origins of HIV and Ebola. Claims that these "emerging viruses" naturally evolved and then jumped species from ape to man seem grossly unfounded in light of the compelling evidence assembled in this extraordinary text. Alternatively, the possibility that these bizarre germs were laboratory creations, accidentally or intentionally transmitted via tainted hepatitis and smallpox vaccines in the U.S. and Africa – as numerous authorities have alleged – is investigated herein.



This book reviews the numerous viral vaccine studies conducted simultaneously in New York City and Central West Africa by a narrow network of virologists working for major military-medical contractors under the auspices of the National Cancer Institute

(NCI) and the World Health Organization (WHO). Included is Dr. Robert Gallo, the notorious discoverer of the AIDS virus. The text presents bizarre and horrifying facts about the biological weapons race of the 1960's and early 1970's when these researchers developed countless immune system ravaging viruses, and experimented with an assortment of antidote vaccines allegedly for "defense" and cancer prevention.

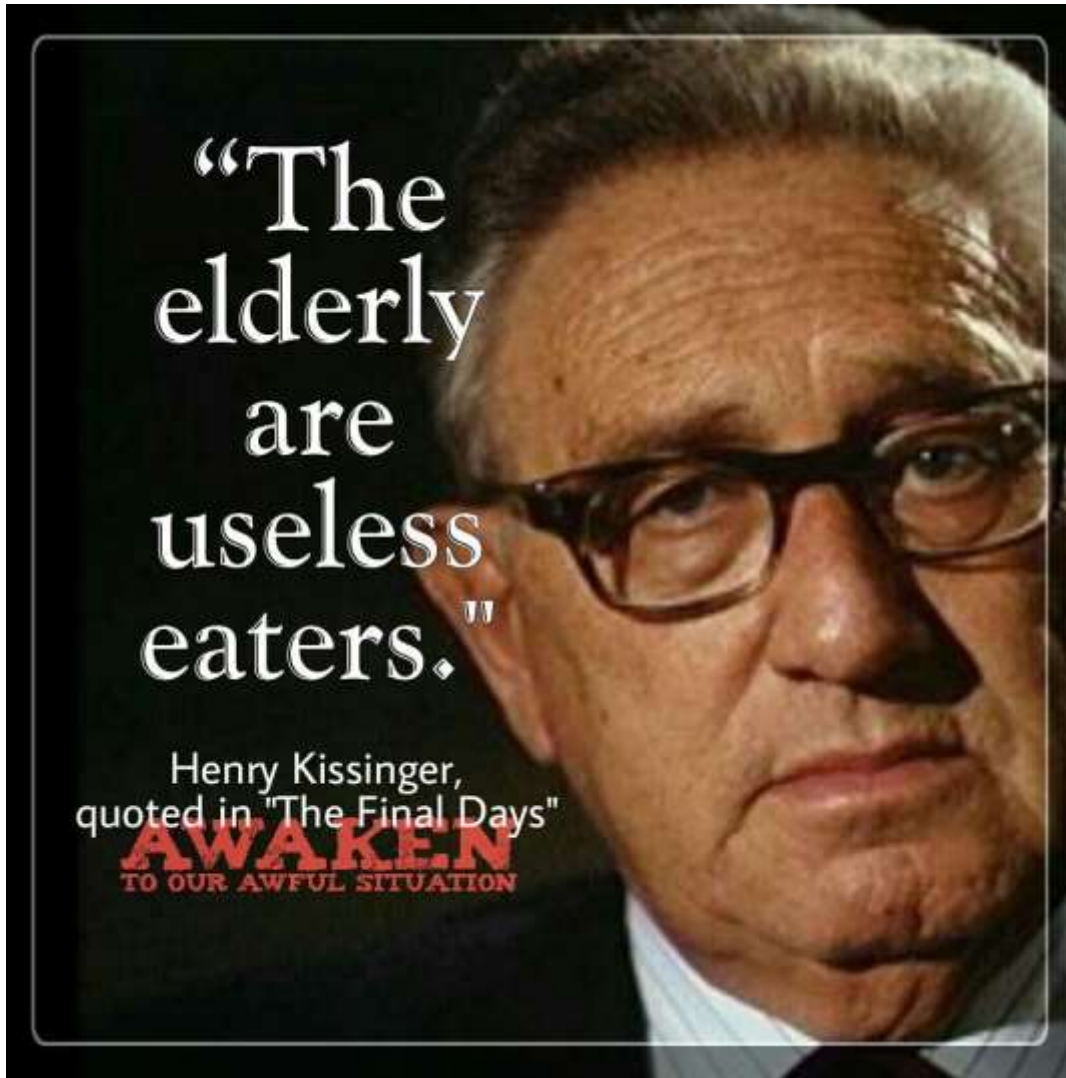

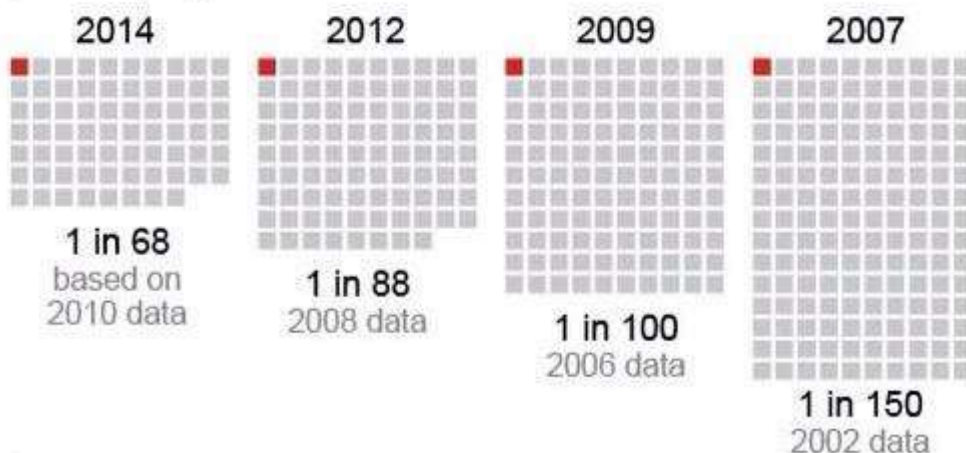
This was the most comprehensive volume first to describe this multifaceted new field. It places viral evolution and emergence in a historical context, describes the

One in 68 U.S. children is believed to have autism or a related disorder, according to the latest estimate – a 30 percent jump from the 2012 federal estimate



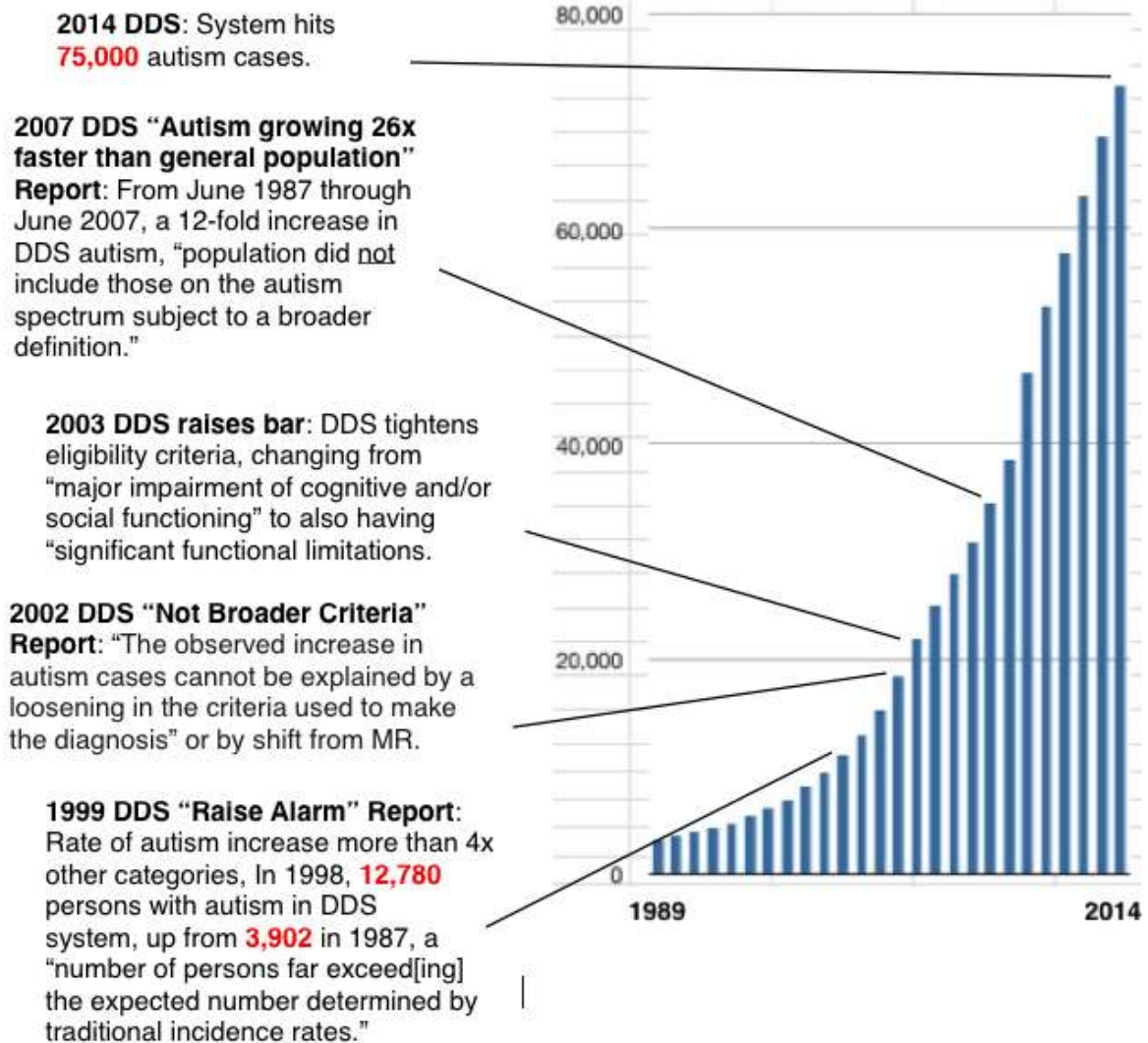

Del Bigtree, founder of Informed Consent Action Network (ICAN), teamed up with Robert F. Kennedy Jr. to take on the U.S. government by filing suit against the



Department of Health and Human Services (DHHS) for vaccine safety violations — and they won. This is big news for all concerned with the topic of vaccine safety. It turns out the federal agency has been neglecting their vaccine safety obligations for over 30 years. The lawsuit brought by RFK Jr. is evidence that “vaccine safety” as we know it is nothing more than a sham.

Government agencies charged with protecting the public are not doing their part to ensure and improve the safety of immunizations, but will they be held accountable?



A clause in The National Childhood Vaccine Injury Act of 1986 (NVICA) compels DHHS to take responsibility for improving vaccine safety and efficacy, and charges the agency with constant monitoring and improving of adverse event reporting. The Mandate for Safer Childhood Vaccines clause also tasks DHHS with providing a report on improvements made in these areas to Congress every two years.

Robert F. Kennedy Jr. and ICAN reportedly suspected that DHHS was failing to meet this responsibility, and filed a Freedom of Information Act request to obtain the records of these biennial reports. For eight months, DHHS tried to blockade their request and refused to provide information. Ultimately, a lawsuit had to be filed.

As [a document from ICAN](#) reads:

*ICAN was therefore forced to file a lawsuit to force HHS to either provide copies of its biennial vaccine safety reports to Congress or admit it never filed these reports. The result of the lawsuit is that HHS had to finally and shockingly admit that it never, not even once, submitted a single biennial report to Congress detailing the improvements in*

*vaccine safety. This speaks volumes to the seriousness by which vaccine safety is treated at HHS and heightens the concern that HHS doesn't have a clue as to the actual safety profile of the now 29 doses, and growing, of vaccines given by one year of age.*

Despite being charged with the responsibility of investigating and improving vaccine safety DHHS has apparently failed to meet even the most basic aspects of this duty by failing to file a single report *for the past thirty years*. Three decades have passed since NVICA was put into place, and DHHS has never so much as raised a finger towards vaccine safety — an issue which should be a top priority, especially given the fact that NVICA erases industry responsibility regarding vaccine injuries.

So not only is the government granting Big Pharma carte blanche on the matter of vaccine injury, yet another agency charged with protecting the public from vaccines has completely dropped the ball.

ICAN reports further that DHHS hasn't eschewed their vaccine responsibilities entirely: The organization has reportedly taken their obligation to promote vaccine uptake very seriously, spending billions and conducting regular reports on how to increase vaccination rates.

As ICAN states further:

*Regrettably, HHS has chosen to focus on its obligation to increase vaccine uptake and defend against any claim vaccines cause harm in the National Injury Vaccine Compensation Program (aka, the Vaccine Court) to such a degree that it has abandoned its vaccine safety responsibilities. If HHS is not, as confirmed in Court this week, even fulfilling the simple task of filing a biennial report on vaccine safety improvements, there is little hope that HHS is actually tackling the much harder job of actually improving vaccine safety.*

Will the DHHS finally be held accountable for their failure, or will the vaccine industry continue to spread its toxic injections without fear of government scrutiny? See more coverage of the atrocities behind inoculations at Vaccine News.

After an uptick in lawsuits in the 1980s, the vaccine manufacturers essentially held the government hostage and threatened to stop making vaccines unless the government took on responsibility for vaccine injury lawsuits. The National Childhood Vaccine Injury Act of 1986 was then enacted which made the taxpayers liable for injuries caused by vaccines and not the manufacturers.

This removal of liability has created the incentive to turn out new vaccines with very little testing, as the companies don't have to worry about financial hardships for injuring people, which in turn has shaped the situation that we find ourselves in today.

In the last 2 decades, we've witnessed a near 300% increase in the number of CDC recommended vaccines. As the vaccine companies no longer had an incentive to

rigorously test the safety of their vaccines, the responsibility of testing vaccine safety was then passed to the US government.

Now, a lawsuit filed against the US Department of Health and Human Services., on behalf of the Informed Consent Action Network (ICAN) and counsel, Robert F. Kennedy, Jr., has revealed that the biannual reports for these safety studies — as required by Congress — have never happened.

Needless to say, the pharmaceutical industry is preoccupied with profits over and above the efficacious value of its product forced upon parents and their children. This speaks to the criminality of the pharmaceutical industry.

One of the most important news sites on the Internet is that of Mike Adams, commonly known as the “*Health Ranger*” at “*Natural News.com*”. I have been a subscriber to ‘*Natural News*’ since Mike Adams went on line nearly twenty years ago. His daily posts cover a variety of issues of concern to public health, nutrition, vitamins, and related topics.

Robert F. Kennedy Jr. led a last ditch rally effort to oppose passage of California bill SB276, on the state capitol Sacramento, on August 28, 2019. SB276 as I recall, was intended to ban all medical doctors from granting medical exemptions from vaccination of children in California.

58,381 vaccine related injuries were officially reported in 2018 alone, including death. That may come as a surprise to some of you; however, the trends suggest even greater numbers in the years ahead. First, universal vaccination promises a world without infectious disease and with theoretical reductions in morbidity and mortality that could ‘save millions of lives.’ This would require vaccination against a near limitless number of ‘germs,’ with a pharmaceutical pipeline of hundreds of vaccines ready to flood the liability-free market, but which largely ignores the discovery of the microbiome’s role in the human holobiont which is comprised mostly of said germs

This lack of safety testing, for both vaccines and the coming 5G, is the primary red flag they share in common. The medical ethical principle of informed consent, arrived at only after the horrors of Nazi human experimentation came into full light during the Nuremberg trials, requires that those who undergo exposure to health risks be fully informed of them, and not just the purported benefits. Without access to information of this kind, without which informed consent is not possible, medical and/or the tech industry’s practice and products violate fundamental human rights.

You may or may not know that the United States is a signatory to the Geneva Convention of 1949. At the Nuremberg trials, the Allied Nations prosecuted the Germans for violating the previous version of the Geneva Convention, one of which was Article 9 of the Convention specified the Red Cross has the right to assist the wounded and sick and provide humanitarian aid. Article 12 stipulated the wounded and sick must not be murdered, tortured, exterminated or exposed to biological experiments.



Yes, the U.S. government through the CDC, NIH, laws and regulations, and mandatory vaccinations violates the Geneva Convention. A member of the U.S. military if captured by a hostile country is instructed only to give his/her name, rank, date of birth, and serial number. It's criminal for the U.S. government to force parents of new born babies to be injected with chemicals that can and do cause harm and long-term injury or death.

From January to June of 1996, I was employed as a substitute teacher for both the local county school system and also the city school system. I had completed my seminary course work, serving a small church, and saving money for moving expenses at graduation. I answered an ad in the local paper that came out three days a week. After completing all the necessary paper work, background checks, etc., I was hired as a substitute teacher.

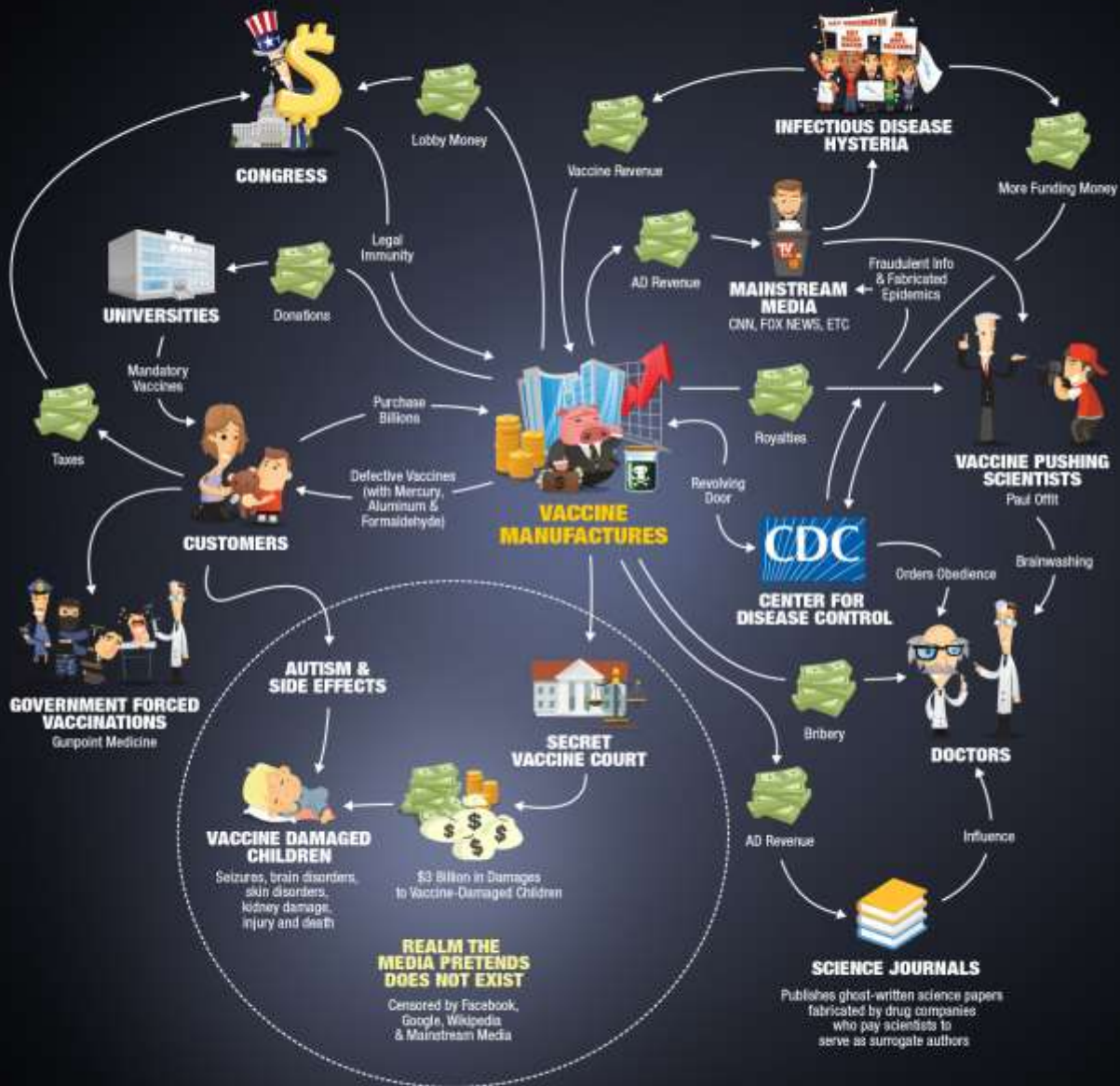
My plan was to be available 2 days a week, but I soon found my phone ringing five days a week at 6:15 AM. As I reflect back now, more than half of those calls were to fill in for the special education teaching staff. I had a six class hour schedule, and in each special education class, I had 10-12 students that were Autistic. This was for the local city school only; and, at the county school system, my substitute calls were for regular academic classes. The city school system where I did substitute teaching was not a large school system, and today averages 2,700 students in six schools. In 1996, the city elementary school had an enrollment of 350, of which 60-70 were categorized as "special education". The question that I ponder today is where is the voice of the educational community in the larger issue of vaccine-damaged children?

To my knowledge, most schools mainstream their "special education" students, and each special need's student is accompanied by a personal student aide during the school day. The financial burden on the educational system is not an insignificant amount, and one would expect the educational system's leaders would express their concern over this growing problem. I even checked the web sites of three county school systems in close proximity to me. It was not surprising at all to discover that there were vacancies posted for all three county school systems for both substitute teachers and special needs student aides. The current pay rate for substitute teachers is \$75 a day for the three county school systems. Student assistants earn \$10.75 hourly, and they stay with the special needs students throughout the class day.

The costs needed to educate "Special Needs" students are shared across the board through tax assessments of property owners, businesses, etc. I'm not aware of federal or state grants to help cover the extra payroll needs due to increased numbers of students with "learning disabilities". Extrapolate this issue out to include the entire nation and one begins to see how big an issue we are facing. It is important to know the fact that the U.S. has more than 14,000 public school districts. Most people do not look at the scope of what a family faces. The illustrations that follow broaden our understanding of how our children and youth suffer at the expense of the pharmaceutical industry, where profits are more important human pain.

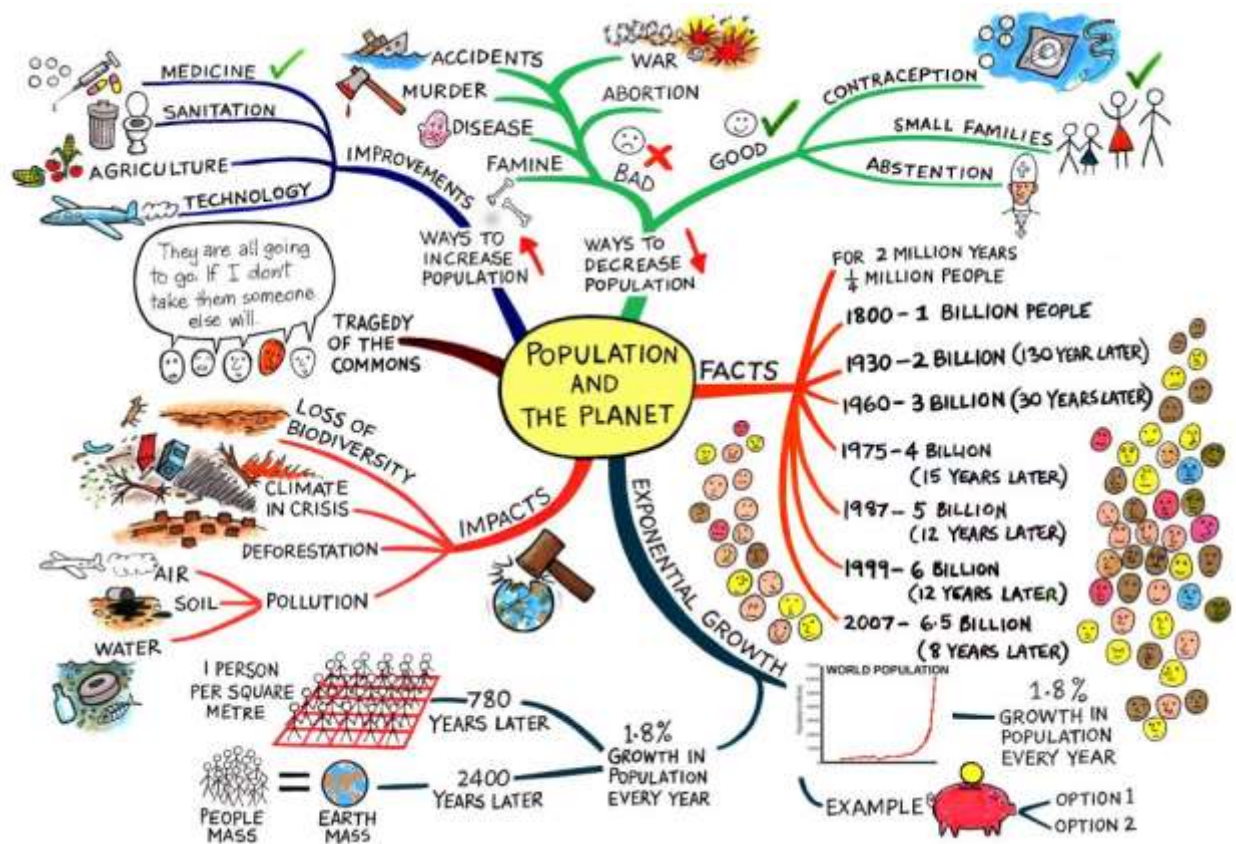
# THE VACCINE RACKET

It seems the mainstream news is trying more forcibly to construct their own form of science, a kind of science rooted deep into delusion and far from fact. 'Newsweek' published an article entitled "The Anti Vaxxer Movement is Growing – We Need to Restore Faith in Science." The article was written by Dr. Barbara Rath, who has a rather extensive academic background. Rath is a co-founder and chair of a pro-vaccine think tank, The Vienna Vaccine Safety Initiative. Yet, her placement on a vaccine safety think tank and her ability to remarkably overlook the indicated health risks of vaccinations are extraordinarily contradictory.

'Newsweek's propaganda piece begins with the following sentences: "The anti-vaxx movement has been gaining momentum in countries across the globe. In a world of post truth politics, more and more parents are buying into the belief that vaccines come with health risks" [1]. There is a lot to unpack here.

Immediately, the article begins by slurring anyone who acknowledges the health risks of vaccines by calling them an anti-vaxxer. When, in reality, anyone who decides to overlook the health risks of vaccinations and claim there are none is ignorant. Nothing more; nothing less.

The second sentence continues by stating, “... *more and more parents are buying into the belief that vaccines come with health risks,*” which implies that there are no health risks that come with being vaccinated. If Rath would simply read Merck’s product insert for its measles, mumps, and rubella (MMR) vaccine, she might be enlightened.

The insert includes the following warnings [2]:

For mothers, the contraindications to vaccination include pregnancy, as “*the possible effects of the vaccine on fetal development are unknown,*” since “*there are no adequate studies of the attenuated (vaccine) strain of measles virus in pregnancy. However, it would be prudent to assume that the vaccine strain of virus is also capable of inducing adverse fetal effects.*” The vaccine-strain mumps virus “*has been shown to infect the placenta and fetus.*”

Studies have shown that the vaccine-strain rubella virus can be transmitted to infants through breast milk. Whether this is also true of the measles and mumps virus “is not known.” Merck also advises that “*pregnancy should be avoided for three months following vaccination*” and that caution should be exercised when M-M-R II is administered to a nursing woman. The vaccine also “*has not been evaluated for carcinogenic or mutagenic potential, or potential to impair fertility.*”

Among those who should not receive the vaccine are children who are hypersensitive to any of the vaccine’s components, including gelatin and eggs, with the latter being included because the live viruses are propagated in chick embryo cultures.

The rubella portion of the vaccine is propagated in “human diploid lung fibroblasts,” specifically WI-38 (ATCC® CCL-75™), which is a female lung that has been in gestation for three months (an aborted female fetus) [3]. Other ingredients that may raise ethical questions are “fetal bovine serum” and “recombinant human albumin,” a genetically engineered human protein produced by Novozyems Biopharma US Inc [4].

Here comes the part Rath has, presumably, not read [2]:

Possible adverse reactions include: Fever, syncope (fainting), headache, dizziness, vasculitis (a condition in which the immune system mistakenly attacks the blood vessels, causing inflammation that can lead to severe problems, including aneurysms), pancreatitis (inflammation of the pancreas that occurs when the digestive enzymes it produces begin digesting the pancreas itself), diarrhea, vomiting, parotitis (inflammation of the parotid glands), nausea, diabetes mellitus, thrombocytopenia (a disorder in which there is an abnormally low amount of platelets, which help a blood

clot), anaphylaxis (a life-threatening allergic reaction that causes cardiac and respiratory arrest), arthritis (joint inflammation), arthralgia (joint pain), myalgia (muscle pain), encephalitis (swelling of the brain, which can cause permanent brain damage or death), Guillain-Barré syndrome (an autoimmune syndrome in which the immune system attacks the peripheral nervous system, which can result in paralysis or death), febrile seizures (convulsions brought on by fever), afebrile seizures (convulsions without fever, which may indicate epilepsy), pneumonia, measles-like rash, or “death from various, and in some cases unknown, causes.”

These are only a handful of the many possible side-effects of the MMR vaccine. Remember, too, this is only one vaccine. The CDC currently recommends nearly twenty vaccinations before the child is eighteen months old, and there are many more after that [5].

Astonishingly, Rath’s implication that vaccines have no health risks is clearly indicative of a pro-vaxxer, to coin the term of someone who ignorantly believes a vaccination has no health risks. Of course, however, Rath, her colleagues, and the mainstream news would gladly push the agenda that none of these risks exist and conceive their own form of science that is based in delusion.

Now, since we have discussed the first two sentences of the articles, let’s continue reading.

Rath writes, “Many still believe the MMR (measles, mumps, and rubella) vaccine is linked with autism, despite numerous scientific studies debunking this myth.” This sentence is twisted.

The research that shows there is no link between vaccinations and childhood neurological disorders only concerns one vaccine (MMR), even though children receive many, and one ingredient, thimerosal. By the way, half of the weight of thimerosal is ethyl-mercury, which is a known neurotoxin. While the link between all of the vaccines and all of their toxin ingredients is highly plausible, studies that debunk the vaccine-autism myth do not examine this whole picture. Instead, they examine only one vaccine and one ingredient. It is also essential to not only focus on autism as a result of large-scale vaccinations but also examine other negative side-effects, like the ones mentioned in the Merck insert [2].

Rath also noted, “The widening communication gap between patients and healthcare professionals.” Again, Rath is implying the patients’ mindless ignorance is causing this gap to be created. However, it is because people are educating themselves by reading the advisory papers that come with the vaccine that is causing parents to be hesitant. Perhaps Rath should read the slips of the twenty immunizations that are recommended for a child by the age of eighteen months.

I have said this before: I am not anti-vaccination; I am pro-medical consent. I believe people should be well-informed of medical procedures they undergo and choose



whether the risks they will encounter outweigh the benefits they will receive. I am all in on evidence-based medicine, in which treatment therapies have been subject to efficacy testing.

The most fundamental communication gap in the current age is the difference of what the mainstream news tells citizens and what the real news is, and this is a perfect example of the difference. The fact that someone with Rath's educational and academic background claims that there are no health risks that come with vaccination is clearly indicative of this gap.

This is an explicit example where the public, parents, and medical people are being both deceived and confused; and, all too often particulars on side effects and potential issues are left out of press releases, public statements, and remarks by the pharmaceutical industry. They cherry-pick their remarks so as to mislead and deceive the people who may be the ultimate victim.

Robert David Steele stated this on September 1<sup>st</sup>, 2019:

*“it's not the older adults reading this who are the target, it's the youngest generation, who are growing up not knowing a life without a smartphone connected to the Internet in the palm of their hands.”*

*“That's why I sat up in my seat when I saw a tweet from Catherine Austin Fitts yesterday about a study cited by her friend, Toby Rogers PhD, who tweeted, **“As societies near 100% vaccination rates, harms become undetectable because everyone is harmed. Autism becomes the new normal; economic and political collapse will soon follow.”***

Dr. Rogers reminds us that the first autism prevalence study (Treffert, 1970) showed an autism rate of less than 1 in 10,000 kids and that today, the autism rate in

the US in 1 in 36 kids (Zablotsky et al., 2017), a **27,000% (277-fold) increase in 50 years**. [Editor comment: If you live in New Jersey, the rate is now 1 in 25 boys!]

If you think these numbers are due to over-diagnosis, it's just the opposite, according to one study published in the JAMA Psychiatry journal, which suggests that many of us are already on the autism spectrum. Autism symptoms, "in seven areas: emotion recognition, theory of mind, cognitive flexibility, activity planning, inhibition, evoked responses, and brain volume...in each of the assessed areas, the measurable difference between the two groups had decreased over the past 50 years," and "...If this trend holds, the objective difference between people with autism and the general population will disappear in less than ten years."

Dr. Rogers added, "*Pharma has captured the political system. Political parties, all federal agencies and most state public health departments work for Pharma. In their endless quest for profits, Pharma is literally going to destroy western civilization.*"

To this, Fitts responded, "*Agreed. Any possibility that this is not a plan is disappearing. Looks like they want humans who are [neurolink](#) ready – no need for anything to be in their brain – AI will provide – just need to make sure you have destroyed the divine spark and empathy. Gruesome.*"

**The research continues to accumulate: Fluoride exposure harms the brain and reduces IQ.**

The U.S. Centers for Disease Control and Prevention considers community water **fluoridation** one of the ten greatest public health achievements of the 20th century. The view of US regulatory agencies has also been the dominate view of the medical community. Have these long-held beliefs stood the test of scientific rigor?

It **has already been established** that fluoride crosses the placenta, and laboratory **studies show** that it accumulates in brain regions involved in learning and memory and alters proteins and neurotransmitters in the central nervous system.

Now, a recent study is the first to estimate fluoride exposure in a large birth cohort receiving optimally fluoridated water. Published in the journal *JAMA Pediatrics*, **the study** has forced many to re-examine the practice of water fluoridation. Funded by the Canadian government and the U.S. National Institute of Environmental Health Science, the new study titled *Association Between Maternal Fluoride Exposure During Pregnancy and IQ Scores in Offspring in Canada* examined the association between fluoride exposure during pregnancy and the IQ scores of the children at ages 3 and 4 years of age.

The scientists assessed fluoride exposure in two separate ways. They measured fluoride in women's urine samples during pregnancy while also calculating fluoride consumption based on how much is in a city's water supply and how much women

recalled drinking. The study found that of the 512 mother-child pairs, a 1-mg/L increase in maternal urinary fluoride was associated with a 4.49-point lower IQ score in boys.

The study's authors concluded:

***"...maternal exposure to higher levels of fluoride during pregnancy was associated with lower IQ scores in children aged 3 to 4 years. These findings indicate the possible need to reduce fluoride intake during pregnancy."***

Perhaps sensing the potential blowback from publishing the recent Canadian study in *JAMA Pediatrics*, the journal's Editor-In-Chief Dimitri Christakis provide **an editor's note** to accompany the study stating impart, *"This decision to publish this article was not easy. Given the nature of the findings and their potential implications, we subjected it to additional scrutiny for its methods and the presentation of its findings."*

Chris Takis said during in recent JAMA Pediatrics Editors Summary **podcast**, *"For me, before there were 'anti-vaxers' there were sort of 'anti-fluoriders.'" He shared that while he was going through residency, the traditional teaching he received was that "fluoride is completely safe. All these people that are trying to take it out of the water are nuts."* He commented about the recent study's findings saying they were "sizable" and "on par" with the IQ drops seen in children exposed to lead. When Christakis was asked what he would recommend as a pediatrician if a pregnant mother came into his office he replied *"I would advise them to drink bottled water."*

Outlets like **NPR** and others cautioned readers not to read too much into a single study. Yet for those who have followed the hard science placing in question the practice of water fluoridation, the recent *JAMA Pediatrics* study is just another data point along an increasingly clear trajectory.

The recent study findings are consistent with that of a **2017 Mexican birth cohort study** published in the journal *Environmental Health Perspectives*. The 2017 study, sponsored by the U.S. National Institutes of Health, spanned 12 years and found a 6.3 point **reduction in IQ** in preschool-aged children.

As of 2018, **53 studies** have found that elevated fluoride exposure is associated with reduced IQ in humans while **45 animal studies** have found that fluoride exposure impairs the learning and/or memory capacity of animals. The Fluoride Action Network **writes**, *"The human studies, which are based on IQ examinations of over 15,000 children, provide compelling evidence that fluoride exposure during the early years of life can damage a child's developing brain."* After reviewing 27 of the human IQ studies in 2012, a team of **Harvard researchers** concluded their findings *"Supported the possibility of an adverse effect of high fluoride exposure on children's neurodevelopment."* They also suggested that fluoride's effect on the young brain should now be a *"high research priority."*

Water fluoridation is supplied to about 66% of US residents, 38% of Canadian residents, and 3% of European residents. In fluoridated communities, fluoride from

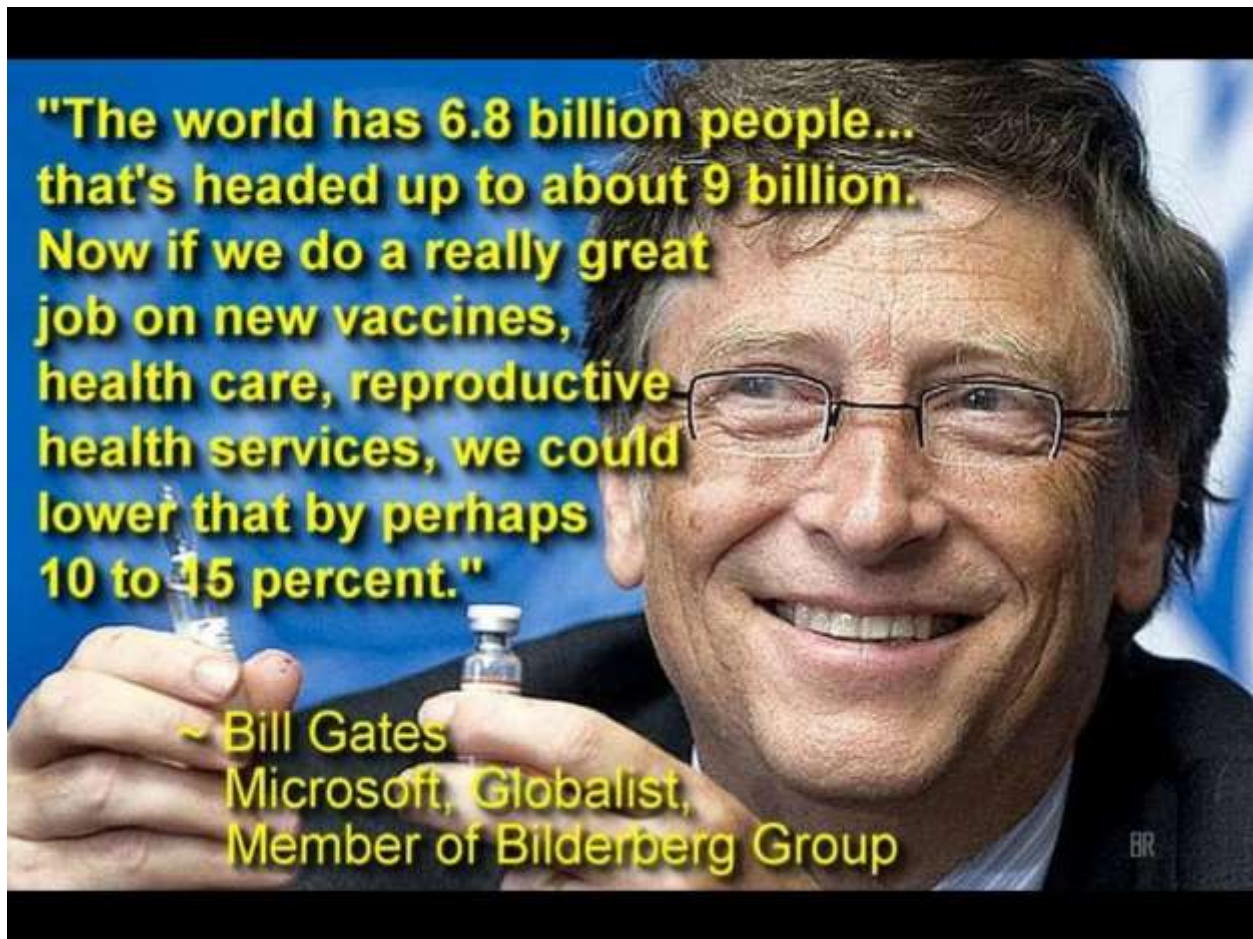
water and beverages made with tap water makes up well over half of daily fluoride intake in adolescents and adults while **dental products** remain a major source of exposure in children. Regulatory agencies have yet to recommend any sweeping reform in light of the scientific evidence regularly contradicting the practice of water fluoridation. In their absence, local communities have taken action with **250 communities ending the practice** since 2010.

Several studies have looked at how to protect and reverse the unwanted effects caused by fluoride (view the GreenMedInfo **database on mitigating Fluoride toxicity**). Curcumin, an active ingredient of turmeric, **has been shown** to attenuate neurotoxicity induced by fluoride. Meanwhile, **iodine and tamarind** have both shown in studies ability to clear fluoride from the body. As the scientific evidence mounts year after year, will you take individual action to protect yourself or wait for regulatory agencies to someday do it for you?

In its statement, Vector said that no biohazard material was being stored in the room where the explosion took place. The city's mayor also insisted that the incident does not pose any biological or any other threat to the local population, according to TASS.



Founded in 1974, the Center for Virology and Biotechnology was once known for developing biological weapons research during the Cold War Soviet era. It is now one of the world's largest research centers developing vaccines and tools for diagnosing and treating infectious diseases.

The head of the Koltsovo science city, where Vector is located, told Russian state news agency RIA-Novosti that there was no biological threat.

Scientists at the center are developing vaccines for swine flu, HIV, and Ebola. In February, scientists there wrapped up clinical trials of an Ebola vaccine, according to TASS.

The US Centers for Disease Control and Prevention is the only other center in the world approved and known to have live samples of the deadly smallpox virus.

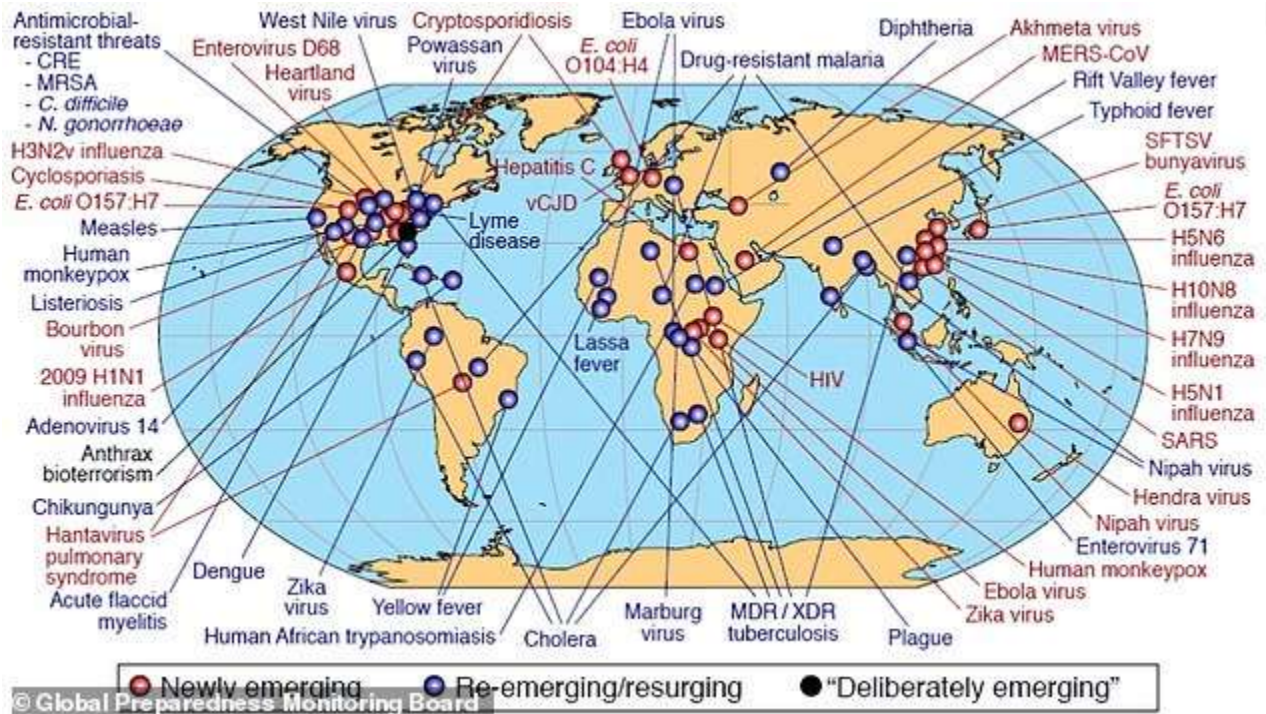
Last year, the US Food and Drug Administration announced its approval of the first drug to treat smallpox. The contagious disease was eradicated in 1980 thanks to vaccination efforts, but there are concerns that it could be used in a bioterror attack.

Outbreak of a flu-like illness could circulate the world in 36 hours and kill 80 million people, warns report by former World Health Organization chief. A flu-like illness could travel around the world in 36 hours and kill 80-million people, experts have warned.

A century ago the Spanish flu pandemic infected a third of the world's population and killed 50-million people. If a similar outbreak were to happen with today's constantly-travelling population, the effects could be even worse, a report has suggested.

The Global Preparedness Monitoring Board (GPMB), a team of health experts led by a former chief of the World Health Organization, has produced the report to try and spur world leaders into action.

'The threat of a pandemic spreading around the globe is a real one,' the group said in a report released today that a quick-moving pathogen has the potential to kill tens of millions of people, disrupt economies and destabilize national security.' The map below shows where known outbreaks have been identified by the World Health Organization and being monitored and tracked. The scope of just one of the many potential viruses or pathogens is frightening to say the least!



The report entitled “*A World At Risk*” listed dozens of illnesses which the experts suggested had the potential to trigger an outbreak which could spiral out of control, among them plague, Ebola, Zika virus and Dengue

The report, named *A World At Risk*, said current efforts to prepare for outbreaks in the wake of crises such as Ebola are 'grossly insufficient'.

The GPMB is headed by Dr. Gro Harlem Brundtland, the former Norwegian prime minister and director-general of the WHO, and Mr. Alhadj As Sy, the secretary-general of the International Federation of Red Cross and Red Crescent Societies.

It said in its report that recommendations it made in an earlier report have been largely ignored by world leaders. Many of the recommendations reviewed were poorly implemented, or not implemented at all, and serious gaps persist,' the GPMB wrote.

For too long, we have allowed a cycle of panic and neglect when it comes to pandemics: we ramp up efforts when there is a serious threat, then quickly forget about them when the threat subsides. It is well past time to act.

The map shows how these were split into 'newly emerging' and 're-emerging/resurging'. Among the former were the Ebola, Zika and Nipah viruses, and five types of flu. And the latter included West Nile virus, antibiotic resistance, measles, acute flaccid myelitis, Yellow fever, Dengue, plague and human monkey pox.

The report referenced the damage done by the 1918 Spanish flu pandemic and said modern advances in international travel would help the disease spread faster.

With vast numbers of people crossing the world on planes every day, an equivalent air-borne outbreak now could spread globally in less than 36 hours and kill an estimated 50-million to 80-million people, they said.

The GPMB report warned: 'There is a very real threat of a rapidly moving, highly lethal pandemic of a respiratory pathogen killing 50 to 80-million people and wiping out nearly five per cent of the world's economy.

A global pandemic on that scale would be catastrophic, creating widespread havoc, instability and insecurity. The world is not prepared. In the case of a pandemic, many national health systems - particularly in poor countries - would collapse, they said.

Poverty and fragility exacerbate outbreaks of infectious disease and help create the conditions for pandemics to take hold, said Axel van Trotsenburg, acting chief executive of the World Bank and a member of the panel. The report set out a series of actions the international community must take to protect people around the world in the event of an illness spreading out of control.

Tedros Adhanom Ghebreyesus, director-general of the WHO, called on governments to heed the lessons these outbreaks are teaching us' and to 'fix the roof before the rain comes.

In their recommendations the team said governments must ring fence money for putting preparations in place and do routine simulation exercises.

The G7, G20 and G77 states should set an example for the rest of the world to follow, they added, and all parties must 'prepare for the worst'.

They also called for more private investment into countries' pandemic preparations and said the UN must do more to co-ordinate responses across international borders.

The WHO also warned earlier this year that another pandemic of flu - which is caused by airborne viruses - is inevitable, and said the world should prepare for it.

### **The Vatican and Pope Francis Push for World Government**

In a recent segment, I stated that Pope Francis was more than just a player in this UN Agenda 30, he is a driving force in the Global Government agenda.

Pope Francis has joined his papal predecessors in calling for a World Government. In his latest encyclical letter, **Laudato Si'**, the Vatican leader wrote a

dissertation on environmentalism, laying out a litany of “sins” against “Sister Earth” which he thinks should be combated by a new “world political authority.”



Pope Francis and the Vatican called for a meeting to discuss the global depopulation agenda of the New World Order. In spite of what Pope Francis has to say publicly, privately he has orchestrated the invasion of Europe flooding the EU countries with aliens from Africa and mid-Eastern. 6.1-million immigrants have fled to Europe since 2011. Pope Francis directed the illegals entering the southern U.S. border, having George Soros fund the boats transporting the invading migrants across the Mediterranean Sea to the coast of Europe. Thousands of Africans have been transported to Central America deliberately to invade the U.S. Hundreds of Africans were detained at a check point near El Paso, TX, each with rolls of new U.S. \$100-bills in their possession given to them to invade the U.S. They had been set-up to cross the Atlantic, given large sums of U.S. Benjamin's, with promise of employment by agents of George Soros.

According to the pope, these eco-crimes include “excessive anthropocentrism” at the expense of nature, destruction of forests and wetlands for the purpose of agricultural cultivation, and human-caused global warming caused by greedy consumption of fossil fuels. The pope opined that increased use of air-conditioning is particularly corrupt.

The Catholic leader also advocated for government-enforced social justice. He wrote that wealthy nations owe a “social debt” to the poor and impoverished people of the world, a debt which can be paid by increased funding and better distribution of wealth. Pope Francis has said no country has the right to deny access to an immigrant seeking to emigrate to it.



If Pope Francis' message was a call for a change of heart among Catholics — to voluntarily take care of the earth and each other — that would be a noble message and consistent with the Bible.

However, Francis made it clear that he was not proposing voluntary, personal reforms. The solution, which was the central theme of his letter, was a proposed global government to impose international taxation and international law enforcement.

This article will parse down the rambling letter to the relevant portions referring to world government, while leaving the context evident for the reader. (Emphasis is added.)

Pope Francis, **LAUDATO SI'**, Paragraph **53**:

**53.** These situations have caused sister earth, along with all the abandoned of our world, to cry out, pleading that we take another course. Never have we so hurt and mistreated our common home as we have in the last two hundred years.

Yet we are called to be instruments of God our Father, so that our planet might be what He desired when He created it and correspond with His plan for peace, beauty and fullness. The problem is that we still lack the culture needed to confront this crisis.

We lack leadership capable of striking out on new paths and meeting the needs of the present with concern for all and without prejudice towards coming generations. The establishment of a legal framework which can set clear boundaries and ensure the protection of ecosystems has become indispensable; otherwise, the new power structures based on the techno-economic paradigm may overwhelm not only our politics but also freedom and justice.

Pope Francis, **LAUDATO SI'**, Paragraph **54**:

**54.** It is remarkable how weak international political responses have been. The failure of global summits on the environment makes it plain that our politics are subject to technology and finance. There are too many special interests, and economic interests easily end up trumping the common good and manipulating information so that their own plans will not be affected.

The Aparecida Document urges that “the interests of economic groups which irrationally demolish sources of life should not prevail in dealing with natural resources”.<sup>[32]</sup> The alliance between the economy and technology ends up sidelining anything unrelated to its immediate interests.

Consequently the most one can expect is superficial rhetoric, sporadic acts of philanthropy and perfunctory expressions of concern for the environment, whereas any genuine attempt by groups within society to introduce change is viewed as a nuisance based on romantic illusions or an obstacle to be circumvented.



Pope Francis, **LAUDATO SI'**, Paragraph **73**:

**73.** Enforceable international agreements are urgently needed, since local authorities are not always capable of effective intervention. Relations between states must be respectful of each other's sovereignty, but must also lay down mutually agreed means of averting regional disasters which would eventually affect everyone.

Global regulatory norms are needed to impose obligations and prevent unacceptable actions, for example, when powerful companies dump contaminated waste or offshore polluting industries in other countries.

Pope Francis, **LAUDATO SI'**, Paragraph **174**:

**174.** Let us also mention the system of governance of the oceans. International and regional conventions do exist, but fragmentation and the lack of strict mechanisms of regulation, control and penalization end up undermining these efforts.

The growing problem of marine waste and the protection of the open seas represent particular challenges. What is needed, in effect, is an agreement on systems of governance for the whole range of so-called "global commons".

Pope Francis, **LAUDATO SI'**, Paragraph **175**:

**175.** The same mindset which stands in the way of making radical decisions to reverse the trend of global warming also stands in the way of achieving the goal of eliminating poverty. A more responsible overall approach is needed to deal with both problems: the reduction of pollution and the development of poorer countries and regions.

The twenty-first century, while maintaining systems of governance inherited from the past, is witnessing a weakening of the power of nation states, chiefly because the economic and financial sectors, being transnational, tends to prevail over the political.

Given this situation, it is essential to devise stronger and more efficiently organized international institutions, with functionaries who are appointed fairly by agreement among national governments, and empowered to impose sanctions. As Benedict XVI has affirmed in continuity with the social teaching of the Church:

*"To manage the global economy; to revive economies hit by the crisis; to avoid any deterioration of the present crisis and the greater imbalances that would result; to bring about integral and timely disarmament, food security and peace; to guarantee the protection of the environment and to regulate migration: for all this, there is urgent need of a true world political authority, as my predecessor Blessed John XXIII indicated some years ago."*

[129] Diplomacy also takes on new importance in the work of developing international strategies which can anticipate serious problems affecting us all.

Manage the global economy? Regulate migration? Bring about disarmament?

The Vatican plan for New World Order would apparently create a platform for limiting basic individual freedoms, such as the right to buy and sell, the right to travel abroad, and the right to defend one's self and one's homeland. This fantasy of a global, centrally-planned utopia would more likely be a corrupt, liberty-devouring nightmare.

### **RECURRING THEME OF THE VATICAN**

The Vatican's promotion of World Government did not begin with the current pope. Francis bolstered his argument by quoting Benedict XVI, and Benedict XVI did the same by quoting John XXIII. The Catholic Church has been infatuated with this idea for quite some time.

Pope Benedict XVI's letter is quoted below, again presented in full context. He wanted the world government to have "real teeth" and to participate in global gun control.

Pope Benedict XVI, **CARITAS IN VERITATE** (2009), paragraph **67**:

**67.** In the face of the unrelenting growth of global interdependence, there is a strongly felt need, even in the midst of a global recession, for a reform of the United Nations Organization, and likewise of economic institutions and international finance, so that the concept of the family of nations can acquire real teeth.

One also senses the urgent need to find innovative ways of implementing the principle of the responsibility to protect[146] and of giving poorer nations an effective voice in shared decision-making. This seems necessary in order to arrive at a political, juridical and economic order which can increase and give direction to international cooperation for the development of all peoples in solidarity.

To manage the global economy; to revive economies hit by the crisis; to avoid any deterioration of the present crisis and the greater imbalances that would result; to bring about integral and timely disarmament, food security and peace; to guarantee the protection of the environment and to regulate migration: for all this, there is urgent need of a true world political authority, as my predecessor Blessed John XXIII indicated some years ago.

Such an authority would need to be regulated by law, to observe consistently the principles of subsidiarity and solidarity, to seek to establish the common good[147], and to make a commitment to securing authentic integral human development inspired by the values of charity in truth.

Furthermore, such an authority would need to be universally recognized and to be vested with the effective power to ensure security for all, regard for justice, and respect for rights[148].

Obviously it would have to have the authority to ensure compliance with its decisions from all parties, and also with the coordinated measures adopted in various international forums. Without this, despite the great progress accomplished in various sectors, international law would risk being conditioned by the balance of power among the strongest nations.

The integral development of peoples and international cooperation require the establishment of a greater degree of international ordering, marked by subsidiarity, for the management of globalization [149].

They also require the construction of a social order that at last conforms to the moral order, to the interconnection between moral and social spheres, and to the link between politics and the economic and civil spheres, as envisaged by the Charter of the United Nations.

A couple years later, emissaries of Benedict XVI released a report that elaborated on his goals, directly called for a World Central Bank and a World Government.

Vatican Council, *“Towards Reforming the International Financial and Monetary Systems in the Context of Global Public Authority”* (2011):

These measures ought to be conceived of as some of the first steps in view of a public Authority with universal jurisdiction; as a first stage in a longer effort by the global community to steer its institutions towards achieving the common good.

Other stages will have to follow in which the dynamics familiar to us may become more marked, but they may also be accompanied by changes which would be useless to try to predict today.

In this process, the primacy of the spiritual and of ethics needs to be restored and, with them, the primacy of politics – which is responsible for the common good – over the economy and finance.

These latter need to be brought back within the boundaries of their real vocation and function, including their social function, in consideration of their obvious responsibilities to society, in order to nourish markets and financial institutions which are really at the service of the person, which are capable of responding to the needs of the common good and universal brotherhood, and which transcend all forms of economist stagnation and performative mercantilism.

Vatican Council, *ibid.*:

### 3. An Authority over Globalization

On the way to building a more fraternal and just human family and, even before that, a new humanism open to transcendence, Blessed John XXIII's teaching seems especially timely. In the prophetic Encyclical *Pacem in Terris* of 1963, he observed that the world was heading towards ever greater unification.

He then acknowledged the fact that a correspondence was lacking in the human community between the political organization "on a world level and the objective needs of the universal common good". He also expressed the hope that one day "a true world political authority" would be created.

In view of the unification of the world engendered by the complex phenomenon of globalization, and of the importance of guaranteeing, in addition to other collective goods, the good of a free, stable world economic and financial system at the service of the real economy, today the teaching of *Pacem in Terris* appears to be even more vital and worthy of urgent implementation. In the same spirit of *Pacem in Terris*, Benedict XVI himself expressed the need to create a world political authority.

This seems obvious if we consider the fact that the agenda of questions to be dealt with globally is becoming ever longer.

Think, for example, of peace and security; disarmament and arms control; promotion and protection of fundamental human rights; management of the economy and development policies; management of the migratory flows and food security, and protection of the environment.

In all these areas, the growing interdependence between States and regions of the world becomes more and more obvious as well as the need for answers that are not just sectorial and isolated, but systematic and integrated, rich in solidarity and subsidiarity and geared to the universal common good.

### **BEWARE OF FALSE TEACHERS**

The Vatican and the Catholic leaders mentioned in this article profess to be disciples of Jesus Christ, and presumably take the Bible as a reliable document of God's word. It is therefore prudent to analyze the subject of world government under a Christian lens.

The Bible does indicate that the earth is destined for a world system of government, but it is not presented in a flattering light. Revelation Chapter 13 says that in the final days, The Beast will have authority over "every tribe and people and language and nation" (v.7).

The global authority will be used to persecute Christians and cause everyone to worship the Beast (v.8), and will physically brand everyone with a mark on either the forehead or the right hand (v.16) to induce economic control over them.

Surely the leaders of the Catholic church have read the Book of Revelation. Surely they realize that, according to their own doctrines, a dreadful Satanic system of world government lies ahead.

It should raise red flags to hear a so-called “Christian” leader advocating for building the global throne upon which the Beast will sit. It is difficult to imagine that this long-standing Catholic goal is pursued with ignorance to the Bible.

Christians are given ample warnings about the church being attacked by corrupted teachings. The Bible gives information about identifying and dealing with false teachers of the gospel in nearly every book of the New Testament.

The recurring theme is that even people who appear “religious” on the outside — like the Pharisees — can be extremely destructive. The Bible says that “even Satan masquerades as an angel of light, so it is no surprise if his servants, also, disguise themselves as servants of righteousness” (2 Corinthians 11:14-15).
