
The Great Reset! Or Is It Really a Cover Story Hiding The Next Solar Micro-Nova



ALL QUIET: Solar activity is low. There are plenty of sunspots, but they all have stable magnetic fields that pose no immediate threat for strong explosions. NOAA forecasters say there is a 5% chance of <u>M-class</u> flares and no more than a 1% chance of <u>X-flares</u> on Nov. 6th. And so what's the big deal you ask? Read on and you will begin to understand the significance and it is far more important than you may think or imagine.

21 YEARS AGO, A SEVERE GEOMAGNETIC STORM OCCURRED: It could happen again--and soon. Twenty-one years ago today, a full-halo CME struck Earth's magnetic field, sparking a severe <u>G4</u>-class geomagnetic storm. "Skies over Central Europe glowed bright red and violet," recalls Heiko Ulbricht, who photographed the display from

Saxony, Germany, on Nov. 6, 2001:



"The shock front hit the Earth's magnetic field around 2 a.m. CET--good timing for sky watchers in Europe," says Ulbricht. From there, auroras spread around the world, descending as far south as Florida, Texas, and California in the United States. The storm persisted for more than 24 hours.

The **CME** or **C**oronal **M**ass **E**jection left the sun two days earlier, propelled by an <u>X1</u>class solar flare from sunspot AR9684. SOHO coronagraph images of the CME were quickly overwhelmed by a *"snowstorm"* of energetic particles accelerated by shock waves in the approaching storm cloud The kind of explosion that produced this storm is, interestingly, not rare. Young Solar Cycle 25 has already produced 8 similar X-flares since 2021. None of the related CMEs delivered a direct hit, however.

"If you look at the sun today, it could definitely produce a spectacle of this kind again," says Ulbricht. Browse the aurora gallery from 21 years ago to see what might be coming.


My interest in these reoccurring solar cycles began 21 years ago with Solar Cycle 25 and while I knew almost next to nothing about such solar activity; it would not be too long before I learned that we are nearing a *"grand solar minimum"*, and that it is the real cause of *"global warming"* and not human CO². I purchased Douglas Vogt's book *'God's Day of Judgment: The Real Cause of Global Warming'* back on March 7, 2021. The title was intriguing and proved to be an un-resistible read. It took me three months to read it among my other tasks of tracking the Covid-19 scamdemic. To be quite honest, it was not anything that I expected, but I have since read all of his other books since reading this title.

However, from my perspective as a retired pastor and a Bible student of more than a half-century, the book was quite thought provoking, even challenging to some of our understanding of the Bible and Biblical history. As far as I can tell from reading Douglas Vogt's books, he is not a Christian but identifies himself as a Jew, Mr. Vogt relates to the Old Testament from that as a geological scientist. By that he relates Old Testament chronology and specific events through the lens of a geologist. I can relate to his view points since I had two years of geology in college and have studied beyond the point where most people go in advanced learning on such topics.

I need to note that nothing in Douglas Vogt's book either contradicts or is in conflict with my Christian faith or belief. In fact, his geologic analysis and findings help explain things in the Bible that we had scant evidence or back up information.

Amazon's lead in to 'God's Day of Judgment' states: "The book is totally unique book. It provides the scientific reason for the polar reversals and ice ages. It also answers the age-old religious question: What is God's Day of Judgment and when will it happen? The thrust of Mr. Vogt's book is to fully explain the cause of the polar reversal and resulting ice age. The model used to explain the mysteries of the ice age is his Theory of Multidimensional Reality, the first information theory of existence. He discovered the exact number of years between polar reversals, which is 12,068 years. The author explains how the Ark, the Tabernacle and the Rod of God worked and shows pictures of many of the altars he discovered during two expeditions to the Sinai, Egypt."

There are some things that Douglas Vogt and I would disagree on but I can say that his writing and YouTube videos offer a challenge to certain thinking's that I believe are worth considering in his study about a potential Solar Micro-Nova event in 2046, just two decades ahead. Douglas Vogt's web page is <u>Dieholdfoundation.com</u> and his videos and presentations are all available to view at his site.

Mr. Vogt offers extraordinary evidence as to why all of this has been off the radar screen since the U.S. first made a 'real' landing, not a faked Disney Studio back lot one, on the moon and what it was that was proved by that mission, the real purpose of the mission is more than simply the words of the late President Kennedy geo-political race with the former Soviet Union.

Doug Vogt believes the reason for the original moon landing mission was to confirm or

disprove a theory that the moon would contain left-over evidence of previous any Solar Micro-Nova that were part of the Coronal Mass Ejection events in the past. Doug Vogt said the theory was proven true and that there was no longer any reason to explore the moon and so the program was no longer needed. A total of 6 manned moon landings to date were a part of NASA's Apollo program. Running from 1961 to 1972, the objective of the program was to gather as much data as possible from close orbits and manned landings, and of course, get to the Moon before the Soviets and take the lead in space exploration. A great deal of evidence exists that question the actual number of manned moon landings actually took place.

The first thing we need to cover comes from the Douglas Vogt's Diehold Foundation web site is an overview summary of what this article is all about:

The Causes of the Ice Ages and Geomagnetic Reversals (Polar Reversals).

The Problem—Why is the Earth Getting Warmer?

The global warming issue has two competing scientific camps. One side claims that global warming exists and is caused by human made CO₂ emissions which is heating up the atmosphere, resulting in global warming. The other camp says there is global warming but it mirrors the Suns output such as changes during the sunspot cycles. I fit into the Sun side of the argument, but both sides have no idea why the Sun's output has been periodically increasing since the 1890s.

The Riddle of the Ice Age:

The problem with current ice age models are, they can only explain a few of the known facts that happened during these periods. Scientists do not know why they happen cyclically through time or why only the Pleistocene period (11,000 years BP to 1.8 million years BP) exhibited repeated ice ages and ice recessions. They do not know why all ice ages are preceded with a geomagnetic polar reversal. We know there was a great mass extinction of species following the polar reversal and ice age but they do not understand why the extinctions affect both plants and animals worldwide. The most difficult problem to explain, using the traditional models, is the creation of new species immediately after the polar reversal and ice age. There are many more phenomena the traditional models cannot explain, but that has not stopped many scientists from presenting their model (explanation) for some of these phenomena.

Scientists have been trying to figure out the ice age riddle for about 100 years. It should be obvious to everyone by now that the underlining philosophy that creates their models is wrong. The problem is that egos and inertia of the academic community and their institutions prevent change. Not to be too brutal on them but the next polar reversal and nova will solve the problem of their egos and academic rigidity. The question then is: will there be anybody left?

The Problem is the Matter Oriented Theory of Existence.

Our science is based on a matter-oriented theory of existence, which assumes that matter is the dominant driving force in the Universe. Energy and light are explained as the changes in the states of matter. All scientific models are derived from this base philosophy. If this philosophy is wrong than all models built on this basic premise will be wrong.

The only other alternative to explain the workings of the Universe is an information theory of existence. This philosophy holds that Information is the dominant force in the Universe and matter is the product of information. The information derives from another time-space dimension. Mr. Vogt's information theory of existence is called **The Theory of Multidimensional Reality** and his three books explains the basic philosophy. The first iteration on the theory was in Reality Revealed, The Theory of Multidimensional Reality (1978). The second iteration was presented in Chapter 3 of God's Day of Judgment, the Real Cause of Global Warming (2007). The third iteration of the theory is in the latest book The Theory of Multidimensional Reality (2015). This is the world's first information theory of existence.

Even Stephen Hawking, a few years ago, corrected his earlier idea about the end of the Universe collapsing down to the size of a grapefruit, to the idea that after the collapse the Universe then goes to information. He also corrected his previous theory about black holes, which stated that when matter entered a black hole it was destroyed. His new theory is that the matter is not destroyed but goes to information. These two ideas were stated back in 1978 in Chapter 6, page 170 of Reality Revealed.

What is Going to Happen.

The sequence of events that created the Ice Age

We will divide the ice age and polar reversal into three time periods, the first being 50 years leading up to the polar reversal and the ice age. The second part being the actual polar reversal, ice accumulation and other events that occurred within 11 years of the reversal. The last part is the aftermath. The following is a condensed version. Chapter 8 in God's Day of Judgment has the complete explanation and all the proofs. Samples of Chapter 8 can be read on <u>www.vectorpub.com</u>.

50 Years before

The polar reversal is caused by a clock cycle that runs through time. This clock cycle crosses the x-axis every 12,068 years. Some might call this a zero-point energy event. A complete cycle would represent two polar reversals, or 24,136 years.

The magnetic field of the Earth will start decaying within 50 years of the actual polar reversal, but the decay will start to exponentially decay as we get within 7 years of the reversal. The magnetic field does not have to go to zero before it snaps to a reversed polarity. As the magnetic field decays, it will create increased heat in the core of the Earth. The additional heat will rise towards the surface and manifest itself in the form of increased volcanoes and earthquakes. The increase in earthquakes is a result of the continental plates sliding more easily against each other. The increased heat of the mantel of the Earth's, upon which the plates "float," will become more lubricated, enabling them to move or fracture more easily. The increase in volcanic activity goes along with that process. The Earth's rotation will start slowing down in this period of time, resulting in the necessity to add seconds, then minutes to our clocks. Weeks, and maybe months, before the reversal the Earth's rotation will slow down markedly, maybe resulting in 28-hour days.

The Sun will also be affected by its own collapsing magnetic field. The Sun's output will start increasing over 140 years before the final reversal. The increased solar output will start heating up the surface of the Earth. Sea surface temperatures will rise during sunspot cycles, successively increasing, as we get closer to the reversal. The polar ice caps and glaciers will start melting, resulting in ocean levels rising. Before the polar reversal, most of the ice caps and glaciers may have melted. The increased sea surface temperature will create more violent and frequent storms worldwide. The increase in solar output will create additional levels of ultraviolet light hitting the Earth. This will deplete the ozone layers in the upper atmosphere during the sunspot maximums.

The Polar Reversal

The actual polar reversal occurs in one day. There is a complex series of events that will happen on that day. I will start with what happens to the Sun.

What Happens on and in the Sun

The collapsing magnetic field deep inside the Sun will create a large spike of energy that will cause the matter and dust shell on the surface, to expand very rapidly. This event we would call a stellar nova. I estimate the speed of the dust shell to approach 1,550 miles per second. My best estimate for the energy output during the nova is no less than 2,000 times the normal energy output. The equatorial region of the Sun will blow outward along the planetary plane, hitting each planet as the dust shell expands rapidly. As the hot dust/matter shell hits each successive planet, it will push the planets a little further away from the Sun. After the nova the planets will receive a little less energy from the Sun. The planets also lose some of their atmosphere and surface liquids. Eventually, the dust/matter shell will lose enough momentum and stall out somewhere past Neptune. This is called the Kuiper belt.

After the Sun's matter shell has been expelled, it will give off mostly ultraviolet light but not that much radiant heat. The Sun will remain that way until the matter shell can form around it again, and that may take a number of sunspot cycles.

The Rotation of the Earth

At the exact time of the polar reversal the Earth will stop its rotation and remain still for seven to eight hours. The forests and buildings on the Sun-side of the Earth will combust if the plants are not flooded by the ocean or nearby lake. Not only will heat affect plants and animals, but the Sun will produce a massive dose of cosmic and gamma rays, which will reach the Earth within 10 to 15 minutes after the reversal. This cosmic particle pulse may last 10 to 30 seconds with the potential to alter the genes/DNA of both plants and animals, including humans. Now you know what creates new species based on older species.

The Solar Dust Shell

The people on the Sun-side of the Earth will be able to see the Sun expanding, and the solar disk getting larger as it expands towards the Earth. I estimate the dust shell will take between 17 to 18 hours to hit the Earth. The dust shell will not necessarily hit the side of the Earth that faced the Sun, at the moment of the polar reversal, because 18 hours will have passed and another side of the Earth will be facing the Sun. When the dust shell hits us, it will deposit vast quantities of dust and rock on one-half of our Earth.

Solar Evaporation of Ocean Water and the Snow

The nova will also evaporate at least 600 feet of ocean water, worldwide. Some of this water will be lost into space, carried away by the expanding dust shell. Some of it will appear to us as returning comets. Most of the water will remain in the atmosphere as superheated water for several days to a week. As the atmosphere cools down it will start to rain hot rain. As it cools further the rain gets colder until it turns to snow. Lots of snow and it will keep snowing for the next 40 to 50 years until most of the moisture is rung out of the atmosphere.

If you could see the Earth from space just after the Nova, you would see it with a thick tail, pointing away from the Sun. It will be made up of dust and ice crystals. Eventually the debris tail will disappear over several thousand years, as the Earth's gravity brings the material back into the upper atmosphere.

Fast Frozen Animals on the Back Side

Just after the solar dust shell passes the Earth, the dust shell side will have extremely low atmospheric pressure because the dust shell would have blown most of the atmosphere away on that side, we just do not know how much. The backside of the Earth will temporarily have normal atmospheric pressure, but that condition will not last long. Very shortly after the dust shell passes by, the normal atmosphere on the backside, will expand very rapidly to fill up the front side (dust shell side) of the Earth. Two things will result from this process: The first will be extremely high-speed winds traveling around the Earth from all four corners of the globe, to fill up the extremely low atmospheric pressure on the dust shell side. The second consequence of this process is revealed in Boyle's law: "If a given weight of gas is considered and if its temperature is held constant, the pressure and volume of the gas will be inversely proportional." Applying this law to the conditions that will be present on the backside of the Earth, the atmosphere will expand very fast and, therefore, the temperature will drop to extreme levels, possibly below -180 degrees Fahrenheit below zero. Any life forms caught out in the open, or even in the average building will be fast frozen almost instantly!

The Oceans

When the Earth stops its rotation, all the water in the oceans and lakes will continue to travel in the former easterly direction of the Earths former rotational velocity. It is like walking at 5 miles-per-hour with a pan of water and you stop abruptly. The water keeps on going at 5 mph. Just before the reversal, the Earth may only be rotating at 800 mph, instead of the normal 1,000 mph (at the equator), because the rotational rate will have slowed down considerably. I would expect the wave-speed to slow down considerably after the first hour on land. Many factors will determine the speed of the wave, such as land elevation, forest ground cover, gravity and the heat blast from the Sun. Depending on how long the Earth remains at rest will determine how far this immense Ocean wave will travel across the continents. When the Earth resumes rotation it will be in the reverse direction than previous. This action will make the tidal wave appear to once again speed up, but really it's because the Earth would be now rotating in the opposite direction of the wave. I believe it is not unreasonable to assume the speed of this massive tidal wave would average about 350-miles-per-hour. Within a week, this massive ocean wave will have returned to the ocean basins. As it returns, it will naturally follow the river basins leading to the sea, cutting deeper into existing deep-sea canyons. Some deep-sea canyons currently cut down to over 11,000 feet below sea level.

The Rotation of the Earth and Major Earthquakes

The rotation of the Earth should resume within seven or eight hours after the reversal point, but in the opposite direction. Currently the Earth rotates from west to east. After the reversal it will rotate from east to west, so the Sun will rise in the west and set in the east. Not only are the oceans affected by the polar reversal, but also the crust of the Earth. Just as the Oceans "swim" on the crust of the Earth, the crust of the Earth "swims" on the heated-up mantle. The continental plates are also traveling at the Earth's previous rotational velocity at the time of the reversal. They will start banging up against each other thereby causing massive earthquakes lasting for weeks of constant shaking (over eight on the Richter scale) until the plates stabilize. Mountains will be pushed up and some may sink.

Volcanoes

Volcanoes will erupt worldwide because of the increased heat in the Earth's core and mantle, and the pressure put upon the magma chambers in the crust. The dust from many erupting volcanoes will further add particles in the atmosphere, which will help seed the dense clouds already present as a result of the massive evaporation from the nova. The lava and mud flows from these eruptions will also further reshape the surface of the Earth.

The Ice Age Comeith

Within a few days of the nova, it will start raining scalding hot rain, which will turn to downpours of cooler and finally cold rain. Within 10 days it should start snowing worldwide because the Sun will not be giving off enough visible light and heat to warm the Earth. It will continue to snow until all the clouds and moisture are out of the atmosphere. This process may take 22 to 44 or more years. When it is done snowing the Earth will be mostly covered with snow and thick ice in the higher latitudes and or elevations. We will then be in the grips of a full ice age maybe for full 700-years!

What About Life

The effects of the polar reversal on all forms of life, will be devastating. It is not difficult to understand why there is always a mass extinction of all types of species at

the time of the polar reversal. I had heard over the radio that biologists had figured out that there was only 35 fetal females worldwide who survived the last Ice Age. Our job is to survive it, because the alternative is too depressing to think about. You now also understand the importance of what the author has discovered, and why God put the clues of this event within the Torah. If you do not care about yourself than think about your children or grandchildren. They should have a chance to survive this event.

The Moon

The surface on the Moon will receive a dusting of particles and rocks from the Sun, in addition to the accumulation it has received from previous novas. There will be additional small craters from the larger molten glass lumps expelled from the Sun. Immediately after the nova, the Moon will appear red because the nova will turn the surface red hot.

Mars

Now you all know what happened to all the water and oceans on Mars. Over the hundreds of millions of years it lost most of its water and the planet was pushed farther and farther away from the Sun. Guess where the people of Mars immigrated to? I will give you a small hint. The translation of the name Giza means Mars.

The Aftermath

Not all of the Earth will get enough snow to form a glacier. Some areas near the equator will not be in the grips of a full ice age. It should be colder than the last ice age because we will be a little farther away from the Sun. Dense clouds will cover most of the Earth for 22 or more years until all the moisture has been rung out of it. The Glaciers will block rivers and streams and create ice dams that will be present for hundreds of years. When the dams finally collapse they will cause huge floods on the rivers effected. Eleven to twenty-two years after the polar reversal most of the snow and ice by the equators should have melted at the lower elevations (10-15° North and South). Animal life will start to come back in these areas. Small plants and trees will start to again appear. The oceans of the Earth will be over 500 feet below current sea level. Glaciers will be present in both Atlantic and Pacific oceans and extend down to the lower North and South Latitudes. The occurrence of frequent major earthquakes should continue for at least 15 years after the reversal, until the outer mantle of the Earth cools down and the crustal plates stabilize.

Part 1 Impending Solar Flash Event Supported by Scientific Studies and Insider Testimony January 07, 2019



In a six-part series of videos titled <u>Earth Catastrophe Cycle</u>, **Ben Davidson**, founder of *Space Weather News*, presented multiple scientific studies of "micronova" (aka "solar flash") events that recur in human history, and the subsequent <u>pole shifts</u> that haven taken place on a cyclic basis.

The scientific data confirms that micronova events are common occurrences in our galaxy, and such events span Earth's history, are associated with pole shifts, yet the evidence has been suppressed by government authorities for decades.

In <u>part 4 of his video series</u>, Davidson presents scientific studies showing how "micronovas" have been observed occurring in multiple stars by astronomers.

"**Micronova**" is Davidson's term, for a supernova type event that is not large enough to exhaust or destroy the star generating it, but large enough to devastate nearby planets.

He said:

"What is a micronova? It's not a supernova, it's not even really a <u>nova</u>, as it is like the little sister of the nova, one that can affect the entire world but not completely destroy it."

Davidson's video shows evidence that such *micronova events are a <u>cyclic part</u> of the life of a star*, and includes the following list of 10 known recurring nova events observed in the Milky Way:

Davidson referred to a number of sources pointing to *solar flashes* being part of Earth's geological history.

Among these is Dr. **Robert Schoch**, Associate Professor of Natural Sciences at Boston University and author of <u>Forgotten Civilization - The Role of Solar Outbursts in our Past</u> <u>and Future</u>.

In a video interview in part 4 of Davidson's series, Schoch explained that ice core samples from Greenland show that there was a solar burst or flare recorded at the end of the last Ice Age, known as the Younger Dryas, about 9700 BCE.

Schock and Davidson estimated that the micronova event was as much as 40 times the power of the most destructive solar storm observed in modern history, the 1859 Carrington event.

This would make the <u>Younger Dryas</u> micronova as much as an X-100+ solar flare according to the measurement scale currently in use. Quite alarming, especially if this were to repeat any time soon.

The enormous amount of plasma that arrived immediately after the micronova event circa 9700 BCE, bombarded the Earth producing an effect similar to one or more major asteroid impacts.

This has caused confusion and led many archeological researchers into mistakenly

interpreting historic evidence of impacts causing and/or ending the last ice age, as deriving from asteroid impacts rather than plasma discharges.

In his interview and book, Schoch asserts that ancient records are consistent with a solar flash that wiped out an ancient civilization predating the end of the last Ice Age, widely assumed to be **Plato**'s <u>Atlantis</u>.

The scientific data on solar flashes goes back several decades.

Bradley Schaefer, an astrophysicist at NASA's Goddard Space Flight Center, wrote a paper titled, "<u>Flashes from Normal Stars</u>" that appeared in the February 1989 edition of *The Astrophysical Journal*.

He dated the beginning of research into solar flashes to a 1959 study by **H.** Johnson who at the time,

"performed the only study which is capable of detecting rare flashes from normal field stars."

Schaefer examined NASA data on glazing discovered on lunar rocks that was first presented in a 1969 paper by **T. Gold** <u>published</u> in Science who had concluded:

"Some glazing is apparently due to radiation heating; it suggests a giant solar outburst in geologically recent times".

Schaefer agreed with Gold's analysis and reached a similar conclusion:

The existence of a glazing on the top surfaces of lunar rocks has been used as a strong argument for a "solar outburst" where the Sun increased its luminosity by over 100 times for 10 to 100s within the last 30,000 years.

Schaefer went on to describe how such a "solar outburst" (aka solar flash or micronova) could result in an *Extinction Level Event* (Flashes from Normal Stars - page 930):

I crudely estimate that a flash... might result in a major extinction episode. (The Cretatious-Tertiary dinosaur extinctions cannot be explained by a flash since there is no mechanism for enhancing iridium.)

The Sun could have undergone a few (at most) such super flashes in the last 108 year [100,000,000 years]. These data suggest that our own Sun may have a significantly lower event rate than average field stars.

In part 5 of his video series, Davidson interviews solar cycle researcher **Douglas Vogt** who discusses the scientific data that lunar rocks provide hard evidence of solar flashes having occurred in recent geological history. The scientific data compiled by Davidson in his video series is cogent and compelling, yet, it provides no answer to the critical question:

"When will the next micronova or solar flash event occur?"

For a detailed answer, we can turn to the startling testimony of **Corey Goode**, who says he has received intelligence briefings about when the "solar flash" will occur from two independent sources:

- a Secret Space Program Alliance
- an Inner Earth civilization he calls the "Anshar"

Goode says that he served in multiple secret space programs over a 20 year period from 1986 to 2007.

While his claims have been very controversial, my research has found multiple points of corroboration which have been detailed in <u>Secret Space Program Series</u>, including Goode being the first to release two <u>Defense Intelligence Reference Documents</u> that corroborate key elements of his remarkable testimony.

Goode said that scientists from different space programs predicted the solar flash occurring at the end of *Solar Cycle 24* (2008-2018/2019), and that this led to plans for the evacuation of global elites to safe places similar to what was depicted in <u>the movie</u>, '2012.'

In an interview, Goode <u>gave details</u> about what he had been told during a December 2017 visit to a secret moon base called *Lunar Operations Command* [LOC] about multiple solar flash events that have been predicted by different groups and their timing: I have said for a while that I was told that it was not one solar event but a series of events that led up to one large event. During my meeting on the LOC...

I was told that the Elite had expected the final "solar sneeze" [solar flash] to occur at the end of this Solar Minimum period (2018/2019 from their estimates).

"Are we officially in Solar Minimum?" was the question of one of the people present.

To my dismay that question went unanswered as the people being briefed were paying very close attention to this particular topic.

The Elite began moving underground in large numbers based on this probable timeline.

The "Programs" had used probable future technology to nail down the time of Alien and Suppressed Technology Disclosure and The Solar Event. None of them agreed on what the Solar Event would be as many thought it would be a flash that would turn them into ascended light beings while others expected it to be a terrible day for the planet Earth...

The "Egg Heads" and the Smart Glass Pads described all of this occurring in the 2018-2023/24 time window.

Goode said that he also received information from another source, <u>the Anshar</u>, who claim to be the descendants of time travelers from our future.

This meant that their ancestors had lived through the upcoming solar flash event(s) and passed down its effects through historical records, which were carried into the Earth's distant past by the Anshar to maintain the current timeline.

Goode explains what the Anshar had told him:

The flashes (not necessarily all flashes are visible) that have been occurring will build up to one large solar event.

The Anshar described a major Solar Event in their past (Our Future?) that was very much like the *"full circumference mass coronal ejection"* that I described being one of the scientific theories about the Solar Event.

They described the solar blast being so powerful that it caused a physical pole shift on the Earth of several degrees.

They described the atmosphere being breached by the CME [Coronal Mass Ejection] in the Northern Hemisphere which caused massive fires that wipe out a large area and in doing so knocks out all technology on the planet.

There was a fair amount of loss of life in the actual event.

Goode's information is very helpful since it provides intelligence data from secret space program scientists and Inner Earth beings that are monitoring solar activity, and are also aware of records detailing solar flashes or micronova from Earth's history.

This complements the scientific data compiled by Davidson which substantiates micronovas as a recurring phenomenon for many stars in our galaxy, including our own Sun.

This take us to another key element of Davidson's *Earth Catastrophe Cycle* series (below video), which Goode's classified sources provide complementary information.

This concerns the predicted micronova or solar flash being a trigger for a <u>geophysical</u> <u>pole shift</u> that could be catastrophic for many regions of the planet.

Part 2

Massive Pole Shifts are Cyclic according to Declassified CIA Document January 09, 2019



Ben Davidson, founder of *Space Weather News*, began his six part Earth Catastrophe Cycle video series by discussing a 57 page booklet called "<u>The Adam and Eve Story</u>" authored by "**Chan Thomas**", which was classified by the CIA at some point after its 1963 publication, and declassified in part on June 24, 2013 with the release of a sanitized digital version on the CIA's website.

Thomas' analysis of cyclic pole shifts was different in key respects to what was being proposed at the time by **Charles Hapgood** in his seminal book, <u>The Earth's Shifting</u> <u>Crust</u> (1958).

According to Davidson, it was Thomas more accurate explanation for how a pole shift happens, which led to the CIA classifying Thomas' book.

The *Adam and Eve Story* was first published in 1963 by **Emerson House**, with a third edition published in 1965, and then republished by Bengal Tiger Press in 1993.

It is not clear when, why and how the CIA classified Thomas book, but the fact that the CIA chose to release a declassified sanitized version in 2013 is very significant.

<u>In part 1</u> of his video series, Davidson contrasts Hapgood's wandering pole hypothesis with the pole shift described in the CIA suppressed book by Thomas.

Hapgood wrote of a pole shift of up to 40 degrees that could recur every 5000 years or

so in *The Earth's Shifting Crust* where earlier geographical poles would wander on the Earth's surface with each crustal displacement.

Instead, Thomas wrote of a massive shift of almost 90 degrees (<u>The Adam and Eve</u> <u>Story</u>) that would move both poles into the tropics in less than a day, and then back to their earlier polar positions after the next cycle:

In $\frac{1}{4}$ to $\frac{1}{2}$ a day the poles move almost to the equator, and all hell lets loose.

The atmosphere and oceans don't shift with the shell - they just keep on rotating West to East - and at the equator that speed is 1000 miles per hour. It has to be, normally, to make one rotation per day.

So, while the shell shifts with the poles going toward the equator, the winds and oceans go eastward, blowing across the face of the earth with supersonic speeds, inundating continents with water miles deep....

You can see, then, that *ice ages* are not a matter of advancing and retreating ice.

It's simply that different areas of the Earth are in polar regions at different times, for different durations of time, with the changes between positions taking place in a fraction of a day.

[The Adam and Eve Story, pp.13-14]

Thomas provided a table illustrating how the North pole, for example, would switch back and forth between northern hemisphere regions after experiencing close to a 90 degree tilt.

It is Thomas' conclusion of cyclic pole shifts of almost 90 degrees that flip the poles back and forth over millennia that Davidson identified as the key reason the CIA classified Thomas' work.

If the North and South poles flipped back and forth 90 degrees, there would be little evidence of previous pole shifts since these would be buried under thick layers of ice.

This takes us to the science of *paleomagnetics* - the study of the record of the Earth's magnetic field in rocks, minerals or archeological materials - which has been used to determine the historic movement of the Earth's magnetic poles.

Davidson cited a number of scholarly articles which studied paleomagnetic data from volcanic hotspots.

A highly regarded 1985 paleomagnetic study titled, "<u>True polar wander - An analysis of</u> <u>Cenozoic and Mesozoic paleomagnetic poles</u>" found,

"the pole has moved 22 deg + or 10 deg in the past 180 m.y. [million years]." This was far less than the 40 degree wandering pole hypothesis that Hapgood proposed in an approximate 5000 year period.

A subsequent 2001 study titled "<u>Stability of the Earth with respect to the spin axis for the</u> <u>last 130 million years</u>" concluded that,


"the time-averaged position of the spin axis has deviated by no more than 5° over the last 130 million yr, indicating that mantle mass heterogeneities have not changed rapidly enough to drive TPW [True Polar Wander]."

Davidson cited these and a 2018 study as the key elements of the body of scientific evidence refuting Hapgood's wandering pole hypothesis.

However, as Davidson <u>pointed out</u>, the scientific data from paleomagnetic studies did not address Thomas' theory of the poles flipping back and forth over geologic time, thereby giving the appearance that the poles had not moved over millions of years as researchers had mistakenly concluded:

All work crushing the theory utilizes these flawed studies, especially the long term average pole position and none address the problem of a *ping pong shift* where you would have that time average pole position appearing to be in the same position over millions of years.

Davidson goes as far as suggesting that Hapgood, who worked for the CIA's predecessor the *Office of Strategic Services* during World War II, conducted a "limited hangout" with his 1958 book to get some of the truth out into the public arena, but doing so in a way that could be eventually discredited.



Davidson cited a 1994 book titled <u>World in Peril</u> about the once classified information provided by an Arctic polar explorer, Major **Maynard White**, who told his son, **Ken** (the book's author), about secret Pentagon meetings in 1948 where suppression of evidence of cyclic pole shifts was discussed:

At one of the scientific meetings that Major White attended in the Pentagon in early 1948, the scientists discussed the advisability of alerting the public to the pending polar-flip phenomenon.

None of the scientist would agree to withhold the information from the public, but, on the other hand, neither could they agree on how to release it. The knowledge of this phenomenon, some felt, could in itself destroy the moral fiber of society.

Their fears were apparently unfounded when, in the early 1950s, information about the flip phenomenon was released in both a newspaper column and a magazine article, but surprisingly generated no responses from an apparently stunned parochial or incredulous public.

Given the amount of scientific data presented by Davidson in his Earth Catastrophe Cycle series, it's clear that physical pole shifts of approximately 90 degrees have been historically recorded, and that this became known to government authorities as early as 1948.

This takes us to the critical question:

"What is the trigger for a geophysical pole shift?"

Hapgood, along with **Albert Einstein**, who wrote the *Preface to Hapgood's 1958 book*, believed that the accumulation of ice at the North and South poles would be the trigger for a crustal displacement (geophysical pole shift).

Einstein explained the triggering mechanism as follows: In a polar region there is continual deposition of ice, which is not symmetrically distributed about the pole.

The earth's rotation acts on these unsymmetrically deposited masses, and produces centrifugal momentum that is transmitted to the rigid crust of the earth.

The constantly increasing centrifugal momentum produced in this way will, when it has reached a certain point, produce a movement of the earth's crust over the rest of the earth's body, and this will displace the polar regions toward the equator.

Davidson asserts in part 1 of his series that Einstein eventually broke with Hapgood when he realized that the amount of ice at the poles would be insufficient to trigger a crustal displacement as he had earlier concluded from Hapgood's data.

In contrast to Hapgood, Thomas believed the explanation was that something in the Earth's interior was occurring that was the triggering mechanism.


Thomas wrote:

...once every few thousand years neutral matter escapes from the 860-mile [1385 km] radius inner core into the 1300-mile [2092 km] thick molten outer core, and there is a literal atomic explosion inside the Earth.

The explosion in the high energy layer of the outer core disrupts completely the electrical and magnetic structure in both the molten outer core and the outer 60-mile thick molten layer.

Finally, the ice caps are allowed to pull the shell of the earth around the interior, with the

shallow molten layers lubricating the shift all the way. [The Adam and Eve Story, p.14]



Thomas likens the *"neutral matter"* escaping Earth's inner core to the plasma in a solar burst since these are based on what he claimed was the same governing universal principle found in the atom and galaxies.

Consequently, Thomas is suggesting that the triggering mechanism for the Sun emitting a solar flash or micronova, is similar to what triggers the Earth's inner core to release waves of energy that ultimately shift both the magnetic and physical poles by as much as 90 degrees, in a cyclic pattern.

In *'World in Peril'*, the triggering mechanism is described as a flip in the Earth's magnetic field as <u>cited</u> by Davidson:

It was determined through repeated experimentation that as the *"magnetic pole approached the geographic pole,"* the *"magnetic"* pole would at some point accelerate its rate of convergence as though pulled toward the *"geographic"* pole by centripetal force and jump to coincide.

But instead of the poles coinciding, the *"magnetic"* pole would rapidly *"flip"* around the *"geographic"* pole, them spin off towards the equator as though by centrifugal force, ending up at a position where the two axes assumed an approximate 89-degree divergence.

After this polar *"flip"* occurred, the axes would then gradually begin to reconverge over a long period of time.

According to the classified information received by Major White and his USAF Arctic reconnaissance unit, the magnetic pole flip would be the trigger for a crustal displacement leading to an almost 90 degree geophysical pole shift, as explained in the description to the *'World in Peril':*

'World in Peril'... provides an explanation, based on the unit's findings, of how Pentagon scientists determined our globe has evolved in prehistory, and how another earth-reshaping cataclysm is imminent!

Now we can understand why mammoths and mastodons found in the arctic permafrost had been instantaneously frozen with subtropical vegetation in their mouths and stomachs.

'World in Peril' may be the only book in print that accurately explains the elusive triggering mechanism for the phenomena known to scientists for over 200 years as "crustal shift," and what it implies.

It's important to emphasize the complementary nature of the triggering mechanisms found in Thomas' '*The Adam and Eve Story*' and White's information in '*World in Peril*'.

White essentially described an internal geological process by which a magnetic pole flip would lead to a crustal displacement so the two sets of poles (magnetic and geophysical) would briefly realign at opposite ends of the equator.

The magnetic poles would then gradually realign with the new geophysical North and South poles until the cycle repeated itself with the former geophysical poles flipping back to their former positions.

Some unknown event inside the Earth would trigger both the magnetic pole flip and the crustal displacement according to the information acquired by White, and had been suppressed by national security officials.

Thomas' book explains the internal mechanism which triggers the pole shifts.

The neutral matter he described is basically the functional equivalent of a micronova or solar flare being emitted by the Earth's inner core. Consequently, any evidence of the Earth's interior generating something analogous to increased solar activity is an important clue to a pole shift occurring in the near future.

Davidson's six part series makes a cogent case for a connection between cyclic micronovas and historic pole shifts of almost 90 degrees, which occur in a back and forth flipping action making it appear that the present poles have been in their respective positions for millions of years, as paleomagnetic studies have mistakenly

concluded.


Furthermore, his emphasis on the information proposed by Thomas and White as crustal displacement being triggered by internal geological events, rather than external events such as accumulation of ice at the poles, leads to a correct focus on something happening inside Earth's molten core.

The historic data and analyses presented by Davidson point to something simultaneously triggering eruptions of *"neutral matter"* from the inner Earth core, and from the Sun in the form of micronovas.

This takes us finally to the role played by cosmic rays as the elusive trigger mechanism, and recent scientific data showing these recently emerging out of Antarctica and a possible connection to mysterious global seismic waves.

Part 3

Cosmic Rays as Triggers for Solar Flashes, Earth Core Eruptions and Pole Shifts January 16, 2019



On January 11, one of the world's top science journals, *'Nature'*, reported an <u>unexpected acceleration</u> in the movement of the Earth's magnetic poles that has required an immediate update of the *World Magnetic Model* (<u>WMM</u>) used for global navigation by ships at sea, Google Maps and smartphones.

Scientists have speculated that the unexpected acceleration is due to,

"liquid iron sloshing within the planet's core", and that in the case of the north magnetic pole, the likely culprit was a "high-speed jet of liquid iron beneath Canada moving the pole towards Siberia".

Importantly, scientists widely agree that the acceleration in the movement of the magnetic poles points to something very unusual happening in the Earth's outer core which is filled with a nickel-iron alloy surrounding a solid inner core of iron.

In <u>part 2</u> of this series of articles investigating issues raised by Ben Davidson in his <u>*Earth Catastrophe Cycle video series*</u>, I discussed a CIA document authored by a geologist, **Chan Thomas**, that was only declassified in 2013.

Thomas hypothesized that the inner core of the Earth, behaves just like a star in terms of emitting plasma or *"neutral matter"* in periodic bursts every few thousand years into the outer core, thereby triggering both magnetic and geophysical pole shifts.

In <u>part 1</u>, I examined evidence of *solar flash* (aka *micronova*) events in history, and the prospects for one recurring in the near future. This raises the possibility of the connection of some kind between solar flash events and *"neutral matter"* eruptions that occur deep inside the Earth's core.

In this article, I examine whether *high energy cosmic rays* from outside our solar system are the trigger mechanism for both solar flashes and neutral matter eruptions that lead to pole shifts.

It's important to first point out that the accelerated movement of the magnetic poles is happening at a time when the Earth's magnetic field is weakening and the <u>Solar</u> <u>Minimum</u> (low sunspot activity) have both made the planet more susceptible than ever to cosmic rays.

<u>Cosmic rays</u> are the atomic nuclei of hydrogen, helium and larger molecules that have been stripped of their electrons. They have been generated from galactic events such as supernova and quasars, and travel throughout the universe at almost the speed of light.


While our Sun also generates cosmic rays, it is the cosmic rays from the galactic core that carry the most energy as they penetrate deep into our solar system, into our Sun, and finally into the Earth's interior.

Cosmic rays are impacting both the Earth and the Sun with increasing impact because the energy shield created by the solar wind is at its weakest level as a result of the current solar minimum.

Some scientific models predict the *solar minimum will continue until October 2020*, and may even *stretch out into a <u>grand solar minimum</u> lasting until 2070*, during which time humanity witnesses a <u>mini-ice age</u> similar to the <u>Maunder Minimum</u> that occurred from

1645 to 1715.

Scientists have for decades tracked solar and cosmic ray activity and confirmed that cosmic rays peak during solar minima as shown in the following diagram.



Top graph shows solar cycles and bottom shows cosmic ray activity during the same period

The intensity of cosmic rays impacting our solar system and the Earth depends largely on the strength of the solar wind generated by our Sun which acts as a shield as <u>explained</u> by NASA:

Our first line of defense is the Sun:

The sun's magnetic field and solar wind combine to create a porous 'shield' that fends off cosmic rays attempting to enter the solar system.


The shielding action of the Sun is strongest during Solar Maximum and weakest during Solar Minimum.

NASA studies have confirmed that cosmic rays, during a solar minimum increase the radiation exposure of astronauts thereby shortening the time they can spend in Earth orbit.

It is worth emphasizing that cosmic rays typically are either deflected by the Earth's magnetic field (magnetic field) or attracted by the field towards the polar regions where most of the world's cosmic ray detectors have been assembled.

Studies have shown the Earth's magnetic field, which acts as the second line of defense against cosmic rays, as well as being a shield against the solar wind, has been steadily weakening throughout the 20th century.

Since the year 2000, however, the weakening has dramatically increased as illustrated in the following image provided by Davidson in his *Earth Catastrophe Cycle* series.

The weakening of the magnetic field has led to some scientists concluding that this is a prelude to a *magnetic pole flip*.

In 2014 **Rune Florberghagen**, the mission manager of the *European Space Agency's* <u>Swarm project</u>, confirmed that the Earth's magnetic field was weakening 10 times faster than normal, and that this was a sign of a future magnetic pole flip.

Florberghagen said that this,

"would take many hundreds if not a few thousand years... They have happened many times in the past."

However, other scientists studying paleomagnetic data cut the time dramatically in Florberghagen's estimate.

A <u>Berkeley University study</u> said that the pole flip could happen in less than a century, anytime during our life-time.


The dramatic weakening of the magnetic field means that fewer cosmic rays are being deflected, and more of these have been absorbed into the Earth, especially at the polar regions where the magnetic field lines attract cosmic rays into the North and South magnetic poles.

This raises important questions about what scientists have recently discovered about the unexpected acceleration in the movement of the magnetic poles, and what we know about the increasing influence of cosmic rays during a solar minimum that may extend well beyond the projected 2020 start of <u>solar cycle 25</u>.

- First, are cosmic rays entering the Earth's magnetic field at the polar regions penetrating deep into the Earth's interior, thereby impacting the molten outer core in some way?
- Second, were cosmic rays recently detected coming out of Antarctica, in any way related to the "neutral matter" eruptions described by Chad Thomas?
- Finally, were the mysterious seismic global waves detected on November 11, 2018, in any way related to neutral matter eruptions from the core, and/or cosmic rays?

Are Cosmic Rays Affecting the Earth's Interior?

The widespread assumption about cosmic rays is that these are absorbed by the Earth's atmosphere as they impact air molecules, which in turn are rapidly accelerated and impact other molecules in cascade effect as the following diagram illustrates.

Several studies have shown, for example, that cosmic rays impact cloud formation leading to greater cloud covers during solar minima.

While the energy of cosmic rays is absorbed by other particles when they collide in the Earth's atmosphere, these "cascade particles" take on the momentum and energy of the cosmic rays and reach the Earth's surface, and along with surviving cosmic rays, penetrate into the Earth's crust extending the cascade effect deep into the earth's mantle and eventually reaching the core.

Sub-atomic particles which are created as a byproduct of the collision of cosmic rays and air molecules, such as <u>muons</u> and <u>neutrinos</u>, more easily penetrate into the Earth's mantle and core due to their smaller cross section.

The impact of cosmic rays through their cascading effect can be visualized as a shotgun blast that carries the energy of the primary cosmic rays deep into the Earth's interior through *"cascade particles"* and their sub-atomic byproducts.

The penetration of cosmic rays into the Earth's surface has had the effect of triggering seismic activity and volcanic eruptions, as confirmed by a team of four Japanese scientists.

In a June 2011 study of 11 volcanic eruptions titled "<u>Explosive volcanic eruptions</u> triggered by cosmic rays", the scientists found that cosmic rays were a factor in triggering nine of the eruptions:

It is well known that the cosmic-ray flux is negatively correlated with solar magnetic activity, as the strong magnetic field in the solar wind repels charged particles such as galactic cosmic rays that originate from outside of the solar system.

The strong negative correlation observed between the timing of silica-rich eruptions and solar activity can be explained by variations in cosmic-ray flux arising from solar modulation.

The Japanese study confirms that cosmic rays, through their cascade effect, do have an influence inside the Earth's interior.

The critical question is:

"How deep into the Earth's interior do cosmic rays penetrate?"

Studies show that the energy transmitted by cosmic rays can be carried deep into the Earth's interior:

During solar minimum high energy cosmic radiation can penetrate to a very deep distance below the Earth's surface, in some case a few hundred kilometers.

This is the reason why most if not all earthquakes during solar minimum are deep earthquakes.

This takes me back to **Chan Thomas** and his claim that the Earth's core periodically releases *"neutral matter"* every few thousand years, and that the Sun experiences a solar flash in a similar millennia long cycle.

Cosmic rays have the capacity to not only interact with the Sun in a way that ultimately triggers a micronova, but they also interact with the Earth's core in a way that triggers the emission of *"neutral matter"* as Thomas' book claims.

If the Earth's core is being stimulated by cosmic rays into emitting neutral matter in analogous manner to a Coronal Mass Ejection by the Sun, is there any evidence of this occurring?

The most compelling sign would be if the Earth's core, like <u>the Sun</u>, was observed to be emitting cosmic rays. Indeed, this has occurred with cosmic ray detectors discovering cosmic rays *coming <u>out</u> of the Earth*, rather than penetrating into it.

Cosmic rays observed to be *coming out* <u>of Antarctica</u> were <u>first detected</u> in January 2007 when the Antarctic Impulsive Transient Antenna (ANITA) balloon experiment

began, as explained by the science writer, Emma Fiala:

Using sensors, ANITA began detecting high energy neutrinos interacting with the ice sheet below...

During ANITA's time in the Antarctic, it detected never before seen *"upward-pointing cosmic-ray-like events."* The rays detected had horizontal planes of polarization, which may suggest they didn't originate in space.

Cosmic rays coming out of the Antarctic ice sheets were observed again by ANITA in December 2016 and sparked intense scientific speculation over whether a new type of particle had been discovered.

This led to a team of scientists at Penn State University studying the ANITA data, and on September 25, 2018, releasing released their report about the anomalous 2007 and 2016 events which was <u>published</u> on the scholarly archive, arxiv.org:


The ANITA collaboration have reported observation of two anomalous events that appear to be $\epsilon cr \approx 0.6$ EeV cosmic ray showers emerging from the Earth with exit angles of 27 and 35, respectively...

We explore here whether "beyond the Standard Model" (BSM) particles are required to explain the ANITA events, if correctly interpreted, and conclude that they are.

Seeking confirmation or refutation of the physical phenomenon of sub-EeV Earthemergent cosmic rays in data from other facilities, we find support for the reality of the ANITA events, and three candidate analog events, among the Extremely High Energy Northern Track neutrinos of the <u>Ice Cube Neutrino Observatory</u>.

It should be noted that on both January 2007 and December 2016, the sunspot numbers were respectively at or near the solar minimum for sunspot activity.

Consequently, it should be noted that at the same time as cosmic rays were peaking as they were coming into our solar system due to minimal solar activity, that Cosmic-like rays were observed to be coming out of the Earth.

This is consistent with the earlier observation that cosmic rays were penetrating deep into the Earth and triggering the neutral matter ejections into the outer core, which in turn stimulated what might be described as *"Earth cosmic rays"* that were detected by ANITA.

This takes me to the mysterious seismic global wave detected on November 11, 2018, 15 miles off the coast of Mayotte, a French island between Madagascar and Africa.

On that day, a seismic wave was detected that travelled around the world for about 20 minutes.

While seismic waves routinely follow earthquakes, there was no earthquake detected by seismographs as explained in an article (<u>Strange waves rippled around the world, and nobody knows why</u>) published by '*National Geographic*'.

Based on the earlier cited 2011 study by Japanese scientists one explanation that arises is that the global seismic wave was caused by cosmic waves penetrating into the Earth's interior.

Another, more disturbing explanation is that the mysterious global seismic waves were a result of unique *"Earth cosmic rays"* emanating from a neutral matter ejection analogous to a coronal mass ejection first described by Thomas.

Conclusion

The accelerated movement of the magnetic poles is a sign that something significant is currently happening deep inside the Earth's interior, at its molten outer core.

The conventional explanation that this pole shift is merely a result of magma moving in the outer core portion under North America does not factor in the important role played by cosmic waves in penetrating deep into the Earth and influencing the core's activity.

The fact that cosmic rays are pouring into the Earth due to a *weakened magnetic field* and *solar minimum*, and this may be triggering an ejection of neutral matter from the Earth's core into the mantle and surface, needs be seriously considered.

Furthermore, the fact that the CIA classified Thomas' book (<u>The Adam and Eve Story</u>) sometime after its 1963 publication and only declassified it in 2013, suggests that his concepts and theory of the dynamics of the inner Earth and associated pole shifts needed to be suppressed since they contained important truths that could destabilize society.

At this time in our collective history, as cosmic rays are impacting our planet at increasing levels, we need to better understand how cosmic rays influence both our planet and the Sun during its period of minimal solar activity.

We need to pay particular attention to evidence that *our solar system has entered a region of the galaxy with increased levels of cosmic ray energy*, and how this might trigger the solar flashes (micronovas) and geophysical pole shifts that occurred in our distant past.

I got this anonymously today in email. It's obviously the result of a whole lot of groundwork, so to speak, by a lot of people, perhaps including Constitutional Unorganized Militia members in various states. This is quite timely, perhaps, as the new Earth-pipes show some promise for neutralizing the predatory aspects of these facilities cheaply and efficiently. We normally locate underground bases by the smog fields that they produce above ground. This happens because nuclear generators produce dense deadly orgone radiation (DOR) which forms smog by positive-charged ionization. Smog is nothing but filth in colloidal suspension in the atmosphere. The various colors of smog are determined by what kind of filth is available.

The earth-pipes are still in the experimental stage, but Carol and I intend to test them on the main U/G base near Dulce, NM, next month and meanwhile, our network is testing them on U/G bases closer to our homes and pooling the empirical data. For example, Carol, Laozu Kelly, and I planted six Earth pipes on the base near Joseph, Oregon a

couple of weeks ago and Kelly and McGinty are perhaps on their way there to check the results today. Both of those fellows are energy sensitives who are reasonably unbiased, so their observations are very useful.

The Earth-pipes may promise to be an excellent alternative for underground targets to the 3oz Tower busters and the 12oz Holy Hand grenades because a much smaller amount of orgonite can get a much more dramatic result underground, thanks to the use of the copper pipe. It's similar to the way a cloud buster can draw in DOR from the atmosphere for many miles around and it may be another step toward what Dr. Grebbenikov was able to achieve with resonant chambers alone (antigravity flight and time/space manipulation). The trend in spiritually-resonant science it to do more and more with less and less. I don't think we'll be like the dolphins in this lifetime but I do believe that they're the living standard for us in 3D.

Having finally busted the underground base complex around Fallon, Nevada, last summer with Dodeca Richard, we'll have a good test bed for busting a similar-sized major underground facility. It took several visits by several people to entirely do that complex and we used about 30 gallons of orgonite before every trace of DOR was absent from the atmosphere. I expect we could have done the entire thing in a day or two with a couple of gallons or less of orgonite if it were used in the form of Earth-pipes, but we'll soon see if my hunch pans out.






These beneath ground projects begin in the \$million-dollar+ and up range. Doug Vogt in one of his videos stated that the elite have not factored in that when the next ice age hits, these people may well find themselves buried beneath thousands of feet of an ice sheet, in some areas more than a mile deep/thick! Over the past two decades many of us have been watching and reading about an interesting seed bank located just above the Arctic Circle in Norway.

Far up in the Arctic, a seed bank chiseled into the hill side of a former coal mine mountain received 60,000 seeds of different crop varieties not too long ago as part of its mission to safeguard the world's food supply.

The Svalbard Global Seed Vault, located on Norway's Svalbard archipelago, received the seeds from 35 institutions during the landmark deposit. The seed bank now holds more than 1 million seeds, representing more than 5,000 crop species from 85 different depositors.

In 1984, the Nordic Gene Bank (now NordGen) began storing backup Nordic plant <u>germplasm</u> via frozen seeds in an abandoned coal mine outside of Longyearbyen. In 2001, the <u>International Treaty on Plant Genetic Resources for Food and Agriculture</u> (<u>ITPGRFA</u>) was adopted and national governments began to ratify the Treaty soon after. The Treaty establishes a multilateral system for plant genetic resources that includes providing access to the materials and providing mechanisms so that those who use the resources can share any derived benefits.

A team led by conservationist Cary Fowler, in association with <u>CGIAR</u>, actively campaigned for the development of the Seed Vault and approached the Norwegian Government. They conducted a feasibility study in 2004 and concurred that Svalbard was an appropriate location for long-term storage.

Also in 2004, the ITPGRFA entered into force and created the legal framework for having one international security facility. The FAO <u>Commission on Genetic Resources</u> for Food and Agriculture endorsed the initiative¹ and in October 2004 the Norwegian Government committed to fund the Seed Vault and begin the construction.

The Seed Vault officially opened on February 26, 2008, although the first seeds arrived in January, 2008. As part of the Seed Vault's first anniversary, more than 90,000 food crop seed samples were placed into storage, bringing the total number of seed samples to 400,000. Among the new seeds included were 32 varieties of potatoes from Ireland's national gene banks and 20,000 new samples from the U.S. Agricultural Research Service. Other seed samples came from gene banks in Canada and Switzerland as well as international gene banks in Colombia, Mexico and Syria. This 4 t (3.9-long-ton; 4.4-short-ton) shipment brought the total number of seeds stored in the Seed Vault to over 20 million. As of this anniversary, the Seed Vault contained samples from approximately one-third of the world's most important food crop varieties. Also as part of the anniversary, experts on food production and climate change met for a three-day conference in Longyearbyen. In 2010, a delegation of seven U.S. congressmen handed over a number of different varieties of chili pepper.

By 2013, approximately one-third of the genera diversity stored in gene banks globally was represented at the Seed Vault.

In October 2016, the Seed Vault experienced an unusually large degree of water intrusion due to higher than average temperatures and heavy rainfall. While it is common for some water to seep into the Seed Vault's 100 m (328 ft) entrance tunnel during the warmer spring months, in this case the water encroached 15 m (49 ft) into the tunnel before freezing. The Seed Vault was designed for water intrusion and as such the seeds were not at risk. As a result, however, the Norwegian public works agency Statsbygg completed improvements to the tunnel in 2019 to prevent any such intrusion in the future, including waterproofing the tunnel walls, removing heat sources from the tunnel, and digging exterior drainage ditches.

For the Seed Vault's 10th anniversary on 26 February 2018, a shipment of 70,000 samples was delivered to the facility, bringing the number of samples received to more than one million (not counting withdrawals).

According to 'The Independent', as of March 2020, the COVID-19 pandemic does not pose a risk to the vault "as there are no permanent staff at the Svalbard facility."

As of June 2021, the Seed Vault conserves 1,081,026 distinct crop samples, representing more than 13,000 years of agricultural history.

In 2019, the seed vault cost about 2.4 million kr (U.S. \$282,000) to maintain.

Against the backdrop of the spreading fear about a global coronavirus pandemic, an event has slipped largely under the radar at a spot so removed from the rest of the world that most are unaware of its existence. The Svalbard *"Doomsday"* Seed Vault on Spitsbergen Island north of the Arctic Circle just received an additional major shipment of plant variety seeds for its special storage. What makes this entire seed bank enterprise suspicious at the very least is the list of financial sponsors behind the global project.

On February 25 more than 60,000 new seed varieties were placed in the Svalbard vault, the largest deposit of seeds since it opened. This brings the total of seed types to over one million since the vault was first opened for deposits in early 2008.

The latest seed deposits include onions from Brazil, guar beans from central Asia, corn seeds sacred to the Cherokee nation and wildflowers from a meadow at Prince Charles's home in the UK (sic). The Svalbard vault is on the island that is legally part of Norway since a 1925 treaty. The Norwegian government put up much of the money for the construction of the facility whose backers declared it was able to withstand a nuclear bomb blast. The only problem was planners did not make the structure, built into a

mountain side, waterproof and the entrance flooded amid heavy rains in 2016, necessitating a major €20 million of repairs and upgrade which were just completed, some four years later. Notably, as Norwegian Prime Minister Erna Solberg pointed out during the recent seed-greeting ceremony, the year 2020 is slated as the year by which countries should have safeguarded genetic diversity of crops to meet the UN goal of <u>"eliminating hunger by 2030."</u> The year 2030 is when the UN IPCC predicts catastrophic climate change barring a radical action from the world, as well as the key benchmark year for the UN's Malthusian Agenda 2030.

The publicly-stated argument for the major seed bank project is supposedly as a safe backup for the numerous national seed bank collections in event they are destroyed in war as in Syria or Iraq, or by natural disaster or other calamity. The Svalbard vault has been called the *"Noah's ark of seeds,"* there should a *"global catastrophe"* occur, to allow a theoretical restart to world agriculture. That sounds OK and interesting. Who would decide how to distribute those seeds in event of such a catastrophe is not addressed.

What is notable is the list of those backing this highly unusual public-private partnership. The seed bank and acquisition of the seeds is managed by an entity known as the Crop Trust, officially known as the Global Crop Diversity Trust, now based in Bonn, Germany. On its website Crop Trust makes the modest claim that their "sole mission is to ensure humanity conserves and makes available the world's crop diversity for future food security."

It has an impressive list of financial sponsors which it calls the Donors' Council. Among the most eye-catching they name Bayer Crop Science, which now incorporates Monsanto; DuPont Pioneer Hi-Bred; Syngenta AG, now owned by ChemChina. These are the world's largest purveyors of GMO patented seeds and the paired agrichemicals such as Roundup with glyphosate. China's now state-owned Syngenta is the world's largest supplier of crop chemicals.

In addition, Crop Trust Donors include the Bill and Melinda Gates Foundation, the major donor to initiate the Trust in 2004 with the FAO, the United Nations Food and Agriculture Organization and CGIAR, acting through Bioversity International. The Bill and Melinda Gate Foundation raises suspicion as to their real motives given what we know of their past activities in the eugenics movement.

Gates Foundation is joined at Crop Trust by the Rockefeller Foundation, the ones who first financed the creation of GMO biotechnology beginning in the 1970's at their International Rice Research Institute, where they spent millions trying to develop the colossal failure called Vitamin A-enhanced Golden Rice. CGIAR, set up in 1972 by the Rockefeller Foundation and Ford Foundation to spread their Green Revolution agribusiness model, controls most of the private seed banks from the Philippines to Syria to Kenya. In all, these present seed banks hold more than six and a half million seed varieties, almost two million of which are 'distinct.' Svalbard's Doomsday Vault has a capacity to house four and a half million different seeds.



At the time the Svalbard Doomsday Seed Vault opened in 2008 the chairman of the Crop Trust was Canadian Margaret Catley-Carlson. Catley-Carlson was also president until 1999 of the New York-based Population Council, John D. Rockefeller III 's population reduction organization, set up in 1952 to advance the Rockefeller family's eugenics program under the cover of promoting *"family planning,"* birth control devices, sterilization and *"population control"* in developing countries. Catley-Carlson also sat on the board of the Syngenta Foundation.

Being President of the Rockefeller-founded Population Council is no minor deal. In the 1990's the UN's World Health Organization launched a campaign to vaccinate millions of women in Nicaragua, Mexico and the Philippines between the ages of 15 and 45, allegedly against Tetanus, a sickness arising from such things as stepping on a rusty nail. The vaccine was not given to men or boys, despite the fact they are presumably equally as liable to step on rusty nails as women.

Because of that curious anomaly, Comité Pro Vida de Mexico, a Roman Catholic lay organization, became suspicious and had vaccine samples tested. The tests revealed that the Tetanus vaccine being spread by the WHO– only to women of child-bearing age- contained human Chorionic Gonadotrophin or hCG, a natural hormone which when combined with a tetanus toxoid carrier stimulated antibodies rendering a woman incapable of maintaining a pregnancy. None of the women vaccinated were told.

It later came out that the Rockefeller Foundation along with the Rockefeller's Population Council, the World Bank (home to CGIAR), and the United States' National Institutes of Health had been involved in a 20-year-long project begun in 1972 to develop the concealed abortion vaccine with a tetanus carrier for WHO. In addition, the Government of Norway, the host to the Svalbard Doomsday Seed Vault, donated \$41 million to develop the special abortive Tetanus vaccine.

Is it just coincidence that the same Gates Foundation is backing the organization responsible for maintaining the Svalbard "*Doomsday*" Seed Vault at the same time Gates is emerging as a major authority on the danger of the Wuhan coronavirus epidemic? In an article he wrote for the 'New England Journal of Medicine', Gates stated that the designated COVID19, "has started behaving a lot like the once-in-acentury pathogen we've been worried about."

A virtually inaccessible seed vault under the control of some of the world's foremost advocates of eugenics and population reduction is definitely remarkable. With more than a million of the irreplaceable seed heritage of the world locked inside the Svalbard Seed Vault, could this be a way for GMO agribusiness giants like Bayer-Monsanto or Syngenta to illegally gain access to those seeds in a time of global crisis? It sounds very far-fetched, yet there are far-fetched goings on in our world. We could say, *"He who controls the world's crop seeds, controls the world."*

The seeds represent widely grown vegetables and herbs, as well as obscure plants and wild varieties, according to the Global Crop Diversity Trust. The Cherokee Nation in the United States deposited squash and beans, the United Kingdom delivered wild oats and barley, and 68 types of rice came from Thailand. The World Vegetable Center handed over seeds for quirky-sounding crops like snake gourd and butterfly pea.

The deposit event was hosted by Erna Solberg, prime minister of Norway and Nana Addo Dankwa Akufo-Addo, president of Ghana, both of whom are co-chairs of the United Nations group of sustainable development goals (SDG) advocates.

"This deposit event is especially timely, given that 2020 is the deadline for meeting target 2.5 of SDG 2 on zero hunger, which calls on the international community to safeguard the genetic diversity of crops and livestock," Solberg said in a statement.

The deposit was the largest to date in terms of the number of institutions involved and is the first since a major update to the facility in 2019, following structural damage when permafrost in the region unexpectedly melted and flooded its entrance. *"The seed vault is a backup,"* Cierra Martin, communications officer at the Global Crop Diversity Trust, an organization that supports seed banks, told Global Citizen. *"It acts as a safety deposit box, only depositors can take seeds out."*

Organizations that collect seeds around the world can store them in Svalbard for safekeeping.

"It's a really iconic piece of our work," Martin said. *"But it's just the tip of the iceberg of a global conservation effort that happens 24 hours a day, seven days a week, for the 1,700 seed banks that tend to biodiversity."*

The Svalbard Seed Bank is a library of global agricultural achievement.

Modern agriculture is the result of 10,000 years of trial and error, cross breeding and trade, research and luck.

For all of the staple crops that are shared across borders and valued in the global marketplace, agriculture is still marked by regional peculiarity. The soil quality, weather conditions, and climate of any given location, combined with the cultural preferences of local communities, means that agriculture takes many different forms.

Seed banks are meant to keep a record of this diversity, safeguard the global food supply, and promote further innovation and collaboration.

And the Svalbard Global Seed Vault is at the forefront of this global effort.

Launched in 2008, the seed bank is located deep in a remote region of the Arctic to prevent outside forces, whether natural or man-made, from harming the seeds.

"Worldwide, there are a lot of different threats to agriculture, from defending against natural disasters to climate change to civil war," Martin said. "If something happens to your core collection, then you can lose valuable material for good."

Martin said that a seed bank in Aleppo, Syria containing more than 155,000 seed varieties was nearly lost during the Syrian civil war, but its contents were successfully transferred to Svalbard in 2008, allowing the facility to rebound.

She said that the seed bank can help organizations have peace of mind that crop varieties will remain safe even during catastrophic events.

Climate change, in particular, threatens to diminish global agriculture, making it harder to grow certain crops and harder for certain regions to foster food production. So the party line supports Prince Charles "Sustainable Development", i.e., "DEPOPULATION!"

There's also the more gradual threat of food standardization — of multinational farmers choosing to invest in highly profitable, easy-to-grow crops rather than opting for variety.

In the U.S., for example, farms have lost 93% of their crop diversity over the course of 80 years, no thanks to the GMO industry.

These trends are spurring greater awareness of the importance of seed banks, Martin said.

"The conversation around food is definitely increasing, people are starting to question how their food is produced, whether its sustainable," she said. "People are talking about farm to fork; we want them to think about seed bank to fork."

I suppose that I am seen as a "conspiracy theorist" and will be labeled such; however, I have been following this grand issue far longer than most of those around. It's not "conspiracy theory" when the data from my days in college are looked at collectively, at least from the days of Dr. Paul Ehrlich's book 'The Population Bomb' published in 1967. Depopulation as an agenda took root even earlier but Dr. Ehrlich's work became a rallying point about there is too many people.

Dr. Ehrlich's book was not the single most important work on this issue but it dominated college campuses across the nation over the next few decades. Some 40,000 attendees have flocked to the Sinai Desert including over 100 world leaders as well as leaders in business and other sectors. Christian, Muslim, Jewish, and other religious figures will participate in a UN conference on climate change that is taking place this week and next. In conjunction with the UN event, a group of faith leaders is taking an alternative approach, seeking a faith-based solution to the

ecological crisis by promoting the "Ten Principles for Climate Justice" in a global initiative.

The multifaith initiative- led by the Interfaith Center for Sustainable Development (ICSD), The Elijah Interfaith Institute, and the Peace Department – is part of the 27th Conference of the Parties to the United Nations Framework Convention on Climate Change (<u>COP27</u>), which is taking place in the Sinai Peninsula, in Sharm El Sheikh, Egypt from November 6-18.

According to the Interfaith Center, the location of COP27 is especially meaningful because the Sinai Desert is *"a place of revelation in the collective consciousness of Christianity, Judaism, Islam, and others. It is a site for turning to God and receiving God's message,"* as they explained in a press release.

On Sunday, the organization held a *"Climate Repentance Ceremonies"* and *"put forth a prophetic interreligious call to action."*

The partnering organizations initially intended to hold the Climate Repentance Ceremony and Ten Commandments events at Jebel Musa in the southern Sinai Peninsula. The area is traditionally believed to be the location of the biblical Mount Sinai, a site of great significance in the Bible and considered holy to Jews, Christians, and Muslims. Unfortunately, the Egyptian government chose not to permit the main interfaith event to be held at Jabal Musa due to security concerns so the central venue for Sunday's events was changed to London, a location that was readily accessible to faith leaders around the world and is a major media hub, as well as other locations. A small group of faith leaders will be allowed to ascend Jabal Mus and hold a repentance ceremony as originally planned. The real location of Mount Sinai is located in Saudi Arabia but it is all about symbolism of counterfeiting God's role in the Antichrist system.

Concurrent faith-based events will be held at Mt. Abu India, Rishikesh in the Himalayas, New York City, Ecuador, Germany, Vienna, Salt Lake City, Mount St. Francis in Indiana, and Australia, joining faith leaders from many denominations including Christianity, Islam, Judaism, and others. Beware of how your specific church or denomination responds to this act of the Whore of Babylonian.

The organizers have also urged houses of worship around the world to join in at the same time on Sunday with prayer and study focused on this *"transformative moment to protect our environment."*

Despite the change of venue, the Biblical significance and Mt. Sinai are still central themes of the event, as Rabbi Yonatan Neril, the founder and Executive Director of <u>The</u> <u>Interfaith Center</u>, explained.

"Some people believe religion is separate and distinct from ecology or care for God's creation," he said. "Were it not for the receiving of the Hebrew Bible on Mt. Sinai, Jewish tradition teaches, God would have returned the world to chaos and void. Applying the

teachings of the Hebrew Bible to stewardship of God's creation is not just an idea for today, but essential for a future in which we achieve a balanced, worldwide ecosystem and thrive on a planet viable for all life."

Among climate experts and environmental activists, there are some who claim that the destructive process of climate change is irreversible, but Rabbi Neril noted that the Bible teaches otherwise.

"Many people fear that humans have irrevocably destroyed the ecology of 'Eden' on earth," Rabbi Neril explained. *"But God created the world out of love for life on earth."*

"We need to change the operating system that humanity generated and is degrading God's creation," he said. "We need to switch from greed, short-term thinking, and individualistic behavior to spiritual satisfaction, long-term thinking, and altruism. And by doing that we will address the symptoms of the problem and manifest a new earth. May God help us." [Note the rabbi's use of "We need to change...."]

Rabbi Neril sees faith and religion as playing essential roles in the solution.

"Leveraging faith communities to move the needle around climate advocacy is a deeply needed and worthwhile effort," he explained. "While the national political culture is so divided, faith is this common ground that can soften the boundaries and open hearts and minds."

Toward this end, Rabbi Neril authored the "<u>Eco Bible</u> An Ecological Commentary" which describes ecology as *"achieving a more sustainable future in accordance with God's Will.*" This rabbi sounds like many liberal heretical religious leaders who endorse the transsexual surgery procedures to change your God-given gender.

Damon Duck posted a piece today that speaks to the efforts of the Antichrist System to *"change"* God's Creation:

On Oct. 29, 2022, I received an e-mail from Brighteon that said:

- "Europe dies from here forward, and it doesn't recover for generations."
- "It's done."

Evil people are killing freedom of religion, freedom of speech, freedom to buy and sell, freedom to own property, independence, democracy, Christian values (truth, morality, prayer, the Ten Commandments, etc.) because Satan has convinced them they can build back a better society (Build Back Better) without these things.

Canada is Considering Just That."* If governments are willing to readily kill babies and senior citizens without consent now, what will this world be like in the near future? Globalists call it <u>depopulation</u>. The Bible calls it the Mark of the Beast.)

Here are some recent articles that appear to tie in with Bible prophecy.

One, concerning food shortages: on Oct. 26, 2022, it was reported that Australia is now requiring dairy farmers to vaccinate their cattle with the Covid mRNA (messenger RNA) vaccine.

A herd of about 200 dairy cows was recently vaccinated, and 35 died immediately.

Some officials are now asking if it is safe to drink milk that comes from vaccinated cows.

(**Question:** If the vaccination killed 35 cows, almost 20% of a herd, immediately after they were jabbed, is it possible that it killed some humans that died shortly after they were vaccinated?)

Two, on Oct. 30, 2022, World Net Daily (WND) published an article by Art Moore that said a Swiss study found increased levels of troponin (a protein found in heart muscles,

but not in one's bloodstream unless there has been heart damage) in everyone they checked (27 people) that had been vaccinated with mRNA Covid-19.

According to the article, there have been other studies that found heart damage in some people that received the mRNA jab.

(**Note:** I can't prove the information, but a reader sent information to me that says whistle-blower nurses in Canada are saying that doctors at the Ontario hospital are vaccinating patients for Covid-19 without their consent while they are under anesthesia. Three, concerning food shortages and famine: on Oct. 27, 2022, it was reported that BASF (the world's largest producer of fertilizer and chemicals) will *"as quickly as possible and permanently"* downsize its operations in Europe because of high energy prices and burdensome regulations.

Four, energy officials in the UK recently warned citizens to prepare for rolling power cuts between 4 pm and 7 pm in Jan. and Feb. 2023. (Incidentally, on Oct. 26, 2022, the UK's new Prime Min. restored a ban on fracking in the UK.)

Five, concerning world government: in 2017, Klaus Schwab, head of the World Economic Forum (WEF), boasted that his organization had infiltrated several governments, and he specifically mentioned Canada and Germany.

On Oct. 25, 2022, Alberta, Canada's new premier, Danielle Smith, said, *"I guess I find it distasteful when billionaires brag about how much control they have over political leaders, as the head of that organization has. And I think that that is offensive."*

Smith said, "The people should be directing government or the people who vote for them. And the people who vote for me and for my colleagues are people who live in Alberta and who are affected by our decisions."

God bless her.

Those in positions of power in Canada, the U.S., etc., should be people that citizens of those nations have elected, not rich unelected globalist elites that live in foreign nations.

Six, concerning world government: on Oct. 27, 2022, The New American posted an article by Alex Newman about the 27th Conference of the Parties (COP27) meeting that will be in Egypt in mid-Nov.

Selected climate change representatives from almost 200 nations, the World Economic Forum (WEF), big business, and others will attend, and the three biggest issues will most likely be:

- Who is going to pay how much to fight climate change all over the world.
- How the war against climate change can be used to advance world government.
- How to advance the war against farmers to increase global control of the world's food production.

For one thing, it appears to be a global wealth redistribution scheme to transfer massive amounts of money from developed nations to underdeveloped nations.
