God's Signature Is In Your DNA?

Vaccine Researcher Admits 'Big Mistake,' Says Spike Protein Is Dangerous 'Toxin'

"The coronavirus spike protein from COVID-19 vaccination unexpectedly enters the bloodstream."

'Terrifying' new research finds vaccine spike protein unexpectedly in bloodstream. The protein is linked to blood clots, heart and brain damage, and potential risks to nursing babies and fertility."

[When that information was first discovered, the entire program should have been shut down entirely. Yet, it continues and from the weekly 'Defender's' post on VAERS data shows the program continues as if nothing has changed.]

New research shows that the coronavirus spike protein from COVID-19 vaccination unexpectedly enters the bloodstream, which is a plausible explanation for thousands

of reported side-effects from blood clots and heart disease to brain damage and reproductive issues, a Canadian cancer vaccine researcher said last week.

"We made a big mistake. We didn't realize it until now," said **Byram Bridle**, a viral immunologist and associate professor at University of Guelph, Ontario, in an <u>interview</u> with Alex Pierson last Thursday, in which he warned listeners that his message was "scary."

"We thought the spike protein was a great target antigen, we never knew the spike protein itself was a toxin and was a pathogenic protein. So by vaccinating people we are inadvertently inoculating them with a toxin," Bridle said on the show, which is not easily found in a Google search but went viral on the internet this weekend.

Bridle, a vaccine researcher who was awarded a \$230,000 government grant last year for research on COVID vaccine development, said that he and a group of international scientists filed a request for information from the Japanese regulatory agency to get access to what's called the "biodistribution study."

"It's the first time ever scientists have been privy to seeing where these messenger RNA [mRNA] vaccines go after vaccination," said Bridle. "Is it a safe assumption that it stays in the shoulder muscle? The short answer is: absolutely not. It's very disconcerting."

Vaccine researchers had assumed that novel mRNA COVID vaccines would behave like "traditional" vaccines and the vaccine spike protein — responsible for infection and its most severe symptoms — would remain mostly in the vaccination site at the shoulder muscle. Instead, the Japanese data showed that the infamous spike protein of the coronavirus gets into the blood where it circulates for several days post-vaccination and then accumulated in organs and tissues including the spleen, bone marrow, the liver, adrenal glands, and in "quite high concentrations" in the ovaries.

"We have known for a long time that the spike protein is a pathogenic protein. It is a toxin. It can cause damage in our body if it gets into circulation," Bridle said.

The SARS-CoV-2 spike protein is what allows it to infect human cells. Vaccine manufacturers chose to target the unique protein, making cells in the vaccinated person manufacture the protein which would then, in theory, evoke an immune response to the protein, preventing it from infecting cells.

A large number of studies has shown that the most severe effects of SARS-CoV-2, the virus that causes COVID-19, such as blood clotting and bleeding, are due to the effects of the spike protein of the virus itself.

"What has been discovered by the scientific community is the spike protein on its own is almost entirely responsible for the damage to the cardiovascular system, if it gets into circulation," Bridle told listeners.

Lab animals injected with purified spike protein into their bloodstream developed cardiovascular problems, and the spike protein was also demonstrated to cross the blood brain barrier and cause damage to the brain.

A grave mistake, according to Bridle, was the belief that the spike protein would not escape into the blood circulation.

"Now, we have clear-cut evidence that the vaccines that make the cells in our deltoid muscles manufacture this protein — that the vaccine itself, plus the protein — gets into blood circulation," he said.

Bridle cited the recent publication of a peer-reviewed <u>study</u> which detected spike protein in the blood plasma of three of 13 young healthcare workers that had received Moderna's COVID-19 vaccine. In one of the workers, the spike protein circulated for 29 days.

The Killer in the Bloodstream: the "Spike Protein"

Effects on heart and brain

Once in circulation, the spike protein can attach to specific ACE2 receptors that are on blood platelets and the cells that line blood vessels. "When that happens it can do one of two things: it can either cause platelets to clump, and that can lead to clotting. That's exactly why we've been seeing clotting disorders associated with these vaccines. It can also lead to bleeding." Bridle also said the spike protein in circulation would explain recently reported heart problems in youths who had received the shots.

The results of this leaked Pfizer study tracing the biodistribution of the vaccine mRNA are not surprising, "but the implications are terrifying," Stephanie Seneff, a senior research scientist at Massachusetts Institute of Technology, told LifeSiteNews. "It is now clear" that vaccine content is being delivered to the spleen and the glands, including the ovaries and the adrenal glands.

The Centers for Disease Control and Prevention (CDC) recently announced it was studying reports of "mild" heart conditions following COVID-19 vaccination, and last week 18 teenagers in the state of Connecticut alone were hospitalized for heart problems that developed shortly after they took COVID-19 vaccines.

AstraZeneca's vaccine was halted in a number of countries and is no longer recommended for younger people because of its link to life-threatening and fatal blood clots, but mRNA COVID vaccines have been <u>linked to hundreds of reports of blood clotting</u> events as well.

FDA warned of spike protein danger

Pediatric rheumatologist **J. Patrick Whelan** had warned a vaccine advisory committee of the Food and Drug Administration of the potential for the spike protein in COVID vaccines to cause microvascular damage causing damage to the liver, heart, and brain in "ways that were not assessed in the safety trials."

While Whelan did not dispute the value of a coronavirus vaccine that worked to stop transmission of the disease (which no COVID vaccine in circulation has been demonstrated to do), he said, "it would be vastly worse if hundreds of millions of people were to suffer long-lasting or even permanent damage to their brain or heart microvasculature as a result of failing to appreciate in the short-term an unintended effect of full-length spike protein-based vaccines on other organs."

Vaccine-associated spike protein in blood circulation could explain myriad reported adverse events from COVID vaccines, including the 4,000 deaths to date, [now over 17,000 in late October, 2021] and nearly 15,000 hospitalizations, reported to the U.S. government's Vaccine Adverse Event Reporting System (VAERS) as of May 21, 2021. Because it is a passive reporting system, these reports are likely only the tip of an iceberg of adverse events since a Harvard Pilgrim Healthcare study found that less than one percent of side-effects that physicians should report in patients following vaccination are in fact reported to VAERS.

Nursing babies, children and youths, frail, most at risk

Bridle said the discovery of vaccine-induced spike protein in blood circulation would have implications for blood donation programs. "We don't want transfer of these pathogenic spike proteins to fragile patients who are being transfused with that blood," he said.

The vaccine scientist also said the findings suggested that nursing babies whose mothers had been vaccinated were at risk of getting COVID spike proteins from her breast milk.

Bridle said that "any proteins in the blood will get concentrated in breast milk," and "we have found evidence of suckling infants experiencing bleeding disorders in the gastrointestinal tract" in VAERS.

Although Bridle did not cite it, one <u>VAERS report</u> describes a five-month-old breastfed infant whose mother received a second dose of Pfizer's vaccine in March. The following day, the baby developed a rash and became "inconsolable," refused to nurse, and developed a fever. The report says the baby was hospitalized with a diagnosis of <u>Thrombotic Thrombocytopenic Purpura</u>, a rare blood disorder in which blood clots form in small blood vessels throughout the body. The baby died.

The new research also has "serious implications for people for whom SARS Coronavirus 2 is not a high risk pathogen, and that includes all of our children."

Effect on fertility and pregnancy?

The high concentration of spike protein found in testes and ovaries in the secret Pfizer data released by the Japanese agency raises questions, too. "Will we be rendering young people infertile?" Bridle asked.

There have been thousands of reports of menstrual disorders by women who had taken a COVID-19 shot, and hundreds of reports of miscarriage in vaccinated pregnant women, as well as of disorders of reproductive organs in men.

Vicious smear campaign

In response to a request, Bridle emailed a <u>statement</u> to LifeSiteNews on Monday morning, stating that since the radio interview he had received hundreds of positive emails. He added, too, that "a vicious smear campaign has been initiated against me. This included the creation of a libelous website using my domain name."

"Such are the times that an academic public servant can no longer answer people's legitimate questions with honesty and based on science without fear of being harassed and intimidated," Brindle wrote. "However, it is not in my nature to allow scientific facts to be hidden from the public."

He attached a brief report outlining the key scientific evidence supporting what he said in the interview. It was written with his colleagues in the Canadian COVID Care Alliance (CCCA) — a group of independent Canadian doctors, scientists, and professionals whose declared aim is "to provide top quality, evidence-based information about COVID-19, intent on reducing hospitalizations and saving more lives."

A focus of the statement was the risk to children and teens who are the target of the latest <u>vaccine marketing</u> strategies, including in Canada.

As of May 28, 2021, there have been 259,308 confirmed cases of SARS-CoV-2 infections in Canadians 19 years and under. Of these, 0.048% were hospitalized, but only 0.004% died, according to the CCCA statement. "Seasonal influenza is associated with more severe illness than COVID-19."

Given the small number of young research subjects in Pfizer's vaccine trials and the limited duration of clinical trials, the CCCA said questions about the spike protein and another vaccine protein must be answered before children and teens are vaccinated, including whether the vaccine spike protein crosses the blood-brain barrier, whether the vaccine spike protein interferes with semen production or ovulation, and whether the vaccine spike protein crosses the placenta and impacts a developing baby or is in breast milk.

LifeSiteNews sent the Public Health Agency of Canada the statement of CCCA and asked for a response to Bridle's concerns. The agency responded that it was working on the questions but did not send answers before publication time.

Pfizer, Moderna, and Johnson & Johnson did not respond to questions about Bridle's concerns. Pfizer did not respond to questions about how long the company was aware of its research data that the Japanese agency had released, showing spike protein in organs and tissue of vaccinated individuals.

As the article noted, it was written in May, 2021 but the program of administering these spike protein (PEG) vaxx "gene" therapy shots are still being administered unabated! Why are they continuing to injure and kill people?

Do these vaccine companies believe the public is stupid or do they believe they are unaccountable to the public? Perhaps if the media was not complicit the program might have been stopped. My interest in genetics and DNA is more than a curious novelty. Seven years ago I was reading about CRISPR-Cas9, I have since read three books on CRISPR, and it is no jump of the imagination to see that this could be a tool to change our DNA. Yes, change our God-given DNA to that of a cyborg — part human and part artificial intelligence. With this new technology of CRISPR, it becomes possible to play God! Despite limits that have been imposed by the scientific community does not preclude developments outside the envelop limit.. With deep pocket's investors like Bill Gates there is no feasible limit to what can be achieved. I read the scientific abstracts of this community and everyone is looking to make a name for themselves as a future Nobel Laureate! I want to get back to the discovery of Neil Whitehead but we will come back to the larger issue that implores me to warn those thinking about taking any of the so-called Vaxxes. I decided early on in the alleged pandemic not to submit to any testing for Covid after reading the horrendous stories of people's reactions and my intuition warned me that something was not quite right about the alleged virus pandemic and its similarity to 5G wireless EMF radiation sickness symptoms. There are so many threads in this issue that even at this point we simply cannot casually exclude 5G since it is the communications link in the coming Internet of Things (IoT) which are intrinsic to DNA as part of the QuantumDot/Hydrogel ID2020 and its invisible Microneedle patch array!

Neil Whitehead said, "It happens that there are about 22 amino acids in humans and 22 letters in the Hebrew alphabet. That set me wondering if there might be something tantalizing written into the human genome. If so what might it be? I wondered if God might have signed it - as a mark of his ownership, a sneaky surprise for the human race."

It was obviously going to be an enormous job to process the entire human genome and I didn't have 35 spare years to do it in. But the idea wouldn't leave me alone so I decided to make a tentative start, downloading the amino acid sequences for the first half dozen genes on each of the 23 chromosomes - including X and Y, the sex chromosomes - and creating a computer program to handle the task. That is, to "read" the amino acids and what meaning they had in Hebrew. I decided to start small, assuming that if God had signed the DNA in some way he would presumably have used his name as a signature, or at least an abbreviation of it. So I set about examining the letter sequences for about a dozen common names of God. I found them in high numbers all through the DNA I sampled.

I used a process that a child might use for a simple cryptography exercise. It was very straightforward. I created a correspondence between each of the amino acids and its equivalent Hebrew letter by matching the most common amino acid found in the human body with the most commonly used letter in the Hebrew alphabet, running down the list from most to least common.

What I found has a lot to do with the structure and grammar of the Hebrew language itself, almost as if it were made for the exercise. Trying the same correspondence in English and Latin yielded almost nothing in comparison.

So what did I find?

I found that abbreviations or full versions of the 14 most common names of God, most of them found in the Hebrew Scriptures, appeared about 500,000 times in each human cell - i.e., trillions of times (500,000 x 10 trillion) in the human body. We appear to be saturated with the names of God - or at least His signature. One of the most common four letter words in the genes was YHWH, the full name of God; it appeared 500 times in each cell. Its common abbreviation, YH, appeared 35,000 times.

It seems the human DNA is thoroughly initialed!!

I found that "YY is", is the predominant message in the DNA! YY is a common Hebrew prayer book abbreviation for Adonai (Lord) and is a kind of assertion that God exists.

Interestingly the Hebrew name for Satan, STN, never appeared in my simple code. I also found that positive statements about God outnumbered negative ones 2:1.

I decided to try the same exercise on non-human DNA to see if names of God showed up there too. They did. I found that the most important name of God, YHWH, appeared almost three times more often in humans, as if he had a special relationship with us. But he also seemed to have written his names into every living thing.

I then decided to look for simple words and even phrases. Because Hebrew is a very condensed language, numerous short, meaningful phrases appeared in a typical gene. It meant I needed more than a nodding acquaintance with Hebrew grammar to check them, but they were mostly not long so I didn't need to be a Hebrew scholar.

Using Hebrew, the phrases divide into:

- (a) proverbial/profound (particularly about God): e.g., Yah is very life
- (b) poetic: e.g, A light heart is like a garden
- (a) amusing: e.g., It's grossly unfair to abhor baldness

Note: where I use the word "genome," I mean that part of the human DNA strand containing genes (which amounts to only about 2% of the DNA.) Junk DNA refers to the balance of 98% of DNA. ["Junk" DNA was the term originally applied to that which scientists could not identify with specific aspects of life. It is not used much anymore.]

In a little more detail, Neil converted the amino acid sequences to strings of Hebrew letters, converted each Hebrew letter to its standard English letter equivalent, and did a computer search for possible meanings in a reputable English-Hebrew lexicon. If anything looked promising he double-checked each word or phrase in Hebrew to make sure it was grammatically correct, and looked at what he had.

The Names

Yes, due to the peculiarities of the Hebrew Language, 12-14 common names of God-whether abbreviations or whole words - predominate greatly over all other possible words. This has nothing to do with interpretation or subjectivity or "personal revelation." The names are simply there - about 500,000 in each cell and in their trillions in the human body, regardless of anyone's personal philosophy. They even appeared in the DNA of 4 tiny organisms Neil analyzed - even *E.Coli*. They are probably in life everywhere. To repeat ourselves, you could say there is simply something about the Hebrew language that seems intended to work with this exercise. English and Latin yielded almost nothing in comparison.

It is probable that God has signed His name in all DNA around us. Some of us will see it; some of us will see it everywhere. Some won't and some will deny a signature is there at all.

The phrases

From time to time people will say that something they read "jumped out and hit them". It is as if a phrase or message intended for someone else in another time applies personally to the present-day reader. Many others who read the same words will not have the same experience. This seems to happen more to readers of the Bible; somehow once doesn't expect to encounter a life-changing phrase in a thriller!

The exercise of searching the DNA for significant phrases only sometimes did this to Neil, and it may well be no reader of this material will have such an "Aha!" moment. So is God speaking in the DNA or not? Yes, but in a way which also seems to depend on us.

In some mysterious way the *phrases* we find written in the DNA will reflect what we are and what we want to see. The phrases Neil found and have listed on his website are only a small sample of what he found. Some phrases made no sense at all. He found a single instance of the phrase, "God is bad" but began to discover that positive phrases outnumbered negative phrases two to one. Partly, he didn't find many negative phrases because a negative in Hebrew can require an extra letter in the sequence making them less likely to appear. Neil certainly had no conscious bias against finding negative phrases about God. He recorded whatever showed up but on finding a 2 to 1 bias against the negative Neil decided to list on his website mainly those phrases that were positive. Within closely prescribed limits someone with a negative cast of mind could scan the same sequence of letters he did and choose a different set of vowel pointing's in a 2-3 letter word to take the meaning in a more negative direction.

Other DNA to Hebrew projects

One writer ("<u>Gregg Braden - The God Code" 2015</u>), using a system partly derived from the Jewish mystics (the Kabbalah) claims to have established a correspondence between DNA and Hebrew. The mystical element is strong, and demands acceptance of the Kabbalah system. [Greg Braden was using Gematria], the letter/number system using system that are commonly known as the "Bible Code" or ELS, Equal Distance Letter Spacing.

Another approach (Anonymous 2015) takes the Divine Name YHWH and from the three basic letters YHW, in various combinations derives the three letter chemical base combinations found in DNA. This relies heavily on a system in a treatise on human consciousness called 'The Keys of Enoch' written by Hurtak in 1973.

An interesting video (Keller 2012) describes how Mannose, a common sugar on the surface of cells, in some configurations looks exactly like the Hebrew for YHWH. Neil had difficulty seeing this in the configurations he knew of, even though he understood the biochemistry well, but perhaps it could look like that if you managed to find the correct viewing angle.

The Image of God

If the names of God are written through our DNA and He has signed His work in us, does it hint at some sort of ownership of us, or reflection of Himself in us? The name YHWH appears far more often in human DNA than in non-human DNA, suggesting there are higher faculties in humans that resemble God's and that aren't shared with animal and other organisms. They have life but not capacity for reasoning, wisdom, creativity or planning at high levels.

And God said "*let us make man in our image, according to our likeness*" -(Genesis 1:26). This implies that there is some degree of signing already – there is an imprint of some kind on us. We bear the God-image in a way which the animals do not.

Genesis 1:26 "...let them have dominion over the fish of the sea, over the birds of the air, and over the cattle, over all the earth, and over every creeping thing that creeps on the earth". It seems to me that an obvious image here is of dominion. Just as God rules, we are supposed to rule. But this is not a mandate to destroy – we are supposed to be stewards not rain-forest clear-fellers.

Genesis 1:27 "in the image of God he created him; male and female he created them." Today it is popular to think that gender is the main image of God, but it would be more natural to think that dominion is the main image, and sexuality is secondary. The reason Neil believe that gender is not the most important image of God is that animals have it too. Any aspect of gender which particularly reflects God must be quite transcendent, but even so gender is not the most important quality. Neil could not find any biblical commentaries prior to 1900 which thought that sexuality was the main image of God. Rather they emphasized dominion, but at least two other factors: wisdom and spirituality.

Humans are *Homo sapiens*, the wise ones, and in Psalm 32:9 we read "Don't be like the horse or the mule, which have no understanding, whose mouth must be held in with bit and bridle or they will not come near you." The animals in contrast to humans, have little wisdom and are not fit to rule each other. Humans can talk to God; the talk of animals to God is more like the grunts of a pig. There is a similarity of spirit between humans and God which hardly exists for the animals. Do animals have souls or spirits at all? The answer quite simply is they have both, but it is the quality which differs from ours.

So, if, in some way God has written His name, His signature, His ownership and His guarantee of care into us, *Homo sapiens*, what does that mean about the way we could be living? We're certainly in need of help; we don't do a very good job of it left to ourselves. Maybe, in keeping with the spirit of this exercise, we could invent the letters RTRO. It could mean Retro, but might more usefully be interpreted as an acronym: Return To Rightful Owner.

DNA

DNA was discovered in 1871 in Germany by Friedrich Miescher, in dead white blood cells, and is a biological recipe for a human. Could that information also contain a mark of authorship, or messages?




Figure 1. Paired bases within a part of the double helix




Figure 2. The biochemical machinery that creates proteins

DNA is made of bases, a technical name for four types of biochemical each of which has at least a one ring structure, and contains nitrogen. These are Thymine, Cytosine, Adenine, and Guanine, which are abbreviated to T, C, A, G. Clusters of various triplet combinations of these, via complex cell machinery cause an individual amino acid to be selected and attached to a growing chain of others, forming a protein. This process is shown in Figures 1 and 2. We can't explain everything here but the interested reader will find plenty of detail elsewhere (e.g., *Wikipedia*) about any obscure names or processes in the following diagrams. The amino acids are important, because it is them that this website takes as an equivalent to Hebrew letters.

In the table below are the base combinations and the corresponding amino acids and their single letter conventional abbreviations. The Amino Acids are: Phenylalanine, Leucine, Isoleucine, Methionine, Valine, Serine, Proline, Threonine, Alanine, Tyrosine, Histidine, Glutamine, Asparagine, Lysine, Aspartic acid, Glutamic acid, Cysteine, Tryptophan, Arginine, Glycine. Sel is the rare amino acid selenocysteine, which contains the rather exotic element selenium, which definitely occurs in humans, and is given here the symbol Z. The amino acids also have abbreviations like Ala (for Alanine), Arg (for Arginine), Ile (for Isoleucine), etc.

In the table, two of the base combinations do not code for an amino acid, but are a signal to stop lengthening the amino acid chain. The amino acid Methionine (Met/ M) can act as a signal to start it. There are 21 amino acids and 3 stop combinations. This could be counted as anywhere from 21-23 letter equivalents. What language has a number of letters like that? We'll look at that in a moment. Only a few percent of DNA is arranged in genes. It is recipes for proteins, and this paper concentrates on these. The "junk" DNA which does not, is considered briefly in Technical Notes.

How do we order the amino acids and letters?

Neil used human amino acid frequency data from a Japanese database (<u>Kazusa DNA Research Institute</u>) which gave me an order of frequency of amino acids greatest to least, that is, those amino acids most commonly found to those least commonly found in humans, coded for within human genes. The order is:

Leu(L), Ser(S), Ala(A), Glu(E), Gly(G), Pro(P), Val(V), Arg(R), Lys(K), Thr(T), Asp(D), Gln(Q), Ile(I), Phe(F), Asn(N), Tyr(Y), Hst(H), Cys(C), Met(M), Trp(W), stop/selen(Z), stop, stop

The most common amino acid, leucine, may possibly stimulate production of muscle protein, but tests in humans so far (elderly men) don't support this.

Are there Names of God in junk DNA?

Most DNA is not in the form of genes. Fifty to sixty years ago 90% of it appeared to have no known purpose at all and researchers referred to it as "junk DNA", though they suspected it had an important but yet unknown function. DNA is a huge molecule, very liable to fall apart spontaneously, and requiring constant energy-intensive repair. It seemed ridiculous that the junk DNA had no role to play. Scientists slowly discovered that "junk DNA" had a similar sequence in very many organisms — another indication it must have useful tasks. "God don't make no junk" as the saying is, and it now seems clear that this very large section of DNA regulates how the genes are expressed in any cell, hence exerting some level of control on genes. In addition to "junk DNA" highly folded sections of DNA also seem to control whether the genes get expressed.

So should we be looking for signatures in the "junk" as well?

The "junk DNA" is very different from genes, and contains an extraordinary number of repeated sequences. About 40% of all DNA is these repetitive sequences. One superfamily of these sequences is called Alu (about 300 bases long), and a family called Alu-Sx is the most common; one sequence from it, which is 11 bases long, occurs a million times in the DNA, while other families like Alu-Jo occur about 400,000 times. They don't code for proteins however, but for RNA. RNA is a very important relative of DNA that also controls the expression of the genes in the DNA.

However, because this "junk DNA" doesn't directly code for amino acids to make proteins it seemed off to the side of the main task, which was to look at the genetic sequence for possible signatures. Transliteration of non-genetic material into Hebrew as if it was actually producing amino acids and proteins didn't make much sense, so Neil quickly discarded this approach.

However two names of God showed up: YY יי (of course), and Most High, על.

Because there is a lot more repetition in junk DNA than in the genetic code itself we could expect these names to show up frequently if we continued with the exercise. We can see that after twenty years since the human genome was decoded, man only has scraped the tip of the surface in understanding the expression of DNA. 

And if we assume that the word "line" can be metaphorically translated as "DNA", then we find:

In gene 8:AC144568.2: [DNA] is destined for Yah's highest place.

In gene 10:TUBB8: My [DNA] is a foundation

* 2 is the chromosome number, followed by the scientific name of the gene.
