Barrett, Kavanaugh reject religious liberty in support of vaccine mandates

David Leach several weeks ago pointed out what we will see in a few weeks once the Supreme Court handle the hot potato of Covid Vax mandate of Joe Biden or whoever the hell he is playing his appearances in public.

Amy Coney Barrett and Brett Kavanaugh reject religious liberty in support of COVID vaccine mandates.

In what could be called an unfortunate but expected moment of political déjà vu, Supreme Court Justices Amy Coney Barrett and Brett Kavanaugh once again voted to reject religious liberty in support of COVID vaccine mandates and tyranny.

Just last month, Barrett and Kavanaugh joined Chief Justice John Roberts and the far-left wing of the Supreme Court to deny a preliminary injunction to a group of medical professionals seeking a religious liberty exemption from Maine's vaccine mandate.

The 6-3 ruling against religious liberty in that case meant that the group of Maine healthcare providers would face being mandatorily vaccinated for COVID against their religious beliefs or lose their jobs. "With Maine's new rule coming into effect, one of the applicants has already lost her job for refusing to betray her faith; another risks the imminent loss of his medical practice," Neil Gorsuch noted in his dissent at the time.

Barrett and Kavanaugh defended their votes against religious liberty based on their contention that the case was brought on the shadow docket, or as an emergency appeal. Shadow docket cases do not involve oral arguments or full rulings that are part of normal cases.

Barrett said the shadow docket should not be used for such a case, and that **the court should not make this decision "on a short fuse without benefit of full briefing and oral argument,"** implying her and Kavanaugh could vote differently if the case came before the court in a different way. (emphasis David Leach)

But that was a lie because they both voted again to reject religious liberty in favor of vaccine mandates in a different case earlier this week (via 'National Review'):

The U.S. Supreme Court rejected two emergency requests to block New York's vaccine mandate for health care workers on Monday.

Three nurses and a group called 'We the Patriots USA' **challenged the mandate, arguing that it violates the First Amendment because it does not include a religious exemption.**

Justices Clarence Thomas, Neil Gorsuch, and Samuel Alito dissented, saying in the order that they would have granted the request.

Gorsuch noted that two of the doctors are not "anti-vaxxers who object to all vaccines" and that their religious beliefs should be respected, particularly given that the state had only recently said religious exemptions would not be accepted and that the state has chosen to accept medical exemptions.

*"Even if one were to read the State's actions as something other than signs of animus, they leave little doubt that **the revised mandate was specifically directed at the applicants' unorthodox religious beliefs and practices,**"* Gorsuch said.

The decision comes after **the high court has similarly allowed state mandates in Indiana and Maine to stand.** (emphasis David Leach)

Brett Kavanaugh and Amy Coney Barrett continue to choose tyrannical government over liberty, something I and my conservative brethren warned about when Trump and McConnell pushed their nominations through the system.

Before her appointment to the Supreme Court, Amy Coney Barrett's judicial track record exposed her as a conservative fraud, not a strict constructionist of the Constitution as we were told by Trump and McConnell. Barrett's past showed that she was a big government, police state advocate who would continue the assault against our constitutionally protected liberties.

Constitutional attorney Robert Barnes reviewed over 40 cases involving Barrett and concluded that she would be a disaster as a Supreme Court justice when it comes to protecting liberty — particularly, religious liberty in the age of COVID tyranny:

“Coney Barrett has sided with the government on the lockdowns, on uncompensated takings, on excusing First Amendment infringements & Fourth Amendment violations... and exclaimed the benefits of Jacobson, the decision that green-lit forced vaccines & carved out an emergency exception to Constitutional protection in ‘public health’ or ‘emergency’ cases used to justify forced sterilizations & detention camps.” (emphasis David Leach)

Barrett concurred with the majority in [Illinois Republican Party et al. v. J.B. Pritzker, Governor of Illinois](#) to keep an illegal lockdown in place, going so far as to her concurring vote behind the precedent established in 1905 in [Jacobsen v. Massachusetts](#) in order to avoid taking defending her decision.

The Jacobson decision gave the green light to vaccine mandates, and it carved out the emergency exception to Constitutional protection in “public health” or “emergency” cases [used to justify](#) state-mandated vaccinations. It was also the legal basis used in *Korematsu v United States* where the court ruled in 1942 that the [internment of Japanese Americans](#) was acceptable.

Earlier this year, Barrett rejected a request to block Indiana University's vaccine mandates for students without providing any reason for doing so. She made the decision without consulting other justices as she could have done and suggested that there was no legal justification for the request.

When Anthony Kennedy resigned, Donald Trump and Mitch McConnell picked Brett Kavanaugh to replace him, and they promised that he was also a “strict constructionist.” But as we knew then and still know today, that was a lie.

Kavanaugh's appointment to replace Kennedy was a bad deal for conservatives and the Constitution from the very beginning, and I opposed his confirmation for several reasons, especially his rulings against the Fourth Amendment and his testimony before the Senate that *Roe v. Wade* is “settled law”.

COVID vaccines for children ages 5 to 11 are now mandated in many states. Based on what we've witnessed so far from Barrett and Kavanaugh, if a religious liberty challenge to such a mandate reaches the Supreme Court, it's highly unlikely that children will be spared from COVID tyranny.

The judiciary was designed by the Founding Fathers to be the weakest branch of government; the real power is supposed to belong to "we the people" via the legislative branch and the individual states. In post-Constitutional America, unelected judges have taken that power from us.

Thanks to Donald Trump and Mitch McConnell, Amy Coney Barrett and Brett Kavanaugh have been given that power and have used it to reject religious liberty in support of COVID vaccine mandates. It is my belief that David Leach's words are prophetic and will not set well with the public. This is the finish of the Republic in many strange ways that are converging such that you might begin preparing for the End of Days!

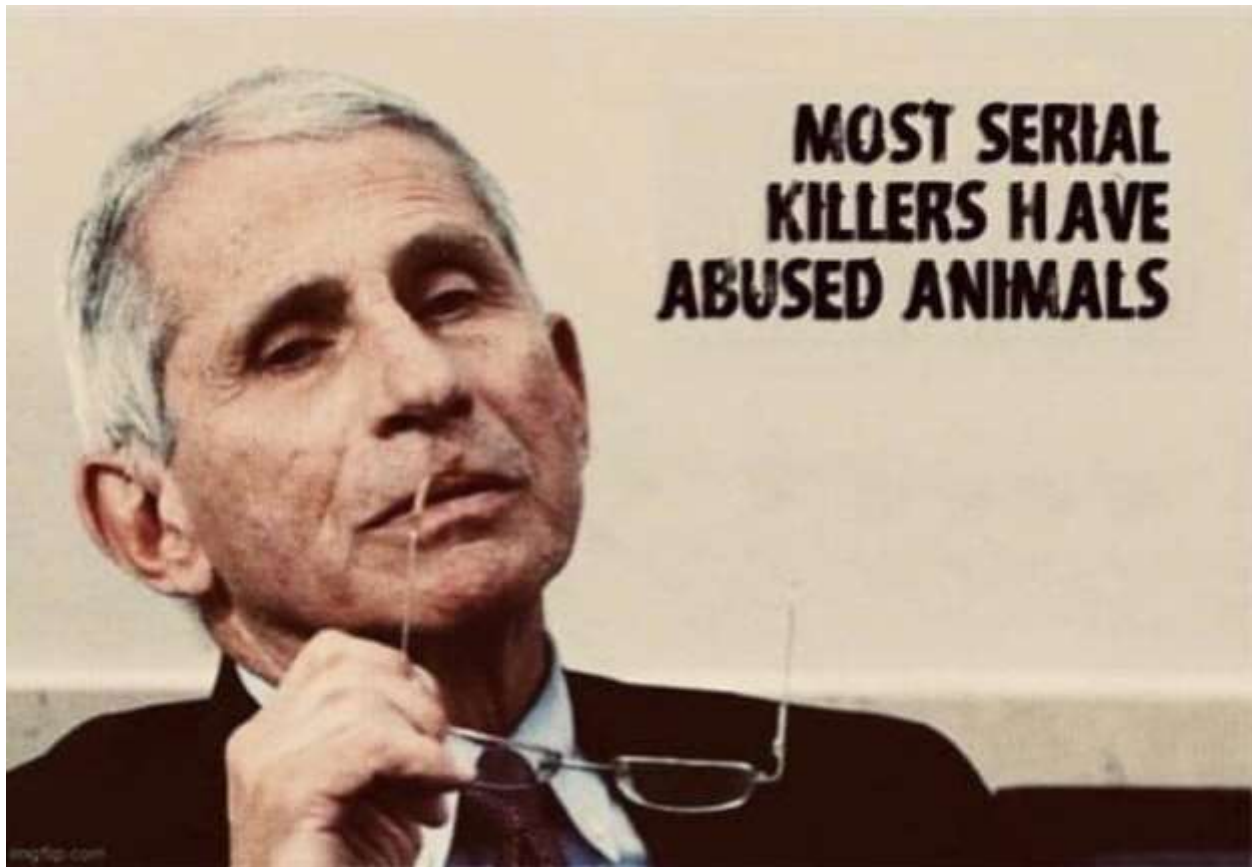
"We're going to have to start living with Covid. I believe that's the case because I don't think we're going to eradicate it," Fauci told CBS.

The good news is that some courts here in the United States are starting to reject the mandates that Joe Biden tried to implement through his bully pulpit. On Monday, a federal court blocked Biden's mandate for health care workers in 10 states, and on Tuesday a different court blocked that same mandate on a nationwide basis...

A federal court then issued a nationwide injunction protecting health care workers across the country from Joe Biden's COVID vaccine mandate. Part of this is being written as each day brings another twist to this crime against humanity! It is a lengthy but significantly important article for those awake with eyes wide open!

Yesterday, in response to a multi-state lawsuit led by Missouri, a federal court barred the Biden administration from enforcing a vaccine mandate for health care workers in 10 states who are employed at federally-funded health care clinics. That means they doctors and nurses can't be fired for refusing the COVID vaccine despite Biden's federal mandate requiring them to get it.

Today, a federal court in Louisiana expanded on that ruling and blocked the vaccine mandate nationwide. But just because they have a legal setback or two does not mean that they are going to stop trying.

Over in Germany, it is being reported that incoming Chancellor Olaf Scholz wants to impose a vaccine mandate on every single German starting in February. Germany's incoming Chancellor Olaf Scholz is in favor of introducing mandatory coronavirus vaccination for all Germans as early as February, an official close to Scholz said. The German public is on the verge of civil war over this issue.

During a crisis meeting Tuesday between the outgoing government of Chancellor Angela Merkel and the premiers of the German federal states, Scholz *"signaled his sympathy for such a regulation,"* the official told POLITICO.

Such a measure would have to be approved by the German Bundestag, the official said, adding that the mandatory vaccination could come *"at the beginning of February."* Other major industrialized nations are considering similar measures.

Once vaccines become mandatory for an entire population, vaccine passports will be absolutely necessary for anyone that still wants to live anything that even resembles a *"normal life"*.

Whether it is a "QR" code on your phone, on a card that you show or actually embedded in your skin, you will need to take it with you wherever you go in case you are stopped by law enforcement authorities. You will no longer be free! You become a slave to the state. You are witnessing the return of Fascism around the world in the name of health, but it remains to be Fascism, the world rejected in the 1940s.

Does any of this sound eerily familiar? It should. The Book of Revelation describes a similar system whereby the people of the world are forced to receive a mark on their right hand or forehead. Those who refuse to comply will be unable to buy or sell. They'll effectively be cut off from society. Greek is more precise and uses words that quite often do not have an English equivalent. The Greek text translated into English loses much in its nuanced message over nearly 2,000 years. But setting this issue aside for now, there are even more serious issues we should consider and focus upon. I mentioned Blessed Hope #87 because of some new insight to the operation of the QuantumDot:Hydrogel ID2020 system patented by Bill Gates, et.al. This symbiotic technology is interdependent of various elements, last of which is the Microneedle Patch.

Nevertheless, vaccine mandates and passports create a social system enabling the “Mark” of the beast. If they are allowed to stand, they will create a “Mark” of the beast system indistinguishable in impact from the true mark of the beast. In doing so, they'll pave the way for the rise of the Antichrist and the “Mark” of the beast as outlined in the Book of Revelation. Lately, a similar trend may be crystallizing, in Australia’s State of Victoria, where people of Melbourne have been in a lockdown literally for months.

A police lady quit and came to the fore giving interviews and divulging that the majority of her colleagues think alike, but they are afraid of losing their jobs and or being punished by Victoria’s tyrannical governor. This is a good start.

It has to happen in unison, in solidarity. In most European countries you are not allowed to go to restaurants or any public event unless you can show the vaxx-certificate – an infamous QR-code on your cell phone that would be read by another cell phone programmed to read your QR-code.

You have no idea what is or what will eventually be put on this QR-code. The video has since been “fact-checked” out of the internet. Mr. Microsoft, Bill Gates, actually spoke of an implanted *Operating System* in the human body. So, we, humans, need to have a body that can respond to electromagnetic waves, in other words our

“It is not just about the vaccine. It’s not just about the virus. It’s about your data. It can be merged with your PayPal account, with your digital currency,” she warns. ***“Your network can be sucked up. It geo-locates you everywhere you go. Your credit history can be included. It is absolutely so much more than a vaccine pass ... it has the power to turn off your life.”*** Yes, literally so.

Just like being jab with the mRNA “operating system”, once you opt in there's no way out. You're only option is to be an outcast from the economic system. Consider that Moderna admits on their own website the functionality of its “vaccine” is more akin to an “operating system.” Do you know what an operating system is and what it can do?

Nuremberg Code (Directives for Human Experimentation)

The Nuremberg Military Tribunal's decision in the case of the United States vs. Karl Brandt et al. includes what is now called the Nuremberg Code, a ten-point statement delimiting permissible medical experimentation on human subjects. According to this statement, humane experimentation is justified only if its results benefit society and it is carried out in accord with basic principles that *“satisfy moral, ethical, and legal concepts.”* To some extent the Nuremberg Code has been superseded by the Declaration of Helsinki as a guide for human experimentation.

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion, and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.
2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury disability or death.
8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.
10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required by him that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

It has been just over a week when the European Parliament president, Ursula von der Leyen exhibited her Fascist heritage by dissing the Nuremberg Treaty. She sees it as interfering with the global murder by the vaxx needle of millions of people and Klaus Schab's Great Reset. President of the European Commission Ursula von der Leyen has said that member states must begin to talk about making the Covid-19 vaccines mandatory.

"It is understandable and appropriate to lead this discussion now – how we can encourage and potentially think about mandatory vaccination within the European Union," von der Leyen said. Ursula Gertrud von der Leyen, who was disgraced by corruption scandals in her previous job as German Defense Minister, made the shocking comments to reporters a few weeks ago.

It is feared that the pronouncement may herald a push by Brussels for member states to implement the nightmarishly Orwellian move to force the vaccination on citizens despite national health remaining a national prerogative in the EU for now.

A federal appeals court late Friday in a split decision ruled that the Biden administration's vaccine mandate for private employers of companies exceeding 100 people can take effect as directed. I expected as much in this dragged out scenario of the war of free choice versus tyranny.

The 2–1 decision by a panel of the Cincinnati-based 6th U.S. Circuit Court of Appeals dissolves the stay entered by the 5th U.S. Circuit Court of Appeals last month on the nationwide mandate.

The rule issued by OSHA meant that some 84 million U.S. workers faced a January 4th dead line to get vaccinated before it was paused. It is unclear after the latest ruling Friday when the requirement will be in effect.

The case was brought by multiple businesses, including the American Family Association; multiple individuals; and several states, including Texas, Utah, and Mississippi. Petitioners said the mandate, promulgated as an Emergency Temporary Standard (ETS) by the Department of Labor's Occupational Safety and Health Administration (OSHA), should be struck down because it exceeds OSHA's authority under the Occupational Safety and Health Act.

The ruling comes after several industries – including airlines and the big three US automakers – agreed not to mandate vaccines for their union employees.

Judge Julia Smith Gibbons wrote in her majority opinion (pdf) on Friday, *“Given OSHA’s clear and exercised authority to regulate viruses, OSHA necessarily has the authority to regulate infectious diseases that are not unique to the workplace.”*

She added, *“Indeed, no virus—HIV, HBV, COVID-19—is unique to the workplace and affects only workers. And courts have upheld OSHA’s authority to regulate hazards that co-exist in the workplace and in society but are at heightened risk in the workplace.”*

Gibbons was appointed by President Ronald Reagan, a Republican. The other judge who ruled in favor of the OSHA mandate, Jane Branstetter Stranch, was appointed by President Barack Obama, a Democrat.

Earlier this week, the 6th Circuit’s active judges rejected a move to have the entire panel consider the case, on an 8–8 vote, reported The Associated Press.

The dissenting judge, Joan Louise Larsen, was appointed by President Donald Trump, a Republican. In her dissenting opinion, she noted that Congress did not authorize OSHA to create such a rule; furthermore, to work around Congress, the rule did not meet the emergency standard of necessity that the secretary of labor needed to bring it about.

“The Secretary has not made the appropriate finding of necessity,” she noted. *“An emergency standard must be ‘necessary to protect employees from [grave] danger.’”*

She wrote, *“The purpose of the mandate is to protect unvaccinated people. The rule’s premise is that vaccines work. And so, OSHA has explained that the rule is not about protecting the vaccinated; they do not face ‘grave danger’ from working with those who are not vaccinated.”*

She also added, *“[A] multitude of petitioners—individuals, businesses, labor unions, and state governments—have levied serious, and varied, charges against the mandate’s legality. They say, for example, that the mandate violates the nondelegation doctrine, the Commerce Clause, and substantive due process; some say that it violates their constitutionally protected religious liberties and the Religious Freedom Restoration Act of 1993. To lift the stay [by the 5th Circuit] entirely, we would have to conclude that not one of these challenges is likely to succeed. A tall task.”*

Under the rule, employees who are not fully vaccinated would have to wear masks and be tested on a weekly basis for COVID-19. Exceptions would apply to those who work outdoors or from home.

The OSHA rule threatens fines of up to \$13,600 per violation. It also threatens to fine an additional \$13,600 per day that an employer does not abate the violation. For a willful, or serious, violation OSHA can issue a fine up to \$136,000.

Arkansas Attorney General Leslie Rutledge denounced the ruling. In a statement, she indicated she would move to ask the U.S. Supreme Court to block it. *“The Sixth Circuit’s decision is extremely disappointing for Arkansans because it will force them to get the shot or lose their jobs,”* she said.

South Carolina Attorney General Alan Wilson, who chairs the Republican Attorneys General Association, expressed disappointment in the decision. *“We are confident the mandate can be stopped,”* he wrote on Twitter, adding: *“We will go immediately to the Supreme Court—the highest court in the land—to fight this unconstitutional and illegal mandate. The law must be followed and federal abuse of power stopped.”*

The Nuremberg Code Outlaws Forced Medical Procedures, Which INCLUDES Mandatory Vaccinations.

Some people might not be familiar with the verb “to dissemble”, but we all need to become familiar with it, because there is a lot of dissembling going on. Dissembling is the inclination or practice of misleading others through lies or trickery. An example is this: Leading Cause of Death for Americans Aged 18-45 is NOT Covid — It’s Fentanyl

Never before has immunization of the entire planet been accomplished by delivering a synthetic mRNA into the human body. It is a medical experiment to which the Nuremberg Code must be applied ...Allegedly around 52% of the world population has received at least one shot. Honest disclosure of the true number of “vaccine” injured, terminally injured as well as deceased worldwide is long overdue... We must be provided with the true numbers of covid vaccine casualties now.

“To dissemble”, basically means to deliberately conceal something or obfuscate it, so that one’s attention is misdirected or deflected from whatever the Dissembler wishes to obscure. Like the truth! And in this case, the truth about the Nuremberg Code and the protection it provides us from accepting any forced medical procedure or therapy at all.

Together with casting doubts and slander, dissembling is one of the chief tools in the propagandist toolbox. This is the kind of statement that politicians often resort to because of gullible poor souls that have been dumbed down by their schools.

Some months ago I wrote an article explaining that forced vaccinations are a violation of the Nuremberg Code. Note the word, “forced”. In fact, any forced medical procedure or therapy is against the Nuremberg Code.

All medical procedures and therapies must have fully informed and freely given consent, to the greatest extent possible – which means that people who are conscious and able to decide things for themselves remain in control of their medical destiny.

It's only when you are in desperate straits and unconscious that medical professionals are allowed to step in and make decisions "for you".

This is all cut and dried and set in cement since the 1940s, but now we have people trying to disassemble it and water it down and reinterpret the Nuremberg Code as applying only to medical experimentation.

It does not! As a member of the U.S. Army in the 1950s we were repeatedly instructed in what the Nuremberg Code meant. Every six months we were required to attend in-classroom lectures on the Nuremberg Code and the Geneva Convention.

The Code itself explains exactly what it applies to, and even though the cases giving rise to the Code arose from medical experiments in Concentration Camps and involved forced medical experimentation on unwilling subjects, the core of the Nuremberg Code rose to the occasion and outlawed all kinds of forced medical procedures and therapies. Not just experimental procedures. We should not be in this discussion at all but it seems our leaders have forgotten we went to war with Germany over such crimes.

Any medical procedure or therapy that you don't want to participate in, you have the full, free, and unprejudiced right to refuse. Period.

Go back and read Article 6, Sections 1 and 3, of the Nuremberg Code for yourselves.

Don't take anyone else's word for it. Not even mine. Be sure to make good use of the information if anyone comes to your door with a needle in hand. Chances are you will see them at your door next year! I would bet on it happening, and albeit for reasons that can only be described as Satanic!

Another good one to quote in their faces is their own cherished Roe vs. Wade decision, the excuse for allowing abortion on demand. My body, my choice! That applies to every aspect of your body, what you take out and what you put into it, too.

This is an example of a dissembling 'news' article so that you can see exactly how they disassemble the actual important information and misrepresent it to mean something else:

The same article draws attention to the fact that the Nuremberg Code doesn't make vaccination illegal. Who said it did? They are deliberately creating a False Argument as a means to obfuscate. Remember that the liars will twist word meanings to suit their agenda.

"So if you want to be vaccinated, after being fully informed of all the possible downsides and consequences, after understanding exactly what the vaccine contains, after

understanding that you will have extremely limited rights of recourse if you voluntarily take the injection and something goes wrong – then you are free to take your chances and do as you will. It's your choice.”

The Nuremberg Code won't protect you from your own fully disclosed consent.

The Nuremberg Code makes FORCED vaccination illegal – along with all other forced medical procedures and therapies. The Nuremberg Code doesn't single out vaccinations or any other procedure or therapy – it outlaws all forced procedures and therapies with the same broad brush.

But it will protect you from being imposed upon by politicians and “private security forces” hired by banks that are colluding in this scheme to defraud America under color of law.

The Nuremberg Code gives you full standing, if they attempt to violate it and force any kind of involuntary or undisclosed vaccination on you by any means – whether by wrestling you to the ground or by threatening to deprive you of any other right or privilege, including the right to travel and use public facilities. **Full Standing is a legal term that refers to the capacity of a plaintiff to bring suit in court.** Typically, the plaintiff must have suffered an actual harm by the defendant, and the harm must be redressable.

All indications are that we are entering a very dark chapter in American history. You will need to stay alert and stay informed, and you are not being given straight information from any of the commercial media channels or their acolytes and paid trolls. You need to read things with a critical eye and be able to discern the tricks the propagandists employ.

Now read the actual Nuremberg Code Sections – Article 6, Sections 1 and 3.

Then stand your solid ground against forced medical procedures of any kind and also against all the dissembling bovine excrement artists out there, because they are multiplying like bunnies in the spring.

Vaccination / chipping is moving by leaps and bounds and people around the world are already starting to think about how to avoid this miraculous manipulation. Of course, no one knows the laws, but in different countries the laws are also different, however, there is a universal law. It is called the Nuremberg Code.

The Nuremberg Code is an international document regulating the principles of conducting medical experiments and procedures on people. The Code was developed and adopted after the Nuremberg trial of doctors in 1947, as a result of which many, many citizens were sent to the gallows, in particular for the forcible administration of different vaccines to people.

As American lawyers write, the key points are 1 and 6 – that is, the person involved in the vaccination must be capable to give consent; a person should be able to exercise freedom of choice, without the intervention of any element of force, deception, coercion, direct or hidden; the person must possess sufficient knowledge and understanding of the elements of the subject in question. The next universal legal document is called Article 6 of the 2005 UNESCO statement on bioethics and human rights. It is written there:

Article 6, section 1. Any preventive, diagnostic and therapeutic medical interventions should be carried out only with the prior, free and informed consent of the person concerned on the basis of adequate information. If necessary, consent must be expressed and can be revoked by the person concerned at any time and for any reason.

Article 6, section 3: In no case shall the collective agreement of the community or the consent of the community leader or other authority be a substitute for the informed consent of individuals.

Thus, any orders of a particular Parliament or a celebrated supreme leader on compulsory vaccination will violate Article 6 of the UNESCO statement on human rights and bioethics. Along the way, they violate the Nuremberg Code, in particular Article 1 and Article 6. It is still unknown how the authorities of different countries will try to circumvent these fundamental ethical documents. When the President of the European Parliament recently brought the issue to the Parliament, it was met with vocal criticism by more than a half-dozen Parliament members who held a press conference and were prepared to fight the suggestion of abandoning the Nuremberg Treaty.

One member, Christine Anderson, said, *“So dear Government bring it on, let’s see what you got, I am not afraid of you!”* She went on further, *“The majority of representatives are selling you down the river. Forcing people into compliance is not democratic or legitimate. And it’s not about your health, either. Big Pharma companies are as interested in your health as arms contractors are interested in peace.”* Christine Anderson so happens to be also German and she asymmetrically put Ursula Gertrud von der Leyen in her place!

State-sponsored/MSM supported medical tyranny is the new abnormal throughout the US/West and elsewhere worldwide.

To my great dismay, intelligent people I know are oblivious to reality on what’s crucial to know — believing rubbish fed them daily from official, MSM, and other disreputable sources instead of what’s scientifically indisputable. It is very disconcerting to know that the public is so easily bullied by those in elected office.

Individuals taking them *"should be considered suicidal or certified insane."*

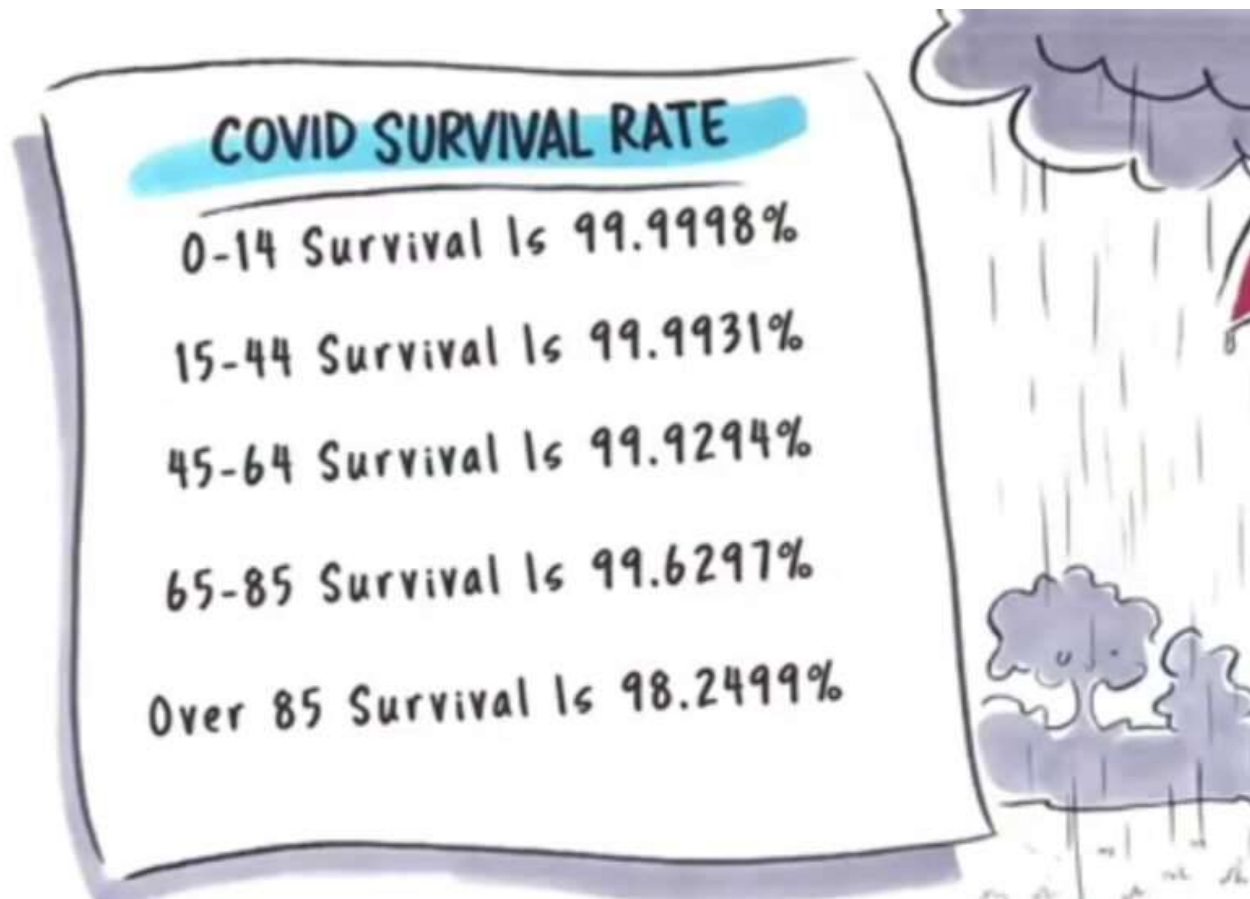

The emails, released on Friday by the House Select Subcommittee on the Coronavirus Crisis, show retiring NIH Director Francis Collins telling Fauci in October 2020 to discredit the Great Barrington Declaration (GBD) – a statement that proposes working towards achieving herd immunity through "focused protection" of the most vulnerable. Days after the GBD was released, Collins notified Fauci and other health officials about how the proposal from "three fringe epidemiologists" was getting a "lot of attention" and called for a "quick and devastating published take down of its premises."

The thread summarizing what we've learned so far of the Fauci/Collins email dump on the Great Barrington Declaration:

It starts on 10/14/20 when Collins instructs Fauci and his staff to "take down" the GBD and the "fringe" scientists behind it.

A short time later, Fauci emails Collins an op-ed from *‘Wired’* magazine that “*debunks this theory*” and calls out the three scientists – Martin Kulldorff, an epidemiologist at Harvard University, Sunetra Gupta, an epidemiologist at Oxford University, and Jay Bhattacharya, a public health policy expert at Stanford University – for touting an approach without “*following the scientific method*” for peer-reviewed hypotheses.

After Collins lauds this “*excellent*” response, Fauci sends him another op-ed in *‘The Nation’* magazine that “[*refuted*] the herd immunity approach.” Collins replies agreeing with article that the idea is a “*deadly delusion.*”

Far from a scientific study refuting the GBD, Gonsalves’s article is a political op-ed attacking @Jacobin magazine for breaking “solidarity” with other far-left media outlets on lockdowns. Why? Because Jacobin ran an interview with @MartinKulldorff on how lockdowns hurt the poor.

This part of the exchange was not included in disclosures by the subcommittee in its year-end report, but was posted in a series of tweets by Phil Magness, education director at the American Institute for Economic Research (AIER), a libertarian think tank that sponsored the GBD. Magness condemns the “smear campaign” later launched by Collins against the scientists through a *‘Washington Post’* article in which he was quoted.

Fauci also emailed former White House Coronavirus Response Coordinator Deborah Birx about taking a “*very [strong]*” public stance against the GBD.

10/16/20 is as far as I’ve gotten in piecing together the story of what happened. Still more documents to go through, including some more explosive revelations about where Fauci was getting his anti-GBD talking points. So stay tuned!

Following the release of the emails, Dr. Bhattacharya said he was the “*subject of a propaganda attack by my own government*” while Kulldorff tweeted that an “*invitation*” to a “*public debate*” on herd immunity was still open.

During a Fox News interview on Friday, Collins stood by his “*take down*” comment, claiming that the herd immunity approach “*didn’t make sense*” to him since adopting it would have led to “*hundreds of thousands of additional deaths.*”

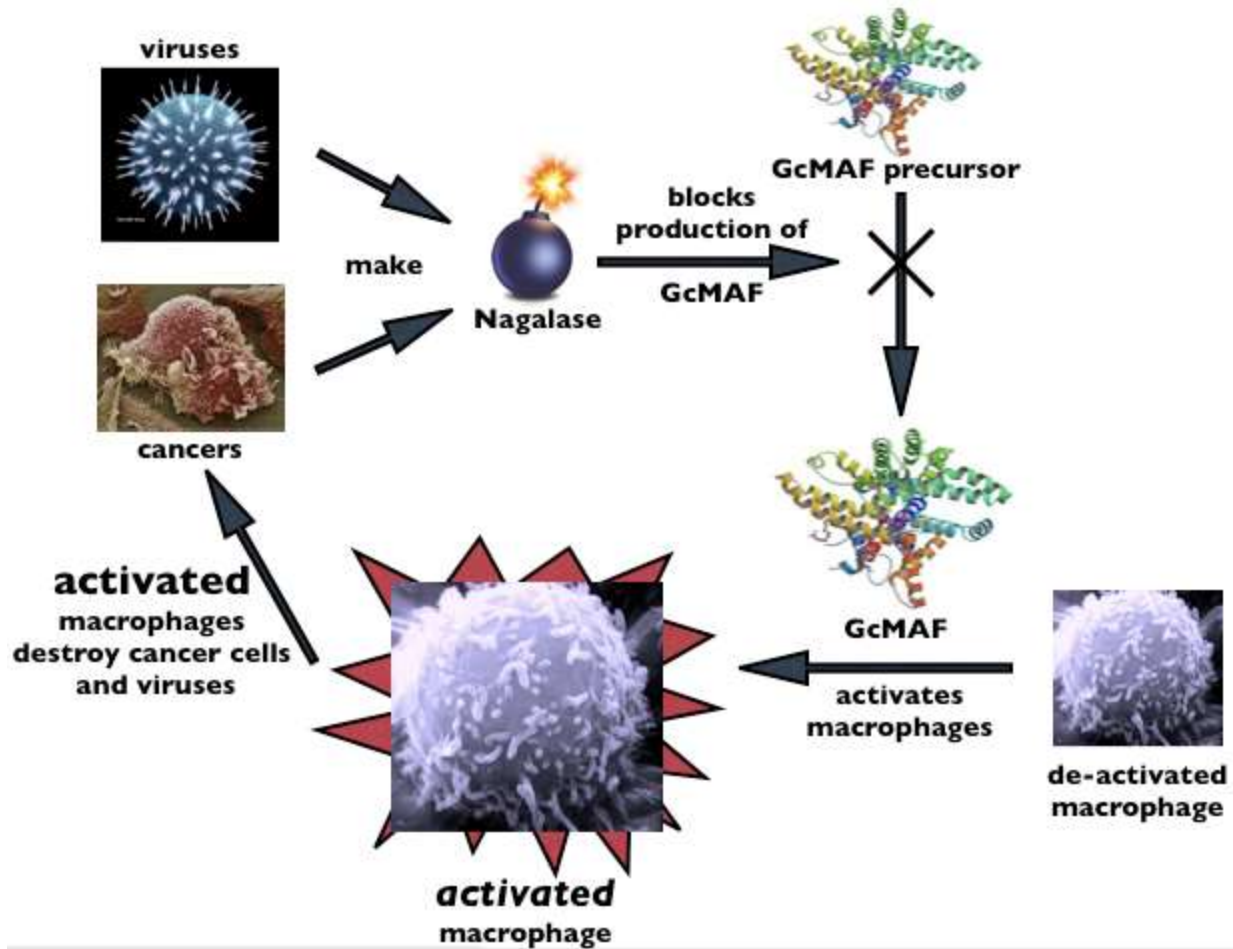
Almost all of them were operating in ways that undermined traditional pharmaceutical-based treatments.
