The airfare is a hefty \$51,000 and change.

condition myocarditis, and neurologically disabling disease like Guillain Barré Syndrome, as well as thousands of recorded deaths and permanent disabilities. Covid is an imaginary virus masking for a technology with potential earnings of \$13-17 Trillion dollars. grew legs and traction. The “*Diamond Princess*” became a Petri Dish for what the World Health Organization tagged it as a “pandemic”, 14 dead and nearly 800 sick diagnosed with the Coronavirus. Little was mentioned about those who died were in their 70s and 80s, or that the “*Diamond Princess*” had just a few months prior been retrofitted with the latest **5G** transceivers for the ultimate in communications. With the new **5G** technologies, passengers and crew could maintain contact with the world in latitudes of 60-degrees north and 60-degrees south of the Equator. The Arctic Circle is 66-degrees latitude and communications at the remote regions was an emergency luxury.

Truth be known, COVID-19 is a Smokescreen for **5G** Radiation Sickness. A little known fact is that the *Diamond Princess* was sporting some new high tech **5G** towers. An earlier news release explained that “Princess Cruises has announced a new dimension in its connectivity partnership with SES and will become the first global cruise ship fleet with early access to SES’s O3b mPOWER network augmenting the ‘Princess Medallion Class’ experience as it sales across the fleet, according to a press release. ‘*Cruise Industry News*’, February 3, 2020. Is there a connection between the newly installed **5G** network on the ship and the passengers being struck ill with coronavirus? It should be noted that only the Princess cruise line that had installed the **5G** had outbreaks of COVID-19. In March 2020, the *Grand Princess* had outbreaks of COVID-19 before docking in San Francisco. The *Ruby Princess* was reported to have had an outbreak of COVID-19 involving 600 passengers prior to docking on March 19, 2020, at Sydney, Australia. All of those ships are Medallion Class ships with the new **5G** tower connectivity from SES’s O3b mPOWER.

On December 25<sup>th</sup>, 2021, A U.S. Navy warship has paused its deployment to South America due to a COVID-19 outbreak among its “100 percent immunized” crew, the Navy announced on Christmas Eve. The USS Milwaukee (LCS 5), a Freedom variant littoral combat ship, remains in port as some Sailors test positive for COVID-19,” the U.S. 4th Fleet said in a press statement.

*“The crew is 100 percent immunized and all COVID-19 positive Sailors are isolated on board and away from other crew members. A portion of those infected have exhibited mild symptoms. The vaccine continues to demonstrate effectiveness against serious illness.”*

The ship currently remains in port at Naval Station Guantanamo Bay, located at the southeastern end of Cuba. It had departed December 14 from Mayport, Florida, and was heading into the U.S. 4th Fleet area of operations to support Joint Interagency Task Force South’s mission, which includes counter-illicit drug trafficking missions in the Caribbean and Eastern Pacific.

The U.S. 4th Fleet’s statement did not quantify the number of those infected, nor how many among them are exhibiting mild symptoms. The specific COVID-19 variant has yet to be determined. The ship is following Centers for Disease Control and Prevention (CDC) guidelines for contact tracing and testing.

COVID-19 cases have recently increased drastically across the United States amid the spread of the contagious Omicron variant, or so we are being told.

The ship is also “following an aggressive mitigation strategy” in accordance with Navy and CDC guidelines.

It was In early 2020, a separate Navy warship, the aircraft carrier USS Theodore Roosevelt that was operating in the Pacific region, was sidelined for about 10 weeks in Guam owing to an alleged outbreak of COVID-19. About 1,000 of the 4,800 sailors on the ship got infected, and a 41-year-old sailor died from COVID-19. On December 18, 2021, the Navy reported the death of the 17<sup>th</sup> U.S. Navy person to die from again, the alleged Covid-19. The latest was a nurse, Lt. Ivey Quintana-Martinez, 35, is the 17th sailor the Navy has lost to COVID-19, according to a USNI News tally of COVID-19 deaths. Quintana-Martinez, of Lake Elsinore, Calif., died at Cedar Sinai Medical Center in Los Angeles, Calif., on Dec. 18.

More than 98 percent of all active-duty sailors have been fully vaccinated, according to the latest data from the Navy.

Strangely enough, this cruise ship virus story keeps re-surfacing. The *Queen Mary 2* arrived in the New York area (at Cunard’s Red Hook pier in Brooklyn) yesterday for the first time in nearly two years. Unfortunately, the ocean liner also brought with it guests who tested positive for COVID-19. The cruise line released a press statement stating that ten COVID-19 positive guests were disembarked upon the ship’s arrival in New York. *‘The Express’* newspaper in the UK characterized the stop as involving “*up to 1,000 passengers are in isolation*” and are “*stranded*” in the city after a COVID-19 outbreak during their cruise from Southampton to New York. At least one Twitter user characterized the stop differently stating “Not stranded – QM2 is on a planned three day turnaround.”

But other media sources report that guests on the Cunard ship must isolate in New York City. A local NBC station in New York reports that:

It’s not clear how often testing is performed on the ship, or whether the requisite pre-embarkation testing is a three-day window or more immediate. It also wasn’t known which strain of COVID the travelers had or if rapid tests were used.

Data indicates the new omicron variant replicates so rapidly in airways — up to 70 times faster than the delta variant— that it’s possible a person’s COVID status could change more quickly than with other strains. Experts say if rapid tests are being used, it’s advised that they be administered as close to travel time as possible.

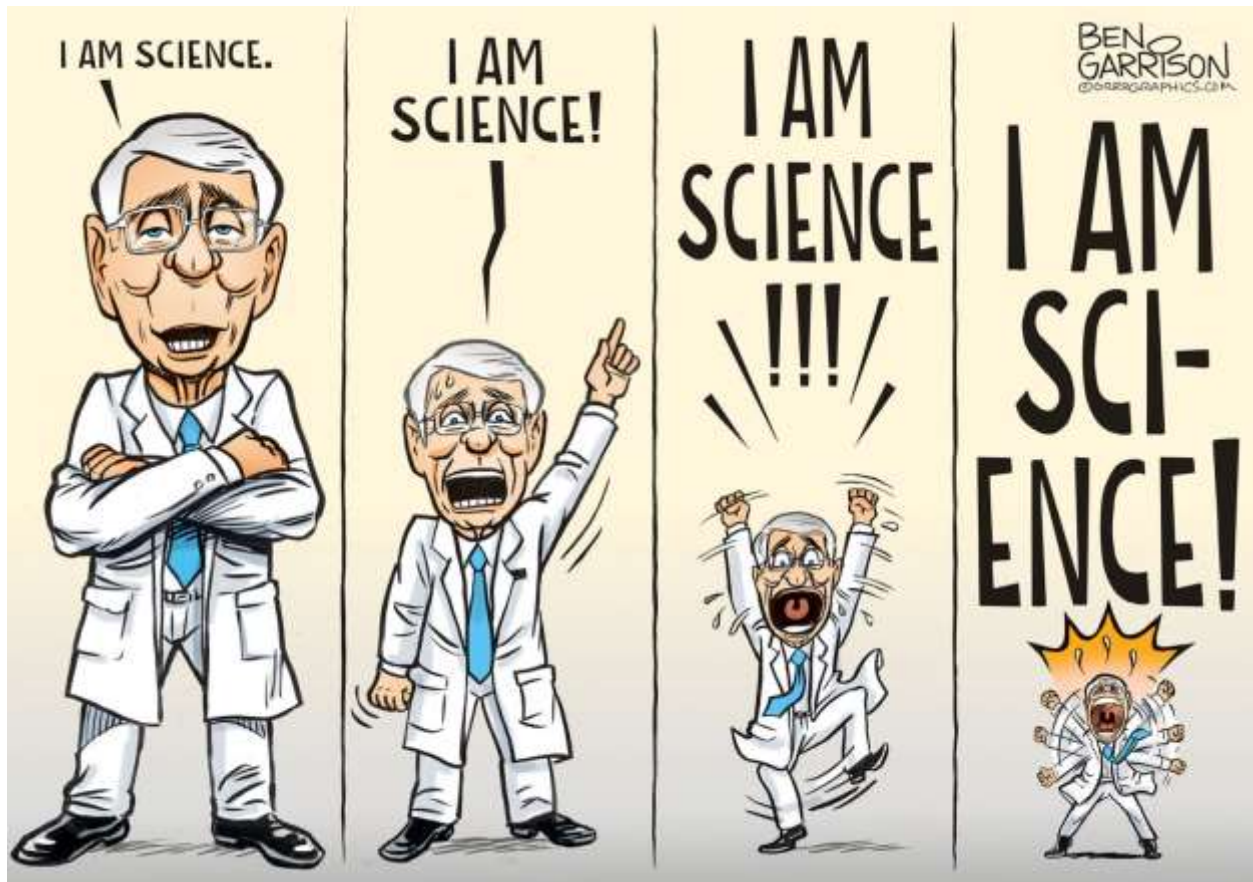
Omicron now is the alleged dominant variant in the U.S., federal health officials said Monday, accounting for about three-quarters of new infections last week. It is expected to become the world’s most pervasive strain as well. Where is the proof? Who is saying that and where is the evidence for those claims? Health authorities in Botswana,



South Africa where the first case of the new variant omicron was found are saying it is just a cold, a tempest in a teapot, or a great commotion over an unimportant matter. Medical personnel in Botswana are saying this case is not serious as others have made it out to seem.

There has been an unfortunate shift in Western educational practices in the past few decades away from what we used to call “critical thinking.” In fact, critical thinking was once a fundamental staple of U.S. colleges and now it seems as though the concept doesn’t exist anymore; at least not in the way it used to. Instead, another brand of learning has arisen which promotes “right thinking”; a form of indoctrination which encourages and rewards a particular response from students that falls in line with ideology and not necessarily in line with reality.

It’s not that schools directly enforce a collectivist or corporatist ideology (sometimes they do), it’s more that they filter out alternative viewpoints as well as facts and evidence they do not like until all that is left is a single path and a single conclusion to any given problem. They teach students how to NOT think by presenting thought experiments and then controlling the acceptable outcomes.

For example, a common and manipulative thought experiment used in schools is to ask students to write an “analysis” on why people do not trust science or scientists these days. The trick is that the question is always presented with a built-in conclusion – That scientists should be trusted, and some people are refusing to listen, so let’s figure out why these people are so stupid.

I have seen this experiment numerous times, always presented in the same way. Not once have I ever seen a college professor or public school teacher ask students: *“Should scientists today be trusted?”*

Not once. This is NOT analysis, this is controlled hypothesis. If you already have a conclusion in mind before you enter into a thought experiment, then you will naturally try to adjust the outcome of the experiment to fit your preconceived notions. Schools today present this foolishness as a form of thinking game when it is actually propaganda. Students are being taught to think inside the box, not outside the box. This is not science, it is anti-science.

Educational programming like this is now a mainstay while actual science has taken a backseat. Millions of kids are exiting public schools and universities with no understanding of actual scientific method or science in general. Ask them what the equations for Density or Acceleration are, and they’ll have no clue what you are talking about. Ask them about issues surrounding vaccination or “climate change”, and they will regurgitate a litany of pre-programmed responses as to why the science cannot be questioned in any way.

In the alternative media we often refer to this as being *“trapped in the Matrix,”* and it’s hard to think of a better analogy. People have been rewarded for so long for accepting the mainstream narrative and blindly dismissing any other information that when they are presented with reality they either laugh at it arrogantly or recoil in horror. The Matrix

is so much more comfortable and safe, and looks at all the good grades you get when you say the right things and avoid the hard questions and agree with the teacher.

Given the sad state of science in the West these days surrounding the response to Covid as well as the insane and unscientific push for forced vaccinations, I thought it would be interesting to try out this thought exercise, but from an angle that is never allowed in today's schools:

Why don't people trust the science and scientists anymore? This is simple:

***Because many scientists have been caught lying and misrepresenting their data to fit the conclusions they want rather than the facts at hand. Science is often politicized to serve an agenda. This is not conspiracy theory, this is provable fact.***

That's not to say that all science is to be mistrusted. The point is, no science should be blindly accepted without independent examination of ALL the available facts. This is the whole point of science, after all. Yes, there are idiotic conspiracy theories out there when it comes to scientific analysis, but there are a number of scams in the world of science as well.

The usual false claim is that the average person is ignorant and that they don't have the capacity to understand scientific data. I do find it interesting that this is the general message of the trust-science thought experiment. It fits right in line with the mainstream and government narrative that THEIR scientists, the scientists they pay for and that corporations pay for, are implicitly correct and should not be questioned. They are the high priests of the modern era, delving into great magic's that we dirty peasants cannot possibly grasp. It is not for us to question "the science", it our job to simply embrace it like a religion and bow down in reverence.

Most people have the capacity to sift through scientific data as long as it's transparent. When the facts are obscured or spun or omitted this causes confusion, and of course only the establishment scientists can untangle the mess because they are the ones that created it. Let's look at a couple of examples directly related to human health...

### **GMO Crops And The Corporate Money Train**

The propaganda surrounding Genetically Modified Organisms is relentless and pervasive, with the overall thrust being that they are perfectly safe and that anyone who says otherwise is a tinfoil hat crackpot. And certainly, there are hundreds if not thousands of studies which readily confirm this conclusion. So, case closed, right?

Not quite. Here is where critical thinking is so useful and where reality escapes the indoctrinated – Who paid for these studies, and do they have a vested interest in censoring negative data on GMOs?

Well, in the vast majority of cases GMO studies are funded by two sources – GMO industry giants like Monsanto, DuPont and Syngenta, or, government agencies like the FDA and EPA. Very few studies are truly independent, and this is the problem. Both the

government and corporations like Monsanto have a vested interest in preventing any critical studies from being released on GMO's.

Monsanto has been caught on numerous occasions hiding the dangerous health effects of its products, from Agent Orange to the RGBH growth hormone used in dairy cows. They have been caught compiling illegal dossiers on their critics. The industry has been caught multiple times paying off academics and scientists to produce studies on GMOs with a positive spin and even to attack other scientists that are involved in experiments that are critical of GMOs. Research shows that at least half of all GMO studies are funded by the GMO industry, while the majority of the other half is funded by governments.

There has also long been a [revolving door between GMO industry](#) insiders and the FDA and EPA; officials often work for Monsanto and then get jobs with the government, then go back to Monsanto again. The back scratching is so egregious that the government even created special legal protections for GMO companies like Monsanto under what is now known as the Monsanto Protection Act (Section 735 of Agricultural Appropriations Bill HR 993) under the Obama Administration in 2013. This essentially makes GMO companies immune to litigation over GMOs, and the same protections have been renewed in different bills ever since.

Beyond the revolving door, the government has approved many GMO products with little to no critical data to confirm their safety. Not only that, but in most cases the government has sovereign immunity from litigation, even if they've been negligent. Meaning, if any of these products is proven to cause long term health damage the government cannot be sued for approving them unless there are special circumstances. If they could be held liable, you would be damn sure the FDA would be running every conceivable test imaginable to confirm GMOs are definitively safe without any bias attached, but this is not the case. Instead, the government [actively propagandizes](#) for GMO companies and uses hired hatchet men to derail any public criticism.

I, for one, would love to know for sure if GMOs are harmful to the human body in the long term, and there is certainly science to suggest that this might be the case. There have been [many situations](#) in which specific GMO foods were removed from the market in foreign countries because of potentially harmful side effects. Endogenous toxins of plants with modified metabolites are a concern, along with "plant incorporated protectants" (plants designed to produce toxins which act as pesticides).

There is data that tells us to be wary, but nothing conclusive. Why? Because billions of dollars are being invested by corporations into research designed to "debunk" any notion of side effects. If the same amount of funding was put into independent studies with no bias, then we might hear a different story about the risks of GMOs. All the money is in dismissing the risks of GMOs; there's almost no money in studying them honestly.

The science appears to be rigged to a particular outcome or narrative, and that is lying. Science is supposed to remain as objective as possible, but how can it be objective when it is being paid for by people with an agenda? The temptation to sell out is extreme.

### **Covid Vaccines and The Death Of Science**

I bring up the example of GMO's because I think it is representative of how science can be controlled to produce only one message while excluding all other analysis. We don't really know for sure how dangerous GMOs are because the majority of data is dictated by the people that profit from them and by their friends in government. The lack of knowing is upheld as proof of safety – But this is not scientific. Science and medicine would demand that we err on the side of caution until we know for sure.

The same dynamic exists in the world of covid vaccines. Big Pharma has a vested interest in ensuring NO negative information is released about the mRNA vaccines because there is a perpetual river of money to be made as long as the vax remains approved for emergency use by the FDA. It may be important to note that the FDA has said it will take [at least 55 YEARS](#) to release all the data it has on the Pfizer covid vaccines, which suggests again that there is a beneficial collusion between the government and corporate behemoths.

In the meantime, anyone that questions the efficacy or safety of the vax is immediately set upon by attack dogs in the media, most of them paid with advertising dollars from Big Pharma. These attacks are not limited to the alternative media; the establishment has also gone after any scientist or doctor with questions about vaccine safety.

There are clear and openly admitted ideological agendas surrounding covid science which have nothing to do with public health safety and everything to do with political control. When you have the head of the World Economic Forum [applauding the covid pandemic](#) as a perfect “*opportunity*” to push forward global socialist centralization and erase the last vestiges of free markets and individual liberty, any rational person would have to question if the Covid science is also being rigged to support special interests.

Luckily, the Covid issue is so massive that it is impossible for them to control every study. Instead, the establishment ignores the studies and data they don't like.

The virus is being hyped as a threat to the majority of the public and as a rationale for 100% vaccination rates, by force if needed. Yet, the [median Infection Fatality Rate of covid is only 0.27%](#). This means that on average 99.7% of the population at any given time has nothing to fear from the virus. This is confirmed by dozens of independent medical studies, but when was the last time you heard that number discussed by mainstream government scientists like Anthony Fauci?

I've never heard them talk about it. But how is it scientific to ignore data just because it doesn't fit your political aims? Again, deliberate omission of data is a form of lying.



What about the multiple studies indicating that [natural immunity is far superior](#) in protection to the mRNA vaccines? What about the fact that the countries with the highest vaccination rates also have the highest rates of infections and their hospitalizations [have actually increased](#)? What about the fact that the states and countries with the harshest lockdown and mask mandates also have the [highest infection rates](#)? What about the fact that the average vaccine is tested for 10-15 years before being approved for human use, while the covid mRNA vaccines were put into production within months? That is to say, there is NO long term data to prove the safety of the Covid vax.

These are easily observable scientific facts, but we never hear about them from corporate scientists or government scientists like Fauci. Instead, Fauci argues that criticism of his policies is an attack on him, and attacking him is [the same as "attacking science."](#) In other words, Fauci believes HE IS the science.

And doesn't that just illustrate how far science has fallen in the new millennium. Real scientists like Kary Mullis, the inventor of the PCR test, [call Fauci a fraud](#), but they are ignored while Fauci is worshiped. I can't even get into climate change "science" here, I would have to write an entire separate article about the fallacies perpetrated by global warming academics (did you know that global temperatures have only increased by 1 degree Celsius in the past century? Yep, just 1 degree [according to the NOAA's own data](#), yet, institutions like the NOAA continue to claim the end of the world is nigh because of global warming).

The stringent bottleneck on science today reminds me of the Catholic church under Pope Innocent III when church authorities forbade common people from owning or reading a Bible in their own language. These laws remained in effect well into the 13th and 14th centuries. Instead, the peasants were to go to church and have the texts read to them by specific clergy. Often the Bible readings were done in Latin (bibles were only allowed to be written in Latin) which most people did not speak, and interpreted however the church wished.

It was only the invention of the printing press in the 1400s that changed the power dynamic and allowed Bibles to be widely distributed and information to spread without church oversight. Much like the creation of the internet allows the public to access mountains of scientific data and methodologies at their fingertips. The free flow of information is an anathema according to the establishment; they argue that only they have the right to process information for public consumption.

Cultism requires excessive control of data and the complete restriction of outside interpretations. As information becomes openly available the public is then able to learn the whole truth, not just approved establishment narratives.

Science is quickly becoming a political religion rather than a bastion of critical thought. Conflicting data is ignored as "non-science" or even censored as "dangerous." Government and corporate paid studies are treated as sacrosanct. Is it any wonder that

so many people now distrust the science? Any reasonable person would have questions and suspicions. Those who do not have been indoctrinated into a cult they don't even know they are a part of.

The very reason I share Brandon Smith's post is directly relevant to the scope of my article. This information stands out in Robert Kennedy's book, *'The Real Dr. Fauci'*. Dr. Fauci's idea of science is very much like that Brandon describes. Dr. Fauci has built his empire at the NIAID on a host of lies, deceptions, rigged results, and buried studies that counter his agenda to true science, and since Fauci controls the purse string of research money, he has been able to control the outcome of his crimes. The U.S. Supreme Court will take into consideration Mr. Science, they have no choice, and he has been at the helm for 50 years. Thousands of researchers adhere to his protocols or they do not get grant money to do research. An afterthought cruise passengers are facing an added expense should they be infected once again. The cruise line's press release refers to the alleged *"length and complexity of the onward itinerary, which includes a number of Caribbean ports of call and countries."* But the itinerary is actually quite straight-forward. The cruise liner is scheduled to call on the British Virgin Islands on December 26th. It will then sail on to four additional Caribbean ports – St. Kitts, Barbados, Dominica and St. Maartan – before it arrives back in New York on January 3, 2022. It will then cross across the Atlantic and arrive back in Southampton on January 10th.

Cunards's press release mentions that upon an unspecified period of isolation and upon a negative COVID-19 test, departing guests may be picked up in New York before the ship begins its journey back to the U.K.

Neither Cunard nor parent Carnival Corporation are stating who will be responsible for the meals and lodging in New York or for additional transportation costs in the event that passengers wish to avoid returning to the ship and prefer to fly home to England. *'The Express'* newspaper states that *"yesterday, rumors were rife they (passengers) were going to disembark and stay at the Holiday Inn in Brooklyn, where they will isolate for 10 days, allegedly at their own expense."*

*'The Express'* also stated that last week around 60 COVID-19 positive passengers were confined to their cabins on one isolation corridor. *"Another isolation corridor is said to be almost full, say passengers who have paid thousands of pounds for the once in a lifetime trip. They fear the cruise chiefs may force them off so the isolation cabins are empty in case more test positive ..."*

If history is any guide, it is likely that there are more than just ten guests on the ship who have been infected and will likely infect others.

This outbreak comes just a couple of days after around fifty guests tested positive for COVID-19 on the *"Symphony of the Seas."* You can read more about that COVID-19 outbreak in COVID-19 Cases Increase on cruise ships as lines suppress information. Many guests were offloaded from the *"Symphony"* and sent to a local Holiday Inn here in Miami where some passengers complained that they were placed in a large conference room without food or water. Since two days ago, there are at least two more cruise ships with outbreaks. There are probably more outbreaks that have not been reported to the government health agencies. The cruise lines are maintaining a level of secrecy rivaling military secrets to maintain a blackout on all Covid data. The Mexican Secretary of Health for the Eighth Health Region blocked the *HAL Koningsdam* from disembarking any of its 1,137 guests or 873 crew members into the port of Puerto Vallarta yesterday due to a COVID-19 outbreak involving at least nineteen of its crew members.

Two days before Christmas, there are two more accounts of cruise ships experiencing outbreaks of Covid-19, or **5G** radiation sickness. I have not included the details of the newest outbreaks I received reports on this morning.

I see nothing to disprove my premise that Covid-19 is being used to cover for **5G** EMF wireless energy radiation sickness. What is the effect of **5G** on humans? Dr. Magda Havas, Ph.D, sought to answer that question. Dr. Havas "compared the average number of cases, deaths, and tests for Covid-19 per million population in states with and without **5G**."

Dr. Havas found that the standardized testing for states with and without **5G** was similar. But he discovered a real difference in COVID-19 cases per million population for those states that deployed **5G**. Dr. Havas found that "**Covid-19 cases per million are 95% higher and covid-19 deaths per million are 126% higher in states with 5G.**"

Conclusion from Research Study:

There is a substantial overlap in pathobiology between COVID-19 and WCR [wireless communications radiation] exposure. The evidence presented here indicates that mechanisms involved in the clinical progression of COVID-19 could also be generated, according to experimental data, by WCR exposure. Therefore, we propose a link between adverse bio effects of WCR exposure from wireless devices and COVID-19.

Specifically, evidence presented here supports a premise that WCR and, in particular, **5G**, which involves densification of 4G, may have exacerbated the COVID-19 pandemic by weakening host immunity and increasing SARS-CoV-2 virulence by (1) causing morphologic changes in erythrocytes including echinocyte and Rouleau formation that may be contributing to hyper coagulation; (2) impairing microcirculation and reducing erythrocyte and hemoglobin levels exacerbating hypoxia; (3) amplifying immune dysfunction, including immune-suppression, autoimmunity, and hyper-inflammation; (4) increasing cellular oxidative stress and the production of free radicals exacerbating vascular injury and organ damage; (5) increasing intracellular Ca<sup>2+</sup> essential for viral entry, replication, and release, in addition to promoting pro-inflammatory pathways; and (6) worsening heart arrhythmias and cardiac disorders.

WCR exposure is a widespread, yet often neglected, environmental stressor that can produce a wide range of adverse bio effects. For decades, independent research scientists worldwide have emphasized the health risks and cumulative damage caused by WCR. The evidence presented here is consistent with a large body of established research. Healthcare workers and policymakers should consider WCR a potentially toxic environmental stressor. Methods for reducing WCR exposure should be provided



to all patients and the general population. One has to wonder whether the U.S. Supreme Court will hear this evidence and or whether it even matters. I'll come back to this point a bit later. The Supreme Court has set a date to hear the Biden "mandate" law suit.

What was interesting in the graphics and visuals, almost none included the human hand, and you can guess why that is. The illustration just above on this page does

show the hand, but I could not find any others picturing the hand as the point of connection between the “Mark” or “embedded” device.

Though the NFC Forum formed in 2004, it wasn't until 2006 that the group produced the first set of specifications for NFC tags. NFC tags are small objects, like a sticker, that contain information that a NFC compatible device, such as a smartphone, can intercept when passed over the NFC tag. The information on the tag is usually read-only, but certain tags do allow the device reading it to write new information to it or alter old information on the tag as well.

In 2006, the specifications for “smart” posters were created. Smart posters hold information that an NFC compatible device can read when passed over it. It can provide all manner of information, such as information about a famous piece of artwork hanging in a museum or a short biography of a famous person's life on a poster with their image on it.

The first NFC-compatible cell phone, the Nokia 6131, also surfaced during this time. As the years passed, more specifications emerged and the technology grew from payment methods to sharing videos, links, and game invites between smartphones and other NFC devices. Android produced its first NFC phone, the Samsung Nexus S, in 2010. She shops Kroger and builds her grocery items list, and the store tells which aisle the items are located in as well.

NFC technology not only lets businesses go green, but it saves money as well. NFC tags are relatively cheap to create and use, and can be altered as needed. Customers will often prefer shopping with a merchant that uses NFC technology over traditional paper coupons and credit card payments. It means the customer has less junk to keep track of, since everything is stored on his smartphone, and can increase repeat visits from that customer.


Getting back to my wife and the remarks that I keep reading about and hearing from others about their cell phones suddenly draining the battery. I began to do some research, asked some friends, and family members in the field of IT and communications to see what others had to say. Regretfully, because of my age, I am falling behind when it comes to what all is happening in the field of electronic communications. For the past few years I have been more focused and devoted to engaged in researching and studying **5G** and less on cell phone communications.

In activating my card I noticed the RFID logo on my debit card  and I began asking the customer service lady about the logo on the back of my debit card. Being physically disabled, my wife takes my card to shop for our groceries. I soon set out to find out how the technology functioned it became crystal clear how it tied the vaxx in the shoulder as the host for one's personal I.D. ## NEAR FIELD COMMUNICATION (NFC)

NFC Devices Operate in 3 Modes



Bringing two devices containing NFC chips together activates magnetic induction, similar to the way proximity cards and access cards carried by workers have been used to unlock doorways for years. Once the two devices are linked, they exchange data over the unlicensed 13.56 MHz radio spectrum -- the same spectrum as proximity RFID tags and contactless smartcards -- at the relatively slow data rate of up to 424 Kbps.

NFC supports encryption, and the fact that the devices must come so close together to communicate further bolsters security because the odds of a hacker intercepting a radio signal over such a short distance is minimal. NFC draws less power than Bluetooth wireless, but early rollouts of NFC are being studied to see how much the constant use of NFC may drain a smartphone.

The NFC Forum defines three modes (PDF) of NFC operation. Peer-to-peer mode enables two NFC devices to communicate with each other to exchange information and share files. Read/write mode enables NFC devices to read information stored on NFC tags embedded in smart posters and displays. Card emulation mode enables NFC devices to act like smart cards, allowing users to make retail and transit purchases.

NFC and other options in the U.S. are ideal for ease, security, and versatility.



Google Wallet is an application that uses NFC to make mobile payments. It first appeared in September 2011 in the U.S. on the Nexus S smartphone over the Sprint wireless network. The Samsung Galaxy S III launched in 2012 with NFC and S Beam (built on Android Beam) for data sharing.

Samsung also launched tiny NFC TecTile tags in 2012 that can be programmed and rewritten by NFC devices. For instance, a tag stationed near a bedside could be programmed to turn the phone's music app on each time the phone comes close. An NFC tag can also be used in a billboard or kiosk, much the same way QR codes are used to provide information when read by a smartphone or other enabled device.

When the Apple iPhone 5 launched in September 2012, many expected it would have NFC, but it did not. It instead relies on Apple's Passbook app and barcodes on the phone's display that are read by optical scanning terminals in stores and at airport check-in counters. Starbucks and Dunkin' Donuts also rely on optical scanners to read the barcodes on smartphone displays for customers who want to buy coffee and make other purchases. The late Rush Limbaugh was an Apple advocate and I remember him talking about (NFC) before he was diagnosed with lung cancer. This was at least four years ago, and since I get a hand-me-down phone from my son-in-law, I am only interested in being able to use the phone and text for emergency, that's it, nothing else.

In other mobile wallet developments in the U.S., the Isis joint venture of AT&T, Verizon Wireless and T-Mobile USA kicked off in October 2012 in Salt Lake City and Austin using nine-NFC ready smartphones to make purchases at NFC-ready terminals.

The activity around NFC and mobile wallet intensified in August, when more than a dozen major retailers including Best Buy, Walmart and Target formed the Merchant Customer Exchange (MCX), a mobile payments network.

MCX still hasn't said which payment technologies it is using, although the group is expected to have a major impact on mobile wallet growth given the size and influence of the retailers involved. Walmart is the heavy weight in this, it was Walmart that in 2002 required its suppliers to RFID tag pallets, and this set the course for inventory control for the industry as a whole.

Other alternatives to NFC, such as barcodes and optical scanners that are used with the iPhone, have also emerged.

Square and, more recently, Bank of America's Mobile Pay on Demand service allow small retailers to use credit card readers attached to smartphones, which rely on apps to transmit the credit card data and receive an authorization. Customers make a digital signature on the display of the smartphone.

The widespread use of credit cards and even paper checks in the U.S. to make payments has put a damper on consumer interest in NFC in smartphones, analysts believe. Surveys also show a large group of Americans still don't trust the security of a smartphone when used to make payments. That is changing rapidly as banks have been removing ATM machines from convenience stores and gas stations around the country.

What became really interesting this past summer was to see men who had been vaxxed with the Moderna shots soon discovered that when walking into a bar or a home, when they got close to a large TV it would turn on as they got close to the TV. More than a dozen such incidents were posted on various Internet sites. As you can see from the few pages below, the versatility of NFC in conjunction with your cell phone, the key issue of security is all but eliminated. A Swedish company has sparked debate after showcasing a microchip that can be implanted under the skin and scanned as proof of one’s Covid-19 vaccination status.

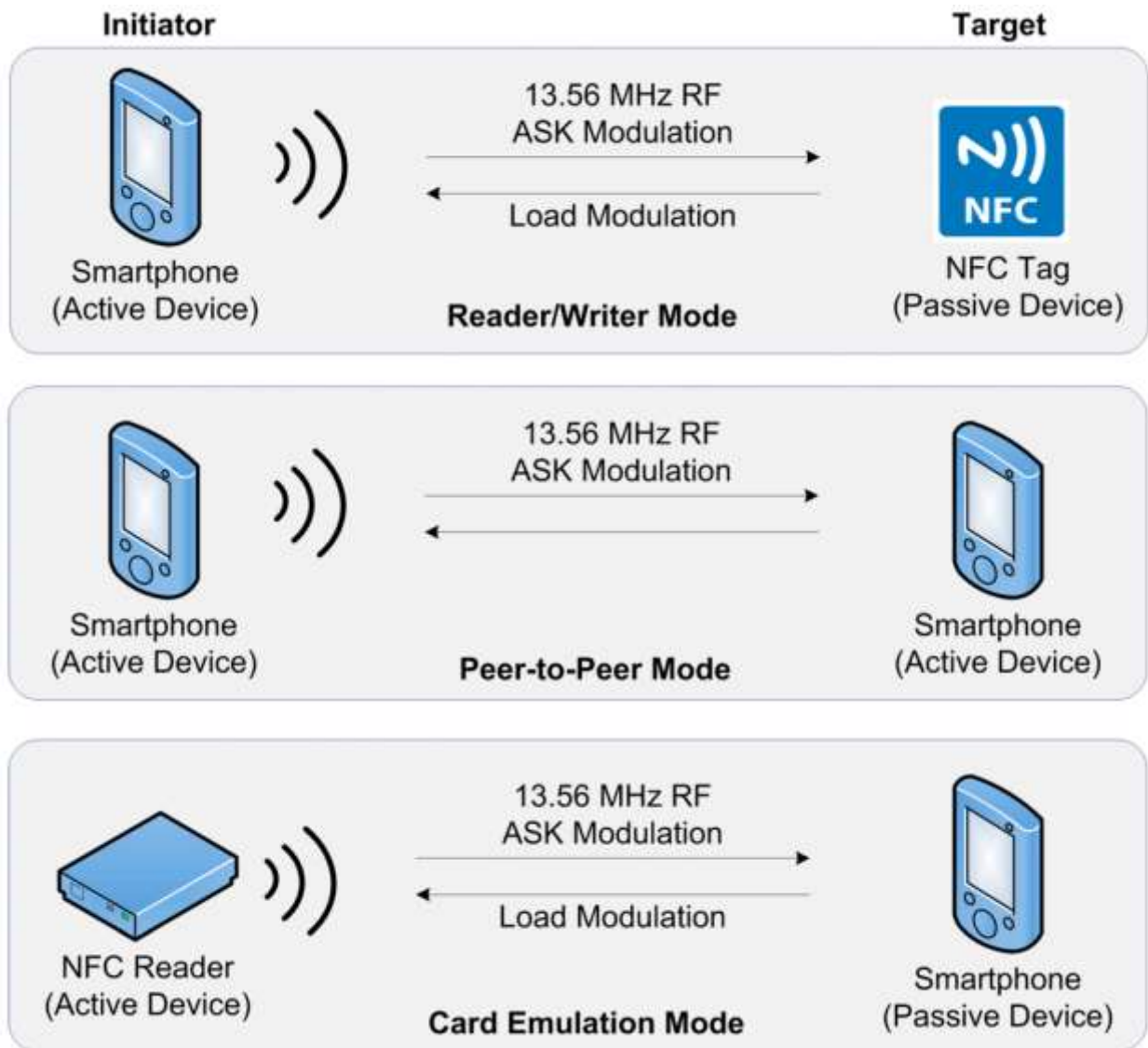
A Swedish company has come up with a microchip that can be inserted under the skin so that users can carry their Covid passports in their arm.

The chip can be inserted either in one's arm or between one's thumb and forefinger, with the data readable through the skin. A unique code generates the individual's vaccine passport file on a reader, as its makers displayed in the demo video distributed to multiple media outlets.

Epicenter's chief distribution officer, Hannes Sjoblad, told the news agency AFP its microchip offered an efficient way to have one's Covid status checked at a movie theater or shopping center without recourse to a cell phone.

*"What matters to me is that the people who get chip implants, they do so on a voluntary basis," Sjoblad said. "And because they are curious, and they want to work with this technology."* The Swedish developer of a COVID-19 vaccine passport chip that individuals implant in their skin has addressed privacy concerns over putting sensitive information in such an easily accessible form.

The implant from tech firm Disruptive Subdermals is only 2 millimeters by 16 millimeters and can be scanned to reveal a user's vaccination information. The implants utilize near field communications (NFC), the same technology that enables contactless payments, which opens a wide field of use for these chips.



*"We know that the world of connected devices, the Internet of Things as a lot of people call it, speaks the language of (NFC) so when I have a chip in my hand it allows me to speak the language of all these devices and interact with them effortlessly," Hannes Sjoblad, Managing Director of Disruptive Subdermals, told AFP.*

That same technology could allow another person to steal the information, but to do so they would need to use a smartphone and get it close to the implant to steal the information by activating the chip.

A Radio Frequency Identification (RFID) microchip is implanted under the skin of a subject's left hand that can be used to unlock a door with a specially modified lock. Technology enthusiasts have purchased RFID devices and inserted them under their skin of the hand.

Sjogblad also assured that the chip cannot transmit a person's location – another significant privacy concern.

*"They don't have a battery, they cannot transmit a signal by themselves, so they are basically passive," Sjogblad said. "They sit there asleep."*

Over 4,000 Swedes have opted for similar chip implants over the past few years, which can carry a variety of information such as business cards, public transport cards or even car key fobs, according to NPR.

The implants cost €100 (\$113) a piece and the distributors describe the tech involved as "passive," as it's unable to generate a signal on its own – though this has not stopped the prospect of Covid chips raising red flags with activists. This is gonna go over well with a certain segment of Americans...

*"Remember when this was just a conspiracy?"* U.S. Representative Lauren Boebert (R-Colorado) tweeted in reaction to initial reports about the implants.

Sweden announced in December, 2021 that vaccine passports would be required at any venue or event with a capacity of more than 100 people. Some 6,000 people have reportedly opted to have an implant since then.

### **HERE WE GO: Pfizer Says Covid Pandemic Could Extend to 2024**

Pfizer Chief Scientific Officer Mikael Dolsten said in a presentation to investors that the company expects some regions to continue to see pandemic levels of COVID-19 cases over the next year or two. Other countries will transition to “endemic” with low, manageable caseloads during that same time period.*

By 2024, the disease should be endemic around the globe, the company projected. These statements confirm the elite need approximately two more years before Klaus Schwab's Great Reset can begin.

Last week Pfizer CEO Albert Bourla [said](#) people will need a fourth jab sooner than expected. All of this talk about boosters is a stall until the Libra Blockchain can be transitioned or moved over to replace the Petro-Dollar. Catherine Austin Fitts has pointed out the problem of synchronizing the transition from a fiat currency system to the Blockchain “cashless” computing of digits. Also, Anthony Fauci just stated this past weekend that the CDC will probably soon change the definition of “vaccinated” to only include those who are up-to-date on their



booster shots, which would mean that everyone who has already taken the full dosage of the existing shots but have not yet taken the booster, will be labeled as “unvaccinated.”
