HSBC, etc.) all originally hail from the same Eastern and Central European nations that constitute the eternal hotbed of conflict on the continent - the Intermarium.

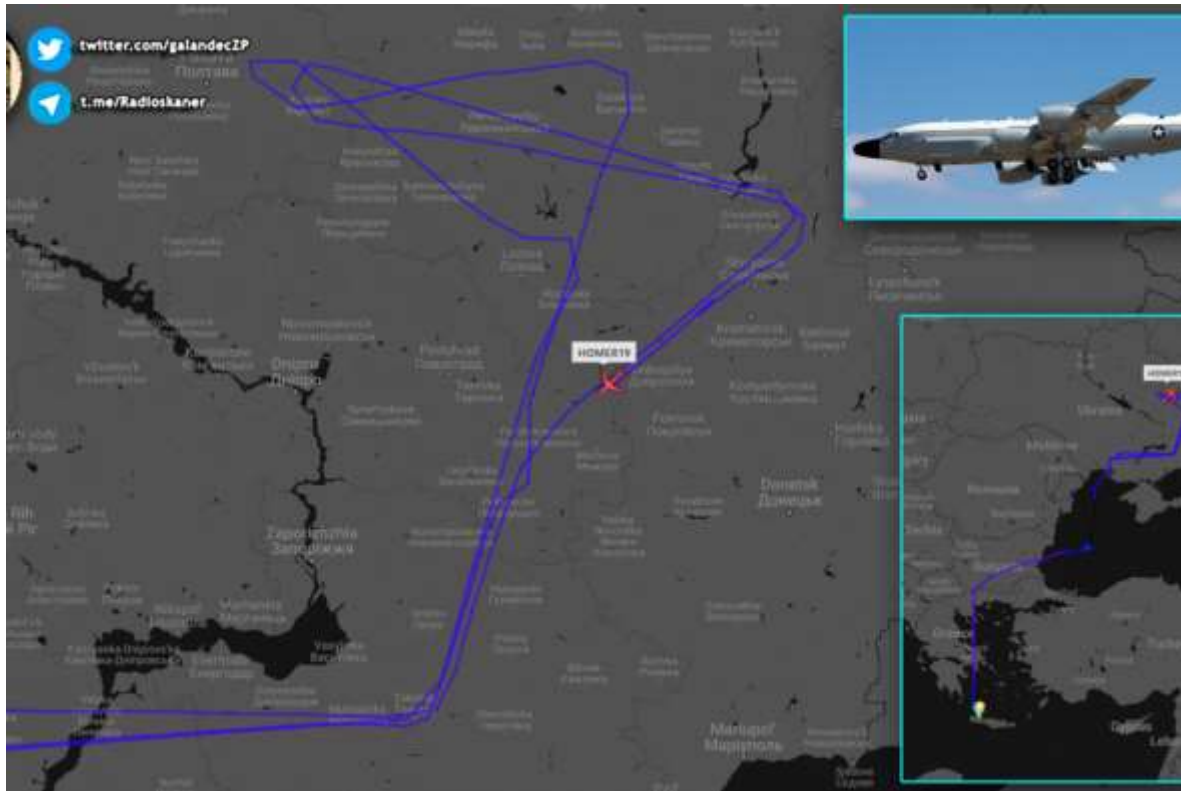

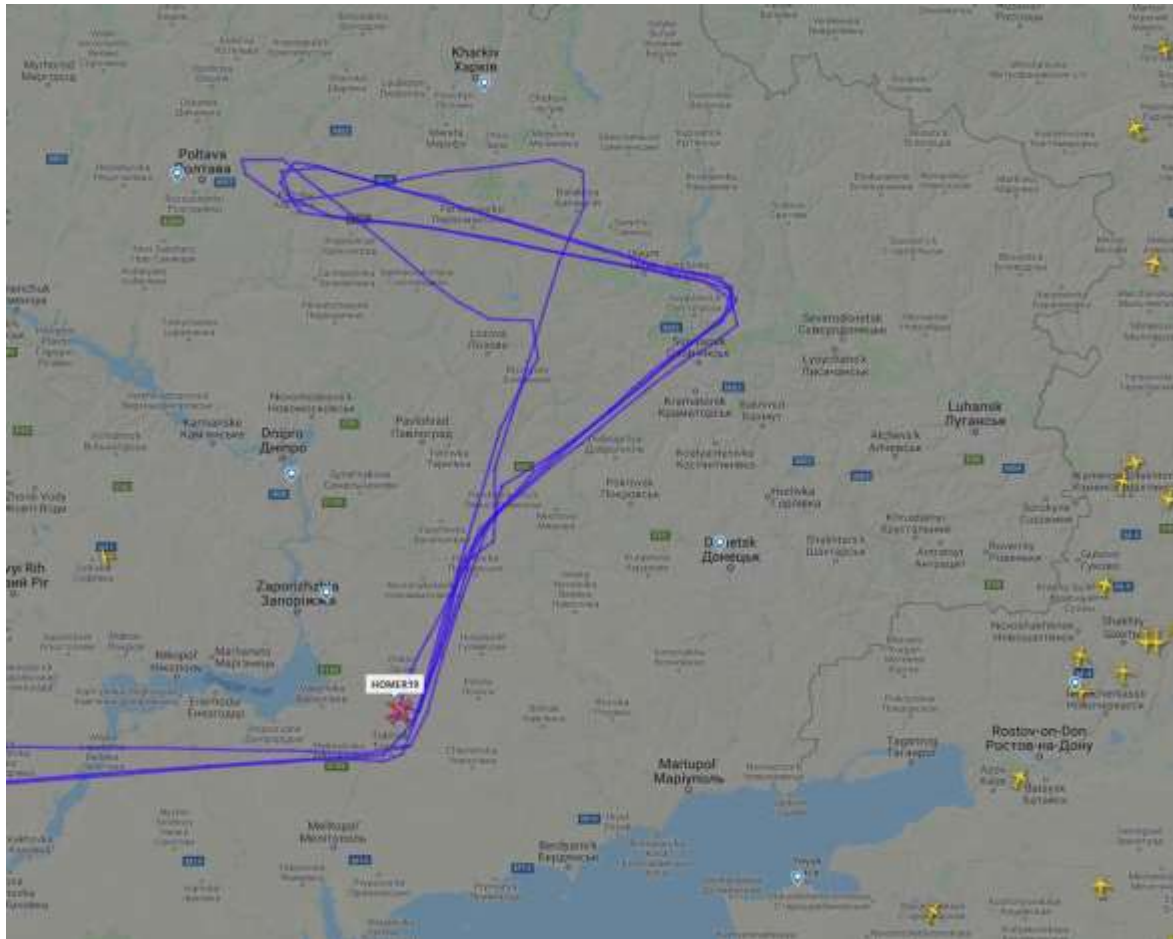

USAF Planes Flying Recon Missions Over eastern Ukraine - Pushing and Poking the Russian Bear



This morning, United States Air Force planes are flying numerous reconnaissance missions over eastern Ukraine, continuing to deliberately poke the Russia Bear, and for no good reason at all.

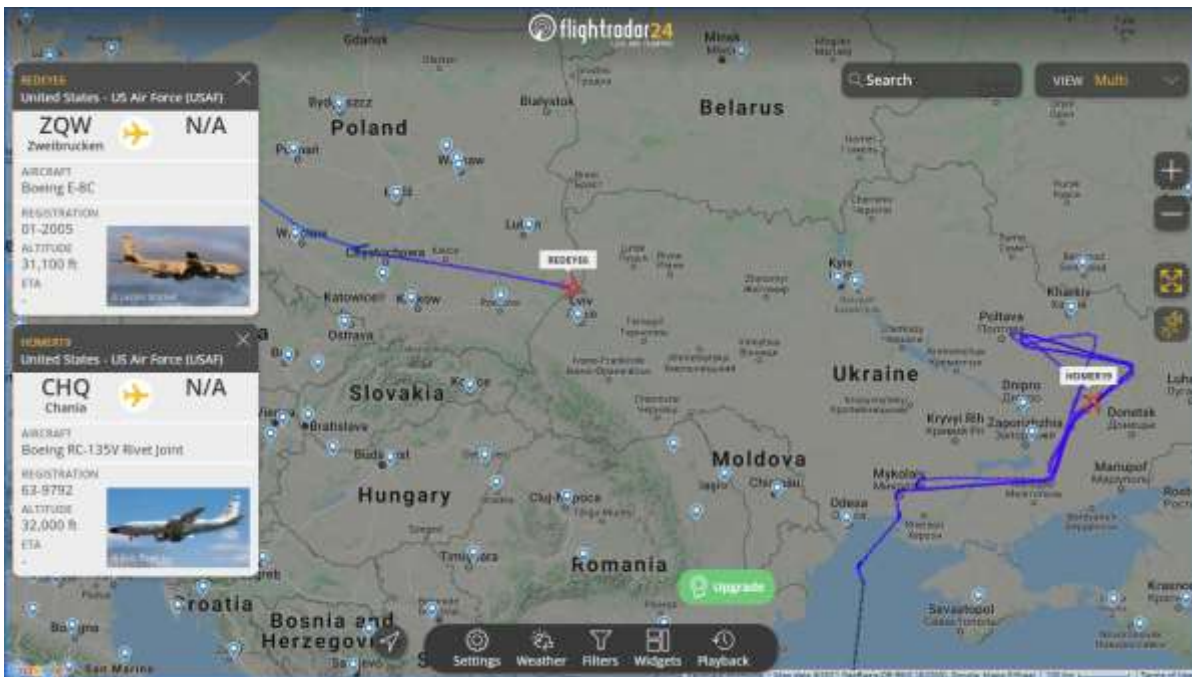
We begin with this flight of a Boeing RC-135V flying over what is considered to be the front line between the corrupt, Nazi-infested Kiev, Ukraine "government" and the breakaway states (oblats) of Luhansk and Donetsk, collectively called "The Donbass."



The Boeing RC-135 is a family of large reconnaissance aircraft built by Boeing and modified by a number of companies, including General Dynamics, Lockheed, LTV, E-Systems, and L3 Technologies. It is used to support theatre and national level intelligence consumers with near real-time on-scene collection, analysis and dissemination capabilities. Known as "Rivet-Joint" here is what the aircraft looks like:



Next, shown entering western Ukraine near Lviv, is a Boeing E-8C.



The Northrop Grumman E-8 Joint Surveillance Target Attack Radar System is a United States Air Force airborne ground surveillance, battle management and command and control aircraft. It tracks ground vehicles and some aircraft, collects imagery, and relays tactical pictures to ground and air theatre commanders. Here is what the plane looks like:



The AN/APY-7 radar on this plane can operate in wide area surveillance, ground moving target indicator (GMTI), fixed target indicator (FTI) target classification, and synthetic aperture radar (SAR) modes.

To pick up moving targets, the Doppler radar looks at the Doppler frequency shift of the returned signal. It can look from a long range, which the military refers to as a high standoff capability. The antenna can be tilted to either side of the aircraft for a 120-degree field of view covering nearly 50,000 km² (19,305 mile²) and can simultaneously track 600 targets at more than 250 km (152 miles).^[1] The GMTI modes cannot pick up objects that are too small, insufficiently dense, or stationary. Data processing allows the APY-7 to differentiate between armoured vehicles (tracked tanks) and trucks, allowing targeting personnel to better select the appropriate ordnance for various targets.

The system's SAR modes can produce images of stationary objects. Objects with many angles (for example, the interior of a pick-up bed) will give a much better radar signature, or specular return. In addition to being able to detect, locate and track large

numbers of ground vehicles, the radar has a limited capability to detect helicopters, rotating antennas and low, slow-moving fixed-wing aircraft.

The radar and computer subsystems on the E-8C can gather and display broad and detailed battlefield information. Data is collected as events occur. This includes position and tracking information on enemy and friendly ground forces. The information is relayed in near-real time to the US Army's common ground stations via the secure jam-resistant surveillance and control data link (SCDL) and to other ground C4I nodes beyond line-of-sight via ultra-high frequency satellite communications.

Other major E-8C prime mission equipment is the communications/datalink (COMM/DLX) and operations and control (O&C) subsystems. Eighteen operator workstations display computer-processed data in graphic and tabular format on video screens. Operators and technicians perform battle management, surveillance, weapons, intelligence, communications and maintenance functions.

Northrop Grumman has tested the installation of a MS-177 camera on an E-8C to provide real time visual target confirmation.

This is a plane the U.S. sends in when it is looking to do actual battle, and wants precise target information.

Russia's Security Concerns

Earlier this month, Moscow submitted draft security documents demanding that NATO deny membership to Ukraine and other former Soviet countries and roll back its military deployments in Central and Eastern Europe.

The Kremlin presented its security demand amid tensions over a Russian troop build-up near Ukraine in recent weeks that has fuelled Western fears of a possible invasion. U.S. President Joe Biden warned Putin in a video call earlier this month that Russia will face "severe consequences" if it attacks Ukraine.

Russia has denied an intention of launching an invasion and, in its turn, accused Ukraine of hatching plans to try to reclaim control of the territories held by Moscow-backed rebels by force. Ukraine has rejected the claim.

Putin has urged the West to move quickly to meet his demands, warning that Moscow will have to take "adequate military-technical measures" if the West continues its "aggressive" course "**on the threshold of our home.**" Bottom line, neither power trusts the other! A simple mistake on either side and everything goes up in radiation ash as Putin stated.

Russia has repeatedly said that the entire reason for NATO trying to bring Ukraine into its organization, is for the U.S. to place anti-missile defences on the territory of Ukraine. These American missiles would have a flight time of five minutes to Moscow, or seven to eight minutes to Russia's strategic nuclear missile silos.

The real problem is that the warheads on these "defensive" missiles, can be replaced within an hour, and made into offensive NUCLEAR missiles. The flight time for a NATO first strike, would then be so small, that Russia would not be able to defend itself against a first-strike.

This reality is untenable to Russia because it threatens their very existence.

For over a year, Russia has publicly and candidly told the world this is what the U.S. and NATO is planning, and in that same year, Russia has repeatedly said such a situation would be an existential threat to them, one which they would have to confront. NATO and the US proceeded anyway.

Now, the world is in an almost reverse "Cuban missile crisis." Back on the early 1960's the then-Soviet Union placed medium range and intermediate range nuclear missiles in Cuba. They were detected by US spy plane flights.

When told of these missiles, then U.S. President John F. Kennedy asked his Generals how long it would take for those Cuba based missiles to hit Washington, DC. They replied "5 minutes." They went on to tell President Kennedy that the Intermediate Range missiles could also wipe out many other US cities, causing the U.S. to lose 80% of its population to a nuclear first strike.

Kennedy took action. He imposed a Quarantine against all vessels trying to enter Cuba; each being searched for missiles or missile parts, and if found, turned back.

A flurry of behind the scenes Diplomatic efforts over thirteen days, brought the world to the literal brink of actual nuclear war. The U.S. made clear diplomatically that the missiles in Cuba had to go and if they didn't, the U.S. would invade and destroy them.

It came down to a period of eight hours where the then-Soviet Union had a choice: Use those missiles, or lose them.

Thank God there were men of good will in the Soviet Union, and they chose to withdraw the missiles. Thus, no invasion of U.S. attack was needed or launched.

But an interesting side event became clear once all the details of this crisis became publicly known: At the time, the U.S. had placed Jupiter Missiles in Turkey. Those missiles posed a unique threat to the Soviet Union and so the Soviets placed nukes in Cuba to duplicate the threat.

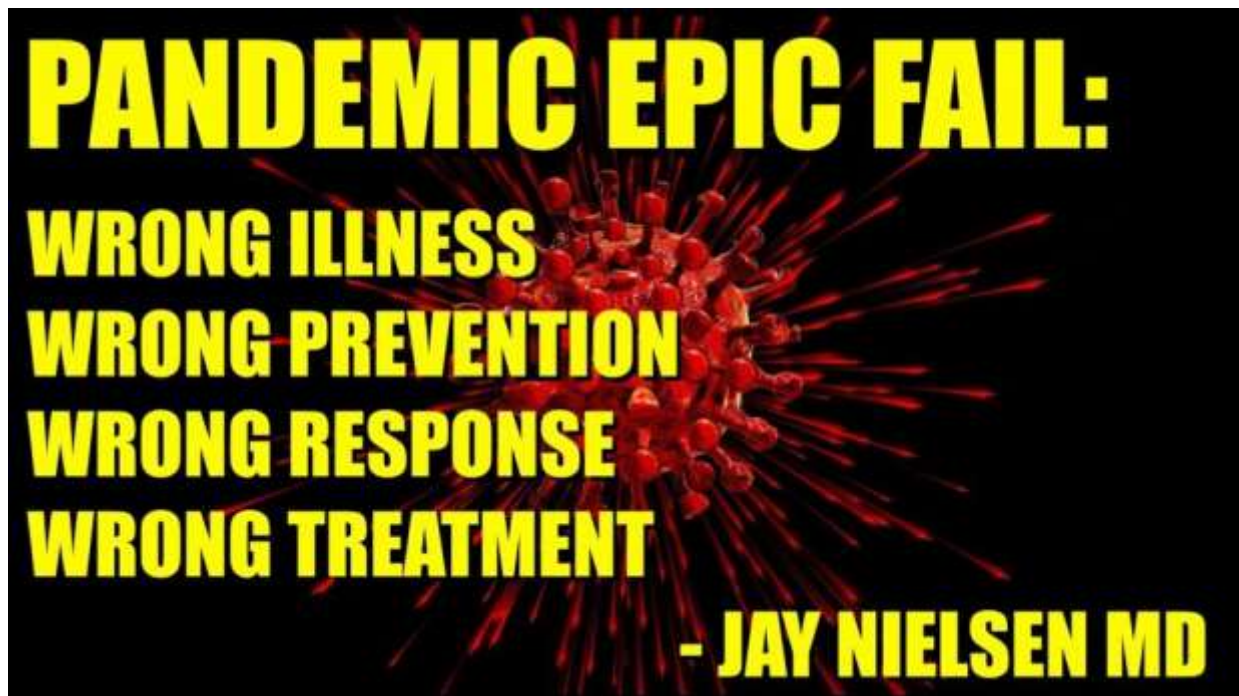
It was agreed diplomatically between the U.S. and Soviets that, as a condition of the Soviets removing the missiles from Cuba, the U.S. would remove the Jupiter missiles from Turkey within 6 months.

World War III

Of course, what goes around comes around. No one — not even the seemingly all-powerful Khazarian banksters — can escape from the jaws of karma. When that warmongering destiny catches up with them, it will likely be fast and furious.

However, Russia's entire eastern border, with the exception of Belarus, has been heavily militarized by NATO and the American DoD. 2022 will be the most volatile year in modern-day history. If you think this last point is nuts, consider that this scenario took place back when the euro was created and countries such as Portugal got absolutely creamed in the rollup to converting their currencies. Russia and China have established their own system equivalent to the (SWIFT) system. The world powers are walking a tightrope without a safety net. President Putin has made it clear to the globalists that he will not cave to their demands and he will fight to maintain a multi-polar world rather than a New World Order controlled by the International Banksters. NATO may be bluffing but President Putin is resolute and has said he warned NATO 'everyone will be turned to radioactive ash' over Ukraine moves.

Consider now all this trade being conducted and both China and Russia (India has also signed up to "SPFS") and the ability of these countries to tell their respective trade counterparts, "Hey, we want you to be paying and receiving via this messaging system (SPFS) and not that (SWIFT) one."

Maybe they even throw in a bone or two?

In other words, as chaotic as any elimination of Russia from SWIFT may be, if used, it could potentially backfire in the most asymmetric way imaginable leaving the Western-led Anglosphere in a much weakened position and creating a truly bipolar world.

It is time now to look at the threat posed, not by Russia invading Ukraine or by some random attack on the financial system by “right wing, anti vax extremists” or whatever nonsense is dreamed up, but by the threat right in front of us, from the globalists.

Russian President Vladimir Putin today (Christmas Day) announced he would ponder a slew of options if the West fails to meet his push for security guarantees preventing NATO's expansion to Ukraine.

Earlier this month, Moscow submitted draft security documents demanding that NATO deny membership to Ukraine and other former Soviet countries and roll back its military deployments in Central and Eastern Europe.

Putin has urged the West to move quickly to meet the demands, warning that Moscow will have to take 'adequate military-technical measures' if the West continues its 'aggressive' course 'on the threshold of our home.'

'We have nowhere to retreat,' he said, adding that NATO could deploy missiles in Ukraine that would take just four or five minutes to reach Moscow.

'They have pushed us to a line that we can't cross. They have taken it to the point where we simply must tell them - `Stop!`'

Putin's announcement comes just one day after Russian authorities released a video of large-scale 'war games' in which Russian troops in five separate locations conducted military drills and live-fire exercises, with many taking place close to the Ukrainian border.

Asked to specify what such Moscow's response could be, he said in comments aired by Russian state TV Sunday December 26th, 2021 that 'it could be diverse,' adding without elaboration that 'it will depend on what proposals our military experts submit to me.'

The U.S. and its allies have refused to offer Russia the kind of guarantee on Ukraine that Putin wants, citing NATO's principle that membership is open to any qualifying country.

They agreed, however, to launch security talks with Russia next month to discuss its concerns, and Putin said the talks with the U.S. will be held in Geneva.

In remarks broadcast today, Putin said that Russia submitted the demands in the hope of a constructive answer from the West. 'We didn't do it just to see it blocked... but for the purpose of reaching a negotiated diplomatic result that would be fixed in legally binding documents,' Putin said.

The Russian President reaffirmed that NATO membership for Ukraine, or the deployment of alliance weapons there, is a red line for Moscow that it wouldn't allow the West to cross.

He voiced concern that the U.S. and its allies could try to drag out the security talks and use them as a cover to pursue a military buildup near Russia.

He noted that Russia published its security demands to make them known to the public and raise the pressure on the U.S. and its allies to negotiate a security deal.

'We have just one goal - to reach agreements that would ensure the security of Russia and its citizens now and in a long-term perspective,' he said.

The Kremlin presented its security demand amid the tensions over a Russian troop buildup near Ukraine in recent weeks that has fueled Western fears of a possible invasion.

U.S. President Joe Biden warned Putin in a video call earlier this month that Russia will face 'severe consequences' if it attacks Ukraine.

Russia has denied an intention of launching an invasion and, in its turn, accused Ukraine of hatching plans to try to reclaim control of the territories held by Moscow-backed rebels by force.

Ukraine has rejected the claim.

Putin's comments on the dangers posed to Russia by a possible NATO expansion into Ukraine come just one day after a video released on Christmas Day showed the Russian army drilling in 'new forms and methods of modern combined arms combat in the Voronezh region' - which borders Ukraine.

The video shows more than 1,200 air assault troops and 250 pieces of military equipment engaged in military drills in snow and fog at the Opuk range in Crimea, annexed by Russia from Ukraine in 2014, and at the Rayevsky range near Novorossiysk in Krasnodar region, close to the Ukrainian border.

The show of strength - coinciding with Christmas celebrations in the West - was accompanied by another announcement from Putin, who revealed that a successful salvo launch of Russia's Mach-9 capable Zircon missiles, which Russia boasts can evade all missile defenses, had been conducted.

President Putin and the Russian Federation, whose bitter lesson learned in World War II has never been forgotten - which is why **President Putin has just warned: "I have spoken about the 'red lines' which we believe should not be crossed...I want everyone to understand, here in our country and abroad, so that our partners understand: The issue isn't about the line which we don't want someone to cross...The issue is that we**

I archive ANP reports because of both their timeliness and the cogency of the topics.

For at least a decade now the Deagel Report for 2025 was highly charged and provocative of what was meant by the numbers. Currently the total number of Americans fully vaxxed is approximately 202 million, with about 241 million at least partially vaxxed. The two I immediately recognized those numbers as aligning very eerily and alarmingly with the number of Americans being forecast to 'die off' by the year 2025 according to Deagel's forecast from past years. Is that a fluke coincidence or was there more to it?

The screenshot below originally from a May, 2018 ANP story, the number of Americans being forecast by Deagel to be stricken from census data back then by the year 2025

was 227 million, which falls right in line with the number of currently 'vaxxed' Americans. If mRNA vax inventor Dr. Robert Malone is correct in his warning that many of the vaccinated will die from the after-effects of the shot, should Americans really be taking their children to get it? Autopsy reports indicate that the Graphene Oxide found in the Vaxxes forms into what might be similar to a razor blade. Graphene Oxide is a single atom molecule and is found in the screen of the smart cell phones. The Graphene Oxide is like 'Death by 1,000 Cuts'. A chemist revealed the effects of Graphene Oxide in the Vaxxes just over a month ago, and he died mysteriously within hours of posting a video explaining the problem. On November 18, 2020, well-known German chemist and one of the EU's top graphene experts, Dr. Andreas Noack was arrested by an armed police unit in the middle of his YouTube livestream.

On November 26th, 2021, just hours after publishing this latest video about graphene oxide and graphene hydroxide, he died suddenly.

In the video, he reveals that that Dr. Pablo Campra from the University of Almeria had recently done a Micro-Raman spectroscopy study of the vaxxine and had discovered that the graphene detected in the vaxx was not graphene oxide (GO) but graphene hydroxide (GHO), which is an extremely stable molecule that is not biodegradable, so it basically stays in your system forever.

Back in 1994, the "QR" code (an acronym for Quick Response code) is a type of matrix barcode (or two-dimensional barcode) invented in 1994 by the Japanese automotive company Denso Wave. A barcode is a machine-readable optical label that contains information about the item to which it is attached. In practice, "QR", Chuck Missler was a tech-oriented type guy, and Naval Academy graduate; his life's work prior to his ministry was in the field of computers and information processing, and so he quickly adopted the technology at his Koinonia House.

I followed its adoption since 1994, however, I saw it as cumbersome. Some thought it would be the successor to the "Digital Angel" but it never happened. I never saw "QR" as a viable medium for the "Mark" of the Beast. I have written a very comprehensive series on the history of the Biblical Mark of the Beast tracking it back to ancient Babylon culture. It was not until 1972 that major research and development was applied to the Grocery Industry tracking inventory and order processing. IBM engineer George Lauer is the man who designed and created the Universal Product Code or UPC Barcode.

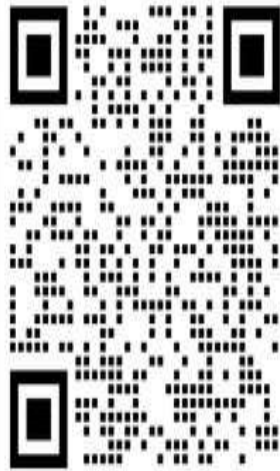
It revolutionized the grocery store system for having full shelves in a super market from that point on. As a teenager, I worked for Walker's Market. After school on Monday, it was my job to compile a list for the owner of items we were low on or out of stock. I went to work for a Giant Eagle supermarket where my inventory experience came in to good use. Then in high school, I worked for a Kroger's. When I graduated college I was recruited for Kroger's management program and began as a co-manager of a large store in Monroeville, PA. The UPC Bar Code came along after I left Kroger. The extended vertical bars on a UPC Bar Code resembled the width of the vertical line for the number 6, however, it was slightly different. The use of this number "6" had more to do with the fact that it could be read upside down since 6 is a 9 upside down. Early scanners required that items be scanned right-side-up. This did little to speed up the scanning process at check-out and so they installed a device beneath the scanning glass with a split-image stainless-steel pyramid-shaped that optically could read the UPC Bar Code on grocery items regardless of its position passing over the scanner below.

There are three vertical bars known as "guard" bars. They are longer than the rest of the number bars in the bar code. They tell the scanner to start and stop in the scan process. The first set of numbers on the left is the assigned manufacturer code number and the second set of numbers is the product code for the SKU (size, kind, and unit) number. Today, of all the many (approximately 30) versions of the UPC Bar Code, all use the same "guard" bars. Even the human genome is bar coded.

Here is a basic lesson on the “QR” code.

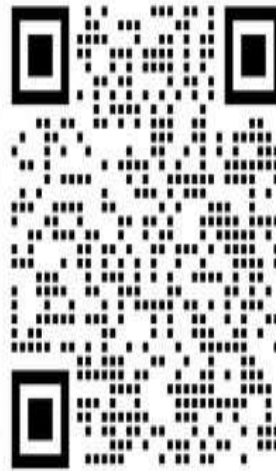
Two types of QR codes: Static and Dynamic

With the use of “QR” code technology, apps like WhatsApp, Snapchat, and Instagram are integrating the use of it to secure their users' information and prevent hackers from stealing their identities.

Because of that, “QR” codes become the essential modern-day solution to fighting identity and data thefts. To learn how “QR” codes intensify information security, here are two use cases that you can agree with.

5. Many users that have mobile phones, do not have smartphones, that have cameras that are unable to get QR reading software for their phones.
6. The user is not too familiar with this technology.
7. Advertisers have to educate consumers about new technology to reduce skepticism.
8. Aksi advertisers have to figure out how best to use this technology with their consumers.
9. In this method, relatively new barcode type, people are not much familiar with its use therefore, it requires in order to fully understand a concept.
10. QR code is not very aesthetic, It contains random patterns of square boxes which might not look pleasing on products, unlike 1-d barcodes.
11. Potential obsolesce from emerging technologies such as near field communication.

12. Poor execution and user experience have presented the biggest obstacle for adoption.

13. Cannot always track the user journey after they arrive on-site from a "QR" code.

Technical experts on "QR" go so far as to mention "QR" can be attacked through four different ways.

1. First, criminals can inject your phone with malware. This direct approach requires nothing more than an unsuspecting consumer or employee to scan a "QR" code out of curiosity leading to an infected website. Just visiting the infected website can trigger a malicious download. One example of how they might deliver this attack method is to send the "QR" code in an email that appears to be legitimate enticing the user to scan it.

2. Second, the attacker leads you to a phishing site to steal your credentials or to gain access to your private information on your mobile device. Phishing websites can be very hard to detect. They use a similar-looking "Universal Resource Locator" (URL) to a trusted website. Another approach is to change the domain extension. For example, they change the ".org" to ".com." Other times, there is a slight change in the spelling of the URL so hard to distinguish that it tricks the user. Once the user visits the phishing site, username/login credentials are requested. After the attacker has your log in, the rest is history. They can access your accounts, make changes, see private information and cause irreversible damage to your company name.

3. Third, cybercriminals can print out free encoding tools on the internet to make "QR" codes. They print the "QR" code on adhesive paper and place it over a legitimate "QR" code, or they can email a malicious "QR" code to an unsuspecting consumer.

4. Fourth, there's always the risk that an attacker finds a bug in a code reader application that could result in the exploitation of cameras and/or sensors in phones or other devices.

David Geer investigates the dangers of malicious "QR" codes and finds this emerging technology is yet another way for criminals to exploit the same old threats. A large number of end-user computers are mobile devices and the lion's share of those are smartphones. APTs are increasingly targeting the mobile market.

"Mobile malware increased more than 1,000-percent in 2012 alone," said Catalin Cosoi, Chief Security Researcher, BitDefender. BitDefender bases this data on analyses of mobile threats it collects via honeypots.

Criminal hackers use malicious "QR" codes for the same reasons they use any attack on mobile devices: the mobile market is outpacing PCs, creating a bigger target; and, these newer, mostly end-user devices (especially smartphones) are the least likely to carry any security software.

A malicious “QR” (Quick Response) code contains a link to a website embedded with malware.

"It doesn't matter how the user scans or collects the QR code, eventually the device translates it to a link," said David Maman, Founder and CTO, GreenSQL, who also speaks at conferences on the dangers of malicious “QR” codes.

Over the course of history, our world has seemed to have shrunk, not just by time, but by data and technology. Not everyone using this information recognizes it with the same set of eyes. Having been exposed by Hitler's atrocities the elite went underground – for example by renaming '*Eugenics Quarterly*' to '*Social Biology*' in 1969.

Psychopathy among Elites

This is not a belief but more of a sobering fact that must be considered when evaluating the values and actions of the elite. It has been well established, as shown by Andrew Lobaczewski in his book '*Political Ponerology*', that the elite and those that are most capable of rising to the top of a system based on money are psychopathic. This includes leaders in all centers of power including business and politics. As psychopaths they have no conscience, lust for power and control and are literally capable of anything.

The Ends Justify the Means

Because the elite truly believe that the ends justifies the means and the fact that they are for the most part psychopathic, they have absolutely no problem lying to the public. This is also known as the ethics of war where the only morally abhorrant act is losing.

Mystery Religions / Occult

As hard as it is to imagine, the elite practice a form of pagan religion based on the mystery school religions of Sumer and Babylon under which they seek to achieve godhood. Equally important is the use of religion to control the masses and to that end they create exoteric (visible) religions for the masses while embedding in those religions esoteric (hidden) meanings that only those that are Enlightened, or illumined as they call it, are able to understand. Consequently, the ancient symbols used thousands of years ago can still be seen in religion, business and the media today.

Collectivism as Social Control

After experimenting for hundreds of years with different forms of social organization, the elite have concluded that collectivism is the best form of social control. For this reason, and according to the United Nations, totalitarian China is considered the model state for the future.

Overpopulation

The elite have long viewed a rising population as a threat to their dominance. They realized that eventually a large number of people will inevitably overthrow and remove them from power. They are particularly concerned with the middle class whose intelligence and capacity to organize makes them the biggest threat. Consequently, the elite plan to destroy the middle class and make all the of public equally poor and thus incapable of rebelling. As written on the Georgia Guide Stones, they want a global

population of just 500 million. This means 7+ billion people must die over the coming century. Those words were etched in granite forty years ago.

Multi-generational Planning

The evolution of society is not something the elite can leave to chance since society could evolve in thousands of different and unpredictable ways. If they were ever to allow this they might lose their control and dominance over us. In order to continue their position as the dominant minority, they plan decades and even centuries in advance.

Revelation of the Method

The elite's do tell us through their books and publications, movies and news releases what they are doing – this is called "*Revelation of the Method*". If you are too stupid to recognize it for what it is that is your problem from their point of view. It is a form of ritual mocking of the victim before they eliminate you.

As with God, humanity has been given "Free Will" to choose our personal destiny. God will not force you to love him, and Lucifer in his quest to be equal or greater than God per Isaiah 14:12 surprisingly operates under the very strange mocking ethic. That ethic is that Satan must tell society what it is going to do to humans. It is like being at the fork of a road where you must choose the path you are to follow. This is not to say that Lucifer's ethic does not exploit tactics that include lying, cheating, deception, temptation, and other devious assorted tricks. Scripture makes it clear that Satan is the father of lies. It all comes down to who you choose to believe and what your choice will be. This is Lucifer's last hurrah and so his camp is going all out in order to attract as many as he can take to Hell with him. This is the greatest test of your life. Who will you choose to believe. The God of the Bible wants a relationship with his earthly creation, and that is a central tenet of Scriptures.

A number of patriot writers have noticed over the years that the New World Order (NWO) elites often tell us exactly what they are up to, and the suspicion is that they do this for magical, ritualistic reasons. The idea is that they (and their ultimate master) are very legalistic and feel that they can get away with anything if they tell us what they are about to do to us, and we, by not protesting in mass and even resisting, are, in effect, agreeing to it.

Or, alternatively, they are taunting the minority of us who are awake and aware, secure in their knowledge that the great mass of people, dumbed down by the indoctrination centers (formerly known as "schools") will pay no attention. Of course, what they say openly is only published in a very few outlets; for the most part the slime-stream media will ignore it. David Rockefeller, who now resides down under (I don't mean Australia), openly boasted of the elite's intention to create a global dictatorship. I went to a conservative United Presbyterian college and the faculty understood all of this and so I had a head's up lead on it all. But even then it was a decade after graduating before it began to emerge from the fog what my professors were alluding to!

The [Georgia Guide Stones](#) openly proclaim that the human population of our planet must be quickly reduced to a small fraction of its present level. Hussein Obama's old comrade from Chicago, the spoiled rich kid communist terrorist Bill Ayers, advocated the extermination of millions of Americans. And many of the false flag operations of the elites, acts of mass murder, are simply so obvious, so in-your-face, that only the terminally mindless and willfully blind (unfortunately, nearly two thirds of the population) could fail to see the truth.

A good example is 9/11...we are expected to believe that the only steel framed buildings ever to collapse completely due to fire did so in one place on one day, and all three collapsed straight down, a feat that can only be accomplished with controlled demolitions. The NWO crowd always hide everything in plain sight, right in front of us, where most people never look.

But there is another way they sign their work, so to speak. As Luciferians, they tend to do things on certain dates and locations for magical reasons. As conspiracy researcher and author David Icke said, even if we think numerology and magical geometry are a joke, we had better at least understand that the elites take it very seriously. If we understand this we can more easily recognize their dark deeds for what they are, and even, to a very limited degree, predict them.

As an example, take our calendar. Suppose the entire modern calendar is deliberately skewed and the elites themselves operate according to a secret calendar. We believe that the last century began in 1901 and ended on the last day of 2,000. But the Mayan calendar ended in 2012 (when nothing, or at least nothing obvious, seems to have happened). If that was the true last year of a century, the first year would be 1913 (the Luciferian number 13).

And what happened in 1913? Our glorious President Woody Wilson gave us the income tax, the Federal Reserve, and the direct election of US senators, which sounds very "democratic" but undercuts state sovereignty. This set the stage for America's involvement in WWI, which began in 1914 and ended in 1918, with the cease fire taking effect on November 11 at 11 in the morning. November being the eleventh month, this means 11/11/11, totaling 33, as in thirty-third degree Mason. And what is significant about that number?

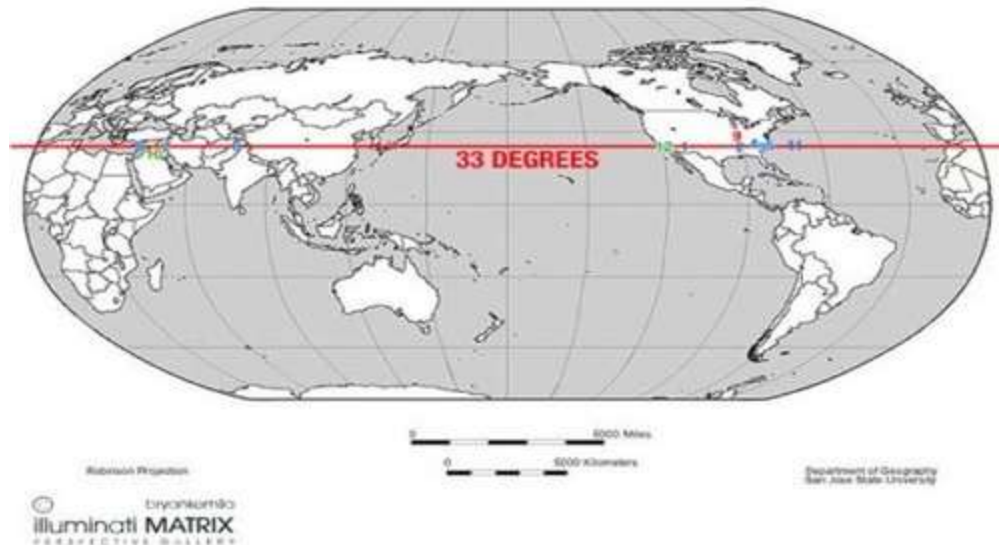
First, the sunspot cycle averages about 11 years, perhaps due to the roughly 11 year orbit of Jupiter, but varies, perhaps due to the orbits of the other planets. Three times 11 is 33, and most people, counting the cervical (neck) vertebrae and the fused vertebrae of the sacrum, at the base of the spine, have 33 vertebrae. Mystics (like the Masons) believe that a mysterious energy, sometimes called kundalini, can be induced to rise up the spine to the head, bringing enlightenment.

Christian (and some Buddhist) mystics have warned of a false, or partial enlightenment that moves people, not closer to God, but in the opposite direction. If 1913 is the true first year of a century, its midpoint is 1963...when they killed JFK. And they shot him in

Dallas, within less than a degree of the thirty-third parallel, on November 22...11 and 22 total 33.

Many strange things happen within less than a degree of the thirty-third parallel. Near Dallas is Stephenville, Texas, where dozens of people reported seeing a massive UFO. Further west is the Roswell/Corona site, where a UFO allegedly crashed in 1947. Yet further west is Holloman Air Force Base, rumored to be the landing site of at least one UFO. South of Holloman, but still near the parallel, is White Sands Missile Range, where America's space program was begun...largely by Nazi scientists...and where the only launch pad is launch pad number 33. North of Holloman, but still less than a degree from the thirty-third parallel, is the Trinity nuclear test site where the first atomic bomb was tested, a tricky plutonium implosion bomb.

Note that Dallas is on the Trinity River. Further west the parallel crosses near Arizona's mysterious Superstition Mountains and then Phoenix, named for the mythical bird which is considered by the Masons to be a symbol of death and rebirth, and in Phoenix thousands of people in one night reported seeing a massive UFO. The parallel passes near Blythe, California, where there is a massive pre-Columbian geoglyph, and, finally, near Nagasaki, Japan, where the second atomic bomb was dropped, another plutonium bomb. Hiroshima is well away from the thirty-third, and was destroyed by a relatively "simple" uranium gun-type bomb.

East of Dallas, the thirty-third passes near ancient Indian ruins at Moundville and Poverty Point, and then Charleston, South Carolina, where the first shots of America's Civil War were fired at Fort Sumter. Prior to the Civil War, Charleston was a hotbed of secessionist sentiment, and was headquarters for the Southern Jurisdiction of Scottish Rite Freemasonry in North America.

The line goes by Bermuda, and then crosses the Syrian/Dead Sea geological rift zone (a tectonic plate boundary) near Mt. Hermon, where the Elohim are said to have descended to mate with human women and produce the Nephilim. It crosses the Persian Gulf rift zone near ancient, magical Babylon, where the U.S. became involved in a senseless war, and then Afghanistan, where we were bogged down. Then it crosses Tibet, allegedly the location of legendary Shamballa.

The America's Declaration of Independence was approved by voice vote of the Continental Congress on 7/2/1776, and sent to the printers and made public on 7/4/1776, when the delegates began signing it, and this is accepted as America's birthday. Note that seven is a magic number, and seven and four add up to 11. The ratio of the height of the Great Pyramid at Giza in Egypt to one of its base sides is seven to eleven. Many of the Founding Fathers were Freemasons and would have been aware of this. Like David Icke said, just remember that our would-be masters take all this very seriously.

But the first shots of the American Revolution were fired in 1775, on April 19 at Lexington Green and Concord Bridge in Massachusetts. Adolf Hitler was born in Braunau, Austria on 4/20/1889. Remember, depending on exact location and time of day it can be April 19 in the US while it is already April 20 in Austria. On April 19, 1985, the U.S. federal government's police forces had been besieging the northern Arkansas compound of the group calling themselves the Covenant, the Sword, and the Arm of the Lord; they surrendered peacefully on that day, but one of their members, Robert Millar, later founded the neo-Nazi group at Elohim City in eastern Oklahoma.

Alleged OKC bomber McVey visited and phoned them before the bombing. And there was no peaceful surrender when the FBI and BATF attacked the Branch Dravidian "compound" near Waco, Texas, burning adults, children, and infants alive on 4/19/1993. The Oklahoma City bombing was on 4/19/1995. The Columbine High School mass shooting, which raised many unanswered questions, was on Hitler's birthday, 4/20/1999.

The Deepwater Horizon explosion and oil spill in the Gulf of Mexico was on 4/20/2010; the well was owned by British Petroleum (BP), and operated by Transocean and the Halliburton Corporation. Peter Sutherland, high in the Luciferian hierarchy, was CEO of BP...and he resigned shortly before the disaster, which allegedly killed 11 workers (one third of 33). Peter became a Goldman Sachs (bankster central) executive, and Goldman Sachs just happened to dump all their BP stock just before the disaster, as did BP's new CEO.

Hussein Obama had investments in Vanguard, and they also dumped their BP stock just before the explosion. Hussein, noble champion of the environment, refused to accept foreign help in cleaning up the spill, and, incredibly, forbade Louisiana Governor Bobby Jindal from conducting earthen barriers to save Louisiana wetlands. But the spill served as a perfect excuse to restrict drilling in the Gulf.

But what is so important about April 19 and 20? Some students of the occult believe that the Luciferians have a “sacred” 13 day period of human sacrifice, beginning on April 19, going through April 30 (the witches’ Sabbath, when Hitler supposedly killed himself) and ending on May first, Beltane, a day sacred to the pagans, the Illuminati, and the communists.

And on 3/11/2004 (three times 11 is 33) alleged Muslim terrorists bombed Madrid’s subway, killing 192 and injuring about 2,000 people. Voters blamed this on the conservative party’s getting Spain involved in the Iraq war, and elected a socialist government which began importing more Muslim immigrants. On 7/7/2005 the London subway was bombed, allegedly by Muslim terrorists; the digits in 2005 add up to seven, giving three sevens.

And the Las Vegas mass shooting took place on 10/1/2017...and ten and one add up to eleven. The NWO types are just getting warmed up, and to be forewarned is to be forearmed. If this freaks you out just remember there is a spiritual entity that most of you have been led to believe does not exist! I would not place that bet and so I suggest that you keep your head out of the sand, and begin to be wise as a serpent,,,,, go and read Matthew 10:16!

If I were confronted with this decision, not knowing what I know, I will keep this very simple. The CDC established these percentages prior to commencing the vaccination program on December 8th, of 2020. The CDC survival rate for those unvaxed has remained fairly steady since they posted the data below on the CDC.gov web site:

I maintain a better system of statistical analysis, but still using the government’s own statistical reporting data. Their reporting system is unreliable for many reasons, inflated numbers and dishonest manipulated reports where deaths were falsely reported as Covid, such as motorcycle accidents, suicides, etc. Last winter they counted deaths

from the flu as Covid. Truth be known, all Covid deaths should have been counted as the seasonal flu virus!

What is most important in understanding the magnitude or lack thereof is to remember that the United States has **3,142 counties** in the U.S. and **100 counties** in the Territories. For all of 2021 so far, we have only had **45** days this year where the national Covid deaths reported exceeded 1 per county. (**January – 20; February – 19; September – 5; and November – 1**). These are typical months for colds and the flu.

We have 100 counties with census population data for cities greater than 1 million residents (1,000,000). I am using the government's own site for the data that follows. To put this into perspective of understandable numbers, **December 13th, 2021 had 575 Covid deaths for the entire U.S.** The next day, **December 14th, 2021, 1,473 Covid deaths were reported.** I am entering data up through December 18th at this point. The government data for December 15th and later is incomplete as data reporting usually takes a week before death certificates are tabulated and recorded. **The mainstream news media distorts reporting data, so as to exaggerate the numbers that serve to frighten the public. They mention new cases but never provide the actual death statistics to this alleged virus.** The folks sitting around the TV at 6:30 and 7:00 pm are oblivious to the truth and living in fear exactly where the global elite want you to be with your head in the sand!
