
How Long Do You Think It Will Be Before Putin Decides to Nuke the U.S.?

As U.S. Announces New \$800M Ukraine Arms Package, Here's The Total List Since War's Start. One can only speculate how long it will be before Russian President Vladimir Putin decides "enough is enough", and it is the U.S. that is his real enemy! In a Thursday CNN interview, Ukrainian Defense Minister Andriy Zagorodnyuk described a stalemated battlefield situation with Russia, while also urging more Western arms to be urgently sent. "The war is in a situation where the Russians cannot move anywhere further because of the weapons the West provided us. We managed now to make them stop," Zagorodnyuk said.

"But unfortunately at the same time we don't have enough weapons for a proper, serious, fully-fledged counter-offensive," he added. Yet a battlefield stalemate is where things can get dangerous fast, as is the case with the ongoing standoff at the Zaporizhzhia nuclear power plant. As we detailed earlier President Putin has warned his French counterpart Emmanuel Macron in a Friday phone call that Ukraine forces' "systematic shelling" risks a "large-scale catastrophe" at the Zaporizhzhia plant, based on his words in the Kremlin call readout.

But the West still appears to be holding out hope that ramped-up arms shipments, including increasingly heavier and longer-range weapons, can tip the scales against the superior and larger Russian forces. This is at least the logic in Washington, despite little evidence the unprecedented defense aid packages have significantly halted or dented the Russian offensive.

Politico reports Friday: "The U.S. will announce a new military aid package for Ukraine on Friday, two people familiar with the announcement told Politico, with another \$800 million in weapons and ammunition." This means the total so far in pledged defense packages (excluding other types of U.S. aid) has just sailed north of \$9 billion, according to the below figures.

"A third person said the next package will include <u>Excalibur precision-guided</u> <u>munitions</u>, which would **further help Ukraine hit far-away Russian targets** during the war's artillery-heavy phase," the report continues. The package is to include additional HIMARS, or the High Mobility Artillery Rocket System, as well as Howitzers.

Russia is already warning that the possibility of a direct clash with NATO or the U.S. is now higher than ever, also as on Thursday the defense ministry sent hypersonic missiles to be stationed in Kaliningrad, to be on 'ready' by three MiG fighter jets.

Tensions with Ukraine's Western backers are also boiling because of recent explosions at Russian bases deep inside Crimea, leading to speculation of long-range attack capability by Ukraine.

Politico speaks to the potential symbolism and timing of the new impending aid: "The tranche comes just days before Ukraine's independence day on Aug. 24, which one DoD official suggested could also bring a fresh American show of support." it notes.

Below is a timeline of all publicly disclosed major weapons shipments or funding packages going back to February 24, compiled by the think tank Quincy Institute for Responsible Statecraft:

August 8

The Pentagon <u>announced</u> that it will send \$1 billion worth of security assistance to Ukraine via presidential drawdown, including:

- HIMARS ammunition (This is an acronym for High Mobility Artillery Rocket System. These mobile missile launchers can fire a wide range of munitions, including rocket artillery and short-range ballistic missiles.)
- Artillery ammunition
- Javelin missiles and other anti-armor weapons

August 1

The Pentagon <u>announced</u> an additional \$550 million of security aid via presidential drawdown, including:

- HIMARS ammunition
- Artillery ammunition

July 22

The Pentagon <u>announced</u> that it will send \$270 million of military aid to Ukraine, with \$175 million authorized via presidential drawdown and the other \$95 million coming via USAI funds. This included:

- Four additional HIMARS
- HIMARS ammunition
- Four Command Post vehicles (These can be used as a tactical operations center or an armored ambulance, among other things.)
- Tank gun ammunition
- Phoenix Ghost drones (These are a type of "loitering munition," or a weapon that can wait in the air for extended periods of time before attacking a target. This was created by the United States for use in Ukraine.)

July 8

The Pentagon <u>announced</u> an additional \$400 million of military assistance via presidential drawdown, including:

- Four additional HIMARS
- HIMARS ammunition
- Artillery ammunition

July 1

The Pentagon <u>announced</u> that it will send \$820 million of security aid, with \$50 million authorized via presidential drawdown and the remaining \$770 million coming via USAI funds. This included:

- HIMARS ammunition
- Two National Advanced Surface-to-Air Missile Systems (NASAMS) (This system launches missiles to defend against various types of aircraft, including drones.)
- Artillery ammunition

June 23

The Pentagon <u>announced</u> an additional \$450 million in military assistance via presidential drawdown, including:

- Four HIMARS
- Artillery ammunition
- Grenade launchers
- Patrol boats

June 15

The Pentagon <u>announced</u> an additional \$1 billion in lethal aid, with \$350 million authorized via presidential drawdown and \$650 million coming from USAI funds. This included:

- Howitzers (This is a popular long-range artillery weapon.)
- Artillery ammunition
- HIMARS ammunition
- Two Harpoon coastal defense systems (These launch missiles that fly just above the surface of the water to attack planes and ships.)

June 1

The Pentagon <u>announced</u> an additional \$700 million in military assistance via presidential drawdown, including:

- HIMARS ammunition
- Javelin missiles and other anti-armor weapons
- Artillery ammunition
- Four Mi-17 helicopters (These can be used for transport or combat.)

May 19

The Pentagon <u>announced</u> \$100 million in lethal aid via presidential drawdown, including:

- Howitzers
- On the same day, Congress <u>passed</u> a \$40 billion aid package for Ukraine, roughly half of which was earmarked for military assistance.

May 6

The Pentagon <u>announced</u> \$150 million in military aid via presidential drawdown, including:

Artillery ammunition

April 21

DoD announced \$800 million in further aid via presidential drawdown, including:

- Howitzers
- Artillery ammunition
- Phoenix Ghost drones

April 13

The Pentagon <u>announced</u> that it will send an additional \$800 million in military assistance via presidential drawdown, including:

- Howitzers
- Artillery ammunition
- Switchblade drones (This is another form of loitering munition.)
- Javelin missiles and other anti-armor weapons
- Armored personnel carriers
- 11 Mi-17 helicopters
- Various types of explosives

April 6

The Pentagon <u>announced</u> an addition \$100 million in aid via presidential drawdown, including:

Javelin anti-armor systems

April 1

DoD <u>announced</u> that it will send \$300 million in lethal aid using USAI funds, including:

- Laser-guided rocket systems
- Switchblade drones
- Puma surveillance drones
- Anti-drone systems
- Armored vehicles

March 16

The Pentagon <u>announced</u> that it will send \$800 million worth of military aid via presidential drawdown. The exact contents of this package are unclear, but it likely <u>included</u> Mi-17 helicopters, Javelin missiles, and Stinger anti-aircraft missiles.

March 12

The White House <u>announced</u> that it will send \$200 million in lethal aid via presidential drawdown, including:

- Javelin missiles
- Stinger missiles

March 10

Congress <u>approved</u> \$13.6 billion in aid to Ukraine, roughly half of which was earmarked for military assistance.

February 25

The White House <u>announced</u> that it will send \$350 million in military aid via presidential drawdown, <u>including</u>:

- Anti-armor weapons
- Small arms

Several Russian soldiers involved in the military operation in Ukraine have been hospitalized with severe chemical poisoning, the Russian Defense Ministry said on Saturday.

Traces of Botulinum toxin Type B, which is an "organic poison of artificial origin," have been discovered in samples taken from the servicemen, the ministry said, accusing Kiev of "chemical terrorism."

The Russian troops were "hospitalized with signs of severe poisoning" after being stationed near the village of Vasilyevka in Zaporozhye Region on July 31, the statement said.


"The Zelensky regime has authorized terrorist attacks with the use of toxic substances against Russian personnel and civilians" following a string of military defeats in Donbass and other areas, the ministry insisted.

Moscow plans to send laboratory tests from the soldiers to the Organization for the Prohibition of Chemical Weapons (OPCW).

Botulinum toxin, often called the "miracle poison," is one of the most toxic biological substances known to science. Produced by the Clostridium botulinum bacteria, it blocks the release of the acetylcholine neurotransmitter, causing muscle paralysis.

Botulinum toxin Type A has been used in medicine in small doses in recent decades, especially to treat disorders characterized by overactive muscle movement. It's also well known in cosmetology under its shortened name, Botox.

However, Botulinum toxin poses a major threat as a bioweapon due its ease of production and distribution, and the high fatality rate resulting from poisoning. Recovery is only possible after a lengthy period of intensive care.



Why is Botulinum of concern in this situation? Well, first off it validates some of the reports Russia has made to the UN. If you recall, Russia reported 16,000 samples of bio-weapons materials gathered from Ukrainian bio-labs in the Ukraine operated by the U.S. 46 bio-labs alone were finally admitted to by the U.S. after months of stonewalling the claims that the U.S. was running "bio-weapons" programs in the Ukraine. I shared a report in my weekly series "Mass Murder" part #79 on this expose of U.S. client states around the world doing genetic research on different ethnic groups.

Yes, that is right, Fauci and crew are now actively performing gain-of-function (GoF) work and infecting primates with the Spanish Flu. For those of you that are unaware, GoF does not have a single agreed upon definition but, as it relates here, is essentially the modification of the Spanish Flu virus to make "more functional." In this case, as with COVID, I have little doubt the GoF supporters will argue that this is not GoF but the article actually notes that this disease was created in canine kidneys with supplemental bovine serum. Here is a quote from the document:

Virus and cells. Influenza virus A/South Carolina/1918 (H1N1) was generated by reverse genetics (9) and handled in biosafety level 4 (BSL-4) containment at the National Microbiology Laboratory (NML). Sequences of the 1918 influenza viral segments were based on data reported under GenBank accession numbers DQ208309, DQ208310, DQ208311, AF117241, AY744935, AF250356, AY130766, and AF333238. 1918 influenza virus was cultured usingMadin-Darby canine kidney (MDCK; ATCC, Manassas, VA, USA) cells. MDCK cells were grown in minimum essential medium (MEM; HyClone) supplemented with 5% fetal bovine serum (FBS; HyClone) and 1 L-glutamine (L-Glu; Gibco, Life Technologies, Grand Island, NY, USA).

A passage 2 (P2) virus stock was prepared using MEM supplemented with 0.1% bovine serum albumin (BSA) (fraction V; HyClone), 1 L-glutamine, and 1 mg/mL N-tosyl-L-phenylalanine chloromethyl ketone (TPCK)-treated trypsin (Sigma-Aldrich). This stock was used for animal inoculation. The mouse 50% lethal dose (MLD50) for this stock was determined previously to be 103.2 PFU (9); this value was confirmed prior to the use of the stock for macaque infection.

I frankly do not care to debate the nuance of whether the recreation of generally extinct virus "generated by reverse genetics" using pieces and parts of other animals qualifies as GoF; what I care about is that we have recreated the Spanish Flu and are experimenting with it on other animals. I also care that one focus of this article is the fact that scientists are frustrated that the recreated Spanish Flu is not dangerous enough. We do not have to get far in this to see this frustration. At the beginning of the article in the summary of its importance this statement is made:

Here, we demonstrate that even at the highest doses tested, 1918 influenza was not lethal in these two macaque species, suggesting that they are not ideal for the development and testing of novel pandemic influenza-specific vaccines and therapies. Therefore, other physiologically relevant nonhuman primate models of pandemic influenza are needed.

At this point I am preparing to release the results of a major investigation we have been undertaking at Renz Law that will demonstrate that SARS-COV2 was in fact created in the Wuhan labs as part of a GoF project. We believe the investigation demonstrates this in a way that far exceeds a preponderance of the evidence standard and probably exceeds reasonable doubt. With that in mind, and given the result of the previous coronavirus GoF, can ANYONE possibly argue GoF work on the Spanish Flu is a good idea? However, 1918 influenza was uniformly nonlethal in these two species, demonstrating that this isolate is insufficiently pathogenic in rhesus and Mauritian cynomolgus macaques to support testing novel prophylactic influenza approaches where protection from severe disease combined with a lethal outcome is desired as a highly stringent indication of vaccine efficacy.

Putin Warns of 'World War 3' with U.S. President Biden's behavior on the world stage risks sparking World War 3 with Russia, President Putin has warned.

"Today, the United States continues to act with no regard to other countries' security and interests, which contributes to an increase in nuclear risks," the Russian embassy warned in a statement on its Telegram channel.

"The [US'] steps to further engage in a hybrid confrontation with Russia in the context of the Ukrainian crisis are fraught with unpredictable escalation and a direct military clash of nuclear powers."

<u>Infowars.com</u> reports: The embassy noted that Washington has recently withdrawn from two key arms control agreements, the 1987 Intermediate Range Nuclear Forces Treaty, which banned certain classes of land-based missiles, and the 1992 Treaty on Open Skies, which allowed for surveillance flights over each other's territories.

The embassy urged the US to "take a closer look at its own nuclear policy instead of making unfounded accusations against the countries whose worldviews do not coincide with the American ones."

"Our country faithfully fulfills its obligations as a nuclear-weapon state and makes every effort to reduce nuclear risks," the diplomats said.

The statement comes after the U.S. accused Moscow of using the Zaporozhye nuclear power plant in southern Ukraine as cover for its soldiers. The plant, the largest in Europe, was seized by Russian troops during the early stages of Moscow's military operation in Ukraine, which was launched in late February. It continues to operate with Ukrainian personnel under Russian control.

U.S. Secretary of State Antony Blinken called Russia's action at the facility "the height of irresponsibility." Russia and Ukraine, meanwhile, have been accusing each other of shelling the plant. According to Moscow, artillery fire by Ukrainians forces caused several fires and partial power outages this month.

Russia initiated a UN Security Council meeting last week regarding the situation around the Zaporozhye power plant. Russian envoy Vassily Nebenzia said that Moscow supports the International Atomic Energy Agency (IAEA) to inspect the facility as quickly as possible.

On Friday, August 19th, 2022 Hal Turner posted the report just below that has raised a great deal of concern as to what might be just ahead. THE GERMAN EMPIRE OF WILLIAM II VERSUS THE RUSSIAN EMPIRE OF NICHOLAS II

At the beginning of the 20th century, before the world wars, Central Europe was deeply unstable. Two powers clashed in this great plain: in the West, the **German and Austro-Hungarian Empires**, in the East, the **Russian Empire.** The populations were invited to choose their protector, knowing that the borders had been modified many times and that none seemed definitive.

The Russian Empire had remained blocked for several centuries, leaving its subjects in a situation of ignorance and complete misery, while the German Empire had become the main scientific center of the world and was developing at great speed. Therefore, most Central European intellectuals chose to support Germany rather than Russia.

During the First World War, the German and Austro-Hungarian foreign ministries launched a joint secret operation: **the creation of the League of Allogenic Peoples of Russia** (*Liga der Fremdvölker Rußlands* – LFR) [1]. They recruited many high-level intellectuals to lead it. The aim was to **implode the Russian Empire by creating separatist movements.** The League called on the United States (which did not enter the war until 1917) to liberate the enslaved peoples.

Dmytro Dontsov, the future founder of "Ukrainian integral nationalism" [2], supported this movement and even became its employee. He shamelessly directed the Bern branch and edited the monthly *Bulletin des nationalités de Russie* in French.



The World League for Freedom and Democracy held its last annual congress on January 22, 2022 in Taiwan.

THE UNITED STATES AGAINST THE SOVIET UNION

In addition, at the end of World War II, the OSS, and later the CIA, organized the transfer of anti-communist leaders from the Axis to the Third World and recycled them into various governments. They created an Asian Peoples' Anti-Communist League around the Chinese Chiang Kai-shek, then a World Anti-Communist League (WACL), with the support of the former Ukrainian full nationalist Prime Minister, the Nazi Yaroslav Stetsko [3]. This secret organization, whose headquarters are still in Taiwan, was renamed the World League for Freedom and Democracy in 1990.

It is no coincidence that the war in Ukraine is followed by provocations in Taiwan, but the logical extension of this strategy. The League is always financed by the Taiwanese secret service and its actions are covered by the defense secret.

UKRAINIAN INTEGRAL NATIONALISTS AGAINST THE RUSSIAN FEDERATION

Ukrainian integral nationalist **Dmytro Yarosh** created in Ternopol (Western Ukraine) in 2007 – that is, under the presidency of Viktor Yushchenko – an "Anti-Imperialist Front", an organization aimed at blowing up the Russian Federation. But whereas the attempts of the 1910s were based on the appeal of the German Empire and those of the Cold War on anti-communism, this third operation relied on **jihadists** [4].

The first Islamic emir of Itchkeria (Chechnya), **Doku Umarov**, should have participated, but he was wanted worldwide and could not get out of Russia. He sent a message of support and was elected co-chairman of the organization. In addition to the abovementioned, he was elected co-chairman of the organization. Jihadists from Crimea, Adygea, Dagestan, Ingushetia, Kabardino-Balkaria, Karachaevo-Cherkessia and Ossetia came to the meeting.

Dmytro Yarosh and many Ukrainian integral nationalists fought in Chechnya on the side of the Islamic Emirate of Itchkeria. At the time, the Western press spoke of a national liberation movement and ignored the imposition of Sharia law by Doku Umarov.

THE FORUM OF FREE PEOPLES OF RUSSIA

Today, when Dontsov's works are required reading for the 120,000 soldiers of the Ukrainian integral nationalist militias and Dmytro Yarosh has become an advisor to the commander-in-chief of the Ukrainian armies, an unidentified sponsor – presumably the German BND, the U.S. CIA and the Ukrainian SBU – organized a Forum of Free Nations of Russia in Prague on July 23-24, 2022 [5].

It seems that the SBU was reluctant to participate and that this was one of the reasons that led the US to recommend to President Volodymyr Zelenskyy to dismiss its director.

The term "Free Peoples" is the one used by Ukrainian integral nationalists, including the Ukrainian economist **Lev Dobriansky**. Dobriansky founded the National Captive Nations Committee with President Dwight Eisenhower and Yaroslav Stetsko, and later helped found the World Anti-Communist League. His daughter, **Paula Dobriansky**, played a central role in the propaganda apparatus of the State Department and the Thomson Reuters news agency. She served as Under Secretary of State for Global Affairs during the presidency of **George W. Bush**. President Donald Trump opposed her appointment as Under Secretary of State for Political Affairs.

The Free Peoples' Forum of Russia uses the argument of peoples' self-determination to justify a partition of Russia. When the USSR was dissolved, fifteen separate states were freed, including the Russian Federation. The idea is to extend this partition, this time creating twenty more states. This would not only create new states in the Caucasus, but also completely change the map of Siberia, that is, the margins of China.

However, if there is a real problem of development in some regions of Russia, it is being solved with the creation of new communication routes, first East-West, then for the last ten years, North-South. The peoples that the BND, the CIA and the SBU wish to "liberate" have never expressed their desire to leave the Russian Federation, with the exception of Chechnya, which is now at peace.

Again, it is no coincidence that the Russian army is emphasizing the place of its Chechen units in its special military operation against the Ukrainian "Nazis" in Donbass [I prefer the term "Ukrainian integral nationalists"]. This is a way for her to remind that she has satisfied the Chechen demands after two terrible wars. Similarly, the President of the Chechen Republic, **Ramzan Kadyrov**, calls on his people to take revenge for the abuses committed in his country by Ukrainian integral nationalists.

On August 15, 2022, President Vladimir Putin, who is acutely aware of this Western strategy, announced the convening of a world anti-Nazi conference in Moscow.

With that burned into the memory of perhaps the greatest chess player in the world of global politics that should be keeping the demons up at night in Washington, D.C. The southern border for all intent and purpose has been an open highway from Central America to the Interstates of the U.S. More than 2-million illegals have made their way to the streets of small towns and cities across the land since the Biden/Harris/Obama team took office. "We will not fight a war against Russia in Ukraine." So said U.S. President Joe Biden back in March this year while also bragging at the same time about pumping Ukraine with lethal weapons to ensure that the NATO-backed Kiev regime would not be defeated.

Biden's nationwide speech added with a foreboding intonation: "A direct confrontation between NATO and Russia is World War Three, something that we must strive to prevent."

We should have expected that appalling, fatuous contradiction to sooner or later become manifestly untenable. Indeed, the American people and the world have been conned by a warmongering puppet in the White House.

In reality, it looks like the Biden administration and its NATO partners have done everything to strive toward making war against Russia happen. This American president's words (like those of his predecessors) have no credibility. Despite his apparent grave warning about preventing WWIII, the manikin in the White House has facilitated this very outcome in the abject service of U.S. imperialist interests. Biden has been a loyal servant of American warmongering for over 50 years, supporting every criminal war that U.S. imperialism has waged. However, it's a mistake to blame Biden personally, a so-called Democrat. He is but the figurehead for a system that needs war in order to function. If for talk's sake, Donald Trump or some other Republican politician happened to be in the White House, we would no doubt see the same despicable dilemma.

There are increasing reports of military attacks on Crimea and other parts of the Russian Federation. The Belgorod Region neighboring Ukraine has been bombed several times with villages being evacuated. A Ukraine drone also reportedly tried to attack the Kerch Bridge which connects the Russian mainland with Ukraine. The 19-km bridge was opened in May 2018 by Russian President Vladimir Putin at a cost of \$3.7 billion.

It is not clear yet what are the exact causes of these explosions. Initially, Russian authorities claimed they were accidental fires, but now they are admitting acts of sabotage being committed. Western media reports claim U.S. and NATO missiles or drones are involved. The United States is increasing its supplies of long-range offensive weapons as well as C-4 explosives for sabotage operations. Up to \$40 billion worth of munitions has been pledged by the U.S., Britain, Poland, Germany and other NATO powers to support the Nazi-infested Kiev regime in its war against Russia. Ukraine has descended into an orgy of Western militarism.

The Kiev regime's military conduct is being overseen by American and British intelligence. Attacks on Crimea and presumably other parts of the Russian Federation are approved by Washington and London.

In addition to an unprecedented flood of NATO weapons into Ukraine, it is increasingly apparent that the U.S.-led axis is training Ukrainian forces.

This week it was reported that Ukrainian soldiers are being trained in Britain to go fight. At a Copenhagen conference last week, British recruitment and training programs for Ukraine were supported by other NATO members including Denmark, Canada, Poland and the Baltic states. The U.S. and its NATO allies have been running combat training in Ukraine for years. That was partly the reason why Russian forces went into Ukraine in February this year to neutralize a growing national security threat.

The fact that NATO is stepping up its combat support for the Ukrainian military in Britain and on other member states' territories is clear proof that the U.S.-led axis is at war with Russia. This is no longer a proxy war, but rather a full-scale multi-level war.

Another ominous development was the deployment of American B-52 long-range bombers to Sweden this week. The Nordic country is a soon-to-be new member of NATO along with Finland. The combined move is intended as a calculated threat to Russia's Arctic region. The Arctic has long seen increasing NATO forces menacing Russia, but the first-ever deployment of nuclear-capable B-52 bombers to Sweden is an "important signal", as Sweden's Defense Minister Peter Hultqvist gloated.

All of this shows a heinous, relentless logic for war. Biden's public misgivings about World War Three were just contemptible piffle. The United States has been gearing up for hostilities against Russia since at least the CIA coup d'état in Kiev in 2014. It really doesn't matter who sits in the White House. Obama, Trump, Biden, like others before them, are all just message boys for U.S. imperialism. The American ruling regime has a desperate addiction to war to revive its diminishing global power and failing capitalist economy. That's why Washington is hell bent on recklessly stoking dangerous tensions with Russia and China, as Russia's Putin pointed out this week.

The sheer array of military involvement in Ukraine and the new, dangerous phase of striking Russian territory means that the U.S.-led NATO axis is de facto at war against Russia. The axis consists of 30 nations (not including Sweden and Finland) plus other non-NATO allies such as Australia and New Zealand. Weapons of increasing long-range offensive capability, as well as training of military forces, are flowing to Ukraine from all of these U.S.-led nations.

Last December, Russia appealed for a diplomatic resolution of long-held strategic security concerns regarding NATO and Ukraine. Those appeals were arrogantly shunted away by Washington and its vassals. Earlier apparent reservations among NATO members about sending lethal weapons to Ukraine have been jettisoned too.

Evidently, so too abandoned are erstwhile reservations about starting an international conflict.

The United States, Britain and other imperialist powers are callously turning on the taps to make a bloodbath in Ukraine. The fascist regime they are backing in Kiev is wantonly using nuclear terrorism by attacking the largest nuclear power station in Europe at Zaporozhye. And yet the Western sponsors continue to double down on the provocations to Russia, provocations that now appear to include military strikes on Russian sovereign territory.

Moscow has repeatedly warned that "decision-making centers" will be targeted if its territory is attacked. That warning implies Western capitals are vulnerable. Russia has also warned that if its national security is threatened then it reserves the right to use nuclear weapons for defense. The unthinkable is becoming thinkable. Western states are in thrall to a warmongering agenda and media system that acts like a propaganda ministry for war. Shamefully, there are scarcely any political voices in the West calling for diplomatic negotiations for peace.

The madcap U.S.-led Western powers do not seem to recognize any boundaries. The whole conflict over Ukraine demonstrates the relentless logic of belligerence towards Russia that the Western ruling regimes are addicted to, in the same way as they are towards any other nation that is perceived as an obstacle to global power ambitions. The Western regimes are helplessly, hopelessly charted for war regardless of the democratic interests and wishes of their populations or the constraints of international law. So much for rules-based order! Western rulers and their puppets in office are leading their people and the rest of the world over the abyss.

Incredibly, it seems, the same vile political and economic forces that created two previous world wars are salivating again. And they are unleashing their apocalyptic desires with the same lies and self-righteous deceptions. In wrapping this up, I can only repeat the words of the title of this article, "How Long Do You Think It Will Be Before Putin Decides to Nuke the U.S.?

Russia denied carrying out any attacks from the plant and demanded that Ukraine cease firing artillery at the plant. Ukraine has NOT stopped.

More recently, Ukraine has now begun publicly claiming it is RUSSIA, firing at its own people in that plant, to "create a false flag excuse to use Tactical nukes against Ukraine."

Russia has repeatedly and publicly decried the shelling of the plant, and has repeatedly and publicly warned of a radiation catastrophe if Ukraine continues firing at the plant.

Russia raised this issue with the UN Security Council, and Russia asked the International Atomic Energy Agency (IAEA) to come to the plant immediately to see for itself who is actually firing against the plant.

The UN Security Council did exactly nothing. The IAEA responded to Russia this week, telling them the IAEA may be able to send someone maybe in September. Yes, you read that right . . . maybe in <u>September</u>.
