9) Even children are now being jabbed with the exceedingly dangerous and deadly COVID-19 'vaccines' with many of them experiencing heart inflammation, among other serious symptoms and medical ailments. The often fatal blood clot only become more evident by the day as do other serious adverse effects that are occurring after vaccination with increasing frequency. All the while, the MSM reporting on the real risks remains virtually nonexistent.

10) Particularly throughout the early stages of this preplanned pandemic, the standard medical response was not to issue treatment guidelines for COVID-19 prior to hospitalization. This immense institutional failure is completely without precedent in both scope and magnitude. Deliberately withholding vital treatments and appropriate medications was the real linchpin in this plan to commit genocide.

11) Once a hospitalization occurred, the medical protocols which were routinely administered became the primary cause of death, not COVID-19. Physicians around the world complained as never before in history that the medical treatments were a HUGE part of the problem; and certainly not part of the solution. The planned result was a culling of the global population via medicide whereby iatrogenic death (and Covid illness) has occurred in record numbers.

Now, more than a year after this article was originally posted, one has to wonder why so many people have "drank the Kool-Aid". By that I am saying that so many supposedly educated people fell into the trap of Mass Formation Psychosis following the herd mentality. I saw this post more than a year ago and watched to see if anyone in the ranks would react to it, challenge it, or see if it got traction legs and circulated. Nothing followed, virtual silence ensued.

In my Mass Murder series, now at segment #76, I have noted that the average age of death is 73, it has only dropped by a year from 74 over the first fifty-two weeks of my series. When Robert Kennedy Jr. began posting the weekly VAERS reports on Fridays, for months the average age of death was 74.3 years. It has been my view from the very start that this was all about the governments of the world agenda to literally "Depopulate" the world of the elderly, or "useless eaters" that Dr. Henry Kissinger referred to the elderly by this term. World leaders could justify their genocidal attack on the frail and elderly. It is a fact that 75% of Americans over the age of 50 are on as many as seven medications.

Something that Franklin D. Roosevelt never counted on when he created the Social Security System in 1935 was the fact that longevity would increase in the ensuing decades. Life insurance data during the 1930s confirmed the average age of death for a man was 59.9 years and 61.6 years for a woman. The average for both sexes was 61.7 years. However, if you note eligibility to receive Old Age Survivors benefits was set at 65 years. Today most people now have to work to age 67 in order to collect their full benefits. The government is considering raising retirement age to 70, among of a half-dozen steps being considered to restore the Social Security system to sound fiscal footing. The fact is millions paid into the system but never lived to see retirement or collect their Old Age benefits. Today we are facing the exact opposite situation due to the increased longevity of American citizens since the 1930s and 1940s. Improved work safety, health, sanitation, and diet have led to increased longevity. Clean water, air, and environmental conditions have been a major factor in increased longevity.

In the wee hours of Wednesday, August 3rd, 2022 I saw a news report on Siri news that future Social Security recipients would face a 20-25% cut in benefits in 2035. Very

intelligent people such as Dr. David L. Martin, and Edward Dowd called this early in 2021 that Covid was all about Genocide of elderly people.

Dr. David L. Martin was the first person that I heard state that this was a culling of those receiving government Social Security Old Age Pensions and health insurance and the strategy would be to let the Insurance industry be the fall guy in paying out life insurance death benefits. It was Edward Dowd who called the spike in overall mortality relative to death benefits. Death rates change very little from year to year, and statistically speaking, they are the basis of life insurance policies premiums. The major life insurance policies written by employers on healthy people began to see spikes of death rates of relatively healthy working people. Overall causes of deaths has exposed that mortality has exploded in huge spikes since late 2021,

Twenty percent of all deaths to Covid vaxxes were directly related to the heart of the victims. Over 17,000 doctors and researchers have signed a declaration stating categorically that genetic vaccinations must be discontinued. According to one amongst them, Dr. Robert Malone, COVID-19 vaccines hinder the immune system and leads to more severe illness. Did they stop administering the vaxxes as the evidence began to pile up? NO! Their propaganda has in fact become even more fearful.

Healthcare professionals who had multiple COVID-19 vaccination boosters after originally contracting the original virus strain from Wuhan are more vulnerable to chronic reinfection from the Omicron variety, according to a study from the United Kingdom.

According to researcher and physician Dr. Robert Malone, this may aid in understanding why individuals who have had several COVID-19 vaccination boosters are frequently the ones who end up in hospitals with severe COVID-19 symptoms, sometimes leading to death.

This phenomenon is the result of a mechanism called “immune imprinting,” through which initial exposure to a virus strain may inhibit the body from generating sufficient neutralizing antibodies against a newer strain, according to Malone, an inventor of mRNA vaccine technology, in an interview.

He continued by saying that multiple vaccinations serve to enhance this process.

“All over the world, we are seeing these datasets that show that, unfortunately, the people that are dying and being hospitalized are overwhelmingly the highly vaccinated,” he said. *“It is not those that have natural immunity.”*

The SARS-CoV-2 strain of the virus causes the illness now known as COVID-19, is the basis for the COVID-19 vaccinations that are currently available.

Several strains have evolved and taken dominance since the Wuhan strain’s prevalence, which includes the present variant know as Omicron.

The issue, according to Malone, is that COVID-19 vaccines only use the spike protein, one of the virus's components, and as a result, the immune system of an individual who has gotten an mRNA vaccination is conditioned to only recognize that component.

"If that antigen has changed slightly, if that virus has changed slightly, [the immune system] still reacts as if it's the old one," he said.

The spike protein of the original virus discovered in Wuhan served as the basis for the COVID-19 vaccines. According to Malone, that particular strain of the virus no longer exists and is not spreading amongst people.

Malone called this effect immune imprinting and said that if a vaccine based on a now-extinct virus strain is regularly given, it trains the immune system to concentrate more and more on the antigen delivered by the vaccine and to ignore anything else that is marginally different.

"The literature on immune imprinting is bombproof," Malone said. "Paper after paper after paper now, in the top peer-reviewed journals from the top laboratories all across the world, is documenting it."

According to Malone, the phenomena has long been recognized in the field of vaccination, but discussion of it is forbidden and avoided by those who work therein.

Malone cited a study from the academic journal *Science* (*read below*) that found that health care workers in the UK, many of whom had the Wuhan variant of the virus and had also had three or four doses of the COVID-19 vaccination, have been suffering chronic recurrent infections from the Omicron variant.

Malone added that a different study that was published in *Nature* demonstrates that the immunocompromised individuals who have had several vaccination doses are where the virus is evolving, and roughly 30% of the highly vaccinated population are experiencing recurrent infections.

Malone pointed out that this runs contrary to the premise that the unvaccinated are endangering the larger community.

According to Malone, who cited a scientific report ([pdf](#)) from Qatar that has not yet undergone peer review, [natural immunity](#) from a COVID-19 infection lasts for at least 14 months and includes immunity against the Omicron strains.

However, he continued, vaccine-induced immunity only persists for a few months. If an individual has not undergone too much immune imprinting, he or she will produce an immune response that includes "all kinds of proteins from the virus" when exposed to the original virus, according to Malone.

“The problem with these monovalent vaccines, or the single-antigen vaccines, is they’re driving all your immune response against one thing as opposed to the whole virus. So all the virus has to do is genetically, through evolution, tweak a few knobs to escape that,” he said. “And that is exactly what’s happened with Omicron.”

The conundrum, according to Malone, is that the majority of the developing nations with poor immunization rates also have the lowest global COVID-19 death rates.

“It’s likely that we’re going to continue to see this trend,” he said.

Only 1.4% of Haiti’s population has received the vaccination, and there have been 838 COVID-19 deaths there, translating to a rate of 73 deaths per 1 million people, according to [Our World in Data](#).

There have been over 102,000 fatalities in South Africa, where vaccination rates are 32%, or 1,717 fatalities per million people.

More than 184,000 individuals have died in the UK, where 75% of people have had vaccinations, translating to a mortality rate of 2,736 per million.

In addition, 1.03 million individuals have died from the virus in the United States, where 67 percent of the population has received vaccinations, resulting in a death rate of 3,058 per million people.

Malone drew attention to an issue with the available mRNA vaccines.

The modified RNA from the vaccine, which is administered into the patient’s arm, is only meant to remain there for a few hours, but a Stanford University study reveals that *“the RNA sticks around for at least 60 days,”* according to Malone.

Despite the fact that the drug is still in the body two months after immunization, the government only takes into consideration vaccine responses and illnesses that are reported on the Vaccine Adverse Event Reporting System ([VAERS](#)) within the first few weeks.

“The RNA from the vaccine produces more spike protein than the natural infection does,” he said. *“Now that makes sense about why we see more adverse events with the vaccines than we see with the infection itself, because spike is a toxin.”*

The Food and Drug Administration and the Centers for Disease Control and Prevention formed VAERS to gather and examine information regarding the negative effects of immunization.

According to the Department of Health and Human Services, the system depends on users to submit reports and is not designed to ascertain whether a reported health issue was brought on by a vaccine. However, it is *“especially useful for detecting unusual or*

unexpected patterns of adverse event reporting that might indicate a possible safety problem with a vaccine.”

Over 17,000 doctors and researchers have signed a declaration stating categorically that genetic vaccinations must be discontinued, according to Malone, president and co-founder of the International Alliance of Physicians and Medical Scientists.

“These genetic vaccines are not working,” he said.

Perhaps maybe they are working as planned!

It's more realistic to believe the so-called vaxxes are “working” and working well enough to kill millions around the world; and those that do not die immediately or within weeks are ultimately faced with a damaged immune system that will shorten their life such that they will not collect Social Security benefits. If 30% of the vaccinated are experiencing repeated infections which will weaken their immune system the likelihood of death before age 65 is assured and that benefits the Social Security Administration.
