# How and Why Biden & Gates Spy Hides Man-Made SARS-Cov-2 in US Intelligence Dossier

# **VERSIONE IN ITALIANO**

Before finding out why one of the most important spies in the world is concealing the artificial origin of SARS-Cov-2, we must make an "epistemological" premise on the methods of analysis used by the U.S. Office of the Director of National Intelligence to deny, for the second time, the construction of the pandemic virus as a bioweapon in a "China-US" deal.

As immediately <u>denounced by the late virologist Luc Montagnier</u>, recently confirmed by <u>a dossier from the U.S. Senate Health Commission</u> and repeatedly highlighted in every detail by the 74 investigations of the Wuhan-Gates cycle conducted by Gospa News (among which only 68 ones already translated in English).

We leave to the philosophers the task of defining whether the document of the ODNI (Office of the Director of National Intelligence), declassified on June 23, 2023, by director Avril Haines who coordinates all 17 federal agencies of American 007, represents a "paralogism" or a "sophism".

We will try to explain how and why the lawyer Haines, an expert in bacteriological weapons and "trusted spy" of the American president Joseph Biden and the world emperor of vaccines Bill Gates (later we will remember why ...) is misleading and concealing the investigations on the origin of the most devastating human pandemic caused by COVID – 19 after twenty years of Fauci's dangerous experiments as DURC: <u>Dual Use Research of Concern to develop vaccines or bio-weapons.</u>

«This report responds to the COVID-19 Origin Act of 2023, which called for the U.S. Intelligence Community (IC) to declassify information relating to potential links between

the Wuhan Institute of Virology (WIV) and the origin of the COVID-19 pandemic» we can read in the paper which refers to the law approved by Congress last March.

#### THE CLAMOROUS GAPS IN THE INTELLIGENCE DOSSIER

The brief did not offer any information beyond that mandate, including possible intelligence about other coronavirus labs in the city or the intelligence that persuaded some agencies the virus has a natural origin.

The brief does not appear to include new intelligence but rather select details about intelligence the <u>U.S. government</u> has had for more than two years written by journalists and activists Emily Kopp and Karolina Corin of *U.S. Right to Know* in an article relaunched by 'The Defender' website by Robert F. Kennedy jr, now a candidate in the Democratic primaries for the 2024 US presidential elections and the first to blame the <u>"pandemic planned for decades by Gates and Fauci".</u>

Three points make the report of the American Intelligence Community (hereinafter IC) misleading, incomplete and therefore deceitful as a "sophistry":

It absolved of all responsibility the research conducted by the Wuhan Institute of Virology in collaboration with Chinese military officials of the People's Liberation Army (PLA) on chimeric viruses with genetic modifications and viral load enhancement, despite the <u>U.S. Department of Energy</u> and the <u>report of the Senate have argued otherwise and they pointed out, among others, the Sino-American research funded by Anthony Fauci which is considered <u>the "smoking gun" of the SARS-Cov-2 bio-weapon</u></u>

It did not in the least delve into the experiments conducted among the WIV, the American scientists coordinated by Fauci, and the projects of <u>Peter Daszak's EcoHealthAlliance financed by Bill Gates.</u> On the other hand, Congress had only asked to investigate the role of the Chinese...

It has not demanded a detailed report from the Central Intelligence Agency (CIA) which has always been the supervisor of every bacteriological project developed abroad in the civilian or military fields thanks to funding from the USAID government agency as happened for the PREDICT project on coronavirus research conducted by the Obama-Biden administration both in Wuhan and in the biological laboratories opened by former CIA director Leon Panetta in Ukraine under the aegis of the Pentagon.

The conclusions of the Haines CI are the same as in the previous IC dossier in which, even then, there was a split within the American federal investigative agencies. Here is the summary of the brief:

The National Intelligence Council and four other IC agencies assess that the initial human infection with SARS-CoV-2 most likely was caused by natural exposure to an infected animal that carried SARS-CoV-2 or a close progenitor, a virus that probably would be more than 99 percent similar to SARS- CoV-2.

The <u>Department of Energy</u> and the Federal Bureau of Investigation assesses that a laboratory-associated incident was the most likely cause of the first human infection with SARS-CoV-2, although for different reasons.

The Central Intelligence Agency and another agency remain unable to determine the precise origin of the COVID-19 pandemic, as both hypotheses rely on significant assumptions or face challenges with conflicting reporting.

Almost all IC agencies assess that SARS-CoV-2 was not genetically engineered. Most agencies assess that SARS-CoV-2 was not laboratory-adapted; some are unable to make a determination. All IC agencies assess that SARS-CoV-2 was not developed as a biological weapon.

In the face of such incomplete information, we should immediately ask ourselves how the USAID government agency and the Pentagon financed research on COVID – 19 in a Ukrainian laboratory three months before the pandemic, again in close collaboration with the PREDICT-USAID project which is supervised by the CIA...

#### THE ODD DEFENSE OF THE WUHAN LABORATORY

As noted in the article by Emily Kopp and Karolina Corin of the U.S. Right to Know: ODNI missed the legally-mandated deadline of June 18, a date that coincided with a trip by Secretary of State Antony Blinken to Beijing in an unsuccessful bid to reestablish military-to-military communications amid escalating U.S.-China tensions. ODNI finally released its report on June 23. A lot of information relevant to the intelligence community's assessment appears to be missing.

Miraculously, after that international summit, the allegations in the dossier of the <u>Department of Energy</u> and the <u>US Senate Health Committee</u> on the significant role played by Wuhan in the engineering of manmade SARS-Cov-2 evaporated in the memory of the Intelligence Community.

The WIV is a civilian research institute founded in the 1950s by the Chinese Academy of Sciences (CAS). Although the WIV is independent of the People's Liberation Army (PLA), the IC assesses that WIV personnel have worked with scientists associated with the PLA on public health-related research and collaborated on biosafety and biosecurity projects reads the ODNI dossier.

The information available to the IC indicates that some of the research conducted by the PLA and WIV included work with several viruses, including coronaviruses, but no known viruses that could plausibly be a progenitor of SARS-CoV-2. For example, PLA researchers have used WIV laboratories for virology and vaccine-related work» wrote ODNI.

In 2013, the WIV collected animal samples from which they identified the bat coronavirus RaTG13, which is 96.2 percent similar to the COVID-19 virus. By 2018, the WIV had sequenced almost all of RaTG13, which is the second closest known whole genome match to SARS-CoV-2, after BANAL-52, which is 96.8 percent similar. Neither of these viruses is close enough to SARS-CoV-2 to be a direct progenitor.

#### THE DANGEROUS CHIMERIC VIRUSES CREATED BY CHINESE SCIENTISTS

Despite that Scientists at the WIV have created chimeras, or combinations, of <u>SARS-like coronaviruses through genetic engineering</u>, attempted to clone other unrelated infectious viruses, and used reverse genetic cloning techniques on SARS-like coronaviruses.

#### And above all:

By the end of 2019, the WIV maintained distinct teams focused on MERS and SARS-related coronaviruses. Both teams separately used transgenic mouse models to better understand how the viruses infect humans as well as related vaccine and therapeutics research.

Between 2017 and 2019, the WIV funded and some of its personnel conducted research projects to enhance China's knowledge of pathogens and early disease warning capabilities for the defensive and biosecurity needs of the military.

Prior to collaborating on a vaccine for SARS-CoV-2, the WIV collaborated with the PLA on other vaccines and therapeutics relevant to coronaviruses. The IC assesses that this work was intended for public health needs and that the coronaviruses known to be used were too distantly related to have led to the creation of SARS-CoV-2.

#### FAUCI'S RESEARCH WILLINGLY IGNORED BY U.S. INTELLIGENCE

This statement is partly correct because according to our investigations, the final version of SARS-Cov-2 was not developed in China but in the U.S. or <a href="mailto:the United Kingdom">the United Kingdom</a>, and partly misleading because it does not take into due consideration at least four studies, including three conducted by Fauci who is never mentioned in the IC report.

The 2004 European Commission-funded experiment in which a strain of SARS was artificially recombined with an HIV virus by the Wuhan Institute of Virology possibly in an attempt to find an AIDS vaccine.

The sequences of the HIV virus were found in SARS-Cov-2 by the French biologist Luc Montagnier, who in 2008 won the Nobel Prize for Medicine precisely by discovering the

virus that causes AIDS, together with <u>his biomathematician colleague Jean-Claude</u> Perez.

Another research ignored is the risky experiments between <u>American scientists and Chinese military doctors in which the "smoking gun" of the pandemic was produced:</u> namely the genetic modification of the furin cleavage site to produce a SARS virus with viral load enhanced by the gain-of-function (GOF) technique in order to make it lethal.

Experiments on WIV1 done in collaboration with U.S. partner EcoHealth Alliance led to the "unexpected" enhancement of the virus' lethality and pathogenicity. The viral load increased by 10,000 times remember in their journalistic investigation Emily Kopp and Karolina Corin.

But above all, the experiments developed on coronaviruses by the microbiologist <u>Ralph Baric of the University of North Carolina since 2000</u> have not been taken into consideration, continued in the research on the chimeric virus RaTG13 created together with the WIV thanks to the exemption from the Obama moratorium on GOF tests obtained by Fauci from the National Institute of Health, and ultimately culminating in DARPA-funded research to Moderna Big Pharma that had two virological records.

In 2016 the pharmaceutical company of Cambridge developed an artificial human gene in the laboratory with 19 nucleotides identical to the same number of SARS-Cov-2. In March 2019 he patented the first anti-COVID mRNA gene serum 9 months before the discovery of the first outbreak of this virus which later became a pandemic.

This was ascertained by the American patent expert David E. Martin who at the last International COVID Summit held in the European Parliament accused the USA of intentionally spreading SARS-Cov-2.

# FORMER CIA DEPUTY DIRECTOR AND PANDEMIC PROPHETESS WITHOUT MEMORY... (video)

In light of this analysis, one wonders why the Office of the Director of U.S. National Intelligence persists in denying the artificial origin of SARS-Cov-2 by concealing documents and research that are now in the public domain even for an online newspaper like Gospa News.

The answer is simple and must be sought in the ambiguous attitude of the Central Intelligence Agency which is not able «to determine the precise origin of the COVID-19 pandemic.

As previously mentioned, the American counterintelligence of the CIA, today at the center of various international investigations on the black market of arms trafficking also intended for international terrorist organizations as has already happened in the past, has always dealt with the bacteriological laboratories open abroad (Ukraine and Georgia) by the Pentagon through the DARPA agency or the more specific DTRA

(<u>Defense Threat Reduction Agency</u>) at least since 2011 when the <u>Lugar Center in Tbilisi</u> in <u>Georgia was inaugurated by then-President Barack Obama.</u>

Suffice it to say that the bacteriological laboratory NAMRU-3 (Naval Medical Research Unit Three) suddenly transferred from Egypt to Italy, has settled in the Naval Air Station of Sigonella (Sicily) where the most important CIA station in the entire Mediterranean Sea is also based.

Well, the lawyer Avril Haines, already Senator Biden's bag-woman before he became president, who today leads the Intelligence Community as head of the ODNI, was hired by the Obama-Biden administration in 2013 as deputy director of the CIA and left Langley counterintelligence headquarters in 2015 to arrive at the White House as deputy national security adviser (until 2017 when Donald Trump was elected president).

At that time Fauci, director of NIAID (National Institute of Allergy and Infectious Diseases) was carrying out his experiments on SARS-Cov-2 using the gain-of-function technique as also <u>confirmed by the former director of the CDC Robert Redfield</u> in a deposition before the U.S. Congress.

Haines had earned the prestigious nomination after becoming an expert on bioweapons in the Nuclear Threat Initiative think-tank created by former Senator Sam Nunn, husband of a CIA official and former chairman of the Senate Armed Forces Commission and <u>author of the DTRA dossier</u> on bacteriological laboratories in the countries of the former Soviet Union (Georgia and Ukraine).

How is it possible that an expert in bacteriological weapons was in the button rooms just when the <u>USA was developing experiments with China</u> (strengthened by a collaboration born in 1998 <u>between Bill Clinton and Jiang Zemin</u> who boosted the Wuhan Institute of Virology) and know nothing of what happened?

Was it thanks to the information she acquired at the CIA that in 2018 during a conference in Camden (New Jersey), she prophesied a coronavirus pandemic as Bill Gates had previously done?

It was thanks to Fauci's studies on laboratory SARS that Haines herself was invited to the simulated exercise on the coronavirus pandemic called Event 201 and organized in October 2019 in New York by the Bill & Melinda Gates Foundation together with the World Economic Forum.
