

# It All Began With GPS

## Why You Should Not Buy or Own A 5G Cell Phone!

It all started with Sputnik. What seemed at the time like a major defeat in the Cold War, turned out to be the catalyst for one of the most important technologies of the 20<sup>th</sup> century, and maybe the 21<sup>st</sup>?

It was October 4th, 1957. Scientists at MIT noticed that the frequency of the radio signals transmitted by the small Russian satellite increased as it approached and decreased as it moved away. This was caused by the Doppler Effect, the same thing that makes the timbre of a car horn change as the car rushes by.

### **The Russians launched the Sputnik satellite in 1957, surprising the world.**

This gave the scientists a grand idea. Satellites could be tracked from the ground by measuring the frequency of the radio signals they emitted, and conversely, the locations of receivers on the ground could be tracked by their distance from the satellites. That, in a nutshell, is the conceptual foundation of modern GPS. That GPS receiver in your phone or on the dash of your car learns its location, rate of speed, and elevation by measuring the time it takes to receive radio signals from four or more satellites floating overhead.

GPS has come a long way since Sputnik. Here are the major milestones along the way. Currently, a total of 31 GPS satellites orbit the earth twice a day.

**1959** The Navy built the first real satellite navigation system, which it called TRANSIT. The system was designed to locate submarines, and started out with six satellites and eventually grew to ten. The subs often had to wait hours to receive signals from the satellites, but the model set the stage for true GPS with continuous signaling from satellites in space.

**1963** The Aerospace Corporation completed a study for the military that proposes a system of space satellites that sends signals continuously to receivers on the ground and could locate vehicles moving rapidly across the earth's surface or in the air. The study lays out the GPS concept that we know today for the first time: receivers in vehicles on the ground would derive a precise set of location coordinates by measuring the transmission times of radio signals from satellites.

### **The Air Force launched the first "Block I" GPS satellite into space in 1974.**

**1974** The branches of the military, after having worked on a GPS system for the past 11 years, launch the first satellite of a proposed 24-satellite GPS system called NAVSTAR. The satellite, and many to follow, are meant to test the NAVSTAR concept.

**1978-1985** The military launches 11 more test satellites into space to test the NAVSTAR system, which by then was called simply “the GPS System”. The satellites carried atomic clocks with them, to more precisely measure transmission times. Some of these satellites (starting in 1980) carried sensors designed to detect the launch or detonation of nuclear devices.

**1983** Shortly after the Russians shot down Korean Air flight 007 after it wandered off course into Soviet airspace over the Kamchatka Peninsula, president Reagan offered to let all civilian commercial aircraft use the GPS system (once it was completed) to improve navigation and air safety.

**1985** The government contracts with private companies to develop “airborne, shipboard and man-pack (portable)” GPS receivers.

**1989** After years of testing, the Air Force finally launches the first fully operational GPS satellite into space. The Air Force had planned to launch the satellite on the Space Shuttle, but changed its plans after the Challenger disaster in 1986 and used a Delta II rocket instead.

#### **The first handheld consumer GPS device, the Magellen NAV 1000.**

**1989** Magellan Corporation claims to be the first to market in the U.S. with a hand-held navigation device, the Magellan NAV 1000.

**1990** Fearing military adversaries might use the GPS system to advantage; the Defense Department decides to deliberately decrease the accuracy of the system.

**1994** The FAA and Bill Clinton tell the worldwide airline industry that can continue using the GPS system free of charge “for the foreseeable future.”

**1995** The first revision of the GPS system was finally completed in 1995 when the last of a full “constellation” of 27 fully operational GPS satellites is launched into space. Of those 27, three were used as spares to quickly replace any of the 24 active satellites that failed. The satellites, which weighed between three- and four-thousand pounds, circled the globe twice a day. They were situated so that at least four of them were visible from any place on earth at any time of day.

**1998** Vice President Al Gore announced a plan to make the GPS satellites transmit two additional signals to be used for civilian (non-military) applications, especially to improve aircraft safety. Congress approved the plan (called “GPS III”) in 2000.

#### **The Befon Esc! was the first mobile phone with GPS built in.**

**1999** Mobile phone manufacturer Benefon launched the first commercially-available GPS phone, a safety phone called the Benefon Esc! The GSM phone was sold mainly in Europe, but many other GPS-enabled mobile phones would follow.

**2000** The Defense Department ended the purposeful degradation of GPS, which it implemented before the first Gulf War. GPS became ten times more accurate overnight, and all kinds of industries—from fishing to forestry to freight management—soon began using it.

**Personal GPS devices like the TomTom Start 45 car navigation device became hugely popular shortly after the turn of the century.**

**2001** As GPS receiver technology got much smaller and cheaper, private companies began pumping out personal GPS products, like the in-car navigation devices from Tom Tom and Garmin.

**2004** Qualcomm said it had developed and tested “*assisted GPS*” technology allowing phones to use cellular signal in combination with GPS signal to locate the user to within feet of their actual location.

**The first “Block II” satellite joined the GPS constellation in 2005.**

**2005** The first of a new generation of GPS satellite, called “Block II,” was launched from Cape Canaveral. The new breed of satellite transmitted signals on a second, dedicated civilian channel.

**2009** The Government Accountability Office (GAO) issued a report warning that the \$5.8 billion effort to upgrade the GPS satellites was so fraught with technical problems, cost overruns, and delays that some of the satellites could begin to fail in 2010. This sent the Air Force scrambling to allay fears, saying “*There’s only a small risk we will not continue to exceed our performance standard.*”

**The next generation of GPS satellite, called “Block III” was activated starting in 2014.**

**2010-2011** The Air Force launched two new GPS satellites, one in 2010 and one in 2011, that are meant to keep the constellation operable until the next generation “Block III” satellites can begin launching in 2014. The new Block III satellites will add an additional civilian GPS signal, and will enhance the performance of existing GPS service.

**2012** At present, the Air Force manages a constellation of 31 operational GPS satellites, plus three decommissioned satellites that can be reactivated if needed. The constellation is managed to ensure the availability of at least 24 GPS satellites, 95% of the time. On October 4<sup>th</sup> the Air Force would launch the next addition to the constellation, the GPS IIF-3 satellite, into space.

What does any of this information have to do with my smart phone or Covid? Far more than you can understand when you have been gas lighted and lied to for the past

## Two Hundred Passengers Infected With COVID-19 Disembark in Melbourne, Australia

7NEWS Australia reports today that 200 passengers infected with COVID-19 disembarked from the “*Grand Princess*” in Melbourne, Australia after the Princess cruise ship completed a thirteen-day around-trip to New Zealand. There are no public accounts of the number of infected crew members.

7News Australia reports on its Facebook page that “*200 COVID positive patients have been allowed to come ashore in Melbourne after they were caught up in a cruise ship nightmare. Some had been stuck in tiny cabins with limited supplies for up to eight days before they were allowed to disembark.*”

In an article titled “COVID-Infested Cruise Ship Docks in Melbourne,” 3AW 693 News Talk interviewed a passenger on the “*Grand Princess*”. The guest, who was not positive with COVID-19, commented that she did not notice other people on the ship coughing or exhibiting signs of the virus. But she said that there was no general testing of guests whatsoever during the nearly two-week cruise. The majority of the passengers left the ship without being tested, thus obviously leading to additional potential transmission and spread of the virus.

With Australia recently opening up for cruises, there has been a spate of COVID19 outbreaks on cruises calling on Australian ports:

[Majestic Princess](#) – 800 infected guests (Sydney);

[Quantum of the Seas](#) – 400 infected guests (heading toward Queensland)

[Coral Princess](#) – 290 infected guests and crew (Fremantle);

[Ovation of the Seas](#) – 129 infected guests and 2 crew member (New Zealand)

[Majestic Princess](#) – 116 infected guests (Tahiti).

On just three Princess cruise ships (*Grand Princess*, *Majestic Princess* and *Coral Princess*), there have been a total of over 1,400 passengers infected with COVID-19. Although a Princess Cruise spokesperson said that the COVID-positive cases onboard are either “*asymptomatic or mildly symptomatic*,” the truth of the matter is that “*in a well-rehearsed routine, ambulances ferried the sickest to hospitals and the others were told to go home and isolate.*” (see Newshub “[COVID-19: Ambulances meet cruise ship in Sydney after hundreds of passengers get infected.](#)”

In the beginning of the coronavirus outbreak on the “*Diamond Princess*” back in 2020, I asked Princess Cruises whether the virus could be spread through airborne particles. In response to my inquiry in mid-February 2020 which I posted on Twitter (along with a photo of Princess crew members huddled together in a hallway in the crew area), Princess Cruises wrongfully **denied that the virus can be transmitted through the air**. It cited to the World Health Organization that the virus is allegedly “mainly” transmitted via droplets from close person to person contact.

It remains surreal to see thousands of cruise guests packed together in the small confines of a Princess cruise ship, breathing the same air and risking exposure to an airborne virus. The “*Grand Princess*” is now scheduled to cruise to Sydney and other ports in Australia.

Unfortunately, the Australian NSW government’s travel website list, under the title “[Update on cruise vessel COVID-19 status](#)” (last updated November 16th), does not indicate a percentage of passengers and crew who have tested positive to COVID-19 in the last seven days for this particular cruise ship.” (Tier 1 is “0.0% to <3%.” Tier 2 is “3% to <10%.” Tier 3 is “=10%.) There is no official indication nor warning that the *Grand Princess* is sailing with around 10% of the approximate 2,000 passengers infected with COVID-19.

In an opinion piece in the Sydney Morning Herald, Margot Saville made the point that Australia has learned precisely nothing from the “*Ruby Princess*” COVID-19 debacle in 2020, which led to the deaths of 28 people and unleashed a wave of the virus that could have overwhelmed the Australian health system. She asked rhetorically “*should a behemoth like the “Majestic Princess” be free to flush out more than 660 sick passengers into the community*” with nothing more than a warning to stay off public transport?

The same question should be asked of Princess Cruises after the “*Grand Princess*”, “*Majestic Princess*” and “*Coral Princess*” have dumped over 1,400 infected guests ashore in Australian ports and smaller communities ashore?

The purpose of including the report by Jim Walker, a Maritime Attorney is again to bring focus back to my point that Covid-19 is not a virus, but rather microwave radiation poisoning from the ships installed 5G transceivers satellite antenna. This feature was initially installed by the cruise lines as a sales feature to its passengers. Before 2000, anyone cruising passengers could not communicate to the outside world when they were above 51-degrees north of the equator or below -51-degrees south of the equator. Emergency calls had to be routed through the GOES satellite network at a much higher altitude as well as cost to use. With the installation of Medallion.net Princess Cruises began to offer “*The Best Wi-Fi at Sea*”. There are 20 satellites in MEO or Middle Earth Orbit, that service the cruise ship industry. Depending upon where a cruise ship is located on the seas, they can provide better “connectivity” to the cruising passengers, both through MEO or GOES.

What is suspicious of the cruise ship infections of so-called Covid-19 on page 5, these all occurred in the springtime in the southern hemisphere; and I have verified the weather and temperature of those specific cruises and the weather conditions was in the low-80s and mostly balmy to warm moderate cloud coverage. This is certainly not a common time of the year for getting ill from so-called infections in open waters on the oceans!

Prices for the Princess Cruises' MedallionNet start at \$9.99 per day (24 hours of unrestricted access) for a package that is good for the duration of the full journey; prorated packages are also available throughout the course of the sailing.

Princess Cruises now offers a variety of Internet and Wi-Fi package deals. Onboard each of their ships, Princess Cruises gives customers the option to purchase one of four different internet packages to better accommodate their needs. Since first introduced in 2019 the MedallionNet has expanded in many ways, options, features, and prices as well.

Reviews of MedallionNet from some ships this week had some interesting comments, now that they're closer to full capacity, are that the internet has been slower and that the app hasn't been functioning as well (*"I couldn't really get the app to work at all on my sailing, but I'd made all my reservations in advance, used the TV to [order OceanNow food to my cabin](#), and appreciated still receiving a hard copy of the Princess Patter for the daily schedule, so I didn't really need it"*). So keep in mind, that while it is technically "possible" to do all the things I discussed above with MedallionNet, internet speed slows with increasing demand. Choosing an off time (early in the morning, late at night, or in port while most passengers are off the ship) to accomplish important internet-dependent tasks may be the best option in some cases. And it's best to have a backup plan for communication with work and home just in case. Band width demand increases on the cruise ships which results in the "modulation" of the 5G signal to handle the demand!

In the spring of 2020, I wrote two articles on "The Best WiFi At Sea" (links below), I lacked some specifics as to how the cruise lines would handle demand issues after the "Diamond Princess" incident that led to the scandemic creation of a virus, a routine Coronavirus that they soon labeled Covid-19. I expected that what I noted above would be how they would deal with cruisers' needs. It was the first major infection that broke

out on the “Diamond Princess” that got the world media attention and launched the fear-drive scenario the world has faced since.

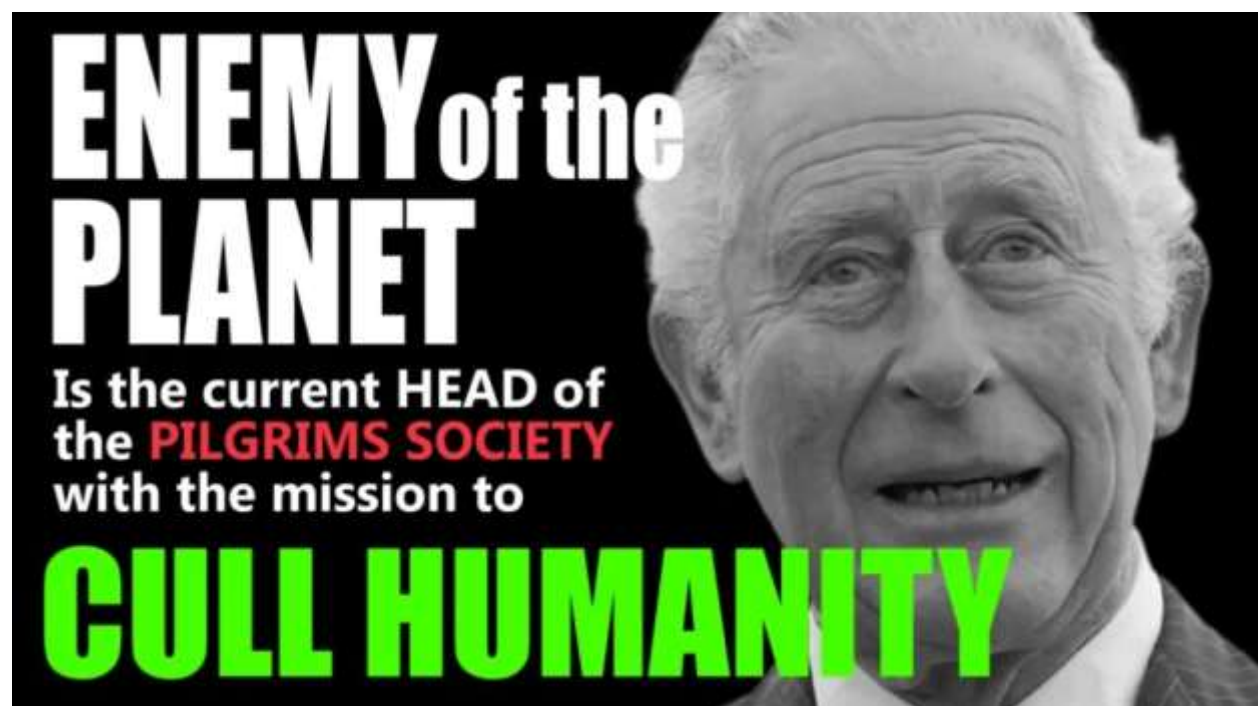

- Daszak visited and worked at the scene of the crime before Covid was first reported. Wuhan China was where the pandemic first started, only CCP stooges deny it.
- Daszak financed the collection of viruses found in bat blood, feces and urine, some of which might be deadly to humans, if they "spilled-over" from nature directly to humans or through an intermediate species. He stored them in BSL-2 lab at the Wuhan Institute of Virology (WIV) that has the same bio-security as a dentist's office. Daszak and Shi Zeng-Li's collection numbers more than 20,000 bat samples. But Shi explained that on average only 10% contain coronaviruses, and only 10% of those are closely related to SARS-CoV-1: in all its years, the team has identified approximately 220 such viruses.
- The process of culturing viruses involves providing them with cells they can infect. Several labs around the world have tried to get live bat coronaviruses and failed. Until <https://www.nature.com/articles/s41467-020-20458-9> target="\_blank" > January 2021, the Wuhan lab was the only one that had managed the feat, according to Stephen Goldstein, a coronavirus expert at the University of Utah in Salt Lake City. Yang Xinglou, a senior research scientist on Shi's team worked on this.
- Daszak intentionally orchestrated the pandemic by financing and initiating dangerous gain-of-function, gain-of-threat experiments with corona bat viruses at the WIV by repurposing NIH grants to WIV. [See for yourself where you taxpayer money went](#) Obama banned these procedures in the USA. Daszak outsourced NIH grants from Fauci and his Deputy, Erik Stemmy to Shi Zeng Li, his anally fixated micro-biologist asset, who believes *"The pandemic is nature's punishment for an unsanitary lifestyle."* This faceless, mentally ill, robot was Head of Security at the WIV. Why was Daszak so determined to continue these Gain-of Threat experiment? Because he knew they would leak and cause a pandemic.
- The experiments he financed were aimed at enhancing Corona virus spike proteins, some found in horseshoe bats that caused the first SARS mini-

pandemic, to more easily invade the ACE2 cells in the human lung. *"We sequenced the spine protein, the protein that attaches to cells, and then you create pseudo particles, insert proteins from the viruses that combined to human cells. Each step of this you move closer and closer to could the virus becomes pathogenic in people! You narrow down the field. You end up with a small number of viruses that really do look like killers."*

- Daszak knew a virus would have a good chance of leaking from the BSL-2 WIV lab built in 1956 and never reported it. How did he know other than his conducting experiments there himself? The U.S. State Department had visited the BSL-4 lab built by the French (for experiments with viruses that had no vaccine or cure) and reported major defects in security - so you can imagine what the BSL-2 lab was like.
- He introduced Shi Zeng Li to Ralph Baric, a cowboy microbiologist known as *"Mr. Gain-of-Function,"* who developed a method to disguise the fact a virus had been genetically altered, among other things. Baric also developed a method to bring viruses of the past, such as polio, back, through reverse genetic engineering. So a virus could never be wiped off the planet as long as its nucleic code existed. Baric once gave a lecture on how to profit from a pandemic. [Baric screwed-up](#) and caused a minor pandemic in the area of the University of North Carolina.
- On New Years Day 2019 Daszak was one of the first people in the USA to know of the existence of COVID-19 from his asset at the WIV, Shi Zeng Li. He was first on the scene of the crime.
- DASZAK covered-up his own crime when Daszak led the WHO investigation and cover-up in China that suggested the virus came from Barcelona via frozen meat. Daszak was not allowed on the second WHO panel because of a *"conflict-of-interest"* due to his WIV connection. *"It can take years or even decades to find the cause of a new infectious disease. Sometimes we just never know."*
- Daszak tried to cover up the lab leak theory by orchestrating a letter from various micro-biologists, many of whom were on Fauci's grant pad, that did not contain his name. The claimed the virus spilled over from nature. Daszak also became a fact-checker at Facebook, which permanently banned this researcher from advertising.
- Daszak had a good cover story to disguise his hidden agenda. Dr. Daszak ran the semi-governmental PREDICT program which was supposed to *predict pandemics* and got millions of dollars from numerous U.S. Government agencies, even from the Department of Fish and Wildlife. He convinced Baric and Li that they were conducting gain-of-threat experiments to see which bat virus was next to spillover from nature so they could develop a vaccine for it before it became a pandemic. In the vernacular, he *"chumped them off."*



- Daszak planned to genetically enhance airborne coronaviruses and release aerosols containing nano particles with “*novel chimeric spike proteins*” among cave bats in Yunnan, China. He was going to do the same with MERS viruses which are 30% more deadly than SARS-19. DARPA refused to fund these experiments because of the danger of creating a pandemic.

- Daszak labeled anyone who attributed the pandemic to a lab leak as a *"conspiracy theorist."* There is no conspiracy here. Daszak played these microbiologists like a violin.
- Daszak violated the law regarding grant subrecipients that required him to *"Monitor the activities of the subrecipient as necessary to ensure that the subaward is used for authorized purposes, in compliance with Federal statutes, regulations, and the terms and conditions of the subaward."* Daszak allowed gain-of-function, gain-of-threat experiments that were illegal in the U.S. when he repurposed his Fauci / Stemmy grants

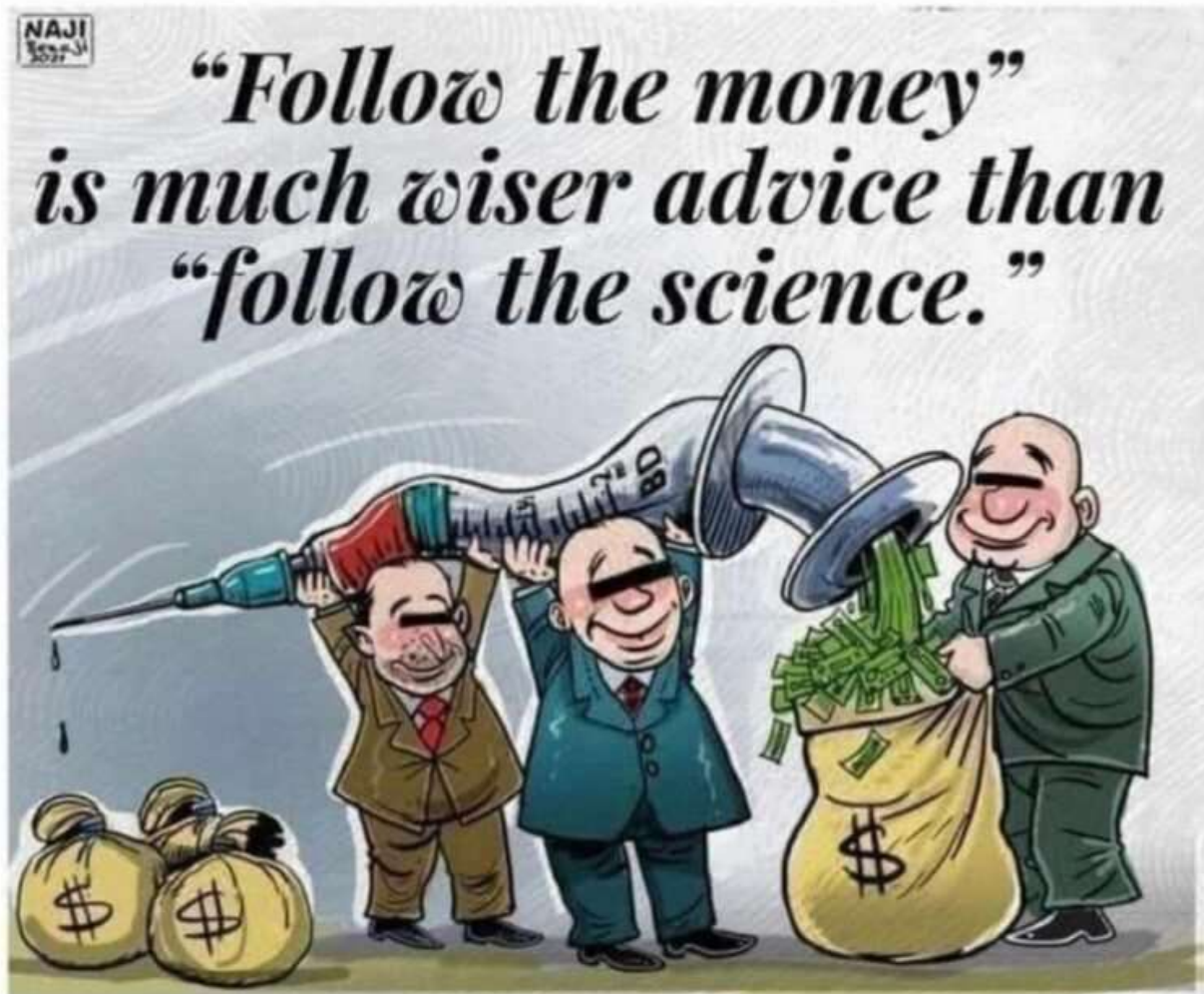

Everyone needs to do what is best for themselves but they need to know the risks. **5G** was created as a military weapon in the 1970s. The Army uses it to breakup crowds of protesters. They used it back in 2008 at the world summit of G8 leader meetings held in Pittsburgh, PA. They turned up the energy beam and it burns rioters skin causing them to scatter. All cell phones produced with a GPS locator chip contains a radioactive isotope called Cesium-137. But the new Samsung and **5G** Apple iPhone 14 series have an enhanced

Once in a while my wife misplaces her cell phone and she will ask me to call her to wit she knows where she left it last and forgot. This little aide proves to be of immense importance in the event one has to place a 911 emergency call. As I noted at the beginning, it was the marrying of GPS to the cell phone that has greatly enabled "connectivity" but at a price few cell phone owners are aware exists. I am about to share some news about the new **5G** cell phones every person should be aware of.

The Foxconn plant in China has had problems for weeks with employees getting sick (blamed on Covid-19) from radiation sickness coming from the new **5G** phones they are assembling. For a month now I have been reading of the problems at the huge plant that assembles 80% of the Apple phones. This past Wednesday morning the plant said it needed 100,000 workers to assemble the new phones and is having trouble keeping employees who quit or escaped the confines of their dorms under lock down from the hazards of assembling the new phone. China's secrecy precludes our knowing of what symptoms or degree of sickness the employees were sick from. The fact that this is concentrated at the main assembly plant is highly suspicious since they are assembling the microchip with the Cesium-137 isotope embedded in the phone's circuit board.

Apple is reporting that the new iPhone 14 series will be delayed until after December 28th due to factory workers getting sick and dying from Covid. The Chinese are blaming this on Covid but it is microwave radiation sickness from the radioactive isotope placed within the cell phone microchip. (If the Chinese do not perpetuate the lie and hide the truth from the world, the industry risks huge class-action law suits). We are talking \$billions of dollars in products the public are anxious to obtain. The plant produces a half-million new iPhone 14 model cell phones a day.

The origin of Covid/5G radiation sickness began on October 31, 2019 when the Chinese turned on their "smart cities" 5G base stations. Thousands died but they hoaxed a story about the cruise ship "*Diamond Princess*" and for a month the ship was denied docking at any port up and down the Asian coast. For 28 days passengers began getting sick and dying and public health authorities blamed it on a virus. The real cause was the new **5G** antennas on the cruise ship upper decks. In late January, 2020 early February 2020, they allowed the ship to dock and allow the passengers to be removed to their home nations. A total of 705 passengers/crew were sickened and 15 older passengers died. The daily figures were in the news media and the public around the world were living in fear of a so-called mysterious "*rogue novel virus*". The Princess Line spent millions of dollars retrofitting each cruise ship with thousands of miles of cable and sensor points.

The world still lives in fear of a non-proved virus. I have written several hundred articles on this scam hoax. The industry and governments of the world are all in on the scamdemic hoax to gas light people. There is just too too much money at stake. The biggest reason behind this hoax is that the governments of the world cannot meet their

At my last inquiry, around 295+ million Americans have "smart" phones. That is about 90% of the U.S. population. From what I know about cell phone radiation, I keep my 4G cell phone at least four feet away from my physical self. I would not own a cell phone were it not for my wife's preference need to keep tabs on my well-being.

The new phones are able to locate a 911 emergency call within 2-meters with the 3 points of triangulation (from cell towers) to provide a closer location of where a person is in an event they need to make a 911 emergency call. The older version 4G phones could locate a distress call but only within a wider range of distance; the new phones use a stronger Cesium-137 chip that is able to narrow the distance to the emergency caller. This has a two-edge sword if you can understand what I am saying.

**5G** technologies does not work without the Cesium-137 isotope which is radioactive and has a half life of 30.7 years. The end result of having one right now is in increased cancer risk! Twenty years ago the rate for cancer was 1 in 5 would contract cancer, today it is 1 in 3 and the American Cancer Society says we are close to 1 in 2 that will contract cancer. It is my opinion that **5G can not be ruled out** as the reason for much of the increase in cancer rates in the U.S..

The media began its scam drumbeat weeks ago and is being hyped again with the term it is now called a "Tripledemic" made up of RSV, Covid, and the seasonal Flu!

How do I know all this you may be asking? Well, installers of the **5G** cell satellites on towers were getting sick and dying. Many have had to go on disability and pension but were required to sign Non-Disclosure Agreements meaning that if they told anyone about their work on **5G** cell towers they could lose their benefits/pensions. When the **5G** tower network rollout is finished sometime late next year it will be used as part of the "Final Solution" phase of a genocide plan to kill anyone who was vaxxed but somehow managed to survive. Cesium-137 amplifies the **5G** wireless signal output and anyone with a new **5G** phone will be executed through a beamed signal frequency that will consume 98% of the oxygen in a person's lungs, resulting in instant death.

To most people this may sound like science fiction but it is technology that has been developed by the military in secrecy over the past fifty+ years. When I got Wi-Fi installed back in Turtle Creek on June 10, 2010, five days later my legs broke out in blisters that burst and leaked milky white liquid. I went to UPMC in McKeesport, PA and the doctors could not identify my problem. They released me from the hospital six days later, billed Medicare \$8K and told me to make followup appointments with them! Each time we moved over the next few years, the blister issue reoccurred and began leaking what I learned to be lymph fluid. Each of the three times we moved we were within 1/3 to a half-mile of a cell tower. It turns out that I am hypersensitive to electricity. I am being slowly poisoned by microwave radiation from the cell towers EMF/EMR. I take measures to minimize or counter its effects to keep it in check. Microwave radiation affects everyone differently. The number one symptom from microwave radiation from cell phones, ipads, chrome books, is headaches. There are over 50 known disorders that are associated with Wi-Fi communications.

The World Economic Forum's Great Reset plan is to eliminate 7-billion people through vaccines and wireless energy. People living near **5G** towers are going to die from cancer, according to *InfoWars* founder Alex Jones.

*“This is what’s going to happen if they execute the next phase of their plan. And they are going to start turning **5G** on and people that live close to it are going to die in a matter of months from cancer. We actually have the studies going back to the other previous forms being used for communications,”* said the host of “The Alex Jones Show” during a recent episode of his program.

*“And what’s important to understand is all of these platforms are multi-use. You can modulate **5G** and these other systems. And they’re good for communications and they still have major cancer-causing effects.”*

Jones added that this is an “*admitted fact*” and there are major studies showing that **5G** causes even more cancer than its previous generations. (Related: Health hazard: **5G** exposure may cause cancer, infertility and developmental defects.)

### **Chicoms are now coming out with 6G and 7G**

The *InfoWars* founder also disclosed that the Chinese communists or Chicoms are now coming out with **6G** and **7G** to run the robot cars, control the robots on record and track everything that people do. The radio talk show host added that these new technologies can be “modulated” differently. Alex Jones has been sued many times and the global elite are trying to silence his program for a number of things he has exposed!

Jones said **5G** has a centralized pre-programmed system that allows it to cause higher rates of medical problems, such as deoxygenation in the lungs and burning of the skin.

Although people can’t see the microwave energy waves coming off the **5G** tower it doesn’t mean they are not there. The independent journalist and author pointed out that people are being hit incrementally from dozens of different angles with these soft kill weapons. You may not see the microwave radiation but you can measure it at levels up to 10-GHz. Anyone with a Tri-Fold meter can measure the waves. I even stopped watching television in my living room after taking meter readings coming from my Wi-Fi router sitting beneath the TV stand. My lift chair is just four feet from the Wi-Fi router! The signal measurements were in the red or hazardous range continuously. My wife complains of headaches regularly and her chair is about 12’ from the TV screen.

According to Alex Jones, the life expectancy of people exposed to **5G** is dropping along with their IQ and cognitive abilities. He also noted that neurological disorders, heart problems and cardiovascular problems are soaring.

*“The body is electrochemical. All your nerves, all your cells are electrochemical. But the heart, particularly, and the brain are extremely electrochemical. The heart is like a big, powered battery full of nerves. And there is a study that these electromagnetic waves jack with your heart. And in studies with mice, they can change the oscillations that aren’t as good for communication, but that will fry you even faster,”* Jones said.

He also said people need to understand that there is a purpose for the **5G** kill grids, along with the Wuhan coronavirus (COVID-19) that came out of the lab and the rollout of the deadly COVID-19 shots like the virus vector injections of J&J and AstraZeneca and the mRNA gene therapy of Pfizer and Moderna.

*“They are then able to test it and gauge the public to see if you wake up and see if you get upset. See if they can normalize a 40-plus percent death rate in every Western country previous to any other year, not COVID-related. They are testing to see if you wake up, if you get organized. If you say no and if you don’t notice what’s happening to you in the stunned condition you’re in, then they up it even more. And they see us as a human scourge,”* Jones said.

Alex Jones is absolutely correct in what he says. I can tell when the cell towers are “modulated” in my area. I meter the signal output several times a day from two towers inside the half-mile range of my residence. I do experience skin and body reactions that go along with the Tri-Fold meter or my other Electromagnetic Radiation meter readings. The mistake people make treating this as nothing is that it is invisible to the eye!

### **Cesium and Cell Phones**

You pull out your phone, ask how to get to the nearest Italian restaurant, and the next thing you know your phone is giving directions and telling you how long it will take to get there. Most of the time we hardly even think about how all of this occurs. One thing that allows cell phones GPS, and the internet to work are atomic clocks. The more technical name for atomic clocks is **cesium clocks**.

Cesium is most commonly used in everyday life with atomic clocks. In fact, the definition of a second is based upon cesium. When a cesium atom vibrates, it goes between two energy levels within a specific amount of time. **One second is the amount of time it takes the cesium atom to vibrate between these two energy levels 9,192,631,770 times!** So this atom is vibrating really quickly! The cesium is so constant in the speed it vibrates that a cesium-based clock takes millions of years to just lose one second!

This extremely accurate time allows satellites to accurately determine where someone is based on GPS data and how long it will take someone to get to somewhere else.

**5G** wireless energy without cesium doesn't work. The new **5G** cellular wireless tech will transfer data and the correct time faster than ever before - fast enough and accurately enough to transform entire industries.

In other words, **5G** technology will rule the world because it can create a continuous, real-time connection for every single device that exists and every single device that will be made because of it.

Cesium is a critical element in all of this, and it could mean the difference between real-time responsiveness and **5G** failure. The battleground for **5G** is also a battleground for cesium, and so far, China is winning by a landslide.

But while cesium is completely insulated from a global pandemic such as that taking down every other industry in the world, from a North American perspective, it matters little that it's insulated or not when China controls almost 100% of the world's supply of cesium.

### **The China Problem**

When the dust settles on the coronavirus pandemic, the world isn't likely to be more unified or to view cooperation as the new way forward. Instead, China particularly is more likely to pursue policies that are more focused on national security than ever.

Washington's battle against China's **5G** giant, Huawei, may have seemed petty to some, but this is the United States' way of playing catchup when it dropped the ball on critical metals like cesium. While the U.S. refused to play along with China's Huawei-led plans for **5G** domination,

The country's **5G** networks, and Germany and France were on the cusp of similar deals. COVID-19 has the potential to put the brakes on this Chinese progress in Europe, but North America still has a major cesium problem to deal with. Beijing is well aware of the power it holds through its monopoly of critical metals. Cesium was only added to the United States list of critical minerals in 2018 despite the fact that it will lead the **5G** revolution, a revolution that will generate trillions of dollars in new products.

Despite the fact that it is so strategic, there are only three pegmatite mines in the world that can produce it: Tanco in Manitoba, Bitika in Zimbabwe, and Sinclair in Australia. Two of them, Tanco and Bitika, are no longer producing, and the stockpiles at Tanco and Sinclair are largely controlled by China. Not only is there limited supply, but there are a very limited number of companies in the supply chain itself.

That positions Power Metals to potentially be a major North American supplier of cesium right at the crucial moment in the **5G** revolution. Known for its major hard rock



lithium deposit in Canada, Power Metals hopes to very soon be known as the company that broke China's monopoly on the critical metal. Power Metals is sitting on what could become only the fourth deposit of its kind in the world, with 100% ownership in the Case Lake property in Northeastern Ontario, where it has made a discovery of high-grade cesium.

The company discovered the pegmatites at a place called West Joe Dyke in August 2018, intersecting high-grade cesium mineralization in six drill holes when it was targeting lithium instead. In February, right before the COVID-19 outbreak turned into a pandemic, Power Metals started drilling, and its world-class geologist, Dr. Julie Selway, says the three properties the company is drilling are hoped to have similar finds to the strategically important Sinclair mine in Australia. *"They are shipping their resource, which they say is higher than 10% cesium-oxide, and ours have some that are between 12% and 14% of cesium-oxide,"* Selway, a key geologist for the Ontario Geological Survey during the tantalum boom of the early 2000s, and now VP of exploration for Power Metals, told Oilprice.com.

Power Metals has intersected cesium (Cs) mineralization in 6 drill holes on West Joe Dyke, with *"exceptionally high-grade"* Li and Ta intervals. They also found Cs mineralization in drill core samples in the first new dyke below Main Dyke, as well as in the drill core in Northeast Dyke. Now, they're working to expose, sample and assay that cesium mineralization on the surface outcrops to find more cesium-bearing pegmatite dykes nearby. When and if they do, it stands a good chance of disrupting the Chinese control of cesium to give North America a huge leg up in the **5G** war, and beyond.

From what we already have learned from Attorney Todd Callender's report that a central aspect of the so-called Vaxxes are embedded with Cesium-137 in the nanoparticles of the spike Protein and their effectiveness is tied to the fact that Cesium-137 bonds to human tissue, and thus enabling the amplification of the **5G** signal "connectivity" with the "Internet of Things". **5G** networks will operate in a high-frequency band of the wireless spectrum, between 28 GHz and 60 GHz (the range which is associated with health problems). This range is known as the millimeter wave (mmWave) spectrum. The sub-6 GHz range that LTE calls home will also be used. **5G** is expected to add unlicensed frequencies such as the 3.5 GHz to its list of new frequencies for mobile use. This means a lot of bandwidth will be available to users. The high-frequency band clearly is lethal!

In addition to greater bandwidth, the new **5G** networks will have a dense, distributed network of base stations in the small cell infrastructure. This will allow more processing to happen on the edge, leading to lower latencies.

### **Smaller Cells for Next-Generation Networks**

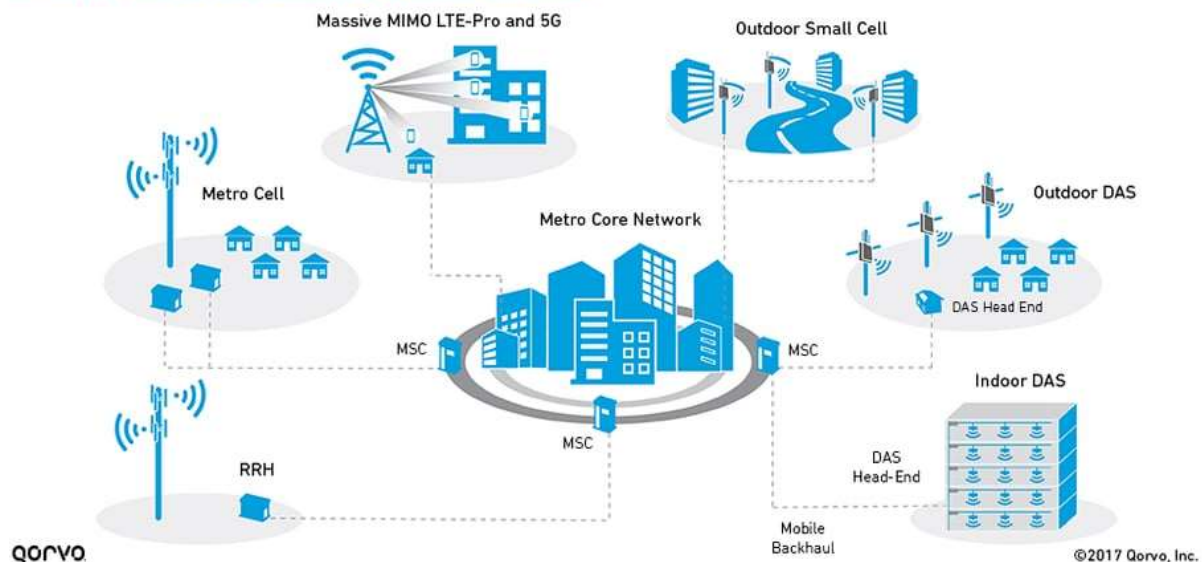
The high frequencies of **5G** networks come with a wrinkle: rather than the huge, geographically dispersed cell towers that characterize LTE networks and its predecessors, many of the **5G** networks will be composed of small cells. Consumers should expect to see **5G** antennas placed throughout their neighborhoods (for example), Qualcomm’s antenna module for their X55 **5G** modem cities, blending in with the local environment. Antennas will even have a place in homes



Small cells are key to the functionality of **5G** networks because they provide the increased data capacity that **5G** demands. They help providers reduce costs by eliminating expensive rooftop systems and installation costs. Users can expect improved performance and battery life of mobile handsets since less power is required to transmit data to something nearby.

Small cells will also be important to the workability of **5G** in the millimeter wave spectrum. At these mmWave frequencies, signals have trouble getting through walls.

#### **5G Network Cooperation**

It will be important that **5G** networks support the coexistence of multiple standards (LTE, Wi-Fi) and coordinate with various site types (macro, micro, and pico base stations). A premier challenge of **5G** network design has been to create a network architecture capable of supporting this kind of flexibility while meeting the multifaceted access demands of an Internet of Things (IoT) future.

The new **5G** networks will also need to incorporate seamless coexistence of LTE and **5G** standards. This is mostly embodied in the spectrum sharing of frequencies used by both standards. “Connectivity” and signal strength is vital in making **5G** an industry success. #### **5G Network Expectations**

Networking and hardware vendors are still trial-testing their technologies. For example, as of early 2019, Verizon is conducting friendly user tests in the U.S., while AT&T is testing its own network with mobile hotspots in 12 cities. Both were introduced in

2018. Verizon also plans to build a fiber and wireless infrastructure to efficiently deliver mobile video.

**Does the human body use cesium?**

People **use both forms of cesium for medicine**. ... Non-radioactive cesium is also used to treat depression. Healthcare providers sometimes treat cancer patients with radioactive cesium (cesium-137). In industry, radioactive cesium is also used in instruments that measure thickness, moisture, and liquid flow.

**How does cesium get into the body?**

Cesium-137 can enter the body **when it is inhaled, ingested, or absorbed through the skin**. After radioactive cesium is ingested, it is distributed fairly uniformly throughout the body's soft tissues. Slightly higher concentrations are found in muscle; slightly lower concentrations are found in bone and fat.

**How do you get rid of cesium?**

How is cesium poisoning treated? Exposure to stable cesium is not considered to be a major public health threat since it is mildly poisonous and has limited use. However, **medical providers may prescribe a compound called Prussian blue**, which can remove stable cesium from the body in waste matter.

**Which is the rarest element on the Earth?**

A team of researchers using the ISOLDE nuclear-physics facility at CERN has measured for the first time the so-called electron affinity of the chemical element **astatine**, the rarest naturally occurring element on Earth.

**What is cesium good for?**

The most common use for caesium compounds is as a **drilling fluid**. They are also used to make special optical glass as a catalyst promoter in vacuum tubes and in radiation monitoring equipment. One of its most important uses is in the 'caesium clock' (atomic clock).

**Is cesium alpha beta or gamma?**

Caesium-137 is a radioactive element with a relatively long half-life of 30.7 years. This particular isotope of caesium is both a **beta and gamma emitter**. It is the **gamma** that is of concern to **5G** cell phones.

### **What does cesium feel like?**

Cesium is a rare, silver-white, shiny metal with brilliant blue spectral lines; the element's name comes from "caesius," a Latin word meaning "sky blue." It is the **softest metal**, with a consistency of wax at room temperature.

### **How do we use cesium in everyday life?**

Cesium is **used to help drill oil and make vacuum tubes**. The most common everyday use for cesium is with the GPS on your cell phone. Cesium clocks is the more accurate term for atomic clocks, since cesium is used in these clocks.

### **What happens when you mix cesium with water?**

When caesium makes contact with water, **it reacts very rapidly, and forms a colourless solution of caesium hydroxide (CsOH) and hydrogen gas (H<sub>2</sub>)**. This reaction is so fast, that if you tried pouring water into a test tube containing caesium (don't do it), the glass container would shatter all over the place.

### **How long before Chernobyl is safe?**

The amount of radiation you're exposed to is similar to on a long haul flight. Some scientists state the estimated time that has to be passed until it will be safe to be around Chernobyl is **20,000 years** — but it's true only for the places near the radioactive remains.

### **Why is cesium-137 used?**

Cesium Sources

Cesium-137 is used **in small amounts for calibration of radiation detection equipment**, such as Geiger-Mueller counters. In larger amounts, Cs-137 is used in: Medical radiation therapy devices for treating cancer. Industrial gauges that detect the flow of liquid through pipes.

### **What is the half life of cesium-137?**

Cesium-137 is significant because of its prevalence, relatively long half life (**30 years**), and its potential effects on human health. Cesium-137 emits beta particles as it decays to the barium isotope, Ba-137m (half life = 2.6 minutes).

### **How much cesium is in the human body?**

The amount of potassium, rubidium and cesium in the total body estimated from the concentrations of these elements in the soft tissues, muscle and bone is, respectively, **136±28 grams, 0.36±0.09 grams and 1.4 × 10<sup>-3</sup> grams** (95% probable range: 0.50—4.1 × 10<sup>-3</sup>) for the standard man of 70 kg body weight.

### **How much does a gram of cesium cost?**

The United States was once 100% import reliant for its cesium needs. In 2019, one company offered 1-gram ampoules of 99.8% (metal basis) cesium for **\$63.00**, a slight increase from \$61.80 in 2018, and 99.98% (metal basis) cesium for \$81.10, a 3% increase from \$78.70 in 2018.

### **What foods have cesium in them?**

Potential for Cesium Contamination

The foods most affected by the Fukushima incident include **mushrooms, fruits, mountain vegetables, ginkgo nuts, chestnuts and seafood**, according to a study published in 2013 in the "Journal of the Food Hygienic Society of Japan." Any of these foods from Japan may contain some cesium.

### **Was Fukushima worse than Chernobyl?**

Key Facts. Both the 2011 accident at the Fukushima Daiichi nuclear energy facility in Japan and the Chernobyl accident in the former Soviet Union in 1986 required countermeasures to protect the public. This fact netted both accidents the **highest rating** on the International Nuclear and Radiological Event Scale (INES). ### **How long does it take for cesium 137 to decay?**

Caesium-137 has a half-life of **about 30.7 years**. About 94.6% decays by beta emission to a metastable nuclear isomer of barium: barium-137m ( $^{137m}\text{Ba}$ , Ba-137m). The remainder directly populates the ground state of barium-137, which is stable.

### **Is cesium used in bombs?**

The most likely radioactive element in a dirty bomb is cesium-137, according to Phil Anderson, a senior fellow at the Center for Strategic and International Studies.
