Fauci Warns There Are Five Stages in a Pandemic... and We Are Still in the First Stage

3. Control

"Control means you have it present, but it is present at a level that does not disrupt society," Fauci says.

4. Elimination

The elimination of a pandemic occurs when the virus still exists in the world but it has been eradicated from certain regions or countries. 5. Eradication

Fauci conceded Covid will never be eradicated.

In a video [shared on Facebook](#), a UK GP tells a woman that the Covid-19 vaccine program will soon be stopped altogether as new information comes out to the public regarding its safety.

The viral video was shared by Chelsea Harman, who said that she contacted 111 on Friday evening to report concerning symptoms she developed after having the jab on the same day.

Harman wrote: *“4 hours after having it I developed 3 lumps on my head, 2 pea size and 1 grape size (these are still here) I called 111 Friday evening and was told a doctor would phone, Saturday evening I received this call from the doctor.”*

The number shown in the video can be traced back to Chichester’s out of hour’s service, and Harman was able to confirm that she did indeed speak to a GP.

In the video, the GP says that young people especially should not have the vaccine and that the third booster jab is completely unnecessary.

“So you think I shouldn’t have any more vaccines then?” Harman asks.

The GP replies, stating:

“If you ask me, then this would be advice, yes. There is a lot of information coming out now which was not available earlier, and very soon all of the vaccines will be completely stopped.”

“This is information that is really...you won’t hear it on TV for a while probably, because... it’s a long story.”

Herman was then told that she shouldn’t worry about her symptoms unless they appear to get worse or if she develops new symptoms.

At the end of the video, Herman tells the doctor that her sister is booked in to get her booster vaccine the next day and asks whether she should tell her not to.

“No, please no,” the GP says, begging the woman to tell her sister not to get the third jab.

It is unlikely that this information will come out to the media any time soon. However, it will be interesting to see how this will unfold when the vaccines are stopped.

It is my opinion that UK Boris Johnson’s announcement puts Joe Biden on the hot seat and will force the hand of Biden or Arthur Roberts to reverse course on the alleged virus for which it has never been proven to exist. It was a “bioweapon” but it was not natural, novel, or a pandemic.

England Ends All COVID Passports, Mask Mandates & Work Restrictions January 19, 2022

Restrictions including COVID-19 passes, mask mandates, and work-from-home guidance will be removed in England, UK Prime Minister Boris Johnson announced on Wednesday. England ends all covid passports, mask mandates & work restrictions.

Johnson also suggested that self-isolation rules may also be thrown out at the end of March as the CCP (Chinese Communist Party) virus pandemic becomes endemic.

Effective immediately, the UK government is no longer asking people to work from home. The COVID pass mandate for nightclubs and large events won’t be renewed when it expires on Jan. 26. And from Thursday, indoor mask-wearing will no longer be compulsory anywhere in England.

The requirement for secondary school pupils to wear masks during class and in communal areas will also be removed from the Department for Education's national guidance. Roaring cheers from lawmakers could be heard in the House of Commons following Johnson's announcements on masks.

People who test positive for COVID-19 and their unvaccinated contacts are still required to self-isolate, but Johnson said he "very much expect[s] not to renew" the rule when the relevant regulations expire on March 24.

"As COVID becomes endemic, we will need to replace legal requirements with advice and guidance, urging people with the virus to be careful and considerate of others," the prime minister said.

Asked to remove testing rules for vaccinated UK-bound travelers, Johnson said the government is reviewing the testing arrangements on travel and that an announcement can be expected in the coming days.

But he refused to reconsider the vaccination mandate for frontline health care workers, insisting *"the evidence is clear that health care professionals should get vaccinated."*

Johnson told MPs that the Cabinet decided to remove its so-called "Plan B" measures on Wednesday morning as data suggest the Omicron wave has peaked nationally, and he attributed stabilizing hospital admission numbers to "the extraordinary booster campaign" and the public's compliance to the restriction measures.

The removal of the "Plan B" measures against the CCP virus came as the prime minister battles increasing pressure calling for him to resign over alleged lockdown-breaching parties in Number 10 Downing Street, the prime minister's official residence, during the pandemic.

It also came after Number 10 received a petition on Monday signed by more than 200,000 people, calling for an end to vaccine passports and similar COVID certifications.

A separate petition calling on the reversal of vaccine mandates for health care workers, which was also delivered to Number 10 on Monday, received about 160,000 signatures.

Governments in Scotland and Wales have also announced the removal of Omicron curbs, but mandatory indoor mask-wearing and COVID passes will remain in place.

The pandemic provides that entry point. The COVID passport becomes the digital ID.

The virus provides the fear needed for a global vaccination program. The mandatory vaccination program then provides the tool for registration of identity. The registered identity then becomes the gateway for a digital identification... which, as outlined, is then used to register, monitor, track and ultimately control, a global population.

However, we enter a phase of hard-line non-compliance. Meaning, if the worry of the virus itself begins to subside, if people start to realize the fear is disproportionate to the risk, if people start to reject the vaccination program because the never-ending contrived fear of variants lead to a never-ending booster shot program to continue the registration demand, then something else is needed in the equation to continue the registration drive. That something else becomes the fear of another essential element for health, "food insecurity." That appears to be the phase we are entering.

As we previously noted, the architects of the Build Back Better society (WEF) are guiding various governments on ways to create efficient registration and compliance systems, i.e., ways that permit citizens to prove their vaccinated and compliant

status. As these discussions are taking place, it is prudent to pause and think very carefully, wisely.

We all know, as we are reading this, under the guise of enhancing our safety, the U.S. Federal Government is in discussions with the medical community, multinational corporations and employers of citizens to create a more efficient process for you to register your vaccine compliance.



We know their conversation under the terminology of a COVID Passport. The current goal is to make a system for us to show and prove our authorized work status, which, as you know, is based on your obedience to a mandated vaccine.

Beta tests are being conducted in various nations, each with different perspectives and constitutional limitations, based on pesky archaic rules and laws that govern freedom.

For the western, or for lack of a better word 'democratic' outlook, Australia, New Zealand and Europe are leading the way with their technological system of vaccination check points and registered state/national vaccination status tied to your registration identification.

New York City has recently joined the vaccine checkpoint process, as their city requires the vaccine to enter all private businesses.

The Australian electronic checkpoints are essentially gateways where QR codes are being scanned from the cell phones of the compliant vaccinated citizen. Yes comrades, there's an app for that.

Currently, the vaccine status scans are registered by happy compliance workers, greeters at the entry to the business or venue. Indeed, the Walmart greeter has a new gadget to scan your phone prior to allowing you custody of a shopping cart.

In restaurants, the host or hostess has a similar compliance scanner to check you in prior to seating or a reservation confirmation.

It's simple and fun. You pull up your QR code on your cell phone (aka portable transponder and registration device), using the registration app, and your phone is scanned delivering a green check response to confirm your correct vaccination status and authorized entry.

The Australian government, at both a federal and state level, is working closely with Big Tech companies (thirsting for the national contract) to evaluate the best universal process that can be deployed nationwide.



As noted by all six Premiers in the states down under, hardware (scanners) and software (registration) systems are all being tested to find the most comprehensive/convenient portable units to settle upon. Meanwhile in the U.S., cities like Los Angeles and New York await the beta test conclusion before deploying their own version of the same process.

In Europe, they are also testing their vaccine checkpoint and registration processes known as the EU "Green Pass."

The "Green Pass" is a similar technological system that gives a vaccinated and registered citizen access to all the venues and locations previously locked down while the COVID-19 virus was being mitigated. What would have been called a "vast right-wing conspiracy theory" 24 months ago is now a COVID passport process well underway.

As with all things in our rapid technological era, you do not have to squint to see the horizon and accept that eventually this process will automate, and there will be a gadget or scanning gateway automatically granting you access without a person needing to stand there and scan each cell phone QR code individually.

The automated process just makes sense. You are well aware your cell phone already transmits an electronic beacon enabling your Uber or Lyft driver access to your location at the push of a touchscreen button, another convenient app on your phone. So, why wouldn't the gateways just accept this same recognizable transmission as registration of your vaccine compliant arrival at the coffee shop?

The automated version is far easier and way cooler than having to reach into your pocket or purse and pulling up that pesky QR code on the screen. Smiles everyone, the partnership between Big Tech and Big Government is always there to make your transit more streamline and seamless. Heck, you won't even notice the electronic receiver mounted at the entry. Give it a few weeks and you won't remember the reason you were laughing at Alex Jones any more than you remember why you are taking off your shoes at the airport.

However, as this process is created, it is worth considering that you are being quietly changed from an individual person to a product. Some are starting to worry in the [beta test](#):

[...] “you must become an object with attributes sitting in a database. Instead of roaming around anonymously making all sorts of transactions without the government's knowledge, Australians find themselves passing through ‘gates’. ...

All product-based systems have these gates to control the flow of stock and weed out errors. It is how computers see things. The more gates, the more clarity.

You are updating the government like a parcel pings Australia Post on its way to a customer. If a fault is found, automatic alerts are issued, and you are stopped from proceeding. In New South Wales, this comes in the form of a big red ‘X’ on the myGov vaccine passport app (if you managed to link your Medicare account without smashing the phone to bits).

Gate-keeping systems have been adapted from retail and transformed into human-based crowd solutions to micromanage millions of lives with the same ruthless efficiency as barcodes tracking stock. There is no nuance or humanity in this soulless digital age. Barcodes are binary. Good – bad. Citizen or dissident.

Even if you have all the required government attributes to pass through the gates – two vaccines, six boosters, and a lifelong subscription to Microsoft – something could go wrong. If your data fails the scan, you'll slip into digital purgatory and become an error message. ([read more](#))

It could be problematic if your status fails to register correctly, or if the system identifies some form of alternate lifestyle non-compliance that will block you from entry. Then again, that's what beta tests are for, working out all these techno bugs and stuff. Not to worry.... move along....



Then again... *“For those in the privileged class allowed to shop, take note of Covid signs which encourage cashless transactions under the guise of ‘health’. Messaging around cards being ‘safer’ will increase until the Treasury tries to remove cash entirely, almost certainly with public approval.”*

Wait, now we are squinting at that familiar image on the horizon because we know those who control things have been talking about a cashless society for quite a while.

We also know that data is considered a major commodity all by itself. Why do you think every system you encounter in the modern era requires your phone number even when you are not registering for anything. It, meaning you, us, are all getting linked into this modern registration system that is defining our status. We also know that system operators buy and sell our registered status amid various retail and technology systems. Yeah, that opaque shadow is getting a little clearer now.

Perhaps you attempt to purchase dog food and get denied entry into Pet Smart because you didn't renew the car registration. Or perhaps you are blocked from entry because you forgot to change the oil on the leased vehicle you drive, and Toyota has this weird agreement with some retail consortium. You head to the oil change place that conveniently pops up in the citizen compliance App –it's only two blocks away– they clear the alert after they do the oil change, and you are gateway compliant again.

Missed your booster shot? We're sorry citizen, your bank account is frozen until your compliance is restored... please proceed to the nearest vaccination office as displayed conveniently on your cell phone screen to open access to all further gates (checkpoints).... tap to continue!

It seems transparently obvious where this is heading:

Covid is a global psy-op: There is no real medical emergency

(Natural News) A leading Israeli immunologist has come forward to claim that the Wuhan coronavirus (Covid-19) is not the threat that it has been made out to be, and is nothing more than “psychological engineering” on a global scale.

Prof. Ehud Qimron, a well-respected authority, penned a letter to the Israeli Ministry of Health denouncing his country's mass vaccination scheme and chastising government officials who have already "branded" the unvaccinated "as spreaders of the disease."

Qimron currently heads Tel Aviv University's Department of Microbiology and Immunology.

"Two years later, you finally realize that a respiratory virus cannot be defeated and that any such attempt is doomed to fail," Qimron's letter reads.

"You do not admit it, because you have admitted almost no mistake in the last two years, but in retrospect it is clear that you have failed miserably in almost all of your actions, and even the media is already having a hard time covering your shame."

The most basic modicum of established science proves that trying to fight a constantly mutating virus with strain-specific injections is a fool's game, and yet few politicians and health authorities are acknowledging this fact.

Qimron is upset with many of them over this, noting in his letter that the Israeli government's jab campaign "failed" to create "herd immunity" as promised, and is only making things progressively worse.

"You refused to admit that the infection comes in waves that fade by themselves, despite years of observations and scientific knowledge," Qimron added in his letter.

"You refused to admit that recovery is more protective than a vaccine, despite previous knowledge and observations showing that non-recovered vaccinated people are more likely to be infected than recovered people."

Governments colluded with Big Pharma to push deadly covid shots

Qimron went on to blast Israeli politicians for refusing to admit that the "fully vaccinated" are also fully contagious. In most cases, they are the ones getting sick and having to go to the hospital, while the unvaccinated, assuming they do not get "shed" on by a vaccinated person, are the healthier members of society.

"Based on this, you hoped to achieve herd immunity by vaccination – and you failed in that as well," Qimron added.

The most at-risk demographics when it comes to Fauci Flu susceptibility are the elderly and people with compromised immune systems or pre-existing health conditions. And yet young people, who have almost zero risk, are being forced to take the jabs in order to participate in Israeli society.

Qimron says this has all been known since early 2020 when the pandemic was first launched, but that those in positions of power ignored it and proceeded to force the shots on everyone.

These same authorities failed to establish an adequate mechanism to identify and track adverse events from the shots, which we now know are numerous and widespread.

“Doctors avoid linking side effects to the vaccine, lest you persecute them as you did with some of their colleagues,” Qimron laments about the covid status quo.

In younger demographics especially, Fauci Flu injections cause far more harm than good, assuming any good at all actually comes from taking them. There is still no solid evidence to suggest that the shots provide any benefits whatsoever.

Meanwhile, young people everywhere are dropping dead from jab-induced heart attacks and other cardiovascular problems and hardly any authority figures anywhere are even acknowledging this.

“You have ignored many reports of changes in menstrual intensity and menstrual cycle times,” Qimron added in his letter.

“You hid data that allows for objective and proper research. Instead, you chose to publish non-objective articles together with senior Pfizer executives on the effectiveness and safety of vaccines.”

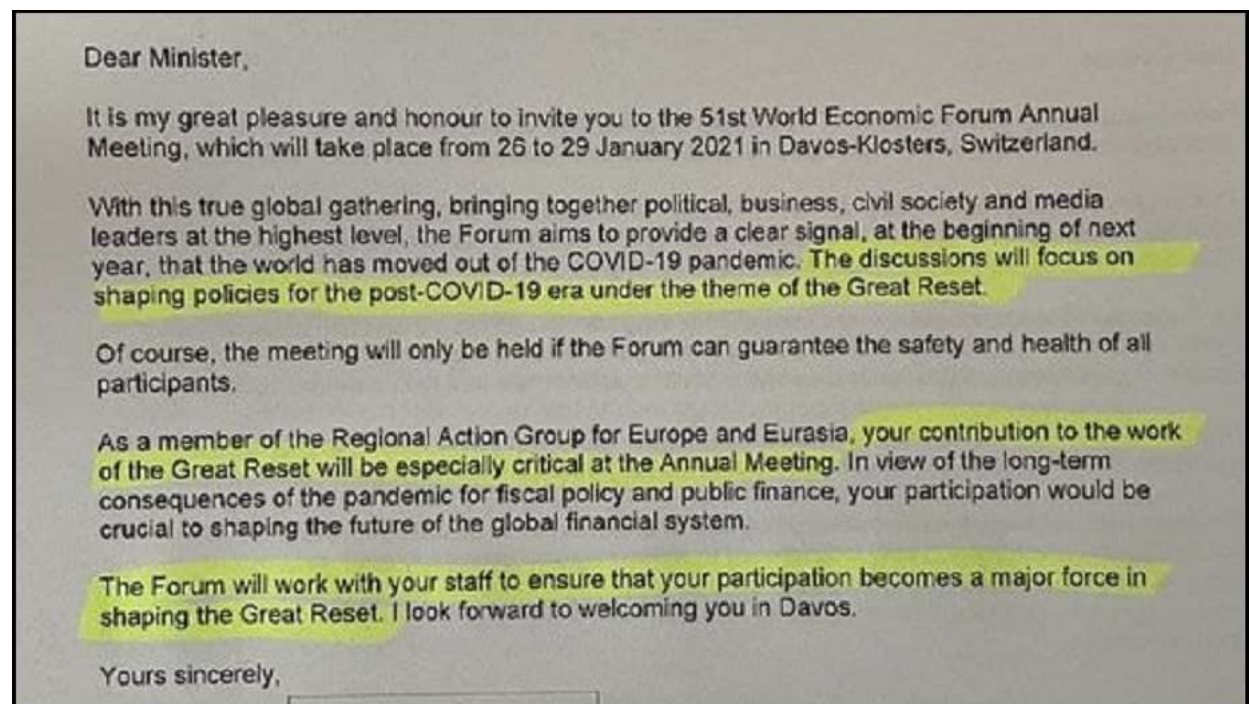
The World Economic Forum, a collection of corporations, “shaping” government “policies.”

Why does this matter? Well, fascism was traditionally defined as an authoritarian government working hand-in-glove with corporations to achieve objectives. A centralized autocratic government headed by a dictatorial leader, using severe economic and social regimentation, and forcible suppression of opposition.
