


Lucifer's Covid Psyop

2020 became the year of fear of propaganda, and 2021 will be the year of genocide! Pope Francis is a Jesuit; in his oath he swore, *"I furthermore promise and declare that I will, when opportunity presents, make and wage relentless war, secretly or openly, against all heretics, Protestants and Liberals, as I am directed to do, to extirpate and exterminate them from the face of the whole earth . . . As you will see below, the virus was a Rothschild scam. As I have said for months, this is not a vaccine, it is a "delivery" system, from Pfizer's own literature. Legally it is not a vaccine!

Protocol "10.17-20 states: "By such measure we shall obtain the power of destroying little by little, step by step, all that at the outset when we enter on our rights, we are compelled to introduce into the constitutions of States to prepare for the transition to an imperceptible abolition of every kind of constitution, and then the time is come to turn every form of government into OUR DESPOTISM."

18. "The recognition of our despot may also come before the destruction of the constitution; the moment for this recognition will come when the peoples, utterly wearied by the irregularities and incompetence—a matter which we shall arrange for—of their rulers, will clamor: *"Away with them and give us one king over all the earth who will unite us and annihilate the causes of disorders—frontiers, nationalities, religions, State debts—who will give us peace and quiet which we cannot find under our rulers and representatives."*

19. "But you yourselves perfectly well know that to produce the possibility of the expression of such wishes by all the nations it is indispensable to trouble in all countries the people's relations with their governments so as to utterly exhaust humanity with dissension, hatred, struggle, envy and even by the use of torture, by starvation, **by the inoculation of diseases**, by want, so that the "goyim" see no other issue than to take refuge in our complete sovereignty in money and in all else."

20. "But if we give the nations of the world a breathing space the moment we long for is hardly likely ever to arrive".

These are the words from the *"Protocols of the Learned Elders of Zion"* Few of you know much of anything about the "Protocols" but they are as important as the name "Rothschild" in the Zionist Chabad agenda. Andrew Carrington Hitchcock is the author of *'The Synagogue of Satan'*, now in its 3rd edition and offers what Christian ministries fail to teach on the larger agenda of the Zionist plan to rule the world. I deal with this in my series, *"The Satanic Talmud and the Synagogue of Satan"*. What follows is an overview of the "Protocols". This is directly related to what I am focusing on in this article about Lucifer's Covid Psyop. The Zionists have a total of 25 Protocols.

The author of this translation of the famous Protocols was himself a victim of the Revolution. He had lived for many years in Russia and was married to a Russian lady. Among his other activities in Russia he had been for a number of years a Russian Correspondent of the *'MORNING POST'*, a position which he occupied when the Revolution broke out, and his vivid descriptions of events in Russia will still be in the recollection of many of the readers of that Journal. Naturally he was singled out for the anger of the Soviet. On the day that Captain Cromie was murdered by Jews, Victor Marsden was arrested and thrown into the Peter-Paul Prison, expecting every day to have his name called out for execution. This, however, he escaped, and eventually he was allowed to return to England very much of a wreck in bodily health.

However, he recovered under treatment and the devoted care of his wife and friends. One of the first things he undertook, as soon as he was able, was this translation of the Protocols. Mr. Marsden was eminently well qualified for the work. His intimate acquaintance with Russia, Russian life and the Russian language on the one hand, and his mastery of a terse literary English style on the other, placed him in a position of advantage which few others could claim. The consequence is that we have in his version an eminently readable work, and though the subject-matter is somewhat

formless, Mr. Marsden's literary touch reveals the thread running through the twenty-four Protocols.

It may be said with truth that this work was carried out at the cost of Mr. Marsden's own life's blood. He told the writer of this Preface that he could not stand more than an hour at a time of his work on it in the British Museum, as the diabolical spirit of the matter which he was obliged to turn into English made him positively ill.

Mr. Marsden's connection with the '*MORNING POST*' was not severed by his return to England, and he was well enough to accept the post of special correspondent of that journal in the suite of H.R.H., the Prince of Wales [Grandfather of Prince Charles] on his Empire tour. From this he returned with the Prince, apparently in much better health, but within a few days of his landing he was taken suddenly ill, and died after a very brief illness.

Of the Protocols themselves little need be said in the way of introduction. The book in which they are embodied was published by Sergyei Nilus in Russia in 1905. A copy of this is in the British Museum bearing the date of its reception, August 10, 1906. All copies that were known to exist in Russia were destroyed in the Kerensky regime, and under his successors the possession of a copy by anyone in Soviet land was a crime sufficient to ensure the owners of being shot on sight. The fact is in itself sufficient proof of the genuineness of the Protocols. The Jewish journals, of course, say that they are a forgery, leaving it to be understood that Professor Nilus, who embodied them in a work of his own, had concocted them for his own purposes.

Mr. Henry Ford, in an interview published in the '*New York WORLD*', February 17th, 1921, put the case for Nilus tersely and convincingly thus:

"The only statement I care to make about the Protocols is that they fit in with what is going on. They are sixteen years old, and they have fitted the world situation up to this time. THEY FIT IT NOW."

Indeed they do! The word "Protocol" signifies a précis gummed on to the front of a document, a draft of a document, 'minutes of proceedings'. In this instance, "Protocol" means minutes of the proceedings of the Meetings of the Learned Elders of Zion. These Protocols give the substance of addresses delivered to the innermost circle of the Rulers of Zion. They reveal the converted plan of action of the Jewish Nation developed through the ages and edited by the Elders themselves up to date. Parts and summaries of the plan have been published from time to time during the centuries as the secrets of the Elders have leaked out. The claim of the Jews that the Protocols are forgeries is in itself an admission of their genuineness, for they NEVER ATTEMPT TO ANSWER THE FACTS corresponding to the THREATS which the Protocols contain, and, indeed, the correspondence between prophecy and fulfillment is too glaring to be set aside or obscured. This the Jews well know and therefore evade.

The presumption is strong that the Protocols were issued, or re-issued, at the First Zionist Congress held at Basle in 1897 under the presidency of the Father of Modern Zionism, the late Theodore Herzl. It is strange that Christian evangelicals praise this man for his vision of a land for the Jews. All I heard for years was praise for Theodore Herzl by the likes of virtually every Christian ministry beginning with Pastor John Hagee during the 1990's. They were signing their own death warrants to the Zionist movement, which was headed by the likes of Jacob and Evelyn de Rothschild, and now the real Zionist movement is coming to vaccinate the world with their own genocidal psyop. Those who would deny this know little of the Zionist Rothschild's.

• Herzl is subsequently elected President of the Zionist Organisation which adopts the, "Rothschild Red Hexagram or Sign," as the Zionist flag which 51 years later will end up as the flag of Israel.



There has been recently published a volume of Herzl's "Diaries," a translation of some passages which appeared in the '*JEWISH CHRONICLE*' of July 14, 1922. Herzl gives an account of his first visit to England in 1895, and his conversation with Colonel Goldsmid, a Jew brought up as a Christian, an officer in the English Army, and at heart a Jew Nationalist all the time. Goldsmid suggested to Herzl that the best way of expropriating the English aristocracy, and so destroying their power to protect the people of England against Jew domination, was to put excessive taxes on the land. Herzl thought this an excellent idea, and it is now to be found definitely embodied in Protocol VI!

The above extract from Herzl's diary is an extremely significant bit of evidence bearing on the existence of the Jewish World Plot and authenticity of the Protocols, but any reader of intelligence will be able, from his own knowledge of recent history and from his own experience, to confirm the genuineness of every line of them, and it is in the light of this living comment that all readers are invited to study Mr. Marsden's translation of this terribly inhuman document.

And here is another very significant circumstance. The present successor of Herzl, as leader of the Zionist movement, Dr. Weizmann, quoted one of these sayings at the send-off banquet given to Chief Rabbi Hertz on October 6, 1920. The Chief Rabbi was on the point of leaving for HIS Empire tour with H.R.H., the Prince of Wales [Grandfather of Prince Charles of Wales]. And this is the "saying" of the Sages which Dr. Weizmann quoted:

"A beneficent protection which God has instituted in the life of the Jew is that He has dispersed him all over the world." ('JEWISH GUARDIAN', Oct. 8, 1920.)

Now compare this with the last clause of but one of Protocol XI.

"God has granted to us, His Chosen People, the gift of dispersion, and from this, which appears to all eyes to be our weakness, has come forth all our strength, which has now brought us to the threshold of sovereignty over all the world."

The remarkable correspondence between these passages proves several things. It proves that the Learned Elders do exist. It proves that Dr. Weizmann knew all about them. It proves that the desire for a "National Home" in Palestine is only camouflage and an infinitesimal part of the Jew's real object. It proves that the Jews of the world have no intention of settling in Palestine or any separate country, and that their annual prayer that they may all meet "Next Year in Jerusalem" is merely a piece of their characteristic make-believe. It also demonstrates that the Jews are now a world menace, and that the Aryan races will have to domicile them permanently out of Europe.

We have been lied to - the Covid-19 vaccine is *not* a vaccine at all—it is a cellular GENETIC MODIFICATION technology, admittedly designed to give those that are ignorant enough to take it, a self-creating **AUTO-IMMUNE DISEASE similar to what used to be called AIDS. In fact, 18 fragments of the AIDS genome and 4 fragments of SARS-2 were “inserted” into the Coronavirus as a “gain-of-function” move to make it more viral and lethal. Four countries have verified this claim to be true. Nobody is discussing this as being a “Bioweapon”!!!!!!**

Even the test swab is a nano-bioweapon. The "*Fourth Industrial Revolution*" is of a scale, speed and complexity that is unprecedented. It is characterized by a fusion of technologies - such as artificial intelligence, gene editing and advanced robotics - that is blurring the lines between the physical, digital and biological worlds. You are now in the era of nano dots - nano particles about .15 x.15 mm that have GPS properties -

sometimes called smart-dust as they can be sprayed on us or absorbed or taken in foods, drinks and even injected. They have a 2-axis magnetic sensor of direction and a 2-axis accelerometer to track speed; a light intensity sensor, humidity, pressure and temperature sensors, and can transmit wireless to the smart grid *internet of things* in the cloud. They can also be inserted through the nasal passage with a 'cotton' technetium swab. Technetium, Tc 43, is a radioactive transition metal with bio-infiltrator properties including mind control and DNA direct manipulation. A pyrophosphate ion with Tc-99m adheres to calcium deposits. Calcium is known to be liquefied by 5G frequencies. Isotope technetium is technetium-99m: it binds chemically with biologically active molecules; these properties make it suitable for many medical radioactive isotope reactions. When Tc-99m is combined with a tin compound it binds to red blood cells and can therefore be used to map circulatory system disorders . . . This can make you patentable, like something synthetic manufactured and property of the patent holder.

By means of such biological warfare the World Bank killed seventy-five million and took over twenty-seven debt-stricken African countries. The Chinese Biological Laboratory in Wuhan is owned by GlaxoSmithKline. Glaxo, coincidentally also merged with and owns controlling stakes (68%) in the company Pfizer which manufactures a Covid-19 'vaccine'. Coincidentally the hedge fund Blackrock also owns stakes in both Pfizer (8%) and AstroZeneca (6.8%) which also manufactures a Covid-19 'vaccine'.

This warning is not against Covid-19 but against the 'vaccines'. Stupidity is a choice. By taking the 'vaccine' you are becoming a genetically modified human being. One should watch "[Attention PCR Testing](#)," a video from Dr. Rashid Buttar which reinforces the essence of this article (above). He shows doctors explaining how the test, with the long swab to the back of your nasal cavity, which, when twisted deposits nano-particles near the very porous bone layer that separates blood-brain barrier found in the cavity from beneath the brain. These nano-particles become beacon locators of your location.

In a new research article published in '*Microbiology & Infectious Diseases*', veteran immunologist Dr. J. Bart Classen expresses similar concerns and writes that "RNA-based COVID vaccines have the potential to cause more disease than the epidemic of COVID-19." For decades, Classen has published papers exploring how vaccination can give rise to chronic conditions such as Type 1 and Type 2 diabetes — not right away, but three or four years down the road.

In this latest paper, Classen warns that the RNA-based vaccine technology could create "new potential mechanisms" of vaccine adverse events that may take years to come to light.

Classen's study establishes the potential for the messenger RNA (mRNA) vaccines developed by Pfizer and Moderna to activate human proteins to take on "pathologic configurations" — configurations associated with chronic degenerative neurological diseases. Although his specific interest is in prion diseases (conditions associated with misfolded versions of normal proteins), Classen also outlines a handful of other

mechanisms whereby RNA-based vaccines could give rise to “multiple other potential fatal adverse events.”

Ensuring that patients clearly understand risks — including known risks as well as potential unknown risks — is an important component of the informed consent process. This is all the more true when the intervention is experimental and lacks long-term safety data, as is the case with the Pfizer and Moderna vaccines against COVID-19. The FDA authorized the two vaccines for widespread emergency use based on just two months of clinical trial data.


Unfortunately, it is not unusual for researchers’ communication of risks to be perfunctory. In October, researchers at New York University and Tulane reported that the information communicated to participants in the coronavirus clinical trials about a worrisome problem known as pathogenic priming was “sufficiently obscured” as to make “adequate patient comprehension” of risks “unlikely.”

In my “Blessed Hope” series #51, I included a letter from Jacob Rothschild to Henry Makow, a Canadian web site. As for stuffing our pockets, the families which make up our network of central banks throughout the world are in fact the main power brokers in the world. That is our right. Furthermore, we are able to charge interest on what we lend, which usually sustains the value of our own holdings in compensation for the masses getting all of their free stuff, for so many generations and not paying us back for the exercise of our god-like powers in being able to create something out of nothing.

PHASING OUT THE USD

You have to realize that with the development of our central banking systems all over the world, and particularly through global development lending and our investments in places like China, the economy of the world has grown exponentially over the last 100 years. Presently, the US dollar cannot serve the global needs and is being phased out not with a whimper but with the bang of a mushroom cloud in the creation of unlimited trillions.

For decades we tried to hide what is now called "the shadow economy" where we worked with the US Fed to create vast amounts of cash out of nothing, to facilitate both business and political interests particularly in developing and other irascible nations around the world. It made little difference to inflation, as the money seldom made it back to the US or to Europe and it usually came back to our banks anyway.

They complain mainly against the US and for the most part just about every other nation in the world has agreed to take that power from the US, and allow our central banks to create a new world currency, and to be their banker.

It will require, however, a central government to allocate the expenditures when the borrowing from us will be necessary, and of course to enforce trade with this currency on a global scale that central government will need independent military backing.

For a good number of decades now the governments of over 190 nations have agreed with this direction and the necessity of there being a one-world government to ensure the necessary financial stability. They are all nations that are part of our web which either have a firmly established central bank in our control or are completely indebted to us for all of our loans from institutions such as the IMF and the World Bank.

The engineering of these new arrangements, which some refer to as the New World Order, however, could not be accomplished by fiat, like we create money. Various nations competing with one another for resources or territories, will not agree just to a global currency, or a global banking system akin to the US Fed, without a central global government for financial enforcement of trade and regulation, and even if they do not agree to a world government, quite frankly places like China and Russia will only continue to feel the abuse of our powers being exercised by favored nations like the US, the UK, and Israel.


PLANDEMIC



But a series of equal and opposite reactions are occurring as nations move to remove the role of the U.S. dollar at the center of global trade and finance.

This will have a long-lasting structural impact in ending the dominance of the dollar as the world's reserve currency.

Over the past years, the U.S. set out to address inequities in the global trade environment by imposing tariffs and sanctions on various countries from China to Mexico and Canada with the rewriting of the North American Free Trade Agreement into the United States-Mexico-Canada Agreement. Even the countries in the European Union were affected. In addition, Washington implemented sanctions against Russia in 2014 in response to Moscow's annexation of Crimea, and more recently against Iran and Venezuela, effectively using the dollar's role at the center of global trade and finance to force compliance of other nations. These actions impacted nations beyond those directly targeted by the U.S. action, and today many governments around the world are taking countervailing steps to remove their reliance on the dollar-based global trade and finance system that has reigned since 1944.

In November, 15 Asian countries, comprising 30% of global GDP, signed the Regional Comprehensive Economic Partnership (RCEP), creating a free-trade zone among the signatories. This agreement attempts to provide gains to trading within the regional partnership through reduction of trade and investment barriers, and increased incentives for economic integration. It is noteworthy that RCEP came about without participation of either the U.S. or Europe, and has effectively created the world's largest trading bloc, according to the Rand Corp. Beyond the obvious benefits for economic growth in the region, a more-subtle byproduct of this agreement is to focus on bilateral settlement of trade, effectively removing the dollar as the standard unit of transaction for regional trade, according to economist and geopolitical analyst Peter Koenig, a veteran of more than 30 years with the World Bank. Liu Xiaochun, deputy dean of the Shanghai New Finance Research Institute, recently furthered this idea, stating, "Under RCEP,

currency choices for regional settlement in trade, investment and financing will increase significantly for the yuan, yen, Singapore dollar and Hong Kong dollar.” Liu’s comments were posted to the China Finance 40 Forum, a think tank comprising senior Chinese regulatory officials and financial experts.


Asia is not the only region taking steps to disentangle itself from the U.S. dollar standard in global trade and payments. The European Commission, the executive branch of the 27-country European Union (EU), released a communication explicitly stating the goal to strengthen the “international role of the euro.” This goal would “help achieve globally shared goals such as the resilience of the international monetary system, a more stable and diversified global currency system, and a broader choice for market operators.”⁵ The communication also highlights the use of sanctions by other countries, which hurt domestic EU interests, as an additional reason for taking action to make the EU more autonomous in the global trade-and-payments infrastructure. This document outlines specific action items to help move the EU in this direction of more autonomy from the current dollar-centric system. The implementation of a digital finance strategy will be a key component of this new EU strategy, including work on a retail central bank digital currency available to the general public.

The Society for Worldwide Interbank Financial Telecommunication (SWIFT), the largest global payment settlement network, has already experienced drop-off in dollar transactions in its most-recent readings. It is interesting that this occurred after the implementation of RCEP, although the timing also comes in the wake of the COVID-19 pandemic and resulting economic disruptions.

An additional element to watch will be the allocation of global central banks’ foreign currency reserves to the dollar. Non-dollar currencies recently have strengthened as the dollar has sold off. This has given many nations the opportunity to start to intervene to help stop the appreciation of their currencies and to rebuild their reserves buffers. Historically, the bulk of international reserves have been in the dollar. Today, a close eye should be kept on these allocations. If holdings in the U.S. currency decrease as a percentage of the total currency reserves while non-U.S. countries are building those reserves that could mark a significant change in their behavior. In fact, perhaps such a deliberate policy change might have already begun. Data published by the European Central Bank (ECB) and the International Monetary Fund (IMF) show a decline in the dollar as a percentage of total currency reserves since about 2016.

The dollar was already contending with structural headwinds. One is the large stock of international savings on deposit and invested in the U.S. A decline in the value of the dollar risks creating a negative feedback loop, where hedging and capital outflows can exacerbate the dollar’s decline. Another is the weakening fundamental picture for the dollar due to America’s widening of the current account deficit and a growing budget deficit. These headwinds are likely to persist for the foreseeable future – not to mention being exacerbated by the aforementioned regional trade agreements and international policy actions.

For the postwar period, the United States wielded the dollar's central role in global trade and finance to its advantage, trying to even the playing field for trading relationships and as a sanctioning facility. The end of this powerful, unipolar advantage might be at hand. The pendulum is swinging in the direction of a new, multipolar world. Countries are reclaiming autonomy in global trade, payments and finance. With the implementation of more regional trade agreements with local currency settlements, the dollar's once-dominant role in global finance likely will continue to erode.



In studying the Biderman report a rather alarming picture emerges. But consider with me the idea that Lucifer and his servants use methods to deceive us. This is extremely important at this time since, the Lord Jesus Christ repeatedly in the close of the gospels warns us about deception, and I submit to you that this is a prime example of how we are being exploited through massive deception that will claim as many as 2-billion people! -(Revelation 9:15).

What are the methods and techniques that the enemy deceives us? Well, for one, let's take a look at Patrick Hamilton's 1938 play, *'Gaslight'*, made into a movie in the early 1940s. In the movie a manipulative husband persuades his wife, against her will and better judgment as well as her common sense, to deny her genuine perceptions and believe a lie that the gas lights in their home remained at a constant, unaltered brightness. In reality, the husband had turned it down progressively over a period of time. Each time the wife noticed a dimmer brightness she would ask her husband if he had changed it. He flatly denied it and then blamed her flawed perception instead. The woman eventually broke down and resigned to believing everything her husband told her was the truth. Why is this example relevant to our discussion of false signs and wonders ushering in the age of the Antichrist? Because this is precisely the same process by which the present 'reality', that is, a wholly manipulated perception of a



purportedly dangerous coronavirus pandemic, race riots, etc., primarily via mainstream media sources is being used to cause the entire world to believe contrary to actual reality. If the powers-that-be can use it in such simple things as a fake pandemic, how

much more could this technique be applied to a fake appearing of Jesus Christ in glory or power?

A second aspect to this process of deception and manipulation is far more sinister and disturbing. In 1975, Amnesty International held a conference for the abolition of torture worldwide. In their document they identified four critical elements of torture..

1. Minimum of two persons involved, the perpetrator and the victim;
2. The torture inflicts acute pain and suffering, physical or psychological or both;
3. The intention of the perpetrator is to break the will and dehumanize the victim;
4. The affliction is deliberate, systemic, and has specific outcomes.

Together, we begin to see an alarming picture emerging. Of the four elements of torture in the Amnesty International report and the eight methods of coercion identified by Biderman, one will immediately recognize a connection with worldwide, government enforced coronavirus pandemic responses. Entire countries are now being subjected to a worldwide program of mass psychological torture and coercion. But how is this possible? How can governments, medical institutions, and media all collaborate together in a program of mass psychological trauma of this magnitude? Shouldn't someone somewhere be aware of this awful conspiracy and blow the whistle? Shouldn't someone know that it's a fraud and complain?

This leads us to a disturbing question as to how the Son of Perdition will arrive in this world with a flashy display of false signs and wonders. He has a supporting cast of completely mind-controlled slaves. This claim will be astounding to some, less so to others who have been researching it for some time Project Bluebird, Project MKUltra and Project Monarch. These mind-control methods are specific to one specific to one particular paradigm of trauma-based mind-control: Satanic Ritual Abuse (SRA). SRA has become widely acknowledge in the field of psychology and psychotherapy as one of the world's most prevalent forms of physical and psychological trauma. The extent of the cognitive dissociation varies from individual to individual subjected to this program; the most dissociative individuals successfully fragment their personalities into multiple, individually programmed entities. This condition is commonly called Dissociative Identity Disorder (DID) or the older literature, Multiple Personality Disorder (MPD). While more general traumas, such as post-traumatic stress (PTSD) or traumatic childhood incidents (e.g. accidents or abuse) may induce such states in individuals, SRA represents a coordinated deliberate, teleological process of creating DID/MPD in its victims, and then rebuilding victim's mental state from the ground up.

The ideal result in the victim is a 100% compliant, obedient mind-controlled slave with specific programmed personalities to perform specified tasks. This is how governments, institutions and media companies are working together in unobstructed collusion in this satanic agenda of false signs and wonders. Some of the programmed

personalities may be perfectly benign – they are often regarded as the ‘front alters’ or ‘Alphas’, that is, public-friendly personalities that usually control the slave in day-to-day tasks, such as being a caring parent, diligent employee (e.g. journalist, doctor, politician) or, more commonly these days, a seemingly faithful adherent of some religious practice like a pastor, evangelist or theologian.

Behind the front Alpha alters, however, is a complex and sophisticated system of mental programming which may be activated with special verbal or non-verbal codes. Systems build behind the scenes include:

Beta programming: these personalities have been trained in every known art of sexual gratification and perversion. Many individuals in the pornography industry are Beta-programmed mind-control slaves.

Gamma programming: these personalities are designed to mislead and deceive, usually as a preventative method to cover the identities of the programmers/handlers and inhibit questioning in the case the slave has been captured after committing some crime or atrocity.

Delta programming: these personalities have been trained in martial arts and assassinations and can have photographic memories for relaying secret messages or operating as stealth informants. Many work in military or government departments. Some Delta personalities are programmed to be aware of the thought processes of the other alters, even if the Delta does not have active control of the slave’s body at the time.

Omega programming: these personalities are designed to prevent psychological treatment or freedom of the slave, and can include violent suicide command by acts of self-harm or of public violence (e.g. school shootings/suicide bombings).

The above systems are very well established in the psychology literature. Anyone trained in psychology or social psychology is usually able to spot such manifestations. This is where this important to understand the present world situation. It is abundantly clear for those who have studied the matter that what is underway in the world right now is a carefully planned and expertly executed program of torture and trauma, utilizing the very methods identified and prohibited by the 1975 Amnesty International Declaration on Torture and Biderman’s Chart of Coercion. These specific methods are hallmarks of SRA for the purpose of creating DID/MPD in the victims and then reprogramming them from the ground up. That this is now occurring on a world-wide scale is unprecedented; usually SRA focuses on single individuals over many years.

Interim Operational Considerations for Implementing the Shielding Approach to Prevent COVID-19 Infections in Humanitarian Settings

The CDC has issued a document which presents considerations from the perspective of the U.S. Centers for Disease Control & Prevention (CDC) for implementing the shielding approach in humanitarian settings as outlined in guidance documents focused on camps, displaced populations and low-resource settings. This approach has never been documented and has raised questions and concerns among humanitarian partners who support response activities in these settings. The purpose of this document is to highlight potential implementation challenges of the shielding approach from CDC's perspective and guide thinking around implementation in the absence of empirical data. Considerations are based on current evidence known about the transmission and severity of coronavirus disease 2019 (COVID-19) and may need to be

revised as more information becomes available. Please check the CDC website periodically for updates.

What is the Shielding Approach?

The shielding approach aims to reduce the number of severe COVID-19 cases by limiting contact between individuals at higher risk of developing severe disease (“high-risk”) and the general population (“low-risk”). High-risk individuals would be temporarily relocated to safe or “green zones” established at the household, neighborhood, camp/sector or community level depending on the context and setting. They would have minimal contact with family members and other low-risk residents.

Current evidence indicates that older adults and people of any age who have serious underlying medical conditions are at higher risk for severe illness from COVID-19.³In most humanitarian settings, older population groups make up a small percentage of the total population. For this reason, the shielding approach suggests physically separating high-risk individuals from the general population to prioritize the use of the limited available resources and avoid implementing long-term containment measures among the general population.

In theory, shielding may serve its objective to protect high-risk populations from disease and death. However, implementation of the approach necessitates strict adherence, to protocol. Inadvertent introduction of the virus into a green zone may result in rapid transmission among the most vulnerable populations the approach is trying to protect.

A summary of the shielding approach described by Favas is shown in Table 1. See Guidance for the prevention of COVID-19 infections among high-risk individuals in low-resource, displaced and camp and camp-like settings for full details.

Table 1: Summary of the Shielding Approach

Level

Movement/ Interactions

Household (HH) Level:

A specific room/area designated for high-risk individuals who are physically isolated from other HH members.

Low-risk HH members should not enter the green zone. If entry is necessary, it should be done only by healthy individuals after washing hands and using face coverings. Interactions should be at a safe distance (approx. 2 meters). Minimum movement of high-risk individuals outside the green zone. Low-risk HH members continue to follow social distancing and hygiene practices outside the house.

Neighborhood Level:

A designated shelter/group of shelters (max 5-10 households), within a small camp or area where high-risk members are grouped together. Neighbors “swap” households to accommodate high-risk individuals.

Same as above

Camp/Sector Level:

A group of shelters such as schools, community buildings within a camp/sector (max 50 high-risk individuals per single green zone) where high-risk individuals are physically isolated together.

One entry point is used for exchange of food, supplies, etc. A meeting area is used for residents and visitors to interact while practicing physical distancing (2 meters). No movement into or outside the green zone.

Operational Considerations

The shielding approach requires several prerequisites for effective implementation. Several are addressed, including access to healthcare and provision of food. However, there are several prerequisites which require additional considerations. Table 2 presents the prerequisites or suggestions as stated in the shielding guidance document (column 1) and CDC presents additional questions and considerations alongside these prerequisites (column 2).


- Each green zone has a dedicated latrine/bathing facility for high-risk individuals
- The shielding approach advises against any new facility construction to establish green zones; however, few settings will have existing shelters or communal facilities with designated latrines/bathing facilities to accommodate high-risk individuals. In these settings, most latrines used by HHs are located outside the home and often shared by multiple HHs.
- If dedicated facilities are available, ensure safety measures such as proper lighting, handwashing/hygiene infrastructure, maintenance and disinfection of latrines.
- Ensure facilities can accommodate high-risk individuals with disabilities, children and separate genders at the neighborhood/camp-level.

- To minimize external contact, each green zone should include able-bodied high-risk individuals capable of caring for residents who have disabilities or are less mobile. Otherwise, designate low-risk individuals for these tasks, preferably who have recovered from confirmed COVID-19 and are assumed to be immune.
- This may be difficult to sustain, especially if the caregivers are also high risk. As caregivers may often will be family members, ensure that this strategy is socially or culturally acceptable.
- Currently, we do not know if prior infection confers immunity.
- The green zone and living areas for high-risk residents should be aligned with minimum humanitarian (SPHERE) standards.
- The shielding approach requires strict adherence to infection, prevention and control (IPC) measures. They require, uninterrupted availability of soap, water, hygiene/cleaning supplies, masks or cloth face coverings, etc. for all individuals in green zones. Thus, it is necessary to ensure minimum public health standards⁶ are maintained and possibly supplemented to decrease the risk of other outbreaks outside of COVID-19. Attaining and maintaining minimum SPHERE standards is difficult in these settings for the general population. Users should consider that provision of services and supplies to high risk individuals could be at the expense of low-risk residents, putting them at increased risk for other outbreaks.
- Monitor and evaluate the implementation of the shielding approach.
- Monitoring protocols will need to be developed for each type of green zone.
- Dedicated staff need to be identified to monitor each green zone. Monitoring includes both adherence to protocols and potential adverse effects or outcomes due to isolation and stigma. It may be necessary to assign someone within the green zone, if feasible, to minimize movement in/out of green zones.
- Men and women, and individuals with tuberculosis (TB), severe immunodeficiencies, or dementia should be isolated separately
- Multiple green zones would be needed to achieve this level of separation, each requiring additional inputs/resources. Further considerations include challenges of accommodating different ethnicities, socio-cultural groups, or religions within one setting.
- Community acceptance and involvement in the design and implementation
- Even with community involvement, there may be a risk of stigmatization.^{11,12} Isolation/separation from family members, loss of freedom and personal interactions may require additional psychosocial support structures/systems. See section on additional considerations below.
- High-risk minors should be accompanied into isolation by a single caregiver who will also be considered a green zone resident in terms of movements and contacts with those outside the green zone.
- Protection measures are critical to implementation. Ensure there is appropriate, adequate, and acceptable care of other minors or individuals with disabilities or mental health conditions who remain in the HH if separated from their primary caregiver.
- Green zone shelters should always be kept clean. Residents should be provided with the necessary cleaning products and materials to clean their living spaces.
- High-risk individuals will be responsible for cleaning and maintaining their own living space and facilities. This may not be feasible for persons with disabilities or decreased

mobility. Maintaining hygiene conditions in communal facilities is difficult during non-outbreak settings. consequently it may be necessary to provide additional human resource support.

- Green zones should be more spacious in terms of shelter area per capita than the surrounding camp/sector, even at the cost of greater crowding of low-risk people.
- Ensure that targeting high-risk individuals does not negate mitigation measures among low-risk individuals (physical distancing in markets or water points, where feasible, etc.). Differences in space based on risk status may increase the potential risk of exposure among the rest of the low-risk residents and may be unacceptable or impracticable, considering space limitations and overcrowding in many settings.

The study, “COVID-19 Data Collection, Comorbidity & Federal Law: A Historical Retrospective,” was authored by Henry Ealy, Michael McEvoy, Daniel Chong, John Nowicki , Monica Sava, Sandeep Gupta, David White, James Jordan , Daniel Simon, and Paul Anderson.”

The study is 25 pages long with over 100 citations. However, the main points can be summarized.

A major point is that testing inaccuracies and unreliability combined with unscientific procedures and methods resulted in demonstrably massive false-positive spikes:

“The CDC is now legally requiring red-blooded Americans to wear face masks on all public transportation as globalists try to push the concept of “double-masking” on the populace. Since the election, the World Health Organization admits that PCR tests are not totally reliable on the first try and a second test might be needed. This corresponds with CDC’s quiet admission that it blended viral and antibody test results for its case numbers and that people can test positive on an antibody test if they have antibodies from a family of viruses that cause the common cold. Hospitals in Florida had so many accuracy complications that Orlando Health had to admit that its 9.4 percent positivity rate got recorded at 98 percent. (READ: The TRUTH About Fauci and Gates And NIH Owning A Stake in the Vaccine).”

“The groundbreaking peer-reviewed research...asserts that the CDC willfully violated multiple federal laws including the Information Quality Act, Paperwork Reduction Act, and Administrative Procedures Act at minimum. (Publishing Journal – Institute for Pure and Applied Knowledge / Public Health Policy Initiative) Most notably, the CDC illegally enacted new rules for data collection and reporting exclusively for COVID-19 that resulted in a 1,600% inflation of current COVID-19 fatality totals,” the watchdog group All Concerned Citizens declared in a statement provided to NATIONAL FILE, referring to the Institute for Pure and Applied Knowledge study.

“The research demonstrates that the CDC failed to apply for mandatory federal oversight and failed to open a mandatory period for public scientific comment in both

instances as is required by federal law before enacting new rules for data collection and reporting. The CDC is required to be in full compliance with all federal laws even during emergency situations. The research asserts that CDC willfully compromised the accuracy and integrity of all COVID-19 case and fatality data from the onset of this crisis in order to fraudulently inflate case and fatality data,” stated All Concerned Citizens.”

But that is not all. Other major Covid collection and reporting standards created on March 24th of 2020 that inexplicably and intentionally changed decade old practices in order to hide comorbidities and preexisting health conditions on death reports. These underlying health conditions may likely have been the actual or most important cause of death:

“On March 24th the CDC published the NVSS COVID-19 Alert No. 2 document instructing medical examiners, coroners, and physicians to deemphasize underlying causes of death, also referred to as pre-existing conditions or comorbidities, by recording them in Part II rather than Part I of death certificates as “...the underlying cause of death are expected to result in COVID-19 being the underlying cause of death more often than not.” This was a major rule change for death certificate reporting from the CDC’s 2003 Coroners’ Handbook on Death Registration and Fetal Death Reporting and Physicians’ Handbook on Medical Certification of Death, which have instructed death reporting professionals nationwide to report underlying conditions in Part I for the previous 17 years. This single change resulted in a significant inflation of COVID-19 fatalities by instructing that COVID-19 be listed in Part I of death certificates as a definitive cause of death regardless of confirmatory evidence, rather than listed in Part II as a contributor to death in the presence of pre-existing conditions, as would have been done using the 2003 guidelines. The research draws attention to this key distinction as it has led to a significant inflation in COVID fatality totals. By the researcher’s estimates, COVID-19 recorded fatalities are inflated nationwide by as much as 1600% above what they would be had the CDC used the 2003 handbooks,” stated All Concerned Citizens.

And, still, there is MORE! Last spring the CDC created covid-19-exclusive rules that violated federal law by outsourcing data collection rule development and wrote new rules to count probable cases without any definitive proof of infection. The new rules also allowed tracers to practice medicine without a license while disallowing any measures to be put in place to prevent a patient from being counted multiple times:

“Then on April 14th, the CDC adopted additional rules exclusive for COVID-19 in violation of federal law by outsourcing data collection rule development to the Council of State and Territorial Epidemiologists (CSTE), a non-profit entity, again without applying for oversight and opening opportunity for public scientific review. On April 5th the CSTE published a position paper Standardized surveillance case definition and national notification for 2019 novel coronavirus disease (COVID-19) listing 5 CDC employees as subject matter experts. This key document created new rules for counting probable cases as actual cases without definitive proof of infection (section VII.A1 – pages 4 & 5), new rules for contact tracing allowing contact tracers to practice medicine without a license (section VII.A3 – page 5), and yet refused to define new rules for ensuring that

the same person could not be counted multiple times as a new case (section VII.B – page 7),” stated All Concerned Citizens.

Why would those in power wish to do such inhumane things to the entire population of America?

The National File concludes:

“By enacting these new rules exclusively for COVID-19 in violation of federal law, the research alleges that the CDC significantly inflated data that has been used by elected officials and public health officials, in conjunction with unproven projection models from the Institute for Health Metrics and Evaluation (IHME), to justify extended closures for schools, places of worship, entertainment, and small businesses leading to unprecedented emotional and economic hardships nationwide. A formal petition has been sent to the Department of Justice as well as all US Attorneys seeking an immediate grand jury investigation into these allegations,” All Concerned Citizens stated.”

Controversial Human Tracking


Researchers say the vaccine zealot has become *"the subject of a diverse and rapidly expanding universe of conspiracy theories,"* including 44% of Republicans and 19% of Democrats in the United States who believe Gates *"is linked to a plot to use vaccinations as a pretext to implant microchips into people."*

"Until vaccines reach everyone, new clusters of disease will keep popping up," Gates asserts. *"Those clusters will grow and spread. Schools and offices will shut down again. The cycle of inequality will continue."*

Gates did not confirm if a blanket bombing of the globe with vaccines would include encoding of medical information in a patient's skin using near-infrared quantum dots (NIR QDs) — invisible to the naked eye but detectable when exposed to near-infrared light.

Human experiments are underway with gene-based vaccines whose ominous dangers have never been revealed to the thousands of unknowing volunteers.

A Massachusetts Institute of Technology (MIT) project funded by the Bill and Melinda Gates Foundation developed the technique — popularly misunderstood as "a cover for implanting some form of microchip, radio frequency identification (RFID) chip or other digital tracking device" — interpreted by some as the satanic "Mark of the Beast," the Australian Strategic Policy Institute.

The MIT report, published in December 2019 in *Science Translational Medicine*, confirmed that *"intra-dermal QDs can be used to reliably encode information and can be delivered with a vaccine, which may be particularly valuable in the developing world and open up new avenues for decentralized data storage and biosensing."*

"Paper vaccination cards or certificates are the most widely used records in the developing world but are subject to error and possessed by only 60% of all households in low-and middle-income countries," MIT researchers argued as a rationale for implanting information under the skin — *"a platform that is robust, inexpensive and easy to use."*

Microsoft donated \$1 million to the [ID2020 Alliance](#) in September 2019 seeking to "leverage immunization as an opportunity to establish digital identity" and to use biometrics to improve vaccine coverage in developing nations.

In his letter, Gates advocates the widespread use of the controversial mRNA vaccine technology, describing it *"in large part"* a *"success" against COVID-19 and explains that "mRNA vaccines are a new type of vaccine that delivers instructions to teach your body to fight off a pathogen."*

"Although our foundation has been funding research into this new platform since 2014, no mRNA vaccine had been approved for use before last month. This pandemic has massively sped up the platform's development process," he writes. Gates insists this is a pandemic with no evidence that this is the case. He hides behind the fact that the CDC and WHO chose this year of all years to not track statistics on the yearly flu

Gates predicts that *"mRNA vaccines will become faster to develop, easier to scale and more stable to store over the next five to 10 years"* and would be a "huge breakthrough, both for future pandemics and for other global health challenges" like HIV, tuberculosis and malaria.

Researchers' Warnings

Top medical researchers, however, have warned against the use of experimental gene-based vaccines.

"Human experiments are underway with gene-based vaccines whose ominous dangers have never been revealed to the thousands of unknowing volunteers," warn award-winning Thai-German medical doctor, microbiologist, virologist and immunologist Sucharit Bhakdi and biochemist Karina Reiss in their bestseller [Corona, False Alarm? Facts and Figures.](#)

A December 2020 review published by the Penn Medicine Center for Evidence-based Practice concludes that current evidence on mRNA vaccines *"is made up entirely of small early-stage trials, nearly all of which examined only short-term outcomes"* and have not assessed *"the risk of serious but uncommon adverse events."*

"There are no specific guidelines for use of messenger RNA (mRNA) vaccines or contraindications to mRNA vaccines. No large trials of any mRNA vaccine have been completed yet," the findings state.

But echoing Pope Francis' slogan, Bill Gates says, *"no one is saved alone; we can only be saved together,"* Gates notes that *"for all our differences, everyone in this world is connected biologically by a microscopic network of germs and particles — and that, like it or not, we're all in this together."* Both Gates and Pope Francis are still pushing the idea of "connection" as akin to "patriotism".
