His orders, released by the state Department of Public Health, demand that churches *"discontinue singing and chanting activities."* Previously, the state "merely said these institutions should 'strongly consider discontinuing singing, group recitation, and other practices and performances,'" the report said.

The state also ordered: "Places of worship must take reasonable measures to remind congregants and visitors that they must use face coverings and practice physical distancing and should frequently wash their hands with soap for at least 20 seconds, use hand sanitizer, and not touch their face."

Governor Newsome overstepped his bounds, and as the governor of the State of California, he has forgotten the very fact that Governor Newsome does not make laws, he merely signs or vetoes the laws created in the California Assembly. As I recall, no State has passed a law requiring its citizens to wear face masks.

It does not matter which state you live in, no governor can force you to wear a face mask, it's not his legal authority to issue such orders. Only the state assembly or legislature can require its citizens to do so and they first must pass a law to do so. It is called "Tyranny" to do so without.

Governor Wolf of PA in expanding on the business safety order signed by Secretary of Health Dr. Rachel Levine in April that requires the wearing of masks in businesses, Governor Tom Wolf today (July 1<sup>st</sup>) announced a new order signed by Dr. Levine that takes the mask-wearing directive one step further.

With this order, signed under Dr. Levine's authority under the Disease Prevention and Control Act, masks must be worn whenever anyone leaves home. The order takes effect immediately.

"This mask-wearing order is essential to stopping the recent increase in COVID-19 cases we have seen in Pennsylvania," Gov. Wolf said. "Those hot spots can be traced to situations where Pennsylvanians were not wearing masks or practicing social distancing – two practices that must be adhered to if we want to maintain the freedoms we have in place under our reopening."

The order outlines the situations when a mask must be worn and includes limited exceptions to the face-covering requirement.

Each of the state's mitigation efforts has helped to slow the spread of COVID-19, kept our health care systems from being overwhelmed, and allowed for Gov. Wolf's measured, phased reopening to proceed. But, with nearly every county is the green phase of reopening, complacency cannot be the norm.

*"It is essential that Pennsylvanians wear masks to prevent the spread of COVID-19,"* Secretary of Health Dr. Rachel Levine said. *"While cases increase in some areas, we cannot become complacent. My mask protects you, and your mask protects me. Wearing a mask shows that you care about others, and that you are committed to protecting the lives of those around you."* 

More and more health experts have called for mask wearing, including Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, who said during a June 30 Senate hearing on COVID-19, *"Americans who don't wear masks may 'propagate the further spread of infection."* 

The mask-wearing order will be sent to state and local officials, law enforcement and others tasked with education about the order for those not in compliance. Governor

Wolf is one of four or five states where Democrats rule states that have continued to blow the Corona virus out of proportion needlessly. Their real intent is to stir the waters every conceivable way possible to disrupt the national election this coming November. This includes New York, New Jersey, Virginia, California, Oregon, and Washington.

Governor Wolf of Pennsylvania seems like Governor Newsome to have forgotten, he does not make Laws, and his office is to sign them into law, or veto a law. We have a national system of government made up of three branches: the Executive, the Legislative, and the Judicial. Each of the individual "50" states has essentially the same system of government checks and balances. Again, to operate outside of the Law, a governor is acting like a tyrant or dictator king.

Federal coronavirus guidelines that <u>recommend</u> wearing masks are posing a challenge for states that have laws on the books from almost a century ago against facial coverings as a way to crack down on the Ku Klux Klan.

Wording of statements reveal that authorities are skirting the issue by using terms "suggest" and "recommend". They know the risk of law suits.

When the words "required," "mandated," and "ordered" are used, it is an invitation to a law suit; the same goes for "executive order" An "executive order" is not a LAW! Even Presidential "Directives" or "Executive Orders" are not sacrosanct. The Legislative branch can overrule and strike down a Presidential Executive Order, Also, any future Presidential EO can be cancelled, repealed, or annulled.

As to businesses, retail establishments, and other public facilities, while it is the prerogative of the management, they are also vulnerable to Law Suits or Litigation when it is a matter of one's health. There are ads appearing on the Internet offering to take class action law suits over this issue.

A week ago, an Ohio State legislator demonstrated an OSHA oxygen detector placed beneath the mask of several volunteers, and in each case, as little as two seconds and longer proved the face masks were detrimental to oxygen access. OSHA has issued Frequently Asked Questions [FAQs] that explain the differences between cloth face coverings, surgical masks and respirators.

The resource is extensive, but some highlights include:

- Cloth face coverings do not constitute personal protective equipment.
- Surgical masks are not considered to be PPE if they are being used solely to contain the respiratory droplets of the person wearing them (referred to by OSHA as "source control").

• Although employers are not required to provide their employees with cloth face coverings or surgical masks, the use of such face coverings and/or surgical masks

would constitute part of "a control plan designed to address hazards from SARS-CoV-2" under the General Duty Clause.

• OSHA suggests following CDC guidance on washing face coverings.

OSHA explains, "Employers may choose to use cloth face coverings as a means of source control . . . [where] transmission risk cannot be controlled through engineering or administrative controls, including social distancing."

OSHA also reiterates guidance from the Centers for Disease Control and Prevention that cloth face coverings are not a substitute for social distancing.

OSHA also emphasizes that surgical masks and cloth face coverings, including in the construction industry, are not acceptable substitutes where respirators are required due to exposures to contaminants such as asbestos or silica.

"In general, employers should always rely on a hierarchy of controls that first includes efforts to eliminate or substitute out workplace hazards and then uses engineering controls (e.g., ventilation, wet methods), administrative controls (e.g., written procedures, modification of task duration), and safe work practices to prevent worker exposures to respiratory hazards, before relying on personal protective equipment, such as respirators. When respirators are needed, OSHA's guidance describes enforcement discretion around use of respirators, including in situations in which it may be necessary to extend the use of or reuse certain respirators, use respirators beyond their manufacturer's recommended shelf life, and/or use respirators certified under the standards of other countries or jurisdictions.

Clarification of OSHA's requirement for breathing air to have at least 19.5% oxygen content. Human beings must breathe oxygen . . . to survive, and begin to suffer adverse health effects when the oxygen level of their breathing air drops below [19.5% oxygen]. Below 19.5% oxygen - air is considered oxygen-deficient. At concentrations of 16 to 19.5%, workers engaged in any form of exertion can rapidly become symptomatic as their tissues fail to obtain the oxygen necessary to function properly (Rom, W., *Environmental and Occupational Medicine*, 2nd ed.; Little, Brown; Boston, 1992).

Increased breathing rates, accelerated heartbeat, and impaired thinking or coordination occur more quickly in an oxygen-deficient environment. Even a momentary loss of coordination may be devastating to a worker if it occurs while the worker is performing a potentially dangerous activity, such as climbing a ladder. Concentrations of 12 to 16% oxygen cause tachypnea (increased breathing rates), tachycardia (accelerated heartbeat), and impaired attention, thinking, and coordination (e.g., Ex. 25-4), even in people who are resting.

At oxygen levels of 10 to 14%, faulty judgment, intermittent respiration, and exhaustion can be expected even with minimal exertion (Exs. 25-4 and 150). Breathing air containing 6 to 10% oxygen results in nausea, vomiting, lethargic movements, and perhaps unconsciousness. Breathing air containing less than 6% oxygen produces

convulsions, then apnea (cessation of breathing), followed by cardiac standstill. These symptoms occur immediately. Even if a worker survives the hypoxic insult, organs may show evidence of hypoxic damage, which may or may not be irreversible.

The Centers for Disease Control and Prevention and OSHA have described crisis strategies intended for use in healthcare in which surgical masks or cloth face coverings may offer more protection than no mask at all when respirators are needed but are not available. Such information is not intended to suggest that surgical masks or cloth face coverings provide adequate protection against exposure to airborne contaminants for which respirators would ordinarily be needed. Although OSHA's enforcement guidance describes equipment prioritization that includes surgical masks, employers must still comply with the provisions of any standards that apply to the types of exposures their workers may face. For example, the permissible exposure limits of all substance-specific standards, such as asbestos and silica, remain in place, and surgical masks are not an acceptable means of protection when respirators would otherwise be required (e.g., when engineering, administrative, and work practice controls do not sufficiently control exposures).

If respirators are needed but not available (including as described in the OSHA enforcement guidance noted above), and hazards cannot otherwise be adequately controlled through other elements of the hierarchy of controls (i.e., elimination, substitution, engineering controls, administrative controls, and/or safe work practices), avoid worker exposure to the hazard. Whenever a hazard presents an imminent danger, and in additional situations whenever feasible, the task should be delayed until feasible control measures are available to prevent exposures or reduce them to acceptable levels (i.e., at or below applicable OSHA permissible exposure limits)."

According to this latest OSHA guidance, if respirators are not available where a Permissible Exposure Limit is exceeded, worker exposure should be avoided by delaying the task until feasible control measures are available to reduce the exposures below the Permissible Exposure Limit.

As clearly understood in the OSHA public statements, <u>we have a serious contradiction</u>, both with the CDC and the World Health Organization (WHO), who publicly stated the face masks are not effective.

Furthermore, there has been massive fraud uncovered with the CDC's inflating the data, and causing states to shut down their economies on falsified data reported by the CDC. This fraudulent activity was discovered by the leftist magazine, *'The Atlantic'* proving the point that a broken clock is right twice a day.

A government Accountability Office levied criticism at the CDC for combining activity for combining active cases of the corona virus and positive antibody tests, which may give a misleading view of nationwide testing and spread. #### Coronavirus spikes in Sun Belt states force closures, re-opening delays

Beaches in some Florida, California counties to close ahead of July Fourth weekend; Casey Stegall reports.

The U.S. reported a record 52,788 new <u>coronavirus</u> infections Wednesday, the first time the single-day number has <u>exceeded 50,000</u>, according to reports.

Wednesday's total topped the previous record, set last Sunday, by 8,600 cases, according to the *'Financial Times'*.

It also came one day after Dr. <u>Anthony Fauci</u> of the White House coronavirus task force predicted U.S. infections could soon climb <u>as high as 100,000</u> per day if mitigation efforts aren't taken more seriously.

## US SETS DAILY RECORD OF NEW CORONAVIRUS CASES

Five states -- California, Texas, Arizona, North Carolina and Georgia -- also reported their highest infection totals Wednesday, The Washington Post reported. In California, 9,740 people tested positive for the virus.

Cases have spiked across the country as states start to reopen businesses and ease restrictions after months of stay-at-home orders.

Both California and Florida are closing beaches in some counties over the Fourth of July weekend and California Gov. Gavin Newsom has <u>ordered bars, dine-in services at</u> restaurants and other indoor activities closed in some areas.

Throughout June, the infection rate rose by 105 percent nationally, according to the <u>Times</u> and weekly averages for new infections have increased in 45 states over the last week, according to The <u>Post</u>.

Apple and McDonald's are among businesses that have reclosed some stores in various states amid the surge.

*"Help is on the way and we're going to spare no expense to provide the kind of reinforcements that you will need across the state,"* Vice President Mike Pence said Wednesday in Arizona, where hospitals have seen a surge in cases, forcing Gov. Doug Ducey to reclose gyms, movie theaters and other businesses, <u>AZCentral.com reported.</u>

President Trump, who has been resistant to wearing a face mask in public in the past, told Fox Business on Wednesday he would have no problem wearing one and was "all for masks."

He said, however, that he disagreed with House Speaker Nancy Pelosi that a national mask mandate was necessary.

Some states -- including California, Nevada, Washington and Pennsylvania -- have mandated masks statewide to help slow the spread as people leave their houses more during summer weather.


"When you do not wear your face covering, we end up in a situation where you see higher rates of disease spread and you end up having to close places," Surgeon General Jerome Adams said Tuesday. "This mask, this face covering, actually is an instrument of freedom for Americans if we all use it."

Trump told <u>Fox Business</u> on Wednesday he still believes that the virus will just "disappear" at some point, he hopes.

The president and the White House have said that the spike in cases is due to increases in testing, but <u>Dr. Fauci</u>, the director of the National Institute of Allergy and

Infectious Diseases, and other experts have said testing can't account for the entirety of the surge.



"When a Jesuit of the minor rank is to be elevated to command, he is conducted into the Chapel of the Convent of the Order, where there are only three others present, the principal or Superior standing in front of the altar. On either side stands a monk, one of whom holds a banner of yellow and white, which are the Papal colors, and the other a black banner with a dagger and red cross above a skull and crossbones, with the word INRI, and below them the words IUSTUM, NECAR, REGES, IMPIOUS. The meaning of which is: <u>It is just to exterminate or annihilate impious or heretical Kings, Governments, or Rulers</u>. Upon the floor is a red cross at which the postulant or candidate kneels. The Superior hands him a small black crucifix, which he takes in his left hand and presses to his heart, and the Superior at the same time presents to him a dagger, which he grasps by the blade and holds the point against his heart, the Superior still holding it by the hilt, and thus addresses the postulant:"

#### Superior:

My son, heretofore you have been taught to act the dissembler: among Roman Catholics to be a Roman Catholic, and to be a spy even among your own brethren; to believe no man, to trust no man. Among the Reformers, to be a reformer; among the Huguenots, to be a Huguenot; among the Calvinists, to be a Calvinist; among other Protestants, generally to be a Protestant, and obtaining their confidence, to seek even to preach from their pulpits, and to denounce with all the vehemence in your nature our Holy Religion and the Pope; and even to descend so low as to become a Jew among Jews, that you might be enabled to gather together all information for the benefit of your Order as a faithful soldier of the Pope.

You have been taught to insidiously plant the seeds of jealousy and hatred between communities, provinces, states that were at peace, and incite them to deeds of blood, involving them in war with each other, and to create revolutions and civil wars in countries that were independent and prosperous, cultivating the arts and the sciences and enjoying the blessings of peace. To take sides with the combatants and to act secretly with your brother Jesuit, who might be engaged on the other side, but openly opposed to that with which you might be connected, only that the Church might be the gainer in the end, in the conditions fixed in the treaties for peace and that the end justifies the means.

You have been taught your duty as a spy, to gather all statistics, facts and information in your power from every source; to ingratiate yourself into the confidence of the family circle of Protestants and heretics of every class and character, as well as that of the merchant, the banker, the lawyer, among the schools and universities, in parliaments and legislatures, and the judiciaries and councils of state, and to be all things to all men, for the Pope's sake, whose servants we are unto death.

You have received all your instructions heretofore as a novice, a neophyte, and have served as co-adjurer, confessor and priest, but you have not yet been invested with all that is necessary to command in the Army of Loyola in the service of the Pope. You must serve the proper time as the instrument and executioner as directed by your superiors; for none can command here who has not consecrated his labors with the blood of the heretic; for "without the shedding of blood no man can be saved." Therefore, to fit yourself for your work and make your own salvation sure, you will, in addition to your former oath of obedience to your order and allegiance to the Pope, repeat after me—

The Extreme Oath of the Jesuits:

"1. \_ now, in the presence of Almighty God, the Blessed Virgin Mary, the blessed Michael the Archangel, the blessed St. John the Baptist, the holy Apostles St. Peter and St. Paul and all the saints and sacred hosts of heaven, and to you, my ghostly father, the Superior General of the Society of Jesus, founded by St. Ignatius Loyola in the Pontificate of Paul the Third, and continued to the present, do by the womb of the virgin, the matrix of God, and the rod of Jesus Christ, declare and swear, that his holiness the Pope is Christ's Vice-regent and is the true and only head of the Catholic or Universal Church throughout the earth; and that by virtue of the keys of binding and loosing, given to his Holiness by my Savior, Jesus Christ, he hath power to depose heretical kings, princes, states, commonwealths and governments, all being illegal without his sacred confirmation and that they may safely be destroyed. Therefore, to the utmost of my power I shall and will defend this doctrine of his Holiness' right and custom against all usurpers of the heretical or Protestant authority whatever, especially the Lutheran of Germany, Holland, Denmark, Sweden, Norway, and the now pretended authority and churches of England and Scotland, and branches of the same now established in Ireland and on the Continent of America and elsewhere; and all adherents in regard that they be usurped and heretical, opposing the sacred Mother Church of Rome. I do now renounce and disown any allegiance as due to any heretical king, prince or state named Protestants or Liberals, or obedience to any of the laws, magistrates or officers.

I do further declare that the doctrine of the churches of England and Scotland, of the Calvinists, Huguenots and others of the name Protestants or Liberals to be damnable and they themselves damned who will not forsake the same.

I do further declare, that I will help, assist, and advise all or any of his Holiness' agents in any place wherever I shall be, in Switzerland, Germany, Holland, Denmark, Sweden, Norway, England, Ireland or America, or in any other Kingdom or territory I shall come to, and do my uttermost to extirpate the heretical Protestants or Liberals' doctrines and to destroy all their pretended powers, regal or otherwise.

I do further promise and declare, that notwithstanding I am dispensed with, to assume my religion heretical, for the propaganda of the Mother Church's interest, to keep secret and private all her agents' counsels from time to time, as they may entrust me and not to divulge, directly or indirectly, by word, writing or circumstance whatever; but to execute all that shall be proposed, given in charge or discovered unto me, by you, my ghostly father, or any of this sacred covenant.

I do further promise and declare, that I will have no opinion or will of my own, or any mental reservation whatever, even as a corpse or cadaver (perinde ac cadaver), but will unhesitatingly obey each and every command that I may receive from my superiors in the Militia of the Pope and of Jesus Christ.

That I may go to any part of the world withersoever I may be sent, to the frozen regions of the North, the burning sands of the desert of Africa, or the jungles of India, to the centers of civilization of Europe, or to the wild haunts of the barbarous savages of America, without murmuring or repining, and will be submissive in all things whatsoever communicated to me.

I furthermore promise and declare that I will, when opportunity present, make and wage relentless war, secretly or openly, against all heretics, Protestants and Liberals, as I am directed to do, to extirpate and exterminate them from the face of the whole earth; and that I will spare neither age, sex or condition; and that I will hang, waste, boil, flay, strangle and bury alive these infamous heretics, rip up the stomachs and wombs of their women and crush their infants' heads against the walls, in order to annihilate forever their execrable race. That when the same cannot be done openly, I will secretly use the poisoned cup, the strangulating cord, the steel of the poniard or the leaden bullet, regardless of the honor, rank, dignity, or authority of the person or persons, whatever may be their condition in life, either public or private, as I at any time may be directed so to do by any agent of the Pope or Superior of the Brotherhood of the Holy Faith, of the Society of Jesus.

In confirmation of which, I hereby dedicate my life, my soul and all my corporal powers, and with this dagger which I now receive, I will subscribe my name written in my own blood, in testimony thereof; and should I prove false or weaken in my determination, may my brethren and fellow soldiers of the Militia of the Pope cut off my hands and my feet, and my throat from ear to ear, my belly opened and sulphur burned therein, with all the punishment that can be inflicted upon me on earth and my soul be tortured by demons in an eternal hell forever!

All of which, I, \_\_\_\_\_, do swear by the Blessed Trinity and blessed Sacraments, which I am now to receive, to perform and on my part to keep inviolable; and do call all the heavenly and glorious host of heaven to witness the blessed Sacrament of the Eucharist, and witness the same further with my name written and with the point of this dagger dipped in my own blood and sealed in the face of this holy covenant."

(He receives the wafer from the Superior and writes his name with the point of his dagger dipped in his own blood taken from over his heart.)

#### Superior:

"You will now rise to your feet and I will instruct you in the Catechism necessary to make yourself known to any member of the Society of Jesus belonging to this rank.

In the first place, you, as a Brother Jesuit, will with another mutually make the ordinary sign of the cross as any ordinary Roman Catholic would; then one cross his wrists, the palms of his hands open, and the other in answer crosses his feet, one above the other; the first points with forefinger of the right hand to the center of the palm of the left, the other with the forefinger of the left hand points to the center of the palm of the right; the first then with his right hand makes a circle around his head, touching it; the other then with the forefinger of his left hand touches the left side of his body just below his heart; the first then with his right hand draws it across the throat of the other, and the latter then with a dagger down the stomach and abdomen of the first. The first then says lustum; and the other answers Necar; the first Reges. The other answers Impious." (The meaning of which has already been explained.) A. —In the bark of Peter the fisherman.


Q. —Whither do you travel?

## Joseph Stalin a.k.a. Fr. Joseph Stalin SJ.

Before looking at his profile, it is also interesting to note the Jesuit connection to Stalin and communism is also seen from Stalin's own words in a little known letter written to the Politburo in 1934.

In the letter Stalin wants to keep the Jesuit name out of the Bolshevik newspaper and tells the leaders to be wary and not to print an article by Engels because it refers, in part, to the Jesuits.

Here is the quote by Engels which Stalin warns must be kept out of the Bolshevik: "Foreign policy," Engels states, "is unquestionably in the realm in which tsarism is very, very strong. Russian diplomacy constitutes a new kind of Jesuit Order, which is powerful enough to overcome, when necessary, even the tsar's whims and, while spreading corruption far beyond itself, is capable of stopping corruption in its own midst."

Josef Vissarionovich <u>Dzhugashvili</u> (December 18, 1878 – March 5, 1953), better known by his <u>adopted</u> name, Joseph Stalin (stalin meaning "made of steel". Josef was born to influential Catholic parents Vissarion "Beso" Dzhugashvili and Ekaterina "Keke" Geladze. His father Beso was a successful and relatively wealthy local businessman. However, in later biographies, he is variously described as poor, dirt poor and a violent alcoholic. Whatever the real truth, Josef was accepted into the Catholic Cappuchin run school at Gori.

He graduated in 1892 first in his class and at the age of 14 he was accepted to enter the "Orthodox" Seminary of Tiflis (Tbilisi, Georgia), a Jesuit institution to be trained as a Jesuit priest. In spite of contrary history written about the Jesuit run seminary, the Jesuits remained in Russian territory after the order was banned by Alexander I in 1820, maintaining control of several institutions, including the Seminary of Tiflis. Stalin himself openly admitted the Jesuit control of the institution in his famous interview with Jewish Journalist Emil Ludwig (Cohen):

Ludwig) What impelled you to become an oppositionist? Was it, perhaps, bad treatment by your parents?

Stalin) No. My parents were uneducated, but they did not treat me badly by any means. But it was a different matter at the Orthodox theological seminary which I was then attending. In protest against the outrageous regime and the Jesuitical methods prevalent at the seminary, I was ready to become, and actually did become, a revolutionary, a believer in Marxism as a really revolutionary teaching.

Ludwig) But do you not admit that the Jesuits have good points? Stalin) Yes, they are systematic and persevering in working to achieve sordid ends but their principal method is spying, prying, worming their way into people's souls and outraging their feelings.

#### What good can there be in that?

For instance, the spying in the hostel. At nine o'clock the bell rings for morning tea, we go to the dining-room, and when we return to our rooms we find that meantime a search has been made and all our chests have been ransacked ... What good point can there be in that?

At Tiflis, Stalin's closest friend was fellow classmate Krikor Bedros Aghajanian, the future Grégoire-Pierre Cardinal <u>Agagianian</u>, a powerful and ruthless Catholic cardinal who went on to control the death camps in Siberia under Stalin's rule. While accounts of his time at Tiflis have been changed many times, it is universally accepted that Stalin was the star pupil of the seminary.

As a result, the events of 1899 remain shrouded in mystery. In the final week of his studies, having completed seven years as the star pupil of the Jesuits, Stalin is variously claimed to have quit or been expelled. Neither account adequately explains how a seminary student of seven years suddenly appeared influential and active in coordinating the Georgian Social-Democratic movement less than 12 months later – an achievement that could not possibly have happened without substantial support.

The more credible and controversial conclusion is that Stalin did graduate from the Jesuit Seminary as a proper Jesuit priest, with his first assignment being to infiltrate and manage the Georgian underground against the Russian Tsarist Government. Again, the fact that Stalin was awarded an academic position at the Tiflis Observatory gives credence to his Jesuit credentials and completed study.

His double life as a secret leader of the May Day uprising of 1901 less than two years from graduating from the Jesuit seminary attests to his skill as a key Jesuit agent. After avoiding capture by the Tsarist Secret Police (Okhrana), Stalin fled to Batumi where <u>he was hidden in safety by the Rothschild's</u> via one of their oil refineries located there. Where have we heard that name before? In 1902, when authorities learnt of his hiding place, the local Cossacks were ordered to capture him.

However, the oil workers rallied behind Stalin with a number killed and arrested along with Stalin. Later this whole event was turned into Stalin rather than remaining in hiding, organizing a strike and arson against the oil refinery – all of which defies common sense of his circumstances. In 1903, Stalin was exiled to Siberia for three years. However, a few months later the Jesuits managed to get false papers to the prison camp and free Stalin, who returned to Tiflis on January 4, 1904. His new orders from the Jesuits was to start an underground paper called Credo, denouncing international Marxist ideology of Lenin in favor of the Facist Social-Democratic model of Roman Catholicism. Once the Russo-Japanese War started in February 1904, Stalin was active across Georgia in organizing resistance and focused attacks against the Mensheivik breakaway faction of the communists.

In January 9, 1905, Stalin succeeded in starting the spark his masters had requested by successfully arranging a mass demonstration of workers with communist and anti-Tsarist banners in Baku. He then secretly alerted the Cossacks that the demonstration was an armed rebellion. The Cossacks reacted as expected and killed several hundred demonstrators thus sparking the Russian Revolution of 1905. During the following months, Stalin excelled as guerilla leader in maintaining the rebellion across Georgia. Yet the movement never gained critical mass and Stalin was ordered to redirect his efforts to infiltrating the top echelon of the Bolsheviks.

In December 1905, Stalin secured a meeting with Lenin, but failed to gain his trust and endorsement and returned to Tiflis, effectively a free agent. In February 1906, to prove his credentials to the Bolsheviks, Stalin arranged for the assassination of <u>General</u> <u>Griaznoff.</u> He also continued to stage bank robberies and extortions, sending the money through to the Bolsheviks as proof of his trustworthiness. These events were enough to force Lenin to permit Stalin to attend the Socialist Democratic Party meeting in London in 1907. After returning to Georgia, Stalin was again arrested in March 25, 1908. He was sentenced to two years in exile in Siberia, but after seven months, the Jesuit influence within the Tsarist Government enabled his escape by February 1909. Around the exact same time, the Bolsheiviks were on the verge of extinction in account of their leaders in prison or exile and a lack of new recruits and funds.

Stalin called for a reconciliation with the Menshevik faction which Lenin opposed. Stalin then called for a major witch hunt to weed out alleged double-agents. A number of key Lenin supporters and intelligentsia were hounded out and some murdered – later records revealing none were traitors.

Stalin was again arrested in 1910 and again in 1913 for four years. In the wake of the February Revolution in 1917, Stalin was released from prison and moved to Saint Petersburg and promptly founded the Pravda, the official Bolshevik newspaper with substantial finances and equipment that arrived virtually overnight while Lenin and the rest of the leadership were still in exile. The Pravda became a major tool of the revolution and Lenin was forced to include Stalin in senior committees on account of the power and influence of Pravda.

# Lenin like most of the Bolsheviks regarded Stalin as a double agent of the Jesuits.

Their most visible proof was the fact that Stalin had escaped death in prison and the extraordinary and unprecedented leniency given to him by the Tsarist Government – when agitators found guilty of a fraction of the actions of Stalin had been brutally tortured and killed. While the escapes and "near misses" are recorded about the life of Stalin, the fact that he was apparently the "luckiest revolutionary" of the 20th Century is not discussed. By 1922, the Bolsheviks had won the Civil War, but left the whole country broke.

The Rothschild's and the American Jesuit Bankers on Wall Street made a simple offer -

they would help fund and bail out the new Soviet Union, providing Stalin was given a key role.

Then on April 3, 1922, Stalin was made General Secretary of the Central Committee, a post he subsequently grew to become the most powerful. In spite of his position, Lenin still sought to thwart the influence of Stalin and in December 1923 it came to a head with Lenin planning to have Stalin finally eliminated.

# In January 1924, Jesuit Superior General <u>Wlodimir Ledóchowski</u> gave the order to Stalin allowing him to kill Lenin and on January 21, 1924, Lenin was poisoned to death at the age of 53.

To quell any rumors of foul play, Stalin published retractions in Pravda against "allegations" that never existed such as Lenin had been mentally unwell and that he even died from syphilis.

From this point on, Stalin was the most powerful and undisputed ruler of the Soviet Union. <u>One of the earliest acts of Stalin was to begin the outlawing of the Russian</u> <u>Orthodox Church</u>, allowing seized thousands of churches and schools to be handed over to the Catholic Church – a highly controversial program that has largely been unreported even to this day. By 1939, the Russian Orthodox Church was all but extinct. Of the other persecutions, the Ukraine and deportation of Jews is also infamous under his reign in which tens of millions perished. **But what is rarely if ever published is that the Head of the Death Camps of Siberia was none other than Catholic Cardinal Gregory Agagianian**, his former classmate at the Jesuit Seminary of **Tiflis**.

# Edmund A. Walsh SJ

An American Jesuit Catholic priest, professor of geopolitics and founder of the Georgetown University School of Foreign Service, which he founded in 1919 – six years before the U.S. Foreign Service itself existed – and served as its first dean. His motivation for doing so came as a result of his experiences at the Versailles Conference of 1919. In 1922, Jesuit Superior-General Ledóchowski appointed Walsh to negotiate with Lenin in Russia to provide emergency financial assistance on the provision that Joseph Stalin SJ was appointed to oversee the day to day operations of the nation. The mission was given the public name Papal Famine Relief Mission with little aid reaching starving Russians, but towards building military and financial infrastructure. In the middle 1920's Walsh was instrumental in the constant upheaval in Mexico having a direct hand in the assassination of several revolutionaries including Álvaro Obregón. In 1929, Walsh then personally assisted Plutarco Elías Calles in the formation of the National Revolutionary Party (PNR) ensuring the security and primacy of the Catholic Church in Mexican politics and the party – an alliance that remains unbroken to this day.

# In 1931, Walsh was instrumental in establishing diplomatic relations for the U.S. Government in Baghdad.

One of his most important and influential appointments was as "consultant" to the U.S. Chief of Counsel at the Nuremberg Trials (1945-1946). It was Walsh who was instrumental in ensuring the heavily occult focused symbolism and activities of the Nazis were never recorded into the trials, even though every single defendant wore dozens of occult symbols on their uniforms and participated in occult related ceremonies.

Walsh also ensured that the key involvement of the Catholic Church was stricken from the official record, with accounts of Catholic priests at concentration camps, regular meetings with Cardinals, Bishops and the Nazis destroyed or suppressed and absolutely no mention of Jesuit involvement. Walsh also ensured a number of prominent Nazis were excluded from the Nuremberg Trials, none more than <u>Karl Haushofer</u> (1869-1946) – German General, geopolitical theorist and political architect of the Nazi political philosophy. Haushofer more than any other German political thinker influenced Hitler and the Nazis in their European political outlook.

# Strike 1.

# Strike 3.

I find Adriana Cohen's rationale interesting to the point that it makes some sense, but I believe there are reasons that escape understanding of this evil man. Dr. Anthony (Jaws) Stephen Fauci is first and foremost a Jesuit Coadjutor [those who do not wear clerical collars]. He graduated from the College of the Holy Cross, a Jesuit University.

A former U.S. military intelligence officer had this to say about Dr. Jaws:

"What the world is witnessing is the raw power and overwhelming influence wielded by both the notorious Medical Mafia and Big Pharma. Not only is Fauci a career-long hitman for the former, he's the quintessential inside man for the latter."

In October 1958, Italian Cardinal Angelo Giuseppe Roncalli was elected pope at the age of 77. Ascending to the papacy at such an old age, he was expected to be a mere caretaker and bridge the short gap to the next ecclesiastical head. But less than three months into office, in January of 1959, he surprised many by calling for the convening of an ecumenical council. Over two years of formal preparations went into launching the meetings on October 11, 1962. It was the first council to be called in almost a century (Vatican I ended in 1870), and only the third since the Reformation (the Council of Trent spanned 1545 to 1563). Many have summarized the core purpose of the council as adapting Roman Catholicism to the modern world. Summoning and beginning the council proved to be John XXIII's most significant work as pope, as he died midway through the council on June 3, 1963.

## What Vatican II Changed

Vatican II brought some major changes to the Roman Catholic church. Most obvious were changes in the mass, which had been said in Latin, with priests facing away from the congregation, often speaking quietly (even mumbling). It was impersonal at best and, for most, not understandable.

After the council, the feel of the mass changed drastically. It now was to be conducted in the language of the people, and participation was encouraged in new ways, with new possibilities granted for music and singing, and women allowed into upfront roles as readers, lectors, and Eucharistic ministers, as well as altar servers in some places (though some bishops and priests still discourage it). The sweeping reforms also included no longer forbidding Catholic attendance at Protestant services or reading from a Protestant Bible.

Another major course correction was Catholicism's orientation on the Jewish people and non-Catholics. According to Catholic author <u>Greg Tobin</u>, this was one of the most important theological and global breakthroughs, in terms of what came out of Vatican II. The church radically changed its position on the teaching about Jews, and really opened up to dialogue with the Jewish community; and encouraged — and demanded — that Catholics not consider the Jews as "other" or enemy but, in fact, as brothers and sisters under the same God. And it was a monumental shift in the position of the church and in the teachings of the church. So it was a sea change, in terms of the Catholic Church.

Vatican II aimed to produce not only a very different experience of the mass, but also a repositioning of the church in relation to the modern world. But many have wondered, despite all the felt flash points of change, whether it hasn't proved to be much more than rearranging deck chairs on the Titanic.

#### What Vatican II Didn't Change

Evangelicals should be careful to not assume that Vatican II changed more than it did. Shortly after the release of the council's official documents, Reformed theologian and author Loraine Boettner, who lived through Vatican II and watched it with a careful eye, provided his perspective on the council's effects (and lack thereof) in the preface of his book <u>Roman Catholicism</u>. Vatican II, he said,

"repeated the claim that the Roman Catholic Church is the only true church, although it did recognize that other churches contain some elements of truth. . . . Pope John XXIII, who called the first session, and Pope Paul VI, who presided over the later sessions (as well as several prominent cardinals and theologians), took care to emphasize that *no changes would be made in the doctrinal structure of the Church*. However, Pope Paul did promulgate one new doctrine, which asserts that "Mary is the Mother of the Church." The primary purpose of the Council was to update the liturgy and administrative practices and so to make the Church more efficient and more acceptable to the 20th century world." Note the added italics: *"no changes . . . in the doctrinal structure of the Church."* 

"On previous occasions, Rome has changed her tactics when old methods became ineffective, but she has never changed her nature. In any religious organization, doctrine is the most basic and important part of its structure, since what people believe determines what they do. An official document, "The Constitution on the Church" prepared by the Council and approved by the Pope, reaffirms basic Catholic doctrine precisely as it stood before the Council met. . "

If the Roman Catholic Church were reformed according to Scripture, it would have to be abandoned. But the gross errors concerning salvation still remain. Moreover, the Council did nothing toward removing the more than one hundred anathemas or curses pronounced by the Council of Trent on the Protestant churches and belief.

Boettner concluded that Vatican II makes it abundantly clear that <u>Rome has no intention</u> <u>of revising any of her basic doctrine</u>, but only of updating her methods and techniques for more efficient administration and to present a more attractive appearance. This is designed to make it easier for the Eastern Orthodox, Anglican, and Protestant churches to return to her fold. There is no indication that she has any intentions of entering into genuine give-and-take church unity negotiations.

Her purpose is not union, but absorption. Church union with Rome is strictly a one-way street. The age-old danger that Protestantism has faced from the Roman Church has not diminished; in fact, it may well have increased. For through this less offensive posture and this superficial ecumenicism, Rome is much better situated to carry out her program of eliminating opposition and moving into a position of world dominance. An infallible church simply cannot repent.

The Jesuits are what we refer to as *"those in the game for the long haul"* and those who study the history of the House of Rothschild document their plan of attack. They have been in it since the 1782 Congress of Wilhelmsbad. This crucial event brought together a union of the different secret societies, committed to control the world.

Both concluded that the "...<u>overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza</u>..."

In the meantime, America is suffering major devastation due to the lockdown. As head of the CDC, Dr. Redfield owns responsibility for this state of affairs. Indeed, most Americans trust the CDC to give them accurate information on Covid – much more so than the rest of the Federal Government.

It begs the question: who exactly is Dr. Redfield? What is his background and track record? Should we trust him with the serious task of leading the CDC?

# The Vital Role of Dr. Redfield's Jesuit Faith and Education

<u>Redfield's pastor</u> and friends testify that his years of work studying viruses along with his deep Catholic faith will help guide the country through the crisis.

Redfield is an active member of Baltimore's Cathedral of Mary Our Queen where his parish priest, Richard Woy, recently remarked that *"the CDC director is 'not shy about his Catholic faith"* and that both he and his wife are serving as extraordinary ministers of holy Communion.

Dr. Redfield was born and raised in a Roman Catholic family. Both of his parents worked at the National Institutes of Health (NIH). Intrigued by <u>Jesuit traditions</u> and teaching, he enrolled at Georgetown University, the nation's oldest educational Roman Catholic Jesuit institution. <u>He received both his BA and MD.</u>

Dr. Redfield has been sitting under the wings of his Jesuit masters from an early age. He admits that *"Georgetown was critical in terms of my formation as a young adult and young physician."* 

This is an unfortunate development, especially for one of the four key leaders of the national effort to fight COVID.

One of the foundational principles of Jesuit teaching is the "ends justify the means". This teaching contradicts Biblical ethics. People devolve into lawlessness. Leaders sacrifice integrity for pushing their own interests.

The Book of Judges shows the oppression and misery of the people of Israel at a time when "every man did that which was right in his own eyes."

The Jesuit Order was created by Spanish soldier Ignatius de Loyola in 1533. Their primary goal was to serve the Pope by taking whatever means necessary to convert people. In fact, the Jesuits were Rome's response to the success of the Protestant Reformation. They were known as agents for the "Counter Reformation."

"Military obedience is not the equivalent of Jesuitical obedience; the latter is more extensive as it gets hold of the whole man and is not satisfied like the other, with an exterior act, but requires the sacrifice of the will and laying aside of one's own judgment." Ignatius wrote in his letter to the Portuguese Jesuits: "We must see black as white, if the Church says so.""

Dr. Redfield sees his Jesuit training as vital to his work. Hence, we should scrutinize his pronouncements as head of the CDC.

"<u>The Jesuit tradition is important to me</u> - women and men for others and a commitment to health justice and equity, seeing the gifts of science applied equitably. Georgetown taught me that science and medicine are made to impact public health.""

# Dr. Redfield's Merciless Approach to AIDS

Impacting the public is exactly what Dr. Redfield vigorously pursued once he was placed in a position of authority. During the AIDS epidemic in the late eighties and early 1990's, Dr. Redfield headed up the US <u>military's response</u> to the HIV/AIDS epidemic. He introduced harsh measures: quarantining infected soldiers investigating their sexual histories, and spreading their diagnoses across the chain of command with little concern for soldiers' privacy.

His subordinate officers were personal witnesses to this cruelty as a young Captain in the US Army. One young Captain said, *"My troops were forced to suffer through public testing and weeks of anxiety until getting their test results. Many tests resulted in false positives."* 

Those who tested positive were segregated from other service members and treated like prisoners. Some were dishonorably discharged. Others even attempted suicide! One of them was John O. Brisbois.

"The trouble came after a blood test showed that he carries the virus that causes AIDS. 'The Army did everything possible to make me want to leave," said Brisbois, who, after three months absent without leave, **surrendered and tried to kill himself**. He was discharged last month. 'I feel I don't have a future anymore. I don't want to die, but I get so depressed.' Brisbois, 24, fled a special barracks wing, known on the base as the '**HIV hotel**' and '**the leper colony**,' to which he and scores of other soldiers had been transferred."

The military rationalized these harsh measures as necessary to control the AIDS epidemic.

*""The reason we have done what we have done,*" said Maj. Robert Redfield, of Rockville, Md., chief scientist for the Army's AIDS research effort, *"is that we think it's good medicine—and it's medicine that <u>might work in the civilian sector</u>, as well."* 

# Should You Trust Dr. Redfield's Track Record?

No wonder much concern arose when President Trump appointed Dr. Redfield to lead the CDC. Dr. Peter Lurie stated 3 grave concerns:

"First, he has no experience running a public health agency, and does not have the allimportant relationships with state and local public health officials such experience would bring. Second, based on work I conducted with Sidney Wolfe at <u>Public Citizen</u> in the mid-1990s, he has been credibly accused of scientific misconduct for exaggerating the benefits of a putative HIV vaccine, for which he was <u>investigated by the</u> <u>military</u>. Third, he has supported a variety of policies related to HIV/AIDS that are anathema to the great majority of public health professionals: mandatory HIV testing, reporting of positive HIV results to public health authorities without the patient's consent, and quarantining of HIV-positive individuals in the military."

Drs. Peter Lurie and Sidney M. Wolfe show that Dr. Redfield and his team ruthlessly engaged in a "systemic pattern of data manipulation, inappropriate statistical analyses and misleading data presentation....in apparent attempt to promote the usefulness of the GP160 AIDS vaccine."

A committee of Air Force doctors in 1992 in San Antonio reached similar conclusions: "The committee agreed the information presented by Dr. Redfield seriously threatens his credibility as a researcher and has thus the potential to negatively impact AIDS research funding for military institutions as a whole. His allegedly unethical behavior creates false hope and could result in premature deployment of the vaccine."

Although the Army acknowledged there were issues about the accuracy of the data, Redfield was ultimately cleared of any allegations of scientific misconduct.

Dr. Redfield actually confessed that his analyses were deceptive and agreed to publicly correct them. Yet, he did not keep his word:

"Afterward, he continued making his false claims at three subsequent international HIV conferences, and **perjured himself in testimony before Congress**, swearing that his vaccine cured HIV. Their gambit worked. Based upon his testimony, **Congress appropriated \$20 million to the military to support Redfield and Birx's research project**. Public Citizen complained in a 1994 letter to the Congressional Committee's Henry Waxman that **the money caused the Army to kill the investigation and** 'whitewash' Redfield's crimes. The fraud propelled Birx and Redfield into stellar careers as health officials."

Observers remain concerned about Dr. Redfield's appointment to lead the CDC.

"...one of the whistleblowers who raised the issue of the trial data to the Army told Kaiser Health News (KHN) that he remains concerned about what happened. 'Either he was egregiously sloppy with data or it was fabricated,' said former Air Force Lt. Col. Craig Hendrix, a doctor who is now director of the division of clinical pharmacology at Johns Hopkins University School of Medicine, to KHN. 'It was somewhere on that spectrum, both of which were serious and raised questions about his trustworthiness.'"

It is tragic indeed that the Trump Administration ignored Dr. Peter Lurie's appeal against Dr. Redfield's appointment at the head of CDC.

"What one wants in a director of the Centers for Disease Control and Prevention is a scientist of impeccable scientific integrity. What one would get in **Robert Redfield is a sloppy scientist** with a **long history of scientific misconduct and an extreme religious agenda**. We urge the administration not to appoint Dr. Redfield."

# Should You Trust Dr. Redfield's "Religious Agenda"?

Dr. Redfield's cruelty and falsification of results should have cause concern. Given his Jesuit training, they might not be all that surprising.

""Liguori, in his treatise on oaths, Question 4, asks if it is allowable to use ambiguity, or equivocal words, to deceive the judge when under oath, and at No. 151 he answers: 'These things being established, it is a certain and a common opinion amongst all divines that for a just cause it is lawful to use equivocation in the propounded modes, and to confirm it (equivocation) with an oath.... Now a just cause is any honest end in order to preserve good things for the spirit, or useful things for the body'...

To add insult to injury, the mainstream media trumpets the Jesuit Dr. Redfield as a Bible-believing Christian.

In reality, he practices the mystical techniques, or "spiritual exercises", of his Jesuit teachers.

The head of the CDC revealed this recently during a <u>radio interview</u> on April 1st, 2020 when he emphasized the "powerful weapon" of social distancing. He told listeners that he understood that staying home is a sacrifice, but asked them to "**close their eyes**" and think of the vulnerable people whose lives they could save if they did their part to break the chain of transmission.

Dr. Redfield merely parrots his living Jesuit master, <u>Pope Francis</u>, who also uses this technique. They both denigrate God's Word in favor of their own imaginations.

On the contrary, Scripture exhorts the Christian "to cast down vain imaginations, and every high thing that exalteth itself against the knowledge of God, for we are to bring into captivity every thought to the obedience of Christ."

# Conclusion: Trust in God, Not in Man

Without a doubt, we live in challenging times. What are the people of God to do?

That said, man is not judge and jury when it comes to determining who lives or dies. Senator Rand Paul expressed his concern about trusting in the tyranny of experts. 
