According to Dr. Peter McCullough, vice chief of internal medicine at Baylor University Medical Center and known for being one of the top five most-published medical

researchers in the United States, COVID-19 vaccines are killing "huge numbers" of people and the government is simply ignoring it.

In a video interview with investigative journalist and founder of Liberty Sentinel, Alex Newman, McCullough says the U.S. government, the Bill & Melinda Gates Foundation and health agencies around the world have all committed to vaccinating the global population while sitting on data showing the COVID-19 "vaccines" are turning out to be the most lethal vaccines ever created.

Safe Treatments Suppressed in Favor of Dangerous 'Vaccines'

McCullough, who also has a master's degree in public health, has provided testimony in three different Senate hearings, sharing the treatments he used to help patients recover from COVID-19 and avoid hospitalization. He summarizes his protocol in the interview. These strategies are also detailed in "Pathophysiological Basis and Rationale for Early Outpatient Treatment of SARS-CoV-2 Infection" published in the January 2021 issue of the American Journal of Medicine. He was also a consulting editor of "A Guide to Home-Based COVID Treatment."

During a recent Texas state Senate Health and Human Services Committee hearing, McCullough noted that, according to available data, early treatment could have prevented up to 85% of COVID-19 deaths.³ Early at-home treatment also minimizes the spread, as the amount of time you're infectious can be reduced from two weeks to about four days.

Yet, despite being inexpensive and readily available, early treatments have all been censored and suppressed, apparently in order to secure this global mass vaccination campaign. In fact, as McCullough notes, there's been no clarified guidance on COVID treatment at all, not even hospital protocols.

The entire focus of our health agencies has been on masking, <u>lockdowns</u> and waiting for a gene therapy "vaccine." The results have been devastating. Five months into the <u>mass vaccination campaign</u>, more than 10,000 in the U.S. and European Union have already died after getting the shots. Any other vaccine would have been pulled from the market by now.

Shocking Stats Show Just How Dangerous COVID 'Vaccines' Are

For example, in 1976, the U.S. government vaccinated 45 million people against pandemic swine flu. The entire program was canceled after reports of just 53 deaths, according to Fox News.⁴ Note: The number of deaths reported after the 1976 inoculation program varies from three to 53, depending on the source.^{5,6,7}

Now, health authorities are shrugging off more than 3,800 deaths⁸ after COVID-19 vaccination as either coincidental or inconsequential. Think about that. Five months into the COVID-19 vaccination campaign, we're looking at a death toll that is 7,000% greater than during the <u>swine flu vaccination campaign</u>, which was canceled after the vaccine was deemed too risky.

The COVID-19 "vaccine" is also on a level of magnitude more dangerous than the seasonal flu vaccine. As reported by McCullough, on average, there are 20 to 30 deaths reported following the seasonal flu vaccine, which is given to about 195 million Americans each year.⁹

Compare that to these novel COVID-19 gene therapies. So far, an estimated 124 million Americans are fully vaccinated against COVID-19 and the death count is already at 3,837, as of April 30, 2021.¹⁰

Worse, it appears the vaccine adverse event reporting system (VAERS) is backlogged by about three months, ¹¹ so this is likely to be a serious undercount. Even if VAERS was fully caught up, it would be an undercount, as only 1% ^{12,13} to 10% ¹⁴ of adverse events after vaccination are ever reported. So, in reality, we might be looking at anywhere from 38,370 to 383,700 COVID vaccine-related deaths.

A third comparison can be made against vaccines as a whole. As reported by Tucker Carlson, ¹⁵May 6, 2021, the COVID-19 shots have already resulted in more deaths than all available vaccines combined from mid-1997 until the end of 2013 — a period of 15.5 years.

No Other Vaccine Has Harmed This Many

In a recent report, the Israeli People Committee (IPC), a civilian body of health experts, similarly concluded that "there has never been a vaccine that has harmed as many people." The Committee received 288 reports of death following COVID-19 vaccination, 90% of which occurred within 10 days. According to this report (translated from Hebrew):¹⁶

"According to Central Bureau of Statistics data during January-February 2021, at the peak of the Israeli mass vaccination campaign, there was a 22% increase in overall mortality in Israel compared with the previous year.

In fact, January-February 2021 have been the deadliest months in the last decade, with the highest overall mortality rates compared to corresponding months in the last 10 years.

Amongst the 20-29 age group the increase in overall mortality has been most dramatic. In this age group, we detect an increase of 32% in overall mortality in comparison with previous year.

Statistical analysis of information from the Central Bureau of Statistics, combined with information from the Ministry of Health, leads to the conclusion that the mortality rate amongst the vaccinated is estimated at about 1: 5000 (1: 13000 at ages 20-49, 1: 6000 at ages 50-69, 1: 1600 at ages 70+).

According to this estimate, it is possible to estimate the number of deaths in Israel in proximity of the vaccine, as of today, at about 1000-1100 people."

CDC Denies Lethal Risks

The contrast in the government's response to COVID-19 vaccine deaths compared to the 1976 swine flu pandemic vaccination campaign is "alarming," McCullough says.

February 19, 2021, the U.S. Centers for Disease Control and Prevention issued a statement saying there were "no safety problems" with Pfizer's and Moderna's mRNA injections.¹⁷ Of the 113 deaths reported at that time, none was deemed to be related to the vaccines.

Then, in May 2021, after reviewing 1,600 deaths reported to VAERS with an unnamed group of U.S. Food and Drug Administration doctors, the CDC declared that none of the deaths was related to the vaccine — this despite 24% of deaths have occurred within 48 hours of injection, and 16% within 24 hours. The problem is that it would take several months to investigate that many deaths, so the likelihood that this was a thorough investigation is slim to none.

"It is impossible for unnamed regulatory doctors without any experience with COVID-19 to opine that none of the deaths were related to the vaccine," *McCullough tells Newman*.

"So, I think this was effectively a scrubbing, like we've seen elsewhere ... We're sitting on, right now, the biggest number of vaccine deaths [and] there's been tens of thousands of hospitalizations, all attributable to the vaccine, and [we're still] going strong."

The reason you're not hearing any negative news about these "vaccines" is because major media networks and stakeholders in COVID-19 vaccines have formed a "trusted news credibility coalition" that seeks to prevent any negative information about COVID vaccines to get into the popular media "because they're concerned about vaccine hesitancy," McCullough says.

Suppression of Concerning VAERS Data Underway

As of April 30, 2021, 3,837 people have died, and 16,014 people have reported serious injuries and disabilities following COVID-19 injections. Among these deaths were two 15-year-olds and one 16-year-old. There were also 235 reports or miscarriage or premature birth as of April 30, 2021.

You can check the latest statistics yourself using openvaers.com.²⁰ So-called fact checkers are of course working overtime to quell rumors about the trends showing in the VAERS data.

A recent fact-check article²¹ by The Post and Courier quotes unnamed, obscure experts stating that dying from the COVID-19 vaccine "isn't an outcome people should worry about," and that "despite misinformation shared on social media that sources a federal vaccines safety database" — meaning the VAERS database — "there is no proof of any patients having died as a result of taking a COVID-19 vaccine in the United States."

They're not going to get any clues elsewhere, thanks to the universal suppression of information.

PolitiFact also recently blew off VAERS as a "breeding ground for misinformation." It warned social media posts reporting VAERS data are not to be trusted, as VAERS "reports are not verified" and "are not enough to determine whether a vaccine causes a particular adverse event."

While both of those statements are true, PolitiFact fails to address the glaring problem that both the CDC and the FDA, which run VAERS jointly, are ignoring clearly emerging trends of harm. The Defender contacted the CDC March 8, 2021, with a list of questions about the vaccine injury reports, and as of May 11 — 64 days later — had received no reply.²³

"[VAERS] is the only place where America, policy makers and others, are going to get a fair shake in understanding safety," McCullough says. He points out that more than 80 colleges and any number of employers are now implementing <u>mandatory COVID vaccination</u>, and the only way for them to understand what the implications of that decision might be is to review the VAERS data. They're not going to get any clues elsewhere, thanks to the universal suppression of information.

Overall, it appears the entire mission of VAERS and other such databases is being tossed aside. The system's primary goal is to "detect new, unusual or rare vaccine adverse events" as a way to monitor the safety of vaccines.

As noted by McCullough, after five reported deaths where a medical product is suspected of being involved, the FDA will issue a black box warning — a notice to consumers warning them that the drug might cause death. At around 50 suspicious deaths, the product is pulled off the market.

The system is clearly failing if every single report of serious injury or death, including all the ones occurring within hours and in people with no underlying health problems, are simply written off as coincidence. It's simply not believable.

EU Reports More Than 7,700 Deaths

Signs of lethal risks are also evident in data from the European Union, where the EudraVigilance system had received 7,766 reports of death after COVID vaccination as of April 17, 2021.²⁴

Of these, Pfizer's mRNA injection accounted for the largest number of deaths at 4,293, followed by Moderna with 2,094 deaths, AstraZeneca with 1,360 deaths and Johnson & Johnson with 19 deaths. As noted by McCullough:

"In my professional opinion, the safest vaccine on the market was the J&J vaccine, and that was pulled for very rare blood-clotting events. We had 7 million people vaccinated but the estimates are for the other two vaccines available [Pfizer and Moderna], the blood-clotting rates are probably 30 times that of J&J, and these others are going strong."

Active Vaccine Surveillance Is Months Away

The FDA has also admitted that its analysis of vaccine safety data will be delayed for weeks, if not months. Right as the pandemic hit, they were in the process of transitioning from its Post-Licensure Rapid Immunization Safety Monitoring (PRISM) network, which was used to track <u>side effects</u> from the pandemic H1N1 vaccine, into a new system called the Biologics Effectiveness and Safety System (BEST).

In the meantime, they're relying on a patchwork of passive reporting systems, including VAERS, the Vaccine Safety Datalink and a phone-based self-reporting system called v-safe.

Since all of these are based on voluntary self-reporting, they can miss potentially lethal and unanticipated reactions. By the end of March 2021, only 6.4% of all vaccinated individuals had enrolled in v-safe, for example, ²⁵ which mean a vast majority aren't being surveilled for side effects.

While BEST will be an active surveillance system capable of examining data from 100 million people and actually compare rates of adverse events between vaccinated and unvaccinated individuals to detect trends, we are months away from this kind of analysis.

In the meantime, people continue to die, and for no good reason, considering the lethality of COVID-19 is on par with seasonal influenza for most age groups. ^{26,27,28,29,30}

Signs of Malfeasance Abound

At this point, the list of evidences of malfeasance is exceedingly long. For a rundown of several key issues, see the peer-reviewed paper "COVID-19: Restoring Public Trust During a Global Health Crisis — An Evidence-Based Position Paper to Ensure Ethical Conduct."

In it, the author substantiates McCullough's allegations of rampant, wanton misconduct among public health officials, the active suppression of safe and effective treatments, and pandemic measures being implemented based on incorrect assumptions and outright lies.

As noted by McCullough in the featured interview, advertisements for COVID-19 vaccines were launched in violation of law before FDA licensing was complete. The initial studies had not even been completed. To this day, none of the COVID-19 "vaccines" has been licensed.

They only have emergency use authorization (EUA), and there's no possible way for anyone to assure their safety. All of these facts are why they're completely optional, and legally cannot yet be made mandatory, even though many schools and businesses are attempting to do that.

McCullough also stresses that in the COVID-19 vaccine trials, both the vaccinated groups and control groups had a less than 1% infection rate, which is about as low as it gets, in terms of risk. What this means is the overall public health impact of COVID-19 vaccination is also bound to be less than 1% — in other words, meaningless.

He also points out that around the world, we're now seeing about 60% of active COVID-19 cases being in fully vaccinated individuals. In McCullough's own practice, the COVID-19 patients he saw in the two weeks before this interview, about 60% were fully vaccinated, and there's no difference in disease presentation between vaccinated and unvaccinated individuals.

Death Tally May Spike During Fall and Winter

While the death toll from COVID-19 vaccines is already at a historical level, I fear it may shoot far higher as we move through fall and winter. The reason for this is because one of the greatest wild cards of these vaccines is antibody-dependent enhancement (ADE) or paradoxical immune enhancement (PIE).

I've detailed this issue in several articles, including "<u>How COVID-19 Vaccine Can Destroy Your Immune System</u>" and "<u>Will Vaccinated People Be More Vulnerable to Variants?</u>" In summary, ADE means that rather than enhance your immunity against the infection, the vaccine actually enhances the virus' ability to enter and infect your cells, resulting in more severe disease than had you not been vaccinated. ^{32,33}

Fall and winter are the seasons in which most coronavirus infections occur, be it SARS-CoV-2 or other coronaviruses responsible for the common cold. If ADE does turn out to be a common problem with these injections, then vaccinated individuals may in fact turn out to be at significantly higher risk of severe COVID-19 and a potentially lethal immune reaction due to pathogenic priming.

Another potential risk is that of Th2 immunopathology, a form of cell-based enhancement in which a faulty T cell response triggers allergic inflammation. This condition may in some cases overlap with ADE, and can, like ADE, be life-threatening.³⁴ In my view, there are still so many potential avenues of harm and so many uncertainties, I would encourage everyone to do your homework, keep reading and learning, weigh the potential pros and cons, ignore all pressure tactics and take your time when deciding whether to get any of these <u>COVID-19 gene therapies</u>.

Almost half of all health care workers in U.S. haven't had COVID-19 vaccine, survey shows

Every day, more Americans become eligible for the COVID-19 vaccine, yet nearly half of all frontline health care workers remain unvaccinated, even though they were given priority access to the first available doses.

Only 52% of all frontline health care workers say they have received even a first dose of a COVID-19 vaccine, according to a <u>new report</u> from the Kaiser Family Foundation and the Washington Post.

That leaves 48% of health care workers on the frontlines of the fight against COVID-19, including doctors, nurses, housekeepers and home health aides, entirely unprotected against and vulnerable to the virus.

Researchers surveyed more than 1,300 health care workers whose jobs expose them to patients or bodily fluids, putting them at higher risk than others of contracting COVID-19, which more than one year into the pandemic has infected nearly 30 million Americans and killed more than 500,000. This figure has been challenged so many times that the CDC even agrees they are incorrect.

Side effects concern some

Three different vaccines that have proven effective against COVID-19 are currently on the market and being administered to large swaths of the U.S. population. Yet clearly, there have been gaps in distribution, as well as in the willingness of individuals to become inoculated against the virus.

Among those health care workers who remain unvaccinated, 12% said they have not yet decided if they will accept a shot in the arm. Another 18% said they do not plan on

<u>receiving a COVID-19 vaccine</u>, citing concerns over side effects and the vaccines' newness, according to the survey results.

Employers also play a role in helping employees access doses. Workers who are selfemployed report lower rates of vaccination.

More than 8 out of 10 vaccinated health care workers who are not self-employed say they received a COVID-19 vaccine through their employer. Meanwhile, only 1 out of 5 vaccinated health care workers who are based in patients' homes say they received a COVID-19 vaccine from their local health department.

Vaccine skepticism among Black Americans

Racial disparities are evident in vaccination rates among health care workers, too. Black health care workers in particular have been reluctant to become vaccinated, with 53% of Black frontline health care workers saying they are not confident that the COVID-19 vaccine is safe. This holds steady across the general population — 47% of Black adults who are not necessarily health care workers feel similarly, according to the survey.

There has been a historic distrust of the medical community by many African Americans, stemming from past abuses that can resonate to this day. They include <u>experimental operations</u> on enslaved Black women in the 1840s as well as the infamous <u>Tuskegee Institute experiments</u> in the 1930s that examined the progression of syphilis in Black men who were misled to believe they were receiving treatment for the disease.

Employers across the U.S. <u>have the legal right to mandate the vaccine</u> as a condition of employment, however most are opting to offer bonuses and other incentives to employees who get jabbed, rather than enforce compliance.

Experts say the government, community leaders and even private companies must be a part of the effort to help individuals overcome vaccine hesitancy so the U.S. can achieve herd immunity.

The Biden administration's <u>American Rescue Plan</u>, signed into law last week, will help fund states' rollout of the vaccine as well as other COVID-19 responses.

Specifically, the package provides \$7.5 billion to the U.S. Centers for Disease Control and Prevention (CDC) to spend on vaccination efforts. Some of the money will be spent on grants for states to improve COVID-19 vaccination distribution and administration.

Researchers find 1,000 different proteins in AstraZeneca's covid vaccine linked to deadly blood clots

(Natural News) A German scientist has discovered why the Wuhan coronavirus (Covid-19) "vaccines" made by AstraZeneca and Johnson & Johnson (J&J) are causing some recipients to develop deadly blood clots.

According to Prof. Andreas Greinacher, a blood expert from the <u>University of Greifswald</u>, the two viral vector vaccines contain genetically modified (GMO) cold viruses that, upon injection, trigger an autoimmune response.

Stray proteins, Greinacher says, along with a preservative used specifically in the AstraZeneca jab known as ethylenediaminetetraacetic acid (EDTA), are directly responsible for causing the blood clots, he says.

Greinacher and his team identified more than 1,000 human-derived cell proteins in the injections that they believe are getting into people's bloodstreams and clamping onto a blood component known as platelet factor 4, or PF4, where they form complexes that activate the production of antibodies.

This then generates an inflammatory response throughout the body, as the immune system is tricked into believing that it has been infected with bacteria. The immune system then overreacts and goes nuts, essentially, causing deadly bleeding and clotting.

Greinacher compares the way the injections trigger this otherwise dormant immune response to "awakening a sleeping dragon." And all for a virus with a 99.9-plus percent survival rate.

Covid vaccines kill, but the establishment still wants you injected

Prof. John Kelton from <u>McMaster University</u> in Canada says he and his team have replicated and confirmed Greinacher's findings, though they are unsure if his causal theory is accurate.

Greinacher, meanwhile, is hoping the two respective vaccine makers will cooperate in nailing down whether or not his causal theory is correct.

"We strongly support raising awareness of the signs and symptoms of this very rare event, and we are currently exploring a potential collaboration with Dr. Greinacher," a J&J spokesperson is quoted as saying.

Numerous other peer-reviewed studies have likewise confirmed Greinacher's findings, reiterating that the type of blood clotting being observed from J&J and AstraZeneca injections is known as vaccine-induced immune thrombotic thrombocytopenia, or VITT.

Most of the science hubs investigating the clotting issue, which was first identified back in March, focus on a similar condition known as heparin-induced thrombocytopenia, or HIT, which has near-identical symptoms and outcomes to VITT.

"With HIT," The 'Wall Street Journal' reported, "the blood-thinning drug heparin causes clots paired with an abnormal decrease in the blood's natural clotting agents."

Other scientists have speculated that the vaccine adenoviruses themselves may be directly triggering the blood clotting, while still others are blaming the "genetic predispositions" of recipients so as to shift the blame away from Big Pharma.

Prof. Eric van Gorp from <u>Erasmus University</u> in the Netherlands also says that the flulike symptoms many recipients of the vaccines experience post-injection could also be the result of autoimmune-provoking inflammation.

The reason why none of this has ever been reported in the past is because viral vector vaccine technology has never before been administered at scale. In other words, these shots, just like their mRNA counterparts, are entirely experimental.

The only viral vector vaccine that even comes close is the Ebola injection developed by J&J, which was only given to about 60,000 people as of last July.

Meanwhile, the *Journal* and other mainstream media outlets are continuing to push the narrative that deadly blood clots are "rare," and that people should still rush out and get injected as soon as possible to "save lives."

"The symptoms are exactly the same as preclinical scurvy," a commenter of ours wrote. "Vitamin C is essential to combat this."

Healthy teenagers have been hospitalized,¹ and at least one death in a teen has been reported,² following experimental COVID-19 vaccinations being distributed under an Emergency Use Authorization (EUA) granted to vaccine manufacturers by the U.S. Food and Drug Administration. The adverse events are especially tragic since COVID-19 has a 99.997% survival rate among children and teens,³ making the necessity of vaccination highly questionable.

One of the risks of receiving an experimental medical procedure like a COVID-19 vaccine is that each person who participates is part of the experiment. Unexpected adverse reactions can and do occur, even with vaccines that have been in use for decades.

Often, the reactions may be mild, including symptoms such as headaches, muscle pain, chills and fever, but in other cases, the reactions may be severe, debilitating and even deadly.

As of April 30, 2021, 3,837 reports of death were submitted to the U.S. Vaccine Adverse Event Reporting System (VAERS).⁴ Past investigations have shown only between 1%⁵ and 10%⁶ of adverse reactions are ever reported to VAERS, which is a passive, voluntary reporting system, so the actual number could be much higher. One study funded by the U.S. government and published in 2011 found that less than 1% of vaccine adverse events are ever reported to VAERS.⁷

After Shot, Healthy Teen Develops Blood Clots in the Brain

April 21, 2021, 17-year-old Everest Romney of Draper, Utah, received a COVID-19 vaccine. The next day, his neck became swollen and he developed severe headaches, which persisted for days. "He could not move his neck without the assistance of his hands," his mother, Cherie Romney, told ABC 4 News.⁸

Everest's pediatrician initially said the neck symptoms were due to a pulled muscle, but Everest also developed a fever, prompting his mother to push for answers.

The pediatrician prescribed antibiotics and a neck brace, suggesting it may be due to an injury from the basketball Everest plays, but Cherie pushed for a CT scan after migraines continued for more than a week, which revealed two blood clots in his brain and a third on the outside of his brain.

After spending time in the intensive care unit, Everest was discharged but swelling persisted in his eyes and they're not sure what the future will bring. "The hardest thing was I let him get that shot. And he was healthy and well before," Cherie said. "But you question it, you can't help but question it when it all goes wrong ... It was pretty awful."

18-Year-Old Hospitalized With Blood Clots After COVID Shot

Emma Burkey, an 18-year-old from the Las Vegas area, also developed blood clots in her brain following a COVID-19 vaccine. She received the Johnson &

Johnson/Janssen vaccine March 20, 2021, and was put into a medically induced coma within two weeks due to seizures and blood clots in her brain.

She is making a recovery in a rehabilitation center, but Bret Johnson, Burkey's minister who was asked to act as spokesman, told Fortune, "We don't know what's going to happen with Emma, how long it will it take for her to return to a normal life." ¹⁰

April 13, 2021, the U.S. Food and Drug Administration (FDA) announced it would pause the use of the <u>Johnson & Johnson COVID-19 vaccine</u> in the U.S. following reports of six cases of rare and severe blood clots called cerebral venous sinus thrombosis (CVST) combined with low blood platelet levels (thrombocytopenia). One death was reported as a result.¹¹

Together, the condition is known as thrombosis-thrombocytopenia syndrome (TTS). At least nine more cases were reported to VAERS between April 13 and April 23, 2021, all in women between the ages of 18 and 59. 12

The experimental Johnson & Johnson COVID-19 vaccine uses a human adenovirus vector to deliver double-stranded DNA for the SARS-CoV-2 spike protein into cells, similar to the AstraZeneca/Oxford University <u>experimental COVID-19 vaccine</u>, which uses a chimpanzee adenovirus vector.¹³

May 10, 2021, an expert panel in Norway recommended that both AstraZeneca's and Johnson & Johnson's COVID vaccines be dropped from the country's vaccination campaign due to the <u>risk of blood clots</u>.¹⁴

Denmark has also rejected Johnson & Johnson's vaccine for the same reason, ¹⁵ while in the U.S. the FDA and the U.S. Centers for Disease Control and Prevention (CDC) lifted the pause on the shot and recommended use of the vaccine should resume, stating, "At this time, the available data suggest that the chance of TTS occurring is very low, but the FDA and CDC will remain vigilant in continuing to investigate this risk." ¹⁶

However, they did add a warning of the risk in their "Fact Sheet for Recipients and Caregivers," which states: 17

"Blood clots involving blood vessels in the brain, abdomen, and legs along with low levels of platelets (blood cells that help your body stop bleeding), have occurred in some people who have received the Janssen [Johnson & Johnson] COVID-19 Vaccine. In people who developed these blood clots and low levels of platelets, symptoms began approximately one to two-weeks following vaccination.

Most people who developed these blood clots and low levels of platelets were females ages 18 through 49 years. The chance of having this occur is remote. You should seek medical attention right away if you have any of the following symptoms after receiving Janssen COVID-19 Vaccine:

Shortness of breath

- Chest pain
- Leg swelling
- Persistent abdominal pain
- Severe or persistent headaches or blurred vision
- Easy bruising or tiny blood spots under the skin beyond the site of the injection

These may not be all the possible side effects of the Janssen COVID-19 Vaccine. Serious and unexpected effects may occur."

COVID Vaccine-Related Death of Teen Reported to VAERS

Another devastating report in VAERS states that a 15-year-old boy from Colorado, with no preexisting conditions or allergies, died from cardiac failure two days after receiving Pfizer's experimental mRNA COVID-19 vaccine.¹⁸

In an interview with Yahoo News, Tom Shimabukuro, deputy director of the Immunization Safety Office at the CDC, was quick to brush off the report, stating: 19

"Anyone can make a report, and the information is not verified. If classified as serious, the CDC follows up to get medical records. Some of these reports might be true adverse reactions that are caused by the vaccine, and some of these reports are coincidental health events and not related to the vaccine at all ... The benefits of vaccination far outweigh any risks from vaccination."

At least five deaths have been reported to VAERS following COVID-19 vaccination in the 6- to 17-year-old category. Thirteen additional reports of life-threatening injury or permanent disability have also been reported in this age group. Despite the unknown and potentially deadly risks, COVID-19 vaccines are being tested on children as young as 6 months old.

Researchers at Yale School of Medicine are leading Moderna's clinical trial of a <u>COVID</u> <u>vaccine for children</u> 6 months to 12 years old, which is being conducted on 6,750 children at 90 sites in the U.S. and Canada. But as noted by Dr. Inci Yildirim, associate professor of pediatrics (infectious diseases) at Yale School of Medicine:²³

"A clinical trial for a children's COVID-19 vaccine requires the consideration of many additional factors. Children are not little adults. As children grow and develop, their immune system grows and develops. A 16-month-old is not the same as a 16-year-old. They are both children, but their capacity to respond to the vaccines is not the same." Victims Looking for Help With Medical Bills, Unlikely to Get It

Burkey, the teen who ended up in an induced coma after vaccination due to blood clots and seizures, has medical bills of \$513,000, and that's just the first round.²⁴ In the U.S., COVID-19 vaccine makers already have something of a "<u>free pass</u>" when it comes to <u>vaccine injury liability and lawsuits</u> under the Public Readiness and Emergency Preparedness (PREP) Act, passed in 2005 and amended in 2020.²⁵

In 1986, the U.S. Congress created a federal no-fault <u>vaccine injury compensation program</u> (VICP) as an administrative alternative to a lawsuit for injuries and deaths caused by vaccines recommended by the CDC for children in the 1986 National Childhood Vaccine Injury Act.²⁶

Over a period of 30 years, that law was weakened with congressional amendments and federal agency rulemaking, as well as a U.S. Supreme Court ruling in 2011 that effectively removed all liability from vaccine manufacturers.

Contested vaccine injury claims filed under the 1986 Act are adjudicated by special masters in the U.S. Court of Federal Claims in Washington, D.C., and there is a trust fund out of which claims are paid, sparing insurance companies representing vaccine makers and vaccine providers from costly payouts for vaccine injuries and deaths.²⁷ Only injury claims for vaccines routinely recommended by the CDC may be heard in this "vaccine court" created in the 1986 Act.

However, the U.S. Court of Federal Claims will not be involved in ruling in contested COVID-19 vaccine injury claims. The previously mentioned PREP Act, which was passed by Congress in 2005 and amended in 2020 with plenty of pharmaceutical industry influence, will separately deal with COVID-19 vaccine injury claims routed through the Countermeasures Injury Compensation Program. As noted by Fortune:²⁸

"The Countermeasures Injury Compensation Program, run by an obscure office within the U.S. Health and Human Services Department, covers medical costs and lost wages not paid by insurance. Some 445 claims had been filed as of April 26 for adverse reactions to either vaccines or treatments, according to the Health Resources and Services Administration [HRSA], which runs the program."

Of these 445 COVID-19 related claims, about one-quarter are linked to vaccines, and so far no payouts have been received. While HRSA stated that no claims have been compensated because they don't have all of the required information, the program has a notoriously low rate of compensation.

In the last decade, only 39 of nearly 500 claims filed under the PREP Act have received federal compensation, most often from reactions caused by the H1N1 vaccine. The bottom line, sadly, is this, as noted by <u>Barbara Loe Fisher</u> of the National Vaccine Information Center:

"Already wealthy drug companies were given at least \$9 billion from the government to develop experimental COVID vaccines in record breaking time, 30 shaving five to 10 years off the normal vaccine development, testing and licensing process. 31,32

But that wasn't enough. Congress also handed companies a liability shield from lawsuits whenever the product government paid them to produce fails to work as advertised or a person is hurt by using it.³³

If you or a loved one dies or is permanently injured by an experimental or soon-to-be FDA licensed COVID vaccine, you cannot sue the drug company who made it, even if there is evidence the company could have made it less reactive or more effective." Sources and References

Pfizer's Covid Injection Linked to Alzheimer's, Neurodegenerative Disease

The long-term effects of Wuhan coronavirus (Covid-19) vaccination remain mostly unknown, but what we do know is that Alzheimer's and other neurological degenerative diseases are already <u>being identified</u> as among the health consequences.

A new study reports that it has been suspected for a while now, based on preliminary evidence, that Chinese Virus jabs could cause dementia. The public, however, is not being told about this risk when lining up for injection.

The risk of developing prion-based disease, the paper suggests, is potentially higher than many people realize. It could take a while for such disease to manifest, but the injections are getting the ball rolling by priming the brain for a degenerative unraveling.

"The current RNA based SARS-CoV-2 vaccines were approved in the U.S. using an emergency order without extensive long term safety testing," it explains. "In this paper the Pfizer COVID-19 vaccine was evaluated for the potential to induce prion-based disease in vaccine recipients."

Messenger RNA (mRNA) injections are especially risky because of how they permanently merge into the human genome. What this means is that a degenerative brain condition could appear at any time down the road if the conditions are ripe for such.

"The RNA sequence of the vaccine as well as the spike protein target interaction were analyzed for the potential to convert intracellular RNA binding proteins TAR DNA binding protein (TDP-43) and Fused in Sarcoma (FUS) into their pathologic prion conformations," the report further explains.

TDP-43 is a protein known to cause dementia, while the FUS protein is known to cause ALS (Lou Gehrig's Disease) and Hereditary Essential Tremors, science has shown.

mRNA technology was created to embed dementia-causing proteins into recipients' DNA

Experiments conducted for the study found that these two harmful proteins do, in fact, embed themselves within a recipient's DNA post-injection. This appears to be what mRNA "vaccines" were designed to do, as they contain special genetic sequences that induce TDP-43 and FUS to fold into their pathologic prion confirmations. "Why are you taking any vaccine?" asked another. "All diseases are survivable with enough vitamin C and D."



Latest CDC Data Show Reports of Adverse Events After COVID Vaccines Surpass 200,000, Including 943 Among 12- to 17-Year-Olds VAERS data released today showed 227,805 reports of adverse events following COVID vaccines, including 4,201 deaths and 18,528 serious injuries between Dec. 14, 2020 and May 14, 2021.

The number of reported adverse events following COVID vaccines surpassed 200,000 according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the <u>Vaccine Adverse Event Reporting System</u> (VAERS).

VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, <u>VAERS</u> makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Today's data show that between Dec. 14, 2020 and May 14, a total of <u>227,805 total adverse events</u> were reported to VAERS, including <u>4,201 deaths</u> — an increase of 144 over the previous week — and <u>18,528 serious injuries</u>, up 1,338 since last week.

This week's data showed <u>943</u> total adverse events, including <u>23</u> rated as serious, among 12- to -17-year-olds.

In the U.S., <u>268.4 million</u> COVID vaccine doses had been administered as of May 14. This <u>includes</u> 115 million doses of <u>Moderna's</u> vaccine, 144 million doses of <u>Pfizer</u> and 9 million doses of the <u>Johnson & Johnson</u> (J&J) COVID vaccine.

Of the **4,201** deaths reported as of May 14, 23% occurred within 48 hours of vaccination, 16% occurred within 24 hours and <u>38% occurred</u> in people who became ill within 48 hours of being vaccinated.

This week's VAERS data show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 44% were female and the remaining death reports did not include gender of the deceased.
- The <u>average age</u> of death was 74.7 and the <u>youngest deaths</u> reported include two 15-year-olds (VAERS I.D. <u>1187918</u> and <u>1242573</u>) and a 16-year-old (VAERS I.D. <u>1225942</u>). There were other reported deaths in children under 16 that could not be confirmed or contained obvious errors.
- As of May 14, <u>1,140 pregnant women</u> reported adverse events related to COVID vaccines, including 351 reports of <u>miscarriage or premature birth</u>.

- Of the <u>2,275 cases of Bell's Palsy reported</u>, 51% were reported after <u>Pfizer-BioNTech</u> vaccinations, 42% following vaccination with the Moderna vaccine and 192 cases, or 10%, of Bell's Palsy cases were reported in conjunction with J&J.
- There were <u>195 reports of Guillain-Barré Syndrome</u> with 40% of cases attributed to Pfizer, 38% to Moderna and 26% to J&J.
- There were <u>65,854 reports of anaphylaxis</u> with 38% of cases attributed to <u>Pfizer's vaccine</u>, 51% to <u>Moderna</u> and 11% to <u>J&J</u>.
- There were <u>3,758 reports</u> of clotting disorders and other related conditions. Of those, <u>1,468 reports</u> were attributed to Pfizer, <u>1,093 reports</u> to Moderna and <u>1,093 reports</u> to J&J.

COVID vaccines may not work for millions with underlying conditions As The Defender reported May 19, some experts are questioning the CDC's recommendation that immunocompromised people get vaccinated after new research showed 15% to 80% of people with underlying health disorders and those on immunosuppressive medications mount few, if any, antibodies to COVID vaccines.

Yet, current CDC guidelines indicate those with compromised immune systems should be vaccinated for COVID even though "no data are available to establish COVID vaccine safety and efficacy in these groups" as people with compromised immune systems or those who take immunosuppressants for a medical condition were largely excluded from vaccine clinical trials.

<u>Dr. Meryl Nass</u>, an internal medicine physician, said it's the responsibility of the CDC to determine the risks and benefits of every vaccine for different groups of people. For COVID vaccines, Nass said, the CDC has failed to publish that information, or tell the public which groups might be at a higher risk of suffering an adverse reaction that far outweighs any potential benefit.

CHD Calls on FDA to Take COVID Vaccines Off the Market - Submit a Comment Ninth fully vaccinated Yankee player tests positive for COVID

As The Defender <u>reported</u> May 19, a ninth, fully vaccinated member of the New York Yankees organization tested positive for COVID. Most of the reported cases were asymptomatic. <u>All nine were vaccinated</u> with the <u>J&J shot</u>, making these cases what the CDC calls "<u>breakthrough</u>" infections.

Some in the medical community claim this is proof COVID vaccines work — because none of the nine became seriously ill or were hospitalized. A <u>CNN article</u> today quoted an infectious disease physician who said the mild cases were evidence the vaccines worked. But Dr. Meryl Nass, told The Defender that the data on COVID infections show young, healthy athletes wouldn't be expected to become seriously ill from COVID, regardless of vaccination status.

Nass said the breakthrough cases raise questions about <u>COVID test accuracy</u> and the vaccine's ability to prevent the virus and its transmission.

Employers may be held liable for "any adverse reaction" if they mandate COVID vaccines

On May 20, The Defender <u>reported</u> that new guidance from the Occupational Safety and Health Administration (<u>OSHA</u>) will hold employers liable for adverse reactions if they require employees are vaccinated for COVID as a condition of employment, which could negatively impact the employer's safety rating.

In the <u>Frequently Asked Questions</u> section of OSHA's website having to do with COVID safety compliance, a question was asked whether an adverse reaction to a COVID vaccine had to be recorded if an <u>employer mandated vaccination</u> as a condition for employment.

OSHA stated:

"If you require your employees to be vaccinated as a condition of employment (i.e., for work-related reasons), then any adverse reaction to the COVID-19 vaccine is work-related. The adverse reaction is recordable if it is a new case under 29 CFR 1904.6 and meets one or more of the general recording criteria in 29 CFR 1904.7."

Conversely, <u>OSHA said</u> it will exercise enforcement discretion and will not require adverse reactions be recorded when an employer only "recommends" that employees receive the vaccine, while noting that for this discretion to apply, the vaccine must be truly voluntary.

In determining whether a vaccine is "voluntary," the <u>website states</u>, "an employee's choice to accept or reject the vaccine cannot affect [his or her] performance rating or professional advancement," and that an "employee who chooses not to receive the vaccine cannot suffer any repercussions from this choice."

If employees are not free to choose whether or not to receive the vaccine without fearing negative recourse, then the vaccine is required and employers should refer to the section on COVID vaccines as a condition to employment.

J&J knew about issues at plant manufacturing its vaccine seven months before shut down

On May 20, The Defender <u>reported</u> that the House Select Committee on Coronavirus launched a probe into Emergent BioSolutions — the plant manufacturing J&J's vaccine — last month after the company acknowledged "serious deficiencies" in the company's manufacturing that <u>caused a mix-up</u> of <u>AstraZeneca</u> and J&J doses.

During a congressional hearing Wednesday, it was revealed that J&J had documented serious contamination risks at the Emergent Baltimore plant in June 2020 — seven months before a <u>contamination incident</u> ruined 15 million doses of COVID vaccine and derailed the company's vaccine production plans.

A <u>memorandum</u> released prior to the hearing raised questions about J&J's lack of oversight of the Baltimore facility, <u>large bonuses</u> paid to top executives despite failures, and described other evidence recently obtained by the House panel in their ongoing investigation into Emergent.

According to <u>Business Insider</u>, CEO of Emergent, Robert Kramer, admitted to the House of Representatives during the hearing that more than 100 million doses of J&J's vaccine are on hold due to possible contamination.

It was the first time Kramer admitted the high figure of potentially spoiled vaccines after The New York Times <u>reported</u> in April the facility <u>may have jeopardized</u> 62 million vaccine doses in addition to ruining 15 million doses through cross-contamination with AstraZeneca vaccine ingredients.

"No one is more disappointed than we are that we had to suspend our 24/7 manufacturing of new vaccine," Kramer said. "I apologize for the failure of our controls."

Eric Clapton blames propaganda for severe adverse reaction to AstraZeneca On May 17, The Defender reported that 76-year-old Eric Clapton suffered a severe adverse reaction after getting the AstraZeneca COVID vaccine that left him fearing he would never play again.

"Needless to say the reactions were disastrous, my hands and feet were either frozen, numb or burning, and pretty much useless for two weeks. I feared I would never play again," Clapton said. "But the propaganda said the vaccine was safe for everyone."

Days after Clapton's criticism of vaccine "propaganda," the <u>Wall Street Journal</u> reported that U.S. vaccine makers are sponsoring ad campaigns targeting the roughly <u>one-third</u> of Americans who are reluctant to get a COVID vaccine.

Pfizer, Moderna, Regeneron and other pharmaceutical companies are sponsoring ads on TV, radio and social media praising COVID vaccines and medications in an effort to increase vaccinations. Unlike ads for drugs where brand names are featured, general "get the vaccine" ads don't have to follow legal guidelines, which include listing the drug's potential side effects.

74 days and counting, CDC ignores The Defender's inquiries

According to the <u>CDC website</u>, "the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated."

On March 8, <u>The Defender</u> contacted the CDC with a <u>written list of questions</u> about reported deaths and injuries related to COVID vaccines. After repeated attempts, by phone and email, to obtain a response to our questions, a health communications specialist from the CDC's Vaccine Task Force contacted us on March 29 — three weeks after our initial inquiry.

The individual received our request for information from VAERS, but said she had never received our list of questions, even though employees we talked to several times said CDC press officers were working through the questions and confirmed the representative had received them. We provided the list of questions again along with a new deadline, but never received a response.

<u>The Defender</u> also followed up with the CDC's media department, which told us the COVID response unit would be informed that the health communications specialist never responded. No explanation was given as to why our inquiries were ignored. We were told to call back, which we did numerous times.

On May 19, a CDC employee said our questions had been reviewed and our inquiry was pending in their system, but would not provide us with a copy of the response. It has been 74 days since we sent our first email inquiring into VAERS data and reports. Children's Health Defense asks anyone who has experienced an adverse reaction, to any vaccine, to file a report following these three steps.

How the CDC is manipulating data to prop-up "vaccine effectiveness" New policies will artificially deflate "breakthrough infections" in the vaccinated, while the old rules continue to inflate case numbers in the unvaccinated.

The US Center for Disease Control (CDC) is altering its practices of data logging and testing for "Covid19" in order to make it seem the experimental gene-therapy "vaccines" are effective at preventing the alleged disease.

They made no secret of this, announcing the policy changes on their website in late April/early May, (though naturally without admitting the fairly obvious motivation behind the change).

The trick is in their reporting of what they call "breakthrough infections" – that is people who are fully "vaccinated" against Sars-Cov-2 infection, but get infected anyway.

Essentially, Covid19 has long been shown – to those willing to pay attention – to be an entirely created pandemic narrative built on two key factors:

- 1. False-postive tests. The <u>unreliable PCR test</u> can be manipulated into reporting a <u>high number of false-positives</u> by altering the cycle threshold (CT value)
- Inflated Case-count. The incredibly <u>broad definition</u> of "Covid case", used all over the world, lists anyone who receives a positive test as a "Covid19 case", even if they never experienced any symptoms.

Without these two policies, there would never have been an appreciable pandemic at all, and now the CDC has enacted two policy changes which mean they no longer apply to vaccinated people.

Firstly, they are lowering their CT value when testing samples from suspected "breakthrough infections".

From the CDC's instructions for state health authorities on handling "possible breakthrough infections" (uploaded to their website in late April):

For cases with a known RT-PCR cycle threshold (Ct) value, submit **only specimens** with Ct value ≤28 to CDC for sequencing. (Sequencing is not feasible with higher Ct values.)

Throughout the pandemic, CT values in excess of 35 have been the norm, with labs around the world going into the 40s.

Essentially labs were running as many cycles as necessary to achieve a positive result, despite experts warning that this was pointless (even <u>Faucet himself</u> said anything over 35 cycles is meaningless).

But NOW, and only for fully vaccinated people, the CDC will only accept samples achieved from 28 cycles or fewer. That can only be a deliberate decision in order to decrease the number of "breakthrough infections" being officially recorded.

Secondly, asymptomatic or mild infections will no longer be recorded as "covid cases".

That's right. Even if a sample collected at the low CT value of 28 can be sequenced into the virus alleged to cause Covid19, the CDC will no longer be keeping records of breakthrough infections that don't result in hospitalization or death.

From their website:

As of May 1, 2021, CDC transitioned from monitoring all reported vaccine breakthrough cases to focus on identifying and investigating only hospitalized or fatal cases due to any cause. This shift will help maximize the quality of the data collected on cases of greatest clinical and public health importance. Previous case counts, which were last updated on April 26, 2021, are available for reference only and will not be updated moving forward.

Just like that, being asymptomatic – or having only minor symptoms – will no longer count as a "Covid case" but only if you've been vaccinated.

The CDC has put new policies in place which effectively created a tiered system of diagnosis. Meaning, from now on, unvaccinated people will find it much easier to be diagnosed with Covid19 than vaccinated people.

Consider...

Person A has not been vaccinated. They test positive for Covid using a PCR test at 40 cycles and, despite having no symptoms, they are officially a "covid case".

Person B has been vaccinated. They test positive at 28 cycles, and spend six weeks bedridden with a high fever. Because they never went into a hospital and didn't die they are NOT a Covid case.

Person C, who was also vaccinated, did die. After weeks in hospital with a high fever and respiratory problems. Only their positive PCR test was 29 cycles, so they're not officially a Covid case either.

The CDC is demonstrating the beauty of having a "disease" that can appear or disappear depending on how you measure it.

To be clear: If these new policies had been the *global approach* to "Covid" since December 2019, **there would never have been a pandemic at all.**

If you apply them only to the vaccinated, but keep the old rules for the unvaccinated, the only possible result can be that the official records show "Covid" is much more prevalent among the latter than the former.

This is a policy designed to continuously *inflate* one number, and systematically *minimize* the other.

Senior Chinese Communist Party Loyalist Professor Declares Victory in "Biological Warfare"


This week it was reported in these pages that a Former US Army scientist and AstraZeneca executive said the "creation" of COVID was under People's Liberation Army command.





Pic: Natural News carbon nanotube hydrogel with gripper





Nobel Prize winner French Virologist Prof. Luc Montagnier in an interview has made a starting claim that the <u>COVID-19 vaccines</u> itself are creating variants.

As reported by <u>GreatGameIndia</u> last year, <u>Luc Montagnier confirmed the study linking COVID-19 and HIV</u> conducted by Indian scientists.

A group of Indian scientists discovered that <u>coronavirus was engineered with AIDS like insertions</u>. The study concluded that it was unlikely for a virus to have acquired such unique insertions naturally in a short duration of time.

How Vaccines Are Creating Variants

Prof. Montagnier referred to the vaccine program for the coronavirus as an "unacceptable mistake".

"Mass vaccinations are a "scientific error as well as a medical error," he said.
"It is an unacceptable mistake. The history books will show that, because it is the vaccination that is creating the variants," Prof. Luc Montagnier continued.

The prominent virologist explained that "there are antibodies, created by the vaccine," forcing the virus to "find another solution" or die. This is where the variants are created. It is the variants that "are a production and result from the vaccination."

Antibody-Dependent Enhancement (ADE)

Prof. Montagnier said that epidemiologists know but are "silent" about the phenomenon, known as "Antibody-Dependent Enhancement" (ADE).

Prof. Montagnier explained that the trend is happening in "each country" where "the curve of vaccination is followed by the curve of deaths."

We observed the same in India as well. India saw nearly 750% increase in COVID-19 cases in less than a month. Was this spike logical? Did the mass vaccination drive in

the metro cities cause the second COVID-19 wave in India? Or is there something else? The Nobel Laureate's point is emphasized by information revealed in an open letter from a long list of medical doctors to the European Medicines Agency. The letter stated in part that "there have been numerous media reports from around the world of care homes being struck by COVID-19 within days of vaccination of residents."

Prof. Luc Montagnier continued to say that he is doing his own experiments with those who become infected with the coronavirus after getting the vaccine. "I will show you that they are creating the variants that are resistant to the vaccine," he said.
